ED arrests Archana

Bhubaneswar, Dec 13: The Enforcement Directorate (ED) Tuesday arrested lady blackmailer Archana Nag, the prime accused in high profile sextortion racket case, under the Prevention of Money Laundering Act (PMLA),

ED sleuths informed the court about the lady blackmailer's arrest while producing her after the completion of the seven days remand period. On December 5, she was remanded to the seven day's ED custody for interrogation.

While hearing the ED's plea seeking seven more days of remand for Nag, the court allowed the central agency to take her on remand for another six days

The court also allowed ED to take Archana's husband and coaccused in sextortion case Jagabandhu Chand on remand for nine days. The ED had sought the court's permission to take Jagabandhu on remand for 15 days.

ED Tuesday took Archana on remand while Jagabandhu will be taken on remand from Wednesday.

Notably, the 26-year-old woman from Kalahandi was arrested October 6 this year and sent to jail on charges of blackmailing rich and influential people along with running a sex racket.

The law states that tobacco can't ever be sold to anybody born on or after Jan 1, 2009. It means the minimum age for buying cigarettes will keep going up

and up. In theory, somebody trying to buy a pack of cigarettes 50 years from now would need ID to show they were at least 63 years old. But health authorities hope smoking will fade away well be-

fore then. They have a stated goal of making New Zealand smoke-The new law also reduces the number of retailers allowed to sell

tobacco from about 6,000 to 600 and decreases the amount of nicotine allowed in tobacco that is smoked.

"There is no good reason to allow a product to be sold that kills half the people that use it," Associate Minister of Health Dr Ayesha Verrall told lawmakers in Parliament. "And I can tell you that we will end this in the future, as we pass this legislation.'

She said the health system would save billions of dollars from not needing to treat illnesses caused by smoking, such as cancer, heart attacks, strokes, and amputations. She said the bill would create generational change and leave a legacy of better health for youth.


Lawmakers voted along party lines in passing the legislation 76 to 43. The libertarian ACT party, which opposed the bill, said many small corner stores, known in New Zealand as dairies, would go out of business because they would no longer be able to sell cigarettes.

'We stand opposed to this bill because it's a bad bill and its bad policy, its that straightforward and simple," said Brooke van Velden. ACT's deputy leader. "There won't be better outcomes for New

worst vear." said Chief Justice S Muralidhar, while hearing the issue of discovery of the carcass of an elephant in Similipal South Wildlife division December 7 this

The Principal Chief Conservator of Forests (PCCF) Manoj V Nair appeared before the court virtually and admitted that three Forest officials had burnt the carcass in order to destroy the evidence of the jumbo

"The field director received complaints from dwellers of Bakua regarding the killing and covering up of a pachyderm in the core area by the field staff December 7. After inquiry, it came to our notice that the poaching had indeed happened. The three officials—forester-cumrange in charge Shiba Shankar Samal, forester Chandrabhanu Behera and guard Binod Daswere instrumental in concealing the fact as they burnt the carcass, Nair told the HC, adding that they have been suspended.

Irked, the HC asked the government as to why no FIR has been registered against the officials who have been suspended in the Similipal case.

The joint task force (JTF) also filed a status report stating that all they could find were a few bones and flesh from the stream where the

charred carcass was found. The court directed the state government to inform as to how elephant death can be prevented and what measures have been taken for elephant corridor mapping, lawyer Asish Mishra, who pre-

sented the case, said. Mishra added that the PCCF has been asked to remain present on the next hearing.

The court has posted the hearing to December 22.

The poaching has triggered apprehension among local wildlife lovers who alleged inadequate protection measures for the fauna in

China tried to change status quo in Arunachal: Rajnath

10.79L Jan Dhan accounts fake

New Delhi, Dec 13: Nearly 47.57 crore Jan Dhan accounts have been opened in the country of which 38.19 crore are operative while 10.79 lakh are duplicate, Minister of State for Finance Bhagwat Karad told the Rajya Sabha Tuesday.

In a written reply, Karad said that as on November 30, a total of 47.57 crore Jan Dhan accounts have been opened in the country.

"PMJDY guidelines envisage issue of RuPay debit card to Jan Dhan account holders and issuance of RuPay debit cards to Jan Dhan account holders by bank is an ongoing process. As informed by banks, there are 19.90 crore account holders who do not have functional debit cards and 4.44 crore account holders did not renew their PMJDY RuPay Card," the minister said.

RBI has advised Financial Literacy Centres (FLCs) and rural branches of banks to conduct outdoor financial literacy camps for customers in collaboration with ground level stakeholders at the district/panchayat or village level. This year, the Moon will interfere with the best view of the Geminids. Rising just before or around midnight (depending on where you live), its glare will wash out and hide the

So where do the Geminids come from?

The Geminids are fragments of

a rock comet. Our Solar System is full of debris left behind from when the planets

formed. That debris includes comets and near-Earth asteroids – objects whose orbits around the Sun cross that of Earth itself. Comets and asteroids are dirty beasts. They

both have a tendency to shed dust

and debris to space as they move

around our star. The parent of the

Geminids is an asteroid called 3200 Phaethon; its extremely elongated orbit around the Sun takes it in closer than Mercury, and out beyond the orbit of Mars. With each lap, the temperatures on Phaethon vary dramatically - from extreme cold (below -100 degree celsius) to extreme heat (above 750 degree celsius) and back again.

The result? The rocks on Phaethon expand and contract with the heat, fracturing and fragmenting, causing shards of debris to go out into space. Over thousands of years, that debris has spread around Phaethon's orbit, creating a vast "tube". We go through that debris each December as we move around the Sun, and it ablates (often described as "burning up", though no fire is involved) high in our atmosphere, giving birth to the Geminid meteor shower.

So where and when should I look for the Geminids in 2022?

For most of the fortnight the Geminids are active, their rates

At that time, Earth is passing through the outer regions of Phaethon's debris stream, where the dust is widely spread. But for around 24 hours, centered on the evening of December 14, Earth will be passing through the densest part of the meteor stream.

That's when the view will be best. While Geminid meteors can appear in any part of the sky, all will point \rightarrow back to the same area. That region, in the constellation Gemini, is known as the shower's "radiant". When the radiant is below the horizon, meteors from the shower are hitting the far side of our planet, and so no

shower meteors will be visible. **Continued on P4**





Bhubaneswar, Dec 13: The Economic Offences Wing (EOW) of Odisha police has arrested two persons from Jharkhand for their alleged involvement in a cheating case involving ₹4 crore.

The accused were identified as Tanweer Nazri and Md Abdul Hasnain, the president and secretary of Vastav India Trust respectively. They were arrested for duping people on the pretext of selling/supplying LED bulbs as part of their solar awareness programme and giving pre-Matric scholarship to the students in their 'Chhulo Aasman' programme, said superintendent of police, EOW, Dilip Tripathy.

The Vastav India Trust, which was registered with sub-registrar of Ranchi in Jharkhand, had

opened its branch office at Bomikhal in the Capital city in March 2022.

Tanweer and Abdul, in connivance with others, launched two programmes on 'solar awareness' and 'pre-Matric scholarship' namely 'Chhulo Aasman'.

Under the solar awareness programme, they collected ₹1,650 in cash from each applicant as member fee with assurance to supply them with LED bulbs, he said.

In their pre-Matric scholarship programme, the trust was offering the scholarship of ₹1,000 per month up to 24 months on the onetime deposit of ₹3,000 as membership charge, said Tripathy.

The accused collected about ₹4 crore from more than 3,500 people. In order to gain the faith of the victims, they initially deposited ₹1,000 in the accounts of some of the investors. However, they did not

pay any amount to the victims after the one-time deposit of

Subsequently, the accused disappeared after closing down their offices in the state.

The trust was inducing the gullible parents and general public in the name of social welfare programme and awareness. They had appointed several block coordinators and other staffers at different places in Sundargarh, Bhadrak. Nabarangpur, Kandhamal, Nayagarh, Mayurbhanj, Balasore and Dhenkanal.

"It is totally a money circulation case," the SP said, adding, the trust has also cheated people of other states like Jharkhand, Delhi and Bihar.

'We will alert the authorities of these states concerned," he mentioned

Opening health edu centres made easier

New rule to be effective from 2023-24 academic session

Bhubaneswar, Dec 13: In a bid to encourage private sector investment in opening of quality healthcare education institutions, the state government has relaxed the norms which will come into effect from next academic session.

The process for obtaining no objection certificate (NOC) for different courses like Nursing, D Pharm, B Pharm, M Pharm, DMLT, DMRT, Physiotherapy, Occupational Therapy and allied medical sciences have been streamlined.

Robust guidelines have also been formulated for ensuring min-



imum standard of requirements in accordance with recommendations of the councils concerned.

Health and Family Welfare secretary Shalini Pandit said that as per the new rules, the requirement of submission of GIS and gap analysis data by the applicant for determining the number of institutions in a district would be discontinued. Pandit said that assessment for suitability of the institutions through inspection would be done by subject experts.

Involvement of district administration i.e. Collector, additional district magistrate, block development officer, deputy collector and tehsildar would be discontinued, she said, adding, the new rules will be effective from 2023-24 academic session.

Educationists opined that such provisions would facilitate establishment of high-quality professional institutions in the state and boost production of qualified and skilled health personnel in different streams

3 held for rape bid on woman

Bhubaneswar, Dec 13: Commissionerate Police Tuesday arrested three persons for allegedly trying to rape a woman in Mancheswar area here Monday evening.

The accused were identified as Debashis Pradhan alias Malinga, 24, of Tikabali in Kandhamal, Deepak Kumar Sethy, 24, of Rangamatia here and Swadhin Kumar Nayak alias Sanu, 22 of Badasahi in Nayagarh district.

Pradhan has been residing in Unit 8 area while Nayak is staying at Dasaraja Basti in Mancheswar. Sources in police revealed that

Sethy had arranged a party on the occasion of his birthday along with his friends including Pradhan and Nayak in a City hotel Monday evening. The heavilv drunk accused later came to an open field near the Railway colony where the victim has been staying along with her family in a tent after the demolition of their house during an eviction drive.

They started drinking liquor at the field making loud noise and using slangs. The woman got annoyed and asked them to stop making noise and using slangs. Subsequently, a verbal duel ensued between the victim and the accused

Startup policy soon for UG, PG students

Bhubaneswar, Dec 13: Higher Education Minister Rohit Pujari Tuesday said the department has decided to introduce a startup policy for Plus III and PG students to further strengthen the startup ecosystem of the state.

He revealed during a meeting organised at Lok Seba Bhawan here under his chairmanship. Council of Higher Secondary

Education (CHSE) vice chairman Ashok Kumar Das, Startup Odisha executive chairman Omkar Rai, and vice chancellors of various state universities were present in the meeting. After the meeting, Das said that the state will soon introduce a startup policy for Plus III and post-graduate (PG) students. "The startup policy will work on how the students can develop their idea into a business company. The projects of Plus III and PG students will be showcased to companies by the Higher Education

department," he added. "Although our Centre of Excellence is doing well as per the World Bank, it is only limited up to a particular level," said Das emaphasing the need for a startup policy to include university students.

A thorough research will be conducted regarding how to fit the commercial and global databases which will be funded by the state government, an official said. It should be mentioned here that Startup Odisha is an initiative of Micro, Small and Medium Enterprises (MSME) department to promote ideas and innovations of budding entrepreneurs in the state.

Earlier: the Higher Education minister and principal secretary had a consultative discussion with the delegates from Australia to envisage the provision of international qualitv higher education in the state. The minister had a detailed discussion with Nottingham Trent University, UK for the internationalisation of higher education in state.

"Our focus is on skill development. The foreign universities are known for their skilling courses. We are initially planning to focus on skill and competency areas like machine learning, data science, data mining (big data management) and artificial intelligence which can be offered and pursued online," said an official of the department.

Fat visible under skin protects females' brains: Study

he subcutaneous fat that appears under the skin in places such as hips, buttocks and back of the arms emerges as protective against brain inflammation in females, a new study has shown.

According to the study by the Medical College of Georgia, this brain inflammation in females could result in problems like dementia and stroke, at least until menopause

However, males of any age are more likely to deposit fat around the major organs in their abdominal cavity, known as visceral adiposity.

As a result, males are considered to be at greater risk for inflammation-related problems, such as heart attacks and strokes be-

fore females reach menopause. "When people think about pro-



tection in women, their first thought is estrogen," said Alexis M Stranahan, PhD, a neuroscientist

at the Medical College of Georgia. "But we need to get beyond the kind of simplistic idea that every sex difference involves hormone differences and hormone exposure,"

The researchers experimented on the male and female mice to look at the increase in the amount and location of fat tissue as well as

levels of sex hormones and brain inflammation, to learn more about

how the brain becomes inflamed. Since, much like with people, obese female mice tend to have more subcutaneous fat and less visceral fat than male mice.

After further experiments, the researchers found that the subcutaneous fat loss increased brain inflammation in females without moving the dial on levels of their estrogen and other sex hormones,

According to the study by the Medical College of Georgia, this brain inflammation in females could result in problems like dementia and stroke, at least until menopause

the study revealed.

"When we took subcutaneous fat out of the equation, all of a sudden the females' brains start to exhibit inflammation the way that male brains do, and the females gained more visceral fat," said Stranahan. She also added that "the females who did not have subcutaneous fat removed but did eat a high-fat diet, showed brain inflammation levels

similar to the males". When subcutaneous fat was removed from mice on a low-fat diet at an early age, they developed a little more visceral fat and a little

more inflammation in the fat. However, Stranahan and her colleagues found no evidence of inflammation in the brain.

Stranahan notes that some consider the reason that females have higher stores of subcutaneous fat to enable sufficient energy stores for reproduction.

"But many questions remain like how much fat is needed to maintain fertility versus the level that will affect your metabolism, she added.

Get ready to witness Geminid...

The time at which the Geminid radiant rises is in the table below for cities around Australia. That marks the start of the show, and is a good time to head out and start getting adapted to the darkness.

In the first hour after the radiant rises, Geminids will be few and far between, but those that do appear have the potential to be spectacular. Entering Earth's atmosphere at a very shallow angle, these "Earthgrazers" can appear to travel from horizon to horizon, an amazing sight.

As the hours pass, the show would normally get better and better, with the best rates visible in the early hours. This year, however, the waning gibbous Moon will rise roughly a couple of hours after the Geminid radiant. The moonlight will add glare to the night sky, hiding the fainter Geminids. Despite this, the show will continue to be spectacular – just a bit less so than in a normal year!

This year, the best time to observe might just be the hour or so before moonrise (and a little while after, when the Moon is still low in the sky). That's a good time to lie back, relax, and gaze up at Mars brilliant, red and brighter than the brightest stars in the night sky. This year, Mars will be a perfect guide to view the Geminids.

and keep it roughly in the centre of your vision, you'll be well placed to see plenty of Geminids. While the meteors can appear anywhere in the sky (always pointing back to the radiant), we've found that looking about 45 degrees from the radiant and about 45 degrees above the horizon seems to be the sweet spot to get the best display.

Find somewhere comfortable to relax, and enjoy the show. Remember, though, that meteors are a bit like buses. While you might hope to see 20 or 30 in the hour before moonrise (more, if you're lucky), don't expect them to fall as regularly as clockwork. You'll wait ten minutes, then three will come along at once! What if it's cloudy? You might have better luck next year!

The Geminids are an annual spectacle - something wonderful to set your calendar by. If you miss the peak this year, all is not lost. The nights either side of the maximum (December 13 and 15) will still put on a decent show, albeit not as good as the maximum. If all three are lost to cloud. then let's look forward to next year's show. There's good news there - in 2023, the Moon will be new, and won't interfere at all.

In the meantime-fingers crossed for clear skies! Hopefully we'll all get a good chance to see the best meteor shower of 2022. And if not, well, there's always next year.

Kendrapara, Dec 13: Five years have elapsed since the Odisha government wrote to the Home Ministry seeking permission to raise a special police battalion that will enhance security along the state's 480km-long coastline. However, the Union Home Ministry is yet to reply on it. The then additional secretary Asit Kumar Tripathy had mentioned in the letter that the setting up of the proposed Coastal India Reserve Battalion (CIRB) will help in supplementing the efforts of the marine police in tightening security along the coastline.

Locals in this town, including Radhakanta Mohanty said that out of the 480km-long coastline, 48 kilometres pass through Kendrapara district. The Talachua, Tantiapal and Jambu marine police stations have been set up for maintaining security along the coastline. However, lack of proper infrastructure and manpower shortage has hampered their functioning. Rampant intrusions are taking place on a daily basis as these police stations do not have boats to patrol the coastline.

60-yr-old man gets 20 years in prison for raping minor

Baripada, Dec 13: A local court here sentenced 60-year old Sunaram Singh, a native of Sagunashola village under Bangiriposhi police limits in Mayurbhanj district to 20 years of rigorous imprisonment after convicting him for raping a minor in 2018. The Additional District and Sessions Judge of the POCSO court, Sumita Jena also slapped a penalty of ₹13,000 on Singh after convicting him for the offence.

Too Much Gloom?

Youriel Roubini thinks the global economy is "lurching toward an unprecedented confluence of economic, financial, and debt crises, following the explosion of deficits, borrowing, and leverage in recent decades." Is he right?

At the risk of sounding Panglossian, I do not regard such a disaster scenario as inevitable, or even as the most likely outcome. Turkey and a few other countries afflicted with severe macroeconomic and regulatory mismanagement will almost certainly suffer the fate Roubini describes, but most economies can still avoid a financial disaster and a deep recession

Yes, private and public debt as a share of GDP is near a peacetime high. At 334% as of the third quarter of 2022, this ratio is down from its 2021 firstquarter peak (363%), but way up from its 1991 first-quarter level (227%). Moreover, the slight reduction since early 2021 is due primarily to (unanticipated) inflation, not real GDP growth. The inflationary surge following the COVID-19 pandemic eroded the real value of nominally denominated fixed-rate debt - a reminder that unanticipated inflation is always the debtors' best friend.

Nonetheless, the risk-free real interest rate across most advanced economies is close to an 800-year low, and the consensus estimate of the risk-free neutral real interest rate is 0.5%. That is comfortably below the current underlying

real GDP growth rate for most countries and the world as a whole. If the effective interest rate on the debt is persistently below the GDP growth rate, Ponzi finance remains feasible and worries about debt sustainability are moot.

The question is whether and how long these conditions will last. After all, the empirical drivers of global real interest rates – never mind the unobservable neutral real rate - are poorly understood. In a recent study of long-maturity real interest rates over the past 700 years, Kenneth Rogoff, Barbara Rossi, and Paul Schmelzing conclude that neither demographics (old cohorts saving less and driving up real rates) nor productivity (higher gains boosting real rates) are the causal drivers of global real rates.

Likewise, former US Secretary of the Treasury Lawrence H. Summers' famous "secular stagnation" hypothesis never made much sense as an explanation for low global real interest rates since the early 1980s. There has been no global stagnation over the past 40 years. Moreover, it remains to be seen how investment demand will be affected by technological advances in artificial intelligence, machine learning, automation, robotics, biotechnology, fin-

tech, and decentralised finance. The best we can do is to welcome the low neutral real rate without pretending to understand it.

Looking ahead, the component of inflation that is due to aggregate supply shocks (rather than to monetary and fiscal stimulus) is likely to be transitory. There also is not yet any evidence to suggest that medium- and longterm inflation expectations are becoming unanchored from the target rate of inflation. Russia's war in Ukraine will end sooner or later, and most likely without a nuclear escalation. Whenever that happens, the subsequent easing of Western sanctions will produce a disinflationary shock.

Moreover, China is rapidly phasing out its zero-COVID policy. Though this is already resulting in a wave of infections – a problem made worse by the government's refusal to use the more effective Western vaccines - the net effect on Chinese economic activity and key global supply chains is likely to be positive. In the United States, continued moderate monetary-policy tightening will slow the economy, but the likely effect will be a growth recession. rather than outright contraction. Similarly, although Europe has been hit harder than the US by the fallout from Russia's war, the European Central Bank's response to higher inflation has been even less aggressive than the US Federal Reserve's, again leaving a growth recession as the most likely scenario. The big loser among advanced economies is the United Kingdom - an economic mess whose external problems have been exacerbated by self-inflicted wounds such as Brexit, various regulatory failures, and an absurd demonstration of fiscal irresponsibility by Liz Truss's short-lived government.

As for Roubini's warning about the likelihood of a financial crisis, it bears mentioning that banking-sector balance sheets in most advanced economies are in better shape than they were at the time of the 2007-09 global financial crisis, and that supervision over much of the non-bank financial sector is much improved. While regulation has failed miserably in the crypto world, that industry's inevitable meltdown has been largely self-contained.

Across the advanced economies and China, monetary authorities are ready and able to monetise future deficit-financed fiscal stimulus should a recession become imminent. From February 2020 onward, central banks dealt effectively with what could have become a first-order financial crisis, by acting as lenders of last resort (including through liquidity swap lines) and market makers of last resort. That outstanding performance makes me confident of their readiness for the next potential crisis. Helicopter money monetary financing – will work again.

Moreover, even fiscally challenged governments that don't have access to monetary financing or external support are not completely without options. The balanced budget multiplier (higher public spending or a selective tax cut increases national income if paid for with appropriately selected higher taxation) can come to the rescue. For example, because low-income households tend to spend a greater share of their incremental income than highincome households do, a tax cut benefiting the poor, and paid for with a tax increase on the rich, should boost total spending on goods and services. So, too, would an increase in public spending on real goods and services (such as a boost to green infrastructure investment – assuming sufficient shovelready projects are available), financed with a tax increase on the well-off. Resource utilisation, broader socioeconomic efficiency, and distributive fairness would all point in the same direction.

Almost everything is possible; but not everything is likely. I, for one, do not anticipate a Roubini-size global financial and macroeconomic disaster in the foreseeable future.



THE PANDITS **AWAIT JUSTICE. DON'T EXPLOIT** THEIR PAIN. **KEEP THEM OUT OF VOTE BANK POLITICS**

√he recent controversial statement made by the Israeli filmmaker Nadav Lapid on Agnihotri's directorial film, The Kashmir Files, at the closing ceremony of the 53rd International Film Festival of India in Goa has once again brought the issue of Kashmiri Pandits into the limelight. The film was one of the highest grossers this year and was based on the persecution of the minority Hindu Kashmiri Pandits by the radical Islamists in the Kashmir valley. Irrespective of whether the film is 'propaganda' or not, the main talking point should be about the plight of the Pandits, who were forced to leave their homeland and in fact became refugees in their own country.

To be very fair, let's not beat around the bush by denying the bitter fact that Kashmiri Pandits were targeted and continue to be targeted by the Islamic terrorist groups because of their Hindu identity. The main agenda of these groups, backed by Pakistan, has alwavs been to make the Valley completely Islamic. It is only the Leftists and liberals who have chosen to ignore this basic issue, often viewing it through the lens of it being one of the Indian government versus the terrorists and even sought to portray the persecution of Kashmir Pandits as mostly "a migration issue.

Unfortunately, even in the mainstream media, the Pandits' persecution in the Valley was largely ignored. This may be a probable reason that a low budget film like The Kashmir Files, hit the box office as it dramatises the persecution of the Hindu Kashmiri Pandits in a Muslim-majority region. More so, as the film also aids the Hindutva agenda of the BJP, and portrays the minority community as villains. It did come as a surprise that the film found a mention by none other than Prime Minister Modi.

That the government of India and Jammu and Kashmir administration failed to stop the persecution and exodus of the Pandits from the Valley is a bitter truth. When the Kashmiri Pandits started fleeing the Valley, the then Prime Minister was VP Singh heading the National Front government, surviving on outside support of both the BJP and Left Front. While talking about the exodus of Pandits,

the Left-liberals do rightly point out that at that time Singh's government was supported by the BJP, but they remain silent on the fact that the same government was also supported by the Left Front.

However, the situation in the Valley started to turn worse much before 1989. In the 1986 communal riots, not so common before then, the minority Hindus and their temples were targeted in the Valley, particularly in the southern areas such as Anantnag. The Congress was in power at the Centre then with Rajiv Gandhi as Prime Minister. So passing on the blame to VP Singh's government alone for the exodus would not be completely right.

Coming to the present regime, the Narendra Modi-led NDA government at the Centre revoked Article 370 three years ago in August 2019, thus removing the special status that Jammu and Kashmir enjoyed. Not only did the BJP eventually act on its poll manifesto of removing the contentious article, but Home Minister Amit Shah justified it saying the move would drastically improve the situation in the Valley and peace would finally return after three decades of insurgency.

True, there have been some positive changes, such as stone pelt-

ing incidents on the Indian armed forces have become incidents of the past. With Governor's rule, guess the stone pelters haven't got the political support they did earlier. Or rather that with senior leaders of parties in the Valley having been put under house arrest for months, has led to a chilling effect on the populace.

Terrorist incidents have gone down. Still, the bitter reality is that the minority Kashmiri Pandits who chose to stay back in the Valley continue to live under nagging fear. Recently, a blog linked to The Resistance Front (TRF), an offshoot of the Lashkar-e-Taiba (LeT) published a list of 56 Kashmiri Pandit employees working under the PM's rehabilitation package, to unsettle them. Indeed, terrorists are again targeting the Hindus in the Valley -- minority Kashmiri Pandits and the migrant workers -- in a very well-planned manner to puncture the Centre's claim that "peace has returned to the Valley.

According to data provided by Minister of State for Home Affairs Nityanand Rai to Parliament, 14 persons belonging to minority communities, including three Kashmiri Pandits, have been killed in J&K this year so far. In all, 180 terrorists, 31 security personnel and

31 civilians were also killed in 123 terrorist incidents this year so far. He said various steps such as group security in form of static guards, day and night area domination, round-the-clock nakas at strategic points among others, have been taken to protect lives of minorities. Plus, under PM's Development Package, 2015, "3,000 government jobs for Kashmiri migrants have been created of which. 2,639 have been appointed in the last five years.

Though the abrogation of Article 370 has completed the integration of J&K into India, this hasn't gone well with neighbour Pakistan, Out of frustration, Pakistan-backed Islamic terrorists have now chosen to target the Hindus again in the Valley to scuttle the Centre's plan to usher in normalcy. More so, as the Centre has been making plans for the return of the Pandits and their rehabilitation. The numbers are small, and the security plan does not evoke confidence, even three years after scrapping of Article 370. In fact, even those recruited by the government have been protesting to relocate them

to Jammu instead. The Centre's promises to provide a secure environ doesn't have too many takers. The recent leaked list of Kashmiri Pandits working in the Valley also suggests there are sympathisers within the system, aiding the terrorists. It was the case then and little has changed. Besides, there were claims of holding business summit in Kashmir and wooing business houses to set up industries. The ground reality suggests otherwise, barring that this summer tourists did go back to Kashmir.

The Modi government is in power at the Centre for past eight years. Instead of using persecution of Kashmiri Pandits by radical Islamists for winning elections. it would be better for the BJP to usher in real change in the Valley. The party should move beyond the film and make genuine endeavour to deliver its promises of the return of Pandits to the Valley When in Opposition it demanded their safety and promised to do so if voted to power. It must deliver now. The Pandits await justice. Don't exploit their pain. Keep them out of vote bank politics.



A statement uploaded on the apex court website said: "The Supreme Court Collegium in its meeting held on 13 December 2022 has resolved to recommend elevation of the following Chief Justices Judges of the High Courts, as Judges in the Supreme Court: Justice Pankaj Mithal, Chief Justice, Rajasthan High Court (par ent high court (PHC): Allahabad); Justice Sanjay Karol, Chief Justice, Patna High Court (PHC: Himachal Pradesh); Justice P.V. Sanjay Kumar, Chief Justice, Manipur High Court (PHC: Telangana); Justice Ahsanuddin Amanullah, Judge, Patna High Court; and Justice Manoj Misra, Judge, Allahabad

High Court". Justice Dipankar Datta was Monday sworn in as a judge of the Supreme Court. CJI Chandrachud administered the oath of office to Justice Datta on the apex court premises, in presence of all apex court judges, lawyers, and family members.

With this, the working strength of the apex court rose to 28 as against its sanctioned strength of 34.

Kerala Assembly passes Bill to remove **Governor as Chancellor**

Thiruvananthapuram, Dec 13: The Kerala Assembly proceedings Tuesday saw high drama as it passed the Bill to replace the Governor as the Chancellor of universities in the State and appoint eminent academicians in the tor post, while the opposition UDF boycotted the House over non-acceptance of its suggestions regarding the bill.

"The University Laws (Amendment) Bill is passed, Speaker A N Shamseer said. The bill, which had undergone scrutiny by a Subject Committee of the House, was passed after hours long discussions during which the Congress-led UDF said it was not opposed to the removal of the Governor as Chancellor.

It said that it wanted retired Supreme Court judges or former Kerala High Court chief justices to be considered for appointment at the helm of universities. The opposition also said there need not be different chancellors for each of the universities and the selection panel should comprise the Chief Minister, Leader of Opposition (LoP) and the Kerala High Court Chief Justice.

The UDF said one Chancellor for all universities was sufficient as day-to-day activities would be handled by the respective Vice Chancellors. However, state Law Minister P Rajeeve said that a judge cannot be a part of the selection panel and the Speaker would be a better option.

He also said that the government has not decided how many chancellors there would be, but laws of each university regarding appointment of Chancellor need to be amended."The number of chancellors can be decided later," he said.

Rajeeve's suggestion regarding the selection panel was accepted by the opposition subject to the condition that retired judges are appointed as Chancellor. The minister, however, said that retired judges cannot be the sole option for being appointed at the helm of universities.

New Delhi, Dec 13: No one can capture an inch of Indian land till the Narendra Modi government is in power, Home Minister Amit Shah said Tuesday and claimed the actual reason behind the Congress disrupting Lok Sabha proceedings was not the clash between Indian and Chinese soldiers but a question on the cancellation of FCRA registration of the Rajiv Gandhi Foundation (RGF).

Shah said if the Question Hour, which was a washout following the opposition's protest, had continued, then he would have told the House that the RGF's Foreign Contribution (Regulation) Act (FCRA) registration was cancelled as it got ₹1.35 crore from the Chinese embassy for research related to development of the Sino-India relationship while its registration is for social work.

In a swipe at the Congress, Shah said since the RGF might already have conducted the research, have it included the issue of the occupation of thousands of hectares of Indian land by China in 1962? "If research is conducted on this subject then what is the outcome of it," he told reporters.

Seeking to turn the tables on the Congress as the opposition party has been targeting the Modi government over its handling of the border dispute with China, the home minister claimed India lost its membership of the United Nations Security Council because of the personal relationship its leaders had with foreign leaders.

He asked whether the party also researched issues like Jawaharlal Nehru "sacrificing" India's seat in the United Nations Security Council, denial of visa by China to the then Chief Minister of Arunachal Pradesh Dorjee Khandu and issuing of staple visa to residents of Jammu and Kashmir.

He also said the RGF headed by Congress leader Sonia Gandhi received ₹50 lakh from Zakir Naik, founder of the Islamic Research Foundation (IRF), which was banned by the government for its alleged involvement in terrorism. On the border issue, the minister

made it clear that the "BJP government will not allow any incursion on land. We will not leave an inch of land. The bravery shown by soldiers is appreciable, they have saved our land". Recalling that China had raised questions about then Prime Minister Manmohan Singh's visit to Arunachal Pradesh on October 13, 2009, he asked if the party carried research on the issue.

24.3% of POCSO cases in Assam, Maha, WB were 'romantic' relationships: Analysis

New Delhi, Dec 13: Of the 7,064 POCSO judgments between 2016 and 2020 from Assam, Maharashtra, and West Bengal, 1,715 cases (24.3 per cent) involved "romantic relationships", according to a new

Enfold Proactive Health Trust, with support from UNICEF India, analysed the 1,715 judgments by Special Courts in Assam, Maharashtra, and West Bengal that entailed an express reference to a romantic relationship between

the victim and the accused. In the majority of cases -- 1,058 or 61.7 per cent -- the Special Court expressly concluded that the relationship between the accused and the girl was consensual in nature

or that they were having a "love affair"

This included 131 cases (7.6 per cent) where the Special Court concluded that the relationship was romantic, but it was denied by the girl or she was silent about it, it said. Of the 7,064 judgments under

the Protection of Children from Sexual Offences Act registered between 2016 and 2020 and available on e-courts from Assam, Maharashtra, and West Bengal, 1,715 (24.3 per cent) "romantic" it said. Informants in "romantic" cases were predominantly the parents (70.8 per cent) and relatives (9.4 per cent) of the girls who together constituted 80.2 per cent of the informants. Girls were informants in 18.3 per cent cases.

The research was initiated in May 2021 and completed by April 2022.

The quantitative and qualitative analysis of the judgments was undertaken to gain an in-depth understanding of the manner in which "romantic" cases enter the criminal justice system, the profile of informants and "victims", nature of charges applied in such cases, and the trends in testimony of the "victims" and its correlation with the outcomes.

The analysis also focuses on the diverse approaches taken by the Special Courts in such cases, particularly their views on "consent" by minors. In 314 cases (18.3 per cent), girls lodged the complaint in a "romantic case", for reasons such as the accused's refusal or breach of promise to marry the girl (155 cases), and forced sex or kidnapping

in 154 cases. Other factors included pressure from family or community to lodge a case (52 cases); sexual harassment, which included stalking bythe accused (24 cases), and other forms of violence (14 cases).


Will repeal PSA if **NC wins: Omar**

Srinagar, Dec 13: Former Jammu and Kashmir chief minister Omar Abdullah Tuesday said the National Conference will repeal the controversial Public Safety Act (PSA) if it forms the government in the Union Territory after the Assembly elections. He also termed as unfortunate the face-off between the armies of India and China in Arunachal Pradesh and said the two countries should work together to improve their relations.

"They (Centre) have only kept those (old) laws here which can be used to harass people. There is no (Public) Safety Act anywhere in the country...It is only in Jammu and Kashmir. I have said it earlier and I repeat when the National Conference government comes, on the first day, this law will be repealed," Abdullah told party workers at Dooru in Anantnag

While the Centre did away with a large number of laws passed by the Jammu and Kashmir Assembly after the abrogation of Article 370 and the reorganisation of Jammu and Kashmir in 2019, the PSA was one of the few laws that were retained. Abdullah said the abrogation of Article 370 will be an issue in the Assembly elections in Jammu and Kashmir, which will be held for the first time after the Centre's August 2019 move. The schedule for the elections has not been announced vet

"It is obvious that this election will not be contested merely on bijli, sadak, pani (electricity, roads





Chief Minister said his party will take every step to protect the identity and interests of the people of Jammu and Kashmir. He accused the Centre of taking away the resources and jobs of local people by bringing outsiders in the Union territory.

"The mineral extraction contracts are given to outsiders...Even the postman who delivers letters will be brought in from other places. Our youth are not deemed fit for these jobs," Abdullah claimed. "I would have had no objection to these things but then they should take our youth and give them jobs in Haryana, Punjab, UP and other states. They should allow our contractors to do mining in Punjab. But they won't do it," he added.

All sub-registrars in Delhi to be women

The sub-registrar offices are responsible for land registry - sale, purchase and lease, registration of properties, sale deeds, issuing share certificates, marriage registrations, issuing of caste certificates, income certificates, verification of documents and other services that have a direct bear ing on the common people, it said.

Through an earlier order, six women SRs had been appointed, in the latest order issued Monday another 16 women officials have been selected and appointed as SRs in the remaining 16 SR offices, thereby taking the total number to 22. Earlier, the chief secretary, following Saxena's directions, had also appointed a woman Officer on Special Duty (OSD) on October 8 for developing an 'e-platform' to ensure that all SR offices become faceless and the services be provided to the people through the online mode.

23378789 and 011-23370560) have also been issued by the Delhi Urban Shelter Improvement Board (DUSIB).

After reviewing the plan with senior officials of various departments Tuesday, Deputy Chief Minister Manish Sisodia said, "To ensure that no one is left out in the cold during the peak winter

season, the government has established food and lodging facilities for homeless people across 195 shelter homes which have the capacity of accommodating over 17,000 people." Those willing to help the homeless to be rescued can call on the helpline numbers issued by DUSIB or access the 'Rain Basera' app. Fifteen rescue teams have also been formed -- each equipped with one vehicle, for surveillance and rescuing the homeless.

"So far over 1,500 homeless people have been rescued by the DUSIB teams in the past few weeks. On receiving information from the DUSIB control room or from any other sources, the rescue teams pick up the homeless from the identified location and take them to the nearest shelter home," a DUSIB official said. The existing 195 night shelters for the homeless in Delhi include 19 for families, 17 for women, four for drug addicts and three recovery shelters. The facilities provided to the people in these government shelter homes are food, lodging, lockers, three meals per day, free medicines, and am-

bulance, among others. People staying at the shelter homes can also avail the free medical services at any Mohalla Clinic.

Smoke intrusion from farm fires in Oct-Nov lowest in four yrs: CSE

New Delhi, Dec 13: Not only have the number of farm fires in Punjab and Haryana this season been the lowest since 2016, the national capital also witnessed the least smoke intrusion from stubble burning during October-November in four years, according to a Centre for Science and Environment analysis.

Analysis of data from SAFAR, the Union Ministry of Earth Sciences' air quality forecasting agency, shows that smoke from farm fires contributed to PM2.5 pollution in Delhi on 53 days this year, starting October 12.

The figure is lower than the previous three years when smoke intrusion was reported on 56-57 days but higher than the 2018 reading of 48 days.

The highest contribution this year was 34 per cent on November 3. Last year, the share of farm fires in Delhi's PM 2.5 pollution peaked to 48 per cent November 7.

The Centre for Science and Environment (CSE) said stubble burning-related smokefall over Delhi depended on two major factors -- the number and intensity of farm fires and meteorological conditions conducive for the transportation of the smoke to the na-

tional capital. This October-November, not only have the quantity and intensity of farm fires been comparatively lower but also the meteorological conditions less conducive for transport of the smoke, the green think tank said. The CSE estimated that smoke from farm fires accounted for 4.1 tonnes of PM2.5 during October-November in Delhi. This is 37 per cent lower than 6.4 tonnes of PM2.5 from stubble burning last year and almost half the 2020 figure (8 tonnes).

The volume this year is also significantly lower than the 2019 figure (6.4 tonnes) – an indicator of the meteorological help Delhi got as there were fewer farm fires in 2019.

Jammu hoteliers concerned over loss of business



Bhopal/Damoh, Dec 13: Congress leader and former Madhya Pradesh minister Raja Pateria was arrested Tuesday morning for his controversial 'be ready to kill Modi to save the Constitution' remark about the prime minister.

He was produced in a court at Pawai in Panna district which refused to grant him bail and sent him in 14-day judicial custody, said his lawyer Govind Narayan Baghel. They will file an appeal in the higher court, the lawyer added. The state Congress, meanwhile, issued a show-cause notice to Pateria, terming his remarks as extremely objectionable.

Pateria was arrested by the police from his residence in Hata town in Damoh district. "A police team went to his house around 5.30 am to inform him about the arrest. They took him to Pawai (in Panna district) around 7 am," Hata sub divisional officer of police Virendra Bahadur Singh said.

MP Home Minister Narottam Mishra said that two more Indian Penal Code (IPC) sections - 115 and 117 -- were added to the First Information Report (FIR) registered against him. Section 115 deals with 'abetment of offence punishable with death or imprisonment for life if offence not committed', and 117 deals with 'abetting commis-

Pateria should not have been arrested as he immediately clarified that he was only talking about defeating Modi and also expressed regret, he said.

New Delhi, Dec 13: Trinamool Congress MP Mahua Moitra Tuesday cited government data showing industrial contraction to question the Centre's handling of the economy and asked "who is the 'Pappu' now?

Participating in a debate in Lok Sabha on demands for additional grants for 2022-23, the firebrand TMC leader said, "This government and the ruling party coined the term Pappu. You use it to denigrate and signify extreme incompetence. But the statistics tell us who the actual Pappu is."

Moitra accused the Narendra Modi government of spreading "falsehood" about India's growth and appealed to Finance Minister Nirmala Sitharaman to take control of the economy, which, according to the TMC leader, is going downhill.

Referring to the latest data released by the National Statistical Office (NSO), Moitra claimed that while the country's industrial output shrunk by four per cent in October to a 26-month low the manufacturing sector, which is "still the biggest generator of jobs", contracted by 5.6 per cent.

'Seventeen of the industry sectors that make up the Index of Industrial Production (IIP) have recorded negative growth. Forex reserves have fallen by 72 billion dollars in under a year," she said. The manufacturing sector's output declined by 5.6 per cent in October 2022 as against a growth of 3.3 per cent recorded in the year-ago month, according to the IIP data released by the NSO.



US storm brings tornado warnings

Sioux Falls (US): Much of the central US from the Rocky was braced Tuesday for blizzard-like conditions, while states farther to the south saw tornado warnings from a massive storm blowing across the country. An area stretching from Montana into western Nebraska and Colorado was under blizzard warnings, and the National Weather Service said that as much as 2 feet (61 cm) of snow was possible in some areas of western South Dakota and northwestern Nebraska. Meanwhile, ice and sleet were expected in the eastern Great Plains.

Earthquakes hit Bali Island

Denpasar (Indonesia): A moderately strong earthquake and two aftershocks hit Indonesia's resort island of Bali Tuesday. causing panic but no immediate reports of damage or casualties. The US Geological Survey said the magnitude 4.9 guake was centred 35 km (22 miles) north of Amlapura, a city in Bali's Karangasem district. Its shallow depth of 9.6 km (6 miles) may have caused people to run outside.

India signs MoUs for **3 projects with Nepal**

Kathmandu: India Tuesday signed Memorandum of Understandings (MoUs) with the Nepal government worth more than Rs 101 million for fast-tracking three projects in education, healthcare sectors and for providing safe drinking water in the Himalayan nation. The implementation of these projects reflects the continued support of the Indian government in bolstering efforts of the Nepal government in upliftment of its people, the Indian Embassy here said.

Paris, Dec 13: Dozens of countries and international organisations threw their weight and hundreds of millions of euros (dollars) behind a fresh and urgent push Tuesday to keep Ukraine powered, fed, warm and moving amid the onset of winter, responding defiantly to sustained Russian aerial bombardments that have plunged millions into the deepening cold and dark by targeting critical infra-An international donor confer-

ence in Paris quickly racked up pledges of financial and in-kind support for Ukraine's beleaguered civilian population to survive freezing temperatures and long nights. It also heard impassioned arguments from Ukraine's president that such help could pressure Russia into suing for peace. There was also strong condemnation from donors of the Kremlin's savaging of civilian targets. French President Emmanuel Macron, the conference host, denounced Moscow's bombardments of civilian targets

as war crimes. He said the Kremlin is pounding civilian infrastructure because its troops suffered setbacks on the battlefields and their "military weaknesses have been exposed to all."

Russia "has chosen a cynical strategy, aiming to destroy civilian infrastructure in order to put Ukraine on its knees," Macron said. "The objective is clear: Respond to military defeats by spreading terror among civilians, try to break the back as it can't maintain the front."

Successive waves of cruise missiles and exploding drones have destroyed about half of Ukraine's energy infrastructure, the Kyiv government has said. Ukraine's Prime Minister says Russia is trying to create a fresh wave of refugees to Europe. Russia says that by striking civilian infrastructure, its military aim is to weaken Ukraine's ability to defend itself and to disrupt the flow of Western weapons to the invaded country.

Ukrainian President Volodymyr Zelenskyy, who addressed the Paris conference by video link, said some 12 million Ukrainians — roughly one-quarter of the country's population before Russia launched its full-scale invasion in February were living with power outages.

Zelenskyy argued that a concerted international effort to keep Ukraine's utility systems working could help dissuade Moscow from further attacks and potentially force it to the negotiating table, and also prevent new waves of Ukrainians fleeing to elsewhere

FTX founder charged with fraud

New York/Nassau, Bahamas, Dec 13: US federal prosecutors Tuesday alleged Sam Bankman-Fried committed fraud and violated campaign finance laws, and the founder and former CEO of FTX also faced additional charges by US regulators.

In the indictment, prosecutors said Bankman-Fried had engaged in a scheme to defraud FTX's customers by misappropriating their deposits to pay for expenses and debts and to make investments on behalf of his crypto hedge fund, Alameda Research LLC.

A lawyer for Bankman-Fried did not immediately respond to a request for comment on the criminal charges

He also defrauded lenders to Alameda by providing them with false and misleading information about the hedge fund's condition, and sought to disguise the money he had earned from committing wire fraud, prosecutors said.

Both the US Securities and Exchange Commission (SEC) and the Commodity Futures Trading Commission (CFTC) alleged Bankman-Fried committed fraud in lawsuits filed Tuesday.

The CFTC sued Bankman-Fried, Alameda, and FTX on Tuesday, alleging fraud involving digital commodity assets.

Since at least May 2019, FTX raised more than \$1.8 billion from equity investors in a years-long 'brazen, multi-year scheme" in which Bankman-Fried concealed that FTX was diverting customer funds to its affiliated crypto hedge fund, Alameda Research LLC, the SEC alleged.

While the public believed Bankman-Fried's "lies" and sent billions of dollars to FTX, he improperly diverted customer funds to his hedge fund, the SEC said in a court filing. He continued to divert FTX customer funds even as it was increasingly clear that Alameda and FTX could not make customers whole, the SEC said.

CRYPTO INVESTORS LOST BILLIONS: FTX filed for bankruptcy November 11, leaving an estimated 1 million customers and other investors facing losses in the billions of dollars. The collapse reverberated across the crypto world and sent bitcoin and other digital assets plummeting. A spokesperson for FTX Debtors declined to comment. The SEC alleged Bankman-Fried exempted hedge fund Alameda from the risk mitigation measures he publicly touted, giving the firm special treatment and a "virtually unlimited line of credit' funded by the platform's

Chinese students return home amid fears of Covid spread

Beijing, Dec 13: Some Chinese universities say they will allow students to finish the semester from home in hopes of reducing the potential for a bigger Covid-19 outbreak during the January Lunar New Year travel rush.

It wasn't clear how many schools were participating, but universities in Shanghai and nearby cities said students would be given the option of returning home early or staying on campus and undergoing testing every 48 hours.

The Lunar New Year, which falls January 22, is traditionally China's busiest travel season

Universities have had frequent lockdowns in the past three years, occasionally leading to clashes between authorities and students confined to campus or even their dorm rooms.

With so many people staying home, Beijing's downtown streets were eerily quiet Tuesday, giving it the feel of a voluntary lockdown. Restaurants were mostly closed or empty, as many businesses are having difficulty finding enough staff who haven't gotten infected. Sanlitun, one of Beijing's most popular shopping districts, was deserted despite having its anti-Covid fences taken down in recent days

Sino-India border situation 'generally stable': China

Beijing, Dec 13: China Tuesday said the situation was "generally stable" along its border with India. days after the troops of the two countries clashed in the Tawang sector of Arunachal Pradesh, resulting in minor injuries to some soldiers on both sides At a media briefing here, Chinese

Foreign Ministry spokesman Wang Wenbin said the two sides have maintained smooth communication on border-related issues through diplomatic and military channels. Wang, however, declined to provide details of the December 9 clash between Indian and Chinese soldiers at the Yangtse area of Arunachal Pradesh's Tawang sec-



tor. Earlier in the day. Defence Minister Rajnath Singh made a statement in Parliament in New Delhi on the incident in the Tawang sector. "The Indian Army bravely

prevented the PLA from encroaching on our territory, and forced them to withdraw to their posts. Some soldiers from both sides were injured in the skirmish," he said in his statement in Lok Sabha and Rajya Sabha.

The Chinese Defence Ministry has not reacted to the incident so far. Wang also said Beijing hopes that the "Indian side will work with us in the same direction and smoothly deliver the important common understanding reached by leaders of both sides.

"And act strictly on the spirit of relevant bilateral agreements signed by both sides and jointly preserve peace and tranquility in the border areas". It is the first major clash between the Indian and Chinese armies since the fierce face-off in the Galwan Valley in June 2020 that marked the most serious military conflict between the two sides in decades.

British Library celebrates India ties with exhibition on Hampi

London, Dec 13: The British Library in London is celebrating the 75th anniversary of India's independence with a special photographic exhibition on the UNESCO World Heritage Site of Hampi in Karnataka.

'Hampi: Photography and Archaeology in southern India' is made up of a display of photographs taken between 1857 and 1970 capturing the archaeological site of Hampi - the capital of the prosperous Vijayanagara kingdom established in the 14th century.

The display, enhanced by three works by celebrated photographer Raghu Rai, is devised as a lens on the archaeological legacy of Hampi

through the archives of the British Library and the research activities that have played a role in preserving the city's cultural heritage.

"An Italian traveller documented that this was the most extraordinary city in the world at the time," said Vikram Doraiswami, Indian High Commissioner to the UK, at a celebratory event for the exhibition in London Monday.

"It had the most amazing urban architecture, it was a developed, flourishing, prosperous city. Even today when you visit it, you need several days to take in the totality of Hampi...In this 75th year of India's independence, the High Commission is happy to work with the British Library, which holds so much that is wonderful



and gives us all an opportunity to be part of history and to be able to celebrate and share it in special ways," he said.

Tata Motors to hike prices

Bangalore: Tata Motors Ltd said Tuesday it would increase prices of its commercial vehicles by up to 2% from January to partly offset a steep rise in input costs. The company's third price increase in the commercial segment this year will be applicable across all vehicles, but vary across models and variants, it said in an exchange filing. "The company has been absorbing a significant portion of the increased costs, but the steep rise in overall input costs has compelled it to pass on some proportion through this minimal price hike," the company said. While prices of commodities such as steel and aluminium have corrected from highs this year, costs related to building vehicles such as trucks and buses are still elevated, analysts have said. The automaker has also raised prices of passenger vehicles four times so far this year.

Kotak arm raises **₹5,328 crore**

Mumbai: A Kotak Mahino Bank arm Tuesday announced it has raised Rs 5.328 crore to invest in infrastructure projects in the country. Kotak Investment Advisors Ltd (KIAL) is targeting to raise Rs 6,000 crore in total for the Kotak Infrastructure Investment Fund, and this is the maiden close for the platform, according to a statement. The fund will be focusing on infrastructure credit and this is the first time where a fund is being set up with significant commitments from global investors, the statement said. Majority of the Rs 5.328 crore fund in commitment has been made by the Canadian Pension Plan Investment Board (CPPIB). while the Asian Infrastructure Investment Bank (AIIB) has pitched in with a USD 100 million (about Rs 828 crore) commitment.

Gold ETFs log ₹195cr outflow

New Delhi: After attracting funds in October, gold exchange-traded funds (ETFs) witnessed a net outflow of Rs 195 crore last month primarily due to profit booking amidst a rally in the markets. In comparison, the segment had attracted a net inflow of Rs 147 crore in October and Rs 330 crore in September. Prior to that, gold ETFs saw a net withdrawal of Rs 38 crore in August, data with Association of Mutual Funds in India (Amfi) showed. "The latest outflow could be attributed to profit booking amidst the rally in the markets and gold demand in the households for the prevailing wedding season," Priti Rathi Gupta, Founder of LXME, said. While the fund inflow in October was mainly on account of festive season demand as investors might have chosen to buy physical gold.

Rupee records 6.9 per cent depreciation in current FY

New Delhi, Dec 13: The Indian rupee has witnessed a depreciation of 6.9 per cent in the current financial year till November 30, the Parliament was told Tuesday.

Exchange rate depreciation, other factors remaining unchanged, is likely to put upward pressure on prices of imported commodities and as a result, imported items becoming costlier. Minister of State for Finance Pankaj Chaudhary told the Rajya Sabha in a written reply.

"The overall impact on the domestic prices depends on the passthrough of import prices into the domestic prices. On the other hand. exchange rate depreciation is likely to enhance the country's export competitiveness. However, the nominal exchange rate is only one factor that determines the export competitiveness and cost of imports and hence, the overall trade balance. Hence, the impact of movements of the exchange rate on the trade balance and also on other components of the current account balance cannot be isolated." he said.

Chaudhary also said that the value of the Indian rupee is market-determined.

"As global spillovers from geo-po-



litical tensions and aggressive monetary policy tightening across the world intensified alongside a surge in crude oil prices, the US dollar strengthened by 7.8 per cent in the financial year (till November 30. 2022). While the rupee has depreciated in the current financial year, it has performed better than most Asian peer currencies, including the Chinese renminbi (10.6 per cent), Indonesian rupiah (8.7 per cent), Philippine peso (8.5 per cent), South Korean won (8.1 per cent), Taiwanese dollar (7.3 per cent) etc

during the financial year," he said.

The Reserve Bank of India (RBI) closely monitors the foreign exchange markets and intervenes only to maintain orderly market conditions by containing excessive volatility in the exchange rate, without reference to any pre-determined

target level or band, he said. The minister also gave details of measures taken by the Reserve Bank of India, saying: "The RBI had announced various measures in the recent period to diversify and expand the sources of forex funding to mitigate exchange rate volatility and dampen global spillovers."

Nifty could post 5% gains next yr: Report

This would be the benchmark index's slowest growth in 5 years, according to BofA Securities

Bangalore, Dec 13: India's benchmark Nifty 50 index will rise roughly 5% next year, which would be its slowest growth in 5 years,

BofA Securities estimated, but also said Indian stocks were a good bet if a global recession struck.

BofA Securities expects the bluechip index to close at 19,500 points next year, while continuing to be

volatile and trade between 17,000 and 20,000 levels for the year.

The Nifty 50 index is up slightly more than 7% at 18,584 so far in 2022, after three straight years of double-digit growth. This year has also been volatile with the index swinging between a low of 15,183.40 to a record high of 18,887.60.

BofA Securities advised buying any dips at around 17,000 levels, saying India's economic growth and equities are less impacted during a recession and recover faster after one.

"Indian markets deliver much higher returns against the U.S, 12 months post a recession," BofA Securities said, based on an analysis of the past three U.S. recessionary cycles.

Even valuations are unlikely to contract below the long-term average, said BofA, as domestic investors could see \$20 billion in inflows from pension, provident, insurance funds and systematic investment plans.

And with foreign institutional investors (FII) ownership of Indian

equities at a multiyear low of 18% now, the potential for incremental outflows from FIIs is limited, it added.

In fact, there could be inflows into emerging markets as the U.S. Federal

Reserve could be forced to start cutting interest rates early if there is a pronounced downtrend in consumer price inflation, BofA Securities said.

BofA analysts remain overweight on sectors like financials, industrials, staples, utilities, metals and cement, and underweight on IT, healthcare, consumer discretionary and autos.

Meanwhile, Samir Arora. founder and fund manager at Helios Capital, expects Indian equity markets to revert towards a long-term trend of 10%-15% returns on average in rupee terms next year.

India's real rates turn positive as inflation eases: Analysts

Mumbai, Dec 13: India's real interest rate has turned positive after headline retail inflation eased below 6% for the first time this year, analysts said, suggesting that the peak policy rate is

now close The RBI has hiked repo rate by 225 basis points since May, taking the terminal rate to 6.25%, to curb inflationary pressures. Inflation had stayed above the central bank's repo rate for this year, implying a negative real

"India returned to a positive

real policy rate in Nov, 2022, and this month's 35bp (basis point) rate hike to 6.25% has moved the real (inflation-adjusted) reporate even more emphatically into positive territory," Prasenjit K. Basu, chief economist at ICICI Securities wrote in a note.

'We retain our view that the Dec, 2022 rate hike was the last one for FY23 (fiscal year 2023), and the next policy action by the Reserve Bank of India (RBI) will entail a rate cut of 25bp.

India's retail inflation was at 5.88% in November, as against 6.77% in the previous month, surprising analysts who had pre-



dicted the reading at 6.40%. Inflation had stayed above the central bank's target for 10 straight months to October.

While the central bank does not target real rates, most analysts expect it to try keeping the inflation-adjusted rate at close to 1% to support growth.

This would mean that the central bank will be ready to pause rate hikes as inflation is seen easing towards 5% in the first quarter of 2022/23, implying a real rate of above 1%

While the economic research division of State Bank of India believes that the chances of a rate hike are minimal in February, Nomura lowered the probability to 60% from 70% previously, reiterating that it remains a close call.

Deutsche Bank also expects the central bank to pause at its next meet and has raised the prospects of the central bank cutting rates from December. The bank lowered its inflation

forecast for the financial year by 40 bps to 6.5% soon after the November inflation data was released, saying the rate hike cycle has ended.

The RBI will pause any policy action between now and September, when it will cut the repo rate, ICICI Securities' Basu said. "Amid a global tighteningof monetary policy, the RBI would be wary of easing sooner."



Giant-killers' gigantic test

Doha, Dec 13: Morocco's improbable, history-making run at the World Cup is about to get its ultimate test. Africa's first World Cup semifinalist is playing defending champion France and its star striker Kylian Mbappe, the leader of a new wave of soccer superstars coming out of an era dominated by Lionel Messi and Cristiano Ronaldo.

Wednesday's match has cultural and political connotations — Morocco was under French rule from 1912-1956 — and the outcome is far from the foregone conclusion many would presume by looking at the names of the players and the rankings of the teams.

Morocco have exceeded all expectations in Qatar by beating second-ranked Belgium in the group stage and then eliminating European powerhouses Spain and Portugal in the knockout phase to reach the semifinals.

No African or Arab nation have ever gotten this far. It is one of the biggest stories in the World Cup's 92-year history and Morocco are not

"I was asked if we can win the World Cup and I said, Why not? We can dream, it doesn't cost you anything to have dreams," said Walid Regragui, Morocco's Frenchborn coach. "European countries are used to winning the World Cup and we have played top sides, we have not had an easy run. Anyone playing us is going to be afraid of us now." The defending champions have just passed their own big test by coming through a tough quarterfinal match against England, on a rare occasion when Mbappe was kept quiet.

No player has scored more than his five goals and it won't be easy for Mbappe to add to that tally against Morocco, which has yet to concede a goal to an opposition

player at this World Cup - or indeed in its nine games since Regragui was hired in August The only goal allowed was an own-goal by its defender, Nayef Aguerd, against Canada in the group stage.

Morocco might have some injuries now - Aguerd and fellow center back Romain Saiss could be missing Wednesday — but Regragui's game plan relies on team shape and discipline more than any specific individual. The Morocco coach said his team

is ready to "change the mentality" of Africa, and he's told his players not to settle for anything less than the top prize. Regragui said defender Achraf

Hakimi is looking forward to a 'nice duel' with Mbappe, his teammate at Paris Saint-Germain, but added that France doesn't just depend on its star player.

The key to winning the game, he said, will be Morocco's 'team spirit' and the support of the crowd at

Al Bayt Stadium, where French President Emmanuel Macron is set to be in attendance along with tens of thousands of green-and red-clad Morocco fans. It will feel like a home game for Morocco's players, which might level things up even more.

France start as the big favourites, though, because of their star quality and experience. In Mbappe and Antoine Griezmann, a forward who has reinvented himself as a midfield playmaker at the World Cup, the team has two of the World Cup's leading players while Olivier Giroud's winner against England took him to four goals — the same as Messi

They have attacking threats from everywhere and that intangible quality of just knowing how to get the job done. France center back Raphael Varane said there will be no danger of complacency among his teammates in a game against the World's No.22-ranked team.

India eye WTC final qualification

Chattogram, Dec 13: KL Rahul's tactical acumen will be tested along with his batting prowess when a depleted Indian team clashes with a tricky Bangladesh in the highstakes two-match series, the result of which will have an impact on India's chances for the World Test Championship final qualification.

India are currently fourth in the WTC table behind Australia, South Africa and Sri Lanka. The only way of qualifying for the final in June is to straightaway win both the Tests against Bangladesh and then all four at home against Pat Cummins' Australia to eliminate any ifs and buts.

The journey starts at the Zahoor Ahmed Stadium, which has traditionally favoured the batters but also offers some turn towards the business end of the match.

The visitors will start as overwhelming favourites in Test format, in which the Bangladesh is yet to beat India but the absence of Rohit Sharma, Jasprit Bumrah, Mohammed Shami and Ravindra Jadeja could hurt the side.



With most of the top Indian players already in one team or the other, out-of-favour national team players Mayank Agarwal and Manish Pandev at ₹1 crore base price will

command a fair bit of bidding. But the same cannot be said about veterans Ishant Sharma and Ajinkya Rahane, who have kept their going price at a modest ₹50 lakh, expecting to get a team or two raise the paddle for them.

One of the players who can cause a bidding war is South African batter Rilee Rossouw, who has been prolific on Indian tracks. Rising Englishman Harry Brook has kept his base price at ₹1.5 crore.
