JEE-Main in 2 parts, starts January 24

New Delhi: Engineering entrance exam JEE-Main will be conducted from January 24 to 31, except on Republic Day, the National Testing Agency (NTA) announced Thursday The second session of the exam will be held in April. Applications for the exam will be accepted from December 15 to January 12. The exams will be conducted in 13 languages. They are English, Hindi, Assamese, Bengali, Gujarati, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu. "For academic session 2023-24, it has been decided that JEE(Main)-2023 will be conducted in two sessions," Sadhana Parashar, senior director (Exams), NTA.

Smartphone ban for all entering Srimandir

POST NEWS NETWORK

Puri, Dec 15: The Shree Jagannath Temple Administration (SJTA) said Thursday after a meeting of its managing committee that a complete ban would be imposed on carrving smartphones inside the 13th century shrine here from next month. The restriction will come into effect from January 1, 2023.

A similar ban was earlier imposed only for devotees, but now the restrictions will be applicable for everyone, including police personnel, servitors and employees, the SJTA said. Servitors will also have to deposit their smartphones before entering the temple premises, the SJTA added.

"Special arrangements will be made for the safe custody of the phones," SJTA chief administrator Vir Vikram Yadav told reporters. "Officials and servitors, however, can carry basic mobile phones which don't have the features of photography and videography," he added.

The decision to ban smartphones completely within the temple premises was taken after photographs and videos of the Sanctum Sanctorum went viral on social media.

New Delhi, Dec 15: It seems that the war of attrition between the Union Law Ministry and the judiciary will continue for a substantial period even as cases continue to pile up across the country. Law Minister Kiren Rijiju fired a fresh salvo Thursday at the Supreme Court and said that the government has a very limited role in the appointment of judges. In other words, he indirectly blamed the Supreme Court Collegium for the delay in appointment of judges to the various high courts.

Rijiju was responding to a question in Parliament on the large number of pending cases when he doubled down on his criticism of the Collegium system of appointing judges. He said it was worrying that more than five crore cases are pending across India. The basic reason, the minister said, was the delay in appointment of judges.

"The government took many steps to reduce pendency of cases, but it has a very limited role in filling vacancies of judges. The Collegium chooses names, and apart from that, the government has no right to appoint judges,' Rijiju informed.

Rijiju said the government had often conveyed to the Chief Justice

Supreme Court had said November 28 that the Collegium system 'is the law of the land and the Centre has to follow it'. The top court had expressed anguish over the Centre not clearing names recommended by the Collegium to fill up the vacancies of judges.

A bench of Justices SK Kaul and AS Oka said a three-judge bench of the apex court had laid down the timelines within which the appointment process had to be completed and those timelines have to be adhered to by the Centre.

Odia girl stabbed to death in Gujarat

Surat, Dec 15: In what can be termed as a rerun of the Shraddha Walker murder case, an Odia girl has been murdered by her live-in boyfriend in this town of Gujarat. The body of the deceased, identified as Luni Das, was found lying in a pool of blood with multiple stab injuries near Anjani Industrial Estate here.

Luni, a resident of Bhuba had allegedly been in a relationship with the accused Jagannath Gouda for the last three years. When she insisted on marriage, Jagannath decided to eliminate her, police informed.

In the Shraddha murder case her boyfriend had chopped her body into pieces after strangling her. In this case Jagannath stabbed



Luni 49 times to ensure her death. Police said that Jagannath's action demonstrates the anger that he had towards Luni. The Crime Branch of this city zeroed in on the accused after examining over 500 CCTV footage and call details.

Police said that Jagannath had taken Luni to Surat from Bhubaneswar two weeks back. Initially he sweet-talked her to stay with him. Then he took her to a secluded place and stabbed the victim to death. He was so infuriated by the marriage demand that he stabbed her multiple times even

Cops get concrete proof against Aftab

New Delhi: Police have finally got some major material evidence in the murder case of Shraddha Walkar. A DNA test has confirmed that the bones that alleged killer Aaftab Poonawala led the cops to, in a jungle in Delhi's Mehrauli area and in Gurgaon, are of Shraddha's. Traces of blood found in their flat too match with hers says the test report, carried out by using DNA samples from her father. She had been killed in May by Aaftab who had then chopped her body into pieces before throwing them away.

"We have also learnt that he is a drug addict. He had developed the idea that Luni was mentally torturing him," Singhal said.

So far 32 persons have been arrested among whom are 23 lawyers, eight transgenders and a civilian. All the 32 have been produced in court and sent to judicial custody.

Police officials informed that in the days to come more arrests will be made as raids are continuing to apprehend culprits involved in the incident of vandalism.

Earlier, the Supreme Court held Wednesday that justification for having additional benches of the High Court in Western Odisha no longer exists as the use of technology has made the parameters obsolete.

Bhubaneswar, Dec 15: Sleuths of the Odisha Crime Branch has arrested a Nigerian national from Delhi for allegedly duping a woman in the state of ₹28.67 lakh, police said Thursday. The accused, identified as Patrick Chizorom Orajaka (35), was arrested from an apartment in Delhi. He was produced in a court in Delhi and has been brought on transit remand for four days to Odisha, an official of the Crime Branch said.

According to the official, the woman came in contact with the accused through Instagram and then subsequently started chatting on WhatsApp. After a few days, the Nigerian told the victim that he was coming to India to meet her.

However, the next day, the victim got a call allegedly from a Delhi customs officer who said that Orajaka has been detained for carrying 90,000 euros with him, which is against the rule. In order to get her friend freed, the victim deposited money in a phase wise manner in different accounts.

Later on however, she realised that she had been duped and filed a complaint. The police have seized 16 ATM cards, 12 mobile phones, 22 bank passbooks, 10 cheque books, 20 SIM cards, a laptop, passport and other documents from the accused.

Parties roll up sleeves for likely early elections

Bhubaneswar, Dec 15: Amidst a buzz in the state's political circle about an early election in Odisha, principal political parties-BJD, BJP and Congress - have rolled up their sleeves for a high-decibel fight.

Following a landslide victory in Padampur bypoll, the ruling BJD has planned to replicate the strategy in all the constituencies to ensure that the party comes out with flying colours in the next polls.

A crucial meeting of the BJD was held at Naveen Niwas here Thursday to review the Padampur by election result and discuss the future roadmap.

"Padampur bypoll has become a model for us as we won it with a huge margin. If the formula we have applied in Padampur is executed in other constituencies, we will get similar results," said BJD leader Pradeep Majhi.

Chief Minister Naveen Patnaik will visit Padampur next month to personally review the developmental projects, said senior BJD leader Prasanna Acharya. The BJD will make big plans for 2024, he said.

NHRC seeks reports on sewage tank deaths

Bhubaneswar, Dec 15: The National Human Rights Commission (NHRC) has issued notice to the Principal Secretary for the state Housing and Urban Development (H&UD) department, commissioner of Cuttack Municipal Corporation (CMC) and the twin city police commissioner seeking reports in connection with the death of two labourers while cleaning a sewage tank in Cuttack April 15, 2021.

While hearing a petition filed by rights activist Akhand, the commission directed the authorities to submit their respective enquiry reports within four weeks of the receipt of the report.

Akhand in his complaint demanded compensation to the victims and stringent action against erring officials holding the CMC authorities responsible for the unfortunate incident in which two poor daily wagers, P Shankar of Patapura area and Bishnu Nayak of Badamba area, perished.

The deceased were illegally engaged in manual scavenging to clean a sewage tank at CDA Sector 10 area in Cuttack.

The duo accidentally fell into the tank and sustained serious due to asphyxiation April 15, 2021. The next hearing on the matter will be conducted January 9, 2023.

Cops record statements of Anand Tappo's kin

She, however, expressed suspicion over the involvement of Lakra and Tappo's friend Manjeet Tete in her son's death. Police Monday questioned Lakra over the suspicious death. Tappo's father had also alleged during a presser that Lakra and Tete were involved in his son's murder.

Significantly, the Bill was passed by the Rajya Sabha in 2010 and sent to Lok Sabha. However, it could not be passed by the 15th Lok Sabha, Further, the Constitution amendment bill lapsed as the term of the 15th Lok Sabha ended.

Chandrani pitches for ST list modification

DJD Thursday sought inclusion of over 160 communities of the state in the Scheduled Tribes (ST) list. The party supported the Constitution (Scheduled Tribes) Order (Third Amendment) Bill, 2022, which seeks to modify the list of STs in Himachal Pradesh stating that it expands the possibility of inclusion of more tribes and sub-tribes under ST category. BJD MP Chandrani Murmu said that the tribal communities still need the constitutional status of STs, SCs and assistance under specific programmes. "They are being deprived of the benefits availed by other ST communities, though they have the same tribal chrematistics as their respective notified STs. Nine communities of Odisha have been recommended for inclusion in the ST list of the state on priority basis. They are: Bhokta Durua, Kalanga, Nakasia, Paba, Khandayat Bhuyan, Tamudia, Chapua Kamar and

Kandhia. But no clarity has been provided

on the progress of these proposals so far,"

On state government's own Biju Swasthya Kalyan Yojana (BSKY), the saffron party MPs said the scheme has limitation to cater to the tertiary healthcare needs of Odia people as it doesn't have a pan India portability/admissibility, enough number of empanelled hospitals, robust and fraud-free claim settlement process.

Despite having the State Health Insurance Scheme, most of the patients are being denied admissions to private hospitals even in the

state citing non-availability of beds. Also, Odisha is prone to distress migration which forces nearly 33.45 per cent of families in rural Odisha to migrate to other states in search of work. An estimated population of 1 crore Odias live outside the state for their livelihood, the MPs further

pointed out. Moreover, the government of India has recently announced that various state sponsored health insurance and benefit schemes can run parallelly. Bhubaneswar: The state Vigilance has booked 45 police officials including a Deputy Superintendent of Police (DSP) under various acts of corruption during January 1, 2017 to December 31, 2021. The Vigilance Directorate, in a reply to an RTI application filed by noted rights activist Biswapriya Kanungo, revealed that 43 corruption cases have been registered during the above period. New Delhi, Dec 15: India Thursday successfully test-fired nuclear-capable Agni-V ballistic missile having a range of over 5,000 km, marking a significant boost to the country's strategic deterrence, people familiar with the development said.

The test-firing of the missile from the Abdul Kalam Island off the Odisha coast came amid India's lingering border row with China.

Existing variant Agni-IV is capable of hitting targets at a range of 4,000 km while Agni-III has a range of 3,000-km, and Agni-II can fly up to 2,000-km.

The Agni-V missile has been successfully test-fired, two people familiar with the matter said.

There is, however, no official word on the test-firing of the missile. The test firing of the missile is part of the process for its induction into the tri-services strategic forces command



The people said the test validated a number of critical aspects of the weapon.

In June, India successfully carried out a night launch of the nuclear-capable Agni-IV ballistic missile, in a boost to India's military capabilities. India has been steadily enhancing its overall military might in the last couple of years.

It has carried out successful tests of a number of missiles during the period.

In May, the extended range version of the BrahMos supersonic cruise missile was test-fired from a Sukhoi fighter jet.

It was the first launch of the extended range version of the BrahMos missile from a Su-30MKI aircraft. An anti-ship version of the BrahMos supersonic cruise missile was successfully test-fired jointly by the Indian Navy and the Andaman and Nicobar Command in April.

Death of six newborns in a fortnight rocks Borigumma

Borigumma, Dec 15: The back-to-back deaths of five newborns within a fortnight and the latest death of another Wednesday have sparked concern among the residents in villages under Borigumma block of Koraput district.

Newborns' deaths are increasing with each passing day. It is alleged that they are dying due to lack of proper care and treatment at the mother and child health centre. Their lives have been put to risk due to the negligence and whimsical attitude of the Health department and lack of awareness among people.

Reports said that a newborn hailing from Rengalguda Baliguda village under Pandasguda panchayat under Kotpad block died Wednesday. The deceased was the newborn son of Raibari Muduli and Indra Muduli in the village. Raibari gave birth to the baby boy at Borigumma community health centre, December 1.

The baby weighed 2.5 kg during birth and

both the mother and child were discharged from the hospital the next day, December 2. The baby's health condition was perfect at the time of discharge but suddenly deteriorated Tuesday night.

Family members were arranging vehicles to take the baby to the hospital but he succumbed before a vehicle could arrive. Later, the parents of the deceased newborn buried the body in their courtyard.

"Since the baby arrived home after discharge, no health personnel turned up at our residence to enquire about his health condition or conduct a health check-up," familv members alleged. However, the back-toback demise of six newborns within a fortnight has raised question marks on the availability of healthcare facilities

Expressing concern over the development, the Health department constituted a team and launched an investigation. However, the actual reason behind the frequent deaths of newborns is yet to be ascertained

Earlier, three babies from Nuaguda village, one from Narigaon and another from Borigumma had died in quick succession within a fortnight. The actual reason behind each of the deaths is yet to be ascertained. The Health department has also not taken any serious measures to stop the deaths. Locals also alleged that the Health personnel posted in the rural areas are yet to take stock of the situation by undertaking visit to their respective areas.

Woman dies in freak mishap

Berhampur, Dec 15: In a freak mishap, an elderly woman died after a fragment of a waste injection syringe hit her eye while setting fire to a heap of garbage outside her house at Kulad village in Ganjam, Thursday.

The deceased was identified as Lakshmi Mohanty, 72, wife of late Jagannath Mohanty at Bilupadha under Tarsingh police limits. Medical outpost police registered a case and handed over the body to her family members after post-

Police said that the woman had been staying at her son Santosh Mohanty's house in Kulad village for the last four months. The incident occurred when she went to throw the waste on the garbage heap after sweeping the front yard of the house.

She noticed that the garbage had been lying there since long and set it on fire. However, fate had some-

thing else in store for her. An injection syringe dumped in the waste suddenly exploded and a fragment from it hit her eye. She lost her sense and collapsed on the spot. Some women who were nearby informed her son.

Family members rushed her to the Bhanjanagar hospital first and later shifted her to MKCG Medical College and Hospital in Berhampur after her condition deteriorated. She however, succumbed dur-

Residents stage roadblock in Keonjhar

Keonihar, Dec 15: Mineral transportation from mineral rich Keonjhar district came to a standstill Thursday as residents of Kandrapasi panchayat staged a road blockade on Palashpanga-Bamebari road over severe air pollution caused by dust due to operation of mineral-laden vehicles as well as bad road condition.

The road connects Palashpanga under Sadar block with Bamebari under Joda block. It is daily used by thousands of iron ore and other mineral-laden trucks to various mines in the district. The road blockade threw traffic out of gear on the route as thousands of mineral-laden trucks, tippers, trailers and Haiwa vehicles were stranded on both sides of the route due to the agitation.

Women of the panchayat were seen spearheading the agitation while no official was learnt to have reached the spot when last reports came in. Police rushed to the spot and tried to placate the agitators but they refused to listen.

The 28-km long road was constructed after the formation of Keonjhar Infrastructure Development Company (KIDCO) comprising the mineral and industrial firms as well as the administration. The mining firms sanctioned funds for the construction of the road by



taking loans from the banks. Later, a toll gate was established to raise funds spent on the road construction. The project failed to become financially viable due to mismanagement

Later, the road developed cracks at many places and potholes appeared on the road as no repair work was undertaken due to paucity of funds. The bad shape of the road resulted in frequent mishaps on the route leading to loss of lives and properties. The dust pollution has made life miserable for residents in over 10 panchayats adjacent to the road. Dust particles settle on and inside the houses along the route. People are suffocated due to air polluted by floating dust particles. A thick layer of dust can be seen spread on the houses, plants and trees in the backvard, farmlands and water bodies affecting humans and livestock alike.

The ambient air is always too hazy making it difficult for people to see and commute even in the day time. The villagers alleged that though they had drawn attention of the administration, their pleas were never addressed. Left with no option, they staged a road blockade. Kandrapasi sarpanch Ayodhya Nayak said that earlier water was being sprinkled to check the dust pollution but now that practice has also been stopped.

Environmentalist Pradip Mohanty said that this has happened due to lack of coordination among the various mining firms

Sadar IIC Sunil Kar said the companies have been asked to sprinkle water at regular intervals and informed them to come for discussion. The local tehsildar has been apprised of it and very soon the matter will be resolved, he added.

ate last month, a foreign leader accused US President Joe Biden of pursuing "super aggressive" industrial policies. It was not Russian President Vladimir Putin or Chinese President Xi Jinping, whose countries are America's main geopolitical rivals. Nor was it Iranian President Ebrahim Raisi or Venezuelan President Nicolás Maduro, whose countries have struggled under the weight of US-led sanctions.

No, the complaint came from French President Emmanuel Macron, a US ally, about the Inflation Reduction Act, Biden's landmark initiative to decarbonise the American economy by subsidising domestic investment in electric vehicles, batteries, and other renewable technologies. Qualifying for these subsidies requires firms to source critical inputs from US-based producers, which irks Macron and other leaders, who claim that the new legislation undermines European industry. France, Macron noted, faces challenges of its own generating middle-class jobs. "And the consequence of the IRA," he put it bluntly, "is that you will perhaps fix your issue but you will increase my problem."

Imposing costs on other countries while addressing climate change is, however, precisely what the European Union has been planning to do. Through its carbon border adjustment mechanism (CBAM), the EU will soon impose duties on certain carbon-intensive imports. The goal is to

maintain a high domestic price for carbon without allowing foreign firms to undercut European producers through cheaper imports. But the import duties will also hurt many lower-income countries such as Mozambique, Egypt, and India.

European officials argue that the CBAM differs from the IRA because it does not violate a fundamental principle of the multilateral trade regime: non-discrimination. The mechanism, they claim, aims merely to level the playing field between European companies, which are subject to high domestic carbon prices, and foreign producers, which are not. The CBAM, they insist, does not give European companies an unfair advantage

But one country's leveling of the playing field is another country's unfair targeting of comparative advantage. Equalising the costs of certain inputs, such as electricity, disproportionately affects exporters of energy-intensive products like steel and aluminum. That is why international trade rules have generally been averse to treating domestic and imported goods differently on the basis of their production processes; it is too easy to disguise protectionism under the guise of non-discrimination.

The better argument, and one that would apply equally to the IRA and the CBAM, is that the climate challenge is too important to be

overshadowed by trade and competitiveness considerations. Letting governments introduce ambitious environmental programmes to promote renewable energy, regardless of the impact on other countries, might just be the most feasible path to decarbonisation.

China is a case in point. Years of high subsidies for the country's solar and wind industries turned Chinese firms into world champions, and China into the world's preeminent renewable-energy producer. With American and European firms priced out of global markets, the West admonished China for its egregious favouritism.

But while the Chinese subsidies may have disadvantaged Western firms, they were also one of the best things that a government ever did to fight climate change. By enabling firms to scale up much faster than they otherwise would have, these policies helped to cut the cost of solar power by 90% and to halve the price of wind power, enabling these technologies to become commercially viable enough to compete with carbon. Notwithstanding the hit to foreign competitors, China has made an undeniable contribution to solving humanity's most pressing challenge.

Of course, it might be possible to achieve better, less acrimonious outcomes by encouraging greater international cooperation on green policies. My Harvard colleague Jeffrey Frankel, for example, argues that disputes over the CBAM and IRA should be adjudicated by the World Trade Organization. As he points out, the WTO does allow countries to pursue independent policies for environmental reasons. But the WTO is not the right forum for determining the circumstances under which trade rules should constrain green measures, or whether these measures should be constrained at all

The WTO's general presumption is that governments should pursue nontrade objectives – such as environmental sustainability or public health – so long as they do not distort trade. Similarly, the logic of mainstream trade economists assumes that efficiency and other public-policy goals can be neatly separable. Accordingly, non-discriminatory free trade is always possible if governments implement the right policies. Sustainability goals, in particular, could be met by pricing schemes (or equivalent quantity targets) that induce firms to internalise the costs of environmental externalities with-


In the real world, however, governments pursuing green policies face administrative and political hurdles that require messy deals to bring opponents and potential losers on board. The IRA and the CBAM were both predicated on such bargains, promising jobs and profits to domestic producers in exchange for their agreement to a green transition that might otherwise be costly for them. In such circumstances, it would be difficult, and perhaps inappropriate, for global trade panels to render judgement on the availability of alternative instruments and second-guess domestic political tradeoffs

Even when the conflict is more conventionally commercial, as was the case with the Chinese solar and wind subsidies, it is unclear whether we should let trade rules stand in the way when the measures in question advance the global decarbonisation effort.

In an ideal world, climate change would be addressed through a globally coordinated set of policies combining carbon pricing, non-discriminatory subsidies for green technologies, and transfers from highincome to lower-income countries. But in the world as it is, our only chance to ensure a sustainable future depends on a hodge-podge of national policies that will be wildly diverse and driven by complicated local considerations. We should not be trade purists and let the perfect become the enemy of the good.

ALREADY, **EUROPE'S DECISION TO TURN ITS BACK ON RUSSIAN GAS HAS INCREASED THE LIKELIHOOD** OF A DEEP RECESSION

t seems obvious that sanctions - an increasingly important tool of Western foreign policy - should inflict significant pain on the target without exacting unsustainably high costs from the country imposing them. But the European Union's sanctions on Russia - intended to punish the country for its brutal war of aggression against Ukraine - do not meet this condition.

At the center of the EU's plan to punish Russia is an effort to eliminate its dependence on the cheap Russian energy that long powered its growth, including by increasing its reliance on liquefied natural gas imported from the United States and elsewhere. But LNG has long been an overpriced (and carbon-intensive) alternative to piped gas: before Russia invaded Ukraine, it was 4-5 times more expensive than natural gas. Now, it is even more exorbitantly priced: since the war began, the cost of LNG has more than doubled.

But with the Kremlin slashing gas flows to Europe, in order to ensure that it - not the EU - dictates the timetable for phasing out Russian supplies, European countries have had little choice but to rely increasingly on LNG imports. This is creating serious challenges for Europe's manufacturing base, to the point that some European firms are now considering shifting production to the US, which offers not only cheaper fuel, but also massive subsidies and tax credits under its new Inflation Reduction Act (IRA).

Already, Europe's decision to turn its back on Russian gas has increased the likelihood of a deep recession. Skyrocketing gas prices - which are a staggering 14 times higher than two years ago - have fueled inflation and destabilised eurozone financial markets. So, just when Europe's economies are on the brink of contraction, the cost of living is spiking – and the threat of rolling power outages looms.

European policymakers' adoption of desperate measures like price caps and regulated tariffs could well exacerbate the situa-

tion. To conserve gas, some European governments have even turned to coal. Moreover, European leaders like French President Emmanuel Macron have pleaded with US President Joe Biden to ease pressure on their economies by adjusting some controversial IRA provisions. Months after an agreement to strengthen and expand NATO, transatlantic relations are beginning to fray.

The one thing the EU appears unwilling to consider is changing course on sanctions. This month alone, it has imposed an embargo on imports of Russian crude and joined its G7 partners in introducing a \$60-per-barrel price cap.

Europe's sanctions recall America's 1930 Smoot-Hawley Tariff Act, which substantially raised import duties on more than 20,000 goods. Far from protecting US industry, the tariffs prompted other countries to retaliate, deepening the Great Depression and contributing to the rise of political extremism, especially in

Today, too, many European countries' politics are lurching rightward. Italy's current governing party traces its roots to Benito Mussolini's Fascist movement; likewise, the Sweden Democrats has neo-Nazi roots. In Poland and

Hungary, right-wing governments show increasing authoritarian tendencies. If soaring energy prices and runaway inflation worsen economic conditions – a likely scenario in the short term - far-right forces could gain further

ground across the continent.

One might be able to argue that the sanctions' large costs were worth shouldering if they were significantly hampering Russia's war effort. But while Russia has certainly suffered, and Ukraine has achieved some high-profile military victories, nearly one-fifth of Ukrainian territory remains under Russian occupation. If the EU is enduring so much pain, while Russia's aggression proceeds apace, sanctions become tantamount to self-flagellation. This is why moral outrage, however justified, should never drive policy.

To be sure, the EU's international image has long rested on its reputation as a force for democracy, human rights, and a rules-based order, which strengthens the case for a bold, if costly, response to Russian aggression. But, had cooler heads prevailed, it would have been obvious that a rapid transition away from Russian energy supplies would undermine the EU's global standing by denting its

sustainability credentials – the turn to coal is a case in point and causing a global energy crisis, which is hurting poorer countries.

Given that the EU accounts for 11% of global energy consumption, its quest to secure replacement supplies was bound to disrupt the entire global economy. After all, the alternative supplies the EU secured were not idle. International oil and LNG supplies were already tight, and there was inadequate production capacity to compensate for the loss of Russian supplies.

As a result, when the EU reiected Russian energy, the world suddenly faced energy scarcity, with countries in Asia, Latin America, and elsewhere losing access to some supplies on which they had previously depended. In fact, soaring European gas prices have encouraged some shippers to divert LNG cargoes from Asia to Europe.

For far too long, the EU believed that economic and trade relations could be managed without regard for foreign-policy and security considerations. The Ukraine war made this approach untenable. But this should have prompted a more considered debate about what should come next, rather than an abrupt transition away from Russian energy supplies. This was a huge decision directly bearing on Europe's socioeconomic security; by making it rashly, the EU committed a major strate gic blunder.

Russia's actions in Ukraine are clearly both unjustified and unconscionable. But it makes little sense for Europe to respond by damaging its own competitiveness and global standing. It will take years for Europe to recover from the unprecedented energy crisis that it has helped to create.

Apex court puts off pleas to January

New Delhi: The Supreme Court said Thursday it will hear in the last week of January 2023, a batch of PILs challenging laws permitting funding of political parties through the electoral bond scheme. Electoral bonds have been pitched as an alternative to cash donations made to political parties as part of efforts to bring in transparency in political funding. A bench of Justices B R Gavai and Vikram Nath said the matter requires to be heard. "This is a 2015 matter. You can't have such an emergency just before the penultimate day of the vacation...There is no election as of now. We will hear it in the last week of January, 2023," the bench said.

Guwahati: At least three people, including a one-andhalf-year-old child, were killed due to an attack by a herd of wild elephants in Assam's officials said. Two persons were also critically injured in the incident. New Delhi, Dec 15: DNA extracted from bone pieces recovered in the Mehrauli forest and from blood found at Aaftab Amin Poonawala's house in connection with the Shraddha Walkar murder case has matched with samples of her father, police sources said Thursday.

The police had recovered 13 bone pieces from the forest and its nearby area while searching for Walkar's body parts. She was allegedly strangled and her body sawed into 35 pieces and disposed in various parts of the capital by Poonawala, her live-in

partner "In the Shradha Walkar murder case, Delhi Police has received the DNA report and its nearby area while from CFSL (Central Forensic Science

body parts Laboratory), Lodhi Road. The DNA report is helpful. "We have also received report of his (Poonawala's) polygraph test from FSL, Rohini, and this report will also help in investigation," Special Commissioner of Police (Law & Order) Sagar Preet Hooda told reporters on Thursday

The murder case that came to light a month ago had sent shock waves across the country, even as DNA forensic reports and the polygraph test report are expected to provide some vital clue to the police.

Delhi Police arrested 28-yearold Poonawala on November 12. During interrogation, he confessed to killing 27-vear-old Walkar and chopping her body parts into 35 pieces, police had said.

Following his confession, the police scanned through various forest areas and even a pond in Madangir was emptied to look for Walkar's missing body parts. Police have recovered more than 13 body parts from forest areas of Mehrauli and Gurugram.

"The police has received the DNA report of the bones found. The DNA of the bones matches with the samples of Walkar's father," a source said. Also, DNA samples extracted from the blood found at Poonawala's house

DCW, cops issue notices

New Delhi, Dec 15: The Delhi Police Thursday issued a notice to Flipkart after it was found the acid thrown on the 17-year-old girl in west Delhi was purchased from the e-commerce site while the victim's family said doctors at Safdarjung Hospital have assured them that her vision has not been affected.

The Delhi Commission for Women also issued notices to Amazon and Flipkart for allegedly allowing the sale of acid on their platform and called it a matter of grave concern. However, when PTI searched on the two platforms, using keywords like 'nitric acid' and 'acid' no results were found.

The National Commission for Women issued summons to Amazon and Flipkart over the alleged sale of acid on their platforms. In a tweet, the panel said it has scheduled a hearing with the country head of Amazon India and the CEO of Flipkart India Pvt Ltd on December 23 at 2 pm and they are required to appear in person.

Later in the day, Flipkart condemned the attack and said it has blacklisted the seller from its platform and is extending all support to the probe agencies. In its notice, police have sought details of

the order placed by prime accused Sachin Arora who planned the attack to exact revenge.

"The notice has been sent to Flipkart to provide information regarding the seller and the particular transaction. They have also been asked regarding the compliance of regulations related to acid sale," said a senior police officer.

According to police sources, the main accused, Sachin Arora, browsed multiple sites for buying acid and also watched films, videos and crime shows to plan the acid attack. Along with his two friends he also conducted a recce of the area, they said.

The victim's family said doctors have assured them that her facial burns will heal, even though it might take some time, and her vision seems to have not been af-

Legal experts decry Rijiju's remarks

New Delhi, Dec 15: Legal experts Thursday decried the Union Law Minister Kiren Rijiju's remark in Parliament that the Supreme Court should not be hearing "bail pleas and frivolous PILs" amid soaring pendency of cases, terming it as "pathetic" and "absurd"

Noted lawyer Prashant Bhushan was critical about the part of Rijiju's statement with regard to listing of bail cases, saying it showed the "anti-liberty mindset" of the minister and the government.

Commenting on the statement made in the Rajya Sabha on



Wednesday, senior advocate Ajit Kumar Sinha said there cannot be "complete negation" of PILs (public interest litigations) and it cannot be said that the top court should not entertain bail pleas as Article 136 of the Constitution provides for special leave to appeal by the Supreme Court against any order of the high courts.

Another senior advocate, Jayant

Bhushan, said the minister's statement in the House only "suits" the government. While speaking on the New Delhi International Arbitration Centre (Amendment) Bill, 2022, Rijiju had said that the Supreme Court should not be hearing bail applications and frivolous PILs when pendency of cases is so high.

"Kiren Rijiju and his government are themselves responsible (for pendency) and they have refused to appoint the judges which are recommended by the Collegium and have kept hundreds of appointments on hold." Prashant Bhushan said.

New Delhi, Dec 15: The government has "referred back" 20 names recommended for appointment as high court judges to the Supreme Court Collegium, Parliament was informed Thursday.

100 days of Bharat Jodo Yatra: Congress eyes revival

Jaipur, Dec 15: As the 'Bharat Jodo Yatra' enters its 100th day Friday Congress watchers feel it has found some answers the party had been looking for on the road to 2024 but questions remain whether it will yield electoral dividends going forward.

The Kanyakumari to Kashmir foot march has also courted many controversies in the last three months and led to several fiery exchanges between the Congress and the BJP including on Rahul Gandhi's ever-growing grey beard and his Burberry T-shirt.

With over 2,800 km under his belt, Rahul Gandhi has managed to catch the attention of his supporters as well as detractors and seen quite a few celebrities including from the tinsel town and academia walking alongside him from time to time.

However, some political pundits feel the party should have had more tangible political objectives for the yatra and questioned the party for skipping poll-bound states of Gujarat and Himachal Pradesh. Amid questions over the yatra translating into any electoral dividend, two recently-concluded assembly elections turned out to be a mixed bag for the Congress as it was drubbed in Gujarat to its lowest-ever tally while won in Himachal.

A clearer picture of the impact on the party's electoral fortunes would emerge in the assembly polls next year, including in Karnataka, Madhya Pradesh and Rajasthan, which were covered well by the Yatra. Former Congress leader Sanjay Jha, who had also been a



party spokesperson, said the Bharat Jodo Yatra could become a "gamechanger" for the Congress in the long term.

"For one, it has revived the political brand of Rahul Gandhi. The BJP cannot ridicule him anymore using their 'fake news malicious campaign'. Secondly, the Congress has at last connected directly with the people through this mass movement," he said.

Noting that it will definitely percolate to the grassroots. Jha stressed that the critical part from now on is for Congress to sustain the mobilisation through its workers who are galvanized."The Himachal Pradesh result shows that the Congress can still pull off a win against BJP if it demonstrates the hunger to win. Next year, the electoral impact of BJY will be more visible in states like Karnataka, Rajasthan, Chhattisgarh, Madhya Pradesh, etc.," he said.

While the yatra's positive of enthusing the party's cadres has been acknowledged, many say it's real test remains its electoral impact. Sanjay Pandey, a political commentator and professor at the Jawaharlal Nehru University, said the vatra has given a "glimmer of hope" to the party and enthused ordinary party workers but whether that would translate into electoral gains, only time will tell.

Sushila Ramaswamy, a professor at the Department of Political Science in Delhi's Jesus and Mary College, believes the yatra ought to have laid down more tangible political objectives at the start.

She asserted that electoral politics is very much part of what a political party should be doing and questioned the logic of yatra not going to poll-bound states of Gujarat and Himachal.

The yatra has traversed eight states – Tamil Nadu, Kerala, 🛶 Karnataka, Telangana, Andhra Pradesh, Maharashtra, Madhya Pradesh and now Rajasthan. The yatra will enter Delhi on December 24 and after a break of about eight days will move on to Uttar Pradesh, Haryana, Punjab and finally

Jammu and Kashmir.

Lucknow, Dec 15: In the New Year, the Uttar Pradesh Legislative Assembly will have a new set of rules, making sweeping changes in the Rules of Procedure and Conduct of Business of the Uttar Pradesh Legislative Assembly, 1958.

Assembly Speaker Satish Mahana said that new rules are the need of the hour to run the Vidhan Sabha.

He has formed a 10-member drafting committee to lay out a new draft of rules and procedures.

"It would be better to bring in a new rule book instead of making amendments to the existing one as it would be a tedious process,'

The drafting committee, headed by principal secretary, Vidhan Sabha. Pradeep Dubey, includes retired officer from the law department, SN Srivastava, and retired special secretary, finance department, Shankeshwar Tripathi, as members

The committee is likely to submit the draft for new rules to the Speaker in January. The Speaker will then put it before the 13-mem-

ber Rules Committee of the UP Vidhan Sabha.

The Rules Committee is chaired by the Speaker himself and has MLAs from various political parties. "Once approved by the Rules Committee, the draft would be tabled before the House for approval," the principal secretary said.

The need for replacing the 64year-old Rules of Procedure and Conduct of Business of the UP Legislative Assembly was felt after

new technology was introduced in the Vidhan Sabha.

"It became more important after e-vidhan was introduced in the legislature," the principal secretary said.

One of the major changes in the rules would be reducing the notice period to convene the house from 14 days to seven days.

The language of the rules would also be simplified as it has been felt that legislators, especially the first-timers, find it difficult to understand the rules. Similarly, several other rules and procedures would not only be simplified but also clarified.

A proposal is also likely to be made to allow members of the House to list questions 15 days after the Speaker adjourns the House instead of the present procedure to list questions after the adjourns Cabinet House sine die.

flower grower, brings jasmines, mogras, roses and lotuses to sell at Asia's oldest wholesale flower market.

The vibrant and bustling market at Mullick Ghat, a photographer's delight, on the banks of the Hooghly, attracts over 2,000 flower sellers daily.

"My father used to sell flowers in this market which is 130 years old. I inherited the business from him and for the last 50 years I am running it," Srimani said

The sale proceeds are enough to lead a decent life with his wife and two children, he added.

'Karigars' at the stalls string the cut flowers for making garlands. They also make decorative panels, and bouquets and women sort leaves which the clientele buy for offerings. Red hibiscus, marigolds in yellow, orange or red varieties, and jasmine required for pujas and wedding decor are in great demand at the market.

The rush and buzz in the whole sale flower market are even more during festivals and the wedding season. Wedding dates mean more customers and increased sales.

Unlike other days, the wedding dates are very special. On a normal day, if the turnover of the market is around Rs 1 crore, then on the wedding days it can easily go up to old Bhakti Maiti, who supplies decoration items for weddings.

Vendors are seen busy making flower arrangements, floral tiaras, and bouquets that are in great demand during festivals and weddings. The market also offers flowers used for other purposes -birthdays, housewarming parties, and funerals.

The business here comprises not only countless farmers and middlemen who sell their products, but also shopkeepers who offer decoration services and more. Many vendors even stay in makeshift shelters in the area. Livelihood of people like porters who carry the bulk purchase up to the vehicles, tea vendors, fruit sellers, shop owners selling snacks also centre around this flower market.

The market starts around 4 am with flower sellers from adjacent areas of Kolkata gathering with their merchandise.

Khirai and Kolaghat in Purba Medinipur district, Bagnan in Howrah district and areas in Nadia, North 24 Parganas and South 24 Parganas districts to this market.

The flower sellers say around 50 varieties of marigold are sold at the market. Mexican tuberose (Rajanigandha) is also a big hit.

Swapan Burman, a member of Mulick Ghat Phool Bazaar Parichalan Samiti, a nominated body of the Department of Food Processing, Industries and Horticulture, Government of West Bengal, said the turnover, including wholesale, retail and exports, of the flower market is in crores.

Flowers are sent to Bangalore, Mumbai, Hyderabad, Chennai and some places in Rajasthan, he said.

Lack of direct flights to places like the Netherlands has affected the export potential of the famed market, he claimed.

Plans are afoot to recycle flow-

duce cold storage facilities, and revamp the market and make it more organised, he said.

Ajit Ghorai, a shop owner since 1982, said, "I have been a part of this market and associated with the business of flower decoration for the last 40 years. When I started here, my profit margin used to be double the expenses incurred. But now, as a result of competition, our days of happiness are gone, and we are compelled to make do with negligible profits.

The words of this market veteran were echoed by Madan Saha, another flower seller which does not have a grand structure to announce its presence.

Ever since the COVID-19 pandemic, sales are not encouraging at all, and we are just able to make both ends meet. My association with the market is for over 30 years now, and each year the competition is increasing manifold,'

Noise levels at all-time high in Noida as debris cleanup misses deadline

Noida, Dec 15: The Supreme Courtmandated demolition of Noida's infamous twin towers in August this year has left behind a recurring nightmare of noise pollution, lingering headaches, breathing issues, shaky floors and rising anxiety levels for the residents of the neighbouring Emerald Court complex.

And anger seems to be the com mon emotion among the residents of Aster-2, who live just nine metres away from the site, and are bearing the brunt of the continuing dismantling of the structure and removal of the piles of concrete debris and metal.

The debris has still not been moved, despite claims of the company assigned by Supertech, the developer of the twin towers, that 60 per cent of the 80,000 tonnes of debris has been carted away.

As a result, daily, sharp at 8 am. the workers dig away non-stop, with the sound from the mammoth machines employed by them reaching up to maximum 100 decibels if three work in tandem. The activity ends at 8 pm, after which the manual cleanup takes place, leading to yet another kind of metallic cacophony.

On Monday, three such big drillers were in operation right under the Aster-2 block and four near ATS Village at 7.35 pm. The work was stopped only after the residents complained bitterly.

Anish Bansal, a World Bank executive, told IANS, "We need to highlight that this digging is not compulsory. It is being done only in order to salvage iron and steel. Otherwise, they can just remove the loose structures above ground zero and retain the unbroken pillars in the basement. If the noise and vibration is for the purpose of removal of rub ble. we wouldn't complain; we know that it is necessary. However, the removal of pillars by digging below ground zero is not necessary."

Inderjeet Kaur, a homemaker and mother of two living in Aster2, Emerald Court, told IANS that she had to undergo brain-mapping and was diagnosed with high stress levels because of the noise

"We have seen this building from its foundations being laid to it being brought down, but all this was done with engineers around; now, there are no engineers to supervise the work. Semi-skilled workers are being employed at the site and they have zero expertise in removing debris from residential areas," Kaur added.

"It is living hell," Kaur continued, "with the noise level rising up to more than 70db throughout the day. Yesterday, I called the police to get their machines moved, but they did not act," she said, adding that she underwent brain mapping because she was experiencing a nagging headache. That's when she learnt that her stress levels were high because of the noise assault.

A senior citizen, who is also a stroke survivor, meanwhile, is complaining about severe wheezing issues because of the bad air quality, courtesy of the dust in the area.

"Work from home is impossible." added Atul Gupta, an entrepreneur. "My work is suffering. My family is suffering. The only time we can relax is at night when these machines stop," Gupta said.

In a letter to the Chief Executive Officer of the New Okhla Industrial Development Authority, Uttar Pradesh, UBS Teotia, President, Emerald Court RWA, pointed out, "The deeper digging near the existing buildings may cause slippage or movement of the earth below the foundation of the existing building and may harm the existing structure with no safety measures in place."

The RWA president concluded by saying, "The residents are in complete distress due to continuous noise, vibration and pollution for the last one year and are not able to sustain any further." He urged the Noida CEO to ask Edifice to stop digging further, level up the ground and hand over the site to the residents at once.

'Area within 500m radius of Ram Temple restricted zone'

Ayodhya (UP), Dec 15: The 500 metres periphery of under-construction Ram Mandir in Ayodhya will now be a restricted zone, where except religious activities no commercial or any other activity will be allowed, a senior official said Thursday

According to Ayodhya Master Plan 2031, within 500 metres periphery of the temple only religious activities will be performed, Vice-Chairman of Ayodhya Development Authority, Vishal Singh told PTI.

Keeping the security of Ram Janmabhoomi on top priority and

to maintain the religious sanctity of the Ram Mandir, the area of about half kilometers will remain

in full religious colour, he said. Restricted temple zone has been created to preserve the grandeur and divinity of the temple. In this zone the maximum height of the buildings are also restricted to

only 7.5 metres. Singh said. Under the Master Plan 2031, the built-up area has also been marked, as in old areas of the city, such as Chowk and its adjacent areas, the height of the buildings in these areas will be 15 metres, he said. The roads in old city areas are relatively less wide, if big buildings are built there, along with the environmental issues, the area will have to face many problems, he reasoned. Apart from this, zonal development plans will be prepared by dividing the development area into seven zones, the senior official said.

In the master plan, market areas have been marked on the main roads outside the old city areas. he said. From Devkali tri-section to DarshanNagar on Ambedkar Nagar Road, from Dabhasemar Sports Stadium on Allahabad highway to Maushiwala locality on Raebareli Road and from Saadatganj Hanumangarhi on Lucknow road to the last boundary of Ghatampur village on Lucknow-Gorakhpur highway will be the market area, he said.

The plan for regularisation of commercial buildings built in these areas has also been cleared, he informed

Conservation of reservoirs, ponds, drains and other water sources or drainage sources has also been included in the master plan, he said, adding there will be no construction within a radius of six metres of such places.

To control the construction taking place in and around the river, a provision has been made for river central development, he said.

Preparation of water action plan for providing drinking water round the clock is also included in the master plan, he added.

Kolkata air pollution levels worse than Delhi this week

Kolkata's iconic Victoria Memorial Hall, which is favourite place for morning walkers is the worst affected on this count, says an environmentalist

Kolkata, Dec 15: The air pollution levels in Kolkata have turned to during the first two days of the current week, Monday and Tuesday.

On Monday (December 12), the $air\,quality\,index\,(AQI)\,was\,recorded$ at 307, which is considered as "hazardous", as against the national capital's figure of 218, which is in the "very unhealthy" category.

The difference in the air quality levels in the two cities further increased Tuesday (Dec 13). While the AQI for Kolkata was 314 or "hazardous" on that day, the figure for New Delhi was 177 or "unhealthy".

Environment activist and green technologist, Somendra Mohan Ghosh said that Kolkata's iconic ers is the worst affected on this count. "The AQI in this heritage zone is quite high. So the shine of marbles of the heritage building is being affected because of the high level of pollution in the area. At the same time, the air quality in the zone is not safe in the morning and evening hours," he said.

He said that it is unfortunate that the Makrana marbles of this heritage structure in the city are getting exposed to and affected by the air pollution. 

UNION HOME SECY REVIEWS CROWDING AT AIRPORTS

New Delhi, Dec 15: The issue of crowding at airports, particularly Delhi and Mumbai, was discussed threadbare at a meeting chaired by Union Home Secretary Ajay Bhalla here on Thursday, officials said.

Bhalla convened the meeting to discuss with stakeholders continuous complaints from passengers the rush at the entry gates, luggage dropping, and security check areas. The meeting discussed the issue of crowding and how to fix the problems faced by the passengers, an official said.

Representatives of key stakeholders such as the Civil Aviation Ministry, CISF, and Bureau of Immigration attended the meeting, an official said. Over the last two weeks, passengers have been posting pictures and videos of long queues and crowding at the IGI in Delhi and the Chhatrapati Shivaji Maharaj International Airport in Mumbai prompting authorities to take note and asking airlines and airport operators to ease the traffic.

The CISF has formed a pool of more than 100 personnel to man additional security counters expected to be handed over to it to ease the congestion at large airports of Delhi and Mumbai, official sources said.

The central paramilitary, designated as the national aviation security force, has informed airport operators, airlines, and the Union civil aviation ministry that while it can bring on board some more security personnel, there can be "no compromise on security protocols and standard operating procedures followed by it for regular frisking of passengers and scanning of cabin baggage apart from fliers required to undergo extensive search due to specific profiling.

The civil aviation ministry had on Tuesday asked airlines to deploy adequate manpower at all check-in and baggage drop counters, besides requesting the scheduled airlines to update their social media feed with real-time numbers on the waiting time at airports' entry gates.

Circumstantial evidence okay to convict babus of graft: SC

New Delhi, Dec 15: The Supreme Court Thursday said a public servant can be convicted for illegal gratification in a corruption case on the basis of circumstantial evidence when there is no direct oral or doc-

umentary evidence against them. A five-judge Constitution bench headed by Justice S A Nazeer said complainants as well as the prosecution should make sincere efforts so that corrupt public servants are brought to book and convicted so that the administration and governance be-

come unpolluted and free from corruption.

"In the absence of evidence of complainant (direct or primary), it is permissible to draw an inferential deduction of culpability," the bench, also comprising justices B R Gavai, A S Bopanna, V Ramasubramanian and B V Nagarathna, said.

The top court said that even if direct evidence of the complainant is not available, owing to death or other reasons, there can be conviction of the public servant under

the relevant provisions. "In the event the complainar

turns hostile or has died or is unable to let in his evidence during the trial, the demand of illegal gratification can be proved by letting in the evidence of any other witness either orally or documentary evidence or the prosecution can prove the case by circumstantial evidence.

"The trial does not abate nor does it result in an order of acquittal of the public servant," the bench said. The apex court's verdict came while examining the issue whether in the absence of direct or primary evidence of demand of bribe, inferential deduction of guilt of a public servant can be drawn based on other evidence

BIHAR TOXIC LIQUOR DEATHS

If you drink, you will die, says Nitish

Patna, Dec 15: After Bihar's hooch tragedy toll climbed to 26, Chief Minister Nitish Kumar Thursday warned that if people drink spurious liquor, they will die.

The chief minister's blunt comments came as his policy of prohibition came under attack from many quarters including from his former political strategist turned activist Prashant Kishor, who demanded scrapping of the prohibition law.

"Jo piyega woh marega" (those who drink spurious alcohol will die), thundered Bihar Chief Minister Nitish Kumar as he stood his ground maintaining that prohibition was "not my personal wish but a response to the cries of the women of the state".

Kumar when he brought in prohibition had won praise from many women's groups who felt it would save their men-folk from the "curse of drunkenness and save homes from financial ruin." He also expressed displeasure over criticisms from the opposition BJP which has raised the issue "even inside Parliament".

Man stuck between rocks for 3 days rescued

Hvderabad. Dec 15: A 36 year-old man precariously stuck between rocks in a forest area in Kamareddy district after a slip spent three harrowing days between the boulders, all the while surviving on liquid diet, before a 24 hour operation that included controlled blast by authorities led to his rescue.

C Raju of Reddypet village got stuck in a narrow space between rocks and the coordinated rescue effort involving different government departments ensured he was pulled out on Thursday Raju slipped into the gap between the rocks and got trapped, without being able to move his body on Tuesday while trying to take out his cell phone which had fallen inside the rocks. He was walking on a hillock in that area



along with a friend when the incident happened

Soon his family members tried to rescue him and when they could not, they alerted the police. Police along with officials from other departments launched a rescue operation on Wednesday at around 4 PM after receiving information.

Controlled blast was done on Thursday to break the rocks as part of efforts to rescue the man, a police official, who supervised the rescue operation said. Initially, the rescue effort started with the help of earth-moving equipment to shatter the boulders besides men trying to break the rocks manually.

Controlled blast was conducted by ensuring that broken rocks did not fall on him, the official said Authorities maintained oxygen supply to Raju and provided him with fruit juice. Ashok, a relative of Raju, played a key role in the rescue operation by providing liquid food to him at regular intervals by reaching near him inside the rocks and also speaking to him to give courage.

Kamareddy District Superintendent of Police B Srinivas Reddy said the boulders where Raiu was stuck had to be removed and about 10 boulders were cleared one after another. In the final stage, two more boulders where he was stuck had to be removed. Finally Raiu was rescued safely after a boulder on which he was lying was brought down, he said.

Godhra convict

New Delhi, Dec 15: The Supreme Court Thursday granted bail to a convict serving life imprisonment in the 2002 Godhra train coach burning case, noting that he has been in jail for the last 17 years.

A bench comprising Chief Justice D Y Chandrachud and Justice PS Narasimha took note of the submission of a lawyer, appearing for one of the convicts Faruk, that he be granted bail considering the period undergone till

Solicitor General Tushar Mehta, appearing for the Gujarat government, termed the offence as the "most heinous" in which 59 people, including women and children were burnt alive and sought hearing of the appeals of the convicts at the earliest.

The top law officer opposed the bail plea and said usually stone pelting is an offence of minor nature, however, in the instant case, the train coach was bolted and stones were pelted to ensure that passengers cannot come out.

Moreover, stones were thrown at fire tenders also, he added."He (the convict seeking bail) instigated others and pelted stones and injured the passengers. Under normal circumstances, pelting of stones may be a lesser offence... But this is different," he said.

"In the facts of the case, the application of bail made by Faruk... Is granted. The applicant was convicted of offences punishable under Section 302 (murder) of the IPC and sentenced to suffer imprisonment for life. "The High Court had dismissed his appeal on October 9, 2017. The applicant has sought bail on the ground that he has been in custodysince 2004 and has undergone imprisonment for about 17 years.

Sources said the French-manufactured jet joined the second Rafale squadron in Hasimara that increased its strength to 18 aircraft. They said the second



squadron of Rafale jets was to be part of the mega air exercise along with other key assets such as Sukhoi-30MKI aircraft under the

Eastern Air Command. An IAF official said the exercise was planned well in advance and it

is not associated with recent de-

velopments in the Tawang sector. On Monday, the Indian Army said troops from the two sides clashed along the Line of Actual Control (LAC) in the Tawang sector and the face-off led to "minor injuries" to a few personnel from both sides".

The face-off took place amid the over 30-month border standoff between the two sides in eastern Ladakh. All frontline air bases and some key Advanced Landing Grounds in the Northeast are set to be involved in the exercise, said a source.

The Army and IAF have been maintaining a high state of operational readiness along the LAC in the Arunachal Pradesh and the Sikkim sector for over two years following the eastern Ladakh row. The IAF scrambled fighter jets last week following China's increasing air activities on its side of the LAC in the Tawang sector of Arunachal Pradesh.

The deployment of some aerial platforms including drones by China in the region preceded the Chinese attempts on December 9 to unilaterally change the status quo in the Yangtse area of the Tawang sector, the sources said.

They said a number of Chinese drones flew close to the LAC prompting the IAF to scramble the jets and increase the overall combat readiness. Defence Minister Rainath Singh on Tuesday told Parliament that the Indian troops bravely thwarted the attempt by Chinese PLA from "unilaterally" changing the status in Yangtse area of the Tawang sector and there were no fatalities or serious casualties to the Indian troops in the scuffle.

London: A grammatical problem which has defeated Sanskrit scholars since the 5th Century BC has finally been solved by an Indian PhD student at the University of Cambridge, it emerged as his thesis was published Thursday. Rishi Rajpopat made

the breakthrough by decoding a rule taught by Panini, known as the father of linguistics, and is now encapsulated in his thesis entitled 'In Panini, We Trust: Discovering the Algorithm for Rule Conflict Resolution in the Astadhyayi'. According to the university, leading Sanskrit experts have described Rajpopat's discovery as "revolutionary". The 2,500-year-old algorithm

decoded by him makes it possible, for the first time, to accurately use Panini's socalled "language machine".

UK nurses strike

London: National Health Service nurses in Britain staged a strike Thursday, their first ever national walkout, as a bitter dispute with the government over pay ramps up pressure on alreadystretched hospitals at one of the busiest times of the year. An estimated 100,000 nurses will strike at 76 hospitals and health centres, cancelling an estimated 70,000

appointments, procedures and surgeries in Britain's statefunded NHS. Britain is facing a wave of industrial action this winter, with strikes crippling the rail network and postal service, and airports bracing for disruption over Christmas.

London, Dec 15: Prince Harry and his wife Meghan piled fresh criticism on the British royal family in new episodes of their Netflix documentary series released Thursday, accusing his elder brother Prince William of being part of media attacks.

William, now heir to the throne, had screamed at him when he discussed leaving his official royal role almost three years ago, Harry said, while he also added he believed the press were responsible for Meghan having a miscarriage.

In the first tranche of episodes released last week, the royals had escaped relatively unscathed. But in the final three, Harry accuses his relatives of not just failing to prevent negative coverage in the press, but actively encouraging it.

India announces candidature for UNSC seat for '28-29 term

United Nations, Dec 15: India has declared its candidature for non-permanent membership of the UN Security Council for the 2028-29 term, External Affairs Minister S Jaishankar said here Thursday.

India December 1 assumed the monthly rotating Presidency of the Security Council, the second time after August 2021 that India is presiding over the Council during its two year tenure as elected UNSC member.

"I am glad to inform you that we have declared our candidature for our next tenure at the Security Council for 2028-29," Jaishankar said.

India, whose 2021-2022 term on the Council ends December 31, has been at the forefront of efforts calling for urgent reform of the Security Council, which has remained deeply divisive in dealing with current challenges.

India has asserted that the Council, in its current form, does not reflect today's geo-political realities and its credibility is at risk if nations such developing powers like India do not have a permanent seat at the horse-shoe table.

India has strongly hit back at Pakistan for raking up the Kashmir issue in the UN Security Council (UNSC), arguing that a country that hosted slain al-Qaeda leader Osama bin Laden and attacked a neighbouring Parliament does not have the credentials to "sermonize" before the powerful

Jaishankar's strong remarks came after Pakistan Foreign Minister Bilawal Bhutto raised the Kashmir issue while speaking in the Council open debate on reformed multilateralism Wednesday. He said the credibility of the UN depends on its effective response to the key challenges of our times, be it pandemics, climate change, conflicts or terrorism.

Washington, Dec 15: The US Pentagon has said that China continues to amass forces and build military infrastructure across the Line of Actual Control (LAC) with India.


Addressing a briefing, Brigadier General Pat Ryder, Press Secretary of the Department of Defense (DoD), said the DoD continues to closely watch developments along the line of actual control at the India-China border.

"We have seen the PRC continue to amass forces and build military infrastructure along the so-called LAC. But I would defer you to India in terms of their views.

"It does reflect though, and it's important to point out, the growing trend by the PRC to assert itself and to be provocative in areas directed towards US allies and our partners in the Indo Pacific. And we will continue to remain steadfast in our commitment to ensuring the security of our partners. And we fully support India's ongoing efforts to deescalate this sit-

uation," he added. Ryder's remarks came as a response to a series of queries on the recent clashes between Indian and Chinese soldiers along the LAC in Arunachal Pradesh.

The queries posed to the



spokesperson was: "How much is the Pentagon concerned that this clash could lead to a bigger military confrontation? Is the Pentagon willing to provide more military support to India to help them handle China's military threats at the border?"

On December 9, troops from China's People's Liberation of Army the LAC in Arunachal Pradesh, but Indian soldiers firmly contested their way, leading to a clash between the two.

India's Defence Minister Rajnath Singh informed that China's People's Liberation Army (PLA) troops tried to transgress the LAC

in Yangtse area of Tawang sector in Arunachal Pradesh and change the status quo. But, Rajnath Singh said, the Chinese troops were sent back by the Indian soldiers.

The face-off between the Chinese and the Indian troops led the physical scuffle but no deaths were reported. Singh said that "our forces are committed to protecting our territorial integrity and will continue to thwart any attempt made on it".

The India-China clash along the LAC in Tawang sector took place amid over 30-month border standoff between the two sides in eastern Ladakh in August 2020.

China blames stirs on 'foreign forces' PRESS TRUST OF INDIA

Beijing, Dec 15: Nearly a fortnight after China lifted the muchdespised 'zero-Covid' restrictions following a spate of protests, the country is reeling under a massive coronavirus wave, with a Chinese diplomat blaming "foreign forces" for the anti-government demonstrations.

Videos circulating in China's social media showed clinics in Beijing and some other cities flooded with patients with queues extending onto footpaths with people patiently waiting for their turn in the cold winter.

While many with heavy fever waited outside the clinics, the Omicron virus is having a field day with most of the apartment blocks, which were earlier under the cover of zero-Covid reported fast-increasing cases.

The virus is not sparing anyone, including Chinese Foreign Ministry officials, Beijing-based

diplomats and journalists. Meanwhile, a senior Chinese diplomat has alleged that last month's anti-zero covid protests, which included slogans against President Xi Jinping and the ruling Communist Party, were caused by the local government's failure to manage the epidemic but were soon "taken advantage of" by "foreign forces.'

The remarks by Lu Shaye, China's Ambassador to France, were the first by a Chinese official after rare protests erupted in Beijing, Shanghai, Guangdong, and other cities, Hong Kong-based South China Morning Post reported Thursday.

A transcript of Lu's comments made at a reception December 7 was published on the Chinese embassy's website. "In the beginning, I think the Chinese public initiated the protests to express their dissatisfaction (with) how local governments have failed to fully implement the central government's policies. But the protests were soon being taken advantage of by foreign forces." Lu said.

"I think the 'real protests' only happened on the first day. Foreign forces came into play already on the second day," said Lu, whose fiery remarks in the past have made him one of the high-profile "wolfwarrior" diplomats of China, the report said.

115 media workers killed in 29 nations this year

Geneva, Dec 15: Since January, 115 media workers have been killed in 29 countries so far. while Ukraine and Mexico topped the list for the most dangerous nations for mediapersons, a Geneva-based rights

body said in a report. By region, Latin America topped the list with 39 journalists killed, followed by Europe with 37 victims, Asia 30, Africa seven and North America two, according to the Press Emblem Campaign (PEC). Europe experienced the worst de-

terioration in the safety of jour-

nalists since the wars in former

Yugoslavia from 1992 to 1999, said the EC report.

There has been at least 34 victims since the beginning of the Russian invasion February 24. with eight journalists killed in

the line of duty. Mexico came in second with 17 victims, the highest annual death toll in the country since at least the beginning of the century. They were the target of criminal gangs in a climate of violence and impunity.

At the third place with eight victims is Haiti, followed by Pakistan (six), the Philippines (five), Colombia (four) and India (four). Bangladesh,



Honduras, Israel/Palestine and Yemen reported three media fatalities each. Two media fatalities were registered each in Brazil,

The number of journalists killed increased by 45 per cent compared to last year (79 victims). It is the highest number of casualties since 2018 with a brutal deterioration in Europe due to the war in Ukraine BLAISE LEMPEN | PRESIDENT, PEC

Chad, Ecuador, Myanmar, Somalia, Syria and the US

The countries with just one victim each were the Central African Republic, Chile, Democratic Republic of Congo, Guatemala, Kazakhstan,

Kenya, Paraguay, Russia, Sweden, Turkey and Vietnam. Meanwhile, there was no casualties among mediapersons in Afghanistan so far this year, compared to the 12 in 2021. However, many journalists have fled the country.

In the last five years, Mexico has recorded the greatest number of victims (69), ahead of Afghanistan (44), then India (37), Ukraine (36), Pakistan (34), Syria (24), the Philippines (21), Yemen (17), Honduras (13), Somalia

(13), Brazil (12) and Haiti (11). From 2013 to 2022, 1,135 journalists were killed, or 113 per year, 2.2 per week, according to figures from the PEC.

New Delhi: Shares of IRCTC fell more than 6.5 per cent in morning trade on the BSE Thursday as the sale of the government's up to 5 per cent stake in the company kicked off. BoE again hikes interest rates

London: Britain's central bank Thursday raised its key interest rate again but toned down the pace as inflation shows signs of easing, mirroring action by the US Federal Reserve and ahead of an anticipated identical move by European policymakers. The Bank of England raised the benchmark rate by half a percentage point, to 3.5 per cent, the highest level in 14 years. It was the ninth consecutive increase since December 2021 and follows last month's outsized threequarter point hike, the biggest in 30 years. This time, officials opted for less aggressive action after data this week showed inflation slipped from a 41-year high, but they warned that more hikes are likely to come.

Japan trade deficit soars on weak yen

Tokyo: Japan's trade deficit surged to over 2 trillion yen (\$15 billion) in November as higher costs for oil and a weak yen combined to push imports sharply higher. Al Khor, Dec 15: Kylian Mbappe vs Lionel Messi. Football's latest superstar against perhaps the sport's greatest player in the World Cup final just about everyone was hop-

France and Mbappe are headed back to the biggest game in football, and to a much-anticipated matchup with Argentina, after ending Morocco's historic run at the World Cup Wednesday.

In front of the country's president, Emmanuel Macron, France beat Africa's first ever semifinalist 2-0, with Mbappe playing a part in goals by Theo Hernandez in the fifth minute and substitute Randal Kolo Muani in the 79th

Mbappe became a global phenomenon by leading the Les Bleus to the title in Russia in 2018 and has a chance to emulate Brazil great Pele as a champion in his first two World Cups when he comes up against the 35-year-old Messi, who has dominated the game with Cristiano Ronaldo for the past 15 years.

It's the dream final for many. with France looking to become the first team to retain the title since Brazil in 1962 and Argentina on a mission to win football's ultimate prize for the third time in what is likely to be Messi's last World Cup.

There will be no team from the Arab world in the final of the first World Cup in the Middle East, a

prospect that seemed nigh impossible before the tournament vet nearly happened in Qatar.

Their players gave France a farfrom-easy ride, too, before collapsing on the ground in despair after the final whistle.

Remarkably, Hernandez's early goal was the first scored against Morocco by an opposition player in the tournament — the other had been an own-goal in the group stage — but the team responded to that and injury issues in its defense with a fearless performance in front of tens of thousands of fans who dominated the 60,000-seat Al Bayt Stadium.

France were forced into some last-ditch defending at times but have developed a knack of pulling out victories despite not playing their best. The country will be playing in the final for the fourth time in the last seven World Cups, more than anyone else

Roared on by their red-and-greenclad fans, Morocco came closest to scoring when Jawad El Yamiq hit the post with an overhead-kick in the 44th minute and forced France to defend in numbers, with Antoine Griezmann — the team's playmaker — effectively playing as a deep-lying midfielder and often

clearing balls from inside his box. However, Mbappe enjoyed more space as Morocco tired late in the second half and he was moved into a central position. After dribbling past two defenders, he took a shot that deflected toward Kolo Muani, who tapped in having been on the field for less than a minute.

The World Cup trophy isn't the only thing at stake Sunday. Messi and Mbappe are tied as the leading scorers with five goals as they chase the Golden Boot award, Morocco's World Cup isn't over. The team will play the third-place playoff match against Croatia Saturday.

Car hits, kills teen as fans celebrate **World Cup victory**

Paris, Dec 15: A car in the southern French city of Montpellier "violently hit" and killed a boy as crowds celebrated France's victory in the World Cup semifinal, according to local regional authorities.

The driver fled the scene, but the vehicle was found nearby and police were investigating what might have caused the vehicle to strike the child, Herault authorities said.

Video emerged on Twitter showing a car being driven dangerously near crowds in the street following the Les Bleus' Wednesday night win over Morocco.

The boy, whose name was not made public, was rushed to a hospital and died of his injuries. French media said he was 14 years old. French lawmaker Nathalie Oziol expressed her "immense sadness (that a) sporting event ends in absolute tragedy."

Elsewhere in France, crowds in Paris and other cities erupted in shouts of joy as France advanced to the World Cupfinal. The displays were relatively restrained. Disappointed Morocco fans mingled with the exuberant supporters of the winning team, paying tribute to the African country's unprecedented achievement.

Al Khor, Dec 15: Yassine Bounou stretched out his arm with everything he had, desperately trying to get something, anything, in the way of the ball. It was no use.

France substitute Randal Kolo Muani had come on only seconds earlier and with his first touch assured the defending champions of a second straight World Cup final, putting an end to Morocco's proud fight once and for all.

But it wasn't until that moment, in the 79th minute of an enthralling semifinal match at Al Bayt Stadium Wednesday that the two-time champions could breathe easily.

"My players gave everything," Morocco coach Walid Regragui said. "They've gone as far as they could. It's difficult for them to take now. They wanted to rewrite the history books, but you can't win a World Cup with miracles, you have to do it with hard work and that's what we are going to do, keep work-The team that has provided the

most improbable story of this year's World Cup got off to a terrible start. Morocco lost two players from their starting lineup and conceded a goal to an opposition player for the first time in the tournament — all by the 21st minute. The sea of red shirts in the stands

still dominated the atmosphere, overpowering the massively outnumbered France supporters even after Theo Hernandez's fifth-minute

As inspiring as Morocco have been in becoming the first African nation to reach the World Cup semifinals, the fans who have cheered them all the way have felt fundamental to an unforgettable jour-

ney.
The tone had been set even before kickoff as the now familiar deafening whistles greeted France's players as they emerged for their pre-match warm-up. It got even louder as the French national anthem was played, coming close to drowning out the stadium's loudspeaker system.

When Morocco's anthem played, the noise reached yet new levels. The theme of Morocco's run has been that anything is possible. Not even the prospect of facing the defending champions and superstar forward Kylian Mbappe could quell the sense of anticipation.

Things weren't going well – with the team lying a goal behind, but a team that had made it this far by defying the odds was not ready to give up on the chance to become the first nation from outside of Europe or South America to make it to a World Cup final.

Morocco had already made history by joining the United States and South Korea as the only teams from outside football's two dominant continents to get this far. It is also the first Arab nation to play in

The team topped a group that contained 2018 finalists Croatia and second-ranked Belgium, and then progressed past 2010 champions Spain and Portugal in the knock-

Morocco have developed a reputation for their strong defense under Regragui. But giving up a goal so early required the team to push forward and take risks at the back. And right up until Kolo Muani's goal, it still felt like anything was_ possible.

"I'm proud because I grew up in France and I learned my trade there. Sometimes you criticize French coaches and French football, but they have the best players and the best coaches, the best team in the world. If France won (the final) it would be great because we could say we lost to the World Champions," said Regragui.


