reviewed the situation Wednesday.
After the meeting, Health Minister
Mansukh Mandaviya asked peo-
ple to start following Covid-19 ap-
propriate behaviour and to wear
masks at crowded places. As of
now there are no mandatory Covid-
19 protocols in the country.

The surge in cases has been attributed to the BF.7 sub-variant of Omicron. Three such cases have been reported in the country also. Two were reported from Gujarat and one from Odisha. However, the ministry said Wednesday that there is no need to panic, but to implement precautionary measures in a stringent manner. The new variants have not only been found in India, but also in the US, UK, Brazil, Italy, Japan, South Korea and some more countries.

Official sources informed that random sample testing will be done at airports for international passengers arriving from China and other countries. "Covid-19 is not over vet. I have directed all concerned to be alert and strengthen surveillance. We are prepared to manage any situation," Mandaviya said.

During the meeting, attended by experts and senior officials, the minister was briefed on the global Covid-19 situation and the domestic scenario, including the preparedness of all stakeholders.

Noting that only 27-28 per cent of India's eligible population have taken the precaution dose of Covid-19, NITI Aayog member (Health) Dr VK Paul, after the meeting, said people should take the jab as quickly as possible, "People should wear masks in crowded areas. Those with comorbidities and old should especially adhere to this rule and take the jab," Paul asserted.

Meanwhile many state governments including Maharashtra and Karnataka said random testing of passengers will start soon.

Mandaviya meanwhile said that keeping in mind the upcoming festive season, people should exercise restraint in whatever they are doing. He directed for strengthening of the surveillance system for whole genome sequencing of positive case

IACKLE **BF.7 VARIANT**

BHUBANESWAR: The Odisha government is taking all precautionary measures keeping in mind the threat of the BF.7 variant of Covid-19. Health Secretary of the Odisha government, Shalini Pandit said in a letter Wednesday that surveillance has to be increased to tackle the new variant. She said in the letter that timely detection of the variant will help in its containment. Sources in the government meanwhile said that a number of testing centres will be reopened both in the Odisha capital and Rourkela, the two cities where matches of the FIH Men's Hockey World Cup will be played. Government officials, when asked about the BF.7 case found in Odisha said that it happened in October and the patient has left the state since then







Bhubaneswar, Dec 21: A delegation of BJD MPs Wednesday met Union Finance Minister Nirmala Sitharaman and demanded withdrawal of 18 per cent Goods and Services Tax (GST) on trade of kendu leaves, considered as green gold of Odisha

In their memorandum submitted to the FM, the BJD MPs mentioned that kendu leaf, used for wrapping 'bidis', is an important non-wood forest produce of the state.

Around 8 lakh pluckers, binders and seasonal workers, mostly belonging to the tribal community and poor families, are dependent on the trade of the forest produce, they said.

The tribal people collect kendu leaves as part of their rights defined under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. They have the rights to procure and The delegation of **BJD MPs said that** withdrawal of GST will help improve the lives and livelihood of eight lakh people associated with the kendu leaf trade

"Imposition of 18 per cent GST is adversely affecting the kendu leaf trade," it said.

The delegation of BJD MPs from Lok Sabha and Rajya Sabha also claimed that if the GST is withdrawn, it will help improve the lives and livelihood of eight lakh people associated with the trade of kendu leaf.

Notably, the GST being levied on the forest produce was a major issue in the recently concluded Padampur bypoll, and the ruling party attacked the BJP-led NDA government at the Centre on this matter.

Earlier. Chief Minister Naveen Patnaik had written to Sitharaman, requesting her intervention for the withdrawal of GST on kendu leaf.

Odisha Finance Minister Niranjan Pujari had also raised the issue in the 48th GST Council meeting held December 17 and demanded for exemption of the indirect tax on the forest produce.

New Delhi, Dec 21: The Biju Janata Dal (BJD) Wednesday reiterated its longstanding demand for special category status to Odisha on account of the massive economic loss that the state faces due to natural calamities.



AI-based digital marker to measure characteristics of heart disease: Study

cientists have constructed an in sil-Sico, or computer-derived, marker for coronary artery disease (CAD) to better measure clinically important characterizations of the disease, a new study has found.

Using machine learning and clinical data from electronic health records, the researchers at the Icahn School of Medicine at Mount Sinai in New York are the first ones to map characteristics of CAD on a spectrum. Previous studies have focused only on whether or not a patient has CAD, the study said.

CAD and other common conditions exist on a spectrum of disease; each individual's mix of risk factors and disease processes determines where they fall on the spectrum. However, most such studies break this disease spectrum into rigid classes of case (patient has disease) or control (patient does not have disease). This may result in missed diagnoses, inappropriate management, and poorer clinical outcomes, said the investigators.

The findings, published in the journal The Lancet, are expected to lead to more targeted diagnosis and better disease management of CAD, the most common type of heart disease and a leading cause of death worldwide, the study said.

"The information gained from this non-invasive staging of disease could empower clinicians by more accurately assessing patient status and, therefore, inform the development of more targeted treatment plans," said Ron Do, senior study author, Icahn School of Medicine. "Our model delineates coronary artery disease patient populations on a disease spectrum; this could provide

more insights into disease progression and how those affected will respond to treatment

"Having the ability to reveal distinct gradations of disease risk, atherosclerosis, and survival, for example, which may otherwise be missed with a conventional binary framework, is critical," said Do. In the retrospective study, the researchers trained the machine learning model, named in silico score for coronary artery disease or ISCAD, to accurately measure CAD on a spectrum using more than 80.000 electronic health records from two large health system-based biobanks, the BioMe Biobank at the

Mount Sinai Health System and the UK Biobank. According to the study, the model, which the researchers termed a "digital marker", incorporated hundreds of different clinical features from the electronic health record, including vital signs, laboratory test results, medications, symptoms, and diagnoses, and compared it to both an existing clinical score for CAD, which uses only a small number of predetermined features, and a genetic score for CAD.

The 95,935 participants included participants of African, Hispanic/Latino, Asian, and European ethnicities, as well as a large share of women. Most clinical and machine learning studies on CAD have focused on white European ethnicity, the study said.

The investigators found that the probabilities from the model accurately tracked the degree of narrowing of coronary arteries (coronary stenosis), mortality, and complications such as heart attack, the study said.

"Machine learning models like this could also benefit the health care industry at large by designing clinical trials based on appropriate patient stratification. It may also lead to more efficient data-driven individualized therapeutic strategies," said lead author Iain S. Forrest, Icahn Mount Sinai,

"Despite this progress, it is important to remember that physician and procedure-based diagnosis and management of coronary artery disease are not replaced by artificial intelligence, but rather potentially supported by ISCAD as another powerful tool in the clinician's toolbox,' said Forrest.

Open access solution to problem at the heart of scientific research

he Covid-19 pandemic exposed many flaws in the way our societies function. Among the less obvious is the gaping problem at the heart of scientific research. In March 2020, scientists were scrambling to understand what the new virus was, how it affected patients, and how it could be treated.

National science agencies from nations including the UK, Australia, Italy, the United States and Brazil called for publishers to make coronavirus research immediately and freely accessible, which in the most part they did.

But the very need for these groups to call for research to be made available in the middle of a global emergency demonstrates the failure of the current publishing system. Making research immediately free to read, which, when combined with the use of an open publishing licence, is known as 'open access' — is a hot topic in

science Global health bodies know how important open research is, espe-

cially in times of emergency, which is why they have repeatedly called for research to be made open.

The latest plaintive request came in August 2022 from the US White House Office of Science and Technology Policy for mpox research to be made open. Previous global calls were in 2016 for Zika and in 2018 for Ebola. The consequences of lack of ac-

cess to research can be dire. In 2015 a group of African re-

searchers claimed that an earlier Ebola outbreak could have been prevented if research on it had been published openly. The past 12 months have seen a

flurry of changes in open access globally and from January 2023, the high profile journal Science will allow published research to be immediately placed in publiclyaccessible repositories at no cost to scientists.

In August 2022, the Office of Science and Technology Policy issued a memorandum to all US research funding agencies that by 1 January 2026 they must make all

the data behind that research. Though the language of the memorandum has been criticised for not specifying how the research is to be made open, it clearly articulates the why and when.

How each federal agency interprets the memorandum will be watched not just in the US but elsewhere, especially as it will provide examples of a diversity of approaches to open access.

The benefits of open research extend beyond simply increasing the readership and use of research

among academics.

Open access is just one part of a global movement of open science that in 2021 led to UNESCO, the United Nations education, science and cultural organisation, to issue 'Open the Science Recommendation'

This is a world-leading initiative that sets international standards for open science built on values such as equity, diversity, collective benefit, quality and integrity.

The recommendation lays out why open science is important, including increasing return on investment, improving the effectiveness and productivity of scientific systems, pushing back against misinformation and disinformation, and addressing existing systemic inequalities to produce and access research.

Crucially, the recommendation is not just a piece of text to be written and forgotten, but rather it has been accompanied by a programme of implementation actions and will include a monitor-

ing process to hold signatories to account.

The UNESCO recommendation, like the Office of Science and Technology Policy memorandum, does not prescribe any particular pathway to open access and we will therefore see a diversity of routes to open access.

Allowing a diversity of approaches also recognises the reality that open access and open science are not static concepts and that they will evolve over time as culture and technology change.

A diversity of approaches also guards against a small number of commercial publishing houses dominating

Many publishers are now negotiating nation-wide deals that bundle reading and open access publishing together. The Confederation of Open Access Repositories has made the case for more diversity in publishing, including through university repositories. As 2023 unfolds, it seems that the benefits of open access have been proved beyond doubt.



Bolangir: Dec 21: A ten-member Crime Branch team along with forensic experts has Wednesday started investigation into alleged suicide of Gobinda Sahu, the prime accused in Mamita Meher murder case, in Kantabanji sub-jail. His body was handed over to his family members after post mortem and which was later consigned to flames at his native Mahaling village.

Reports said, the CB team led by DSP Bijay Kumar Mallick accompanied by a scientific team reached Kantabanji sub-jail at 10am Wednesday. On the other hand, the body of Sahu had been brought to BBMCH, Bolangir Tuesday night and was kept in morgue. A team of doctors conducted post mortem in the forenoon today in the presence of a magistrate as per the NHRC guidelines. Security arrangements had been made on the BBMCH premises. Gobinda Sahu's in-laws Mahendra Sahu and Tuna Sahu were present at the hospital.

His relatives alleged that Gobinda's suicide inside the jail is not believable. "He was a strong minded person. As Mamita Meher case is a sensitive one, Gobinda might have been murdered. Two

sheets of papers were recovered from the pockets of Sahu, but police did not reveal what was written on them," Mahendra Sahu rued

Keonjhar, Dec 21: A controversy has broken out over construction of a stockyard near Talakainsari village under Banspal block in Keonjhar district. Local tribal residents have strongly opposed the project.

The locals have long been appealing to the administration to stop the project claiming that the land on which the stockyard is being built by Gandhamardan iron ore mine was under their occupation for many years in the past.

"We were raising paddy and other crops. As elephant menace continued, we had given up farming on the land. We oppose the construction of the stockvard on our land." locals Bhimsen Munda, Laxmidhar Munda, Rato Munda, Raya Munda and Dhaneswar Nayak said.

They also alleged that the mining company is trying to snatch their land by building a stockyard.

Some villagers have moved the sub-divisional magistrate's court to stop the work seeking proclamation of Section-144 on the land.

Admitting the petition, the court has ordered the local IIC to look into the matter.

Notably, Gandhamardan iron ore mine is building a stockyard on 12.50 acre of land. Many trees on the land have been cleared while construction work is underway. "After an investigation, truth will come out and action will be taken accordingly," said sub-divisional magistrate Ramachandra Kisku.

Role of rangers in Similipal Tiger Reserve under scanner

Nine out of 16 posts of rangers are lying vacant in the tiger reserve

Baripada, Dec 21: Protecting forests and wildlife is the duty of the range officers posted in the Similipal Tiger Reserve (STR) of Mayurbhanj district. However, staff crunch and range officers going on long leaves have severely affected the day-to-day functioning of the range offices inside the STR.

There are also instances of range officers handing over charges to their juniors and going on leave. As a result, poachers and timber mafia gangs are having a field day inside the forest

Locals have lost faith in forest officials. The recent poaching of a tusker and the involvement of forest officials in disposing of evidence by burning the carcass have only compounded the problems. Apart from that, the Special Task Force's seizure of a Royal Bengal Tiger skin has put forest officials on the defensive.

Sources informed that majority of the range offices are being manned by junior officials. Nine out of 16 posts of rangers are lying vacant under the STR-North and garding the death of the tusker and the burning of the carcass

Former honorary wildlife warden Bhanumitra Acharva alleged that the Forest department is trying to sweep the entire matter under the rug to cover up its own wrongdoing.

Wildlife lovers have demanded action against Forest department officials responsible for the death of a Kumki elephant, which died due to alleged medical negligence.

They have also demanded the transfer of inexperienced officials posted in the Similipal National Park and STR and a probe into disproportionate assets earned during their period of service in the sanctuary. The demand for action against officials working in collusio with the poachers is als growing.

When contacted, ST field director T. Asho Kumar said that the range who was on leave had bee asked to join work after the poaching of the jumb He added that requests hav been sent to the Odish government to fill up the v cant ranger posts.

Time to Deglobalise

fter four decades of fostering integration through trade and finance, the global economy has begun a painful process of fragmentation. Initially driven by wealthy countries – namely, the United States under former President Donald Trump and the United Kingdom following the Brexit referendum – several geopolitical forces have combined to accelerate the shift toward deglobalisation.

The fracturing of global trade could herald the fragmentation of international capital markets. COVID-19-related lockdowns and closures have disrupted global supply chains and shut down major production centers, most notably in China. Similarly, the war in Ukraine has altered trade routes and forced Western countries to find alternative suppliers of major commodities like oil, gas, wheat, and fertilizers. Western-led sanctions on Russia have further impeded trade and sharply increased food and energy prices.

But while global trade could become even more fragmented if major economies adopt protectionist policies such as border carbon taxes, financial markets remain strongly integrated. Cross-border capital flows are still largely unregulated and more volatile than ever. It's a combination that is currently proving to be lethal for many low- and middle-income countries. The liberalisation of capital accounts in these countries in the 1990s has

led to large inflows of "hot money": private financial capital driven not so much by developing countries' economic outlook as by developed countries' macroeconomic policies. In the years following the 2008 global financial crisis, capital flows to emerging and "frontier" markets surged as prolonged monetary expansion by developed countries' central banks fueled asset bubbles. Financial agents borrowed cheap in dollars and either lent in foreign currency to developing countries or invested in local currency markets. Capital inflows triggered higher interest-rate spreads and currency appreciation, making carry trades particularly lucrative - at least for a while

Over the years, the inflows of hot money, often held as reserves and invested in low-return dollar assets, have made emerging and developing economies vulnerable to capital flight. This has had a dampening effect on these countries fiscal policies, as rising seigniorage costs have stoked fears of credit-rating downgrades.

The rapid interest-rate hikes in the US and the European Union have compounded low and middle-income countries' external debt burdens, forcing them to raise interest rates even more aggressively than advanced economies and hindering their recovery from the COVID-19 pandemic. Moreover, these dramatic rate hikes have not prevented fickle foreign investors from fleeing, causing emerging-market currencies to depreciate and severely damaging labour markets and growth prospects. But the developed countries' combination

of higher interest rates and fiscal consolidation is counterproductive, as it risks causing recessions without addressing the real forces behind surging inflation. As a result of following the US Federal Reserve's lead, many lowand middle-income countries already face severe stagflation - and integration with global finance is worsening their economic woes.

Instead of mimicking developed countries' ineffective approach, developing and emerging countries must introduce policies tailored to their specific needs and political economies. Such policies include controlling the prices of key commodities, increasing domestic production to alleviate critical shortages, and ensuring social protections for the newly unemployed and those who are worst affected by high inflation.

Above all, developing countries must introduce more effective capital controls. Imposing constraints on volatile portfolio flows, particularly those that contribute to currency depreciation, is crucial to mitigating the risks associated with financial globalisation. Moreover, just as several developing countries have explicitly or implicitly defied the US-led trade sanctions on Russia, policymakers must break free from the US-dominated international

HERALDING A NEW ERA

ith the launch of the country's first privately developed rocket named Vikram-S by ISRO on 18 November 2022 from its facilities at Sriharikota India has entered into a new era of space programme which is now actively thrown open for private partnership. Earlier, the exploration of the space sector was purely the domain of ISRO, India's state-owned body, which was established under the able leadership of Dr Vikram Sarabhai in 1969. In its illustrative career of 53

years, ISRO has not only sent missions for exploring the outer space including the Moon and the Mars in its own vehicles, but also successfully launched satellites of other nations on a commercial basis. The organisation has made India self-reliant in the field of space technology and its application to the cause of national development in areas like agriculture, forest cover mapping, disaster management, weather forecast ing, and communication. It has also demonstrated how crucial space missions could be accomplished with a low investment economy affordable by a developing nation like India. However, ISRO's earnings over the years were only 2% of the global space market. Although this is a minuscule amount, India's space sector aims to make it 8% in coming days by including active participation of private players in the field. The new space policy and nounced by the Government of India will remove most of the constraints faced by the private players, who can now look forward to building satellites, leasing out transponders, building launch vehicles and exploring the whole world of space-based applications. While the transition for NASA to the realm of private sector business took nearly a decade, India can aspire to reach the same status in the next 10 to 15 years with the opening up of its space sector. ISRO is also expanding its launch facilities by developing a third launch pad at Sriharikota and another spaceport in Tuticorin dis-

trict of Tamil Nadu to facilitate increasing use of its infrastructure by private stakeholders

The Vikram-S rocket was developed by a Hyderabad-based startup named Skyroot Aerospace Private Limited over a period of two years of research and hard work. The six-meter tall singlestage solid fuelled, sub-orbital rocket soared to an altitude of 89.5 km after its launch and met all the flight parameters and mission objectives before having a smooth splash down in the Bay of Bengal covering a total time span of nearly five minutes. One of the notable features of the mission was that few advanced technologies were incorporated in some of its designs such as the use of carbon composite structures in building its motor casing and 3D printer components in building its thrusters. The Vikram-S Rocket is equipped with a gross lift-off mass of 545kg with a payload mass of 80kg. In its maiden flight, it carried three customer payloads which will map the measurement and validation of certain flight parameters and payload integration processes. The rocket will help validate the technologies that will be used in the subsequent Vikram-1 orbital vehicle of Skyroot that is planned for launch next year, subject to technical clearance from the reg-

ulatory authority IN-SPACe. The rocket was named after Dr Vikram Sarabhai, the Father of India's

Space programme. The launch of India's first privately developed rocket was a tech-

nology demonstration to show case the tremendous potentials of Indian private players in the field. The Indian National Space Promotion and Authorization Centre (IN-SPACe) has been designated as a nodal agency under the Department of Space (DoS) to look after the private sector's access into the field. It has given five authorizations to various space NGEs for undertaking space activities in India and signed six teen MoUs. Till date, IN-SPACe has received more than 150 applications from different space NGEs for authorization, facilitation, and promotion. Union Minister of State for Science and Technology & Earth Sciences, Jitendra Singh, has described the achievement as a new dawn in building India's space ecosystem. The unlocking of the immense

potential of the Indian space sector began with a landmark policy decision taken by the government in June, 2020. Previously, the role of the private sector was limited only to the supply of satellite hardware to ISRO. But now, the private sector can play a more proac-

tive role by not only building satellite parts or complete satellites, but also launching them using ISRO's facilities subject to clearance from IN-SPACe.

This will also give a boost to the space tourism sector in India which is yet another untapped area to be exploited. Private agencies can now fare prospective tourists in their own vehicles to low earth orbits in zero gravity conditions and present them a glimpse of the uncanny space and the rare view of the earth from that van tage location and earn handsome revenue in return. This is a huge field to be explored.

Space exploration is entering a new era of innovation and change ever since Sputnik-1 sent its first message back to earth. The space race that followed was fuelled by the tensions of the Cold War. It was funded by the US and the USSR, both racing for technolog ical and military supremacy. At the time, only global superpowers had the resources to even imagine a space programme. Today, new technologies, new uses of space and decreasing costs have made space flight far more accessible. Private space companies now can launch satellites, resupply the International Space Station, and even offer spaceflights to private citizens. However, large companies like Boeing, Lockheed Martin, and Northrop Grumman have been involved in space flight for many decades. In contrast, smaller space startups are now creating innovative technologies and developing new industries in space to embark on this new field. These include notably three companies such as SpaceX. Blue Origin and Virgin Galactic that hope to push innovation forward to expand humans' reach into the cosmos. India's entry into this new field is expected to usher in progress and prosperity for the country which will eventually help the whole of humanity to unravel the mysteries of this vast void universe.

Given that most developing countries cannot afford to act on their own, regional cooperation is also critical. The United Nations Conference on Trade and Development's annual report mentions several innovative forms of finance and exchange payments that Global South countries could implement to counter advanced economies' financial dominance, including "South-South clearing unions."

If trade among Global South economies grows quickly, the report notes, the flows will be settled in their own currencies or through regional currency mechanisms. Such mechanisms could also help negotiate debt-restructuring deals, provide financial insurance at the regional level, and even establish stabilisation funds to improve countries' foreign-asset positions.

Financial globalisation was supposed to usher in an era of robust growth and fiscal stability in the developing world. It ended up doing the opposite. Now, to restore their economic viability, low- and middle-income countries must make the most of deglobalisation and embrace the fragmentation of international capital markets

Dydler

n 2007, the Royal Society for the Protection of Birds (RSPB) bought a remote fen in the Norfolk Broads, so isolated that few people had ever been there. This is from one report of the sale: A few wild-fowlers would have visited it by boat when it was owned by Lord Percy; a handful of marsh men and sedge cutters still go there occasionally to harvest reeds; ditch "dydlers" are sometimes sent in to keep the water channels open from vegetation, and a few naturalists and artists know about this lost world of swamp and sky (The Guardian, 8 Jan. 2007). As this indicates, a dydler is a clearer of water channels in the Broads. He gets his name from his principal tool, the dydle. Though cutting drainage ditches has always been part of the job, the dydler used to be as often occupied with dredging navigable channels through the fens. The Oxford English Dictionary points out that early examples of dydle, from the sixteenth century, could also refer to a sharp triangular spade for edging ditches that was used in conjunction with a crome, a hooked stick to remove weeds.

by engaging Union & state governments, district administration, civil society and public in a single platform and manage all data and complaints related to child labour practice through a single database, the government launched PENCiL (Platform for Effective Enforcement for No Child Labour) portal on 26 September 2017. Successful implementation of the Act, complaint cell, convergence of all departments, management of National Child Labour Project (NCLP) and tracking of children remain the main components of this portal. Through the complaint cell on this portal, anyone who sees child or adolescent labour being employed anywhere in the country can file a complaint immediately without going to the office. By clicking on the new complaint link, a complaint can be filed by providing the details of the child/adolescent employed, the address of the workplace and the details of the complainant. On receiving the compliant, the District Nodal Officer investigates the genuineness of the allegations and takes action as well as rescues the concerned child/adolescent labourer. Rescued children between the ages of 5 to 8 are ad-

NCLP Special Training Centres (STC) and adolescents of 15-18 age group are admitted to the relevant skill development centres

Since the opening of the PENCiL portal, the management of all NCLP STCs has been accepted through the portal only. STCs were also forced to upload the daily attendance of the child labour students through the portal only. But the infrastructure was not developed for the purpose. For example, in STCs, the salary of a working teacher and accountant is ₹7000 and ₹5000 per month respectively. How can the employee buy an Android phone and how to recharge data pack every month to manage the portal with such a salary? Again, according to the data provided by the Union Ministry of Communications in the Parliament this year, out of 5,97,618 villages of our country, 25,067, including 6099 villages of Odisha. have not received mobile and internet services at all. Then how will the public and NCLP STCs of the said villages use the PENCiL portal without mobile and internet facility? The government didn't release funds to the NCLPs who fail to upload information daily through the PENCiL portal as a result of which

child labourers and thousands of workers employed by the government for their rehabilitation.

Examining the data displayed on the PENCiL portal shows how useful the portal's management is. According to the data displayed on this portal on 17 November 2022, only 1.97.365 (0.05%) children were identified in the whole country since launching of the portal. So, during this period an average of only 105 children were identified daily in such a large country? Similarly, while there are 763 revenue districts in our country, according to the data of the PENCiL portal, District Nodal Officers have been appointed in only 620 districts in the last 62 months. What about the future of the children of the remaining 143 districts? The user ID and password required to use this portal has not been provided by the ministry for years. Most of the staff have not been given the necessary practical training to use this portal. Since the stipend amount of the child labour students is also forced to be paid through this portal, till now many child labourers could not get their stipend amount. The launch of this portal is an innovative scheme, but to make it 100 per

all parts of the country. Secondly, to use it, the concerned staff and officials should be given full practical training. During the last Budget speech, the Finance Minister announced in Parliament that the NCLP, which has been functioning smoothly since 1988 for the welfare of child labour across the country under the Ministry of Labour and Employment, will be subsumed in the Samagra Shikshya Abhiyan. Here the question arises that if a ministry of the government has been working efficiently for child labour in the country since 1988, in whose interest and why was the responsibility removed from that ministry? After the Finance Minister's announcement, the Ministry of Labour did not take over the NCLP and the Ministry of Education did not take any action. As a result, millions of child labourers and employees of the country are forced to beg on the streets today for livelihoods.

Parl passes anti-piracy Bill

New Delhi, Dec 21: Parliament Wednesday passed a Bill which provides for prevention of maritime piracy and stringent punishment to those convicted of such crimes.

The Rajya Sabha passed the Maritime Anti-Piracy Bill 2022 by voice vote Wednesday. The Bill was passed by the Lok Sabha Monday.

Moving the Bill for consideration and passage in the Rajya Sabha, External Affairs Minister S Jaishankar said it has provisions for the prevention of maritime piracy, will strengthen India's maritime security and give it an effective legal instrument to combat the menace.

"Ensuring maritime security is key to safeguard India's security and economic wellbeing," he said. The Bill was initially introduced in the Lok Sabha December 9, 2019 and referred to the Standing Committee on External Affairs for examination. Jaishankar said the ministry had held several rounds of extensive inter-ministerial consultations with the departments concerned to incorporate the recommendations of the Standing Committee. Out of 18 recommendations of the Standing Committee, 14 have been incorporated suitably in the Bill, he said, adding that three recommendations were only observations which too have been duly noted. "The bill addresses the issue of death penalty as an exceptional case and the quantum of punishment envisaged are in

The passenger is also heard telling her, "You are a servant of a passenger", to which she responded, "I am an employee and not your servant... I am not vour servant." At one point, the passenger said "why are you yelling? Shut up" to the air-hostess, who also asks the former to "shut up", according to the nearly one-minute-long clip that was apparently shot by a passenger in the flight. A senior official at the Directorate General of Civil Aviation (DGCA) said the regulator is looking into the incident and shall take appropriate action.

Fire in restaurant, no casualty

New Delhi: A fire broke out Wednesday at a restaurant in South Extension Part-2 of the city, officials said here. Fire services officials said they were informed about the fire around 12.45 pm and they rushed eight fire tenders to the spot. The restaurant is near a petrol pump, they said, adding that the fire was doused around 4 pm. According to police, the fire was doused with the help of fire tenders and DDMA staff. No injury was reported, a senior police officer said.

CBI takes over missing girl's case

New Delhi: The CBI has taken over the probe into a case where a six-year girl went missing from a Saraswati Puia pandal in Bihar's Muzaffarpur February 16 last year, officials said Wednesday. The agency acted with alacrity registering the FIR within 15 days of the case being handed over to it by the Patna High Court December 5, they said. The girl had gone missing last year but local police failed to make any headway into the matter following which the case was given to the CBI, they said.

Hoax social media bomb threat at IGI leads to security drills

New Delhi, Dec 21: A social media chat about "bombing and eliminating" Delhi's IGI Airport led to a brief panic and triggered a counter-terrorist security drill at the country's largest civil aviation facility Wednesday, official sources said. The threat was categorised as "non specific" or hoax around 6:30 am after over an hour of conducting anti-sabotage checks at the facility even as normal passenger traffic continued, they said.

Airport security officials, sources told PTI, were informed about a social media post, in reply to an another message, that the Indira Gandhi International Airport should be bombed. The chat posts, whose creators are being traced by the police, also talked about "eliminating" the airport, the sources said. A bomb threat assessment committee (BTAC), comprising security, intelligence and airport operators, was triggered into action soon after the chats were flashed at the IGI control room around 5:15 am.

The threat was declared a "hoax" and "not serious" after about an hour of anti-sabotage checks at the three IGI terminals by the Central Industrial Security Force (CISF), the Delhi Police and airport authorities, they said.

Biting cold, dense fog grip north India

New Delhi, Dec 21: Intense cold and dense fog gripped large swathes of north India Wednesday, significantly reducing visibility, disrupting rail services and causing a vehicle pile-up in Uttar Pradesh while the harshest winter period 'Chilla-i-Kalan' set in Kashmir freezing fringes of many water bodies.

However, three flights were returned or diverted to the Delhi airport due to bad weather in Chandigarh, Varanasi and Lucknow Tuesday night.

Amid low temperatures, high moisture and still winds, a layer of dense to very dense fog persisted over Punjab, Haryana, northwest Rajasthan, Uttar Pradesh, Bihar and parts of Uttarakhand, according India Meteorological Department. At 5:30 am, visibility levels stood at zero in Bhatinda; 25 m in Ganganagar, Amritsar and Bareilly, and 50 m in

fog in many/most pockets is very likely over Punjab, Haryana, Delhi and Uttar Pradesh during night and morning hours in the next 24 hours due to moisture and light winds at lower tropospheric levels over the Indo-Gangetic plains. According to IMD, very dense fog is when visibility is between 0 and 50 metres, 51 and 200 is dense, 201 and 500 moderate, and 501 and 1,000 shallow.

The Sadarjung Observatory, the primary weather station in Delhi. recorded a minimum temperature of 7.1 degrees Celsius, a notch below normal. The maximum temperature settled at 21.2 degrees Celsius, the lowest so far this season.

The minimum and maximum temperatures are likely to drop to 5 degrees Celsius and 20 degrees Celsius in the next few days. On the Lucknow-Gorakhpur National Highway, a bus overturned after colliding with a truck which led to the pile-up of more than 12

New Delhi, Dec 21: Government has no plans to reduce the age of consent for consensual relationships, the Rajya Sabha was informed Wednesday.

In a written reply to a question whether the government is considering changing the age of consent for consensual relationships to 16 years from the present 18 years, Women and Child Development Minister Smriti Irani said the question "does not arise". The minister said the Protection of Children from Sexual Offenses

(POCSO) Act, 2012 enacted to safeguard children from sexual abuse and sexual offences clearly defines a child as any person below the age of 18 years.

The Act was further amended in 2019 to introduce more stringent punishment, including death penalty for committing sexual crimes on children, with a view to deter the perpetra tors and prevent such crimes against children.

"In case of commission of offence by child, Section 34 under POCSO Act already provides procedure in case of commis-



sion of offence by child and determination of age by Special Court," the minister said.

"If any question arises in any proceeding before the Special Court whether a person is a child or not, such question shall be determined by the Special Court after satisfying itself about the age of such person and it shall record in writ-

ing its reasons for such determination," Irani said. The minister added that The Majority Act, 1875, which was amended in 1999, provides 18 years as the age for attainment of majority.

In reply to another written question on child marriages, the minister informed the Rajya Sabha that number of cases of child

marriages reported has increased over the last few years as per the data of National Crime Records Bureau, but added that it does not necessarily reflect increase in the number of cases of child marriages, but may be because of increased awareness.

In 2019, 523 cases of child marriage were reported, in 2020 it was 785, and in 2021, it was 1050. "Higher reporting of cases does not necessarily reflect increase in the number of cases of child marriages, but it may be because of increased awareness among citizens to report such incidents due to initiatives such as Beti Bachao Beti Padhao (BBBP), Women Helpline (181) and Childline (1098) implemented by the Ministry and better enforcement of law by states/Union Territories," Irani said.

Toronto: Eight teenage girls who apparently met on social media have been charged with second-degree murder in the stabbing death of a 59year-old man in Toronto. police said Tuesday. Investigators allege that the girls assaulted and stabbed the man in the city's downtown core early Sunday morning. According to police the eight girls were arrested near where the attack happened. Three of the girls are 13 years old, three are 14 and two are 16.

The site, about 35 km (22 miles) southwest of Bethlehem, has been known for generations as the Cave of Salome.

Earlier excavations located Jewish relics "but the surprise was the adaptation of the cave into a Christian chapel," the IAA said. "Judging by the crosses and the dozens of inscriptions engraved on the cave walls in the Byzantine and Early Islamic periods, the chapel was dedicated to the sacred Salome.³



anished from public consciousness for decades, the nightmare of Nuclear warfare has surged back to prominence with Russia's invasion of Ukraine, highlighting the erosion of the Cold War global security architecture.

With Moscow on the back foot in its offensive, the military stalemate has raised fears Russia could resort to its nuclear arsenal to achieve a military breakthrough. Russia, along with Britain, China, France and the United States, are the five recognised Nuclear weapons powers and permanent UN Security Council members. For now, the moral and strategic nuclear "taboo" that emerged after the US bombings of Hiroshima and Nagasaki at the end of World War II in 1945 still holds. But rhetoric has escalated massively. India, North Korea and Pakistan, along with the five recognised powers, also have nuclear weapons, while Israel is widely assumed to do so while having

never officially acknowledged it. North Korea sharply steppedup missile testing this year, continuing its pursuit of an independent nuclear deterrent that began when it quit the Non-Proliferation Treaty (NPT) in 2003.

Washington, Seoul and Tokyo all believe a seventh nuclear weapons test by Pyongyang is imminent. The isolated dictatorship announced in September a new nuclear doctrine, making clear that it would never give up the weapons and that they could be used preemptively.

Non-nuclear countries in the region fear that the protection provided by the US nuclear umbrella is fraying. The invasion of a state that willingly gave up nuclear weapons, Ukraine, by its nucleararmed neighbor has increased fears of proliferation.

NUCLEAR Chaos, crisis, catastrophe

ince the invasion began in February, Russia made most of its gains in the first month of the war when it seized Kherson, surrounded Mariupol, and was on the doorsteps of Kyiv and Kharkiv. But Russia soon gave up on Kyiv and withdrew all its forces from the north.

In the first week of the counter offensive, Ukraine liberated more territory than Russia had captured in the previous five months. The success of the counter offensive showed that Ukraine's military was superior to Russia's in every category with the exception of size.

The Ukrainians were able to conquer much of the territory without using many troops on the ground. Instead, Ukraine used long-range rockets supplied by the US and NATO allies to bombard Russian bases and supply lines that were previously unreachable. After nine months of fighting, the Russian military has shown itself incapable of seizing and holding a large part of Ukraine.

With the help of western air defence systems, Ukraine was shooting down 50 per cent of Russian missiles in October and is now intercepting over 80 per cent of them. For the energy industry, 2022 will be remem-

bered as the year Russia's invasion of Ukraine accelerated a global crisis. The invasion, and subsequent Western sanctions, heaped new pressures on oil and gas supplies already strained from the rapid economic rebound from the pandemic. The world's top energy

Mumbai, Dec 21: The Sensex slumped 635 points while the Nifty finished below the 18,200-mark Wednesday as surging Covid cases in China and concerns over renewed outbreaks in other countries sapped risk appetite.

Three cases of Omicron subvariant BF.7, apparently the strain driving China's current surge of Covid cases, have been detected in India so far, official sources said. Different sets of data modelling indicate that China could be facing a massive death toll after it lifted its stringent zero-Covid policy.

Declining for the second straight day, the 30-share BSE benchmark Sensex tumbled 635.05 points or 1.03 per cent to settle at 61.067.24. The broader NSE Nifty declined 186.20 points or 1.01 per cent to end at 18,199.10.

IndusInd Bank was the biggest laggard in the Sensex pack, shedding 2.28 per cent, followed by Maruti Suzuki, UltraTech Cement, Bajaj Finserv, ICICI Bank, Tata Motors and Axis Bank.

Sun Pharma topped the index gainers' chart with a jump of 1.67 per cent. HCL Technologies, Tech Mahindra, TCS, Nestle India, Wipro and Infosys were the other winners. climbing as much as 1.01 per cent.

In the broader market, the BSE smallcap gauge tumbled 2.18 per cent and midcap index declined 1.40 per cent. Among sectoral indices, utilities declined 2.50 per cent, followed by power (2.40 per cent), services (2.34 per cent), telecommunication (2.32 per cent), industrials (2.13 per cent) and commodities (1.91 per cent).Healthcare

Over 17 million votes were cast in the poll that began Sunday evening and ended early Monday morning with most respondents voting in the affirmative, CNN reported. Musk had not immediately reacted to the outcome of the vote and declared two days after the poll that he will resign as soon as he finds someone foolish enough to take the job.

He had tweeted on Sunday: "Should I step down as head of Twitter? I will abide by the results of this poll".

"As the saying goes, be careful what you wish, as you might get it," Musk added in a later tweet. A total of 57.5 per cent voted "yes" after Musk asked his 122 million followers whether he should stand down.

In the past, Musk has obeyed Twitter polls. He's fond of quoting the phrase "vox populi, vox dei", a Latin phrase that roughly means "the voice of the people is the voice of God". Musk also announced on Twitter that major policy changes would be voted on moving forward.

The poll comes as Twitter says it will shut down accounts solely designed to promote other social media platforms.

The measure would also affect accounts that link off to or contain usernames from platforms such as Facebook, Instagram, Mastodon,

Truth Social, Tribel, Nostr and Post, the company said in a tweet. But cross-content posting from other sites will still be allowed. Twitter had already blocked users from sharing some links to Mastodon, the platform many Twitter users moved to after Musk's takeover. Musk's announcement was the

latest in a series of decisions by Twitter to generate blowback, after the suspension last week of more than half a dozen journalists who report on Musk.

On Friday, he reinstated a number of journalists he had suspended for allegedly sharing location data about him after the EU and UN called it an attack on press freedom. Musk has started, stopped, and

restarted a revised verification system that costs \$8 for a blue check mark.

The RBI has raised repo rate by 225 basis points since May to 6.25% as it continues its fight against inflation. In contrast, the US Federal Reserve raised interest rates by 425 bps to 4.25%-4.50%.

The Fed is set to raise rates to above 5% in 2023, which may force India's central bank to also follow suit. the treasury official said.

He expects the Indian rupee to remain vulnerable, with a possibility of hitting a fresh record low, as the dollar index braces to rise again.

We may see another 1.00-1.50 rupee move on the exchange rate against the dollar on the downside. We are not expecting much appreciation on the rupee at least until there is a sustained increase in foreign flows to India," Arun Bansal said. The currency was at 82.81 against the dollar, and down 11.4% so far in 2022 Bansal expects the benchmark 7.26% 2032 bond yield to stay in the 7.00%-7.35% band in the near term. and rules out chances of any major increase, even if the reporate reaches 6.75% "Most of the negatives are also priced in," he said, adding that any increase in yields after a rate hike will be temporary. Money in the fund would be used by a market regulator to buy carbon credits if prices fell too low, one of the officials said. Consistent investor interest in

credits and a floor under the price would be needed because sharp falls in the market could discourage industries from reducing carbon dioxide emissions. that official added.

Planning envisages the market becoming fully operational in 2026, covering 37% of the country's emissions, according to slides, seen by Reuters, that the Power Ministry has shown to stakeholders. The sources said the government intended to publish the market's rules soon.

In creating a carbon market, a country sets a limit on emissions and then allocates a corresponding quantity of tradable permits, or credits, to emitters. The quantity reduces over time. If a company

New Delhi, Dec 21: Two of Indian cricket team's main sponsors, edtech major Byju's and MPL sports, want to exit from their sponsorship agreements with the BCCI. In June, Byju's had extended its

jersey sponsorship agreement with the Board until November 2023 for an estimated USD 35 million. Byju's now wants to terminate its agreement with the BCCI which has asked the company to continue at least until March 2023.

"BCCI received an email from Byju's on 4.11.2022 requesting terminating the association post the recently concluded T20 World Cup. As per our discussions with Byju's, we have asked them to continue the current arrangement and continue the partnership at least until 31.3.2023," read a BCCI note on the matter.

The matter was discussed at the BCCI Apex Council meeting Wednesday. The brand had replaced Oppo back in 2019. Byju's was also one of the sponsors of the 2022 FIFA World Cup in Qatar.

The edtech company had recently announced plans to lay off not more than five per cent of its total strength of 50000

Team kit and merchandise sponsor had conveyed the BCCI for the complete assignment of its rights

to Kewal Kiran Clothing Limit (KKCL). The existing contract is valid until December 31, 2023. MPL had replaced Nike back in November 2020.

'BCCI received an email communication from MPL sports 2.12.2022 seeking a complete assignment (team + merchandising) at full value to Kewal Kiran Clothing Limited, a fashion wear brand, for the period from 1.12.2023 to 31.12.2023.

"With the upcoming back to back home series and the women's away calendar, it was suggested that the current arrangement should not be hampered as it involves performance gear for the national teams.

"We have asked MPL sports to continue the association at least until 31.3.2023 or look for a partial assignment that would involve only the right chest logo but not the kit manufacturing agreement," the note read

Earlier this year, Paytm had transferred its title sponsorship rights for Indian cricket's home season to Mastercard.

The Apex Council was expected to decide on the players' central contracts but it would only be done after the formation of the new selection committee. The BCCI had sacked the Chetan Sharma-led panel after the T20 World Cup in Australia.
