SC demonetisation judgement Jan 2

NEW DELHI: The Supreme Court will pronounce its judgment January 2 on a clutch of petitions challenging the Centre's 2016 decision to demonetise currency notes of ₹1,000 and ₹500 denominations. A fivejudge Constitution bench, headed by Justice SA Nazeer, is scheduled to pronounce the judgment. The other judges comprising the bench are Justices BR Gavai, AS Bopanna, V Ramasubramanian, and BV Nagarathna.

Random testing of arrivals at international airports to start Dec 24 and a slew of other measures on cards to prevent the spread of Covid-19

New Delhi, Dec 22: Amid a spurt in Covid-19 cases in China and in some other countries. Prime Minister Narendra Modi cautioned Thursday against complacency and directed officials to strengthen the ongoing surveillance measures, especially at international airports. Modi's assertion came during a high-level meeting, which he chaired to assess the Covid-19 situation in India, preparedness of health infrastructure and logistics, status of the vaccination campaign and the emergence of new variants and their public health implications.

During the meeting, Modi urged everyone to follow Covid-appropriate behaviour, including wearing masks in crowded public places, at all times, especially in view of the



upcoming festive season, according to a statement issued by the Prime Minister's Office (PMO). Advisory regarding the masks has also been sent to all the states, sources informed. They added that the Centre is contemplating to put in place compulsory use of masks again, especially in crowded places.

Modi also urged that precaution doses may be encouraged especially for vulnerable and elderly groups. **Continued on P4**

'Follow rules or face lockdown'

Bhubaneswar: Amid resurgence of Covid-19 due to Omicron BF.7 sub-variant of the virus, Odisha Public Health director Niranjan Mishra said Thursday that people need to take precautions to avoid lockdown and shutdown in the state. "There is no need to panic about the sub-variant of the virus. Covid-19 cases are rising in other countries but not in India, However, chances of a spike can't be ruled out. People should obey Covid-related rules to avoid lockdown and shutdown situations." Mishra warned. Meanwhile a crucial meeting will be held Friday here to discuss containment measures that need to be taken to prevent the spread of the disease. After the meeting, the Health department is likely to announce new guidelines to check spread of the virus.

CM launches slew of projects in Balasore

₹220 CRORE AID FOR 60,000 WOMEN DISTRIBUTED

Bhubaneswar, Dec 22: Chief Minister Naveen Patnaik visited Balasore Thursday and launched 191 developmental projects worth ₹1,806 crore. Patnaik inaugurated projects worth ₹374 crore and laid foundation stone for projects worth ₹1,431 crore. Besides, he inaugurated a Railway overbridge at Somnathpur in the district.

During his visit to the coastal dis-

trict, the Chief Minister also distributed ₹220 crore aid to 60,000 women of 5,600 women Self Help Groups (SHGs) and appealed to them to become entrepreneurs.

Stressing on 'one panchayat one product', Patnaik stressed on the need for each panchayat to produce one 'special' item. "It will help create a market for the product and create a special identity for the panchayat," Patnaik said.

1 dead, 2 injured in Ganjam clash

Patrapur, Dec 22: A youth was killed and two of his relatives suffered critical injuries Thursday after a group of villagers attacked them over past enmity outside the Samantiapalli panchayat office under this block in Ganjam district. The deceased was identified as M Rama Rao of Ambagaon village under the same panchayat. Among the injured are M Krishna Rao and M Lachheya, an uncle and cousin of the deceased.

The incident occurred when the three had gone to the panchayat office to collect their quota of public distribution system (PDS) quota of rice. It should be stated here that in the past similar clashes have occurred between people of a particular community in Ambagaon village. A number of people have suffered injuries in the past due to the clashes.

Thursday also there was fight be-

tween the two groups over rice distribution. Members of one group viciously attacked Rama Rao with sharp weapons leaving him seriously injured.

In an effort to save him, Rama Rao's uncle and cousin were also injured. Locals rescued the three and took them to Patrapur community health centre (CHC) where doctors pronounced Rama Rao dead. Krishna and Lachheya were shifted to the MKCG Medical College and Hospital in Berhampur from where they were again transferred to the SCB Medical College and Hospital in Cuttack after their condition deteriorated.

Meanwhile after the clash personnel from Jarada police station reached the spot and have launched a probe.

Bachelors march for brides in Maharashtra

STATE'S SEX RATIO AT 1,000:920 PREVENTING MANY WANNABE BRIDEGROOMS FROM GETTING THEIR PERFECT MATCH

Pune, Dec 22: A total of 50 eligible bachelors, clad in wedding costumes, riding horses and accompanied with 'band baja and baraat' took out a procession, not to a marriage hall, but to the Solapur district collector's office seeking brides. Their main intention was to highlight the issue of skewed male-female ratio in Maharashtra.

The unusual march, organised by NGO 'Jyoti Kranti Parishad' (JKP),

evoked curiosity, leers and even cheers, but highlighted a major problem gnawing at the rural hinterlands of Solapur and other districts, where there is a stark 'shortage' of girls for marriage to the bachelors, in the age group of 25-40, and even older hopefuls.

The JKP later submitted a memorandum at the district collector's office seeking strict implementation of the Pre-Conception and Pre-Natal Diagnostic Techniques (PCPNDT) Act to improve the male-female ratio in Maharashtra. As per the National



Family Health Survey (2019-21), Maharashtra's sex ratio stands at 920 females per 1,000 males.

All the wannabe grooms carried placards that read, "Wanted a Wife, A

Wife! Anybody can give a Girl to Marry Me! Government, come to your senses and talk to us, you will have to take note of our plight!" A flustered 12-year-old kid Vicky Sadigle led the procession carrying a poster "In future, Will I get married or Not?!"

Shilvant Kshirsagar, 29, who runs a dairy business, was among the 50 eligible bachelors seeking a bride. "I am 29 years old, unmarried, and hail from a rural part of Solapur district. We have a family dairy business and also do farming on two-acre

land. Every time a marriage proposal comes, the prospective bride's first question is whether I live in a city and have a job or not," he said.

"So far there have been 25 marriage proposals but in most cases, the woman's side rejected the proposal after coming to know I do not live in a city and I do not have a job. I have also put up my profile on some matrimonial sites and marriage bureaus, but in vain," a visibly disappointed Kshirsagar said.





Row over Mamita's DNA test report

BJP demands a CBI probe into Gobinda Sahu's death, while a Congress delegation meets Governor *Ganeshi Lal and urges him to direct the state govt for a High Court-monitored SIT probe*

Bhubaneswar, Dec 22: The opposition BJP and Congress Thursday intensified their demand for a neutral inquiry into the death of Gobinda Sahu, the prime accused in Kalahandi woman teacher's kidnap and murder case. At the same time, the disparity in statements by the police and the victim's lawyer regarding the DNA test report of Mamita Meher has kicked up a political storm.

BJP demanded a CBI probe into the incident, while a Congress delegation met Governor Ganeshi Lal and urged him to direct the state government for a High Court-monitored SIT probe.

Raising the issue of disparity in the DNA test report of the woman teacher, Union Minister Dharmendra Pradhan said a CBI probe into Sahu's death is the need of the hour as the incident has raised many questions.

Sahu, who was the president of the school managing committee where the teacher worked, was arrested and lodged in Kantabanji sub-jail in Bolangir district died in suspicious circumstances hours before his production in a local court. His body was found hanging from a tree behind the jail's kitchen

Tuesday. Pradhan said the iail administration needs to answer how Sahu died inside the prison and the manner in which he was found dead raises many questions and suspicion.

Pradhan said. "In a democratic set up the government is answerable to the people ... The disparity in the DNA test report has added to the suspicion in the Gobinda

Sahu death case. While the victim's advocate said that the teacher's DNA report does not match with that of her parents, the police claimed otherwise.'

A five-member Congress delegation submitted a memorandum to the governor seeking a High Court-monitored probe by a special investigation team into the case as the government's claim that the death is a case of suicide is "totally unacceptable"

It also said that Sahu's wife has lodged a police complaint and demanded a CBI probe into the death of her husband

The incident is a case of gross negligence of jail administration for cape accountability as he is also the home minister, the petition said. "It is natural that the question arises when every activity is under CCTV surveillance, how could Sahu come out and hang himself?" it said. The delegation comprised MLAs Santosh Singh Saluja and Adhiraj Panigrahi besides senior leaders Lalatendu Mohapatra, Ganeswar Behera and Sivananda Ray.

BJD MLA Amar Prasad Satapathy said, "CBI and Crime Branch are separate investigative agencies and have defined domains to work. Let them work independently."

Meanwhile, a CB team along with scientific experts Thursday visited Kantabanji sub jail for inquiry into Sahu's death. Ward No-1 where Sahu was staying was opened by the team in the presence of jail authorities and witnesses.

"During search, a bunch of documents including some hand written papers, medicine files, FIR copy and final form related to the case vide Sindhekela PS Case No. 97/2021 have been seized. Daily medicine issue registers and personal file of UTP Sahu were also seized,' said the CB. Location of 16 CCTV installations has been verified and requisition has been placed with the jail authorities for production of

Pandit said that as per the provisions of the MTP Act, 1971 (34 of 1971), for referral of such cases, the state government had constituted a medical board at SCB to take decisions regarding allowing or denying termination of pregnancy beyond 24 weeks of gestation period after due consideration and assurance that the procedure would be safe for the woman at that stage.

'The MTP cases from all over the state were being referred to that board for decision taking in a time bound manner. Start survey on qualification of doctors: High Court to govt

Cuttack, Dec 22: The Orissa High Court has directed the state government to develop a comprehensive plan under which a survey will be conducted to find out if allopathic doctors practising in Odisha possess the relevant qualification.

"Such a survey should be undertaken in a time-bound manner and be concluded preferably within a period of six months," said a division bench headed by Chief Justice S Muralidhar.

The bench was adjudicating over a writ petition filed by the Odisha State Legal Aid Services Authority (OSLASA) Wednesday.

Quoting a survey conducted by the World Bank in which it was reported that at least 51 per cent of medical practitioners across

State to have 55 more trauma care facilities

Bhubaneswar. Dec 22: With a view to providing emergency medical care to road accident victims, the state government has given inprinciple approval to establishment of 55 more trauma care facilities (TCFs) in the existing health

facilities across the state. The Health and Family Welfare department Thursday issued a notification in this regard.

As per the operational guidelines on capacity building for developing trauma care facilities along National Highways issued by the Ministry of Health & Family Welfare, the preventable deaths because of road accidents are to be brought down to 10 per cent by developing a pan-India trauma care network in which no trauma victim would have to travel for more than 50 km and a designated trauma centre is available at every 100 km.

Following the direction of the Supreme Court, the state government has already asked for setting up of 33 TCFs through a notifica-

tion in 2018. With the decision to establish 55 more TCFs, one trauma care facility will now be available within 50 km.

The Health department will also take steps to assess the gap in infrastructure, manpower, equipment and instrument and fulfil them to strengthen the new trauma care





Barsha came to the emergency department of AIIMS recently at around 9pm with traumatic amputation of the left forearm below the elbow.

As per available information, Barsha was working at her home and her dupatta got stuck in the rice cutting machine along with her left hand at around 4pm following which she was taken to the local government hospital along with the amputated hand where primary treatment was given, with dressing, to stop the bleeding. The amputated part was wrapped in a ganjee pad and was kept in an ice bath by the



person who attended her in the local hospital.

The patient was immediately planned for reimplantation and was taken up for surgery on the same night at around 11:30pm by a team lead by Sanjay Kumar Giri (head of burns & plastic surgery). The team consisted of Santanu Suba, Priyanka Pant, Akanksha Rajpoot, Vishnu from plastic surgery department, Nikhil and Manjoy from Orthopaedics, Jayant Mitra, Hrushikesh and Shailaja from Anaesthesia department, and

was assisted by nursing officer Babulal and Jaswant Singh.

At first, the doctors took out the amputated part from the fridge and started bench dissection, identifying all the vital structures and shortening 3 cm bone. Then the patient was taken into the operating room and was given anesthesia. Amputated stumps were opened and debridement was performed after which all the vital structures were isolated.

"After that, the amputated part


bony fixations. Then arterial circulation was established along with vein, followed by two major nerves that were repaired along with muscles and skin," said Sanjay Giri.

The surgery went up till 8am in

ALZHEIMER'S RISK MAY VARY WITH RACE

A study conducted by US-based researchers has found that the same gene variant may carry different risks for Alzheimer's disease in people from different

In the largest-ever genetic study of dementia among people of African descent, Veterans Affairs (VA) researchers have identified several genetic risks different from those seen in people of European ancestry.

By using data from the VA Million Veteran Program (MVP), the team found multiple instances where gene variants may raise the risk of Alzheimer's disease and related dementias, the study said. The findings appear in the journal Molecular Psychiatry.

"MVP represents an incredible resource for examining the genetics of many diseases, including dementia," said study author Dr. Mark Logue.

"This study is one of the first Alzheimer's disease-related studies to come out of MVP. My colleagues and I are working hard to ramp up dementia work in MVP and to team up with other large-scale Alzheimer's disease and dementia studies. "The results signify a substantial increase in the knowledge of the genetic architecture of dementia risk in African ancestry populations," said Logue.

People of African descent and other minority groups are historically underrepresented in genetic research, which is why this study represents an important milestone, according to the research team.

According to the study, in the United States, a greater proportion of African-Americans have Alzheimer's disease than people of European descent; however, most large genetic studies of



Alzheimer's disease study white participants.

While there are genes implicated in Alzheimer's that are consistent across different populations, the researchers explained in the study that specific variants may differ by ancestry. That means study results using only one ethnic group

may not apply to other groups, hindering dementia prevention and treatment, the study said.

For example, studies have found that a gene variant called APOE E4 carries the largest genetic risk for Alzheimer's disease in people with European ancestry, but the effect of APOE E4 is half as strong in people of African ancestry, the study said. Increasing the representation of non-European ancestry populations in genome-wide association studies has been identified as a critical scientific and equity issue in genetic studies. The difference in sample sizes between European ancestry and non-European ancestry studies to date could even contribute to health disparities in minority populations, according to the study.

To address this disparity, Boston VA researchers compared the genomes of more than 4,000 MVP participants of African ancestry who had dementia with more than 18,000 Veterans without dementia.

The team also conducted a second analysis comparing 7,000 black MVP participants who reported that their parents had dementia with 56,000 others whose parents didn't have dementia.

Satellite survey exposes false paddy cultivation



Sonepur. Dec 22: A satellite survey has uncovered false cultivation of paddy crops on 12,776 plots by some unscrupulous farmers and landowners in Subarnapur

Reportedly, hundreds of farmers, including landowners, had registered their names with the Primary Agricultural Cooperative Societies (PACS) and women Self-Help Groups (SHGs) to sell their harvested paddy and grab the government benefits for paddy

cultivation in this kharif season. After the allegations, a satellite survey was conducted by the state Revenue, Agriculture, and Cooperative departments. Subsequently, their lies have been exposed by the survey. The farmlands they had mentioned in their registration were found to be grass lands, barren lands, open grounds, and water bodies with no sign of

any cultivation.

During registration, the farmers mentioned that paddy cultivation had been carried out on 12,959 plots in Subarnapur district. However, the satellite survey has unmasked the truth.

Reports said that paddy cultivation was carried out on 77,389 hectares of farmlands in Subarnapur district during the 2022–23 kharif season. As many as 65,523 farmers registered their names with the PACS and women SHGs to sell their harvested paddy.

As per the rules, the farmers had submitted all details regarding their lands during the registration. However, it was alleged that paddy cultivation was not done on as many lands as in previous years and that some unscrupulous and dishonest individuals were attempting to sell their paddy stocks at government rates.

The Revenue department took the allegations into cognizance and directed the revenue inspectors (RIs) and village agricultural workand take stock of paddy cultivation. The RIs and VAWs visited their respective areas and cancelled the registration of farmlands where there was no paddy cultivation.

However, due to lack of workforce, thousands of hectares of farmlands in the district were not thoroughly investigated. Subsequently, the government decided to conduct a satellite survey and get proper details of the farmlands.

Satellite survey found that no paddy cultivation was carried out on 12,959 plots in the district. To make the survey free from any rected the District Collector to ask revenue and cooperative officials to conduct field visits and submit their reports in this regard. As many as 206 employees visited the plots that had raised doubts during the satellite survey.

They clicked the photographs of the lands where no cultivation was undertaken and uploaded them to the departmental website. According to the survey, no paddy cultivation was carried out on 12,776 plots.

The wrongdoings were committed by unscrupulous farmers and landowners in Dunguripalli, Binka, Tarava, Birmaharajpur, Ulunda, and Sonepur blocks. Many unscrupulous people sell paddy without any actual cultivation.

Paddy was purchased from the farmers through a satellite survey conducted in eight districts, including Subaranapur district, in the 2021–22 kharif season. The state government has also made plans for the 2022-23 kharif season in all

GOBINDA'S DEATH IN JAIL

Mystery deepens as pictures of sub-jail premises go viral

Bolangir, Dec 22: A ten-member Crime Branch team has intensified its probe into the alleged suicide of Gobinda Sahu, the prime accused in Mamita Maher murder case, in Kantabanji sub-jail.

The sudden death of Gobinda has led to claims and counterclaims with the jail authorities and police claiming it to be a suicide while family members have termed it as murder.

While the mystery is yet to be unraveled, a photograph of the place where Gobinda allegedly committed suicide inside the jail has gone viral, Thursday. The photograph has given rise

to more doubts about Gobinda's death. In the photograph, two napkins were found hanging from the railings of a window which is fitted with iron doors. One of the napkins is blue in colour with white prints while another is white and soiled.

It is suspected that the second white napkin was being used for mopping the kitchen in the jail. A piece of tree trunk used to cut

Questions are being raised such s who took the tree trunk near the window and at what time while avoiding the close watch of the jail staff, how Gobinda got the two napkins, when did he commit suicide and who first spotted him after the suicide.

It is also being asked who made the photograph viral and with what motive. These questions have remained unsolved and need to

be answered Gobinda's uncle in-law made some serious allegations Wednesday. He alleged that Gobinda has been murdered inside the jail by engaging Supari killers and rejected the CB probe while demanding a probe by the CBI.

Fake IMFL liquor-making unit busted, 3 arrested

Berhampur, Dec 22: A strike team of the Excise department busted a fake liquor-manufacturing unit and arrested three persons including the kingpin here in this connection, Thursday.

The breakthrough came after Excise Commissioner Ashish Singh and District Collector Dibyajyoti Parida were tipped off about manufacturing of fake IMFL (Indian Made Foreign Liquor) in the district and smuggling of liquor to various places in and outside the district. The seized liquor and raw materials were valued at ₹10 lakh in the market.

A case was registered in this connection and the accused were identified as Tarini Jena, 25, the kingpin, a liquor trader Prafulla Kumar Sahu, 59, and a pickup van driver Nakula Gamango, 28.

The strike team conducted a raid at Indira Awas Square in

trict where it intercepted a liquorladen pickup van and seized 100 litre of fake IMFL from it. The vehicle driver Nakula Gamango, 28, and trader Prafulla Kumar Sahu, 59, were detained.

During questioning they revealed that they have brought the consignment from a fake liquor manufacturing unit at Ayodhya Nagar, Fast Gate being run by one Tarini Jena. The team members asked Prafulla to call Tarini on phone and tell him that he requires more liquor for sale.

Accordingly, Tarini came to the place with 54 bottles of liquor on a scooter when the team members nabbed him. Later, basing on his confessions, the team members raided his unit at Ayodhya Nagar and seized another 54 bottles from the place and raw materials used in manufacturing.

Excise officials have been carrying out raids in various parts of the city, but bootlegging has not been curbed as yet, it was alleged.

tion project. The main objective of the crocodile conservation project was to protect their natural habitats and to rebuild the population quickly through captive breeding as the survival rate of the crocodile hatchlings in nature is low because of predation, added Dr Kar.

The forest department stopped the crocodile rearing programme in 1995 as the crocodile population reached a saturation point from mere 96 in 1974 to more than 1,000.

But each year the forest department collects eggs from a nest to breed them in the crocodile hatchery and rearing complex at Dangamal. As per the 2022 January crocodile census report, the population of the crocodile reached 1,784 in the Bhitarkanika National Park, Kar said.

Crocodiles are also an important part of the ecosystem and help keep the riverine ecology clean and guard mangrove forest from tree cutters and poachers as locals fear to reach near the mangrove forest by crossing the crocodile infested rivers and creeks, said Dr Basanti Sukla of Zoology department


Defending Defenders

n the southwest corner of the Philippines, the forest of the Batak people is a biodiversity hotspot. At least 31 endangered and threatened species lacksquare – including the pangolin, the world's most trafficked mammal – can be found only here, in an area the size of Montreal. The forest also played a critical role in shielding people from the 160-mile-per-hour winds of Super Typhoon Odette at the end of 2021. The Batak maintain and monitor the forest for only \$20,000 per year – about the price of a low-end Rolex watch.

The Batak are not alone in calling a biodiversity hotspot home. The Innu homelands of Nitassinan, in what is now known as Quebec and Labrador, lie in Canada's boreal forest - the largest intact forest left on the planet. Home to migratory and woodland caribou, lynx, wolves, and polar bears, and a major flyway for birds, scientists predict that it will become a refuge for even more animals and plants as climate change transforms their habitats. The Innu Nation, longtime stewards of these lands, is attempting to protect them by proposing and establishing Indigenous Protected and Conserved Areas

An estimated 80 per cent of the planet's remaining biodiversity can be found on the lands of indigenous peoples and local communities. With as many as one million species of plants and animals at risk of extinction today, the need to empower these groups to protect nature should be obvious. The just-concluded United Nations summit on biodiversity (COP15) in Montreal - several hundred miles south of the Nitassinan – offered an opportunity to do just that

The world has failed to recognise the seriousness of the extinction crisis, let alone taken the action needed to address it. COP15 was delayed for more than a year by the COVID-19 pandemic, but the problem goes back much further. Scientists were publishing papers about the extinction crisis more than a decade ago, while indigenous communities were fighting to stop rapacious development – from open-pit mines to vast soybean plantations to massive hydropower barrages – from destroying their lands.

190 countries approved an agreement that included the 30x30 goal. Representatives of indigenous peoples and local communities from around the world attended the summit to push world leaders to match their ambitions for sustaining biodiversity by recognising indigenous and community land rights and supporting tried-and-true conservation practices. Their advocacy helped to ensure that language about indigenous rights were included in the agreement - an important safeguard for communities that feared being displaced by measures linked to the 30x30 goal. Indigenous peoples and local communities should have the opportunity to give their informed consent to measures linked to the goal – which must be pursued with a humanrights-based approach - and should receive direct funding for their work on

biodiversity protection. In this respect, Canada is setting a powerful example. Like indigenous people around the world, Canada's First Nations – including the Innu – have proved that they know how to manage ecosystems sustainably. Indigenous leadership or partnerships have been behind the creation of nearly 90 per cent of the protected areas established in Canada over the past two decades. And First Nations are leading the way on proposals to establish scores more pro-

The Canadian government has recognised indigenous peoples as essential partners in achieving biodiversity goals. Last year, it announced CAN\$340 million (\$258 million) in new funding for indigenous-led conservation, to be delivered over five years. Almost half of the total will support indigenousprotected and conserved areas: the rest will fund First Nations-led stewardship initiatives. The success of the COP15 agreement hinges on whether other industrialised countries follow this model.

As it stands, indigenous peoples and local communities receive only 16-23 per cent total support for land protection from international conservation institutions. But we deliver the same outcomes with fewer resources than government-run conservation. In other words, indigenous peoples and local communities are not only the best protectors of biodiversity, but also the most cost-effective – and among the most in need. Support for their conservation and stewardship benefits people and the planet.

The COP15 agreement is an important step toward stopping the biodiversity crisis from robbing us of our pollinators, our sources of new medicines and superfoods, and the ecosystem services that underpin healthy and prosperous communities. But given how rapidly the extinction crisis is progressing, transforming commitments into action is vital. Indigenous peoples have shown that we can protect the Earth's biodiversity. But we can't do it alone. We need the world's support.



Eagre

bore is a type of tidal wave, a single wave that flows up a river Aestuary as a result of an especially high tide. It's an example of what scientists call a soliton, a solitary wave that travels with little loss of energy, retaining its shape and speed but increasing in height as the river narrows and shallows. Among the most famous bores is that on the River Severn, a few miles from me. Eagre is an older dialect name for the phenomenon on the rivers Ouse and Trent as well as the Severn. It's been written in many ways, among them hygre, higre, agar and aigre. These are now rarely seen, but the spelling aegir is still in use for the similar bore on the River Trent. Though we understand how eagres happen, we're no nearer discovering the origin of that name. One theory was described by Eliza Chase in her novel Acadia of 1884: "In some northern countries the Bore is called the Eagre. Octavia says this must be because it screws its way so eagerly into the land, but is immediately suppressed, and informed that the name is a corruption of Oegir, the Scandinavian god of the sea." Dictionary makers are now sure that's incorrect, but they have nothing to put in its place.

A WAKE UP CALL

WHETHER INDIA AND CHINA WILL **GO TO WAR AT SOME POINT IN FUTURE IS NOT** THE QUESTION. **THE REAL POSITION SHOULD BE** THAT WE ARE AT **WAR WITH CHINA**

n 9 December; Indian and Chinese troops clashed at Yangtse in Tawang sector in Arunachal Pradesh. The fight involved hundreds of Chinese and Indian troops, a few of them sustaining minor or major injuries. Tawang is quite a sensitive border area. It was in this sector that the 1962 India-China war had first begun. It was also the last spot where the ceasefire was brought about. The Chinese attempted unsuccessfully to change the status quo at Yangtse by perhaps wresting the area from India. The debate in India and speculations across the world has revived on whether India and China will go to war at some point.

Before engaging in the debate on probability of an India-China war, a quick dip into the causes of the latest physical conflict is in order. India and China share the longest border in the world which has been contested by both sides. There have been recurring conflicts on the border since 1962. The bones of contention are Aksai Chin, a region north of Nepal, which is controlled by China and claimed by India. Likewise, Arunachal on the east of Bhutan is controlled by India while claimed by China. Such claims and counter-claims have created 13 hotspots.

At any rate, the Chinese incursions into India are not random or one-off. They are consistent and coordinated. Some Dutch academics have studied this process deeply in a commendable work called, "Rising tensions in the Himalayas: A geo-spatial analyses of Chinese incursions into India". By studying several incursions from 2006 to 2020, they have established the pattern of incursions as a part of expansionist strategy adopted by China. Elaborating on Chinese military tactics, they infer that China will bite a bit of territory, than a bit more, forcing India to accept it as part of Chinese occupation. Some people call it the 'salami slicing' tactics.

Another metaphor for Chinese strategy of nibbling away our territory is to 'keep the pot boiling, but do not let it boil over'. China

will like to tear into other countries' territory. It will take a small piece of land; keep it under the threshold from where the target country, in this case India, could counter attack. But over time, it becomes a bigger piece of land as part of Chinese territory. Yet another Chinese tactic of grabbing land is to enter into another country's territory and when confronted militarily or diplomatically backoff half way and declare that they had done it inadvertently as the lines of demarcation were not clear and have then withdrawn.

Such strategies for acquiring territory are well-known. The Dutch study has also found out that Beijing goes for territorial aggression on certain periods of its domestic politics and economy. The study said, "We found an uptick in incursions when China is experiencing economic stress such as low consumer confidence and in Indian case, when New Delhi gets closer to Washington." If overseas observers are aware of Chinese 'deception diplomacy' and territorial expansionism, it will be hard to believe that Indian foreign policy officials and strategists are oblivious to Chinese games at borders!

Since the Galwan confrontation in June 2020 that killed Indian and Chinese troops, the 9th December clash is a serious development which should be regarded as a wake-up call vis-à-vis China. The current debate post 9 December is whether China will launch a fullscale war on India. Some observers contend that war is not a question of whether but when. Some of us, myself in this column, have repeatedly alerted the government about the sinister designs of China on India: trying to encircle India by poaching on her neighbours, stunting India's economic growth, making illegitimate claims on Indian territory and sporadic incursions into Indian land. So, whether India and China will go to war at some point in future is not the question. The real position should be that we are at war with China. Such a position will correctly define or redefine our strategy towards China. One can credit Narendra Modi regime for breaking some new grounds on India's foreign policy. But on China, I have consistently maintained that New Delhi has fumbled. It does not have a longterm, viable and workable policy towards China. It is at best react-

Admittedly, there is a clear economic asymmetry between New Delhi and Beijing. This need not translate into military power disparity. If Ukraine can engage the mighty Russia, Indian Army can certainly stand up to China. At any rate, if a military conflict breaks out, the world powers get involved di-

ing to each crisis that emerges,

whereas it should have a compre-

hensive, well thought-out strategy

rectly or indirectly in order to maintain the balance of power and in some cases, related superiority.

The current Indian strategy appears to consist of the following steps – build border infrastructure, use military power as India did in Galwan and Tawang in order to rebuff Chinese intrusion, seek military advantage strategically or even fortuitously. Furthermore, diplomatically deepen partner ship with the democratic world by projecting China as a systemic threat; participate in countervailing coalitions. Moreover, over a period of time when Indian economy catches up with that of China, New Delhi could take on China in any which way Beijing approaches.

Even the Dutch scholars are suggesting that confrontation or military retaliation is not the way to resolve the border disputes. Early warning systems have to be used to ward-off incursions and negotiations for settling disputes. New Delhi needs to buildup its economy to match the might of Chinese robust economy. The strategy may be appropriate for the time-being. But nothing stops India from being diplomatically pro-active in countering China.

Why is India in SCO and BRICS when Beijing is moving its military into Indian territory? New Delhi has taken a position against Islamabad that it will not hold talks until the latter stops sponsoring terrorism in Indian territory. Why cannot New Delhi have a similar approach to China however big it may be?

To reiterate, we have been arguing that India's foreign policy should revolve around our China policy not Pakistan although the latter is a vote-catcher. This shift away from Islamabad to Beijing has not happened yet. The present government seems to be uncertain about this necessary and unavoidable shift. Galwan and Tawang are litmus tests on Chinese intention and attitude towards India. Will the government take this on board and make this urgent shift forthwith.

Quest for environmental justice

ENVIRONMENTAL JUSTICE CANNOT BE ATTAINED OVERNIGHT OR THROUGH ADJUDICATION. IT **MUST BE PUT** AT THE **CENTRE OF THE DECISION-MAKING PROCESS**

n the eve of the Human ious provisions especially through the premises that natural resource Parliament to Panchayat, meansively spoke about the dignity and rights of nature. In Montreal, the 15th Conference of Parties (COP15) to Convention on Biological Diversity ironed out a fair and just global biodiversity governance system. Meanwhile, in Dubai, during the India Global Forum UAE 2022. External Affairs Minister S Jaishankar slammed developed countries that despite occupying major carbon space they are not helping poorer countries in addressing climate change. Even if these three episodes are geographically separated, they have one common underpinning objective quest for environmental justice.

To preserve, conserve and manage the common heritage of humankind in the ecosphere is one of the contested turfs in achieving environmental justice among countries. At macro level, fairness is being sought after between the State and its various citizen groups in the environmental decision-making process. At micro level, it's the equity of survival space between

humankind and other living beings.

ments. Can justice, as we understand so far, be expanded to include the environmental dimension as President Murmu suggested in her speech? Or, will it remain just a catchphrase to be used in eloquent speeches or covering up one's weakness in environmental governance? Inequality is the norm of the

world. Access to and control over environmental resources weigh in favour of a few resulting in huge environmental burden on the rest of the humankind. Let's take the example of greenhouse gas (GHG) emissions. The world's richest one per cent will have per capita GHG emissions 30 times higher than the global per capita by 2030. At the same time the carbon footprint of the poorest half of the world will be several times below. But, it's the countries which have emitted GHG the least that will be harmed the most due to climate change. Who must carry the environmental burdens of climate change? This is exactly the message the EAM of India intended to send for next year's climate conference in the UAE.

Achieving environmental justice is a perpetual struggle. It is about the interweaving of the environment and society. It is based on

Environmental justice, as the US Environment Protection Agency defines, is the fair treatment and meaningful involvement of all people with respect to the development, implementation, and enforcement of environmental laws. regulations, and policies.

Can we find an example in India of formulation of any such environmental laws or policies recently? If we put recent amendments, proposed or inserted, to environmental laws or policies such as Environment Impact Assessment, Indian Wildlife Protection Act or Forest Conservation Act, to test under environmental justice lens of meaningful participation of all sections of society, neither of them would have been approved in present form.

In the realm of State vs citizens, the State controls and manages the environmental space and resources. While the State solely takes the decision to alter that environmental space and resources, the environmental burden is potentially high on the vulnerable citizen groups. The Constitution in its various provisions guides both State's obligation and citizen's duty to collaboratively preserve, protect and manage the ecosphere. From laws, regulations and policies on the environment is a step towards achieving environmental justice in India. The symbiotic relation between human and nature has been eroding fast and frantic. The human and animal conflict has increased manifold. Despite the High Court of Uttarakhand holding that the Ganga and Yamuna have the same legal rights as human beings, 351 river stretches of India were polluted in 2018, as identified by the Central Pollution Control Board. Unregulated maldevelopment that is being relentlessly executed by humans is threatening the very existence of the natural world. But who will speak for the natural world, a river, an elephant or an Olive Ridley?

With multiple threats emanating from degradation of ecosphere, environmental justice can uphold the survival of humankind. Agreeing with President Murmu, we must re-learn to treat nature with dignity. Environmental justice cannot be attained overnight or through adjudication. It must be put at the centre of decision-making process.

Don't lower guard

Sir, COVID-19 is rearing its ugly head again. Globally, active cases and the case fatality rate were on the wane though its presence always posed a threat. India is under constant risk; the authorities can't lower their guard. It is said that the national recovery rate is 98.8 per cent, but fresh cases are being reported from Kerala. The time rested test-track-treat-vaccination should be undertaken on a war-footing. The problem lies in complacency. The health ministry has declared that 220 crore doses of COVID-19 vaccines have been administered in the country. But many districts are running short of vaccines. Children, especially, are not able to complete their vaccination schedule due to paucity of particular vaccines. The Centre has to clear this confusion. In addition, people seem to have given a toss to the COVID-appropriate behaviour. 

The corps commander-level talks took place over a month after Prime Minister Narendra Modi and Chinese President Xi Jinping shook hands and exchanged pleasantries familiar with the military dialogue at the Chushul-Moldo border meeting point on the Chinese side of the Line of Actual Control (LAC) said it began around 9:30 am and continued for 10 hours

It is learnt that the Indian side insisted on resolving the issues at the remaining friction points of Demchok and Depsang in eastern Ladakh soon possible."Building on the progress made after the last meeting (16th round) on July 17, the two sides exchanged views on the resolution of the relevant issues along the LAC in the Western Sector in an open and constructive manner.' the statement said

They had a frank and in-depth discussion, keeping in line with the guidance provided by the state leaders to work for the resolution of the remaining issues at the earliest which would help in restoration of peace and tranquility along the LAC in the Western Sector and enable progress in bilateral relations," it said.

In line with a decision taken at the 16th round of military talks, the two sides carried out disengagement from Patrolling Point 15 in the Gogra-Hotsprings area in September.

"In the interim, the two sides agreed to maintain the security and stability on the ground in the Western Sector," the joint statement said.

"The two sides agreed to stay in close contact and maintain dialogue through military and diplomatic channels and work out a mutually acceptable resolution of the remaining issues at the earliest," it noted. New Delhi, Dec 22: The Enforcement Directorate Thursday said it has attached a "benami" asset worth ₹55 crore of DMK MP A Raia -45 acres of land in Coimbatore district in Tamil Nadu - under the anti-money laundering law.

The federal agency said in a statement that the land was purchased by a company allegedly linked to Raja, in lieu of granting environmental clearance to a Gurugram-based real estate company by the leader during his stint as the Union minister for environment and forests between 2004 and 2007.



The land is held in the name of a "benami" company of Raja, the ED said. Benami means 'no name' or 'without name' and such properties are those in which the real beneficiary is not the one in whose name the property has been purchased.

"The real estate company (listed on the BSE) has given kickbacks to A Raja as quid pro quo for awarding the environmental clearance, around the same period in 2007, in the garb of land commission income in the hands of one benami company of A Raja.

"It is found that A Raja incorporated the company in the same year (2007) in the name of his family members and his close family friend, with the sole objective ofusing it as a vehicle to park the proceeds of crime," the ED alleged.

the status quo in the Yangtse area.

Srinagar, Dec 22: 'Chilla-i-Kalan', the 40-day harshest winter period, has made its presence felt in the Kashmir valley with Srinagar recording its coldest night this winter, even as water supply lines and interiors of the Dal Lake froze due to the cold conditions, officials said Thursday.

The minimum temperature in Srinagar recorded Wednesday night was minus 5.5 degrees Celsius, which is the lowest so far this season, they said. The city had recorded minus 4.2 degrees Celsius the pre-

The cold conditions led to freezing of water supply lines in many places across the valley, even as the interior parts of the Dal Lake also developed a thick layer of frost.

The officials said Pahalgam, which serves as one of the base camps for the annual Amarnath yatra, recorded a low of minus 6.8 degrees Celsius and was the cold-



est recorded place in the valley. It was also the coldest night of the season so far at the tourist resort.

The famous ski-resort of Gulmarg in north Kashmir's Baramulla district recorded a low of minus 5.2 degrees Celsius, they said.

The minimum in Kupwara in north Kashmir settled at minus 5.1 degrees Celsius, while Qazigund, the gateway town to the valley, recorded minus 4.4 degrees Celsius, and Kokernag recorded a low of minus 3.3 degrees Celsius.

The meteorological department has forecast mostly dry weather in Jammu and Kashmir till December 24

There is possibility of rain or light snowfall in some parts of Kashmir around Christmas, it said.



"We are going to issue advisory to wear masks in indoor locations, closed spaces and air-conditioned rooms. Also, there will be mandatory testing of ILI and SARI cases across Karnataka," Sudhakar said briefing reporters after a meeting chaired by Chief Minister Basavaraj Bommai on COVID-19.

The meeting was attended by ministers, health department officials and the members of the Technical Advisory Committee



(TAC) on COVID-19.

Sudhakar said that it was also decided in the meeting to open dedicated Covid wards in all district hospitals with sufficient beds and supply of Oxygen.

There will also be coordination with private hospitals and super speciality hospitals for reserving beds to treat Covid patients as existed during the peak of COVID a year ago, he added.

In view of fresh outbreak of COVID-19 in countries like China, the state government decided to review its preparedness and the measures to be taken to check any such occurrence in the state.

The government decided to set up special camps across Karnataka to improve the booster dose coverage from the existing 20 to 60 per cent within a month. In this connection, the state will coordinate with the Centre for additional stock of booster doses.

In order to check its readiness, the government planned to hold drills in all government and private hospitals to test the condition of oxygen generators, supply networks and the functioning of oxygen cylinders.

All samples from positive patients are to be sent to the labs for genomic sequencing.



Winter storm threatens US

Mission (US): Temperatures plunged far and fast Thursday as a winter storm began forming ahead of Christmas weekend, promising heavy snow, ice, flooding and powerful winds across a broad swath of the country and complicating holiday travel. The National Weather Service reported that temperatures across the central High Plains plummeted 50 degrees Fahrenheit in just a few hours.

Official birthday date revealed

London: The official birthday of the new British monarch, King Charles III, will take place on June 17 next year, Buckingham Palace said Thursday. The celebration, packed with pomp and pageantry, is known as Trooping the Colour and will involve the King's wife, Queen Camilla, and daughter-in-law Catherine, the Princess of Wales, taking on ceremonial military roles during the royal parade.

SL navy arrests **Indian fishermen**

Colombo: The Sri Lanka Navv has arrested 12 Indian fishermen and seized their trawlers for allegedly poaching in the country's territorial waters. The fishermen were arrested off the coast of Vettilaikerni in northern Jaffna district on Wednesday, the Sri Lanka Navy said in a statement.

Turkey, Saudi decry ban

Kabul: Turkey and Saudi Arabia became the latest Muslim-majority countries to condemn a decision by Taliban authorities to bar women from universities, while about two dozen women staged a protest in the streets of Kabul on Thursday. In another sign of domestic opposition, several Afghan cricketers condemned the university ban. Cricket is a hugely popular sport in Afghanistan, and players have hundreds of thousands of followers on social media.

Round six of **India-UK FTA ends**

London: The sixth round of negotiations between India and the UK to finalise a free trade agreement (FTA) concluded last week with detailed draft treaty discussions across 11 policy areas over 28 separate sessions, the British government said Thursday.

Patriot missiles will not help end conflict: Russia

Washington/Kyiv, Dec 22: Russia said Thursday that supplies of U.S. Patriot missile systems to Ukraine. announced during Ukrainian President Volodymyr Zelenskyy's visit to Washington, would not help settle the conflict or prevent Russia from achieving its goals.

In a call with reporters, Kremlin spokesman Dmitry Peskov said that there had been no signs of readiness for peace talks during Zelenskyv's visit, proving that the United States was fighting a proxy war with Russia "to the last Ukrainian"

Zelenskyy told the U.S. Congress on Wednesday that aid to his country was an investment in democracy as he invoked battles against the Nazis in World War Two to press for more assistance in the war against Russia.

Zelenskyv's comments came as Republicans - some of whom have voiced increasing scenticism about sending so much aid to Ukraine are set to take control of the U.S. House of Representatives from Democrats on January 3.

The United States announced another \$1.85 billion in military aid for Ukraine, including the Patriot air defence system to help it ward off barrages of Russian missiles. Zelenskyy said the Patriot system was an important step in creating an air shield.

"This is the only way that we can deprive the terrorist state of its main instrument of terror - the possibility to hit our cities, our energy," Zelenskiy told a White House news conference, standing next to President Joe Biden. "We would

Congress is on the verge of approving an additional \$44.9 billion in emergency military and economic assistance, on top of some \$50 billion already sent to Ukraine this year as Europe's biggest land conflict since World War Two drags on. White House National Security Council spokesman John Kirby said Washington was seeing no sign that Russian President Vladimir Putin was willing to engage in peacemaking.

Zelenskyy's aide, Mykhailo Podolyak, said the United States had "finally pinpointed the baseline" in the conflict. "1. Russia must lose. 2. No 'territory in exchange for pseudo/world' compromises. 3. Ukraine will receive all necessary military aid. As much as possible. 4. No one cares about Russia's 'talk to us' hysteria...," he wrote on Twitter.

Ukraine has come under repeated Russian strikes targeting its energy infrastructure in recent weeks, leaving millions without power or running water in the dead of winter. Zelenskyy congratulated electrical workers for working round the clock, trying to keep the lights on as they marked Power Engineers' Day on Thursday, a day after the Winter Solstice, the shortest day of the year.

India, China abstain on first-ever UNSC resolution on Myanmar

United Nations, Dec 22: India, China and Russia abstained in the UN Security Council on a draft resolution that demanded an immediate end to violence in Myanmar and urged the military junta to release political prisoners, including State Counsellor Aung San Suu Kyi.

The 15-nation Security Council, under India's Presidency this month, adopted the resolution Wednesday after 12 members voted in favour, none against and India, China and Russia abstained.

This is the first Security Council resolution adopted on Myanmar in 74 years.

The only other UNSC resolution on Myanmar was in 1948 after the country formerly known as Burma got independence from Britain when the Council recommended to the General Assembly "that the Union of Burma" be admitted to membership in the United Nations.

India's Permanent Representative to the UN Ambassador Ruchira Kamboj, presiding over the meeting, delivered the explanation of the vote in her national capacity and said New Delhi believes that the complex situation in Myanmar calls for an approach of "quiet and patient diplomacy"

She said any other course will not help in resolving the longstanding issues which have prevented enduring peace, stability, progress and democratic governance. "Under the current circumstances, we are of the considered view that a UN Security Council resolution may entrench the parties in their inflexible positions rather than encourage them to pursue an inclusive political dialogue.'

Charles Sobhraj's release delayed

Kathmandu, Dec 22: Charles Sobhrai, a Frenchman of Indian and Vietnamese parentage, will spend one more day in Nepal's prison as the immigration authorities on Thursday expressed their inability to arrange accommodation for the notorious serial killer who is expected to be deported after his release on the orders of the apex court.

A joint bench of justices Sapana Pradhan Malla and Tilak Prasad Shrestha on Wednesday ordered to free 78-year-old Sobhraj from iail. "Though everything has been cleared for his release from jail, he has to be handed over to the Immigration Department. The immigration authorities have requested to postpone his release till Friday as they need preparation for his accommodation," said his lawyer Gopal Shivakoti Chintan.

Nicknamed "the Bikini Killer" and "the Serpent" due to his skill at deception and evasion, Sobhraj was serving a life-term in the Kathmandu jail since 2003 for the

Sobhraj was serving a life term in the Kathmandu jail since 2003 for the murder of **American woman Connie** Jo Bronzich in 1975

murder of American woman Connie Jo Bronzich in 1975 in Nepal, In 2014, he was convicted of killing Laurent Carriere, a Canadian backpacker, and given a

second life sentence. A life-term in Nepal means 20 years in jail. The order by the division bench of Nepal's top court came after Shobraj filed a plea claiming that he was put in prison more than the period recommended for him. There is a legal provision to release prisoners who have completed 75 per cent jail term and showed good character during imprisonment. Sobhraj through his petition had claimed that he had completed his jail term as per the 'concessions' entitled to senior citizens of Nepal.

China hospital warns of 'tragic battle'

Shanghai/Beijing, Dec 22: A Shanghai hospital has told its staff_ to prepare for a "tragic battle" with COVID-19 as it expects half of the city's 25 million people will get infected by the end of next week, while the virus sweeps through China largely unchecked.

After widespread protests against strict mitigation measures, China this month began dismantling its "zero-COVID" regime, which had taken a great financial and psychological toll on its 1.4 billion people. China's official death count since the pandemic began three vears ago stands at 5.241 - a fraction of what most other countries faced but now looks bound to rise sharply. China reported no new COVID deaths for a second consecutive day for Wednesday, even as funeral parlour workers say demand for their services has increased sharply over the past week.

Authorities - who have narrowed the criteria for COVID deaths, prompting criticism from many disease experts - confirmed 389.306 cases with symptoms.

Some experts say official case figures have become an unreliable guide as less testing is being done following the easing of restrictions. Infections in China are likely to be more than a million a day with deaths at more than 5,000 a day, a "stark contrast" from official data, British-based health data firm Airfinity said this week. Airfinity said it examined data from China's regional provinces, noting that cases are rising quicker in capital Beijing.

Trump paid no income tax in 2020 REUTERS

Washington, Dec 22: Donald Trump paid no income tax during the final full year of his presidency as he reported a loss from his sprawling business interests, according to tax figures released by a congressional panel.

The records, released by the Democratic-led House of Representatives Ways and Means Committee after a years-long fight show that Trump's income, and his tax liability, fluctuated dramatically during his four years in the White House The records cut against the

Republican ex-president's longcultivated image as a successful businessman as he mounts another bid for the White House. Trump and his wife, Melania, paid some form of tax during all four years, the documents showed, but were able to minimize their income taxes in several years as income from Trump's businesses was more than offset by deductions and losses.

The committee questioned the legitimacy of some of those deductions, including one for \$916 million, and members said the tax returns were short on details. The panel is expected to release redacted versions of his full returns in coming days.

Trump refused to make his tax returns public during his two presidential bids and his campaign for office, even though all other majorparty presidential candidates have done so for decades. The committee obtained the records after a years-long fight and voted on Tuesday to make them public.

A Trump spokesman said the release of the documents was politically motivated.



Chinese aircraft Taiwan warns away 39

Taipei, Taiwan, Dec22: Taiwan scrambled combat jets to warn away 39 Chinese aircraft that entered its southeastern air defence zone, the island's defence ministry said on Thursday.

Taiwan has complained of repeated missions by the Chinese air force over the last two years, often in southern areas of its air defence identification zone, or ADIZ. Thursday's incursion in-



cluded 21 fighters and four H-6 bombers, as well as early warning, antisubmarine and aerial refuelling aircraft, Taiwan's defence ministry said in a report detail-

ing Chinese activities in its ADIZ over the last 24 hours.

Many of the aircraft flew over a waterway known as the Bashi Channel to an area off the island's southeastern coast, according to a map provided by the ministry. Three Chinese navy ships were also detected near Taiwan, the ministry said

Taiwan sent unspecified combat aircraft to warn away the Chinese planes, while missile systems monitored their flight, the ministry said, using standard wording for its response.

Separate Taiwan government notices have said the defence ministry's research and development arm, the National Chung-Shan Institute of Science and Technology, is holding a missile firing drill this week on the island's southeastern coast. China, which claims Taiwan as its own, has stepped up pressure in recent years on the self-governed island to accept Beijing's rule.

Japan looks into claim that China running covert police stations

Tokyo/Beijing, Dec 22: The government in Tokyo is investigating a report that China has set up covert police stations inside Japan, amid similar checks by authorities in European countries, the United States and Canada.

Safeguard Defenders, an Asia-focused rights group based in Spain, has published two reports since September alleging that Chinese authorities have established 102 overseas police stations in 53 countries. including Japan.

China has dismissed the allegations and on Thursday its foreign ministry denied that such police stations existed.

Asked about the Japanese government's response to the report, Chief Cabinet Secretary Hirokazu Matsuno told a news conference: 'We will take all necessary steps as we clarify the situation. Matsuno said Japan had told Chinese authorities that any activity that violated Japan's sovereignty would be "unacceptable."

The Safeguard Defenders reports alleged that the Chinese po-



lice were using the police stations to target Chinese nationals living abroad and pressuring some to return home to face criminal

charges. Chinese authorities have said the facilities are volunteer-run centres that help citizens renew documents and offer other services that were disrupted during the COVID-19 pandemic.

'China has always adhered to the principle of not interfering in the domestic affairs of foreign countries, strictly abided by international laws and respected the judicial sovereignty of each country," foreign ministry spokesperson Mao Ning said on

Thursday. 'The so-called Chinese overseas police stations simply do not exist." Safeguard Defenders said in a September report that police from the Chinese city of Fuzhou had set up a "service station" in Tokyo. The group indicated in a follow-up report that police from China's Nantong had another such station somewhere in Japan.

South Korean authorities are investigating allegations similar activities there, Yonhap news agency said in a report. A spokesperson for the foreign ministry in Seoul declined to com-

ment directly on the report.

Islamabad: Pakistan, a country of around 220 million people with a \$350 billion economy, has long struggled with its external accounts, and the IMF has bailed it out over 20 times since 1958.

Concerns are rising again over the health of Pakistan's economy as foreign reserves run low, the local currency weakens and inflation stands at decades-high levels despite the resumption of an International Monetary Fund funding programme in August.

Adding to the already troubled economy, Pakistan was hit by major floods in late August that killed more than 1,500 people and caused nearly \$30 billion in damages, heaping even more pressure on its finances.

The biggest worries centre around Pakistan's ability to pay for imports such as energy and food and to meet sovereign debt obligations abroad. Before the floods hit, external financing needs for the 2022-23 financial year were estimated at \$33.5 billion.

The government raised fuel prices by more than 50% last month to counter soaring costs due to high oil prices, triggering protests over the rising cost of living. As a result, the current account deficit — the shortfall between exports and imports — widened over six times to \$17.2 billion in the first 11 months of fiscal 2021-22.

WORLD'S WORST FINANCIAL CRISES Financial crises are,

unfortunately, quite common in history and often cause economic tsunamis in affected economies

The Credit Crisis of 1772

This crisis originated in London and quickly spread to the rest of Europe. In the mid-1760's the British Empire had accumulated an enormous amount of wealth through its colonial possessions and trade. This created an aura of over optimism and a period of rapid credit expansion by many British banks. The hype came to an abrupt end June 8, 1772, when Alexander Fordyce—one of the partners of the British banking house Neal, James, Fordyce, and Down-fled to France to escape his debt repayments. The news quickly spread and triggered a banking panic in England, as creditors began to form long lines in front of British banks to demand instant cash withdrawals. The ensuing crisis rap-



idly spread to Scotland, the Netherlands, other parts of Europe, and the British American colonies. The Great Depression of 1929-39

This was the worst financial and economic disaster of the 20th century. Many believe that the Great Depression was triggered by the Wall Street crash of 1929 and later exacerbated by the poor policy decisions of the US government. The Depression lasted almost 10 years and resulted in massive loss of income, record unemployment rates, and output loss, especially in industrialized nations. In the United States the unemployment rate hit almost 25 percent at the peak of

the crisis in 1933. The OPEC Oil Price Shock of 1973 This crisis began when OPEC

(Organization of the Petroleum Exporting Countries) member countries—primarily consisting of Arab nations-decided to retaliate against the United States in response to its sending arms supplies to Israel during the Fourth Arab-Israeli War. OPEC countries declared an oil embargo, abruptly halting oil exports to the United States and its allies. This caused major oil shortages and a severe spike in oil prices and led to an economic crisis in the US and many other developed countries.

The Asian Crisis of 1997 This crisis originated in Thailand in 1997 and quickly spread to the rest of East Asia and its trading partners. Speculative capital flows from developed countries to the East Asian economies of Thailand, Indonesia, Malaysia, Singapore, Hong Kong, and South Korea (known then as the "Asian tigers") had triggered an era of optimism that resulted in an overextension of credit and too much debt accumulation in those economies.

The Financial Crisis of 2007-08

This sparked the Great Recession, the most-severe financial crisis since the Great Depression, and it wreaked havoc in financial markets around the world. Triggered by the collapse of the housing bubble in the US, the crisis resulted in the collapse of Lehman Brothers (one of the biggest investment banks in the world), brought many key financial institutions and businesses to the brink of collapse, and required government bailouts of unprecedented proportions. It took almost a decade for things to return to normal, wiping away millions of jobs and billions of dollars of income along the way.

Gas procurement rules for fert firms tweaked

New Delhi, Dec 22: India has revised the gas procurement policy for fertiliser companies, allowing them to buy about a fifth of their monthly needs through the domestic spot market to help the government cut its subsidy bill, two government officials said.

The federal government provides financial support for domestic fertiliser sales at rates below the market to insulate farmers from high prices and to contain inflation.

The government expects to cut its fertiliser subsidy bill by up to Rs 240 billion if the fifth of companies' supplies is bought through bilateral contracts or gas exchange, said one of the government officials, who declined to be identified.

Early last month, Fertilisers Minister Mansukh Mandaviya said that due to higher global prices, India's fertiliser subsidy bill for the fiscal year would rise to a record 2.25 trillion rupees from about 1.5 trillion rupees the previous year.

To help rein in the fertiliser subsidy bill for next fiscal, the fertiliser ministry is trying to rework

the mechanism of how gas is procured by fertiliser plants," said a second government official, who also declined to be identified.

The government has amended 2015 gas procurement guidelines under which fertiliser plants had to procure 80% of their gas through long-term contracts, and the balance through three-month tenders, they said.

Three-month prices are high as there is lot of padding and hedging by suppliers, more so since there is so much volatility in global gas prices," the first official said.

Under the revision, fertiliser companies will have to buy 40% of their supplies under a "take or pay" rule, in contrast to no minimum purchase required under the guidelines previously, the official added. The "take and pay" rule led to shares of state-run fertiliser companies, National Fertilizers Ltd, Rashtriya

Chemicals and Fertilizers Ltd, falling by 4% to 5% after the news, under performing the broader

Fertiliser plants can source gas through the Indian Gas Exchange and inter-company contracts. The new rule also allows fertiliser companies to withdraw tenders if they feel the bidding has led to higher than-expected prices.

Fertiliser plants bought gas at \$38 per million British thermal units (mmBtu) for supply in the October-December quarter through a tender. The maximum price quoted in the tender was \$55 while gas was available at the Indian Gas Exchange and bilateral markets for \$15 to \$20 per mmBtu.

New Delhi, Dec 22: The country's aviation industry has suffered a loss of Rs 11,658 crore in 2021-22, the government said.

According to the Civil Aviation Ministry, the details of losses incurred by the industry are: FY 2019-20 Rs 4,770 crore; FY 2020-21 Rs 12,479 crore; and FY 2021-22 Rs 11.658 crore.

The losses to the industry were primarily because of the Covidinduced disruption across the globe; currency depreciation (USD/INR); high operating cost environment. especially due to increase in ATF prices which constitute a major portion of the operational cost of airline; increase in crude oil prices in international market: VAT: excise duty; and the ongoing Ukraine-Russia war.

Airlines were unable to pass full impact of cost increases to the passenger, Union Civil Aviation Minister Jyotiraditya Scindia told the Lok Sabha in a written reply Thursday.

The actual figure of profit/losses to the industry will be known only when the audited accounts are available at the end of the financial vear 2022-23, the reply added.

The airlines and major airports are operated by the private sector and they evolve their own SOPs for cost minimisation and profitability.



However, the government has taken various steps to facilitate airlines. The UDAN Scheme is a game-changer for the aviation industry, the reply added.

The UDAN Scheme or Ude Desh Ka Aam Nagrik, is a regional connectivity scheme that seeks to make air travel accessible and affordable for the masses.

Other measures taken by the Government included the reduction of VAT on Aviation Turbine Fuel (ATF) was taken up with state governments/union territories levying high VAT on ATF. As a result 16 states have reduced the VAT in the range of 1-4 per cent.

Parl panel for digital competition act to rein in Big Tech

Competitive behaviour of big tech companies needs to be monitored in advance and not after markets become monopolised, the panel noted



Mumbai, Dec 22: An Indian parliamentary panel Thursday recommended the government enact a digital competition act to regulate anti-competitive business practices by Big Tech companies on its platforms.

Prime Minister Narendra Modi's government has had strained relations with many large technology companies, and New Delhi has been tightening the regulation of firms such as Facebook, YouTube

Alphabet Inc's Google and Apple have in the past faced scrutiny from the country's competition watchdog, the Competition Commission of India (CCI), over alleged abuse of the application market.

The Committee recommend that the government should consider and introduce a digital competition act to ensure a fair, transpar-



ent and contestable digital ecosystem, which will be a boon not only

for our country and its nascent start-up economy but also for the

entire world, the panel said in a report submitted in India's lower house of parliament.

The panel recommended the identification of top tech players as systemically important digital intermediaries to counter monopoly and warned they must not favour its own offers over the offers of its competitors when acting as mediators to supply and sales markets.

In India, Amazon and rival Flipkart are facing accusations of anti-competitive practices, such as promoting preferred sellers on websites and giving priority to listings by some sellers.

Companies including Facebook, Twitter and Google have for years been concerned with many regulations India has proposed for the technology sector, with companies complaining about excessive compliance burdens. The complaints have sometimes strained relations between New Delhi and Washington.

A specialised digital markets unit should be established within the competition watchdog, the panel said, adding that competitive behaviour of big tech companies needs to be monitored inadvance and not after markets become monopolised.

At stumps, India reached 19 for no loss with skipper KL Rahul batting on 3 in company of Shubman Gill (14 batting). Some of the balls bowled by Bangladeshi spinners were turning square and the decision to drop last Test's player of the match Kuldeep Yadav is looking a controversial one.

When Bangladesh batted, Umesh (4/25) led the Indian pace attack manfully while Ashwin (4/71) closed in on a career-haul of 450 wickets (447 currently) on a day when Jaydev Unadkat's (2/50 in 16 overs) return to Test fold after 12 long years did stir up fair amount of debate about some selection calls taken by this team management.

However, Unadkat could term himself lucky as last game's hero Kuldeep (8 wickets and 40 runs) was unceremoniously dumped by the team management comprising the two Rahuls - head coach Dravid and skipper Kannaur Lokesh (KL).

The pitch was termed to be a confusing one by skipper Rahul at the toss which prompted them to pick an extra seam bowler in Unadkat. The decision didn't backfire because of the inferior quality of Bangladesh batting line-up more than anything else

Former skipper Mominul Haque (84, 157b, 12x4, 1x6) was the only batter who showed admirable patience for more than four hours but he hardly enjoyed any support from the other end.

Zakir Hasan (15) and Najmul Hosain Shanto (24) added 39 for the first wicket but more importantly saw off the morning spell from Umesh and Mohammed Sirai

(0/39). It was Unadkat who got the first breakthrough when the ball bounced a tad more and was caught

However, the Saurashtra player bowled a better delivery to get the stodgy Mushfiqur Rahim when he came round the wicket and angled one into the batter. The ball straightened enough after pitching as it completely squared up Rahim.

Unadkat, who made his debut against South Africa at Centurion in December 2010, returned to Test format after a gap of 12 years. In between, he missed 118 matches, the highest by an Indian and the second highest in world cricket.

However, the most impressive bowler for India was Umesh, who consistently pitched the ball up. What was heartening to see was that along with his stock ball - the outswinger - he has also developed a potent inswinger, one which he used to get rid of Nurul Hasan.

He also got important wickets of Shakib Al Hasan and Mehidy Hasan Miraz by bowling a probing channel and the slowness of the track

Unadkat's rare feat

Mirpur: Pacer Jaydev Unadkat's got into cricketing records for an unenviable piece of statistic Thursday, returning to the Test fold after missing 118 games. PELE'S CANCER WORSENS; KIDNEYS, HEART AFFECTED

Sao Paulo, Dec 22: Pele's health has worsened during his hospital stay to regulate his cancer medication, doctors said. The Albert Einstein hospital in Sao Paulo said in a statement on Wednesday that Pele's cancer has advanced and that the 82-year-old Brazilian soccer great is under "elevated care" related to "kidney and cardiac dysfunctions."

The hospital did not mention any signs of the three-time World Cup winner's recent respiratory infection, which was aggravated by

Edson Arantes do Nascimento, who is globally known as Pele, is undergoing chemotherapy in his fight against cancer since he had a colon tumor removed in September 2021. Neither his family nor the hospital have said whether it had spread to other or-

Kely Nascimento, one of his daughters, said Pele will stay in the hospital during Christmas. "We decided with doctors that, for many reasons, it will be best for us to stay here, with all the care that this new family at Einstein gives us," she wrote on Instagram. "We will even make some caipirinhas (no kidding). We love you and we will give up an update next week."



Newspaper Folha de S Paulo reported Saturday that Pele's chemotherapy is not working and that doctors had decided to put him on palliative care. Pele's family denied that report. The Associated Press could not con-

firm the newspaper's information. Pele led Brazil to victory the 1958, 1962 and 1970 World Cups and remains one of the team's all-time leading scorer with 77 goals. Neymar tied Pele's record during

Argentina No.2 in FIFA

Zurich, Dec 22: Winning the World Cup was not enough to lift Argentina atop the FIFA world rankings with Brazil keeping the No.1 position Thursday.

Brazil was eliminated in the_ quarterfinals by Croatia but built enough rankings points from results over recent years that feed into FIFA's calculation.

Argentina moved up one place No. 2 and beaten finalist France also rose one to No.3. Belgium are still at No.4, a fall of two places, despite winning only one game in Qatar and failing to advance from the group stage.

England and the Netherlands, both beaten quarterfinalists, stay at Nos.5 and 6 respectively. Croatia climbed five places to No.7. European

champion Italy is at No.8 despite failing to qualify for the World Cup. Morocco are the best-placed African nation at No.11, up 11 places, for its historic run to the semifinals. The United States at No.13 is the best of the CON-CACAF region teams, rising three places after advancing to the round of 16. Mexico are No.15. Japan lead the Asian confederation teams at No.20, up four places, and Australia rise 11 places

to No.27. Both reached the round of 16. Cameroon, which beat Brazil in the group stage, rose 10 places to be No.33. Qatar dropped 10 places to No.60 after losing all three games as the home team at the World Cup.

Messi's black cloak: A brief history of the bisht

nortly before Lionel Messi took to the stage to lift up the World Cup trophy, Qatari Emir Sheikh Tamim bin Hamad Al Thani put a black cloak, called a "bisht," over the Argentine football star's shoulders.

Images of Messi wrapped in black fabric, which might have been construed as obscuring his national iersev, caused confusion around the world

Many fans questioned why the La Pulga was shrouded in an Arabian cape, with some suggesting that it "ruined an iconic moment.

A cloak for the ages

The origins of the bisht date back to the fifth century BC. It was initially used as a travelling coat to protect the skin of nomadic shepherds and Bedouins as they journeyed through different climates.

The word itself derives from Persian and translates literally to "on one's back." Also called an "aba" in Arabic, the bisht is traditionally a long, hand-woven cloak made of camel hair and goat fur. Its fibres were specifically crafted for the harsh desert climates – both cold and warm.

The process of spinning and weaving the fabric together - usually black, brown, beige or gray makes it highly breathable. Over time, tailors began adding specialised trim to the cloth, such as hand-spun gold or silver. The trim, called "zari," was crafted by mixing fine metals with silk to give it

a lasting sheen. The zari was added to the outer

portions to distinguish travelling cloaks from those to be worn by dignitaries or on special occa-

By the time of the Prophet Muhammad in the sixth century, soldiers and generals who performed well were shrouded with a bisht after battle in the conquests of the Persian and later Ārab empires.

The more transparent the fabric and more ornate the trim, the higher the honour. In countries such as the United Arab Emirates and Qatar that were formed in the early 1900s, royalty and politicians, referred to as Al Malaki, frequently wore the more ornamented bisht.

Culture and the meaning of

Today, there are many kinds and levels of the bisht, ranging in price from a few hundred to a few hundred thousand US dollars.

While the invention of the sewing machine facilitated the mass production of these cloaks, royalty, dignitaries and sheikhs wear only handmade, woven and trimmed bisht.

Like fashion and outerwear around the world, Middle Eastern clothing such as the bisht or the traditional white robes worn by many Arabs in the Persian Gulf, called "dish dasha," are a status symbol. 🔑

For Qataris, shrouding Messi, the star of the FIFA World Cup, with their most honorific clothing was an opportunity to share their culture - and the geopolitical importance of the World Cup games — – with the world.
