

### China sees 37mn Covid cases a day

Washington, Dec 23: Nearly 37 million people in China may have been infected with Covid-19 on a single day this week, according to estimates from the government's top health authority, making the country's outbreak by far the world's largest, Bloomberg reported.

As many as 248 million people, or nearly 18% of the population, likely contracted the virus in the first 20 days of December, according to minutes from an internal meeting of China's National Health Commission held Wednesday, confirmed with people involved in the discussions. If accurate, the infection rate would dwarf the previous daily record of about 4 million, set in January 2022.

Beijing's swift dismantling of Covid restrictions has led to the unfettered spread of the highly contagious omicron variant in a population with low levels of natural immunity. More than half the residents of Sichuan province, in China's southwest, and the capital Beijing have been infected, ac-

New Delhi, Dec 23: Sixteen Indian Army personnel including three Junior Commissioned Officers (JCOs) were killed in a road accident when the vehicle they were travelling in fell into a gorge while negotiating a sharp turn at Zema in North Sikkim, the Army said.

It said four injured soldiers have been air evacuated. "In a tragic road accident, involving an Army truck December 23 at Zema in North Sikkim, 16 bravehearts of the Indian Army have lost their lives. the Army said in the statement. Defence Minister Rajnath Singh said he is "deeply pained" over the loss of lives of the personnel. "The nation is deeply grateful for



Condolences to the bereaved families. May the injured recover soon.

The Army said the truck was part of a three-vehicle convoy that moved from Chatten in the morning towards Thangu.

'Enroute at Zema, the vehicle skidded down a steep slope while negotiating a sharp turn. A rescue mission was immediately launched, and four injured soldiers have been air evacuated," the Army said "Unfortunately, three Junior Commissioned Officers and 13 soldiers succumbed to the injuries sustained in the accident. Indian Army stands firm with the bereaved families, at this hour of loss." it said.

Rajnagar, Dec 23: In a tragic incident, three minor boys drowned Friday while taking bath in a pond at Bagapatia village under Rajnagar police limits in Kendrapara district. A pall of gloom descended on the village after the tragedy.

The deceased were identified as Bishal Rout (12), Sandeep Sahu (12) and Briben Parida (13). They were friends studying in Class-VII at Maa Panchubarahi High School in Satabhaya.

The three had arranged a feast at home. Later, they went to a pond for bath. While drowning they screamed for help. Hearing their scream, a girl tending to cattle at a nearby field came to the pond, but she did not find anyone. However, she spotted three pairs of shoes on the banks of the pond.

Tokyo, Dec 23: If you are unable to control your urge from snacking over chips, ice creams or chocolates, blame it on a gene. A team of Japanese researchers has identified the role a gene plays in stimulating the brain, causing people to overeat. Recently, it became clear that a gene called CREB-Regulated

**Transcription Coactivator 1** (CRTC1) is associated with obesity in humans. When CRTC1 is deleted in mice, they become obese,



indicating that functioning CRTC1 suppresses obesity. However, since CRTC1 is expressed in all neurons in the brain, the specific neurons responsible for suppressing obesity and the mechanism present in those neurons remained unknown, according to the study published in the FASEB Journal.

To understand the mechanism by which CRTC1 suppresses obesity, a research group led by associate professor Shigenobu Matsumura from Osaka Metropolitan University focused

on neurons expressing the melanocortin-4 receptor (MC4R). They hypothesized that CRTC1 expression in MC4R-expressing

**BJD-BJP tug of war in** truncated Parl session

THIS IS FOR THE EIGHTH TIME THAT THE PARLIAMENT SESSION CONCLUDED AHEAD OF ITS SCHEDULED ADJOURNMENT

New Delhi, Dec 23: A truncated Winter Session of Parliament that concluded Friday, almost a week ahead of its scheduled adjournment December 29, saw a deadlock between the ruling dispensation and the Opposition over the latter's demand for a discussion on China's repeated incursion in Arunachal Pradesh.

However, the session remained quite active from Odisha's perspective as the MPs raised many state specific issues in both houses of the Parliament. The session also saw a tug of war between the ruling Biju Janata Dal (BJD) and the Bharatiya Janata Party (BJP) MPs from Odisha with both blaming each other for the situation that occurred due to the arrest of lawyers in Sambalpur. On the opening day of the session, December 7, the BJD demanded withdrawal of the GST on kendu leaf. BJD MP Achyuta Samanta highlighted the significance of kendu leaves for tribal communities in the state and requested the Centre for withdrawal of GST. Later, the party MPs from both Lok Sabha and Rajya Sabha also met Union Finance Minister Nirmala Sitharaman and submitted a memorandum for the same.

The ruling party of the state reiterated its long-standing demand seeking special status to Odisha and also requested the Union government to introduce and pass the Women's Reservation Bill which seeks to grant 33 per cent reservation to women in Lok Sabha and Assemblies. In Lok Sabha, BJD MPs raised farmers' concerns over crop insurance and national horticulture mission. In Rajya Sabha, the party demanded inclusion of

#### ED cuffs on Archana's hubby over money laundering

Bhubaneswar, Dec 23: The Enforcement Directorate (ED) Friday arrested lady blackmailer Archana Nag's husband Jagabandhu Chand, one of the accused in high profile sextortion case, on charges of money laundering. Earlier, Archana and her business partner Khageswar Patra were also arrested by the ED in the same case. The ED sleuths Friday produced Jagabandhu before the court following the end of his nine-day remand period. He was on ED's remand since December 14. Sources revealed that ED has again sought court's permission to take Jagabandhu on remand for some more days for questioning in sextortion case.

The BJD MPs were quite active outside the Parliament as well. They met four Union ministers on the Parliament premises and submitted memorandums regarding several state issues. The MPs met Union Food and Public Distribution Minister Piyush Goyal and requested him to release the pending food subsidy of Rs 14,292.51 crore to Odisha and Union Tribal Affairs Minister Arjun Munda seeking inclusion of over 160 tribal communities in the state ST list.

Likewise, a delegation of BJD MPs also met Union Railway Minister Ashwini Vaishnaw and requested him for commencing passenger train service between Visakhapatnam and Haridaspur. Significantly, the BJP MPs from

Odisha left no stone unturned in attacking the state government on burning issues like lawyers' agitation for Western Odisha bench. The saffron party criticised the BJD government in Odisha for the violent protests and arrests of lawyers in Sambalpur. It alleged that the state government let the situation escalate and did not send a composite proposal for the establishment of a High Court bench in Western Odisha as sought by the Union Law ministry. However, the BJD countered the allegations by citing Entry 78 of the Union list of the Constitution and said that the Centre can ask or can establish a bench in Western Odisha under the Orissa HC. The BJD asked the BJP MPs to talk to the Union government and ensure that the bench is established using the powers of the Indian Constitution under Entry 78 of Union list. The BJP also alleged massive corruption in mining activities in Odisha and requested the Centre to order an inquiry and seek a report from the state government on the issue. The saffron party MPs further pulled up the state government alleging mal-

practices in the paddy procurement. Bargarh MP Suresh Pujari raised the Archana Nag case in Lok Sabha and sought a CBI probe. The lone Congress MP from Odisha, Saptagiri Ulaka raised issues concerning his Lok Sabha constituency, Koraput. He urged the gov-

ernment to initiate steps to boost transport connectivity in the region, dominated by the tribal population.

#### **₹118cr diesel cost saved from Apr-Nov: ECoR**

Bhubaneswar: The East Coast Railway (ECoR) has saved Rs 118.29 crore on diesel costs by using a technology called head on generation (HOG) in trains between April and November this year. In HOG, power is drawn from

an overhead electric supply and the power generator cars provide a noisefree and pollution-free environment for passengers in stations. There is a sharp fall in the cost of power in trains using HOG technology than normal LHB (Linke Hofmann Busch) coaches, a statement issued by the ECoR said. The cost of power in normal LHB coaches is over Rs 36 per unit and in rakes with the HOG system, the cost comes down to Rs 6 per unit, it said.

Bhubaneswar, Dec 23: With the surge in Covid-19 cases in some countries like China, Japan, USA and France, the state government has advised the people to follow Covid appropriate behaviour voluntarily.

After holding a meeting to review the pandemic situation in the state, Health secretary Shalini Pandit said all people should have to adhere to Covid appropriate behaviour like use of mask, hand washing, avoiding spitting in public places and self-isolation in case of development of any Covid like symptoms.

Countries like Japan, Republic of Korea, USA, France, Brazil, Germany and China are showing a surfeit in cases in the last two weeks. However, the situation in Odisha has remained stable with below 15 cases per day since November 2022 and on most of the days it is below 10 cases, she said.

The present testing level of 134 tests per million is much higher than the country level of 109 per million. Also, Odisha is testing 1,552 samples to get one positive against all-India figure of 589 tests for one positive, she said.

Hospitalisation rate in the state has remained nil with an active case load of 54 as on date. All ex-

"There was a necessity to dis-

the third line rail link was on its alignment. Out of 32km long Khurda-Barang line, a total of 26 km track has been made and construction of remaining 6km rail line between Bhubaneswar-Mancheswar will take place after demolition of old RoB," said RVNL chief project manager Pradeep

Kumar Mohanty. "This is regarded as a super critical project involving Rs 581 crore. The three-lane RoB will be commissioned within a year," he asserted. It should be noted that traffic will be diverted on new twolane RoB during construction of second one. Vehicular movement will resume on three-lane RoB after its construction and adjacent two-lane RoB will be used as service road in the neighbourhood Rasulgarh area.

The CS also reviewed the plan for modernisation of Bhubaneswar railway station. "Developmental activities will take place on either sides of the station - Kalpana and Master Canteen - as per plan submitted by ECoR.

### Spurious drugs worth ₹23L seized

"These drugs were found to have been procured from Uttar Pradesh. Total drugs worth ₹23,22,948 were seized," it added.

Molnupiravir is one of the more expensive antivirals used to treat Covid-19, with a seven-day course costing around USD 700 in the US. Molnuvirapir was sent directly

The results represent outcomes for patients treated between December 8, 2021 and April 27, 2022, during the

peak of the Omicron wave in the UK Approximately half the patients in the trial (12,774 people) received 800mg molnupiravir twice daily for five days, which was taken at home, in addition to standard care. The control half of the trial (12,934 people) received standard care only. There was no benefit observed in hospitalisation or death rates be tween the molnupiravir group and the control group, the study found. In the group treated with molnupiravir there were 105 cases of death or hospitalisation (0.8 per cent), while in the control group there were 98 cases of death or hos

pitalisation (0.8 per cent). Participants receiving molnupiravir reported more favourable outcomes for a variety of the secondary outcomes in this study.

The median average length of illness in patients who took molnupiravir was nine days compared to 15 days in the control group. PTI

Baripada, Dec 23: A team led by the Chief Conservator of Forests (CCF) has Friday started an investigation into the alleged poaching of a Royal Bengal Tiger (RBT) in the fringe area of Similipal Tiger Reserve (STR) area after recent seizure of its hide. The team is looking into different angles of the RBT skin seizure.

They have spread a dragnet to nab the poachers and people involved in the wildlife crime in and around the Similipal National Park. Notably, the Special Task Force

(STF) of the Crime Branch had seized the hide of an RBT from the fringe areas of the national park in the wee hours of December 14.

The STF subsequently arrested a 21-year-old man and seized the tiger skin in Belpal under Udala police limits.

Initial investigation had suggested that the big cat was possibly shot dead by poachers. A gunshot wound was noticed on the seized hide. It has been sent to the Wildlife Institute of India (WII) in Dehradun for a detailed examination.

The seizure came days after the poaching of an elephant followed by a subsequent attempt by three Similipal Tiger Reserve (STR) staffers to cover it up

Such incidents have pointed to the fact that wildlife poaching has been going on inside the STR area. The STF exposed the wildlife crime through a covert operation. The 21-year-old Debasish Patra was lured into a decov operation by the STF for the sale of the hide. Well



past midnight, a team of STF nabbed Patra with the skin but two others, including the mastermind, managed to flee.

It was said that the tiger may have been poached in about a month's time as its claws were intact on the skin which had not completely dried.

Patra could possibly be a middleman who was waiting to hand over the hide to a customer when the STF conducted the raid. The STF later arrested another accused while another is absconding.

The recent spate of incidents including the poaching of elephants has raised a question mark on protection measures in the tiger habitat.

The Forest department recently arrested three of its suspended officials for allegedly covering up the poaching of a male elephant and burning its carcass to destroy evidence. Turam Purty was the eyewitness in the alleged poaching and burning of the carcass.

plaint at Jashipur police station against the three accused - Jenabila ranger in-charge Shiv Shankar Samal, forester Chandrabhanu Behera, and forest guard Binod Kumar Das charging them with murder in the said case.

When the forest staff had burnt the poached elephant's carcass and thrown the charred remains to a nearby stream in an attempt to destroy evidence, Purty was present there. He sent some photos of the

incident to the higher authorities. Acting on it, the Forest department conducted a probe and suspended the three accused. The three had threatened Purty with dire consequences if he opened his mouth

Later, Purty drank poison December 11 and was admitted to SCB Medical College and Hospital in Cuttack where he passed away during treatment December 16.

Various outfits and wildlife activists staged demonstrations over the growing wildlife crimes in the Similipal area. They demanded a CBI probe into the poaching of the RBT and the elephant. A local outfit Bhanja Sena has warned of agitation outside the office of the STR deputy director.

Dharmasala, Dec 23: Vigilance has started an investigation into the alleged irregularities in pond renovation works in Taranjia panchayat under Dharmasala block of Jajpur district. Lakhs of rupees meant for the pond renovation allegedly were misappropriated in two phases.

Vigilance DSP Sushil Lenka and inspector Anusuya Senapati examined files and documents related to the pond renovation works in the block office.

The officials inquired the BDO about the irregularities and later, they visited the pond site.

According to reports, the Minor Irrigation department had allocated ₹24.99 lakh for renovation of the pond in 2019-20 fiscal. In the same

year, the block administration also allocated ₹3.50 lakh and got the pond renovated.

RTI activist Sarbeswar Behura alleged that the pond renovation was done twice in the same fiscal year and a major portion of the fund was embezzled. He moved the Lokayukta in this regard.

Admitting the case, the Lokayukta had issued notice to an assistant engineer of the block, a junior engineer, a panchayat executive officer and a former sarpanch to clarify their stand on the irregularities in the pond renovation.

However, their replies were not satisfactory to the Lokayukta.

Sensing massive irregularities in the pond renovation, the Lokayukta had then ordered a Vigilance investigation into the matter.

Sinha also added that the CB team had called in two experts from Bolangir Friday to check the footage of 16 CCTVs on the jail premises that might have captured visuals of the incident

The 11-member team led by DSP Bijay Kumar Mallick attempted to recreate the scene of suicide.

On the other hand, the envelope found from the pocket of Gobinda Sahu was found addressed to his elder daughter Lipika Sahu, who is serving in a company outside suicide and before. Notably, a photograph of the place where Gobinda allegedly

committed suicide inside the jail went viral Thursday giving rise to more doubts about Gobinda's death. In the photograph, two napkins were found hanging from the railings of a window fitted with iron doors. One of the napkins was blue in colour with white prints while another was white and soiled.

It is suspected that the second white napkin was being used for mopping the kitchen in the jail. A piece of tree trunk used to cut meat is also seen under the window along with a pair of slippers lying nearby.

It is suspected that the photograph shows the window railings of the kitchen from where Gobinda committed suicide inside the Kantabanji sub-jail.

# **CLIMATE-FINANCE CHALLENGE**

The dust has now settled after the United Nations Climate Change Conference (COP27) in Egypt, but there are still many unanswered questions about how to finance emissions reductions and adaptation. The world will not avoid dangerous levels of climate change without a significant increase in investment in developing countries. If these countries lock in dependency on fossil fuels and dirty technologies, they will be the largest source of emissions growth in the coming decades.

Fortunately, such investment can not only reduce emissions and build resilience; it also can drive a new form of growth and development that is much more attractive than the dirty and destructive paths of the past. Helping these countries accelerate the transition to sustainable, inclusive, and resilient economies is therefore in developed countries' own interest.

We were commissioned by the Egyptian COP27 presidency and the British COP26 presidency to conduct an independent analysis of the financing that developing countries (other than China) will need by 2030 in order to realize the goals outlined in the Paris climate agreement. Our report, published during the first week of COP27, concluded that these countries' annual investment in climate action needs to increase immediately, from about \$500 billion in 2019 to \$1 trillion by 2025, and to \$2.4 trillion by 2030. That investment will not only deliver on the Paris agreement; it will also drive this new form of growth and advance progress toward achieving the UN Sustainable Development Goals.

We identified three investment priorities. First, financing should go toward accelerating the energy transformation, particularly the deployment of renewables, as this is essential to keeping the Paris agreement's targets within reach. Second, we need increased investments in resilience to protect

Finally, the World Bank and other multilateral development banks have a critical role to play in achieving the Paris targets. Their annual investments in climate action will need to triple to \$180 billion by 2025, from about \$60 billion today, to realize co-financing with the private sector on the necessary scale, combined with support for public infrastructure.

The decision at COP27 to create new loss-and-damage funding arrangements recognizes that additional investment by developedcountry governments is needed to help developing countries limit the harm from more frequent and severe extreme-weather events. rising sea levels, desertification and other climate-driven problems. All countries are already suffering loss and damage from climate change, but the social and economic consequences can be far more devastating for developing countries, which face not only repair and reconstruction costs but also severe reductions in economic output, employment, and living standards.

The 2020s are the crucial decade in the fight against climate change. Further delay would be profoundly dangerous. But all countries will need to advance the transition to carbon neutrality. The rich world must not only do much more to reduce its own emissions. It must also generate the financing needed to help others and to protect the world's poorer countries from a problem they did not create.

### **Turf War**

he sudden repatriation of Punjab cadre IPS officer KS Chahal and his replacement by Haryana cadre IPS officer Manisha Chaudhary has triggered a Punjab vs Haryana turf battle. When Punjab Governor and Chandigarh administrator Banwari Lal Purohit appointed Chaudhary, objections from Punjab were expected given that in the existing administrative arrangements in Chandigarh where the posts of the home secretary and deputy commissioner were earmarked for Harvana cadre officers while finance secretary and SSP posts were allotted for Punjab cadre officers. Appointing Chaudhary to a post earmarked for Punjab naturally led to a puzzled reaction. Had Chahal been replaced by a Punjab cadre officer, perhaps it would have been seen as another regular reshuffle. But Punjab Chief Minister Bhagwant Mann jumped into the fray, accusing the action as "provocative" and breaking a decades-old arrangement between Punjab and Haryana.

Mann's accusation, sources have informed DKB, has forced the Governor to clarify that Chahal's repatriation was due to the babu's alleged misconduct and with the Punjab Chief Secretary VK Janjua well in the loop. But Mann is not letting go. Sources say that the AAP-ruled Punjab government has not only protested to the Governor but is also sending a panel of three IPS officers for the Governor to choose from for the Chandigarh SSP post. Will Mann prevail with these aggressive tactics?

#### Ex-Maha babu may get new role

Retired 1985-batch IAS officer and former Mumbai municipal commissioner Praveen Pardeshi, who during the worst months of the coronavirus pandemic, led the



civic body's efforts to create Covid treatment facilities, is reportedly being brought back as the new CEO of the Maharashtra Institution for Transformation (MITRA), which is the state's equivalent of the NITI Aayog. The buzz is that Chief Minister Eknath Shinde and his deputy Devendra Fadnavis both are favouring Pardeshi's candidature. While the NITI Aayog has the prime minister as its head, MITRA will have the chief minister as its head.

Pardeshi had reportedly fallen out with his seniors during his stint as municipal commissioner and transferred abruptly as additional chief secretary (urban development) but he refused to join. Instead, the babu chose a deputation to the UN. After losing his chance to become the state chief secretary in February last year, he voluntarily resigned from the service and was then brought in as a member (administration) of the National Capacity Building Commission.

Sources say that it seems that the retired babu's rehabilitation is well underway.

#### **Delays in PSU appointments**

As reported earlier in this column, after a long delay that has not been sufficiently explained, the government recently appointed Arun Kumar Singh, the former CMD of Bharat Petroleum Corporation Ltd (BPCL) as the new chairperson of the Oil and Natural Gas Commission (ONGC). So far, so good. But there are still as many as 72 posts of CMD, MD and whole-time directors lying vacant in PSUs still. This is an alarming number of key vacancies that ideally should not be allowed to stay open for long.

If we accept Minister of State for Finance Dr Bhagwat Krishnarao Karao's statement in Parliament that the selection process is continuous and ongoing, it does raise questions about the efficacy of the selection process which regularly delays these appointments. Those in the know are saying that the absence of full-time leadership in key PSUs is hurting the economy.

Ironically, government ministers are often heard deploring the lack of good leadership in these companies without acknowledging that perhaps the solution lies in studying the practice of top appointments in some key sectors such as power and energy. Various ministries have different stipulations for these posts. The Finance Ministry, for one, has decided that the chairperson of a state-owned company should have a five-year tenure, extendable to 10 years, for the 12 state-owned banks. The Petroleum and Natural Gas Ministry has settled for a three-year term for the companies under its purview, while the Power Ministry apparently is yet to take a call.

#### Anadiplosis

his is yet another term from that repository of extraordinary expressions, the field of rhetoric. It refers to the trick of repeating the last word of a sentence, line, or clause, at or near the beginning of the next. An example will make the idea clearer and to give it I call upon that fortune-cookie philosopher, Yoda from Star Wars: "Fear leads to anger. Anger leads to hate. Hate leads to suffering." Understanding you are? A more sanctified appearance is at the start of the Gospel according to John in the King James Bible: "In the beginning was the Word, and the Word was with God, and the Word was God." Anadiplosis derives from Greek diplous, double, from which also come diploid, diploma and diplomat (the last two from the idea of a doubled or folded paper, hence an official document). The prefix ana- is also Greek, meaning back or anew. Do not confuse this figure of speech with epanadiplosis, in which a sentence begins and ends with the same word. A famous example is in a speech by Malcolm X: "You bleed when the white man says bleed. You bite when the white man says bite, and you bark when the white man says bark." The extra prefix that appears in epanadiplosis derives from the Greek preposition epi, "upon, in addition". Likewise, don't muddle anadiplosis with the better-known anaphora, in which successive clauses or sentences begin with the same word or words. Bleak House, by Charles Dickens. Ait is another way to spell eyot, island. Another rhetorical term for a similar trick is antistrophe (which is also known as epiphora or epistrophe - there's disagreement over terms), which refers to repeating a word at the end of successive clauses or sentences ("government of the people, by the people, for the people, shall not perish from the earth"). Both antistrophe and epistrophe derive from Greek strephein, to turn.

#### Wax poetic

t one time wax was the usual verb meaning to become bigger, but from Athe fifteenth century onwards it was progressively replaced by grow, so that it survives now only in discussions of the moon or in set phrases such as your wax poetic and similar formations - wax eloquent, wax lyrical, even wax sententious. I agree this is an idiomatic form that's not easy to understand. In everyday usage, in which such set forms are bordering on cliché, it means merely to communicate in the way described. So wax poetic means only "speak or write poetically".

The new Indian economy may have patches of problematic developments and the private sector may not rev up the economy. The hurried approach at privatisation hopefully would not become a critical block for the government. Still a large chunk of public sector remains the flag bearer of the Indian economy. As their role shrinks, the country could slip into myriad problems.

Meanwhile, debts of some large houses have spiralled and RBI refuses to name them though smaller borrowers are named and shamed.

The country is on an uneven patch and has to ensure how a non-PSU economy remains responsive.

They said the Kochhars were called to the agency headquarters and arrested after a brief questioning session. The CBI has alleged that they were evasive in their responses and did not cooperate in the investigation.

The Kochhars will be produced before a special CBI court on Saturday. They are likely to be kept in separate lockups on the ground floor of the 11-storeyed agency headquarters after their medical examination.

Sources said that agency is likely to move at a swift pace to file the first charge sheet in the case in which the Kochhars could be named along with Venugopal Dhoot of Videocon Group.

The CBI had named the Kochhars and Dhoot, along with companies Nupower Renewables (NRL) managed by Deepak Kochhar, Supreme Energy, Videocon International Electronics Ltd and Videocon Industries Limited, as accused in the FIR registered under IPC sections related to criminal conspiracy and provisions of the Prevention of Corruption Act in 2019, they said.

Sujith Somanathan, a 12th standard student from a government school of Madurai, said, "I am worried as I don't have any 10th marks to show which is mandatory for applying in JEE. He further said, "After entering the personal details, the marks of Class 10 are mandatory and we are not able to further proceed in the application and hence we are really worried.

It is to be noted that around 40,000 students appear for JEE from Tamil Nadu and the students



who have taken the Tamil Nadu state board exams for the 10th standard don't have any marks for the tenth exam which is a mandatory criterion for applying in JEE. The registration for JEE commenced on December 12 and would continue till January 12

The Chief Minister in the highlevel meeting has directed officials to test all symptomatic passengers arriving on international flights according to the Standard Operating Procedure (SOP) and to make sure that they are provided treatment. A statement from the Chief Minister's office on Thursday said that the government was prepared with beds, drugs, testing, and oxygen facilities being made available adequately in all hospitals.

The state government has also directed the officials to conduct whole genome sequencing of Covid-19 samples to detect new variants. It is to be noted that the Omicron BF-7 which is the new causative variant for Covid-19 surge in China and other countries is a subvariant of Omicron BA-5 which was detected in Tamil Nadu during genome sequencing conducted in June, July and August.

### Search engines can't claim to be 'content-blind': HC

Kochi. Dec 23: The Kerala High Court has held that search engines like Google cannot claim to be mere intermediaries with no control over the content that appears in search results.

This came in a judgment by a division bench of Justices Muahmed Mustaque and Shoba Annamma Eapen on the right to be forgotten and the manner in which it applies to publication of court judgments and proceedings, in the absence of any specific legislation. The bench observed that even though making court judgments available in search results cannot be faulted, it cannot be said that Google has no control over the information that gets thrown up in search results.

The court pointed out these on a batch of pleas moved by certain litigants seeking erasure of their personal details that were appearing on Google search.

It also clarified that it is not looking at the responsibility or liability of Google for publishing judgments online, and rather, the court is concerned with the eternal nature of information online, which goes against the right to be forgotten.

Therefore, it said that in the absence of legislation, litigants may have to approach the court and it may have to recognise their right and direct removal of such content available online on a case-to case basis

The High Court took the decision even taken after an expert committee constituted by the Appropriate Authority under the Transplantation of Human Organs and Tissues Act, 1994 initially opined that the daughter cannot be exempted from the bar imposed by the Act and Rules on organ donation by minors

A single-judge Justice V.G. Arun asked it to reconsider its stance after another team of experts arrived at the opposite conclusion. The Appropriate Authority then changed its stance and the court recorded its appreciation for its quick response as well as the tenacity of the minor girl, one Devananda, who fought to save her father's life.

"It is heartening to note that the unrelenting fight put up by Devananda has finally succeeded. I applaud the petitioner's fight to save her father's life. Blessed are parents who have children like Devananda. I also place on record my appreciation for the prompt manner in which the Appropriate

Authority responded to the directions issued by this Court. The writ petition is disposed of permitting the petitioner to donate a portion of her liver for conducting her father's transplantation surgery, subject to the other requirements of the Act and the Rules," the order said. The petitioner's father is critical and doctors had advised a liver transplant to save his life.

The plea moved by the minor petitioner submitted that that she is ready and willing to donate a portion of her liver to her father and that there are no medical impediments to her donating her organs.

However, according to Rule 18 of the Transplantation of Human Organs and Tissues Rules, 2014, the age of the donor must be above 18 years. The petitioner submitted that being the daughter, she is willing to donate a portion of her liver to her father, who is only 48 years of age and the sole breadwinner of the house.

However, the hospital authorities did not allow her to be the donor for the sole reason that the law doesn't allow a minor to be a donor of a living organ, the plea said. Therefore, the petitioner approached the court seeking a declaration that she may be exempted from the age.

Zelenskyy posted on his Telegram account that he's in his Kyiv office following his US trip that secured a new \$1.8 billion military aid package, and pledged that "we'll overcome everything."

The Ukrainian President also

thanked the Netherlands for pledging up to 2.5 billion euros (USD 2.65 billion) for 2023, to help pay for military equipment and rebuild critical infrastructure.

Kremlin spokesman Dmitry Peskov said the war would end at the negotiating table once the "special military operation" achieves "the goals that the Russian Federation has set," adding that "a significant headway has been made on demilitarisation of Ukraine.'

The Kremlin spokesman said no reported Ukrainian peace plan can succeed without taking into account "the realities of today that can't be ignored" — a reference to Moscow's demand that Ukraine recognise Russia's sovereignty over the Crimean Peninsula, which was annexed in 2014, as well as other territorial gains.

At least six civilians were killed and 18 others were wounded in Russian attacks on eight regions in Ukraine's south and east in the past 24 hours, according to Ukrainian officials.

Court in Manhattan also barred the former FTX CEO from opening any new lines of credit of more than \$1,000 while awaiting trial, CNBCreported late Thursday.



He will face his next hearing in New York City January 3. The bond has been secured by equity in his family home, and by the signatures of his parents and two other individuals with "considerable" assets.

As part of the bond agreement, Bankman-Fried will wear an "electronic monitoring bracelet" and submit to "mental health counselling" amid restrictions on travelling out of the city. Bankman-Fried was charged by the US Attorney for the Southern District with eight counts including securities fraud and money laundering.

United States, Dec 23: A historic and brutal winter storm put some 240 million Americans under severe weather warnings Friday as the United States faced holiday travel chaos, with thousands of flights cancelled and major highways closed.

Heavy snow and howling winds upended holiday plans for millions at one of the busiest times of the year, just days before Christmas, as a huge cold front swept down from the Arctic and took freezing hold of much of the nation, including normally temperate southern states.

Temperatures plunged below -40 degrees Fahrenheit (-40 Celsius) in some locations, with a staggering 240 million people -- some 72 percent of the US population -- under winter weather warnings or advisories, according to the National Weather Service.



"Winter weather hazards remain in effect from the Canadian border south to the Rio Grande (border river with Mexico), Gulf Coast and central Florida Peninsula while spanning from the Pacific Northwest to the Eastern Seaboard," the NWS said in a report early Friday.

The warnings appear to be one of the most sweeping sets of US winter weather advisories ever.

Meteorologists said it was so cold in places -- 10 degrees Fahrenheit was recorded Friday in normally mild Dallas, Texas that anyone venturing outside risked frostbite within minutes.

The biting cold is an immediate concern for more than one million customers, mainly in the US south and east, who were without power as of Friday morning, according to electricity tracker poweroutage.us.

Road conditions remained treacherous, even as 100 million people were expected to take to the roads, according to the American Automobile Association.

Transportation departments in North and South Dakota, Oklahoma. Iowa and elsewhere reported near-zero visibility, icecovered roads and blizzard conditions, and strongly urged residents to stay home.

Two traffic fatalities were reported in Oklahoma Thursday, while the Weather Channel quoted the Kansas Highway Patrol saying three people died in road accidents in that Midwestern state. with weather considered a contributing factor.

came one of the most expensive hurricanes in US history. In Pakistan, record Monsoon rains inundated more than one-third the country, killing over 1,500 people. In India and China, prolonged heat waves and droughts dried up rivers, disrupted power grids and threatened food security for billions of people. Widespread flooding and mudslides brought on by torrential rains also killed hundreds of people in South Africa, Brazil and Nigeria.

Rising climate costs to challenge countries in 2023

#### WHY IT MATTERS



n a year marked by yet more climate-linked floods, hurricanes and droughts, governments and companies were forced to look more closely at the financial risks and their exposure to liability.

Nowhere was this more apparent than at the UN climate conference in Egypt, where countries reached a landmark agreement to set up a fund to help poor countries cope with climate-fueled disaster costs.

Egypt's COP27 talks did little, however, to address the cause of those disasters - the ever-rising levels of greenhouse gases in the atmosphere.

That kind of slow progress in tackling climate change made vulnerable countries determined to get the so-called Loss and Damage fund approved – after yet another year of extreme weather disasters including record heatwaves from the United States to China, glaciers collapsing in India and Europe, and unending drought pushing millions toward famine in East Africa.

Insurers were feeling the pain, as the year delivered three of the decade's

costliest disasters - "dystopian" flooding that delivered \$40 billion in damages to Pakistan, a series of deadly summer heatwaves that collectively caused more than \$10 billion in losses for Europe, and Hurricane Ian tearing across Florida and South Carolina to the cost of \$100 billion, according to risk modeling firm RMS.

The Loss and Damage fund also marked a diplomatic coup by poor nations, after decades of US and European resistance over fears it could open them to legal liability for their historical emissions. But countries agreed the fund would pull from existing financial institutions rather than rich nations, assuaging those liability concerns - for now.

### 198 govt firms/corp incur accumulated losses of over ₹2L-cr

New Delhi, Dec 22: There were 198 government companies and corporations with accumulated losses of ₹2,00,419 crore, as March 31, 2021, and of these, the net worth of 88 companies had been completely eroded by their accumulated losses, a CAG report said.

"As a result, the aggregate net worth of these companies had become negative to the extent of ₹1,13,894 crore as on March 31, 2021. Only 20 out of these 88 companies earned a profit of ₹973 crore during the year 2020-21," the General Purpose Financial Reports of Central Public Sector Enterprises (CPSEs) Union Government (Commercial) - Report No 27 of 2022, tabled in Parliament Thursday, said.

The report deals with 453 government companies and corporations (including six statutory corand porations) 180 government-controlled other companies. As many as 84 CPSEs (including 23 government-controlled other companies) whose accounts were in arrears for three years or more or were under liquidation or first accounts were not due are not covered in this Report.

On returns from government companies and corporations, the report said that 251 government companies and corporations earned profit of ₹1,95,677 crore during 2020-21 of which, 72 per cent (₹1,40,083 crore) was contributed by 97 government companies and corporations in three sectors - power, petroleum, and financial services. Return on Equity (ROE) in these 251 CPSEs was 16.34 per cent in 2020-21 as compared to 13.54 per cent in 224 CPSEs in 2019-20.

On rate of real return (RORR) on government investment, the CAG report said that out of 633 CPSEs covered in this report, the Central government has direct investment in 195 CPSEs. RORR in respect of 173 CPSEs (58 listed CPSEs and 115 unlisted CPSEs) has been computed since 2000-01 to compare the same with the conventional rate of



**173 CPSEs incurred** losses during the year 2020-21. The losses incurred by these firms during the year 2020-21 decreased to ₹42,876 crore from

₹67,845 crore in 2019-20 

return on historical cost.

"RORR was 17.52 per cent in comparison to conventional rate of return on historical cost of 46.78 per cent in 2019-20. RORR has shown an increasing trend till 2006-07 after which it started to decline and ranged between 10 per cent and 23 per cent during the preceding five years from 2016-17 to 2020-21," it said.

The report further said that 112 government companies and corporations declared a dividend of ₹80,105 crore during the year 2020-21. Out of this, the dividend received/receivable by Central government amounted to ₹36,982 crore which represented 7.22 per cent return on the total investment by the Central government (Rs 5,12,547 crore) in all government companies

and corporations. It said that 10 government com-

panies under the Ministry of Petroleum and Natural Gas contributed ₹28,388 crore representing 35.44 per cent of the total dividend declared by all government

companies and corporations. 'Non-compliance with directive of government of India on declaration of dividend by 20 CPSEs, which were having sufficient fund (retained earnings and general reserves), resulted in a shortfall of ₹9,449 crore in the payment of dividend for the year 2020-21," it said.

**Russia may cut oil** output up to 7%

Moscow, Dec 23: Russia may cut oil output by 5%-7% in early 2023. as it responds to price caps on its crude and refined products, and halt sales to the countries that support them, Deputy Prime Minister Alexander Novak told state television Friday.

Detailing for the first time the Russian response to the price caps introduced by the West over Moscow's invasion of Ukraine, Novak said the cuts could reach 500,000-700,000 barrels per day (bpd). He also said that despite Europe's

efforts to cut reliance on Russian oil and gas, energy exports from Russia are in demand worldwide and Moscow has been diversifying its buyers.

Novak said it would be difficult to provide for global economic development without Russian energy, and predicted possible gas shortages in Europe, which has introduced restrictions on gas prices, as well as on oil.

On oil, the European Union, G7 nations and Australia introduced a \$60 per barrel price cap from December 5, in addition to the European Union's embargo on imports of Russian crude by sea and similar pledges by Britain, Canada, Japan and the United States.

'We believe that in the current situation, it is even possible to take risks of lower production rather than be guided by the selling policy regarding the price caps. Today it is \$60, tomorrow it can be anything, and getting dependent on some decisions made by unfriendly countries is unacceptable for us,' Novak said

# Pant, Iyer propelindia Four All-Rounders Go

Mirpur, Dec 23: Rishabh Pant enhanced his reputation of being team's biggest game-changer with a scintillating 93 (104b, 7x4, 5x6) that put India in a commanding position for a series clean sweep against Bangladesh, here Friday.

Pant, who got out in the 90s for the sixth time in his Test career, again brought his 'A' game to the fore with a counter-attacking knock that formed the cornerstone of India's first innings score of 314 on the second day of the second Test

Between the lunch and the tea, the match which seemed to be hanging in balance was singlehandedly changed by Pant. Shreyas Iyer, who has been consistent since his Test debut last year, also batted with a lot of intent but missed his second hundred of the series, getting out for 87 (105b, 10x4, 2x6).

Riding on the 159-run fifth wicket stand between Pant and Iyer, India, who were tottering at 94/4, will fancy their chances for a fourth-day finish and consolidate their position in the World Test Championship table

Trailing by 87 runs, Bangladesh were seven for no loss at stumps on Day 2. The batting will only get difficult on the third day and playing Ravichandran Ashwin and Axar Patel on this track will be a Herculean task.

The morning session belonged to Bangladesh's left-arm spinner Taijul Islam (4/74), who rocked the top-order by dismissing skip per KL Rahul (10), Shubman Gill (20) and Cheteshwar Pujara (24) but by the end of afternoon session, Pant had blown the hosts away

It only helped Iyer at the other end, who was equally aggressive and a surface that looked difficult to bat on suddenly appear to be a willow wielder's paradise. Pant literally manhandled the

Bangladeshi spin troika by smashing five sixes - two off Taijul, a couple off Mehidy Hasan Miraz and one off skipper Shakib Al Hasan

The visitors were in trouble at 94/4 when Virat Kohli (24) once again nicked one off Taskin Ahmed (1/58) outside the off-stump channel before Pant propelled the Indian innings.

But Taijul was made to look pedestrian by the maverick keeperbatter from Rourkee. Pant hammered Taijul into submission by repeatedly dancing down the track and

carting him either in the arc between the mid-wicket and long-on or by lofting him down the ground.

The most exhilarating one was a one-handed down-the-ground shot off rival captain Shakib. And it was not at all surprising when he repeated the stuff off Miraz over long-on for a 100-metre long maximum

The Bangladeshi bowlers, who

were pumped up at the lunch break, had drooped shoulders by the time tea was called. Pant's beast mode did rub off on Iyer as he also lofted Miraz for his first six and duly completed his second half-century of the series with a single.

By the time, Pant nicked one to Nurul Hasan behind the stumps, missing out on yet another Test hundred, he was completely done and didn't come out to keep after experiencing cramps.

Earlier, having misread the track on day one, Rahul paid the price for his ultra defensive mindset on a pitch that offered fair bit of turn on the opening day itself. Not for once during his 45-ball stay did he look comfortable, save the cover driven boundary off a seamer at the start of the day.

Gill, on the other end, looked more assured even as Taijul kept his deliveries on good length and bowled a nice trajectory. The delivery that got Rahul, seemed like an armer that came in with the angle and then straightened enough to trap him in-front of the wickets. Umpire had dismissed the LBW plea but Bangladesh got the decision in their favour after taking DRS review.

In case of Gill, it was more of a straightforward decision where he was caught plumb as he missed a straighter one while attempting a sweep shot. Pujara looked assured till the time he was at the crease but with the deliveries stopping and turning, there was always the danger of negotiating that ball which would send him back.

Kochi, Dec 23: England all-rounder Sam Curran Friday became the most expensive player in the history of IPL auctions after fetching a whopping Rs 18.5 crore bid from Punjab Kings here.

An intense bidding followed for Curran with Mumbai Indians, Royal Challengers Bangalore, Rajasthan Royals, Chennai Super Kings, Lucknow Super Giants and Punjab Kings raising their paddles frenetically to secure the services of T20 World Cup player-ofthe tournament.

In the end, it was Punjab Kings (PBKS) that broke the bank to get Curran, who drew highest-ever bid that bettered the previous best buy of Rs 16.25 crore that Rajasthan Royals had shelled out to grab South African all-rounder Chris Morris in 2021.

Australia all-rounder Cameroon Green was second-highest earner, fetching Rs 17.5 crore bid from Mumbai Indians. England Test skipper Ben Stokes was the thirdhighest gainer, fetching Rs 16.25

crore from CSK who pipped Kolkata Knight Riders in another intense bidding war.

England players were in demand as batter Harry Brook earned a Rs 13.25 crore winning from Sunrisers Hyderabad, Brook, who struck three hundreds in as many games and set new record for most runs by an England batter in a Test series in Pakistan, started at a base price of Rs 1.5 crore. The bidding for Brook was mainly between SRH and Rajasthan Royals.

India international Mayank Agarwal was also bought by Sunrisers Hyderabad for Rs 8.25 crore. His base price was set at Rs 1 crore, New Zealand stalwart Kane Williamson was sold at his base price at Rs 2 crore to Gujarat Titans.

Out-of-favour India batter Ajinkya Rahane was sold at his base price of Rs 50 lakh to Chennai Supper Kings, the only bidder for the player. South Africa batter Rilee Rossouw and Bangladesh alrounder Shakib-Al-Hasan went unsold. West Indies all-rounder Jason Holder was sold to Rajasthan Royals for Rs 5.75 crore.

Manchester, Dec 23: Erling Haaland scored his 24th goal of the season but it was Nathan Ake's first that clinched Manchester City's 3-2 win over Liverpool in the English League Cup.

Kevin De Bruyne, one of six City starters coming off World Cup duty, set up both goals and Riyad Mahrez scored just after halftime to help City reach the quarterfinals.

De Bruyne, part of Belgium's squad that failed to advance from the group stage in Qatar, crossed to Haaland to open the scoring in the 10th minute and later sent a cross to the far post, where Ake headed home in the 58th at the Etihad Stadium.

Liverpool twice fought back to equalize on goals by Fabio Carvalho and Mohamed Salah, respectively, but its title defense is over after Darwin Nunez missed several good chances in front of the net. The victory keeps Pep Guardiola's team on course for a fifth cup title in

#### six seasons.

Haaland showed signs of rustiness when he fired an early chance over the bar, but the Norwegian quickly made amends with a 10thminute volley to make it two-dozen goals in 19 appearances overall.

An unmarked Carvalho made it 1-1 in the 20th after a pass from James Milner, who left the game with an injury before halftime. The teams traded goals early in the second half. Mahrez curled home a left-footed shot before Nunez

set up Salah's equaliser. Roberto Firmino was unavailable for Liverpool after picking up what manager Jurgen Klopp described as a minor injury in training earlier this week. ### Asian football panel approves strategic reforms

Kuala Lumpur, Dec 23: The Competitions Committee of the Asian Football Confederation (AFC) Friday approved several gamechanging reforms for club competitions with an increased foreign players' quota, financial regulations and a new three-tier format for competitions that will include relegation and promotion.

"In perhaps the most significant reforms to be introduced since the enhancements to the AFC Champions League in 2009, amongst the recommendations include the introduction of new competition formats, lifting the foreign player quota and increasing the financial distribution for participating clubs," the AFC said in a release Friday.

Clubs across the region can now recruit five foreign players of any nationality and one from an AFC

member country (5+1) instead of the three of any nationality and one from the AFC region that was allowed earlier. The new quota will come into effect after the 2023-24 season.

"In another breakthrough de cision aimed at enhancing the quality and stature of the AFC Club Competitions, the Committee also agreed to recognise each MA's domestic regulations on the foreign player registration and remove the foreign player registration quota from the 2024/25 season onwards,' the AFC informed.

As per the current rules, all decisions by the Competitions Committee will have to be ratified by the AFC Executive Committee before taking effect.

The AFC panel has also approved a three-tier competition for the Continent's 76 participating clubs. The clubs will be classified under two heads – West and East – instead of the five zones earlier.

"The top tier will comprise 24 participating clubs in total, divided into 12 teams across the West and East regions competing in a league format. Each club will play four home and four away matches against eight different clubs within its region, with the top eight sides from both regions 16 in total – advancing to the Round of 16 stages, which will be played in a home and away format," the AFC said.

The second tier of Asian club football will see 32 participating clubs divided into eight groups of four teams each. The clubs will face off home and away in a roundrobin format in the Group Stage, with the top two sides advancing to the Round of 16 and the subsequent rounds of quarterfinals, semifinals and final.

Tier 3 will comprise 20 participating clubs divided into five groups.

The clubs will compete in single leg ties to be played in a centralised format with the top eight sides qualifying for the Quarter Finals.

'The strategic reforms also pave the way for more opportunities for participating clubs from different zones to compete against each other as the competitions transition from its current five zone format to the East and West regions," said the release.

The losing teams from the Preliminary and Playoff stages of the top tier will be allowed to participate in the second tier, and likewise, the losing teams from the Preliminary and Playoff stages of the second tier competition will ২ participate in the third tier.

The AFC also introduced a new calculation methodology for club competition ranking and slot allocation. The rankings will be calculated based on all results of the clubs over an eight-year period.
