Casino fire kills 19 in Cambodia

Phnom Penh: A massive fire that lasted more than 12 hours in a Cambodian hotel casino killed at least 19 people and injured about 50, while other victims were apparently not yet accounted for Thursday, as neighbouring Thailand sent fire trucks to help fight the blaze in a bustling border town. More than 30 of those injured may not survive, doctors at the hospital informed. Videos posted on social media showed people falling from a roof after they were trapped by the fire at the Grand Diamond City casino and hotel in the border town of Poipet. Many of those inside. both customers and staff, were from neighbouring Thailand.

Football King Pele no more

LEGENDARY BRAZILIAN LOSES BATTLE AGAINST CANCER AND OTHER AILMENTS

Sao Paulo, Dec 29: Pelé, the Brazilian king of soccer who won a record three World Cups and became one of the most commanding sports figures of the last century, died Thursday. Pele had been hospitalised for more than a month with cancer and multiple ailments. Finally the King of Scorers failed to defend an own goal. He was 82. The standard-bearer of 'the beautiful game' had undergone treatment for colon cancer since 2021. His agent Joe Fraga confirmed his death.

Widely regarded as one of football's greatest players, Pelé spent nearly two decades enchanting fans and dazzling opponents as the game's most prolific scorer with Brazilian club Santos and the Brazil national team

Pele's grace, athleticism and mesmerising moves transfixed players and fans. He orchestrated a fast, fluid style that revolutionised the sport — a samba-like flair that personified his country's elegance on the field.

He carried Brazil to soccer's heights and became a global ambassador for his sport in a journey that began on the streets of



Sao Paulo state, where he would kick a sock stuffed with newspapers or rags. In the conversation about soccer's greatest players, only the late Diego Maradona, Lionel Messi and Cristiano Ronaldo are mentioned alongside Pelé.

in Brazil's 5-2 victory over the host country in the final.

Injury limited him to just two games when Brazil retained the world title in 1962, but Pelé was the emblem of his country's World Cup triumph of 1970 in Mexico. He scored in the final and set up Carlos Alberto with a nonchalant pass for the last goal in a 4-1 victory over Italy.

The image of Pelé in a bright, yellow Brazil jersey, with the No. 10 stamped on the back, remains alive with soccer fans everywhere. In fact, at one point of time, the Brazilian Football Association had thought of doing away with the No. 10 jersey for good in honour of Pele.

Pelé's fame was such that in 1967 factions of a civil war in Nigeria agreed to a brief ceasefire so he could play an exhibition match in the country. He was knighted by Britain's Queen Elizabeth II in 1997.

When he visited Washington to help popularise the game in North America, it was the US President who stuck out his hand first, "My name is Ronald Reagan, I'm the President of the United States of America," the host said to his visitor. "But you don't need to introduce yourself because everyone knows who Pelé is," Reagan added.

RT-PCR mandatory for travellers from **5 nations and China**

New Delhi, Dec 29: Passengers arriving in India from China, Hong Kong, Japan, South Korea, Singapore and Thailand will be mandatorily required to provide negative Covid-19 reports from January 1, Union Health Minister Mansukh Mandaviya said Thursday.

They will have to upload the negative Covid-19 reports from RT-PCR tests on the 'Air Suvidha' portal prior to their arrival in the country. The tests have to be conducted within 72 hours of undertaking the journey to India, Mandaviya informed.

This requirement is in addition to the random two per cent tests of all international passengers in all incoming international flights on their arrival in India irrespective of their port of departure, Mandaviya stated.

Amid a spike in coronavirus cases in some countries, the government has sounded an alert, tightened Covid-19 guidelines and asked states and Union Territories to prepare for any eventuality.

India recorded 268 new coronavirus infections, while the active cases increased to 3.552, according to the Union Health Ministry data updated Thursday. The daily positivity rate was recorded at 0.11 per cent while the weekly positivity was pegged at 0.17 per cent, the Health Ministry informed.

EC develops RVMs for migrant voters


The election body feels that a major proportion of the electorate who have shifted to other states for work refrain from casting their votes as they have to travel

New Delhi, Dec 29: In a major move to increase voter participation, the Election Commission (EC) said Thursday it has developed a prototype of a remote electronic voting machine (RVM) for domestic migrant voters and has invited political parties for a technical demonstration here January 16. However, a number of political

parties including the Congress and the JD (U) are unsure about how the RVM will work. Leaders cutting across party lines also pointed out that legal implications have to be taken into account for the use of RVMs. They also expressed apprehension whether such an idea would be feasible in India.

If the RVM is implemented after stakeholder consultations, domestic migrant voters do not need to travel to their home districts to exercise their franchise. The voter turnout in the 2019 Lok Sabha elec-



tions was 67.4 per cent and the EC is concerned over the issue of over 30

crore voters not exercising their franchise, the body said in a statement. "It is understood that there are

multifarious reasons for a voter not opting to register in a new place of residence, thus missing out on exercising the right to vote. Inability to vote due to internal migration (domestic migrants) is one of the prominent reasons to be addressed to improve voter turnout and ensure participative elections," the EC said. "Out-migration is predominant

among the rural population in overall domestic migration and around 85 per cent of the internal migration is within states," the commission noted.

Terming counting of votes cast at remote booths and their transmission to the returning officer in other states as a 'technological challenge', the EC officials said RVMs will be developed as 'a robust, fail-proof and efficient stand-alone system' based on existing electronic voting machines and will not be connected to the internet. **Continued on P3**

Srimandir timings changed for Jan 1

Puri, Dec 29: Keeping in mind the rush that is usually seen on the year's first day at the Srimandir here, the Shree Jagannath Temple Administration (SJTA) said Thursday that timings of darshan will be changed. Officials said that a decision has been taken to open Srimandir in the wee hours of January 1, next year.

A meeting which was held under the chairmanship of Puri District Collector Samarth Verma, took the decision to change the timings. Temple servitors and officials of the SJTA were also present in the meeting. A decision was taken to make all possible arrangements for the smooth darshan of the devotees.

The Dwarafita Niti (opening of Singhadwar) will be done 1.00am January 1," a SJTA official said. "As there will be heavy rush both December 31 and January 1, a decision has been taken to close the main entrance of the temple for a few hours, December 31 and reopen it at 1.00am, January 1, he added.

The officials also informed that a special sitting arrangement will be made for senior citizens. Also the existing shed meant for devotees wanting to take rest will be expanded, the SJTA official added.

No major headway in Pavel death case

Rayagada, Dec 29: The state Crime Branch constituted Thursday another team of four officials to probe into the mysterious deaths of Russian legislator and businessman Pavel Antov and his friend Vladmir Bidenov at a hotel in Rayagada.

"Another Crime Branch Team consisting of four officers has been formed. Headed by DSP Saroj Kant Mahanto, the team has gone to Ravagada for further investigation. This apart, two forensic experts and an identical number of photographers have been designated to assist the CID-CB team. The team has been entrusted with the responsibility of visiting the accident spot, examining the witnesses and identifying and collecting evidence. They will also follow up with the police regarding

Bhubaneswar, Dec 29: Keeping in view the increase in Covid-19 cases in some foreign countries, the state government has urged the Centre to provide precaution vaccine doses for 1.93 crore people left out in Odisha.

Writing a letter to the Union Health Minister Mansukh Mandaviya, state Health Minister Naba Kishore Das said there has been an outbreak of new Covid variant BF-7 across some countries like China, Japan, USA, Brazil, and Republic of Korea with India reporting some cases.

So far, 8.14 crore doses have been given as first dose and 3.30 crore doses as second dose to the people aged 12 years and above, and 1.31 crore doses to the citizens aged 18 years and above as precaution dose in the state, Das said.

The precaution dose has covered only 41% of the population and currently

no vaccine stock is available in the state

"Keeping in view the demands from various categories of citizens, there is further requirement of precaution dose for 1.93 crore people against a total of 3.25 crore citizens," Das wrote to Mandaviya.

Orissa HC disposes of 1,36,599 cases till Dec 23

Bhubaneswar, Dec 29: The Orissa High Court has registered a disposal rate of 133.60 per cent as 1,36,599 cases were disposed of against 1,02,247 instituted between January 1 and December 23, 2022, an official said Thursday.

While there were 1,96,662 cases pending with the HC at the beginning of 2022, the figure stood at 1.62.310 as of December 23, an of ficial said, adding that 8,769 cases of more than 10-year old were disposed of during the year.

According to the district judiciary statistics, the outgoing year saw a rise in cases being instituted as compared to the previous year.

While 5,00,404 cases were instituted in the district courts till November 30, 2022, the corresponding figure for the whole year of 2021 was 4.34.810.

As many as 4,47,733 cases were


disposed of in 2022 as compared to 2,38,588 cases in 2021, registering a 53.28 per cent rise over the previous year.

Around 72,806 judgements (civil 17.370 and criminal 55.436) were delivered in 2021, while the figure stood at 1,41,920 (civil 29,209 and criminal 1,12,711) as of November 30, 2022. The outgoing year saw a 51 per cent rise in delivery of judgements as compared to the previous year.

Better disposal can be achieved if Odisha judiciary functions with full strength. While the average working strength of judicial officers was 767 against the sanctioned strength of 962 in 2021, the corresponding figure in 2022 is 776 and 977 respectively.

The per capita disposal in 2021 is 311 cases whereas it is 577 cases in 2022.

The case clearance rate in 2021 ranges from 36.84 per cent to 76.86



per cent and in 2022 it is between 45.76 per cent to 177.32 per cent.

The pendency of rape and POCSO cases in the District Judiciary stands at 18,882 as of November 30, 2022. Around 1,042 rape cases were disposed of from January 1, 2022 to December 26. 2022, out of which 125 cases were disposed of within one year from the date of taking cognizance.

Similarly, 3,309 cases were disposed of in the District Judiciary for the corresponding period, out of which 660 cases were disposed of within the statutory period of one year from the date of taking cognizance of offence as delineated under Section 35(2) of the POCSO Act. As many as 4,351 cases relating to rape and POCSO cases were disposed of during the period, out of which 785 were disposed of within one year from the date of taking cognizance.

Also, eight special courts to deal with the cases under POCSO Act have been established. Similarly, in order to combat the mounting pendency of family court cases in Bhubaneswar, another Court of Judge, Family Court -II, Bhubaneswar have been established.

This apart, six courts in the cadre of Civil Judge have been established during the period. In a significant step towards rationalisation of courts vis-à-vis the cases, 25 courts have been made

Interconnected Goals

n November, hundreds of corporate CEOs and heads of state convened in Bali, Indonesia, for the B20 global business summit. The topics on the agenda this year revolved around three interconnected goals: sustainability, inclusion, and economic growth.

Far from being in conflict with one another, these three goals could be mutually reinforcing. A sustainable world could contain climate change and preserve natural capital and biodiversity. Inclusivity would create economic opportunities and shared progress for everyone. And while some believe that economic growth is incompatible with fighting climate change, it is necessary to produce the financial resources needed to create a sustainable, inclusive world - provided that those resources are used correctly.

To estimate the scope of the challenges ahead, we examined two crucially important indicators. First, we measured the sustainability gap, which is the additional investment in low-emissions technologies that every country must make to achieve net-zero emissions by 2050. Given that the world is on track to deplete its "carbon budget" – the amount of carbon dioxide it can emit without triggering dangerous levels of global warming - by 2030, there is little time left to make critical investments. The transition to a netzero economy will require taking decisive steps by the end of this decade.

Another indicator, which we call the empowerment gap, equals the consumption level required to meet basic needs like food and energy, have discretionary income beyond the essentials, and be able to weather emergencies. According to our calculations, the empowerment line amounts to \$11

per person per day in poorer countries and \$55 in richer countries (at 2011 purchasingpower parity). If every household in the world could reach that level of consumption by 2030, every adult by 2050 would have grown up out of poverty and in economic security. But here, too, the world would need to make drastic shifts before this decade ends.

Economic growth could help us reach both goals. Governments could spend some of the income from growth to bring poorer households into the global middle class, while allocating some of it to build green infrastructure.

At the same time, research we presented at the B20 summit suggests that growth alone will not be able to close the sustainability and empowerment gaps. If the countries and regions we studied maintained their current spending levels, few would be able to close more than half of their empowerment gap by 2030, and none would close more than half of their sustainability gap. In the United States, for example, we estimate the empowerment gap to be \$5 trillion, and the sustainability gap to be \$5.6 trillion. If the US economy grew at an an-

nual pace of 2.1% for the rest of the decade, the country would close just 36% of its empowerment gap and 7% of its sustainability gap by 2030.

The situation is very different in Sub-Saharan Africa, where we estimate the empowerment gap to be far larger, at \$10.3 trillion, with the sustainability gap totaling \$600 billion. Growth (as currently projected) is expected to close only 6% of the empowerment gap and 25% of the sustainability gap.

To close these gaps, economic growth would have to be bolstered by additional forces. Business-led innovation, for starters, could alter the current growth model in ways that are more oriented to inclusion and sustainability. Large G20-based companies spend over \$2 trillion per year on research and development and thus have a critical role to play in developing new technologies and solutions to reduce the costs of the sustainability transition.

And when these businesses figure out how to reduce the cost of low-emissions infrastructure, they could also help reorient growth toward sustainability by shifting consumers' preferences toward green products, as electric-vehicle manufacturers have done in recent years. At the same time, when accompanied by strategies and public policies that enable education, training, childcare, health care, and inclusive hiring, business-led innovation could help close the empowerment gap by boosting workers' incomes.

Government and philanthropy could also steer incentives and public resources toward sustainability and inclusion. For example, governments could mobilise more private capital for sustainable projects by investing in them, an approach known as blended finance. Carbon taxes and subsidies for low-carbon projects could also encourage investors to close the sustainability gap. Alternatively, governments could use direct transfer payments to lift more households over the empowerment line.

Unfortunately, the world's current empowerment and sustainability gaps cannot be closed immediately. But that should be a rallying cry, not cause for inaction. Companies must not only take up the challenge and innovate; they also must seize the many opportunities that already exist. Similarly, governments and philanthropists should focus on areas where markets currently fall short. If the business, public, and social sectors work together, we could generate the sustainable and inclusive growth that the world urgently needs.

It often appeared in medical literature alongside the closely related diapasm, also a scented powder made from aromatic herbs for sprinkling over the person. A diapasm was sometimes made into little balls that were strung together round the neck. A third word of similar form is cataplasm, an old term for a poultice. All three are from the Greek plassein, to sprinkle or shape.

THE RISING **FOOD PRICES ARE HITTING POOR AND DEVELOPING COUNTRIES THE HARDEST**

he year 2022 has been blustery for the Indian as well as the global economy. The World Bank in its report titled "2022 in Nine Charts" released December 20. 2022, says that 2022 has been a year of uncertainty. The confluence of crises that defined the year continues to hinder global growth. The global economy is now in its steepest slowdown following a post-recession recovery since 1970 with global consumer confidence already suffering a much sharper decline than during the run-up to previous global recessions.

The world's three largest economies - the US, China, and the euro zone - have been sharply slowing. In addition to the lingering effects of the pandemic, rising food and energy prices fuelled couple by climate shocks and conflicts have hindered a rapid recovery. The rising food prices are hitting poor and developing countries the hardest. Under the circumstances, even a moderate hit to the global economy over the next year could tip it into recession.

As an unstable and uneven economic recovery took form in 2022, global development faced a crisis and slowing growth contributed to a reversal of progress on the global poverty agenda and an increase in global debt. The World Bank says poverty eradication has now become a stalled agenda. By the end of 2022, as many as 68.5 crore people could be living in extreme poverty—making 2022 the secondworst year for poverty reduction in the past two decades (after 2020). It is now projected that 7% of the world's population -- roughly 57.4 crore people - will still scuffle in extreme poverty in 2030, far short of the global goal of 3% in 2030.

Over-encumbered with debt, the world's poorest countries are unable to make critical investments in economic reform, health, climate action, or education among

other key development priorities. Perhaps more significantly, the composition of debt has changed dramatically since 2010, with private creditors playing an increasingly larger role which has made the restructuring of debt far harder. This is particularly perplexing at a time when global growth is stagnating-leading to fears of 'stagflation' - and global initiatives, like the Common Framework, have proved inadequate so far.

The year $20\overline{2}2$ was marked by a severe rise in food insecurity around the globe. The war in Ukraine, high inflation, supply chain disruptions, and the global economic downturn all combined to drive large price increases for many agricultural products and inputs, such as fertilizers.

The first half of the year displayed one of the largest shocks to global energy markets in decades sending energy prices soaring, exacerbating energy shortages and energy security concerns, and further slowing progress toward universal access to affordable, reliable, sustainable, and modern energy by 2030. Globally, 73.3 crore people still have no access to electricity and, at the current rate, 67 crore people will remain without electricity in 2030. In Sub-Saharan Africa, recent improvements have been reversed, with the number of people without access to electricity jumping to 56.8 crore in 2020.

Even prior to the pandemic, the world was facing a learning and skills crisis. COVID-19 has only intensified this crisis, as long school closures have led to colossal learning losses.

The report does not talk about individual countries. Though India does not face a slowdown, it is plagued by other problems. Poverty, hunger, unemployment, and inequality have been exacerbated further in 2022. Despite the Indian government talking of "Amrit Kaal" the grim reality is that India is home to the largest number of hungry, poor, and homeless people. Nearly 16.4% or 22.8 crore Indians are multi-dimensionally poor while 16.3% or 22.43 crore Indians are un-

dernourished in 2019-2021. The proportion of the population that is severely food insecure in the country has risen from 20.3% in 2018-20 to 22.3% in 2019-21. The extension of free rations under the National Food Security Act to 80 crore people is an indirect admission that the spectre of hunger is stalking the country. The inflation eroded the purchasing power of people in India massively. India has one of the highest unemployment rates in the world accompanied by shrinking labour forces and a low employment rate.

In order to enhance its image, the World Bank has mentioned how it is addressing the above problems in the world. But the real problems lie with policies of the Unholy Trinity: the World Bank, the IMF and the WTO which act in the interest of corporates and developed countries like the US. They batter the poor and developing countries to expedite neoliberal policies, restructure the economies and implement conditionalities to suit the interests of multinational corporations when confronting balance of payment problems or unbridled debt burden.

The real problems are: the rich and wealthy pay fewer taxes; the market is highly volatile; the policy of ultra-low interest regime and dollar hegemony. The existence of tax havens is helping the rich to evade taxes and accumulate black money and convert it to white when necessary. Those are leading to extreme inequality, with a concentration of wealth in a few hands. If countries are allowed to make trade and payments in their own currency or the currencies they can afford easily, many problems will evaporate.

ne of the most visible effects of the technological revolution in financial services is in how we pay for goods and services and transact with each other financially. From cash and cheques, it has rapidly transitioned into real-time transfers, contactless payments and app-based banking. In the critical times of COVID-19, mobile money helped governments navigate the financial dystopia and address the practical challenge of delivering affordable and efficient financial services. The ubiquity of the mobile phone

has made it possible to deliver financial services to people for whom a bank account is a distant dream. Digitisation has turned a smartphone into a wallet, a chequebook, a bank branch and an accounting ledger. The innumerable global poor have gained a new value through the cell phone: They are now the "new oil," crucial for future innovation, and tech companies are waking up to the possibility of this vast and relatively untapped mine of further data.

Four in 10 people in the world are below 25 years of age, and 85% of them live in developing countries. Today China has about 800 million internet users in contrast to 300 million in the US. India has the most WhatsApp users worldwide. From South Africa to Brazil, young people are taking to mobile internet with enthusiasm, due to the increased affordability of these devices and data plans. The most significant beneficiary sector in

developing countries from this technological revolution is the financial sector, which has revolutionised the speed, efficiency and affordability of remittances.

Mobile money sometimes considered a form of branchless banking, has allowed people otherwise excluded from the formal financial system to perform relatively cheap, secure, and reliable financial transactions. Some of the most profitable gains for mobile banking have come in remote areas. In these communities, basic mobile phones have leapfrogged the substandard physical branch-banking system. We've reached the point where more people use phones for banking than banks.

Further, the penetration of cellular phones puts developing countries in an advantageous position where making a quantum leap in financial inclusion is concerned. For communities with low literacy levels and sporadic incomes, digital money can transform the socioeconomic landscape. Mobile banking is enabling women to overcome common barriers. It reduces the need to travel long distances to access banking facilities and ensures privacy and security. Mobile money has laid the foundation for a raft of innovations, evolving from a tool for purchasing airtime and sending money between friends and family to a convenient way to access and pay for essentials, such as water bills or school fees. Mobile finance offers advantages

over traditional financial models.

First, digital transactions are essentially free. In-person services and cash transactions account for most routine banking expenses, but mobile finance clients keep their money in digital form. They can send and receive money without incurring transaction costs from their banks or mobile service providers.

Second, mobile platforms link banks to their clients in real-time. Further, digital footprints and transaction data can significantly help assess individual creditworthiness. Mobile network operators are teaming up with banks, financial-tech companies, and data analytics specialists to use customer information to gauge their credit risk and offer microfinance products to some who would otherwise lack any proof of their capacity to repay a loan.

But such success stories do not happen in a vacuum. To begin with, everyone needs a cellular phone with an affordable data plan. It is entrusted to governments and nongovernmental organisations to extend mobile networks to remote areas.

Mobile money transactions will also have to address the limitations which prevent countrywide adoption of the channel.

The promises of mobile finance are certainly very seductive. However, the reality is much harder than we can imagine. It is easier to spread technology than to bring about extensive change in social and individual attitudes. Fraud may be endemic in many financial systems, and risk may always be present. However, with the right digital payment platform and investment, customers are given protection and privacy over their transactions, increasing confidence and providing a safe and convenient way to undertake transactions.

Although mobile telephony might entail initial fixed costs, the variable costs associated with their use are significantly lower, reducing transaction costs overall. Since success is in everyone's best interest, mobile and financial industries and regulators should work collaboratively to unlock the transformative social impact of mobile money. We need a supportive and enabling policy environment. The regulators may balance innovation with risks and systemic stability to support market dynamism. Rules that are too tight will stifle innovation and hinder adoption: rules that are too lax could allow fraudsters to bring mobile banking into disrepute. The right way would be light-touch regulation. The existing law covers most issues such as consumer protection, privacy, fraud; regulators will have to come with industry to build capacity in

law enforcement agencies. As with any revolution, the old order is giving way to a new one, and banks are just one group of players on the mobile money battlefield. Telecommunication companies, internet and technology firms, retailers, and others are in this fight. Governments will have to close the digital divide to reap the benefits of digital financial services.

Biodiversity conservation

Sir, It is disheartening to realise that human activity is causing an enormous loss to the world's biodiversity, which includes everything from forests to oceans, animal species, and tropical plants. The term "biodiversity" refers to all of the species that inhabit the planet and the intricate web of relationships that connects them. The three global issues of climate change, nature and biodiversity loss, pollution and waste have been frequently raised by the scientific community. The recently concluded United Nations Biodiversity Conference (COP15) endorsed the "Kunming-Montreal Global Biodiversity Framework" (GBF) on the final day of discussions. The GBF which contains four goals and 23 targets aims to reverse biodiversity loss, restore ecosystems, and protect indigenous people's rights. By 2030, efforts will be made to prevent the destruction of unaltered landscapes and places with a variety of species. The strategy calls for putting 30% of the earth and 30% of degraded ecosystems under protection by 2030 in order to stop and reverse the loss of nature. It also includes recommendations for increasing funding for developing nations, which has been a key point of contention in negotiations. The fact that nearly 200 nations have endorsed a new set of objectives to "stop and reverse" biodiversity loss by the end of the decade is noteworthy. Targets will also be set for preserving indigenous peoples' rights and crucial habitats like wetlands and rainforests. India is already a member of the High Ambition Coalition, a group of over 113 countries that aims to bring 30% of the world's geographical area under conservation by 2030. India also made a point at COP15 about the need to concentrate biodiversity conservation and mitigation measures on ecosystem-based approaches rather than nature-based solutions

The 14-km-long Angul-Balram rail link is the first phase of a total 68-km inner corridor connecting Angul with Putugadia, Jarapada and Tentuloi, which will cater to coal mines of Talcher coalfields.

The inner corridor is being implemented by MCRL in two phases.

In phase two, the Balram-Putugadia-Jarapada-Tentuloi rail link would be completed. IRCON is the implementing agency of the project that is being developed at an estimated cost of ₹1,700 crore, the statement said. The commissioning of the first

Harnessing solar energy: Gajapati farmer shows the way

R Udayagiri, Dec 29: Manoj Raika, a farmer of Nuagada block in Gajapati district, has set an example for others by harnessing solar energy for growing a variety of crops and becoming self-sufficient.

"As I am making use of solar energy to run pump sets for watering crops, I have nothing to pay for electricity bills. Solar pump sets helped me save several thousand rupees on energy bills during the last three years," said Manoj, a resident of Atarasingh village.

Manoj, who has been pursuing farming for the last 15 years, has four acres of land but in an un-irrigated area. Initially, it was tough for him to grow crops like paddy,

stumbling block as agriculture here is primarily monsoon-dependent. There is no electricity near the farmland. It is too difficult for me to draw up water from the depth of the well,' he added. In 2018, he thought of using solar energy. Under Jalanidhi Yojana, he got a solar-powered pump set after applying for the scheme.

"The pump set has been very helpful in irrigating crops free of cost. As irrigation is easy, I had to grow other crops too, increasing my farm income," he added.

He has underscored the need for more and more farmers making use of such solar-powered agriculture implements so that they can save a lot of money towards electricity bills.

Besides, he is adopting farm mechanisation to reduce dependence on farmhands. He is using a power weeder and mini rice mill which also help him in cultivating the land more effectively and save money.

Drawing inspirations from Manoj, many other farmers in the area have also purchased solar pump sets to grow crops. Manoj earns ₹2.5 lakh annually from farming. Unlike others, he needn't have to migrate to other states in search of livelihood opportunities.

IAF TEST-FIRES **BRAHMOS AIR** LAUNCHED MISSILE

New Delhi, Dec 29: The Indian Air Force Thursday said that it has successfully fired the extended range version of Brahmos Air Launched Missile against a ship target from a Sukhoi SU-30MKI aircraft.

The IAF said that the missile can hit a target at a range of around 400 km. After being launched from a Su-30 fighter aircraft, the missile hit the target ship in the centre, achieving the desired mission objectives in firing conducted in the Bay of Bengal region.

With this, the IAF has achieved a significant capability boost to carry out precision strikes from SU-30MKI aircraft against land and sea targets over very long



ranges, it added.

According to the IAF, the extended range capability of the missile coupled with the high performance of the SU-30MKI aircraft gives the IAF a strategic reach and allows it to dominate the future battlefields. The dedicated and synergetic efforts of IAF, Indian Navy, the DRDO, the BAPL and the HAL have been instrumental in achieving this feat, Defence Ministry officials added.

The IAF will be further strengthened with enhanced lethal capabilities by induction of new range of missile system, long-range guided bombs, the range augmentation kit for conventional bombs and advanced surveillance systems.

Last week, the Defence Acquisition Council (DAC), headed by Defence Minister Rajnath Singh, had accorded approval for acceptance of necessity (AoN) for 24 capital acquisition proposals. These proposals include six for the Indian Army, six for the Indian Air Force, 10 for the Indian Navy and two for the Indian Coast Guard for a total value of Rs 84.328 crore.

Congress calls for white paper on farmers' income

THE ALL INDIA KISAN CONGRESS SAID THE BJP'S CLAIM OF DOUBLING OF FARMERS' INCOME BY 2022 IS JUST A MYTH

New Delhi, Dec 29: The Congress Thursday accused the government of not fulfilling the promise of doubling farmers' income and demanded a white paper on their earnings since 2004.

The All India Kisan Congress, a department of the opposition party, said the Bharatiya Janata Party's claim of doubling of farmers' income by 2022 is just a myth. In reality, their income has come down during the NDA regime.

"In February 2016, PM Modi had promised doubling of farmers' income by 2022. What to speak of doubling their income, if the inflation is accounted for, the farmers' income has actually reduced during these years," Kisan Congress chairman Sukhpal Singh Khaira told a press conference here.



He cited the National Sample Survey of 2018 and said it was actually the Congress-led United Progressive Alliance government between 2004 and 2014 which had "more than doubled the farmers" income". He said the UPA government doubled the MSP of wheat and paddy -- two main crops -within eight years of coming to power. During the Congress regime, the MSP for wheat was Rs 640 per quintal in 2004 and it went up to Rs 1,400 per quintal for the 2013-14 season. Similarly, the MSP for paddy in 2004 was Rs 560 per quintal and it which went up to Rs 1,310 per quintal in 2013-14.

In strong contrast, Khaira said, the MSP for both paddy and wheat did not increase by more than 50 per cent during the BJP regime.

"After independence, the Modi government is the first regime which imposed GST on pesticides, fertilisers and farm appliances..."he said. "Doubling of farmers' income was another epic 'jumla' of Prime Minister Narendra Modi, he alleged. Questioning Prime Minister Modi's silence on the nonfulfilment of his promise of doubling farmers' income by 2022, the Congress leader asked him what happened to the recommendations of the committee set up for the

The Prudent ET donated the highest amount (Rs 336.50 crore) to the BJP, against Rs 209 crore contributed in FY 2020-21. AB General ET and Samaj ET donated Rs 10 crore and Rs 5 crore to the BJP in FY 2021-22, respectively.

The Congress and the Aam Aadmi Party (AAP) have received a total of Rs 18.43 crore and Rs 21.12 crore from ETs, respectively.

While there is only Rs 0.19 crore difference in the donations made by the Prudent ET to both parties, Independent ET donated Rs 4.81 crore to the AAP, making AAP the bigger receiver compared to Congress. Small Donations ET donated only Rs 1.9351 cr to the Congress.

Moreover, the Prudent ET donated to nine political parties, including the TRS, the Samajwadi Party, the YSR Congress, the Shiromani Akali Dal, the Punjab Lok Congress Party, and the Goa Forward Party.

Six ETs, that have declared receiving contributions from different corporates and individuals during FY 2021-22, received a total amount of Rs 487.0856 crore and distributed Rs 487.0551 crore (99.994 per cent) to various political parties.

However, details of donors to these six ETs remain unknown. thereby leading to speculation on whether donations to these trusts were only a means of getting tax exemption or a way to convert black money stashed in tax havens to white money in India, the ADR said.

According to the ADR, details of donors to these ETs, which were formed before the Central Board of Direct Taxes rules came into existence, should also be disclosed.

In FY 21-22, 89 corporate/business houses contributed Rs 475.8021 crore to ETs out of which 62 contributed Rs 456.30 crore to Prudent ET. two contributed Rs 10 crore to AB General ET, three contributed Rs 5 crore to Samaj ET, and 15 contributed Rs 2.20 crore to Independent ET.

Marudhupandi, a college student. The youth, who managed to get to the hump could not sustain the brief success as the bull eventually gave the youth the slip and he tripped and fell to the ground with a thud.

"Adjusting the position of the hand very fast is important to avoid injury. If the bull turns its neck, its horn may pierce or hit the tamer badly," Mani, a veteran bull tamer, who has successfully tamed over 3.500 bulls over a span of about 25 vears told PTI.

"The tamer's legs should not go too close to the animal's legs. The aspirant's knees must bend slightly backwards as and when needed.'

Many Jallikattu bulls do not have hooves and the idea is to prevent injuries to men in case the animals kicked them. Similar training sessions are held in various rural regions of the State.





NIA raids 56 locations linked to PFI in Kerala



New Delhi, Dec 29: The National Investigation Agency (NIA) Thursday conducted searches at 56 locations in Kerala in a case related to unlawful and violent activities being carried out by the Popular Front of India (PFI), its office-bearers/cadres, members and affiliates.

The PFI has been found justifying the use of criminal force and encouraging vulnerable youth to join terrorist organisations. This case was registered suo moto by the NIA September 19.

Searches were conducted at residences of seven State Executive

Committee members, seven Zonal Heads of PFI, 15 Physical Training Instructors-Trainers of PFI, houses of seven PFI cadres trained in the use of knives, daggers, swords and other types of weapons to carry out murderous violent acts and 20 other suspects.

The raids were carried out at three places in the districts of Thiruvananthapuram, three places in Kollam, Pathanamthitta, Alappuzha, two places each in Kottayam, Thrissur, at one place in Palakkad, seven places at Malappuram, 13 places in Ernakulam, four in Kozhikode, nine in Kannur and six at Wayanad.

Earlier September 22, the NIA conducted searches at 24 locations in Kerala, including the offices of

PFI and residences of 13 accused. "Searches have led to the recovery and seizure of sharp-edged weapons, incriminating material and digital devices," the official said in a statement.

Make changes in film, songs: CBFC

Mumbai. Dec 29: The Central Board of Film Certification (CBFC) has directed the makers of Shah Rukh Khan-starrer "Pathaan" to implement "changes" in the movie, including its songs, in accordance with board guidelines, chairperson Prasoon Joshi said Thursday.

The CBFC has asked production banner Yash Raj Films to submit the revised version of the spy action thriller before its release next month, Joshi said in a statement.

He did not detail the changes suggested to the makers or specify the song.

"Pathaan" has been battling controversy and calls for a ban after the release of its song "Besharam Rang", also featuring Deepika Padukone, December 12. A sequence in the song showing Deepika in a saffron bikini led to protests across India for allegedly hurting "Hindu senti-



Last week, the makers released another song, "Jhoome jo Pathaan".

"The film recently reached the CBFC examination committee for certification. The film went through the due and thorough examining process as per the CBFC guidelines.

"The committee has guided the makers to implement the advised changes in the film including the songs and submit the revised version prior to theatrical release,' Joshi said in a statement to PTI. "Pathaan" is the latest in a long line of films to face censor hurdles

Firm halts production for now, probe begins

The CDSCO, he said, has been in regular contact with the national drug regulator of Uzbekistan regarding the matter since December 27. "Immediately on receipt of information, joint inspection of the NOIDA facility of the manufacturer, Marion Biotech, was carried out by UP Drug Control and CDSCO team and further action as appropriate would be initiated based on the inspection report," Mandaviya said in a series of tweets.

Marion Biotech is a licensed manufacturer and holds the licence for manufacturing Dok-1 Max syrup and tablet for export purpose granted by the Drugs Controller, Uttar Pradesh, the health ministry said in a statement.

The governments of both countries are looking into the matter, said Hasan Harris, legal representative of the Noida-based Marion Biotech.

"There is no problem from our end and no issue in testing. We have been there for the past 10 years. Once the government report will come, we will look into it. For now the manufacturing has stopped," Harris told PTI.

Before Uzbekistan's claims were reports linking the deaths of 70 children in Gambia to cough syrups manufactured by Haryana-based Maiden Pharmaceuticals earlier this year. Sources said the DCGI has sought more information from the Uzbek regulator regarding the latest allegation. According to the Uzbek ministry, the chemical ethylene glycol was found in a batch of Dok-1 Max syrup during laboratory tests. The alleged role of Indian pharma companies in the deaths of children abroad had a political fallout too. While the Congress asked the government to stop boasting about India being a pharmacy to the world and take strictest action, the ruling BJP accused it of deriding India in its "hate" for Prime Minister Narendra Modi.

CBI searches 91 locations over medical laxity

New Delhi, Dec 29: The CBI conducted searches at 91 locations across the country Thursday in connection with its investigation against several state medical councils and foreign medical graduates who were allowed to practise in India without qualifying a mandatory test, officials said.

The agency had registered an FIR against 14 state medical councils and 73 foreign medical graduates who were allowed to practise medicine in India without qualifying the mandatory Foreign Medical Graduate Examination (FMGE), they said.

According to norms, a foreign medical graduate must qualify



FMGE/Screening Test conducted by the National Board of Examination in order to get provisional or permanent registration with the National Medical Commission or a state medical council to practise medicine in India.

The sources said NBE sends its results to candidates as well as councils, they said. When fake eligibility certificates were produced by these candidates, medical councils could have verified it from the results directly sent to them by NBE, they said.

The CBI has registered the case of alleged corruption, criminal conspiracy, forgery and cheating against unidentified officials of state medical councils, the erstwhile Medical Council of India. and 73 foreign medical graduates,

Urgent need to develop antibiotics for newborns: Experts

RECENT ESTIMATES SHOW ABOUT 2.3 MILLION NEWBORNS DIE OF SEVERE BACTERIAL INFECTIONS EVERY YEAR

New Delhi, Dec 29: There is an urgent need to develop antibiotics for newborn babies, a population that is particularly vulnerable to antibiotic resistance, according to leading global public health experts including those from India.

Over the last decade, AMR has worsened to the point where around 50-70 per cent of common pathogens show a high degree of resistance to available first and second-line antibiotics, they said

The paper is co-authored by international experts in the field of antimicrobial resistance (AMR), including those from the Global Antibiotic Research & Development Partnership (GARDP) and All India Institute of Medical Sciences

The authors noted that despite substantial progress in medical research and a steep decline in the number of children under the age of five who die of preventable diseases, many problems related to child health remain to be tackled. Severe bacterial infections are one of them.

"There is an urgent need to identify high priority antibiotics to understand which ones work best and safely in children, and then make them available where they are needed," said Mike Sharland from St George's, University of London (SGUL), and member of the Antimicrobial Resistance Programme at Penta - Child Health

"By achieving global consensus, we can streamline the process of antibiotic development, allow for faster access to antibiotics, and reduce the burden of AMR on the vul-



nerable neonatal population," added Manica Balasegaram, Executive Director of GARDP.

The report also highlights how collaborative antibiotic development and access network specifically targeting newborns could also prove valuable compared to single independent studies.

A successful example, the authors noted, has been the collaboration between GARDP, Penta -Child Health Research, SGUL, and other partners on a recent global observational study of 3,200 babies with neonatal sepsis across 19 hospitals in 11 countries.

They are also partnering on an upcoming clinical trial, which will start in South Africa within the next few months before being expanded to other countries.

Despite a rising number of newborn deaths caused by AMR, very few effective antibiotics have been adequately studied to treat serious bacterial infections such as neonatal sepsis, the authors said

As many as 40 antibiotics approved for use in adults since 2000, only four have included dosing information for newborns in their labels, they said. According to the report, ethical concerns, logistical issues and regulatory requirements have made it difficult to conduct clinical research in newborns.

There is a long delay in completing paediatric regulatory studies and they are also not harmonised globally to demonstrate clinical utility in newborns, it said.

OBC RESERVATION IN URBAN LOCAL BODY POLLS

UP govt moves apex court against Allahabad HC order

New Delhi, Dec 29: The Uttar Pradesh government Thursday moved the Supreme Court challenging the Allahabad High Court order quashing its draft notification on the urban local body elections and directing the state to hold the polls without reservation for the Other Backward Classes

The state government, in its appeal against the December 27 order, has said the high court cannot quash the December 5 draft notification which provided for reservation of seats in the urban body polls for the OBCs apart from those for the Scheduled Castes, Scheduled Tribes and women.

The appeal, filed through advocate on record Ruchira Goel, said the OBCs are a constitutionally protected section and the high court erred in quashing the draft notification

The Uttar Pradesh government had Wednesday appointed a fivemember commission for going into the entire gamut of issues for providing reservation to the OBCs in urban local body polls.

The panel will be headed by Justice (Retd) Ram Avtar Singh. The four other members are retired Indian Administrative Service officers Chaub Singh Verma and Mahendra Kumar, and former legal advisors to the state Santosh Kumar Viskarma ঽ

and Brajesh Kumar Soni. The Lucknow bench of the high court had ordered that the state government should notify the polls "immediately" as the term of several municipalities would end by-January 31, while annulling the December 5 draft notification.



There have been no reports of new variants to date, but China has been accused of not being forthcoming about the virus since it first surfaced in the country in late 2019. The worry is that it may not be sharing data now on any signs of evolving strains that could spark fresh outbreaks elsewhere.

The US, Japan, India, South Korea, Taiwan and Italy have announced testing requirements for passengers from China. The US cited both the surge in infections and what it said was a lack of information, including genomic sequencing of the virus strains in the country.

Authorities in Taiwan and Japan have expressed a similar concern."Right now the pandemic situation in China is not transparent," Wang Pi-Sheng, the head of Taiwan's epidemic command centre, said. "We have a very limited grasp on its information, and it's not very accurate.

The island will start testing everyone arriving from China on January 1, ahead of the expected return of about 30,000 Taiwanese for the Lunar New Year holiday later in the month. The new Japanese rules, which restrict flights from mainland China, Hong Kong and Macao to designated airports beginning Friday, are already disrupting holiday travel plans.

Between 6 am Sunday and 6 am Monday, 47 of the Chinese planes crossed the median line of the 160 kilometre (100 mile)-Taiwan Strait, an unofficial boundary once tacitly accepted by both sides, according to the Defence Ministry.

Kabul, Dec 29: A quarter of Afghanistan's private universities risks closure because of the ban on female students imposed by the Taliban government, a spokesman for the sector said Thursday.

Afghanistan's rulers last week barred women from attending universities effective immediately. dealing another blow to women and girl's rights and freedoms since

they seized power in the country in August 2021. The move also triggered international condemnation and an outcry at home.

A minister for higher education in the Taliban government, Nida Mohammad Nadim, has defended the ban, saying it is necessary to prevent the mixing of genders in universities and because, according to him, some subjects violate Islamic and Afghan values. Despite initially promising a more moderate



rule respecting rights for women and minorities, the Taliban have widely implemented their interpretation of Islamic law, or Sharia, since their takeover of the country. They have banned girls from middle school and high school, barred women from most fields of employment and ordered them to wear head-to-toe clothing in public. Women are also banned from parks and gyms. The Afghan society, while largely traditional, had increasingly embraced the education of girls and women over the past two decades under a US-backed government.

A spokesman for the private universities' union, Mohammad Karim Nasiri, said 35 institutions risk closure because of the ban. Male students have also been boycotting classes and exams in solidarity with their female counterparts, he added.

Afghanistan has 140 private universities across 24 provinces with around a total of 200,000 students. Out of those, some 60,000-70,000 are women. The universities employ about 25,000 people."Closing the universities (to women) is both a spiritual and material blow," Nasiri said. "We boldly told authorities that, with this decision, the nation is going backward and everyone is worried.'

"It is not a good situation, everyone is worried about this decision - whether they are teachers, students, or administrative staff," he added. Because of all the financial losses, private university owners told a senior Taliban official, Maulvi Abdul Kabir, and the union that they will have no choice but to close the schools and move their investments abroad if the decision is not reversed, Nasiri said.

Mineral output rises 2.5% in Oct

New Delhi: The country's mineral production increased 2.5 per cent in October over the same month a year ago, the mines ministry said Thursday. The index of minera

production of mining and quarrying sector for the month stood at 112.5, up 2.5 per cent as compared to October last year. As per provisional figures of the Indian Bureau of Mines, the cumulative growth during April-October 2022-23 over the corresponding period of previous year is 4 per cent. The output of important minerals in October includes coal (662 lakh tonne), lignite (35 lakh tonne), natural gas (utilized) 2,829 million cubic metre and petroleum (crude) 25 lakh tonne.

New Delhi, Dec 29: Even as the average price of Indian basket of crude oil increased by 102 per cent (from \$43.34 to \$87.55) between October 2020 and October 2022, the retail prices of petrol and diesel have increased in India by only 19.3 per

cent and 27.1 per cent, respectively, during this period, sources said.

According to Petroleum Ministry sources, petrol prices stood at ₹81.06 per litre in October 2020, however by October 2022, they had risen only 19.3 per cent to ₹96.72 per litre. Similarly diesel prices, which were at ₹70.53 per litre in October 2020, rose by 27.1 per cent to stand at ₹89.62 per litre.

Prices of petrol and diesel have not been increased by public sector oil marketing companies (OMCs) since April 6, 2022, despite record high international prices.

As a result, against the combined 'Profit Before Tax' of ₹28,360 crore in the first half of 2021-22, the three OMCs - Indian Oil Corporation, Bharat Petroleum and Hindustan Petroleum - have booked a combined loss of ₹27,276



crore in the first half of 2022-23. The Centre had reduced the central excise duty twice November 4, 2021 and May 22, 2022, effecting a cumulative reduction of ₹13 and ₹16 per litre for petrol and diesel, respectively

Following these reductions in Central excise duty, some of the states also reduced Value Added Tax (VAT) rates on petrol and diesel.

India imports more than 85 per cent of its crude oil requirements. therefore the prices of petrol and diesel in the country are linked to their respective prices in the international market.

In the broader market, the BSE smallcap gauge climbed 0.22 per cent, while the midcap index dipped 0.09 per cent. Among sectoral indices, oil and gas jumped 1.36 per cent, metal 1.14 per cent, energy 1.09 per cent, bankex 0.93 per cent, utilities 0.88 per cent and services gained 0.59 per cent. FMCG and capital goods suffered losses.

International oil benchmark Brent crude declined 2.01 per cent to \$81.59 per barrel.

Mumbai, Dec 29: The RBI Thursday said banks' gross NPA ratio has fallen to a seven-year low of 5 per cent and the banking system remains sound and well-capitalised.

The declining tendency in the Gross Non-Performing Assets (GNPA) ratio is likely to continue and under the baseline scenario of the stress testing framework, it is projected to fall further to 4.9 per cent in September 2023, the 26th issue of the Financial Stability Report (FSR) said.

The report further said the capital positions of scheduled commercial banks (SCBs) remained strong in September 2022. The Capital to Risk Weighted Assets Ratio (CRAR) and Common Equity Tier 1 (CET1) ratio of SCBs stood at 16 per cent and 13 per cent, respectively.

"Their GNPA ratio have been steadily trending down to a sevenyear low of 5 per cent in September 2022, while net non-performing assets (NNPA) have dropped to tenyear low of 1.3 per cent of total assets," it said.

The provisioning coverage ratio (PCR) has been increasing steadily since March 2021 to 71.5 per cent.

The profit after tax of SCBs registered a growth of 40.7 per cent in the first half of the current fiscal, led by strong growth in net interest income and a reduction in provisions.

GLOBAL SHOCKS LOOM LARGE

The report also said the global economy is facing formidable headwinds with recessionary risks looming large. The interplay of multiple shocks has resulted in tightened financial conditions and heightened volatility in financial markets, it pointed out.

For emerging market economies (EMEs), it said, the challenges are even harsher as they encounter global spillovers, debt fragility, currency volatility and capital outflows.

On inflation, the report said though prices are elevated, frontloading of monetary policy actions and supply side interventions are easing the pressure.

In the financial sector, it said, buoyant demand for bank credit and early signs of a revival in investment cycle are benefiting from improved asset quality, a return to profitability and resilient capital and liquidity buffers.

Monetary tightening in advanced economies, tightening of financial conditions, geopolitical risks, global growth uncertainty and growing risks from private cryptocurrencies and climate change are cited as the major contributors to rise in global. financial market and general risks.

Gross NPA ratio falls CAD at 4.4% of GDP

Mumbai, Dec 29: Widening trade gap pushed up the country's current account deficit to \$36.4 billion or 4.4 per cent of the GDP in the second quarter of the current fiscal, as per data released by the Reserve Bank Thursday.

India's current account balance recorded a deficit of \$36.4 billion in July-September 2022-23, up from \$18.2 billion (2.2% of GDP) in the first quarter of the fiscal and \$9.7 billion (1.3% of GDP) in the year ago period. "Underlying the current account deficit in Q2:2022-23 was the widening of the merchandise trade deficit to \$83.5 billion from \$63 billion in Q1:2022-23 and an increase in net outgo under investment income," the RBI said.

It also said the current account deficit for April-June quarter of 2022-23 has been revised downwards due to downward adjust ment in Customs data

"India recorded a current account deficit of 3.3 per cent of GDP in H1:2022-23 on the back of a sharp increase in the merchandise trade deficit, as compared with 0.2 per cent in H1:2021-22" the RBI added.

Services exports reported a growth of 30.2 per cent on a yearon-year (y-o-y) basis on the back of rising exports of software, business and travel services. Net services receipts increased both sequentially

and on a y-o-y basis. Meanwhile, the RBI's Financial Stability Report said the steady net inflows of foreign direct investment and the resumption of

'India-Aus FTA to cross \$70bn in next 5 years'

India's goods exports to Australia stood at \$8.3 billion and imports from the country aggregated to \$16.75 billion in 2021-22

New Delhi, Dec 29: The free trade agreement (FTA) between India and Australia, which comes into effect from Thursday, will help boost bilateral trade in goods and services to cross \$70 billion in the next five years, according to economic think tank GTRI.

The India-Australia Economic Cooperation and Trade Agreement (ECTA) has come into force from December 29. Global Trade Research Initiative (GTRI) said trade of value \$23 billion would become duty-free from day one.

"This is 93 per cent of mer-

chandise trade of \$25 billion in 2021-22 between India and Australia. This creates opportunities for more trade in tough times. GTRI estimates suggest that the bilateral trade will cross \$70 billion in the next five years due to buoyant trade relations and Australia's gradual weaning away from China," GTRI Co-founder Ajay Srivastava said.

He said while India's exports are diversified, ranging from agriculture, garments, and railway engines to telecom, 95 per cent of India's imports from Australia are raw materials and mining products needed by industry. This makes the two countries gain from both exports and



imports, he added. He also said this agreement will be an antidote for Australia's China troubles.

Under the agreement, Australia is allowing duty-free import of all Indian products. Key gainers will be India's labour-intensive exports. Duty on these will decrease from the current four-five per cent to zero. These goods include textiles, apparel, footwear, furniture, sports goods, jewellery, machinery, railway wagons, and medicines.

Coal accounts for three-fourths

of Indian imports from Australia. LNG, alumina, and manganese are other vital imports.

Australian wine will gain from reduced-duty access to the Indian market. India charges 150 per cent duty on wines, the highest on any product in India.

Under ECTA, Australian wines priced above \$5 for a 750ml bottle can enter India at reduced duties. This pact also allows limited quantities of Australian almonds, pears, oranges, and mandarins.

"No threat to local produce is seen as India already imports these products in large values. India has exercised prudence in opening its market. It did not provide any concession on dairy products, wheat, rice, bajra, apple, sugar, oil cake, etc. To protect the interest of farmers." he said.

BITING Russia to divert metals away from West: Min

Moscow, Dec 29: Russia will redirect its metal exports from Western countries to alternative markets due to sanctions imposed by the EU and US, Trade Minister Denis Manturov said, RT reported.

Moscow named China, Turkiye, southeast Asia, member states of the Russia-led Eurasian Economic Union and CIS countries as priority areas for diversifying metal supplies. According to Manturov, trade flows will also focus on the Latin American, African, and Middle Eastern markets, RT reported.

At a meeting with Russian Prime Minister Mikhail Mishustin, Manturov noted that "our enterprises, with the participation of trade missions, are already reorienting exports", adding that the state will provide measures of support for logistics.

Russia is a major metals producer and exporter. According to Institut Polytechnique de Paris, last year the country held a 13 per cent market share for titanium production, 11.2 per cent for nickel, 10.5 per cent for platinum, 5.4 per cent for aluminium 4 per cent for copper, and 4.4 per cent for cobalt. It is the world's top producer of palladium, a rare metal used in car manufacturing, accounting for 37 per cent of production in 2021.



Haaland sets scoring record

Leeds, Dec 29: Erling Haaland set a Premier League scoring record in Manchester City's 3-1 win over Leeds. At this pace, it won't be his last.

Haaland scored twice to become the fastest player to 20 goals. The Norwegian star, who was born in Leeds, reached the mark in 14 games. Not a bad homecoming.

"For me, as a striker, I could have scored a couple more but that's life, what can I do? I have to practice more," Haaland told Amazon Prime.

City's victory at Elland Road reduced first-place Arsenal's lead to five points. Rodri gave the visitors the lead on the stroke of halftime when he tucked in from close range after goalkeeper Illan Meslier parried a Riyad Mahrez shot.

Haaland beat Kevin Phillips' quickest-to-20 goals record — set in 1999-20 with Sunderland — by seven games. Haaland's father, Alf-Inge, was on hand to watch Wednesday.

"With my father in the (stands) over there, it's special," the 22-yearold Haaland said. "I am happy today, it's a really special moment in my career... It's my craziest fantasy that I could be at Elland Road and score for Manchester City against Leeds.'

Liverpool sign Gakpo

Liverpool completed the signing of Netherlands forward Cody Gakpo from PSV Eindhoven. The 23-year-old Gakpo, who scored three goals at the World Cup, will officially join the Premier League club when the transfer window opens Sunday.

PSV announced Monday that it had agreed to the transfer for an undisclosed fee, describing it as a "record" for the Dutch club.

"This is a great club for me to come in and try to show what I can (do) and try to help the team to achieve more beautiful moments

that they already did in the past years," Gakpo told Liverpool's website. Gakpo scored 55 goals and provided 50 assists in 159 appearances for PSV.

CHELSEA DEAL

Chelsea has agreed to sign striker David Datro Fofana from Norwegian club Molde. The 20year-old Ivory Coast international will join Chelsea on New Year's Day, the Premier League club confirmed Wednesday. Terms of the deal were not disclosed.

Fofana was the leading scorer for Molde, one of Erling Haaland's former clubs, with 15 league goals last season. He's made three appearances for his national team. Molde's statement noted that Fofana is looking forward to following in the footsteps of his idol,

Mbappe saves PSG the blushes

Paris, Dec 29: World Cup superstar Kylian Mbappe scored a penalty deep into stoppage time as un-beaten league-leader Paris Saint-Germain overcame Neymar's red card to scrape a 2-1 home win against Strasbourg.

PSG players celebrated wildly at the final whistle, probably out of relief following a poor performance against a team in 19th place. The penalty came after Jean-Ricner Bellegarde clumsily lost the ball trying to dribble through midfield rather than clearing it in the 93rd

The ball reached Mbappe and he was fouled from behind. PSG captain Marquinhos swept the loose ball home but referee Clement Turpin disallowed the goal and the penalty stood. Mbappe held his nerve to sweep the ball past goalkeeper Matz Sels, who guessed the right way but was beaten for speed.


Mbappe's 96th-minute penalty increased his league-leading tally to 13 goals as PSG moved eight points ahead of second-place Lens.

Neymar was earlier shown a second yellow card in the 62nd for diving in the penalty area and red-carded. It means he will be suspended for Sunday's trip to Lens.

Mbappe started just 10 days after playing in the World Cup final. He became only the second player to score a hat trick in the final but was inconsolable after Les Bleus lost on penalties to Lionel Messi's Argentina following a 3-3 draw. Messi was given extra time off by PSG and is expected back at training early next week.

Neymar, who was in tears after Brazil lost to Croatia in the quarterfinals, set up PSG's opening goal at Parc des Princes. His free-kick from the left was headed in by countryman Marquinhos in the 14th minute, moving Neymar level with Messi on a league-leading 10

Strasbourg's equaliser in the 51st was given as a Marquinhos own goal, as he tried to block Adrien Thomasson's cross from the right

MONACO'S NEW TALENT

After launching the career of Mbappe, French club Monaco may have found another gem in Eliesse Ben Seghir. The 17-year-old midfielder came off the bench to score twice — including an Mbappe-style winner — in his league debut to help Monaco win 3-2 at Auxerre.

Ben Seghir's goals both came from the left side — which is where Mbappe was so devastating when he made his debut for Monaco in 2015 as a 16-year-old. Mbappe helped the Principality club win the title in 2017, before

joining PSG and winning the World Cup with France in 2018.

Ben Seghir replaced striker Wissam Ben Yedder at the start of the second half, with the score 1-1, and made it 2-1 in the 58th minute from Russia midfielder Aleksandr Golovin's pass.

He then struck a brilliant winner in the 85th. Cutting inside from the left, Ben Seghir bamboozled a defender with a stepover and then feigned to shoot several times as he advanced before curling the ball into the right corner — which is one of Mbappe's signature moves.

After the final whistle, Ben Seghir's celebrated with Monaco's 700 away fans by shouting into a megaphone. The win moved Monaco up to fifth place.

A SAGA OF FORGETTABLE YEAR FOR INDIAN C

New Delhi, Dec 29: Virat Kohli's artistic sixes against Pakistan united fans from Kashmir to Kanyakumari in an otherwise underwhelming year for Indian cricket, which started with a promise of transformation but ended with the commencement of another difficult transition period.

Indian cricket in 2022 was chaotic, to say the least and messy at most of the time both on and off the field. The only saving grace was a Rs 48,000 crore IPL media rights deal, an indication of what market forces aspire the cricketing ecosystem to be. But on the field, it was a saga of disappointing results at least for the men.

It started with a Test series defeat in South Africa which led to a dejected Virat Kohli stepping down from captaincy in the longest format. His relationship with the BCCI bigwigs was a fractured one after being sacked from ODI captaincy and he wanted to leave on his own terms. It happened in January and as the year comes to an end, Kohli's illustrious heir Rohit Sharma too finds himself shunted from the national T20 captaincy.

In an expected change of guard, Hardik Pandya emerged as a new leader of the national T20 team as Rohit paid the price for another semi-final exit in the T20 World Cup following defeat against England. The Indian team looked good during bilaterals but came a cropper at the

Afghanistan (T20) and Bangladesh (ODI) didn't have a lot of currency. While Kohli's straight six off

changer and Jammu's tearaway quick Umran Malik entering collective conscience were some of the positive signs. In women's cricket, Mithali Raj and Jhulan Goswami, who set a bench mark in the women's game and

earned respect for the national team on the international stage ended their respective glorious journeys.

While there are a number of batters who could fill Mithali's void, finding Jhulan's replacement will be difficult if the performance of the team under Harmanpreet Kaur is an indication.
