Protests in many areas as terrorists strike twice at same site within 14 hours; minor siblings among 6 killed



Rajouri/Jammu, Jan 2: In an apparent security lapse, two cousins aged four and 16 - were killed when an improvised explosive device (IED) went off in a village in Jammu's Rajouri area Monday, 14 hours after terrorists had shot dead four people there.

The terrorists, locals claimed had planted the IED Sunday itself and it was missed during the scanning by police and security officials who had cordoned off the area after the shootings last evening.

Samiksha Sharma (16) and Vihan Kumar Sharma (4) were killed and six others injured in the blast in Dangri village near the house of Pritam Lal, a victim of the Sunday attack, locals said. There were several people, including Lal's relatives, in the house when the blast took place at around 9.30am. Six persons were killed and 12 injured in

Village Sarpanch (headman) Deepak Kumar said that it was a serious security lapse on the part of police and security agencies.

It is a serious security lapse by security agencies. Minority community people do not feel secure. The administration should take tough measures, he told reporters in Rajouri.

As the incidents led to protests across the district, including in Rajouri town, and a complete shutdown, Director General of Police Dilbag Singh, who visited the site, said that the IED blast was intended to target senior officers who were about to reach there.

He announced that village defence committees (VDCs) will now be revived and rearmed, after some protesting leaders and locals claimed that the incidents could have been averted had the authorities not taken away the weapons of VDCs.

The improvised explosive device (IED) was planted beneath a bag, Additional Director General of Police, Jammu, Mukesh Singh told reporters in Rajouri.

Senior J&K BJP leader and former MLC Vibodh Gupta alleged that 60 per cent of the guns of VDCs have been taken back

Govt announces

New Delhi, Jan 2: The Supreme Court Monday upheld the legality of the Centre's 2016 decision to ban Rs 1,000 and Rs 500 currency notes, saying the decision-making process was neither flawed nor hasty and that it is not relevant whether the stated objectives were achieved or not.

In a big win for the Modi government, a Constitution bench by a 4:1 majority also held that demonetisation is not bad in law merely because some citizens suffered through hardships. The decision does not suffer from illegality as there was consultation between the RBI and the Centre for a period of six months before the notification under challenge was issued, it said.

The shock move to demonetise 86 per cent of the country's cash in circulation overnight in a bid to tackle black money and corruption was announced by Prime Minister Narendra Modi in a tel-

evised address November 8, 2016. Scrutinising the entire record on demonetisation, the bench said there has to be great restraint in matters of economic policy and the court would not interfere with



any opinion formed by the government if it is based on the relevant facts and circumstances or based on expert's advice.

The decision had a reasonable nexus with its objectives, such as eradicating black money and terror funding, and it is not relevant whether those objectives were achieved or not, the court said, adding such decisions required to be taken with utmost confidentiality and speed. The individual interests must yield to the larger public interest sought to be

achieved Justice BV Nagarathna dissented from the majority judgment and said the demonetisation of highvalue currency notes was vitiated and unlawful

Holding that Parliament cannot be left aloof in a matter of such im-

portance and its views on demonetisation were critical, Justice

Nagarathna, who was the juniormost judge in the bench, noted there was no independent application of mind by the Reserve Bank of India (RBI) and the entire exercise was carried out in 24 hours.

A third of world to be hit by recession this year

Washington, Jan 2: A third of the global economy will be in recession this year, the IMF chief has said, and warned that 2023 will be tougher than last year as the US, EU and China will see their economies slow down.

Kristalina Georgieva, the chief of the International Monetary Fund (IMF) made these grim assertions Sunday during a CBS news programme Face the Nation.

It comes at a time when the ongoing conflict in Ukraine shows no signs of abating after more than 10 months, with spiralling inflation, higher interest rates and the surge in coron avirus infections in China fuelled

by the Omicron variant. "We expect one-third of the world economy to be in recession," Georgieva said on the news programme.

The year 2023 will be tougher than last year because the economies of the US, the EU and China will slow down, she said.

Even in countries that are not in recession, it would feel like a recession for hundreds of millions of people, she explained. In October last year, the IMF trimmed its growth forecast for 2023.

Global growth is forecast to slow from 6 per cent in 2021 to 3.2 per cent in 2022 and 2.7 per cent in 2023. This is the weakest growth profile since 2001 except for the global financial crisis and the acute phase of the Covid-19 pandemic, it said.

SOP for police in case of foreign national's death

New Delhi, Jan 2: What should the police do if they find about death of a foreign national in India? There is a certain standard operating procedure, laid down by the Union government, for police to follow in case of death of a foreign national.

If police finds the dead body of a foreign national, it should use the quickest medium of communication to inform the Union Home ministry about the death and it should also inform the Ministry of External Affairs.

The information should contain all details of the foreign national such as name, nationality, date of birth, parentage, number, date and place of issue of passport, residential address in their country of domicile, exact date and time and cause of death.

It should also specify whether postmortem examination was conducted or not. If yes, the result of the postmortem and whether action required from Interpol wing, needs to be conveyed. The police should also collect finger impressions and photographs for identification of foreign national in case of unnatural death.

The Union government official, then, informs the concerned embassy about the death.







2 woman daily wagers found dead in City

Bhubaneswar, Jan 2: The bodies of two woman daily wagers were found under mysterious circumstances at Koradakanta under Mancheswar police limits and Indradhanu Market under Nayapalli police limits here Monday, raising suspicion of murders.

In Koradakanta incident, the deceased in her 30s, Sarita Nayak, who hailed from Berhampur in Ganjam, had married Bidyadhar Nayak, a resident of Banigochha area in Daspalla block of Nayagarh, a year back. Since then, the couple, who made a living by making odd jobs, had been residing at the underconstructing building near which Sarita was found dead, sources said.

According to police, Sarita's brother Herambh Nayak, also a daily wage earner and stays at the building, was the first to spot her body. Informed, police recovered the body before sending it to AIIMS-Bhubaneswar for autopsy.

CMIE's unemployment report 'sponsored': BJP

A REPORT PUBLISHED BY THE CENTRE **FOR MONITORING INDIAN ECONOMY JANUARY 1 CLAIMED** THAT THE STATE'S UNEMPLOYMENT **RATE WAS 0.9% BY DECEMBER 2022**

Bhubaneswar, Jan 2: Opposition BJP and Congress Monday targeted the BJD government and raised questions over the report claiming a drastic fall in the unemployment rate in the state.

A report published by the Centre for Monitoring Indian Economy (CMIE) January 1, 2023, claimed that the state's rate of unemployment was 0.9 per cent by December 2022.

However, the Union government in a statement in Raiva Sabha during the recently concluded Winter Session stated that the unemployment rate of Odisha was 5.3 per cent. At national level, the rate of unemployment was 4.2 per cent.

State BJP general secretary Prithviraj Harichandan said it (CMIE report) is a sponsored one. Almost all the reports of different organisations have shown that Odisha's rate of un-



employment is very high.

There is no industrialisation and no scope for employment in the state. Besides, the state government is also not making any effort to create job opportunities for the youths. "How has the employment rate suddenly increased today." he questioned.

The BJP leader said Naveen Babu should stop hoodwinking the people of Odisha by producing false survey reports before elec-

Similarly, Congress MLA Santosh Singh Saluia said. "The vouths in Odisha are in streets for employment. If we consider the registration figures of 40 employment exchanges, a total of over 8.80 lakh unemployed youths are there in the state. I think Odisha will be at the top in unemployment in India.'

Responding to the allegations, BJD spokesperson Chinmay Sahoo said the private organisation must have prepared the report with some facts and figures. In the coming days, the government of India report will come up, you will see Odisha in a good position in the employment index, he added.

Bhubaneswar, Jan 2: The state government Monday said it has initiated separate registration of vintage vehicles in a bid to fulfil the ambition of owners intending to keep such vehicles and enjoy exemption from scrappage policy.

The owners, enthusiasts and collectors of vintage vehicles, classic vehicles of more than 50 years can apply for special number plates and enjoy exemption from scrappage in Odisha, Joint Transport Commissioner (Technical) Dipti Ranian Patra said.

The Ministry of Road Transport and Highways (MoRTH) has a provision under CMV Rule, 1989 for the registration process of Vintage Motor Vehicles, Patra said, claiming that Odisha would be the first state in the country to implement it.

"Odisha being a state of heritage and culture is the first state to implement this provision so as to fulfil the ambition of the vehicle owner intending to keep such

He said, "MoRTH has taken initiatives to discourage the use of old vehicle by introducing scrapping policy. At the same time to preserve and promote the heritage of old vehicles in India, Central Government has formalised the registration process of vintage motor vehicles. The new rules shall provide salient features such as retention of old already registered vehicles with a new Vintage registration mark 'VA' series (Unique Registration Mark).'

According to the provision, two-

wheelers and four-wheelers (personal use) that are more than 50 vears old from the date of their first registration (including imported vehicle) shall be defined as

the Vintage Motor Vehicles.

However, only vehicles that have no substantial overhaul including modification in chassis or body shell, and/or engine will be considered as vintage, he said, quoting the provision.

The official said the application for registration/re-registration will be made as per Form 20 and shall be accompanied by an insurance policy, fee, bill of entry in case of imported vehicles, and old RC in case of an already registered vehicle in India.

The old certificate of registration of a motor vehicle after being registered as Vintage Motor Vehicle, will be marked as cancelled and the owner may retain such cancelled certificate of registration for historical purposes only, he said.

The State Registering Authority will issue a certificate of registration as per Form 23A after inspection of the vehicle and subject to the condition that the vehicle is fit and having valid PUC (pollution under control) certificate.

If the vehicle is approved, a fresh registration mark will be assigned to the eligible vehicles for Vintage vehicle as 'XX VA YY***', where VA stands for vintage, XX stands for State Code, YY will be a two-letter series and "***" is a number from 0001 to 9999 allotted by the State Registering Authority.

'Under the new law, the issue of a new certificate will cost the owner Rs 20,000 and will be valid for a period of 10 years. Subsequently, the renewal of said registration will cost the owner an additional Rs 5,000 and shall be renewable for a period of five year," the official said.

However, the official said according to a provision, the Vintage motor vehicles shall not be driven on roads for regular/commercial purposes. A vintage motor vehicle is allowed to run on Indian roads only for display, technical research or taking part in a vintage car rally, re-fuelling and maintenance, exhibitions, vintage rallies, and to and fro to such exhibition or car rally, he said.

The owner of a Vintage Motor Vehicle after assignment of Vintage number can also sell his vintage vehicle by applying for transfer of ownership of the motor vehicle and also can change his address by making application in the manner as provided under the Motor Vehicles Act, 1988, the official said.

Labelling norms to fuel refrigerator prices



the new norms also mandate separate star labelling for freezers and refrigerator provisioning units (storage part) of the frostfree models.

"Now, we have to declare labelling for both. That is the new change," said Godrej Appliances Business Head and Executive Vice President Kamal Nandi told PTI.

When asked about the price in crease, he said, "In every energy efficiency tightening, cost inputs go up a little bit to achieve those efficiencies through better insulation and around 2-3 per cent price hike because of this will be happening, depending on various models and Moreover, another change in

Bhubaneswar, Jan 2: Environment activist Prafulla Samantara Monday wrote to Chief Minister Naveen Patnaik urging him to stop auction of mines in virgin forests. In a letter, Samantara said, "As

a sincere social and environment activist and also a concerned citizen, my appeal to you as the Chief Minister to reconsider the decision for auction of five mines in virgin forests in undivided Koraput and Nuapada districts. These are bauxite mines at Balada in Koraput, Kutur Mali & Siji Mali in Rayagada, limestone mines at Uskalvagu of Malkangiri and Garramura in Nuapada district. The auction is scheduled for January 16, 2023.

Virgin forests are key natural resources to be conserved, protected and saved, not only for the livelihood of lakhs of people and climate justice but also for future generational equity and justice, he stated.

'Unmindful' and 'indiscriminate' mining in the said auctioned and to be auctioned forests and hills will result in depletion of perennial water sources to rivers and dams. This will also destroy bio-



diversity and green vegetation, and ultimately sustainable livelihood system of tribal communities. This destruction will cause further pollution and climate crisis, leaving the state in a resourceless situation, he added.

The above said auctions are illegal and undemocratic as the government did not follow laws of the land and rules as per PESA and Forest Rights Act, 2006. Lease for mining should not be allotted without the consent of gram sabhas.

'We expect that it will be a universal technology with high economic efficiency that can purify contaminated water and supply drinking water even in areas where there is no power supply," Chi-Young said in a statement.

In January last year, 12 boys and nine girls were rescued from the station followed by seven boys and two girls in February. Jajpur health officials face heat for buying substandard furniture

MASSIVE IRREGULARITIES ALLEGED; VIGILANCE PROBE SOUGHT

Jajpur, Jan 2: Massive irregularities have allegedly been committed in the purchase of furniture by the Health department in Jajpur district. Substandard products have been purchased from a Raipurbased firm which allegedly used forged documents while bidding.

Various quarters alleged that former chief district medical officer (CDMO) Biranchinarayan Barik has been transferred to Kalahandi district due to his alleged involvement in procuring the substandard furniture.

Additional CDMO, Shibasish Maharana has been entrusted with the responsibilities of Barik. However, there were three senior medical officers who ruled out Barik's involvement in the purchase of furniture.

Sources said that guidelines of GeM have been violated in the purchase of furniture for 133 health subcentres in the district as it has been done through a single bidding. This shouldn't have happened, they added.

Popularity of Daringbadi coffee growing rapidly

Daringbadi, Jan 2: Daringbadi in Kandhamal district is a popular place for tourists and is also referred to as the 'Kashmir of Odisha'. Now however, Daringbadi is also gaining recognition for its coffee cultivation. To add to the success story, now the state-run coffee plantations are processing the seeds in the gardens itself. Earlier coffee seeds were collected from the plantations and sent to Koraput or Odisha University of Agriculture and Technology (OUAT) in Bhubaneswar for processing. Now the cumbersome process has been shelved.

 Tourists at Daringbadi will always make it a point to visit the coffee plantations. To facilitate them, the block administration constructed a 'Hill View Park' in 2000 and renovated it again in 2015.

The Forest department also constructed a nature park for entertainment of tourists. The 'Shita Utsav' which was first started by the district administration in 2015 currently attracts tourists from all parts of the world. However, even then, the coffee plantations have remained prime attraction spots for visitors.

Earlier, the Soil Conservation department had floated a tender and assigned a private agency for upkeep of the coffee gardens, but the agency failed to carry out the work in a proper manner.

However, things started changing for the better after the state-owned Tribal Development Cooperative Corporation of Odisha LTD (TDCCOL) took up the management of the coffee plantations. New coffee gardens have also been developed under the 'Mission Coffee' programme. For this programme coffee cultivation will be taken up



on 70 hectares of land

opportunities for women have
grown. Women belonging to self
help groups are now involved in
the coffee processing work after
getting the training required. So
they have become self reliant.

All this development is happening under the direct supervision of Kandhamal District Collector Ashish Ishwar Patil with the assistance of local BDO Gadadhar Patra and project director Prashant Tripathy, who works in the Soil Conservation office at Baliguda.

Officials said that after processing of the seeds, the entire amount is taken to Koraput for preparation of the coffee powder. Last year approximately seven tonne of coffee seeds were processed. The district administration has set a seed processing target of 10 tonne or more for 2023.

get of 10 tonne or more for 2023.

Officials said that soon a government-run café will come up here at a cost of ₹50 lakh. A children's park, roads and ponds will be constructed as part of beautification project. The state Tourism department has sanctioned ₹30 lakh for the project while another ₹20 lakh will be spent from MGNREGS funds. The district administration will spend an additional ₹50 lakh for beautification, Patra said.

The reason behind setting up of the café is to allow tourists have a taste of organic coffee. They will also be able to buy coffee powder, roasted beans and green coffee at government rates. Demand for all these products are increasing, officials said.

Xi-Marcos Meet

he Philippine President Ferdinand Romualdez Marcos Jr's three-day visit to China from 3 January when he will meet China's President Xi Jinping and other top leaders will be a test of his policy of "friend to all and enemy to none." The exchanges will influence geopolitical equations in the South China Sea region as both China and the US are wooing the Philippines to checkmate each other in the strategically important area. The US has forged ties with the Philippines for providing assistance in the event of attacks by China. This has caused anxieties in Beijing as China is embroiled with the Philippines over control of the South China Sea. According to reports, Chinese fishing boats were seen last week carrying out landfill work at four reef sites around the Spratly Islands, a disputed archipelago claimed by both Beijing and Manila, as well as Taiwan, Malaysia,

The Philippine military reacted to the reports and expressed its "serious concern." It vowed to increase its presence. China, however, dismissed the reports as fictitious. Washington, on the other hand, issued a statement to support Manila's "continued calls on Beijing to respect the international law of the sea in the South China Sea." The thorny issue of maritime disputes will be discussed during Marcos' trip along with areas of cooperation in bilateral trade, infrastructure development, energy and communications.

The meeting between Xi and Marcos is dictated by both domestic and international compulsions. Just as the Philippines likes to continue its policy of bilateral cooperation with China, China is also keen on weaning the Philippines away from the orbit of US influence. The situation has been succinctly summed up by Philippines' foreign affairs assistant secretary Nathaniel Imperial who said both sides have agreed to sign an agreement establishing direct communication between the foreign ministries of both countries "to avoid miscalculation and miscommunication in the West Philippine Sea." The comments also signal a reconciliatory approach and

The President himself has hinted as much in his remarks that the maritime issues do not define "the totality of our relationship with China." In the same breath he has acknowledged the importance of this issue, according to his foreign affairs official.

Marcos' visit is expected to lead to 1.5 billion yuan (US\$217 million) in Chinese grants for the Philippines as well as tourism and infrastructure deals. Though similar agreements were signed between the two countries during the tenure of Marcos' predecessor, former President Rodrigo Duterte, only a few produced tangible results. This was despite the fact that Duterte had friendly relations with China. As such, Marcos' visit will be a test of his abilities to navigate his country's relations with China and the US. Marcos has to show that his independent foreign policy is efficacious as he engages with China.

Incidentally, Marcos' trip to China comes only a month after he met visiting US Vice President Kamala Harris who pledged the commitment of

Marcos' engagement with China will also have a bearing on his domes tic support base. He has been trying to project an image that he will defend the country at all costs. This will add legitimacy to his presidency. The South China Sea issue will bring out the Marcos administration's position on engaging international partners, but more importantly it will address a domestic audience to strengthen the President's support base. China's news agency has put out the news about Marcos' meeting with Xi in a big way. This underlines the importance China is attaching to the Philippines as it is under pressure following efforts by the US, the UK and Australia forming the AUKUS grouping to frustrate China's ambitions over control of the South China Sea. China's spokesperson Wang Wenbin's superlative praise of the Philippines prior to Marcos' visit makes clear China's intent to mollify its neighbour. He said, "China looks forward to working with the Philippines to make this visit an opportunity to carry forward friendship, deepen mutual trust and continue to advance cooperation in the four key areas as good neighbours, good relatives and good partners.'

The fact that the meeting is on even after a fresh surge of COVID-19 in China shows the desperation of China to keep its borders open for the country's economic growth and also thwart efforts of the US and its Western

Ephebicide

George Monbiot created this word in an article entitled Lest we forget in the Guardian on 11 November 2008: "There are plenty of words to describe the horrors of the 1939-45 war. But there were none, as far as I could discover, that captured the character of the first world war. So I constructed one from the Greek word ephebos, a young man of fighting age. Ephebicide is the wanton mass slaughter of the young by the old." The root appears in a few English words, including ephebe, the Greek word filtered through Latin that means a young man aged between 18 and 20 who undertook military service. Ephebiatrics is a rare medical term for the branch of medicine that deals with the study of adolescence and the diseases of young adults; an ephebophile is a adult who is sexually attracted to adolescents. Though George Monbiot created it afresh, there is one previous example of ephebicide on record, in a work of 1979, Saul's Fall: A Critical Fiction. This purported to be a collection of critical essays about a play by a forgotten Spanish author, but the whole book, including the play, was an invention by Herbert Lindenberger, now Emeritus Professor of Humanities at Stanford University.

Epigenome

his term of the biological sciences has been around for decades but it has been specialist, unknown to the general public. That changed to some extent in October 2009 when newspapers reported a paper that had appeared in the science magazine Nature. We're familiar these days with the idea that the nature of living things is controlled by the DNA in their genes, the genetic code of an individual being its genome. Since there are many sorts of cell, but only one genome in an individual, there must be a way to switch genes on and off inside the cell so that it develops into a specific type - fat, muscle, brain or other sort. This process is controlled by chemical switches collectively called the epigenome. The report in Nature was that researchers at the Salk Institute in La Jolla, California, had for the first time mapped it. Environmental factors can disrupt the epigenome, which can lead to a variety of medical conditions, including cancers. Armed with the new roadmap of the way the epigenome works, specialists can now study the differences between healthy and diseased cells and begin to understand how this can happen. Epigenome includes the prefix epi-, upon or in addition to, from Greek epi, upon, near to, or in addition to. Its study is epigenomics and the adjective is epigenomic. The field is new and the terminology is still evolving; it is common for researchers to use epigenetics instead of epigenomics for the study of all the changes to a cell that result from external rather than genetic influences. The closely related term epigenesis refers to our current understanding that an embryo progressively develops from an undifferentiated egg cell, rather than the older belief that it is created completely formed (an homunculus) and merely grows bigger.



Year but the panwill follow us into 2023. If the world thought this would be the first COVID-free year since 2019, then the current suf fering in China sends us a reminder that it may not be so easy.

This is where it all began in China in late 2019 but the true picture of the epidemic was never fully shared with the rest of the world. It was reported that Italy had the SARS-CoV-2 infection (then called just novel coronavirus) during the last quarter of 2019, but it was discovered only after the RT-PCR test became available in January-February of 2020. Details about the origins of the virus and time sequence are still unknown. The geopolitical challenge was that many doors were closed to investigators looking for clues in China.

Once again, China was playing hide and seek with information during the winter months of 2022. Worldometer (using governmentreleased data) showed a wave during November-December that peaked in the second week of December with just over 4,000 daily cases steadily declining to less than 3,000 by Christmas, slowly climbing to a little over 3,000 as of 26 December. Other sources, particularly foreign news agencies, reported an epidemic raging in the whole country with Beijing and Guangdong the worst affected. The New York Times reported on Christmas Day: "a picture is emerging of the virus spreading like wildfire." The current spread is mostly Omicron BF-7 variant, which has been found earlier in isolated pockets in India.

Unfortunately, the WHO has once again been unable to lead the world about this outbreak, mirroring the delay seen in January 2020 when there was an obvious pandemic with the virus detected in many countries in three continents plus Australia. WHO announced the pandemic only in the second week of March 2020. A new WHO investigation accepts this-a panel headed by Helen Clark (former PM of New Zealand) and Ellen Johnson Sirleaf (former President of Liberia) asked why WHO waited until January

30 to declare an international health emergency (which is still short of calling it a pandemic), a surprising and costly delay that came due to apparent Chinese efforts to stop the announcement. During 2020-21-22, the world has moved on, scientists and epidemiologists, India included, are past the learning curve and quite well-informed. India has no cause to panic. All we need to do today is to keep watching the daily numbers of diagnosed infections, the pressure on our healthcare system in various states. and make slow but deliberate conclusions. So far there is no signal of any new wave in India.

India had three major waves in 2020 spread over 10 months, caused by the original, slow spreading Wuhan virus and a small proportion of the Alpha variant that emerged in the UK; in 2021 spread over March-July, about five months, caused by Delta variant that had emerged in India; in 2022 spread over just two months, January-February, due to the Omicron variant. In epidemiological terms, a wave is an epidemic spread, and the valley, if sustained over a long period, is an endemic spread. India has been in an endemic pattern since March 2022, with a slight increase in daily numbers in June-July-August, partly due to the BF-7 variant, not quite a wave.

The Omicron variant defied predictions - it spewed out many subvariants; all of them defied immunity from previous infections or from two or even three doses of available COVID-19 vaccines. Reinfections were common, in some once, in others more than once. We have already seen the BF-7 subvariant. So, what should India be afraid of? True, the SARS-CoV-2 has not followed the rules made by virologists, and caution is the watchword. Panic is certainly not called for. Full facts will take time to be known. But we know that there was a ruthless lockdown in Wuhan district in early 2000, obviously as they had a calamitous wave, spreading fast and putting immense pressure on healthcare, and causing very high mortality. While preparing for the lockdown, they let foreigners leave, and medical students returning to Kerala, even in January 2020, had famously carried the virus. The strict and ruthless lockdown was imitated by India in March as soon as WHO declared a pandemic, but even before the virus had begun spreading.

China had consistently been ruthless when it came to slowing the spread of the virus, yet kept up the image that all was well in the country. The Chinese even went through the Winter Olympics 2021. Then they had the 'Zero-COVID' policy in vogue up until the end of November 2022

All in all, many Chinese were protected from the infection and disease during 2020 and through the last quarter of 2022. But nothing can stop the transmission of BF-7, as the Chinese have learned.

out to have low efficacy. Their killed-virus vaccine is with aluminum salt as the adjuvant, but the Indian adjuvant for killed-virus vaccine is a novel one called al hydroxyquim - a combination of aluminum to strengthen antibody response and a special, innovative, molecule to markedly enhance cell-mediated immunity. What high immunity does is to protect from severe disease in spite of re-infection.

On account of earlier infection prevention interventions under the Zero-COVID policy, a large proportion of Chinese were immunity-naïve. Now, millions of Chinese are getting their first infection with BF-7 and that would explain the current scenario in China with severe disease. Omicron disease is not a killer in the immune-population - except in the elderly, the immunosuppressed due to malignancies, organ transplants, immunosuppressive therapies, and particularly in the non-immune.

At present, it is reasonable to predict that India is not anywhere near as vulnerable as China. We had our share of mortality during 2020-2021, the scale of which is disputed. The unmistakable fact is that we had no 'Zero-COVID' policy but let the virus spread at its will, we let re-infections happen too, and we have much more efficacious vaccines. Omicron (known sub-variants) cannot do much harm in India in 2023. The advice of the experts is: Be cautious, not anxious. Be alert, not in panic. Keep watching daily numbers and events to see the trend.

That's as good as it can get for 2023. It is advisable to be masked up in crowded areas. The practice helps prevent other infections, and puts in place civic discipline as a simple and easy layer of protection that can be made mandatory should the situation turn out different.

SPECTRUM CLIMATE CHANGE

Is it time to give up on 1.5°C?

the rage. Countries, companies, and others worldwide have committed to eliminating their net greenhouse-gas emissions by a particular date - for some, as early as 2030. But net-zero targets are not tantamount to limiting global warming to the Paris climate agreement's goal of 1.5° Celsius - or any particular level of warming, for that matter. It is the path to net-zero emissions that makes all the difference.

This is well understood among experts. A 2021 report by the International Energy Agency, for example, charts a detailed path, divided into five-year intervals, toward achieving net-zero emissions by 2050 – and giving the world "an even chance of limiting the global temperature rise to 1.5°C." The most striking feature of this analysis, at least to me, is the magnitude of the decline that is required by 2030: roughly eight billion tons of fossil-fuel-based emissions, taking us from the 34 gigatons carbon dioxide today to 26 Gt.

To achieve this, emissions would have to decline by 5.8% per year. If the global economy grows at a conservatively estimated annual rate of 2% over that period, the global economy's carbon intensity (CO2 emis-

Tet-zero commitments are all sions per \$1,000 of GDP) would need fell significantly short of the first ing to tout an unrealistic goal hamto decline by 7.8% per year. While carbon intensity has been declining over last 40 years, the trend has been nowhere near this rate: from 1980 to 2021, carbon intensity fell by just 1.3% per year, on average.

In fact, with global GDP growth exceeding the rate of carbon-intensity decline by about two percentage points, emissions roughly doubled during that period. One reason is precious little effort was made to reduce carbon intensity for most of that time. The decline that occurred was largely a byproduct of emerging economies becoming wealthier. To be sure, as climate change gained more attention from policymakers, the rate of decline did accelerate, averaging 1.9% per year since 2010. And with supply-side constraints now encumbering the global economy a modest further reduction in carbon intensity could be enough to put the global economy at or near the peak of its total CO2 emissions. An emissions peak would be an important milestone. But unless it was followed immediately by a sharp decline, we would still be pumping some 34 Gt of CO2 into the atmosphere each year. While the IEA report does not address what would happen if we two interim targets (2025 and 2030), one can probably assume that it will be next to impossible to avoid crossing the 1.5°C threshold.

We have the tools to reach the IEA's targets. As the report makes clear, no new technological breakthroughs are needed in the first decade. Moreover, the costs do not appear to be prohibitive. The prices of wind and solar energy, for example, have declined substantially in recent years. But there would have to be huge changes in almost every corner of the global economy, and those changes do not appear to be occurring nearly as fast as the IEA timeline would demand.

The sobering fact is that the IEA report's target of 26 Gt of CO2 by 2030 is not within reach, because the global economy's carbon intensity is declining at barely a quarter of the required rate. A sharp discontinuity in this variable is possible, and perhaps some would argue that 26 Gt remains a useful aspirational target. But it does not seem particularly realistic.

Is it better to cling to an unattainable target, because it represents the best path for people and the planet, or revise that goal to something more feasible? Can continu-

per progress, as people become demotivated or simply stop viewing the effort as credible? Or is it worse to acquiesce to the consequences of abandoning the ambitious path, including the risk of crossing irreversible tipping points?

Whichever route the world chooses, the challenge will remain the same: reduce CO2 emissions dramatically - and fast. Of course, that is easier said than done. The world economy comprises 195 countries with different cultures and political systems and at different stages of development, as well as countless businesses of all sizes

and types, and eight billion peole. But there are ways to simplify the challenge. Half of global greenhouse-gas emissions come from just seven economies: China, the US, the EU, Japan, India, Canada, Australia, and Russia. A concerted and coordinated effort in these large economies would make a material difference in emissions trajectories and, perhaps more important, generate technologies and management approaches that will be needed to reach net-zero goal.



New Delhi, Jan 2: The father with money in the bank but none to pay vendors for his daughter's wedding, the retailer scrounging for funds to keep business going, the house help who didn't get a salary for two months.

On Monday, these and many other similar tales of hardship became alive again, when the Supreme Court upheld the government's November 8, 2016 decision to demonetise Rs 1000 and Rs 500 denomination notes.

The decision, touted by the government to be a 'surgical attack' on black money, missed its mark by a great margin and became the bane of the daily-wage labourers and poor Indians, a section which relies almost exclusively on cash. To 38-year-old house help Parvesh, even the mere mention of the word 'notebandi' sends a shiver down

her spine. The single mother of a 20-year-old son said she was forced to work without a salary for almost two months and went empty stomach for days at a stretch. "It was the worst time of my life. Worse than even Covid-19, because during the Covid there was at least

some help from the government and society at large. But during demonetisation, we are left alone to suffer," said Parvesh

"I mean how can I expect my employer to help me when he himself was struggling with money?' she said, having little to no idea

about Monday's Supreme Court verdict. The SC in its verdict said the decision-making process behind the 2016 demonetisation was "not flawed."

In a five-judge bench, four judges voted in favour of upholding the note-ban decision-making whereas one judge dissented.

The pain was not limited to the poor, and the middle class too struggled to understand the withdrawal rules that cascaded with everyday regularity in the wake of demonetisation. Nor was it any more inured to the agony of standing in the unending queues before the ATMs, which too often ran out of cash, and too early. Many small-scale businesses are still reeling from demonetisation.

"Our business relies on cash and this makes it impossible for us to function properly and run our business. A limited time was given by the government to exchange the cash left with us, we were in continuous confusion about whether we should do business or stand in long queues for hours to get our cash exchanged,' Manish Shah, a Surat-based retailer, recounted.

"The whole business cycle was disrupted in the entire country,' he added. For Jammu-based Rajendra Gupta, the cash crunch due to demonetisation had turned the once-in-a-lifetime occasion of his only daughter's wedding into a nightmare. He recalled how he was made to beg for his own hardearned money to pay the vendors so that preparations could go on without a hitch.

"I didn't have enough money to pay the vendors. There was a limitation on how much money you could withdraw from banks. And then the government's continuous flip-flop on rules and regulations and whatnot," he said.

HP cops being trained in Tibetan, Chinese

sengers arriving in India from China, Hong Kong, Japan, South Korea, Singapore and Thailand from the first day of 2023. The test must be conducted within 72 hours of undertaking the journey to India and the negative report from the RT-PCR test has to be uploaded on the Air Suvidha portal before their departure. This will also apply to transit-

ing passengers through the coun-

tries (mentioned) irrespective of their originating countries before coming to any Indian Airport,'

Bhushan said in the letter. Accordingly, the Ministry of Civil Aviation's Air Suvidha Portal has to be made operational for passengers on all international flights from these countries, with a provision to allow international travellers arriving in India to submit negative RT-PCR test reports as

India building permanent bunkers for BSF at Sir Creek

A BSF contingent is providing armed protection to the labourers engaged by the CPWD to complete the construction of the three bunkers in the Sir Creek area by March

New Delhi, Jan 2: For the first time, India is constructing "permanent vertical bunkers" of concrete to station BSF troops right at the strategically significant Sir Creek and 'Harami Nalla' marshy area along the India-Pakistan International Border in Gujarat,

official sources said. The Union Home Ministry has sanctioned a Rs 50-crore fund for the construction of eight multistoreved bunkers cum observation posts in this area along the

Bhuj sector in view of the "constant infiltration of Pakistani fishermen and fishing boats in the area", the sources said.

According to official data, the Border Security Force (BSF) apprehended 22 Pakistani fishermen and seized 79 fishing boats as well as heroin worth Rs 250 crore and charas worth Rs 2.49 crore from this region of Gujarat in 2022.

While three pylon-shaped towers are coming up in the Sir Creek area, a 4,050 sq km marshy area between India and Pakistan, five such concrete structures will be



constructed by the Central Public Works Department (CPWD) along the 'harami nalla' area spread

across 900 sq km, sources said. The top floor of each of the 42foot high 'vertical bunkers' will

have space for mounting surveillance gadgets and radars to keep an eye on the area that comprises serpentine estuaries. The rest two floors will have the capacity to

house around 15 armed BSF per-

sonnel and their logistics, the officials said.

According to officials, these bunkers are being erected in the Lakhpat Wari bet, Dafa bet and Samudra bet on the eastern side of the creek area, well within Indian territory. A BSF contingent is providing armed protection to the labourers engaged by the CPWD to complete the construction of the three bunkers in the Sir Creek area by March. The ocean gets too turbulent from April and hence the work is going on at war footing, a senior BSF officer said.

The move to build the bunker came after then BSF director general (DG) Pankaj Kumar Singh, during a tour of Union Home Minister Amit Shah to the Gujarat border in April last year, along with senior officers made a presentation that the creek area and the marshy water body between India and Pakistan were prone to infiltration and the BSF security apparatus was located way behind. The BSF said it requires eyes right at the front and for that to happen it needed a permanent base, a senior official privy to this

meeting said. It was informed during the presentation that the area is "very sensitive and holds enormous strategic significance" and hence the BSF needs some permanent bases right on the front as compared to the border posts that are currently located about 50-60 km from the creek area.

In order to "dominate" the creek areas, the BSF sends regular foot and boat patrols to keep vigil in the entire 85-km-long coastal region of Gujarat under its control, they said, adding that currently, it takes about five to six hours for troops to reach the border from their posts, onboard speed boats or regular boats.

A final agreement acceptable to all sides remained elusive with Naga rebels and the Centre agreeing to disagree on two key issues

Kohima, Jan 2: The Gordian knot enveloping the Naga peace talks could not be untied through the year gone-by, as a final agreement acceptable to all sides remained elusive with Naga rebels and the Centre agreeing to disagree on two key issues.

The coming of Centre's new interlocutor for Naga Peace talks, AK Mishra to Dimapur in Nagaland earlier last year and holding parleys with representatives of various Naga groups and other stakeholders in an effort to resolve the vexed problem had spread hope that a solution to the decades long insurgency in the state would come as a welcome Christmas gift.

Mishra met the leadership of National Socialist Council of Nagaland (Isac-Muivah) including veteran leader Th Muivah inside the group's headquarters in Hebron, a first in the history of such talks.

A former special director of the Intelligence Bureau, Mishra succeeded the last Interlocutor and Nagaland Governor RN Ravi who was transferred to Tamil Nadu as the Governor in September last year.

After this, the negotiations continued in Delhi with Muivah and other leaders of the group for several rounds, but a final settlement remained elusive, as the NSCN-IM remained adamant on its demand for a separate flag and constitution for the Nagas. A demand, which till now has not favour with the Centre. However, while marking the 25th year of ceasefire with the Centre, the NSCN-IM has assured it will continue to uphold



The reassurance was made by the Ceasefire Monitoring Cell (CFMC) of the NSCN-IM on completion of 25 years of ceasefire agreement with the Government of India entered July 25, 1997.

The Government of India has been holding separate dialogue with the NSCN-IM and the Working Committee of Naga National Political Groups (NNPGs) since 1997 and 2017 respectively.

NNPGs comprise of at least seven Naga groups. It inked the Framework Agreement with NSCN-IM in August 2015 and the Agreed Position with NNPGs in November 2017.

While NNPGs have agreed to accept a solution and continue the dialogue, the NSCN-IM has been rigid on its demand for a separate flag and constitution for the Nagas.

"They (Naga negotiators) have come back from Delhi and nothing is likely to happen before Christmas as talks will resume only after the festive season,' Nagaland Chief Minister Neiphiu Rio had said last month.

On the other hand, the Centre

heeded to the cry of the people of the State for removal of Armed Forces Special Powers Act (AFSPA) 1958 from Nagaland.

March 31, the Centre announced withdrawal of AFSPA 1958 from 15 police stations in 7 districts in Nagaland with effect from April 1, which was welcomed by the State government but rejected by Naga civil societies demanding complete repeal of the Act from the State.

AFSPA was imposed in the entire state of Nagaland from 1958 to curb the Naga insurgency movement.

A demand from people residing in six districts supported by the Eastern Nagaland People's Organisation (ENPO) for a separate state-'Frontier Nagaland'-tooremained a chimera.

The ENPO, an apex body of the seven tribes from the six districts – Mon, Tuensang, Longleng, Kiphire, Noklak and Shamator, had started seeking a separate state from 2010 and in August this year announced a boycott of the Hornbill Festival held from December 1 to 10. to highlight the demand.

Agartala, Jan 2: Ahead of the Assembly elections in three northeastern states -- Nagaland, Meghalaya and Tripura -- the demands for separate states by the local parties for the tribals are gaining momentum. The national parties, in terms of tribal vote share, are caught in a tricky situation on the issue.

The creation of separate Garo. Khasi states in Meghalaya, the separate state of 'Frontier Nagaland' and elevation of the Tripura Tribal Areas Autonomous District Council (TTAADC) into "Greater Tipraland State" for the tribals are the key issues in the poll bound three states.

The leaders of the national political parties including the BJP, the Congress and the CPI-M, though not supporting the separate state demand, remained non-committal about openly opposing the issue fearing loss of tribal votes.

Leaders of TIPRA (Tipraha Indigenous Progressive Regional Alliance), who have been demanding the elevation of the TTAADC into the 'Greater Tipraland State' for the tribals, said that it is ready for an electoral alliance with those parties who give their commitment and support to their demand.

Senior TIPRA leader and Deputy Chief Executive Member of the TTAADC, Animesh Debbarma told IANS: "We have only one agenda, that is 'Greater Tipraland' and constitutional solution for the Tiprasa (tribal) people living in the TTAADC area. Until this issue is resolved we are not going to form any type of alliance with anyone. We are also protesting against the violence unleashed by the BJP.

The TIPRA is now ruling the 30member TTAADC, which has jurisdiction over two-third of Tripura's 10,491 square km area and is home to over 12,16,000 people, of which around 84 per cent are tribals, making the autonomous council a mini-assembly.

The TTAADC, in terms of its political significance and geographical area, has been considered a mini-assembly in Tripura after

The TIPRA organised a two-day sit-in demonstration at Jantar Mantar in Delhi December 5 and 6 and submitted a memorandum to Prime Minister Narendra Modi demanding upgradation of the TTAADC to a 'Greater Tipraland State' under Articles 2 and 3 of the Constitution for the protection of the demography and rights of the tribals.

In Nagaland, the influential Eastern Nagaland People's Organisation (ENPO) is firm on boycotting the forthcoming Assembly election if the Centre does not fulfil its demand for a separate state of 'Frontier Nagaland'.

ENPO Secretary W. Manwang Konyak said that Union Home Minister Amit Shah is expected to visit the ENPO areas in northern Nagaland in the third or fourth week of January to discuss the issue. "The three-member central team, which visited Nagaland in mid-December to study the separate state of 'Frontier Nagaland' demand, has submitted its report to the central government," he told IANS over phone.

The ENPO leader said that the 'Frontier Nagaland' would cover six of the 16 backward districts of Nagaland - Mon, Tuensang, Kiphire, Longleng, Noklak and Shamator.

A delegation of the ENPO met the Union Home Minister in New Delhi December 6 and Shah, according to the Naga leaders, highlighted a clear roadmap for an amicable, legislative and sustainable solution of their demand which also includes consultation with the people of Nagaland and the state government.

In support of their demand for the creation of 'Frontier Nagaland', seven tribes of Nagaland rejecting the state government's appeal had also boycotted the recent 'Hornbill Festival'. Seven tribes of Nagaland - Chang, Khiamniungan, Konyak, Phom, Tikhir, Sangtam and Yimkhiung - are spread across six districts.

On the separate state demand, the Nagaland cabinet had recently resolved that whenever a Legislative Assembly session is convened, legislators and members of Eastern Nagaland Legislators' Union, if and when they desire to discuss, may move accordingly and the issue

would be deliberated threadbare. In Meghalaya, different tribal groups in the state in support of the separate Garoland state demand organised a sit-in demonstration at Jantar Mantar in New Delhi in mid-December under the umbrella of the National Federation for New States, in an effort to make their respective demands for statehood heard by the Centre.

The Garoland State Movement Committee in collaboration with the NFNS has been agitating for a separate Garoland state for the past many years. The Garo Hills region in western Meghalaya is spread across 10,102 sq. km and according to the 2011 Census, is home to 13.94 lakh people, mostly tribals.

NFNS Vice-President Nikman C. Marak said: "If we work together, we would be able to achieve our demand. We need to work unitedly to achieve our long-standing demand of Garoland.'

The assembly elections in Nagaland, Tripura and Meghalaya are expected to be held in February

Police to scrutinise madrasa teachers from outside Assam

Sarma said the police are coordinating with Bengali Muslims, who have a positive attitude towards education to create "a good environment" in

AIADMK settles issues with TN

Chennai, Jan 2: The opposition AIADMK, which is heading the National Democratic Alliance (NDA) in Tamil Nadu, has settled the issues with the state BJP and has commenced focusing to highlight the flaws of the ruling DMK government.

The BJP and AIADMK were in a war of words in the state after the AIADMK leader and former minister, CV Shanmughan said in a public programme that the DMK would forgo all its present allies and enter into a political alliance with the BJP in the next Lok Sabha elections.

This evoked a sharp response from the Tamil Nadu BJP and many leaders took to social media handles against this statement from the AIADMK leader. However, in another public programme. AIADMK interim general secretary and former Chief Minister, Edappadi K. Palaniswami said that the AIADMK and BJP alliance was intact and that there should not be any public opinion from the AIADMK leaders or cadres against

The BJP also directed its leaders



and cadres not to attack the AIADMK leaders in public or through social media platforms.

With the 2024 Lok Sabha polls approaching, the AIADMK has now commenced focusing on the flaws of the DMK government in the state and the failure to keep its promises

AIADMK leader and former minister Sellur K. Raju in a public programme Sunday said that if the DMK government of Stalin had kept its promise, the women in the

state would have been richer by Rs 22,000. He was rebuking the promise made by the DMK before the 2021 Assembly elections that if the party was elected to power it would provide Rs 1,000 per month to women voters. The DMK came to power in May 2021 and if the promise was kept each woman would have gotten Rs 22,000 taking into consideration Rs 1,000 per month for the past 22 months.

The former minister also said that except for the Rs 1,000 as Pongal

gifts, the DMK government has not been able to provide anything to the people of the state. AIADMK also is highlighting the fact that even sugarcane was included in the Pongal gift hamper after the party had taken a strong stand for the sugarcane farmers.

The AIADMK interim general secretary, Edappadi K. Palaniswami (EPS) said that the DMK government was bent on destroying the Pongal gift scheme envisaged and executed by the legend of Tamil Nadu politics, former Chief Minister, MG Ramachandran

The AIADMK leader has also demanded Rs 5,000 as the Pongal gift amount and said that when the DMK was in opposition, it had promised that the Pongal gift money would be enhanced to Rs 5,000 if the party gets power.

According to sources in the AIADMK, the party would be highlighting the issues of the flaws of the DMK government, including unkept promises across the state. The party is also planning a doorto-door campaign against the DMK government as part of its preparations for the 2024 Lok Sabha polls.

Despite border troubles with China, Arunachal revs up development

the state government have rolled out an ambitious infrastructure development mission along Arunachal Pradesh's border with Myanmar (520 km), Bhutan (217 km) and China (1,080 km), even as the intermittent troubles that keep erupting along the Line of Actual Control (LAC) show no signs of abating.

December 9, PLA troops approached the LAC in Arunachal Pradesh, but Indian troops firmly contested their way, leading to a clash between the two. Sources said that although no loss of life or major injuries were reported but both - some Indian and Chinese troops - received some minor injuries during the clash.

Besides the problem in the international frontiers, the 804 km inter-state decades old border issue with Assam, Chakma-Hajong tribal issue and Arunachal Pradesh Public Service Commission recruitment examination paper leakage also dominated Arunachal Pradesh in 2022 and their consequences would carry forward in the new year.

After Tripura, Arunachal Pradesh is the second state in the northeastern region to become a power surplus state after Prime Minister Narendra Modi dedicated the 600 MW Kameng HydroPower plant to the nation November 19.

The Prime Minister November 19 also inaugurated northeast's first greenfield airport called Donvi Polo airport at Itanagar and with this the northeastern state got three airports with the Pasighat and Tezu airports- the other two.

Arunachal Pradesh Chief Minister, Pema Khandu, said that to develop the bordering areas of the state and to facilitate the people to remain in their border villages and to prevent their migration, the Centre would invest Rs 50,000 crore to construct highways in farflung areas along the 1,817 km international borders with China, Myanmar and Bhutan.

The Chief Minister, who was recently on several day visit to the remote areas along China, said that the Union Road, Transport



Highways Ministry has sanctioned adequate money for the 1500 km frontier highway that would connect all the border areas of the state from East to West and interconnecting roads between the highways of about 1.000 km.

To tap the state's hydropower potentiality, Union Power Minister RK Singh recently assured Arunachal Pradesh Deputy Chief Minister, Chowna Mein, that the Centre would soon approve an investment of Rs 32,000 crore for the 2,880 MW generation capacity Dibang hydroelectric project in the state.

Assam and Arunachal have earlier agreed in-principle to restrict the number of disputed villages to 86 instead of 123 along eight districts of Assam and 12 districts of Arunachal. Chief Minister, Minister and official level meetings were held both in Arunachal Pradesh and Assam to resolve the several decades old 804 km inter-state border dis-

putes between the two states. There are about 65,000 tribals belonging to Chakma and Hajong community in Arunachal who fled from East Pakistan, now Bangladesh, and were settled by the Central government in the then North East Frontier Agency (NEFA), now Arunachal Pradesh.

Various tribal organisations in Arunachal have been agitating both in the state and in New Delhi alleging deprivation of their basic rights including racial profiling, cancellation of the Residential Proof Certificates issued to the Chakmasand Hajongs tribals by the state government.

Special diet for Jallikattu bulls to eat well, fight well

Food items, neatly divided into 'three square meals' a day are provided to bulls in the morning, afternoon and evening

Madurai, Jan 2: Farm fresh grass rolls, a big bucket full of rice bran and husk of black and red gram with plenty of water! These are among the 'delicacies' that figure in the 'special diet plan' for bulls that are being trained for the bull taming sport, 'Jallikattu.'

A big pack of hay and fodder made of cotton seed and corn are part. of the other items of food provided to bulls. Such food items, neatly divided into 'three square meals' a day are provided to bulls in the

morning, afternoon and evening. Sundaravalli, a cowherd with hands-on experience in cattle farming says the diet plan is designed



to ensure nutritious food to bulls. 'We provide nutritious food at all times. However, now we go the extra mile to ensure nutrition as

Jallikattu is nearing and bulls need to be physically more strong.' "The first full meal is at 9.30 AM when we provide a full, big bucket of rice bran and a roll of hay," she says.

Also, farm fresh grass and plenty of water is ensured at all times. The next meal, by 3 PM comprises 'Makkacholam' (corn), 'Paruthi Vidhai' (cotton seed cake), 'Nel Thavidu' (rice bran) and 'Ulundu-Thuvaram doosi' (husk of black and red gram). Bran obtained from 'Pachha nellu' (raw rice bran) and Puzhunga nellu (boil rice bran) is alternately used. Corn and cotton seed cake are among the fresh additions to the diet

plan considering Jallikattu. The next food in the evening is light and it is a good combo of what was provided in the morning and afternoon, she says. "We also provide Thavidu Thanneer (bran mixed water) on and off. The workout for bulls, which includes taking them for pretty long walks, running and swimming make them super fit and it ensures good appetite."

As she prepares 'bran meal,' a pair of 'Uzhavu madu' (bulls used only for farming purposes) rushes ahead to partake of the food. Jallikattu bulls 'Rana,' 'Rudra' 'Aacha' and others enjoy the sumptuous meal!

Sundaravalli's husband Marimuthu, a herdsman, promptly arrives to help her feed the cattle. After feeding them, the duo double up as 'physicians' and gently touch the ears of bulls.

"We try to ascertain if the warmth is normal or not. In case there is a fever, we could feel the extra-warmth.

After noticing that a bull had comparatively less feed, they quickly prepare a fine mix of 'Vetrilai' (piper betel) and 'Milagu' (black pepper-Piper nigrum) and push it into the animal's mouth.

"If such simple home remedies do not yield results we take the advice of doctors.' Quoting veterinarians, she says

the food they provide to bulls has

all the nutrients including pro-

teins that animals need.

Traditionally, Jallikattu commences in the Tamil month of Thai (starts in January and ends in February) and goes on for at least 3-4 months. It is held in various parts of the state. The star attractions are, however, those held in Alanganallur, Palamedu and

Avaniapuram in Madurai district. December 8, 2022, the Supreme Court reserved its order on petitions against the bull taming sport. The top court had said that Jallikattu cannot be termed a blood sport as nobody is using any weapon and the blood may only be an incidental thing.

MHA seeks report from Delhi police

New Delhi, Jan 2: The 20-yearold woman, killed in the early hours of New Year after her scooter was hit by a car, was dragged for 12 kilometres under the vehicle on the city's roads, police said and added culpable homicide among other stringent sections on Monday in the case following protests over alleged "shoddy investigation".

Police said that the victim's body was found naked on roadside in Kanjhawala area in outer Delhi and a medical board conducted a post-mortem on Monday, which will establish if she was sexually assaulted by the accused.

As outrage mounted over the incident, officials said that the Union Home Ministry has sought a detailed report from the Delhi police on the direction of Home Minister Amit Shah. The Delhi police has also constituted an inquiry committee, headed by Special Commissioner Shalini Singh, and asked her to submit a probe report as early as possible, they said.

All five accused were sent to three-day police custody Monday. Prima facie, it is suspected that the accused were allegedly intoxicated at the time of the incident. Sources said that blood samples have been sent for medical examination to ascertain if the accused were under the influence of alcohol. The report is awaited.

New high-quality security camera footage confirmed horrific witness accounts that she had been dragged under the wheels for over an hour. A senior police said that the woman was dragged for around 12 kilometres following the accident. The victim, who was the sole bread earner of her family, leaves behind

an ailing mother and six siblings.

The mother alleged that police were trying to "make it look like an accident" as she expressed dissatisfaction with their handling of the case. Chief Minister Arvind Kejriwal termed it a "rarest of rare crime" and demanded the strictest punishment for those behind the incident, while L-G V K Saxena said his head hung in shame over the "inhuman" crime. The victim's family demanded the death penalty for the accused.

Addressing a press conference here, Special Commissioner of Police (Law and Order) Sagar Preet Hooda said fresh charges could be added against the five accused arrested in connection with the case on the basis of the post-mortem report. The accused have been booked on charges of culpable homicide (Section 304) not amounting to murder, causing death by negligence and criminal conspiracy, according to the police.

According to Section 304 of IPC. whoever commits culpable homicide

not amounting to murder shall be punished with imprisonment for life or imprisonment of either description for a term which may extend to ten years."The accused will be taken to the scene of the crime and their story will be verified. The timeline of events will be established on the basis of CCTV footage and digital evidence." Hooda said.

He said the victim's family is being updated about the investigation and assured that the police will gather all evidence to ensure that the accused get the strictest punishment.

A political slugfest erupted over the incident, with the Aam Aadmi Party attacking the BJP alleging that one of the accused - Manoj Mittal - is linked to it. It also accused the lieutenant governor of being "negligent" in the matter.

Delhi BJP leaders said the accused should be given the strictest punishment if found guilty and claimed that its rivals were indulging in politics over a sensitive issue.

26 INJURED AS TRAIN DERAILS

Jaipur, Jan 2: Twenty-six passengers were injured after 13 coaches of a Jodhpur-bound express train derailed in Rajasthan's Pali district early Monday, an official said.

No loss of life has been reported, a spokesperson of the North Western Railway (NWR) said and added that several trains have either been cancelled or diverted due to the derailment of the Bandra Terminus-Jodhpur Suryanagri Express (12480) on the Rajkiyawas-Bamodara route at 3.27 am.

The injured, two of them seriously hurt, have been admitted at the Bangad Hospital in Pali, the official said. The railways is operating helpline numbers and Railway Minister Ashwini Vaishnaw is monitoring the situation, the spokesperson said. Vaishnaw will visit the spot in the evening, the official added.

MOTHER ARRESTED FOR KILLING BABY

Ahmedabad, Jan 2: Police in Ahmedabad have arrested a woman who killed her three-month-old baby girl by throwing the infant from the third floor of a hospital.

According to the complaint lodged by Asifmiya Shaikh, his wife Farzanabanu gave birth on October 5, 2022, at a hospital in Uttarsanda of Anand district. On Sunday morning, Farzanbanu informed her husband that the baby had gone missing.

Shaikh along with staff of the hospital searched for the baby and even informed the police. While checking the CCTV footage of the hospital corridors, at around 4 a.m.

Farzanabanu can be seen coming out of the ward with the baby in his arms, she stands near a pillar for a while, later she returns to the ward empty handed, Asifmiya said in the complaint. During police interrogation, the accused said that she was fed up of the infant's illness and pain which led her to take the drastic step.

TN student dies in China

Chennai, Jan 2: A 22-year-old student pursuing medical education at Qiqihar Medical University, China died due to a brief illness Sunday.

The family of deceased S. Sheikh Abdulla has petitioned Chief Minister, M.K. Stalin to help bring the body back to his native Pudukottai for the last rites. According to the family members, Sheikh Abdulla had been pursuing medicine in China since 2017 and during Covid-19 he came back to India and continued his edu-

cation online. The university later granted him an opportunity to do internship at the university after his course was completed. The university also directed him to reach the university in person and to continue the internship.

Abdulla left on December 11 and was quarantined following the advent of the new Covid-19 variant. Later, the family was informed that the 22-year-old had fallen ill and was admitted to the hospital attached to the medical university.

The family had also to shell out huge money for his treatment in China but on Sunday, the hospital authorities informed Sheikh Abdulla's father, Syed that his son had passed away due to illness and that his liver and kidney were damaged.

The family has appealed to the Chief Minister and state (health minister for suitable compensation.

Celebrate endings- for they precede new beginnings

elebrate endings- for they precede new beginnings goes a saying. And as the old year yields place to the new, hopes surface that India's lawmakers will spare time to pause and ponder at the plummeting levels of public discourse and the crass contradictions that mark their conduct.

The contradictions are most noticeable in the matter of the spurious liquor tragedy in Saran district of Bihar in December where over 80 people lost their lives. Both Houses of the Bihar legislature were adjourned indefinitely ahead of schedule following the BJP opposition's backlash over the hooch deaths and the demand for a review of the prohibition policy in the state.

Taking suo moto cognizance, the National Human Rights Commission issued notice to the Bihar government. The NHRC also underlined the failure of the State government to implement its policy of prohibition of sale and consumption of illicit liquor in Bihar since 2016. Soon after a 9-member NHRC team landed up to take stock of the situation inviting strong objections from the state government which called it wholly unjustified and beyond the aims and objectives of the Commission

However when a similar liquor tragedy took place in BJP ruled Gujarat, Uttar Pradesh and Haryana the party's approach was wholly different. Like-minded Opposition parties in a statement issued in Delhi charged the Modi government with double standards pointing out that there had been over 200 hooch deaths during 2016 and 2021 when the JD-U-BJP government had been in power in Bihar but the NHRC never felt the need to investigate such incidents. In Uttar Pradesh 36 people had died after consuming spurious liquor in Aligarh in May 2021 and 40 in Haryana's Panipat and Sonepat districts after consuming adulterated liquor in November 2020,14 people in the Ujjain hooch tragedy in October



2020 and 24 people in similar fatalities in Morena district, Madhya Pradesh in January 2021

There has been liquor Prohibition in Gujarat since the inception of the state in 1960 and its consumption or possession is an offence. Nevertheless the state has witnessed numerous spurious liquor deaths over the years.

Earlier in July, 2009, over a 150 people fell to the killer brew in Ahmedabad while the Vidhan Sabha was in session. Moving fast into damage control mode, Chief Minister Narendra Modi, announced a further tightening of prohibition laws

and amended the Bombay Prohibition Act to provide for death sentences for those found guilty of manufacturing and selling spurious liquor called "lattha" (hooch) in 2009. The Bill received the Governor's assent in December 2011 but to date there has not been a single case where the culprit has received the death penalty though liquor tragedies have been taking place even thereafter.

The Narendra Modi government had also set up a one-man judicial inquiry commission headed by Justice K.M. Mehta to probe the tragedy. Justice Mehta was surprised when he learnt that the state government did not have regulations for transportation of methyl alcohol, which was the root cause of the tragedy. He had termed it as a ridiculous situation.

Justice Mehta noted that methyl alcohol had been responsible for all the spurious liquor tragedies that have taken place in Gujarat over the years and yet even after the 2009 Ahmedabad liquor deaths

no rules had been framed by the time the matter came up before him. Successive inquiry commissions set up

after every major liquor tragedy have drawn attention to this anomaly and yet it remained unattended. Following the 1989 hooch tragedy in Vadodara in 1989 in which 132 people died and 200 were affected, the Justice A.A. Dave inquiry commission set up to probe it, had strongly recommended that either the government should abolish prohibition or make suitable and stringent changes in the policy to tighten it.

Justice(retd) N.M. Miabhoy inquiry commission which probed the 1977 Ahmedabad hooch tragedy in which 100 people lost their lives and over 200 were badly affected had observed that the prohibition policy in Gujarat was a failure and that sweeping changes were necessary for its effective implementation. One of the main reasons he attributed for its failure was the rampant corruption in the police force. Nothing has changed even now.



Massive anger in Russia as scores of troops killed

Kyiv, Ukraine, Jan 2: Russia acknowledged Monday that scores of its troops were killed in one of the Ukraine war's deadliest strikes, drawing demands from nationalist bloggers for commanders to be punished for housing soldiers alongside an ammunition dump.

Ukrainian forces fired six rockets from a HIMARS launch system and two of them were shot down, a Russian defence ministry statement.

Damascus airport out of service

Beirut, Jan 2: Israel's military fired missiles toward the international airport of Syria's capital early Monday, putting it out of service and killing two soldiers and wounding two others, the Syrian army said. The attack, which occurred

shortly after midnight Sunday, was the second in seven months to put the Damascus International Airport out of service. It caused material damage in a nearby area, the army said, without giving further details.

Syria's Ministry of Transport said work to repair the damage began immediately and later Monday, some flights resumed while work in other parts of the airport continued

Israel has targeted airports and ports in government-held parts of Syria in an apparent attempt to prevent arms shipments from Iran to militant groups backed by Tehran, including Lebanon's Hezbollah. An opposition war monitor reported the Israeli strikes hit the airport as well as an arms depot close to the facility south of Damascus.

The Britain-based Syrian Observatory for Human Rights said four people were killed in the strike. The conflicting reports could not immediately be reconciled. The Observatory said the runway used for civilian flights was fixed while another, used for cargo trans-

port, remains out of service. That runway is also used by Iran-backed backed groups, the

No reason for the change was given. Pyongyang regularly revamps its leadership and the yearend party gathering has often been used to announce personnel reshuffles and major policy decisions.

State television showed Pak sit $ting\ in\ the\ front\ row\ of\ the\ podium$ with his head down during the meeting while other members

raised their hands to vote on personnel issues. His seat was later shown unoccupied. He was also absent in photos re-

In late 2020, Pak was promoted to the politburo and earned the title of marshal, the highest military rank under Kim, and became a leading voice last November against joint South Korea-US military exercises.

Lula sworn in as Brazil President

Brasilia: Luiz Inacio Lula da Silva has been sworn in as the new President of Brazil -- a hird time he has held the country's highest office. The inauguration of Lula da Silva and his Vice President Geraldo Alckmin took place at 3 p.m. pm Sunday during a plenary session of the Chamber of Deputies in Brasilia, reports Xinhua news agency. This is Lula da Silva's third presidential term and his return to power comes after having spent more than a year in prison



between 2018 and 2019, due to a controversial sentence that was later annulled by the Supreme Court. In October, he was elected president with 60.3 million votes, or 50.9 per cent of the vote, while then President Jair Bolsonaro obtained 58.2 million votes or 49.1 per cent. Lula da Silva returns to the presidency with an agenda focused on strong social programs aimed at fighting poverty, under the motto "union and reconstruction".

Parts of China return to regular activity amid Covid wave

Beijing, Jan 2: Some people in the Chinese cities of Beijing, Shanghai and Wuhan braved the cold and a rise in Covid-19 infections to return to regular activity Monday, raising the prospect of a boost to the economy as more recover from infections.

Among those who gathered to sled or ice skate on a frozen lake in the capital's Shichahai Lake Park, some were upbeat about the opening-up after China dropped stringent "zero-Covid" measures on December 7 to adopt a strategy of living with the virus.

Monday was a public holiday but traffic in the capital has built up again in the last few days as

people flock to outdoor sites, although business is still slow in some smaller, confined locations, such as restaurants. The owner of a Beijing seafood restaurant said patrons had not returned to full strength. In the central city of Wuhan, where the pandemic began three years ago, people were not as anxious any more.

During the New Year's holiday period, 52.7 million domestic tourist trips were made, an increase of 0.44% over the same period a year earlier and up 42.8% over the corresponding period in 2019, according to government data posted Monday.

Petrol export by **OMCs rose 142%**

New Delhi: Export of petrol by Indian oil marketing companies (OMCs) rose 142 per cent in a year between 2020-21 and 2021-22, while there was a miniscule rise of less than 1 per cent in export of diesel during the same period. According to official figures, the OMCs exported 668 thousand metric tonnes (TMT) of petrol in 2021-22, which was 142 per cent more than 276 TMT of petrol exported by the country in 2020-21. In 2020-21, the OMCs exported 1,985 TMT of diesel, while in 2021-22, it exported 1,994 TMT of diesel, a growth of less than 1 per cent over the previous year. The three OMCs, namely the Indian Oil Corporation, Hindustan Petroleum, and Bharat Petroleum Corporation, export petrol and diesel to several

Indian Bank hikes lending rates

New Delhi: State-owned Indian Bank Monday increased lending rates, including the marginal cost of funds-based lending rates (MCLR), by up to 25 basis points. The new rates are effective from January 3, Indian Bank said in a regulatory filing. The Asset Liability Management Committee (ALCO) of the bank has reviewed the Marginal Cost of funds based Lending Rate (MCLR), Treasury Bills Linked Lending Rates (TBLR). Base Rate and Benchmark Prime Lending Rate (BPLR) and decided for an upward revision in MCLR, TBLR, Base Rate and RPI R across various tenors, it noted. The one-year rate is used to fix most consumer loans, such as auto. personal and home loans. The overnight MCLR rate has been revised upward by 25 basis points to 7.75 per cent, while that of one month to six months tenure hiked by 20 basis points, the bank said.

Swiggy's losses jump 2X in FY22

New Delhi: Online food delivery platform Swiggy's losses doubled to ₹3,629 crore in FY22 compared to ₹1,617 crore in the last fiscal year. Total expenses went up 131 per cent to ₹9,574.5 crore in FY22. According to its annual financial statement with the Registrar of Companies (RoC). during the last quarter of FY22, Swiggy turned "decacorn" (with a valuation of \$10 billion and above) after raising a \$700 million round led by Invesco. Meanwhile, Swiggy's revenue grew 2.2 times to ₹5,705 crore during FY22 as opposed to ₹2,547 crore in FY21.



BANKING SBI, ICICI, HDFC remain 'too big to fail'

Mumbai, Jan 2: The RBI Monday said state-owned SBI, along with private sector lenders ICICI Bank and HDFC Bank continue to be Domestic Systemically Important Banks (D-SIBs) or institutions which are 'too big to fail'

SIBs are perceived as banks that are 'too big to fail (TBTF)'. This perception of TBTF creates an expectation of government support for these lenders in times of distress. Due to this, these banks enjoy certain advantages in the funding markets.

"SBI, ICICI Bank and HDFC Bank continue to be identified as Domestic Systemically Important Banks (D-SIBs), under the same bucketing structure as in the 2021 list of D-SIBs," the Reserve Bank said in a statement.

The additional Common Equity Tier 1 (CET1) requirement for D-SIBs was phased-in from April 1, 2016 and became fully effective from April 1, 2019. The additional CET1 requirement will be in addition to the capital conservation buffer.

Govt drafts rules for 13-month uptick online gaming firms

New Delhi, Jan 2: Online gaming companies will not be allowed to engage in betting on the outcome of games under the principle laid in draft rules, Minister of State for Electronics and IT Rajeev Chandrasekhar said Monday.

The minister said that as of now, all permissible online gaming will need to be registered with a self-regulatory organisation that will be accountable to the online gaming rules.

"As per the principles laid under the rule, wagering on the outcome of game will not be allowed. All online gaming companies will have to register with the self-regulatory body that will decide on the action required to be taken as per the rules," Chandrasekhar said.

The Ministry of Electronics and IT has published draft rules for online gaming companies and has invited comments on the same by January 17.

The government has proposed a self-regulatory mechanism, mandatory verification of players and physical Indian address for online gaming companies, according to the draft online gaming rules.

Online gaming companies will be covered under the new IT rules that were issued in 2021 for social media platforms. Online gaming platforms are expected to comply

with the laws of the land, including any such law that relates to gambling or betting.

"If you bet on an outcome of the game, it is prohibited. The self-regulatory organisations will develop filters and tests required to decide permissible gaming, be it a game of chance or game of skills or anything else," Chandrasekhar said.

The draft rules prescribe additional due diligence for companies by displaying a registration mark on all online games registered by a self-regulatory organisation (SRO) and informing its users regarding its policy related to withdrawal or refund of the deposit, manner of determination and distribution of winnings, fees and other charges payable and KYC procedure for

user account registration. On the verification requirement of children, the minister said the finer details will evolve after the consultation is over.

Chandrasekhar also said that he has learnt that 40-45 per cent of gamers are women and the feedback that the government has received shows that there is a considerable amount of work that needs to be done to make online gaming safe for women

In response to a question on the impact of rules on the laws passed by some states, the minister said that the centre wants online gaming to grow without any contradiction to local or state laws.

"We want the year 2023 (to be) a vear where online gaming rapidly explodes and expands with investments and new platforms develop," Chandrasekhar said.

He said as per the draft rules, even casual gaming entities need to register with SROs but the final call will be taken based on the feedback during the consultation process. "We hope that by early February we will have final rules."

Economy poised for further growth in '23'

The challenges before the govt and RBI in the new year would be to arrest inflation, check declining value of rupee against US dollar and promote private investment and growth, with a view to ensure that the country remains one the fastest growing major economies of the world

New Delhi, Jan 2: The Indian economy recovered from the Covid-induced downturn during 2022 and is poised for further improvement in the coming quarters though downside risks emanating from geopolitical tensions, strengthening dollar and elevated inflation will continue.

The positive trajectory in the growth trend and improved fundamentals will help the nation in neutralising the impact of global headwinds which are expected to have a bearing on the country's exports in the months to come.

"From the viewpoint of India, in terms of headwinds originating abroad, the worst is probably behind us ... Overall, I still expect us to end the current fiscal year with a growth rate exceeding 7 per cent. Next year, the 7 per cent growth rate should sustain assuming the forthcoming Budget does not have any negative surprises," opined former vice-chairman of the Niti Aayog and noted economist Arvind Panagariya.

The biggest problem the economy faced was persistent high inflation which remained above the Reserve Bank's comfort level for the most of the year. Infact, the



RBI had to file a report to the central government on why it failed to check inflation.

The depreciating rupee against the US dollar too remained a challenge for policy makers making imports costlier and in turn impacting the country's current account deficit. The rupee, according to analysts, will continue to remain under pressure in the coming months.

Exports too faced global headwinds and the things may not be rosy either in 2023, because of recession in key western markets and geo-political crisis due to the Russia-Ukraine war.

Later months of 2022 witnessed

lots of job cuts in the technology segment amid global economic turmoil, though a mixed bag of opportunities is likely to greet job aspirants in the New Year as telecom and services-oriented sectors are anticipated to accelerate hiring.

The Reserve Bank front-loaded interest rate hikes to check inflation as well as rupee depreciation triggered by repeated hike in interest rate by the US Federal Reserve, thus making loans dearer.

'MISSION 2024' KICKS OFF

Mumbai, Jan 2: Hardik Pandya will be expected to begin his fulltime T20 captaincy tenure on a bold note as the Indian T20 team prepares to start its life beyond Virat Kohli, Rohit Sharma and KL Rahul with the three match series against Sri Lanka, beginning here Tuesday.

The followers of Indian cricket got more than glimpse of Hardik's vision for the team when led the team to victory in the rain-hit T20 series in New Zealand.

In an ODI World Cup year, the shortest format is not priority for the Indian team but the series will allow Hardik to start planning for the future, specifically the 2024 T20 World Cup. India's famed top three - Rohit,

Kohli and Rahul – are not part of the squad and irrespective of their T20 future, the team must prepare for life without them. The problem with the current

Indian T20 team in recent past, has been distinct lack of intent and ability to play fearless cricket. The idea of self preservation at

the cost of impactful performance was hurting the team for a long time and perhaps the poor show in the T20 World Cup became the last straw.

The combination

Rishabh Pant, who suffered a horrific car crash last week, opened for the team in New Zealand alongside Ishan Kishan. Pant was anyway not picked for the Sri Lanka series, making Kishan and Ruturai Gaikwad opening combination most likely for the first T20 at the high-scoring Wankhede Stadium.

Both Kishan and Gaikwad have been bonafide IPL stars for a past few years and this is their real chance to show their wares without worrying about their place in the side.

With next T20 World Cup at least 18 months away, the duo is expected to get a fair run although the number of T20Is this year is less than 15 with ODI gaining more precedence. Shubman Gill, who is yet to make his T20 debut, is another opening option for Hardik.

At number three, the skipper will rely on the brilliance of world's No.1 batter Suryakumar Yadav. With Hardik keen to have six bowling options in the playing eleven,

Deepak Hooda could be a likely

starter for Tuesday's game. The management will have to choose between Sanju Samson and uncapped Rahul Tripathi for the one spot in the middle order. Tripathi has been warming the bench for a while now and it could continue against Sri Lanka but Samson on account of experience should get

Though uncapped Shivam Mavi and Mukesh Kumar have been included in the squad, the likely pace bowling trio will be of Arshdeep Singh, Harshal Patel and Umran

India could also pack in more allrounders in the team with the option of Washington Sundar and Axar Patel. Specialist spinner Yuzvendra Chahal is expected to

VVS Laxman in line for India's head coach job

New Delhi, Jan 2: The Board of Control for Cricket in India (BCCI) may consider making VVS Laxman the next head coach of the Indian men's team after the end of Rahul Dravid's contract, which currently runs till the 2023 ODI World Cup.

A report by News18 Cricketnext has said it is reliably learnt that should Dravid not consider an extension as men's team head coach, then Laxman, who is currently the Head of Cricket at the National Cricket Academy (NCA) in Bangalore, could be the person to take the top job.

Laxman, 48, has filled in as the head coach of the Indian team in Dravid's absence. He was with the team for the bilateral series against Ireland in June 2022, as well as for the first T20I against England and the short tour of Zimbabwe.

He was also with the Indian team for the 2022 edition of the T20 Asia Cup in the UAE when Dravid was $\,$ down with Covid-19 and has also travelled to New Zealand as the head coach of the team for their white-ball tour immediately after the T20 World Cup ended in November 2022.

Apart from grooming the next generation of players at the NCA, Laxman had travelled with the India U-19 team for their successful 2022 World Cup too and played a very proactive role with the young bunch during their campaign in the West Indies.

The report also said that for now, split coaching will not be happening. "Has that happened in Indian cricket before?" a senior BCCI official was quoted as saying in the



report when asked about the possibility of split coaching coming into the set-up.

Ever since he took over from Ravi Shastri as the head coach in November 2021, Dravid has had an indifferent run at the helm of the Indian team.

They lost to England in the semifinals of the T20 World Cup and didn't reach the final of the 2022 T20 Asia Cup apart from losing the Test and ODI series in South Africa and rescheduling the fifth Test to England at Birmingham.

PANT SHIFTED FROM ICU TO PRIVATE WARD

Dehradun, Jan 2: Cricketer Rishabh Pant has been shifted from the ICU to the private ward of the Max Hospital here following improvement in his condition. He was shifted to the private ward Sunday evening as his condition improved but the pain in his leg persists, sources said. No MRI is planned vet, they added.

Pant was admitted to the intensive care unit (ICU) of the hospital hours after the wicketkeeper-batsman suffered multiple injuries in a car accident on the Delhi-Dehradun highway, near Roorkee, in the early hours of Friday.

Uttarakhand Chief Minister Pushkar Singh Dhami, who met Pant at the hospital Sunday had said quoting the cricketer that he had lost control over his car while trying to avoid a pothole and something black on the road.



Delhi and District Cricket Association (DDCA) director Shyam Sharma, who met the cricketer on Saturday, had also told reporters that the accident took place when Pant was trying to negotiate a pothole.

The accident took place at around 5.30 am Friday, when Pant's luxury car hit a road divider, rolled over to the other side of the road and caught fire. Pant had a miraculous escape but he sustained injuries on his forehead, leg and bruises on his back

Hire drivers: Kapil's suggestion to players

NEW DELHI: The legendary Kapil Dev believes any cricketer representing the country like Rishabh Pant should be "more careful" and hire drivers instead of getting behind the wheels to avoid the mishap that happened last week. Kapil made the statement while reacting to Pant's horrifying accident Friday while driving his Mercedes on NH-58. "We can avoid things that can lead to mishaps like these," Kapil was quoted as saying by ABP News. "Especially for these special players. I remember during my early playing days, I was riding a bike and met with an accident following which my brother never let me ride one. The players should be careful. They don't need to drive themselves. They can afford drivers. I know a lot of people are passionate about driving but when one has so many responsibilities, one must take care of oneself," the 63-year-old stated.

Pele funeral: Fans line up to mourn Brazilian legend

The Brazilian football great died Thursday after a battle with cancer. He was 82. Pele scored scored some of the best goals of his career at the 16,000-seat stadium outside Sao Paulo. His funeral is scheduled start at 10 am local time, and the burial will take place in a vertical cemetery only 600 meters away Tuesday.

Fans started arriving at the stadium in the early hours of Monday to pay their last respects to Edson Arantes do Nascimento, globally known as Pele. One of them was Brazilian Supreme Court Justice Gilmar Mendes. Mendes said Pele was a humble man despite his global fame, and that he deserves every tribute.

Inside the Vila Belmiro, a large tent has been set to place Pele's coffin. After Pele's funeral, his casket will be ushered through the streets of Santos before his burial. Brazil President Luiz Inácio Lula da Silva and other dignitaries are expected to attend.

Pele had undergone treatment for colon cancer since 2021. The medical center where he had been hospitalised said he died of multiple organ failure as a result of

Pakistan bounce back after Conway ton

Karachi, Jan 2: New Zealand slipped against Pakistan all-rounder Agha Salman's offspin in the final session after Devon Conway hit his fourth Test hundred on the opening day of the second Test New Zealand were cruising along

at 234/1 on the back of Conway's 122 (191b, 16x4, 1x6) before Salman picked up 3/55 and the Black Caps finished the day at 309/6. Tom Blundell was not out on 30 while Ish Sodhi, who made a career-best 65 in the drawn first Test, was unbeaten on 11. Conway put on two solid cen-

tury stands with Tom Latham (71, 100b, 9x4) and Kane Williamson (36, 91b, 5x4) in a dominating first two sessions for the Black Caps after Tim Southee won the toss and elected to bat before losing five wickets for 45 runs after tea.

Salman pegged back New Zealand with the old ball on a wicket that had some grass and tempted Pakistan to go with three



fast bowlers - Mir Hamza, recalled Hasan Ali and fit-again Naseem Shah — and just one spe-

cialist spinner Abrar Ahmed. Salman ignited the collapse when he found the outside edge of Conway's bat that ended his 100-run stand with Williamson.

The off-spinner, who bowled 12over spell after tea, hit back the off stump of Daryl Mitchell (3) with his turning delivery before successfully overturning a caught behind decision through TV referral against Henry Nicholls (26).

Earlier, Conway and Latham contributed a second successive century opening stand in the twomatch series before Naseem Shah (2/44) brought the lone success in the first two sessions when he had Latham trapped leg before wicket of a full delivery after lunch but New Zealand added further 107 runs in the post-lunch session.

Both lefthanders Conway and Latham dominated the pace and spin in the first session to produce 119 runs and even showed aggression against Abrar's mystery spin after captain Babar Azam turned to his ace spinner as early as in the ninth over.

Hasan Ali, playing his first Test since July, twice found the edges of Conway's bat in successive overs after lunch only to see the ball fall short of Abdullah Shafique in the slips and then Saud Shakeel couldn't hold onto a sharp chance in gully while diving full length to his right when the lefthander was 11 shy of his hundred.

Latham and Conway completed their half centuries before lunch and provided New Zealand a solid start. Both batters motored New Zealand to 63 inside the first hour and batted aggressively against fast bowlers Naseem and Hasan.

Conway raised New Zealand's half century with a six against the mystery spinner Ahmed over wide mid-on as Pakistan struggled to get through the defenses.

New Zealand, on their first Test tour to Pakistan since 2002, had made a strong bid to chase down 138 in the last hour of the first Test of the two-match series last Friday after Pakistan captain Babar Azam made a daring declaration. Poor visibility halted the Black Caps at 61/1 in the eighth over to draw the game.

Mumbai City FC thrash Odisha, regain top spot
