#### **Odisha wins UN award** for 'Jaga Mission'

Bhubaneswar: Adding yet another feather in its cap, the Odisha government Wednesday won the UN-Habitat's 'World Habitat Award-2023' for its 5T initiative 'Jaga Mission'. The innovative programme which aims at upgrading almost 3,000 slums in the state, has won the prestigious 'Bronze World Habitat Award', officials stated. 'Jaga Mission' is the world's largest land titling and slum upgrading programme which aims at empowering the lives of slum dwellers. Under the leadership of Chief Minister Naveen Patnaik, the Odisha government has set for itself the ambitious target of becoming the first slum-free state in India and is leading the Jaga Mission' programme to upgrade all the 2,919 bustees, they added.

#### **CM to unveil Rourkela** hockey stadium today

Rourkela: Chief Minister Naveen Patnaik will be inaugurating here Thursday the Birsa Munda hockey stadium, which is the biggest hockey arena in India. The stadium has been built at an expenditure of ₹146.5 crore and will host matches of the FIH Men's Hockey World Cup beginning January 13. The stadium will host a total of 20 games while the other matches will be played at the Kalinga Stadium hockey complex in Bhubaneswar. The Indian team have already started training at the Birsa Munda Stadium where they will play two of their pool games against Spain and England. The stadium can accommodate 20,000 people, officials said here Wednesday.

#### **Medical teachers on** contract get salary hike


Bhubaneswar: The Odisha government has hiked the consolidated remuneration of contractual teachers of government medical college and hospitals in the state. As per a notification issued Wednesday by the Health and Family Welfare Department, contractual professors of government medical college and hospitals will get ₹2,30,000 as revised remuneration with five per cent hike per annum against the existing remuneration of ₹1,25,000 with three per cent hike per annum. Similarly associate professors will receive ₹2,00,000 as revised remuneration with five per cent hike per annum.

# 5G SERVICES IN STATE FROM TODAY

Bhubaneswar, Jan 4: Union IT Minister Ashwini Vaishnaw will roll out the much-awaited 5G telecom network services in Odisha during a programme here Thursday. Union Minister Dharmendra Pradhan will also be present on the occasion.

Sources informed Wednesday that, 510 base transceiver station (BTS) towers have already been installed across Odisha by telecom operators Jio and Airtel. Initially the service will be available in Bhubaneswar, Cuttack and a few other places in the state.

The programme in Bhubaneswar will also include the announcement of Universal Service Obligation Fund (USOF) aided projects including spectrum enablement for Research and Development (R&D), Ministry of Electronics and Information Technology (MeitY), and Software Technology Parks of India (STPI).

Vaishnaw will also dedicate 100 4G telecom towers in rural areas of Odisha Thursday. The event will be on digital communications by technology companies and start-ups.

Earlier, the IT Minister had stated that Modi government has allocated ₹5,600 crore for development of the telecom sector in the state

PM Modi had October 1 launched the 5G services that promise to provide ultra high-speed internet on mobile phones. In Odisha, President Droupadi Murmu's village Pahadpur under Kusumi block in Mayurbhanj district has also experienced the new generation telecom network.

The state Cabinet led by Chief Minister Naveen Patnaik had approved a proposal to provide 2,000 square feet of land each at 1,687 places to BSNL for 30 years at Re 1 per site per annum without any premium and incidental fees.

The first phase of 5G services was rolled out in October last year across 13 cities in India by Prime Minister Narendra Modi. Among the cities where 5G services have already been launched are Ahmedabad, Bangalore, Chennai, Delhi, Gurgaon, Mumbai, Pune and a few others.

# **Gujarat Bill to criminalise protests**

The bill will come in handy for governments as it can now register criminal cases against persons who stage protests in violation of Section 144

New Delhi, Jan 4: The Gujarat Bill facilitating registration of criminal cases against persons who stage protests in violation of Section 144 of the Code of Criminal Procedure (CrPC) has received Presidential assent, officials said here Wednesday. In name it may just sound as the 'Gujarat Bill' but the assent will clear the passage for the law to be used by other states also if they feel it necessary. To put it succinctly police may use the bill to terrorise even peaceful protestors by criminalising their act.

The Code of Criminal



Procedure (Gujarat Amendment) Bill, 2021, was passed by the state Assembly in March last year. It should also be stated here that a month before Guiarat went to polls this year, the Centre cleared the state legislation that 'empowers police officers to register cases - without informing the local court in writing – against persons who protest and agitate violating Section 144 of the Code of Criminal Procedure (CrPC)'.

The bill amends Section 195 of the CrPC which states that no court shall take cognisance of any criminal conspiracy for contempt of the lawful authority of public servants, except on the complaint in writing of the public servant concerned.

A Home Ministry official in-

formed Wednesday that the Code of Criminal Procedure (Gujarat Amendment) Bill, 2021 has been assented to by President Droupadi

Murmu According to the statement and objects of the bill, the 'Gujarat government, police commissioners and district magistrates are empowered to issue prohibitory orders under CrPC Section 144, directing any person to abstain from a certain act or to take certain order to prevent disturbance of public tranquillity or a riot or an affray to maintain public order on various occasions'.

It said the police officers while deployed on such duties come across incidents of violation need to take appropriate legal action against the violators under Section 188 of IPC.

After the bill was passed by the Gujarat Assembly in March 2021, it was sent to the Ministry of Home Affairs (MHA) to examine if it was repugnant with any central law or deviated from the Central government's policy. After the MHA okayed the bill, it got the President's assent.

However, Section 195 of the CrPC, 1973, makes it mandatory for the public servant issuing such orders to be the complainant against the violators thereby creating an impediment to taking cognisance of violations. However, now other states, especially those ruled by the BJP may take the Gujarat path.

#### **Justice Trivedi** opts out of Bilkis case yet again

New Delhi, Jan 4: Supreme Court cused herself Wednesday from hearing a batch of pleas challeng ing the remission of sentence of 11 convicts in the Bilkis Bano case in which she was gangraped and seven members of her family killed during the 2002 Gujarat riots. She did not give any reason.

Earlier Justice Trivedi had recused herself December 13 last year from hearing a writ petition filed by Bilkis in which she challenged the remission of sentences of 11 convicts by the Gujarat government. Like the previous occasion, no reason was assigned for recusal.

A bench of Justices Ajay Rastogi and Trivedi took up the pleas by CPI(M) leader Subhashini Ali, journalist Revati Laul and TMC MP Mahua Moitra against the premature release of the convicts.

Advocate Shobha Gupta, the counsel for Bilkis, pointed out at this juncture that Justice Trivedi has recused herself from hearing the victim's plea. Justice Rastogi, then said, "Since my sister judge has already recused from hearing the victim's plea, she would like to recuse from hearing this matter also."

He added, "We will list all the matters on the next date, possibly in February and tag along all the petitions. All the pleadings should be completed by then.

# Man sues MP govt over loss of 'sexual pleasure'

Ratlam (Madhya Pradesh), Jan 4: After languishing behind bars for close to two years in this town of Madhva Pradesh, a man has been acquitted of gangrape charges. The man now has sued and sought compensation of over ₹10,000 crore from the Madhya Pradesh government citing 'suffering and mental agony' caused to him as his incarceration sent his family to the brink of starvation.

Of the ₹10.006.02 crore compensation the man has sought ₹2 lakh towards the 'loss of God's gift to humans, e.g. sexual pleasure', as per his petition.

Kantu, alias Kantilal Bheel (35), has moved the District and Sessions Court here after a local court dropped the gangrape charges against him, October 20, 2022, his lawyer Vijay Singh Yadav informed Wednesday, He added that the case against the MP government and police will be heard January 10.

The lawyer also explained why such a whopping compensation amount has been asked for: "₹10,000 crore has been sought on the grounds that 'human life is precious'. Two years of my client's life got wasted for no reason in prison," Yadav said. "The remaining ₹6.02 crore is for various reasons, including legal expenses of ₹2 lakh, mental agony and suffering by my client's family," the lawyer added.

In his petition, Bheel said he was the sole breadwinner for his

family when the police arrested him in the gangrape case December 23, 2020. Bheel also said that he supported his ageing mother, wife and their three children. He added that since his arrest, his family had to face the pangs of hunger. Yadav pointed out that his client and his family suffered tremendous mental agony due to the fake charges of gangrape. He added that Bheel's family was on the verge of starvation

# Nasal swab may provide early warning of stealthy viruses

esting for the presence of a single immune system molecule on nasal swabs can help detect hidden viruses not identified in standard tests, says a study published in The Lancet Microbe journal

As seen during Covid-19 pandemic, potentially dangerous new viruses can begin to spread in the population well before the global public health surveillance system can detect them.

'Finding a dangerous new virus is like searching for a needle in a haystack," said Ellen Foxman, an associate professor at Yale University in the US.

'We found a way to significantly reduce the size of the haystack, said Foxman, a senior author of

Public health officials typically look to a few sources for warning signs of emerging disease. They study emerging viruses in animals that may transmit the infection to humans.

However, determining which of the so many new viral variants represent a true danger is difficult. They also look for outbreaks of

unexplained respiratory ailments, which was how SARS-CoV-2, the virus that causes Covid-19, was discovered in China late in 2019.

However, by the time an outbreak of a novel virus occurs, it may be too late to contain its spread.

Nasal swabs are commonly taken from patients with suspected respiratory infections and are tested to detect specific signatures of 10 to 15 known viruses. Most tests come back negative.

However, as Foxman's team observed previously, in a few cases, the swabs of those who tested negative for the "usual suspect" viruses still exhibited signs that antiviral defenses were activated, indicating the presence of a virus.



The telltale sign was a high level of a single antiviral protein made by the cells that line the nasal pas-

The team applied comprehensive genetic sequencing methods to old samples containing the protein, and in one sample, found an unexpected influenza virus called influenza C.

The researchers also used this same strategy of retesting old samples to search for missed cases of Covid-19 during the first two weeks of March 2020. While cases of the virus had surfaced in New York State around that same time, testing was not readily available until weeks later.

ples collected from patients at Yale-New Haven Hospital during that time had tested negative for standard signature viruses. When tested for the immune system biomarker, the vast majority of those samples showed no trace of activity of the antiviral defense system.


However, a few did show the activity of antiviral defence system. Among those, the team found four cases of Covid-19 that had gone undiagnosed at the time

The findings show that testing for an antiviral protein made by the body, even if the tests for known respiratory viruses are negative, can help pinpoint which nasal swabs are more likely to contain unexpected viruses.

Screening for the biomarker can allow researchers to narrow down the search for unexpected pathogens, making it feasible to do surveillance for unexpected viruses using swabs collected during routine patient care, the researchers said.

Samples found to possess the biomarker can be analysed using more complex genetic testing methods to identify unexpected or emerging pathogens circulating in the patient population and jumpstarta response from the health care

# Revenue collection up 5.6% by Q3 end

Bhubaneswar, Jan 4: State government's total revenue collection has registered a growth of 5.6 per cent by the end of December of current financial year 2022-23 over the corresponding period of last financial year.

The total revenue of the state has crossed ₹1 lakh crore to ₹1,01,119 crore by the end of the third quarter of the current fiscal. In spite of negative growth in grants from the central government by about 21 percent, total revenue has increased by 5.6 percent.

This was revealed during allsecretary meeting held under the chairmanship of Chief Secretary Suresh Chandra Mahapatra here Wednesday.

According to official sources, the revenue generation from own tax sources increased by 13.51 percent with a collection of around ₹32,029 crore by the end of December, 2022 against corresponding period of last year's collection of ₹28,216 crore.

Similarly, with a total collection



of ₹63,523 crore, the revenue from state's non-tax sources grew by 1.17 per cent by the end of December 2022 in comparison to the corresponding period of the last year.

Accordingly, the total revenue generation from both the sources by the end of December 2022 has increased around 5.6 percent over the corresponding period of last fiscal.

Keeping in tune with the revenue generation, the budget utilization by the end of December also witnessed a sharp growth of 2.26 per cent over last fiscal year. The budget utilization in agriculture and allied sector, infrastructure spending, social sector has been increased, the sources said.

Reviewing fiscal performances of various departments, the Chief

Secretary directed the departments to avoid parking of funds at the bank account of the implementing agencies so that actual expenditure would be reflected on the common treasury portal.

Mahapatra directed the departments to adopt 5T parameters scrupulously while dealing with financial matters. The submission of Utilization Certificates in a time bound manner should be given priority, he said.

# Are black holes time machines? | Come near, they fall into the valley. | the future. If you want to jump

machines torm natural time machines that allow travel to both the past and the future. But don't expect to be heading back to visit the dinosaurs any time soon. At present, we don't have space-

craft that could get us anywhere near a black hole. But, even leaving that small detail aside, attempting to travel into the past using a black hole might be the last thing you ever do. What are black holes?

A black hole is an extremely massive object that is typically formed when a dying star collapses in on itself.

Like planets and stars, black

Like planets and stars, black holes have gravitational fields around them. A gravitational field is what keeps us stuck to Earth, and what keeps Earth revolving around the Sun. As a rule of thumb, the more massive an object is, the stronger its gravitational field.

Earth's gravitational field makes it extremely difficult to get to space. That's why we build rockets: we have to travel very fast to break out of Earth's gravity.

The gravitational field of a black



hole is so strong that even light can't escape it. That's impressive, since light is the fastest thing known to science!

Incidentally, that's why black holes are black: we can't bounce light off a black hole the way we might bounce a torch light off a tree in the dark.

Stretching space

Albert Einstein's general theory of relativity tells us matter and energy have a curious effect on the universe. Matter and energy bend and stretch space. The more massive an object is, the more space is stretched and bent around it.

A massive object creates a kind of valley in space. When objects

come near, they fall into the valley.
That's why, when you get close enough to any massive object, including a black hole, you fall towards it. It's also why light can't escape a black hole: the sides of the valley are so steep that light isn't

going fast enough to climb out.

The valley created by a black hole gets steeper and steeper as you approach it from a distance. The point at which it gets so steep that light can't escape is called the event horizon. Event horizons aren't just interesting for would-be time travellers: they're also interesting for philosophers, because they have implications for how we understand the nature of time.

Stretching time When space is stretched, so is time. A clock that is near a massive object will tick slower than one that

is near a much less massive object.

A clock near a black hole will tick very slowly compared to one on Earth. One year near a black hole could mean 80 years on Earth, as you may have seen illustrated in the movie Interstellar. In this way, black holes can be used to travel to

the future. If you want to jump into the future of Earth, simply fly near a black hole and then re-

turn to Earth.

If you get close enough to the centre of the black hole, your clock will tick slower, but you should still be able to escape so long as you don't cross the event horizon.

ross the event h Loops in time

What about the past? This is where things get truly interesting. A black hole bends time so much that it can wrap back on itself.

Imagine taking a sheet of paper and joining the two ends to form a loop. That's what a black hole seems to do to time. This creates a natural time ma-

This creates a natural time machine. If you could somehow get onto the loop, which physicists call a closed timelike curve, you would find yourself on a trajectory through space that starts in the future and ends in the past.

Inside the loop, you would also find that cause and effect get hard to untangle. Things that are in the past cause things to happen in the future, which in turn cause things to happen in the past!

Cuttack from Chandbali. The driver lost control of the vehicle and collided with the Hyva truck at Chhapolia, following which the bus overturned leaving at least 25 people injured.

Meanwhile, 21 of the critically injured persons were undergoing treatment at Aul Hospital while one was shifted to SCB Medical College and Hospital in Cuttack after his condition deteriorated. The rest of the injured were undergoing treatment at Pattamundai community health centre.

Meanwhile, Aul police registered a case in this connection and launched a probe into the matter.

# **CB mulls dummy** simulation of fall

Rayagada, Jan 4: Speeding up its probe into the mysterious death of two Russian tourists in a hotel here, the state Crime Branch (CB) is planning to re-create the circumstances in which the Russian lawmaker Antov Pavel died. In its plan to recreate the circumstances that led to the death of the Russian lawmaker, the CB has contacted leading experts in Delhi.

The CB sleuths are specifically planning to conduct a dummy simulation exercise of falling from the roof top in similar circumstances to recreate the scene and ascertain the situation leading to his death.

For this, a dummy of same weight and height as that of the deceased shall be created with the help of experts of anatomy department of All India Institute of Medical Sciences (AIIMS) and forensic experts. The objective is to study the fall pattern.

In this regard CB has contacted Dr Rajendra Dangi, former Director, Laboratory (CFSL), CBI and Dr Dogra of AIIMS, Delhi who are the leading experts in dummy fall simulation exercise.

They have been involved in resolving several complicated cases of CBI. They will ascertain the cause, nature and manner of the incident and the injury on Pavel's body and crosscheck with the postmortem report. This is expected to help the inquiring team of CB to come to a definite conclusion.

Meanwhile, the CB team as well as scientific and forensic officers are camping at Ravagada and continuing with their investigation into the death of Pavel and his friend Vladimir Bidenov which entered its sixth day, Wednesday.

Another CB sleuth DSP Tapan Das reached Rayagada Tuesday night and joined the probe. He questioned the Town police IIC about the deaths after his arrival. He reached the Town police station again and verified the details collected earlier and matched them with the details and evidences collected by CB DSP Saroj Kanta Mohanta during the probe.

They are continuing with their interrogation of the staff of Sai International hotel where the incidents took place and examining and receiving the seized exhibits from the district police to be sent to forensic experts for examination.

Notably Russian lawmaker Pavel Antov died December 24 allegedly after a fall from the roof of the hotel in Rayagada where they were staying, two days after Bidenov

### **'Koraput's millets** are of high yield, nutritional value

Koraput, Jan 4: Some indigenous varieties of millets produced by tribals in Koraput district are capable of giving high yield and high nutrition. This was claimed by Dr Debabrata Panda, an assistant professor of Central University of Odisha, Koraput. For the last 10 years, Panda has been carrying out research on the indigenous varieties of millets, their qualities and production.

He told about his research articles detailing 33 varieties of millets, their nutritional values and yielding capacity. The research article was published in the international journal Cereal Research Communication, December 31, 2022.

In his research, he found that farmers would get higher yields of four varieties such as Bhalu, Ladu, Telugu and Bada than the other varieties of millets. Moreover, these millet varieties are highly nutritious and fibrous, containing sulfur and anti-oxidants.

He has examined the genetics of these millets. New varieties of millets can be produced by using the genes of these four varieties. Such varieties of millets are preserved by M.S. Swaminathan Research Foundation (MSSRF)in Jeypore.

He observed that such varieties of high quality, rare millets should be preserved and its cultivation promoted through Millets Mission of the state government. Such millets will help ensure food as well as nutrition security for the tribals and others. Besides, the tribals can boost their economy if they are encouraged to raise such millets on a large-scale, he added.

### **GOBINDA** Audio conversation of CB with Gobinda's daughter goes viral

Bolangir, Jan 4: An audio recording of the conversation between a Crime Branch (CB) official and Lipika Sahu, elder daughter of Mamita Meher murder case prime accused Gobinda Sahu who was found dead on Kantabanji sub-jail premises recently, has gone viral. In the audio, Lipika can be heard asking the official to hand over the letter written to her by her deceased father. The CB official, however, turns down her request in the viral audio.

Notably, Gobinda Sahu was found dead on Kantabanji sub-jail premises December 20. The CB is looking into the matter. As part of the investigation, CB officials had visited Gobinda's residence and Mahaling College. At this time, Lipika had asked for the letter of his father addressed to her, which had been recovered from his pocket. "As the last letter is written to me,

I need to read what is written in it. The letter should be given to me,' Lipika is heard telling a CB official in the recorded conversation.

The CB official outright rejected it, saying it is a matter under investigation, adding that the letter has been sealed and will be sent to the Handwriting Bureau for examining its veracity.

# ICDS efficacy under lens

Mahakalpara, Jan 4: The efficacy of the Integrated Child **Development Services Scheme** (ICDS) has come under scanner in Mahakalpara block of Kendrapara district as 145 children were reportedly found malnourished in various areas of the block.

Crores of rupees are being spent through supplementary nutrition programme (SNP) under ICDS to tackle malnutrition and control infant and maternal mortality rate (IMMR). The programme being executed through Anganwadi centres is aimed at meeting nutritional needs among infants, expectant and lactating mothers

Dry and cooked food is provided to children and pregnant women through Anganwadi centres to ward off nutritional deficiency and foster physical growth. Due to lack of proper nutrition, children become underweight, stunted and vulnerable to various diseases.

However, it was alleged that sattu or mixed flour as prepared by the SHGs is of very poor quality and fails to provide any nutritional value to the children. As a result, many children are affected by malnutrition.

Reports said, there are 31 panchayats under this block. According to official data from the office of the ICDS, 145 children have been affected by malnutrition in 23 panchayats.

As many as 7,628 kids in the age



group of 6 months to 3 years, 7,617 children in the age group of three to six years and 1,296 lactating mothers and 1,594 expectant mothers are now being covered here under the SNP.

It was stated that special sattu prepared from dry milk powder, fat, groundnut, wheat and peas will be given to the 145 malnourished children.

Every child will be given 3 kg of special sattu each month. The sattu has been prepared by Baba Abhiram SHG and has reached the ICDS office, it was learnt.

CDPO Kabita Mallick said that 4 kids in Batighar, 7 in Kharinasi, 13 in Ramnagar, 7 in Baulakani, 3 in Petachhela, 8 in Barakandha, 5 in Mangalpur, 12 in Jambu, 12 in Bardang, 5 in Mahakalpara, 3 in Sattu prepared by the SHGs is of very poor quality and fails to provide any nutrition to the children. As a result, many children are affected by malnutrition

Rajgad, 8 in Bijaynagar, 1 in Balipal, 8 in Badidhi, 5 in Kebi Dandua, 4 in Suniti, 4 in Gogua, 7 in Jaychandrapur, 9 in Badakul, 6 in Patulipank, 15 in Tikarpanka, 4 in Tikhiri and 2 in Ameipal panchavats were found to be malnourished.

Now, social activists and various outfits have sought to know why crores of rupees are being spent towards the scheme in the name of controlling malnutrition.

Subash Swain, a local resident said that sattu prepared for kids and women are sub-standard and, it naturally will not be effective against malnutrition.

Contacted, the Child Development Project Officer (CDPO) said that a team will be formed in each Anganwadi centre to conduct field visits to identify malnourished kids and provide them sattu.

# Tomato farmers in Keonjhar resort to distress sales

**LACK OF MARKETING FACILITIES AND COLD STORAGES HAS HIT** THE FARMERS HARD

Keonjhar, Jan 4: Farmers in Keonjhar district have reaped a very good harvest of tomatoes this season. However, they are resorting to distress sale due to a lack of marketing facilities and cold storages in the district, sources said Wednesday. As a result the farmers are being deprived of fair

prices for their produce. Things have come to such a pass that now farmers are selling a 25 kg crate of tomatoes for only ₹150. The bumper harvest has been possible due to the support of the Horticulture and Agriculture departments.

Currently, they are harvesting around 10,000 metric tonnes of tomatoes, but a major chunk of vegetables remain unsold and get rotten due to their inability to sell them at a fair price. They have been demanding the construction of a cold storage facility in the area to store perishable produce and sell it in lean seasons to do away with the distress sale, but their demands are yet to be addressed. Sources said that tomato culti-

vation is mainly carried out in Tikarpada, Rajabandha, Nuagaon, Raisuan, Mahadeijoda, and Padmapur areas under Sadar block in Keonjhar district.

Apart from that, farmers in Maidankel and Kathabari areas grow tomatoes as a cash crop. Farmers in these areas are now harvesting tomatoes, but they lack a cold storage facility to store them.

Fearing that the vegetable might rot, they are selling it at ₹6 per kg. The traders, equally apprehensive about loss, are not inclined to take all their harvested tomatoes. The farmers had borrowed a lot to buy fertiliser, seeds, and even a motor pump to raise their



crops and expected to pay it back after the harvest

Tomatoes imported from outside the state, such as those from Bihar, Jharkhand, and other districts of state, are transported and sold in the area, while tomatoes produced

locally rot on their farmlands. According to a farmer named Laghu Soren, the local farmers

were also forced to go to the market to sell their produce in order to make up for their losses. It was also observed that many farmers did not harvest their crops leaving them to rot on the farmlands.

A farmer named Biswambar Majhi and others said that they would get a fair price for their produce if the administration could

help them in transporting the produce to the districts where tomato is not cultivated or readily available. They also demanded for proper market linkage facilities with food processing units engaged in manufacturing sauce and juice to help them tide over the crisis.

A retired college reader named Bimbadhar Behera said that students residing in various hostels in the state could get good food to eat if the harvested tomatoes were supplied to the hostels.

When contacted, Jayant Nayak, deputy director for horticulture, said that agriculture production clusters (APC) have been engaged to market the harvests. Earlier, the farmers were taking decisions on their cultivations, but now the APC

is guiding them. As a result, farmers will not be forced to do any distress sale in the coming days, he said. Similarly, steps are being taken for the establishment of food processing units and selling the harvested tomatoes to different hostels in the state, he added.

### The Last Cannibal

ecall the story about the explorer who encounters an aboriginal tribe for the first time. "Are there cannibals among you?" he asks. "No," they reply, "We ate the last one yesterday." To constitute a civilised community by eating the last cannibal, the final act must be called something else. It is a kind of original sin that must be erased from memory.

Similarly, the transition to a modern legal order in the American "Wild West" was accomplished through brutal crimes and the creation of myths to cover them up. As a character in the John Ford western The Man Who Shot Liberty Valance put it, "When the legend becomes fact, print the leg-

But the "facts" that are born of legends are not verifiable truths. Rather, they are social artefacts: shared ideas that form the basis of the actually existing sociopolitical order. If enough people were to reject them, the entire order would disintegrate.

These social artefacts allow a society's original sins to remain in the background, where they continue operating silently because modern civilisation still relies on barbarism. Recall how the legal apparatus of power was used to sanction the extralegal practice of torture by calling it "enhanced interrogation.

Yet now, a new type of political dispensation  $\,$ is emerging. As the philosopher Alenka Zupančič observes in her new book, Let Them Rot (on which I rely here extensively), we increasingly have leaders who take pride in their crimes "as if it amounted to some kind of fundamental moral difference or difference of character, namely, 'having the courage, 'the guts,' to do it openly." But, Zupančič hastens to add, "what may appear to be their courageous transgression of state laws by avoiding the 'hypocrisy' that those laws sometimes demand is nothing more than a direct identification with the obscene other side of state power itself. It does not amount to anything else or different. They are 'transgressing' their own laws. This is why even when they are in power, these leaders continue to act as if they are in opposition to the existing power, rebelling against it - call it the 'deep state' or something else.'

Obviously, this description summons up images of Donald Trump, who just this month called for the "termination" of the US Constitution. But, of course, appearances have also been disintegrating in Russia. For ten months, President Vladimir Putin insisted that there was no war in Ukraine, and ordinary Russians risked criminal prosecution for sug-

gesting otherwise. But now, Putin has broken his own rule and acknowledged that Russia is at war

Likewise, Yevgeny Prigozhin, a Putin crony, long denied that he had anything to do with the Wagner Group of Russian mercenaries. He has, however, now admitted that he founded the group, and that he has interfered in US elections and will continue to do so.

For political figures like Trump and Putin, courage is redefined as a willingness to break the state's laws if the state's own interests – or their own - demand it. The implication is that civilisation endures only if there are brave patriots who will do the dirty work. This is a decidedly right-wing form of "heroism." It is easy to act nobly on behalf of one's country - short of sacrificing one's life for it – but only the strong of heart can bring themselves to commit crimes for it.

Hence, in 1943, Heinrich Himmler, the architect of the Holocaust, spoke of "a chapter of glory in our history which has never been written, and which never shall be written." The question was what do with Jewish women and children. "I decided here to find a completely clear solution," Himmler told a gathering of SS officers. "I did not regard myself as justified in exterminating the men ... and to allow the avengers in the shape of the children to grow up for our sons and grandchildren. The difficult decision had to be taken to have this people disappear from the earth."

But in today's Russia, the idea that atrocities "never shall be written" is increasingly out of fashion. Far from ignoring the eating of cannibals, such acts are being enshrined into law. On December 14, the Russian Duma (legislature) adopted a bill stating that any atrocities committed in Donetsk, Luhansk, Zaporizhzhia, and Kherson before those Ukrainian regions' annexation "will not be considered a crime punishable by law" if they are deemed to have been "in the interest of the Russian Federation."

How this determination will be made is unclear; but it is safe to assume that all the torture, rape, murder, looting, and vandalism committed by Russian forces will be excused – even celebrated. One is reminded of the paradox in Sophocles' Antigone, where it is riskier to obey morality than to become complicit in criminality.

"Russian culture," the historian Timothy Garton Ash observes, has become "a collateral victim of Putin's self-devouring cannibalism." Accordingly, "The time has come to ask whether, objectively speaking, Vladimir Putin is an agent of American imperialism. For no American has ever done half as much damage to what Putin calls the 'Russian world' as the Russian leader himself has." Offering a similar analysis, Kazakh journalist Arman Shuraev recently excoriated Russia's bullying ambassador to his country: "Russophobia is all that you have achieved with your stupid actions.  $\dots$  You are idiots. You are cannibals who eat themselves.

Paradoxically, Russia's exercise in false transparency makes the mystifications of state power even more dangerous, by eroding our moral sensitivities. It shows why we need figures like WikiLeaks founder Julian Assange more than ever. Assange is our Antigone. For years, he has been kept in an undead, isolated state, awaiting extradition to the United States for serving as a spy for the people, making public just one small part of the obscene dark side of US policy. Although Assange may have done some very problematic things, my wish for the New Year is that President Joe Biden will show true courage and drop the charges against him.

# **DISSENT IN DEMONETISATION**

**IT IS A PITY THAT THE COURT DID NOT ADDRESS THE LARGER QUESTION OF ECONOMIC IMPACT OF DEMONETISATION** 

Variable The Tender The Constitution Bench through a 4-1 judgement found no flaw in the Union government's process to demonetise ₹500 and ₹1,000 currency notes through government notification issued on 8 November 2016. Justice Gavai writing the majority judgement observed that the procedure under Section 26(2) was not violated just because the Centre had taken the initiative to advise the Central Board of the RBI to consider demonetisation. In a sparkling dissenting judgement, Justice Nagarathna has observed that the Centre should have issued a notification under Section 26(2) only if the Central Board of RBI had initiated the proposal to demonetise. The government could have gone forward by promulgating an ordnance or legislative act, should there be any difference of opinion between the Central Board and the government. She further observed: "Parliament is the nation in miniature and without Parliament democracy will not thrive. No meaningful application of the mind by the government seems to be visible when 86% of the currency had ceased to be circulated. causing severe financial crunch and socio economic despair." The process undertaken was bad in law,

The difference of opinion between the majority of judges and the lone dissenting voice is based on interpretation of Section 26(2) of the RBI Act which states: "On recommendation of the Central Board, the Central government may declare that any series of bank notes of any denomination shall cease to be legal tender." The four judges are of the view that recommendation means a consultative process which was initiated six months before the promulgation of the government order. Further, it was done for the elimination of fake currency, black money and terror financing. There was thus a reasonable nexus be-

tween the measure of demonetisation and its objectives. It therefore satisfied the basic canon of proportionality test for adjudicating reasonability of a government decision. In an earlier judgement (2018), the Supreme Court, in a split verdict had upheld Aadhaar since it had the potential to bring down proliferation of fake PAN cards. It would thus be seen that while the dissenting iudgement has interpreted Section 26(2) in a literal manner, the majority judgement has taken a more expansive opinion of the consultative process between the RBI and the government.

However, the majority verdict disappoints on a major score as to whether the intended objectives of demonetisation have been achieved or not. The majority judgement observes that it is not relevant for the Court to examine whether the objectives have been achieved and that the Central government is the best judge." On the other hand, the dissenting judge seems to believe that it has caused severe financial crunch and socioeconomic despair. There have been several studies on the impact of demonetisation on the Indian economy but none of them have been able to clearly quantify the extent of GDP loss, except to state that it affected the informal sector badly which was dependent on cash. In particular, it affected the agricultural sector, which was in the thick of harvesting and bereft of cash the small farmers were hugely affected. Also on the question of reducing black money, nearly 98% of demonetised notes came back to banks. On the stated objective of reducing terror financing, no incontrovertible evidence is available. However, most studies show that demonetisation has helped digitisation and fostered its usage. It's a pity that instead of leaving the government to adjudge the intended objectives the court should have ideally examined the outcomes in a holistic manner and provided proper advisory

to the government. The stance taken by the majority is surprising as the Supreme Court has been abdicating its earlier stance that it will only look in to the procedural fairness and not merits of public policy. For instance, in the 2G case the court clearly ruled that the first come first serve policy goes against the policy of public auctioning and has caused huge loss to the public exchequer. This was proved to be a prescient verdict when the NDA government resorted to public auctioning, winning the government a bonanza. The Supreme Court thus acted as an ideal check and balance against arbitrary decision-making by the government, involving public in

terest and economic justice. Interestingly, when the Morarji

Desai government decided to demonetise the high value currencies in January 1978, the then RBI Governor IG Patel had strong reservations. He writes in his autobiography 'Insider's View' that he spoke to HM Patel, the then HM, who advised him to speak to the PM. When IG told the PM not to play politics with economics, Desai apparently asked him not to interfere in the process. As per grapevine, Raghu Rajan was not in favour of the government's de cision. However, the judgement does not bring out if the consultative process which started in May 2016 when Rajan was RBI Governor contained any dissenting opinion by him. Interestingly, the demonetisation decision in 1978 was challenged in the Supreme Court on the ground that it curtailed freedom of trade and commerce, a fundamental right under Article 19(1)(g).

Nagarathna reminds one of the famous quotes of Justice Hughes: "A dissent in a court of last resort is an appeal to the brooding spirit of law, to the intelligence of a future date, when a later decision may possibly correct the error into which the dissenting judge believes that the court seems to have been betrayed." Justice Nagarathna has been bold enough to conclude unlike four of her colleagues that that the recommendations were obtained from the board and did not originate from the RBI. Quite clearly the autonomy and professional independence of the RBI board was compromised at the altar of an authoritarian government. It is a pity that the court did not address the larger question of economic impact of demonetisation, particularly on 92% of the unorganised sector of the economy.

# Urban job creation crucial

demic looms large in the country with job creation being a critical challenge. Recently, the government's quarterly urban Periodic Labour Force Survey (PLFS) and the Centre for Monitoring Indian Economy's Consumer Pyramids Household Survey has found India's unemployment rate at 7.2% and 8% as of September and November respectively. This means, around 3.8-3.9 crore Indians of the working age population, who are willing and able to search for jobs, are not able to get one.

This is only part of the story as the total unemployed youths are not taken into consideration. Moreover, those who call themselves employed, may be working part-time and drawing a paltry remuneration. Joblessness plaguing the nation has got worse and despite promises the ruling dispensation needs to act. Another aspect requiring urgent attention is gender disparity. The female labour force participation is just 19% and even lower than a conservative Muslim

country such as Saudi Arabia. In 2019, only 30% of Indian females with tertiary education participated in the labour force as compared to around 81% males. Youth unemployment has also been increasing steadily. From 22% in 2019, it reached 28% in 2021 and will be perhaps 30% presently. But this figure is not quite indicative

The after effect of the pan- as it does also include youth who earn but not enough for a decent livelihood.

The PLFS indicates that around 47% of labour force works in the agriculture sector today as compared to 42.5% in 2019. This increase is not just a pandemic effect. Between 2018-19 and 2019-20, agricultural employment increased by 3.4 crore, whereas industry and services employment only grew by 93 lakhs. In recent months, analysts have

warned of lower formal sector employment and subdued rural wages which could prove to be a dampener on consumption. "Improving contact-intensive services amid stable urban consumption demand could continue at a slower pace for some more time," says a report by Emkay Global Financial on the second quarter GDP data, adding its channel checks depict quite mixed demand trends during the recent festive season. The formal sector employment growth seems to be reducing, indicated by the sequential fall in new Employees Provident Fund Organisation (EPFO) payrolls and the Naukri Job index. Additionally, subdued real rural wage growth is expected to further impact rural consumption.

CRISIL, the analytical company providing ratings, research, and risk and policy advisory services, has noted that while domestic demand has stayed relatively resilient so far, it would be tested next year by the current weakening industrial activity. Increasing transmission of interest rate hikes to consumers will also be a pressure point and rural income prospects remain dependent on vagaries of weather, it added. Some feel there is a lowering demand for MGNREGA jobs, which is debatable as rural economy is stagnating with depressed wages and with little or no likelihood of the demand picking up.

The government is trying to boost up industrial activity but there's not much increase in industrial output. In fact, in October it had shrunk 4% to a 26-month low and forex reserves had fallen by \$72 billion a year. Additionally, the government is not concentrating on the labour-intensive sector, where job potential is undeni-

ably high. Meanwhile, the forecast for this year is not quite encouraging, rather worrying thereby retarding the possibility of a growth in employment opportunities. With domestic demand being insufficient, it is difficult to presume expansion of the labour-intensive industrial sector, which can actually generate job opportunities. Moreover, there is the resource crunch aspect of most states which are busy with rather unproductive welfare schemes and don't have sufficient funds to promote industrial activity. However, it is time that industrial clusters with small and cottage industries should be encouraged.

Besides, district infrastructure is rather poor and needs to be improved vastly to encourage setting up of manufacturing units that could promote employment cre ation. Experts need to be consulted, and universities tapped so as to prepare and frame a realistic and achievable policy so that government aid could be extended to units that generate employment. Plus, the service sector should be given additional impetus as it is con-

tributing to employment creation. Finally, it needs to be emphasised that the government must create adequate employment opportunities to ensure that the social fibre is maintained, and that social disturbance is checked given that the youth may be waylaid to anti-social activities. In this context, the government may seriously think of starting an urban job scheme for poor and economically weaker sections, as has been suggested by many experts. Undoubtedly, lack of productive work has a negative effect on the socio-economic structure, more so with widening inequality in wages and incomes. Corrections need to be made. And urgently.

# 63K animals died on rail tracks from 2017-18 to 2020-21

New Delhi, Jan 4: Over 63,000 animals, including four Asiatic lions and 73 elephants, died on railway tracks between 2017-18 to 2020-21, the CAG has cited, raising concern over steps taken by the Union environment ministry as well as the railways in preventing such

In its report 'Performance Audit on Derailment in Indian Railways' submitted to Parliament last month. the Comptroller and Auditor General (CAG) noted that the railways should ensure that "joint advisories" issued by the Ministry of Environment & Forest and the Ministry of Railways be followed scrupulously to prevent animal deaths, which in turn will also help in preventing derailments on this account.

In these three years, the CAG found that 63,345 animals, including 73 elephants and four lions, had died after being run over. The CAG said that to prevent train accidents involving elephants, general advisories approved by both the ministries had been jointly issued to the railways in 2010.

The advisories include clearance of vegetation on sides of railway tack, under passes/overpasses across railway track to allow elephants to escape, signage boards to pre-warn train drivers, sensitising programmes for train drivers, guards and station masters, engagement of elephant trackers. and to keep railway track free from food waste that attract elephants.

Joint inspections conducted in 102 sections across 18 divisions on nine ZRs (zonal railways) by officials of Audit Department and Engineering Department of ZRs show that there is a 76 per cent shortfall in construction of underpasses and ramps for the movement of elephants at identified locations, 41 per cent shortfall in fencing at isolated locations and 64 per cent shortfall in deployment of forest department staff in railway control offices.

"It can be seen that the important precautionary measures related to provision of signage boards, construction of underpasses, provision of fencing and deputation of forest staff in divisional offices had not been implemented in many sections, even after a lapse of more than 10 years period from the issue of Joint General Advisories by Ministry of Environment & Forests, and MoR," the report said.

With special reference to Asiatic lions, the report said that even these are not safe in the Gir Forest despite the existence of passages in the Bhavnagar Division.

# 'No signs of rape of minor girls'

The medical examination report is likely to give a new twist to the scandal

Bengaluru. Jan 4: In a major development the medical examination of the victims in the sensational Lingayat mutt sex scandal case has shown no signs of rape, according to sources.

Lingayat seer Shivamurthy Murugha Sharanaru of the influential Chitradurga Murugha Mutt has been accused of sexual exploitation of minor girls. He is presently in jail. The medical examination report

is likely to give a new twist to the scandal. The report submitted to the court has categorically stated that there was no penetrative sex with two minor girls who complained against the pontiff, sources said.

The sources said the Chief Medical Officer of the Chitradurga district hospital has conducted the medical tests on the minor victims in the first case lodged against the accused seer on August 27, 2022. The report also stated that the hymens of the minor girls are intact. Sources informed that one of

the minor girls refused to undergo the medical test initially and maintained that she was exploited sexually. Later, when the examination proved otherwise the girl said there was no penetration.

The accused seer has been booked under the provisions of the Protection of Children from Sexual Offences Act and the Atrocity Act. He was arrested on September 1, 2022 amid high drama

and sent to judicial custody.

The courts have rejected his bail pleas and the government has appointed an administrator for the mutt. In another development, the police had arrested a former administrator of the mutt S.K. Basavarajan, his wife Sowbhagya and others for hatching a conspiracy against the accused seer and tutoring the alleged minor victims.

### Kerala HC dismisses bail plea of woman accused

Kochi, Jan 4: The Kerala High Court on Wednesday dismissed the bail plea of the woman accused in the human sacrifice case in which two other women were allegedly killed, saying granting of the relief could "thwart" justice and that the accused could influence witnesses.

The court said the probe was still going on in both cases of murder, in which the victims were allegedly killed in a brutal manner and if the accused was released on bail there was every chance that she may influence the witnesses. "If bail is granted, there is the stark reality of justice being thwarted. Thus the circumstances do not lean in favour of the grant of bail to the petitioner (accused), Justice Bechu Kurian Thomas said and rejected the plea for bail moved by Laila Bhagawal Singh, one of the

New Delhi, Jan 4: The family of Anjali Singh, who was hit and dragged by a car, Wednesday reiected the statements of her 'friend' that she was drunk at the time of the incident, and said they had never seen or heard of Nidhi, while police quizzed seven people present at a New Year party attended by the two women before the accident.

Also, more CCTV footage emerged where Nidhi is seen returning home around 1.37 am, about five minutes after they left the party venue, leading to questions being raised about the timeline of the events on the fateful night.

A post-mortem report stated that Singh had sustained 40 injuries over her body due to the drag. Her "brain matter" is missing and she had multiple contusions, abrasions and lacerations, the doctors found.

Delhi Deputy Chief Minister Manish Sisodia met Anjali's family and said the incident was an example of extreme brutality. He said efforts will be made to provide employment to one of Anjali's kin.

"If a piece of polythene or even paper is stuck, it is easily sensed and the driver stops the vehicle to check it. The incident is an example of extreme cruelty that shook one from inside," Sisodia said.

# Cong forms 3-member committee to evaluate poll results

New Delhi, Jan 4: The Congress on Wednesday set up a three-member fact-finding committee to evaluate the party's performance in the recently concluded Gujarat assembly elections and suggest corrective measures.

The committee will be chaired by former Maharashtra minister Nitin Raut, who also heads the party's SC department. The panel has been asked to submit its report to the party within two weeks.

The other members of the committee are Shakeel Ahmad Khan and Saptagiri Sankar Ulaka, an official communication from the party said. The party has set up several

such panels in the past to assess the party's poll debacle in several states but none of the reports have been discussed within the party forums, Congress leaders maintained

The formation of the committee comes in the wake of the Congress' worst-ever performance in the Gujarat assembly polls where it won only 17 seats out of total 182 assembly constituencies.

"The Congress president has constituted a fact-finding committee to evaluate the results of the recently concluded assembly elections in Gujarat and suggest measures to be taken, with immediate effect," it said.

"The committee will submit a report to Hon'ble Congress president within two weeks," All India Congress Committee (AICC) general secretary KC Venugopal said in the communication.

Many in the party, however, feel that reports of such committees are gathering dust in the party and the recommendations have not been implemented.

Former Congress president Sonia

Gandhi had set up a committee headed by former Maharashtra chief minister Ashok Chavan after the party's poll debacle in Assam and Kerala and some other states, but the recommendations were not discussed at the party forum.

Veteran party leader A K Antony has in the past headed several such committees on fact facing the party's performance in the past, but senior leaders point out that none of them have seen any of Antony's reports

and wondered where they are. The Congress performed poorly in the Gujarat assembly elections getting a vote share of 27.28 per

cent. In the 2017 assembly polls in Gujarat, the party had won 77 seats.

### 95,000 beneficiaries reject AP govt's house sites THE LAYOUTS PROPOSED ARE EITHER

**FAR AWAY FROM HUMAN HABITATIONS** OR CLOSE TO BURIAL GROUNDS

Amaravati, Jan 4: More than 95,000 women beneficiaries, who were given house sites in Andhra refusing to build houses under a government scheme for a variety of reasons, according to Housing Department officials

The beneficiaries have been asking the state government to provide them sites at alternative locations as the layouts now proposed are either far away from human habitations or close to burial grounds the officials said.

This has pushed the government into a quandary as it will be required to spend close to Rs 800 crore to find alternative sites.

"If we are to fulfil the demand we will have to acquire more than 2,000 acres of land from private owners for these people. Previously. what we gave away was government land," a top official of the Housing Department said.

The department officials informed Chief Minister Y S Jagan Mohan Reddy recently that there were 95,106 'tough cases' where the beneficiaries were refusing to take the house site (1.5 cents each) and also build a house.

Officials pointed out that in at least 30 per cent of the cases, the new housing layouts were "located near unsuitable areas like burial

In another 30 per cent of the cases, the proposed layouts were far away from the existing habitations were rejecting them

Such problems have cropped up in many mandal headquarter towns and in some semi-urban areas. In some districts, the officials grouped people from two-three villages and sought to develop a single layout, away from the villages. Here, the beneficiaries are demanding that they be provided sites in their re spective villages only.

Special Chief Secretary (Housing) Ajay Jain, however, maintained that the problem arose only in respect of about 50,000 benefi-

"We have asked the district collectors to conduct a survey and identify alternative land for house sites. After the survey, we will complete land acquisition and distribute house sites to the beneficiaries," Jain told PTI

"In only 1.5 per cent of the total cases have the beneficiaries sought alternative land for various reasons. We have taken this to the notice of the Chief Minister, who asked us to provide alternative sites to the 100 per cent satisfaction of the beneficiaries," Jain pointed

Meanwhile, the government is going to acquire about 600 acres of land, at an estimated cost of Rs 251 crore, for another 24,068 beneficiaries in Prakasam and Anantapuramu districts as the sites previously allotted were under

The beneficiaries here could not go ahead with construction of houses. Housing department auhave been identified in the two dis-

was on. Two years ago, the state government distributed house sites to about 25 lakh women beneficiaries under the flagship 'Pedalandariki Illu' (houses for all poor) programme and promised to build as many houses in new

The state government dovetailed this with the Centre's Pradhan Mantri Aawas Yojana and took up construction of 18.63 lakh houses in the first phase, targeting to complete them by June 2023.

However, construction of about two lakh houses has not yet begun because of legal issues and reluctance on part of the beneficiaries.

Of the 16.67 lakh houses started, only 6.96 lakh reached the basement and above level in over two years now while construction of only 2.09 lakh houses was completed, official said.

The Government of India released a sum of Rs 5,172 crore to the state for the housing programme so far during the current financial year but Rs 1,140 crore has not been spent on the intended purpose. The state government is also yet to release its share of Rs 888 crore for the housing works, severely hampering the progress, officials lament.

"Unless this Rs 2,028 crore is immediately released and utilised, the Centre will not release a further grant of Rs 2,488 crore. This will ieopardise the whole programme. the officials said.

For work done under the Pradhan Mantri Aawas Yojana (Gramin), the state government is yet to pay Rs 120 crore to the beneficiaries, even as the Housing department requested that Rs 220 crore be immediately released to put the programme on 'auto-pilot mode'

Kishore Babu, who was elected to Andhra Pradesh Assembly from Prathipadu in 2014, had served as SC and ST welfare minister in the Telugu Desam Party (TDP) goventering his constituency The state government has

ordered a ban on public meetings on roads in the wake of the December 28 stampede at Kandukur during Naidu's roadshow which had claimed eight lives

Wednesday prevented Telugu Desam Party president N Chandrababu Naidu's entry into his Kuppam constituency, days after the Andhra Pradesh government issued an order (GO No.1) prohibiting public meetings and rallies on roads across the state. Police resorted to a lathi charge

and seized several vehicles of TDP leaders, including Naidu's campaign vehicle, besides taking many party workers into custody. As thousands of TDP workers welcomed him on his arrival from

Bengaluru, the TDP supremo refused to take a notice served on him by the police denying him permission for his tour.

Naidu entered into a heated argument with the local Sub-Divisional Police Officer as the latter sought to stop the former Chief Minister's convoy saying there was



no permission for his rally

He demanded to know why permission was being denied for his visit but the SDPO did not give any reason and left.

Tension prevailed at Pedduru village, bordering Kuppam, as Naidu reached there from Bengaluru airport on the first day of his proposed three-day trip and the police blocked his entry.

Getting down from his bulletproof vehicle, the former Chief Minister questioned the SDPO over the police action.

"I am the MLA from Kuppam for the past seven terms. It's my home. How can you prevent me from going to my own house,' Naidu angrily questioned

"What sanctity does the GO No. 1 have. The Police Act, 1861 is not

applicable to the state of Andhra Pradesh. How can the government issue an order based on that Act,' he asked. Naidu pointed out that he had written to the Director General of Police several days ago informing about his Kuppam tour.

"We have applied for permission to the district Superintendent of Police. The illegal GO was issued on January 2 but the police claim the prohibitory orders came into force from January 1," he noted.

Defying the police, Naidu marched on the streets in Pedduru and addressed the people.

Lashing out at Chief Minister Jaganmohan Reddy, he charged him with "muzzling not just the Opposition's voice but the people's voice itself. We will fight it out,'



The IPC sections included in the case are 294 (obscene act in public place), 354 (assault or criminal force to woman with intent to outrage her modesty), 509 (word, gesture or act intended to insult the modesty of a woman) and 510 (misconduct in public by a drunken person), he added

"We have formed multiple teams to keep a track of the accused passenger and he will be arrested soon," the officer said.

Air India Wednesday said it has imposed a 30-day flying ban on the passenger who had urinated on a co-passenger onboard a flight from New York to Delhi in November last year and set up an internal panel to probe whether there were lapses

It has written to Air India Chairman Chandrasekaran to intervene in the matter and take appropriate action against the culprit. The Commission has sought a detailed action taken report from Delhi Police within seven days.

#### **SC grants bail to** wife of aide of slain gangster Dubey in cops' killing case

New Delhi, Jan 4: The Supreme Court Wednesday granted bail to Khushi Dubey, the wife of a close aide of slain gangster Vikas Dubey, in a case related to the killing of eight policemen who had gone to arrest him in a Kanpur village in July 2020

A bench comprising Chief Justice D Y Chandrachud and Justices S Abdul Nazeer and P S Narasimha took note of the submissions of senior lawyer Vivek Tankha that Khushi was a minor at the time of offence and regular bail be granted to her as the charge sheet has also been filed in the

Khushi's counsel said it is a case of an innocent person at a wrong place at the wrong time as she was married to Amar only seven days before the July 3 incident

case. "Having regard to the... Facts and circumstances, we are of the view that the continued custody of the petitioner at this stage would not subserve the ends of justice. We accordingly direct that the petitioner be released on bail subject to such terms and conditions as may be imposed by the Sessions Court in connection with Sessions Trial No...," the bench said in its order.

The local court shall ensure that one of the conditions to be imposed for the grant of bail is that Khushi shall appear at least once every week before the station house officer (SHO) of the police station concerned and cooperate in the trial.

The top court took note of the submissions that the petitioner was a minor on the date of the

Khushi is the wife of Amar Dubey, who was also killed in a police encounter later.

### SC stays Allahabad HC order on OBC quota for UP civic body polls

New Delhi, Jan 4: In a major relief to the Uttar Pradesh government, the Supreme Court on Wednesday stayed the Allahabad High Court order directing it to hold urban local body polls without reservation for the other backward classes (OBCs).

A bench comprising Chief Justice D Y Chandrachud and Justice P S Narasimha also ordered that the committee appointed by the state government to decide issues related to grant of OBC



quota for the local body polls will have to conclude the exercise within three months by March 31, 2023 instead of six months as stipulated The bench took note of the submissions of Solicitor General Tushar Mehta, appearing for the state government, that one of the directions issued by the high court with regard to the functioning of the local bodies under administrators after the expiry of the terms of the elected representatives can be allowed to operate.

The top court permitted the state government to appoint administrators to run the affairs of the local bodies after the expiry of the

tenure of the elected representatives but said the administrators will not be empowered to take major policy decisions. "The high court by impugned judgement dated ... Has directed (to hold elections without OBC reservation) ... Pending further orders of this court, the operation of the above direction shall remain stayed," the bench said in its order.

At the outset, the bench considered submissions of the solicitor general that the state government has set up the Uttar Pradesh State Local Bodies Dedicated Backward Classes Commission in pursuance of the apex court judgements to decide the quota issue keeping in mind the political representation of different backward castes in local bodies

The bench also took note of the submission of the state government that though the tenure of the newly appointed commission is six months an effort will be made to ensure the exercise gets over as expeditiously as possible on or before March 31.

The top court also issued notices to those who had moved the high court against the notification of the state government and listed the matter for hearing after three weeks. Earlier, the state government had moved the top court with its appeal against the December 27 order of the high court, saving the high court cannot quash the December 5 draft notification which provided for reservation of seats in the urban civic body polls for other backward classes (OBCs) apart from those for Scheduled Castes, Scheduled Tribes

# Siddaramaiah calls Bommai a 'puppy'

# Over 5.7cr Indians affected by serious fungal diseases: Study

#### FUNGAL DISEASE IS FREQUENT IN INDIA, BUT ITS INCIDENCE AND PREVALENCE ARE UNCLEAR

New Delhi, Jan 4: Over 5.7 crore Indians are affected by serious fungal diseases, 10 per cent of which are from potentially deadly mold infections, according to a review of over 400 published research


articles Fungal disease is frequent in India, but its incidence and prevalence are unclear. This review is the first to define the frequency or burden of various fungal infections in the country

Researchers from All India Institute of Medical Sciences, New Delhi, AIIMS Kalyani, West Bengal and PGIMER, Chandigarh, along with The University of Manchester, UK, estimate that 57,250,826 (over 5.7 crore) - or 4.4 per cent of India's population -- are likely to be affected.

"The total burden due to fungal diseases is huge but underappreciated," said Animesh Ray of AIIMS Delhi, the lead author of the article.

"While tuberculosis affects less than three million people in a year in India, the number of Indians affected by fungal disease are several times higher," Ray said.

The review, published in the journal Open Forum Infectious Diseases, found that vaginal thrush -- or yeast infection of vagina -- affected around 2.4 crore women of reproductive age, with repeated attacks. Hair fungal infection -known as tinea capitis -- in schoolage children affected a similar number. It causes a painful infected



scalp and leaves many with hair loss, according to the study. Major contributors to death were mold infections of lungs and sinuses, affecting over 250,000 (2.5 lakh) people, the researchers said.

Another 1,738,400 (over 17 lakh) people had chronic aspergillosis - an infection of respiratory system caused by a type of mold - and there were 35 lakh people with serious allergic lung mold disease,

they said. The review shows that over 10 lakh people are thought to have potentially blinding fungal eye disease, and nearly two lakh had mucormycosis, so called "Black

This total burden of serious fungal infections is over 10 times the annual incidence of tuberculosis in country India. indicating an enormous population of patients affected by fungal

diseases, the researchers said Professor David Denning from The University of Manchester and Global Action For Fungal Disease noted that there have been major diagnostic improvements in re-

cent years, with public health services in India catching up with private hospitals in terms of capability. "However, fungal This disease continues to be

#### **UNSC** welcomes new members

United Nations: Ecuador, Japan, Malta, Mozambique and Switzerland got a formal welcome into the UN Security Council Tuesday, taking the two-vear seats they won unopposed in June. #### **Germany rejects** Poland's demand

Warsaw: Germany has formally rejected a World War II reparations claim estimated to be 1.3 trillion euros (\$1.4 trillion), the Polish foreign ministry said Tuesday. Since coming to power in 2015 Poland's governing Law and Justice (PiS) party has championed the issue and evoked Germany's "moral duty". Poland in September estimated the financial cost of World War II losses to be 1.3 trillion euros and sent a formal diplomatic note to Berlin demanding compensation.

MOSCOW: President Vladimir Putin sent a frigate to the Atlantic Ocean armed with new generation hypersonic cruise missiles Wednesday, a signal to the West that Russia will not back down over the war in Ukraine. Russia, China and the United States are in a race to develop hypersonic weapons which are seen as a way to gain an edge over any adversary because of their speeds - above five times the speed of sound and manoeuvrability. In a video conference with Defence Minister Sergei Shoigu and Igor Krokhmal, commander of the frigate named "Admiral of the Fleet of the Soviet nion Gorshkov", Putin said the ship was armed with Zircon (Tsirkon) hypersonic

weapons. "This time the ship is equipped with the latest hypersonic missile system - 'Zircon'," said Putin. "I am sure that such powerful weapons will reliably protect Russia from potential external threats." Russia sees the weapons as a way to pierce increasingly sophisticated US missile defences which Putin has warned could one day shoot down Russian nuclear missiles.

### China Covid outbreak stokes global fears

China is convinced of 'final victory' over Covid as world awaits virus data

Beijing, Jan 4: China's state media rallied citizens Wednesday for a "final victory" over Covid-19 as health officials abroad tried to work out the scale of its raging outbreak and how to stop it spreading.

Beijing's abrupt axing of "zero Covid" curbs last month has unleashed the virus on China's 1.4 billion people who have little immunity after being shielded since the virus emerged in the Chinese city of Wuhan three years ago.

The World Health Organization holds a briefing Wednesday, a day after WHO officials met Chinese scientists amid concern about the accuracy of China's data about the outbreak. The UN agency has yet to release details about its talks.

The head of the World Health Organisation said the agency is "concerned about the risk to life in China'



#### HDFC posts 19.5% loan growth in Q3

#### **Setback for Google** as NCLAT refuses stay on CCI penalty

New Delhi, Jan 4: In a setback for Google, an appellate tribunal Wednesday refused an interim stay on the competition regulator imposing a ₹1,337-crore penalty on the US tech giant and asked it to deposit 10 per cent of the amount.

The National Company Law Appellate Tribunal (NCLAT) admitted the search giant's challenge to the Competition Commission of India (CCI) slapping a ₹1,337.76-crore fine for abusing the dominant position of its Android smartphone operating system in the country.

CCI in October last year had asked Google to allow smartphone users on the Android platform to uninstall apps and let them select a search engine of their choice. That order was to become effective from January 19.

NCLAT issued notices to CCI and directed to list the matter February 13, for hearing over the interim stay on the regulator's



order during the pendency of the matter before it.

Google challenged the CCI order on grounds that it affects consumer safety and experience on Android and could raise smart-

The fall meant that in just one year, the tech giant lost \$1 trillion in market capitalisation.

According to CNN, like many other tech companies, Apple has been hit by supply chain issues. Its manufacturing in China has taken a hit due to a fresh wave of Covid infections in the only major economy combating such a crisis.

On January 3, Apple's shares were down by nearly 4 per cent after a report raised concerns about consumer demand for its products, according to the report

# **Govt boost to green** hydrogen industry

India aims to produce 5 million tonne of green hydrogen per annum in the next five years and the incentives would help bring down the cost

New Delhi, Jan 4: Prime Minister Narendra Modi-led Cabinet Wednesday approved a ₹19,744 crore incentive plan to promote the manufacturing of green hydrogen in the country in a bid to cut emissions.

Information and Broadcasting Minister Anurag Thakur said the Cabinet approved the National Green Hydrogen Mission which is expected to attract ₹8 lakh crore of investment in the green hydrogen chain.

"The Union Cabinet, chaired by Prime Minister Narendra Modi, has approved National Green Hydrogen Mission," Thakur said while briefing reporters about the Cabinet decisions.

Carbon-free hydrogen, which can be used as fuel in automobiles and as an energy source in industries such as oil refineries and steel plants, is produced by splitting water. When electricity generated from renewable sources such as the sun is used to split water through electrolysis, green hydrogen is produced. Oxygen is a by-product of such a process.

The initial outlay for the mission will be ₹19,744 crore, including an outlay of ₹17,490 crore for the SIGHT programme, ₹1,466 crore

Meanwhile, the S&P Global India Composite PMI Output Index -which measures combined services and manufacturing output -rose from 56.7 in November to 59.4

Gurugram, Jan 4: Droupadi Murmu, President of India, virtually dedicated transmission system built for evacuation of 8.9 GW of solar power in Bhadla, Fatehgarh and Bikaner regions of Rajasthan at a function held at Raj Bhavan in Jaipur January 3.

Government and POWERGRID were also present.

Energy transition in the country is happening at an accelerated pace through large scale grid integration of Renewable Energy. By the year 2030, more than 500 GW of non-fossil fuel

based generation capacity is envisaged. Government has planned various inter-state transmission scheme for renewable energy integration.

Under Phase-I, 8.9 GW of solar power was envisaged from Rajasthan and POWERGRID has developed

inter-state transmission system for evacuation of power from various complexes such as Bhadla-3.55 GW, Fatehgarh-3.5 GW and Bikaner-1.85 GW. 3 sub-stations at Fatehgarh, Bhadla & Khetri, 1872 circuit kms of EHV transmission lines and 12,500 MVA transformation capacity have been added to the Inter State Transmission System. The solar complexes in the region have now been connected to the National Grid.

The total cost of the project is ₹4,928 crore. After completion of the project, renewable energy from solar complexes of Rajasthan is easily accessible to millions of consumers across the country.

# Turnaround of PSBs: A story from doom to bloom

privatising a PSB was taken to give a signal that the government is really committed to reforms and can bite the bullet. After hectic parlays, the majority 51 per cent stake of IDBI Bank was sold to LIC in January 2019, making it a private sector bank.

Aided by the capital infusion and nudge from the Department of Financial Services compelled

PSBs to step up action on defaulters who committed fraud. Action against big defaulters like Bhushan Steel, Jet Airways, Essar Steel, Nirav Modi and Rotomac along with bankers like Yes Bank, DHFL, IL&FS, etc. Fundamentally corrected the imbalance in the creditor-debtor relationship.

As a result, the PSBs, which reeled under the stressed assets, bounced back with a vengeance and have started giving a tough fight to private sector peers on all counts. They turned the corner during 2020-21 with a combined net profit of ₹31,820 crore, supported by impressive loan recovery, reduction in NPAs and windfall gains on their bond portfolio.

Subsequently, the combined profit more than doubled to ₹66,539 crore in 2021-22 despite Covid-19 pressure. Many state-owned banks after a hiatus also declared dividends in the last financial year. In all, nine banks, including SBI, declared dividends of ₹7,867 crore to shareholders.

# India aim to seal series Mavi makes intention clear

Pune, Jan 4: Shubman Gill will be aiming to up the ante in the Powerplay overs to keep his nearest competitor Ruturaj Gaikwad at bay as a buoyant India team aims to come all guns blazing against Sri Lanka in its bid to clinch the series in the second T20I here Thursday.

However, this is the identical approach that had cost KL Rahul a place in the T20 squad. While skipper Pandya, like every other Indian captain in the recent past has promised a fearless approach at the top, he would need each of his player to walk the talk.

The Indian T20 cupboard is brimming with talent with players likes Ruturaj and Rahul Tripathi cool-

ing their heels in the dugout. It is expected that both Gill and Ishan Kishan will get all three games in the series and an impactful Powerplay will also give the batters coming down the order more confidence to play fearless

The batting unit will like to score more runs in the second game and a lot will depend on the manner in which new vice-captain Suryakumar Yadav does what is known as 'front-loading' (heavyduty hitting in the first 10 overs) in cricketing jargon.

Surya was dismissed cheaply, one of his rare T20 failures after a golden 2022 but it was more to do with a bit of less pace off the surface unlike Australia and New Zealand where the 'blind scoop' over '45', would normally go for a six.

But the smart operator that he is, Surya will find a way to manoeuvre against a Sri Lankan bowling attack which is more dependant on spinners Wanindu Hasaranga and Mahesh Theekshana who accounted for two wickets, giving away only 51 runs in their cumulative eight overs.

Deepak Hooda and Axar Patel's batting effort was lauded by one and all and their utility is there to be seen. Shivam Mavi's dream debut is certainly a big relief for skipper Pandya, who could be lauded for taking the new ball and bowling an incisive first spell alongside the new-

Mavi (4/22), with his ability to swing the ball, and Umran Malik's (2/27) raw pace is welcome addition to this T20 playing XI and seem to be long-term investments going into the 2024 T20 World Cup.

Mavi had match figures of 4/22, which will warm the hearts of the selectors, who are looking for someone to pair with Jasprit Bumrah in white-ball cricket.

Following India's two-run win in the opening game of the threematch T20I series, the team's bowling coach, Paras Mhambrey, asked the young Mavi what went through his mind when skipper Hardik Pandya handed the new ball to him.

"My main agenda is to attack first in the powerplay as I always go for lbw bowled... Whether the boundaries happen or not, my mindset is to get wickets," said the Noida cricketer, who had been waiting for the India debut for the last six years.

Mhambrey, while praising Mavi's work ethic since his Under-19 days, complimented his "hardworking attitude" and also his resolution to come back from injuries and play in the domestic circuit.

"After the U-19 (World Cup in 2018) when I played in the IPL, I had injuries but I decided to level up my fitness because I was getting injured in between my performance. I decided to work hard on my fitness and it paid me back in this

Riyadh, Jan 4: Cristiano Ronaldo has just completed a move to Saudi Arabian club Al Nassr, but made a slip up during his official presentation in Riyadh when mistakenly saying he had "come to South Africa."

Perhaps the Portugal great was disorientated by the whirlwind nature of his arrival at his new club, which saw him fly out to Saudi Monday night, before undergoing a medical the next morning and then being greeted by thousands of cheering fans at Al Nassr's Mrsool Park stadium Tuesday.

"For me it is not the end of my career to come to South Africa," Ronaldo said at a news conference before stepping out on the field at the 25,000 capacity stadium. "I really don't worry about what people say. I took my decision and I have responsibility to change that, but for me I'm really, really happy to be here."

After what was clearly a slip of the tongue, Ronaldo went on to outline his reasons for joining Al

Nassr and said he had turned down "many clubs" around the world to complete one of the most surprising moves in soccer history.

"I want to give a different vision of this country and football. This is why I took this opportunity," he said. "I know the league is very competitive. People don't know that, but Iknow because I saw many games."

Ronaldo has signed a two-and-ahalf-year contract to play in the Saudi Pro League and will reportedly earn up to USD 200 million a year. The former Manchester United, Real Madrid and Juventus forward also said is ready to play straight away with Al Nassr facing Al Ta'ee Thursday.

However, the 37-year-old Ronaldo was handed a two-match suspension by the English Football Association in November for knocking a mobile phone out of the hand of a supporter after a game against Everton last April. He had already left United by the time of the ruling, but the FA said the suspension would be transferred to any new club.

### **WICKETKEEPER-BATTER TO UNDERGO SURGERY, STATES BCCI** Pant airlifted to Mumbai

New Delhi, Jan 4: Star India batter Rishabh Pant is all set to "undergo surgery for ligament tears", the BCCI stated Wednesday, effectively ruling him out of competitive cricket for an indefinite period.

Pant has been airlifted from a Dehradun hospital to Mumbai where he will undergo extensive treatment for ligament injuries in the knee and ankle which he had sustained during a car crash December 30, BCCI secretary Jay Shah said in a press release.

The BCCI decided to shift Pant to Mumbai by air ambulance since he is not in a position to fly by a commercial airline.

"Rishabh, who is currently receiving treatment for his injuries at Max Hospital, Dehradun following a car accident December 30, will be brought to Mumbai in an air ambulance," Shah said in the

As reported earlier by PTI. Pant will be treated by noted sports orthopaedic surgeon Dinshaw Pardiwala. "He will be admitted to Kokilaben Dhirubhai Ambani Hospital and Medical Research Institute and will be under the direct supervision of Dr Dinshaw Pardiwala, Head - the Centre for Sports Medicine, and Director -Arthroscopy & Shoulder Service at the hospital," Shah said.

"Rishabh will undergo surgery and subsequent procedures for ligament tears and will continue to be monitored by the BCCI Medical Team throughout his recovery and rehabilitation. "The Board will make every effort to aid and expedite the recovery process of Rishabh and will provide him with all the support he needs dur-

ing this period," he added. Pant, 25, survived a horrific car accident when he was driving from Delhi to his hometown Rourkee but lost control on the NH-58 high

way before hitting the divider. Pant sustained cuts on his fore-

head, have a severely bruised back along with injuries on his knee and ankle. While most injuries are superficial, the worrying factor will be the ankle and knee. Being a centrally-contracted cricketer, his treatment is the board's prerogative.

The MRIs of his injured knee and ankle couldn't be performed as there was extensive swelling and hence the degree of tear is yet to be ascertained.

However, it is understood that any sports-related injury diagnosis and prognosis for a centrally-contracted cricketer will be done by the BCCI's panel of doctors and the rehabilitation and recuperation will be managed by the Sports and Medical Science team at NCA, led by Dr Nitin Patel. Pant will now be missing the Test series against Australia and also the cash-
