Matric summative exams start March 10

Cuttack: The Board of Secondary Education (BSE) in Odisha, which conducts the Class-X exams for Odia medium students, has decided to hold this year's matriculation examinations from March 10 to March 17. Over six lakh students will appear in the examinations this year in regular, ex-regular, madhyama (Sanskrit) and Open School Certificate streams. Under the new pattern, the BSE is now conducting a total of six assessments for Class-X students in a year, that includes four formative assessments (FAs) and two summative assessments (SAs). BSE president Ramashish Hajra said that the exams in March will be known as Summative Assessment II (SA-II). He added that students have already appeared in FA-I, FA-II and SA-I.

Dolphin count rises slightly in Odisha

slight increase in the number of dolphins in Odisha as per the census report released Thursday. The number of dolphins has increased to 733 from the 726 spotted in 2021. The census was carried out December 21 to 23, last year. It states that out of the total number registered, 550 dolphins have been sighted alone in Gahirmatha and Bhitarkanika. Nine teams led by DFO Sudarshan Gopinath Yadav and comprising wildlife experts had carried out the headcount in the three-day exercise. Among the species spotted were humpback, chinensis, bottlenose and spinner dolphins.



DELAY IN APPOINTMENTS OF SC, HC JUDGES **SHOCKS PARL PANEL** PRESS TRUST OF INDIA

New Delhi, Jan 5: A parliamentary panel has expressed surprise that the government and the Supreme Court Collegium have failed to arrive at a consensus on the memorandum of procedure (MoP) guiding the appointment, elevation and transfer of apex court and high court judges, even after almost seven years.

In a recent report, the Departmentrelated Standing Committee on Law and Justice and Personnel said it expects the government and the judiciary to finalise the revised MoP, 'which is more efficient and transparent', in terms of a Supreme Court observation.

'The panel is surprised to note that the Collegium and government have failed to reach a consensus on revision of the Memorandum of Procedure (MoP) for appointment of judges to the constitutional courts (SC and the 25 HCs), though the same is under consideration of both for about seven years now," the panel headed by BJP leader Sushil Kumar Modi noted in a report.

SC slams CBI over chit fund probe

The Supreme Court points out that many cases in Odisha have still not reached their logical end due to lackadaisical approach by probe agencies

New Delhi, Jan 5: The Supreme Court expressed Thursday dissatisfaction with the Central Bureau of Investigation (CBI) for its inordinate delay in investigation of financial scams. It made the observations while hearing a PIL seeking probe in the multi-crore chit fund scam in Odisha.

A two-judge bench of SC comprising Justices MR Shah and CT Ravikumar observed that whenever CBI and Enforcement Directorate (ED) are in the frav probing financial scams, there is delay in taking those to a logical end.

"Whenever CBI and ED come into the picture in investigating financial scams, there is delay. Show us where it has come to logical conclusion. In most cases, money has gone to tax haven countries. The accused will be enjoying in London. We have to change the system," the bench observed.

The Supreme Court noted that chit fund scams are a very serious issue and asked the CBI to file its response on the petition seeking probe in chit fund scam. The bench posted the matter for hearing Monday. The apex court as-



serted that it cannot spend 10-15 years in hearing a case.

Earlier in November 2022, the Odisha government had informed the Supreme Court that it has filed chargesheets in 334 cases out of 806 registered in connection with the chit fund scam in the state and paid compensation to 2.10 lakh depositors to the tune of ₹83.46 crore.

The Odisha government had earlier filed a status report in the apex court on a petition seeking probe in multi-crore chit fund scam and compensation to depositors. The Odisha government submitted that the Economic Offences Wing and the district police have registered 806 cases against the persons and financial establishments involved in unauthorised collection of public deposits and chit fund activities

from 2011 to till date. It said that the EOW has registered 67 cases and the district police have registered 739 cases against 280 companies.

In the affidavit filed by it, the Odisha government said it had also passed orders in 83 cases to attach properties of 65 companies involved in chit fund scams. Out of them, orders in 28 cases have been made absolute and the rest 55 cases are pending for adjudication in different designated courts, it added.

"So far, 1,403 accused persons have been arrested/remanded. The trials are in different stages in different courts including designated courts under OPID Act and in the meantime 12 cases have ended in conviction of the accused persons," the Odisha government had submitted

4 held for thrashing 1st yr BJB student -

Bhubaneswar, Jan 5: The Commissionerate police arrested Thursday four students including three minors for thrashing a fellow junior over an alleged love affair inside the campus of the BJB Autonomous College here. The accused senior student has been identified as Chinmaya Behera, 18 and is Plus-II 2nd year student of the college.

Police held the accused stu after registering a case (No. 5/23) on the basis of a complaint registered by the victim's girlfriend



January 4. She had alleged that the accused persons thrashed the victim, who is a first year student. The college falls under Badagada police limits here in the state capital.

The incident sparked widespread resentment after the video of the attack went viral. City police soon swung into action and started a probe into the incident detaining the accused persons.

Police officials said that the accused had warned the victim not to keep relationship with the girl. However, he did not pay heed to the warnings which irked seniors. When Chinmaya and his friends

again saw the two together, they beat the boy black and blue. Efforts by others to prevent the accused from thrashing the boy went in vain.

Chinmaya was produced in court Thursday and sent to judicial custody while police presented the minors before the Juvenile Justice Board here which sent them to a correctional home.

The college management also came down hard on the accused and suspended the four till fur-

ther orders. Although officials in the college said that the students had been suspended for 'ragging', police did not term it so. Bhubaneswar DCP Prateek Singh told mediapersons that it was a 'personal attack' and not a case of ragging.

ODISHA ON 5G RADAR

Bhubaneswar, Jan 5: Union IT Minister Ashwini Vaishnaw along with Union Education Minister Dharmendra Pradhan launched Thursday the high-speed fifth generation (5G) telecom service in Odisha. The Odisha capital and Cuttack became the first cities in Odisha to get 5G services. The 5G services have been unveiled in Odisha in the first phase of national launch, much before the first phase deadline (March, 2023), Vaishnaw informed.

"We have set a target to cover entire Odisha within the next two

years," Vaishnaw said. "A total of 5,000 towers will be constructed within the next 18 months," the minister added. He informed that 5G services will be available in Rourkela, Berhampur, Puri, Sambalpur, and Balasore by February. Initially Jio and Airtel will be providing services.

Vaishnaw also informed that for revival of BSNL, the Centre has allocated ₹1.64 lakh crore. BSNL will start rolling out 5G services by 2024. Vaishnaw said

Bhubaneswar, Jan Commissionerate Police finally arrested Thursday three persons for threatening woman subinspector (SI), Subhasree Nayak deployed at Mahila Police station here and brandishing swords to create panic on the intervening night of January 1 and 2. The accused were identified as Kuna Chandra Sahoo, 23, of Ranpur in Nayagarh district, Arabinda Mahakud, 28, of Manamunda and Pradeep Behera, 35, of Puruna Katak in Boudh district. The accused were staying at Saheed Nagar in the state capital.

DCP Parteek Singh while speaking to mediapersons said that it is a case of road rage. The vehicle in which the accused were travelling came on a collision course with the car of the SI on a narrow stretch near the Reserve Police Office. The three, who were allegedly under the influence of alcohol, then abused the lady SI and threatened her by brandishing a sword.

Based on the complaint, Saheed Nagar police registered a case and launched a manhunt to identify and nab the accused. After examination the CCTV footage in and around the place of the incident, police identified the accused and arrested them from different places in Cuttack and Puri.

London, Jan 5: Prince Harry has made a shocking revelation in his upcoming autobiography that his brother Prince William 'knocked' him to the floor during an argument over his American wife Meghan Markle, according to a media report here. The autobiography titled Spare also reveals the abusive words used by Prince William against Meghan.

Describing a confrontation at his London home in 2019, Harry says William called Meghan 'difficult', 'rude' and 'abrasive', which Harry calls a 'parrot (ing of) the press narrative' about his American wife, according to 'The Guardian', which says it has seen a copy of the duke's memoir *Spare* .

The confrontation escalated. Harry writes, until William 'grabbed me by the collar, ripping my neck-

lace, and... knocked me to the floor'. the paper has quoted the book while publishing the narrative.

"I landed on the dog's bowl, which cracked under my back, the pieces cutting into me. I lay there for a moment, dazed, then got to my feet and told him (William) to get out," Harry writes in the book.

The extraordinary scene, which Harry says resulted in visible injury to his back, is one of many in the book, which will be published worldwide next week. The book is likely to spark a serious furore for the British royal family.

The book's title comes from an old saying in royal and aristocratic circles: that a first son is an heir to titles, power and fortune, and a second is, therefore, a 'spare', should anything happen to the first-born, 'The Guardian' report added.

The period drama's director, SS Rajamouli, is in the running for Best Director,


but he gets an honourable mention, in a field topped by Todd Field, the helmer of the highly anticipated film, Tar. Also to land an honourable





Matric exam from March 10 to 17

Bhubaneswar, Jan 5: The Summative Assessment-2 (SA-2) of Class X students would be conducted from March 10 to 17, said the Board of Secondary Education (BSE) Thursday.

The practicals for vocational trade students will be held from February 15 to 22. External examiners will be appointed by the Board to conduct the practical tests, said BSE President Ramashis Hazra.

The pattern for SA-2 will be uploaded on the Board website. There will be no change in examination and nodal centres for SA-2.

Addressing a presser at BSE office in Cuttack, Hazra said that SA-2 will start March 10, 2022 and will continue till March 17.

The Class X exam for Madhayama and state open school certificate (SOSC) 2023 (first) will be held simultaneously.

Questions for all categories of students including Regular, Madhayama and others will remain the same.

The examination centres and nodal centres which were fixed in SA-1 will be the same for SA-2.

As per BSE officials, Formative Assessment-3 has already been conducted by the third week of December 2022 at school level and FA-4 is now continuing and shall be completed by second week of February

The marks of both FA-3 and FA-4 will be uploaded by the respective mentor schools from February 15 to 22. Likewise, SA-2 of Class IX students in high schools and Madhyma schools will be conducted from February 20 to 25. Evaluation of answersheets will be done in neutral schools between February 22 and 28.

Senior BSE Odisha officials said the next academic session will be from April 2023 to March 2024.

The Matric SA-1 examinations for Class 10 students were conducted in November last year.

Centre to spend ₹8,400cr for rice to poor: Pradhan

The Union minister says of the 4.5 crore population in Odisha, 3.25 crore will get 'Modi rice' free of cost

Bhubaneswar, Jan 5: Union Minister Dharmendra Pradhan Thursday claimed that the Centre will spend ₹8,400 crore for distribution of the food grain among the poor in Odisha while the state government's expenditure in this regard is only ₹185 crore per

The Union Education minister told reporters that the Centre will spend ₹700 crore per month which amounts to ₹8,400 crore annually to provide free rice for 3.25 crore people of Odisha under the food security scheme.

He, however, urged the state government to ensure that the poor beneficiaries get the 'Modi rice' without any hurdles.

According to a decision taken by the Union Cabinet last month, the Narendra Modi government would provide free food grain to the people for one year under Pradhan Mantri Garib Anna Kalyan Yojana (PMGKAY) "Odisha's 3.25 crore people will be covered under the PMGKY and will get free of cost rice for one year," Pradhan said.

The Union minister said of the 4.5 crore population in Odisha, 3.25 crore will get 'Modi rice' free of cost. They constitute around 85 per cent of the state's population, he claimed. "Let people decide who is helpful to them. Its ₹8,400 crore versus ₹185 crore," he

Referring to Odisha government's cheap rice scheme where the poor people were getting rice at the rate of ₹1 a kg, Pradhan said: "The Centre was bearing 90 to 95 per cent of the cost, while the state had to take care of the rest. The state government had the responsibility to properly distribute the rice to the beneficiaries." Of the rice priced at ₹30 per kg,

the Centre was bearing ₹27 while the state government was giving ₹2 a kg and the beneficiary gets it at the cost of ₹1.

Pradhan said now that the Centre will take full expenditure, the state has nothing to continue, but to ensure proper distribution.

Explaining the cost involved in the free rice programme, Pradhan said around 1,87,475 metric tonnes of rice will be required for distribution among 3.25 crore people of the state per month. With rice costing ₹37.28 per kg, around ₹700 crore will be spent per month and ₹8,400 crore per year by the Centre in the state, the Union Minister said.



Railway Minister Ashwini Vaishnaw said, "With the Centre announcing free rice for poor, the state government's claim to provide cheap rice will end now. They (state) were giving ₹2 a kg and taking all credit of cheap rice distribution. Modi government de-

Odisha's Food Supplies and Consumer Affairs Minister Atanu S Nayak, however, said: "We do not compete with any one and seek mileage from welfare schemes. People know who is what. The state government is now providing free of cost rice worth ₹185 crore. The amount may increase."

The Naveen Patnaik government had first launched the cheap rice scheme in the state just before the 2009 general elections. Before the National Food Security Act came into existence. Patnaik government had introduced the scheme to provide 25 kg of rice to BPL families every month

Covid may impact semen quality: AIIMS study

r nfection with the SARS-CoV-2 virus may negatively impact semen quality, according to a study on 30 males conducted by researchers at the All India Institute of Medical Sciences (AIIMS), Patna.

The team led by researchers at AIIMS Patna noted that Covid-19 can lead to multiorgan damage through the angiotensin-converting enzyme-2 receptor (ACE2), abundant in testicular tissue.

ACE2 acts as the receptor for the SARS-CoV-2 spike protein, through which the virus gains entry into the host cells.

However, little information is available regarding the shedding of SARS-CoV-2 in semen - the thick, white fluid that contains sperm -and its impact on sperm forma-

tion and fertility potential. The study, published in the Cureus Journal of Medical Science,

investigated the presence of SARS-CoV-2 in the semen of Covid-19 males. The researchers also analysed the effect of the disease on semen quality and sperm DNA fragmentation index, which reflects the integrity of and the damage to the DNA, thereby detecting potential sperm damage.

Thirty Covid-19 male patients aged 19-45 registered to AIIMS Patna hospital participated in the study between October 2020 and

"We conducted a real-time reverse transcriptase test on all the semen samples. Detailed semen analysis, including the sperm DNA fragmentation index, was done at first sampling that is during Covid-19," the authors of the study said. "After 74 days of the first sam-

pling, we obtained the second sam-

pling and repeated all the tests," they

said. The study including researchers from AIIMS Managalagiri and AIIMS New Delhi, found that all semen samples collected in the first and second sampling tested with real-time reverse transcription-polymerase chain reaction (RT-PCR) were negative for SARS-CoV-2.

In the first sampling, semen volume, vitality, total motility, sperm concentration, and total sperm count were significantly lower, the researchers said. In contrast, semen agglutination or formation of sperm heaps, head defect, DNA fragmentation index, liquefaction time,

Ensure accident-free traffic, OHRC to CP

Bhubaneswar, Jan 5: While hear ing a plea on the unfortunate death of female student in road mishap, the Odisha Human Rights Commission (OHRC) Thursday issued a slew of recommendations to the state government for a smooth traffic movement in the twin city. The OHRC has also directed the state Chief Secretary to pay a financial compensation of ₹5 lakh to the relatives of the victim who died at College Square in Cuttack September 5, 2019.

The chief secretary has been asked to pay the said amount to the victim, Ananpirna Chaudhury's relatives within two months and submit Action Taken Report (ATR) by March 31, 2023. The OHRC delivered the order while hearing a plea filed by advocate Shivasankar

Expressing displeasure over the unabated rise in road fatalities, the commission said that it is the duty of the commissionerate police



to ensure 'zero road accident'. The commission has also asked the twin city police to initiate steps to make some stretches of roads in the city as honking free.

It advised the government to increase the strength of traffic police in various towns of the state, especially the twin city corresponding to the rise in vehicular population. The government has also suggested the refresher courses for traffic staff who should also be instructed to not ignore any violation of traf-

It advised the government to take the help of experts for corrective measures to address the faulty road designs in the twin city

and replace the lighting systems on place at crossings with effective advanced alternative road designs for smooth flow traffic. The commission also asked to evict shops and stalls located alongside the road or encroaching upon the roads to avoid road jams.

The government has been advised to build more bicycle paths and free encroachments on the existing ones in the twin city. It recommended the government to encourage people to use bicycles, electronic vehicles instead of four and two-wheelers for pollution free environment and eased traffic movement.

This apart, the commission recommended the government to introduce car-pooling system, sharing same vehicle for journey, in various institutions and offices and encourage the private and public servants to use the same. It advises regular periodic inspection of traffic training institutions to ensure the learners get proper training on road safety

cientists are harnessing a new way to turn cancer cells into potent, anti-cancer agents,

according to a study. According to the study, investigators have developed a new cell therapy approach to eliminate established tumours and induce longterm immunity, training the immune system so that it can prevent cancer from recurring.

In the latest work from Brigham and Women's Hospital, the team of researchers tested their dual-action, cancer-killing vaccine in an advanced mouse model of the deadly brain cancer glioblastoma, with promising results, said the study. Findings are published in the journal Science Translational Medicine.

"Our team has pursued a simple idea: to take cancer cells and transform them into cancer killers and vaccines," said corresponding author Khalid Shah, director of the Centre for Stem Cell and Translational Immunotherapy (CSTI) and the vice chair of research in the Department of Neurosurgery at the Brigham and faculty at Harvard Medical School and Harvard Stem Cell Institute (HSCI).

"Using gene engineering, we are repurposing cancer cells to develop a therapeutic that kills tumour cells and stimulates the immune system to both destroy primary tumours and prevent cancer,

said Shah Cancer vaccines are an active area of research for many labs, but the approach that Shah and his colleagues have taken is distinct, the study said.

Instead of using inactivated tumour cells, the team repurposes living tumour cells, which possess an unusual feature. Like homing pigeons returning to roost, living tu-

Dolphin population on the rise in Bhitarkanika

Rajnagar, Jan 5: Dolphin population in Bhitarkanika wetland and Gahirmatha marine sanctuary has seen an increase this year more than any other water body in the state.



Reports said that, 550 out of 733 dolphins identified in the water bodies all over the state were traced in Bhitarkanika and Gahirmatha marine sanctuary. This means that 75 per cent of the total dolphins have been identified in these two sanc-

This year 544 dolphins were spot ted under Gahirmatha range while four dolphins were identified in Kanika range and two in Rajnagar forest range. Among them, 208 Indian Ocean humpback dolphins (Sousa plumbea), 281 Indo-Pacific humpback dolphins also known as the Chinese white dolphin (Sousa chinensis), 52 bottlenose dolphins and three spinner dolphins were found during the census drive.

Last year, 726 dolphins were identified in the state in a census out of which 540 were identified in Gahirmatha and Bhitarkanika alone. In comparison to last year, dolphin population has decreased by three in the state while it is 10 more in Bhitarkanika than last vear's count.

Similarly, four Irrawaddy species of dolphins were found from Khola to Kantiakhal areas under Kanika range and two in Rajnagar range.

Two CB teams step up probe

Security guards of Sai Int'l hotel quizzed

Rayagada, Jan 5: The state Crime Branch (CB) stepped up its investigation into the mysterious death of two Russian tourists in Sai International Hotel here. Two teams of CB are on their toes collecting all possible evidences and materials from the hotel and local police



A team of CB led by DSP Tapan Das has got all data and evidences related to the deaths while another team led by DSP Saroikant Mohanta visited Sai International Hotel Thursday and quizzed two security guards. The CB officials also checked the entry register of tourists at the hotel.

 $Some\ CB\ sleuths\ carrying\ seized$ materials left for the State Forensic Science Laboratory (SFSL) in Bhubaneswar Wednesday night, while some others also visited the district police office Thursday. Notably, the CB is planning to recreate the circumstances in which the Russian lawmaker Pavel Antov died. It was said that CB is investing all possible angles of the deaths.

In its plan to recreate the circumstances that led to the death of the Russian lawmaker, the CB has contacted leading experts based

The CB sleuths are specifically planning to conduct a dummy simulation exercise of falling from the roof top in similar circumstances to recreate the scene and ascertain the situation leading to his death.

For this, a dummy of same weight and height as that of the deceased shall be created with the help of experts of anatomy department of All India Institute of Medical Sciences (AIIMS) and forensic experts. The objective is to study the fall pattern.

In this regard CB has contacted Dr Rajendra Dangi, former Director, Central Forensic Science Laboratory (CFSL), CBI and Dr Dogra of AIIMS, Delhi who are the leading experts in dummy fall simulation exercise.

They have been involved in resolving several complicated cases of CBI. They will ascertain the cause, nature and manner of the incident and the injury on Pavel's body and crosscheck with the postmortem report. This is expected to help the inquiring team of CB to come to a definite conclusion.

The CB team as well as scientific and forensic officers are still camping at Rayagada and continuing with their investigation into the death of Pavel and his friend Vladimir Bidenov which entered its sixth day, Wednesday.

DSP Das had earlier questioned the Town police IIC about the deaths after his arrival and verified the details collected earlier and matched them with the details and evidences collected by CB DSP Sarojkant Mohanta during the probe.

Notably, Russian lawmaker Pavel Antov died December 24 allegedly after a fall from the roof of the hotel in Rayagada where they were staying, two days after Bidenov was found dead in his room.

NHRC directs CS, DGP to look into fake murder case

Kendrapara, Jan 5: The National Human Rights Commission (NHRC) has directed the Chief Secretary (CS) and the Director General of Odisha Police (DGP) to look into the matter of a man being lodged in jail and facing trial in the fake murder case of his wife, a report said Thursday.

The rights body has directed the CS and the DGP to take exemplary action against the policemen responsible for his plight since the woman who was alleged to be killed by her husband is alive with her children.

The victim was identified as Abhaya Sutar, a native of Chaulia village under Patkura police limits in Kendrapara district. Abhaya has already spent seven years in jail as an under-trial prisoner for the murder of his wife Mili, a crime which he did not commit. He is currently out after being granted bail by a designated court.



The NHRC passed the order over a petition filed by rights activist and advocate Radhakanta Tripathy, December 30, last year.

In the petition, Tripathy stated that a villager Abhaya Sutar of Chaulia village under Patkura police limits of Kendrapara district was falsely implicated by the police for murdering his wife and remanded to judicial custody for the offence which he had never committed.

Police took action after Abhaya's father-in-law Prahllad Moharana of Samagola village under Kujang police limits in Jagatsinghpur district lodged a murder complaint at Patkura police station stating that his daughter was killed by her

husband over dowry, May 14, 2013. Mili went missing from home the next day after she informed her father that she is being tortured by her in-laws for dowry, February 22. Moharana in his complaint alleged that Abhava had killed his wife to have second marriage with another woman.

Police registered a case and arrested Abhaya and produced him in the court. Abhava informed police that he did not kill his wife but failed to get any relief. As a result, Abhaya had to spend seven years in jail as an under-trial prisoner.

Later, a team led by Patkura IIC Sujit Pradhan rescued Mili from Pipli in Puri district in February. 2020. Mili informed that she had eloped with her lover to Maharashtra and was staying there for seven years and recorded her statement before police that she was being tortured for dowry by Abhaya's family members.

Man dies by suicide in police custody

Jajpur, Jan 5: A 24-year-old man, who was arrested on charges of circulating photos of intimate moments of him and his former girlfriend on social media, allegedly died by suicide in police custody in Jajpur district, an official said Thursday.

The man was found hanging with an electric wire from the skylight of the Dhanmandal police outpost in Jajpur district Wednesday night, a day after his arrest. He died during treatment in a hospital in Cuttack.

Police arrested him following a complaint by a 21-year-old woman, his former lover. He was accused of circulating photos of their intimate moments on social media after they broke up. He was being interrogated in the outpost.

"He attempted suicide by hanging himself with a wire from the outpost's skylight last night. We admitted him to Barachana community health centre and later shifted him to SCB Medical College and Hospital where he died," SDPO (Jajpur Road)Sanjaya Kumar Patnaik, said.

Youth beats dad to death, buries corpse in house

Bhawanipatna: A missing man's body was found buried inside his house at Kadam village under Bhawanipatna Sadar police limits in Kalahandi district. The deceased was identified as Parama Harijan. Parama's younger son Sumant Harijan beat up him to death and later buried the body inside a dilapidated house. The matter came to the fore after family members dug up the floor and exhumed the body from the room. Thursday. A complaint was lodged by deceased's son Madan Hariian at the Bhawanipatna Sadar police station and a case was registered. The wives of the deceased and the accused were taken for interrogation. Police conducted post-mortem of the body and handed it over to the family members. Meanwhile, the accused is absconding Police said the father-son duo was having regular fights over some issue. January 1. Sumant beat up his father with a lathi to death and buried him inside a dilapidated room.

Bhubaneswar/Berhampur, Jan 5: Asia's largest brackish water lagoon Chilika lake has welcomed 10.93 lakh migratory birds this winter, 5.4 per cent more than last year, according to

A total of 11,31,929 birds were recorded in the lake this year, of which 10.93 lakh are migratory birds. This is around 57,000 more than the previous year, when 10.36 lakh avian guests had visited the lake, according to a bird census conducted Wednesday.

A total of 184 species of birds were found during the census. Apart from migratory birds, the survey spotted 38,880 local birds that reside at the lake.

In Nalabana Bird Sanctuary in the lake, enumerators found a total of 3.42.897 birds.

The winged guests from faroff places, including the Caspian Sea, Lake Baikal, remote parts of Russia, central and Southeast Asia. Ladakh and Himalavas, descend to the lake every winter for feeding and roosting. They start their homeward journey with the onset of summer.

reen hydrogen is all the rage these days. During November's United Nations Climate Change Conference (COP27) in Egypt, German Chancellor Olaf Scholz announced that Germany will invest more than €4 billion (\$4.3 billion) in developing a market for it. In the United States, President Joe Biden's administration has made "clean" hydrogen a centerpiece of its Inflation Reduction Act, which provides subsidies for renewable energies. China, too, is so invested in electrolysis that some observers already fear that it will take over the market the same way it did with photovoltaic panels. And even corporations like the Australian mining giant Fortescue are betting on it becoming a multibillion-dollar industry.

When a technology is hyped to such an extent, many environmental activists tend to become nervous. Is "clean hydrogen" merely a way to greenwash so-called "blue" and "pink" hydrogen, generated from natural gas and nuclear energy, respectively? Is it an attempt to produce a magic technofix that vindicates absurd excesses like space tourism and hypersonic flight, when the world's middle and upper classes should be shrinking their energy and resource consumption? Or is this the next stage of extractivism, appropriating low-income populations' land and water under the guise of fighting climate change?

The short answer to all these questions is yes. But that is neither inevitable nor the whole story. Yes, the green hydrogen dream could well develop into a nightmare if we do not get it right. Still, it is an indispensable building block of the global economy's transition from climate-destroying fossil fuels to sustainable models based on 100 per cent renewable energies. It may be difficult to accept this ambiguity, but the urgent need to avert a climate catastrophe requires no less.

Given hydrogen's many potential applications, some leading experts estimate that it could power 20-30 per cent of global energy consumption by mid-century. But that does not necessarily make it the most efficient choice. Electric batteries, for example, require far fewer renewable kilowatt hours per kilometre travelled to power cars and trucks than hydrogen fuel cells or e-fuels do. Similarly, using heat pumps is more efficient than converting gas boilers to hydrogen. Organic alternatives to nitrogen fertilizer should also be given much more consideration

But there are several critical sectors with few economically viable zero-carbon alter-

natives to green hydrogen and its derivatives, including long-distance shipping and aviation, chemicals, and steelmaking. Notwithstanding the hype, many industries will clearly need vast amounts of clean hydrogen to achieve net-zero emissions by 2050. To illustrate the scale of the challenge, Bloomberg New Energy Finance founder Michael Liebreich recently estimated that just replacing today's "dirty" hydrogen - produced from fossil fuels - would require 143 per cent of the wind and solar energy the world currently has.

Several countries in the Global South have been blessed with world-class solar and wind potential, enabling them to produce green hydrogen at very low cost. Some, like Namibia, have built their industrial development strategy around this competitive advantage. But how could international trade in green hydrogen and its derivatives become a pathway to prosperity? And how can developing countries avoid the green extractivism trap and ensure that trade is fair and sustainable?

A series of consultations and studies in Chile, Argentina, Brazil, Colombia, South Africa, Morocco, and Tunisia have explored these questions at length. A new report by the Heinrich Böll Foundation and Bread for the World synthesises their findings and highlights the need to do no harm. To prevent the green hydrogen dream from becoming a nightmare, we must develop the sector with territorial planning, and clear standards and policies, as well as uphold local communities' right to prior informed consent. To deliver on the promise of post-fossil development and foster sustainable economies, governments must devise ambitious and realistic industrial strategies. And these strategies must be embedded in a systemic approach to sustainable development and the energy transition. Moreover, we need to consider how hydrogen is used - not just who can pay for it.

None of this will happen by itself. Achieving a sustainable future is a political choice that requires leadership and cooperation. Several countries could help make fair and sustainable trade in green hydrogen a reality. Namibia, Chile, Colombia, and now (under President Luiz Inácio Lula da Silva) Brazil, for example, have the right political conditions for balancing green-hydrogen production with strong environmental and social standards. Over time, Argentina and South Africa could join this list and become producer countries.

As a prospective major importer and consumer of green hydrogen. Germany would need to form partnerships with producing countries, based on strong environmental and social standards. And given its progressive government, it can be expected to engage with its long-term partners not just as resource providers, but as fellow travellers on the journey toward sustainable. inclusive prosperity.

To that end, Germany and other energy importers must also support exporting countries in their efforts to localise value creation. In this way, the emerging international trade in green hydrogen could become a harbinger of a new, equitable trading relationship between the Global North and South. That is a future worth fighting for, and renewable energy holds the key.

■ Erumpent

Stifle your delight, Harry Potter fans. We're not discussing that elephant-like beast, whose over-sensitive horn exploded in Harry Potter and the Deathly Hallows. It's a good name for the animal, though, with its hints of "erupt" and "trumpet", and its true meaning, of something bursting forth, might describe an explosion. A few writers have borrowed the word to salt their prose: "The musicians added to the erumpent revelry with a sprightly semi-martial tune", wrote Alan Dean Foster in Icescape. Better was the almost poetic "Snowdrops are erumpent in the dreary winter landscape", which the gardener Lia Leendertz wrote in The Guardian, because it locates the word nearer to its true home. Botanists, biologists and mycologists, the only people who employ it at all regularly, commonly bury it in the undergrowth of dense technical descriptions: "Pseudothecia mainly epiphyllous, in dense clusters, immersed but becoming erumpent". It has most often been used to refer to the fruiting bodies of fungi, which in their season are notably erumpent. It's from the Latin verb rumpere, to break out. That's the source of several much more common English adjectives and verbs that end in -rupt, notably abrupt, erupt and interrupt, as well as the outstandingly rare rumpent — the Oxford English Dictionary defines this last word as an application for breaking a swelling, but it has only one example of it and doesn't explain further.

HOPE ON A DIFFICULT ROAD

THE IDEA OF **GROWTH FUELLED BY GLOBALISATION HAS BEEN VERY REAL AND MANY COUNTRIES HAVE BENEFITED**

ndia has taken over leadership of the G-20 and has said it wants to lead with a presidency of "healing, harmony and hope." with the theme of "One Earth, One Family, One Future.' This reflects the very Indian idea of "Vasudhaiva Kutumbakam' and the celebration of all life and the interconnectedness of the wider universe. The G20, or Group of Twenty, comprises as many as 20 major developed and developing economies, so this is described as "the premier forum for international economic cooperation." Clearly, economics will be at the heart of this cooperation and in that sense the Indian theme would also be seen within the meaning of economic prosperity - that the world should prosper together as part of one global community. This is a fine idea but it comes at a difficult time. It is quite obviously fraught with many challenges that must be overcome in order to become workable. India holds the Presidency of the G20 from December 1, 2022, to November 30, 2023. This includes a major event where 43 heads of delegations, the biggest so far in the G-20, will be participating in the New Delhi summit this September, So, time is short and ambition is high.

This ambition comes at a time of heightened geopolitical volatility, a very real VUCA (volatility, uncertainty, complexity and ambiguity) world that is showing signs of increasing volcanic activity, if that term can be used. Consider the rise of right-wing politics (the latest woes of Republicans in the US, where deciding a House speaker takes multiple votes because the hardliners within the party want to extract their price), economic nationalism, the attempt to shut borders rather than open them more freely, the Russian invasion of Ukraine and consequent economic turmoil, rising inflation worldwide, the continued toll of COVID-19 and new variants of the virus, particularly in China and that country's refusal to be transparent with information - all point to the world in a state that does not look like a peaceful and set of families, let alone "one family."



To move forward, it is necessary to prioritise cooperation and dialogue between nations and to work towards ending geopolitical conflicts. It is also important to address issues of inequality and deprivation. Protecting the environment and addressing climate change are also crucial for the long-term well-being of the planet

In that sense, India has a difficult task of leadership at hand. But this is also the time that can bring out the best, with the right leadership marked by a sense of purpose and the understanding that everyone suffers if the strains continue or escalate

In order to meet these challenges, it may help to revisit the factors that contributed to the period of "great moderation" from the mid-1980s to 2007, when the global economy was growing and many were lifted out of poverty. These included broader geopolitical peace, conciliatory political leadership, low inflation, deepening globalisation and free movement of capital. David Ricardo's theory of "comparative advantage" which made the case for opening up global trade was at play along with a universal sharp focus on economic growth.

Unfortunately, all the building blocks seem to have crumbled and inequality and economic misery

tectionism" hasn't been a sudden development. It has been slow cooking for more than two decades. It was more than two decades ago that an academic paper picked up early warning signs as it noted: "public anxiety about globalisation and free trade is rising ... Yet, the idea of growth fuelled by globalisation has been very

real and many countries have benefited. That memory is only too recent to be forgotten.

The total factor productivity (TFC) growth in the first world was substantially contributed by the increase in labour force - new births, migration, and greater participation of women, and technology upgradation. Currently, population is declining, migration is prevented and women's participation has nearly peaked. COVID-19 has shaped up reluctance to work. Technology improvements are contributing, albeit marginally.

The developing economies were beneficiaries of outsourcing, flow of abundant capital and sharing of technological developments. The planetary economy was the beneficiary of broader global geopolitical peace, low inflation, low interest rates and low costs of labour, energy, metals and minerals.

Now, with economic growth threatened, the customary dialogue and discussions are bound to be infructuous. When the world at large is facing a near similar situation, it is time to sink the idea of a First World and a Third World. In this context, "One Earth, One Family, One Future" becomes very relevant. Therefore, the underpinning of narratives in all the meetings will have to be that all are sailing in the same boat and will benefit equally from cooperation toward reorienting and even rewriting the rules of the game.

To move forward, it is neces sary to prioritise cooperation and dialogue between nations and to work towards ending geopolitical conflicts. It is also important to address issues of inequality and deprivation. Protecting the environment and addressing climate change are also crucial for the long-term well-being of the planet.

Ultimately the goal is ambitious and will require the effort and cooperation of all nations and people to achieve. The question to ask is: Is that possible?

Jain threatens jail officials

New Delhi: Tihar Jail officials Thursday claimed that jailed minister Satyendar Jain has been abusing them and threatening them with dire consequences once he gets out of prison. Assistant Superintendent Jaidev and Deputy Superintendent Parveen Kumar, Tihar Jail, had complained against Satyendar Jain in an 'incident report' on December 8, 2022, that when they went to serve a Show Cause Notice to Jain as per rule 1272 of DPR, 2018, he threatened them. Jain has been blatantly intimidating these officers and others for their acts trying to prevent him from availing facilities of massage, lavish food and other VIP treatments, that came to the fore recently, said a jail official Thursday.

2 killed in accident

Noida: A container hit four people travelling on one bike on the Greater Noida Expressway, which resulted in two deaths. The other two were injured. The injured have been admitted to Sharda hospital for treatment. Additional DCP Ashutosh Dwiwedi said the four victims were returning to their rented house in Baraula, when the container coming from Lucknow hit their bike from behind. Due to the impact, two victims identified as Bhavna and Shobhit died on the spot, and the bike was flung far away.



New Delhi, Jan 5: Foreign universities will be able to set up their campuses in India for the first time with the UGC Thursday unveiling draft norms, under which these varsities can also decide on the admission process, fee structure and repatriate its funds back home.

Noting that foreign universities with campuses in the country can only offer full-time programmes in offline mode and not online or distance learning, UGC chairper-

eign universities and Higher Education Institutions (HEIs) will need a nod from the UGC to set up their campuses in India

The initial approval will be for 10 years and will be renewed in the ninth year subject to the meeting of certain conditions, he added and clarified that these institutions shall not offer any such study programme which jeopardises the national interest of India or the standards of higher education here. The University Grants



draft regulations for 'Setting up and Operation of Campuses of Foreign Higher Educational Institutions in India' and the final of the month after considering feedback from all stakeholders.

While these universities will have the freedom to decide their admission criteria and fee structure, the commission has advised keeping the fees "reasonable and transparent".

"The new National Education Policy (NEP), 2020 has envisioned that top universities in the world will be facilitated to operate in India. For this, a legislative framework facilitating such entry will be put in place, and such universi-

ties will be given special dispensation regarding regulatory, governance, and content norms on par with other autonomous institutions of India," Kumar said. On matters related to funds and funding, he said that the cross-border movement of funds will be according to the Foreign Exchange Management Act. There will be two categories of foreign institutions eligible to apply for setting up their campuses in India-the universities that have secured a position within

the top 500 of overall or subject

wise global ranking or a reputed institution in its home jurisdiction.

The foreign institution shall have the autonomy to recruit faculty and staff from India and abroad as per its recruitment norms.

According to a survey by the National Institute of Education Planning and Administration (NIEPA), eight foreign universities have expressed interest in setting up their international campuses in India. Five of these are US universities and one each from the UK. Australia and Canada.

New Delhi, Jan 5: Ten days after the shocking November 26 incident on a New York-Delhi Air India flight, another episode of a drunk male passenger allegedly urinating on a female passenger's blanket was reported on the Paris-Delhi sector but there was no penal action after he gave a written apology, officials said on Thursday.

This incident happened December 6 on Air India flight 142 and the pilot of the aircraft reported the matter to the Air Traffic Control (ATC) at the Indira Gandhi International (IGI) Airport about it, following which the male passenger was apprehended. It is not known which class the passengers were travelling in.

The flight landed around 9:40 AM $\,$ at Delhi and the airport security was informed that the male passenger was "under the influence of alcohol and he was not following the instructions of the cabin crew and he later peed on a blanket of an onboard lady passenger", airport officials told PTI. The male passenger was apprehended by the Central Industrial Security Force (CISF) as soon as he deboarded the plane but was later allowed to leave after the two passengers had a "mutual compromise" and the accused tendered a "written apology", they said.

The lady passenger, who had initially made a written complaint, refused to file a police case and hence the passenger was allowed to go by the airport security after

DGCA show cause notice to Air India

Mumbai: Holding that Air India's conduct appeared to be "unprofessional", aviation regulator DGCA Thursday issued notices to the officials and crew of the New York-Delhi flight, asking why action should not be taken against them for "dereliction" of duty while handling the November 26 'urination' incident. The Tata Group-owned airline Wednesday had said it has imposed a 30-day travel ban on the man and instituted an internal probe to find if there were lapses in handling the situation by the crew. The accused Shankar Mishra is the vice-president of the India Chapter of an American multinational financial services company headquartered in California. The Delhi Police sent multiple teams to nab the man. but he was absconding, officials said Thursday.

He claimed that documents show Parasnath as `Marang Buru' or hill deity of Santhals. "Each year we assemble on full moon in Baishakh for a religious hunt for three days..." the tribal leader said. Murmu claimed that the patron of the Council is President Droupadi Murmu herself and the President is P Manjhi, former MP from Assam.

Another tribal body Adivasi Sengel Abhiyan (ASA) too chipped in to allege that Jains have illegally grabbed the highest place of worship of the Santhals.

North India reels under cold wave

New Delhi, Jan 5: Several parts of north India reeled under severe cold and dense fog affected railway movement, with Delhi recording a minimum temperature of three degrees Celsius -- the lowest in January in two years -- making it cooler than several hill stations.

Most people kept indoors and turned to space heaters and cups of hot beverages to keep themselves warm as frosty winds from the snow-clad Himalayas barrelled through the plains, including the national capital.

The Meteorological (MeT) Department had on Wednesday issued an orange alert for Delhi-NCR for Thursday and Friday.

Much on expected lines, Delhi's minimum temperature was lower than Dalhousie (4.9 degrees Celsius), Dharamshala (5.2 degrees Celsius), Kangra (3.2 degrees Celsius), Shimla (3.7 degrees Celsius), Dehradun (4.6 degrees Celsius), Mussoorie (4.4 degrees Celsius) and Nainital (6.2 degrees Celsius), according to official data.

No criminality found against Zubair: Police

New Delhi, Jan 5: The Delhi Police told the high court Thursday that it has not found any criminality against fact-checking website Alt News co-founder Mohammad Zubair in a case lodged against him for allegedly threatening and torturing a minor on social media.

Taking note of the submissions of the city police, the court asked the probe agency to place the chargesheet filed in the case before it. "Before proceeding further, let a copy of the chargesheet be filed before the next date of hearing," Justice Anup Jairam

Bhambhani said.

The counsel for the Delhi Police informed the court that the probe agency has found no criminality against Zubair and his name has not been included in the chargesheet. The court also asked police to give a copy of the chargesheet to Additional Solicitor General K M Natraj, who is representing complainant National Commission for Protection of Child Rights (NCPCR) in the matter.

The law officer said he would take further instructions, after which the court listed the matter for the next hearing March 2.

On the basis of a complaint from the NCPCR, the Delhi Police lodged an FIR against Zubair August 9, 2020 under the provisions of the Information Technology Act for allegedly threatening and torturing a girl on Twitter. The NCPCR complaint referred to a photo of the girl and her father shared by Zubair on Twitter during an online spat with the man. The journalist has approached the court seeking quashing of the FIR against him.



Therefore, the state government rejected the petition seeking a premature release of the petitioners. The convicts then approached the Bombay High Court, challenging the state's decision not to consider their case for a premature release.

The apex court said the submission on behalf of the petitioners relying upon section 55 of the Prisons Act, 1894 that even on parole, prisoners shall be deemed to be in custody and therefore, the said period is to be included for the purpose of actual imprisonment had no substance.

The top court stayed the high court's direction for eviction of families within a week and that their houses be demolished. It observed that a large number of people cannot be uprooted by using force without examining their occupancy rights, and emphasised that alternate arrangements would have to be made before uprooting people.

The petitioners claimed they are poor people who have been lawful residents of Mohalla Nai Basti and Line No 17 & 18, Banbhulpura (Azad Nagar), Haldwani for more than 70 years.

The top court issued notice to the Uttarakhand government and the railways on a batch of petitions filed against the judgment passed

by a division bench of the high court December 20, 2022.

During the hearing, the top court asked the railways to find a practical solution to the issue and stressed that many of the occupants have been residing there for decades, claiming rights on the basis of leases and auction pur-

> The bench said, "There are two aspects of the issue. One, they claim leases. Two, they say people migrated after 1947 and the lands were auctioned."

Justice Kaul said that there are establishments on the land in question and questioned, "how can you say in seven days clear them off?"

Justice Oka noted that the peo ple have been staying there for 50 years. He further added: "How do you deal with the scenario of people who have purchased the land in auction. You may acquire the land and utilise..." Additional Solicitor General Aishwarya Bhat, representing the Railways, submitted that the land belongs to the Railways and several orders for eviction have been passed under the Public Premises Act. Advocate Prashant Bhushan, representing some of the petitioners, submitted that they were ex-parte orders passed during the Covid period. Bhati contended that the petitioners claim the land as their own and that they have not sought rehabilitation

Kolkata, Jan 5: Ahead of the panchayat elections due this year, the West Bengal government has decided to introduce chicken and seasonal fruits in mid-day meals for a four month period from January.

In addition to the existing midday meal menu of rice, potato, soybean and eggs, chicken and seasonal fruits will be served weekly once for additional nutrition under PM POSHAN, according to a notification. An amount of ₹371 crore has been sanctioned for the extra nutrition scheme.

A school department official, who confirmed that the extra nutrition scheme was being rolled out, added that as yet no decision has been taken on whether it would be continued after April. Students are currently given rice, pulses, vegetables, soybean and eggs in schools as part of mid-day meals.

An amount of ₹20 will be spent per week on providing additional



nutrition to every student, and the process will continue for 16 weeks. according to the January 3 notifi-

cation, a copy of which is available with the PTI. Over 1.16 crore students in state-run and aided

schools are beneficiaries of the mid-day meal scheme, for which the state and Centre share the cost on a 60:40 ratio The additional allocation of 371

crore, however, was made entirely by the state. He said the additional items will be served with immediate effect in every block on different days of the week.

The move, however, triggered a political row, with the BJP questioning why such a decision was taken ahead of the panchayat elections due this year and Lok Sabha polls in 2024, while the Trinamool Congress accused the Opposition of "smelling politics in everything".

The decision to serve chicken to school children ahead of elections raises questions about the change of heart of the TMC government. Why were poor children deprived

of these items and only given rice and lentils till recently? The decision smacks of a political motive to secure votes as panchayat polls are around the corner," BJP leader Rahul Sinha said.

TMC's Rajya Sabha MP Santanu Sen said party supremo and West Bengal Chief Minister Mamata Banerjee always stands by the side of the common people, and this decision "reaffirms that fact".

"Trinamool Congress is a peoplecentric party, unlike the BJP which wants to do politics on every issue. During the COVID pandemic and lockdown, our state ensured that children were not deprived of midday meals and distributed rice, pulses, potato, soybean regularly from school buildings. Despite difficulties, we did not shut down mid-day meals," he added.

Beijing/Shanghai, Jan 5: China defended Thursday its handling of its raging COVID-19 outbreak after US President Joe Biden voiced concern and the World Health Organisation (WHO) said Beijing was under-reporting virus deaths.

China scrapped its stringent COVID controls last month after protests against them, abandoning a policy that had shielded its 1.4 billion population from the virus for three years.

China's foreign ministry spokesperson Mao Ning told a regular media briefing in Beijing that China had transparently and quickly shared COVID data with the WHO and said China's "epidemic situation is controllable".

"Facts have proved that China has always, in accordance with the principles of legality, timeliness, openness and transparency, maintained close communication and shared relevant information and data with the WHO in a timely manner." Mao said.

London, Jan 5: Britain had its warmest year on record in 2022, official figures showed Thursday, the latest evidence that climate change is transforming Europe's weather.

The Met Office weather agency said the provisional annual average temperature in the U.K. Was 10.03 degrees Celsius (50 Fahrenheit), the highest since comparable records began in 1884. The previous record was 9.88 Celsius (49.8 Fahrenheit) set in 2014

Met Office scientists said human activity - primarily fossil fuel emissions - has made such warm conditions vastly more likely."The results showed that recording 10C in a natural climate would occur around once every 500 years, whereas in our current climate it could be as frequently as once every three to four years," said Met Office climate attribution scientist Nikos Christidis.

making it the hottest year since weather readings began in 1900. In Spain, preliminary data from the end of December indicated that 2022 was the hottest year since

records started in 1961. Norway's Svalbard islands in the Arctic had their warmest summer in more than a century of record-keeping. The archipelago's average temperature for June, July and August was 7.4 Celsius (45.3 Fahrenheit), the Norwegian Meteorological Institute said.



he Suvarna Vidhana Soudha in Belagavi, which has been hosting the Winter Session of the Karnataka Assembly since 2012, was primarily meant to assert the rights of the state over the disputed border region.

phant. The name of the building, incidentally, commemorates the golden jubilee of state's formation. The late former President Pranab Mukharjee inaugurated the Suvarna Soudha on October 11, 2011. The construction had started in 2007. Then BJP-JD(S) coalition

Amazon, Salesforce jettison jobs in latest techie purge

A slew of firms hit by geopolitical downturn have reduced their workforce exponentially after hiring aggressively during the pandemic

Washington, Jan 5: E-commerce giant Amazon and business software maker Salesforce are the latest US technology companies to announce major job cuts as they prune payrolls that rapidly expanded during the pandemic lockdown.

Amazon said Wednesday that it will be cutting about 18,000 positions. It's the largest set of layoffs in the Seattle-based company's history, although just a fraction of its 1.5 million global workforce.

Amazon CEO Andy Jassy said the layoffs will mostly impact the

company's brick-and-mortar stores, which include Amazon Fresh and Amazon Go, and its PXT organizations, which handle human resources and other functions.

In November, Jassy told staff that layoffs were coming due to the economic landscape and the company's rapid hiring in the last several years. Wednesday's announcement included earlier job cuts that had not been numbered. The company had also offered voluntary buyouts and has been cutting costs in other areas of its sprawling business.

Salesforce, meanwhile, said it

is laying off about 8,000 employees or 10% of its workforce.

The cuts announced Wednesday are by far the largest in the 23-year history of a San Francisco company founded by former Oracle executive Marc Benioff. Benioff pioneered the method of leasing software services to internet-connected devices - a concept now known as "cloud computing."

Salesforce workers who lose their jobs will receive nearly five months of pay, health insurance, career resources, and other benefits, according to the company. Amazon said it is also offering a separation payment, transitional health insurance benefits, and job placement support.

Meta Platforms CEO Mark Zuckerberg also acknowledged he misread the revenue gains that the owner of Facebook and Instagram was reaping during the pandemic when he announced in November that his company would by laying off 11,000 employees, or 13% of its workforce.

Dec air passenger traffic surges 15%

Mumbai, Jan 5: Domestic air passenger traffic grew 15 per cent year-on-year to around 129 lakh in December 2022 but remained 1 per cent lower than the pre-pandemic level (December 2019), rating agency Icra said Thursday.

Icra has also maintained a 'Negative' outlook on the Indian aviation industry.

In the April-December period of the current fiscal, domestic passenger traffic is estimated at around 986 lakh, registering around 63 per cent year-on-year growth and lower by approximately 9 per cent compared to April-December 2019 (pre-Covid levels), it said.



At the same time, the airlines deployed slightly higher capacity (less than 1 per cent) in the previous month over the year-ago period, the rating agency said, adding that it, however, was lower by around 7 per cent than the pre-Covid levels.

According to Icra, the domestic aviation industry operated at an estimated passenger load factor of around 91 per cent in December 2022 against approximately 80 per cent in December 2021 and about 88 per cent in December 2019.

The agency said it expects a fastpaced recovery in domestic passenger traffic in FY2023, aided by normalcy in operations. However, the earnings recovery for domestic airlines is likely to be decelerated due to sharp escalations in aviation turbine fuel (ATF) prices and depreciation of the rupee against the US Dollar in the back-

drop of increased competition.

While a meaningful improvement in passenger traffic is expected in FY2023, the pace of recovery in the industry earnings will be sluggish, and the industry is expected to incur a net loss of around ₹150-170 billion owing to elevated costs, the report said.

'India's growth to dip to 5.5% in '24 from 6.8% in 2023'

Mumbai, Jan 5: India's economy is expected to grow 5.5% in the next financial year, a notch below the expected potential rate of 6%, as growth momentum in the country was slowing gradually, an economist at HSBC said Thursday.

The Indian economy grew 8.7% in year ended March 2022, and is expected to grow by 6.8% in the current financial year.

A Reserve Bank of India survey of professional forecasters released in December had pegged growth at 6% in 2023/24.

'While both exports and imports have slowed over the last few months, the former has slowed more sharply than the latter, indicating a sharper fall in the global growth momentum," Pranjul Bhandari, chief India and Indonesia economist at HSBC Securities and Capital Markets (India) said in a note to clients.

Economists at the brokerage expect domestic demand to remain stronger as compared to global demand, the note said, adding that demand for goods - higher than services demand during the pandemic has fallen in recent months.

"Urban demand has far outstripped rural demand over 2022, but is also moderating since mid-2022, led primarily by goods," the note added.

AXAR, SURYA KNOCKS IN VAIN

Pune, Jan 5: Suryakumar Yadav (51, 36b, 3x4, 3x6) and Axar Patel (65. 31b, 3x4, 6x6) struck blistering fifties in a stunning 91-run stand albeit in a losing cause as Sri Lanka tightened the screws in the nick of time to beat India by 16 runs in the second T20I and level the three match series 1-1 here Thursday. Skipper Dasun Shanaka made

a rear-guard unbeaten 56 (22b, 2x4, 6x6), while wicketkeeper Kusal Mendis hit a 31-ball 52 (3x4, 4x6) to power Sri Lanka to an imposing 206/6.

India had a nightmarish start to their chase slumping to 57/5 before Axar and Surya raised hopes of an improbable win with a scintillating sixth-wicket stand. The task became tough once Surya departed in the 16th over, but Axar and Shivam Mavi (26, 15b, 2x4, 2x6) shared quick 41 runs to bring down the equation to 21 off the last over.

But Axar's dismissal in the third ball of the final over was the last nail in the coffin for India. Chasing the total, India lost openers Ishan Kishan and Shubman Gill in the second over to Kasun Rajitha (2/22).

If that was not enough debutant Rahul Tripathi sneaked one to Mendis off Dilshan Madushanka (2/45) in the next over before skipper Hardik Pandya (12) departed an over later as India slumped to 34/4 in 4.4 overs.

Surya and Deepak Hooda (9) tried to stabilise the innings with a hard-fought 23-run partnership but with the asking rate creeping up, the latter departed in search of a big shot, caught by Dhananjaya de Silva off Wanindu Hasaranga as India lost half of their side for 57.

Surya and Axar tried to up the ante with a sensational 91-run sixthwicket partnership off just 40 balls to keep India afloat after a forget-



table start. The duo raised hopes of a famous victory but it was not to be as the visitors pulled the strings just in time to level the series.

Earlier, it was a disastrous performance from the Indian bowlers after electing to field as the Lankan batters went hammer and tongs from the onset. Barring Axar (2/24), all other Indian bowlers went for runs.

Even though speedster Umar Malik (3/48) picked up three wickets, he too was taken to the cleaners. while last match's hero Mayi (0/53) looked a pale shadow of himself.

Arshdeep Singh conceded 19 runs of the second over, which included two back-to-back no balls that yielded 17 runs. Hardik too went for 11 runs from his second over as Mendis top-edged one over deep third man. Mavi was also taken to the cleaners by Mendis in his opening over, which yielded 15 runs.

Spin duo of Axar and Yuzvendra Chahal (1/30) gave respite for two overs before Pathum Nisanka (33) struck a four and then a mammoth six over deep midwicket. India's first breakthrough came in the ninth over when Chahal had Mendis LBW after Hardik went for a successful review.

Sri Lanka suffered their second blow in the first delivery of the next over when Malik beat Bhanuka Rajapaksa by pace to clean his stumps. Despite losing two wickets, Sri Lanka reached a healthy score of 89 at the half-way mark.

But Axar tasted success soon when he dismissed Nissanka, caught by Tripathi. He snared his second victim of the day in his next over when De Silva was caught by Hooda at long on. Charith Asalanka (37) looked in ominous mood before Malik got rid of him. Malik knocked off the timbers off Hasaranga with a pacy delivery a ball later. Then it was all Shanaka till the end.

Green rubbishes rumours about his IPL unavailability

Sydney, Jan 5: Young Australian all-rounder Cameron Green is puzzled by rumours that he will not be able to bowl in the early part of the Indian Premier League (IPL) this year, saying he will be "100 percent available" to bat and bowl for Mumbai Indians.

Reports have circulated that Green, who suffered a broken finger after being hit by an Anrich Nortje bouncer during the second Test against South Africa, can only bowl in IPL 2023 after

But the 23-year-old, bought by the most successful IPL franchise for Rs 17.50 crore - the secondmost costliest player in the history of IPL auction - rubbished the rumours Thursday, saying he doesn't know how and where the news originated.

"No, that's not correct," Green was quoted as saying by SEN. "I've heard about this for quite a while now, I think. I don't know where it's come from. I've heard that I'm 100 per cent available for both skill sets in the IPL at the start, so yeah, I'm not too sure where that's kind of come from,' added Green.

Green and pace bowler Mitchell Starc are both missing the third and final Test against South Africa, currently underway at the Sydney Cricket Ground, due to finger in-

The all-rounder, after retiring on day two of the Boxing Day Test following the injury, returned the next day to complete his half-cen-

tury. Australia won the second Test to take a 2-0 lead in the three-Test series.

Doctors have recommended surgery for Green and he is expected to be fit in time for the opening Test of the Border-Gavaskar Trophy, scheduled to begin on February 9. Green said he has set his sights on the opening Test in India.

"Obviously my first priority is the Test series that's beforehand (before the IPL)," Green added. "I think me and Starcy (Starc) are maybe touch and go for that first one (Test) but obviously we'll give ourselves the best chance."

Green said money earned during the IPL auction in Kochi recently will not be a distraction for him when it comes to playing his natural game.

"Yeah obviously it (auction) turned out really well but I think at the same time you want to go out there and perform and kind of re-pay the faith they showed you,'

"I think just having the right people around you I think keeps you pretty humble in a way. You've got the right people to drag you down if you get too ahead of yourself, but also the right people to bring you back up when you're going not as great as you like.

"I think that's kind of cricket. It's a game of failures, you're going to fail more than you succeed. As long as you have the right people around you to kind of bring you back up is probably key,"
