Dhabaleswar temple reopens for public

Cuttack: The famous Dhabaleswar Temple at Athagarh in Cuttack district reopened for devotees Wednesday ahead of schedule. The temple had been closed November 1 last year to carry out repair of the hanging bridge over the Mahanadi river through which devotees could reach the temple. A temporary bridge has been constructed over the Mahanadi for devotees and tourists to facilitate their passage to the temple. The administration had planned to oper the temple on Makar Sankranti. However, with the construction of the temporary bridge, it was decided to throw open the door for the devotees before the auspicious day. The hanging bridge had earlier been closed in the aftermath of the Morbi disaster in Guiarat.

2 newborn lion cubs die in Nandankanan

Bhubaneswar: There was jubilation at the Nandankanan Zoological Park (NZP) here Tuesday after lioness 'Rewa' gave birth to four cubs Tuesday. However, the joy turned into grief as two of the cubs died Wednesday. The remaining cubs have been now been kept inside incubation chambers and their health is being constantly monitored. Officials said that since Rewa had become feeble after giving birth she was unable to attend to her cubs. As a result, the newborns had been shifted to a veterinary shelter. "The condition of Rewa is being constantly monitored also," Nandankanan deputy director Sanjit Kumar said Wednesday.





Cabinet rejig expected soon

New Delhi, Jan 11: As the BJP is set for its national executive meeting and prepares for the upcoming Assembly polls, the possibility of a reshuffle in the Union Cabinet this month has gained ground with the performance of ministers and the ruling party's political imperatives likely to drive changes.

Prime Minister Narendra Modi has rejigged his team only once, in July 2021, during his second term, unlike in his first stint, when he reshuffled and expanded his council three times.

Though there has been no official word, sources said Wednesday the changes may occur anytime this month before the start of the Budget Session of the Parliament January 31. The BJP's executive meeting is slated for January 16-17.

There is a view that the party's standout win in the Gujarat Assembly polls and the lessons drawn from the losses in the Himachal Pradesh Assembly and the Delhi municipal elections may play a factor in ministerial changes, besides its political needs in poll-bound states like Karnataka, Rajasthan and Chhattisgarh.

Sources also said that this reshuffle is likely to be the last as the Lok Sabha polls are only 15 months away. The changes in the Cabinet will also be made keeping in mind the BJP's goals in Bihar, Bengal and Telangana.

There are indications that the Eknath Shinde faction of the Shiv Sena may get a representation in the new Cabinet while Chirag Paswan may also be rewarded.

The changes in Modi's council of ministers have always been marked by shock exits and surprise entries, and have also hit headlines for the changes in portfolios of incumbents.

Last time, Prakash Javadekar_ and Ravi Shankar Prasad were dropped from the Cabinet while former IAS officer Ashwini Vaishnaw was inducted and given key ministries like Railways and IT.

Docs to cease work in state from Feb 1

GOVERNMENT'S APATHY IN IMPLEMENTING 'DACP' MAIN REASON FOR CALLING STRIKE

Bhubaneswar, Jan 11: Doctors in Odisha have threatened to cease work from February 1 as a mark of protest against the state government's failure to implement dynamic assured career progression (DACP) for them. The doctors belonging to the Odisha Medical Services Association (OMSA), a body of government doctors, said that they would not participate in executing national programmes till their demands are met from February 1.

"We have had several discussions with on this issue with the state government. However, till now steps have not been taken to address our grievances. It seems that the government is not interested in fulfilling our demands. It has forced us to take such a

decision." said a doctor Wednesday. "We know that this decision will cause immense problems to the peo-

ple. We had decided to go on strike January onwards, but postponed it keeping in mind the prestige of the state during the ongoing hockey World Cup," he added.

Addressing mediapersons here, the doctors said that a 'financially backward' state like Bihar has implemented DACP, but it has not been done in Odisha. The Odisha government has given only 10 grade pay in the last 20 years which is disappointing, the doctors alleged.

The doctors said that the Odisha government is proactive when it comes to construction of medical colleges. But that is not the case with the demands made by doctors. The government is yet to take a proper decision regarding the contractual appointment of doctors, they said. "It has left us with no choice, but to go for complete cease work. We are just hoping that the government will notice our plightand do something fruitful," the doctors said.

Optimistic teens may lead to better health in adulthood

eenagers with the feeling of optimism, happiness, self-L esteem, belongingness and love, were more likely to reach their 20s and 30s in good cardiometabolic health compared to teens with fewer of these positive psychological assets, a new study has shown. According to the study published

in the Journal of the American Heart Association, fostering positive psychological assets in teenagers may help prevent cardiometabolic disease in adulthood and may also play a role in addressing health inequities.

The study mentioned that the way teens -- especially Black youth -- feel about their lives may impact their cardiometabolic health risk

"We learned a lot in the last few decades about the impact of discrimination and other social risks youth of colour face that may explain their elevated rates of cardiometabolic disease, however, much less attention is paid to the inherent strengths they possess and the ways those strengths may be leveraged to advance health equity," said lead study author Farah Qureshi, ScD, MHS, an assistant professor at the US-based Johns Hopkins Bloomberg School of Public Health.

Researchers identified five mental health assets associated with better cardiometabolic health outcomes based on survey responses when participants were teenagers: optimism, happiness, self-esteem, belonging, and feeling loved.

The study found that about 55 per cent of youth had zero to one positive mental health asset, while 29 per cent had two to three assets and

16 per cent had four to five assets. As young adults, only 12 per cent of participants maintained cardiometabolic health over time, and



white youth were more likely to maintain good health later in life compared to Black or Latino youth. Teens with four to five positive

mental health assets were 69 per cent more likely to maintain positive cardiometabolic health as young adults.

While psychological assets were beneficial to all racial and ethnic groups, Black youth experienced the greatest health benefits, according to the study.

Black teens also reported having more positive mental health assets than the youth of any other racial or ethnic group.

Despite having the most assets and reaping the most health benefits from them, there were still racial disparities in cardiometabolic health in adulthood. Black individuals were the least likely to maintain good cardiometabolic health over time, said the study.

"This work suggests that early investments in youth mental health may be a critical new frontier in the advancement of cardiometabolic health equity," Qureshi said.

RURAL FOREST AT RISK FROM INDUSTRIAL POLLUTION

Forest dept to write to SPCB

■ Black smoke and fly-ash discharged by a steel plant have threatened the forest's flora and are gradually denuding the area of its green cover

Sambalpur, Jan 11: A newly raised rural forest near Potapali village under Town forest range in Sambalpur forest division is slowly inching towards total destruction due to rampant discharge of fly-ash and smoke by a steel firm in the vicinity.

The Forest department has created the rural jungle in a year through plantation of over 10,000 saplings in Japanese Miyawaki method on one hectare of land on Landa hill. The plantation work



had been started from August 2021. The forest is home to over 70 types of trees and has been raised in organic method. The soil of the area underwent a test before the start of plantation and organic medicines were also sprayed to prevent pest attacks.

This is the second successful forest raised by the Forest department. Debadutta Biswal, the principal chief conservator of forest (PCCF) visited the site and expressed his dis-

pleasure over the degrading condition of the trees. He directed the DFO Biswanath Nilambaran to take steps in this regard.

The locals have also been opposing the works of the steel plant. They reiterated that there is no problem in operating the plant but the firm should not overlook protection of the local environment and pollution norms.

The land, which was earlier lying

barren, has turned into a lush green forest within a year. However, the steel plant in close proximity has posed serious threat to the forest. The black smoke and fly-ash discharged by the plant have threatened the forest's flora and are gradually denuding the area of its green cover, Forest department officials said.

The claim has been found to be true as ash discharged from the plant is enveloping the branches and leaves of the trees. It is apprehended that the ash settling on the trees might also result in spread of disease and pest attack, potentially putting the forest at risk of total destruction

On the other hand, ACF Tejaraj Nayak said that the trees get enveloped in thick layer of ash from the steel plant for which a letter will be written to the state pollution control board (SPCB) asking for its intervention in the matter.

32 held for fishing in prohibited sea zone

Tension in hosp after newborn's death due to medical negligence

However, despite repeated requests not a single nurse or doctor attended to the baby on time which led to her death Wednesday, family members alleged.

On being informed, Town Police rushed to the hospital and started investigation. The father of the deceased child said that he had initially taken his wife to a government hospital in Balasore. Later, he shifted her to the nursing home thinking that she would be given better service. However, they killed his daughter after



Family cries foul over youth's death

Autocracy in Crisis

ntil fairly recently, Chinese President Xi Jinping touted his zero-COVID policy as proof that authoritarian one-party states like China are better equipped to deal with pandemics (or any other crisis) than messy democracies hampered by selfish politicians and fickle electorates.

This might have seemed plausible to many in 2020, when hundreds of thousands of Americans were dying and former US President Donald Trump was touting anti-malaria drugs and bleach injections as COVID-19 remedies. Meanwhile, Xi enforced rigid pandemic restrictions that almost shut down the entire country, forced people into isolation camps, and insisted that Chinese citizens travelling abroad wear hazmat suits, like workers in some giant toxic laboratory. For a while, this strict regime appeared to keep COVID deaths to a minimum, compared to most other countries (though Chinese government statistics are notoriously unreliable)

But the high economic costs of China's zero-COVID strategy drove people to such despair that some finally took to the streets, at great risk. Still, Xi continued to claim that the ruling Communist Party was waging a "people's war" against the virus and would do whatever it takes to save lives. Then, at the end of last year, when protests erupted across Chinese cities, the war was suddenly declared over. No more lockdowns, hazmat suits, or even reg-

ular PCR tests. Following last year's unprecedented protests, it appears that China now deems COVID-19 harmless

But as a result of Xi's volte-face, together with the poor quality of Chinese-made vaccines and China's low vaccination rate, nearly 9,000 Chinese people are probably dying every day, and 18.6 million across the country have reportedly been infected since zero-COVID restrictions were lifted in early December. And things could easily get much worse.

These developments suggest that Indian economist Amartya Sen was correct when he famously argued in 1983 that famines are caused not only by a shortage of food but also by a lack of information and political accountability. For example, the Bengal famine of 1943, India's worst, happened under imperial British rule After India gained independence, the country's free press and democratic government prevented similar catastrophes. Sen's thesis has since been hailed as a ringing endorsement of democracy. While some critics have noted that elected governments can also cause considerable harm, including widespread hunger, Sen points out that no famine has "ever taken place in a functioning democracy.'

China's system of one-party, and increasingly one-man, rule is couched in Communist or nationalist jargon, but is rooted in fascist the ory. The German jurist Carl Schmitt, who jus tified Adolf Hitler's right to wield total power, coined the term "decisionism" to describe a sys-

tem in which the validity of policies and laws is not determined by their content but by an omnipotent leader's will. In other words, Hitler's will was the law. Decisionism is aimed at eliminating class conflict, factional strife, and pesky political opposition. The will of the people, often expressed through a rigged plebiscite, is carried out by the leader who decides in the people's name.

Autocratic centralisation can indeed have some advantages. Top-down decisions, often implemented by competent technocrats, have enabled China to build high-speed railways, fancy highways, excellent airports (even remote ones are modern marvels compared to New York City's JFK or most other major airports in the United States), and even entire cities in a matter of years. When the Party is always right, obstacles such as public opinion or parliamentary debate cannot stand in its way.

But when an actual crisis strikes – earthquakes, pandemics, and so on – the vulnerability of decisionist rule is exposed. That is why autocratic rulers need to hide or embellish statistics and silence critics like Wuhan-based doctor Li Wenliang, who first reported the COVID-19 threat in 2019 and was publicly rebuked for "spreading false rumors," before dying of the disease in early 2020. Whatever they do, absolute rulers and the parties they lead cannot be proven wrong.

In the US, by contrast, expert opinion, critical media, and the risk of losing the 2020 presidential election forced even the blundering Trump to channel vast amounts of money into vaccine research and development. Despite many mistakes along the way and perverse obstruction by demagogues and conspiracy-mongers, the democratic response to the pandemic followed Sen's playbook: the press and the public carefully scrutinised official statistics, most people were vaccinated, and the US, along with other Western democracies, gradually opened up, enabling people to go about their business in

Even without Xi's absolutist aspirations, this would have been hard to achieve in China. To justify its monopoly on power, the Communist Party has had to maintain a façade of infallibility, making it impossible to condemn the most colossal mistakes, even in retrospect. The nationwide famine of the 1950s is still often blamed on bad weather and natural disasters rather than Mao Zedong's catastrophic Great Leap Forward. Even as at least 30 million Chinese died, officials remained silent, fearing that annoying the Great Helmsman with bad news might cost them their lives as well.

China, of course, is no longer as isolated as it was in the 1950s, Xi is not Mao, and his erratic decision-making will most likely not claim 30 million lives. But with a daily death toll of 9.000, the costs will be massive. And precisely because China is no longer isolated, the implications will extend far beyond Chinese borders. Viruses, after all, travel, as do economic disruptions. The damage done to China by its autocratic regime will end up hurting us all.

CAN ESG SAVE EARTH?

√here has been a significant interest in ESG (Environmental, Social and Governance) investing in the last few decades. The vouth want to invest their hard-earned money into companies that would reflect their values, especially reflecting environmental sustainability. Global companies as well as governmental organisations are adopting ESG reporting. However, the definition of ESG and their assessment criteria are still evolving. Some have hailed the advent of ESG as a fast-track mechanism to help save the planet from the destruction from an inevitable climate crisis. Others see it as a passing fad easily subverted by 'greenwashing' - which describes the corporate spin on environmental issues.

Tariq Fancy was the Chief Investment Officer of BlackRock one of the largest global investment firms. In his experience the rapid spurt in interest in ESG investing could be dangerous as it is like offering 'wheatgrass to a cancer patient'. There are several cases of 'greenwashing' that would be illustrative of the debate around ESG investing - a well intentioned initiative to tackle the biggest flaws of free market economics being accused of as a cover for greenwashing. A diversion that can delay urgent action to stem global warming that is driving the climate crisis.

The 27th Conference of Parties (COP27), organised by the United Nations (UN), has recently concluded in Sharm el-Sheikh, Egypt. The goal of the Paris climate agreement of 2015 (COP21) of keeping the long-term global temperature rise restricted to 2 degree Celsius above the pre-industrial age was the centre of attention. Emissions should be reduced by roughly 50% by 2030 to stay below 1.5 degree C of global warming and reach 'net zero' by the middle of the 21st century. One of the major concerns to emerge out of COP27 is articulated by UN Secretary General António Guterres: "We must have zero tolerance for net-zero greenwashing and ensure credible, accountable net-zero pledges." This is at the centre of the debate around

ESG policies and their implementation or lack of it by big market players and even nations. It may even determine whether capitalism survives in its current form besides averting the predicted climate catastrophe.

In 2005, in a study report titled Who Cares Wins' by lead author Ivo Knoepfel, the idea of ESG was first elaborated. It resulted from a UN initiative under then Secretary-General Kofi Anan, in which CEOs of 50 global financial companies. International Finance Corporation and the Swiss government came to gether to make a case for embedding environmental, social and governance issues into the way capital markets operate. Specifically, ESG refers to environmental sustainability-related issues such as greenhouse gas emissions or biodiversity loss, social responsibility towards gender parity or respect for human rights, and practice of good corporate governance such as having a well-balanced board or

whistleblower policy. Before the rise of ESG-driven impact investing, terms like ethical investing, corporate social responsibility, the triple bottom line defined by profit, people and planet, tried to capture the same issues but in a more voluntary framework. Ethical investing uses a negative filter to eliminate investment in specific sectors such as tobacco. firearms, fossil fuel, that have a demonstrable negative social impact

Environmental, social and governance are the three dimensions in which the impact of a company or any entity on our society and environment can be measured. The same set of parameters can also be used to measure the sustainability of the business itself. For example, the fast-deteriorating global climate crisis driving disruptive extreme weather events has obvious implications for many businesses and their long-term sustainability. It is as true of corporations as it is for other entities, be it cities or states or even countries. Traditionally, capitalism and market-driven economics demanded only return on investment from entrepreneurs and their ventures. There was little attention on matters such as whether the enterprise damaged the environment, abided by labour laws, respected human rights, promoted diversity at the workplace and followed good governance practices.

Interestingly, it is not the concern for the impact of the business and industry on the environment and society alone that drove the adoption of ESG policies. The realisation that the so-called non-financial ESG factors do ultimately have an impact on the bottom line of the company was also a major driver. The growing interest in ESG reporting and ratings by in vestors and fund managers also was for the same reason

In an era of trillion-dollar com-

panies dominating the world economy, the impact of their business practices on society and the eco-system is significant. When companies like Google, Amazon and Microsoft declare their goals to become carbon-neutral in all their operations. it has huge consequences for the world's net-zero carbon goal. Currently, among the top ESGrated companies listed on S&P 500 are household names like Microsoft, Nvidia and Salesforce that have achieved MSCI AAA ratings consistently while delivering very good financial performance. Microsoft has been carbon neutral globally since 2012 and has a policy to be carbon negative by 2030. Nvidia invests in 5,000 non-profits for over 25 million US dollars a year while committing to use 65% renewable energy in all its operations.

In spite of the many scandals and shortcomings exposed in how it is practised, the growth of ESG ratings-driven investment and as sets under management remains unaffected (37.5 trillion US dollar and increasing). An NYU Stern Center for Sustainable Business performed a meta-analysis of 1000 case studies between 2016 and 2000. It was found conclusively that there is a positive or neutral correlation between ESG focus and financial performance. It improved financial performance; it is a better strategy than a negative screening approach; it improves risk management, drives innovation, and helps mit igate economic downturn and social unrest. An honest implementation of ESG-driven policy actions certainly has long-term financial returns while benefitting society at large. Clearly, the verdict favours a more rigorous adoption of ESGbased policies in business management and corporate governance. It will help save the planet and make the business world more resilient and sustainable in the process, helping the current form of capitalism evolve into a more benevolent version of itself.

Democracy dies with death of dissent

plete with instances which show that some judges of the Supreme Court are more influenced than others by the famous patriotic song of Rabindranath Tagore "ekla chalo re": Lay bare your soul and speak your mind, say what you have to say. They stand out, speak up, and share their opposing views openly. While some call them dissenters, many call them reformists.

Legal researchers and observers in India often give credit to three great dissenters, Justice Fazl Ali, Justice Subba Rao and Justice Khanna for creating and maintaining the tradition of judicial dissents in India. In the recent past too, we have witnessed dissents in two government decisions relating to Aadhaar and demonetisation. In both cases, one of the five

judges delivered a dissenting note. The latest one is the five-judge Constitution Bench of the Supreme Court which delivered its verdict on 2 January 2023. The court upheld the decision of the Central government taken in 2016 to demonetise the currency notes of ₹500 and ₹1,000 denominations. There was one voice of dissent. The youngest of the five judges, Justice BV Nagarathna wrote a dissenting judgement. She ercise of power, contrary to law, and therefore unlawful." She said that though demonetisation was in the best interest of the people, it had to be done through legislation and not through a gazette notification as the Parliament cannot be left aloof in a matter of such critical importance. It seems for Justice Nagarathna, it is not enough just to have good intentions, even the process of achieving such good intentions should be legitimate.

A similar high-profile dissent was that of Justice Chandrachud in 2018. Four judges of the panel had upheld the Aadhaar Act as Constitutionally valid. However, Justice Chandrachud delivered a powerful and philosophical dissent. He said: "Constitutional guarantees cannot be compromised by vicissitudes of technology." Like Justice Nagarathna, Justice Chandrachud also held the purpose of the Aadhaar Act to be legitimate, but he differed from the majority opinion by saying "the passing Aadhaar Act as money bill is a fraud on the Constitution.'

These two dissents convey a message that even today there are judges who raise their voice, give their own views and not just follow the majority But unfortunately, such dissents are to a well-researched book, "Supreme Whispers" by Abhinav Chandrachud, despite the rivalries among the judges, there is a lack of dissent in the day-to-day decision making of the court. According to the author, around 70% of cases in the US Supreme Court recorded dissents and more than 25% of cases in the UK. Australia, and Canada recorded dissents. Whereas such dissents were recorded in less than 10% of cases in India. Should India go the US way? The answer of course is not an unconditional ves. Dissent has both merits and demerits

Dissent is the manifestation of the right to freedom of speech and expression. The practice of dissent is an important part of democracy. Democracy dies with the death of dissent. Judges too use this right and write their own dissenting opinions, if they feel that the maiority is failing to understand the spirit of the case. Often it has been found that dissent improves the quality of judgement too as both sides need to explain the rationale of their judgement more clearly and strongly. Dissent reveals flaws in the majority's judgement and therefore works as a corrective for future judgements. As dissents are

ity judgement, it sends a positive signal to the society at large about the process of judgement.

Though judicial dissent has no force of law, it has the power and potential to create new laws. Dissents also explain the case facts with opposite legal principles which may be useful in the long run. The followers of law see a ray of hope of change in every word of a dissent. Today's dissent may be tomorrow's law.

Concerted efforts are needed to strengthen this pillar of democracy. We need to work in that direction. We must talk openly about dissents and eulogise the dissenters. Let us create opportunities for young professionals to talk to dissenters and understand the spirit of dissents too. Dissent should not be confined to courtrooms, classrooms, boardrooms or office rooms. We should develop the ability to see dissent in the larger perspective of life as enunciated by Justice Thurgood Marshall while accepting the prestigious Liberty Award (1992): "We cannot play ostrich. We must dissent from the indifference, the apathy, the fear, the hatred, and the mistrust."



North Lakhimpur (Assam), Jan 11: The drive to evict encroachers from a forest land in Assam's Lakhimpur district continued for the second day Wednesday, with 299 families residing on a 250 hectare tract left in the lurch.

The administration cleared the remaining 250 acres during the daylong exercise Wednesday. Around 70 bulldozers, excavators and tractors were pressed into action in Adhasona village, while 600 police and CRPF personnel stood guard, the official stated.

With some belongings in tow. Hasmat Alam (name changed on request), who witnessed his house being razed to the ground, claimed that he had been a resident of that area for the past 28 years.

"This year, the harvest was good. I grew brinjal, cabbage and cauliflower and sold some of the produce in the market. Around 70 per cent of the crop, however, got destroyed in the drive," he said.

Some of the victims claimed that there are around 500 Hindu families living in the forest, and the "government must evict them too" if it is really concerned about encroachment. According to the senior official, the Hindu families. most of them belonging to

Lakhimpur Divisional Forest Officer (DFO) Ashok Kumar Dev Choudhury noted that out of 46 sg km Pava Reserve Forest, earmarked in 1941, only 0.32 sq km were free and the rest all occupied. Altogether 701 families have encroached upon the Pava Reserve Forest land over the last three decades, he said. These settlers had in 2006 applied for declaring their place of stay as 'Forest Village'. but the government had rejected that proposal then. In July last year, 84 families had submitted documents claiming land ownership but those were found to be fake

India recycles only 30 per cent of 3.4 MT plastic waste generated annually: Report

New Delhi, Jan 11: India gener ates around 3.4 million tonnes (MT) of plastic waste, a report said on Wednesday noting that only 30 per cent of it is recycled.

Over a five-year period, the plastic consumption in the country has risen at a compounded annual growth rate (CAGR) of 9.7 per cent to 14 MT in the financial year 2016-17 to 20 million tonnes in 2019-20. Marico Innovation Foundation said in a report released in the national capital. India's plastic waste output also doubled between the said period, the report titled 'Plastics, The Potential and Possibilities' said.

According to the report, which has been prepared in association with the Indian Institute of Science (IISc) and Praxis Global Alliance, Maharashtra, Gujarat and Tamil Nadu together contribute 38 per cent to the total plastic waste that



is generated in India. "The plastic consumption in India has grown at a significant pace over the past five years, and so has its waste output. India produces 3.4 million tonnes of plastic waste in a year, only 30 per cent of it is recycled,

While the rest of the plastic waste is sent to landfills or aquatic dumps, the report noted and suggested ways to deal with the challenge as the entire plastic value chain from production to waste disposal severely impacts the local ecologies it surrounds. This impact is wide ranging, and affects communities and ecosystems.

Apart from imposing a ban on single-use plastic, the government has been working on creating a statutory framework for including the use of biodegradable plastics as an alternative material. However, there are other effective policy interventions that can be used to create a sustained impact.

"Landfill and incineration taxes must be levied in India to encourage recycling rather than dumping. Authorise a 'pay-as-you-throw' system, which requires citizens to pay a variable rate per kilogram for a bag of mixed garbage," it suggested.

There is a need to regulate the entire life cycle of plastic bags, from manufacturing or imports to disposal, besides specific incentives to the bioplastics industry like corporate income tax exemptions, infrastructure development support and installation cost reduction.

New Delhi, Jan 11: It might take at least five years in the normal course to conclude the trial in the Lakhimpur Kheri violence case, a sessions judge conducting the trial in the case in which Union Minister Ajay Kumar Mishra's son is one of the accused, informed the Supreme Court Wednesday.

In a report submitted to the apex court, the additional sessions judge said there are 208 witnesses, 171 documents and 27 forensic science laboratory (FSL) reports in the case.

"The report says it will take at least five years. It says there are 208 witnesses, 171 documents and 27 FSL reports," said a bench of Justices Kant and Ramasubramanian while referring to the report received from the trial court judge. "He (sessions judge) says in normal course, it may take five years," observed the bench,



which is hearing a plea by Ashish Mishra seeking bail in the case of mowing down of protesting farmers in October 2021 in Lakhimpur Kheri.

During the hearing, the bench asked the counsel appearing for the Uttar Pradesh government to confirm whether the four accused in a separate case lodged over the killing of three occupants of the SUV, which allegedly moved down four farmers in the incident, are still in custody.

At the outset, advocate Prashant Bhushan, appearing for the complainant in the case of the killing of farmers, requested the bench to post the hearing for some other day, saying senior advocate Dushyant Dave who is leading him in the matter is unwell.

The bench inquired from the state's counsel about the status of the separate case lodged over the killing of three occupants of the SUV which allegedly moved down farmers. The counsel said charges have been framed against the accused in that matter. "We just want to know if there are accused in that case who have been arrested?" the bench asked. The state's counsel said four accused were arrested in the case. Senior advocate Mukul Rohatgi, appearing for the trial judge has sent a report to the apex court.

When the bench said as per the report of the additional sessions judge, it may take at least five years in the normal course to conclude the trial, Bhushan said material wit nesses can be examined first.

"The problem is the report says when the case was fixed for examination of prosecution witnesses, one of the material witnesses was to be examined but he got fever and was unwell on that day...These practical difficulties may arise," the bench pointed out. It said if the trial in the case is asked to be speeded up, it will have to be done at the cost of all other cases pending in that court.

Bhushan said day-to-day trial is needed in this case being probed by a special investigation team. On October 3, 2021, eight people were killed in Tikunia in Lakhimpur Kheri district during violence that erupted when farmers were protesting against the then Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurva's visit to the area. Four farmers were moved down by an SUV in which Ashish Mishra was seated, according to the Uttar Pradesh Police FIR.

'Not tobacco ban, new therapies key to combating lung cancer'

New Delhi, Jan 11: The key to combating lung cancer is the development of novel immunotherapies and diagnostic techniques and not a complete ban on tobacco that is impossible to enforce, says American Nobel laureate Harold Varmus. Varmus won the 1989 Nobel

Prize in Medicine - along with American immunologist Michael Bishop -- for the discovery of gene mutations that can lead to the transformation of a normal cell into a tumour cell and result in cancer.

The Parliamentary Standing Committee on Health and Family Welfare in India has recommended in its latest report that the government ban the sale of loose cigarettes.

'The focus should be on novel therapies and diagnostic techniques and not on complete prohibition," the 83-year-old said when asked if tobacco ban is the answer to combat the deadly



Trying to prohibit tobacco or to ban tobacco entirely is a mistake because we know that you can't enforce complete prohibition. That is the kind of thing that leads to various forms of crime and it doesn't work. I don't think bans work very well. But I do think that not just in India and every country, including the US, where we still have 18 per cent of our population smoking, we have people using nicotine vapes instead of cigarettes. All these are risk factors for cancer HAROLD VARMUS | AMERICAN NOBEL LAUREATE

Noting that there were limited therapies available for lung cancer 20 years ago, Varmus said he is "optimistic" about developments in the field of cancer research."Broadly speaking, in addition to the preventive advice, which is mainly about smoking, that's the biggest with respect to lung cancer. But the second thing is early diagnosis and there are new ways to make diagnoses of lung cancer earlier. Third thing is the development of new kinds of therapies.

Varmus, who is currently the Lewis Thomas University Professor of Medicine at Weill Cornell Medicine and a senior associate at the New York Genome Center, said there are two major types when it comes to diagnostics.

"The first one I'm particularly knowledgeable about because it involves work that I and my colleagues have done over the years, It is to identify the genetic changes that have occurred in an individual's lungs over that person's lifetime, that are the causative agents of the disease, he explained.

The scientist also highlighted the role of genetics in cancer diagnosis, saying the chances of different cancers arising vary if a person comes from a certain ancestry.

Cairo, Jan 11: Weapons supplied by the United Kingdom and the United States and used by a Saudiled coalition fighting in war-torn Yemen killed at least 87 civilians and wounded 136 others in just over a year, a new report said Wednesday

The report by the Oxfam charity found that the Saudi-led coalition used weapons supplied solely by the UK and the US in hundreds of attacks on civilians in Yemen between January 2021 and the end of February 2022.

Britain is the second-biggest supplier of weapons to Saudi Arabia, after the US.

Yemen's war began when the Iran-backed Houthis seized the country's capital, Sanaa, in September 2014 and forced the internationally recognised gov-

A Saudi-led coalition — armed with US and UK weaponry and intelligence — entered the war on the side of Yemen's exiled government in March 2015.

Oxfam's report comes ahead of a legal challenge by the Campaign Against Arms Trade, a group of anti-weapons campaigners, against the UK government for supplying weapons used in Yemen's war. The charity says it provides witness in support of the challenge The court battle by the anti-

weapons campaigners is years old. The Court of Appeal in London ruled in 2019 that the British government acted unlawfully in selling weapons to Saudi Arabia that were used in the Yemen war. The court, however, did not order a halt to the exports to the Gulf Arab kingdom.

Oxfam's report portrayed a grim picture.

alyzed 1,727 attacks on civilians in Yemen's war during the 14month period, with the Saudi-led coalition, using weapons supplied by the UK and the US, being responsible for a quarter of all attacks.

"It's just so relentless," Butcher told the AP. "People just find it so hard to escape the violence and the killing."

The 43-page report said the analvzed attacks killed at least 839 civilians and wounded 1,775 others. Of all the attacks by the Saudiled coalition during the 14-month period, airstrikes alone killed at

least 87 civilians and wounded 136, the report found.

The rest of the attacks were artillery, missiles and drone attacks, as well as from land mines, road bombs and light arms.

The report found that airstrikes and artillery attacks involved cluster munitions, "weapons banned by international convention and customary law".

The charity counted at least 19 attacks by the coalition on health facilities and ambulances. It said 293 airstrikes forced people to flee

All parties to the war have been accused of killing and wounding civilians in Yemen's eight-year conflict. Overall, the war has killed more than 150,000 people, including over 14,500 civilians, according to The Armed Conflict Location and Event Data Project.

Oxfam accused the British government of turning a blind eye to the Saudi-led coalition attacks in Yemen. The charity said UK imposed sanctions on Russian officials over attacks on civilians in Ukraine, while continuing to defend arms sale to the Gulf monar chy to use in Yemen's war.

This is "a clear demonstration of double standards and politicization of the law for reasons of national interest", it said.

US airports rumble back to life after FAA outage

The Federal Aviation Administration announced earlier in the morning that it suffered an outage of its Notice to Air Missions or NOTAMs, which alerts pilots and other personnel about airborne issues



Washington, Jan 11: US flights were slowly beginning to resume departures and a ground stop was lifted after the Federal Aviation Administration (FAA) scrambled to fix a system outage overnight that had forced a halt to all US departing flights.

The cause of the problem with a pilot-alerting system, which delayed thousands of flights in the United States, was unclear, but US officials said they had so far found no evidence of a cyberattack. The outage occurred at a his-

torically slow time for US travel after the December holiday travel season, but airlines have said demand remains strong as travel continues to recover to near pre-pandemic levels. "Normal air traffic operations are

resuming gradually across the US following an overnight outage to the Notice to Air Missions system that provides safety info to flight crews. The ground stop has been lifted. We continue to look into the cause of the initial problem," the FAA Tweeted.

The number of flights impacted continued to steadily rise even after the ground stop was canceled.

One issue airlines are facing is trying to get planes in and out of crowded gates, which is causing

More than 5,400 flights had been delayed and 900 canceled according to the FlightAware website as officials said it will take hours to recover from the halt to flights.

The FAA had earlier ordered airlines to pause all domestic departures after its pilot alerting system crashed and the agency had to perform a hard reset around 2 am, officials said.

The FAA is expected to implement a ground delay program in order to address the backlog of flights halted for hours. Flights already in the air had been allowed to continue to their destinations during the ground stop.

US President Joe Biden ordered the Transportation Department to investigate the outage and said the cause of the failure was unknown at this time. Asked if a cyber attack was behind the outage, Biden told reporters at the White House, "We don't know.

information essential to personnel concerned with flight operations but not known far enough

in advance to be publicized by other means. A ground stop is an air traffic control measure that slows or halts aircraft at a given airport.

Chicago-based United said it has resumed operations, but warned customers might continue to see some delays and cancellations.

A trade group representing the US travel industry, including airlines, called the FAA system failure "catastrophic."

"America's transportation network desperately needs significant upgrades," Geoff Freeman, president of the US Travel Association, said in a statement. "We call on federal policymakers to modernize our vital air travel infrastructure.'

FAA's system outage comes weeks after an operational meltdown at Southwest at the end of last year left thousands of passengers stranded.

A severe winter storm right before Christmas, coupled with the Texas-based carrier's dated technology, led to over 16,000 flight cancellations last month.

Fighting rages over Ukraine's Soledar

Kyiv, Jan 11: Russian and Ukrainian forces were engaged in intense fighting on Wednesday over the town of Soledar in eastern Ukraine - a stepping stone in Moscow's push to capture the entire Donbas region - with the Russians appearing to have the upper hand.

The mercenary group Wagner, which has spearheaded the assault, Tuesday claimed to have taken control of the small salt-mining town although pockets of Ukrainian resistance were holding out in the centre.

Russia's defence ministry said Wednesday that airborne units had cut off Soledar from the north and south. But Ukraine denied that the town, with a pre-war population of around 10,000, had fallen.

"Heavy fighting continues in Soledar," Deputy Defence Minister Hanna Maliar, wrote on Telegram. "The enemy has again replaced its units after sustaining losses,



Wagner fighters and is trying to burst through our forces' defence and fully seize the city, but is not having success. The Kremlin also stopped short

of claiming victory and acknowledged heavy casualties. "Let's not rush, let's wait for official statements. There is a positive dynamic in progress." Kremlin spokesman Dmitry Peskov said.

With the war now in its 11th month, Russian commanders have targeted Soledar as a platform to attack the nearby city of Bakhmut, which has held out for months against a Russian onslaught and is a hub for supply lines in eastern Ukraine.





'Cost of living crisis biggest short-term risk; climate action long-term'

New Delhi/London, Jan 11: The cost of living crisis is the biggest short-term risk the world is facing, while the failure of climate mitigation and climate adaptation is the largest long-term concern, the World Economic Forum said Wednesday.

Releasing its annual Global Risks report in London ahead of its Davos summit next week, the WEF also said geopolitical rivalries and inward-looking stances will heighten economic constraints and further exacerbate both shortand long-term risks.

The Global Risks 2023 report,

perts, policy-makers and industry leaders from across the world, also urged countries to work together to avoid 'resource rivalries'.

"Conflict and geo-economic tensions have triggered a series of deeply interconnected global risks, the report said.

These include energy and food supply crunches, which are likely to persist for the next two years, and strong increases in the cost of living and debt servicing. At the same time, these crises risk

undermining efforts to tackle longerterm risks, notably those related to climate change, biodiversity and investment in human capital.

The report said the window for action on the most serious longterm threats is closing rapidly and concerted, collective action is needed before risks reach a tipping point.

Produced in partnership with Marsh McLennan and Zurich Insurance Group, the report painted a picture of the global risks land-

scape that is both new and eerily familiar, as the world faces many pre-existing risks that previously appeared to be receding.

Noting that the global pandemic and war in Europe have brought energy, inflation, food and security crises back to the fore, the report said these create follow-on risks that will dominate the next

Those include the risk of recession; growing debt distress; a continued cost of living crisis; polarised societies enabled by disinformation and misinformation; a hiatus on rapid climate action; and zero-sum geo-economic warfare.

Failure to mitigate and adapt

to climate change, natural disasters, biodiversity loss and environmental degradation represent five of the top 10 risks - with biodiversity loss seen as one of the most rapidly deteriorating global risks over the next decade.

In parallel, crises-driven leadership and geopolitical rivalries risk creating societal distress at an unprecedented level, as investments in health, education and economic development disappear, further eroding social cohesion.

Finally, rising rivalries risk not only growing geo-economic weaponisation but also remilitarisation, especially through new technologies and rogue actors, the WEF said.

The government has increased infrastructure spending and various business facilitation measures. However, it will crowd-in private investment and support the expansion

of manufacturing capacity. "Growth is projected to slow, to 6.6 per cent in FY2023/24 before falling back toward its potential rate of just above 6 per cent," it said.

The GDP expanded by 9.7 per cent on an annual basis in the first half of fiscal year 2022-23, reflecting strong private consumption and fixed investment growth.

Consumer inflation in most of the last year was above the Reserve Bank's upper tolerance limit of 6 per cent, prompting the policy rate to be raised by 2.25 percentage

TAX MOP-UP **RISES 24.58%** TILL JAN 10

New Delhi, Jan 11: The country's gross direct tax collection rose 24.58 per cent to Rs 14.71 lakh crore till January 10 this fiscal buoyed by an upsurge in personal income tax mop-up, the govern-

ment data showed Wednesday. After adjusting refunds, net direct tax collection stood at Rs 12.31 lakh crore, 19.55 per cent higher than the net collections for the corresponding period of last year.

The net collection is 86.68 per cent of the total budget estimates of direct taxes for the current fiscal. The Budget had estimated direct tax collection at Rs 14.20 lakh crore this fiscal.

On gross basis, collections from corporate income tax (CIT) grew 19.72 per cent, while that for personal income tax (PIT) increased 30.46 per cent.

"The provisional figures of direct tax collections up to 10th January, 2023 continue to register steady growth. Direct tax collections up to 10th January, 2023 show that gross collections are at Rs 14.71 lakh crore which is 24.58 per cent higher than the gross collections for the corresponding period of last year." the Central Board of Direct Taxes

(CBDT) said in a statement. After adjusting refunds, the net growth in CIT collections is 18.33 per cent and that in PIT (including securities transaction tax) is 20.97 per cent.

Refunds amounting to Rs 2.40 lakh crore have been issued between April 1, 2022, to January 10, 2023, which are 58.74 per cent higherthan refunds issued during the same period last year.

Oil price cap takes small slice of Russia war chest and the United States.

The current price cap is above the market price for Russian oil and remains in the range of what Moscow needs to balance its budget

Frankfurt (Germany), Jan 11: A price cap and European Union embargo on most Russian oil have cut into Moscow's revenue from fossil fuels, but the Kremlin is still earning substantial cash to fund its war in Ukraine because the \$60-perbarrel cap was "too lenient", researchers said Wednesday.

The combination of the cap by the Group of Seven major democracies and the EU ban are costing Russia an estimated 160 million euros (\$171.9 million) per day, the Helsinki-based Centre for Research on Energy and Clean Air said in a study of the first weeks of the sanctions, which took effect December 5.

But the group's figures showed that Russia was still taking in 640 million euros a day from fossil fuels, down from 1 billion euros daily from March to May 2022 just after the country invaded Ukraine February 24.

Russia would lose an additional 120 million a day starting February 5, when the EU bars imports of refined oil products such as diesel fuel, for which Russia is a major supplier. That would drop Moscow's earnings to 520 million euros a day by February. The group said Russia still man-

Western governments have struggled to find a way to cut into the fossil fuel income that is the main funding source for Russia's government budget and its war against Ukraine.

Early rounds of sanctions mostly avoided blocking oil and natural gas shipments. That's because the European Union had been heavily dependent on Russian fossil fuels to run its economy and because sharply higher energy prices early in the war helped send inflation through the roof in Europe

Add young opener Shubman Gill's splendid ODI run to Indian top three and Indian top-order looks sorted and would once again look to dominate the pedestrian Lankan attack.

Having got unflinching support from his skipper, Gill was back as opener in the ODI format at the expense of left-handed keeper-batter Ishan Kishan, a selection that copped

New Delhi, Jan 11: India captain Harmanpreet Singh is one of the star attractions of the men's hockey World Cup starting Friday because of his sheer calibre of penalty-corner conversions, but the team's chief coach Graham Reid has worked upon plans to divert the attention from his key player.

Harmanpreet is currently regarded as one of the world's finest penalty-corner exponents but Reid wants his other dragflickers - vicecaptain Amit Rohidas, Varun Kumar and Nilam Sanjeep Xess to share the responsibility with their skipper.

"I would be lying if I say that there isn't pressure on him (Harmanpreet). We have been spending a lot of time on our variations and making sure that we can deflect some of the pressure



from Harman," Reid told this agency in an interview ahead of their tournament opener against Spain in Rourkela Friday.

"There are other dragflickers in the squad in the form of Amit, Varun and Nilam and they have to share the burden.

Eight-time gold medallists India grabbed an Olympic medal - a bronze in Tokyo – after 41 years and the expectations are high from the home team to return to the podium in the World Cup since 1975, when they won their maiden yellow metal in the event.

And the Australian coach, under whose tutelage India won the Olympic medal in Tokyo, understands the need of modern-day hockey. "We focussed mainly on scenarios in our training, what if we are 0-1 down, what if we are playing with 10 men, what if they take their keeper off. Those types of scenarios which are important that we have dealt with," Reid said.

"Spending a lot of time on those sorts of scenarios, lots of goal shooting, a lot of tackling, a lot of penalty corners. There is no rocket science there."

Asked about his realistic expectation from the World Cup to be jointly hosted by Bhubaneswar and Rourkela from January 13 to 29, the Indian coach said, "I always

say that we shouldn't be too much outcome focussed. India as nation always is focussed on outcome. "It's an old adage that the first

game is the most important, so we are just focussing on that and then take it forward. That's how we are approaching. My job as a coach is to keep them focussed and the result will follow. It's an old sports psychology but it works.

"But having said that after winning medals in the Olympics and the Commonwealth Games, it would be great for a hockey nation like India to win a World Cup medal," he added.

But the coach added he isn't ঽ looking too far ahead and just wants to focus on the pool matches at this stage. India are placed in a tough Pool D alongside Spain, England and Wales. India will open their campaign against Spain
