India qualify for crossovers projects worth ₹1.53 lakh crore

HOME TEAM BEAT WALES 4-2 BUT FAIL TO TOP POOL, TO PLAY NZ IN CROSSOVER FOR PLACE IN LAST-EIGHT

PRESS TRUST OF INDIA

Bhubaneswar, Jan 19: India defeated Wales 4-2 to finish second in Pool D and qualify for the crossover match, where they will take on New Zealand, for a place in the quarter-final of the FIH Men's Hockey World Cup here Thursdav.

India took a 2-0 lead through goals from Shamsher Singh (21st) and Akashdeep Singh (32nd) before Wales stunned the home team with twin strikes in a span of two minutes. Both the Wales goals came from penalty corners through Gareth Furlong (42nd) and Jacob Draper (44th) as they drew level.

Akashdeep came to India's rescue, scoring a fine field goal in the 45th minute before skipper Harmanpreet Singh converted a penalty corner in the 59th minute. Both India and England finished with seven points each from three games but the latter topped the pool on account of better goal difference.

In an earlier Pool D match, England beat Spain 4-0. While England directly qualified for the quarterfinals by topping the pool, India and Spain will play in the crossover matches for the other four quarter-final spots. **FULL COVERAGE ON P12**

POST NEWS NETWORK Bhubaneswar, Jan 19: The state government Thursday approved nine mega industrial projects worth ₹1,53,074.63 crore that would generate employment for over 27,030

persons in the state. The High Level Clearance Authority led by Chief Minister Naveen Patnaik has approved the projects, for which intents were received during the Make in Odisha Conclave, 2022. The approved projects are spread across diverse sectors like green energy and equipment, metals and minerals, paper and IT infrastructure. The projects will be set up in Balasore, Dhenkanal, Ganjam, Jagatsinghpur, Kalahandi, Khurda, Koraput, and Mayurbhanj.

The HLCA has given a go-ahead to four projects in the green energy and equipment sector, two projects in the paper industries, two projects in the metals and minerals sector and one project in the IT infrastructure sector. The Committee approved the proposal of ACME Clean Energy Private Limited, entailing an investment of ₹58,209.13 crore. It has proposed to set up a green hydrogen plant and a green ammonia plant with a capacity of 1.1 million tonne at Kujanga, Jagatsinghpur and a captive renewable energy unit (4500 MW solar power plant) in Koraput and Kalahandi districts. It is expected to provide employment opportunities to about 3,400 people

The state has also approved the proposal of Avaada Green H2 Private Limited in Ganjam district, which promises an investment of ₹23,500 crore and is expected to provide employment opportunities to about 1,500 people. **Continued on P4**

New Delhi, Jan 19: India is set to overtake China as the world's most populous country this year, but a small northeastern state is worried about its shrinking indigenous communities and urging them to have more babies.

Sikkim, a state with fewer than 700,000 people, has India's lowest fertility rate and now wants families to have three children, making it the first to do so in a country where authorities, in a bid to fight overpopulation, have long pushed par-

ents to stop at two.

"If our indigenous people vanish, their culture will vanish with them too, which will be a big loss for us," said Shanker Deo Dhakal, secretary to the Chief Minister of Sikkim, where almost 80% of people are estimated to be indigenous. The border state also recently announced incentives like year-long maternity leave for women, month-

long paternity leave for men, and financial support for those seeking pregnancy through IVF. Family size came into spotlight

Idco slum murder case accused held

Bhubaneswar, Jan 19: Commissionerate Police Thursday arrested an accused involved in the murder of a 35-year-old youth at Idco slum under Maitree Vihar police limits here in the wee hours of Tuesday. The arrested was identified as Sunaram Murmu, 22, a resident of Khunta area in Mayurbhanj district. Sunaram was absconding since the incident.

As per police sources, the deceased Sushil Hembrum, a resident of Salia Sahi, had a fight with Sunaram, his neighbour, over some trivial issue a few days back.

Later, Sunaram informed his distant cousin Biswanath Kisku, the prime accused in the case, about the brawl. Subsequently, they hatched a plan to eliminate Sushil.

During the wee hours on Tuesday, Kisku along with Sunaram came to Sushil's house when he was fast asleep. They first woke up Sushil and then Kisku attacked him with a wooden plank. Sushil sustained severe head injuries and was sent to Capital Hospital for treatment where the doctors declared him dead.

When informed, police reached the spot and arrested Kisku after registering a case (11/23). However, Sunaram, who had fled the spot after the incident, was arrested by cops near the slum Thursday.

He was later produced before the court that sent him to judicial custody.

LEOPARD HIDE SEIZED; 3 HELD

Malkangiri: Forest officials have seized a leopard hide from Poteru canal area in Malkangiri and arrested three persons on the charge of smuggling wildlife body parts, police said Thursday. Malkangiri DFO Pratap Kotapalli said three people were arrested along with the seizure of a leopard skin worth over ₹1 lakh under Motu forest limits. He said the seizure was made Wednesday. The officials led by Motu Forest Range officer Rashmi Ranian Swain came across three people in forest area and on checking of their bags a leopard skin was seized. The accused were identified as Mukesh Madkami, Penta Madkami and Dula

New Delhi, Jan 19: Nearly 85 per cent of organisations were attacked by ransomware at least once in the past 12 months, up from 76 per cent, a report said Thursday.

Specifically, recovery is a main concern as organisations reported that only 55 per cent of their encrypted/destroyed data was recoverable from attacks, according to Veeam Software. The survey found that companies

are challenged with more complex hybrid IT environments and are raising budgets to fend off cvberattacks as well as keep up as production environments continue to diversify across various clouds. Globally, organisations expect to increase their data protection budget in 2023 by 6.5 per cent.

Of the 85 per cent of organisations planning on increasing their data protection budgets, their average planned increase is 8.3 per cent and often in concert with increased investments in cybersecurity tools.

"IT leaders are facing a dual challenge. They are building and supporting increasingly complex hybrid environments, while the volume and sophistication of cyber attacks is increasing," said Danny Allan, CTO and Senior Vice President of Product Strategy at Veeam.

India's total fertility rate (TFR) - children per woman - fell to 2 in the latest assessment period, for 2019-2021, from 3.4 in 1992-93, according to a government report issued in October: It estimated that the average must be 2.1 for the population to reproduce itself.

Of India's 36 states and Union territories, only five have a TFR of above 2.1, the highest being in Bihar with a TFR of 3 as of 2019-20. Sikkim, with a TFR of 1.1. is at the risk of seeing its population shrinking.

The population of at least two of Sikkim's 12 indigenous communities - Bhutia and Limbu - has been declining in recent years, Dhakal said, without providing any data.

HC's proposal pending with Union, state govt

New Delhi, January 19: Proposals sent by the Orissa High Court for construction of new court rooms in the state have been lying pending with the Union and the state government, amicus curiae Vijay Hansaria submitted in the Supreme Court.

Hansaria, in a case filed in the apex court on judicial infrastructure, submitted an affidavit in the apex court stating that there are 174 vacancies in the sub-ordinate courts in Odisha. He also submitted that there is a shortage of 123 court rooms in the state. The affidavit also highlighted the shortage of 503 residential quarters for the judicial officers. It was submitted in the affidavit

that the assistance for construction of new court rooms under the Centrally Sponsored Scheme (CSS) have not been released by the Union government for the years 2020-21 and 2021-22. The Orissa HC has also



submitted a detailed action plan under the CSS for the financial vear. 2022-23 amounting to ₹60.40 crore (₹36.24 crore as Central share + ₹24.16 crore as State share) to the Union government and the state government. The amount hasn't been released for the year 2022-23 till January 14, the affidavit revealed.

Significantly, demand for funds amounting to ₹722.4868 crore (₹600.506 crore for non-residential + ₹121.98 crore for residential) have been made under the State Sector Scheme(SSS) for the financial year, 2023-24 for infrastructure development of subordinate Judiciary to the state government, the affidavit reads.

fter three long years, the pandemic shows no signs of slowing down. Unfortunately, public resistance and fatigue toward COVID-19 interventions and restrictions are at an all-time high. Even China, which was once considered a leader in virus control, has rapidly dispensed with most mitigation strategies.

But make no mistake: COVID-19 still poses a clear and present danger. Research shows that two or more COVID-19 re-infections doubles the risk for death, blood clots, and lung damage, among other negative health outcomes. The risk of cardiovascular events has been found to increase by 4.5 per cent up to 12 months after infection, regardless of age, race, sex, obesity, smoking, or other factors. Moreover, the latest waves of infection are being fueled by new variants that evade immunity from both vaccination and previous infections.

The good news is that we still have powerful prevention tools at our disposal. In fact, there is one widely underused strategy that doesn't require behavioural change or restrictions, that can be used just about anywhere, and that would also help protect us against other airborne viruses, such as RSV and influenza. It requires investing much more in basic measures such as ventilation, air filtration, and ultraviolet germicidal light, and accelerating the exploration of newer discoveries, such as the potential use of aerosol acidity levels to inactivate certain air-

borne viruses. Vaccines are highly effective in reducing the risk of death and serious illness, but they are generally not as effective in preventing transmission. Mask-wearing has become so highly politicised and stigmatised in many Western countries that even some health-care workers are neglecting to wear them. Yet aerosols carrying viruses can linger for hours in the air after they have been exhaled, making it difficult to judge what counts as a high-risk situation. Given all these factors, the best way to reduce the risk of transmission is to decrease the concentration of airborne viruses that are available to be inhaled in the first place.

We need to challenge the prevailing attitude that treats the spread of airborne pathogens in indoor spaces as an inevitable part of daily life. Unlike our ancestors, we spend almost 90 per cent of our time indoors. For decades, governments around the world have invested heavily in food safety, sanitation, and clean drinking water - all in the name of protecting public health. In developed countries, food and waterborne disease have largely been eliminated through a combination of research, legislation, the development of authoritative public-health agencies, and infra-

structure funding. Why shouldn't we give the same priority to achieving clean, pathogen-free air in public and private spaces?

Taking the fight to pathogens before they can infect us will require a multi-pronged strategy. Professional engineering bodies need to develop comprehensive ventilation standards, and new measures will be needed to ensure that these standards are met. That means establishing regulatory bodies to oversee monitoring and enforcement, not just for new construction but also in the retrofitting of existing buildings. To that end, governments should help to provide specialised training for building operators and owners. The goal for all buildings should be to recirculate the air supply of occupied spaces at a rate of at least six air changes per hour.

This may sound like an enormous task. But improvements can be rolled out gradually, and strategically, across different sectors. The immediate priority is to ensure pathogen-free air in hospitals and health-care settings, to protect vulnerable patients, and in airplanes, to stop the rapid spread of new variants around the world.

After that, our focus should shift to public transportation, including trains and buses, and then to offices, schools, and daycare facilities. In addition to preventing viral transmission, better-ventilated areas have been shown to improve children's cognitive performance and reduce illness-related absenteeism. Finally, we should address ventilation in individual

teresting reading and is a timely pointer to our Finance Minister to contain growing income inequality, improve tax collection and reduce market borrowing. There have been two ideological perspectives on taxation. While Arthur Laffer has championed the cause of low taxation as the forerunner of better tax collection, economists like Thomas Piketty and the OXFAM report clearly bring out how this is not the case in actuality. Reaganomics thrived in the 70s when the tax rate on the superrich was reduced from 60% to 30% and income inequality increased sharply in the USA thereafter. In India also, the tax rate on the rich was reduced significantly by P Chidambaram in 1997. As per the World Inequality Report (2022), the bottom 50% of the population in India which accounted for 21% of national income share in India in 1991 witnessed its share coming down to only 15% of the national pie by 2015. In contrast the top 10% who accounted for 32% of national wealth in 1991 now account for 57%. Ironically the 40% middle class who accounted for 43% of national wealth, today account for only 30%. Quite clearly the soft taxation policy after economic liberalisation has made the bottom 50% and middle 40% poorer while the top 10% has harnessed unusual spurt in prosperity.

ity would reduce when countries grow richer. For him inequality is not an accident of history but a feature of capitalism that can be reversed through state intervention. Walter Schedel in another pathbreaking work "Great Leveller" (2017) also found that the average tax rate on top 1% households has come down from 42% to 27% during 1980 to 2013. While agreeing with Piketty's finding, he was not very sanguine whether the government would have the requisite political will to increase the personal income tax rate on the super-rich and impose wealth tax. However, he was prescient enough to conclude that "peaceful policy reforms will prove unequal to the growing challenge of inequality."

In this backdrop, the OXFAM report is a reiteration of concerns raised by Piketty and Schedel but raises interesting insight on the post-pandemic situation, globally. It brings out that for the first time poverty has increased in 25 years. Besides since 2020, the richer 1% have captured 66% of the new wealth created. While the fortune of the billionaire increased by 2.7 billion dollars per day, inflation out paces wages of 1.7 billion workers. Food and energy component doubles the profit of the suppliers in 2022 while 800 million people

budgeting trend has been the sig nificant drop in the tax to GDP ratio from 13.2% in 2018-19 to 10.9% in 2021. This is significantly lower than most emerging market economies like China where it is around 10%. In developed countries the tax to GDP ratio hovers between 20-30%. The report recommends wealth tax up to 5% on multi-millionaires and billionaires which will fetch 1.57 trillion dollars per year which will be enough to lift 2 billion people out of poverty. As an interesting aside, it brings out that if 5% wealth tax is imposed on Ambani and Adani, it will fetch \$9.1 billion which will be sufficient to cover a scheme like MNRGA which supports 100 days' work to nearly 5 crore unskilled men and women. It also recommends that the highest tax rates on millionaires should be increased to 50-60% based on an IMF study. The tendency of the rich corporate to hide their money in tax havens can be stopped by bringing in legislation like GARR which has been working very effectively in countries like Australia and Germany. The report also calls for taxing capital gains at 18% rates and remove the plethora of tax exemptions that principally benefit the rich.

As Nirmala Sitharaman inches towards the new Parliament building to present her budget, quite clearly she will look for a continuance with her strategy to increase capital expenditure, and continue with support for the PLI scheme and SMEs. However, the most disquieting aspect of India's

revenue to spend on most of our social sector programmes. MMR on decline: An accomplishment?

tem generates a sense of accomplishment with a trend closing towards the SDG target of reaching 70 by 2030. Such a divide undoubtedly should deter us from celebrating a national level decline in expected trend and the optimism of achieving the SDG goal of 70 in due time. Kerala obtains an estimate of 19 with a confidence interval of (0-42) as against the national figure of 97 with a confidence interval of (88-106). the range of confidence intervals that clearly make the estimates untrustworthy.

The two other alternative indicators of MMR and lifetime risk of maternal death are 6 per lakh women of reproductive ages and 0.21% respectively. This figure too is very much responsive to the magnitude of reproductive-age women wherein this number would be reasonably lower in southern states vis-à-vis the northern states which needs to be accounted for in the comparison. Alternatively, the lifetime risk needs to be responsive to the levels of TFR that seems to be in place as it is very much in keeping with the pattern. For instance states like Bihar. UP. MP have greater life time risk of maternal death in comparison with other states. Another verification of this out-

come could be in terms of split share of deaths in reproductive years of life due to maternity and non-maternity. Here too there is a pattern match of this split share in peak ages of fertility which subscribes to the fact that maternal deaths are responsive to declining levels of reproduction This engagement with producof increasing the sample size towards obtaining reasonable and trustworthy estimates. An obses sive, indiscriminate drive behind generating indicators in the current SDG environment has an oversight of evaluating indicators in terms of quality. A whole host of indicators generated are headcount indicators which are read temporally overlooking whether the trend emerging is owing to the change in the numerator/denominator. Such indicators being constructed based on a likelihood principle may well be in confrontation with magnitude of the phenomenon raising a debate on whether size or proportion matters? While indicators are ideally desirable to monitor progress, multiple indicators inform more but at the same time need mutual consistency as well, something which is largely overlooked in the race of generating indicators.

Govt vs judiciary

Sir, The row over the appointment of judges is back on table. Ever since the proposal for NJAC (National Judicial Appointments Commission) was struck down by the Supreme Court in 2015, the contours of strained relationship between the government and the judiciary are visible. The argument of Union Law Minister Kiren Rijiju that if the government is just to sign the file sent by the court vis-à-vis appointment of judges where is the need to send such files to the government is not untenable. Vice President Jagdeep Dhankhar has backed the contention of the law minister. The law minister has been asking for a representative from the government side in the collegium system. The Supreme Court judgment in the Keshavananda Bharati case that the basic structure of the Constitution should not be altered has been contested by the law minister. A full-fledged debate on the basic structure is necessary even though a good chunk of the 22 features of basic structure are not negotiable. The government is of the view that the Parliament can amend the basic structure of the Constitution. The government places sovereignty of the Parliament supreme in democracy and is also of the view that the Parliament cannot pass judgments and courts should not make laws. Making laws should be left to the Parliamentarians and the interpretation of the laws must rest with the courts. KV Seetharamaiah, BANGALORE

Apex court again backs Saurabh Kirpal

New Delhi: The Supreme Court Collegium has reiterated its November 11, 2021 recommendation for appointing senior advocate Saurabh Kirpal, an openly gay person, as a judge of the Delhi High Court, rejecting the Centre's contention that though homosexuality stands decriminalised in India, same-sex marriage is still bereft of recognition. New Delhi, Jan 19: From April 1, all vehicles owned by central and state governments, including buses owned by transport corporations and public sector undertakings, that are older than 15 years will be de-registered and scrapped, according to a notification by the Road Transport and Highways Ministry.

NIA chargesheets 2

New Delhi: The National Investigation Agency (NIA) Thursday filed a chargesheet against two accused before a NIA Special Court. Announced in the Union Budget 2021-22, the policy provides for fitness tests after 20 years for personal vehicles, while commercial vehicles will require it after 15 years.

Under the new policy which is effective from April 1, 2022, the Centre has said states and Union Territories will provide up to 25 per cent tax rebate on road tax for vehicles that are purchased after scrapping old vehicles. Last year, Union minister Nitin Gadkari had said his aim is to develop at least one automobile scrapping facility within 150 kilometres from each city centre, while asserting that the country has the potential to become a vehicle scrapping hub of the entire South Asian region.

New Delhi, Jan 19: An accused should not be incarcerated for an indefinite period unless he is proven to be guilty of an offence, the Supreme Court said Thursday while hearing the bail plea of Union Minister Ajay Kumar Mishra's son, who is one of the accused in the Lakhimpur Kheri violence case. The top court said the worst vic-

tims in the case are those farmers languishing in jail and if Ashish Mishra is not granted anything, then they are also likely to remain in jail. Reserving its order on the bail plea, a bench of Justice Surya Kant and Justice J K Maheshwari said it is a case of balancing the rights of the parties.

According to Uttar Pradesh Police FIR, four farmers were mowed down by an SUV, in which Ashish Mishra was seated. Following the incident, a driver and two BJP workers were allegedly lynched by angry farmers.

A journalist also died in the violence. "The state has a right to ensure there is a fair trial uninfluenced by extraneous circumstances. The state has a right because society has a lot of stakes involved. The accused has a right that unless he is proven to be guilty of the of-

fence, he should not be incarcerated for an indefinite period." "To us, this is not one petitioner before us. My principle has been for the last 19 years that I never see the victim who is before me, I also see the victims who cannot come to court and they are the worst victims. You want us to open our mouths. The worst victims are those farmers who are also languishing in jail. Who is going to look after them? If this man is not granted anything, then nobody is going to grant them. They will remain in jail for times to come. The trial court has already rejected their bail," Justice Kant observed orally.

Senior advocate Dushyant Dave, appearing for those opposing the bail plea, said he was surprised and disappointed at this comparison by the court. The top court said this is a case which requires further monitoring by this court and it was inclined to do that.

JOSHIMATH CRISIS Land subsidence shatters many business dreams

As per hoteliers and tour operators, since the crisis of "sinking Joshimath" occurred, tourists have stopped coming to the picturesque locale

Joshimath (Uttarakhand), Jan 19: The hotel owner, the shopkeeper, the laundry owner, the roadside vendor... Hundreds of people watch in dismay as rapidly deepening cracks write the epitaph of their businesses and homes in a sinking town that was bustling till just a few weeks ago. Their dreams for the future shattered, small businesspersons in the Himalavan town of Joshimath wonder how their lives could have been

upended so completely - and so fast. Suraj Kapruwan, a hotel management graduate who left his wellpaying job in Mumbai and returned to Joshimath a few years ago to set up a laundry business, remembers the exact moment his plans for the future crumbled.

It was January 2 when land subsidence led to hairline wall fissures widening with a distant rumbling noise heard in some places, leading to gaping cracks in houses, streets and other establishments of the town of nearly 23,000 people, "The disaster shattered my dreams. Tourists have stopped coming here, and bookings have been cancelled. I had to let go of my staff of nine people," an emotional Kuprawan told PTI.

He set up a laundry to cash in on the booming tourist business of the town, which acts as a gateway to sev-



eral Himalavan mountain climbing expeditions, trekking trails, and pilgrim centres such as Badrinath and Hemkund Sahib, and also the Valley of Flowers, a UNESCO world heritage site.

Carefully calibrated plans for the future have collapsed into noth-

ingness, said residents of this picturesque town. Suraj Singh, who moved to Joshimath from a village about 30 km away so his children could go to a better school, had set up a shop near the Joshimath-Auli ropeway selling trekking shoes, jackets and other equipment to

tourists. But as the land sank, wide cracks appeared near the ropeway to the ski destination, thronged by visitors in this season. Operation of the ropeway was suspended last week when land subsidence aggravated.

Vivek Rawat, the owner of a restaurant near the two hotels dangerously leaning towards each other, said tourists have stopped coming since word spread about the land sinking.

The hotels, Malari Inn and Mount View, have been declared unsafe and are being dismantled.

After the January 2 subsidence, his house was one of those totally damaged. His family of six have shifted to a shelter home provided by the authorities. "We didn't bring this upon us. The government allowed the NTPC to dig a tunnel here," said Vyapar Mandal Sangh's Bhandari.

LIVING WITH DISABILITY High fluoride in water takes its toll on villages

Sambhar (Rajasthan), Jan 19: Two cousins, one 18 and the other six, struggling with deformed limbs and stunted growth, and several others, including toddlers and elders, in the joint family coping with frequent joint pains - knowing the water they drink could be the reason but doing so anyway because there are no options.

That's the story of not just Singh family but others as well in the villages of Devpura and Moondwara in Rajasthan's Sambhar block, about 80 km from the Sambhar salt lake, India's largest inland salt lake. The villagers, many of them unlettered, blame the lake water that has contaminated the groundwater as the main reason for high salinity and fluoride content in drinking water.

According to Om Prakash Sharma, head of the NGO Gram Chetna Kendra that works in the area, disability in the two villages about 50 km from Jaipur averages about 10 in 1,000. The national number is 5 in 1,000 people. That is almost double the normal average, he pointed out.

The disability is directly linked to high fluoride content in the area, a fact backed by studies, he said Long term effects of skeletal fluorosis takes place if the fluoride level in water is more than 1 mg/litre, said Dr Aman Dua, director, joint replacement and orthopaedics, at Delhi's Fortis Escorts hospital.

"So there is widening of bones. deformities in joints and the symptoms are specially marked in the

Her mother Shanti Devi points to the pump from where the family gets their water. It looks clear to begin with but collect it in a container and the salt soon settles at the bottom. "The drinking water we get here is saline. This is leading to pain in different parts of the body-hands, legs. Our children are becoming disabled at different ages, some at six months, some at 12 months, some at five years,'

Shanti Devi said. The government, she added, started a pipeline to connect them to a different source but did not finish work on it so they continue to be dependent on groundwater The joint family of 13 lives in Devpura, about 50 km from Jaipur. And nothing has changed for them since Lalita's disability was first noticed 13 years ago.

Jaipur, Jan 19: As Assembly elections near in Rajasthan, the confusion over leadership seems to be growing for both the ruling Congress and opposition BJP in the desert state.

While former CM Vasundhara Raje is maintaining a distance from BJP's much-talked about 'Janakrosh Yatra', the Congress too is battling the confusing situation arising post the September 25 (2022) incident, when MLAs from Chief Minister Ashok Gehlot's camp convened a parallel meeting after the Congress high command called an official meeting to decide on the leadership change issue in the state.

Due to lack of clarity from the high command of both the parties, there is confusion and tussle at the internal level of the two outfits. And its effects can be seen in the programmes and preparations of the Congress and the BJP in an election year.

The tussle between Ashok Gehlot and Sachin Pilot over the CM's chair is an open secret now, which has been going on continuously since the July 2020 rebellion by the Pilot camp. At the same time, after the resignation politics on

September 25, when 91 Congress MLAs submitted their resignation

Senior Congress leaders have been continuously making statements, describing both Gehlot and Pilot as assets for the party. However, none has confirmed that Gehlot shall stay as the CM till the time the state goes to the polls at the end of this year, or if Pilot can be made the Chief Minister before the elections

Congress sources say that the party is studying the circumstances and shall take a decision accordingly. The tussle and confusion at the upper level of Congress is affecting the leaders and workers at the lower level. In an election year, leaders are confused about asking for tickets and other responsibilities. This is because the workers still feel that the CM can change.

On the other hand, if the CM does not change, the post of state president or chairman of the campaigning committee can go to the Pilot camp. Similarly, due to the lack of clarity regarding leadership in the BJP, the party workers at the lower level are not able to clear their mindset.

In view of the upcoming elections, there is already a lot of confusion over BJP's CM face. Many contenders, including former CM Vasundhara Raje, Union minister Gajendra Singh Shekhawat, state unit chief Satish Poonia, leader of opposition Gulabchand Kataria are in the fray for the top post.

On Wednesday, the police have arrested Surendra Yaday, who used to sell ganja-laced chocolates to even children from his shop in Triplicane and recovered seven kg contraband from his shop.

they indulged in sexual conversations online, they said. On being asked what measures they would like to take if their children faced OCSEA, only 30 per cent of the parents stated that they would go to the police station and file a complaint, while a "worrying 70 per cent discarded the option" Further, only 16 per cent of par-

ents reported being aware of any legislation relating to OCSEA. These findings indicated a huge information deficit and low trust in the legal and law enforcement institutions among the parents, the report said.

Germany, US at odds over tanks

Kyiv/Berlin, Jan 19: Western allies pledged billions of dollars in new weapons for Ukraine Thursday, but the big question of whether to send heavy tanks remained unanswered, with Berlin yet to signal whether it would lift a veto.

Fearing winter will give Russian forces time to regroup and unleash a major attack, Ukraine is pushing for German-made Leopard battle tanks, which are held by an array of NATO nations but whose transfer to Ukraine requires Germany's approval.

A German government source said Berlin would lift its objections if Washington sends its own Abrams tanks. German Chancellor Olaf Scholz, a Social Democrat, has been reluctant to send weapons seen as provoking Moscow. Many of Berlin's Western allies say that concern is misplaced, with Russia already fully committed to war.

The two countries tried to resolve the stand-off as U.S. Defence Secretary Lloyd Austin and the new German Defence Minister Boris Pistorius met in Berlin. But there was no word on whether they had made progress ahead of a meeting of dozens of allies on Friday at Ramstein, Washington's main European air base.

NK sustains high defence spending with new budget

Seoul (South Korea), Jan 19: North Korea's rubber-stamp parliament has passed a budget that sustains a high level of defence spending despite the country's' economic troubles as leader Kim Jong Un pushes for an aggressive expansion of his nuclear arsenal.

State media reports indicated Kim didn't attend the Supreme People's Assembly's two-day session that ended on Wednesday. Pyongyang's official Korean Central News Agency didn't mention any comments by assembly members toward the United States or South Korea in Thursday's report on the meetings.

The assembly convened weeks after Kim called for an "exponential increase" of nuclear warheads, mass production of battlefield tactical nuclear weapons targeting 'enemy" South Korea and the development of more advanced intercontinental ballistic missiles designed to reach the US mainland.

Macron to proceed with pension reform

Paris, Jan 19: Hundreds of thousands protested on the streets of Paris and other French cities on Thursday amid nationwide strikes against plans to raise the retirement age, but President Emmanuel Macron insisted he would press ahead with the proposed pension

reforms. Nationwide strikes severely disrupted transport, schools and other public services across France. During a news conference at a French-Spanish summit in Barcelona, Spain, Macron said that "we must do that reform" to "save" the pension system. "We will do it with respect, in a spirit of dialogue but also determination and responsibility," he added.

As Macron spoke, riot police pushed back against some protesters throwing projectiles on the sidelines of the largely peaceful Paris march. The incident appeared to quickly get back under control. French workers would have to work longer before receiving a pension under the new rules - with the nominal retirement age rising from 62 to 64.

In a country with an aging population and growing life expectancy where everyone receives a state pension, Macron's government savs the reform is the only way to keep the system solvent. Unions argue the pension overhaul threatens hard-fought rights, and propose a tax on the wealthy or more payroll contributions from emplovers to finance the pension system. Polls suggest most French people also oppose the reform. More than 200 rallies were staged around France on Thursday, including a large one in Paris involving all France's major unions. Jean Paul Cachina, 56, a worker in human resources, joined the march in the French capital - a first ever for him. "I am not here for myself," he

said. "I am here to defend the vouth and workers doing demanding jobs. I work in the construction industry sector and I'm a firsthand witness of the suffering of employees.' Many young people were among the Paris crowd, chanting "the youth is protesting. Macron you are finished.

High school student unions had urged members to join the protests. Nathan Arsac, 19, a student and member of the UNEF union, said: "I'm afraid of what's going to happen next. Losing our social achievements could happen so fast. I'm scared of the future when I'll be older and have to retire."

Sylvie Béchard, a 59-year-old nurse, said she joined the march because "we, healthcare workers, are physically exhausted." "The only thing we have is demonstrating and to block the economy of the country," she added.

The economic cost of the strikes was not immediately clear. The government worries that a big show of resistance Thursday could encourage unions to continue with protracted walkouts that could hobble the economy just as France is struggling against inflation and trying to boost growth. Police unions opposed to the retirement reform also took part in the protests, while those on duty braced for potential violence should extremist groups join the demonstrations.

HK to scrap isolation rule

Hong Kong: Hong Kong will scrap its mandatory isolation rule for people infected with COVID-19 starting January 30 as part of its strategy to return the semi-autonomous Chinese city to normalcy, the city's leader said Thursday. For most of the pandemic over the last three years, Hong Kong has aligned itself with mainland China's "zero COVID" strategy, requiring those who test positive to undergo quarantine.

His statements during a major political conference in December underscored an intensifying nuclear standoff with the United States and its allies in Asia after he pushed North Korea's weapons tests to a record pace in 2022.

The North fired more than 70 missiles last year, including multiple ICBM launches, and conducted a series of tests it described as simulated nuclear attacks on South Korean and US targets.

Two killed, many hurt in stampede

Baghdad, Jan 19: A stampede outside a stadium in southern Iraq Thursday killed at least two people and injured dozens, a health official said.

The deadly incident happened as spectators gathered to attend the final match in the first international soccer tournament held in the country in four decades. The official Iraqi News Agency said some of the 60 people who were injured outside the Basra International Stadium were in critical condition

A physician at Basra General Hospital told The Associated Press that two people were killed and 38 were injured, some of whom have been discharged from the hospital. The physician spoke on condition of anonymity because he was not authorised to talk to the media.

Iraq's Interior Ministry in a statement urged people without tickets for the final match to leave the stadium area. It said the stadium was full and that all gates have been closed. Iraq's new Prime Minister Mohammed Shia al-Sudani, who arrived in Basra on Thursday, urged people to help authorities in order to "show the final match of 25th edition of the Gulf Cup in its most beautiful form."

Later, the Iraqi News Agency reported that giant screens were placed in different public places, as well as another stadium in Basra, so that people can watch the match. The game in the eight-nation Arabian Gulf Cup will see Iraq play Oman later Thursday. The Oman Football Association said Omani citizens who are currently at Basra's airport will start returning home for their own safety and in order to help-Iraqi authorities make the final match "successful."

New Zealand's Ardern, an icon to many, to step down

Wellington, Jan 19: New Zealand Prime Minister Jacinda Arden. who was one of the first members of her generation elected as a national leader and became a global icon of the left, said on Thursday she was leaving office after five and a half years.

Ardern was praised around the world for her handling of the nation's worst-ever mass shooting and the early stages of the coronavirus pandemic. But she was facing mounting political pressures at home and a level of vit riol from some that hadn't been experienced by previous New Zealand leaders

Still, her announcement came as a shock throughout the nation of 5 million people. Fighting back tears, Ardern told reporters in Napier that February 7 would be her last day as prime minister.

"I know what this job takes, and I know that I no longer have enough in the tank to do it justice. It is that simple," she said. Ardern became an inspiration to women around the world after first winning the top job in 2017 at the relatively young age of 37. She seemed to herald a new generation of leadership — she was on the verge of being a millennial, had spun some records as a part-time

DJ, and wasn't married like most She notched up centre-left victories while right-wing populism

was on the rise globally: she pushed through a bill targeting net-zero carbon emissions by over for 2050, oversaw a ban on assault New

politicians.

Her approach to the pandemic earned the ire of US President Donald Trump, and she ended up refuting wildly exaggerated claims from Trump about the spread of COVID-19 after he said there was a massive outbreak and "It's

Ardern said about Trump's comments in an interview with The Associated Press at the time. In 2018, Ardern became just the second world leader to give birth while holding office. Later that year, she brought her infant daughter to the floor

UN General Assembly in New York. In March 2019, Ardern faced one of the darkest days in New Zealand's history when a white supremacist gunman stormed two mosques in Christchurch and slaughtered 51 worshippers during Friday prayers. Ardern was widely praised for her empathy with survivors and New Zealand's wider Muslim community in the aftermath.

After the mosque shootings, Ardern moved within weeks to pass new laws banning the deadliest types of semi-automatic weapons. A subsequent buyback scheme run by police saw more than 50,000 guns, including many AR-15-style rifles, destroyed.

Less than nine months after the shooting, she faced another tragedy when 22 tourists and guides were killed when the White Island

volcano erupted. Ardern was lauded globally for her country's initial handling of the coronavirus pandemic after New Zealand managed to stop the virus at its borders for months. But she was forced to abandon that zero-tolerance strategy as more contagious variants spread and vaccines became widely available. Ardern faced growing anger at home from those who opposed coronavirus mandates and rules. A protest against vaccine mandates that began on Parliament's grounds last year lasted for more than three weeks and ended with protesters hurling rocks at police and setting fires to tents and mattresses as they were forced to leave. Bangalore, Jan 19: Foreign portfolio investors (FPIs) offloaded Indian equities worth ₹150.68 hillion in the first half of January, the most since the end of September 2022, data from National Securities Depository Ltd showed.

The selling coincided with a slide in equity benchmarks, with Nifty 50 falling nearly 1% between January 1 and January 15, 2023. Among sectors, foreign investors sold off ₹67.01 billion worth of shares in financials, followed by ₹34.57 billion in IT and ₹28.25 bil-

lion in oil & gas consumable fuels. Metals was the only major sector that saw renewed interest from foreign investors, who bought ₹25.18 billion worth of equities. China is the world's largest consumer of metals.

Fintech startups hit hard by funding winter

INDIA IS STILL THE THIRD-HIGHEST FUNDED COUNTRY IN TERMS OF FUNDING RECEIVED IN THE FINTECH SECTOR. ONLY BEHIND THE US AND THE UK

New Delhi, Jan 19: Fintech startups in India raised \$5.65 billion in 390 rounds last year, a massive drop of 47 per cent in terms of funding amount and 29 per cent in the number of rounds when compared with 2021, a report showed Thursday.

This drop in funding can be attributed to the decline in latestage funding from \$8.3 billion in 2021 to \$3.7 billion in 2022, a drop of 56 per cent, according to data provided by global software-as-aservice (SaaS)-based market intelligence platform Tracxn.

Fintech startups recorded 13 funding rounds of \$100 million+ in value. This is a massive drop of 50 per cent, from 26 rounds in 2021.



Y Combinator, Tiger Global the space, with more than 20 in-Management and Lets Venture vestments in 2022. were the most active investors in

fintech sector received unicorn status in 2022, far lower compared with 13 new Unicorns in 2021, said the report.

Among the cities, fintech companies in the Delhi-NCR region (Delhi, Noida and Gurugram) have raised a combined funding of \$14.9 billion till date, followed by Bangalore (\$10.2 billion) and Mumbai (\$4.2 billion).

India is still the third-highest funded country in terms of funding received in the fintech sector, only behind the US and the UK, said the report.

"The country is currently experiencing a funding winter. Growing inflation and macroeconomic tensions have made the investors step back from makingbig investment decisions," the findings showed.

INDIA DOWN WALES 4-2

Bhubaneswar, Jan 19: A belowpar India beat tournament debutants Wales 4-2 in their final pool match but failed to qualify directly for the quarterfinals of the FIH Men's World Cup here Thursday. India can still qualify for the quarterfinals if they beat New Zealand in their crossover match here Sunday.

Akashdeep Singh (32nd and 45th minutes) struck twice, while Shamsher Singh (21st) and Harmanpreet Singh (59th) got the other goals for India. Gareth Furlong (42nd) and Jacob Draper (44th) were the goal-getters for Wales.

Needing to win by a margin of eight goals to directly qualify for the quarterfinals, India failed to live up to the expectations as they finished second in Pool D behind England

Both India and England ended their pool engagements on seven points each after winning two matches and drawing one but the European side topped Pool D on the basis of superior goal difference.

England, who had outclassed Spain 4-0 in the earlier Pool D match here, have a better goal difference of plus nine as against four of India. When two teams are on same points and won equal number of matches, the ranking is decided by goal difference.

India will play New Zealand - the third-placed team in Pool C-Sunday in their crossover match here.

England wait one of the four qualifiers to the quarterfinals from the crossover matches. They play January 25 against the winner of the second placed team in Pool A vs the third placed side in Pool B.

Played under windy conditions with the temperature hovering just over 20 degree celsius at the jampacked Kalinga Stadium, India played their worst match of the

tournament. India dominated all throughout but their goal-scoring woes continued for the second match in a row. The Indians got seven penalty corners and at least six other scoring chances but their forwards wasted most of them

Mandeep Singh earned a penalty corner in the seventh minute of the second quarter. Harmanpreet's drag-flick was rebounded from a defender but Shamsher's powerful shot from top of the circle beat the Wales goalkeeper to hand India the lead. India led 1-0 at halftime.

In the third quarter, Akashdeep found himself clear on the top of Wales circle and his fierce hit beat the rival goalkeeper for India's second goal. Soon after, India's defence was breached for the first time in the tournament with Furlong sounding the board from

Wales' second set piece three minutes from the end of third quarter. Less than a minute from the end of the third quarter, Wales stunned

the vociferous home crowd as they equalised through Draper, who

beat Indian goalkeeper PR Sreejesh all ends up from his side's third penalty corner.

Akashdeep brought back the deafening roar of the home crowd again as his thunderous reverse shot in the first minute of the fourth quarter gave India the lead again. A minute before the final hooter, Harmanpreet scored his and India's first goal from penalty corner to make it 4-2.

England seal quarters berth

England came into the match with four points from two matches and led India on goal difference. By winning 4-0 against Spain Thursday, England set India an uphill task of scoring eight goals to overtake them on goal difference

or scoring seven goals with six field goals in their final Pool D match against Wales to finish on top of the table and claim the direct berth into the quarterfinals. The team that finishes second and Spain will make it to the crossover matches.

Phil Roper (10th min), David Condon (21st min), Nicholas Bandurak(50th min) and Liam Ansell (51st) scored for England as they made a good start, quelled a

fightback from Spain in the second and third quarter before scoring twice in the final quarter to seal a comfortable victory. England thus finished the group phase of the 2023 World Cup unbeaten and without conceding a goal.

Bhubaneswar, Jan 19: Threetime champions Netherlands registered a record-breaking 14-0 win over debutants Chile to secure a direct qualification into the quarterfinals, while Malaysia stunned New Zealand 3-2 to finish second in Pool C at the FIH Men's Hockey World Cup here on Thursday.

With three wins from as many games, Netherlands finished at the top of Pool C with maximum nine points, while Malavsia were second with six points from two victories.

In the second match of the day, World No.3 Netherlands toyed with Chile, ranked 23rd, and scored goals at will to register the biggest margin of victory in a World Cup match. The record for the biggest margin of win in a hockey World Cup match was earlier held by World No.1 Australia, who thrashed South Africa 12-0 in New Delhi.

Jip Janssen (sixth, 29th, 34th, 44th minutes) and skipper Thierry Brinkman (25th, 33rd, 58th) scored a hat-trick each, while Koen Bijen (40th, 45th) struck a brace. Derck de Vilder (22nd), Thijs van Dam (23rd), Terrance Pieters (37th), Justen Blok (42nd) and Teun Beins (48th) were the other goal-getters for the Dutch. Janssen's all four

goals came from penalty corners. The Netherlands, who have won the World Cup thrice and finished runners-up in the last two editions, earned 18 penalty corners from which they converted six, while Chile got just two PCs in the match.

Earlier, Malaysia's star player Faizal Saari (eighth, 56th minutes) struck a brace, while Razie Rahim converted a penalty corner in the 42nd minute as World No.11 Malaysia shocked No.9 New Zealand 3-2 in another Pool C match.

Hayden Phillips (51st) and Sam Lan (52nd) scored two goals in as many minutes to raise New Zealand's hopes before Saari drew the final blood four minutes later. Lan's strike was also the 2500th goal of the World Cup.

New Zealand are third in Pool C with just one win, while Chile finished winless. While Netherlands qualified directly for the last-eight round, Malaysia and New Zealand will play crossover matches to book their place in the quarterfinals.

The top teams from the four pools qualify directly for the lasteight, while the second and thirdplaced sides play in the crossovers matches to fill up the remaining four slots. Chile will play in the fifth to 16th place classification matches

As if he needed another distraction, Djokovic was flustered enough by a heckler that he asked chair umpire Fergus Murphy to have the spectator removed from Rod Laver Arena, saying: "The guy's drunk out of his mind. He's been provoking. He just wants to get in my head.'

Sania-Danilina sail into Oz Open Rd 2

MELBOURNE: Competing in her last Grand Slam, India tennis star Sania Mirza cruised into the second round of the Australian Open here Thursday. Sania and her Kazakh partner Anna Danilina prevailed over Hungary's Dalma Galfi and American Bernarda Pera 6-2 7-5 in one hour and 15 minutes in the women's doubles. A six-time Major champion (three in doubles and three in mixed doubles), the 36vear-old Indian has announced that the Australian Open is her last and she would be retiring after WTA 1000 Dubai Tennis Championships slated from February 19.

Melbourne Park, to add to his own record, and a 22nd Grand Slam title overall, to equal Nadal's, Djokovic put everything aside and beat 191st-ranked French qualifier Enzo Couacaud 6-1, 6-7(5), 6-2, 6-0.

It was Djokovic's 23rd consecutive win at the Australian Open, a streak that paused a year ago when he couldn't play in the tournament because he was not vaccinated against COVID-19.

New Delhi, Jan 19: Defending champion Lakshya Sen suffered a heartbreak, going down narrowly to world number 20 Rasmus Gemke of Denmark in the second round as the Indian ended at the Yonex-Sunrise India Open here Thursday.

World No.12 Sen reduced an 8-14 deficit in the decider to 13-14 after losing the second game but couldn't go the distance, losing 21-16, 15-21, 18-21 to Gemke in a match that lasted an hour and 21 minutes at the IG stadium. Gemke will now take on top seed and compatriot Viktor Axelsen, who outwitted China's Shi Yu Qi 21-16, 16-21, 21-9.

Reigning champions in men's doubles, Satwiksairaj Rankireddy and Chirag Shetty, who had come into the tournament after a semifinal finish at Malaysia Super 1000 last week, withdrew from the tournament after the former suffered a hip injury ahead of their second-round clash.

London Games bronze medallist Saina Nehwal also found the going tough against Olympic champion Chen Yufei, surrendering meekly 9-21, 12-21 in just 32 minutes to draw curtains on India's campaign at the Super 750 tournament. Earlier, Commonwealth Games

bronze medallists Gayatri Gopichand and Treesa Jolly lost 9-21, 16-21 to sixth-seeded Chinese Zhang Shu Xian and Zheng Yu in women's doubles pre-quarterfinals.

The rising men's doubles pair of Krishna Prasad Garaga and Vishnuvardhan Goud Panjala also was no match for China's Liang Wei Keng and Wang Chang, going down 14-21, 10-21 in 33 minutes.

Also advancing to the next round were fourth seed Jonatan Christie of Indonesia, third seed Loh Kean Yew of Singapore and fifth seed Chou Tien Chen of Chinese Taipei in men's singles. Top seed Akane Yamaguchi of Japan, Spaniard Carolina Marin and He Bingjiao of China also made it to the quarters in women's singles.
