# Odisha's allocation hiked by ₹3K crore

New Delhi, Feb 2: Odisha will receive ₹46,251 crore, an increase of ₹3,261 crore, as the share of Union Taxes and Duties for the year 2023-24. The Union government will distribute a total amount of ₹10.21 lakh crore to the states, says the section 'Receipt Budget, 2023-24'.

There are various heads under which Odisha will receive the above mentioned amount. The state will receive ₹14.955 crore under central

Parliament was adjourned for the day after the Opposition stalled proceedings in both the Houses. demanding a Joint Parliamentary Committee (JPC) or a Supreme Court-monitored probe into the allegations of fraud and manipulation against billionaire Adani's companies that have triggered an

unprecedented stock crash. A united Opposition, led by the Congress, raised the issue as soon as the Houses commenced for the day with their MPs giving adjournment notices for a discussion on the issue.

The chair in both the Upper and Lower Houses rejected the notices, prompting Opposition leaders to question the presiding officers on procedures and asking what could be more serious than demanding a discussion involving hard-earned money of Indians in LIC and SBI invested in the Adani Group stocks. Lok Sabha Speaker Om Birla denied the request for discussion, asking members to 'not to make unsubstantiated claims' while

President Jagdeep Dhankhar, rejected notices, saying they were 'not in order'. Congress president and Leader

of Opposition in Rajya Sabha Mallikarjun Kharge led the charge Rajya Sabha Chairperson, Vicein the Upper House, with nine MPs

of various parties giving notices under Rule 267 seeking suspension of the day's business to discuss the Adani-Hindenburg issue.

In the Lok Sabha too, the Opposition MPs stormed the Well forcing adjournment within minutes of the House meeting and then again soon after lunch.

Leaders of several parties including the Congress, DMK, TMC, SP, JD (U), Shiv Sena, CPI(M), CPI, NCP, IUML, NC, AAP and the Kerala Congress, earlier held a meeting in the morning in Kharge's chamber in the Parliament, where they strategised their plan.

Kharge told reporters that the Opposition parties have also called for day-to-day reporting of the JPC or the SC-monitored probe into the issue as it concerned public money invested in Adani stocks

which have taken a beating on the markets ever since the Hindenburg charges came out.

"Keeping public interest in mind, we want a thorough probe into the Adani issue either by the JPC or the Supreme Court-monitored probe. There should also be day-to-day reporting of the investigation on the issue," Kharge later told reporters along with a host of representatives of other parties.

The Opposition protest came a day after Adani Enterprises recalled its full-subscribed ₹20,000crore Follow-on Public Offer (FPO) and said it will return the proceeds to investors. Opposition parties also targeted the government over the issue and asked why it was silent on the allegations and why no investigation has been ordered **MORE P11** so far.

Odisha had received ₹42,989.33 crore for the year 2022-23 as per the revised estimates.

According to the Union government, the distribution was planned as per the recommendation of the 15th Finance Commission which fixed the

41 per cent of the net proceeds of sharable Central Taxes. Accordingly, Odisha is entitled to receive 4.528 per cent of share of Union taxes.

Uttar Pradesh will receive around 18 per cent of the shares of Union Taxes and duties which is the highest among all states and amounts to ₹1,83,237.59 crore. The second highest share has gone to Bihar which will receive ₹1,02,737 crore.

Union Finance Minister Nirmala Sitharaman tabled Wednesday the Budget for 2023-24 in the Lok Sabha. The Budget allocation to the Indian Railways always assumes significance. In the budget, the Finance Minister announced highest-ever

> outlay of ₹2.40 lakh crore for the Indian Railways. Such a huge outlay will help the Indian Railways roll out major projects, new 'Vande Bharat' trains and the electrification of new railway lines.

Sources said that Odisha is all set to feature prominently in the allocation of the Railway Budget. With the Railway Minister from Odisha, the expectations are sky high. It should however, be stated that giving his reaction Wednesday to the Budget, Odisha Chief Minister Naveen Patnaik had expressed concern at the reduction of funds for MGNREGS.

# 2 minors drown in Malkangiri

Malkangiri, Feb 2: Two minor girls met their watery grave Thursday as they fell into a waterfilled pit at Dhepasahi under Chitrakonda police limits in this district. The deceased were identified as Subhadra Kamar (4) and Sumi Janam (3)

Local residents pointed out that the pit had been constructed by a contractor. He used to store water there when his company was constructing a road in the locality. The two girls were playing near the pit when they accidentally slipped into it and fell. As there was no one nearby, their cries for help went unheeded.

When the two girls did not return home, the family members started looking for them frantically. They discovered the two girls inside the pit. Villagers rushed to the spot and rescued the two girls in a critical condition. The two were rushed to a local hospital nearby, but doctors pronounced the two dead on arrival. A pall of gloom descended on the village as news of the demise of the two kids spread.

Locals alleged that they had requested the contractor to fill up the pit once the construction of the road was over. They pointed that despite doing so, the pit had been left unattended. The villagers said that had the large hole full of water had been covered, tragedy could have been averted. They demanded stringent action against the contractor.

On being informed, police reached the spot and launched a probe into the matter.

Cambridge, Feb 2: The experimental aircraft 'X-57', developed by Nasa, is due to fly for the first time within the next few months. It has an impressive 14 propellers along its wings and is powered entirely by electricity. This may be just the first step to finding an alternative to aviation fuels considering the fight against global warming and climate change. The demand for aviation is growing, but at the same time people are wanting to get rid of fossil fuels. The 'X-57' uses lithium batteries

to run electric motors for its propellers. But the energy one gets from batteries, relative to their weight, is 50 times less than one can

#### get from aviation fuel.

The 'X-57' is a modified, fourseater, Italian-built 'Tecnam P2006T' aircraft. It relies on a combination of lots of propellers, small motors and many batteries spread out across an aircraft, known as 'distributed propulsion'. As of now however, using it in a commercial way is ruled out. However, what needs to be noted that it is the first step towards developing an aircraft that does not run on aviation fuel.

What's different about the 'X-57' is that the wings are completely redesigned with propellers positioned to optimise air flow around them. When a propeller is not needed, its blades can be folded back to reduce drag

Propeller technology generally



is having a rebirth. Designs are becoming not just more efficient, but also less noisy and more affordable. The speed and pitch angle of propellers can even be changed during flight to adapt to the different aircraft speeds required for takeoff, landing and cruising, a member of the research team said.

These aircraft might more resemble helicopters than aircraft, and might mean conventional airports with long runways and large terminals will be a thing of the past. However, who cares as long as carbon emission is prevented, researchers said.

With a range of about 160km

hour, the 'X-57' is not expected to lead to a replacement technology for long-haul flying. Instead, shorthop flights with 10 or so passengers are a good and potentially possible target for early, batterypowered flights. An area of concern however, is

and a flight time of about one

the lithium-ion batteries. This is because they are heavy and are prone to catching fire easily. In such a situation it will be an important challenge for electric aircraft developers to overcome.

There are advantages to using batteries. Their weight stays constant throughout the flight, meaning they don't need to bestored in the wings as aviation fuel traditionally has been.









# **Budget exposes BJP's** false propaganda: BJD

Bhubaneswar, Feb 2: The Biju Janata Dal (BJD) Thursday said that the Union budget has exposed the Bharatiya Janata Party's false propaganda and deception on Ayushman Bharat scheme.

Addressing mediapersons here, BJD spokesperson Shreemayee Mishra said that on a regular basis. Odisha BJP has been harping on how Ayushman Bharat Yojana is a better programme than the state government's Biju Swasthya Kalyan Yojana (BSKY).

However, Wednesday's Union Budget has exposed the Odisha BJP's false propaganda and decep tion on Ayushman Yojana, she said. Under the outlay on major schemes in the Union Budget for the year 2023-24, the Centre has provided only ₹7,200 crore towards

Ayushman Bharat. "When we take into consideration India's 28 states and 8 Union territories, per state/UT, it comes to around ₹200 crore per annum for Ayushman Bharat Yojana, Mishra said.

On the other hand, she said, the BJD government spends about ₹6.000 crore under its BSKY which is on average about ₹200 crore per district per year in Odisha.

It means, ₹200 crore of Ayushman Bharat scheme per year would only cover one district of Odisha. Where would the rest 29 districts of Odisha go? What relief do the people of Odisha get?, she asked.

BJD Another leader Gautambuddha Das said a woman can only avail treatment of ₹5 lakh

Housing and Urban Development (H&UD) principal secretary G Mathi Vathanan received the International Award in the event held at the Ford Foundation Centre for Social Justice in the New York

City. H&UD joint secretary Sarada Prasad Panda has accompanied Mathi Vathanan for the event.

MUKTA was selected as a winner among 260 applications from 155 cities in 65 countries.

Chief Minister Naven Patnaik congratulated the team and Housing and Urban Development department on their successful journey. In his twitter account Patnaik said, "Congratulations to H&UD department on winning WRI Ross Cities Ross Center Prize 2021-22 for cities for #MUKTA scheme. Glad to know that our effort to create mass employment opportunities for vulnerable people during COVID19 has been appreciated at global level.'

The Prize for Cities, WRI's Urban Transformation Award recognises the leaders trying to create more sustainable and inclusive cities worldwide. The award acknowl-



edged MUKTA's innovative approach to respond uncertainty, disruption and crisis by creating mass employment opportunities for the urban poor and migrant labourers by engaging them in development work of cities to live at ease in times of turbulence.

Till date, 7 lakh urban poor and migrant workers across Odisha's 114 cities have got enrolled in 22,500 community-level development works worth ₹208 crore, which include paved roads, drains, rainwater harvesting, community cen-

tres, plantation, water bodies reiuvenation and public space development



### Myo-Mission aims to develop therapies for rare diseases **Dillip Parida takes charge** as Med Supdt of City AllMS

About 95% of rare diseases do not have a treatment, and in most cases the patients have to live with extreme disability, often also leading to death

esearchers are working on a new platform that aims to develop several treatments, including gene and mRNA therapies, for three rare diseases which are estimated to affect about one million people in India.

The Myo-Mission anchored by Ashoka University, Sonipat in partnership with 18 institutions and 38 investigators across India, will enhance capabilities for carrying out future clinical trials for Duchene Muscular Dystrophy (DMD), GNE Myopathy and Limb-Girdle Muscular Dystrophy (LGMD).

All the three diseases either lead to muscular weakness or muscle wasting, and can cause permanent disability.

"In India, estimates suggest that the three diseases combined affect about one million people. The burden of these debilitating, often incurable diseases is made greater by the rarity and lack of diagnosis and treatment options in India," said Alok Bhattacharva. Professor of Biology at Ashoka University.

"Our goal is to develop patient cohorts, create a comprehensive database, and conduct research on disease progression to pave the way for clinical trials," Bhattacharya told PTI.

In its Phase 1, the mission plans to have five clinical centres in Mumbai, Bangalore, Chennai, Delhi and Anand in Gujarat that have been managing patients of these diseases.

The mission researchers plan on different aspects such as developing systems or technology platforms for therapeutic molecules for treatment, as well as developing animal and cellular models for testing purposes.

The clinical groups associated with the mission will also monitor the progression of the disease for the Indian patients, the researchers said.

Such models for diseases such as GNE myopathy and LGMD have not been done for Indian patients and are required for carrying out clinical studies and drug trials, ac-



cording to a statement.

The mission researchers, who have applied for funding from the government, are aiming at multiple types of treatments. This is because not all types of therapies are suitable for all patients as well as different diseases, the researchers said.

Availability of multiple therapies will help to provide clinical treatment to large fraction of patients, they said.

The platform being proposed are gene therapy, mRNA therapy, oligo-nucleotide-based therapies and small molecules that target known or novel disease associated molecules

These technologies once developed, will also be useful for developing drugs for other diseases, according to the researchers.

A substantial fraction of all rare diseases are genetic disorders that mainly get inherited from parents. Since human beings have about 25,000 genes, a mutation in a set of genes carries a disease risk.

Globally, it is estimated that there are about 7,000 types of rare diseases out of which about 80 per cent are likely to have a genetic

basis. The clinical methods of diagnosis for such diseases exist. however they are often not conclusive.

Usually, the final diagnosis can only take place through DNA sequencing of both parents and children. However, this method is expensive and not affordable for a large section of the population, especially in lower and middle income countries.

In India, about 500 rare diseases have been identified, Bhattacharya said.

The number of individuals suf-

fering from one particular disease in the country may be small, but given the population size and number of such diseases, the overall burden is estimated to be quite large, approximately 7 crore individuals, he said.

These diseases often go undiagnosed in the country due to reasons such as high cost, lack of testing infrastructure even in urban centres, and insufficient awareness even among clinicians.

About 95 per cent of rare diseases do not have a treatment, and in most cases the patients have to live with extreme disability, often also leading to death beyond the age of around 20 years. For the 5 per cent of diseases that have a treatment, but not cure, the cost of treatment

is extremely high. Most drugs are made abroad and their cost ranges from lakhs to crores, leaving a large section of Indian population outside the ambit of adequate healthcare.

'We aim to improve awareness and access to drugs to ultimately improve the lives of millions affected," Bhattacharya said.

"We are awaiting for the government to make a decision about funding the mission," the scientist added. AGENCIES

# JUDICIAL INFRASTRUCTURE SC takes note of 'mismatch' between Centre, state data

New Delhi, Feb 2: The Supreme Court Thursday took note of a "mismatch" between the data of the Department of Justice in the Union Law Ministry and the Odisha government's communication to the ministry on the utilisation certificates (UCs) of the central assistance released to the state in 2018-19 and 2019-20 for judicial infrastructure

The court directed that a meeting be convened within two weeks between the Department of Justice, the law secretary of the Odisha government and others to ensure the reconciliation of the UCs that are stated to have been submitted by the state.

A bench headed by Chief Justice DY Chandrachud observed that the data made available before it by Additional Solicitor General (ASG) Aishwarya Bhati, who appeared in the court on behalf of the Centre. indicated that an amount of ₹35.69 crore was released to Odisha for 2019 20 and for 2020-21, 2021-22 and 2022-23, no funds were released.

The bench, also comprising Justices PS Narasimha and J B Pardiwala, observed that accord ing to a note from the Department of Justice, the UC for the unspent



balance of ₹22 crore for 2019-20 has not been submitted.

It referred to a report submitted by senior advocate Vijay Hansaria, who is assisting the court as one of the four "amici curiae" (friends of the court) in the matter pertaining to infrastructure and filing up of vacancies in district courts. The bench observed that the re-

port contains a communication dated December 17 last year, which was sent to the Ministry of Law and Justice by the Odisha government. The court noted that according

to the communication, the state has already utilised more than 75 per cent of the central assistance released in financial years 2018-19 and 2019-20, and the utilisation certificates for the same have also been furnished to the Union government

"There is evidently a mismatch between the data given by the Department of Justice and the communication of December 17 of the state government," the bench said.

It directed that in order to reconcile, a meeting be convened within two weeks between the Department of Justice, the Odisha law secretary and others, including the registrar general of the Orissa High Court.

"The purpose of the meeting shall be to ensure reconciliation of the utilisation certificates, which are stated to have been submitted by the state government," the bench said. It said the meeting may be fixed either physically or on an online platform.

In his report submitted to the SC, Hansaria, who is assisted by advocate Sneha Kalita in the matter, said even for the current financial year 2022-23, an amount of ₹60.4 crore has been allotted for which an action plan has also been submitted. However, the funds are vet to be released.

It said the High Court report states that proposals under the state sector scheme (SSS) for 2023-24 for ₹722.49 crore have been submitted to the Odisha government. The bench asked the counsel

representing the state in the matter regarding the proposal for ₹722 crore.

# **De-addiction centre inmate** succumbs following attack

Bhubaneswar, Feb 2: The youth who was brutally injured at a drug de-addiction centre in the city few days back succumbed at Hi-Tech medical here Thursday during treatment. The deceased, Sarbeswar Behera was undergoing treatment at the ICU of the private medical college since January 30.

Wednesday, the Commissionerate Police arrested three persons including the owner of the centre, Anirudha Ray in the case (37/23) under sections 323 and 307 IPC. Sources claimed the section 307 earlier slapped against the accused trio has now been converted to 302(murder charges) following the death of Sarbeswar.

Sarbeswar used to earn his liv-

ing by working as a driver in the city. He is survived by his wife and three young children.

The victim, Sarbeswar who originally hails from Nayagarh district had been residing at Patharabandha Basti in Saheed Nagar area along with his family for the last several years. Urmila, wife of the deceased, had revealed that Sarbeswar was excessively addicted to liquor and psychoactive drugs

The worried family members had admitted Sarbeswar to the deaddiction centre, "Sai Kripa" located in Mancheswar area January 27. 2023 Owner of the de-addiction center, Anirudha, present during the admission assured the family members that the center would take good care of the addict and pro-

vide him all the facilities. Anirudha also told the complainant that they would supply all the information regarding any problem caused by Sarbeswar at the center.

Urmila also deposited ₹7000 at the center for her husband's admission Tuesday. Meanwhile, when she came to know that her husband was brutally assaulted by the staffers, she rushed to the deaddiction center.

She found that her husband sustained severe injuries with wound marks on different parts of his body.

The victim was later admitted to Capital hospital from where the family later shifted him to Hi-tech medical college for advanced treatment.

# KIMS Hospital performs state's 1st hybrid surgery

Bhubaneswar, Feb 2: Kalinga Institute of Medical Sciences (KIMS) doctors claim to have performed the first hybrid surgery in Odisha, Thursday. The surgery was performed on Sushama Rana (50) of Ratagada of Banki block. Cuttack district, after she complained about the severe pain in her chest and back.

Following multiple consultations at various places, Sushama was not able to bear the pain and visited KIMS January 18. She consulted the cardiologists and had undergone a series of tests, which inferred an internal bleeding in aorta which supplies blood to



major organs.

The cardiology and cardiac surgery team at KIMS started the procedure after proper diagnosis. Cardio thoracic and vascular surgery (CTVS) surgeon, A Sharda and Chandan Kumar Ray Mohapatra carried out the bypass surgery and joined the aorta with the vessels.

After the bypass graft, which prevented brain stroke and maintained blood flow to the left arm, the cardiology team led by Anupam Jena put a covered stent inside the damaged aorta to seal the tear.

The procedure was carried out for the first time in Odisha despite the fact that an untreated dissection of aorta might create some serious

With the help of cardiac anesthesiologist Ashok Kumar Badmali, the surgery continued for more than five hours. "If the surgery was delayed, it could have resulted in multi-organ failure," the doctor stated

intestinal problems.

As per sources, the hybrid surgerv costs around ₹14 to 15 lakh outside Odisha, but at KIMS it was performed under ₹6.5 lakh only. Five days after the surgery, Sushama returned to her village and is doing well.

NABA DAS ASSASSINATION POLICE YET TO ΕA

Bhubaneswar; Feb 2: Even though four days have passed since the murder of Health Minister Naba Das, the police are vet to reveal

the motive behind the brutal killing. To recall, assistant sub-inspector Gopalkrishna Das had shot Naba Das in Jharsuguda district January 29. Later the same day, the minister had succumbed to

his injuries Soon after the incident, Gopal Das was arrested and the Crime Branch took over the case. The Crime Branch officials have been interrogating Gopal Das and his family members since then.

However, the police are yet to reveal the motive behind the murder. In a press statement issued Thursday evening, the crime branch said that it has recovered one bullet which is a valuable piece of evidence.

Following the lead given by the ASI during interrogation, the crime

branch recovered some pieces of handwritten papers of the accused from the septic tank attached to the toilet of Airport police station in Jharsuguda.

The accused told the police about dumping handwritten papers, in which he had noted down in detail his motive behind the crime, in the toilet of the Airport police station.

The paper pieces will be sent to forensic and handwriting experts for reconstruction and examination, the Crime Branch said.

The preserved viscera of the deceased have been sent to the state forensic science laboratory (SFSL) in Bhubaneswar for examination, it said.

Similarly, another team of Crime Branch is verifying the medical treatment records and financial behaviour of Gopal Das, besides examining the near and dear ones of the accused. Earlier, the elder brother of the accused ASI was interrogated.

# **Pollution grips Paradip air**

Paradip, Feb 2: With the serious problem of air pollution in Paradip aggravating rapidly, things have come to such a pass that trees and plants in this port town are struggling for survival.

The port town is facing severe air pollution with iron, coal dust, gypsum dust and other pollutants getting diffused in the atmosphere. This has happened due to reckless handling of cargo like coking coal and thermal coal at the port as well as through transportation of gypsum by two fertilizer units in the area.

As a result, leaves and branches of the trees are found enveloped with a thick layer of black and grey coloured dust. The heavy pollution is untimely drying up the trees impacting their survival.

The annual declaration on pollution level in the cities by Central Pollution Control Board (CPCB) and State Pollution Control Board (SPCB) is changing every year. In 2014-15, the borderline was 69.60

This year, the SPCB informed that pollution is declining in Paradip. However, the reality is that if a person goes around the port town for an hour in an open vehicle then the colour of his clothes will change for sure. The claim can be substantiated by examining the leaves of trees in the town.

Paradip is one among the four most polluted cities in Odisha while the other three are Ib Valley, Jharsuguda and Angul

hese four cities in Odisha are in the list of 88 cities which have been declared as the most polluted by the government

The leaves instead of being green appear black or red in colour. The trees which are key to sustaining human life are now fighting for survival. An environmentalist Amaresh Naresh Samant alleged that the trees, with thick layers of black dust gathered on the leaves, fail to properly absorb carbon dioxide and give out oxygen for sustenance of the living. Environmentalists said dust particles are a potential source of air and water pollution.

The pollution in Paradip is of varied nature. In parts, it is related to use of chemicals while on the other hand, air pollution gets even worse due to reckless handling of cargo like coking coal and

thermal coal. Pollution also arises from the ash and smoke billowing out of the many industrial plants in the port town.

People residing in areas near industrial units of the town have become susceptible to respiratory disorders and skin diseases. Smoke and dust filled air has emerged as a major health hazard in these localities. However, allegedly no proper regulatory measure is being taken to contain the pollution.

When contacted, SPCB regional officer Pushkar Chandra Behera said that the parking of heavy vehicles in the port is responsible for the pollution to some extent. Iron and gypsum dust falls on the road as the heavy vehicles are parked on the road. Dust remains suspended in the ambient air and not only pollutes the air and water but also gather in houses in the adjoining areas where the vehicles have been parked in the port town. He said special programmes will be launched to clean dust from the month of April.

# Why not create National Elephant Conservation Authority: SC bench

New Delhi, Feb 2: The Supreme Court has sought reply from Centre on a 2010 'Gajah Report' recommendation on conferring statutory status to a proposed body National **Elephant Conservation Authority** (NECA) for the preservation of elephant corridors


A bench headed by Chief Justice DY Chandrachud said, "In the recommendations submitted in Gajah report, there was a recommendation to the effect that 'Project Elephant' be converted into a statutory agency."

The top court was hearing a plea by activist Prerna Singh Bindra, Wednesday

According to the government, the elephant population has reached 29,964 (as per the census 2017) in India, the elephant habitats are being consolidated across India, and the Elephant Reserves' area has been increased.

The government emphasised that it is deeply committed to protect the safety of the elephants and continued to take various steps to prevent their death including electrocution. Additional Solicitor General Aishwarya Bhati represented the

Central government in the apex court. The bench, also comprising Justices PS Narasimha and JB Pardiwala, added that the task force has proposed that the new body may be termed as the 'National Elephant Conservation Authority' (NECA). It further suggested that amendments can be introduced to effectuate the conferment of a statutory status on the authority.

"Since the proposal would envisage requisite legislative amendments, this is something of which would be appropriate for the Ministry of Environment and Forest and Climate Change to respond," it said.

During the hearing in the matter, the bench also sought a status report on setting up of the central project elephant monitoring committee for the purpose of monitoring and implementation of relevant directions and guidelines in connection with the protection of elephants.

In a written response, the Central

government said, "Continuous efforts have been made to minimise the human elephant conflict and also to ensure the welfare of captive elephants in India.'

After hearing arguments, the apex court directed the Ministry and the Central Electricity Authority to facilitate an inspection of the protected areas to avoid electrocution of elephants. The bench gave Centre four weeks' time to file a response in a PIL filed by activist Bindra.

The petitioner had contended that the electrocution is one of the major reasons for deaths of elephants and sought a direction for insulation of high voltage power transmission lines passing through protected areas, elephant reserves, identified elephant corridors and known areas of elephant movement.

**FISCAL CORRECTION IMPERATIVE** 

he Union budget for 2023-24 came against a backdrop of economic recovery and optimism in the medium-term growth outlook despite persistent global recessionary winds. The budget speech of the Finance Minister recognised the constraints, saying this performance was about "resilience amidst multiple crises." There are indeed a number of threats to macroeconomic stability, particularly that of inflation, and the hazards of a projected recession and high inflationary trends in most parts of the world. The International Monetary Fund in its update on the World Economic Outlook released on January 30 has mentioned "inflation picking-up amid low growth." These global developments will pose a threat of "spill-overs" to Indian economic development in terms of lesser capital inflow, lower inward remittances, reduced exports and imported inflation.

However, India's economy is relatively insulated from global threats when compared to other emerging market economies partly because of its large domestic market and relatively looser integration in global value chains and trade flows. In contrast to the prepandemic years of 2018-19 and 2019-20, there is evidence of a strengthening of balance sheets by Indian corporates and the financial sector which provides "a solid underpinning to growth.' Apart from this, "India's public digital infrastructure expansion is leading to accelerated financial inclusion for low-income households, micro and small businesses and the economy's rapid formalisation." This is observed in the statement of fiscal policy released with the budget. Balance sheet strength and digital advancement are growth differentiators not only for 2023-24 but also in the years ahead. Recognising that uncertainties

Amidst severe fiscal stress, the budget has still attempted fiscal correction and consolidation by reducing the fiscal deficit to 5.9% of GDP against 6.4% of GDP in 2022-23 and the revenue deficit is budgeted at 2.9% of GDP as compared with 4.1% of GDP in 2022-23. The correction in the revenue deficit has been budgeted with a reduction in all subsidies (fertiliser, food and petroleum) together amounting to Rs 3,74,707 crore from Rs 5,21,585 crore in the revised estimate for 2022-23, recording a decline of 39.2%. It is important to mention here that due to the unprecedented levels of borrowing during the pandemic (9.2% of GDP in 2020-21 and 6.7% of GDP in 2021-22), the interest payment has been projected higher at Rs 10,79,971 crore, recording an increase of 14.8 % over 2022-23 revised estimates. At this level, the interest payvised estimates. Our tax to GDP ratio is low; this needs to go up at least by 2% with better tax compliance and an increase in the tax base. If this happens, a return to the 3% fiscal deficit to GDP will be quicker along with a sharper cor-

Another important aspect is the selling of assets of public sector units. The entire move has been weak. This needs to be corrected

To strengthen cooperative fiscal federalism, the budget has provided financial assistance to the states for capital expenditure to the tune of Rs 1.30 lakh crore repre senting an increase of 30% over allocations of the 2022-23 budget estimate and accounting to around 0.4% of GDP. Secondly, there has been a substantial increase in the share of states in the revised estimates of 2022-23 to Rs9.48 lakh crore from Rs 8.17 lakh crore in the budget estimate. However, the 15th finance commission recommendation was of providing 41% of tax devolution from the divisible pool of tax. The budget for 2023-24 has provided to the states Rs 10.21 lakh crore. Thirdly, there are transfers to states in terms of centrally sponsored schemes (CSS), finance commission grants and other loans and grants together (Rs 9,89,337 crore) accounting for 30% of total expenditure or 3.2% of GDP.

As mentioned in the govern ment's Economic Survey 2022-23, the Indian economy is poised for a potential growth of 7 to 8% in the medium term. The current growth rate at 7% is among the highest in the world. But to remain ahead and in a "bright" position, prudent and strong fiscal management in terms of 3% of the fiscal deficit to GDP is an essential prerequisite especially for attracting foreign direct investment. However, the Union budget 2023-24 has been conservative in fiscal correction and consolidation. This is where a bold step was required. It is sorely missing.

he annual meeting of the World Economic Forum in Davos used to be the premier destination for renowned academics and public figures to comment on the state of the world. But nowadays, the destination is just a click away. Our social-media-driven news ecosystem is virtually drowning us in expert opinion, inundating us with so much verbiage that little room is left for thoughtful analysis and focused debate - the oxygen of healthy public discourse.

Consider, for example, how quickly and how often the expert consensus shifted throughout the COVID-19 pandemic. China did a far better job containing the spread of the virus than many liberal democracies, until its draconian zero-COVID strategy demonstrated the failure of autocracy. And, despite the surge of infections in the weeks since policymakers abruptly abandoned the strategy, it is still possible that China will have fewer excess COVID-related deaths than the United States. Others argued that polarised societies like the US would fare worse than countries with high levels of social trust, until Sweden became a cautionary tale. And India was considered to be performing relatively well until the catastrophic death toll of the Delta variant revealed the scale of the government's mismanagement - and the latter, too, seems slightly less severe in hindsight, following the country's successful vaccination drive.

Then there is the great US inflation debate. Initially, it seemed like Team Transitory – the inflation doves who predicted that prices would go down quickly - had it right. But then the persistence of high inflation vindicated the hawks who had called for the Federal Reserve to engineer a massive recession to restore price stability. Nowadays, the doves are flying high again, as inflation seems to be declining without the Fed having to inflict excessive pain on US labour markets.

Russia's invasion of Ukraine, soaring inflation, and the escalating rivalry between the Arvind Subramanian US and China have given us the term "polycrisis" - the Financial Times' word of the year - to describe today's confluence of calamities. But the global economy seems to have escaped the worst, at least for the moment, and the International Monetary Fund expects growth to pick up next year. The Economist now speaks of a "poly-recovery." Similarly, the doom-and-gloom predictions that characterised the spring and summer of 2020, the height of the COVID crisis, did not materialise, and the world economy turned out to be more resilient than many had believed.

And remember the warnings of a "winter of discontent" in Europe and the looming threat of wartime energy rations? Instead, gas prices have been declining steadily since the summer. And many of the same analysts who predicted a few months ago that the Chinese economy was about to collapse were proclaiming that "China is back" just a few weeks later.

The current fickleness of expert consensus

is rooted in a media environment that rewards instant theorising and glib generalisations as long as they are delivered with absolute certainty. When reality exposes the flaws in these hypotheses, the expert caravan simply moves on to the next topic without self-reflection or accountability, leaving viewers and readers dumbfounded.

To be sure, expert opinion is still valuable, despite its increasingly ephemeral nature. But experts inhabit the same world as everyone else, and thus are not immune to the cognitive effects of its frantic pace. Given that institutions like the IMF are tasked with providing real-time analyses and predictions in a rapidly-changing environment, getting things wrong or having to pivot on a dime is an occupational hazard. And arguably the warnings and instant analyses might be responsible for policy actions that preempt worst-case scenarios. Howling like a wolf can sometimes keep the real wolf at bay

Still, one cannot deny the fact that there are too many overconfident experts making too many predictions about too many issues too quickly these days. A basic economic principle is useful here: the 24-hour news cycle has created a huge need for expert opinion, and the market has simply created the supply to meet the growing demand.

But some correction is required. When he received the Nobel Prize in economics in 1974, Friedrich von Hayek famously suggested that his fellow laureates take an economist's Hippocratic oath: avoid commenting publicly on matters beyond one's immediate expertise. Winning such a prestigious prize, he said, should come with a certain responsibility. The same could be said of all current purveyors of elite opinion.

While voluntarily reducing one's profile may not seem appealing to many experts and intellectuals, it is the only way to avoid debasing the public discourse. Without a modicum of self-restraint, the constant stream of hot takes might end up undermining the informed debate that undergirds all open societies. To paraphrase Ludwig Wittgenstein, whereof one cannot say anything of substance after considered reflection, thereof one must be silent.

his has the melancholy distinction of being one of the very few words in English that derive from the Cornish language (which died out in the late eighteenth century, though enthusiasts have revived it). It is mainly a term in archaeology for a kind of man-made stone-lined underground passage found in Cornwall. Some are rather large, opening out from a narrow entrance to a long chamber that can sometimes hold a substantial group of people. They are of Iron Age date and seem always to have been built on the edge of settlements. Nobody knows what they were for. They can hardly have functioned as defensive structures, because they would have been a death trap for anybody sheltering inside (unlike underground structures elsewhere, which do seem to have been designed as hiding places); they are too big and too damp to be used for storage; they're the wrong shape and their entrances are often too narrow for housing livestock. Some people believe that they are ritual structures, perhaps associated with an earthmother religion or sun worship (some seem to be aligned with midsummer sunrise or sunset). The Cornish word from which their name comes originally meant a cave. They have also been known as vugs or vows, from the related Cornish vooga for a cavern.

The budget is contractionary in the sense that the budgeted total expenditure is projected to be Rs 45 lakh crore, only 7.39% higher than the revised estimate of the previous fiscal (Rs 41.9 lakh crore), which is not only lesser than the projected nominal GDP growth of 10.5% but amounts to slashing ex-

Further, the budgetary outlay of India as a percentage of GDP is shrinking and much lower than many countries. What is worrying is that it has come down from 20% in 2020-21 to 15.93% in 2021-22 and 15.34% in 2022-23. It is estimated to decline to 14.91% in 2023-24. When the size of budget does not increase as percentage of GDP, then when the government increases expenditure, it also reduces some other expenditure, affecting the poor.

The government has cut estimated spending on food, fertiliser and fuel subsidies which are indispensable for the uplift of farmers, labourers and other poor sections. The government has allocated just Rs 60.000 crore for the Mahatma Gandhi National Rural Employment Guarantee Scheme for 2023-24, which is much lower than the revised estimate for 2022-23 at Rs 89,400 crore. The scheme was pivotal to the rural economy's recoverv during the pandemic, protecting the most vulnerable households against complete income loss. It continues to provide a safety net to a large section of the vulnerable rural population.

In her budget speech, the finance minister said that the govis different. India's position in Human Development Index is 132 out of 191 countries. In the recent report of the Global Hunger Index, India ranked 107 out of 121 countries with its child-wasting rate at 19.3%, the highest in the world.

The finance minister said that she has raised income tax exemption limits and changed the slab for the benefit of the middle class. Actually, this is very low if compared with the rise of inflation. In a progressive tax system, there should be more collection from direct taxes and less from indirect taxes. The direct tax rate should be increased with the rise in income. But the finance minister has reduced the surcharge rate for higher income tax category.

In the past, she has reduced the corporate tax rate too. India has no inheritance and wealth taxes while many countries have these. The finance minister has taken recourse to indirect taxes by burdening the poor and the middle class while allowing the rich to pay lesser tax. Hence the budget is pro-rich and anti-poor.

# No action against hate speeches, SC laments

The Supreme Court orally observed that it has passed many orders in connection

with hate speeches at events yet nobody was taking action, while

agreeing to examine a plea against an alleged hate speech event scheduled February 5 in Mumbai

New Delhi, Feb 2: The Supreme Court Thursday lamented that nobody was taking action against hate speeches despite its orders, and observed that the top court will be left "embarrassed again and again" if it is asked to give further directions to curb such statements.

The court's strong observations were made by a bench comprising Justice K M Joseph, Justice Aniruddha Bose and Justice Hrishikesh Roy when a plea seeking to prohibit an event scheduled to be



held February 5 by the Hindu Jan Akrosh Morcha in Mumbai was mentioned for an urgent hearing. The bench agreed to hear the

plea Friday subject to instructions and approval from Chief Justice D Y Chandrachud on the administrative side. "We are with you on this, but understand that the Supreme Court cannot be triggered every time there is a rally notified. We have already passed an order which is clear enough. Just imagine rallies happening all across the country. Every time there will be an application before the Supreme Court. How can that be feasible?

'You ask us to be embarrassed again and again by getting an order. We have passed so many orders vet nobody is taking action. The Supreme Court should not be asked to pass an order on an event to

### event basis," it observed.

The observation came after a lawyer mentioned the matter, saying the issue needs urgent hearing against holding of the Mumbai rally. She submitted that a similar rally was organised a few days ago in which 10,000 people participated and allegedly gave a call to boycott Muslim communities economically and socially. On continuous persistence of the lawyer, the court asked her to serve a copy of the application to the counsel for Maharashtra.

"Serve a copy on the State, we will list it tomorrow subject to orders of the CJI. Only this case, not the entire batch," the bench said. Holding that the Constitution of India envisages a secular nation, the top court October 21 last year directed the Delhi, Uttar Pradesh and Uttarakhand governments to come down hard on hate speeches. promptly registering criminal cases against the culprits without waiting for a complaint to be filed.

It had also warned that any delay on the part of the administration in taking action on this "very serious issue" would invite the court's contempt

the deceased, prosecution initiated against the factory owners and the number of safety officers employed as per Section 40B of the Factories Act, 1948.

"The reports must contain yearwise reports of the Chief Inspector Factories Act. 1948, must also be part of the reportsa, said NHRC.

A notice has also been issued to the Secretary, Union Ministry of Labour & Employment to submit an action taken report with regard to the implementation of the occupational Safety Health and Working Conditions Code and the measures taken or to be taken for improving the human rights conditions in respect of the factory workers across the country.

Reportedly, as many as 3331 deaths were recorded between 2018 and 2020 but only 14 people were imprisoned for offences under the Factories Act, 1948. The NHRC has sought the response within six weeks.

# Limiting global warming to 1.5°C not plausible: Report

New Delhi/Berlin, Feb 2: Limiting global warming to 1.5 degrees Celsius is currently not plausible, according to a new report

Climate policy, protests, and the Ukraine crisis - The participating researchers systematically assessed to what extent social changes are already underway, while also analyzing certain physical processes frequently discussed as tipping points.

The interdisciplinary team of researchers addressed ten important drivers of social change. the report said. "Actually, when it comes to climate protection, some things have now been set in motion. But if you look at the development of social processes in detail, keeping global warming under 1.5 degrees still isn't plausible," says CLICCS Speaker Anita

Engels. According to the Hamburg Climate Futures Outlook, especially consumption patterns and corporate responses are slowing urgently needed climate protection measures. Other key factors like UN climate policy, legislation, climate protests and divestment from the fossil fuels are supporting efforts to meet the climate goals.

As the analysis showed, however, this positive dynamic alone won't suffice to stay within the 1.5degree limit.

In addition, the research team assessed certain physical processes that are frequently discussed as tipping points, such as the loss of the Arctic sea ice and melting ice sheets, which are se-

Petition filed to prevent traders of other faiths on temple premises

Tumakuru (Karnataka), Feb 2: The Vishva Hindu Parishad (VHP) and the Bajrang Dal have submitted a petition to the Deputy Commissioner of Tumakuru city in Karnataka asking the authorities to prevent traders of other faiths to carry out business within the premises of a historical temple during the celebration of a festival

# Cooum river in Chennai most polluted in country: CPCB report

The number of polluted rivers in Tamil Nadu has increased *in the past four years*

Chennai, Feb 2: The Central Pollution Control Board (CPCB) in a recent report has termed the Cooum in Chennai the 'most polluted' river in the country.

According to the report Biomedical Oxygen Demand (BOD) in the river between Avadi to Sathya Nagar was 345 mg per litre which is the highest among the 603 rivers of the country. Interestingly, the Sabarmati river in Gujarat with a BOD of 292 mg per litre and Bahela in Uttar Pradesh with a BOD value of 287 mg per litre are second and third most polluted rivers respectively.

The report also states that the number of polluted rivers in Tamil Nadu has increased in the past four years. The CPCBA report titled, 'Polluted River Stretches for Restoration of Water Quality, 2022' states that the water quality of 12 rivers in Tamil Nadu was monitored at 73 locations during the period between 2019 to 2021. BOD in 53 locations of 10 rivers was not found complying with the prescribed water quality criteria, the report said.

Amaravati, Bhavani, Cauvery, Cooum, Palar, Sarabanga, Tamaraibarani, Vasishta and Tirumanimuthar in Tamil Nadu. Notably, Tamaraibarani and Cooum rivers have been highly polluted for the past few years with environmentalists and social workers relentlessly campaigning against

# TN prepares for synchronised vulture survey SDPI to contest 100 seats in

With the vultures flying long distances, the survey has to be conducted in the three states -- Tamil Nadu, Kerala and Karnataka - at the same time and using the same methodology

Chennai, Feb 2: The Tamil Nadu forest department has sought the support of Kerala and Karnataka forest departments for a synchronised vulture survey to be held in March.

The forest department of Tamil Nadu has planned a survey of vultures after a few numbers were spotted at Madhumalai Tiger Reserve (MTR) in Nilgiris which is a tri-junction of forest areas spread across Kerala, Karnataka, and Tamil Nadu. With the vultures flying long distances, the survey has to be conducted in all three states at the same time and using the same methodology.

The Chief Wildlife Warden of Tamil Nadu, K. Sreenivasa Rao has already written a letter to the wildlife



wardens of both Karnataka and Kerala. Speaking to media persons, Rao said that he had personally communicated to the wildlife wardens of both states to include vulture conservationists in the survey.

The Animal husbandry department of Tamil Nadu is also joining hands with the Forest department of the state for the conservation of these birds. The chief wildlife warden also said that the department is creating awareness among cattle farmers to regulate the use of painkillers on cattle. It may be noted that the carcass of cattle is

the main fodder for the vultures. The Forest department has used the services of Arulgam, an NGO that is into Vulture studies and conservation. Wildlife Institute of India and Bombay Natural History Society are also associating with the Tamil Nadu forest department to create awareness among farmers to reduce the usage of painkillers among cattle as it would be dangerous to the survival of vultures.

The conservationists are creating awareness among cattle farmers not to rear cattle without drugs and have selected 20 hotspot villages in each state to create awareness among farmers.

Even as the Tamil Nadu government restricted the use of antiinflammatory drugs ketoprofen and flunixin, considering the adverse impact they cause to predatory birds, the Egyptian vulture population in the state is on the decline. According to Arulgam, there is no authentic breeding record in the state except for one in Krishnagiri district a few years back. The main reason for dwindling vulture population, according to conservationists, is the lack of food for these vultures and the presence of non-steroidal anti-inflammatory drugs like diclofenac in the bodies of their prey.

Most of the farmers bury their cattle even after the local bodies, health department and state forest department have conducted awareness campaigns to leave the dead cattle in areas with less population as predatory birds depend on these carcasses. Deworming drugs, rodenticide poisoning and chemicals released by tanneries are also reasons for the decline in the population of Egyptian vultures.

Farmers poison rats which are eaten by the vultures, leading to these chemicals entering the food chain and turning fatal for the birds. With the volume of tanning increasing, the industry which earlier used plant-based materials turned to chemical tanning, including ammonia and sodium, leading to the death of vultures that feed from tanneries.

The bench, also comprising Judicial Member Justice Sudhir Agarwal and Expert Members A Senthil Vel and Afroz Ahmad, said, "Without undermining the need for study in all eco-sensitive areas... We direct specific study for Mussoorie..

Such study may cover as to how much constructions can be allowed and with what safeguards, what safeguards be used for ex-



isting buildings and all other relevant and associated aspects including vehicular traffic, sanitation management, maintaining ecological integrity in terms of soil stability and flora/fauna," the bench said. The bench also formed a nine-member joint committee headed by the Uttarakhand chief secretary.

Other committee members include the Central Pollution Control Board, ACS Environment, Wadia Institute of Himalayan Geology,

Govind Ballabh Pant National Institute of Himalaya and Environment, National Institute of Hydrology, Space Application Centre and National Institute of Rock Mechanics, the bench said.

"The committee may suggest remedial measures to prevent environmental damage in the light of carrying capacity, hydro-geology studies, geo-morphological studies and also covering other allied and incidental issues," it added. The committee can seek

### 296 families shifted to safer places: Govt

NEW DELHI: The Uttarakhand government has shifted 995 members of 296 families from subsidence-hit Joshimath to safer places, Earth Sciences Minister Jitendra Singh told Rajya Sabha Thursday. In written replies to three different questions in the Upper House, Singh said cracks have been observed in 863 buildings in Joshimath due to recent land subsidence and many structures have been reported to have moderate and major damages. # Journalist Kappan walks out of UP jail

Lucknow. Feb 2: Kerala journalist Siddique Kappan walked out of jail on bail Thursday, over two vears after he was arrested for allegedly trying to instigate violence after the death of a woman in Uttar Pradesh's Hathras. The release came almost six weeks after Allahabad High Court granted him bail in a money laundering case filed by the Enforcement Directorate. In September, the Supreme Court granted him bail in another case under the Unlawful Activities (Prevention) Act (UAPA). Kappan was released from jail around 9.15 am, Lucknow district prison jailor Rajendra Singh told PTI. A day earlier, his lawyer submitted two sureties of ₹1 lakh each at the special PMLA (Prevention of Money Laundering Act) court here, fulfilling a bail condition. "I struggled," Kappan said minutes after he walked out to camera crews, a small curious crowd -- and to his wife and teen son, waiting patiently. "It has been 28 months. I am out after a lot of fight. I am happy," he said. Speaking to PTI, the journalist added, "I am coming to Delhi. I have to stay there for six weeks." The Supreme Court bench headed by then Chief Justice Uday Umesh Lalit had directed Kappan to remain in Delhi for six weeks after his release from prison.

Kappan and three others were arrested in October 2020 while they were going to Hathras where a Dalit woman died allegedly after being raped.

Asked about the purpose of his visit to Hathras, Kappan told the assembled reporters that he had gone there for "reporting". About those who had accompanied him, he said they were students. Questioned on recoveries made from him. Kappan

# SC to hear bail pleas of Michel James Feb 7

New Delhi, Feb 2: The Supreme Court Thursday said it would hear February 7 the bail pleas of Christian Michel James, an alleged middleman in the AgustaWestland chopper scam in which the CBI and the ED have lodged two separate cases. The ₹3,600-crore alleged scam relates to the purchase of 12 VVIP helicopters from AgustaWestland.

In May last year, the apex court had sought the responses of the Central Bureau of Investigation (CBI) and the Enforcement Directorate (ED) on the bail pleas of James. During an earlier hearing, the counsel for the accused had said the case was covered under section 436A of the CrPC (maximum period for which an under trial prisoner can be detained) and James had served 50 per cent of the sentence for the offence allegedly committed by him.

The accused was extradited from Dubai in December 2018 and has been in custody since then, his counsel had said, adding that the probe against him was yet to be concluded.

The lawyer had said the petitioner's case is that under sections 8 and 9 of the Prevention of Corruption Act, the maximum sentence is five years in jail and he has spent nearly four years in prison.

Appearing in the court on behalf of the probe agencies, Additional Solicitor General SV Raju had earlier said with great difficulty, the agencies got the custody of the accused and section 436A of the Code of Criminal Procedure (CrPC) would not apply to ED proceedings. He had said James was a resident of the United Kingdom and was extradited from Dubai. James has challenged the March 11, 2022 order of the Delhi-High Court that dismissed his bail plea.

CRPF sets up camp in Maoist stronghold after 17 years

The CRPF said that with this camp, the administration would be able to decisively restore the trade route and pave the way for the economic development of the area

New Delhi, Feb 2: A forward operating base housing armed troops has been created in one of the remotest and high-Maoist violenceaffected district of Chhattisgarh that has led to the re-opening of a Tamarind trade route after 17 years, the CRPF said Thursday.

The strategic FOB has been created at Bedre in the Sukma district of Bastar region that lies on the southernmost tip of the central Indian state, along the tri-junction of Chhattisgarh, Telangana and Odisha borders.

"This FOB will effectively help in the re-opening of the old trade route connecting the Tamarind market at Jagargunda with the nearby districts of Bijapur and

Dantewada and will also choke the transit corridor that Maoists used for movement between west Bastar and south Bastar," a CRPF spokesperson said. The base has been established by the joint efforts of the 165th battalion of the CRPF and the Chhattisgarh Police.

'The establishment of the Bedre FOB can be termed as historic as after 17 years, it reclaims from the clutches of the Maoists the old route which once facilitated the trade of tamarind and forest produce from Jagargunda - the prominent tamarind market of India, till the emergence of Maoist menace in 2006." "In addition, the FOB will pave the way for development activities by allaying the fear of the Maoists," the officer said.

The paramilitary force has es-



tablished some other FOBs sometime back in this remote Naxal violence-affected district, more than 400 kms from state capital Raipur,

like Kunder and Silger (at a distance of about 5 kms each) and Jagargunda (around 10 kms away). Around 14-15 FOBs have been established by the force over the last three years in Chhattisgarh. The FOBs houses a small but strong and armed contingent of CRPF personnel who work to cut the supply chain of Maoists in remote and hardcore extremism-affected areas by not only undertaking quality operations but also by interacting with civilians, officials have said in the past.

The Central Reserve Police Force is the lead anti-Naxal operations force of the country and it has deployed close to one lakh personnel for this task in various LWE violence affected districts including that in Chhattisgarh.

The Union government informed the Parliament in December, 2022, that the geographical spread of the LWE has significantly reduced

and only 191 police stations of 46 districts reported LWE-related violence in 2021 as compared to a high of 465 police stations of 96 districts in 2010.

The decline in geographical spread is also reflected in the reduced number of districts covered under SRE (security related expenditure) scheme and the number of these districts reduced from 126 to 90 in April, 2018 and further to 70 in July, 2021, data provided by Union minister of state for home Nityanand Rai had said.

The number of districts contributing approximately 90 per cent of the LWE violence, categorised as most LWE affected districts, also came down to 30 from 35 in 2018 and further to 25 in 2021, he said.

A new Indigenous design will replace the previous portrait of the late Queen Elizabeth II, Australia's Reserve Bank said, a move which honors "the culture and history of the First Australians." The \$5 bill is Australia's only bank note to feature the monarch.

### Thai air pollution past safe levels

Bangkok: Air pollution in Bangkok and neighbouring Thai provinces spiked past safe levels Thursday, prompting authorities to urge people to stay indoors and avoid strenuous outdoor activity. The concentration of small and hazardous airborne particles known as PM2.5 in lital was at level recommended by the World Health Organisation (WHO), making it the sixthworst in the world, according to IQAir, a Swiss air quality tracking platform. The country's pollution control department said "stagnant weather conditions" were exacerbating vehicle emissions and seasonal fires on agricultural lands.

REUTERS Bucharest, Feb 2: The woman from Moldova thought it was love. Internet celebrity Andrew Tate had offered her a new life. They'd even discussed marriage. He asked for only one thing: ab-

solute loyalty. 'You must understand that once you are mine, you will be mine forever," Tate told her February 4 last year in one of dozens of WhatsApp messages cited by Romanian prosecutors who allege he trafficked and sexually exploited several women.

Tate, an influencer with millions of online followers, urged the Moldovan woman to join him in Romania. "Nothing bad will happen." he reassured her February 9. "But you have to be on my side." The following month, Romanian

prosecutors say, Tate raped the woman twice in the country while seeking to enlist her in a humantrafficking operation focused on making pornography for the online platform OnlyFans, a site that allows people to sell explicit videos of themselves.

The allegations and messages are included in a previously unpublished court document, dated December 30 and reviewed by Reuters, which paints the most detailed picture yet of the illicit business allegedly run by Tate, a former kickboxing world champion, and his brother Tristan.

They came to light following the arrest of the brothers December 29 on charges of forming a criminal gang to sexually exploit women. The brothers used deception and intimidation to bring six

women under their control and



"transform them into slaves", prosecutors said in the document. The 61-page file, produced by Bucharest court officials, comprises minutes of a hearing when a judge extended the Tates' detention plus evidence submitted by the prosecution. Attorney Vidineac said the broth

ers' alleged victims weren't mistreated, but "lived off the backs of the famous Tates", according to the court document. "They were joyful and nobody was forcing them to do these things," he added. Vidineac acknowledged in the

document that Andrew Tate and the

Moldovan woman had sex but he said it was consensual and accused her of fabricating the rape claims.

Two of the women told Romanian TV station Antena3 January 11 that they're not victims and the Tates are innocent. The station identified them only by first names, Beatrice and Iasmina. "You cannot list me as a victim

if I say I am not one," Beatrice told the station. The four other women, including the Moldovan woman, haven't publicly commented. ONLYFANS

Prosecutors say the Tates controlled the victims' OnlyFans' accounts and earnings amounting to tens of thousands of euros, underlining concerns among some human rights groups about the potential for the exploitation of women on such platforms. UK-based OnlyFans has 150 million users who pay "creators' monthly fees of varying amounts for their content, much of it erotic or pornographic, but also in areas such as fitness training and music. **EXPLOITATION** 

The detention of the Tates, along with two Romanian women accused of working for them, has been extended to February 27. Their appeal against that detention was rejected by a court Wednesday. The suspected accomplices, Georgiana Naghel and Luana Radu, controlled the six victims' OnlyFans and TikTok accounts on behalf of the Tates. skimming off half the revenue and fining women for being late or sniffling on camera, said prosecutors. The pair threatened to beat the women up if they did not do their job, according to the court document.

# **N Korea warns of N-force to deter US**

North Korea for decades has described the US' combined military exercises with South Korea as rehearsals for a potential invasion, although the allies have described those drills as defensive

Seoul, Feb 2: North Korea said Thursday it's prepared to counter US military moves with the "most overwhelming nuclear force" as it warned that the expansion of the United States' military exercises with rival South Korea is pushing tensions to an "extreme red line."

The statement by Pyongyang's Foreign Ministry came in response to comments by US Defense Secretary Lloyd Austin, who said Tuesday in Seoul that the United States would increase its deployment of advanced military assets to the Korean Peninsula, including fighter jets and aircraft carriers, as it strengthens joint training and operational planning with South Korea.

South Korea's security jitters have risen since North Korea test fired dozens of missiles in 2022, including potentially nuclear-capable ones designed to strike targets in South Korea and the US.

### Iran blames Israel for drone attack

Hong Kong, Feb 2: Hong Kong is ready to welcome the world back, its leader said Thursday, pledging more than half a million free flights and positive publicity to resurrect the once-vibrant global hub after three years of Covid-enforced isolation.

The government's rebranding campaign, "Hello, Hong Kong", bills itself as an effort to tell "good stories" about the southern Chinese city, where years of political repression, coupled with pandemic curbs, have tarnished its businessfriendly reputation.

Promising "no isolation, no quarantine and no restrictions" during a speech to business and tourism heavyweights, Chief Executive



John Lee announced 500,000 free air tickets for visitors to experience the city's "hustle and bustle"

The giveaway will open in March, and mainly be distributed by local airlines Cathay Pacific, HK Express

and Hong Kong Airlines. Another 80,000 tickets will be offered to residents in the summer, with the carriers yet to announce destinations

"This, ladies and gentlemen, is probably the world's biggest welcome ever," Lee said.

Adherence to Beijing's zero-Covid doctrine of quarantine, closed borders and face masks kept Hong Kong largely virus-free until a deadly Omicron outbreak at the start of 2022. But it also contributed to an economic recession and the exodus of more than 2.5 percent of the population.

Even as business leaders warned Hong Kong would need a full Covid exit plan before any meaningful reboot, officials insisted on gradually rolling back restrictions.

The controls closed off what was previously one of Asia's most connected cities. Hong Kong welcomed just 600,000 visitors in 2022, less than one percent of 2018's figure.

More than 130 international companies have shuttered their Hong Kong offices over the past three years, while a recent survey of 253 Japanese firms showed se-

curing quality workers was their top concern.

More than a quarter of the surveyed companies worried about brain drain due to the national security law Beijing imposed in 2020 to quell huge and often violent protests.

According to official figures, more than 140,000 people left Hong Kong's labour force last year, when the economy contracted by 3.5 percent. The top US diplomat in Hong Kong, Greg May, said last week that the city's reputation as a financial centre will hinge on its ability to uphold human rights.

"Our view continues to be that Beijing's actions could further force many of the city's best and brightest to flee," he said.

For me, the interest of my investors is paramount and everything is secondary. Hence to insulate the investors from potential losses, we have withdrawn the FPO," Adani said.

# **FMCG consumption** continues to decline

New Delhi. Feb 2: The country's Fast-moving consumer goods (FMCG) industry witnessed a consumption slowdown in the December quarter, with an overall "negative" volume growth, as consumers continue to reel under inflationary pressure, says a report.

According to the report leased by data analytics firm NielsenIQ Thursday, in October-December, the FMCG industry grew 7.6 per cent in terms of value but its volume growth was (-) 0.3 per cent. The rural markets declined 2.8 per cent registering the sixth consecutive quarter with negative volume growth, while the urban market maintained stable positive growth of 1.6 per cent. In the retail space, Modern Trade channels maintained a double-digit value growth of 23.3 per cent and volume growth of 12.6 per cent on a year-on-year basis. While the FMCG sales from traditional trade channels such as Kirana stores "witnessed continuous negative consumption growth (-1.5 per cent) for the fifth consecutive quarter".

## **RBI seeks details of** banks' exposure to Adani Group

he Reserve Bank of India (RBI) has sought details about lenders' exposures to the Adani Group, banking sources said, a day after the conglomerate withdrew the Rs 20,000-crore follow on public offer (FPO) of its flagship firm Adani Enterprises amid the steep fall in its stock prices. On Wednesday, Swiss lender Credit Suisse stopped accepting bonds by Adani group companies as collaterals for margin lending. The RBI gets access to banks' large corporate borrowers on a regular basis as part of the central repository of information on large credits (CRILC) data base, the banking sources said. Many a time bank lending happens against pledged securities and a massive fall in the price of the equity shares of the Adani group's 10 listed entities could have accordingly lowered the value of the pledged securities.

New Delhi, Feb 2: The sevenmonth-old windfall profit tax on domestically produced crude oil and export of fuel is likely to give about Rs 25,000 crore in the current fiscal ending March 31 and the levy will continue for now as international oil prices are up again, top government officials said.

"As of now, crude prices are again on the rise. So, for time being windfall tax will continue," CBIC chairman Vivek Johri told PTI here.

Separately, Revenue Secretary Sanjay Malhotra said the budget has estimated collection from windfall tax at Rs 25,000 crore in the current fiscal.

As the geopolitical situation continues to be volatile, Johri said it would be "difficult to predict how long the windfall taxes will continue'

night and rates are moderated based on international oil prices. The windfall tax on crude oil

produced by companies, such as Oil and Natural Gas Corporation (ONGC), is currently Rs 1,900 per tonne.

Crude oil pumped out of the ground and from below the seabed is refined and converted into fuel like petrol, diesel and aviation turbine fuel (ATF).

The tax on the export of diesel is Rs 5 per litre and that on overseas shipments of ATF is Rs 3.5 a litre.

The export tax on petrol was scrapped in the very first review. The government levies tax on

windfall profits made by oil producers on any price they get above a threshold of \$75 per barrel.

The levy on fuel exports is based on cracks or margins that refiners earn on overseas shipments. These margins are primarily a difference between the international oil price realised and the cost.

# **ECB outpaces US Fed**

The Frankfurt-based policymakers are moving aggressively to get on top of price spikes that have slowed but are still hurting households in the 20 countries that use the euro currency.

# Renault-Nissan plan India reboot in test of reshaped alliance

Unlike Nissan, Renault does not have a significant presence in major markets like China, the United States and Japan, raising the stakes for its success in India

New Delhi, Feb 2: A revamped alliance between Renault and Nissan will face an early test in India, where the automakers plan new investment in a bid to close the gap on rivals, people with knowledge

of the plans told Reuters. The automakers reached a deal in principle Monday to restructure their two-decade partnership by putting both companies on an equal footing in terms of shareholding and with Nissan investing in Renault's

new electric vehicle (EV) unit. The French and Japanese companies announced they had identified key projects on which they would deepen collaboration in India, Latin America and Europe, without elaborating.

In India, the world's fastest-growing car market, the new invest-

ment will be led by Nissan, and the companies are evaluating vehicles they could launch from 2025, two of the people told Reuters. That could include a reboot for Renault's popular Duster sportutility vehicle, they said.

Renault-Nissan also plan to return to a strategy of sharing and cross-badging vehicles in India, aiming to increase plant utilisation rates and reduce costs, the people said. The Duster SUV, for instance, is being considered for

launch under both the Nissan and Renault brands, they said. The sources asked not to be identified because the companies have not announced details of the new strategy, which could be made public as early as next week.

The new collaboration underscores the pressure automakers face as they invest in EVs, au-



tomation and other software services even as demand for gasoline cars greatly outstrips that for EVs, especially in up-and-coming markets like India.

It also points to the rising potential for sales in India, which last year overtook Japan to become the world's third-largest car market. Industry-wide sales in India surged 23% last year to 4.4 million, according to S&P Global Mobility, while other major markets faced supply constraints.



The first test for the new Renault-Nissan approach could be the Renault Triber, a seven-seat car that the companies have discussed selling in India under the Nissan brand, one of the people said. Those talks were put on hold while they negotiated the broader partnership, he said.

Renault is considering an electric version of its mass-market Kwid small car for India, Reuters reported last month. Two of the peo-

500,000 cars a year but is only running at about a third of that capacity, industry data show. Nissan owns 70% of the plant, but its sales in India lag Renault's. Nissan sold just 35,000 vehicles in India in 2022 - 60% below Renault's 87,000.

Renault has a bigger stake in the research centre, which focuses on localising vehicles for India and global markets.

Cross-badging carries the risk that a Nissan version of a vehicle could cannibalise sales for the Renault equivalent or vice-versa. That was one reason the companies previously scrapped the approach. But rivals like Japan's Toyota

Motor and partner Suzuki Motor 🛁 have had success with the strategy in India.

In Latin America, Renault and Nissan are studying the shared use of low-cost vehicle platforms, a person with knowledge of theplan there said. The alliance has plants in Mexico and Argentina.

### DAVIS CUP: INDIA MAKE SMART SELECTION CHOICES AS TEAM PREPARE TO NEGATE RUNE'S PRESENCE IN PLAY-OFF TIE

Herculean task awaits India

Hillerod (Denmark), Feb 2: It will be a Herculean task for the Indian Davis Cup team to save their place in World Group I when they clash with the Holger Runeled Denmark in the Davis Cup Playoff tie, starting Friday.

India does not have even one player inside the top-300 while World No.9 Rune will make the hosts firm favourites to stay in World Group I. The tie will be played indoors on hard courts.

India had blanked Denmark 4-0 in Delhi in March 2022 but the presence of 19-year-old Rune, who reached the fourth round at the Australian Open last month and won three ATP titles in 2022, makes it a very different proposition.

However, India have come out with a nice strategy to counter Rune's presence and are targetting lower-ranked players in the Denmark camp-August Holmgren (ranked 484) and Elmer Moeller (ranked 718)-to emerge victorious

The team has decided to field Yuki Bhambri on day one as the country's second-highest ranked player so that Sumit Nagal can go in as the number one player and strive to eke out a win on the opening day.

Holmgren might be ranked low but he is a tough nut to crack. He has been an NCAA champion in the past and will pose a strong challenge to the Indian team.

The doubles match will assume significance and seasoned Rohan Bopanna will have to use his experience to lead the side.

Ever since the new format was introduced in 2019, the Indian team has managed to stay in World Group I but the team will have to work hard to keep its place.

There are three singles players in the playing squad – Prajnesh Gunneswaran (306), Ramkumar Ramanathan (412) and Sumit Nagal (509) - while Sasi Kumar Mukund has been left out.

But it's not a surprise that captain Rohit Rajpal has decided to play Bhambri. He has quit the singles format on the ATP Tour but still is such a good player on indoor courts (where external factors like wind do not count) that it is difficult to ignore him. Yuki will open the tie with the match against Rune while Nagal will play against

The newly-laid indoor court is a bit slow and is offering waistheight bounce. According to captain Rajpal and coach Zeeshan Ali, Nagal is looking the sharpest on the Indian side.

Nagal also looked in good form in Pune where he went down fighting. "The waist-height bounce won't help us like the grass courts, the lower it is, better it is for us. But still it is better than those high-bounce courts. It suits them more and that's why they have prepared such

court where the home players can strike big," captain Rajpal told this agency. "This tie we have 50-50 chance

and I am looking for at least a 1-1 score on day one. Hope Yuki can produce something special.'

Coach Zeeshan explained the strategy. "We wanted Sumit to play as our number one player so that he can play Denmark's second singles player on day one. The rankings of our players are such that it was possible only if Yuki or Rohan played as the second singles player, so it was Yuki," he said.

"We have played defensive in previous ties where we played against top players and it did not work. We had to do something different.'

The team management admitted that the side is feeling the pressure going into the tie without having a single top-300 player. On day two, Bopanna and Yuki will play the doubles against Johannes Ingildsen and Christien Sigsgaard. However the hosts can also field Rune if required on day two.

# It was near-perfect game: Gill<sup>-</sup>

Ahmedabad, Feb 2: Young opener Shubman Gill said his unbeaten 63ball 126 was "tactically and technically" a near-perfect game as it set up India's massive series-clinching 168-run win in the third T20I against New Zealand.

Gill smashed 12 boundaries and seven maximums in his scintillating maiden century in the shortest format to power India to a mammoth 234 for 4 in the final T20I. The hosts then bundled out New Zealand for 66 in 12.1 overs to not only win the match but also se cure a 2-1 series win.

"To be able to play how I play, I have to be mentally clear," Gill said during an interaction with skipper Hardik Pandya, a video of which was posted on BCCI.Tv.

"This is what you (Hardik) told me. Every time I hit a six, he came and told me – hold your shape in the next ball, you don't have to do anything extra, just do what you are doing and don't try to go too hard. Every ball he kept reminding me and that helped.

"In the last over of (Mitchell) Santner, I was in the zone and I was hitting. So, I thought I will go after him but you asked me to hold myself back and target other bowlers because he (Santner) is bowling well in the entire T20 series. So, tactically and technically it was a near-perfect game for me.

'Player of the series' Pandya snapped four wickets as he bowled with the new ball to dismiss Finn Allen and Glenn Phillips. He later returned to take two more wickets to demolish the Kiwis.


"Four wickets, to be honest, are just part and parcel of the sport but I think I bowled at 145 (kmph) if 1 am not wrong and that kind of gave me the happiness and the smile you can see.
