

Pakistan's wily former military ruler General Pervez Musharraf, the architect of the Kargil War in 1999, died Sunday in Dubai after battling an incurable disease.

Musharraf, 79, who lived in selfimposed exile in the UAE to avoid criminal charges against him in Pakistan, died after a prolonged illness at American Hospital in Dubai.

He was suffering from amyloidosis, a rare disease caused by a build-up of an abnormal protein called amyloid in organs and tissues throughout the body, according to his family.



In a statement issued immediately after Musharraf's death, the Inter-Services Public Relations (ISPR), the media wing of the Pakistan military, said that Chairman Joint Chiefs of Staff Committee General Sahir Shamshad and all the services chiefs express their heartfelt con-

dolences. "May Allah bless the departed soul and give strength to the bereaved family," it said.

Musharraf's family has filed an application in the Pakistani consulate in Dubai to shift the former military leader's body to Pakistan.

His illness came to light in 2018 when his party - the All Pakistan Muslim League (APML) - announced that the former military ruler was suffering from amyloidosis. In June last, he was hospitalised in Dubai for three weeks. MORE ON PAGE 10

2,278 ARRESTED IN 3 DAYS IN NORTHEASTERN STATE'S RUTHLESS ACTION

Morigaon, Feb 5: Nimee's eyes do not sparkle with the joy of new motherhood, instead, they reflect fear, insecurity and sense of foreboding that stalks her village in Assam's Morigaon district.

Rezina Khatun stares vacuously into the distance - trying to make sense of the sudden apocalypse, which has struck her till-now happy world

While Nimee is among the thousands of child brides whose husbands were arrested in a statewide crackdown against child marriage by the Assam Police over the last three days, Rezina is a mother whose son's romantic escapade, which had ended with marriage, has landed him in jail now.

In the drive against child marriage, police till Sunday arrested 2,278 people, including Hindu and Muslim priests who conducted such weddings. Police said there is

a list of a total 8,000 accused. The police had registered 4,074 cases of child marriage in less than a fortnight after the state Cabinet decided January 23 to arrest offenders, besides launching an extensive awareness campaign against the menace.

"There was a knock on the door

around 2 am Thursday. We opened the door and found policemen outside. They took away my husband," Nimee told PTI in a feeble voice, as her one-and-half-month-old son cried in her arms just as he had when his father was being arrested.

The 17-year-old had eloped and tied the knot with Gopal Biswas,

who is in his twenties, more than a year back, and they were starting off their family with the husband providing for them by selling pakoras and other savouries.

The names of those affected were changed to protect their identities. "We barely earn enough to feed our own families. Who will look

after Nimee and her son? She has been inconsolable, barely eating anything. The child is also getting sick now," said Yudishter, Gopal's elder brother, who lives in the same house along with their aged parents.

Rezina's son Rajibul Hussain was picked up from their home around 6 pm Thursday, barely a few minutes after he had reached home with his father after returning from a trip to Kerala, where they had gone to bring back his injured uncle.

"My daughter-in-law is not underage but there was some error in her Aadhaar card due to which my son is now behind bars. She has gone to our native place, some distance away, to get her birth records," Rezina claimed, trying to convince whoever cared to listen.

A neighbour of the family claimed that many like Rajibul's wife were not minors at the time of the marriage but their dates of birth were wrongly entered while enrolling for Aadhaar cards.

"Data on the age was taken by the police from local health workers, who have the information based on the Aadhaar. Now, we are helping these women to get their original birth records so that their husbands can get bail,' Contd...4 he claimed.

Nilagiri, Feb 5: A mother bear and its two cubs were killed after being hit by an unknown vehicle at Patana on the Ajodhya-Mitrapur road under Nilagiri forest range in Balasore district, in the wee hours

of Sunday. The mishap occurred when the mother bear was crossing the road with its two cubs. An unknown vehicle hit them and sped away. The three animals died on the spot. Nilagiri forest ranger Aisha

Akhtari Nisha reached the spot with forest officials and conducted an investigation.

Carcasses of the animals were recovered and a veterinarian conducted their post-mortem. Later, the carcasses were buried at a forest nursery near Sajanagarh.

Notably, the mother bear and its two cubs had strayed into nearby

villages in search of food and were returning back to the jungle in early morning when the mishap occurred.

The bear is a Schedule I animal protected under the Wildlife Protection Act for which attacking the animal is a punishable offence. Environmentalists said that shrinking forest cover has led to the loss of habitat for the animal and shortage of food in the forest. As a result, the animals often stray into nearby human habitats at night in search of food.

This results in man and animal conflicts as their straying into human habitats threatens the safety of humans while endangering the lives of the animals.

Moreover, the animals end up losing their lives either in attack by villagers or in road accidents while returning to forests in the morning

stant complaints against Chinese loan and betting apps, the Ministry of Electronics and Information Technology (MeitY) has started the process of banning 138 betting apps and 94 lending apps that had Chinese links, on the instructions of the Union Ministry of Home Affairs (MHA).

The MeitY was recently instructed by the MHA to ban such apps, which operate through a third party link.

Sources said that all these apps were found violating Section 69 of the IT Act and contained material which was deemed as a threat to India's sovereignty and integrity.

As per sources, these apps were used to trap financially strapped people in a debt trap by increasing their interest on loans up to 3,000 per cent.

Many such people who were caught in the debt trap committed suicide when the people working

borrowers were seen in Andhra Pradesh and Telangana.

On the other hand, the Chinese apps can potentially misuse serverside security by using them as spying tools as they have access to the important data of many Indians.

Access to such data can be used for espionage on a large scale, due to which all such apps are being considered as a threat to the country. The MHA had started investi-

gating some Chinese loan-giving apps around six months ago.

It was revealed that 94 such apps were available on the e-store and operated through third party links.

Around that time, security agencies had asked the Ministry to impose a ban on such betting and loan-lending apps.

Significantly, the Centre had banned 54 Chinese apps that posed a threat to the country's security in 2022.

US DOWNS CHINESE SURVEILLANCE BALLOON

Washington/Beijing, Feb 5: The US military has downed the suspected Chinese spy balloon over the Atlantic Ocean and launched a mission to recover all the equipment from its debris, drawing a strong reaction from China which Sunday warned of repercussions over America's use of force against its civilian unmanned airship.

At the direction of President Joe Biden, the US military at 2.39 pm EST Friday shot down the Chinese surveillance balloon in the Atlantic Ocean, some six miles (9.65 kms) away from the US shores in South Carolina, with no damage to the life and properties of Americans, a senior defence official told reporters in Washington. "I told them to shoot it down,"



Biden told reporters in Hagerstown, Marvland. "Wednesday, when I was briefed on the balloon, I ordered the Pentagon to shoot it down as soon as possible. They decided - without doing damage to anyone on the ground -- the best time to do that was as it got over water, outside within the 12-mile limit."

India turning Russian oil into the West's fuel

New Delhi meeting the West's twin goals of crimping Moscow's energy revenue while preventing an oil supply shock

New Delhi, Feb 5: India is playing an increasingly important role in global oil markets, buying more and more cheap Russian oil and refining it into fuel for Europe and the US, the Bloomberg reported.

Yet New Delhi has faced little public blowback because it's meeting the West's twin goals of crimping Moscow's energy revenue while preventing an oil supply shock. And as Europe ramps up sanctions, India is only going to become more central to a global oil map that's been redrawn by Vladimir Putin's yearlong war in Ukraine. 'US treasury officials have two

main goals: keep the market well supplied, and deprive Russia of oil revenue," said Ben Cahill, a senior



fellow with the Center for Strategic and International Studies, a Washington think tank. "They are aware that Indian and Chinese refiners can earn bigger margins by buying discounted Russian crude and exporting products at market prices. They're fine with that."

India shipped about 89,000 barrels a day of gasoline and diesel to New York last month, the most in nearly four years, according to data intelligence firm Kpler. Daily lowsulfur diesel flows to Europe were at 172,000 barrels in January, the most since October 2021.

India's importance is expected to expand after fresh European Union sanctions on Russian petroleum exports take effect. The ban will

remove a huge volume of diesel from the market and see more consumers, especially in Europe, tap Asia to fill the supply gap.

That will make cheap Russian oil even more attractive to India, which relies on imports to meet around 85% of its crude needs. Its refiners, including state-run processors that are responsible for meeting domestic demand, ramped up exports last year in order to profit from higher international prices.

"India is a net exporter of refined product and much of this will be going to the West to help ease current tightness," said Warren Patterson, Singapore-based head of commodities strategy at ING Groep NV. "It's pretty clear that a growing share of the feedstock used for this product originates from Russia." Under EU guidelines, India is likely operating within the rules. When Russian crude is processed into fuels in a country outside of the bloc such as India, the refined products can be delivered into the EU because they're not deemed to be of Russian origin.

The Group of Seven nations are keen to cut Moscow's revenue as much as possible, but they also have an interest in ensuring that Russia's oil and refined products continue to flow to avoid a global supply crunch, said Serena Huang, lead Asia analyst at Vortexa Ltd.

A US National Security Council spokesperson said a price cap had been put in place that countries including India could leverage tokeep energy markets stable, while limiting the Kremlin's revenue.





Bhubaneswar, Feb 5: With the Odisha Police still in dark about the reasons behind the assassination of Health Minister Naba Kishore Das by a policeman, the Bharatiya Janata Party (BJP) Sunday slammed the state government over the law and order situation while the Biju Janata Dal (BJD) said the government has never neglected any investigation.

Expressing concern over the law and order situation in Odisha, Union Education Minister Dharmendra Pradhan Sunday said the state gov ernment has no clue why an onduty policeman shot dead Health Minister Naba Kishore Das.

Talking to reporters. Pradhan said Chief Minister Naveen Patnaik, who also holds the Home portfolio, has not spoken publicly on the killing of the influential minister other than condoling his death.

"No one has a clue why an on-duty policeman shot dead a minister from point blank range with a gun provided by the government. And one week after the incident, the DG is saying 'we have hope in Jagannath'. It shows the law and order situation of the state," he said.

Das, 60, breathed his last January 29 evening, hours after he was shot by the policeman at Gandhi Chhak in Brajarajnagar area of Jharsuguda district, where he had gone to attend an event. "There is no clarity on the role of the retired High Court judge who has been assigned to monitor the investigation. The retired judge has not been appointed in ac





Seminar on effects of chemical usage

Bhubaneswar, Feb 5: A seminar on the topic 'Chemicals harming health and environment' was organised by the Orissa Environmental Society (OES) to address the toxic nature of chemicals and the aftereffects of their usage.

In 21st century, we are exposed to various chemicals in our everyday life to meet our escalating material demands. As per the estimation, on a regular basis we come across about 500 chemical compounds, which are synthetic as well as toxic in nature.

"Many of these toxic chemicals have the potential to initiate health hazards in living beings. These chemicals also contaminate our environment including soil, water and air, and ultimately the chem ical particles enter the human body through the food chains. Concentration of these toxic chemicals in human body becomes higher through the process of biomagnifications, thus causing diverse health-related disorders and disruptions," said one of the en vironmental experts.

Dysfunction of organs, development of allergies, respiratory and cardiac disorders, weakening of immune system, hormonal dis-



turbances, reproductive problems and birth defects, growth-related issues and increased occurrence of cancer are some of the important manifestations. Most of the chemicals are also used in cosmetics and personal care products, surface cleaners and disinfectants, food preservatives, solvents and paints, air fresheners, bleaching chemicals, batteries and pesticides used in agriculture.

Lead and other heavy metals are carcinogenic in nature, which wreak havoc with our body's regulating system.

Hence, we must take every possible step towards reducing the use of these destructive chemicals and to avoid the radiations involved with them, the speaker added.

The chief speaker of the seminar Shreerup Goswami, who is a faculty of Geology, Utkal University, made an elaborate description of the contemporary diverse syn-

thetic chemicals that includes serious health concern. Female hormone Oxytocin is injected into cattles for better milk production, hens for more eggs, vegetables to get larger in size and well shaped. Formaldehvde is used to preserve fish, and Melamine and urea are added to milk to create a fake impression of enhanced protein and fat. Dexamethasone is given to cattle, goats and sheep to produce more meat. Even cold drinks are laden with pesticides, apples are coated with wax, and chemical colours are added to fruits and veg-

hance flavour. Goswami dismayed over such happenings that trigger mankind towards grave health disasters. Presiding over the seminar, former Chief Conservator of Forests (PCCF Wildlife), Bijay Kumar Patnaik emphasized on spreading awareness among people and strict enforcement of existing laws that prevent the use of certain

etables to look fresh and to en-

chemicals. The welcome address by the secretary Jaya Krushna Panigrahi suggests giving utmost priority to the use of products derived from natural resources to meet our basic needs and how to reduce the use of synthetic chemicals to the greatest possible extent.

Critical ignoring needed to beat information overload

he web is an informational paradise and a hellscape at the same time.

A boundless wealth of high-quality information is available at our fingertips right next to a ceaseless torrent of low-quality, distracting, and manipulative false information. The platforms that control search

were conceived in sin. Their business model auctions off our most precious and limited cognitive resource: attention. These platforms work overtime to hijack our attention by purveying information that arouses curiosity, outrage, or anger. The more our eyeballs remain glued to the screen, the more ads they can show us, and the greater prof-

its accrue to their shareholders. It is hardly surprising, therefore, all this should take a toll on our collective attention. A 2019 analysis of Twitter hashtags, Google queries, or Reddit comments found that across the past decade, the rate at which the popularity of items rises and drops has acceler-

tag on Twitter was popular on average for 17.5 hours, while in 2016, its popularity faded away after 11.9 hours. More competition leads to shorter collective attention intervals, which lead to ever fiercer competition for our attention - a vicious circle. To regain control, we need cognitive strategies that help us reclaim at least some autonomy and shield us from the excesses,

The textbook cognitive strategy is critical thinking, an intellectually disciplined, self-guided and effortful process to help identify valid information. But is it enough in a world of information overabundance and gushing sources of disinformation? The answer is "No" for at least two reasons.

First, the digital world contains more information than the world's libraries combined. Critically thinking through all information and sources we come across would utterly paralyse us because we would

never have time to actually read the valuable information we painstakingly identify.

Critical ignoring is the ability to choose what to ignore and where to invest one's limited attentional capacities. Critical ignoring is more than just not paying attention -it's about practising mindful and healthy habits in the face of information overabundance.

Three main strategies exist for critical ignoring. Each one responds to a different type of noxious information.

Self-nudging aims to empower people to be citizen "choice architects" by designing their informational environments in ways that work best for them and that constrain their activities in beneficial ways. We can, for instance, remove distracting and irresistible notifications. We may set specific times in which messages can be received, thereby creating pockets of time for concentrated work or socialising. Lateral reading is a strategy

that enables people to emulate how

professional fact checkers establish the credibility of online information. It involves opening up new browser tabs to search for in-

formation about the organisation or individual behind a site before diving into its contents. The do-not-feed-the-trolls heuris-

berbully or use other antisocial tactics. Trolls thrive on attention, and deliberate spreaders of dangerous disinformation often resort to trolling tactics. One of the main strategies that science denialists use is to hijack people's attention by creating the appearance of a debate where none exists. The heuristic advises against

directly responding to trolling. Resist debating or retaliating. Of course, this strategy of critical ignoring is only a first line of defence. It should be complemented by blocking and reporting trolls and by transparent platform content moderation policies including debunking.

The philosopher Michael Lynch has noted that the Internet "is both the world's best fact-checker and the world's best bias confirmer-often at the same time.

Navigating it successfully requires new competencies that should be taught in school.

Mahakalapara, Feb 5: Red crabs have started their migration to the expansive sea beach of Gahirmatha marine sanctuary under this block in Kendrapara district for mating and spawning.

The scene of red crabs gathering in hordes on the vast sand bed of Hukitola, Madali, Lunchghola, Tanda, Agarnasi islands of the sanctuary is a sight to behold. The deep burrows dug out by them on these islands have become their new homes as they arrive in hordes for spawning.

After mating, male crabs go back and the females stay behind in burrows for about two weeks to lay eggs. Each female can produce up to one lakh eggs, which it deposits into the ocean

Red crabs play a great role in protecting the ecological balance in the mangrove forests, maintaining biological diversity and in protecting the marine environment

These crabs dig out two to three feet deep burrows and make it their new home for mating. They feed on dead seaweeds, dead fish and small marine creatures. Breeding mostly takes place during the winter sea son when the female crabs give birth to hundreds of baby crabs. Later, they move on the beach and then into the sea with the mother crabs

Not more than two inch in length, these crabs survive till two years. They prefer to live in hordes and are apt in sensing natural calamities and in changing places before

Case filed against State govt to build alternative Anandapur MLA route of Dwarasuni ghat road

Keonihar: Feb 5: Anandapur MLA Bhagirathi Sethy was caught on the wrong foot after the local police registered a case against him on charge of hurling abuses and issuing threat at BJP's Zilla Parishad (ZP) (zone no-3) member Ashima Mishra during a meeting of the Anandapur Panchayat Samiti, last year.

The case-24/2023 under Section-294 and Section-506 of Indian Penal Code (IPC) was registered after the Orissa High Court directed the police to register a case on the complaint filed by Mishra at Anandapur police station.

The case was registered following a direction of the Orissa High Court and action will be taken after conducting a probe,² Anandapur IIC Debaki Nayak said. The incident occurred during

a review of the developmental works at a meeting of the Anandapur Panchayat Samiti, August 30, 2022. The MLA flew into rage and asked Mishra to get out from the meeting when she questioned the progress of the developmental works being implemented in the area.

Hurling abuses, Sethy told her that she has no rights to ask ques-



tions, the woman ZP member alleged. He even threatened her of dire consequences, she alleged. She first lodged a complaint at Anandapur police station and later, filed a written complaint with the SP.

However, she moved the high court after she failed to get justice from the district police.

Baripada, Feb 5: With Dwarasuni ghat road on National Highway-49 under Bangiriposi limits in Mayurbhanj district witnessing frequent accidents and subsequent traffic jams, the state Rural Development department has planned for an alternative route to fix the problems

The department has decided to construct a 31-km long road connecting Bisoi-Joka-Saraskana and Jharpokharia in Mayurbhanj district to fix the problem. The road will be nine metre in width with 5.5 metre of it will be blacktopped. It is expected to get completed towards the end of 2023.

At the outset, the Rural Development department has prepared a plan outlay of Rs 41 crore and sent it for approval by the department authorities. This was stated here by superintending engineer Aswini Dandapata while talking to mediapersons here. Saturday. After construction, the road will prove to be an alternative route to Dwarasuni ghat road (Bamanghati) in the district, he said.

Earlier, the road was connected with two roads built under Pradhan Mantri Gram Sadak Yojana from Bisoi to Hatichhad and from to Joka. A blacktopped road connects



Joka with Saraskana.

The road, when completed, will resolve the commuting and traffic problem on Dwarasuni ghat. The alternative road will be 14 km more in length than the Dwarasuni ghat road but the commuting time will be same for two roads, he said.

Sources said that the NH-49 connecting Mumbai with Kolkata passes through this 17-km long stretch of Dwarasuni ghat road Expressing concerns over the frequent mishaps, the state government has written to the National Highways Authority of India (NHAI) urging to fix the road problems without delay.

However, the NHAI authorities have failed to carry out its expansion and double-laning works as the Union Forest Ministry is yet to give its approval on environmental clearance.

This has stalled the expansion

works of the ghat road following which road mishaps have become a regular occurrence leading to deaths and injuries. Mishaps also lead to frequent traffic jams on the ghat road. The scene of hundreds of ve-

hicles getting stranded on the route for hours together is a regular sight. Several agitations have been carried out demanding expansion of the hilly road but so far they have failed to give any result so far.

Cancer projections for 2021-25 show a worrisome figure: Experts

Bangalore, Feb 5: The cancer projections for 2021-2025 show a worrisome figure and are looking at an increase to 29.8 million in 2025 from 26.7 million in 2021, as per the Indian Council of Medical Research (ICMR) report, with men contributing to 14.7 million Years of Life Lost (YLLs) and women up to 13.6 million YLLs in India, said Dr Sharat Damodar, Chairman, Oncology Collegium, Narayana Health.

People above the age of 40 need to be vigilant towards symptoms of prolonged fever, weight loss, abnormal swellings or any bleeding symptoms and get themselves screened immediately, said Sharat Damodar, who is also a senior consultant and head of Adult Hematology and BMT.

One should adopt healthy lifestyle, avoid smoking, alcohol, high fatty foods, packaged food, adulterated food, polluted surrounding with unhealthy gases or radiations, etc. Exercising regularly, having natural, non-processed diet made through fresh non-contaminated vegetables and fruits and trying to lead a stressfree life can be key towards a cancerfree tomorrow, he said.

Most common cancers seen in men include oral, lung, stomach, colon, oesophagus and in woman include breast, cervix, ovary, oral cav-



ity and colorectal, according to some of the past data. The commonest cancer in children is leukaemia which comprises about 30 per cent of cancers and around 80 per cent

the Karnataka state showed cumulative risk of developing cancer of any site in 0-74 years of age group was 1 in 7 for males and 1 in 6 for females, he said.

"At Mazumdar Shaw Medical Centre, Narayana Health City, we are treating 1100 to 1200 new patients a year out of which 500 to 600 are males, 500 females and around 100 children. In last 4-5 years, we are seeing that of all cancers 15 to 20 per cent are breast cancer, 15 per cent to 20 per cent head and neck cancers and around 10-15 per cent of gynaecology-related cancer cases,' Damodar said.

Considering the burden of the disease not seeing any reduction in numbers, we need to pledge towards self-awareness around the disease. The pandemic registered less detection of cases hence lesser number of diagnosed cases, he said.

Myanmar Mess

he bad news from Myanmar is that its military junta has imposed martial law in areas where anti-military resistance is growing from strength to strength and extended the state of emergency for six months. It means the people there, accused of everything from treason to 'spreading false news,' will be tried by military tribunals. No one has a shadow of doubt that the charges will be trumped up. In the 37 townships affected by the new measures announced in the state-controlled media February 3, no appeals will be allowed for convictions handed down by military tribunals. Only cases where the death penalty is imposed will have to be approved by military chief Senior General Min Aung Hlaing.

One implication of the extension of martial law and the state of emergency is that the possibility of holding elections expected in August as announced before, whatever their worth, becomes uncertain. The new measures show the military junta has grown nervous even two years after it staged a coup and did not allow the installation of an elected government. This is because resistance against military dictatorship has spread throughout the country so much that the junta itself has admitted that its fiat does not run in onethird of the country. A measure of the determination of the people of Myanmar to stand up to the junta is the silent protest observed in the country to mark the second year of the military coup February 1. Streets in many cities fell quiet after protesters urged people to stay indoors and asked businesses to close. The main message of the silent strike is that the military "shall never rule the country's people."

In fact, the announcement appears to indicate that the military is looking for new ways to stamp out resistance in areas where people have taken up arms to fight against its seizure of power. The official explanation for the expansion of martial law is but an eyewash. Germany's foreign ministry rightly described the new measures as "illegitimate steps" and rightly called for an end to the military's violence and human rights abuses.

The military authorities stated the aim is "to exercise more effective undertakings for ensuring security, the rule of law and local peace and tranquility." The 37 townships affected by the imposition of martial law are located across eight states and regions. Regular clashes between the military and the anti-coup People's Defence Force, the armed wing of the opposition's underground National Unity Government, have been continuing in the new areas to come under martial law.

Myanmar's military has been struggling to contain a nationwide insurrection by opponents of military rule who took up arms after peaceful protests against the coup in February 2021 were suppressed with lethal force. According to an independent watchdog, at least 2,948 civilians have been killed since the military grabbed power and toppled elected leader Aung San Suu Kvi

On the other hand, the country's gross domestic product (GDP) shrunk by almost a fifth in 2021 before growing by just 3 per cent from a much smaller base the following year. The World Bank this week put Myanmar's growth for the fiscal year ending in September at 3 per cent but warned that per capita GDP would remain about 13 per cent below its level before the COVID-19 pandemic. That means Myanmar's 2023 GDP will still be smaller than the pre-coup economy

Recovery from the shocks of COVID-19 and the coup "is expected to remain subdued in the near term, constrained by significant macroeconomic and regulatory uncertainty, persistent conflict, and ongoing electricity outages,' the World Bank said in its update.

The military regime has detained some of Mvanmar's tycoons and confiscated the passports of foreign corporate executives. Business groups and diplomats, including the friendly Chinese Ambassador, have openly expressed their dissatisfaction over the junta's economic measures.

It means the international community, including the regime's main supporter China, finds it difficult to invest in Myanmar plagued by a repressive regime, growing protests in large swathes of the land and a faltering economy. The junta appears to be fighting a losing battle. The best remedy for both the military and the people will be to begin dialogue and revive at least the hybrid democracy prevailing in the country before the military takeover. Tyranny and terror by the junta will plunge Myanmar into greater turmoil and chaos.

do not invest more on basic healthcare, surveillance systems, and public health functions, the damage would be enormous. In this context, the allocation and expenditure in the previous two years were in right direction. However, this momentum was disrupted in 2023-24 BE.

Within the health and family welfare department, the budget allocations to several priority areas - National Health Mission (NHM), PMJAY, PM Health Infrastructure Mission and National Digital Mission are critical as they build necessary health infrastructure, support primary care development and provide financial protection against regressive out of pocket expenditure due to hospitalisation. In 2018, the announcement of PMJAY, the largest public funded health insurance scheme in the world, brought health to the center of political discourse. The allocation to PMJAY stands at ₹7200 crore in 2023-24 BE and this was ₹6412 crore in 2022-23 BE. Being a demand driven scheme, the expenditure on PMJAY is contingent upon healthcare utilisation by the beneficiary. And therefore, empanelment of hospitals, disbursement of funds to hospitals, quality of care and administrative issues are more important than resource allocation.

Allocation to the NHM, another flagship programme which aims at strengthening both rural and urban health systems along with ing ₹341 crore in current budget compared to ₹200 crore in last budget is notable. This will create and strengthen the much-needed digital ecosystem in order to improve service delivery and ease access.

The health sector priorities were announced within the inclusive development agenda, one of the seven priorities declared by the finance minister. To achieve inclusive development, the announcement to create a sickle cell mission and eliminate sickle cell by 2047 is commendable, as this will benefit a large segment of population in tribal areas. Another bold announcement that will contribute to the holistic development of PVTG within the tribal population is the Pradhan Mantri PVTG Development Mission with a budg etary support of ₹15,000 crore for three years.

Furthermore, this budget has aptly identified other social determinants of health especially highlighting the role of millets for improving nutritional deficiency observed among a large segment of population. Our progress on nutritional front as revealed from the NFHS V especially, declining stunting and wasting among the prosperous states is quite perplexing and this needs to be contextualised considering the announcement of Mission Poshan 2.0 in 2021 budget and emphasis on millets in the current budget.

Health is one of the important pillars of achieving sustainable development goals by 2030 and the priorities should not be out-ofplace as healthcare challenges are manifold. The momentum created by announcing PMJAY in 2018 should not be halted and public financing should be stepped up in order to increase its share to 2.5-3% of GDP. This however, requires equal or higher commitment from states so that India's tag as a low public financier for health is reversed soon.

Forthwith

Forth is one of those words that has gone out of the language except in a number of set phrases. Wey back the set of the language except in a number of set phrases. Way back beyond the Norman Conquest it meant forwards. That sense lingers in the phrase back and forth, backwards and forwards. Another semi-archaic phrase is from this day forth, in which it has the figurative sense of onwards: and so forth includes it in a similar sense: henceforth includes the same idea of time as does forthwith; to hold forth is to talk at length about some subject, often tediously; sally forth is still known. Round the middle of the twelfth century, the phrase forth mid appeared (mid being essentially the same as the modern German word mit, with), later forth with, to go somewhere in the company of other people. Necessarily, if you go forth with others, you go at the same time as they do. It seems this sense of time eventually took over, though the process of transition isn't very clear, and it's mixed up with other phrases that also referred to time. Certainly, by about 1450 the phrase had condensed to a single adverb with the modern meaning of immediately, without delay. Much of the idea of forth has been taken over in today's language by forwards, but that word itself is a contracted compound of forth with the suffix -ward, to go in a specified direction.

Fossick

Cossick is a characteristically Australian word (and, let us not forget, of New Zealanders too). As you've discovered, it isn't widely used in Britain, though there are so many Antipodean writers working in the media over here that the word is by no means unknown. These days, it means to search about in an unsystematic way in the hope of finding what you're looking for, or just searching in the hope of turning up something interesting. My New Zealand dictionary also says it can refer to pottering about more or less aimlessly (a travel writer in the Guardian in October 2005 used it this way: "And so back on board, for a last fossick through the Kattegat and Skaggerak.") But the original sense, and one that's still used, is to search gold-mine waste dumps or abandoned claims in the hope of turning up a few overlooked nuggets. That dates from the late 1850s in Australia and a few years later in New Zealand. Its origin isn't altogether clear, but the experts point to Cornish dialect. Cornishmen were well represented in early migrants to both countries and were known everywhere for their expertise in hard-rock mining. The English Dialect Dictionary a century ago included the Cornish dialect fossick in the sense of "to obtain by asking; to 'ferret out'", as well as fursick or fossick, East Anglian words for pottering over one's work, and fussock about, a rather more widely distributed dialect term for making a fuss or bustling about in an irritating way. The truth is lurking in there somewhere.

Already hailed as a milestone in the evolution of so-called large language models (LLMs), the world's most famous generative AI raises important questions about who controls this nascent market and whether these powerful technologies serve public interest. OpenAI's release of ChatGPT last November quickly became a global sensation, attracting millions of users and allegedly killing the student essay. It is able to answer questions in conversational English (along with some other languages) and perform tasks, such as writing computer code.

The answers that ChatGPT provide are fluent and compelling. Despite its facility for language, however, it can sometimes make mistakes or generate factual falsehoods, a phenomenon known among AI researchers as "hallucination." The fear of fabricated references has recently led several scientific journals to ban or restrict the use of ChatGPT and similar tools in academic papers. But while the chatbot might struggle with fact-checking, it is seemingly less prone to error when it comes to programming and can easily write efficient and elegant code.

why Microsoft recently announced a "multivear. multibillion-dollar investment" in OpenAI, report edly amounting to \$10 billion, on top of the \$1 billion it had already committed to the company. Originally a nonprofit, OpenAI is now a for-profit corporation valued at \$29 billion. While it has pledged to cap its profits, its loose-fitting structure limits investors' returns to 10.000%

ChatGPT is powered by a GPT-3, a powerful LLM trained on vast amounts of text to generate natural-sounding, human-like answers. While it is currently the world's most celebrated generative AI, other Big Tech companies such as Google and Meta have been developing their own versions. While it is still unclear how these chatbots will be monetised, a paid version of ChatGPT is reportedly forthcoming, with OpenAI projecting \$1 billion in revenues by 2024.

To be sure, bad actors could abuse these tools for various illicit schemes, such as sophisticated online scams or writing malware. But the technology's prospective applications, from coding to protein discovery, offer cause for optimism. McKinsey, for example, estimates that 50-60% of companies have al-

LLMs, companies could improve efficiency and productivity.

But the massive, immensely costly, and rapidly increasing computing power needed to train and maintain generative AI tools represents a substantial barrier to entry that could lead to market concentration. The potential for monopolisation, together with the risk of abuse, underscores the urgent need for policymakers to consider the implications of this technological breakthrough.

Fortunately, competition authorities in the US and elsewhere seem to be aware of these risks. The UK's communications regulator, Ofcom, launched an investigation of the cloud computing market, on which all large AI models rely. late last year, while the US Federal Trade Commission is currently investigating Amazon Web Services, which, along with Google and Microsoft Azure, dominates the market. These investigations could have far-reaching implications for AI-powered services, which rely on enormous economies of scale.

But it is not clear what, if any thing, policymakers should do. On one hand, if regulators do nothing, the generative-AI market could end up dominated by one or two

World Economic Forum meeting in Davos, generative AI is too powerful and potentially transformative to leave its fate in the hands of a few dominant companies. But while there is a clear demand for regulatory intervention, the accelerated pace of technological advance leaves governments at a huge disadvantage. To ensure that the public interest is represented at the technological frontier, the world needs a public alternative to forprofit LLMs. Democratic governments could form a multilateral body that would develop means to prevent fakery, trolling, and other online harms, like a CERN for generative AI. Alternatively, they could establish a publicly-funded competitor with a different business model and incentives to foster competition between the two models.

Whichever path global policymakers choose, standing in place is not an option. It is abundantly clear that leaving it to the market to decide how these powerful technologies are used, and by whom, is a very risky proposition.

More and more elephant corridors and enhanced budgetary provisions for ensuring elephants are safe are paramount.



The superintendent of police of the district was transferred within 24 hours of the incident, though the administration claimed that the move is not related to the killings.

TMC workers Newton Sheikh and his companion Laltu Sheikh, brother of the local panchayat chief, were going somewhere on a motorcycle when some miscreants hurled bombs at them on Saturday evening, police said. While Newton died at night, Laltu succumbed to his injuries at SSKM Hospital in Kolkata, where he was shifted from Rampurhat Hospital in the district. The relatives of the deceased



persons alleged that the bombs were thrown by goons of the Congress as the party was scared of the "increasing popularity" of the two in the area ahead of the panchayat polls due this year.

Countering their claims, West Bengal Congress president Adhir Ranjan Chowdhury said the party has little presence at Margram to be able to carry out such an attack.

New Delhi, Feb 5: India has witnessed a nearly six-fold increase in the total number of voters since 1951 to over 94.50 crore this year, but almost one-third of them stayed away from exercising their franchise in the last Lok Sabha polls. This has prompted the Election

Commission to walk the extra mile to bring them to the polling booths. In 1951, when the voter lists for the first general elections were prepared, India had 17.32 crore registered electors and 45.67 per cent had turned up to exercise their franchise in the newly-born Republic.



The number of registered electors witnessed a gradual increase over the years, and so did their participation in the subsequent elections. In the 1957 general elections, the number of registered

electors was 19.37 crore and 47.74 per cent cast their ballots to send their representatives to the Lok Sabha. Amid talks of taking the voter turnout to 75 per cent, the Election Commission has flagged

the issue of the 30 crore voters who did not turn up at the polling booths in the 2019 Lok Sabha elections. People from urban areas, youth and migrants are part of the category of these 30 crore missing voters.

The EC has pointed to urban apathy in the recently-held assembly polls on Himachal Pradesh and Guiarat. For migrants who have their names in electoral lists in their home state and cannot afford to go there to cast vote due to various reasons, the poll panel has proposed remote voting technology. But it needs political consensus, followed by change in legislative framework to roll out remote

electronic voting machines.

As it prepares to hold several assembly polls this year and Lok Sabha elections early next year, the poll panel aims to push voter percentage through innovative communication strategies.

Peoples' participation in the election process breached the 50 per cent for the first time in 1962 general elections when 55.42 per cent of the 21.64 crore voters exercised their franchise. By 2009, the total number of registered voters had zoomed to 71.70 crore but the turnout to the polling booths was only 58.21 per cent, a marginal increase in percentage terms over 1962.



'Queen of Hills' skips its white winter

EXPERTS BLAME DEFORESTATION FOR THE CHANGE IN SHIMLA'S CLIMATIC CONDITIONS

Shimla, Feb 5: Planning to head to the Himachal Pradesh capital to enjoy the snowy landscape? You will be disappointed, as declining forest cover and rise in pollution have rendered this hill destination unusually 'warm' this winter with long sunny days.

This is for the first time in many years that the 'Queen of Hills', as Shimla was fondly called by the British, is almost bereft of snow cover and parched too.

An official with the local Meteorological Centre told IANS Saturday that only Shimla's Mount Jakhu (the highest peak in the town) received mild snowfall this season. while commercial centre Mall Road. the historic Ridge and the US Club are yet to get snow cover.

However, even in the Jakhu area the snow melted within a few hours.

Under the guise of climate scepticism, most of the locals narrate the tale of indiscriminate construction that has turned the summer retreat of the then British rulers into a concrete jungle in the past few decades.

To highlight that climate change is already having visible effects on Shimla's precipitation patterns, old-timers have shared their photos posing with a cone of ice-cream in the backdrop of the British-era Christ Church on the social media

Octogenarian Shyam Saran Begta, who was born and brought up in Shimla, said the British had dug several wells in Mount Jakhu where the snow is stored during the winter. The wells helped in recharging the groundwater, which enabled spouting of perennial springs in the peak summer.

'Where have those wells gone? Now multi-storeyed concrete structures are standing on them. The for-



est cover has declined, so the noticeable change in weather patterns." he said.

Sounding alarm bells on climate change, another old-timer Ramesh Thakur said icicles are missing this year from Shimla's landscape.

We feel a delight to see these hanging icicles outside windows. Thakur, who lives in Jakhu hills, told IANS while pointing towards a smoke chimney, once the city's landmark on heritage buildings.

The icicles were the common feature till the 1980s and they were fivesix feet long at that time. Now their size has drastically reduced, he added. Icicle, a pendent spear of ice formed by the freezing of dripping

rooftop water, indicates a harsh winter Hospitality industry representatives are worried about their

businesses. They say lack of snow can impact tourism as the town draws a large number of holidaymakers from across northern India. According to the Meteorological

Earlier, the children used to take out sledges with the onset of

winter in November. Sledging on the snow-laden streets of Shimla was once their favourite pastime. It's now in the memory albums only MOHAN LAL SUD

SKATER AND SHIMLA NATIVE

Centre, Shimla saw 102.4 cm of snowfall in eight days in January 2022 while there was no snow in January 2021. This year Shimla saw just scanty snow of 6 cm January 13, while there was no snowfall in December 2022.

In January in the years 2009 to 2022, the highest spell of 14 days was recorded in 2012 in Shimla when a total 95 cm of snow was recorded. Some residents have been wondering if the rise in minimum temperatures in recent years in win-

ter is a result of global warming. though scientists have said the overall warming trend should not

have any effect on local weather on such short-time scales, as per current models.

Currently, most of the tourist destinations like Shimla, Kufri, Kasauli, Chail, Dharamsala, Palampur and Manali have been witnessing long sunny days.

Richa and Abhishek Pathak, a couple from Mumbai, said they have come to enjoy snowy landscapes. "Our travel agent is advising us to travel to Narkanda as it is still wrapped in snow. Now we don't want to travel further. So we are enjoying long sunny days in Shimla," Richa said.

The far-off mountain peaks viewed from Shimla's historic Ridge have been wrapped in a thick white blanket of snow, she added Experts blame deforestation for the change in Shimla's climatic conditions.

The shift in temperatures and weather patterns reminds of Vivek Mohan's 30-minute documentary For Whom the Jingle Bells Toll

Study confirms drastic effect of climate change

study by the local Met A Department has confirmed the experts' fears. The study examined the snowfall trend in Shimla in the past 20 years. It concluded that Shimla's harsh winter, which normally commenced in November and ended in March, has declined after the mid-1980s.

The snowfall pattern has undergone a drastic change after 1991 with the snowing days shrinking at a rate of 11 days per decade, said the study.

Published in the Journal of Agro-meteorology, the study said the decadal average overall precipitation from December to March has declined from 283.9 mm (1991 to 2001) to 235.1 mm (2002 to 2010-11). The quantum of snow has come down and most of the precipitation was in the form of rain.

Even the percentage of snowfall to the total precipitation during this period has declined to 30 from 39.

The snowfall trend has also changed. The snowfall is being recorded more in February in Shimla than in December and January, said the study.

Lucknow, Feb 5: Aspirations need wings but, unfortunately, alliances clip them - at least this is what is happening in Uttar Pradesh.

Opposition unity in Uttar Pradesh - despite repeated efforts - remains a distant dream and is likely to remain so in the next Lok Sabha elections.

Even as the Samajwadi Party and the Bahujan Samaj Party reiterate their commitment to defeating the BJP, they fight shy of forging an alliance with the Congress, the only national political player which could offer an alternative to the BJP. And the reasons are more than evident.

Interestingly, the Samajwadi Party has also started gnawing at the BSP's Dalit vote base and the recent controversy over the use of the word 'Shudra' in Ramcharitmanas is an example.

Both the Samajwadi Party (SP) and the Bahujan Samaj Party (BSP) were born from the vote base of the Congress -- the BSP with Dalits and the SP with Muslims. Muslims, Dalits, along with Brahmins, were once the mainstay of the Congress in Uttar Pradesh.

A veteran SP leader puts it rather clearly when he says, "Aligning with the Congress at this point when the party is looking towards a revival after the Bharat Jodo Yatra (BJY) would amount to harakiri. We cannot give our own vote bank (Muslim in this case) a political option. What is the guarantee that Muslims will not return to the Congress if we forge an al-

liance with them?" The SP leadership, after several brainstorming sessions in the party and the family, therefore decided that it would be a better idea to continue projecting themselves as the only alternative to the BJP and use the 2022 assembly results to push the point.

SP president Akhilesh Yadav has consciously avoided being seen in the frame with Rahul Gandhi. Even though several top Congress leaders visited his Saifai home to offer condolence when his father Mulayam Singh passed away in October last year, Akhilesh did not soften his stand and refused to join the BJY. Similarly, Mayawati, who suffered a major erosion of her vote bank in the last assembly elections -- with a large part of her Dalit vote bank shifting to the BJP -- is now wary of the Congress which is blatantly targeting the Dalits. The Congress leadership in Uttar Pradesh now comprises of lead ers culled from the BSP -- from Brijlal Khabri to Nakul Dubey to Naseemuddin Siddiqui -- all of whom are using their previous connect with the BSP to bring Dalits closer to the Congress. Mayawati now claims that the Congress is following the culture and ideology of the BJP and hence,

similar to the 'leech technique' The BJP allied for the first time with BSP in 1995, supporting the first Mayawati government. The party rapidly lost ground and remained out of power for 14 years till it made a comeback in 2017. Similarly, when the BSP allied with the Congress in 1996, it was the BSP which gained while the downfall of the Congress began. In 2019, the SP allied with the BSP and it was the BSP that gained while the SP lost ground, said a SP leader.

The Congress, for apparent reasons, is now considered 'small' in UP and parties are naturally wary of joining hands with it and losing their own ground.

Another factor that is obstructing alliances in UP is the aspiration of both, Akhilesh Yadav and Mavawati, to attain the status of a national leader.

Both the leaders have been unsuccessfully trying to find a toehold in other states but have not got much success so far.

As the countdown begins to the 2024 general elections, it is clear that the Samajwadi Party will contest the polls in alliance with Rashtriva Lok Dal (RLD) which is gaining strength in western UP. Another ad dition to the alliance may be the Azad Samaj Party, popularly known as the Bhim Army. Bhim Army chief Chandra Shekhar is known for his proximity to RLD chief Javant Chaudhary and the latter could help in cementing the alliance between the SP and the Bhim Army which is looking to make inroads in the BSP's Dalit votes.

During a discussion with IANS, the young entrepreneurs said they registered their startup in 2019 in Himachal, processing the stem and seeds of the hemp plants successfully for producing protective face masks during the Covid-19 pandemic. They said that though the pandemic hit their start-up just a few months after it was launched, they did not lost hope. They succeeded in netting a revenue of over Rs 20 lakh through the sales of perhaps the world's first N95 certified hemp face mask and the oil and related products generated through the seeds of hemp plants.

Startup turns hemp into prized ingredient

Katnawer, who is the CEO of 'Himalayan Hemp', said they will be launching the first of its kind hemp fibre sanitary pad in two months. He disclosed that the startup is working with 70 small hemp farmers in four districts of Uttarakhand, including Dehradun, Bageshwar, Pithoragarh and Nainital and 30 women artisans from the weaker sections in Kangra and Kullu districts of Himachal Pradesh.

"We get raw hemp fibre and seeds from the 70 farmers. The hemp stem fibre is subsequently processed into cloth in our mechanized systems (financed by government grants) and the resultant cloth is stitched into designer wear, masks and the soon to be launched first of its kind hemp fibre sanitary pad by 30 women artisans in Himachal," Katnawer told IANS. But it's not just apparel and hemp seed oil based products which are part of the start-up's product line, as the unique venture also claims to have built the first of its kind carbon negative and high thermal insulation clay hut in Kullu district, made out of bricks created from a mixture of hemp hurds (generated through hemp stem stalks), lime and clay.

"We are already selling the face masks and hemp seed oil based products, but the complete apparel line, including the first of its kind sanitary pads will be launched soon, after rigorous quality control and testing," added Sonam Sodha, who is the MD and COO of the start-up.

The duo's start-up, which showcased their hemp based products at the Start-Up Expo of the four-day India International Science Festival (IISF-2022) that concluded in Bhopal in January, has already won four national and three international awards, besides government grants.

New Delhi, Feb 5: Nearly one in four users are unaware of crypto cybercrime risks, while half of the users are hit by crypto cybercrime, a new report has shown.

According to the cybersecurity firm Kaspersky, just 25 per cent of those surveyed felt well-informed about potential cryptocurrency cyberthreats, while 23 per cent had no information at all. The report also discovered that

nearly half (49 per cent) of the respondents had been affected by cryptocurrency crime in some way,

New Delhi, Feb 5: About 48 crore individual Permanent Account Numbers (PANs), out of the total 61 crore issued till now, have been linked with Aadhaar till date and those who do not link it by the declared deadline of March 31 will not get benefits while undertaking various business and tax-related activities, CBDT Chairperson Nitin Gupta said.

The government has made the linkage of the two databases mandatory and declared that those individual PANs that are not attached to the Aadhaar by the end of this financial year (March 31, 2023) will be rendered inoperative.

A fee of ₹1,000 will be payable for those who want to link their PAN and Aadhaar between now and March 31.

'There are about 61 crore individual PANs issued till now and out of this, around 48 crore have been seeded with Aadhaar. The difference is around 13 crore now, including the exempt category, and we hope the rest will also be linked by the end date," Gupta told PTI in a post-Budget interview.

New Delhi, Feb 5: The Supreme Court is all set to get five new judges, taking its strength to 32 against the sanctioned strength of 34, Monday when three chief justices-- Justice Pankaj Mithal, Justice Sanjay Karol and P V Sanjay Kumar -- of high courts of Rajasthan, Patna and Manipur respectively will take oath alongside two other senior high court judges.

Justice Ahsanuddin Amanullah of the Patna High Court and Justice Manoj Misra of the Allahabad High Court will also be administered oath of office by the Chief Justice of India (CJI) as apex court judges in a ceremony to be held at the court's auditorium in its new building complex.

The senior most among the five judges, whose names were officially announced by the Centre Saturday, is Justice Mithal whose parent cadre is the Allahabad High Court.

Justice Mithal was elevated as additional judge of the Allahabad High Court July 7, 2006, and took oath as permanent Judge July 2, 2008. He took oath as the Chief Justice of the Common High Court for the Union Territory of Jammu and Kashmir and the Union Territory of Ladakh January 4, 2021.

The second senior-most judge who will take oath Monday, is Justice Karol, whose parent HC cadre is Himachal Pradesh. He was the chief justice of the Patna High Court at the time of elevation. Justice P V Sanjay Kumar, who originally belonged to the Telangana High Court, is third in the list of five judges and was heading the Manipur High Court at the time of recommendation by the Collegium December 13 last year and subsequent clearance by the Centre.

Justice Ahsanuddin Amanullah of the Patna High Court is the fourth judge who has been appointed to the SC.

Justice Manoj Misra, the fifth in the list, was born June 2, 1965. He enrolled as an advocate December 12. 1988, and was elevated as additional judge at the Allahabad High Court November 21, 2011. He took oath as a permanent judge August 6, 2013.

All the five names for the judgeship in the top court were recommended by the six-member Supreme Court Collegium December 13 last year.

7 lakh cos facing debt recovery proceedings

Nearly seven lakh companies have either been shut down or facing debt recovery proceedings under the stringent SARFAESI Act for their failure to repay debt taken from financial institutions and banks. As many as two lakh companies were taken to Debt Recovery Tribunals (DRTs) by banks and financial institutions in the first year itself after the SARFAESI Act was amended by the Modi government in 2016. The largest number of companies, 2.35 lakhs, were taken to the DRTs in the year 2018-19. In all, 6.88 lakh companies have been taken to the DRTs across the country during 2016-17 to 2020-21 period. Though there is no official data available with the Corporate Affairs ministry that how many of these 6.88 lakh companies shut shop due to their failure to repay debt. But official sources say that most of

these companies were either declared bankrupt or may vanish from the radar.

Confusion in Bihar

Three developments in Bihar are worth watching closely; one that the Union home ministry decided to give Z-category security cover to LJP (Ram Vilas Paswan) MP Chirag Paswan; 2) Banner of revolt by Janata Dal (U) Parliament Board chairman Upendra Kushwaha against Nitish Kumar and 3) Bihar BJP leaders suddenly declaring "no truck" with JD (U) after remaining silent against Nitish Kumar. The straw in the camel's back came when Janata Dal (U) decided not to go to Srinagar to participate in the Bharat Jodo Yatra led by Rahul Gandhi. The JD (U) leaders rather went a step further and declared that why should they go there as its Congress Party's internal program. Political pundits are baffled as to what Nitish Kumar is upto after dumping the BJP and joining hands with Congress and RJD to remain in power comfortably. The BJP, meanwhile, is cooking JD (U)'s goose and may engineer some defections when Lok Sabha polls draw near. With the 2024 elections in sight, the saffron party plans to use Paswan against Nitish and unite the two groups of LJP soon.



OPPN LEADER CALLS FOR REFERENDUM

appeared to be the lowest ever in the United States. The air temperature at the peak reached minus 47 degrees F (-44 C), with winds gusting near 100 miles per hour (160 kilometers per hour), according to the Mount Washington Observatory.

Musharraf: Kargil architect who brought Pak, India to the brink of war

Pak's ex-military dictator General Pervez Musharraf was the first leader who was sentenced to death for treason in a country with a history of military coup

Islamabad, Feb 5: Pakistan's former military dictator General Pervez Musharraf, the architect of the Kargil War, toppled the democratically-elected government in a bloodless military coup in 1999 and ruled the country for nine years during which he survived numerous assassination bids

Born in a middle-class family of Urdu-speaking Mohajir parents in Delhi in 1943, Musharraf migrated to Pakistan with his family after the Partition in 1947

Pakistan's last military dictator died Sunday as a forgotten man in politics after spending his final years in self-exile in the UAE to avoid criminal charges against him in his country. He died in the Gulf country after a prolonged illness.

During his stint as the head of the Pakistan government, Musharraf allied with America in the war against terror after the 9/11 attacks on the US and cracked down on Islamist groups and banned dozens of radical outfits, a move that angered radicals. He even escaped assassination attempts in later years.

Musharraf, who was appointed the chief of army staff by the then prime minister Nawaz Sharif in 1998, engineered the Kargil War that took place months after Sharif signed a historic peace accord with his Indian counterpart Atal Bihari Vajpayee in Lahore.

After his misadventure in Kargil, Musharraf deposed Sharif in a bloodless coup and ruled Pakistan from 1999 to 2008 in various positions – first as the chief executive of Pakistan and later as the President.

Musharraf, who announced elections in 2008 under domestic and international pressure, was forced to resign as president following the polls and went into self-imposed exile in Dubai

In 2010, he formed his own party, the All Pakistan Muslim League and declared himself the party president. He voiced his opinion of actively taking part in Pakistan's politics sometime in the future.

He returned to Pakistan in March 2013 to contest polls after living in selfexile for about five years but was hauled to court in different cases - including the 2007 assassination of former premier Benazir Bhutto, treason under article 6 of Pakistan Constitution and murder of Bugti tribe chief Nawab Akbar Khan Bugti.

In 2006, on the orders of Gen Musharraf, the Pakistan Army killed the former junior interior minister and Governor of Balochistan Bugti and over two dozen of his tribesmen, leading to widespread unrest in the area and a surge in the Baloch nationalist sentiment in the province.

In 2019, Musharraf was sentenced to death in absentia by a special court which found him guilty of high treason, for imposing a state of emergency November 3, 2007, by keeping the country's constitution in abeyance.

The judgement angered the country's powerful Army which has ruled over Pakistan for most of the period since its existence. It was the first time a former top military official had faced such a sentence for treason in Pakistan. The death sentence was later annulled by the Lahore High Court.

Musharraf, who was living in Dubai since March 2016, was also declared a fugitive in the Benazir Bhutto murder case and Red Mosque cleric killing case.

During his tenure, Pakistan saw some structural reforms - ranging from the economic and social sectors to administrative and political restructuring.

Musharraf visited India for the failed Agra summit in 2001 and made two more visits in 2005 as President to watch an India-Pakistan One-day Cricket match and in 2009 to attend a media event after shed-

ding power. Musharraf, the second of three brothers, spent his early years in Turkey, from 1949 to 1956,

as his father Syed Musharrafuud-din was posted in Ankara.

He fought in the Indo-Pakistan War of 1965 as a young officer, and also participated in the Indo-Pak War of 1971 as a Company Commander in the Commando Battalion.

Musharraf rose to the rank of General and was appointed as the Chief of Army Staff October 7, 1998, by then prime minister Sharif. He was given additional charge of the

Chairman Joint Chiefs Staff Committee April 9, 1999. Six months later, he toppled the Sharif government and became the head of the state designated as Chief Executive.

Frankfurt, Feb 5: Europe imposed a ban Sunday Russian diesel fuel and other refined oil products, slashing energy dependency on Moscow and seeking to further crimp the Kremlin's fossil fuel earnings as punishment for invading Ukraine.


The ban comes along with a price cap agreed by the Group of Seven allied democracies.

The goal is allowing Russian diesel to keep flowing to countries like China and India and avoiding a sudden price rise that would hurt consumers worldwide, while reducing the profits funding Moscow's budget and war.

Diesel is key for the economy because it is used to power cars, trucks carrying goods, farm equipment and factory machinery.

Diesel prices have been elevated due to recovering demand after the Covid-19 pandemic and limits on refining capacity, contributing to inflation for other goods worldwide. The new sanctions create uncertainty about prices as the 27nation European Union finds new supplies of diesel from the US, Middle East and India to replace those from Russia, which at one point delivered 10% of Europe's total diesel needs. Prices also could be driven up by

reviving demand from China as



the economy rebounds after the end of draconian Covid-19 restrictions. The price cap of \$100 per barrel for diesel, jet fuel and gasoline is to be enforced by barring insurance and shipping services from handling diesel priced over the limit. Most of those companies are located in Western countries. It follows a \$60-per-barrel cap

> on Russian crude that took effect in December and is supposed to work the same way. Both the diesel and oil caps could be tightened later. "Once we have these price caps set, we can squeeze the Russian price and deny them, deny (President Vladimir) Putin money for his war without a price spike that's going to hurt Western

economies and developing economies," said Thomas O'Donnell, a global fellow with the Washingtonbased Wilson Center.

The diesel price cap will not bite immediately because it was set at about what Russian diesel trades for: Russia's chief problem now will be finding new customers, not evading the price ceiling. However, the cap aims to prevent Russian gains from any sudden price spikes in refined oil products. Analysts say there might be a price bump initially as markets sort out the changes. But they say the embargo should not cause a price spike if the cap works as intended and Russian diesel keeps flowing to other countries.

The ban provides for a 55-day grace period for diesel loaded on tankers before Sunday, a step aimed at avoiding ruffling markets. European Union officials say importers have had time to adjust since the ban was announced in June



Nervous over the fate of their fortunes, some of the country's megarich have since booked tickets to Singapore, insiders told AFP.

Singapore has been ruled by one party for the past six decades, and labour strikes and street protests are banned. Taxes are comparatively low and the population is predominantly ethnic Chinese. The presence of recent Chinese

arrivals is keenly felt in Singapore, with some relocating to luxury homes with waterfront views on Sentosa Island, which also houses a theme park, a casino and a pres-

tigious golf club. 'You cannot imagine the way they spend money. It's crazy," said Pearce Cheng, CEO of AIMS, a firm providing immigration and relocation services. He recalled attending a client's

"Many of them are younger

Chinese, in fashionable designer clothes, and they usually keep to themselves and dine amongst themselves, which is not surprising," said Benny Teo, managing director of Blazon, a consultancy specialising in golf.

'MY MONEY IS MINE'

Relocating to Singapore puts the wealth of China's richest beyond the reach of Beijing, whose recent high-profile crackdowns have rattled billionaires.

Jack Ma, one of the most recognisable faces in Asian business, lost an estimated \$25 billion when Chinese regulators pulled the plug on a blockbuster IPO in 2020.

Other Chinese tycoons fear the Communist Party could apply similar pressure or even take over their businesses at low prices, an accountant familiar with the situation told AFP.

"Moving to Singapore is about making sure the family wealth is kept safe and can last for several generations," the accountant said.

Singapore is increasingly viewed as a home rather than just a backup plan, another source in the industry said, adding that clients had told him: "At least when I'm here, I know my money is mine." One of the founders of China's largest hotpot chain, Haidilao, re-

cently set up a so-called family of-

fice in Singapore. The Monetary Authority of Singapore estimates that the number of family offices, wealth management companies dedicated to individual and group assets, rose from 400 in 2020 to 700 in 2021.

'NEUTRAL ZONE

The outflow is expected to continue even though China's strict zero-Covid policy and curbs have now been lifted, analysts said.

Political tensions between Beijing and Washington are reinforcing the desire of some of China's richest to move abroad.

Singapore is a "very handy neutral zone" where the mega-rich can do business, said Song Seng Wun, a regional economist with CIMB Private Banking.

The city-state has deftly managed its relations with Washington and Beijing, maintaining close security ties with the United States while preserving robust trade links with China.

YOUNGSTER REMEMBERS JOYDEEP'S HEARTBREAK AT THE LONDON OLYMPICS

Bhopal, Feb 5: Joydeep Karmakar, who had missed out on an Olympics bronze in the 50 metres rifle prone event in London 2012, was following the rifle competitions at the Khelo India Youth Games 2022 with a lot of interest here Sunday. His interest was expected as Joydeep is currently the chief rifle coach of the Indian shooting team. But there was a personal reason too for his interest-his 17-year-old son Adriyan was competing at the MP Shooting Academy ranges here.

Adriyan, however, showed no signs of any pressure as he emerged victorious in the tough 50m Rifle 3 Positions (3P) boys competition. He got the better of Rajasthan's Manvendra Singh Shekhawat 16-12.

Looking ahead, Adriyan said his immediate goal is to earn a place in the national team for the Junior World Cup and strive for medals in the international arena. And if possible achieve what his father just missed out at the London



Olympics, a bronze medal. Yes, that (Olympic medal) is definitely on my mind," Adriyan stated. "I remember a bit about it but he did his best. I just want to go one step further," the youngster said.

Adriyan spoke about the pressures of being the son of such an

accomplished rifle shooter. "Yes pressure will be there but to be honest with you, I have grown used to it. I now know how to separate my game from what people say. When I focus on my shooting, I try to cut off myself from the real world," said the cherubic Adriyan. The 17-year-old, a Class-XI student, had been creating ripples in the national shooting circles in recent times. Last April, he finished with a gold in the national selection trials in the 50 m rifle prone event.
