Bhubaneswar, Feb 7: SAI International School's Amrutanshu Mohanty emerged topper from the state in the JEE (Main), the results of which were announced late evening Monday. In fact students of

SAI International performed excellently with 16 students getting more than 99 NTA score, 24

students finishing with NTA scores of above 95 and 31 students achieving scores between 90 and 95. Amrutanshu achieved a score of

99.9749727 percentile with 99.7604534, 99.9678221 and 99.9499455 percentiles in Physics, Chemistry and Maths respectively. Amrutanshu had previously aced the Class X CBSE examinations in 2021 by being the school topper with 99.8% marks.

There were 20 candidates who scored a perfect 100 in engineering entrance exam JEE-Main's January edition, the National Testing Agency (NTA) said Tuesday in a release. The 20 toppers include 14 from the general category, four from the OBC category and one each from gen-EWS and SC category. While Md Sahil Akhtar is the PwD topper with 99.9848042 NTA score, the SC topper is Deshank Pratap Singh with 100 NTA score and ST topper is Dheeravath Thanuj with 99.99041.

Virginity test on accused unconstitutional: Delhi HC

The court made the observations while hearing a plea by sister Sephy convicted for the murder of sister Abhaya in 1992

New Delhi, Feb 7: The Delhi High Court said Tuesday that 'virginity test' conducted on a female detainee or accused is unconstitutional and in violation of Article 21 of the Constitution. The high court said that if such a test is conducted it interferes with the bodily integrity of the woman and also affects her mental health.

Justice Swarana Kanta Sharma said that virginity test brings forth the 'undesirable and abhorrent notion of differentiation on the basis of gender and stereotypes' and amounts not only to interference with bodily integrity of a woman but also her psychological well-being.

"Virginity testing is a form of inhuman treatment and the same violates the principle of human dignity. The test, being violative of right to dignity of an individual, cannot be resorted to by the State and the same shall be in teeth of the scheme of Indian Constitution and the right to life enshrined under Article 21," Justice Sharma said.

'Some fundamental rights cannot be suspended or infringed or abridged even when a person is in custody and right to dignity is one such fundamental right which falls within the ambit of Article 21," the judge observed.

Justice Sharma made the observations while passing the order in a case concerning the virginity test

conducted by the CBI on sister Sephy. a nun who was convicted in the sister Abhaya murder case.

Sister Sephy was among those convicted by a special CBI Court in Kerala in 2020, for the murder of sis-

ter Abhaya in 1992. In the trial court verdict. the judge had concluded that sister Abhaya was killed after she witnessed a priest (also convicted in the case), Father Thomas Kottoor and sister Sephy in a compromising position.

The trial court was

told sister Sephy had and psychologically undergone a gynecol-**DELHI HC** ogical procedure to cover up the fact that she had engaged in

sexual intercourse. The court noted that the procedure was done 'on the eve' of her arrest by the CBI.

In 2008, after her arrest in the case, sister Sephy accused the CBI of having conducted a virginity test on her without her consent.

The Delhi High Court, while stating that the virginity test conducted was unconstitutional, added that sister Sephy may avail legal remedies against the CBI for her alleged defamation. Justice Sharma also ordered that the

> information about the test being declared unconstitutional should be circulated to all investigating agencies through Ministry of Home Affairs (MHA) and Ministry of Health and Family

> Welfare (MoHFW). The bench directed the Delhi Judicial Academy to include this information in its curriculum and in the workshops for investigating officers, prosecu-

tors and other stakeholders. "The Delhi Police Academy for Training shall also include the necessary information regarding this issue in its training curriculum. The Commissioner of Police, Delhi is also directed to ensure that the investigating officers are informed," the HC said.

Forest fire threat grows

Bhubaneswar, Feb 7: Over 500 incidents of forest fires, 533 to be precise, have been reported from different parts of Odisha, a report released Tuesday by the Forest Survey of India (FSI), said. Among the total cases of forest fires reported, 23 are said to be major ones, officials informed here.

There could be a spurt in forest fire incidents in the state this summer following the prolonged dry spell across Odisha for over three months, an official stated.

The long dry spell following last year's monsoon could lead to more number of forest fires this season," informed Principal Chief Conservator of Forests (PCCF) and Head of Forest Force (HoFF) Debidutta Biswal, Around 643 forest fire points have been reported between January 30 and February

6 in Odisha, the highest in the countrv. the PCCF said. Around 161 fire incidents were

reported February 2 and 106 the next day. Similarly, 113 forest fires, including five large active ones, were reported February 4. Usually forest fires occur February 15 onwards. This time, however, a large number of forest fires were reported from Malkangiri and Nabarangpur in the first week of January. Most of those fire points appear to be deliberate fires lit by people that need to be brought under control, the senior official informed.

Fire management squads have been kept ready to tackle the situation with equipment including blowers and safety gears Besides. the PCCF said awareness drives are continuing in villages for community involvement in

TURKEY, SYRIA **QUAKE TOLL RISES TO 6,200**

Adana (Turkey), Feb 7: Rescuers raced Tuesday to find survivors in the rubble of thousands of buildings brought down by a 7.8 magnitude earthquake Monday and multiple aftershocks that struck eastern Turkey and neighbouring Syria, with the discovery of more bodies raising the death toll to 6,200. Turkey's vice-president Fuat Oktay said the total number injured people in the country stood at 20,534 and the condition of some of them were quite critical.



Countries around the world dispatched teams to assist in the rescue efforts, and Turkey's disaster management agency said more than 24,400 emergency personnel were now on the ground.

But with such a wide swath of territory hit by Monday's earthquake and nearly 6,000 buildings confirmed to have collapsed in Turkey alone, their efforts were spread thin. Attempts to reach survivors were also impeded by temperatures below freezing and close to 200 aftershocks, which made the search through unstable structures perilous.

Nurgul Atay told this agency that she could hear her mother's voice beneath the rubble of a collapsed building in the city of Antakya, the capital of Hatay province, but that her and others efforts to get into the ruins had been futile without any rescue_ crews and heavy equipment to help. "If only we could lift the con-

crete slab we'd be able to reach her," she said. "My mother is 70years-old, she won't be able to withstand this for long, added Atay

In areas where teams worked, occasional cheers broke out through the night as survivors were brought out of the rubble.

The NHRC has also directed the DGP and the secretary, Ministry of Home Affairs, government of India to act on the issue immediately and ensure exemplary compensation to the family members of the deceased and a minimum of Rs 10 lakh rupees to the injured person and recommend steps to be taken in the interest of justice and protection of human rights. Meanwhile in a separate devel-

opment, Crime Branch sleuths recreated Tuesday the murder scene at Gandhi Chowk in Brajarajnagar of Jharsuguda district. Amid tight security, accused Gopal was brought to the crime spot where he showed how he gunned down the minister while the latter was stepping out his vehicle for a public meeting January 29.

Gopal showed how he held his service revolver with both hands when he shot the minister. He also demonstrated how he was overpowered by two policemen when he tried to flee the crime spot.

Oil exploration near Konark to start soon

Puri: Oil India Limited has set up a rig at Kusupur in Gop block of this district to explore the possibilities of the presence of crude and natural gas. Officials of the company said Tuesday that the machinery and equipment required for operating the rig has reached the spot and the exploration process will start shortly. After Oil India found proof of crude oil in the Mahanadi Basin near Konark last year, the Centre-run PSU acquired eight acres of land from 37 owners in Kusupur on lease for three years to explore the quantity and quality of underground oil. An Oil India official said that drilling initially will be done till 22,000m and the process will take approximately 1-2 years before oil can be found.

60 prisoners to appear for Matric

Bhubaneswar: A total of 60 prisoners, lodged at various jails across the state will appear in the annual Matric examinations, conducted by Board of Secondary Education (BSE), this year. The prisoners are being allowed to appear for the exams under the prison reform programme in Odisha. They will appear in the exams at the Jharpada prison here. This year, the convicts and undertrial prisoners lodged at jails in Khurda, Bolangir, Angul, Nayagarh, Kujang, Jagatsinghpur, Jajpur and Puri in various criminal cases will appear in the examination, said Jharpada prison's jailor Santoshini. The examinees will be brought to the Odisha capital amid tight security,

Washington, Feb 7: Indian-American schoolgirl Natasha Perianayagam has topped the 'world's brightest' students list in a survey conducted by the USbased 'Johns Hopkins Centre for Talented Youth', Over 15,000 students from 76 countries were featured in the survey and the tests

conducted by the John Hopkins Centre. This is the second time she has topped the list, her other success coming in 2021.

Perianayagam, 13, is a student at Florence M Gaudineer Middle School, in New Jersey. She also took the Johns Hopkins Centre for Talented Youth (CTY) test in the spring of 2021, when she was a Grade 5 student. Her results in the verbal and quantitative sections levelled with the 90th percentile of advanced Grade 8 performance, which catapulted her into the honours list that year. This year, she was honoured for her exceptional performance on the SAT, ACT, School and College Ability Tests, the university said

in a press release Monday. Perianayagam, whose parents



hail from Chennai, said she loves doodling and reading JRR Tolkien's novels in her spare time. Talking about her achievement

Perianayagam said, "This motivates me to do more. I am certainly going to try new things and improve on my performances.'

Perianayagam also stated that she reads vociferously. "It helps in accumulating knowledge and there are so many things to learn. If I don't learn something new every day, I somehow feel that the day has gone to waste,'

CTY used above grade-level testing to identify advanced students from around the world and provide a clear picture of their academic abilities

According to the university release, Perianayagam was among the 15,300 students who joined CTY in the '2022-23 Talent Search Year'. Less than 27 per cent of those participants qualified for the CTY ceremony, receiving either high or grand honours based on their test scores.

In her latest attempt, Perianayagam scored the highest grades among all candidates. "This is not just recognition of our students' success in one test, but a salute to their love of discovery and learning, and all the knowledge they have accumulated in their young lives so far," said CTY's executive director Dr Amy Shelton.

"It is exciting to think about all the ways in which they will use that potential to discover their passions, engage in rewarding and enriching experiences, and achieve remarkable things - intheir communities and in the world," Shelton added.





Ensure early release of ₹14,249cr food subsidy, state urges Centre

Bhubaneswar, Feb 7: Food Supplies and Consumer Welfare Minister Atanu Sabyasachi Nayak has urged Union Consumer Affairs, Food and Public Distribution Minister Piyush Goyal to ensure expeditious release of Rs 14,249 crore food subsidy pending with the

According to sources, the Odisha State Civil Supplies Corporation (OSCSC) Limited, the nodal agency of the state, procures paddy at Minimum Support Price (MSP) from the farmers and undertakes distribution of food grains under the NFSA and other welfare

As per pact between the state government and Centre, there has to be zero financial liability on the procuring agencies as the cost would be borne by the Centre, Nayak said in his letter to the Union

The anticipated cost is required to be released in the form of advance subsidy at the rate of 90 per cent of admissible claim on quantity basis in the first month of every quarter, he said, adding that the Centre should also release a quarterly provisional subsidy to the state government (OSCSC) after deduction of advance amount. "However, the release of advance



and provisional subsidy to Odisha is highly irregular," said Nayak.

The Centre is vet to release food subsidy of Rs 14,249.07 crore, which includes Rs 5,027.36 crore of provisional subsidy claim upto third quarter and Rs 1,469.78 crore of unpaid advance subsidy claim for the fourth quarter of the financial year 2022-23.

Similarly, he said, as per the standard operating procedure (SOP) issued by Food and Public Distribution department, there are provisions for replacement of stock by rice miller followed by certification by the joint team which is to be completed within

"The certificate of replacement

is a mandatory document for release of subsidy to the state. However, the abnormal delay is being done for inspection by the Central officials. It subsequently causes hindrance for receipt of subsidy in respect of BRL rice stock," he added.

Nayak said the delay and short release of subsidy has put OSCSC in tremendous financial hardship.

Nayak sought intervention of the Union Minister for release of the subsidy at the earliest.

Since all the resources, including the sanctioned limit of bank finance, have already been exhausted, further paddy procurement may be severely affected if the subsidy from the Centre is not received at

'NO COMPLETE **PROPOSAL YET** FOR HC BENCH'

New Delhi, Feb 7: The Centre is vet to receive a complete proposal from Odisha for setting up of additional Benches of Orissa High Court, Union Law and Justice Minister Kiren Rijiju said.

He said the Union government has requested the Odisha government, time and again, to work out details of proposed Benches including its location in consultation with Orissa High Court, the recent one being vide letter dated April 7, 2022. However, no response has been received yet, the Union Law Minister said.

BJD miffed as Women's Reservation Bill finds no mention in Prez address

New Delhi, Feb 7: The Biju Janata Dal (BJD) Tuesday expressed displeasure over the Women Reservation Bill finding no mention in President Droupadi Murmu's address to the joint session of the Parliament January 31 this year.

Participating in the debate on the Motion of Thanks on the President's address, BJD MP Pinaki Misra said it was somewhat an untrustworthy document, and it suppressed several truths.

The address talked about women empowerment, but it did not mention the Women's Reservation Bill, which is pending for long, he said, adding, "We are deeply unhappy that Women Reservation Bill did not find mention in the address."

Sources said the Women's Reservation Bill was passed by the Rajya Sabha in 2010. However, it could not be passed by the 15th Lok Sabha. The Constitution amendment bill lapsed as the term of the 15th Lok Sabha ended.

He also said the address talked about the poor, but in the Budget,

the government slashed allocation to the Mahatma Gandhi National Rural Employment Guarantee Act 2005 (MGNREGA). The Finance minister needs to reconsider this, he added.

The BJD member also said that some half-truths crept into the statement on medical colleges as well. Most colleges lack good infrastructure and equipment, he said. Misra, however, said that government policies on mines, minerals and


NASA's Webb detects smallest main belt asteroid by chance n asteroid roughly the size of Rome's Colosseum, between 300 and 650 feet, or 100 and 200 metres, in length, has been detected by scientists using NASA's James Webb Space Telescope, according to a new research.

The object, detected by the international team of European astronomers, is likely the smallest observed to date by Webb, the research

It may also be an example of an object measuring under 0.6 miles, or 1 kilometre, one of the smallest in length within the main asteroid belt located between Mars and Jupiter, the research said.

The team's project used data from the calibration of the Mid-InfraRed Instrument (MIRI), in which the team serendipitously detected an interloping asteroid, the research published in the journal

Astronomy and Astrophysics said. Calibration is the act of checking or adjusting the accuracy of a measuring instrument by com-



"We - completely unexpectedly detected a small asteroid in publicly available MIRI calibration observations," explained Thomas Mueller, an astronomer at the Max Planck Institute for Extraterrestrial Physics in Germany.

The measurements are some of the first MIRI measurements targeting the ecliptic plane and our work suggests that many new objects will be detected with this instrument," said Mueller.

According to the research, these Webb observations, were not designed to hunt for new asteroids in fact, they were calibration images of the main belt asteroid (10920) 1998 BC1, which astronomers discovered in 1998.

The Webb observations were conducted to test the performance of some of MIRI's filters, but the calibration team considered them

to have failed for technical reasons due to the brightness of the target and an offset telescope pointing. Despite this, the data on asteroid 10920 were used by the team to establish and test a new technique to constrain an object's orbit and to estimate its size, the research said.

The validity of the method was

demonstrated for asteroid 10920

using the MIRI observations com-

bined with data from ground-based telescopes and ESA's Gaia mission. In the course of the analysis of the MIRI data, the team found the smaller interloper in the same field of view, the research said.

The team's results suggested that the object measured 100-200 metres, occupied a very low-inclination orbit, and was located in the inner main-belt region at the

time of the Webb observations. 'Our results show that even 'failed' Webb observations can be

scientifically useful, if you have the right mindset and a little bit of luck," elaborated Mueller. 'Our detection lies in the main asteroid belt, but Webb's incredible sensitivity made it possible to see this roughly 100-metre object at a

distance of more than 100 million kilometres," said Mueller. If confirmed as a new asteroid discovery, the detection of this asteroid would have important implications for our understanding of the formation and evolution of the

solar system, the research said. According to the research, current models predict the occurrence of asteroids down to very small sizes, but small asteroids have been studied in less detail than their larger counterparts owing to the difficulty of observing these objects. Future dedicated Webb observations will allow astronomers to study asteroids smaller than 1 kilo-

metre in size, it said.

This result also suggested that Webb will also be able to serendipitously contribute to the detection of new asteroids. The team suspects that even short MIRI observations close to the plane of the solar system will always include a few asteroids, most of which will be unknown objects, the research said.

In order to confirm that the object detected is a newly discovered asteroid, more position data relative to background stars is required from follow-up studies to constrain the object's orbit, the research said.

'This is a fantastic result which highlights the capabilities of MIRI to serendipitously detect a previously undetectable size of asteroid in the main belt," concluded Bryan Holler, Webb support scientist at the Space Telescope Science Institute in Baltimore,

Maryland. Repeats of these observations are in the process of being scheduled, and we are fully expecting new asteroid interlopers in those images," said Holler.

Sebastien Gay, the head of mission in Syria for 'Doctors Without Borders', said health facilities in northern Syria were overwhelmed with medical personnel working around 'around the clock to respond to the huge numbers of wounded'.

Turkey has large numbers of troops in the border region with Syria and has tasked the military to aid in the rescue efforts, including setting up tents for the homeless and a field hospital in Hatay province. More than 7,800 people have so far been rescued across 10 provinces. according to Orhan Tatar, an official with Turkey's disaster management authority. The region sits on top of major fault lines and is frequently shaken by earthquakes. Some 18,000 were killed in similarly powerful earthquakes that hit northwest Turkey in 1999. According to the study titled 'Embracing All Abilities', 67 per cent of the business leaders from Indian public sector companies and 55 per cent from private sector companies said inclusion is present, but not mandated in their goals.

"While many companies in India are still working towards creating inclusive workplaces, we believe that by fostering positive role models, investing in necessary infrastructure & accommodation facilities, and implementing effective



policies and legal frameworks, we could fast-track significant progress in this area," Viswanath added.

The study further noted that only a very small percentage (17 per cent) of the business leaders from the public sector companies mentioned that their goals are aligned with inclusion. On the other hand, 53 per cent of MNC leaders have

The alleged callous attitude of NHAI authorities, its non-cooperation with the district administration and substandard construction work are stated to be the main reasons behind the rising road mishaps and subsequent deaths. Various stakeholders attending the meetings on road safety have expressed their concern over the issues.

Reports said NHAI divisions in Balasore and Dhenkanal look after the issues pertaining to NHs-16, 20 and 53 passing through Jajpur district. Although the highway authority claims that the work on NH-16 has been completed, the reality is different as some works are still in progress.

The condition of NH-53 and 20 is worse than that of a village road. The road space is getting shrunk and large potholes have come up on the highway making it difficult for the commuters to travel on the highways

The district administration is empowered to file case in the court of the sub-collector under Section-133 of IPC against the consultancy agency and the contractor for causing harm to the commuters but the former is not taking any action against them. This is only emboldening the NHAI authorities and the consultancy agency to remain recalcitrant, the report added.

3 critical in Badamba custodial torture

Badamba, Feb 7: The death of a villager in the custody of forest officials over alleged poaching of a tusker in Hinpinda jungle has opened up a can of worms with three other villagers were also found to have been brutally assaulted by the forest officials during their detention here in Cuttack district.

The injured villagers were identified as Raj Kishore Pradhan, 58, of Shyamsundarpur village, Biranchi Jani, 60, of Soruan vil-

lage and Rajiv Swain, 36, of Gopapur village under Badamba police limits in Cuttack district. The three injured villagers after being brutally assaulted were released from detention by the forest officials, Athagarh SDPO Bijay Kumar Bisi

Rajkishore and Biranchi sustained critical injuries and have been admitted to Badamba community health centre for treatment. Both the critically injured require advanced treatment but shifting them to any other hospitals is becoming difficult due to lack of money, family members said.

Sources said forest officials recovered the carcass of a tusker with its tusks trimmed from Hipinda jungle bordering Badamba in Cuttack district and Hindol in Dhenkanal district.

They conducted a post-mortem of the carcass but failed to ascertain as to when the tusker was killed and who might be responsible behind the death of the animal.

They picked up four persons on suspicion of their involvement in the killing of the tusker four days back. They detained them in their custody and brutally assaulted them to elicit the truth about the animal death, A villager Dhaneswar Behera of Satagochhia village under the Badamba police limits succumbed to the brutality and a complaint

was lodged at the local police station. Senior police officials and Athagarh Sub-Collector conducted a probe into the incident.

Food Supplies and Consumer Welfare Minister Atanu Sabyasachi Nayak has written a letter to Union Minister for Consumer Affairs, Food and Public Distribution, Piyush Goyal in this regard, Odisha State Civil Supplies Corporation (OSCSC), the nodal agency of the state procures paddy at minimum support price (MSP) from the farmers and undertakes distribution of food grains under NFSA and other welfare schemes. Further, the Centre should release a quarterly provisional subsidy to the state government (OSCSC) after deduction of advance amount, But, the release advance and provisional subsidy to Odisha is highly irregular, Nayak pointed out in the letter.

Where will the farmers of the other 29 districts sell their paddy," Acharya asked and added that the Centre is completely silent about it.

"We demand that every single surplus foodgrain must be lifted from Odisha through paddy procurement by the Centre in the interests of farmers of mainly Western Odisha and the farmers of Odisha must not be deprived of their MSP at any cost by the Centre," Acharya said.

Democratic Dictator

here is no halfway, either in democracy or in dictatorship. In other words, a hybrid democracy is a dangerous commodity and a recipe for disaster for both the country where it is practised and the person or persons who implement it. One has to go the whole hog, no matter whether one wants to be a dictator or a democrat. This is the lesson offered by the life and legacy of Pakistan's General Pervez Musharraf who died February 5 at the age of 79 at a hospital in Dubai.

Musharraf was the last military leader to have ruled Pakistan from 1999 to 2008, following a bloodless coup. That coup that had brought him to power was unique in some ways. As the Chief of the Army, Musharraf was away on a visit to Beijing when junior field commanders revolted and carried out the change of power. Then they called the General and asked him to cut short his China visit and return home immediately. At that time, Pakistani planes were barred from over flying India. That forced Musharraf to fly from China through Sri Lanka back to Islamabad. When he landed, he was welcomed as the Chief of the country, not just the army.

His story is a reflection of Pakistan itself, a country tormented since its creation in 1947 by unrest, assassinations, leaders going into exile to save their lives, fratricidal battles between rival dynasties, economic crises, natural disasters of massive proportions and games played by Western powers. Perhaps, the most remarkable feature of the country's tryst with democracy and dictatorship is that no Prime Minister could ever complete a term.

Musharraf was the most charismatic leader of Pakistan who was credited with attracting foreign investment to the country that saw the strongest economic growth in nearly 30 years during his rule. It was he who gave a new lease of life to an independent media and sought to free the country from the shackles of bigoted, religious fanatics and extremists.

However, the irony of history is that his decade-long rule was also marred by a heavy-handed approach to dissent, arrest of rivals who included top political leaders of the country. What is even worse is he imposed a nearly sixweek-long state of emergency in which he suspended the constitution and censored the media. In fact, he failed to build on his early popularity to carry out sustainable economic and political reforms. On the contrary, he turned into a military dictator and pursued vested interests after his short flirtation with democracy.

It could be his background of being a graduate from a Christian high school that shaped his liberal outlook and he was keen on Pakistan embracing liberal Islam. This very approach endeared him to the West. Subsequently, he joined what Washington called its "war on terror" and gave ground and air access to US armed forces launching attacks on al-Qaeda militants operating in Afghanistan.

However, this decision reversed Pakistan's long-standing policy of supporting the Taliban, which at that point controlled Afghanistan. As a result, domestic militant groups bayed for his blood and he survived at least four assassination attempts. No wonder the Tehreek-e-Taliban Pakistan, an umbrella group of Pakistani militant organisations formed after Musharraf's crackdown on extremists, celebrated his death. In a statement it said, "This was the infamous army chief who sold off the country's honour and respect.' Pakistan's lawmakers and lawyers are also divided on the question of whether respect should be paid to the departed leader since he had targeted both the judiciary and politicians. He was accused of aiding and abetting the assassination of former Prime Minister Benazir Bhutto, killed while on campaign for national elections.

The assessment by Fawad Chaudhury, a former aide of Musharraf and currently a senior leader of former Prime Minister Imran Khan's party, best describes the former ruler of Pakistan: "He is called a military dictator, but there has never been a stronger democratic system than that under him.'

In the ultimate analysis, Musharraf could be said to be a bundle of contradictions that ultimately sealed his fate. He tried to be a democrat, but ended up becoming a dictator. He sought to stamp out religious extremists, as was evident in his operation at the Lal Masjid in Islamabad, but gave shelter to Osama bin Laden when the US, his ally, was frantically trying to hound him out. The policy of running with the hare and hunting with the hounds does not pay in the long run. Musharraf's life best demonstrates this truth while also showing that dual policy did a lot of good for him. He survived long enough and died a normal death as opposed to the tortuous end he had put some others to.

he idea behind freeganism is that you get as much of your food as you can from stuff that has been thrown out by supermarkets, restaurants and street markets. Though the practice is also known as voluntary simplicity and monetary minimalism it's only partly about living cheaply. It's more a political philosophy, a statement of defiance against what freegans regard as the wasteful consumerist culture of the developed world, which is why it has also been called ethical eating and the ultimate boycott. The name is usually said to be a blend of free and yegan, since early practitioners were either vegetarian or vegan (not least because it is much more dangerous to eat discarded meat or fish than vegetables and grains). But it has also been argued from a political perspective that it's short for free gain. The evidence is that some normally vegan freegans will take animal products, since there's another term, meagan, for vegans who will eat meat if they can get it for nothing. The culture lives on the edge of illegality, since many firms regard taking food from skips or dumpsters as theft. Some extreme freegan practices would be considered unacceptable by most people, such as table diving, in which freegans hover in a restaurant and grab discarded food from diners' plates after they leave.

■ Frick and Frack

Frick and Frack remains a fairly common one in North America for any two people who are closely linked in some way, especially through a work partnership. The Random House Historical Dictionary of American Slang cites it as being Black English, but it certainly has a much wider circulation than that. For example, this appeared in The Atlanta Journal and Constitution in April 2005: "And where had all his old friends gone? You know, he and Woods used to be as close as Frick and Frack." Or this from the Palm Beach Post in August the previous year: "Goss called himself and Graham the 'Frick and Frack' of congressional intelligence and won high marks for helping shepherd the contentious inquiry in the face of White House resistance." So it's reasonable enough that Brian and Nick of the Back Street Boys should use the nicknames Frick and Frack for each other. The origin is ultimately and undoubtedly in a famous partnership of Swiss comedy ice skaters, Werner Groebli and Hans Mauch, whose stage names these were. They came to public fame in the later years of a series of skating spectaculars called Ice Follies, promoted by Eddie Shipstad and his brother Roy, which began in 1936 and ran for almost 50 years.

WHAT'S WRONG WITH CHATGPT?

icrosoft is reportedly delighted OpenAI's ChatGPT, a natural-language artificial-intelligence programme capable of generating text that reads as if a human wrote it. Taking advantage of easy access to finance over the past decade, companies and venture-capital funds invested billions in an AI arms race, resulting in a technology that can now be used to replace humans across a wider range of tasks. This could be a disaster not only for workers, but also for consumers and even investors.

The problem for workers is obvious: there will be fewer jobs requiring strong communication skills, and thus fewer positions that pay well. Cleaners, drivers, and some other manual workers will keep their jobs, but everyone else should be afraid. Consider customer service. Instead of hiring people to interact with customers, companies will increasingly rely on generative AIs like ChatGPT to placate angry callers with clever and soothing words. Fewer entrylevel jobs will mean fewer opportunities to start a career - continuing a trend established by earlier digital technologies.

Consumers, too, will suffer. Chatbots may be fine for handling entirely routine questions, but it is not routine questions that generally lead people to call customer service. When there is a real issue -like an airline grinding to a halt or a pipe bursting in your basement - you want to talk to a wellqualified, empathetic professional with the ability to marshal resources and organise timely solutions. You do not want to be put on hold for eight hours, but nor do you want to speak immediately to an eloquent but ultimately useless chatbot

Of course, in an ideal world, new companies offering better customer service would emerge and seize market share. But in the real world, many barriers to entry make it difficult for new firms to expand quickly. You may love your local bakery or a friendly airline representative or a particular doctor, but think of what it takes to create a new grocery store chain, a new airline, or a new hospital. Existing firms have big advantages, including important forms of market power that allow them

to choose which available technologies to adopt and to use them however they want.

More fundamentally, new companies offering better products and services generally require new technologies, such as digital tools that can make workers more effective and help create better customised services for the company's clientele. But, since AI investments are putting automation first, these kinds of tools are not even being created.

Investors in publicly traded companies will also lose out in the age of ChatGPT. These companies could be improving the services they offer to consumers by investing in new technologies to make their workforces more productive and capable of performing new tasks, and by providing plenty of training for upgrading employees' skills. But they are not doing so. Many executives remain obsessed with a strategy that ultimately will come to be remembered as self-defeating: paring back employment and keeping wages as low as possible. Executives pursue these cuts because it is what the smart kids (analysts, consultants, finance professors, other executives) say they should do, and because Wall

Street judges their performance relative to other companies that are also squeezing workers as hard as they can.

AI is also poised to amplify the deleterious social effects of private equity. Already, vast fortunes can be made by buying up companies, loading them with debt while going private, and then hollowing out their workforces – all while paying high dividends to the new owners. Now, ChatGPT and other AI technologies will make it even easier to squeeze workers as much as possible through workplace surveillance, tougher working conditions, zero-hours contracts, and so forth.

These trends all have dire implications for Americans' spending power – the engine of the US economy. But as we explain in our forthcoming book, Power in Progress: Our Thousand-Year Struggle Over Technology and *Prosperity*, a sputtering economic engine need not lie in our future. After all, the introduction of new machinery and technological breakthroughs has had very different consequences in the past.

Over a century ago, Henry Ford revolutionised car production by investing heavily in new electrical machinery and developing a more

efficient assembly line. Yes, these new technologies brought some amount of automation, as centralised electricity sources enabled machines to perform more tasks more efficiently. But the reorganisation of the factory that accompanied electrification also created new tasks for workers and thousands of new jobs with higher wages, bolstering shared prosperity. Ford led the way in demonstrating that creating human-complementary technology is good

Today, AI offers an opportunity to do likewise. AI-powered digital tools can be used to help nurses. teachers, and customer-service representatives understand what they are dealing with and what would help improve outcomes for patients, students, and consumers. The predictive power of algorithms could be harnessed to help people, rather than to replace them. If AIs are used to offer recommendations for human consideration, the ability to use such recommendations wisely will be recognised as a valuable human skill. Other AI applications can facilitate better allocation of workers to tasks, or even create completely new markets (think of Airbnb or rideshare apps).

Unfortunately, these opportunities are being neglected, because most US tech leaders continue to spend heavily to develop software that can do what humans already do just fine. They know that they can cash out easily by selling their products to corporations that have developed tunnel vision. Everyone is focused on leveraging AI to cut labour costs, with little concern not only for the immediate customer experience but also for the future of American spending power.

Ford understood that it made no sense to mass-produce cars if the masses couldn't afford to buy them. Today's corporate titans, by contrast, are using the new technologies in ways that will ruin our collective future.

New Delhi, Feb 7: Aaftab Amin Poonawala was dating several women through an app and even brought one to his residence while the body parts of his live-in partner Shraddha Walkar were still lying there and used to remove them from the fridge during her visits, the Delhi police have claimed in its chargesheet.

and brutal manner

Giving a chilling account of the gory crime, the police alleged that Walkar was "already living in constant fear of getting killed" even before the accused decided to get rid of her in a barbaric and brutal manner.

Poonawala had earlier tried to mislead police by giving a false statement that after murdering Walkar, he had burnt her body pieces and after grinding the bones with a stone grinder, blown or thrown away the powder, the charge sheet said.

According to excerpts from the 6,629-page-long chargesheet, accessed by PTI, soon after the murder of Walkar, the accused again came in contact with several girls through 'Bumble', a dating app through which he came to know Walkar.

"He came in contact with one such girl... who is a psychologist and called (her)... To his flat. However, when she used to visit his flat, Aaftab used to clean the fridge and used to put the body parts of Shraddha on the upper shelf and at times on the lower shelf of the kitchen," the chargesheet said.

Poonawala, 28, allegedly strangled his live-in partner Walkar on May 18 last year and sawed her body into several pieces which he kept in a fridge for almost three weeks at his residence in South Delhi's Chattarpur locality. He later disposed of the body parts across the city over several days.

The accused claimed that he became friends with Walkar in 2018-19 through the 'Bumble' app itself and later the couple "fell in love", it said. According to Poonawala's disclosure statement, he made physical relations with Walkar for the first time on May 17, 2019. Walkar's family, however, found a pregnancy test kit and raised obiections to their relationship, following which Ponnawala took Walkar to a rented accommodation in Mumbai in October 2019, the

chargesheet said. The couple's relationship soured when Walkar found out that Poonawala was talking to other women on the App, the chargesheet said.

Poonawala's motive was to get rid of Walkar as she fought with him and abused him, the chargesheet said.

A Delhi court on Tuesday took cognisance of the chargesheet

filed by Delhi police.

The sources said that the petitioners are not activists and taking up the matter to SC to oppose Gowri's appointment was an act of duty to safeguard, preserve and protect the independence of judiciary and the values of the Constitution.

The petitioner-lawyers are Anna

She thanked the Supreme Court judges including the Chief Justice DY Chandrachud. Gowri said she hailed from a very remote village (West Neiyur) in Kanyakumari district of Tamil Nadu and is a first generation lawyer from a 'very ordinary fam-

She thanked all her senior advocates, including Maniraj and Jacob Fletcher. She is an alumnus of Madurai Law College. "I bow to the noble feet of all the elder brother and sister judges who are on the dais and who are watching from my beloved Madurai Bench.," she said.

She also thanked members of the Bar and sought their blessings.

Fresh row over Mhadei diversion Kerala mulls Singapore-model

Panaji, Feb 7: Union Finance Minister Nirmala Sitharaman's announcement to a grant of Rs 5,300 crore for the Upper Bhadra in rigation project in Karnataka has stirred up a fresh controversy over Mhadei diversion issue in Goa.

Opposition in the coastal state has alleged that the particular announcement furthers the cause of (Karnataka) stealing water from neighbouring states and also BJP eveing to win maximum seats in Karnataka during the Lok Sabha

Thiruvananthapuram, Feb 7: The Kerala government is planning to develop a major business hub based on the model of those in Singapore or Shanghai, in the areas around Vizhiniam International Port, one of the largest transhipment container ports in the world, being constructed by Adani group.

Noting that Vizhinjam port is the most important gateway for the transhipment of cargo for our country and neighbouring countries, state Finance Minister KN Balagopal said here Tuesday the most important cities and industrial centres in the world have been developed adjacent to such ports. Highlighting the Pinarayi Vijayanled government's plan, Balagopal told PTI, "examples of port-cities including Dubai, Singapore and Shanghai are before us" and the areas around Vizhinjam port could also be developed like that.

He said in the budget presented for the Year 2023-24 a vision about the development plans, comprising government, private entrepreneurs and property owners, has been unveiled. Panaji, Feb 7: Drishti Marine, a Goa government-appointed lifeguard organisation, has introduced camera-based artificial intelligence (AI) robots - 'Aurus' and 'Triton', to monitor the surroundings, assess and detect risks at the beaches. and share real-time information with the on-duty lifeguards.

In a statement, Drishti Marine said that in the past two years, it has witnessed over 1,000 rescue incidents along the coastal belt.

It said "both the AI-monitored camera-based systems can monitor the surroundings, assess and detect risks, share real-time information with on-duty lifeguards so they may respond faster to avoid tragic incidents."

"The main reason is to incorporate new technology under the banner of lifesaving to help to mit-



igate risks while assisting the manpower to be more effective in ensuring the safety and security of individuals on the beaches. The inclusion of AI highlights the progress made in the department of lifesaving," Navin Awasthi, Operations Head of Drishti Marine, said.

Developed by Drishti Works, a division of Drishti, Aurus mans the state's expansive coastal stretch.

The new addition will aid in increased surveillance and crowd management of beaches.

Aurus is a self-driving robot developed to assist lifesavers by patrolling extensive non-swim zones and alerting tourists during high tide. Aurus employs artificial intelligence to assist lifeguards with a variety of duties at the beach. It will work alongside lifesavers in emergency circumstances, from patrolling to providing multilingual notifications.

Kerala welcomes record 1.88cr domestic tourists in 2022: Min



SC panel frowns on tiger safaris in wildlife parks

New Delhi, Feb 7: A Supreme Court-constituted panel has asked the Union Environment Ministry to amend or withdraw guidelines related to setting up zoos and safaris within tiger reserves and wildlife sanctuaries to discourage the use of wildlife habitats for tourism activities which are non-site specific.

In its report submitted to the apex court last month, the Central Empowered Committee (CEC) also said that approvals given for setting up zoos and safaris within tiger reserves and protected areas should be withdrawn forthwith.

It said tiger safaris being "nonsite specific" should also be discouraged within forest areas since the Forest (Conservation) Rules, 2022 discourage diversion of forest land for non-site specific activities under the Forest (Conservation)

The SC panel's observation came on an issue involving the establishment of a tiger safari in the buffer area of Corbett Tiger Reserve in Uttarakhand. According to the National Tiger Conservation Authority (NTCA) guidelines issued in 2012 and amended in 2016 and 2019, tiger safaris can be established in buffer and fringe areas of tiger reserves to "reduce pressure of tourism on core and critical tiger habitats and to foster awareness for eliciting public support".

Also, the ministry had said in June last year that the establishment of zoos on forest areas

should not be considered a nonforest activity, doing away with the need for approval under the Forest (Conservation) Act. 1980. Only in exceptional cases, the fringes of the buffer zone of protected areas may be considered for the construction of a zoo on forest land, it had said.

"The mandate to locate tiger safaris within buffer and fringe areas

of tiger reserves originates from the guidelines issued by the NTCA in 2012... Subsequently, the NTCA issued guidelines on establishment of tiger safaris within tiger reserves in the year 2016 and 2019. It is therefore imperative that the guidelines issued in 2012, 2016 and 2019 in this regard are amended/withdrawn," the CEC report read.

The Central Zoo Authority (CZA) should also not consider and approve the establishment of zoos and safaris within tiger reserves. wildlife sanctuaries, national parks. along animal corridors and animal dispersal routes, the panel said.

The panel said the NTCA should make it mandatory that tiger safaris be established "only outside the notified tiger reserves and the natural habitat of tigers". "The tiger corridors and tiger dispersal routes shall always be avoided so as to ensure that the tiger habitat is not sacrificed for the development of

Cops move HC against order discharging Sharjeel, 10 others

New Delhi, Feb 7: Delhi Police Tuesday moved the High Court against the Saket court's order dated February 4, discharging former JNU student and activist Sharjeel Imam, co-accused Asif Iqbal Tanha and nine others in a case related to the incidents of violence at Jamia Millia Islamia in December 2019.

The police are likely to seek an urgent hearing from the HC on February 8. While discharging, Additional Sessions Judge of Saket Court Complex, Arul Verma had said that the police were unable to apprehend the actual perpetrators behind the commission of the offence, but surely managed to rope in the above-mentioned accused as 'scapegoats'.

The violence had erupted after a clash between the police and people protesting against the Citizenship Amendment Act (CAA) in December 2019. Judge Verma had said that the protesters were surely there in large numbers and it cannot be denied that some anti-social elements within the crowd created an environment of disruption.



BJP leader 'glorified Sati', alleges Oppn

New Delhi, Feb 7: Lok Sabha was adjourned briefly on Tuesday due to protests by opposition members who alleged that BJP member CP Joshi had glorified 'Sati' in his speech. Joshi, however, clarified that he did not support the banned practice and that his remarks were on the tradition of 'Jauhar'.

He said he did not mention 'Sati' and perhaps due to an error in translation from Hindi, the word was mixed with his reference to 'Satitva' (chastity). Joshi, a BJP member from Chittorgarh in Rajasthan, had initiated the debate on the Motion of Thanks on the President's Address when he referred to Padmavati, the queen of Mewar who is believed to have selfimmolated when invader Allaudin Khilji laid a siege at the Chittor fort.

Opposition members Supriya Sule (NCP), Kanimozhi, Dayanidhi Maran, A Raja (DMK), K Muraleedharan (Congress) and Imtiaz Jaleel (AIMIM) were on their feet claiming that Joshi had glorified the practice of 'Sati'.

Joshi asserted that he had not made any reference to the practice of 'Sati', but mentioned that Padmayati had performed 'Jauhar' (self-immolation) to protect her honour. "I stand by my words," Joshi said, as opposition members raised slogans in the Well of the House.

As protests continued, Speaker Om Birla adjourned the proceedings for 20 minutes. When the House reassembled, Birla assured the House that objectionable references will be examined and expunged. Joshi sought to further explain his comments and said he was mentioning 'Jauhar', a practice of mass self-immolation

"Neither I nor my party has ever supported Sati... Perhaps due to an error of translation 'Satitva' was mixed with 'Sati'.... My government keeps nation above politics," he said. "She (Queen **Opposition members** Supriya Sule (NCP), Kanimozhi, Dayanidhi Maran, A Raja (DMK), K Muraleedharan (Congress) and Imtiaz Jaleel (AIMIM) were on their feet claiming that BJP member C P Joshi had glorified the practice of 'Sati'

Padmavati) sacrificed her life to protect her 'Satitva' (chastity)..., Joshi said, inviting fresh protests from the Opposition benches.

"It was Jauhar... Perhaps you don't understand Hindi," he added as protests continued. As the ruckus continued, the Speaker again assured members that objectionable comments will be expunged and urged members to maintain the decorum of the House.

DMK leader A Raja said even as they wanted to abide by the rulings of the Chair, the reference made by the BJP MP was "completely against the society" and "anti-human".

Participating in the debate later, DMK's Kanimozhi said her head was hanging in shame due to the reference made in the House, even as she did not name the MP."Every country when it talks about its past has different narrations... Whose past are we talking about? We talk about the greatness of the nation, valour, art, temples, and philosophy.

"But we can't forget the people who found no place in history - the untouchables, the unseeable and women who were pushed in the fire in the name of honour," she said."Today we celebrate that and I stand on the floor of the House hanging my head in shame because we had to listen to something like that," she said.



INDIA SENDS 4 AIRCRAFT TO QUAKE-HIT TURKIYE

New Delhi, Feb 7: India Tuesday sent to Turkiye relief materials, a mobile hospital and specialised search and rescue teams in four C-17 Globemaster military transport aircraft to support the country's rescue efforts following the massive earthquake that has killed over 5000 people in the region.

India is also expected to send by Wednesday morning relief materials

onboard a C-130J aircraft of the Indian Air Force to Syria which was also hit by the earthquake, people familiar with the matter said.

Several countries around the world have extended help to both countries in their rescue and recovery efforts."India expresses its solidarity at this challenging moment," External Affairs Minister S Jaishankar tweeted. In another tweet, Jaishankar said he contacted his Syrian counterpart Faisal



Mekdad to express solidarity and convey India's support. Defence Minister Rajnath Singh too said India stands in solidarity with the people of Türkiye in this "difficult time." India sent rescue teams and equipment to Turkiye as rescuers in quake-hit areas have been racing against time to save people trapped under the rubble of thousands of buildings.

The first C-17 transport aircraft of the Indian Air Force, carrying a group of search and rescue personnel, specially trained dog squads, drilling machines, relief materials

and medicines landed in Adana in the quake-hit country in the morning. A second IAF plane with similar consignments was sent to Turkiye around noon. Man thrashed, forced to drink urine

Jodhpur, Feb 7: A group of villagers in Rajasthan's Jalore district allegedly caught a man who had come to visit a girl, tied him to a tree, thrashed him and poured urine into his mouth, police said on Tuesday.

They have detained six people after a video of the assault surfaced on social media. They also slapped a case against the man under the Protection of Children from Sexual Offences (POCSO) Act.

According to the police, the victim had allegedly come to meet a girl in a nearby village on Sunday night. He was caught and beaten up brutally after being tied to a tree by the villagers and family members of the girl.

On receiving information, the family members of the man also reached the spot and pleaded the mob to spare him. But the villagers poured urine into his mouth before letting him off with a warning, they said.

SP (Jalore) Harshvardhan Agarwalla said a video of the incident went viral on Monday."Though nobody came forward to file an FIR, we have identified and contacted the victim and took an FIR from him," said Agarwalla.

Six persons in connection with the incident have been detained, he said.

Legislature Party leader Amit Chavda charged the ruling party with destroying the future of the youth.

Justice M.B.Shah, former judge of the Supreme Court and chairman of the Gujarat State Law Commission had in its 34th report submitted on July 1, 2022 recommended introduction of a special law against paper leak in recruitment exams conducted by the state government through appropriate authority/board. However with elections on its mind, the state government failed to act. It is only after the latest leak that Minister Rushikesh Patel

(Prevention of Unfair Means) Act 2021 and making amendments in the Gujarat Secondary and Higher Secondary Education Act. Exam paper leaks have been a recurring factor in Gujarat. In 2018 about 8.75 lakh students were similarly left to rue their fate following postponement of the written examination for recruitment of 9,713 policemen. The postponement came just an hour before the written test was to commence on December 2, 2018 at 2440 centres statewide, after it came to light that the exam paper had been leaked.



25 killed in Pak mishap

Islamabad: At least 25 people were killed and several others injured when a passenger bus collided with a car in Pakistan's northern Gilgit-Baltistan (GB) region, government officials and police said Tuesday. The accident occurred after the over-speeding bus collided with a car near the Shatial checkpost in the Kohistan district of the region, Information Minister of the GB province, Fatehullah Khan told media. The passenger bus and the car fell into the ravine after the accident. At least 45 passengers were onboard the bus when the incident took place.

Central Oz: Alcohol bans reinstated

Canberra: Alcohol bans will be reinstated for indigenous communities in central Australia in response to a crime wave. Prime Minister Anthony Albanese and Chief Minister of the Northern Territory (NT) Natasha Fyles confirmed that dry zones will be reinstated for indigenous town camps and communities near Alice Springs, reports said. It comes less than 12 months after intervention-era alcohol bans in the NT ended in July 2022 making alcohol legal in some areas for the first time in 15 years.

N Korea calls for war preparedness

Seoul: North Korea has convened a meeting of the ruling party's central military commission to discuss ways to expand operational combat drills and "more strictly perfect" its readiness posture for war, Pyongyang's state media reported Tuesday. Kim Jongun presided over an enlarged meeting of the Central Military Commission of the Workers' Party of Korea (WPK) Monday according to the North's official Korean Central News Agency (KCNA). Participants "discussed in depth the major military and political tasks for 2023 and the long-term issues concerning the orientation for army building", as per reports.

Why was Turkey-Syria quake so bad?

London, Feb 6: The magnitude 7.8 earthquake that struck Turkey and Syria Monday is likely to be one of the deadliest this decade, seismologists said, with a more than 100 km (62 miles) rupture between the Anatolian and Arabian plates.

Here is what scientists said happened beneath the earth's surface and what to expect in the after-

■ WHAT TYPE OF EARTHQUAKE **WAS THIS?**

Researchers said the earthquake was a strike-slip quake, where two tectonic plates slide past each other horizontally. The Earth is divided up into different pieces, "kind of like a jigsaw puzzle", said Eric Sandvol, a seismologist at the University of Missouri. Those pieces meet at fault lines, where the plates usually grind against each other slowly. But once enough tension builds up, they can snap past each other quickly, releasing a large amount of energy. In this case, one plate moved west while the other moved east — jerking past each other to create the quake, said Alex Hatem. a USGS research geologist.

■ ARE EARTHQUAKES COMMON **IN THIS AREA?**

The quake occurred in a seismically active area known as the East Anatolian fault zone, which has produced damaging earthquakes in the past. "Almost all of Turkey is really seismically active," Eric Sandvol, a seismologist at the University of Missouri said.

Turkey was struck by another major earthquake in January 2020 — a magnitude 6.7 that caused significant damage in the eastern part of the country. In 1999, a 7.4 magnitude quake struck near



Istanbul and killed an estimated 18,000 people.

■ WHY WAS THIS EARTHQUAKE SO DEVASTATING?

The earthquake was powerful — especially for a quake that hit on land. Typically, very strong earthquakes occur underwater, Margarita Segou, a seismologist with the British Geological Survey, said in an email. On top of that, the quake hit near heavily populated areas. The epicentre was near Gaziantep, a major city and provincial capital in Turkey. The affected regions were also home to vulnerable buildings, said Kishor Jaiswal, a USGS structural

While new buildings in cities like Istanbul were designed with modern earthquake standards in mind, this area of southern Turkey has many older high-rise buildings, Jaiswal said. Rapid construction in Syria — plus years of war — may have also left structures vulnerable, researchers said.

Erdogan declares state of emergency

Antakya: Turkish President Tayyip Erdogan Tuesday declared a state of emergency in 10 provinces devastated by two earthquakes. A day after the quakes hit, rescuers working in harsh conditions were struggling to dig people out of the rubble of collapsed buildings in a "race against time". As the scale of the disaster became ever more apparent, the death toll looked likely to rise considerably. One United Nations official said it was feared thousands of children may have been killed. Thousands of buildings were toppled, hospitals and schools wrecked and tens of thousands of people were injured or left homeless in several Turkish and Syrian cities by the magnitude 7.8 quake - the deadliest in Turkey since 1999 - and a second one hours later. Bitter winter weather hampered rescue efforts and the delivery of aid, and made the plight of the homeless even more miserable. Some areas were without fuel and electricity. Aid officials voiced particular concern about the situation in Syria, already afflicted by a humanitarian crisis after nearly 12 years of civil war.

20 ISIS terrorists escape prison

Drisoners mutinied in a northwestern Syria prison following a deadly lacksquare earthquake, with at least 20 escaping the jail holding mostly Islamic State group members, a source at the facility told AFP. The military po lice prison in the town of Rajo near the Turkish border holds about 2,000 inmates, with about 1,300 of them suspected to be IS fighters, said the source. The prison also holds fighters from Kurdish-led forces. The British based Syrian Observatory for Human Rights war monitor said it could not verify whether prisoners had escaped, but confirmed there was a mutiny.

Paris, Feb 7: Public transportation, schools and electricity, oil and gas supplies were disrupted in France as demonstrators numbering in the tens of thousands took to the streets Tuesday for a third round of nationwide strikes and protests against the government's pension reform plans.

The demonstrations came a day after French lawmakers began debating a pension bill that would raise the minimum retirement from 62 to 64 The bill is the flagship legisla-

Deadliest day for Russians so far

Kyiv, Feb 7: Ukraine said Tuesday the last 24 hours were the deadliest of the war so far for Russian troops, as Moscow pressed on with an intensifying winter assault in the east bringing tens of thousands of freshly mobilised troops to the battlefield.

The Ukrainian military increased its running tally of Russian military dead by 1,030 overnight to 1,33,190, and described the increase as the highest of the war so far. For its part, Russia said it had inflicted 6,500 Ukrainian casualties in the month of January.

The Ukrainian claim could not be independently verified and Russia has also claimed to have killed large numbers of Ukrainian troops in recent weeks.

Tallies of enemy casualties from either side have typically been seen as unreliable, and Kyiv offered few details of the latest battles. But the assertion that the fighting was the deadliest so far fits descriptions from both sides of an escalating campaign of close contact trench warfare, which has left

snow-covered battlefields of eastern Ukraine littered with corpses.

The war is soon entering its second year at a pivotal juncture, with Moscow attempting to regain the initiative while Kyiv holds out for Western tanks to mount a counteroffensive later in 2023

After Russia failed to capture the Ukrainian capital last year and lost ground in the second half of 2022, Moscow is now making full use of hundreds of thousands of troops it called up in its first mobilisation since World War Two.

Kyiv and the West say Russia has been pouring troops and mercenaries into eastern Ukraine in recent weeks in hopes of being able to claim new gains around the time of the first anniversary of its fullscale invasion later this month.

The last few weeks have seen Russia boast its first gains for half a year. But the progress has still been incremental, with Moscow vet to capture a single major population centre in its winter campaign despite thousands of dead.

Fighting has focused for months around the Ukrainian-held Bakhmut in eastern Donetsk province, a city with a pre-war population of around 75,000. Russia has made clear progress towards encircling it from both the north and south, but Kyiv says its garrison is holding fast.

Moscow has also launched an assault further south against Vuhledar, a Ukrainian-held bastion on high ground at the strategic intersection between the eastern and southern front lines

A cybersecurity firm assessed that North Korean cybercrime yielded cybercurrencies worth more than \$1 billion

United Nations, Feb 7: North Korea stole more cryptocurrency assets in 2022 than in any other year and targeted the networks of foreign aerospace and defense companies, according to a currently confidential United Nations report.

"(North Korea) used increasingly sophisticated cyber techniques both to gain access to digital networks involved in cyber finance, and to steal information of potential value, including to its weapons programmes," independent sanctions monitors reported to a UN Security Council committee.

"A higher value of cryptocurrency assets was stolen by DPRK actors in 2022 than in any previous year," the monitors wrote in their report - submitted to the 15-member council's North Korea sanctions committee Friday - citing information from UN member states and cybersecurity firms.

The sanctions monitors said South Korea estimated that North Korean-linked hackers stole virtual assets worth \$630 million in 2022, while a cybersecurity firm assessed that North Korean cybercrime yielded cybercurrencies worth more than \$1 billion.

"The variation in USD value of cryptocurrency in recent months is likely to have affected these estimates, but both show that 2022 was a record-breaking year for DPRK (North Korea) virtual asset theft,' the UN report said.

The UN report noted: "The techniques used by cyberthreat actors have become more sophisticated, thus making tracking stolen funds more difficult.'

EXTORTION

The monitors said most cyber attacks were carried out by groups controlled by North Korea's primary intelligence bureau - the Reconnaissance General Bureau. It said those groups included hacking teams tracked by the cybersecurity industry under the names Kimsuky, Lazarus Group and Andariel.

These actors continued illicitly to target victims to generate revenue and solicit information of value to the DPRK including its weapons programmes," the UN report said.

The sanctions monitors said the groups deployed malware through various methods including phishing. One such campaign targeted employees in organizations across various countries.

"Initial contacts with individuals were made via LinkedIn, and once a level of trust with the targets was established, malicious payloads were delivered through continued communications over WhatsApp," the UN report said.

In 2019, the UN sanctions monitors reported that North Korea had generated an estimated \$2 billion over several years for its weapons of mass destruction programs using widespread and increasingly sophisticated cyberattacks.

Adani Group mulls independent review

The crisis is one of the biggest challenges for the firm, whose fortunes surged in recent years along with his stock prices, before the Hindenburg jolt

Bangalore, Feb 7: Adani Group is considering independent evaluation of issues relating to legal compliance, related party transactions and internal controls following a US short-seller's critical report on its businesses, disclosures showed Tuesday.

The group, led by billionaire Gautam Adani, has been roiled by days of market turmoil after Hindenburg Research January 24 alleged it had engaged in stock manipulation and used tax havens. It also said the group had unsustainable debt

Adani Group has denied the allegations, saying it complies with all laws and has made necessary disclosures over time. Nonetheless. investors dumped its shares as concerns of financial contagion grew.

The quarterly earnings disclosures of three Adani units - Adani Green Energy (ADNA.NS), Adani Ports and Special Economic Zone (APSE.NS) and Ambuja Cements (ABUJ.NS) -- noted that a short seller had alleged "certain issues against some" Adani group entities, saying for the first time they may be looked into.

"The management of Adani group entities are evaluating an independent assessment, basis the requisite corporate approvals, to look into the issues and compliance of applicable laws and regulations, transaction specific issues," Adani Green said in its quarterly earnings filing, without describing the issues.

While Ambuja's filing was similar, Adani Ports said it would evaluate an independent assessment on the matter, if required. The disclosure comes as shares

of Adani Group rallied Tuesday, a day after it prepaid some loans, bringing relief to investors that have seen \$113.6 billion wiped off the conglomerate's market value since the Hindenburg Research report two weeks ago.

In a major setback for the billionaire, the market rout also forced him to shelve a key \$2.5 billion



On Monday, Adani Group said it would pre-pay \$1.11 billion of loans on shares. Separately, JPMorgan Tuesday said the group companies were still eligible for inclusion in the bank's bond indexes.

The group's flagship company Adani Enterprises Ltd closed up 14.6% Tuesday, still around half the level seen before the Hindenburg report was released.

The cumulative losses of Adani group's seven listed companies still stand at \$109 billion despite Adani Ports also gaining 1.4% Tuesday and Adani Wilmar adding 5%. Adani Green, Adani Total Gas Ltd and Adani Power, all however ended 5% lower.

No credit risk for banks: Rating agencies

Global rating agencies Fitch and Moody's Tuesday said banks' exposure to Adani group is not large enough to affect their credit quality, and bank ratings are driven by expectations that they would receive 'extraordinary' sovereign support, if needed. "Fitch Ratings believes that Indian banks' exposure to the Adani group is insufficient in itself to present a substantial risk to the banks' standalone credit profiles," the rating agency said in a note. Moody's stated that although the exposures to Adani group are larger for public sector banks than for private sector banks. they are smaller than 1 per cent of total loans for most banks. "Risks for banks can increase if Adani becomes more reliant on bank loans," Moody's said.

breadth of the world's knowledge with the power, intelligence and creativity of our" AI, Pichai said.

Behind the new chatbot is LaMDA, Google's AI that generated text with such skill that a company engineer last year called it sentient, a claim the technology giant and scientists widely dismissed.

In a demo of the service, Bard like its rival chatbot invites users to give it a prompt while warning its response may be inappropriate or inaccurate. It then bulleted three answers to a query about a space telescope's discoveries, the demo showed.

"Google is relying on a version of LaMDA that requires less computing power so it can serve more users and improve with their feedback." Pichai said.

ChatGPT at times has turned away users because of explosive growth, with UBS analysts reporting it had 57 million unique visitors in December outpacing potentially TikTok in adoption.

Google also plans to give technology tools, first powered by LaMDA and later by other AI, to creators and enterprises starting next month. Pichai said.

'Move away from hypocrisy': Global South demands energy justice

Bangalore, Feb 7: Rich countries should stop throwing up roadblocks to poorer ones trying to secure energy supplies and do more to help them make the green transition, officials from Global South nations told the India Energy Week conference Tuesday.

The criticism highlights the gaping political fault lines in the battle against climate change and underscores the challenges in drafting effective decarbonisation strategies.

Tanzania's energy minister January Makamba called for "a move away from hypocrisy" by wealthy nations refusing to finance gas projects, while a senior official from Bangladesh said its energy security was compromised by the higher gas prices caused by Western sanctions on Russia.

Makamba said Japan rejected a proposal last week to finance a gas-fired power plant in southern Tanzania because it was no longer



"Japan is one of the largest importers of LNG (liquefied natural gas). So if gas is good for you to run an economy but it's bad for me to generate power, there's a problem," Makamba told the conference in

Japan also stopped financing two coal power plant projects in Indonesia and Bangladesh in June. responding to global criticism over its continued support for the polluting fuel.

Government officials in some countries and industry officials call this discriminatory.

made LNG inaccessible for the south Asian country.

"There were ships floating around Western Europe carrying gas, and other countries were not able to buy because of the price. he told Reuters on the sidelines of the conference.

Bangladesh, which counts on natural gas for over two-thirds of its power generation, was one of the worst hit by the surge in LNG prices. Major cities in Bangladesh were forced to resort to hours of power cuts during the second half of 2022, disrupting commercial and industrial activity.

'Western countries literally priced us out of market, Chowdhury said.

Zimbabwe, where electricity shortages were among the key reasons for slower economic growth in 2022, is still far from transitioning from traditional sources of power, its deputy energy minister Magna Mudyiwa said.

'We are a growing economy, plenty of mining is going on, plenty of agriculture is going on. We still need some more electricity in Zimbabwe. And then we can talk about transitioning from what we have to green energy," she said.

'No unified global energy market'

There is no unified global energy market and energy security is no longer global, Russia's powerful oil executive Igor Sechin said amid talk for countries coming together to check volatility in prices and ensure smooth transition to net zero. Speaking at the India Energy Week here, Sechin, chief executive of Rosneft, said all principles of market trading have been destroyed and market pricing and contract law abolished. Russia was slapped with sanctions by some Western countries following the war in Ukraine. Some countries in Europe stopped buying contracted natural gas. Russian crude oil was shunned. leading to it being traded at a discount to international rates. This meant that while all major benchmark crude oil moved in a particular fashion, Russian crude was traded at discounts as high as \$40 per barrel. "There is no unified global energy market, and energy security is no longer global," he said.

Govt gets 33.44% stake in VI post equity allocation

The shares have been allocated to the government in lieu of conversion of interest dues arising from deferment of adjusted gross revenue and spectrum auction payments, the company said in a regulatory filing.

The government cleared conversion of Rs 16,133 crore interest dues of debt-ridden Vodafone Idea into equity after receiving a firm commitment from Aditya Birla Group to run the company and bring necessary investment.

The paid-up share capital of the company stands increased to Rs 482,520,327,840 comprising of-48,252,032,784 equity shares of the face and paid-up value of Rs 10/- each.

There's temptation to play three spinners but you never know with Nagpur pitch, says Rahul

Nagpur, Feb 7: India's Test vicecaptain KL Rahul feels it's never easy to predict the nature of a track but there is a "temptation" to play three spinners in the first Test against Australia, beginning here Thursday.

With less than 48 hours left for the Border Gavaskar Trophy to begin, Rahul didn't provide any definitive answers about three key slots in the team - the wicketkeeper, the third spinner and the No.5 in the batting order.

Asked if Shubman Gill will bat in the middle-order, Rahul said: 'We still haven't decided on the final XI. It's going to be a tough decision to make. There are guys who have performed exceedingly well and there are a few spots open so there are a few discussions going on and the players are being spoken to."

The VCA track is expected to assist spinners from day one itself but Rahul doesn't want to be a soothsayer when it comes to reading the 22-yard strip.

'Yes, we did see it (the pitch), but it's still too early to really know what the pitch is going to do. We need to come here on the day of the match to know how it's really going

to play," he told reporters.
"We can only look at it and assume it's going to play a certain way. but you never know with pitches. Yes, there is the temptation to play three spinners because we're p ing in India. We'll take that call on the day of the game or the day before the game," the stylish right-

With skipper Rohit Sharma back in the mix. Rahul was asked if he would like to bat in the middleorder where he had started his Test career back in 2014. "If it arises, then I'm more than happy to do that. Whatever little cricket I've played for the country, I've always done that.

"Whatever the team has asked me to do, I try and prepare that way and try and do my best for the team, and if that is something that the team wants me to do here. I'll be more than happy to do it," Rahul said, although it is unlikely that he would come down the order.

So does he find it unique that there is no straightforward choice for picking the playing eleven this time around? "I don't know if it has happened before but, yes, this time is is going to be tough. Tough decision to select an eleven. All the 15 guys in the side are top quality, and that's why they're here. Anyone of them on any given day can be a

"The playing XI, we always try and make a decision based on what's best for the team and for that particular Test match. We have done that over the last two years," that was his response to a

Rahul didn't forget to remind the media that he is still pretty sour about the backlash that he got for dropping Kuldeep Yadav for the second Test against Bangladesh after his match performance in the series opener.

"There have been questions about why a certain player has played... even in Bangladesh, I remember, Kuldeep (Yadav) got the man of the match and did not play

the next Test. Obviously, the only reason, or the only thinking, behind such decisions is which player fits the role for that particular condition. You said, I have played for 10 years, but even if I have played for 20-30 years, and even after retirement, there is nobody who can look at the pitch and say accurately that 'this is how it is going to play'

"It's really based on some experience and a little bit of history of that place. Even in this series, that's something we will continue to do,"

Whether it is Suryakumar Yadav or Kuldeep Yadav, whoever gets dropped needs to take that on chin. "Everyone is very clear about why they're playing, why they aren't playing, their roles in the team. That's a good thing, and the atmosphere in the team is very good."

Rahul feels with the quality in the Australian bowling line-up, reverse swing in the dry and abrasive conditions can play a huge role. "It always plays a huge role in India. We have seen that historically as well. Any team that has quality fast bowlers who can exploit reverse swing will be dangerous on pitches like these. That's something that we have tried to prepare for over the last week, 10 days.

"We all know the Australian team has always produced highquality fast bowlers, and we know the threat they can pose. That's the beauty of playing against Australia, that's what excites you and something we are kicked about.

While R Ashwin, Ravindra Jadeja, Axar Patel and Kuldeep Yadav would like to conserve energies for the big five days, there were off-spinners Pulkit Narang and Jayant Yadav along with legspinner Rahul Chahar and leftarm orthodox R Sai Kishore and Saurabh Kumar who did bulk of the



The paucity of good off-break bowlers in domestic cricket is pretty evident that Narang and India international Jayant, both of whom aren't even in top 10 domestic wicket-takers, being called for simulation. While Jalaj Saxena continues being ignored, Jayant's presence shows that Lyon is very much in India's head.

"The things that, obviously, we have worked on is playing spin, and we know the pitches are going to play here in India and what to expect. Keeping that in mind, we have practiced playing spin," vice captain KL Rahul gave a sneak peek into team's preparation in the lead up.

While Shubman Gill and Virat Kohli did play the sweep shot, Cheteshwar Pujara was more intent on negating the off-breaks with a big forward stride.

"Each person has his own individual plans. Everybody wants to play a certain way, or everyone has

their own set way which has been discussed with the coaches. We have discussed this as a batting group in an attempt to try and play spin better," said the Indian vice cap-

In fact, head coach Rahul Dravid devoted considerable amount of time with Gill and was explaining the various methods to keep the sweep down with some shadow batting. He was seen showing Gill as to how he can avoid offering catch to forward short leg or leg gully if there is big turn on offer.

Gill was later seen himself standing at forward short leg wit fielding coach T Dileep giving him close in catching practice. The team combination isn't being spelt out but it seems that Gill, who is in the midst of a purple patch, will have to make way for Rahul at the top.

However with a dry patch on one side of the track, the ball will do its bit from day one itself and a good wicketkeeper will be need of the hour.

KS Bharath, who had once shown admirable skills keeping upto Ashwin on a low bounce Green Park track in Kanpur is likely to get his maiden Test cap although Ishan Kishan remains an exciting lefthand option.

DUMINY BACKS AUSSIES TO WIN TEST SERIES 2-1

Duminy was quick to add that one can never "write off" India in their home conditions. "You think about (Ravichandran) Ashwin who has a prolific Test record in India, he's probably

going to be the key for them." "When it comes to Test cricket, you have got to utilise your resources. Guys like (Cheteshwar) Pujara, Virat Kohli who are prolific in Test cricket. They churn out runs after runs. It's an opportunity for those guys to step up.

"Virat Kohli also smiled at me nd gestured thumbs up and wished me luck," you couldn't miss the pride in his voice.

He has just started his journey in senior cricket for Baroda and that is what he focuses on at the moment. 'I have started my journey in Ranji Trophy and I want to focus on my red ball game. I want to cement my place in the Baroda side. I am not thinking about IPL now," said Mahesh, who had worked in a tea stall few years ago.

So what exactly does he bowl? Does he have a carrom ball or a slider like Ashwin? "No, I don't bowl carrom ball or doosra. My stock ball is off break and another ball that I have myself developed is one that has a bit of backspin in

it. But I bowl that in white-ball cricket," said the man who lives with his parents, elder brother and sister in law.

Bowling to Smith and Labuschagne has been a life changing experience for him. "It has been amazing to work with this Australian side. My job is to mainly bowl to Smith at Australia nets. He didn't ask me to bowl anything specific."

Mahesh feels lucky that he is able to interact a lot with Nathan Lyon who has given him some invaluable tips on the art of off spin.

"Lyon first asked me to show my grip and explain what I do while rolling my fingers. He then explained how I can get more revs (rotation) on the ball and also how my front leg (left) should land. He told me to have confidence in my ability."

The Australian team be using Mahesh's services till the start of the second Test in Delhi. "I am there with the team till February 17. It has been a life changer for me,' said the young man.

Besides India captain Harmanpreet, Mandhana and Australian star Healy and number one England spinner Ecclestone, the others in the highest base price bracket include U-19 World Cup winning captain Shafali Verma, Deepti Sharma, Sneh Rana, Jemimah Rodrigues, England's Nat Sciver, Australia captain Meg Lanning among others.

India's U-19 stars, who won the World Cup in South Africa, will also be part of the action. They include uncapped Parshavi Chopra, Archana Devi, Titas Sadhu, Shweta Sehrawat and Mannat Kashyap (Rs 10 lakh base price for all).

"The WPL Player Auction list is out with a total of 409 cricketers set to go under the hammer at the Jio World Convention Centre in Mumbai on February 13, 2023," said the BCCI in a release.

Finch hangs up his international gloves

Melbourne, Feb 7: Australia's most successful T20I batter and captain Aaron Finch, who led the country to its maiden shortest format World Cup triumph in 2021, announced his retirement from international cricket Tuesday.

The 36-year-old will, however, continue to play for the Renegades in the Big Bash League and would consider domestic T20 opportunities in other countries.

"Our World Cup winning, longest serving men's T20I captain has called time on a remarkable career. Thanks for everything @AaronFinch5," Cricket Australia (CA) said on its official Twitter handle.

Finch's retirement from international cricket was on expected lines. He played just five Tests, the last one being in 2018, and retired from the ODIs last year after a much-publicised struggle for form as captain of the Australian team. He captained the team to their

first T20 World Cup title when they

defeated New Zealand in Dubai in

2021 and is one of only four male

Australians to captain a World Cup



winning side.

But, the Australian team under him failed to qualify for the semifinals T20 World Cup at home last year. His last international match came in the T20 showpiece when he top-scored with 63 as Australia beat Ireland by 42 runs.

"Realising that I won't be playing on until the next T20 World Cup in 2024, now is the right moment to step down and give the team time to plan and build to

wards that event," Finch told reporters at the Melbourne Cricket Ground. "I also want to say a huge thank you to all the fans who have supported me throughout my in-

ternational career.' The long-term white-ball skipper and longest-serving T20I captain represented Australia in 254 international matches across all formats, playing five Tests (278 runs), 146

ODIs (5406 runs) and 103 T20Is. Since making his international

debut in a T20I in January 2011. Finch amassed 8,804 runs in all formats which includes 17 ODI centuries and two T20I tons.

Finch led Australia in a world record 76 men's T20Is, as well as in 55 ODIs, before his retirement. He is Australia's most prolific T20I batter with 3120 runs from 103 matches at an average of 34.28, with two hundreds and 19 fifties, and a strike-rate of 142.53.

He also holds the record for the highest score in a T20I when blasting 172 runs from just 76 balls against Zimbabwe in Harare in 2018, an incredible knock that included 10 sixes and 16 fours. Finch was also a part of the Australia team that won the ICC Men's Cricket World Cup in 2015.

"Team success is what you play the game for and the maiden T20 World Cup win in 2021 and lifting the ODI World Cup on home soil in 2015 will be the two memories I cherish the most," Finch said.

"To be able to represent Australia for 12 years and play with and against some of the greatest players of all time has been an incredible honour.
