#### Af activist shortlisted for Nobel Peace Prize



Kabul: When the Taliban seized power in August 2021, hundreds of women's rights activists fled Afghanistan, fearing reprisals

from the militant group. But Mahbouba Seraj, one of the most prominent rights campaigners in the country, refused to leave, even though she holds a US passport, the media reported. Despite intimidation from the Taliban, the 75-year-old has continued to advocate for the rights of women and girls and operate a network of shelters for women fleeing domestic abuse, Radio Free Europe (RFE)/Radio Liberty (RL) reported. Seraj's work and courage were recognised when she was shortlisted for the Nobel Peace Prize earlier this month. She was nominated jointly with Narges Mohammadi, the jailed Iranian human rights activist and lawyer.


#### **Cuttack man among 4 AQIS ultras convicted**

#### ₹22.52cr fine on pvt firm for illegal mining

Bhubaneswar, Feb 11: The National Green Tribunal (NGT) has slapped a penalty of ₹22.52 crore on a private firm engaged in National Highway-16 expansion project for illegally extracting minor minerals in Balasore district.

The firm was alleged to have violated several environmental guidelines while extracting minor minerals for widening of Bhadrak-Balasore stretch of the National Highway.

The State Pollution Control Board (SPCB) has been asked by the apex green body to recover the amount and utilise the same in restoration of environment in the district.

"Further action may be taken for recovery of assessed compensation in accordance with law. The recovered amount may be utilised for restoration of environment in accordance with the District Environment Plan of the area, supplemented by such other plan as may be found necessary, with the approval of the State PCB," ordered NGT.

Following the directions of the NGT, the Regional Officer of SPCB at Balasore inspected the spot to check compliance of rules by the private firm and suppliers of minor minerals for the project. On December 22, 2022, the SPCB submitted its report along with the assessment of environmental compensation which stood at ₹22.51

Notably, complainant Alaya Samantary had alleged that the firm procured huge quantities of different minor minerals like soil/earth/murram, sand and stone aggregates from suppliers who don't have any official approval to lift minor minerals

The contractor firms had reportedly not obtained any Consent to Establish (CTE), and Consent to Operate (CTO) certificate from \_\_\_\_ the SPCB for the mining.

Cuttack, Feb 11: President Droupadi Murmu Saturday said that rice is the cornerstone of food security in the country, and a key factor of the nation's economy.

The President said this while inaugurating the Second Indian Rice Congress at ICAR-National Rice Research Institute, here in Odisha. "Though India is the lead-

ing consumer and exporter of rice today, the situation was different when the nation got Independence... those days, we were dependent on imports to meet our food requirements," she said.

Praising the National Rice Research Institute (NRRI), the President said: "If the nation could overcome that dependency and has become the largest exporter, a lot of credit goes to the NRRI. It has contributed immensely to India's food security and also in improving farmers' lives." Koraput, Feb 11: Two officials of Hindustan Aeronautics Limited (HAL) at Sunabeda in this district were reportedly picked up by Central Bureau of Investigation (CBI) officials Saturday on alleged charge of leaking classified data of the Centre-owned agency. It is suspected that they leaked the information after allegedly being honeytrapped.

The incident came to the fore during a raid by CBI sleuths from Nasik at HAL's Sunabeda unit.

According to sources in the know of the development, the accused include a senior official of the aerospace and defence establishment. A laptop and hard disk were reportedly seized from their possession.

The two have been taken to an undisclosed location where they are being interrogated. The development has spread panic among the HAL employees. However, Sunabeda HAL's deputy general manager (DGM) Bhawani Shankar Shah said this is a rumour and nothing of this sort has happened.

## Hubble captures onset of Saturn's 'spoke season' As the autumnal equinox of Saturn's northern hemisphere draws near, the spokes are expected to become increasingly prominent



Washington, Feb 11: In a latest image of Saturn captured by National Aeronautics and Space Administration's (NASA's) Hubble Space Telescope, the appearance of spokes on the planet's rings heralded the start of a new 'spoke' season, according to a statement by NASA.

Scientists will be looking for clues to explain the cause and nature of the spokes, the statement said. The suspected culprit for the spokes is the planet's variable magnetic field, the statement said. Planetary magnetic fields interact with the solar wind, creating an electrically charged environment.

On Earth, when those charged particles hit the atmosphere this is visible in the northern hemisphere as the aurora borealis, or northern lights, NASA said.

Scientists think that the small-



est, dust-sized icy ring particles can become charged as well, which temporarily levitates those particles above the rest of the larger icy particles and boulders in the

rings, NASA said. Like Earth, Saturn is tilted on its axis and therefore has four sea-

sons, though because of Saturn's

much larger orbit, each season

lasts approximately seven Earth years, the space agency said. Equinox occurs when the rings

are tilted edge-on to the Sun. The spokes disappear when it is near summer or winter solstice on Saturn, which is when the Sun appears to reach either its highest or lowest latitude, respectively, in the northern or southern hemisphere of a planet, the space agency said. As the autumnal equinox of Saturn's northern hemisphere May 6, 2025, draws near, the spokes are expected to become increasingly prominent and observable, the statement said. The latest image captured by

Hubble is heralded the start of Saturn's "spoke season" with the appearance of two smudgy spokes in the B ring, one of the rings, of Saturn, the statement said.

The ephemeral features don't last long, but as the planet's autumnal equinox approaches, more will appear, the statement said.

The ring spokes were first observed by NASA's Voyager mission in the early 1980s. The transient, mysterious features can appear dark or light depending on the illumination and viewing angles, the statement said.

NASA senior planetary scientist Amy Simon, head of the Hubble Outer Planet Atmospheres Legacy (OPAL) program said, "Thanks to Hubble's OPAL program, which is building an archive of data on the outer solar system planets, we will have longer dedicated time to study Saturn's spokes this season than ever before.

NASA's Hubble Space Telescope has observation time devoted to Saturn each year, thanks to the OPAL program, and the dynamic gas giant planet always showed something new, said the space agency.

Saturn's last equinox occurred in 2009, while NASA's Cassini spacecraft was orbiting the gas giant planet for close-up reconnaissance. the agency said in the statement.

With Cassini's mission completed in 2017, and the Voyager spacecrafts long gone, Hubble is continuing the work of long-term monitoring of changes on Saturn and the other outer planets, the space agency said. Contd...P4







The police had claimed that Rehman was suspected to have international links in Saudi Arabia, Pakistan and Dubai.

It had alleged that the other coaccused were also trying to radicalise youths and propagating the terror agenda of AQIS in India.

The police had quizzed the accused persons in its custody about the conspiracy and funding of AQIS and also to ascertain the identity of their associates.

The narco-analysis test was conducted on the dismissed police ASI after a thorough medical examination and polygraph test at the Directorate of Forensic Science in Gandhinagar.

After the narco-analysis, the ex-ASI was kept under observation. It takes some time to regain complete consciousness after the complex test, sources said.

The Crime Branch (CB) had taken Gopal to Gujarat February 8. It has taken him on remand for five days for detailed investigation and tests following permission from the court.

Although Gopal has reportedly confessed to have killed the minister, the CB is yet to ascertain the motive behind the assassination. In order to ascertain the motive behind the crime, the investigating agency is conducting the tests.

Earlier, a team from the Central Forensic Science Laboratory of New Delhi had conducted forensic psychological assessment and layered voice analysis test on Gopal at Jharsuguda. A special medical board, comprising psychiatry doctors, also conducted a detailed study of the mental health of the accused in Jharsuguda and the report is awaited

## Tiny California mouse in Guinness record

tiny California mouse now has a big title after winning a Guinness World record for longevity.

A Pacific pocket mouse named Pat - after "Star Trek" actor Patrick Stewart — received the Guinness approval Wednesday as the oldest living mouse in human care at the ripe age of 9 years and 209 days, the San Diego Zoo Wildlife Alliance announced after a certification ceremony

Pat was born at the at the San Diego Zoo Safari Park on July 14, 2013, under a conservation breeding program, the alliance said.

The Pacific pocket mouse, which weighs as much as three pennies, is the smallest mouse species in North America and gets its name from cheek pouches the animals use to carry food and nesting materials, the wildlife alliance said.

The mouse once had a range stretching from Los Angeles south to the Tijuana River Valley but the population plunged after 1932 because of human encroachment and habitat destruction, the alliance said.

The mouse was thought to be extinct for 20 years until tiny, isolated popu-



lations were rediscovered in 1994 in Dana Point in Orange County but the species remains endangered, the al-

liance said. In 2012, the alliance began a breeding program to help save the mouse from extinction. Last year, the alliance recorded 117 pups born in a record 31 litters. Many of the mice will be reintroduced to the wild this spring, the alliance said.

A new population of Pacific pocket mice was established in Orange County's Laguna Coast Wilderness Park and the mice began breeding without human assistance in 2017, the alliance said.

Though it doesn't receive the publicity of larger and more charismatic species, the Pacific pocket mouse is critical to its ecosystem because the mice disperse the seeds of native plants and their digging encourages plant growth, the alliance said.

## Quadruple joint replacement surgery by City AIIMS

Bhubaneswar, Feb 11: In a firstof-its-kind surgery in the state, AIIMS Bhubaneswar has conducted successful quadruple joint replacement surgery in a crippled patient, the institute said Saturday

A 37- year old female from Aul block of Kendrapara district, with impaired movements in the hip joints and knees due to rheumatoid arthritis, had been admitted to



After evaluating the patient, the team of doctors planned for

the challenging task of conducting surgeries of both the hip and knee joints in one setting. Orthopedic surgeons Sujit Kumar Tripathy and Mantu Jain assisted by Sritam Swarup Jena led anesthesia team performed the surgery in which replacements of the hips were performed first followed by the knees.

The surgery was completed in three hours with the patient being able to walk after two days' rest.

AIIMS sources claimed that previously only one case has been reported from AIIMS Delhi in which an Odia patient was operated with all four joint replacements in one

AIIMS Bhubaneswar executive director Ashutosh Biswas said, "I congratulate the team for managing such a complex case and providing mobility to the patient. Such surgeries are rare and must be carried out with extreme caution.

#### Rice key to food...

Speaking about the challenges faced for cultivation of rice, the President said: "Even as rice has broken new ground, there are places where traditional varieties are facing challenges. Thus, the task before us today is to find the middle path -- preserving and conserving traditional varieties on one hand and maintaining ecological balance on the other.'

Another challenge is to save the soil from excessive use of chemical fertilisers, which are considered necessary for modern rice cultivation, she added.

Murmu further said: "As rice forms the bedrock of our food security, we must consider its nutritional aspects too. Large sections of low-income groups depend on rice, which is often the only source of daily nutrition for them.

Murmu said: "ICAR-NRRI has developed India's first high protein rice, called CR Dhan 310 and released a high-zinc rice variety, called CR Dhan 315

Development of such bio-fortified varieties is an ideal example of science in the service of society. More and more of such efforts

would be needed to support the increasing population amid a changing climate, she said. Earlier, Saturday morning, the

#### US downs object...

Another US F-22 fighter jet February 4 brought down what the US government called a Chinese surveillance balloon off the coast of South Carolina following its week-long journey across the United States and portions of Canada. China's government has said it was a civilian research vessel.

Some lawmakers criticised the president for not shooting down the Chinese balloon sooner. The US military had recommended waiting until it was over the ocean out of fear of injuries from falling

The Pentagon and the White House declined to give a detailed description of the latest object, saying only that it was far smaller than the Chinese balloon.

US officials declined to speculate about what the object might be, even after a day of observation, raising questions about what kind of object could be so difficult to identify by experienced US pilots and intelligence officials.

The Pentagon said it was first detected Thursday using ground radars. F-35 aircraft were then sent to investigate. The UFO was flying at about 40.000 feet (12.190 meters) in a northeasterly direction, posing a risk to civilian air traffic.

The object was shot down off the coast of northeastern Alaska over frozen US territorial waters near the Canadian border. Officials said it would be far easier to retrieve pieces of the object from the ice than it was with the Chinese balloon, pieces of which sank in the ocean when it was shot down.

Ryder said American pilots who flew alongside the latest object before it was downed determined that no human was aboard. He added it was incapable of maneuvering and did not resemble an airplane. Ryder and other officials would not say whether it could simply be a weather balloon or another type of balloon. "It wasn't an aircraft per se," Ryder told a news briefing.

## Emissions from fertilisers could be cut down by 80 pc

missions from manure and synthetic fertilisers could be reduced by as much as 80 per cent, to one-fifth of current levels, according to a new study.

Researchers have quantified that two thirds of emissions from fertilisers take place after they are spread on fields, with one third of emissions coming from production processes, the study said.

The researchers, from University of Cambridge, UK, have calculated the carbon footprint for the full life cycle of fertilisers, the study said.

Fertilisers are responsible for approximately five percent of total greenhouse gas emissions, the first time this has been accurately quantified, and found that carbon emissions could be reduced to onefifth of current levels by 2050, the study said.

Although nitrogen-based fertilisers are already known to be a major source of greenhouse gas emissions, this is the first time that their overall contribution, from production to deployment, has been fully quantified, the study said.

Their analysis found that manure and synthetic fertilisers emit the study said.

According to the study, earlier research has estimated that 48 per cent of the global population is fed with crops grown with synthetic fertilisers, and the world's population is expected to grow by 20 per cent until 2050.

The Cambridge researchers said that a combination of scalable technological and policy solutions are needed to reduce fertiliser emissions while maintaining food security.

However, they estimate that if such solutions could be implemented at scale, the emissions from manure and synthetic fertilisers could be reduced by as much as 80 per cent, to one-fifth of current levels, without a loss of

The results are reported in the journal Nature Food.

"Incredibly, we don't actually know how many chemicals we produce globally, where they end up, where and how they accumulate, how many emissions they produce, and how much waste they generate," said co-author Dr Andre Cabrera Serrenho from Cambridge's

Department of Engineering. Serrenho and his co-author Yunhu Gao undertook a project to accurately measure the total impacts of fertilisers, one of the two main products of the petrochemical industry, the study said.

Of all the products made by the petrochemical industry, the vast majority, as much as 74 per cent, are either plastics or fertilisers, the study said.

"In order to reduce emissions, it's important for us to identify and prioritise any interventions we can make to make fertilisers less

harmful to the environment," said Serrenho. "But if we're going to do that, we first need to have a clear picture of the whole lifecycle of these products. It sounds obvious,

but we actually know very little

about these things." said Serrenho.

The researchers mapped the global flows of manure and synthetic fertilisers and their emissions for 2019, along all stages of the lifecycle, by reconciling the production and consumption of nitrogen fertilisers and regional emission factors across nine world regions, the study said.

After completing their analysis, the researchers found that unlike many other products, the majority of emissions for fertilisers occur not during production, but during their use. "It was surprising that this was the major source of emissions," said Serrenho.

"But only after quantifying all emissions, at every point of the lifecycle, can we then start looking at different mitigation methods to reduce emissions without a loss of productivity," said Serrenho.

The researchers listed and quantified the maximum theoretical impact of different mitigation methods – most of these are already known, but their maximum potential effect had not been quantified.

Emissions from the production of synthetic fertilisers are mostly from ammonia synthesis, partly due to chemical reactions used in the production process

The most effective mitigation at the production stage would be for the industry to decarbonise heating and hydrogen production.

Fertilisers could also be mixed with chemicals called nitrification inhibitors, which prevent bacteria from forming nitrous oxide.

## Will NCM, MISHTI be able to save mangrove forests?

Miniscule fund allocation under the schemes has raised question marks on the safety and preservation of mangroves leaving environmentalists concerned

They said that the Budget will impact the protection of mangrove forest in Bhitarkanika wetland. This wetland, spread in an area of 672 sq km, has 209.25 sq km of mangrove forest cover by 2019.

The mangrove forest here is deemed as a protective wall for Kendrapara district and a sanctuary for scores of wild and marine animals. The mangroves house rich bio-diversity and protect the land mass from natural calamities like cyclonic storms, floods and tsunamis.

Union Finance Minister Nirmala Sitharaman said the scheme will be implemented by converging Compensatory Afforestation Fund Management and Planning Authority (CAMPA) funds, Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) and other sources.

In reply to question on protection of mangrove forests, the Union Environment, Forest and Climate Change Minister Aswini Kumar Choubey said that a budget will be prepared under the NCM

and the new MISHTI scheme has been launched, February 6. However, the budget in NCM has been reduced. Moreover, no special allocation has been made under MISHTI scheme which is likely to impact protection of the mangrove forests.

The Centre had allocated ₹27 crore in the 2021-22 FY for the NCM. According to Indian State of Forest Report-2021 these funds will be used in protection of mangrove forests spread over 4,992 sq km area and create more mangrove forests on 7,500 km-long coastline.

However, the budgetary allocation for the NCM was reduced to ₹25 crore in 2022-23 FY while this year it has been reduced to ₹12.50 crore.

While the centre is reducing the budgetary allocation for the NCM, it is also doing the same for MGN-REGS. The survival rate of mangroves when grown by sowing seeds is 50 per cent while it is 60 per cent if done through plantation of saplings. A mangrove tree takes three years to achieve full growth.

Protection of mangrove forests has come under question mark as the MGNREGS and CAMPA funds are released annually. Moreover, the Bhitarkanika wetland is facing acute shortage of freshwater and the mushrooming of prawn gheries. industries and intrusion by Bangladeshi nationals has led to pollution, hindering the growth of new forests and destroying the existing forest cover.

 $The \, coastal \, erosion \, has \, remained \,$ unchecked and the low budgetary allocation is all the more likely to impact the existence of Bhitarkanika.

When contacted, DFO Sudarshan Gopinath Yadav said that special nursery has been established for preparation of mangrove saplings and plantation of saplings and their maintenance is being given the highest priority.

According to the SDPO, police have already started investigation by deploying a special team in that area.

The smuggler from Kendumundi area of Mayurbhani has reportedly been arrested with seizure of eight pieces of two full-sized tusks. However, the police are still unaware about the source of the recovered items and have directed a probe into the matter. #### **Collector reviews** Rangeilunda airstrip expansion works

Gopalpur, Feb 11: Flight services from the Rangeilunda airstrip situated at close proximity to the Berhampur University has been a long standing demand of the residents of the locality. Regarding this, Ganjam district Collector Dibyajyoti Parida along with the departmental officials reviewed the air strip development works, Friday.

Currently the air strip is only 975 metre long with 150 metre width and the run way is only 750 metre in length making it difficult for commencement of flight operation. For the expansion of the air strip, government

and private land has been identified. Land from the boundary up to 90 metre towards the hostel, 40 metre towards the University administrative block and 250 metre towards the Berhampur main road and nearly 30 metre from the Monarch Chowk boundary will be taken up for the expansion of the airstrip.



A letter had been sent to the Higher Education department regarding the reguirement of 15 acres of the University's land for the project. The department has identified the land and replied to the Registrar of the varsity.

During the review, discussions were held regarding the development of Rangeilunda airstrip with improvements, the tender process for which has been completed and the need for surveying the technical aspects. The government will decide on operationalisation of the air strip as soon as its construction gets completed, the Collector said.

## Villagers snub construction of hydro-power project in Kotia

Pottangi, Feb 11: With Odisha and Andhra Pradesh caught up in an ugly imbroglio over their claim over Kotia panchayat under this block in Koraput district, a fresh row has erupted over the construction of a hydropower project at Talaganjeipadar village in the panchayat, a report said Saturday.

Controversy broke out as residents of seven villages armed with sharp-edged weapons recently marched to the work site and opposed the construction of the hydro-power project at Talaganjeipadar village in the panchayat

All the villagers -- starting from children and youths to the elderly -- were seen carrying sharp-edged weapons in their hands opposing the project, Friday.

Sources said that six persons from Tamil Nadu arrived with earth moving equipment last Sunday at Talaganjeipadar village. They pitched tents and started excavating the area under the hill with earth movers. Thursday. They were busy in their works when villagers reached the spot and questioned who had sent them and enquired on the purpose of their visit to



whether it is Odisha government or the Andhra Pradesh government that has sent them to the area. Fearing backlash, the workers did not reply and instead stopped the works.

Notably, an Andhra team had visited the area December 28, 2021 and was identifying land for the hydro-power project. Some officials from Odisha also visited the place after learning about their arrival. Both the groups had had a heated exchange of words before the Andhra team abandoned the place and dispersed.

The villagers have alleged that seven villages in the area would be submerged and their forest land destroyed if the project comes up in the area. They have warned that they will not allow work on the project under any circumstances

administration and the block officials to first talk to them before making any further move with the project. "We should be explained first on the benefits and losses arising out of the project," they said.

When contacted, Kotia sarpanch Liu Gemel said she is unaware of the development. She, however, said that no pallisabha or gramsabha has been conducted before taking up the construction of the project. On the other hand, BDO Soumva Sarthak Mishra, despite being present at Kotia during the period, chose not to the visit the spot and held talks with the aggrieved villagers. ## No Longer News

ews is defined as "information about a recent event or recently changed situation." There is something missing in the definition and that is the filter that is applied to news. Things that are more important, more interesting, more relevant tend to get picked by news editors and news producers over things that are either seen as less interesting, less important or less relevant. Stories move from the front page to the inside pages and then, if similar incidents keep coming, they no longer become 'news'.

In the second part of the BBC documentary that this government is upset with I said something about the category of violence we call beef lynching. In all of my decades in journalism I had not come across a story of a beef lynching, and almost all of the violence on this issue has come to us after 2015. It was triggered by speeches made by the Prime Minister against what he called the 'pink revolution' and then the criminalisation of the possession of beef by BJP states, starting with Maharashtra and Haryana, trig-

The question is has that spate of violence ended? On 6 February a headline read "Many lynched by mob in Assam, locals protest arrests". The dead man, a Muslim, was accused of stealing a cow. This story did not make it to the news channels and there were no debates on it. There is no point in

trying to convince them to do this. One can assume this is because media no longer thinks lynching of this sort is important or interesting or relevant.

The same day another story was reported with the headline "94% acquittal rate under Haryana's cow slaughter law in Muslim-dominated Nuh". One need not get into the details except to say that it is clear that the police is being used to victimise minorities. Another story, this time from Gujarat, came into prominence recently though it is from an event three months ago. A 22-year-old man was given life in jail because he was transporting cattle. Stories reporting this carried headlines which were quotes from the judge who gave the sentence. One was: "Religion is born out of Cow: Problems on Earth will be solved the day cow slaughter is stopped: Gujarat court"

The reason it took so long for the story to come out in English was that the judgement was passed in Guiarati and the local media for whatever reason did not take interest in the story. If reported it was likely on the inside pages because, once again, such things are no longer important, interesting or relevant. The interesting thing about all of these cases is the laws in which

the burden of proof is reversed and the State presumes guilt rather than innocence. In the case of the 22-year-old, the law says that anyone found transporting a cow without a certificate from the government would be considered as guilty and carrying it for slaughter, "unless the contrary is proved thereto to the satisfaction of the concerned authority of officer".

The important thing here is not the judge's observations but the fact that on the face of it the judgement appears to be valid. If we write up and pass laws specifically to harass then we must not be surprised by the results they

In 2019, a man in Gujarat, a Muslim again, was accused of slaughtering a calf and serving it at his daughter's wedding. The police could not prove that this had happened but they did not have to prove it. The law requires the accused to show that the meat consumed days or weeks or months earlier was not beef. This of course he could not do, and so the judge sentenced

This was later reversed by the high court, which did not give any reason other than to say that it was using "judicial discretion". It is possible that the high court was embarrassed or uncomfortable by what was being done. But again, the fact is that the judge who sentenced the man was only fol-

Now let us move past the incidents, if we can, and look at the larger picture. Are we, are the media having a debate on these laws themse which are absurd and designed to target and harm? This is a rhetorical question of course. There is no interest in such things and they have been going on now for far too long for us to assume that any interest will come. We are all right with inflicting cruelty on others and inflicting absurdity on all of

What does this say about our society and our democracy? This is a deeper question but it doesn't have easy answers. Not many modern democracies have gone down this path before, setting it upon themselves to use law and media to target citizens.

It cannot be that there is no damage to our social fabric, and because of social media one is aware of the anxiety and trauma of the minorities as they face this onslaught.

The end-state that we are heading towards with this ideology, as I have written often before, is only more of the same. What has been happening over the last few years will continue to happen, but we will hear less and less of it because it is no longer news.

It's not a mistake for forward, though a typing error in an e-mail brought it to mind. The first part of this archaic word could at one time stand alone. Fro is based on Old Norse frá, from which we also get from. We now know it only in to and fro, which is a scaled-down form of the Middle English come toward and go froward. Froward means leading away. Old English also had fromward in the same sense, though they later diverged. Fromward retained its literal sense of direction — until it died out in the eighteenth century — whilst froward moved to the metaphorical. By the fourteenth century, froward was attached in particular to a person who figuratively moved away from others by doing the opposite of what was asked of them or what other people thought reasonable. A froward person was hard to deal with obstinate, peevish, perverse or childish. Indeed, a difficult child was often said to be froward: Human Life is, at the greatest and the best, but like a froward Child, that must be play'd with and humour'd a little to keep it quiet till it falls asleep (An Essay on Poetry by Sir William Temple, 1690). That sense remained until froward slipped out of daily use in the latter part of the nineteenth century. If you read it today in a newspaper it's either in a quotation from an old work or a misprint for forward.

## **BLUEPRINT FOR EMPOWERMENT**

THE **EXTRAORDINARY SUCCESS OF WOMEN'S SELF-HELP GROUPS** IN INDIA **REPRESENTS ONE OF THE BEST-CASE OUTCOMES** 

s we embark on a new year, I have been reflecting on "resolutions," and more specifically, what it takes for an individual or a society to be resolute in a world of endless challenges and obstacles. Throughout my career, I have seen many examples of triumph against the odds - extraordinary accomplishments that often begin with a small group of individuals seeking to solve a problem. In the best cases, local communities, government, and the private sector align and invest in programmes and policies that create more opportunities for these groups to flourish.

The extraordinary success of women's self-help groups in India represents one of the best-case outcomes. Established by women determined to build a brighter future for themselves and their families, these groups have thrived thanks to innovative financial and infrastructure support from the Indian government. With over 80 million women participating in 7.5 million such groups, India is fostering the world's largest community development programme, which is now a key component of the country's economy.

Women, especially in rural areas, face gender-based barriers to participating fully in their communities and building a livelihood: Many, unable to open a bank account or access credit, are dependent on informal loans from relatives, friends, or money lenders. Moreover, traditional family structures and social norms may constrain women from engaging in activities necessary to start or expand a small business.

Self-help groups were first formed in the mid-1980s to address these barriers by providing access to savings and credit so that women could earn a livelihood and lift themselves and their families out of poverty. The results speak for themselves: women's self-help groups have contributed to India's extraordinarily sharp reduction in poverty, from 55.1% to 16.4% (415 million people), over

the last 15 years.

Initially, new groups were dependent on members, though often impoverished, pooling what little money they had to get started. The Indian government stepped in to alleviate this hardship by providing unsecured loans without the need for a formal, registered business entity. Importantly, these loans are offered at a very competitive interest rate of 12%, which drops to 7% if a group repays its loans within 30 days of the due date. With this support, the average self-help group was able to borrow around ₹200,000 (\$2,500) each, and in 2021 the limit for collateral-free loans was increased from \$10,000 to \$25,000.

Over the past decade, more than \$60 billion has been made available to self-help groups in India and, cumulatively, women in these groups have saved an estimated \$6 billion. Access to low-interest loans continues to help an increasing number of women create sustainable sources of income, accumulate assets and savings, and build financial security. And individual group members are building more than their financial skills; they are also raising their selfconfidence and influence within the community.

For example, a self-help group in Chak Singar Barari village in Bihar state was able to structure their enterprise so that each member is sent home with ₹3.000-4.000 per month. And each woman has her own story: Sunila Devi enrolled her children in private schools, Chitrekha Devi is working toward a bachelor's degree, and Pushpa Devi has started her own ambitious business renting mobile sound systems, which allows her to employ others.

Now multiply those stories by millions, and you can begin to grasp the full effects of these groups. As each woman contributes more to the household income, she gains more say in household decisions. And collectively, they show what is possible when one of the most essential challenges to gender equality – increasing women's economic power – is addressed.

Ultimately, we know that increasing a woman's economic power bolsters her personal agency and empowers her to play a greater role in her family and in her community. India's government-supported self-help groups demonstrate the transformative effects of policy initiatives that are designed to meet the needs of marginalised women. The task now is to repli

The goals should be clear: In this case, to make credit accessible and affordable, build women's financial skills and credit history and strengthen their financial se curity. And the various players must be resolute in their support. The closer you look at the details of the self-help groups in India, the more you see the dedication it took from all stakeholders – across economic sectors, states, and organised interest groups – to bring together the people, resources, and tools needed to succeed at this scale. Government agencies at both the federal and state levels were involved, along with banks and other financial institutions, re searchers, and an extensive network of non-government and voluntary organisation partners working at the grassroots level in communities across India.

This formula of determination, collaboration, and political will can be applied to other stubborn barriers to gender equality. One of the more persistent challenges I hear from women, most recently during a visit to Dakar, Senegal is that entrepreneurs also need business development services skills-building, and access to markets and value chains. India's programme shows that this is feasible: Currently about 20% of self-help group members have these additional supports, and efforts are underway to promote women-owned cooperatives and

businesses. Everyone deserves the chance to live a healthy and productive life. My resolution for this year is to remain inspired by the determined efforts of individuals and by our collective capacity – as India's selfhelp groups' remarkable success have demonstrated - to innovate as we strive for a healthier, happier, more equitable world.

## Troubling trends in education

ON AN AVERAGE **ONLY 10% OF TOTAL EXPENDITURE IS EARMARKED** BY MOST STATES FOR EDUCATION

The NEP 2020 rightly recoging 2018, it has come down to 25% in school education in Anganwadis relation with Human Development nises that education is fundamental in achieving full human potential and development of an equitable and just society. Five years earlier the SDG 4 had flagged that all countries must "ensure inclusive and equitable quality education and promote life long learning opportunity for all. PRATHAM, a well-known NGO, has been bringing out the Annual Status of Education Report (ASER), a comprehensive report highlighting the achievements of different states in terms of enrolment, learning outcomes and facilities as against the various milestones earmarked by the RTE 2009 Act. The recently released ACER takes into account 616 districts, 1.9 lakh villages and around 7 lakh children. Some of the interesting findings have been that in terms of enrolment there has been hardly any reduction. In terms of attendance there are interesting inter-regional differences, with southern and western states having attendance of 80%, central and north-central states 50-60% and eastern states 60-70%.

There has been a dramatic drop in percentage of children going to private schools. As against 30.9%

2022 clearly showing that due to the economic distress during the pandemic, many parents from lowincome categories have shifted their children from private to government schools.

Despite supply of textbooks to government schools and complete involvement of parents to help out children, learning outcomes show distressing trends. In terms of the ability of reading by a grade III student of a grade I book the percentage has dropped from 27.2% to 20.5%. In terms of a grade III child's ability to subtract, the per centage has gone down from 28.1% in 2018 to 25.9% in 2022. This clearly shows the sharp dip in learning outcomes which was already at very low levels.

In terms of facilities, the percentage of usable toilets has gone up from 74% to 76% in 2022, while 56% of schools still don't have a proper library and 92% don't have access to computers. In Kerala. 20% of schools have computers, while in Odisha only 5% of schools have. Mid-day meal shows a robust trend of around 89% students being provided with hot, hygienic food.

The NEP 2020 had suggested that there is a need to integrate pre-

with school education in public schools, with age 3 to 8 being considered as an integrated foundational stage for every child. The report noted with concern that the 27 lakh Anganwadi workers working in 14 lakh centres have to render 6 different services to children including nutrition, basic healthcare and preschool education. It notes with dismay that only 40% of these children are actually enrolled in Anganwadis for early childhood education. The quality of learning leaves a lot to be desired. From the Kothari Committee

recommendation in 1968 that 6% of GDP should be allocated to education, and Prof Amartva Sen's fervent calls to earmark a significant allocation for capability development, the current spending by the Centre and states shows a disturbing fixation at around 3.5% of GDP. On an average only 10% of total expenditure is earmarked by most states for education. Kerala and Delhi are outliers in this regard and spend close to 17-18% on improving school infrastructure and quality of training of teachers. Prof Lekha Chakravarty empirically shows that allocation to education has a better positive corIndex than focusing on GDP growth.

Unless informal learning seamlessly segues into formal learning and the child by the age of 8 has basic foundational literacy and numeracy skills, the concept of demographic dividend is likely to degenerate into a demographic disaster.

Many discerning observers believe that there are deep structural issues in our school education. The curriculum is often over ambitious and teachers illequipped to ensure that most children are in sync with the curriculum and the learning expectations. Given the fact that nearly 75% of children are getting left behind in our govt schools, there is a necessity to introduce catch up interventions in our public schools on an urgent basis.

The ASER 2022 report is a timely warning to the government to allocate enough for school education, rev up its quality to achieve universal foundation in literacy and numeracy and pave the path for a just and equitable India.

Non-platform employees are the ones who work elsewhere than on these platforms. Construction workers, regular employees, and temporary workers without a technical focus are mainly included in this group. The government has also been considering methods to expand and assist the gig economy in the nation, and there may soon be a programme to provide loans to gig workers and budding businesses. As more people want to work flexibly, the gig economy is constantly growing. The entire ecosystem can benefit from the government's policies. ## Delhi LG, AAP govt's tussle intensifies

New Delhi, Feb 11: Delhi's Power department has removed the Arvind Keiriwal government's four nominees, including AAP leader Jasmine Shah, from the boards of power discoms and replaced them with senior officials, on the directions of Lieutenant Governor V K Saxena.

The action triggered a fresh confrontation between the Raj Niwas and the AAP government, with Deputy Chief Minister Manish Sisodia terming the move "illegal, unconstitutional and contrary to the procedures" and ac-

cusing the lieutenant governor of not following the Constitution and Supreme Court orders. Sources at the Raj

Niwas said on Saturday that besides Shah, a spokesperson of AAP, Naveen Gupta, the son of AAP MP N D Gupta, and other private persons "illegally" appointed as "government nominees" have

been removed. The Power department of the Delhi government issued an order removing the four nominees on

Friday, following directions from LG Saxena The lieutenant governor's directions for removal of the government nominees came as an interim measure since the issue was referred by him for approval of the President which is still

pending. The ruling Aam Aadmi Party in a statement said the lieutenant governor does not have the power

to issue such orders. The sources at the LG's office,

meanwhile, said the finance secretary, power secretary and the MD of Delhi Transco will now represent the city government on the boards of the discoms.

AAP, however, said only the elected government has powers to issue orders on the subject of electricity.

Gaud was a resident of Padampur area in Kotdwar in Pauri district. His clothes had been found on Friday."We inform with sorrow that the mortal remains of Shri Vijay Kumar, an Indian national missing in Turkey since February 6 earthquake, have been found and identified among the debris of a hotel in Malatya, where he was on a business trip," the Indian embassy in Turkey tweeted.

Gaud's wife and son, who were

hoping against hope for some positive news, were inconsolable as their worst fears had come true. Friends and relatives flocked to Gaud's house to express their con-

dolences to the bereaved family. His body will first be flown to Istanbul and then taken to Delhi.

It may take three days for his body to reach Kotdwar, family sources said quoting Indian embassy officials.

"Our deepest condolences to his family and loved ones. We are making arrangements for the earliest possible transportation of his morbassy said on Twitter.

Gaud worked for Oxy Plant India Pvt Ltd and was on an official assignment, his elder brother Arun Kumar Gaud said."His phone rings but no one responds," Arun had said after his brother went missing. His wife and six-year-old son had last talked to him on the phone on February 5 and he was to return to

India on February 20, he had said. The Ministry of External Affairs had said Wednesday that an Indian was missing and 10 others were stuck but safe in remote regions following the quake. The number of Indians residing in Turkiye was around 3,000, out of which about 1.800 live in and around Istanbul. while 250 were in Ankara and the rest were spread all over the country, according to officials.

The hotel where Gaud was staying collapsed on the morning of February 6 when the 7.8 magnitude earthquake hit Turkey leaving behind a trail of death and destruction. Over 23,000 people have died in the region due to the temblor.

## Haryana bans jeans, makeup for medical staff

Chandigarh, Feb 11: Makeup, "funky hairstyles", and long nails are out for medical and other staff at Haryana government hospitals, and so are T-shirts, denims and skirts, as the state is going to implement a dress code for healthcare professionals. Haryana Health Minister Anil Vij said Friday the dress code being prepared by the state government is in final stages.

The move to ban certain types of dresses drew mixed reactions from the medical fraternity with a doctors' body in Ambala asserting implementing a dress code would give staff a professional outlook, while a nurses' association said the government should have taken its opinion too.

Vij said dress code must be adhered to by the on-duty staff 24 hours a day, including on weekends, evenings and night shifts, he said, asserting the erring employees will be marked absent for the day. He said a hospital requires its employees to follow certain con-

duct, and a dress code is an essential component which gives the organisation a "professional touch".

'Funky hairstyles, heavy jewellery, accessories, makeup, long nails during working hours are unacceptable, especially in the healthcare centres," said minister Vij, a BJP leader. He said jeans of any colour, denim skirts and denim dresses are not considered professional dresses and, therefore, will not be permitted. The employees will have to wear a name badge declaring their designation.

"Sweatshirts, sweatsuits, and

dresses, skirts and palazzos shall not be permitted too. T-shirts, stretch T-shirts, stretch pants, fitting pants, leather pants, capris, sweatpants, tank tops, see-through dresses or tops, crop tops, off-shoulder dresses, sneakers, slippers etc will not be permitted. Similarly,

shorts are not permitted. Slacks

footwear must be black, clean, comfortable and free from funky de-

signs," the minister added.

A formal order to ban these dresses has not been issued yet. The purpose of the dress code policy, Vij said, is to maintain discipline, uniformity and equality among the staff in government healthcare centres

"A well-followed dress code policy in a hospital not only gives an employee his professional image but also presents an elegant image of an organisation among the public," he said. All hospital staff working in clinical roles (medics and paramedics), cleanliness and sanitation, security, transport, technical, kitchen, field and other departments should be in a proper uniform during their working hours, the minister said.

Employees looking after nonclinical administrative work in hospitals shall wear only formals, said Vij. "Every employee is expected to wear neat, clean dress and practice good hygiene.'

"Hair must be clean, wellgroomed and neat. Men's hair should be no longer than collar length and should not interfere with the patient's care," he said."Unusual hairstyles and unconventional haircuts are not permitted. Nails must be clean, trimmed and well-manicured," the

## Bengal gears up to increase vulture population

Kolkata, Feb 11: With the vulture population in West Bengal decreasing at a very fast pace, the state Forest Department has undertaken an unique initiative to increase the population of these nature's scavengers.

According to a Forest Department official, the unique method will be applied at the state government-run vulture breeding centre at Rajabhatkhawa in Alipurduar district.

"This unique method of breeding is the double clutching system. Generally, the female vulture lays one egg in a year, which is a major reason for the decline in the vulture population. But under the double clutching system, the first egg she lays will be taken away and stored in an incubator. This will prompt the female vulture to lay the second egg and in this process, the breeding count will be doubled," the official said.

He said that there is a similar artificial vulture breeding centre at ON FRIDAY, THE STATE SPECIES OF VULTURES INTO THE WILD 13 WERE ORIENTAL WHITE-BACKED VULTURES, RIFFON VULTURES

Haryana's Pinjore, which was the first to adopt this double clutching system to increase the vulture population there. "This was a great success story and inspired by them the state Forest Department has decided to adopt a similar process at the Rajabhatkhawa vulture breeding centre. Dialogues have started with the experts in the field at Pinjore to get technical assistance on this count," the offi-

cial said. On Friday only, the state Forest Department released 20 endangered species of vultures into the wild. Out of the 20 vultures released, 13 were oriental whitebacked vultures, while remaining seven were Himalayan griffon vultures. While the oriental white-backed vultures were bred at the Rajabhatkhawa vulture breeding centre, the Himalayan griffon vultures were rescued from time to time.

#### 13,500 houses connected with running water taps in Kargil

Kargil/Jammu, Feb 11: More than 13,500 households have been connected with functioning water taps under the centrally-sponsored Jal Jeevan Mission (JJM) in Kargil district of Ladakh, an official spokesman said Saturday.

The information was given at a meeting chaired by Additional

Deputy Commissioner, Kargil, Ghulam Mohi-Ud-Din Wani as he reviewed the progress on JJM projects

in the district, the spokesman said. "Till January 2023, as many as 13,506 households have been connected with FHTCs in Kargil. In 2019, before the start of JJM, only 1.610 households in the district had tap water," the spokesman said.

He said that in the meeting the

officials reviewed the status of JJM scheme and discussed strategy for "improving Functional Household Tap Connections (FHTCs) coverage, installation of solar water heaters in schools, 100 per cent saturation of villages, and availability of material.'

Wani also reviewed the physical and financial progress on all JJM projects in the district, and tap connection in schools and anganwadi centres, the spokesman said. The spokesman said work on

544 connections has been completed across schools, while 35 connections are pending.

The officials have been directed to restart the work on installation of solar water heaters in schools as soon as the snow recedes.

## 'Lithium reserve found in J&K is of best quality'

VILLAGES AROUND THE SITE ARE EXCITED AT THE DISCOVERY

Jammu, Feb 11: The country's first lithium reserve, found in Jammu and Kashmir, is of the best quality, a senior government official said here Saturday, as upbeat villagers expressed hope the discovery will bring them a bright future.

The 5.9-million tonne reserve of lithium, a crucial mineral for the manufacturing of electric vehicles and solar panels, had been discovered in Reasi district by the

Geological Survey of India (GSI). "Lithium falls in the critical resource category which was not earlier available in India and we were dependent for its 100 percent import. The G3 (advanced) study of the GSI shows the presence of best quality lithium in abundant quantity in the foothills of Mata Vaishno Devi shrine at Salal village (Reasi),' J-K Mining Amit Secretary Sharma told PTI.

He said against the normal grade of 220 parts per million (PPM), the lithium found in J&K is of 500 ppm-plus grading, and with a stockpile of 5.9 million tons, India will surpass China in its availability

"India joined a select group of countries at the global level after this finding and it will fulfil the vision of Prime Minister Narendra Modi's 'Aatmanirbhar Bharat' (selfreliant India)," he said.

Sharma said lithium has wide spread usage and its discovery at a time of India's G20 presidency provides an opportunity for J-K to showcase its rich reserves.

Asked about the possible timeline for its extraction to start, he



"We had G3 level study and it will now be followed by G2 and G1 study before the final extraction of the metal.'

"Everything will be done at the earliest and we will collaborate with the GSI and extend our full support in this historical feat," he said. The officer assured the people that the reserve will be a gamechanger for them as the local youths are given preference in any project as per the government's industrial policy.

"The local youth, whether skilled, semi-skilled or unskilled, will be part of this project. People who will be affected by this project will be adequately compensated and rehabilitated under rules," he said.

People living in the villages around the site are excited at the discovery. "It is a very happy moment for all of us and we are feeling proud. After the railway projects and Mata Vaishno Devi shrine, which are major sources of employment for the locals, this project is going to be a game-changer for us," Salal Deputy Sarpanch Rajinder Singh said.

Salal is home to the Salal Hydroelectric Power Station, a run-of-the-river hydropower project on Chenab river. Salal is located on way to under-construc-

tion paradigmatic Chenab railway bridge with a height of 359 meters, 30 meters higher than the iconic Eiffel Tower in Paris.

Jaspal Singh, another villager who claimed to have worked as a labourer with the GSI survey team, said they surveyed the hills for the last two years and returned about three months back.

"We are feeling lucky to be part of this project which will generate ample employment opportunities for the locals. We salute the hard work of the survey team especially given the challenging situation during the outbreak of corona pandemic," he said, adding "one of the team members died during the survey.

Senior Democratic Azad Party leader (DAP) and former minister Jugal Kishore Sharma congratulated the people for the finding of the lithium reserve and urged the government to ensure that the local vouth be given employment in the project.

"The industry for excavation of the metal should be set up in Reasi and the local people should be engaged," the former member of legislative assembly from Reasi said

He said there is also a need for fully exploring the lower Himalayas across Jammu and Kashmir.

## Mandaviya spars with DMK MPs over medical colleges issue

When DMK MPs Dayanidhi Maran and K. Kanimozhi protested. the Health Minister said that as the Tamil Nadu government didn't allot land on time, the infrastructure for Madurai AIIMS couldn't be completed on time.

When DMK MPs protested, members from the treasury benches also got up from their seats and both sides could be seen arguing.

At this, Mandaviya said that as he had taken action against many medical colleges in Tamil Nadu, which were functioning without proper infrastructure, it (the protests by DMK MPs) was a reaction to that action.

The Health Minister further informed the Lok Sabha that as AIIMS Madurai was a project funded by Japan International Cooperation Agency (JICA), and their representatives could not visit India during the last two years owing to the pandemic, the project's cost had gone up to Rs

DMK MPs alleged that the minister was threatening them, to which Speaker Om Birla said that the minister had not hinted at anybody specifically, and was mak-

ing a general observation. Birla further assured an agitated Baalu that he would look into the matter regarding removing the comments by the minister from the records.

## Madras HC allows RSS march in TN

marches. Senior functionaries of the organisation will sit and finalise this and let you know on

It may be noted that the Tamil Nadu government had not given permission to the RSS route marches to be held during the Vijayadashami day celebrations.

Citing law and order situation, the police had denied permission to the route march. The police stated that after the ban of the Islamist organisation, Popular Front of India (PFI), the route march could cause some communal disturbances affecting law and order situation.

A single bench of the Madras

High court had allowed the RSS to conduct the marches but within compound walls and the organisation had filed an appeal against this before the division bench.

The court in its order Friday (February 10), said, "The state's approach towards citizens' rights can never be adversarial in a welfare state and it must be considered for granting permission for peaceful rallies, protests, meetings or processions so as to maintain a healthy democracy.'

The division bench had set aside the single judge bench order of November 4, 2022, restricting the route marches within the compound premises.

## Stalin miffed over Gadkari's 'non-cooperation' remarks

Chennai, Feb 11: Tamil Nadu Chief Minister MK Stalin Saturday wrote to Union Minister for Highways and Roads Nitin Gadkari, expressing disappointment on the BJP leader's statement "for completion of road projects, the Central government requires the cooperation of the state government.

Srinagar, Feb 11: With conservation efforts going on in Asia's second largest freshwater lake in Kashmir's Bandipora and Baramulla districts, the Smew - scientifically known as Mergellus albellus and the Long-tailed Duck, a rare duck species found in European and American continents and assessed as highly vulnerable on the International Union for Conservation of Nature Red list. were among the new sightings in the lake after over 80 years.

The rare sighting of new species has enthralled bird watchers, while the authorities expressed delight.

Wular Conservation and Management Authority (WUCMA), Irfan Rasool, said: "Besides these sightings, many new migratory bird species are expected to be seen in Wular as the Wular restoration plan is bearing fruits with process going on large scale besides public



awareness playing significance

role in going with the mission.' "A group of five ducks were seen foraging in Wular lake January 22 by WUCMA field officials and they recorded the details on their field book and captured camera pictures of ducks," he said.

The pictures were shared with ornithologists for identification and it was discovered that the birds are, in fact, rare migrants known as "Long Tailed Duck", Rasool said.

The last record of this bird was

reported from Hokersar lake, Kashmir in 1939 as mentioned by F. Ludlow in a research paper published in 'Journal of the Bombay Natural History Society'.

It is after 84 years that the bird has been spotted again in Kashmir and has been documented now. There are only a few sites in India which meet the '1 per cent criteria' necessary for the survival and propagation of this duck species, Mudasir. a local resident, said.

Much to the delight of ornithologists, the eco-restoration of Wular lake has created a ray of hope, as record number of migratory birds have visited Wular lake, this year, Mudasir said, adding that the rare sightings have been of common pochard, red crested pochard and long tailed duck apart from other common water birds normally seen in other wetlands.

Mudasir said the Smew is another species of duck and is the only living member of the genus mergellus. A female pair of these birds was photographed by Showkat Ahmad, a staff of WUCMA along with Ansar Ahmad an avid birder from Wular Lake, he said, adding the last found record of this migratory bird in Kashmir was in 1907.

Many internationally and nationally reputed bird photographers are thronging the lake to capture these rare sightings of migratory birds. "Along with the longtailed duck, common pochard, redcrested pochard, common shelduck, ruddy shelduck, and other birds which share Wular Lake's habitat, have been sighted after long," Ahmad added.

Recently, during the Wular Festival, the Divisional Commissioner, Kashmir, Pandurang Kundbarao Pole said that the government is going to construct a non-motorable walkway around-Asia's famed Wular Lake in Bandipora district.

They have been booked under various IPC sections, including 222 (intentional omission to apprehend on the part of public servant bound to apprehend person under sentence or lawfully committed), 186 (Whoever voluntarily obstructs any public servant in the discharge of his public functions...), 506 (criminal intimidation), 201 which deals with tampering with evidence, and 120B (criminal conspiracy).

The police also recovered some Saudi Arabian currency from Ansari's wife. The SP said that Nikhat Ansari was taken into custody, and after investigation, the accused prisoner officials are also likely to be arrested.

Last Saturday, while discharging the 11 accused in the other case, the judge had said that legal proceedings were initiated in a "perfunctory and cavalier fashion" and "allowing them to undergo the rigmarole of a long-drawn trial, does not augur well for the criminal justice system of the country".

Delhi Police had registered an FIR in connection with the violence that erupted after a clash between police and people protesting against the Citizenship Amendment Act (CAA) in December 2019.

The enforcement action came following a surveillance inspection conducted by the DGCA on the airline during November 23-25 last year and subsequent show cause notice to the airline, its head of training, and all DEs.

## Population, infrastructure 'root causes' of sinking Joshimath: IUCN

New Delhi, Feb 11: While India's disaster preparedness and response has improved, the fragility of the Himalayas and the increase in population and infrastructure are at the root of crises like the Joshimath incident, senior officials at the International Union for Conservation

of Nature (IUCN) said. Authorities in Uttarakhand have declared Joshimath in Chamoli

district a landslide and subsidencehit zone. Wide cracks have appeared on residential and commercial buildings and roads and fields in the town renowned as a hiking and pilgrimage destination. A number of structures have been declared unsafe and residents shifted to safer places. "Whether it is flash floods, cloud

bursts or incidents like Joshimath,

it is partly because of a combina-

tion of issues. The increase in

human population and infrastructure to cater to tourists and the fragility of the Himalayas are at the root (of it)," Yash Veer Bhatnagar, country representative of IUCN India, said in an interview. "As conservationists, we do not want to stop development everywhere. We want to make it as sustainable as

possible, knowing well that remote villages in the Himalayas need basic amenities," he asserted.

Satellite images released by the Indian Space Research Organisation showed the Himalayan town sank 5.4 cm in just 12 days following a possible subsidence event on January 2. Although Joshimath is built on a fragile mountain slope in a region prone to landslides, its sinking is being attributed to large-scale development projects being undertaken there

IUCN India and the TCS Foundation have launched an initiative, "Himalaya for the Future", which aims to enhance sustainability and the well-being of the people in the Indian Himalayan Region (IHR) and downstream communities. It involves reviewing existing initiatives, research and literature; mapping and consulting with stakeholders, building scenarios to identify possible interventions and developing a tool for quantitative and qualitative modelling.

"We are designing a tool which looks at cross-cutting areas such as forests, urbanisation, water resources, energy, infrastructure, gender, migration, traditional knowledge, disasters among others," Archana Chatterjee, Programme Manager, IUCN India, said.

'We wanted to look at these issues in an integrated manner... And what are the challenges emerging in the region for which we have to plan now in terms of policies and programmes." she added.

It is an open and evolving model. Technical studies and mind maps of experts and communities can also be fed in it. The tool, for example, will help people know how a policy decision for the tourism sector can impact forests, water resources, waste management and other aspects, Chatterjee said.

Bhatnagar said though there has been some criticism. India hasimproved a lot in terms of disaster preparedness and response.

#### Indians abused

London: A UK government investigative agency for labour exploitation has said that it has succeeded in getting a court order against five people from Kerala for suspected labour abuse of more than 50 Indian students, Investigators from the Gangmasters and Labour Abuse Authority (GLAA) were granted a Slavery and Trafficking Risk Order (STRO) indefinitely against the defendants at Mold Magistrates' Court last week.

The GLAA said in a release that its probe identified "more than 50 Indian students as being potential victims of modern slavery and labour abuse over the last 14 months" while working at care homes in North Wales

#### Secret docus saga

Washington: The FBI found an additional classified document at the property of former vice president Mike Pence Friday, two weeks after the Republican acknowledged having a "small number" of government files at his hom Pence's spokesman Devin O'Malley said that agents had turned up the material in a "thorough and unrestricted" five-hour search of the Carmel Indiana house, conducted with Pence's consent. The search came after Pence, who is weighing a run for the presidency in 2024, reported last month that an aide had uncovered classified papers, likely taken with other material when he left the White House in January 2021. That followed searches of the homes of President Joe Biden and former president Donald Trump that also turned up classified documents.

#### Man lynched in Pak

Nankana Sahib: A 35-year-old man, who was arrested on blasphemy charges, was lynched Saturday in Pakistan Puniab's Nankana Sahib district after a mob broke into the police station where the victim was being held, media reports said. According to reports, the victim was accused of desecrating the Holy Quran while the locals claimed he was involved in 'witchcraft'. The Express Tribune reported. Following the accusation, he was handed over to the local police. However, a mob later gathered at the police station soon after news of the incident spread in the area, the report said.

#### Spy balloon drama

Beijing: The United States blacklisted six Chinese entities it said were linked to Beijing's aerospace programs as part of its retaliation over an alleged Chinese spy balloon that traversed the country's airspace. Ankara, Feb 11: Rescuers pulled children and the elderly from the rubble Saturday as miraculous survival stories coincided with hasty mass burials five days after an earthquake devastated parts of Turkey and Syria, leaving more than 25,000 dead.

Tens of thousands of local and international rescue workers are still scouring through flattened neighbourhoods despite freezing weather that has compounded the misery of millions now in desperate need of aid. However, amid the destruction and death, survivors continue to emerge.

Compounding the anguish, the United Nations has warned that at least 870,000 people urgently need of hot meals across Turkey and Syria.

Turkey's disaster agency Saturday said nearly 32,000 people from Turkish bodies are working on search and rescue efforts. In addition, there are 8,294 interna-

#### Turkey-Armenia gate opens for first time in decades

A border gate between long-feuding Turkey and Armenia has been opened for the first time in 35 years to allow aid for victims of the devastating earthquakes in southern Turkey, state-owned Anadolu news agency and a diplomat said. the crossing was last used to send aid from the Turkish Red Crescent to earthquake-hit Armenia in 1988.

Five days of grief and anguish have been slowly building into rage at the poor quality of buildings as well as the Turkish government's response to the country's worst disaster in nearly a century.

Officials in the country say 12,141 buildings were either destroyed or seriously damaged in the earthquake.

Damage was to be expected, but not the type of damage that you are seeing now, said Mustafa Erdik, a professor at Istanbul-based Bogazici University.

Authorities in Kahramanmaras and Osmaniye have launched investigations into the buildings that have collapsed, according to the Anadolu state news agency.

The tremor was the most powerful and deadliest since 33,000 people died in a 7.8-magnitude tremor in 1939.

#### Erdogan in vulnerable spot before elections

Paris, Feb 11: Police were out in force across France Saturday as protesters held a sometimes restive fourth round of nationwide demonstrations against President Emmanuel Macron's plans to reform the country's pension system.

Over 960,000 people marched in Paris, Nice, Marseille and other cities. Protesters hoped to keep up the pressure on the government to back down, and further action is planned for February 16.



In the French capital, authorities counted some 93,000 participants, the most to demonstrate in Paris against the pension changes since the protests started last month.

The French spend the largest number of vears in retirement among OECD countries - a benefit which, opinion polls show, a substantial majority of people are reluctant to give up. French lawmakers began a rowdy

debate earlier this week on the pension bill to raise the minimum retirement age for a full state pension from 62 to 64. It's the flagship legislation of Macron's second term. The government has insisted it's determined to push through Macron's election pledge to reform France's generous pension system.

#### 5.3mn in Syria may be homeless

Beirut: Up to 5.3 million people in Syria may have been made home less by the devastating earthquake which rocked the region this week a United Nations official said Friday. "As many as 5.3 million people in Syria may have been left homeless by the earthquake," the Syria representative of the UN High Commissioner for Refugees, Sivanka Dhanapala, told a press briefing. He said the UN estimated that 5.37 million people affected by the quake will need shelter assistance across the country. "That is a huge number and comes to a population already suffering mass displacement," he said. "For Syria, this is a crisis within a crisis. We've had economic shocks, Covid and are now in the depths of winter." Quake survivors have flocked to camps set up for people displaced by nearly 12 years of war from other parts of Syria.

Karachi, Feb 11: Pakistan and the International Monetary Fund are to resume talks online next week they said Friday, after ten days of face-to-face discussions in Islamabad on how to keep the country afloat ended without a deal.

With the nuclear-armed nation in the grip of a full-blown economic crisis, the IMF talks are aimed at unlocking at least \$1.1 billion of stalled funding as part of a \$6.5 billion bailout signed in 2019.

Finance Minister Ishaq Dar told reporters Pakistan had agreed with the IMF on the conditions to release the funds, which have been delayed since last December.

Talks would resume virtually Monday, he added, citing "routine procedures" for the delay. "We will implement whatever has been agreed upon between our teams," Dar said. Pakistan is in dire need of a suc-

cessful outcome. The \$350-billion economy is still reeling from devastating floods last year, and the government estimates rebuilding efforts will cost \$16 billion.

The heavily-indebted nation only has enough foreign reserves to cover less than three weeks of crucial imports. The longer it takes for the IMF tranche to be paid out, the higher the risk of default, analysts say, especially with elections also looming.

FOREX RESERVES: Pakistan's foreign exchange reserves have fallen to the lowest level in 10 years and cover only three weeks' worth of imports. In the week ending February 3, the central bank's foreign currency reserves shrank to \$2.917 billion, down \$170 million from the previous week.

INFLATION: Inflation has averaged a record 25.4% in the seven months of the current fiscal year starting July versus 10.3% in the same period of the previous year. The consumer price index rose 27.5% year-on-year in January, its highest in nearly half a century.

**CURRENT ACCOUNT DEFICIT:** Pakistan's current account deficit shrank to around \$400 million in December 2022 from \$1.9 billion a year earlier, as the government slashed imports in a bid to avert an external payments crisis.

# SHOCK OF WAR World economy at crossroads

**ECONOMIC SANCTIONS ON MOSCOW CAME AS HURDLES TO WORLD TRADE WERE** MOUNTING AFTER AN ERA OF RAPID GLOBALISATION

Washington, Feb 11: A year of war in Ukraine has already made a dent in world prosperity. But its deeper impact will be felt in how the conflict plays into shifts that were already reshaping the global economy before Russia's tanks rolled in.

Most immediately, the war added new uncertainties to the economic trauma of a Covid-19 pandemic that had already led to record rises in public debt, inflation-fuelled cost-of-living crises, and labour shortages in essential sectors.

Russia's weaponisation of its gas and oil exports bolstered the case for an energy transition already made urgent by climate change.

The war has devastated Ukraine's economy, shrinking it by a third, while sanctions are now starting to starve Russia of revenues from energy and other exports. But it is harder to quantify its impact on the rest of the world.

European neighbours have so far avoided the mass energy rationing and wave of bankruptcies that were feared, thanks to efforts to build up fuel stocks and rein in energy demand, and - not least - to an unusually mild winter.

Global food and energy prices were already surging as the world emerged from the pandemic lockdowns of 2020 and spiked higher after the outbreak of war, but many indices are now below their levels of a year ago.

"We find that energy prices increased more in 2021 than in 2022, suggesting that the war and the sanctions were not the most important drivers," analysts Zsolt Darvas and Catarina Martins found

Some might conclude that means the world economy has taken the conflict in its stride. Optimism prevailed at this year's World Economic Forum in Davos, while financial markets are betting that advanced economies can avoid allout recession.

But that still requires more than the record \$1.4 trillion investment in clean energy the IEA sees for 2022. For the economy, the risk is that energy prices - and hence inflation - will be squeezed higher if shortfalls are not met.

What the conflict means for global trade is also unclear.

The 2007/08 financial crisis and election victories for politicians advocating protectionism had already paused a two-decade spurt in globalisation that saw containerisation expand and both Russia and China enter the world trade system.

Now the question is whether Western sanctions on Russia which effectively cordon off what was the world's 11th largest economy - are the start of a further entrenchment as countries restrict trading partners to those they see as allies. The World Trade Organization and others see a risk that commerce splinters into hostile trading blocs, a scenario the IMF has modelled as shaving as much as 7% off global output.

One possible trigger for that could be a shift towards an extensive round of secondary sanctions targeting not only Russia but companies and investors that do busi-

## India topples France as UK's largest Scotch whisky market

60% HIKE IN IMPORTS IN 2022 OVER THE PREVIOUS YEAR

London, Feb 11: India has overtaken France to become the UK's largest market of Scotch whisky in terms of volume with a 60 per cent hike in imports in 2022 over the previous year, according to the latest figures released by Scotland's leading industry body.

(SWA) revealed Friday that India imported 219 million 70cl bottles of Scotch compared to France's 205 million last year - representing growth of the Indian Scotch market of more than 200 per cent in the past As one of the key sectors of focus

The Scotch Whisky Association

for the UK in the free trade agreement (FTA) talks with India, now in their seventh round of negotiations, SWA pointed out that the hike in volume still makes up only a fraction of the Indian whisky market due to high tariffs.

"Despite double-digit growth, Scotch whisky still only comprises 2 per cent of the Indian whisky

market," the association said. "SWA analysis shows that a UK-India FTA deal which eases the



whisky in India could boost market access for Scotland's whisky companies, allowing for an additional GBP 1 billion of growth over the next five years," it noted.

The value of the Indian market for Scotch exports comes in at fifth worth GBP 282 million, up 93 per cent in 2021 and behind France, Singapore and Taiwan. The 2022 trend also saw the Asia-Pacific region overtake the European Union (EU) as the industry's largest regional market, with double-digit in Taiwan, Singapore and China besides India.

"During a year of significant economic headwinds and global supply chain disruption, the Scotch Whisky industry continued to be an anchor of growth, supporting investment and job creation across Scotland and the UK," said SWA Chief Executive Mark Kent.

"By reducing tariffs through the UK-India free trade agreement, continuing the duty freeze in the March budget, and ensuring the industry's continued ability to advertise our world-class product in our home market, the Scottish and UK governments can count on the Scotch Whisky industry to reinvest its success across the UK," he said.

Overall, the year 2022 saw solid growth in Scotch exports around the world, with the US holding on to its topmost position as the largest market by value at GBP 1,053 million. The total export value of Scotch whisky – one of the UK's biggest exporters – was up 37 per cent by value to GBP 6.2 billion.

UK Trade Minister Nigel Huddleston said: "Scotch whisky is one of the UK's great exporting success stories, contributing billions of pounds to the economy and supporting thousands of jobs, so I'm pleased to see these export figures showing a growing global

## Rohit stunned by Aussies' collapse

Nagpur, Feb 11: India captain Rohit Sharma won't comment on the mental fortitude of the Australian team but certainly didn't expect them to get bowled out in just one session on the third day of the opening Test, here Saturday.

"No, I didn't," is what the skipper said when asked if he expected the match to end well inside three days. "We were prepared to have hard day's bowling, spending session after session. We never thought they would get bowled out in a ses-

"As you saw, the pitch became slower and slower and there was no bounce on the pitch, so it was a bit of surprise for me," the Indian skipper said at the post-match press conference.

There was a lot of pre-match talk from the Australian media with one leading newspaper terming the Jamtha track as "systematically doctored" while other termed it "dodgy" even before a ball was bowled.

The calm Indian skipper in his own inimitable manner rubbed it in when asked if he found his team to be mentally tougher than Australia.

"I don't know the mental status of the Australian team. I can vouch for our team and we are the ones who want to play on pitches like these and not just from now, we have been playing on pitches like these for last 3-4 years," the skipper said.

He continued with his sarcastic way of saying things. "Because we have all grown up playing on pitches like these, so there is no talk about pitches anymore in the changing room.

Rohit also said that the Indian pair of R Ashwin and Ravindra Jadeja always aims to "reach the next level" while playing Tests. "He (Ashwin) looks a different bowler.
