



# **Twin murders shock the nation**

PARTNER SAHIL GEHLOT IN SOUTHWEST DELHI

New Delhi/Palghar, Feb 15: Two horrific cases of murder – one in southwest Delhi and another in Maharashtra's Palghar – have shaken the conscience of the people of the country, reminiscing the grisly murder of Shraddha Walkar by her boyfriend Aaftab Amin Poonawala last year.

In the Delhi incident, Police Wednesday retrieved the footage from CCTVs that showed 23-yearold Nikki Yadav in her rented house hours before she was allegedly killed by her live-in partner Sahil Gehlot, who stuffed her body inside a fridge in his family-owned dhaba.

Yadav's family members demanded that Gehlot be hanged to death for this gruesome act, reminiscent of the grisly murder of Shraddha Walkar by her boyfriend Aaftab Amin Poonawala who chopped her body into pieces, stored them in his refrigerator and disposed them of over a period of

The CCTV footage retrieved by the Delhi Police are from February 9. the day of Gehlot's engagement. Yadav allegedly called to meet Gehlot and express her displeasure

at his decision to get married.

A senior police officer said, "We are looking into the CCTV footage and also scanning for more to collect evidence and ascertain the sequence of events that unfolded on the day of the murder."

Yadav was allegedly strangled to death by her 24-year-old boyfriend who stuffed her body inside a refrigerator of his dhaba (eatery) in southwest Delhi and went off to marry another woman the same day, police said Tuesday.

Police said that the accused strangled Yaday to death in his car near Kashmere Gate, adding that he drove around 30-40 km to his dhaba along with her body in his car. The

car used in the commission of crime has been seized by the police. Gehlot, a resident of Mitraon village in southwest Delhi, has been arrested.

Meanwhile, Chief Metropolitan Magistrate Archana Beniwal granted the Crime Branch of the Delhi police custody of the accused for five days to interrogate him and ascertain the exact scene of the murder and the route he took after committing the alleged crime.

In the chilling incident of Palghar in Maharashtra, a 40-year-old jobless man allegedly killed his wife. hid her body in a bed, and sold off all household articles before trying

to flee by train, police said Wednesday. However, accused Hardik Raju Shah was nabbed 650 km away in Madhya Pradesh, a police official said.

According to police, Shah used to work in a call centre but was unemployed since the pandemic lockdown for many months, and his wife Megha Dhansingh Thorvi, 37, was working as a nurse to support the family.

The duo had met through a social media site three years ago, got married in August 2022 and shifted to a rented flat in Sitasadan Apartments in Tulinj area of Nalla Sopara town in Palghar district for the past six months.

Shailendra Nagarkar, from the Mira Bhayander-Vasai Virar Police Commissionerate said that after they got married last year, the couple fought almost daily as Shah did not get any work, leaving the entire burden of household expenses on his wife.

After one such bitter domestic brawl February 11, Shah - who is the son of a Mumbai diamantaire - allegedly assaulted and killed her in a fit of anger, dumped her body inside the bed, and planned

## Bird flu spreads to new countries

Chicago, Feb 15: Avian flu has reached new corners of the globe and become endemic for the first time in some wild birds that transmit the virus to poultry, according to veterinarians and disease

Wild birds are primarily responsible for spreading the virus, suggest experts. Waterfowl like ducks can carry the virus without dying and introduce it to poultry through contaminated feces, saliva and other means.

Outbreaks of the virus will not abate soon on poultry farms, ramping up threats to the world's food supply. Outbreak of the virus has continued in North and South America, Europe, Asia and Africa. The United States, Britain, France and Japan are among countries that have suffered record losses of poultry over the past year, leaving

some farmers feeling helpless. Farmers' best efforts to protect flocks are falling short. They are trying unusual tactics to protect poultry, with some using machines that make loud noises to scare off wild

birds, experts said While the virus can infect people, usually those who have contact with infected birds, the World Health Organisation says the risk to humans is low.

Such infections of "resident" birds are helping the virus to persist throughout the year when it didn't previously, he said.

## 2,674 challans issued to vehicles without high security plates

"In case a vehicle is not affixed with HSRP within the scheduled date, echallans with a fine of ₹5,000 or ₹10,000 are being issued against the offending vehicle under the Section 192 of Motor Vehicle Act, 1988," Sethi said.



# Lung abnormalities in patients 2 years after Covid

hest CT scans revealed persistent lung abnormalities in patients two years after Covid-19, according to a new study.

Globally, more than 600 million people have recovered from Covid-19, but concerns remain that some organs, especially the lungs, may suffer long-term damage after infection, the study said.

This is the first research paper with two-year follow-up data on Covid-19 lung effects, it said. It is published in the journal Radiology.

According to the paper, Qing Ye and Heshui Shi from Tongji Medical College of Huazhong University of Science and Technology in Wuhan, China, and colleagues set out to assess residual lung abnormalities in patients up to two years post-Covid-19 pneumonia.

They also looked at the correlation between residual lung abnormalities and changes in lung function, the study said. In this prospective study, it said,

144 patients, 79 men and 65 women with a median age of 60, discharged from the hospital after SARS-CoV-2 infection between January 15 and March 10, 2020, were included. Three serial chest CT scans and

pulmonary function tests were obtained at six months, 12 months and two years after symptom onset. the study said.

Residual lung abnormalities after discharge from the hospital included fibrosis (scarring), thickening, honeycombing, cystic changes, dilation of the bronchi, and



more, the study found

The study also found that over two years, the incidence of lung abnormalities gradually decreased. At six months, 54 per cent of patients showed lung abnormalities.

On two-year follow-up CT scans. 39 per cent, or 56 of the patients, had lung abnormalities, including 23 per cent, or 33 patients, with fibrotic lung abnormalities and 16 per cent, or 23 patients, with nonfibrotic lung abnormalities, the study reported.

"In particular, the proportion of fibrotic interstitial lung abnormalities, an important precursor to idiopathic pulmonary fibrosis, remained stable throughout followup," the authors said.

"Therefore, the fibrotic abnormalities observed in our study might represent a stable, irreversible pulmonary condition, such as lung fibrosis, after Covid-19," the authors said.

The remaining 88 cases, or 61 per cent of the participants, showed no abnormalities, the study said. Patients with lung abnormali-

ties on CT were more likely to have respiratory symptoms and abnormal lung function, the study said.

The proportion of individuals with respiratory symptoms decreased from 30 per cent at six months to 22 per cent at two years, the study said

At two-year follow-up, the most common respiratory symptom was exertional dyspnea or shortness of breath, observed in 14 per cent of the study group, while mild and moderate pulmonary diffusion were observed in 29 per cent, or in 38 out of 129 of the patients, the study said.

Pulmonary diffusion refers to how well the air sacs in the lungs are delivering oxygen to and removing carbon dioxide from the blood in the tiny blood vessels that surround them.

Pulmonary diffusion was regarded as abnormal when diffusing capacity of the lung for carbon monoxide was less than 75 per cent of the predicted value, the study said.

The researchers suggested that persisting residual symptoms and abnormal lung function could be related to the patient's ongoing lung damage.

"Long-term and functional consequences of chest CT findings post-Covid-19 are largely unknown," the authors said.

Misleading marketing claims and strategic lobbying from the dairy and formula milk industries further add to the challenges parents face by increasing anxiety around breastfeeding and infant care.

The World Health Assembly developed the International Code of Marketing of Breast-milk substitutes (the Code) in 1981 and several subsequent resolutions. However, intensive marketing of infant formula continues largely unabated, with sales from these products now approaching USD 55 billion a year, WHO said in a statement.

The first paper in 'The Lancet' series documents how misleading marketing claims directly exploit parental anxieties around normal infant behaviours, suggesting that commercial milk products alleviate fussiness or crying, for instance, that they help with colic, or prolong night-time sleep.

The formula milk industry uses poor science to suggest, with little supporting evidence, that their products are solutions to common infant health and developmental challenges, said Professor Linda

Richter from the University of the Witwatersrand, South Africa. "This marketing technique clearly violates the 1981 Code, which says labels should not idealise the use of formula to sell more product," Richter added.

The series explains how formula milk marketing exploits the lack of support for breastfeeding by governments and society, while misusing gender politics to sell its products. This includes framing breastfeeding advocacy as a moralistic judgment, while presenting milk formula as a convenient and empowering solution for working mothers. The series further draws attention to the power of the milk formula industry to influence national political decisions and interfere with international regulatory

In addition to ending exploitative marketing tactics and industry influence, broader actions across workplaces, healthcare, governments, and communities are needed to effectively support women who want to breastfeed so that it becomes a collective societal responsibility, rather than placing the onus on women, the authors said.

## China Is Dying Out

hina's population decline, which the Chinese government officially confirmed in January, has led many observers to wonder if the country's current demographic trends threaten its stability.

According to the National Bureau of Statistics, China's population shrank last year for the first time in 60 years, nine years earlier than government projections had anticipated. The fertility rate (births per woman) fell to 1.0-1.1, well below the official forecast of 1.8. Most notably the number of births dropped sharply to 9.56 million, the fewest since 1790, despite China's shift to a two-child policy in 2016.

But this sharp drop in the number of births is an illusion caused by a gross exaggeration of pre-2020 numbers. For example, a sample survey from 2016 showed a fertility rate of 1.25 and only 13 million births, which was later inflated to 18.83 million. Similarly, the United Nations' World Population Prospects report, typically regarded as a reliable source for estimates and projections of Chinese demographic trends, is wrong every time, without exception. The 2022 WPP suggests that China's population began to decline last year (ten years earlier than its 2019 projection), whereas I estimate that the decline began in 2018. The latest WPP also predicted that China's population would fall to 767 million in 2100, far below its earlier forecast of 1.065 billion.

WPP projections still overestimate China's population. While the 2022 WPP puts the Chinese population at 1.43 billion people, I estimate that it is now smaller than 1.28 billion. Moreover, according to the WPP, there were 28.2 million births in China in 1990 and 17.4 million in 2000. Yet the 1990 and 2000 censuses put the number of Chinese births at 23.7 million and 14.2 million, respectively, as confirmed by the number of ninth graders in 2004 and 2014.

The 2022 WPP also exaggerates China's future population, predicting a fertility rate of 1.31 for 2023-50 and 1.45 for 2051-2100. The fertility rate among Chinese in the region suggests otherwise. Hong Kong, Macau, Taiwan, and Chinese Singaporeans have all had average fertility rates of 1.0-1.1 - the lowest in the world - over the past two decades, despite local authorities pro-natalist policies.

China's efforts to boost its fertility rate face three major challenges. First, the one-child policy has reshaped the Chinese economy, dramatically increasing the cost of raising children.

China's household disposable income is equivalent to only 44% of its GDP, compared to 72% in the United States and 65% in the United Kingdom. The Chinese housing market was valued at four times the country's GDP in 2020, whereas the American real-estate market is valued at 1.6 times GDP.

Chinese policymakers now face a dilemma: if the real-estate bubble does not burst, young couples will be unable to afford to raise two children. But if the bubble does burst, China's economy will slow, and a global financial crisis will erupt. Likewise, raising household disposable income to  $60\text{-}70\,\%$ of GDP in order to increase fertility could reduce the government's power, undermining the economic foundations of its current "authoritarian at home and aggressive abroad" policy approach.

Given these difficult tradeoffs, Chinese policymakers might be more inclined to replicate Japanese policies to lower child-rearing costs, such as reducing school fees and providing convenient childcare, childbirth subsidies, and housing benefits to young couples. But Japan's approach has proved expensive and ineffective: the country's fertility rate received a temporary boost, from 1.26 in 2005 to 1.45 in 2015, before falling back to 1.23 in 2022. Moreover, because it is "getting old before it gets rich," China lacks the financial wherewithal to emulate Japan.

There are both physiological and cultural reasons for China's demographic crisis. With more women delaying marriage and childbirth, the country's infertility rate has increased from 2% in the early 1980s to 18% in 2020. From 2013 to 2021, the number of first marriages fell by more than half, and by three-quarters for 20-24-year-olds. And the one-child policy, which had been in place for 36 years, has irreversibly changed Chinese views of childbearing: having one child - or none - has become the social norm.

The more recent the cohort of Chinese women, the less willing to have children they seem to be. One recent survey found that while the average number of intended children among women in China is 1.64, the average decreases to 1.54 for women born after 1990 and 1.48 for women born after 2000. For comparison, in South Korea and Hong Kong, the average intended number of children is 1.92 and 1.41, respectively (both fertility rates are roughly half the intended figures). If this declining interest in childbearing is any indication, China will struggle to stabilise its fertility rate at 0.8, and its population will fall to less than 1.02 billion by 2050 and 310 million in 2100.

Ancient China also experienced population declines due to war and famine, but recovered quickly, similar to blood loss with normal regeneration. Modern population declines, like aplastic anemia, are hard to recover from.

Even if China succeeds in increasing its fertility rate to 1.1 and prevents it from declining, its population will likely fall to 1.08 billion by 2050 and 440 million by 2100. The country's share of the world's population, which declined from 37% in 1820 to 22% in 1950-80, will fall to 11% in 2050 and 4% by 2100.

The effects of this population decline will be compounded by rapid aging, which will slow Chinese growth and likely increase government debt. The share of Chinese people aged 65 and older will rise from 14% in 2020 to 35% in 2050. Whereas five workers aged 20-64 supported every senior citizen aged 65 and older in 2020, the ratio will continue to decline to 2.4 workers in 2035 and 1.6 in 2050. By that point, China's pension crisis will develop into a humanitarian catastrophe. Women, who live 6-7 years longer than men, on average, and are usually a few years younger than their spouses, will ultimately pay the price for this painful demographic shift.

skilled workforce is needed for strong, sustainable and balanced growth of a state. According to the International Labour Organisation, Geneva "the cornerstones of a policy framework for developing a suitably skilled workforce are: broad availability of good quality education as a foundation for future training; a close matching of skills supply to the needs of enterprises and labour markets; enabling workers and enterprises to adjust to changes in technology and markets; and anticipating and preparing for the skills needs of the future. By applying this approach, more productive and rewarding jobs can be created through better education, training, and innovation.

As per the NITI Aayog (National Multidimensional Poverty Index report), Odisha is among the top ten states with a significant share of the population living under poverty. More specifically, one in every three persons in Odisha is poor. Around 29.35% of Odisha's population is multidimensionally poor despite the implementation of numerous schemes and welfare programmes by the government. Furthermore, the ever shrinking plottage per families of farmers in rural Odisha has virtually guaranteed poverty; and it will get worse in the course of time even if mechanisation and various technical interventions are implemented in the farming sectors. One of the ways to circumvent this problem is by moving farmers into non-farming occupations on a large scale. In the past several decades, the government of Odisha has established many higher education facilities and also converted several government colleges into universities. However, university education alone will not give a big dent to the problem of unemployment in Odisha

In the USA, community colleges are designed to train the workforce to fulfil the needs of society as well as industries. The primary goal of such institutes is to enable upward mobility by making relevant education and training accessible at the grassroots. Very often, community colleges pay attention to the needs of local communities, industries, and economy. In addition, these institutions are highly responsive to already existing local bottlenecks in education and skill availability. The economy of many developed countries and community colleges are historically tied. To meet the needs of advancing and ever expanding industries, whenever mass amounts of workers needed to be up-skilled or re-skilled the community colleges rose to the

It is worth noting that in several industries of Odisha; particularly,

in western Odisha most of the skilled trade jobs are filled with people from outside the state. It is apparent that there is a need to open better schools to train people in occupations like plumbers, welders, bricklayers, electricians, nursing, nurse's aides, machinists, lathe operators, electricians, book keepers, accountants, data managers, and computer operators.

Opening myriads of Arts and Science colleges with much fanfare has become a trend in Odisha. These institutions are breeding grounds for unemployed youths. Our education system is antiquated and is not well designed to create a highly skilled labour force. Very clearly, there is a disconnect between what industry needs and the present education system. The way forward could be establishing community colleges, and more polytechnics. In a state like Odisha, community

colleges should be located in gram panchayats and should enrol students of the area in which they are located. This will facilitate a sense of comfort and ease of accessibility. To make such schools technically sound and relevant, they should be intimately connected with nearby industries, and should regularly conduct surveys of occupational needs. There must be an active collaboration between industries and community colleges in terms of sharing resources and personnel, curriculum development, provision of internships and apprenticeship. Also, it would be prudent to bring in a rule to automatically admit high school students to their gram panchayat level community college if they have not opted for further higher studies in other colleges/uni versities. Such an open-enrolment policy will allow students to gain access to higher education who might not be able to attend a faraway university. Graduates of these institutions can be more easily hired by industries than those who graduate from traditional universities. Additionally, students graduating from community colleges can enter universities with credits for courses taken in colleges.

Employers in various developing countries are reporting that a lack of skilled workers is a major stumbling block for their operations. In Odisha too there is a huge shortage of skilled labour force. Therefore, on a priority basis, government and private organisations should establish excellent community colleges, trade schools, and polytechnics at gram panchayat level. This will benefit students, taxpayers, and society as a whole.

# India as global leader in digital landscape

igitalisation is reshaping economic activities, shrinking the role of cash, and promoting new digital forms of money and payments. Payments system is witnessing a sea change. The role of central banks in supporting digital infrastructure and regulating digital transactions has been crucial for developing coun-The RBI unveiled in June 2022,

the Vision Document 2025, to take the payments landscape to new heights. The document promises to further elevate our payments system towards a realm of empowering users with affordable options accessible anytime and anywhere with convenience. As this journey towards less-cash regime unfolds, concomitant expansion in the basket of digital payments options with credence and confidence would ensure sustenance of RBI's approach of facilitating users with a seamless digital payments experience. This will also reinforce India's position as global leader in digital pay

ments domain. India has made impressive progress towards innovation in digital payments. The present stateof-the-art payments systems that are affordable, accessible, convenient, efficient, safe, secure, and available 24x7x365 are a matter of pride for the nation. This striking shift in payments preference has been due to creation of robust

round-the-clock electronic systems such as Real Time Gross Settlement and National Electronic Funds Transfer that has facilitated seamless real time or near real time fund transfers. In addition, the launch of Immediate Payment Service and Unified Payments Interface (UPI) for instant payment settlement, the introduction of mobile-based payment systems such as Bharat Bill Payment System have transformed the payments ecosystem of the country and made India a global leader in payments system landscape.

India's digital payments volume has gone up at an average annual rate of about 50% in past five years. Its expansion has been even more rapid—about 160% annually—in UPL Transactions more than doubled, to 5.86 billion, in June 2022 from a year earlier. Values nearly doubled in the same period. In addition, the RBI in March introduced a UPI for feature phones that can potentially connect 400 million users in distant rural areas.

RBI had placed a concept note on Central Bank Digital Currency (CBDC) on its website 7 October 2022. The purpose of this Concept Note is to create awareness about CBDCs in general and the planned features of the digital rupee, in particular. It explains the objectives, choices, benefits, and risks of issuing a CBDC in India.

RBI Deputy Governor T Rabi Sankar, who oversees payments systems and fintech, said in June 2022 at an IMF event: "CBDCs could actually be able to kill whatever little case there could be for private cryptocurrencies."

CBDC has been gaining momentum with 86% of central banks globally reviewing its feasibility for cross-border transactions as well as for internal benefits (2021 BIS Survey). CBDC is also an area of interest for G20 under its priority initiative to enhance cross-border payments. The RBI announced the launch

of the first pilot for retail digital rupee on 1 December, 2022. The retail digital rupee is in the form of a digital token that represents legal tender. It is issued in the same denominations that paper currency and coins are currently issued. It would be distributed through intermediaries, i.e., banks. Users will be able to transact with retail digital rupee through a digital wallet offered by the participating banks and stored on mobile phones/devices. Transactions can be both Person to Person (P2P) and Person to Merchant (P2M). Payments to merchants can be made using QR codes displayed at merchant locations. The retail digital rupee would offer features of physical cash like trust, safety and settlement finality. As in case of cash, it will not earn any interest and can be converted to other forms of money, like deposits with banks.

Eight banks have been identified

for phase-wise participation in\_\_\_ this pilot. The first phase began with State Bank of India, ICICI Bank, IDFC First Bank and Yes Bank in four cities. Four more banks - Bank of Baroda, Union Bank of India, HDFC Bank and Kotak Mahindra Bank will join this pilot subsequently.

The support of the finance minister in the Union Budget 2023-24 has been fabulous. The Budget emphasises that: Digital payments continue to find wide acceptance. Fiscal support for this digital public infrastructure will continue in 2023-24. As per RBI data, the number of payment acceptance devices deployed under the Payment Infrastructure Development Fund Scheme as on 31 December 2022 has been 455,415 in physical devices and 182,88,974 in digital de-

UPI has become hugely popular for retail digital payments in India, RBI Governor Shaktikanta Das in his statement of 8 February 2023 proposed to permit all inbound travellers to India to use UPI for their P2M while they are on visit to the country. To begin with, this facility will be extended to travellers from G-20 countries arriving at select international airports. This is a progressive step in the path of digital globalisation.



A series of hostile events led to Ottawa hardening its traditional soft stance against Beijing. Economic cooperation including trade relations, security partnership and issues of migration are said to have figured in the meeting between Joly and her Indian counterpart S Jaishankar. As Joly said investment opportunities for either country in the other has huge potential to be a game changer. Common democratic interests and long standing bilateral people-connect have always held the relation between the two countries in good stead. Therefore, the strain between India and Canada due to the apparent pro-Khalistan leaning of the ruling dispensation at Ottawa, among others, has not suffered beyond repair.

#### Six killed as jeep hits truck

Patan (Guj): Six people including four women were killed and eight injured after a jeep rammed into a stationary truck from behind in Gujarat's Patan district Wednesday afternoon, police said. The incident took place near Radhanpur when the driver of the Mahindra Jeep, which was carrying some 15 passengers, lost control after a tyre burst, said Deputy Superintendent of Police K K Pandya. Lucknow: The Allahabad High Court has granted interim bail to eight more accused till March 20 in the 2021 Lakhimpur violence. With this all the 13 accused in the case including Ashish Mishra, son of Union home minister Ajay Mishra alias Teni, are now on bail. A Lucknow bench passed the order Tuesday considering the Supreme Court's January 25 order allowing bail to Ashish Mishra. The bench of justice Raiesh Kumar Singh Chauhan has fixed March 20 as the next date of hearing in the case.

#### Fire in Mumbai building, one dies

Mumbai: A 70-year-old woman died and eight other people suffered from suffocation after a fire broke out in a 13storey residential building in Kurla area of Mumbai Wednesday, officials said. The blaze erupted at around 7 am in the building located in Premier compound, Kohinoor City, following which some people were stranded on different floors due to smoke in the premises.

# **India to strengthen ITBP** amid tensions with China

The government decisions come amid the India-China military standoff along the LAC in eastern Ladakh that erupted in May 2020 and scuffles in the Tawang sector of Arunachal Pradesh in December last year

New Delhi, Feb 15: Seven new battalions of the Indo-Tibetan Border Police (ITBP) will be raised and a 4.1-km tunnel to provide all-weather connectivity to the border areas of Ladakh built with the government giving its approval Wednesday, in a major move to bolster the country's defence along the China border.

The Cabinet Committee on Security (CCS) cleared the proposal for hiring of 9,400 fresh personnel for raising seven new border battalions apart from a new operational base for the ITBP, which guards the 3,488-km-long India-China border ranging from the Karakoram Pass in Ladakh to Jachen La in Arunachal Pradesh. The new personnel will be stationed mainly in Arunachal Pradesh.

The ITBP proposal was cleared during the CCS meeting that was chaired by Prime Minister Narendra Modi, Union Information and Broadcasting minister Anurag Thakur told reporters.

The new battalions and the sector headquarters are expected to be put in place by 2025-26, he said. The Union Cabinet at its meeting chaired by Prime Minister Modi gave its nod for the construction of the 4.1-km Shinkun La tunnel on the Nimu-Padam-Darcha road link to provide all-weather connectivity to the border areas of Ladakh.

Thakur said the tunnel will be completed by December 2025 at a cost of Rs 1,681 crore. The tunnel will provide all-weather road connectivity to Ladakh and this will be the shortest route to the border areas of the union territory, he said. "The Cabinet Committee on Security (CCS) today approved the

Sources said the tunnel project is a significant step in terms of security perspective as Nimu in Ladakh is close to Kargil as well as Leh and will help the armed forces in quicker deployment of forces and equipment in the region if there is any tense situation.

The ITBP, which has about 90,000 personnel in its ranks, was raised in the aftermath of the 1962 Chinese aggression.

According to the government sanction, the fresh manpower will be utilised for manning 47 new border posts and a dozen 'staging camps' or troops bases to be created along the LAC, largely in Arunachal Pradesh.

In order to ensure effective guarding of the LAC, these new bases were sanctioned in 2020 and now seven battalions comprising about 9,400 personnel and a new sector headquarters have been approved, a senior officer said.

Thakur said a non-recurring expenditure of Rs 1,808.15 crore is estimated to be spent for land acquisition, creation of office and residential buildings, and arms and ammunition while there will be a recurring annual expenditure of Rs 963.68 crore under the salaries and rations head for the fresh manpower.

#### **Adityanath orders** magisterial probe

Lucknow/Kanpur, Feb 15: Uttar Pradesh Chief Minister Yogi Adityanath Wednesday ordered a magisterial inquiry into the death of a woman and her daughter in Kanpur Dehat during an anti-encroachment drive, an incident which the opposition is set to raise during the assembly session beginning next week.

Pramila Dixit (45) and Neha (20) were cremated at Bithoorghat in Kanpur Dehat district with policemen deployed along the road from the victims' Madauli village. The women died after allegedly setting themselves on fire Monday in a hut in the presence of police, district administration and revenue officials who had come to the village to demolish encroachments from "gram samaj" land.

On Wednesday, Congress workers protested outside the party office in Lucknow after they were apparently not allowed to proceed towards Raj Bhavan and submit a memorandum to Governor Anandiben Patel. Police put barricades outside the Congress office and there were heated exchanges between the protesters and them. Congress state president Brijlal Khabri demanded a judicial probe into the deaths.

### Ladakh groups protest in Delhi PRESS TRUST OF INDIA

New Delhi, Feb 15: Slogans demanding statehood for Ladakh were raised at the Jantar Mantar Wednesday as a joint protest was held by the Leh Apex Body and Kargil Democratic Alliance in the

national capital. Representatives of social, cultural and political organisations from Ladakh, as well as hundreds of common Ladakhis gathered at the 18th-century observatory, a stone's throw away from the Parliament building, and said they hoped their voice would reach the government.

"Our traditions, ethnic identity, resources and security are at stake today. Our demand is very simple, we want democracy to be restored in Ladakh by giving it statehood, and to be brought under the sixth schedule of Constitution," said Thupstan Chhewang, a former BJP MP who resigned in 2018 accusing the party of not fulfilling promises made to the people of Ladakh.

He said Ladakh is an ecologically sensitive area and development activities without consulting locals will be harmful

"A big solar power project has been planned, but the area earmarked is the area of nomadic people who are known for producing Pashmina. It will displace them because their rich pastures will go. In addition, it will also im-

#### **CBSE BOARD EXAMS BEGIN**

New Delhi, Feb 15: The CBSE board exams for classes 10 and 12 began on Wednesday with over 38 lakh students set to appear for the examinations at 7.250 centres.

The Class 10 exam Wednesday was conducted for six subjects including Painting, Gurung, Rai, Tamang, Sherpa and Thai while the Class 12 exam was conducted for Entrepreneurship.

The Class 10 exams will be conducted in 76 subjects and will be over March 21 while Class 12 exams will cover 115 subjects and will be over April 5. According to Board officials, over 38.83 lakh students will be appearing for the exams being conducted at 7,250 centres across India and in 26 other countries.

"CBSE has made elaborate arrangements. To ensure that all the important information for the conduct of examinations is communicated to all responsible officials at the examination centres, CBSE has circulated detailed guidelines to all the stakeholders,'

a senior board official said. To ensure that the students are appearing in the examinations without any stress, CBSE has fixed the timetable in such a manner that students are getting sufficient  $\stackrel{\scriptstyle \sim}{=}$ time for exam preparation in all the

subjects, he said. "As per the information collected from all the examination centres, all preparations have been completed by the centres for the smooth conduct of examinations," the official added.

## INDIA, SOON TO BE WORLD'S MOST POPULOUS NATION

New Delhi, Feb 15: In two months, India is projected to become the world's most populous country with over 1.4 billion people. But for at least a year, and possibly longer, the country won't know how many people it has because it hasn't been able to count them.

India's once in a decade census. due in 2021 and delayed due to the pandemic, has now got bogged down by technical and logistical hurdles and there are no signs the mammoth exercise is likely to begin soon.

Experts say the delay in updating data like employment, housing, literacy levels, migration patterns and infant mortality, which are captured by the census, affects social and economic planning and policy making in the huge Asian

economy. Calling census data "indispensable", Rachna Sharma, a fellow at the National Institute of Public Finance and Policy, said studies like the consumption expenditure survey and the periodic labour force survey are estimations based on information from the census.

"In the absence of latest census data, the estimations are based on data that is one decade old and is likely to provide estimates that are far from reality," Sharma said.

A senior official at the Ministry of Statistics and Programme Implementation said census data from 2011, when the count was last conducted, was being used for projections and estimates required to assess government spending.

A spokesman for the ministry said its role was limited to providing the best possible projec-



tions and could not comment on the census process. The Prime Minister's Office did not respond to requests for comment.

The office of the Registrar General of India, which is responsible for the census, did not respond to a request for comment. The main opposition Congress

to cloak critical data. The ruling Bharatiya Janata Party's national spokesperson, Gopal Krishna Agarwal, dismissed the criticism.

The voting will be held under tight security between 7am and 4pm at 3,337 polling stations, out of which 1,100 were identified as sensitive and 28 as critical, Dinakarro

# shooters to kill nilgais, boars

Patna, Feb 15: The Bihar government has hired 13 professional shooters to kill wild boars and 'ghodparas' or nilgais to save crops. a forest official said Tuesday.

Animal lovers have opposed the move and demanded that the government find a long term solution to the problem and not allow the killing of the animals.

The state environment, forest and climate change department has sent the list of the professional shooters to the authorities concerned in all 38 districts in the state to use their services wherever required.

Districts where these two animal species are found in large numbers include Muzaffarpur, Vaishali, Sitamarhi, Bhojpur, Sheohar and West Champaran, he said.

There is no record of the number of nilgais or wild boars in the

"These two animal species move in herds and destroy acres of crops in a day. Farmers sit out all night to protect their ripening crops from them in some Bihar districts. Both ghodparas (nilgais) and wild boar are vermins and can be killed, but according to laid down procedures, PK Gupta, Bihar Chief Wildlife Warden, told PTL

Efforts should be made to kill only full grown animals and the shooters have been instructed to fol-

low norms while carrying out culling operations, he said.

Gupta said besides damaging crops, nilgais also cause road accidents. Human lives have been lost due to man-animal conflict, along with loss of crops and valuable property.

The role of mukhiyas (village heads) is important in the operation beginning from the killing of the animals to their burial. All village heads will have to engage the professional shooters to kill the two species with utmost caution as and when required, Gupta said.

"As per the provisions of the Wild Life (Protection) Act, 1972, the mukhiyas have been appointed as the nodal authority to identify and allow killing of these two species with the help of professional shooters outside the protected area. The mukhiya concerned can allow the killing by hired shooters on the basis of com plaints received from farmers of his/her respective area in coordination with the officials of the environment and forest departments,

Explaining the procedure, Gupta said the state government will provide a specific amount to the village heads for cartridges that will be used for killing nilgais and wild boars and Rs 700 for the burial of the an-

"A mukhiya will issue hunting permits to shooters only after proper verification of the complaints of farmers of his or her respective area. The village heads will have to submit a monthly report of permissions and animals hunted of their respective areas to the competent authority," the chief wildlife warden said.

Reacting to the government move, the managing director for **Humane Society International** (HSI), India, Alokparna Sengupta, said the killing of any animal must be condemned.

HSI works round the globe to promote human-animal bond.

The state government should try to find out a long term solution and not allow the killing of these two species in this way. It is a fact that several state governments have already allowed killing of the two animals but the problem of crop damage by them still persists, Sengupta added.

Aizawl, Feb 15: The Mizoram Assembly Tuesday unanimously adopted an official resolution op-Uniform Civil Code (UCC) in the

Home minister Lalchamliana moved the resolution which said, "This House unanimously resolved to oppose any steps taken or proposed to be taken for enactment of UCC in India.'

While moving the resolution, Lalchamliana asserted that the UCC, if enacted, would disintegrate the country as it was an attempt to terminate the religious or social practices, customary laws, cultures and traditions of the religious minorities, including the Mizos.

He alleged that several attempts

Agartala, Feb 15: In view of the forthcoming Assembly elections, the governments in Tripura, Nagaland and Meghalaya declared paid holiday on the day of polling to enable the employees of government and private organisations to cast their votes.

Officials said that in accordance with the Representation of the People Act, 1951, and in view of the Assembly elections in the three states, the polling day has been declared a paid holiday for all the employees of government, public sector undertakings, banks, financial institutions, private and all the business establishments to enable them to exercise their franchise.

This applies to all categories of employees, including the daily wage and casual workers, and also those electors working outside the constituency concerned.

However, this shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged, an official said. Elections in Tripura will be held February 16, while Meghalaya and Nagaland will go to the polls February 27.



Patna, Feb 15: The 'Samadhi Sthal' or the memorial of 'Mountain Man' Dashrath Manjhi is emerging as the 'Taj Mahal of Bihar' as large numbers of foreign and domestic couples come here to take inspiration from Dashrath Manjhi's love for his wife.

Dashrath Manjhi, a native of Gehlaur village in Gaya district, had carved a path 110 m long, 9.1 m wide and 7.7 m deep through a ridge of hills using only a hammer and chisel. After 22 years of work, Dashrath Manjhi shortened travel between the Atri and Wazirganj blocks of Gaya town from 55 km to 15 km.

In 2015, Director Ketan Mehta made a movie based on the life of Dashrath Manjhi. Nawazuddin Siddiqui played the lead role in the movie.


couples, especially on Valentine's Day, throng the memorial of Dashrath Manjhi in Gehlaur.

Dashrath Manjhi was also issued by the Central government.

Died in 2007, Dashrath Manjhi was daily wage labourer from Gehlaur. When his wife Falguni Devi died in 1959 due to injury caused by falling from a mountain and due to the same mountain blocking easy access to a nearby hospital in time, he decided to carve the path through a ridge of hills using only a hammer and a chisel. After 22 years of work, Dashrath Manjhi shortened travel between the Atri and Wazirganj blocks of Gaya district from 55 km to 15 km.

Following his demise, the Bihar government built a statue and a memorial of Dashrath Manjhi. It also named the road between Gehlaur and Wazirganj as 'Dashrath Manjhi Path'.



### Another eviction drive in Assam to clear encroached forest land

Guwahati, Feb 15: The Assam government Tuesday launched another eviction drive in Sonitpur and Nagaon districts to clear 1,900 hectares of encroached forest land, an official said.

Over 2,000 security personnel, including paramilitary, Home Guards, Central Reserve Police Force (CRPF) and Assam Police, have been stationed in the Char-Chapori area of the Burhachapori wildlife sanctuary region for ensuring a smooth eviction drive.

At least 50 excavators and 30 tractors would be used in the eviction exercise, an official said.

Around 2.500 establishments including houses and schools have come up on 1,900 hectares of land, a government official said.

Sonitpur district Superintendent of Police, Sushanta Biswa Sarma told IANS: "We have started the eviction and it will continue for the next three days

According to officials, 'illegal' settlers were served notice a few days ago to vacate the encroached

"At least 80 per cent of the people who had earlier encroached on the land, destroyed the illegal structures by themselves and left the place. We did not face any sort of resentment while carrying out the eviction drive," a police officer said. Last month, an eviction exercise took place in the Paboi Reserve Forest area.

# I-T dept survey on BBC continues for 2nd day

New Delhi, Feb 15: The Income Tax department survey operation against the BBC India continued for the second day with the sleuths understood to be making copies of electronic and paper-based financial data of the organisation, officials said Wednesday.

The tax department had launched the action Tuesday at the BBC's Delhi and Mumbai offices along with at least two linked premises as part of an investigation into alleged tax evasion against the British broadcaster in India. Sleuths knocked at the doors of the BBC around 11:30 AM Tuesday and they are still present, sources aware of the development told PTI.

The tax officials are speaking to staffers of the BBC in the finance and some other departments even as other staffers and journalists were allowed to leave Tuesday night. Some computer peripherals and mobile phones were cloned as part of the operation, officials had said.

The action, which sparked a sharp political debate with the ruling BJP accusing the *BBC* of "venomous reporting" and the opposition questioning the timing of the move, came weeks after the broadcaster aired a two-part documentary, "India: The Modi Question", on the prime minister and the 2002 Gujarat riots. The survey is being carried out to investigate issues related to international taxation and transfer pricing of BBC subsidiary companies, officials had said Tuesday

While there has been no official statement from the Income Tax department on the action, the British Broadcasting Corporation (BBC) has said it was cooperating with the authorities.



# Having cancer not end of world: Experts

ACCORDING TO THE ICMR, APPROXIMATELY 500 CHILDREN IN BANGALORE ARE DIAGNOSED WITH CANCER EACH YEAR

Bangalore, Feb 15: The International Childhood Cancer Day (ICCD) is observed February 15 every year with the aim of creating awareness. The experts advise parents on the occasion that having cancer is not the

end of the world. "My message to the public is to have an awareness that having cancer is not the end of the world. It's just a phase that will pass and together we can be successful in making sure that children with cancer can have a normal life, free of disease," Dr Ashish Dixit, Consultant - Haematology, Haemato Oncology and Bone Marrow Transplantation, Manipal Hospital

Old Airport Road said. Dixit said that, "Most of the can-

cers in children are curable. Prompt recognition of cancer and the early start of the therapy holds the key to a successful outcome. One of the most common cancers in children is acute leukaemia.

Dr Vinay Munikoty Venkatesh, Consultant - Paediatric Haematology Oncology and BMT, Manipal Hospitals Yeshwanthpur said that every year nearly 4 lakh children and adolescents are diagnosed with cancer. In India alone, more than 75,000 new childhood cancers are diagnosed each year. Cure rates of childhood cancers is close to 85 per cent if diagnosed timely. A robust system of "referral to pe-

diatric oncology" centres is lacking when a child is suspected of cancer in the community. Raising the awareness in the community and amongst general physicians is the need of the hour, he explains.

Treatment advancements in childhood cancers over years has not just resulted in excellent cure rates but also has minimized the side effect profile of these treatments. Cellular therapies (CAR-T cell therapy, gene therapy etc) and immunotherapy have shown pathbreaking clinical results in cancers previously considered incurable! We need to invest more in childhood cancer research to further improve, Venkatesh said.

Dr Niti Krishna Raizada, Senior Director Medical - Oncology and



Hemato-Oncology, Fortis Hospitals, Bengaluru said, childhood cancers refer to a group of diseases that include many different types of cancers, such as leukaemia, brain and spinal cord tumours, neurob-

lastoma, Wilms tumour, and others. Each type of childhood cancer is unique and requires specific treatment and care. According to the Indian Council of Medical Research (ICMR), approximately 500 children in Bangalore are diagnosed with cancer each year.

"Fatigue, discomfort, edoema, and behavioural changes are just a few of the symptoms. Due to the child's developing body and symptoms that may resemble those of other disorders, diagnosis and therapy can be difficult," Raizada said.

Raizada added that many families in India struggle to afford the cost of treatment, which can run into lakhs of rupees, leading to financial ruin and severe stress. Additionally, the lack of trained paediatric oncologists and adequate treatment facilities in many parts of India results in late diagnosis and inadequate care, leading to lower survival rates for children with cancer.

allegedly offering a sophisticated software package named Advanced Impact Media Solutions (Aims) to commercial clients as one of its

The unit is said to be run by Tal Hanan, a 50-year-old former Israeli special forces operative who works privately using the pseudonym "Jorge", and Team Jorge is accused of using means such as hacking, sabotage, and automated disinformation online.

When questioned, Hanan told the investigation that he denies



"any wrongdoing"

The newspaper report said Wednesday that over several months last year, along with its reporting partners on the investigation, it had tracked Aims-linked bot activity across the internet and found it was behind "fake social media campaigns, mostly involving commercial disputes, in about 20 countries including the UK, US, Canada,

Germany, Switzerland, Mexico, Senegal, India, and the United Arab Emirates".

The consortium of journalists that investigated Team Jorge includes reporters from 30 global media outlets including Le Monde, Der Spiegel, and El País.

The project, part of a wider investigation into the disinformation industry, has been coordinated

by Forbidden Stories, a French non-profit with a mission to pursue the work of assassinated, threatened or jailed reporters

The investigation is part of Story killers, a collaboration led by Forbidden Stories, and was inspired by the work of Gauri Lankesh, a 55-year-old journalist who was shot dead outside her Bangalore home in 2017.

"The Guardian" notes that hours before Lankesh was murdered, she had been putting the finishing touches on an article called "In the Age of False News", which examined how so-called lie factories online were spreading disinformation in India.

In the final line of the article, which was published after her death, the late Indian journalist

#### Scottish leader Sturgeon to quit

London, Feb 15: Scottish First Minister Nicola Sturgeon Wednesday announced her intention to resign, saying that part of serving in politics is knowing when it is time to make way for someone else.

Speaking at a news conference at her official residence in Edinburgh, Bute House, Sturgeon said she wrestled with the decision, but that the pressure of the job was relentless and that she is a human being as well as a

Sturgeon, who has led the country's devolved government and the Scottish National Party for eight vears, has faced months of controversy over a law that makes it simpler for people to change their gender on official documents, the BBC reported Wednesday.

The decision caught political observers by surprise, despite the ongoing controversy over the gender recognition measure. She had vowed to take the British government to court over its decision to block the law and argued that the Conservative UK government was making a "profound mistake" by vetoing the Gender Recognition Reform Bill.

Hailed as a landmark by transgender rights activists, the bill would allow people age 16 or older in Scotland to change the gender designation on their identity documents by self-declaration, removing the need for a medical diagnosis of gender dysphoria.

The legislation sets Scotland apart from the rest of the United Kingdom, where a medical diagnosis is needed before individuals can transition for legal purposes.

But the measure was only one controversy in a career where Sturgeon has been noted for rarely putting a foot wrong. She had been lauded for her response, for example, to the Covid-19 pandemic, where she won praise for her sober, straight-talking abilities. That catapulted the idea of Scottish independence from the United Kingdom —the long-held dream of Sturgeon's nationalist government — back up the political agenda. Scotland is part of the UK but, like Wales and Northern Ireland, has its own semiautonomous government with broad powers over areas including health care.

Washington, Feb 15: Several Russian strategic bombers and fighter jets have been intercepted by North American air defence forces as they flew over international airspace near Alaska, the North American Aerospace Defence Command said.

The aircraft, which were identified Monday, did not enter US or Canadian airspace and did not pose a threat, the joint US-Canadian centre said in a statement dated Feb 14.

It added that the Russian flights were in no way related to the mysterious spate of airborne objects shot down by the US military over North America in the past few



unknown. "NORAD had anticipated this Russian activity ... Two NORAD F-16 fighters intercepted the Russian aircraft," it said. Russia said Wednesday that it had carried out several flights over international waters in recent days, including in the Bering Sea between Alaska and Russia.

It said two of its Tu-95MS strategic missile carriers had flown over the Bering Sea accompanied by Su-30 jets, and that it had made similar "routine" flights north of Norway and over international waters near Russia's far east.

It did not say whether its aircraft had been intercepted.

"Long-range aviation pilots regularly perform flights over the neutral waters of the Arctic, North Atlantic, Black Sea, Baltic Sea and Pacific Ocean," Russia's defence ministry said.

The White House has disputed China's allegations.

Washington has added six Chinese entities connected to Beijing's suspected surveillance balloon program to an export blacklist. "The US has abused force, overreacted, escalated the situation, and used this as a pretext to illegally sanction Chinese companies and institutions," Wang said.

"China is firmly opposed to this and will take countermeasures against relevant US entities that undermine China's sovereignty and security in accordance with the law," Wang said, without specifying the measures.

The balloon dispute has delayed efforts by both sides to mend relations, although US President Joe Biden has also said that he does not believe ties between the two countries were weakened by the incident.

US Secretary of State Antony Blinken, who postponed a planned trip to Beijing over the balloon, is considering meeting China's top diplomat Wang Yi in Munich this week, sources have said.

United Nations, Feb 15: UN Secretary-General Antonio Guterres warned Tuesday that sea levels will rise significantly even if global warming is "miraculously" limited to 1.5 degrees Celsius – and said Earth is more likely on a path to warming that amounts to "a death sentence" for countries vulnerable to that rise.

Every fraction of a degree counts since sea level rise could double if temperatures rise by 2 degrees Celsius (3.6 degrees Fahrenheit), and increase exponentially with further temperature increases, the UN chief said. He spoke at the opening of a UN Security Council meeting on sea level rise, which

was hearing from 75 countries, and said the council has a critical role in building support for actions to fight climate change.

Under any scenario, countries like Bangladesh, China, India and the Netherlands are all at risk, and large cities on every continent will face serious impacts, including Cairo, Lagos, Maputo, Bangkok, Dhaka, Jakarta, Mumbai, Shanghai, Copenhagen, London, Los Angeles, New York, Buenos Aires and Santiago, he added.

The World Meteorological Organisation released figures Tuesday, cited by Guterres, that say global mean sea level will rise by about 2 meters to 3 meters (about 6.5 to 9.8 feet) over the next 2.000 years if warming is limited to 1.5



degrees Celsius. With a 2-degree Celsius increase, seas could rise up to 6 meters (19.7 feet), and with a 5-degree Celsius increase, seas could rise up to 22 meters (72 feet), according to the WMO.



Guterres said the world must address the climate crisis as the root cause of rising seas, and the Security Council has a critical role to play in building the political will required.

#### Adani looks to repay \$500mn

Bangalore: India's embattled Adani Group is in talks with lenders to repay a \$500 million bridge loan facility it had taken to buy controlling stakes in cement companies ACC Ltd and Ambuja Cements Ltd last year, the Economic Times daily reported Wednesday. Bangalore, Feb 15: India will spend 75 per cent of the total defence capital outlay for procurement from domestic defence manufacturers in 2023-24, Defence Minister Rajnath Singh said Wednesday in a significant decision aimed at boosting the indigenous production of various weapons and military platforms.

The move will mean setting aside around Rs one lakh crore for procurement from domestic sources out of the total defence capital outlay of Rs 1.62,600 crore announced in the Union Budget for the next fiscal, officials said on the sidelines of Aero India here.

Separately, Aero India witnessed the firming up of 266 partnerships including 201 MoUs, 53 major announcements, nine product launches and three transfers of technology (ToT) pacts - worth around Rs 80,000 crore.

"If you take one step, the government promises to take 10 steps forward. You spoke of land to run on the path of development. We are providing you the full sky," Singh said at the event "Bandhan ceremony" where the pacts were formally inked.

Earmarking three-fourths of the capital procurement budget for the local industry is a step in that direction," Singh said.

From a market share of less than 1 per cent in India's import basket before the start of the Russia-Ukraine conflict, Russia's share of India's imports rose to 1.27 million barrels per day in January taking a 28 per cent share.

# Indian airlines have more than 1,100 planes on order

INDIA IS ONE OF THE FASTEST GROWING AVIATION MARKETS IN THE WORLD

New Delhi, Feb 15: The country's airline industry is poised for expansion with more than 1,100 planes on order by various domestic carriers.

After more than 17 years, Air India, now owned by Tata Group, Tuesday placed orders for a total of 470 planes with Airbus and Boeing. The total order, comprising wide-body and narrow-body aircraft, is the largest so far by an Indian carrier and also one of the largest single aircraft orders in the world.

The country's largest airline IndiGo has around 500 planes on order and Akasa Air has placed an order for 72 Boeing narrow-body aircraft, out of which 16 planes have been delivered. That leaves

Akasa Air with 56 aircraft on order. Go First, earlier known as Go Air, has 72 planes on order while Vistara is to receive 17 more Boeing planes. Together, Air India, IndiGo, Akasa Air, Go First and Vistara have at least 1,115 planes on order.

Currently, there are around 700 commercial aircraft in the country, with a majority of them being narrow-body or single-aisle planes. Among others, around 470 aircraft of Airbus and about 159 Boeing planes are in commercial service in India.

Boeing Tuesday projected the country will require around 2,210 new planes in the next two decades and also pegged annual domestic air traffic growth to be nearly 7 per cent through 2041. On February 14, Prime Minister

The 36-year-old is 21 rating points behind Australia captain Pat Cummins and is contention to return to the No.1 ranking for the first time since 2017.

While Ashwin stepped up in what turned out to be the last session of the Test, Jadeja did the damage on the first day with 5/47. Jadeja then took 2/34 in the second Australian innings. Australia were bowled out for just 91.

Among other Indian bowlers, pacer Jasprit Bumrah, who too has been out of action since September last due to a lower back stress fracture, is placed fifth.

In the Test batting chart, India captain Rohit Sharma has been rewarded for his match-defining ton in Nagpur. He gained two spots to be at number eight.

Rohit came to the crease after Australia were all out for 177 in their first innings, then made the wicket look all-but tame with an assured 120 that set the tone for the rest of the match.

Wicket-keeper Rishabh Pant, who will be out of action for an indefinite period following his horrific car accident, is the other Indian batter in top-10. He is placed seventh.

In contrast Australian openers David Warner and Usman Khawaja have paid the price for being dismissed cheaply twice. Warner has fallen six places to 20th after his scores of 1 and 10, while Khawaja has dropped two spots to 10th after only making 1 and 5 in the first Test.

Australian duo of Marnus Labuschagne and Steve Smith occupy the top two positions with Pakistan captain Babar Azam in the third spot.

India all-rounder Axar Patel has leaped six places to seventh in Test all-rounder rankings after coming to the crease at a tense 240/7. He hit a patient 84 for his highest score in

### Starc hopeful of playing 2nd Test vs India

New Delhi, Feb 15: An optimistic Mitchell Starc on Wednesday said he was hopeful of returning to the Australian playing XI for the second Test against India, starting here Friday.

Then it's a discussion for the rest of the group involved," he added.

Australia have been laid low by injuries to key players including Starc and all-rounder Cameron Green, who is also recovering from a finger injury. The duo trained Wednesday, bowling on a centrewicket strip, while Green also batted for over an hour. A call on their selection will be taken Thursday.

The left-arm pacer said his finger is still not at full strength. "Still lacking a bit of strength having been in a splint for six weeks. There's still a fair bit of restriction there, it's progressing each day," said

Not even Kylian Mbappe's substitute appearance could end PSG's slump, as they lost 0-1 at home to

Bayern in the first leg of their round of 16 clash. A third straight loss made it five defeats in 11 games this year for PSG coach Christophe

Galtier's team. Bayern winger Coman volleyed home inside the penalty area from Alphonso Davies' left-wing cross in the 53rd minute Tuesday. The Parisraised Coman, who PSG sold to Juventus when he was 18, held his hands up to show he wasn't celebrating scoring against his former

club — again. "It's the city where I was born and raised so it was difficult to celebrate here," Coman said. "Given our performance we could have done more, but at the end it was a bit difficult so we're satisfied with the win."

When Bayern won the last of their six Champions League titles in 2020, they beat PSG 1-0 with Coman heading home the winner.

The World Cup superstar Mbappe made an unexpectedly quick recovery from injury and had two would-be goals disallowed for offside after coming on in the second half. The return leg is

PSG were eliminated by Real Madrid in the last 16 last season and may need Mbappe at this best to avoid another early exit. Mbappe showed no ill effects of the thigh tear he sustained two weeks ago.

He had a shot saved by Yann Sommer in the 73rd after racing through down the left. Sommer saved Neymar's follow-up and the ball fell to Mbappe near the line, but he was well offside.

Mbappe peeled away in delight after volleying Nuno Mendes' cross from close range with 10 minutes left, but it was chalked off following a quick video review.

Bayern's defence held firm under some late pressure, although defender Benjamin Pavard received a second yellow card was sent off for a late tackle on Lionel Messi in stoppage time.

It was a miserable return to San Siro for Tottenham manager Antonio Conte, who endured only his second loss against Milan in 15 matches as coach. The former Inter Milan and Juventus coach had engineered 10 victories over the

It was also Spurs' second straight defeat since Conte returned to the dugout following gallbladder surgery. Spurs lost 1-4 at Leicester in the Premier League Saturday.

For Milan, it is a further sign that things might be turning around after a tough run. Milan were winless in their past seven matches, including losing their previous four matches, before Friday's 1-0 win over Torino.

The match at San Siro was Milan's first in the Champions League knockout stage since 2014. They haven't reached the quarterfinals since 2012.

And the Rossoneri got their return off to the perfect start. Theo Hernandez saw his shot parried by Fraser Forster and Tottenham's goalkeeper then did brilliantly to claw away Diaz's effort from the rebound but the Milan midfielder bundled in from point-blank range on the second attempt.
