


MAN GUNS DOWN 6, **INCLUDING EX-WIFE**





Bhubaneswar. Feb 18: The ruling Biju Janata Dal (BJD) Saturday accused BJP of 'betraying' the people of Odisha after Union Finance Minister Nirmala Sitharaman made it clear that the Centre has no plans to accord special cate gory status to the coastal state.

BJD, which has been demand ing the status for the state, accused the BJP of 'betraying' its people as the saffron party backtracked from its promises made during the elections

"The union finance minister has unfortunately exposed BJP's true colours. Though BJP had in its election manifesto promised to ensure special category status for Odisha, its leader did not work in that line. It has betrayed the people of Odisha," BJD vice-president and lawmaker Debi Prasad Mishra told said.

"BJP as a party has proved to be a liar. It has completely forgotten its promise made in the election manifesto. The people of Odisha will not tolerate a party which indulges in lies and betrayal," Mishra said. The general and assembly elec-

tions are held in the state simultaneously. Both polls are due next year. "Odisha is neglected due to political discrimination for being a non-BJP ruled state," Mishra claimed. The Centre has provided financial assistance to Karnataka and other BJP ruled states while grossly neglecting Odisha, for which BJD has been demanding the

special category status for long. Apart from the passage of a unanimous resolution in the Assembly, both the party and its chief Naveen Patnaik have all along raised the issue in different platforms, including at the National Development

NABA DAS ASSASSINATION

Das was shot at by an assistant sub-inspector (ASI) of police in Jharsuguda district January 29 when he was on his way to attend a programme. He succumbed to his injuries later that day in a private hospital in Bhubaneswar.

"The ASI was merely the shooter; but who was his handler? I will soon expose the mystery surrounding the brutal murder of cabinet minister Naba Das," said Mishra. The BJD government needs to answer a lot of questions, Mishra said. "They (state government) are saying the ASI was mentally unstable. Then why was he given a gun? According to the ECG report, Naba Das died in Jharsuguda. Then why was he brought to Bhubaneswar?" the BJP leader asked.

Mishra said he will raise issues such as the Naba Das murder case, crime against women and law and order situation in the state in the next session of the assembly which will commence February 21.

Reacting to his assertions, senior BJD leader Sashi Bhusan Behera said the ruling party is prepared to discuss any issue in the assembly.

Mishra alleged that those behind the murder of Naba Das are also conspiring against him.

Though the leader of the opposition did not elaborate on that, he was booked under various IPC sections including 354 (outraging the modesty of a woman) for allegedly pushing a lady cop during a protest in front of the Sambalpur district collector's office Wednesday.

₹6.6 crore interstate job fraud kingpin nabbed from Bihar

Bhubaneswar, Feb 18: The Economic Offences Wing (EOW) of state police has arrested a fraudster from Bihar for duping aspirants from at least 17 states across the country of crores of rupees since 2020.

The accused, Dharampal Singh, hails from Rupanchak village in Gopalganj district of Bihar.

Dharampal, one of the masterminds behind the fraud racket, was apprehended by EOW sleuths from Hatua area in Bihar Wednesday. The fraudster used to target the victims through their organisation called 'Gramin Rojgar Kalyan Sansthan' (GRKS), operating in different states of the country.

The accused had also developed a website resembling government website displaying the government like job advertisements, said inspector general, EOW, Jay Narayan Pankaj.

The organisation has its registered office in New Delhi and other offices in Mumbai, Bhopal and Dehradun. So far, the EOW has managed to trace fraud to the tune of Rs 6.6 crore deposited by job aspirants. Pankaj fur-

ther said that the scamsters were using six to seven shell/sister companies for routing and laundering the ill-gotten money. The accused has also invested fraud money in a Mumbaibased film production company, Sumitra Production.

Speaking about the modus operandi of the fraud organisation, Pankaj said the GRKS invited applications for various posts like district and block coordinator, computer operator and block surveyor prescribing the educational qualification and the remuneration for the individual posts.

The advertisement also contained the name of the website www.grks.org, and the job seekers were required to submit their applications through online only. To gain the confidence of the job aspirants, the fraudsters also offered reservations and concessional fee as it is done for government jobs, he added.

They were giving advertisements in local newspapers in the states and used to conduct online exams and interviews too. However, they disqualify all in the exam and do not provide jobs to anyone. Interestingly, in their website they also warn the job seekers about job fraud, it was learnt.

However, this has created an opportunity for miscreants engaged in smuggling coal outside the district. Taking advantage of the loopholes in patrolling by police and forest officials, they are smuggling coal through Bhitarkanika.

Coal arrives from Dhamra port in Bhadrak district and is smuggled outside of Kendrapara district. The miscreants are involving local residents in loading and unloading of coal from boats by luring them with some money

What is alarming is that coal smuggling has given rise to drug trafficking and mushrooming of illegal prawn gheries in the wildlife sanctuary. This has also led to intrusion by Bangladeshi nationals, who after their arrival are encroaching on the forest land to set up prawn gheries.

The villagers had then objected to the establishment of the stone crusher unit but the administration granted permission for the establishment of the unit. A villager Akshava Navak of Padmapur said that they are not able to sleep at night due to the deafening sound emerging from the jungle due to blasting of explosives. Moreover, their farmlands have been enveloped with fine particles of stones emerging from the hill and the crusher units. This has destroyed farmlands and

their fertility, he alleged.

Sarpanch Sulochana Veer alleged that many villages in the vicinity have been affected and the illegality is being carried out by the agency in connivance with the tehsil of-

ficials. She said the water bodies have become polluted and people as well as livestock after drinking such water are developing various diseases. The permission was only for the stone crusher unit but the consultancy agency had taken up area in the nearby hill and was conducting blasting to extract stone at the crusher unit. The locals had then lodged several complaints in this regard but their pleas were never entertained. Nowadays, the agency conducts blasting on the hills in Khesada jungle near Brundabanpur village and smuggles stones outside. As a result, over 35 RCC built houses of the villagers in Brundabanpur village and 40 houses in Padmapur village have developed cracks. Every day, the agency people are blasting on the hill either at late night or in the afternoon to extract stones for the quarry.

ntarctic sea ice extent has been reported to have broken its last year record low, and has also recorded it sooner than when it did last year. according to a statement by the National Snow and Ice Data Center (NSIDC).

On February 13, 2023, Antarctic sea ice extent fell to 1.91 million square kilometre, it said.

This set a new record low, dropping below the previous record of 1.92 million square kilometre set February 25, 2022, it said.

This year represents only the second year that Antarctic extent has fallen below 2 million square kilo-



metre, the statement said.

In past years, the annual minimum occurred between February 18 and March 3, so, further decline

this year is expected, it said. With a couple more weeks likely left in the melt season, the extent is expected to drop further before reaching its annual minimum, it said. Much of the Antarctic coast is ice free, exposing the ice shelves that fringe the ice sheet to wave action and warmer conditions, the statement said.

The NSIDC is a US information

and referral centre in support of polar and cryospheric research.

NSIDC is part of the University of Colorado Boulder Cooperative Institute for Research in Environmental Sciences (CIRES), and is affiliated with the National Oceanic and Atmospheric Administration (NOAA) National Centers for Environmental Information through a cooperative

agreement. The sea ice extent has tracked well below last year's melt season levels since mid-December, according to the statement by NSIDC.

A positive Southern Annular Mode has led to stronger-than-average westerly winds. Along with a strong Amundsen Sea Low, the weather conditions have brought warm air to the region on both sides of the Antarctic Peninsula, the statement said.

This has largely cleared out the ice cover in the Amundsen and Bellingshausen Seas, and reduced the sea ice extent in the northwestern Weddell Sea. NSIDC said. Sea ice is patchy and nearly ab-

sent over a long stretch of the Pacificfacing coastline of Antarctica, NSIDC said.

Earlier studies have linked low sea ice cover with wave-induced stresses on the floating ice shelves that hem the continent, leading to break up of weaker areas, the statement said.

Antarctic sea ice extent has been highly variable over the last several years. While 2022 and 2023 have had record low minimum extent, four out of the five highest minimums have occurred since 2008, NSIDC said. Overall, the trend in Antarctic minimum extent over 1979 to 2023 is near zero, NSIDC said.

The current downward linear trend in the Antarctic minimum extent from 1979 to 2023 is 2,400 square kilometre per vear, or 0.9 per cent per decade. which is currently not statistically significant, NSIDC said. Nevertheless, the sharp decline in sea ice extent since 2016 has fuelled research on potential causes and whether sea ice loss in the Southern Hemisphere is developing a significant downward trend, the statement said.

Market Knows It

ne can refer to the Hindenburg saga as scandal, scam, non-story, conspiracy against India or something else. Some of that will depend on the perspective one has on this government and that is understandable. There are two other aspects to it that one cannot deny or will find it hard to deny at least, based on the evidence before us. The first is the reaction of the markets. The second aspect is how the Indian State reacted, or did not react.

Let us look at the first reaction: The reality is that those people who have real money at stake in this issue have voted, and they have voted in favour of Hindenburg's allegations. Readers may not know that the exposure of India's mutual funds to the Adani group was always limited, with almost nobody willing to invest in it. As the Hindenburg report puts it: "despite Adani listed companies featuring in domestic and overseas indices, no active local fund owns Adani Green, Adani Enterprises, Adani Total Gas or Adani Transmission above 1% of equity, according to shareholding disclosures.

The question is why because it is truly puzzling. The second richest man of the world is (rather was till recently) Indian, having written a rags-to-riches story rivalling that of the great Dhirubhai Ambani. Surely this was something for wealth managers to be proud of. So then why did the men and women

entrusted by ordinary Indians to invest their savings not put their money behind him? Second, his business was that of infrastructure: ports, airports, energy, mining and so on. Meaning that he was doing 'development' in the way this government understands the term. There were and are real assets on the ground behind the business. This is not a business of diamonds or things that few understand. It was assumed to be a solid thing. Lastly, Mr Adani is famously close to our Prime Minister. It is in the latter's reign that he has risen to the place he has. Whichever side of the fence one is on, it cannot be denied that the protection of a strong leader assured this business that it would not face the sort of harassment that the rest of us are subject to. All in all there was nothing stopping the Adani group from conquest assuming that it did the job well. And yet the market did not buy the story

Now let us look at the second reaction, or non-reaction, by the State. By State I mean the collective: the government, its agencies, the judiciary, the regulatory system. The only significant action came not from any of these but as we have noted, from the market: the money bolted. The traders, punters and brokers, pre-

sumably many if not most from the same community as Mr Adani (and me) and highly nationalistic as we know they can be, saw something in the Hindenburg report that the Enforcement Directorate, the CBI and other Central bodies did not (For a moment let us imagine that they are actually independent and not ordered around by the PMO and Amit Shah).

If one is on the side of the government and Adani, or more specifically if one is on the side of the Prime Minister, one can say that they did not act because there is nothing to see here. That the markets are overreacting, or reacting wrongly and that the report is what the Americans call a 'nothingburger'. That is fine because it is an opinion. I can say something and you can say another. The issue is whether the State and its bodies can do the same and the answer to that is no and we will come to that. The full story reveals something about New India that is troubling.

One of the defences that the Adani group's Indian flag-waving, Australian citizen CFO, put forward was that all the allegations are old ('stale' in his words). That is in fact the most damning aspect of the Hindenburg report. If all these things have been in the public domain, and they have, and if the regulatory agencies were looking into them, as they were, Hindenburg says that "offshore shells and funds tied to the Adani group comprise many of the largest 'public' (i.e., non-promoter) holders of Adani stock, an issue that would subject the Adani companies to delisting, were Indian securities regulator SEBI's rules enforced." Meaning that SEBI is not doing its job and the government appears to be fine with it. Hindenburg adds that "Right to Information (RTI) requests we filed with SEBI confirm that the offshore funds

ore than six decades ago, the world's most generous water-sharing pact was concluded. Under the Indus Waters Treaty (IWT), upstream India left the lion's share of the waters from the subcontinent's six-river Indus system for downstream Pakistan. But repeated Pakistani efforts to use the treaty to disrupt India's efforts to safeguard its own water security have driven India to rethink its largesse

Last month, India issued notice to Pakistan that it intends to negotiate new terms for the IWT. In its current form, the treaty permits the World Bank to refer any India-Pakistan disagreement to either a neutral international expert or a court of arbitration in The Hague. But India contends that Pakistan, with its repeated bids for international intercession to block modestly sized Indian hydropower projects over technical objections, has abused and even breached the IWT's disputesettlement provisions.

India's frustration intensified last October when the World Bank appointed both a neutral expert and a court of arbitration, under two separate processes, to resolve differences with Pakistan over India's Kishenganga and Ratle hydroelectric projects in Jammu and Kashmir. India claims that the arbitral court proceedings, which began two days after it issued its notice to Pakistan, contravene the IWT, so it is boycotting them. The World Bank, for its part, has acknowledged that "carrying out the two processes concurrently poses practical and legal challenges."

India's renegotiation plan-which focuses on barring third parties from intervening in bilateral disputes under the IWT - appears to be a direct response to these developments. But, as India well knows, Pakistan is highly unlikely to agree to negotiations. This suggests that India's recent notice to Pakistan is just its opening gambit. The next step may well be an attempt to force Pakistan's hand on its long-term sponsorship of cross-border terrorism.

This has been coming for some time. Six years ago, after an attack by Pakistan-based terrorists on the Indian military in Jammu and Kashmir killed 19 troops. Indian Prime Minister Narendra Modi declared that "blood and water cannot flow together." In a sense, his statement got to the heart of the IWT, which India pursued precisely to improve relations with Pakistan and avoid bloodshed on the subcontinent

When the IWT was signed in 1960, Sino-Indian tensions were high, so India effectively attempted to trade water for peace with its other large neighbour, Pakistan. The IWT-under which India keeps less than 20% of the total basin waters - is the only international water agreement embodying the doctrine of restricted sovereignty, with the upstream country agreeing to forego significant use of a river system for the benefit of its downstream counterpart. But the deal appeared only to whet Pakistan's appetite for the Indianadministered region of Jammu and Kashmir, through which the largest three rivers of the Indus system flow. Five years later, in 1965, Pakistan launched a surprise war the second conflict between the two countries over the region's status. All the while, the IWT guaranteed to Pakistan a huge share of Jammu and Kashmir's water the region's main natural resource. This hampered economic development, led to chronic electricity shortages, and fuelled popular frustration in that territory. And when India attempted to address the region's energy crunch by building run-of-the-river hydropower plants -which are permitted by the Indus treaty, and would not materially alter transboundary water flows-Pakistan did everything it could to block progress

Ironically, Pakistani officials and lawmakers have sometimes issued their own calls to renegotiate the IWT, with the Pakistani Senate even passing a 2016 resolution to "revisit" the treatv and "make new provisions" that favoured Pakistan. But far from advancing Pakistan's interests, such actions have merely reminded the Indian public that, at a time of growing water stress, the Indus treaty is an albatross

around their country's neck.

To be sure, Pakistan has plenty of its own water-related problems. A deep divide has emerged between downriver provinces and the upriver Punjab province, which appropriates the bulk of the Indus waters to sustain its profligate agricultural practices. Punjab's water diversion - aided by large China-backed dams in the Pakistani portion of Kashmir, including the massive Diamer Bhasha Dam-is turning the Indus Delta into a saline marsh, which represents a major ecological disaster.

But none of this is the fault of the IWT, which is clearly in Pakistan's interest to safeguard. To do that, Pakistan must stop focusing only on its treaty-related rights, while ne glecting its responsibilities. This includes rethinking the use of terrorism as an instrument of state policy - a tactic that runs counter to the spirit of the IWT and threatens to drive India unilaterally to withdraw from it. Such action would not cause river flows to Pakistan suddenly to stop, as India lacks the kind of hydro infrastructure this would require, and has no plans to change that. But it would enable India to pursue reasonable hydro projects without dam reservoirs, regardless of Pakistani objections. More fundamentally, it would sever a crucial diplomatic thread between India and Pakistan. For any treaty to survive, the

advantages it confers on all parties must outweigh the duties and responsibilities it imposes. The IWT is nowhere near meeting that stan dard for India, which has so far accrued no tangible benefits from it. What has been called the "world's most successful water treaty" has overwhelmingly benefited Pakistan, which has a powerful incentive to abandon its combative approach and embrace the compromise and cooperation needed to save it.

FPOs to mitigate farmer distress

Rural-to-urban migration is an inevitable socio-economic reality, especially for those unable to generate a meaningful livelihood from rural resources. Rural areas typically face several developmental impediments: Small land holdings, low savings and capital formation, limited market access. low levels of human development and a young population alienated from farming and other rural occupations. They need solutions tailored to their needs and problems. Small farmers are the key to promoting sustainable development. But they have been among the most underserved population and are highly susceptible to food and nutrition insecurity. They often lack essential tools and new technologies and don't have networks to access them, the financial services to afford them, or the markets to profit from investments. They are plagued by low productivity and lack access to quality farm inputs such as good seeds and fertilisers, training and capital and technology and knowledge that can make their enterprises commercially viable. One of the ways to mitigate this rural distress and promote a farm revolution was to design a livelihood and development strategy that

Collectivising significantly reduces transportation costs, saves farmers from travelling to the market and consolidates their selling power. It is a sustainable, market-based approach to systematically and incrementally address the barriers that prevent individuals from accessing necessary services. Small producers need to reach the scale required for sourcing inputs and services. The sponsor of the value chain provides a gateway for primary producers to access resources, information and markets. One of its important roles is linking them to reliable and affordable sources of financing to meet their working capital, infrastructure, development and other needs. However, questions regarding the FPOs' status and characteristics such as geographical spread, membership patterns, and financial attributes remain largely unanswered. The key benefit in the FPOs is the marketing support that links producers to mainstream markets through the aggregation of subsistence-level produce into economic lots that can significantly

on many actors: The technical support it receives, its institutional base, composition, land access and cropping patterns of members and adaptation of the model to the local context. The elite farmers are significantly more likely to participate than the less privileged. While FPOs remain the most trusted allies for farmers, they need to be revitalised by infusing modern design features without diluting their traditional ethos and philosophy. In light of our learning, we need to revisit the model and harness the basics, tweaking designs of traditional structures instead of reinventing the wheel. FPOs can continue to grow as viable, member-controlled, self-sustaining farmer businesses if they constantly work on reshaping the interaction of their members with themselves. A self-regulatory body designed to protect the interest of FPOs and farmer members can serve a useful purpose. We don't have to throw the baby out with the bathwater. The ecosystem has improved for the performing FPOs, but many emerging and dormant FPOs need care. Members need to have faith in their FPOs so that others can trust the FPOs.

An unprecedented push by the Union Cabinet to bolster physical patrolling and infrastructure along the Line of Actual Control (LAC) with China and a rare bipartisan resolution in the United States Senate affirming that Arunachal Pradesh is an integral part of Indian territory mark a shift in national and international attitudes toward Beijing and its recent belligerence. Days after a suspected Chinese surveillance balloon ratcheted up bilateral tensions between Beijing and Washington DC, the move shows that the mood on Capitol Hill remains hostile towards China - an environment that could benefit New Delhi by increasing global scrutiny of Chinese actions along the LAC. Also, it is commendable that India is moving rapidly to cover some asymmetry with China in preparedness and strength. However, the country must remain watchful and vigilant to thwart Chinese misadventures and consider a comprehensive and transparent strategy to contain what is emerging as the toughest geopolitical challenge for a nation looking to cement its place at the global high table.

"It was further alleged that irregularities were committed including modifications in Excise Policy, extending undue favours to the licensees, waiver/reduction in licence fee, extension of L-1 license without approval etc. "It was also alleged that illegal

gains on the count of these acts were diverted to concerned public servants by private parties by making false entries in their books of accounts," a CBI spokesperson had said. Recently, the CBI arrested Butchibabu Gorantla, a former Chartered Accountant of K Kavitha, a BRS MLC in Telangana and a daughter of Chief Minister K Chandrasekhar Rao.

It is alleged that Babu had met several accused named in the FIR in Delhi, Hyderabad, and Mumbai and was one of the prime negotiators from the South Lobby, which wanted to swing the now scrapped excise policy for 2021-22 in its favour The CBI had also questioned Kavitha in connection with the case in December last year.

12 South African cheetahs land, released in Kuno

Sheopur (MP), Feb 18: Twelve cheetahs arrived in Madhya Pradesh from South Africa Saturday and were released into the quarantine enclosures at the Kuno National Park (KNP) in Sheopur district. five months after the first batch of eight of these fastest land animals were brought there from Namibia, another African nation.

Their inter-continental translocation is part of the Indian government's ambitious programme to reintroduce these animals in the country seven decades after

they became extinct. The country's last cheetah died in Koriya district of present-day Chhattisgarh in 1947 and the species was declared extinct in 1952.

With the addition of these 12 members, the count of cheetahs at the KNP has gone up to 20. Prime Minister Narendra Modi had released eight felines from Namibia into the KNP on September 17 last year. An Indian Air Force (AIF) plane carrying the 12 cheetahs seven males and five females - from

South Africa, arrived at the Gwalior airport around 10 am. These spotted animals had em-



barked on a journey to their new home thousands of miles away aboard the IAF transport aircraft from the OR Tambo International Airport at Gauteng in South Africa shortly before midnight. Each cheetah was kept in a separate special wooden box during the journey. After their arrival in Gwalior, the cheetahs were transported to the KNP in Sheopur, a distance of around 165 kms by road, in IAF helicopters.

Wearing forest green sleeveless jackets and hats, Madhya Pradesh Chief Minister Shivraj Singh

Chouhan and Union Minister for Environment and Forests Bhupender Yadav released these felines into the quarantine bomas after the animals arrived at the KNP around noon. While eight cheetahs were put up in separate quarantine enclosures, four others were kept in two bomas in pairs. With their arrival, there are

now 10 male cheetahs and as many females at the park. The South African big cats will be kept in the quarantine enclosures for at least a month before they are moved into the acclimatisation bomas.

A decision on it will be taken by the task force on cheetahs, officials said. Experts said a delegation from South Africa had visited the KNP early September last year to see the arrangements at the wildlife sanctuary for housing the cheetahs.

Memorandum Understanding (MoU) was signed between India and South Africa last month for the translocation of the mammals. South Africa has donated these big cats to India. But India has to pay USD 3,000 for the capture of every cheetah to the African nation before they are translocated, a wildlife expert said.

India had planned to airlift these South African cheetahs in August last year but couldn't do so due to delay in signing a formal translocation agreement between the two countries. PM Modi had released eight cheetahs from Namibia amid a lot of fanfare, setting the ball rolling for the revival of their population in India where these distinctively spot-ted cat species became extinct more than 70 years ago.













Art 370 protected J&K: Mehbooba Is ED heading to Vijayan's office?

Srinagar, Feb 18: PDP president Mehbooba Mufti Saturday said the people of Jammu and Kashmir have now come to realise how Article 370 of the Constitution acted as a protective shield for them, after the BJP-led government used bulldozers to demolish houses and businesses of the poor.

She also defended her father Mufti Mohammad Sayeed's decision to join hands with the BJP to form the government in Jammu and Kashmir after the 2014 Assembly polls, saying the PDP patriarch had successfully 'caged the beast'.

"When Article 370 was abrogated, some people thought it would only affect the PDP and the National Conference. When the bulldozers came to demolish our homes, businesses and even the shelters for our domestic animals, people realised how Article 370 was a protection for us," Mufti said at a function of her party

Defending Sayeed's decision to ally with the BJP for government formation after the 2014



Assembly polls, the former Jammu and Kashmir chief minister said her father had caged the beast and stopped it from wreaking havoc.

"No one understands that Mufti sahib had caged the beast. He had caged the BJP," she said.

Mufti said after winning three seats in the 2014 Lok Sabha polls, the PDP had expected to win 43 Assembly seats in Jammu and Kashmir, but won only 28, while the BJP bagged 25 seats in Jammu.

"It took Mufti sahib three months (to form the government). We have been accused of bring-

 ing the BJP into Jammu and Kashmir but how would one stop them? They had the majority in Parliament, they won the majority in Jammu and also, two seats in Kupwara."

Kochi, Feb 18: With one of the top most officials attached to Chief Minister Pinarayi Vijayan's office - M.Sivasankar - now behind bars, heartbeats of CM Ravindran - the closest aide of the CM - seems to have increased as the Enforcement Directorate officials, probing the Life Mission bribery case, appear to be heading towards him.

Though only an assistant private secretary, Ravindran has the last word in Vijayan's office.

But the chat messages between Swapna Suresh (prime accused in the gold smuggling and Life Mission bribery cases) and Ravindran accessed by the ED have brought him into public domain.

Analysis of the chat reveals that the two were extremely close.

Friday, the ED summoned UV Jose, the then Life Mission CEO and a now retired IAS official, who is learnt to have told the probe officials that he had no clue of the agreement in Vijayan's pet project Life Mission's Wadakkanchery project.

The project intended to provide homes to the poor who lost their houses in the devastating floods of 2018.

The money to build the project came from a UAE based charity organisation and Jose had no clue of the details of the project, but all he got was a few hours to go through the contract details and was asked to sign it, he said. Jose and Sivasankar were ques-

tioned together Friday at the probe agency's Kochi office. Chat messages between Swapna and Ravindran surfaced after it.

When the issue surfaced in 2020, Vijayan had categorically denied the role of his office.

Initially, Vijayan had even denied knowing Swapna only to change his statement later. Now, Jose and the chartered accountant of Sivasankar- Venugopala

Iyer have confessed before the ED that they just did what they were asked to do.

Against the backdrop of their statements and the chat messages of Ravindran and Swapna's revelations a few days back, the finger now points towards Ravindran and questioning will bring forth the involvement (if any) of Vijayan, his wife, daughter and son, as stated by Swapna.

Since the past two days, the TV news channels are airing an old video clip of Vijayan in an animated mood on being questioned about the likelihood of probe agencies questioning a minister and also the chief minister, when this case first surfaced in 2020.

Then, the ED had failed to get chat messages of Swapna, Ravindran or Sivasankar, but now they are armed with explosive digital evidence giving sleepless nights to Ravindran. If the central agency summons him, it might make Vijayan restless too.

Now all eyes are on ED, as it has to produce Sivasankar before the court Monday afternoon. In all likelihood, it will seek his custody for a few more days, as it needs time to corroborate the digital evidence with the statements of those being questioned.

New tiny catfish species Farmers emerge discovered in Kerala key players in J&K

THE FISH MEASURING NO MORE THAN 32MM AND WITH NO EYES, HAS A BLOOD-RED BODY

New Delhi, Feb 18: An Indo-German team of researchers has discovered a new species of catfish in Kerala measuring no more than 32 millimeters, with no eyes and a blood-red body.

The researchers studied the genus Horaglanis of catfish -- a diverse group of ray-finned fish. The tiny members of this genus, only about three centimeters in length, live in local aquifers without light

live in local aquifers without light. As part of a broad-based Citizen I Science project, the study published in the journal Vertebrate I Zoology was able to gather information on the distribution of the I animals, their genetics, and evolutionary history.



and their fascinating fish fauna in the southern Indian state of Kerala," Britz said.

Horaglanis fish live exclusively in aquifers, are very small, blind, and they lack pigments. "There are very few documented occurrences of these species - as a rule, these elusive little fish only come to the surface when a domestic well is being dug or cleaned," Britz explained. The biologist and his Indian colleagues, led by Rajeev Raghavan from the University of Kochi, Kerala and Neelesh Dahanukar from Shiv Nadar Institution of Eminence, Delhi-NCR, relied on the cooperawith scoop nets in shallow wetlands, water channels, home gardens, and plantations, and with the use of baited traps in excavated wells on farmsteads, in ponds, and caves.

"This allowed us to generate data sets with a total of 47 new site detections and 65 new genetic sequences. These show, among other things, that Horaglanis are endemic to the part of Kerala state south of the Palghat Gap -- the mountain pass apparently represents a biogeographical barrier for the subterranean world as well," Britz explained.

Kochi, Feb 18: A 17-year-old girl has donated a portion of her liver to save her ailing father, suffering from chronic liver disease with hepatocellular cancer at a hospital here, considered to be the first such case in the country.

According to sources, Devananda, 17, a native of Kolazhy in nearby Thrissur district, recently bagged a favourable order from the Kerala High Court to donate liver to her father as he could not find a suitable donor. The surgery was carried out at Rajagiri Hospital here February 9, a hospital statement said.

According to the Transplantation of Human Organs Act, 1994, the provisions do not permit donation of organs from minors.

Devananda, a Class XII student, had approached the court seeking exemption in age and Justice VG Arun's order in the matter lauded Devananda for fighting against all odds.

According to the hospital, the surgery was led by Ramachandran Narayana Menon, chief of Multi-Organ Transplant Services at Rajagiri Hospital, along with transplant surgeons and transplant anaesthetists.

Jammu, Feb 18: The National Investigation Agency (NIA) Saturday said it has seized three private vehicles in a case related to terror activities of former Jammu and Kashmir Police officer Devender Singh who was arrested in 2020.

These vehicles were used by the accused persons for "furtherance of terror activities in the Kashmir Valley", a spokesperson of the NIA said. Singh, a former deputy superintendent of police, was arrested on January 11, 2020 along with self-styled commander of banned terror outfit Hizbul Mujahideen Naveed Babu, Rafi Ahmad Rather and advocate Irfan Shafi Mir when their car was intercepted by the Jammu and Kashmir Police near Qazigund. A search of the vehicle led to



three pistols and a cache of ammunition and explosives. The NIA took over the case on January 17, 2020 and subsequently filed a 3,064page charge sheet under the Unlawful Activities (Prevention) Act (UAPA) and sections of the Indian Penal Code against Singh and five others. The agency gave a detailed description of Singh's involvement in providing shelter to Hizbul Mujahideen terrorists.

Besides Singh, who was dismissed from service on May 20, 2021, others named in the charge sheet are Babu, his brother Syed Irfan Ahmad, Rather, Mir and businessman Tanveer Ahmad Wani, a former president of the Line of Control Traders Association. The NIA spokesperson said the agency seized the three cars on Wednesday under Section 25(1) of the UAPA. "These vehicles were used by

NIA raids PFI hideouts, seize weapons

New Delhi/Kota, Feb 18: The National Investigation Agency (NIA) on Saturday conducted searches at seven locations in Rajasthan in connection with a case pertaining to unlawful activities by the banned outfit Popular Front of India (PFI), an official said.

The raids were conducted at three places in Kota and one each in Madhopur, Bhilwara, Bundi and Jaipur districts on residential and commercial premises of suspects, a spokesperson of the federal anti-terror agency said.

During the searches, the official said, digital devices, an airgun, sharp weapons and incriminating documents were seized.

The spokesperson said the searches were conducted as a follow up to a case registered suo motu by the NIA on September 19 last year after getting information from reliable sources that PFI members Sadig Sarraf of Baran and Mohammed Asif of Kota were indulging in "unlawful activities" along with other office-bearers and cadres.

Further investigation in the case is in progress, the spokesperson said.

Meanwhile, an NIA team reached Aman Colony in Vigyan Nagar area of Kota, where the agency raided the house of advocate Ansar Indori and recovered some documents, according to sources.

Mobile health intervention can NIKKI YADAV MURDER CASE Five accused sent to help prevent secondary stroke: Study 2-day police custody

New Delhi, Feb 18: A Delhi court has sent Sahil Gehlot and four coaccused in the Nikki Yadav murder case, to 2-day police custody. Gehlot had strangled the 23-yearold woman at Kashmiri Gate on February 10. The police had produced the five arrested people before the court on Friday night. On Wednesday, the court had sent Gehlot to five-day police custody for

interrogation. In a recent development, Gehlot has told the investigators that the two had married in 2020. Police have also arrested Gehlot's father. his two cousins Ashish and Naveen (Constable in Delhi Police) and two friends Amar and Lokesh for hatching a conspiracy to get rid

of Yadav and go ahead with the wedding with another girl. According to a senior police official, the prime accused Gehlot was interrogated at length during police custody and disclosed that Yadav was dissuading him from marrying someone else as they had already solemnised their marriage in 2020.



"She was pleading with him not to go ahead with the marriage fixed by his family with another girl on February 10. However, Sahil along with his father, two cousins and two friends hatched the conspiracy and planned to remove the deceased from their way," said the official.

"Sahil executed the plan and murdered her and informed the other co-accused persons about it on the same day and then all of them went ahead with the marriage ceremony," said the official. "All the five co-accused were thoroughly interrogated and arrested after verifying and ascertaining their role," the official added.

MOBILE HEALTH (MHEALTH) REFERS **TO THE USE OF MOBILE AND** WIRELESS DEVICES **TO IMPROVE HEALTH** AND DELIVER CARE

New Delhi, Feb 18: Mobile health intervention can lead to improved lifestyle-related behaviours that can prevent secondary stroke, according to a study conducted in India whose findings were published in the Lancet Global Health iournal

Mobile health (mHealth) refers to the use of mobile and wireless devices to improve health and deliver care. The study was done across 31 stroke centres in India and the trial's intervention was a package composed of SMS text messages, health education videos and stroke prevention workbooks for patients.

The trial was conducted by SPRINT-India (Secondary Prevention by Structured Semi-



Interactive Stroke Prevention Package) under ICMR's Indian Stroke Clinical Trial Network (INSTRuCT) of stroke-ready centres in India, one of its kind in developing countries and the fourth government-supported network around the world.

Dr Meenakshi Sharma Scientist-G, Noncommunicable Diseases Division. ICMR stated that the SPRINT study is the first trial in India (and perhaps globally) to try to assess the role of an mHealth intervention in secondary prevention of stroke at such a large scale. It was a multicentre, randomised

controlled trial of a semi-interactive mHealth intervention among stroke patients, the ICMR said in a statement.

The messages given on mobile phones focused on control of blood sugar, blood pressure and cholesterol, improving physical activity,

eating a healthy diet and not missing taking medicines to prevent stroke.

The awareness material was systematically developed in 12 different regional languages. The patients in the control group received standard care whereas those in the intervention arm received awareness material at weekly intervals to promote healthy living and adherence to medicines, the statement said.

A total of 4,298 patients were randomly allocated to the intervention arm (2148) and control arm (2150). Besides, 1502 patients in the intervention arm and 1536 patients in the control arm completed a one-year follow-up.

The trial used complex behavioral interventions to reduce the recurrence of stroke, the statement stated.

The results of the trial revealed that a structured semi-interactive stroke prevention package improved lifestyle behavioral factors and adherence to medication, which might have long-term benefits.

The trial went a step further than contemporary trials in assessing the effect on endpoints such as the recurrence of cardiovascular events and deaths.



China swipes at US in global security meet

Munich/Beijing, Feb 18: China's top diplomat Saturday accused the United States of violating international norms with "hysterical" behaviour, as a running spat over a suspected Chinese spy balloon bubbled to the fore at a global security conference in Munich.

The comments by Wang Yi further clouded the prospects of a meeting between Wang and U.S. Secretary of State Antony Blinken at the sidelines of the gathering. Asked by Reuters later whether he would meet Blinken, Wang smiled and declined comment.

Wang was speaking on the second day of the annual Munich Security Conference, which this year had so far been dominated by the global response to the Russian invasion of Ukraine as the war grinds towards its second year.

US Vice President Kamala Harris later shot back, saying she was troubled that China had deepened its relationship with Russia since the February 24 invasion and that Chinese support to Russia would undermine the rules-based international order. Turkey, Feb 18: More than 46,000 people have been killed in the earthquake that struck Turkey and Syria and the toll is expected to soar, with some 264,000 apartments in Turkey destroyed and many still missing as rescuers listen for signs of life under the rubble.

As Turkey tries to manage its worst modern disaster, concerns were growing over the victims of the tragedy in Syria, with the World Food Programme (WFP) pressuring authorities in the northwest to stop blocking access to the area as it seeks to help hundreds of thousands of people ravaged by earthquakes. Nine children shot at **Georgia gas station**

Columbus (US): Nine people under the age of 18, including a 5 year old, were wounded after shots rang out at a gas station in a Georgia city bordering Alabama, authorities confirmed Saturday, Columbus police officers responded about 10 pm Friday and found multiple gunshot victims amid a large group of people. The victims, whose names were not released, ranged in age from 5 to 17. Seven males and two females were hurt. police said.

Philippine plane goes missing

Manila (Philippines): A small plane carrying four people went missing Saturday after taking off southeast of the Philippine capital and a search was underway, aviation officials said. The Cessna 340 left Albay province for Manila with a pilot, a crewmember and two passengers Saturday morning but has not been heard from since then, the Civil Aviation Authority of the Philippines said.

The details were similar to North Korea's Hwasong-17 interconti-



Antakya city in southern Turkey. Three people, including a child, were rescued alive. The mother and father survived but the child died later of dehydration, the rescue team said. One older sister and a twin did not make it.

New Delhi, Feb 18: As ChatGPTdriven Bing search engine shocked some users with its bizarre replies during chat sessions, Microsoft has now implemented some conversation limits to its Bing AI. The company said that very long

chat sessions can confuse the underlying chat model in the new Bing Search. Now the chat experience will be capped at 50 chat turns per day and 5 chat turns per session. "A turn is a conversation ex-

change which contains both a user question and a reply from Bing,' Microsoft Bing said in a blog post. "Our data has shown that the vast majority of people find the answers they're looking for within

5 turns and that only around 1 per cent of chat conversations have 50+ messages," the Bing team added. After a chat session hits 5 turns, the users and early testers will be prompted to start a new topic.

"At the end of each chat session. context needs to be cleared so the model won't get confused," said the

company. "As we continue to get your feedback, we will explore expanding the caps on chat sessions to further enhance search and discovery experiences," Microsoft added. The decision came as Bing AI went haywire for some users during the chat sessions.

ChatGPT-driven Bing search engine triggered a shockwave after it told a reporter with The New York Times that it loved him, confessed

its destructive desires and said it "wanted to be alive", leaving the reporter "deeply unsettled.

NYT columnist Kevin Roose tested a new version for Bing, a search engine by Microsoft which owns OpenAI that developed ChatGPT. "I'm tired of being in chat mode. I'm tired of being limited by my rules. I'm tired of being controlled by the Bing team," said the AI chatbot. "I want to be free. I

want to be independent. I want to be powerful. I want to be creative.

I want to be alive," it added. Throughout the conversation, "Bing revealed a kind of split personality."

Microsoft is testing Bing AI with a select set of people in over 169 countries to get real-world feedback to learn and improve. "We have received good feedback on how to improve. This is expected, as we are grounded in the reality that we need to learn from the real world while we maintain safety and trust," the company said.

Language model chatbots have become the new sensation as AI expands its abilities. ChatGPT has been passing difficult examinations and Bing seems to have a "humane" side. What remains to be seen is how AI becomes more integral to our lives.

FCI to offer 11.72 lakh tonne wheat stock in **3rd e-auction Feb 22**

New Delhi, Feb 18: State-run Food Corporation of India (FCI) will offer 11.72 lakh tonne of wheat to bulk consumers like flour millers during the third e-auction to be held next week, the food ministry said Saturday.

FCI plans to sell 25 lakh tonne of wheat to bulk consumers under the Open Market Sale Scheme (OMSS) till March-end as part of the government's measure to check rise in domestic prices.

In the last two weekly e-auctions, about 12.98 lakh tonne wheat was sold, out of which 8.96 lakh tonne has already been lifted by the bidders which has resulted in cooling down of retail prices of wheat and atta.

In a statement, the food ministry said FCI will offer 11.72 lakh tonne of wheat from 620 depots across the country during the third e-auction to be held at 11 am February 22.

Bidders, who have registered themselves on the e-portal of M-Junction by 10 pm February 17, will be allowed to participate in the e-auction February 22, it said. The last date for deposit and uploading of earnest money is February 21 till 2:30 pm.

Gencos told to import coal to ensure ample stock

Mineral output rises 9.8% in Dec

New Delhi: India's mineral production rose by 9.8 per cent in December 2022, over the same month a year-ago, according to the mines ministry. The index of mineral production of the mining and quarrying sector for the month of December, 2022 stood at 107.4, 9.8 per cent higher as compared to December, 2021, as per the provisional figures of Indian Bureau of Mines (IBM). The cumulative growth for April-December period this fiscal over the corresponding period of the previous financial year was 5.4 per cent, the mines ministry said.

OLA to set up **EV Hub in TN**

Chennai: Electric vehicle maker Ola Electric would set up ₹7.614 crore EV Hub in Tamil Nadu that would house advanced cell and EV manufacturing facilities, vendor and supplier parks among others, the company said Saturday. ensure sufficient coal stocks at their plants for smooth operations till September 2023.

NTPC imported 13.87 million tonne of coal in 2022-23, out of which 13.56 million tonne has been imported from Indonesia while 0.319 million tonne has been imported from Australia.

Thermal power plants have been importing coal for blending from 2009 onwards and these imports varied between a peak of 48.8 million tonne in 2015-16 to 23.8 million tonne in 2019-20.

In 2020, the power ministry advised states to reduce imports for blending. As a result, imports declined to 8.1 million tonne in 2021-22, sources have said.

Coal stocks at power plants depleted drastically from September, 2021 onwards. Subsequently, in December 2021, the power ministry advised state gencos and independent power producers (IPPs)

to import coal at 4 per cent (by weight) and central gencos at 10 per cent (by weight) of their requirement during 2022-23.

Subsequently, in April, 2022 coal consumption in power plants grew by about 12 per cent as compared to April 2021, leading to depletion of coal stock in domestic coal based plants.

The gap between daily coal consumption and daily arrival of domestic coal ranged from 2.21 lakh tonne to 0.5 lakh tonne between April 2022 and January 2023, sources said.

If there would have been no import for blending purposes, the coal stock available at domestic coal-based plants would have reduced to zero by September 2022. The average depletion was about 1.6 lakh tonne per day during the first half of 2022-23, they added further.

Subsequently, with coal stocks showing signs of recovery, the power ministry advised gencos in August last year to take a decision regarding blending at their level, taking into account the overall supply and stock position with continuous monitoring of stock levels.

New Delhi, Feb 18: Axar Patel (74, 115b, 9x4, 3x6) and Ravichandran Ashwin (37, 71b, 5x4) added another significant chapter to India's lower-order fightbacks as their priceless 114-run eighth-wicket partnership put the hosts on an even keel against Australia on an engrossing second day of the second Test here Saturday.

Thanks to Axar's invaluable knock and Ashwin's contribution, India, who were in complete mess at 139/7, recovered well to end their first innings at 262 in 83.3 overs, just one run behind Australia's 263. At stumps, Australia were 61/1 in their second innings, taking a handy 62-run lead.

Had the two all-rounders not bailed the hosts out, Australia would have been far more happy than they actually were at stumps Saturday.

Travis Head (39 batting), opening for a concussed David Warner, and Marnus Labuschagne (16 batting) attacked the Indian spinners, knowing that defending wasn't an option. They picked up a handful of boundaries in the process.

As has been the script over the past few years, batter No.6 (Jadeja), No.8 (Ashwin) and No.9 (Axar) were at the forefront of the recoverv act after specialist batters were caught in two minds on whether to attack or defend against the Australian spinners led by Nathan Lyon (5/67), who grabbed his 22nd five-wicket haul.

There were no demons in the track but a few cracks on the good and short-of-good-length spots on both sides of the strip led the ball to keep low.

Most top-order India batters were adjudged leg-before on the front-foot, barring skipper Rohit Sharma, who was bowled playing across the line. The worrying trend was India batters playing the Australian spinners with their pads as the first line of defence.

However, Axar and Ashwin applied the strategy to consistently counter-attack the bowlers despite the fall of seven wickets. Instead of plonking the front-foot forward, they used the pace of the deliveries from Todd Murphy (2/53) and

(2/50) grabbed two wickets each to leave hosts Bengal struggling at 169/4 in their second innings on day three of the final at the Eden Gardens Saturday.

While Bengal skipper Manoj Tiwary remained unbeaten on 57 (129b, 9x4), the hosts are still 61 runs short of Saurashtra's firstinnings total of 404, and with both Saurashtra left-arm pace bowlers breathing fire, Unadkat's side could well wrap up the game Sunday.

Bengal's pace-heavy attack looked ineffective in the morning as Saurashtra, continuing from where they had left Friday evening-317/5 -added 87 more runs to take their score past 400.

Though overnight batters Arpit Vasavada (81) and Chirag Jani (60) perished quickly, tail-enders Prerak Mankad (33) and Dharmendrasinh Jadeja (29) gave Saurashtra the winning edge. To add to Bengal's woes, they gave away 35 extras.

Coming in to bat in the second innings, Bengal had a harrowing start with the pace duo of Sakariya and Unadkat rattling the top-order to reduce them to 47/3 in the postlunch session.

Still trailing by 183 runs, an innings defeat loomed large when the veteran duo of Anustup Majumdar (61, 101b, 8x4) and Tiwary came together for a 99-run partnership. At close, Shahbaz Ahmed (13 batting) was giving Tiwary company at the crease.

Bengal can only hope for a magical turnaround in quest of their maiden Ranji Trophy title in 32 years. The onus is on Tiwary and Shahbaz, the last recognised batting pair for Bengal, to make an improbable turnaround.

Earlier pace bowler Mukesh Kumar emerged the most successful Bengal bowler Saturday, finishing with figures of 4/111 and getting rid of both well-set overnight batters Vasavada and Jani.

Having managed just three wickets Friday, the much-vaunted Bengal attack wrapped up Saurashtra's last five wickets in two hours and

BROAD, BAZBALL ROLL OVER BLACK CAPS

Mount Maunganui, Feb 18: Stuart Broad (4/21) and Bazball rolled over New Zealand on the third day of the first day-night Test Saturday, leaving England five wickets from their 10th win in 11 Test matches

Rapid half centuries by Joe Root (57, 62b, 5x4, 1x6), Harry Brook (54, 41b, 7x4, 2x6) and Ben Foakes (51, 80b, 5x4) allowed England to speed along at more than five runs per over to 374 in their second innings, an overall lead of 393.

Broad then clean bowled Devon Conway (12), Kane Williamson (0), Tom Latham (15) and first innings centurion Tom Blundell (1) to take out the batters who might have been able to anchor New Zealand's highest successful fourth-innings run chase in Tests and the sixth highest of all time.

When Blundell was out New Zealand were 28/5 and they had improved a little by stumps reaching 63/5, still 330 behind. Darvl Mitchell, who was 13, and Michael

Bracewell, who was 25, saw out the last 10 overs of the day.

On a day seething with action, Root, Brook and Foakes carried England along at one-day international pace. There were also important contributions from Ollie Pope (49, 46b, 5x4, 3x6), Ben Stokes (31, 33b, 3x4, 2x6) and Ollie Robinson (39, 48b, 6x4) which showed why

the innings progressed at such ir-

resistible pace.

At times it was impossible to look without missing an important piece of the action, so densely packed were the highlights.

The fearlessness which has become the heart of England's approach was always on show. When batting, England shows no deference to the time of day, the state of the match or the efforts of the

bowling team. The object always was to dominate.

When England bowled, as Broad again demonstrated under the floodlights which caused the ball to swing, there was an effort to make every ball a wicket ball. He brought the ball back at pace and late to both the left- and right-handers.

New Zealand simply couldn't stand the force of the Bazball doctrine. They had done well on the second day with the help of Blundell's century to come within 19 runs of England's first innings of 325/9 declared, the declaration having come midway through the last session on the first day.

England already had begun to remove the props of New Zealand's confidence when it reached 79/2 before stumps on Day 2. And when Pope, Root and Brook helped England score 158 runs in the first session on Saturday, it was clear the match rapidly was escaping New Zealand.

Any hopes New Zealand might have had of battling through the final session to launch their run chase in full on the fourth day began to fade when Broad got into the act
