#### **SC turns down plea for** uniform marriage age

New Delhi: The Supreme Court Monday turned down a plea seeking uniform minimum age for marriage for both men and women, saving there are some matters which are reserved for Parliament and courts cannot enact a law. A bench headed by Chief Justice DY Chandrachud said the top court cannot issue a mandamus (an extraordinary writ) for parliament to legislate. "We must defer to the Parliament. We can't enact law here. We should not perceive that we're the exclusive custodian of Constitution Parliament is also a custodian," the bench observed while declining to allow the plea.

## **Naba Das assassination** may set House on boil

Opposition readies ammo to target the ruling BJD during Budget Session of Odisha Assembly beginning today

Bhubaneswar, Feb 20: With Odisha Police yet to ascertain the motive behind the assassination of minister Naba Kishore Das by a policeman even after 23 days, the opposition BJP and Congress announced they will make the incident a major issue during the Budget Session of the Assembly commencing Tuesday.

The BJP Monday held islative party meeting, while BJD and Congress would hold their meetings Tuesday to prepare strategies for the session.

"A cabinet minister was killed in broad daylight by a police official. Although nearly a month has passed into the murder of Naba Das, the Crime Branch is vet to ascertain a conclusive motive behind the murder," said BJP chief whip Mohan Majhi. There is no law and order in the state. So, the BJP will raise the minister's murder case as its major issue in the Budget Session, he said. Apart from the murder case, the BJP will also raise farmers' plight, irregularities in Pradhan Mantri Awas Yojana (PMAY), free rice scheme of the Centre and harassment case against Tirtol BJD MLA during the session.

Congress Legislature Party (CLP) leader Narasingha Mishra slammed the BJD government over the minister's murder case and said his party will raise the issue in the House. Stating the main issue for the Budget Session is deteriorating

#### **ED raids Congress** leaders in Ch'garh

New Delhi, Feb 20: The Enforcement Directorate(ED) Monday conducted raids at over a dozen locations in Chhattisgarh including at premises linked to state Congress leaders as part of an ongoing probe into the alleged coal levy scam, officials said.

The raids that were underway over 12 hours after they were launched early this morning come days before the start of the threeday plenary session of the Congress party which is in power in the state. The three-day session begins February 24 in Raipur.

## Biden springs Kyiv visit surprise

#### THE US PRESIDENT MEETS UKRAINIAN COUNTERPART IN A SHOW OF SOLIDARITY BEFORE THE FIRST ANNIVERSARY OF RUSSIA'S INVASION

Kyiv, Feb 20: US President Joe Biden made an unannounced visit to Ukraine Monday to meet with President Volodymyr Zelenskyy, a striking gesture of solidarity that comes days before the oneyear anniversary of Russia's invasion of Ukraine.

Biden spent more than five hours in the Ukrainian capital, meeting Zelenskyv at Mariinsky Palace. honouring the country's fallen soldiers and meeting with US Embassy staff in the war-torn country.

In his remarks with Zelenskyy, Biden recalled the fears nearly a vear ago that Russia's invasion forces might quickly take city.

"One year later, Kyiv stands,"

## What's the safest seat on an airplane?

Queensland, Feb 20: When you book a flight, do you wonder which seat will protect you the most in an emergency? Probably not. Most people reserve seats for comfort, such as legroom, convenience, or easy access to the toilet. Frequent flyers sometimes reserve their seat as close as possible to the front of the plane to be able to disembark more quickly.

We rarely book a flight expecting to get one of the middle seats in the last row. Well, guess what? These seats are statistically the safest on an airplane.

Air travel is safe

Before getting to the heart of the matter, let's reiterate the fact that air transport is the safest mode of transport. In 2022, there were just under 70 million flights worldwide, with just 174 fatalities.

According to analysis of census data by the US National Security Council, the odds of dying on an airplane are approximately 1 in 205,552, compared to 1 in 102 in a car. Despite this, we pay little attention to road fatalities, but when we hear about a plane crashing, it's front page news.

Our interest in plane crashes may lie in our desire to understand why they happen, or what the chances are of them happening again. And that may not be a bad thing: our interest helps ensure that these tragic incidents are thoroughly investigated, which contributes to the safety of air travel.

There's really no need to worry about safety when boarding a commercial flight. But if you still have that nagging question in





## SC turns down plea for uniform marriage age

**WE SHOULD NOT PERCEIVE THAT** WE'RE THE EXCLUSIVE **CUSTODIAN OF** CONSTITUTION. **PARLIAMENT IS ALSO** A CUSTODIAN, SAYS THE APEX COURT

New Delhi, Feb 20: The Supreme Court Monday turned down a plea seeking uniform minimum age for marriage for both men and women, saying there are some matters which are reserved for Parliament and courts cannot enact a law.

A bench headed by Chief Justice DY Chandrachud said the top court cannot issue a mandamus (an extraordinary writ) for parliament to legislate. "We must defer to the Parliament. We can't enact law here. We should not perceive that we're the exclusive custodian of Constitution. Parliament is also a custodian," the bench observed while declining to allow the plea.

The apex court was hearing a petition filed by advocate Ashwini Upadhyay seeking equality in the legal age of marriage for men and women. Men in India are permitted to get married at the age of 21, while the marriageable age for



'The petitioner seeks that women's age of marriage should be increased to 21 to be par with men. Striking down of provision will result in there being no age for marriage for women. Hence, petitioner seeks a legislative amendment. This court cannot issue a mandamus for parliament to legislate.

'We decline this petition, leaving it open to petitioner to seek appropriate directions," the bench, also comprising Justices PS Narasimha and JB Pardiwala said. The petitioner said the plea was filed raising a legal question and forming a task force to look at the issue will not serve the purpose.

The difference in marriage age violated the principles of gender equality, gender justice and dignity of women, the petition claimed. The plea contended, "The petition challenges a blatant, ongoing form

petition claimed of discrimination against women. That is the discriminatory minimum age limit for marriage for

men and women in India. "While men in India are permitted to get married only at the age of 21 years, women are allowed to get married when they are 18. This distinction is based in patriarchal stereotypes, has no scientific backing, perpetrates de jure and de facto inequality against women, and goes completely against global trends.

"...It is a social reality that married women are expected to perform a subordinate role vis-a-vis the husband and this power imbalance is deeply aggravated by the age difference," it said. The younger spouse is, therefore, expected to respect and be servile to her elder partner, which aggravates the preexisting gender based hierarchy in the marital relationship, the pe-

#### Ex-VLW gets 2-yr RI in corruption case

Bhubaneswar, Feb 20: A special Vigilance court here Monday sentenced a person to two years rigorous imprisonment (RI) after finding him guilty of taking bribe to issue work order to a contrac-

The convict was identified as Sushant Kumar Sahoo, former village level worker (VLW) and incharge of the secretary of Chhamundia panchayat under Gania block in Nayagarh district.

The convict has also been asked by the court to pay ₹4,000 as penalty under two different sections of Prevention of Corruption Act, 1988. Sushant has to serve additional imprisonment for two months if he fails to deposit the amount within the stipulated time.

"One Mula Ray lodged an FIR before SP, Vigilance, Bhubaneswar 22.12.2009 alleging inter-alia that the accused Sushant Kumar Sahoo demanded bribe of ₹1800 from him for issue of work order for construction of platform of village well. A trap was laid on 22.12.2009 and the accused Sushant Kumar Sahoo was caught red-handed while demanding and accepting bribe of ₹1800 from the informant Mula Ray at Gania Block Office. The bribe money was recovered from the possession of the accused," revealed special public prosecutor Hemanta Kumar Swain.

The court went through statements of seven witnesses, several documents and material objects during trial before pronouncing the judgement. The case was conducted by Swain on behalf of the Vigilance.

# Mangu Mutt petition dismissed in SC

New Delhi, Feb 20: The Supreme Court Monday dismissed a contempt petition filed against the state government for demolishing 500 year old Mangu Mutt in a demolition drive in Puri.

A two-judge bench of Justice MR Shah and Justice CT Ravikumar dismissed the petition stating that it won't initiate contempt proceedings in the matter.

"We see no reason to initiate contempt proceedings. The contempt proceedings stand dismissed," the bench said.

The contempt petition was filed alleging non-compliance of the Supreme Court order of 2019 in Mrinalini Padhi vs Union of India case over construction of Mutt around Shri Jagannath Temple in Puri.

Senior advocate Anand Grover submitted during the hearing that the Mutt was not supposed to be demolished. He submitted that Guru Nanak himself visited this shrine 500 years ago. The contempt petitioners submitted in the apex court that the state government had violated the apex court order of November 2019 by demolishing centuries-old Mangu Mutt in Puri.

The contempt petition was filed alleging non-compliance of the Supreme Court order of 2019 in Mrinalini Padhi vs Union of India case over construction of Mutt around Shri Jagannath Temple in Puri

The petitioners submitted that the Odisha government had filed an additional affidavit in the Supreme Court in October 2019 stating that the deities, sanctum sanctorum, gaadi, Samadhi and relics of the Mutt will not be disturbed and remain at their current place with better beautification in line with Kalinga style architecture.

However, the government had demolished the centuries-old Mangu Mutt in order to construct a security corridor around Shree Jagannath temple, the petitioner said. It was further submitted that the Sikh community gathered and started protesting against such demolition as it was harmful to their faith and rituals.

#### Over 5gm brown sugar seized; 2 held

**Bhubaneswar:** Jatni police arrested two drug peddlers and seized five and a half gram of brown sugar from them, Monday. Police have filed a case (59/23) against the two culprits- Rakesh Kumar Harichand alias Dipu of Rajabazar, Khuntia sahi and Lokanath Mohapatra alias Loka of Kusumati Tangisahi. On receiving information, an independent team of Jatni police raided the Kudiari M.A. school field and caught the two peddlers with the cotrabands. Of the two peddlers Lokanath has two previous cases registered against him in the Jatani police station, informed the police.

## Centre announces 100-bed ESIC hospital in Balasore

New Delhi, Feb 20: The Union Labour and Employment Ministry Monday approved the proposal for setting up of a 100 bedded Employees' State Insurance Corporation (ESIC) hospital at Balasore in the state.

Union Labour and Employment Minister Bhupender Yadav, while chairing 190th Meeting of ESIC, also announced Hospitals at Belagavi (Karnataka), Shamshabad (Telangana), Baramati (Maharashtra), Kishangarh, Ajmer (Rajasthan) and 30 bedded ESI Hospital at Kurnool (Andhra Pradesh) and 350 bedded ESI Hospital at Greater Noida (Uttar Pradesh). The minister said the decision has been taken after considering the increase in the number of workers.

The ministry said in order to provide relief to insured workers who became unemployed during the Covid-19 pandemic, ESI Corporation, in the meeting, agreed to the proposal of extending the benefits available under Atal Beemit Vyakti kalyan Yojana (ABVKY) for two more years. ABVKY is a welfare measure in the

form of cash compensation up to 90 days once in lifetime of the worker in the contingency unemployment.

Foreseeing the considerable increase in the number of insured workers and their dependents coming under the ambit of ESI Scheme after the implementation of Social Security Code – 2020, Bhupender Yadav directed ESIC to lay emphasis on strengthening and expanding the medical services infrastructure by adopting multipronged strategies for providing primary medical care to the IPs and their beneficiaries.

#### Biden springs...

The Ukraine visit comes at a crucial moment in the war as Biden looks to keep allies unified in their support for Ukraine as the war is expected to intensify with both sides preparing for spring offensives.

Zelenskyy is pressing allies to speed up delivery of pledged weapon systems and is calling on the West to deliver fighter jets to Ukraine something that Biden to date has declined to do.

In Kyiv, Biden announced an additional half-billion dollars in U.S.
Assistance — on top of the more than \$50 billion already provided — including shells for howitzers,

anti-tank missiles, air surveillance radars and other aid but no new advanced weaponry.

Ukraine has also been pushing for battlefield systems that would allow its forces to strike Russian targets that have been moved back from frontline areas, out of the range of HIMARS missiles that have already been delivered.

Zelenskyy said he and Biden spoke about "long-range weapons and the weapons that may still be supplied to Ukraine even though it wasn't supplied before." But he did not detail any new commitments.

"Our negotiations were very fruitful," Zelenskyy added.

Biden also got a short firsthand taste of the terror that Ukrainians have lived with for close to a year, as air raids sirens howled over the capital just as he and Zelenskyy were exiting the gold-domed St. Michael's Cathedral, which they

visited together.
Looking solemn, they contin-

ued unperturbed as they laid two wreaths and held a moment of silence at the Wall of Remembrance honouring Ukrainian soldiers killed since 2014, the year Russia annexed Ukraine's Crimean peninsula and Russian-backed fighting erupted

in eastern Ukraine. Biden's mission with his visit to Kviv, which comes ahead of a scheduled trip to Warsaw. Poland. is to underscore that the United States is prepared to stick with Ukraine "as long as it takes" to repel Russian forces even as public opinion polling suggests that U.S. And allied support for providing weaponry and direct economic assistance has started to soften. For Zelenskyy, the symbolism of having the U.S. President stand side by side with him on Ukrainian land as the anniversary nears is no small thing as he prods the U.S. And European allies to provide more advanced weaponry and to step up the pace of delivery.

Kesinga, Feb 20: Sattu packets prepared by women self-help groups (SHGs) under department of Women and Child Development is being supplied free of cost to children, pregnant women and mothers.

However, substandard quality has forced the beneficiaries to sell the sattu at a price to the interested traders.

It is clearly mentioned on the sattu packets that those are 'not for sale'. However, to everyone's surprise, beneficiaries are selling off sattu packets in broad daylight at Paralsing panchayat under this block in Kalahandi district.

A trader was seen moving from village to village on a vehicle and buying sattu packets that weigh around 4.410 kg by paying ₹50 per packet to the beneficiaries. This is not an isolated case as several traders were seen moving in villages and buying sattu from the beneficiaries. This is allegedly due to the substandard quality of sattu provided to the beneficiaries. The beneficiaries are not able to consume the sattu and selling it to interested traders.

Reports said that a packet of sattu costs around ₹60 to 70 in the open market while the packets prepared by the women SHGs are supplied free of cost to the

beneficiaries.

Sources said that a local women SHG Dibyajyoti Mahila Mandal has been allegedly preparing substandard sattu and supplying packets to beneficiaries through the Anganwadi centres under the block.

After reports surfaced, a fivemember team from the district administration met the president of the women SHG Geetanjali Dash and directed her to prepare sattu as per prescribed quality and standard. However, the SHG allegedly continued to distribute sub-standard sattu without heeding to the order of the district administration.

A beneficiary requesting anonymity said that the sattu is of substandard quality for which she sold it to the traders who latter sell it as fodder for the livestock in the area

As per instruction, sattu has to be prepared making a proper composition of chickpeas, sugar and groundnuts but the women SHG is allegedly preparing it with very less wheat and sugar.

When contacted, child development project officer (CDPO)

Mujibun Nisha said that sattu is being supplied to the beneficiaries for their consumption. She wondered what she can do if they sell it to traders. She, however, assured to send the supervisor and con-

duct a probe in this regard.

### Kapilash ecological New tool could provide insight park getting a facelift into powerful quakes to come

Dhenkanal, Feb 20: With the state's investment of ₹90 lakh, the Kapilash Ecological Park is all set to get a new look this year, sources revealed. The park situated in the foothills of Kapilash is expecting more tourists this year as 10 different animals including a leopard will be added to its newly proposed acclimatisation

Reportedly, the park already housing 247 animals including 8 elephants will get an upgraded boating facility with beautification of the garden soon to be completed. Elephant Rakesh has been staying in a special enclosure, while others are staying at the Elephant Rescue Centre inside the boundary. The present animal count of 124 includes sambars, deer and drung oxen, two bears, a large

crocodile and four hatchlings of the reptile, hares, peacocks and dif-

ferent kinds of birds and snakes. In 1979, a deer park was inaugurated with the allocation of 5 hectare of land in the foothills of Kapilash. However another 24.64 hectare of land was allocated later. The Central Zoo Authority of India declared the spot as a full-fledged zoo from April 1, 1995. With the newly built enclosure, the park is going to get a new look this year, said Divisional Forest Officer (DFO) Prakash Chand Gogineni.

A new crawl space will be constructed and a leopard among 10 different species of new animals will find place in the zoo. A special vehicle will also be provided for forest trail from the forest range office. The redevelopment project is expected to attract massive footfall this year, a department official added.

Houston, Feb 20: An everyday quirk of physics could be a valuable new way to investigate the causes and potential for a large, damaging earthquake to happen, according to a study.

Researchers at the University of Texas at Austin, US, discovered that a frictional phenomenon could be key to understanding when and how violently a fault -- a fracture or zone of fractures between two blocks of rock -- moves.

The phenomenon, which explains why it takes more effort to shove a heavy box from a standstill than it does to keep it moving, governs how quickly the fault surfaces bond together, or heal, after an earthquake, they said.

The study, published in the journal Science, shows that a fault that is slow to heal is more likely to move harmlessly, while one that heals quickly is more likely to stick until it breaks in a large, damaging earthquake

The discovery alone won't allow scientists to predict when the next big one will strike because the forces behind large earthquakes are too complex, the researchers said.

However, it does provide a valuable new way to investigate the causes and potential for a large, damaging earthquake to happen, they said.



The same physics and logic should apply to all different kinds of faults around the world, said the study's co-lead author Demian Saffer, director of the University of Texas Institute for Geophysics at the Jackson School of Geosciences

With the right samples and field observations we can now start to make testable predictions about how big and how often large seismic slip events might occur on other major faults, like Cascadia in the Pacific Northwest, Saffer said.

The researchers devised a test that combined rocks from a well-studied fault off the coast of New Zealand and a computer model, to successfully calculate that a harmless kind of slow motion earthquake would happen every few years because the clayrich rocks within the fault are very slow to heal.

The rock samples they tested were drilled from about half a mile under the seafloor in a fault in New Zealand.

The researchers squeezed the fault zone rocks in a hydraulic press and found that they were very slow to heal and slipped easily.

When they plugged the rock data into a computer model of the fault, the result was a small, slow-motion tremor every two years, a near exact match with observations from the New Zealand fault.

The researchers think the clayrich rocks, which are common at many large faults, could be regulating earthquakes by allowing plates to slip quietly past each other, which limits the buildup of stress.

The discovery could be used to determine whether a fault is prone to slipping in large, damaging earthquakes, said study co-lead Srisharan Shreedharan, affiliate researcher at the University of Texas Institute for Geophysics and assistant professor at Utah State University.

This doesn't get us any closer to actually predicting earthquakes, but it does tell us whether a fault is likely to slip silently with no earthquakes, or have large ground-shaking earthquakes, he added.

## Democracy in Peril

srael is now on the cusp of a change that has the potential to derail the country's democracy. The fast-paced developments there indicate the danger facing democracy when two of its pillars – the legislature and judiciary - are not properly in place, guaranteeing the system of checks and balances that alone can thwart the aspirations of individuals or groups to foist autocracy. The experience in Israel can offer an object lesson to democratic institutions across the world, including India, which are often under the threat of attempts by the executive to make the judiciary subservient to it

Trouble stems from the fact that the changes will do away with the powers of the judiciary to scrutinise laws passed in the Knesset (parliament) and actions of the government and the Prime Minister. In other words, the executive will no longer be required to answer before the court of law for its omissions and commissions. The new political actors belonging to the ruling hawkish Likud Party of Netanyahu and the Far-right fanatics seek immunity from the judiciary so that they can do whatever they please to advance their private and partisan agenda.

However, the advocates of skewed reforms are facing a roadblock that they do not seem to have thought of. Israel is now witnessing its biggest demonstrations in years since the plans were unveiled last month. Thousands of people have taken to the streets in different cities against the proposed reforms. They fear that these changes, if passed, would curb the Supreme Court's power and give the government more say over judicial appointments. Critics say it will undermine democracy even though the government argues the reforms will strengthen it.

Among the reforms, the ability of the Supreme Court to strike down laws would be severely weakened. A simple majority in the Knesset would have the power to override court rulings. The reforms would also give the government more influence over the committee which appoints judges, including those to the Supreme Court.

Israel's Justice Minister Yariv Lavin, who introduced the plans, accused opponents - including the Attorney General and Supreme Court's Chief Justice - of seeking to "carry out a coup" against Netanyahu, after a petition was filed to the court to declare the Prime Minister unfit for office.

But, even diehard Israel backers, such as US President Joe Biden, seemed worried over the development. In an unusual step, he criticised the proposals in their current form. It is a rarity for a US leader to express an opinion on constitutional matters in Israel.


Not only that, Israel's own President, Isaac Herzog, warned that the country was on the verge of constitutional and social collapse. This is even more surprising since involvement by Israeli Presidents in political issues are also rare since the post is considered to be a politically neutral figurehead. All these are because a realisation is dawning on advocates of democracy that the reforms will end up politicising the judiciary which in turn could pave the way for an authoritarian government.

However, these reforms may not be acceptable universally in all democracies. In India too, efforts to weaken the judiciary and all other constitutionally formed bodies have become a matter of great concern in present times. In a healthy democracy, each and every decision, no matter where it emanates from, needs to be closely scrutinised by the other wings before implementation. For example, even the Indian Parliament has grave weaknesses that truly do not permit the voice of the people to be heard in the House. For instance, the ruling party, if it is singularly large enough to form the government, does not wish to pay heed to any suggestion from the non-Treasury benches. This results in lopsided and motivated laws getting passed on the floor of the House. Within Parliament, the various ministry related committees too require an unambiguously nonpartisan and nongovernmental bureaucracy that will keep the Temple of Democracy on even keel. Unfortunately today, the machinery within the Parliament has also been badly mauled and therefore it is incapable of looking at government functioning objectively. Therefore India also very badly requires a judiciary that can distance itself from government and operate in a manner that will ensure laws are conducive to people's needs. For reaching this goal of impartiality, it is vital that judges are not chosen by the government nor can government reappoint judges in any post after retirement.

The US system speaks volumes about what happens when governments appoint judges. Take for example the large number of judges appointed by Donald Trump during his presidency. He brought in judges who were clear conservatives. The result was overturning the Roe Vs Wade judgement which had given American women the legal right to abortion. Less governance may be the only way out to ensure survival of democracy.

Galligaskins were wide, very loose breeches. They were a fashion of the sixteenth and seventeenth centuries, one that eventually disappeared, as did the active use of the word, which survives in historical contexts or as a humorous word for nether garments. It's an odd-looking word, well fitted to the epithet weird. It came about through another of those cloth-eared Englishmen's attempts at getting their minds around a foreign term. They knew it was French in immediate origin, gargesque, and they knew the garments were often worn by sailors, so they assumed that the first part was galley, either from the oared ship, or from the cooking area on board ship. Similar items were known at about the same time as gally-slops or gallybreeches, so that would easily account for the conversion of the first element of the French word into something more English-sounding. (The first of these was often abbreviated to slops, a similar item; the material for them was kept on board ship in the slop-chest, though sailors' working garments called slops, at least of a later period, were loose trousers rather than breeches.) Some dictionaries of the eighteenth and nineteenth centuries suggested that the word was from Gallic Gascons, the inhabitants of Gascony. They were looking too far west — the French word was taken from the Italian grechesca, something Greek, because the fashion for loose breeches was originally from that country. Around the years 1580-1620 similar garments were called Venetians, because a comparable fashion had been imported from Venice.

## **RESOLVING MSME DUES**

√he Parliamentary Standing Committee on of members from across all political parties, in its report of last April highlighted the importance of micro, small and medium enterprises (MSMEs). There are an estimated 64 million of these, and nearly 99% of them are very small, micro or tiny. These MSMEs are among the ones that employ less than five persons, and whose annual turnover may not even be ₹20 lakh. Their importance to the economy can be gauged by the following: As per the Standing Committee, the MSMEs contribute 30% to the national GDP, 45% to the national manufacturing output and 48% to exports. They together employ 11 crore people, which is 42% of all industrial workers.

Despite the economic significance of MSMEs to employment, output and exports, they only get a small share of bank credit or any formal credit. The Standing Committee says that their funding gap is  $\stackrel{7}{\sim}20-25$  lakh crore. Their funding requirement is most often in the form of working capital. That's because the small businesses are mainly vendors, suppliers and ancillaries to large corporations, be they public or private sector. They may be providing some spare parts, or packaging service, or what is called "job work". These small vendor supplier businesses have complete dependency on their customer, and many have only one or two customers. For instance, the Indian Railways is supposed to have one million suppliers, and for most of the suppliers the Railways is their only customer. Think of those who supply earthen cups (kulhaad) for tea, or napkins and towels, steel fabricated parts, or food packets to railway canteens and so on. The same is the fate for most MSME's who have one or two major corporations as their customers. There is rarely a system where some advance payment is made to the supplier which can then be used as working capital. And after the product or service

has been delivered, the MSME law states that no customer can delay payments for more than 45 days to the vendor. This is a protective clause because of the extreme financial vulnerability of the MSME. But in practice it is rarely enforced. The bane of the MSME is

delayed payment. The reason the large corporation or customer can get away by not paying within 45 days, is because the invoicing is not proper, reliable or valid. It could be a proforma invoice, preliminary bill or "rough" paperwork. So technically payment delays can be indefinite. By one estimate the problem of delayed payment is as large as ₹10 lakh crore. This is the aggregate amount owed to all MSME's on a national level. Imagine if the delay is for say 12 months, then the interest cost itself is ₹1 lakh crore in the aggregate. If the delayed payment problem is addressed then it will release ₹1 lakh crore as productive capital, without any subsidy from the government to MSMEs.

How can customers be forced to pay their MSME suppliers in quick time? We don't want to unleash an inspection Raj. The problem has been recognised for quite some time. In 2018 the Reserve Bank of India set up an online platform called the Trade Receivables Discounting System (TReDS) wherein the receivables of MSMEs can be put up "for sale" i.e. also called bill discounting. So, if an MSME has ₹100 due from say XYZ Corporation, someone can pay off ₹97 to the MSME and then go pursue the big company XYZ for the full ₹100. The transaction does not have any "recourse" to the MSME once the receivables right has transferred. The success of TReDS requires onboarding of a large number of buyers (large corporations) and sellers (MSMEs). Only then can the bill discounting business take off. But that has met with limited success, since many large companies simply do not want to come on to the platform. Even public sector companies are reluctant. Neither the RBI nor the government is able to enforce this discipline. Another method was devised in Tamil Nadu to put up names of "defaulters" on a government portal. But this requires the MSME vendor to "complain" i.e. name and shame the customer. Which right minded small vendor will want to anger their only lifetime customer in such a way? So, the name and shame method is also not working.

Here comes the importance of GST. The fact is despite delayed payments, the big corporations take advantage of input tax credit paid by their vendors when they file their GST returns. Among the recent budget proposals there is an amendment to section 43 B of the Income Tax Act. This amendment disallows any deduction to the large corporate, unless the payment to the MSME has been actually done. You can't claim tax credit and not pay your vendor on time. This is a great step ahead although it needs cooperation at the state level to be come fully functional. More importantly, the GST network data is a rich source of data for lenders to finance MSMEs. Since the transaction has been recorded on GSTN even if the actual payment is delayed, the lender bank can provide finance to the MSME on the basis of GSTN data. This is called cash flow-based financing and is not against any physical collateral. Since the payment is due from a large corporate the bank can get a good assessment of the payment risk. The GSTN approach has several advantages. It encourages MSMEs to come into the GST net (many were reluctant earlier). It makes the data transparent, and can also put the defaulters and delayed payments in the spotlight. It brings more formal finance and credit to MSMEs. It also encourages the MSME to go fully digital, i.e. not just for their receivables and accounts, but also for the enterprise, including inventory control, payroll etc. The cost of going fully digital using off the shelf ERP software packages is declining and is affordable. Even banks will nudge their MSME clients to go digital in this way.

In response to the growing need, funding for humanitarian causes has nearly doubled over the past decade, reaching \$31.3 billion in 2021. But while funding has increased, the challenge facing international agencies and NGOs today is to maximise the impact of these resources and empower local

and national organisations. As matters currently stand, twothirds of all direct contributions to humanitarian causes go to United Nations agencies and prominent international organisations like the Red Cross and Red Crescent. While these large institutions play a crucial role, community-based initiatives often have a better grasp of local contexts. The world's largest donors and NGOs seemed to acknowledge this when they launched the Grand Bargain initiative in 2016, committing to providing 25%

figure is still less than 2%.

So far, the sector's modus operandi has been reactive. Whether it is Haiti, Ethiopia, or Pakistan, the methods are the same: a crisis emerges, a humanitarian appeal is launched, funding is raised, and assistance is delivered many days (if not months) later. But by relying on climate science, we can anticipate risks and address humanitarian needs before they become emergencies. Anticipatory action, defined as

"acting ahead of predicted hazardous events to prevent or reduce acute humanitarian impacts before they fully unfold," involves forecasting mechanisms and preagreed triggers and thresholds for releasing funds in advance. By responding to needs in this way, we can deliver aid more effectively and in a more dignified way. In 2019, for example, the Senegalese government and Start Network each purchased insurance policies against drought, allowing them to receive funding for humanitarian action and coordinate measures to protect atrisk communities.

But anticipatory action also has its limits. As a recent report by Start Network shows, not all crises

ganisations to be proactive, improve efficiency, and prevent lifethreatening events from developing into large-scale disasters.

The global aid system needs rapid reform. While some progress has been made in recent years. much of it has been transactional rather than transformative. To be sure, the problems we face are complicated and multidimensional, and we cannot disregard the political dimension of humanitarian action. Some may believe that necessity or desperation will force the sector to change for the better, but scaling up anticipatory and locally-led action represents a far more promising path.

The ongoing climate crisis offers a unique opportunity for evidence-based humanitarian reform. In our data-driven world, there is no reason to wait until disaster strikes. By anticipating risks and planning ahead, we can protect vulnerable communities and make the world



#### Olaf Scholz to visit India

He is scheduled to arrive in Delhi on February 25 and will proceed to Bengaluru on February 26, the MEA said.

#### **Military drill begins**

New Delhi: The armies of India and Uzbekistan on Monday began a two-week military exercise in Uttarakhand's Pithoragarh with an aim to enhance operational interoperability. The fourth edition of joint military exercise 'Dustlik' commenced in Foreign Training Node in Pithoragarh (Uttarakhand). Forty-five soldiers each from Uzbekistan and the Indian Army are participating in this exercise which is aimed at promoting positive relations between the two sides, the Indian Army said.

#### 2-year-old dead

Gurugram: A 2-year-old boy was crushed to death by a speeding SUV outside his house in the Saraswati Enclave area of Gurugram. the police said Monday. During the incident, the child got stuck under the vehicle which was pulled out by the father. Farman Khan, a resident of Bareilly (Uttar Pradesh), told the police that on Sunday, his twoyear-old son was playing outside the house at around 11.15 a.m. when the incident took place.

#### 6 workers injured

Chandigarh: Six workers were injured in an accidental blast in a boiler at an industrial unit near Aurangabad village in Haryana's Palwal district on Monday, police said. The cause of the accident is not known. The injured have been admitted to a nearby hospital. Of the six, two have suffered grievous injuries.

#### Bike lifter killed

Guwahati: A bike lifter was shot dead during a police encounter in Assam's Charaideo district, officials said Monday. The deceased has been identified as Santosh Jaiswal and the incident took place Sunday night in Sonari. Shwetank Mishra, Superintendent of the Dibrugarh police, said that Jaiswal was a seasoned bike lifter who had been convicted under the Arms Act.

New Delhi, Feb 20: The Uddhav Thackeray faction Monday approached the Supreme Court challenging the decision of the Election Commission recognising the Eknath Shinde-led bloc as the real Shiv Sena and allotting the 'bow and arrow' poll symbol to it.

Senior advocate Abhishek Manu Singhvi mentioned the matter before a bench headed by Chief Justice DY Chandrachud for an early listing of the petition. The plea filed by the Thackeray faction stated the points raised in the petition have a direct bearing on the issues which are being considered by the Constitution bench.

The petition contended the poll panel erred in holding that disqualification under the Tenth



Schedule and proceedings under the Symbols Order operate in different spheres and that disqualification of MLAs is not based on cessation of membership of a political party.

It also submitted that the Election Commission has erred in holding that there was a split in the Shiv Sena. "In the absence of any pleadings and evidence that there was a split in a political party, the finding The plea filed by the **Thackeray faction** stated the points raised in the petition have a direct bearing on the issues which are being considered by the **Constitution bench** 

of the ECI is completely erroneous on this ground," the plea said.

The petition said the Thackeray faction has an overwhelming majority in the Pratinidhi Sabha, which is the apex body representing the wishes of the primary members and other stakeholders of the party. The plea said the poll panel has acted in a "biased and unfair

"It is submitted that the ECI has failed to discharge its duties as a neutral arbiter of disputes under para 15 of the symbols order and has acted in a manner undermining its constitutional status," the petition said.

The poll panel had on Friday recognised the Eknath Shinde-faction as the real Shiv Sena and ordered the allocation of the bow and arrow election symbol of the undivided party founded by the late Balasaheb Thackeray to it.

In a 78-page order on the protracted battle for control of the organisation, the Commission allowed the Uddhav Thackeray faction to keep the "flaming torch" poll symbol allotted to it till the completion of the assembly by-polls in the state. The Commission said the MLAs backing Shinde got nearly 76 per cent of votes polled in favour of the 55 winning Shiv Sena candidates in the 2019 Maharashtra Assembly elections. The MLAs in the Uddhav Thackeray camp got 23.5 per cent of the votes polled in favour of the winning Shiv Sena\_ candidates, the three-member Commission said.

### Woman kills husband, mother-in-law Niti Aayog gets new CEO Bihar prisoner

Guwahati, Feb 20: A man and his mother were killed, cut into pieces, packed in polythene bags and dumped in gorges of neighbouring Meghalaya allegedly by his wife and her two "close friends", police said Monday.

The murders happened in July and August last year, and few parts of the mother's body were recovered on Sunday near Cherrapunji in Khasi Hills."The first murder of the mother-in-law happened on July 26, while the husband was killed on August 17. We have arrested all the three accused and they are being interrogated now," Guwahati Police Commissioner Diganta Barah said.

He said the wife and one of her accomplices were arrested in Guwahati, while the third accused



was nabbed in Tinsukia district. Deputy Commissioner of Police (Central) Diganta Kumar Choudhury said the wife had lodged a missing complaint about her husband Amarjyoti Dey (32) and mother-in-law Shankari Dey (62) on August 29 and the police started an investigation.

"In November, Amarjyoti's cousin filed another missing complaint, which raised doubts about the wife as she allegedly withdrew money from her mother-in-law's account. Then we re-started our investigation and detected the murders,"

Choudhury said. Both the cases were registered at Noonmati police station, and the murders took place at different houses in Chandmari and Narengi areas in Guwahati, he said.

Addressing a press conference later, the Police Commissioner said the wife has been identified as Bandana Kalita (32), while her two male friends are Dhanti Deka (32) and Arup Deka (27). "During interrogation, it was revealed that Bandana and Amariyoti married around 12 years ago against the wishes of both families. The postmarital relationship between the two could not exactly be termed as cordial," he added. While Amarjyoti's mother accepted the marriage later and started supporting them financially, he was not gainfully employed and this led to frequent quarrels between the couple, Barah said.

The matter, however, came to light Sunday after Ali developed extreme pain in his stomach.

"The prisoner informed the jail authorities and narrated the sequence of events. He was immediately rushed to Gopalganj district hospital where the x-ray of the inmate revealed the presence of a foreign particle in his abdomen," Manoj Kumar, Gopalganj jail su-

perintendent said Monday. Salam Siddiqui, the doctor at the hospital's emergency ward said, "The prisoner was admitted in the hospital due to stomach pain. The x-ray of his stomach was taken and the presence of foreign particles was visible during the examination. There is a need to investigate it thoroughly"

A medical board was constituted by the hospital and the man was referred the prisoner to Patna Medical College and Hospital for further treatment

Ali was arrested by Gopalganj police on January 17, 2020 under provisions of Narcotic Drugs and Psychotropic Substances Act (NDPS Act). He has been in jail for the last three years.

Use of mobile phone by inmates inside Bihar prisons has raised eyebrows over security officers' credentials.

setting up mental-wellness centres. Suicide by an IIT Bombay student recently amid allegations of caste discrimination has brought the limelight back on the rigorous curriculum and competition at the prestigious institutes.

IIT Bombay Director Subhasis Chaudhuri has announced that the institute is working towards changes in their undergraduate curriculum to make it "more relevant and motivating to students, and to reduce some of the stress". "We are working actively to create an inclusive campus where all students feel at

home," Chaudhari said. The parliamentary standing committee for the welfare of scheduled castes and scheduled tribes (SC/ST) has called a meeting on Tuesday to discuss the recent sui-

The residents requested the officials to make proper arrangements to guarantee their safety.



Apart from this, three options have been kept for permanent rehabilitation. 100 per cent compensation will be provided for the loss of residential buildings. For a residential building made of brick, Rs 31,031 per sq metre will be paid, whereas, for residential buildings made of beams and columns, Rs 36,386 per sq metre will be provided. Rs 39,030 per sq metre will be paid for commercial buildings made of brick and Rs 45,921 will be paid for commercial buildings

made with beams and columns. 100 per cent payment will be done for the commercial buildings costing up to Rs 5 lakh, and for the tween Rs 5-15 lakh, compensation of Rs 5 lakh, along with 40 per cent will be paid.

For the commercial buildings ranging from Rs 15-30 lakh, Rs 9-15 lakh will be given along with an additional 30 per cent. For a commercial building costing between Rs 30-50 lakh, Rs 30.5 lakh will be paid for the structures costing up to Rs 30 lakh, along with an additional 20 per cent. For commercial buildings above Rs 50 lakh, Rs 17.5 lakh will be paid and an additional 10 per cent.

On loss of residential land, 75 sq metres of land will be provided. If the area of the land lost is larger than 75 sq metres, compensation will be provided for the excess. In cases of loss of commercial land. 15 sq metres land will be provided.

Along with this, Rs 2 lakh will be given to the affected person who had been running the shop on rent. Sinha said that all standards have been fixed in Joshimath under the displacement and rehabilitation policy, the process of which will start after the report of the investigative agencies.

#### **China-made drone** seized in Puniab

The current maximum temperature in Punjab and Haryana is 4-5 degrees Celsius above average,



## Gujarat govt to seek death penalty for 11 in SC JD(U), floats party

New Delhi, Feb 20: The Gujarat government Monday told the Supreme Court that it will press for death penalty to 11 convicts whose sentences in the 2002 Godhra train burning case were commuted to life imprisonment by the state's high court.

A bench comprising Chief Justice DY Chandrachud and Justices PS Narasimha and JB Pardiwala also fixed the bail pleas of several accused in the case for hearing after three weeks. It asked counsel for both sides to file a consolidated chart giving details such as actual sentences awarded to them and the period spent in jail till now.

"We will be seriously pressing for award of death penalty to the convicts whose death penalties were commuted into life imprisonment (by the Gujarat High Court). This is the rarest of rare cases where 59 people, including women and children, were burnt alive," Solicitor General Tushar Mehta, appearing for the Gujarat government, told the bench.

#### **CBI** sets new date for Sisodia


New Delhi, Feb 20: Deputy Chief Minister Manish Sisodia on Monday said he has been called for questioning by the CBI on February 26 in connection with the Delhi excise policy scam case.

The Central Bureau of Investigation (CBI) had on Sunday deferred his questioning after he sought time from the agency citing the Delhi government's ongoing budget exercise. The agency had asked Sisodia to appear for questioning on February 19.

The senior Aam Aadmi Party (AAP) leader told a press conference that he has been called for questioning on February 26 and will appear before the probe agency.

CBI officials said that the agency has issued a fresh notice to Sisodia to appear for questioning in the case on February 26. The notice was issued on his request. He had sought deferment of his previously scheduled questioning on Sunday, they said.

The CBI had earlier accepted his application to defer the questioning and had said it will give a new date soon. Sisodia, who holds the finance portfolio in the Delhi government, had cited the ongoing budget exercise to postpone the questioning and sought a date in the last week of February, the officials said.





Giving details, the law officer said 11 convicts were sentenced to death by the trial court and 20 others granted life term in the case.

The high court upheld total 31 convictions in the case and commuted the death penalties of the 11 convicts to life term, Mehta said, On February 27, 2002, 59 people were killed when the S-6 coach of the train was burnt at Gujarat's Godhra, triggering riots in the state.

The state government has come in appeal against the commuta-

tion of death penalty into life term for 11 convicts, Mehta said. Several accused, he added, have filed pleas against the high court upholding their convictions in the case.

The top court has granted bail to two convicts in the case so far. Seven other bail pleas are pending adjudication in the matter. ever, berated the former parliamentary board chairman as an over-ambitious party-hopper, whose return was "opposed by all, but materialised only at the insistence of the CM" whom Kushwaha had assured "I will now live and die here" Kushwaha, who has been vent-

ing spleen against Kumar for some time, also announced that he will be seeking an appointment with chairman of the legislative council to resign from his membership of the House, adding with rhetorical flourish "'zameer bechkar amir nahin banenge' (I cannot barter my conscience for perks)". He alleged that Kumar, his po-

litical benefactor, had "pawned his political capital ('rajneetik sampatti ko girwi rakh diya') by having hinted that Tejashwi Yadav (the deputy CM) shall be the future leader of the coalition", which JD(U) had joined nearly six months ago. Lalan, however, pointed out that

Kushwaha, who then headed the Rashtriya Lok Samata Party (RLSP), had aligned with the RJD after quitting the NDA in 2018, "and he appeared to be fine with Teiashwi Yadav back then"

The JD(U) chief also rubbished

Kushwaha's allegation that Kumar, the party's de facto leader, no more exercised his own judgement, but acted on the advice of a coterie with vested interests. "Had it been so, Kushwaha could have never returned to the JD(U) in 2021. Not a single person was in favour of his return, since all knew about his vaulting ambition that causes him to go astray. But, the CM put his foot down since he trusted Kushwaha's declamation – 'jeena marna ab sab yaheen hai'," Lalan said.

'The problem is Kushwaha cannot think of anything less than the chief minister's chair for himself. This had led him to quit the NDA and fancy his chances with the RJD-led 'Mahagathbandhan'. "He could not stay there as well and ahead of 2020 assembly polls, he formed a hurried coalition with Mayawati's BSP and Asaduddin Owaisi's AIMIM just because these parties agreed to announce him the chief ministerial candidate," the JD(U) chief said.

May Kushwaha last long enough wherever he now goes, though this seems unlikely because of the "deformation" his personality has undergone due to "uncontrollable ambition", Lalan added, mockingly.

Kushwaha minced no words while giving vent to his frustration over Yadav taking centre-stage, but maintained, "I would have been okay with Kumar not projecting me as the future leader had he chosen anybody from within the party, belonging to the 'Luv Kush' samaj (Kurmis and Koeris) or the Extremely Backward Classes who form the JD(U)'s support base."

#### Baby declared dead found alive Owaisi's house attacked in Delhi

New Delhi, Feb 20: The All India Majlis-E-Ittehadul Muslimeen chief Asaduddin Owaisi, has alleged that some unidentified miscreants pelted stones at his residence in Delhi and windows of the house were damaged.

Owaisi also shared a video of his residence at Ashoka Road in New Delhi, showing the damages.

"Earlier tonight, I returned from Jaipur & was informed by my domestic help that a bunch of miscreants pelted stones that resulted in broken windows. @DelhiPolice must catch them immediately," he tweeted late on Sunday.

"It's concerning that this has happened in a so-called a "high security" zone. I've submitted a complaint to the cops & they've reached my residence," he said in another tweet.

Meanwhile, a senior police



official said that a complaint was received from the MP and Owaisi was not present at his residence when the alleged incident happened.

"The crime team has inspected the spot. One brick/stone was also found in the parking area at the back entrance. Windows were also found broken," said the official, adding that a probe has been initiated. More details are awaited.

New Delhi, Feb 20: A newborn girl was "declared dead" soon after birth at the Delhi governmentrun LNJP Hospital, her family members alleged on Monday, and said they found the infant alive about an hour-and-a-half later when they were making plans for her burial.

A senior doctor at the city government's largest hospital said it was a regular delivery but the mother was just 23-weeks pregnant and the pre-term baby "weighed only 490 grams". He added that the authorities had ordered an inquiry into the matter.

"Yesterday, my niece was born. She was alive but they declared her dead," Md Salman, the infant's uncle, alleged. The incident came to light on Monday after a video showing the baby in a box became



widely circulated on social media.

The family admitted that the video was shot by them after they brought the infant back to the hospital. The baby's 35-year-old mother has another daughter, aged three. The baby's father works in the business of simple toolmaking, the family said.

"The baby was handed over to us in a box and we took her to our home in New Mustafabad. We had started making preparations for

her burial and ordered to prepare a grave for her. Around 7.30 pm, when we opened the box, we saw the baby moving her legs and arms. We immediately rushed her back to hospital," an aggrieved Salman told PTI over phone.

The baby's father even called the PCR helpline but police only took some notes on a "rough piece of paper" when they came, he claimed. A senior police official said no formal complaint had been lodged by the family.

Salman, the baby's uncle, also alleged that when they reached the hospital, the doctors "shut their rooms and refused to admit the baby again"."The guards misbehaved with us. We protested and asked them to admit the child but they refused to budge. We called the police, who then intervened and got the baby admitted again,'

## Data turns dormant desire into informed insights

f Jharkhand's poverty riddled backyard, Jamtara, gained notoriety as the cybercrime capital of the country. It is now the turn of Haryana's Mewat to emerge as digital India's underbelly.

This came to the fore with a recent revelation that Haryana police's cybercrime cell had blocked almost five lakh SIM cards over the year that were in use in the state's Mewat region to commit cyber frauds countrywide. Published reports point out that the SIM cards were operational in 40 villages, had led to identification of over 400 alleged cybercriminals, acting on 66,784 complaints made between January

and December 2022 that had led to a loss of Rs 301.48 crores and does not include the Rs 47 crore in fraudulent transactions that were thwarted through use of Artificial Intelligence and advanced cyberidentification tools. Also that it had managed to identify about 5 lakh mobile numbers issued from other states but put to use exclusively in this region.

The statistics are re-assuring in the strides by the cops in using emerging technologies to combat cyber-crime but stunning in the breadth of the fraudsters reach, spread and financial figures skimmed in this digital fiscal fraud.

Is India fast gaining notoriety

as the global hotbed of financial fiscal fraud through con-calls? There are reasons to believe so because illegal con-call centres have been mushrooming all over the country with their proceeds fuelling a wholly illegal, black money economy of humongous proportions and global connections, all working in tandem.

According to the eighth edition of the Truecaller Insights 2022, US Spam and Scam Report dated May 24, 2022, a staggering \$ 39.5 billion was lost to phone scams in America over the past 12 months and marked an increase of 14.9 per cent over the same period last year. To put things into perspective, the total money lost to con-call scams is comparable to American Rescue



Plan Act's entire childcare budget of \$39 billion. In other words if this fraud is eliminated, the amount saved could fund federally subsidized child

care across US for one full year. Importantly, published Federal Bureau of Investigation (FBI) data shows that 20,000 US citizens lost more than \$10 billion to con-call fraudsters operating from India in 2022. In 2021 the amount was \$6.9 billion thus indicating a 47 per cent increase. Romance-related frauds led to a loss of Rs 8,000 crore to victims in 2021 and another Rs 8,000 crores in iust 11 months of 2022, FBI website reported.

It was this rise in frauds originating from India that led to the FBI deputing a permanent representative at the US Embassy in Delhi to coordinate with Indian investigation agencies as well as

Interpol. It is unbelievable yet true that over 202 million calls were made by just one spammer in 2021.That would be 6,64,000 calls per day and 27,000 calls every hour every day.

An analysis of call centre crimes in Gujarat by Akanksha Kakhse and Dr Pavitran Nambiar of the Gujarat Forensic Science University (GFSU) points to the use of advanced communication technologies wherein calls to US citizens are mimicked as coming from the Internal Revenue Service of the US government .In fact these emanate from fraudulent facilities clandestinely operating from various parts of India and are used to extort money

#### Heavy rains leave 36 dead in Brazil

Sao Paulo: Heavy rain caused flooding and landslides that have killed 36 people in Brazil's north Sao Paulo state, officials said Sunday, and the fatalities could rise. Sao Paulo state government said in a statement that 35 died in the city of Sao Sebastiao and a 7-year-old girl was killed in neighbouring Ubatuba. The cities of Sao Sebastiao, Ubatuba, Ilhabela and Bertioga, some of the hardest hit and now under state of calamity, cancelled their Carnival festivities as rescue teams struggle to find missing, injured and feared dead in the rubble.

#### **EU targets more Iran** officials, organisations Brussels: The European Union

Monday imposed sanctions on two organisations and 32 Iranians, including the culture and education ministers, intelligence officials and lawmakers, accused of links to Iran's security crackdown on protesters. The protests began after the September 16 death of 22-year-old Mahsa Amini. At least 529 people have been killed in demonstrations.

#### 12 dead, 54 hurt as bus falls into ditch

Islamabad: At least 12 passengers were killed and 54 others injured after a bus fell into a ditch in the Chakwal district of Pakistan's Puniab province, the rescue service said Monday. The service said that the accident took place late Sunday night on the motorway near Kallar Kahar area when the bus went off to the other side of the road due to brake failure, hit three cars coming from the opposite direction, and eventually fell off the road into a ditch.

#### 43 migrants found in van

Sofia (Bulgaria): Bulgarian police discovered 43 migrants, including ten children, hidden in a van in the west of the country, officials said Monday, just days after authorities found the bodies of 18 migrants concealed in a lumber truck. Prosecutor Natalia Nikolova said the 43 migrants appear to be in good health, despite being squeezed into a tight space. She didn't provide the migrants' nationalities.

#### **Search underway**

Manila: Philippine authorities Monday prepared to send a search mission near the crater of a restive volcano after they spotted the suspected wreckage of a small plane that went missing with four people on board over the weekend. Two Filipino pilots and two Australians were aboard the Cessna 340, which lost contact after takeoff from Albay province southeast of the capital Saturday morning on its way to Manila, the Civil Aviation Authority of the Philippines said.

Beijing, Feb 20: Nearly one year after Russia invaded Ukraine, new questions are rising over China's potential willingness to offer military aid to Moscow in the increasingly drawn-out conflict.

In an interview that aired Sunday, US Secretary of State Antony Blinken said American intelligence suggests China is considering providing arms and ammunition to Russia, an involvement in the Kremlin's war effort that he said would be a "serious problem."

China has refused to criticise Russia for its actions or even to call it an invasion in deference to Moscow. At the same time, it insists that the sovereignty and territorial integrity of all nations must be upheld. The question now is whether China is willing to convert that rhetorical backing into material support.

The US has sought to limit Chinese access to the latest microprocessors and manufacturing equipment, and has continued to challenge Chinese territorial claims in the South China Sea.

For China, the most sensitive issue is US support for Taiwan, the self-governing island democracy that Beijing considers its own territory to be conquered by military force if deemed necessary. Taiwan is a major customer for US defensive arms and has hosted a growing number of prominent American elected officials, en-

raging Beijing. Meanwhile, US congress members have called for the banning of TikTok and other Chinese-owned social media platforms, as well as increased sanctions on Chinese firms backed by the Communist Party, which wields ultimate control over the Chinese economy and suppresses independent media and political opposition voices.

#### **Imran Khan gets** protective bail

had directed Khan to appear before court for hearing of his protective bail petition in the case. Justice Najafi appreciated Khan for submitting to the law. The judge granted him protective

bail till March 3 and refrained police and any other agency from arresting him.

Khan evaded the PML-N government's plan to arrest him as he appeared before the court and secured the protective bail in the case in which he was booked under terrorism charges.

### Hasty rebuild could leave Turkey at risk of another disaster

#### Air traffic nearly doubles in Jan

New Delhi: Domestic aviation traffic has continued to witness a massive growth as passengers carried by domestic airlines during January 2023 were 1.25 crore as against 64.08 lakh during the corresponding period of previous year thereby registering an annual growth of 95.72 per cent and monthly growth of 95.72 per cent. According to data released by the Directorate General of Civil Aviation (DGCA) Monday, the passenger load factor or occupancy of the airlines remained on the higher side in the range of 80 to 90 per cent. The newly-launched Akasa Air marked an 82.8 per cent occupancy during January. SpiceJet recorded the highest occupancy of 91 per cent, while Indigo witnessed 82 per cent. Air India and Go First followed with 87.5 per cent and 90.9 per cent of occupancy, respectively. IndiGo, however, maintained its top position in On-Time Performance (OTP) in January with 84.6 per cent on an average of its flights from four key metro airports -- Delhi, Mumbai, Bangalore and Hyderabad -- departing and arriving at their scheduled time.

#### **India jumps 10-spot** in mobile speeds

New Delhi: As 5G roll-out picks up speed thanks to Reliance Jio and Airtel, India climbed 10 spots for median mobile speeds globally in the month of January, from 79th position in December to 69th, a report said Monday. The country also increased two snots in rank globally for overall median fixed broadband speeds, from 81st in December to 79th in January, according to network intelligence and connectivity insights provider Ookla. Overall fixed median download speeds in India saw a slight increase from 49.14 Mbps in December to 50.02 Mbps in January. In November, India ranked at 105th position, globally in median mobile speeds.

Islamabad, Feb 20: Cash-strapped Pakistan's current account deficit shrank 90.2 per cent to \$0.24 billion in January from \$2.47 billion in the same month last year, the data shared by the State Bank of Pakistan (SBP) showed Monday. Current Account Deficit (CAD)

recorded \$0.2 billion in Jan 2023 against a deficit of \$2.5 billion in Jan 2022, the central bank said in a brief statement on Twitter. The decrease in the deficit is also 16.55 per cent lower than December when the SBP announced that the deficit was \$0.29 billion.

Pakistan has a chronic balance of payments problem which has exacerbated in the last year, with the country's forex reserves declining to critical levels. As of February 10, the central bank had only \$3.2 billion in reserves, enough to cover barely three weeks of imports.

To stem dollar outflows, the government has imposed restrictions, allowing imports of only essential food items and medicines until a lifeline bailout is agreed with the

#### **FPIs' investment** value in equities drops 11% YoY

New Delhi, Feb 20: The value of foreign portfolio investors' (FPI) holdings in the domestic equities reached \$584 billion at the end of December 2022, which was 11 per cent lower from preceding year, according to a Morningstar report.

This was largely on low return given by the Indian equities and exodus of foreign money from the domestic stock market



FPIs investments in Indian equities dropped to \$584 billion as of December 2022 as compared to \$654 billion at the end of December 2021. On a quarter-on-quarter basis,

the value of FPIs investment grew 3 per cent from \$566 billion in the three months ended September 2022. This was also the second consecutive quarter, when the value of their investment in the domestic stock market had increased.

Consequently, FPIs' contribution to Indian equity market capitalisation also went up during the quarter to 17.12 per cent from 16.97 per cent in the September 2022 quarter.

After posting a robust growth in 2020 and 2021, the global equity markets went through a turbulent phase in 2022. In fact, 2022 was a difficult year as the world witnessed multiple challenges that weighed on the international markets. Though the Indian equity mar-

kets also felt the heat and witnessed a slowdown, they were still among the better-performing markets in the world and among very few which delivered positive returns. Through the year, S&P BSE Sensex Index returned 4.44 per cent, whereas its mid-cap counterpart S&P BSE Midcap Index ended the year with a 1.38 per cent gain. In contrast, the small-cap segment went through a downturn with the S&P BSE Small Cap Index clocking a negative 1.8 per cent return.

The year 2022 experienced an unprecedented exodus of foreign money from the Indian equity markets with a net withdrawal of \$16.5 billion (around ₹1.21 lakh crore).

This was the worst year for FPIs in terms of flow and withdrawal from equities following a net investment in the last three years.

Bangalore, Feb 20: The government has opposed Hindustan Zinc Ltd's \$2.98 billion acquisition of assets from the flagship firm of Vedanta Resources, dealing a blow to billionaire Anil Agarwal's plans to trim down the mining giant's \$7.7 billion net debt.

The Ministry of Mines in the letter said it is writing on behalf of the government on the resolution approved by the HZL board in its meeting January 19 "for the creation of a wholly-owned overseas subsidiary of the company, funding such subsidiary to the extent of \$2.981 billion and such subsidiary acquiring the shares of THL Zinc Ltd from THL Zinc Ventures Ltd."

"The proposed resolutions which envisage the acquisition of THL Zinc (a Vedanta company) by HZL (also a Vedanta company) thus being a related party transaction, we, the government of India would like to reiterate our dissent on the matter and the resolutions forming part of the agenda matter," it said. It wanted the company to explore other cashless methods of acquisition of assets.

The government, which owns a nearly 30% stake in Hindustan Zinc, is against the miner buying some Africa-based zinc assets from Vedanta Ltd - its top shareholder with a near-65% stake - as it was a "related party transaction".

### Sensex, Nifty extend losses for 2nd day

Mumbai, Feb 20: Benchmark equity indices Sensex and Nifty declined for a second straight session Monday, losing more than half a per cent due to selling in energy, banking and financial stocks amid lingering concerns over interest rates and inflation.

Reversing its early gains, the BSE Sensex closed lower by 311.03 points or 0.51 per cent at 60,691.54 as 18 of its scrips declined. The index opened higher at 61,112.84 and gained further 290 points to hit the day's high of 61,290.19.

However, selling in index major Reliance Industries, HDFC twins, ICICI Bank Maruti and Kotak Bank dragged down the barometer to a

## SMRITI, RAIN GUIDE Clarke takes a dig at Aussies INDIA INTO SEMIS

Ggeberha (South Africa), Feb 20: Vice-captain Smriti Mandhana stood out with a scintillating 56-ball 87 before rain, to some extent, helped India seal a berth in the semifinals of the Women's T20 World Cup, Monday.

But Shafali once again got out after getting a start, caught by Amy Hunter off the bowling of skipper Laura Delany, who introduced herself into the attack after the frontline bowlers failed to get the team a breakthrough.

Harmanpreet joined Mandhana in the middle, and the two looked to build on a partnership. Playing strokes turned out to be difficult on a surface that appeared to be a bit on the slower side.

The slow nature of the wicket



notwithstanding, Mandhana maintained an excellent strike rate and reached her half century in style, hitting leg-spinner Cara Murray for a six over deep mid-wicket.

Mandhana was lucky to have survive a scare just before getting to her fifty but Arlene Kelly could not complete the catch after the batter topedged a tossed-up delivery from Murray towards mid-wicket.

Mandhana then struck two successive fours off Georgina Dempsey, before sending Delany over the cow corner for another maximum.

Ireland came back with the wickets of Harmanpreet and Richa Ghosh in successive balls, but Mandhana continued to attack the bowlers and hit two more boundaries off Kelly before giving the same treatment to Delany, striking her for a four and a six to help India inch towards 150.

A century was on the cards, but Mandhana's brilliant innings came to an end as she tried to take the aerial route. Jemimah Rodrigues struck two fours in the final over, before getting off in the last ball of the India innings for a 12-ball 19.

Melbourne, Feb 20: Australia's wretched run on the tour of India so far has been filled with "major mistakes", reckons former captain Michael Clarke. Clarke feels the biggest mistake Australia made was not playing a tour game ahead of the four Test series that began February 9

Instead, Pat Cummins chose to simulate Indian conditions back home before having a short camp near Bengaluru ahead of the series opener in Nagpur. Two weeks later. the visitors are 0-2 down in the series and have already lost a shot at regaining the Border-Gavaskar

"I'm not surprised by what I'm seeing because we didn't have a tour game. Major, major, major mistake. There should have been at least one game over there to get used to the conditions," Clarke said on Monday on Big Sports Breakfast.

The Australian batters' inability to play top-quality spin has been thoroughly exposed in the first two Tests. In Delhi, they tried to sweep their way out of trouble but that ploy failed miserably. Apart from that, another major mistake. according to Clarke, was not playing Travis Head in the series opener.

The southpaw top-scored for Australia in the second innings with a 43 off 46 balls before his team collapsed to 113 all out. It was



also the first time he opened in

"Selection for the first Test, major, major mistake. Second Test, blokes sweeping, we saw enough of that the first Test match. They're not the right conditions to sweep when you start your innings. And they're never going to be the right conditions to reverse sweep against the spin at the start of your innings," said Clarke.

Half of the side fell to sweep or reverse sweep on a track with low bounce. "It doesn't matter how many support staff there are around, you're playing for Australia. Surely as a batsman playing at the highest level, you calculate that risk versus reward.

"Against spin bowling on a pitch like that, you would say my 'swim between the flags' is play straight, hit with spin. Let's just stick to those two theories. Straight bat ... I'm going to be playing every single ball with the spin," said Clarke.

He also added that Australia

on how to bat in spin-friendly conditions. "It's like we're not watching India bat," he said. "Why would vou not look at that example and go, 'OK, these guys know the conditions so well, and this is how they're playing'. Why would we try and do something different when they have been so good?

Steve Smith was dismissed (LBW)

'The game was there for us to win if we make 200... And we were 1-60," he said referring to the dramatic batting collapse with Australia losing nine wickets for 52 runs. India needed to chase down 115 and they did that with six wickets in hand. Clarke also questioned Pat Cummins' field placements Sunday. "I'm not sure what happened with our tactics. We had just 100 runs on the board.

"At one stage, Patty Cummins had four blokes on the boundary. There's 2½ days left in the Test match. You're either bowling India out for under a hundred or you're losing: one or the other.

"If you lose in 20 overs, or you lose in two days, it's irrelevant. So fielders get up, bat-pad off side, bat-pad leg side. If the ball turns, if the ball bounces, if the ball shoots along the ground, if you make an error in judgment, you are getting out.

'That's what Australia had to do with the ball. I know it's only a tiny run lead, but we had to still try and win the game, and we had mid-off back, mid-on back, deep point, deep square leg. What was I watching?'

Madrid, Feb 20: With yet another win, Barcelona left its problems off the field after a turbulent week. Barcelona defeated Cadiz 2-0 Sunday as they extended their winning streak and lead over Real Madrid in the Spanish league.

Sergi Roberto and Robert Lewandowski scored late in the first half to give Barcelona their seventh straight league win and get their lead over second-place Madrid back to eight points. Madrid had cut the gap to five points with a 2-0 win at Osasuna Saturday.

Barcelona's home game at Camp Nou came after it became publicly known that a state prosecutor is probing Barcelona's payment of millions of dollars over several years to a company that belonged to the vice president of the Spanish federation's refereeing committee.

Barcelona has been heavily criticized but denied any wrongdoing, saying it paid for reports on referees but never tried to influence their decisions in games.

On the field, Roberto opened the scoring in the 43rd with a shot from the middle of the area after Lewandowski's header off a cross by Ferran Torres was cleared by a defender on the goal line.

Lewandowski added to the lead before halftime with a low shot from just inside the area for his league-leading 15th goal – and first overall after three scoreless matches in all competitions. It was the 17th clean sheet for Barcelona in the league this season.

Cadiz, coming off two wins in its last three matches, thought it had opened the scoring in the 19th but the goal by Roger was disallowed for offside. The club from southern Spain dropped to 17th place, two points from the relegation zone. GRIEZMANN THRIVES

Antoine Griezmann made a great run from near the halfway line to score for Atletico Madrid in a 1-0 victory against Athletic Bilbao, allowing Diego Simeone's team to strengthen its hold on the final Champions League place.

The goal saw Griezmann speeding past two defenders before entering the area and firing a low shot into the net in the 73rd minute, giving Atletico their fourth win in five league matches.

The victory left the team four points ahead of fifth-place Real Betis. Atletico are two points behind third-placed Real Sociedad. Atletico are 10 points behind city rivals Real Madrid and 18 points behind league leaders Barcelona

## Barcelona beat Cadiz Liverpool, Real Madrid collide in CL

Manchester, Feb 20: With 20 Champions League titles between them, Liverpool vs Real Madrid is a meeting of two European soc-

Their round-of-16 match at Anfield Tuesday is also a repeat of last year's final in Paris, which saw Madrid win the competition for a record-extending 14th time after producing a series of improbable comebacks just to make it to the European showpiece at the Stade de France.

Madrid secured come-from-behind wins against Paris Saint-Germain, Chelsea and Manchester City in each of the knockout rounds before beating Liverpool 1-0 in the final.

Where the Champions League is concerned anything seems possible for Madrid, which won the trophy three years in a row from 2016-18 at a time when Barcelona was dominating the Spanish title.

But if any team can rival Madrid's ability to produce the unexpected in European club soccer's most prized competition, it is

Liverpool. There was the famous comeback from 3-0 down against AC Milan in the 2005 final before going on to win on penalties. And more recently the 4-3 aggregate win against Barcelona in the semifinals in 2019 after losing 3-0 in the



first leg at the Nou Camp. Madrid, however, has felt like a step too far ever since the draw was made last November.

After all, this is a Liverpool team that faces a fight just to qualify for next season's competition, let alone win it this year. Jurgen Klopp has struggled to get his team firing after the departure of key forward Sadio Mane to Bayern Munich last

summer and a host of injuries. Ahead of the first-leg match at Anfield, Klopp can at least be encouraged by a recent upturn in



misfiring forwards Cody Gakpo and Darwin Nunez. Suddenly Liverpool looks in con-

tention again for a Champions League-qualifying spot, sitting seven points off fourth place Tottenham with two games in hand.

Then there is the Anfield factor, with an atmosphere that saw Barcelona wilt in that semifinals comeback and Manchester City repeatedly fall despite dominating English soccer in recent years. Like Madrid's fans, the Liverpool crowd believes nothing is beyond their team when it comes to Europe

after winning the trophy six times.

Joe Cole played for and against Liverpool and was part of a Chelsea team that lost in the semifinals at Anfield in 2005 and 2007. But Cole questions whether Liverpool can overcome this Madrid team, which recently won the Club World Cup. Madrid also beat Liverpool in the final of 2018 and won when the sides met in the quarterfinals two years ago.
