### 8 new health centres to come up in Odisha

**SHORT TAKES** 

Bhubaneswar: Odisha government's Health and Family Welfare Department will set up eight new urban primary health centres (UPHC) in different districts of the state under the National Urban Health Mission (NUHM), officials said Wednesday. According to a notification issued by the department, two such centres will be set up in Jajpur district (Jajpur and Vyasanagar). The other centres will come up in Rairangpur of Mayurbhanj district, Malkangiri town in Malkangiri district, Soro in Balasore district, Rajagangpur in Sundargarh, Angul in Talcher and Cuttack town in Cuttack district. Officials said that these centres will go a long way in providing proper healthcare to the people.

### **Emergency landing** for Air India flight

New Delhi: An Air India flight from Newark to Delhi, carrying 292 passengers, made an emergency landing Wednesday in Stockholm due to an oil leak in one of the engines. Aviation regulator DGCA will probe the incident, according to senior officials. A DGCA official said the flight (No. AI 106), operated with a Boeing 777-300 ER aircraft. had an oil leak in one of the engines. Following this, the engine was shut down, and later the aircraft made an emergency landing in Stockholm. Other than the passengers, there were 15 crew members and four pilots on board the aircraft. The airline said the aircraft is being thoroughly checked

#### 2 dead, 53 missing in China mine collapse

Beijing: A vast portion of an outdoor opencast mine in China's Inner Mongolia autonomous region collapsed Wednesday. So far two persons have died, but the toll may rise as 53 are reportedly missing, officials said. They added that the rescue work has been hampered by darkness. The incident happened in Inner Mongolia autonomous region's Alshaa and the authorities were at work to rescue those trapped inside. Six persons have been brought out from the mine, but their condition is stated to be

### 9 DEAD IN TWO **ROAD MISHAPS**

Rayagada/Keonjhar, Feb 22: A total of nine people were killed Wednesday while five others were injured in two different road mishaps in the districts of Rayagada and Keonjhar.

In the first accident six persons died on the spot and two others suffered serious injuries when a truck rammed into an auto-rickshaw near Rayagada. All the persons in the auto-rickshaw were residents of Andhra Pradesh. They had come to attend a marriage function in Ravagada and were returning to Kamarada village in Andhra Pradesh when the accident occurred. Among the dead were four women.

Five of the deceased were identified as Meleka Sharada (31), Meleka Amudu (44), Huika Laxmi (45), Huika Narasama (42) and Meleka Venkat (59). The identity of the sixth deceased is yet to be ascertained. The two injured have been shifted to a hospital in Vizianagaram

as their conditions deteriorated.



The mangled auto and the injured

from Parvathipuram hit the auto near Cholapadar. The collision was so hard that the three-wheeler was completely mangled. Among those injured is the driver. Police have launched a probe to ascertain the cause of the accident.

In another accident reported late in the evening Wednesday three persons lost their lives and three others suffered serious injuries after an SUV rammed into the rear of a stationary truck on Barabanka road under Rugudi police limits in Keonjhar district. Among the deceased were two men and a woman and all were occupants of the SUV. The injured have been shifted to the Keonjhar DHH.

# Not CBI, but FBI: CM

Naveen Patnaik told the Opposition that the Crime Branch is taking help from FBI in the Naba Das murder case as it has expertise in behavioural analysis

Bhubaneswar, Feb 22: Speaking for the first time on the brutal murder of former Odisha Health Minister Naba Kishore Das, Chief Minister Naveen Patnaik said Wednesday that the state Crime Branch is seeking the help of the Federal Bureau of Investigation (FBI) of the US, as they have the best expertise in behavioural analysis in such cases. Patnaik made the announcement following a ruckus by the Opposition BJP and Congress in the Assembly.

'We have requested the Ministry of Home Affairs (MHA) to facilitate an evaluation of the behaviour of the accused by the behavioural support unit of the FBI," the chief minister said.

Das was gunned down January 29, by now dismissed ASI of police, Gopal Das. In view of the sensitive nature of this incident, a Crime Branch investigation was ordered immediately. To ensure transparency in the investigation, the Orissa High Court has nominated retired judge JP Das to monitor the probe as per the request of the government.

Patnaik said that the Crime Branch has been asked to do a thorough and scientific investigation to establish the truth in the case. To examine whether the accused is telling the truth or is being deceptive, several tests including psychiatric evaluation, narco-analysis, forensic psychological assessment and lavered voice analysis of the accused were conducted, Patnaik informed the Assembly. ### Harassed SI wants to quit

Jajpur, Feb 22: A sub-inspector (SI) of Odisha police has written to the Jajpur SP alleging constant mental torture by his senior and has offered to resign from his job, officials said Wednesday.

SI Radhanath Das posted at Dharmasala police station in Jajpur district dashed off the letter Tuesday to Jajpur SP police Vineet Agarwal. Das alleged that the inspector-in-charge (IIC) of the police station, Rakesh Tripathy has been harassing him mentally and threatening to put him in trouble during his tenure at the police station.

Das alleged that the IIC has been ignoring investigation into a number of important cases, including POCSO and rape incidents. Instead of probing the cases himself, he was allegedly forcing the SI to handle such sensitive matters.

'I have an ailing mother at home and she is in the last stage of her life. However, I have been deprived of leave to visit her. I'm mentally depressed as I'm not able to visit my mother," Das said in the letter.

A top district police official said "We will conduct an inquiry into the allegations and if found true suitable action will be taken.' Tripathy denied the allegations.





■ How was the journey from studying chemical engineering to running a chemical products business?

Generally, youths prefer to get a good government job that will offer them modest income and job security when they complete higher education. But when I finished my engineering course, I wanted to start my own business. And, because I was a student of chemical engineering, I had a weakness towards chemical products manufacturing. So, initially I started sourcing different types of raw materials from Kolkata and then in 1999 I started Smile Plus brand to formally run a chemicals business

Can you tell us about the current state of chemicals manufacturing market?

Minor chemical products business has existed before and it will continue to exist in future too. But there is a lot of importance given to the business environment and processes as well as the consumer demand as the market is large and sustainable in long run. And specifically in Odisha, the demand is always higher because these chemical products are used everywhere, from households to laboratories and from industries to social sector. Similarly, market leaders in this sector always enjoy the lion's share of profit. So, to survive in the industry, you have to prioritise good customer relationship.

■ What changes do you see in the demand for minor chemical products before and after Covid?

Before Covid in Odisha, approximately 40 per cent of the population used different chemical products manufactured for household use. But after Covid, it has increased to 75 to 80 per cent because of the panic created by the pandemic. People have started spending more on phenyls, bleaching and hand washes. Similarly, though the demand for minor chemical products is high, rise in import cost and raw material cost have pushed the price up.

What are your plans for expanding the business in future?

 We have plans to survive in the current competitive environment but none to expand the business. But we are constantly taking steps to change our business strategy to come closer to the customers. Smile Plus brand is now selling many minor chemical products while Jayadurga Chemicals, Jayadurga Pet Industry and Smile Gold are running other

### Oppn, BJD cross swords over minister's killing

Bhubaneswar, Feb 22: Even as the Crime Branch (CB) is groping in the dark to ascertain the motive behind now sacked cop Gopal Das killing minister Naba Das January 29, BJP, Congress and ruling BJD Wednesday engaged in mudslinging over the issue.

Attacking the BJP, which dragged 5T Secretary VK Pandian and BJD organisational secretary Pranab Prakash Das Tuesday into the murder case, the ruling dispensation Wednesday alleged that Union Minister Dharmendra Pradhan and Leader of Opposition (LoP) Jayanarayan Mishra had threatened the now slain minister during the Padampur bypoll.

Hinting towards senior BJD leader and former minister Susanta Singh, the state Congress, on the other hand, alleged that an influential (bahubali) leader of western Odisha is behind the sensational killing.

Speaking to reporters outside the House, BJD MLA Rudra Pratap Maharathy alleged that Union Minister Dharmendra Pradhan and the LoP may have involvement in the minister's murder.

"During the Padampur byelection, Das (Naba) had told me that Pradhan and Mishra were using force and intimidating him. They were asking him to stay off the Padampur bypoll," alleged

Stating that Das had played a key role in the Padampur by election, the BJD legislator said that BJD won the bypoll with a huge margin, thanks to Das. He demanded that both Pradhan and Mishra should be brought under the purview of investigation.

Reacting to Maharathy's allegation, BJP MLA Suryabanshi Suraj, said, "Naba babu was a senior leader. Why should he discuss these stuffs with Maharathy? If he was scared, he could also have taken up the matter with the Election Commission and sought intervention of the police.'

Commenting on the Chief Minister's statement in the House on the murder, BJP MP Suresh Pujari said, "It's evident that the CB probe has completely gone off track. It's unfortunate that instead of reposing faith in the CBI, they (state government) are now seeking the help of a foreign agency (FBI).

Meanwhile, Congress MLA Tara Prasad Bahinipati alleged that 'bahubali' leader of western Odisha is behind the assassination, which has sent shockwaves across the state.

ing him, following which he is seen falling down. The child was apparently carrying a packet containing some food items when the dogs pounced on him, a Greater Hyderabad Municipal Corporation (GHMC) official said. In his Twitter account, Swain said,

"Seeing this horrifying incident at Hyderabad, I have directed respective CDVOs of all 30 districts of Odisha to be strictly vigilant and remove stray dogs from roads. CDVOs have also been instructed to take immediate & proper action regarding this."

The state government had last year launched a state animal helpline number and a tele veterinary service for protection of stray and abandoned an-

The toll-free helpline will extend veterinary service through animal ambulance in 11 urban areas of the state. The helpline will be functional round the clock. Citizens can dial 1962 or 155333 to avail all necessary help pertaining to stray animals.

New Delhi, Feb 22: The Ministry of Education has directed all states and Union Territories to fix the minimum age for admission in Class 1 as six years, officials said

According to the new National Education Policy (NEP), the foundational stage consists of five years of learning opportunities for all children (between 3 to 8 years) that includes three years of preschool education followed by Classes 1 and 2.

"The policy thus promotes seamless learning and development of children from pre-school to class 2. This can only be done by ensuring accessibility to three years of quality preschool education for all children studying in Anganwadis or government, government-aided, private and NGO-run preschool centres," a senior MoE official said.

"The ministry has directed state governments and UT administra-

tions to align their age to admission with the policy and provide admission to class 1 at the age of six years and above," the official added.

The Supreme Court had last year observed that children should not be sent to schools at a very young age keeping in mind their psychological and mental health.

The MoE officials said the most important factor at the foundational stage is the availability of qualified teachers who are especially trained in the age and develop mentally-appropriate curriculum and pedagogy.

The ministry has also advised states to initiate the process of designing and running a two-year diploma in preschool education (DPSE) course in their respective iurisdiction.

"The course is expected to be designed by the State Council of Educational Research and Training (SCERT) and run or implemented through District Institute of **Education and Training (DIETs)** under supervision and hold of SCERTs," he said.

### **ILS discovers** drugs for malaria

Bhubaneswar, Feb 22: Institute of life sciences, (ILS) Bhubaneswar continues to make significant progress in research and development and addressing social issues. This process had taken pace and shape during the able stewardship of late Ajay Parida, Ex-

In a predominant development ILS scientist Arun Nagraj and his team have discovered therapeutic interventions which can prevent cerebral and severe malaria mortality. This would be a milestone achievement for the malaria prone area of the state and for the societv as a whole.

Malaria remains a major global health concern causing 247 million infections and 619,000 deaths in 2021. The most vulnerable populations include children under five years of age and pregnant women. In spite of the intense global efforts to roll back malaria, there is no significant reduction in the global incidence since 2015 and rather, there is a considerable increase. This is further worsened by the emergence of drug resistance in parasites and insecticide resistance in mosquitoes.

Falciparum malaria is the deadliest one responsible for more than 90 per cent of infections and deaths. The mortality due to cerebral and severe malaria occurs despite treating the patients with WHO-recommended artemisininbased combination therapies (ACTs). The last resort is intravenous administration of antimalarials - artemisinin or quinine, along with supportive therapies. Therefore, there is a need of adjunct therapy to prevent malaria mortality. Heme is required for various cellular functions and malaria parasite makes

# **Potato Mission lets farmers down**

Absence of storage facility in Kendrapara has forced the tuber growers to sell off their harvest at throwaway prices

Kendrapara, Feb 22: Just two months back, potato was being sold at ₹25 to ₹30 per kg in Kendrapara district. However, much has changed within these two months with prices of the tuber dropping to an unbelievable low.

Things have come to such a pass that farmers are forced to resort to distress sale. They are now selling the tuber at just ₹4 per kg to the traders, who are selling it at ₹7 per kg in the open market.

Undertaking potato cultivation has been a let-down for farmers as the district neither has storage facilities nor government mandis to store or sell their harvested potatoes respectively. Lack of storage facilities in the district has forced farmers to sell off their harvest at throwaway prices.

A potato farmer Bidhubhushan Mohapatra of Palei village under Derabish block said that he has cultivated potato on four acre of farmland and also reaped a good harvest. However, all the farmers who have undertaken potato cultivation are encountering problems to store or sell off their produce. Mohapatra apprehends that

Another farmer Kalpataru Samantaray of Pattamundai said that the local farmers have cultivated potato on over 30,000 hectare of farmland. However, they are unable to store their leftover stocks anywhere for sale later. Moreover, they are forced to sell their harvest to the local traders due to lack of any government mandi, he added.

The state government's ambi-

A local entrepreneur Ratanlal Samal said that farmers are forced to resort to distress sale during harvest of tomato and potato. Realising the problem, many aspiring youths are interested to set up food processing industry for manufacturing of potato chips and tomato sauce.

They have been contacting various banks and the district industry centre to get a loan. However, no such industry has been established yet in the district due to lack of coordination between the banks and the district industry centre, he rued

Farmer leader Gayadhar Dhal said that the state government launched Potato Mission in 2015-16 to achieve self-sufficiency in potato production. The mission implemented by the state Horticulture department aimed at making the farmers self-reliant through potato cultivation and reducing dependency on outside states for the essential tubers.

The Potato Mission however has failed to achieve any success. The state government had sanctioned ₹20 crore in 2017-18 FY for the mission but not a single pie has been spent under the scheme which finds mention in the 2019 CAG report.

The problem could be resolved only through establishment of food processing units, cold storages and government mandis, he said.

When contacted, Debadas Dutta, assistance director of Horticulture department said that the problem can be resolved with construction of cold storages but the district lacks even a single cold storage.

### Sand mafia attack Derabish tehsildar

'Then we called up the police. Irked by the development, the vehicle owner threatened us with dire consequences. Subsequently, he called some people and the miscreants tried to snatch documents from me. They also attacked me and I have been badly injured in the process," he added.

Parida alleged that the sand mafia also took their vehicle under their control in a bid to prevent them from leaving the place. The attackers even threatened to mow them under the vehicle.

Parida received treatment at Kendrapara hospital and then lodged a complaint at Kendrapara Sadar police station.

In his complaint, Parida has sought stringent action against the accused for attacking government officials on duty and preventing them from carrying out their tasks.

### Over 500 kg ganja from Ganjam seized in Greater Noida

Noida, Feb 22: More than 500 kg of cannabis brought from Odisha's Ganiam to be smuggled into the National Capital Region has been seized by the police in Uttar Pradesh's Greater Noida, officials said Wednesday.

The consignment is pegged at worth more than ₹1 crore in black market and two persons have also been arrested in connection with the case, Deputy Commissioner of Police (Greater Noida) Saad Miya Khan told reporters.

Khan said the police have been continuously targeting gangs and people involved in drug trafficking and narcotics smuggling.


"Some gangs have been busted in the past also and in one such case in which around 500 kg of cannabis was seized, a suspect identified as Ratan Singh, who is a native of Hapur district, was absconding and a reward also announced on his arrest." Khan said.

"Today, a consignment of the same Ratan Singh has been seized by the officials of the Knowledge Park police station and the SWAT team. The total recovery is 539 kilogrammes of cannabis which was concealed in a canter truck," the DCP said.

Besides Ratan Singh, a person identified as Sadashiv Mishra, who hails from Ganjam district in Odisha, has also been arrested, the officer said. Khan said the estimated value of

the seized cannabis is worth more than ₹1 crore, and the consignment had started from Ganjam in Odisha and was meant to be smuggled in Noida and other parts of the NCR.

An FIR is being lodged at the Knowledge Park police station and further legal proceedings are underway, the officer said, adding that a reward of ₹20,000 has been announced for the police teams involved in seizing the cannabis.

## Fire line to contain forest fires in Keonjhar district

**Keonjhar**, **Feb 22**: At a time when Similipal wildlife sanctuary in Mayurbhanj district continues to battle wildfire, forest officials in Keonjhar have launched efforts to ensure that the district's forests do not fall prev to the blaze.

They are using 'forest fire line' to prevent fire breaking into the forest from one compartment to another. The collected litter, which is mostly dry leaves, was burnt in isolation. Reports said that the fire spreads only if there is continuous supply of dry vegetation along the path of fire.

The forest officials in Palashpanga forest section under Sadar forest range in Keonjhar forest division have launched efforts to contain the forest fire with the involvement of women self-help groups (SHGs) and the local Vana Suraksha Samitis (VSSs) comprising the vigilant villagers in the area.

Learning from past experiences, the forest officials are leaving no stone unturned to ensure no forest fire takes place in the jungle. The programme will soon be extended to other parts of the district, sources said.

fires have been organised by the Vana Suraksha Samitis at Aharpasi, Kandrapasi Amunipur, Naigaon, and Sandiapasi villages under Palshpanga forest section. The women members joined the programme and completed the work on the fire lines.

They have roped in the members of 16 women SHGs and undertaken clearing of vegetation and controlled burning of the of the same to create bald patches of land across the boundary line of the forest to prevent the fire from spreading further into other areas in the jungle. Meanwhile, the programme is underway at Baulamala and Kashirapatna areas where the forest officials with the assistance of Vana Suraksha Samitis are completing the work on fire lines with the active involvement of women SHGs.

Attending a programme organised by Baulamala Vana Surakasha Samiti Palashpanga forester Jaikruhsna Das, forest guard Subhasini Giri and members of Vana Surakasha Samiti explained the role of villagers in containing forest fires. Later, the participating villagers also took a pledge to protect the forest from fire and other threats.

### MAN IN TROUBLE FOR KEEPING 30 CATS IN CHHATRAPUR

CHHATRAPUR: In a strange occurrence, a police complaint was filed against Basanta Biswas Ray Wednesday for keeping more than 30 pet cats in his residence situated near Sankarmatha Street in Chhatrapur of Ganjam district. ### **Broken State**

The town of Joshimath may be nestled 6,000 feet (1,800 meters) above sea level in the Himalayas, but it is sinking fast. In early January, large cracks split homes, hotels, and roads, leaving the town's future hanging in the balance. Joshimath is a grim metaphor for India's woefully unaccountable state.

Joshimath is located in a seismically active zone of landslide debris and sediment layered over a weak assemblage of rocks. Such terrain naturally sinks and slides, but the problem is made worse by deforestation. Moreover, because the Alaknanda River (a tributary of the Ganges) has eroded the northwestern toe of the slope on which Joshimath stands, the formation does not have a high load-bearing capacity, as has been known since the

Cracks appeared in Joshimath's roads in the 1970s. In 1976, a committee appointed by the government of Uttar Pradesh (of which Joshimath was then a part) reiterated the risk of subsidence (sinking) and advised that construction be undertaken only in areas determined to be stable. This official warning went unheeded, and local activists fought unsuccessfully to forestall unsafe construction.

The problem grew worse following the economic liberalisation of the early

1990s, when the state endorsed and supported a form of unregulated capitalism, which often centered around lucrative construction contracts and featured a total disregard even contempt – for the environment. Joshimath's current troubles began innocuously in 1993, when Auli, a neighbouring town, began construction of a ski-resort ropeway. That was the opening salvo in a much broader construction programme.

State authorities soon launched ambitious plans for hydroelectric dams to harness the energy from Himalayan runoff. The 400megawatt Vishnuprayag plant became operational in 2006, and construction of the more controversial 520 MW Tapovan-Vishnugad dam began the same year. To generate electricity from the project, a tunnel had to be built under the Joshimath hillslope, directly below the Auli ski resort. In 2009, a tunnel-boring machine punctured an aquifer in the mountain, depleting the groundwater on which Joshimath and other nearby towns depended. Sediment then filled the gaps left by the receding water, which some experts and activists believe added to the area's subsidence tendency.

In June 2013, a disastrous flood killed more than 4,000 people in the area, leading to legal proceedings in which the Supreme Court ex-

pressed grave concerns over the "mushrooming" of dams in the region. The court was aghast that the authorities had not scientifically assessed "the cumulative impact" of the dams and the associated blasting, tunneling, muck disposal, mining, and deforestation. Under a court order, the government appointed an expert committee headed by the noted environmental scientist and activist Ravi Chopra.

The Chopra Committee concluded that the Himalayan mountains, rivers, and communities were in "a crisis" exacerbated by global warming. The government's "rampant development" approach, the committee said, would cause more deforestation and biodiversity loss alongside "unpredictable glacial and paraglacial activities." Warning that this explosive combination would invite even greater disasters in the future, the committee proposed halting work on 23 dams

When a second committee endorsed the Chopra Committee's judgement, the government appointed a third committee that gave the go-ahead for more dams, and in July 2020, the authorities invited bids for the Helang-Marwari bypass road through a fragile landslide zone near the foot of the Joshimath hill. Construction of the bypass began two years later as part of Prime Minister Narendra Modi's ecologically damaging programme to ease travel to the holy shrines in the Himalayas.

Disasters continued to take lives. In February 2021, another flood killed a few hundred people, mainly around Tapovan-Vishnugad and another dam site. The dams themselves were almost irreparably damaged, and activists called on the Uttarakhand High Court to halt dam construction. The court threw out the case, reprimanding the petitioners and fining them for wast-

After unusually heavy rains in October 2021, the cracks in Joshimath reached a tipping point. By January 2023, the threat of collapsing structures had made large parts of the town uninhabitable. Hundreds of residents have been herded into shelters, and the government has halted the rehabilitation of the Tapovan-Vishnugad dam and construction of the

Helang-Marwari bypass. Yet with calamity looming, credible information has become hard to come by. National authorities recently ordered the Indian Space Research Organisation to unpublish satellite images that reveal the pace at which Joshimath is sinking, and officials are now prohibited from speaking to the media about the matter.

Joshimath is hardly alone. Many other towns and roads throughout the Himalayan range are showing similar signs of stress. This should surprise no one. It is vet another symptom of Indian authorities' criminal lack of accountability. More tipping points loom as forests are being cleared; lakes, wetlands, and natural water reservoirs are being built over; urban areas are contending with mountains of garbage; and rivers have been almost irreversibly polluted. Education, healthcare, the judicial system, and city services work mainly for the privileged.

The practice of embellishing data, integral to the lack of accountability, extends to macroeconomic management. GDP growth jumped inexplicably after a data revision in 2015. In 2018, the government rejected its own survey when it showed that poverty had increased. The finance ministry reports absurdly unrealistic unemployment figures, despite a jobs crisis. The decadal census that was due in 2021 has been postponed until some unknown future date.

India's elite, with its "see-no-evil" approach to economic discourse and policy, has blotted out Joshimath's fate as an aberration of nature. Instead, world-class electronic-payment systems and technology-based startups have fed a global narrative of an imminent "Indian century." Make no mistake though: Joshimath is a microcosm of the brazen unaccountability corroding Indian politics and society. It should be a reality check, not a footnote.

## **LESSONS FROM AMERICA**

**EVEN AMERICA HAS A BIG PROBLEM BY WAY OF FARMER SUICIDES** 

arlier this month, President Joe Biden delivered his State of the Union Address, which is the annual message delivered by the President to a joint session of the United States Congress. It is always widely covered by the media. The President's political comments and observations on international matters were also recorded by the Indian media, but none of our publications reported that President Biden had frankly spoken about the poor state of US veterans (ex-servicemen). There are several lessons for India that we should not miss.

The first point he mentioned was the rate of suicides among former servicemen. He said: "We cannot go on losing 17 veterans a day to the silent scourge of suicide." According to the 2022 annual report of the Department of Veteran Affairs, suicides of ex-servicemen had increased from 5,989 in 2001 to a peak of 6,700 in 2017, then it came down to 6,261 in 2019 and 6,146 in 2020. The second point Biden touched upon is the "homelessness" of the veterans. He said that his government would help veterans pay their rent because "no one should be homeless in this country, especially not those who served it." According to the report submitted by the Department of US Housing and Urban Development (HUD) to the US Congress, the number of "homeless" veterans was 33,136 in 2022. This has come down from the peak of 74.087 in 2010 and 37.252 in 2020.

Suicides and attempted suicides, which may or may not necessarily be related to homelessness or financial conditions, are also a problem, given the country's high per capita income of \$70,248 (2021). In 2020, there were overall 45,799 suicide deaths in America. The Commonwealth Fund, a private US research organisation for healthcare said in their annual report for 2020 that the US has the "highest suicide rate of any wealthy nation." According to them, this is twice the number in Britain. Part of the reason is the high rate of mental illness, increasing number of substance use, drug overdoses and the inability of many people

to pay for mental health treatment.

It was a revelation to me, when I studied this subject further, that even America has a big problem by way of farmer suicides. There are many reasons. On March 9, 2020, USA Today published that US farmers were "saddled with near-record debt, declaring bankruptcy at rising rates and selling off their farms amid an uncertain future clouded by climate change and whipsawed by tariffs and bailouts." During 2014-18, more than 450 farmers had committed suicide across nine mid-western states. The paper said that the toll could be more as all states had not provided data.

According to this paper's survey, the main reasons were plummeting commodity prices by about 50% since 2012, farm debts jumping about by a third from 2007 and reaching levels last seen in the 1980s. Also, bad weather, which prevented farmers from planting nearly 20 million acres in 2019 alone, and political reasons like the US soybean exports to China dropping by 75% from 2017 to 2018 amid trade tensions.

On November 27, 2019, Time Magazine wrote that the "picturesque American family of small farms" had been declining for generations and remained only on holiday greeting cards. They were affected by foreign policy tensions like trade wars, climate change, falling commodity prices, new technologies, globalisation and corporate farming. "Chapter 12 farm bankruptcies" had gone up by 12% in the Midwest from July of 2018 to June of 2019 and up to 50% in the Northwest. This is a special legal provision for farmers (a version of the "Chapter 11 bankruptcy" for non-farmers) to retain ownership provided they reorganise their finances within a stipulated period of time. As a result, thousands of small farms just stopped their farming as they felt that they would not be able to reorganise their business through this route. Thus, the US lost more than 100,000 farms between 2011 and 2018, with 12,000 between 2017 and 2018 alone.

On 9 March 2019, The Guardian UK) went to the root of the problem, which was "factory farming" or what we call "corporate farming." One feels proud of our farmers that they had stood defiantly steadfast to prevent such a situation in India during 2020-21.

It all began in 1970 when the then Agriculture Secretary Earl Butz pushed the idea of large farms and asked the small farmers either "to get big or get out." It said that President Richard Nixon "plucked him out of Purdue's agriculture department and planted him in the USDA-Department of Agriculture.'

Grist, a non-profit "climate solutions" organisation (Feb 8, 2008) said that Butz wanted a "hyper-efficient, centralised food system, one that could profitably and cheaply feed the world by manipulating mountains of Midwestern corn and soy." Amazingly, Butz was then serving as a board member of several "agri biz" corporations like Ralston Purina. He rejected criticism that his corporate connection would compromise his government policy decisions.

Listening to this, many farmers took big loans and expanded their production. However, President Jimmy Carter's 1980 grain embargo against the Soviet Union struck a big blow, wiping off farmers' income overnight. Simultaneously, high interest rates drove up costs and debts increased for family farms. Land prices collapsed and banks started attaching farmers' properties. Every blow to independent farming made it more of an opportunity for large corporations to come in. The paper found that in 1990, small and medium-sized farms had produced nearly half of all agricultural production in the country. Now it is less than a quarter. When small farms collapsed, the local businesses helping their lives also crumbled. Local seed and equipment suppliers closed their shops as "corporates" purchased things from wholesalers or manufacturers.

"Demand for local vets collapsed As those businesses packed up and left, communities shrank. Shops, restaurants and doctors' surgeries closed. People found they had to drive for an hour or more for med ical treatment. Towns and counties began to share ambulances.

Many owners who had to take up jobs after bankruptcy moved out. Low paid migrants who were imported from outside came in-a textbook story of how capitalism kills the soil and the worker, as Karl Marx once said.

in the recent Union Budget, is testimony to this. It is disheartening that the government remains oblivious to the ever-widening disparity between the rich and the poor, between the urban and rural sectors and between the organised and unorganised sector workers

Another point highlighted by the Prime Minister was that "some may argue that confrontation and greed are just human nature" but he refuted this proposition. To back his view, he pointed to the spiritual traditions pursued by human beings as evidence of the higher instincts that lie embedded in human beings. While many Indian political leaders have focussed on the path of diplomacy, dialogue and negotiation instead of taking recourse to violence and war to resolve inter-state disputes, Modi sought to provide a theoretical underpinning to his view on the causes of wars between states and that past reasons for war are no longer applicable due to technological advances.

This is indeed a laudable observation, but on the other hand his government has not denounced the invasion of Ukraine by Russia. Obviously, the economic factor may have stood in the way of India takand the desire to correct historical wrongs are also reasons for hostility. Social notions of superiority despite the political acceptance of equality cannot be wished away. These too, lead to conflict within states and between states. And in India, this is very much evident as the present establishment is in process of re-writing history and correcting the so-called wrongs of the Mughals.

The resultant violence among communities, especially Hindus and Muslims, has affected our social fibre and life and has impeded the process of development. Caste had always been a crucial factor for political parties to garner votes and now the present dispensation is exploiting religion for political gains. This does not augur well for a developing country like India with professed secular ideals. The bogey of ultra nationalism and other ideological vice has no meaning for the socially and economically backward sections.

One may refer to a book recently released by Prof. Ranabir Samaddar which pointed out that the existing networks of solidarity based on family, religious community, kinship and workplace ties weakened, the interventions of the State weakened with the increasing "finan-

Another important development of recent years is rampant corruption across the country and all those who are involved are directly or indirectly linked to political bigwigs. Economists have attributed these developments to the growth of crony capitalism and following Western models of materialism in trying to develop the country without thinking of the grassroots.

The value system in society is lost and the young generation has an uncertain future. The lack of jobs, the deteriorating social atmosphere and the corruption in society along with promotion of Hindu nationalism have further pushed them to a precarious situation. The huge population of the country poses a challenge to development, but a serious concern of how to bring the poor into the mainstream of life and activity, which is connected, goes largely unanswered. Much more needs to be done.

### Cheetah translocation

Sir, 12 cheetahs from South Africa have arrived at Kuno National Park, Madhya Pradesh under the Indian government's efforts to reintroduce cheetahs in India after their extinction for seven decades. This is the second time in six months that cheetahs have arrived in the Kuno National Park from an African country. Last year in September cheetahs from Namibia was translocated to India. The last cheetah died in the year 1947 and India declared cheetah an extinct species in the year 1952. India has recently signed an MoU with South Africa to bring more than 100 cheetahs over the next few years. This reintroduction programme is the world's first intercontinental translocation project of wild animals. The success of the project will depend on how the African cats adapt themselves to the Indian conditions and how well they will breed.

## No SC relief for Uddhav

New Delhi, Feb 22: In a jolt to the Uddhav Thackeray camp, the Supreme Court Wednesday refused to stay the Election Commission order recognising Maharashtra Chief Eknath Shinde-led bloc as the real Shiv Sena and alloting the party's original 'bow and arrow' poll symbol to it.

The top court, while issuing notice to the Shinde group on the appeal against poll panel's decision, permitted the Thackeray faction to use 'Shiv Sena (Uddhav Balasaheb Thackeray)' name and 'flaming torch' as poll symbol in state by elections scheduled for February 26.

"Issue notice...Senior advocates N K Kaul, Mahesh Jethmalani and Maninder Singh (for Shinde) receive notice... Counter affidavit, if any, be filed within a period of two weeks. Pending further orders, the protection (on use of party name and flaming torch symbol) and which has been granted in paragraph 133 (IV) of the impugned order of the Election Commission dated February 17, 2023 shall continue to remain in operation," ordered the bench headed by Chief Justice DY Chandrachud.

It, however, did not grant any relief to the Thackeray camp despite its vehement submissions that the assets of the party and its bank accounts be saved from being taken over by the Shinde faction.

Senior advocate Kapil Sibal, assisted by lawyer Amit Anand Tiwari, urged the court on Thackeray's behalf that a status quo order on party properties and bank accounts be granted as the Shinde faction is taking over everything on the ground that now they are the real Shiv Sena

Does the (EC) order contain any direction with regard to bank accounts and properties? asked the bench, which also comprised Justices PS Narasimha and J B Pardiwala. "No, no," replied Sibal, adding, "but, they will say that they are the real party and will take



over everything. Rather, they are doing that". "Mr Sibal, if something is part of the Election Commission order we can certainly look at. This does not form... The EC order is confined to the allotment of symbols. Now for us to go beyond is not possible ... Equally, now they have succeeded after hearing before the Election Commission, we cannot pass an order which has the effect of staying the order without hearing them," the bench said.

There was some positive outcome for the Thackeray faction as senior advocate  ${\bf N}\,{\bf K}$  Kaul, appearing for the Shinde bloc, assured the bench it will not take steps like issuing whip or initiation of disqualification proceedings against lawmakers – MLAs, MLCs and MPs – of the Thackeray faction for the time being.

The assurance came after senior advocate A M Singhvi, also appearing for Thackeray, raised apprehension, saying "Tomorrow, if they issue a whip or a letter and if we do not do it then we will be disqualified. Now they are the party. I have no protection. Your lordships should give us the status quo at least.'

This led the bench to ask: "If we take this (petition for hearing) after two weeks, are you in the process of issuing a whip or disqualifying them." "No, no, responded Kaul.

The bench, while refusing to grant the interim relief of status quo on properties and bank accounts, said though it was entertaining the plea of Thackeray it cannot "stay an order at this stage as they have succeeded before the EC.'

Sibal also sought the liberty to move the court again if the Shinde faction takes any action to precipitate the situation by taking over properties

"That is independent of the EC order. Ultimately that is a contractual relationship within a political party. Any further action is not based on the Election Commission order," the bench said, adding the Thackeray group will have to "exhaust other remedy

At the outset, the Shinde group raised preliminary objections on maintainability of the plea, saying the petition against the EC decision should have been filed in the high court.

The poll panel said that even for recognition of a political party, the number of votes, number of lawmakers are taken into account, and as there was no democratic set up in the organisation, the majority in the legislative wing was considered, Kaul said countering Sibal.

The Sena chief elects members of the electoral college and they, in turn, elect the party 'pramukh', he said, adding this led the EC to take note of the majority in the legislative wing of the party while deciding which group is the real Sena.

Hyderabad, Feb 22: In another incident of street dogs targeting children in Hyderabad, a four-year-old boy playing outside his house in Chaitanyapuri here has been attacked by canines, leading to bleeding injuries.

The boy's mother told media that a pack of four to five dogs Tuesday chased three children, and attacked her son resulting in scratches and bleeding injuries to him. He was taken to hospital for treatment, according to the woman.

She said her neighbours were feeding the stray dogs despite objections by some residents there. "Earlier also, stray dogs -attacked the locals and complaints were made to municipal authorities then and they caught the dogs. But the neigh-

bours, who were feeding them got these  $\,$ dogs released and they are attacking the children," the woman claimed.

The woman said after noticing the dogs attacking her son, she along with some other locals rescued her child. She demanded the municipal authorities to immediately take away the stray dogs from the area as they are pouncing on children and others.

A police official, however, said they have not received any complaint over the incident. This comes close on the heels of the gruesome instance of a pack of stray dogs attacking and killing a four-year-old boy in Amberpet in the city February 19. The child was apparently carrying a packet containing some food item when the dogs pounced on him, a Greater Hyderabad Municipal Corporation (GHMC) official said. The incident was caught on CCTV camera and the footage went viral provoking public outcry.

In a high-level meeting, Special Chief Secretary Arvind Kumar Wednesday directed the officials to pay special attention on controlling the stray dog menace in GHMC limits. The senior bureaucrat chaired the meeting to chalk out an action plan on a war-footing to prevent the menace of stray dogs in the civic body's limits along with other municipalities in the state, an official release said.

He instructed GHMC officials to immediately carry out Animal Birth Control (ABC) sterilisation operations. Municipal authorities have been directed to restrict the hotels, restaurants, function halls, meat markets within the GHMC limits from dumping waste on the streets.

# In a first, tiger spotted in Himachal

Spotting of tiger in Himachal assumes significance as there are plans by the NTCA for reintroducing tigers in the western part of Rajaji from the eastern landscape

Shimla, Feb 22: A fully grown tiger caught on a camera-trap in Himachal Pradesh's 27.88-sq-km Simbalbara National Park, which supports dense Sal forests with grassy landscape and diverse wildlife and bird species, has sent foresters and wildlife conservationists into a tizzy as they say the wild big cat was captured for the first time in the state.

The news comes as a major boost for state wildlife wing as elephants are the sporadic visitors to the Simbalbara National Park in the Paonta Valley in Sirmaur district that lies in the Shivalik hills, adjacent to Haryana's Kalesar National Park.

On the spotting of the tiger, Divisional Forest Officer (Wildlife) N Ravisankar told IANS Wednesday that its pugmark was spotted on the periphery of the national park January 16. "Since then our teams led by Range Officer Surender Singh were constantly working to trace the whereabouts of the tiger. We have installed eight camera traps at various locations in the park to record its presence," he

"A clear picture of the tiger has been seen four days ago in one of the cameras in which the tiger is seen sauntering in the park,'

The Shimla Wildlife Division has shared a tweet that contains the image of the first ever tiger found in the territory of Himachal Pradesh. The division also said that this is the first camera trap image of a tiger recorded in Himachal Pradesh.

Ravisankar added.

Forest department officials believe the movement of the tiger is likely between the Simbalbara National Park and the adjoining Kalesar National Park in Haryana, both parks support diverse prey

But they are certain that the tiger has come from the Rajaji National Park in Uttarakhand over a month and a half months back.

"The Simbalbara National Park and its surrounding areas have reported tiger sightings over the decades, but no conclusive evidence of their presence was ever found. This is the first documentation in the park, of course, big cat spotting brings cheer." a wildlife conservationist told IANS.

"The tiger is rare in Himachal Pradesh. In such a situation, the presence of tiger in the state is considered a good sign for both biodiversity and eco-tourism," he said.

"In the footage, the tiger seems healthy, a clear indication that the park supports enough prey species to sustain it with no chance of conflict with another predator," said another official.

After the spotting of the tiger's pugmark, the department claimed that it started removing 'Lantana camara' in the park, so that the tiger does not have difficulty in moving. Invasive lantana grass threatens the tiger habitats.

For tracking the movement of the tiger, the Forest department took assistance of the Wildlife Institute of India, Dehradun, to install eight camera-traps.

According to the Zoological Survey of India (ZSI), the Simbalbara National Park is the only conservation area in Himachal Pradesh where the occurrence of

tiger and elephant has been re-

In a faunal survey by the ZSI in 2005 and 2006, tiger pugmarks and scats were observed in two instances. One scat sample collected was composed of pure soil with abundant undigested ants, while another scat sample composed of digested bones in the form of powdery calcareous substance along with undigested hairs.

Although Simbalbara supports a good prey base for large carnivores, its smaller size is not suitable for a tiger to reside permanently, says the ZSI.

In November last, a herd of elephants was spotted in Simbalbara National Park, which is now renamed as Sher Jung National Park On the habitat of the elephants,

the ZSI says since grass is the major

size and deciduous vegetation of Simbalbara without much grass land, cannot sustain an elephant herd for a longer period. Hence the park is not an attractive habitat for the elephant. On the tiger's presence in

Simbalbara, Ravisankar said the water flow in the Yamuna river is minimised during winter and there "is possibility that it reached up to Simbalbara from the Rajaji National Park in neighbouring Uttarakhand"

Upbeat over the spotting of tiger, wildlife experts say this is good to know that a tiger is able to reach up to Simbalbara. They say the contiguity of Rajaji-Kalesar-Simbalbara makes the landscape extremely important and worth protecting.

Simbalbara, originally the hunting ground for the Maharaja of Sirmaur, is home to the sambhar. spotted deer (cheetal), barking deer wild boar, the blue bull and many other prey mammals.

The park shares a boundary with the Darpur, Majra and Nagli reserve forests with seasonal and perennial streams.

Yogi govt presents state's biggest ever Budget for FY 23-24

Lucknow, Feb 22: The Uttar Pradesh government Wednesday presented the Budget FY24 with an aim to lay the foundation for a self-reliant Uttar Pradesh and focus on the all-around development of the state for making it a USD 1 trillion economy.

The budget of ₹6,90,242.43 crore for FY24 was the biggest in the state's history.

'This budget was for 'Atmanirbhar Uttar Pradesh'. It will prove to be a milestone for making the state's economy USD 1 trillion," Chief Minister Yogi Adityanath said, adding that in the past six years, the government ensure 'sabka saath, sabka vikas, sabka vishwas, sabka prayas (Together, everyone's development, trust and effort).

He said his government's first budget in 2017 was dedicated to farmers, budget in 2018 for infrastructure and industrial development, 2019 for women empowerment, 2020 for youth power, employment and infrastructure development, 2021 for self-reliance and empowerment, 2022 'from antyoday' to 'atmanirbhar' (self-reliance).

He said that while Ayodhya will be developed as a model solar city, the number of active airports in the state will go up to 21 in the days to come.

For the metro in Varanasi, Gorakhpur and other cities, a provision of ₹100 crore has been made, while construction work of expressways will also be accelerated. he noted. For farmers, in the past budget, the government gave them a subsidy of 50 per cent in electricity for irrigation and this will be increased to 100 per cent in a systematic way in future.

The government will also provide ne cylinder free to beneficiaries of the Ujjawala scheme, he said, adding that the first night safari will come up in Kukrail in Lucknow.

The chief minister also said the exports from the state rose to over 1.60 lakh crore from over ₹86 lakh crore in 2017-18. And in the past six years, per capita income and GDP have doubled.

Earlier, finance minister Suresh Kumar Khanna tabled the budget in the state Legislative Assembly.

Targeting youths, the budget made provision of ₹1,050 crore under the 'Chief Minister Kanya Sumangala Yojana', ₹4,032 crore

For providing tablets and smartphones to eligible students under Swami Vivekananda Youth Empowerment Scheme, a provision of ₹3,600 crore has been made in the budget for the financial year 2023-24.

On the infrastructure front, the finance minister proposed a provision of over ₹21,159 crore for the construction of roads and bridges. and ₹6.209 crore for their maintenance.

Khanna said ₹3,473 crore is proposed for the work of bridges and roads for agricultural marketing facilities and ₹1,525 crore for roads in rural areas.

While ₹1,700 crore is proposed for the construction of railway overhead bridges and ₹1,850 crore for other bridges, the budget proposed ₹2.588 crore for widening/strengthening and new works of state high-

A provision of ₹2,538 crore is proposed for widening/strengthening and new works of major/other district roads. Khanna said. With religious tourism in mind, the budget proposed ₹1,000 crore for the development of 'Dharmarth Marg' (roads to religious places). The budget also proposed ₹3,000 crore for maintenance of roads and ₹2,500 crore for construction from the State Road Fund,

out on clothing or fingers when touched. The disease can spread rapidly under congenital conditions and affects crop development and eventually yield.

Yellow rust requires living green plant material to survive. In the winter, the fungus survives as dormant mycelium or active sporulating pustules on volunteers and autumn-sown crops. Although low temperatures kill pustules, mycelium within plant tissue can survive temperatures of minus 5°C.

Normally, wheat crop in certain parts of Punjab, Haryana, and J&K is affected by stripe rust or yellow rust caused by a fungal pathogen, Puccinia striiformis presently.

The prevalence of the disease was found to be 5 to 7 per cent in villages Bahal and Sadhwan. Based on the weather forecast in the district, the chances of spread of this disease are high in the coming one or two weeks, farmers are advised to keep monitoring their fields from time to time during this period.

The Deputy Director said that if the symptoms of this disease were seen in the wheat field, make a solution of one milliliter propiconazole fungicide in one liter of water and sprinkle it in the affected area.

#### 5 killed as tempo collides with car

Lunawada: At least five persons were killed and nearly 15 injured when a tempo turned turtle in Gujarat's Mahisagar district following a head-on collision with a car on Wednesday afternoon, a police official said. Sources said the death toll might increase. About 20 passengers travelling on a tempo to attend a pre-wedding event when the vehicle met with an accident near Kotha village of Lunawada taluka, said Deputy Superintendent of Police PS Tadvi citing preliminary investigation.

### Major fire in **Dharavi slum**

Mumbai: A major fire broke out in some structures in Dharavi, the biggest slum in Mumbai, in the wee hours of Wednesday, but there was no report of injury to anyone, officials said. The blaze erupted in Kamala Nagar and Shahu Nagar localities near the Dharavi fire station around 4.15 am, they said. "At least 12 fire engines, eight water tankers and other fire brigade vehicles were engaged in the firefighting operation. The fire was doused around 11.50 am after more than seven hours of efforts," the official said.

### GJM, Hamro party 'suspend' bandh

Darjeeling / Kolkata: The pro-Gorkhaland parties Wednesday suspended the planned 12-hour bandh in Darjeeling hills February 23 for the time being, citing the class 10 West Bengal board exams which are starting on that date. The parties, however, maintained that they would continue to fight for the aspirations of the hill people. The Gorkha Janmukti Morcha (GJM) and Hamro Party had Tuesday called for a 12-hour strike in the Darieeling hills February 23 to protest a motion passed in the state Assembly opposing "attempts to divide the state".

### Newly-married couple found dead

Raipur: A newly-married couple was found dead with stab injuries on their bodies inside a room at their house just before their wedding reception in Chhattisgarh's capital Raipur, police said Wednesday. Police suspect that a scuffle broke out between the duo, following which the man stabbed his wife to death before killing himself. The incident took place at Brijnagar under Tikrapara police station limits late Tuesday evening, an official here said.

## **GIRLS MOVE SC FOR PERMISSION TO TAKE EXAM IN HEADSCARF**

Following the SC's split verdict on the issue of ban on sporting the Islamic headscarf in educational institutions in Karnataka, girls in hijab are not being permitted to take the exams scheduled to begin from March 9, a bench headed by CJI DY Chandrachud was told

New Delhi, Feb 22: The Supreme Court said Wednesday it will take a call on listing a plea for allowing Muslim girl students to sit for examinations in Karnataka government schools while wearing the hijab.

They are wearing headscarf. If they are wearing headscarf they are not allowed inside the examination hall. Only on that limited aspect, the court may consider listing it on Monday or Friday," said lawyer Shadan Farasat.

He told the bench, also comprising Justice P S Narasimha, that a few girls have moved to private institutions because of the prohibition on wearing hijab but have to take their exams in government institutions. They risk losing another year if not permitted, he said. "I will take a call," the CJI said.

Due to the split verdict, the high court's judgement still holds. The split verdict October 13 last year held off a permanent resolution to the

hijab row as both judges suggested placing the matter before a larger bench for adjudication.

The top court had said last month it will consider setting up a threejudge bench to adjudicate the case related to the ban on wearing the Muslim headgear in Karnataka

government schools. While Justice Hemant Gupta, since retired, had dismissed the appeals challenging the March 15, 2022 judgement of the Karnataka High Court which had refused to lift the ban, Justice Sudhanshu Dhulia held there will be no restriction on wearing hijab anywhere in the schools and colleges of the state. Permitting a community to wear its religious symbols to schools will be an "antithesis to secularism", Justice Gupta had said, while Justice Dhulia insisted that putting on the Muslim headscarf should simply be a "matter of choice"

Earlier, a full bench of the Karnataka High Court March 15 had dismissed a batch of petitions filed by Muslim girls studying in pre-university colleges in Udupi seeking the right to wear hijab in classrooms. The high court had stated that wearing the hijab is not an essential religious practice in Islam and that the Freedom of Religion under Article 25 of the Constitution is subject to reasonable restriction.

During the arguments in the apex court, a number of counsel appearing for the petitioners had insisted that preventing Muslim girls from wearing the hijab to the classroom will put their education in jeopardy as they might stop attending classes.



New Delhi, Feb 22: India and China Wednesday held diplomatic talks in Beijing and discussed proposals for disengagement in the remaining friction points along the LAC in eastern Ladakh in an "open and constructive manner", but there was no indication of any

breakthrough. During the meeting held under the WMCC framework, the two sides agreed to hold the 18th round of military talks at an early date to achieve the objective in accordance with the existing bilateral agreements and protocols, the Ministry of External Affairs (MEA) said.

The Working Mechanism for Consultation and Coordination on India-China Border Affairs (WMCC) was established in 2012 as an institutional mechanism for con-

sultation and coordination for the maintenance of peace and tranquillity in the border areas.

"The two sides reviewed the situation along the Line of Actual Control (LAC) in the Western Sector of India-China border areas and discussed proposals for disengagement in the remaining areas in an open and constructive manner. which would help in the restoration of peace and tranquillity along the LAC in Western Sector and create conditions for the restoration of normalcy in bilateral relations,

the MEA said. "To achieve this objective in accordance with the existing bilateral agreements and protocols, they agreed to hold the next (18th) round of the Senior Commanders meeting at an early date," it said in a statement. The MEA said the two sides agreed to continue discussions through military and diplomatic channels.

"The 26th meeting of the WMCC was held on 22 February 2023 in person in Beijing. This was the first WMCC meeting since the 14th meeting held in July 2019, to be held in person," it said. The Joint Secretary (East Asia) from the Ministry of External Affairs led the Indian delegation. The Chinese delegation was led by the Director General of the Boundary and Oceanic Affairs Department of the Chinese Ministry of Foreign Affairs.

The 17th round of military talks was held December 20 but there was no indication of any forward movement in the resolution of the remaining issues

### **Court sends Sahil** to judicial custody

New Delhi, Feb 22: A metropolitan court here Wednesday remanded Sahil Gehlot, accused of killing his secretly married wife Nikki Yadav and stuffing her body into a fridge, in 12-day judicial custody.

Meanwhile, the Delhi Police have invoked fresh charges against Gehlot and others in the case, his lawyer said. Chief Metropolitan Magistrate Archana Beniwal passed the order for sending Gehlot to jail.

Gehlot along with five other coaccused will now be produced in court March 6. Gehlot's father, two cousins and two friends were arrested in the case. DS Kumar, the counsel for Gehlot, said while the FIR was initially registered under Sections 302 (murder) and 201 (causing disappearance of evidence of offence, or giving false information to screen offender) of the IPC, police have now invoked sections 120 B (criminal conspiracy), 34 (common intention), 202 (intentional omission to give information of offence by person bound to inform) and 212 (harbouring offender) of the penal code.

Earlier Monday, a court had extended the police custody of Gehlot (24) by two days, while other five coaccused were remanded in 14-day judicial custody.

New Delhi, Feb 22: Cancer of the large intestine, called colorectal cancer, is on the rise in India and although there has been a decline in the death rate, experts stress on early screening, especially of those aged 45 and above, and a healthy lifestyle to prevent fatalities.

According to experts, while it is common to think that having a family history makes it difficult for one to keep cancer at bay, the disease is quite often lifestyle driven and even in hereditary cases, prevention and early diagnosis can improve outcomes. "Cancer is being caused by multiple factors. Genes do play a role, but only 1-2 per cent cases are genetic. The rest are lifestyle driven. It takes just a faulty inner or outer environment to switch the bad genes on," Dr Vivek Mangla, a Gastro-intestinal, Hepato-Pancreatico-Biliary and Colorectal surgeon, said. "As the saying goes prevention is better than cure, it is advisable that people seek preventive screening for colorectal cancer. Any person aged above 45 years should go for it," he added, more so if there is a family history of cancer.

"The polyps can be mostly removed endoscopically, sometimes requiring surgery which can be done laparoscopically, or by robotic surgery. These are minimally invasive procedures which shorten the length of a patient's stay in the hospital."However, if the polyp turns cancerous, one might need to have those removed surgically mostly laparoscopically, or by robotic surgery," Dr Mangla said.

According to him, there is no need for one to be worried or over-



whelmed following a colorectal cancer diagnosis. Stage I and II colorectal cancer can be cured in more than 90 per cent of cases and

stage III in about 70-75 per cent. About 40 per cent of patients with Stage IV but resectable colorectal cancer can be cured despite the disease having advanced

to stage four, the doctor said. "In early stages of rectal tumours, we usually avoid attaching stoma (a tool to help passage of stools). For advanced cases also, most patients receiving radiation and chemotherapy would need a temporary stoma which would be closed once the postoperative treatment is over." "Using special laparoscopic and surgical techniques, we can preserve a person's ability to pass stool normally albeit with an increase in stool frequency which usually settles over time.

nent colostomy," Dr Mangla said. Studies suggest that a sedentary lifestyle and faulty food habits are making this variant of cancer common, even among the young, Dr M D Ray, Professor at the department of Surgical Oncology at AIIMS, Delhi said.


Over the last five years, the disease has doubled to four out of one lakh people from 2-3 in 1 lakh people, he stated.

Although this number may seem insignificant, because of the huge population of India, which has become the most populous country in the world, it adds up to a huge disease burden.

No wonder that colorectal cancer, which was the seventh most common cancer to affect Indians, has shot up to third place.

"If a member of your family had this cancer before turning 40 or 50, the risk of this disease for you is high. You should get a colonoscopy done around 20 years of age. After that, undergoing colonoscopy every 1 to 3 year, depending on the molecular variety of the cancer, is advisable under the guidance of the concerned expert." Dr Ray stated. He also added that 80 per cent of cancer is preventable and even cur-

able if detected early.

#### **Nord blast probe:** Russia, West clash

United Nations: Russia clashed with the United States and other Western nations Tuesday over the Kremlin's call for a UN investigation of last September's sabotage of the Nord Stream 1 and 2 gas pipelines from Russia to Western Europe, Russia's UN Ambassador Vassily Nebenzia told the UN Security Council that Moscow has "no trust" in the separate investigations being carried out by Denmark, Sweden and Germany, but it does "fully trust" UN Secretary General Antonio Guterres to establish an independent international investigation of the explosions.

### **UK govt supports BBC** over I-T row

London: The British detended the BBC and its editorial freedom in Parliament after the Income-Tax department's survey operations on the UKheadquartered media corporation's New Delhi and Mumbai offices over three days last week. David Rutley, Parliamentary Under-Secretary of the FCDO, pointed to a "broad and deep relationship" with India which meant the UK was able to discuss a wide range of issues in a "constructive manner".

### **China approves** \$700mn for Pak

Islamabad: In a boost to the forex reserves, Pakistan Finance Minister Ishag Dar announced Wednesday that the Board of China Development Bank has approved a \$700 million facility for Pakistan. The News reported. "This amount is expected to be received this week by State Bank of Pakistan which will shore up its forex reserves!" tweeted finance minister Dar, adding that the formalities have been completed. However, according to official sources, two more commercial loans were expected, including \$500 million and \$800 million.

# Russia-China ties at new frontiers: Putin

Moscow, Feb 22: President Vladimir Putin said Wednesday that China's Xi Jinping would visit Russia, saying relations had reached "new frontiers" amid US concerns that Beijing could provide material support to Russia's invasion of

Chinese weapons supplies to Russia would threaten a potential escalation of the Ukraine war into a confrontation between Russia and China on the one side and Ukraine and the US-led NATO military alliance on the other.


Putin welcomed China's top diplomat, Wang Yi, to the Kremlin, telling him that bilateral trade was better than expected and could soon reach \$200 billion a year, up from \$185 billion in 2022.

"We await a visit of the President of the People's Republic of China to Russia, we have agreed on this. Putin told Wang. "Everything is progressing, developing. We are reaching new frontiers," Putin said.

Wang told Putin that relations between the two countries had withstood the pressure from a volatile international situation and that crises offered certain opportunities.

The relationship between China and Russia, Wang said through an interpreter, was not directed against any third party but equally would "not succumb to pressure from third parties" - a clear jab at the United States.

Together we support multi-polarity and democratisation in international relations," Wang told Putin. "This fully meets the course of time and history; it also meets the interests of the majority of



#### XI. PUTIN'S SELF-INTEREST

For Putin, China's big-power support amid the biggest confrontation with the West since the height of the Cold War allows him to cast Russia's isolation in the West as a tilt towards Asia For Xi, Russia is now more dependent on China than ever. Once the leader in the global Communist hierarchy, Russia after the 1991 collapse of the Soviet Union is now a junior partner to a resurgent China which already leads in many 21st century technologies

Wang earlier met Russia's Foreign Minister Sergei Lavrov, saying that he looked forward to clinching new agreements during his visit to Moscow. There were no details on the agreements.

When Xi met Putin face to face just before Russia sent troops into Ukraine, they sealed a "no limits" partnership that triggered anxiety in the West.

China has pointedly refused to criticise the invasion of Ukraine echoing Moscow's claim that the US and NATO are to blame for provoking the Kremlin while blasting the punishing sanctions imposed on Russia. Russia, in turn, has staunchly supported China amid tensions with the US over

The two nations have held a series of military drills that showcased their increasingly close defence ties.

The rapprochement has worried the West, leading US Secretary of State Antony Blinken to warn that any Chinese involvement in the Kremlin's war effort would be a 'serious problem.'

Relations between Russia and the West are at their lowest point since the Cold War, and ties between China and the US are also under serious strain. Moscow suspended its participation in the last remaining nuclear arms control treaty with Washington this week And the US expressed concern in recent days that China could provide arms and ammunition to Russia.

### 'Putin's suspension of US arms treaty big mistake'

WARSAW: President Joe Biden said Wednesday that Russian President Vladimir Putin made a "big mistake" by suspending his country's participation in the the last remaining US-Russia nuclear arms control treaty. The US President was in Poland to reassure eastern flank NATO allies that the US will remain by their sides amid the grinding Russian invasion of Ukraine.

In his first comments since Putin's announcement Tuesday, Biden condemned the Russian decision to pull back from the treaty, known as New START. The decision to suspend Russian cooperation with the treaty's nuclear warhead and missile inspections follows Moscow's cancellation late last year of talks that had been intended to salvage an agreement that both sides have accused the other of violating.

Russia said Wednesday it would need to see a change in NATO's stance and a willingness for dialogue before it would consider returning to its last remaining nuclear treaty with the United States.

The lower house of the Russian parliament voted quickly in favour of suspending Moscow's participation in the New START treaty, rubber-stamping a decision that President Vladimir Putin announced on Tuesday when he accused the West of trying to inflict a "strategic defeat" on Russia in Ukraine.

Asked in what circumstances Russia would return to the deal, Kremlin spokesman Dmitry Peskov said: "Everything will depend on the position of the West... When there's a willingness to take into account our concerns. then the situation will change.'

Russian President Vladimir Putin's announcement Tuesday that Moscow is suspending its participation in the last remaining US-Russia arms control treaty will have an immediate impact on US visibility into Russian nuclear activities, but the pact was already on life support

The 2010 treaty limits each country's deployed nuclear warheads to 1,550. Security analysts say its potential collapse could unleash a new arms race at a perilous moment when Putin is increasingly portraying the Ukraine war he launched one year ago as a direct confrontation with

### IFJ suspends **Russian union**

Brussels, Feb 22: The International Federation of Journalists (IFJ) has suspended with immediate effect the Russian Union of Journalists over its action since Russia's invasion of Ukraine and its role in annexed Ukrainian territories

The IFJ, which represents more than 600,000 media workers across the world, said the Russian union's membership was suspended following an investigation then a vote by its global executive committee Wednesday. The vote was held after the union refused to reconsider its decision to set up branches in four regions annexed by Russia, the federation said. "The Russian Union of Journalists' actions in establishing four branches in the an-



nexed Ukrainian territories have clearly shattered ... Solidarity and sown divisions among sister unions," said IFJ President Dominique Pradalié.

The Kremlin in September illegally annexed the Donetsk, Kherson, Luhansk and Zaporizhzhia regions, where it claims its rule is welcomed. Pro-Moscow separatists have controlled part of Donetsk and neighbouring Luhansk province since 2014.

The IFJ said it will continue to support independent journalists inside and outside Russia while providing aid to its Ukrainian affiliates. According to the federation. Ukraine was the deadliest country for journalists in 2022, with 12 media workers killed while doing their work.

### Second Indian-American enters 2024 US prez bid

Ramaswamy, 37, whose parents migrated to the United States from Kerala and worked at a General Electric plant in Ohio, made the announcement during a live interview on Fox News's prime time show of Tucker Carlson, a conservative political commentator.

Earlier this month, two-term former governor of South Carolina and former US Ambassador to the United Nations, Haley announced her presidential campaign. She announced that she will contest against

### Pak PM announces austerity measures

*Shehbaz emphasised the need for all citizens*, including government officials, to do their part in addressing the country's economic challenges, urging them to embrace a culture of frugality

Islamabad, Feb 22: Pakistan Wednesday announced a raft of austerity measures like Cabinet ministers and advisors not drawing salaries and not staying at fivestar hotels during foreign trips, as a desperate government attempt to pull the country out of its economic morass amidst mounting

criticism against the ruling elite. Pakistan, which is in dire need of funds as it battles a wrenching economic crisis, has received financial assistance from the International Monetary Fund (IMF) in the past and is presently in discussions with the organisation to resume its loan programme.

An agreement on the ninth review of the programme would release over \$1.1 billion. A resumption of the IMF programme would also unlock other avenues of funding for Pakistan.

PRESS TRUST OF INDIA Prime Minister Shehbaz Sharif announced the decisions agreed upon in the Cabinet meeting which after a detailed discussion approved the measures to cut official expenditures.

"All Cabinet members and advisors have voluntarily decided that they will not draw salaries or any other benefits from the state treasury and also pay their utility bills," he said.

He said that Cabinet members would stop the use of luxury cars and travel in economy class and would not stay in five-star hotels during foreign trips. It would also apply to all government officers.

The premier also announced a gross 15 per cent reduction in the current expenditure of each federal government department and urged the provinces to follow the suit and cut expenditures. He also banned the use of luxury cars by cabinet members.



He also banned the purchase of all luxury items, including new cars till June 2024. The prime minister said that the colonial period palatial official accommodation by district officers would be put to better use.

Other measures include the opening of government offices at 7.30 am in summer and starting a one-dish policy at government functions. The policy will not apply to events held for foreign guests.

The measures came as the country bent its back to get \$1.1 billion from the IMF under a \$7 billion loan package to avoid a default on foreign payments.

The PM also said talks with the IMF Fund were at the "last stage" and hoped that "matters would be settled in a few days" to get the agreement

Pakistan has been severely impacted recently by the floods that put one-third of the country under water.

The cataclysmic floods inundated a third of the country, displaced more than 33 million and caused economic damages to the tune of \$12.5 billion to Pakistan's already teetering economy. The devastating floods last year killed 1.739 people.

Washington, Feb 22: Seattle has become the first US city to outlaw caste discrimination after its local council passed a resolution, moved by an Indian-American politician and economist, to add caste to its non-discrimination policy.

The resolution moved by Kshama Sawant, an upper-caste Hindu, was approved by the Seattle City Council by six to one vote. The results of the vote could have far-reaching implications on the issue of caste discrimination in the US.

"It's official: our movement has won a historic, first-in-the-nation ban on caste discrimination in Seattle! Now we need to build a movement to spread this victory around the country," Sawant, a

city council member, said soon after the resolution was voted.

Hours ahead of the vote, Indian-American Congresswoman Pramila Jayapal lent her support to the move.

'Caste discrimination has no place in society anywhere in the world, including here in America. That is why some colleges and universities have banned it on campuses, and workers are fighting for their rights and their dignity in cases involving caste discrimination," she said.

The Hindu American Foundation, which had campaigned against the resolution, said singling out South Asians and the addition of 'caste' to the non-discrimination policy violates the very policies it now amends.

The City of Seattle has voted to treat South Asians (and Southeast Asians and African) in a manner that

no other ethnic or racial community is treated under the guise of nondiscrimination. It has voted yes to discriminating against ethnic minorities, repeating the ugliness of nativists in the state nearly a century ago," Suhag Shukla, co-founder and executive director of the Hindu American Foundation said. In passing this resolution, Seattle

is now in violation of the US Constitution's guarantees of equal protection and due process that prohibit the state from treating disparately people on account of their national origin, ethnicity, or religion, and implementing a vague, facially discriminatory and arbitrary category, Shukla alleged.

'Seattle has taken a dangerous misstep here, institutionalising bias against all residents of Indian and South Asian origin, all in the name of preventing bias," said HAF managing director Samir Kalra.

"When Seattle should be protecting the civil rights of all its residents, it is actually violating them by running roughshod over the most basic and fundamental rights in US law, all people being treated equally," Kalra said.

Many Indian-Americans fear that codifying caste in public policy will further fuel instances of Hinduphobia in the US.

Over the last three years, ten Hindu temples and five statues, including those of Mahatma Gandhi and Maratha emperor Shivaji, have been vandalised across the US as an intimidation tactic

against the Hindu community. Indian-Americans are the secondlargest immigrant group in the US. According to data from the 2018 American Community Survey (ACS), which is conducted by the US Census Bureau, there are 4.2 million people of Indian origin re-

siding in the United States.

India banned caste discrimination in 1948 and enshrined that policy in the Constitution in 1950.

#### ADB proposes \$25bn to India

New Delhi: The Asian Development Bank's (ADB) president has proposed up to \$25 billion development support to India over 5 years in a meeting with Prime Minister Narendra Modi Tuesday, a statement from the bank said. "ADB will provide multifaceted support for India's key priorities," the statement quoted ADB president Masatsugu Asakawa as saying. This includes support for an infrastructure push a under a connectivity plan, support for building cities, mobilising domestic resources and strengthening basic services in disadvantaged districts, the statement added.

### Adani firm repays ₹1.500 crore loan

New Delhi: Adani Ports and Special Economic Zone has repaid ₹1,500 crore loan and will repay another ₹1,000 crore in commercial papers due in March. The Adani Group firm paid ₹1,000 crore to SBI Mutual Fund and ₹500 crore to Aditya Birla Sun Life Mutual Fund on commercial papers that matured Monday, as scheduled. An SBI MF spokesperson said it has no further exposure. "SBI MF had an exposure of around ₹1,000 crore to Adani Group, which has been repaid on maturity. We have no further exposure to the Adani Group," he said.

Mumbai, Feb 22: Benchmark Sensex tanked 927 points while the broader Nifty settled at a fourmonth low Wednesday due to an intense selling in heavyweight stocks triggered by geopolitical and inflation concerns.

The BSE Sensex tumbled 927.74 points or 1.53 per cent to settle at 59,744.98, the lowest closing level since February 1. As many as 29 of the Sensex stocks declined. During the day, it tanked 991.17 points or 1.63 per cent to 59,681.55.

The 50-issue NSE Nifty declined 272.40 points or 1.53 per cent to end at a four-month low of 17,554.30 with 47 of its constituents ending in the red. As many as 2.592 stocks declined while 884 advanced and 130 remained unchanged. Also, 266 firms hit their 52-week low levels on the BSE.

The rupee depreciated by 9 paise to settle at 82.88 against the US dollar Wednesday. Foreign Portfolio Investors (FPIs) sold shares worth ₹579.82 crore.

In the broader market, the BSE midcap gauge declined by 1.16 per cent and smallcap index fell by 1.09 per cent. From the Sensex pack, Bajaj Finance, Bajaj Finserv, Reliance Industries, Wipro, HDFC Bank, HDFC, ICICI Bank and Tata Steel were the major laggards. ITC was the lone winner in the Sensex pack.

### India to contribute 15% of global growth in 2023, says IMF MD

*IMF MD expects India to* witness fastest growth rate among major economies

Washington, Feb 22: India continues to remain a relative "bright spot" in the world economy and will alone contribute 15 per cent of the global growth in 2023, International Monetary Fund (IMF) managing director Kristalina Georgieva said.

While digitisation pulled out the world's fifth-largest economy from pandemic lows, prudent fiscal policy and significant financing for capital investments provided in the next year's budget will help sustain the growth momentum.

"India's performance has been quite impressive. For this year, we expect India to retain a high growth rate, 6.8 per cent for the year that ends in March. For FY 2023/24 (April 2023 to March 2024) we project 6.1 per cent, a bit of slow down like the rest of the world economy, but way above the global average. And in that way, India is providing about 15 per cent of global growth in 2023," Georgieva told PTI in an interview. That is the fastest growth rate among major economies.

India remains a bright spot at a time when the IMF is projecting 2023



to be difficult with global growth slowing down from 3.4 per cent last year to 2.9 per cent in 2023, she observed.

"Why is India a bright spot? Because one, the country has done really well to turn the digitalization that has been already moving quite well into a major driver of overcoming the impact of the pandemic and creating opportunities for growth and jobs," the Managing Director noted.

"Second, because India's fiscal policy has been responsive to economic conditions. We have seen the new budget presented, and it signals the commitment to fiscal consolidation, while at the same time provides significant financing for capital investments. And three, because India didn't shy away to learn the lessons from the pandemic and to implement very strong policies to overcome what has been really a difficult time for a number of months," she said.

New Delhi, Feb 22: Foreign direct investment (FDI) into India declined by 15 per cent to \$36.75 billion during the April-December this fiscal, according to the latest Department for Promotion of Industry and Internal Trade data.

The FDI inflows stood at \$43.17 billion during the corresponding period of the previous year.

The total FDI inflows, which includes equity inflows, re-invested earnings and other capital, declined to \$55.27 billion during the nine months of the current fiscal year as against \$60.4 billion in the year-ago pe-



Mumbai, Feb 22: Majority of members of the high-powered Monetary Policy Committee (MPC) of the Reserve Bank were concerned about heightened inflation even as two panellists raised objections against an increase in the benchmark interest rate, according to the minutes of the meeting released Wednesday.

Following the recommendations of the MPC, the RBI increased the rate by 25 basis points February 8, taking the reporate to 6.5 per cent. It was the sixth straight hike since

#### Ashok K Meena told PTI The government January 25 announced that it will offload 30 lakh tonne of wheat in the open market. Wheat is being offloaded under the OMSS to cool down the retail prices of wheat and wheat flour (atta). To further soften the retail wheat prices, the government recently reduced the reserve price of FCI wheat offered to bulk users and also announced the sale of an additional 20 lakh tonnes of wheat in the open market.



After the announcement of the OMSS policy, the food ministry has said that prices of wheat and atta have come down but still inflation figure for January 2023 was at a three-month high of 6.52 per cent.

As per the government data, the average price of wheat across major cities stood at ₹33.09 per kg on Wednesday, while the average price of atta (wheat flour) stood at ₹38.75 per kg.

Last week, the ministry reduced the reserve price of fair and average (FAQ) quality wheat to ₹2,150 per quintal, while for Under Relaxed Specifications (URS) wheat to ₹2,125 per quintal. These new reserve prices were applicablefrom the third sale of wheat

through e-auction.

Washington, Feb 22: One month into the invasion of Ukraine, President Joe Biden stood in the courtyard of a grand Polish castle and laid out the punishing economic costs that the US and its allies were inflicting on Vladimir Putin's Russia, declaring that the ruble is almost immediately "reduced to rubble.'

Russia is now the world's most heavily sanctioned country, according to US officials. The ruble

Australia opener Betth Mooney is wary of India's challenge though going by past results, they should win comfortably.

## 'No psychological edge over India'

Cape Town, Feb 22: Australia skipper Meg Lanning believes her side will not go into the Women's T20 World Cup semi-final against India with a psychological edge, saying past results don't matter against a strong team.

Australia will take on India for a place in the World Cup final, after defeating Harmanpreet Kaur's side 4-1 in the five-match T20I series last December and also the 2022 Commonwealth Games final in Birmingham, besides triumphing in the 2020 T20 World Cup final at MCG.

"I don't think so (Australia will have a psychological advantage), said Lanning on the eve of the semifinal here. "Both teams start at the same level tomorrow when we come out and play. What's happened in the past doesn't make a difference. We need to come out and play our best cricket and play the way that we want to.

"And in India, we look to do the same. So, as I said, it's going to be an incredible game, two world-class teams going at it. And it's about putting out your best performance on the day," added Lanning.

The captain also said beating India in the five-match series last December in Mumbai doesn't make Australia firm favourites, given that the opponents are an "incredible side" and are not relying on just a couple of players to win them games.

"I'm not sure (Australia are favourites), to be honest. We obviously both know each other very well. They're (India) an incredible side. They've got some match winners and world-class players and it's going to be a cracking game.

"Obviously, we came here to be part of a game like this and we're expecting to have to play at our best to win. And that's something that I know this group is up for and we're certainly very much looking forward to it."

She also added that India now have a strong group which bats deep and is able to deliver in bigticket events. "I think that they've shown that they're not relying on one or two players. They've got some great depth as well. So, for us as a team, we've had to prepare for all their players to do well.

"And I think when you get to that point as a squad, you know vou're going to be in most games because T20 cricket, some things work out, some things don't. And sometimes it's not going to be your day. But as long as someone steps up, then that's the most important thing. And that's what they've shown to be able to do.

"They've really created that real strong group of players who have played a lot of cricket together now. And they're able to deliver. So, we know they're strong. And that sort of just makes the challenge even greater and something we look forward to."

Meanwhile, star Indian keeperbatter Richa Ghosh feels that her side would need to put up at least 180 on board to challenge the depth of Australian batting line-up.

"Australia is comfortable chasing because they bat deep, we do too, but toss is not in anyone's hand. So whatever the situation, we will have to go through with it. We have plans," Ghosh, India's best finisher by a distance, said on the eve of the semi-finals against Southern Stars.

"We don't know how the pitch will behave tomorrow but it looks nice. We can target 180 on this if all our batters click and while bowling we will try to restrict them to 140-150 because they have a good batting line up," Ghosh said.

Australia has been India's bogey team in recent years but Ghosh is confident that Meg Lanning's team is a beatable one. Australia have been a dominant force in the format since winning the last edition in 2020 at home.

"Australia are beatable, in the our last series we beat them and we have also done it before. They are a strong team but we can beat them," Ghosh stated. "We are trying to improve our mindset. Everyone has the game but the team that is mentally strong will win. We have been working on that," said Ghosh.

"We know the weak spot of Australia and we are planning against it but I will not say what that (weakness) is because then they will come prepared."

The hard-hitting Ghosh said India will play an attacking game similar to Australia Thursday. "They attack a lot. So, whatever happens to them, even if the batter is out, they don't leave the attacking. Because they have batters from top to bottom. We also have batter from top to bottom. So, we will play an attacking game.

Liverpool, Feb 22: While both Real Madrid and Liverpool are rightly considered Champions League royalty, there can only be one king. Down by two goals after 14 minutes at Anfield, defending champion Madrid came back to win 5-2 Tuesday and take a commanding lead into the second leg of the round of 16 matchup.

Vinicius Jr and Karim Benzema scored two goals each to stun the hosts — Liverpool conceded four goals in a home European match for the first time — and confirm the Spanish giant will take some stopping in their defense of the trophy.

If anything, this Madrid team look more complete than the one that beat Jurgen Klopp's team in last year's Paris final. Yet this win echoed the memorable comebacks that led to that record-extending 14th Champions League title.

There was the chaotic defending that allowed Liverpool to race into a 2-0 lead as Darwin Nunez struck with a backheel in the fourth minute and Mohamed Salah doubled the advantage thanks to Madrid goalkeeper Thibaut Courtois' blunder. Then came the rousing fight-

back, led by one of European football's emerging stars in Vinicius and sealed by an aging icon in Benzema. Eder Militao was also on the scoresheet when he headed Madrid into a 3-2 lead just after halftime.

The 22-year-old Vinicius became the youngest player to score two goals against Liverpool at Anfield since Johan Cruyff for Ajax in 1966 when the Dutch great was 19. The Brazil international is establishing himself as Madrid's star player and, in the face of a typically daunting Anfield atmosphere, he rose to the occasion.

Just as the visitors looked in danger of buckling under the pressure, Vinicius produced a moment of magic with his first goal in the 21st. Exchanging passes with Benzema just inside the box, there didn't look to be any obvious danger until he flashed a low shot through a crowd of legs and into the bottom corner.

Vinicius evened the score in the 36th when Alisson's attempted kick rebounded straight off him and looped into an empty net. While the goal was a moment of good fortune, it was also a measure of the panic he sparked in Liverpool's defense that Alisson was rushed into

making the mistake.

Two minutes after halftime, Madrid took the lead when Militao headed in Luka Modric's free-kick from the left. It went from bad to worse for Liverpool as the 35-yearold Benzema, the inspiration for Madrid's triumph last year, got in on the act. His shot was deflected off Joe Gomez in the 55th to make 4-2 and he added and fifth when rounding Alisson in the 67th.

### Napoli beat Frankfurt

Victor Osimhen scored again to help Napoli to a 2-0 win at Eintracht Frankfurt in the first leg of their Champions League last-16 tie. The Nigeria forward scored his 10th goal in his last eight appearances across all competitions, opening

the scoring in the 40th minute. Napoli captain Giovanni Di Lorenzo scored the second goal in the 65th by finishing a wonderful team move with a sweeping, curled shot inside the far post after Kvaratskhelia back-heeled the ball into his path. Frankfurt's hopes of mounting a comeback were dealt a major blow minutes before when forward Randal Kolo Muani was sent off for catching Anguissa with his open sole as both went for the ball.

### VIDIT STUNS CARLSEN AT PRO CHESS LEAGUE PRESS TRUST OF INDIA

Chennai, Feb 22: Grandmaster Vidit Gujrathi became the fourth Indian to stun Norwegian chess wizard Magnus Carlsen, in a Pro Chess League online match. Playing for team Indian Yogis, Gujrathi capitalised on a mistake committed by World No.1 Carlsen, who missed a checkmate late Tuesday.

Carlsen was playing for Canada Chessbrahs in the Pro Chess League, an online tournament for teams from all over the world. The event features 16 teams playing rapid games and has a USD 150,000 prize fund.

This was Gujrathi's maiden victory over the reigning World Champion. Significantly, Gujrathi won the match with black pieces as he exploited a tactical oversight from his famous opponent.

## Aishwary bags ISSF WC gold

Cairo, Feb 22: Olympian Aishwary Pratap Singh Tomar claimed the gold medal in the men's individual 50m rifle 3 positions competition at the ISSF World Cup here Wednesday as India continued their dominance in the tournament. This was the Indian's second individual World Cup gold, the first coming in South Korea.

This was India's sixth medal, including four gold, in the tournament as the country strengthened its position at the top of the medals tally.

The 22-year-old Tomar, who had also won a gold in the Changwon

gold-medal contest to comfortably beat Austria's Alexander Schmirl. Tomar was placed second in the ranking round, with a total score of 406.4, while Schmirl was at the top with 407.9.

Earlier, the Indian had topped the qualification after aggregating 588 over the three stages of kneeling, prone and standing. Akhil Sheoran, another Indian participating in the event, was second in the qualification with 587.

Tomar first topped the qualification round with a score of 588 after 20 shots each in the kneeling, prone and standing positions. He had teammate Sheoran for company in the ranking round.

The Indian duo began slow in the ranking round with Tomar sixth and Sheoran eighth after the first five kneeling position shots.

After the end of the allocated 10 shots in the second prone position however, both had moved up with Sheoran in second and Tomar in fifth. All the while the Austrian Schmirl was leading the match and did so till the end of the ranking round.

It changed dramatically after the first five standing position shots, as India number one Tomar got up to second, just 0.5 behind Schmirl who was still leading.

Sheoran was down to fifth and eventually bowed out in seventh place after 30 shots. After 40 shots both the Austrian and the Indian held on to the top two positions to set up a gold medal clash.

In the gold medal round, which is basically a race to 16 points with two points being awarded to the winner of each single-shot series, Tomar took the first series.

 $However, it\, remained\, tight\, with$ the scores reading 4-4 and then 6-6 before the Indian broke away with some sensational shooting to close out the match. A timeout taken by the Austrian at 6-12 did nothing to break Tomar's momentum.
