

ing and one has to work'. I went there for work. My friend was in Canada and he said, 'come here'. I applied and I got in.



# Survey pegs state's growth rate at 7.8%

Per capita income stands at ₹1,50,676 as against nat'l average of ₹1,70,620

**Bhubaneswar, Feb 23:** Odisha's economy is estimated to grow at 7.8 per cent in real terms by the end of current financial year (FY) 2022-23 against the national rate of 7 per cent.


This was revealed in Odisha Economic Survey Report for FY 2022-23 that was laid before Assembly Thursday.

In 2022-23, the state's economy is expected to grow at 7.8 per cent which is higher than pre-Covid average growth of 7.1 per cent (2012-13 to 2019-20) in real terms.

The survey report also said, "The state economy is poised to grow at 8 per cent to 8.5 per cent in real terms in 2023-24 by harnessing human, natural, and financial resources and strengthening the productive base of the economy."

The state's growth resilience is reflected in its average medium-term growth rate of 7.9 per cent from 2013-14 to 2021-22, leaving aside the Covid year.

In nominal terms (growth in current price), Odisha grew by a rate of 23.5 per cent against the

### BUDGET TODAY

Finance Minister Niranjan Pujari will present state's annual Budget for 2023-24 in the Assembly Friday. The Budget outlay was approved by the Council of Ministers February 13 this year. According to sources, the total size of the Budget will be around ₹2.30 lakh crore -15 per cent more than last full-fledged Budget of ₹2 lakh crore. As this will be the last full-fledged Budget of the current government, some new schemes and programmes are expected to be announced during its presentation in the House.

national average of 19.5 per cent in 2021-22, it said.

Agriculture and allied sectors employ more than 40 per cent of the workforce, thus being the biggest employment generating sector in Odisha. This sector is expected to grow at 5.9 per cent in FY 2022-23 as against 3.5 per cent at all-India level.

Due to proactive measures of the government, agriculture and allied sector grew at nearly double the rate than of all-India rate of 6.3

per cent in real terms in 2020-21.

Similarly, industry sector has recorded the highest growth on average in pre-Covid times (7 per cent). However, in 2022-23, the industry sector is expected to grow at 6.1 per cent, as per the report.

The third major sector, the services sector, is expected to grow at 8.8 per cent in 2022-23, higher than pre-Covid average growth.

## Khera arrested for 'remarks against PM'

**New Delhi, Feb 23:** Congress leader Pawan Khera was Thursday arrested by Assam Police and later released on an interim bail by the Supreme Court in connection with an FIR lodged over his alleged remarks against Prime Minister Narendra Modi, the action coming soon after he was deplaned from a flight to Raipur where he was going to attend the party's plenary session.

Khera, who was in the headlines this week for apparently fumbling on the Prime Minister's father's name during a press conference, moved the Supreme Court to seek



relief in multiple FIRs against him in Assam as well as in the Uttar Pradesh towns of Varanasi and Lucknow. A three-judge bench headed by Chief Justice DY Chandrachud said that upon being

produced before the competent magistrate in Delhi, Khera would be released on interim bail.

"The above order will remain operational till Tuesday (February 28)," the bench, also comprising Justices M R Shah and P S Narasimha, said and listed the matter for February 27.

Earlier in the day, Khera was arrested at Delhi airport after being deplaned from a flight to Raipur in connection with his alleged remarks against Modi, made at a press conference February 17 at Mumbai. The Delhi Police said he was detained at the request of the Assam Police. **MORE P5**

## Sura says goodbye to electoral politics

**Bhubaneswar:** Veteran Congress leader and six-time MLA Suresh Routray Thursday announced his retirement from electoral politics and said his son, Manmath Routray, would contest the next polls from Jatni Assembly constituency. Addressing a presser here, the 80-year-old senior Congress leader said, "I will not contest elections any more. However, my youngest son Manmath Routray will contest from Jatni constituency on a Congress ticket." Routray said that he was a loyal Congress worker for the past 55 years and had no intention to change the party. As his presser came barely a couple of days after he met BJD president and CM Naveen Patnaik, speculations were rife that his son Manmath may join the regional party.

# Pramila pooh-poohs Andhra intrusion



**Revenue Minister Pramila Mallik says Koraput district administration has no info about distribution of ration and allowances by Andhra Pradesh officials in Kotia in 2021**

**Bhubaneswar, Feb 23:** The state government has no information about intrusion by Andhra Pradesh officials into disputed Kotia Gram Panchayat of Koraput district in the year 2021, Revenue and Disaster Management Minister Pramila Mallik said in the Assembly, Thursday.

In a reply to an unstarred question by Sundargarh legislator Kusum Tete, the minister said the district administration has no information about distribution of ration and allowances by Andhra Pradesh officials in Kotia in 2021. Mallik informed

the House that the government is yet to get information about construction of roads by the neighbouring state in the disputed area.

The state government will take immediate action if such activities by the Andhra Pradesh government come to the fore, Mallik added.

The minister's answer has surprised many as there have been several media reports including video footage about intrusion by Andhra Pradesh officials and their deputy chief minister in the disputed Kotia area.

The statement of the Revenue Minister over Kotia and Andhra intrusion has sparked a debate in Odisha.

Andhra and Odisha have been at loggerheads over territorial control of 21 of the 28 revenue villages in Kotia gram panchayat for more than five decades.

As per reports, Andhra Deputy Chief Minister Rajanna Dora Peedika had visited Kotia panchayat in October last year and held meetings and discussions about his government's schemes with locals there.

Strongly opposing the visit, local BJD MLA Pritam Padhi had cautioned the neighbouring state against creating tension in Kotia area.

According to an official, Peedika had visited Neradivalsa village under Kotia panchayat and reviewed the status of several welfare schemes launched by the Andhra government.

# PUTIN UPS NUCLEAR ANTE

Russian President Vladimir Putin announces plans to deploy new Sarmat multi-warhead intercontinental ballistic missiles this year as the war against Ukraine completes one year

**Kyiv, Feb 23:** Ukraine said Thursday that its forces had repelled Russian assaults along the length of the front-line on the eve of the war's anniversary, as President Vladimir Putin, empty-handed after a bloody winter offensive, talked up Russia's nuclear arsenal.

After a series of strident speeches in the run-up to the anniversary of his invasion, Putin announced plans Thursday to deploy new Sarmat multi-warhead in-





and in the air. "We will continue mass production of air-based hypersonic Kinzhal systems and will start mass supplies of sea-based Zircon hypersonic missiles," Putin said in the remarks issued by the Kremlin early Thursday.

Ukraine and its Western allies have brushed off the nuclear posturing as a diversion from a failing Russian military campaign on the ground, a year after Putin launched the biggest land war in Europe since World War Two. **Contd...P2**

Replying to the motion of thanks on Governor's speech to Odisha Assembly, Patnaik said, "Odisha is being recognised as a role model in many fields. We are on a journey of significant growth and development to make Odisha emerge as a leading state in the country."

The recently organised FIH Men's Hockey World Cup is an example of the state's capacity to successfully organise mega events involving multiple national and international agencies, he said.

It is a matter of pride for all that this was possible in spite of the challenges posed by Covid, adverse weather conditions and supply as well as logistics issues, he pointed out.



The CM also said that the Birsra Munda Hockey Stadium in Rourkela was completed within just 15 months. This has been recognised by the Guinness Book of World Records as world's largest fully-seated hockey stadium. To attract investors, Naveen said,

the state government has brought a new Industrial Policy Resolution-2022 for the next five years, which will transform Odisha into an industrial hub in eastern India.

Stating that two new airports at Rourkela and Jeypore have been operationalised, the CM

said his government is going to launch direct international flight services to Dubai, Bangkok and Singapore soon.

Patnaik further said his government is investing hugely in agriculture and allied sectors and water resources. A host of irrigation projects are nearing completion and will be inaugurated this year. The state has set a target to ensure piped water supply to all houses in the state by 2024, while 100 per cent household tap connections will be covered in all urban areas by December this year, he informed.

"Odisha has been rated among the top in the country in terms of action against corruption. We are committed to providing transparent and effective delivery of public services to the citizens," added the CM.

Opposition BJP and Congress staged walkouts during the speech of the Chief Minister in the House.

Thursday, the cops also apprehended one lady identified as Mamata Parida who illegally sold the landed plot at Malipada impersonating the original owner. The EOW registered the case (7/2023) on the basis of the complaint lodged by Lipika Das of Nasadipur village in Kendrapada district.

"Lipika is the bonafide owner of the land plot in Phase-II of Vasanta Vihar at Malipada Mouza, and the ROR stands in her name. Meanwhile, the accused Mamata identifying herself as Lipika illegally registered the plot in the



name of accused Haladhar at the Sub Registrar's office in Khandagiri," told a senior EOW official.

Accused Mamata allegedly prepared a false sale deed document using a fake Aadhaar card and other required documents. The forged ID card had the image of Mamata in place of Lipika while the other details were same.

The information we have managed to collect so far clearly indicates that the above accused

were involved in several such fraud activities. We suspect this is a tip of the iceberg. They used to target gullible owners who own plots in Capital city but residing outside. Haladhara who was a junior assistant in BMC has been involved in such fraudulent activities after his retirement. We have received information regarding illegal registration of another landed plot in the name of Haladhar's wife too," the EOW official added.

## Naveen unveils statue of Utkalmani Gopabandhu Das

### Putin ups nuclear ante

The last weeks have seen Russia mount infantry assaults across frozen ground in battles described by both sides as the bloodiest of the war.

Western officials said they believed Russia had planned an offensive to capture new territory ahead of the anniversary, using hundreds of thousands of reservists conscripted in recent months to give Putin a victory to announce.

Moscow's forces have made progress trying to encircle the small city of Bakhmut, but have failed to break through Ukrainian lines to the north near Kremmina and to the south at Vuhledar where they have taken heavy losses assaulting across open ground into the teeth of Ukrainian artillery.

Ukrainian forces repelled 90 Russian attacks in the northeast and east over the past 24 hours, the military said early Thursday.

Ukraine has shut some schools for the war's anniversary in anticipation that Moscow might launch long-range missile attacks to mark the date. But Kyiv officials said they believe Moscow no longer has the capability for a dramatic show of force. "Nothing unusual will happen. Usual (Russian) effort... A small missile strike is

planned," Kyrylo Budanov, the head of Ukraine's military intelligence, told the Ukrainska Pravda news website in an interview. "23-24 (February), they have two dates. Believe me, we have experienced this more than 20 times," he said.

Britain's military said in a daily intelligence update that Moscow could be planning another large-scale assault on Vuhledar, despite costly failed attacks there earlier this month. It said last week that two full brigades of thousands of elite Russian marines had been rendered combat ineffective because of massive losses there.

With no major battlefield victories to report in time for the anniversary, Putin has instead turned to nuclear rhetoric, announcing in a major speech on Tuesday that Russia would suspend participation in the New START arms control treaty.

The practical implications appear limited: inspections under the treaty had already been halted over the war. A senior defence official said Moscow would stick to the treaty's limits on missiles and continue to notify Washington when it moves them. US President Joe Biden, who upstaged Putin this week by journeying unannounced to Kyiv and then giving a landmark speech

of his own to a crowd in Warsaw, called the suspension of START a "big mistake" but said on Wednesday: "I don't read into that that he's thinking of using nuclear weapons or anything like that." The RS-28 Sarmat missiles, dubbed "Satan 2", whose deployment Putin announced Thursday were first unveiled in 2018 and already supposed to have been deployed last year. Putin also promised to produce more hypersonic missiles, which fly too fast to be shot down. Russia is due to begin military exercises with China in South Africa Friday and has sent a frigate equipped with them. Russia still controls nearly a fifth of Ukraine, despite losing swathes of territory in major battlefield setbacks last year after failing to capture Kyiv at the outset of its "special military operation".

Tens of thousands of Ukrainian civilians and troops on both sides are believed to have died in the past year. Russian artillery has destroyed Ukrainian cities and set millions of refugees to flight. Ukrainian troops have stuck mainly to defence since their last offensive in November, hoping that Russian forces replenished with reservists will be exhausted in attacks. Kyiv has meanwhile received pledges of Western weapons for a planned counter-offensive later in 2023.

## ₹1,062cr nod for health infra

**Bhubaneswar, Feb 23:** Odisha government approved an annual action plan of ₹1062.10 crore for strengthening hospital infrastructure in the state, Thursday. The approved amount would be invested in the construction of 863 projects under Mukhya Mantri Swasthya Seva Mission, informed Health and Family welfare department.

While giving nod to the proposed action plan, Health and Family Welfare minister Niraj Pujari asked the department and Chief District Medical Officers to "prioritize patient-centric basic infrastructure in the hospitals". Secretary of the department Shalini Pandit said, "Director of National Health Mission along with directors of different state agencies have been asked to expedite the process for obtaining administrative approval against the projects from authorities."

### Survey pegs state's growth rate at 7.8%

Similarly, state's per capita income (PCI) grew three times between 2011-12 and 2022-23 while at national level, it grew by 2.7 times.

The state's PCI grew at an annual compound rate of 10.9 per cent while national PCI grew by 150 basis points lower than that of Odisha during this period, the report said.

The present (2022-23 annual es-

timation) PCI in the state is ₹1,50,676 in current prices as against the all-India average of ₹1,70,620. However, within 7 years, the state has successively reduced the gap between Odisha's per capita income and per capita income at the national level from 31.6 per cent in 2015-16 to 12 per cent in 2022-23.

The state continues to be a revenue surplus economy for

the last 17 years since the enactment of Fiscal Responsibility and Budget Management (FRBM) Act. Total outstanding liabilities as percentage of GSDP stood at 15.6 per cent in FY 2022-23, it said. Odisha is among six highest spending states in the country. In 2020-21, the total public expenditure (revenue expenditure plus capital outlay) of the state was 21.3 per cent of GDP.

## SC sets aside Orissa HC order, affirms Vig inquiry

**New Delhi, Feb 23:** In a major setback to MLA Pradeep Panigrahi, the Supreme Court Thursday set aside an order of Orissa High Court that restrained the Vigilance department to probe corruption charges against the legislator.


A two-judge bench headed by Justice Ajay Rastogi held that the division bench of Orissa High Court had committed "manifest error" by setting aside the order of Odisha Lokayukta to conduct preliminary inquiry against Gopalpur MLA.

"The action of the division bench of the High Court indeed was in violation of the principles of natural justice," the bench ruled after noting that the High Court passed the order without hearing the Lokayukta.

The Lokayukta is empowered to utilize services of any officer and agency of government for the purpose of preliminary inquiry, the bench said, adding that the Lokayukta hadn't committed any legal infirmity in the process of conducting preliminary inquiry.

"The finding returned by the Division Bench of the High Court under the judgment impugned, in our view, is not legally sustainable," the apex court held. The Supreme Court held that the plea of bias filed by Pradeep Panigrahi was "ill-founded" and the "principles of bias, even remotely, are not attracted in the present case".

The apex court noted that the

Deputy Superintendent of Police of the Directorate of Vigilance has submitted a complaint and the Lokayukta directed the Directorate of Vigilance to conduct a preliminary inquiry which, in fact, was conducted by a senior officer of the department who submitted a report to the appellant.

"We are not persuaded with the submission of there being any bias on the part of the Directorate of Vigilance cell in conducting preliminary inquiry for the reason that the Officer who submitted a complaint was simply an informant and not the person interested, at the same time, preliminary inquiry was conducted by a different Officer not connected with author of the complaint, thus the plea of bias was ill founded," the bench said.

The bench also overruled the objection of Panigrahi in reference to the locus standi of the Lokayukta in filing appeal in the apex court. The bench held that being aggrieved by the judgment of the High Court, the Lokayukta can certainly question the legality of the High Court order in the Supreme Court.

# Rampant use of antibiotics in fish farming raises alarm

USE OF 20 TYPES OF ANTIBIOTICS IN FISH AND PRAWN CULTIVATION HAS BEEN BANNED BY F&ARD DEPARTMENT AND MPEDA

Paradip, Feb 23: Rampant use of antibiotics and poisonous chemicals in fish and prawn cultivation has threatened to affect the lives of thousands of fishermen in Odisha coast while also bringing ecological disaster in its wake.

This has happened as some farmers are applying various antibiotics and chemicals in the ponds or gheries to raise the fish and prawn in a short period of time. Those are exported to many European countries for their high demand.

However, some European countries have banned the import of fish and prawn from state due to presence of hazardous chemicals. When consumed by people, the chemicals in the food items result in anaemia, cancer, allergy, bone related diseases, and intestinal diseases.

Concerned over the development, the state Fisheries and Animal Resources Development department as well as the Marine Products Export Development Authority (MPEDA) has banned the use of 20 types of antibiotics in fish and prawn cultivation and have insisted on safe cultivation.

Some of the banned drugs are chloramphenicol, nitrofluorene and the additives under them like furazolidone, furaltadone, furilfauramide, nitrofurantoin, nifuratel, nifurozime and several other antibiotics and chemicals.

It is alleged that many fish farmers in Odisha are using these banned antibiotics to boost the growth of the



fish and prawns. Coordinator Gayadhar Jena of MPEDA confirmed that a ship carrying prawns had to return from a foreign country without unloading the stocks only for this reason in 2022.

However, the use of these antibiotics allegedly goes on unabated notwithstanding the ban order. Moreover, these prawns are consumed more in wedding feasts and in other get-togethers.

A scientist Dr Ambika Prasad Ray of Central Institute of Freshwater Aquaculture (CIFA) at Kaushalyaganga on Bhubaneswar outskirts said that the remnants of these antibiotics and chemicals remain in the body of fish and prawns after they are harvested.

Use of these antibiotics has been banned considering their harmful effects on human body. These antibiotics get mixed in the blood vessels of humans and result in various diseases. The presence of antibiotic like nitrofurantoin may even give rise to dreaded diseases

like cancer, he added. Moreover, the aquaculture farms that have sprouted along the coastline over the past few years have also polluted the rivers and creeks, poisoning the coastal waterways with the excrement and waste water from the farms.

The aquaculture farms demand artificial feed, pesticides, chemical additives and antibiotics all the time. Many other toxic substances and pesticides such as malathion, parathion, azodin and paraquat are used in large-scale shrimp farming.

Other ill effects of prawn farming are the conversion of coastal ecosystem into monoculture production. Once the prawn farms are abandoned, it is expensive to make the land suitable for farming.

A local fish trader Paresh Mandal said that the prawns produced here are sold at ₹250 to ₹500 per kg in the local market. Locals have demanded a ban on the cultivation of such fish and prawns.

## Vigilance raids asst engineer

Balasure, Feb 23: After multiple raids, the state Vigilance department has taken Balasure East Division-II assistant engineer Ajay Kumar Senapati into custody for amassment of disproportionate assets (DA) at various places.

The Vigilance sleuths recovered cash in lakhs from the Balasure East Division-II office after raiding twice in the last 14 months. Reportedly, a peon Padmanabha Swain from the same office was caught December 3, 2021, while taking a bribe of one lakh to clear the paper of a contractor.

Suspecting amassment of disproportionate assets, Vigilance raided seven places including Balasure, Puri, Khurda and the ancestral properties of Senapati. Senapati works as an estimator and was transferred to Balasure four months back, the report said.

Following the search warrant ordered by a special judge of the Bhubaneswar Vigilance team, a four-member team including four DSPs, 10 inspectors, and others conducted the raid.

Raids took place in different places including the Balasure office, government quarters, a property located near Madanmohan Road of Harachandi Sahi in Puri, a flat on the second floor of Anan Palm Beach, a two-storey building in Balugaon, a relative's place in Tangi and the ancestral home in Bhagabati Sahi of Banapur.

During the raid, cash worth ₹1,22,500, one four-wheeler, three two-wheelers and jewellery have been recovered. Further investigation is going on, sources said.

## Woman Kho Kho player kills self

Jhumpura, Feb 23: A national level junior Kho Kho player committed suicide by hanging at her residence in Nayadhanurjayapur village under Baria police limits in Keonjhar district, Thursday.

The deceased was identified as Manika Nayak, 17, a Plus II student of Ukhunda College. She had represented the state in the national junior level women's Kho Kho team and had bagged several awards in individual and team categories. She had recently displayed her exemplary skill in the sport making Odisha win in the Kho Kho tournament held at Jharkhand.

However, allegedly due to some domestic dispute she hanged herself from the ceiling fan at her residence, Thursday. Family members rushed her to the Jhumpura hospital where the doctors pronounced her brought dead. Baria IIC Vandana Patra launched an investigation after the family members lodged a complaint.

# Bamra rly stn turns battlefield; RPF resorts to mild lathicharge

Hundreds of people waiting to board the Rourkela-Bhubaneswar Intercity were disappointed after the train did not stop at the station, Thursday.

They ransacked and locked the ticket counter and the panel room, and drove the employees out. A scuffle broke out after police tried to clear the agitators from the station premises. The scuffle led to a clash between the agitators and police. The Railway Protection Force (RPF) resorted to mild-lathicharge to disperse the mob which went berserk and pelted stones. Some police vehicles have allegedly been damaged in the stone pelting by the mob.

# Spring water sole option for Malabandha locals

Tentulikhunti, Feb 23: With summer approaching fast, residents of Malabandha under Dangasil revenue village of Tentulikhunti block in Nabarangpur are in dire straits as there is no option left except a small spring to quench their thirst. The village folks depend solely on a small mountain spring flowing 500 metre away from the village.

While the government is busy celebrating 'Azadi Ka Amrit Mahotsav', it has failed to provide a tube well for the people of Malabandha. However the matter



has never been able to grab the attention of higher ups. Elections come and go, but the problem never goes, alleged villagers. Moreover, the water is so dirty

and unsafe that apart from visible dust particles it often emanates a foul smell. People are forced to drink it as there is no other option available to them. Every now

and then, many get admitted to hospitals every year contracting diarrhoea and other diseases. The spring water gets polluted raising the risks of such water-borne diseases due to manmade and natural reasons. The scarcity of water will worsen in the upcoming days. After waiting for hours, the locals get to avail a bucket of water from the spring, a villager said. Residents of the village including Kishore Nayak, Sadan Jani, Jadu Jani, Phulamati Jani, Jamuli Jani, Mati Jani and others demanded digging of a tube well in their area.

# TECH THREAT TO DEMOCRACY

members of the clandestine group. Some of it lines up with claims Team Jorge made about team members in calls with journalists. One team member described his other colleagues as former senior information officers, former senior financial information and warfare experts, and psychological warfare specialists, all with intelligence services background. Hanan indicated that he had orchestrated lobbying operations in the US despite not registering as a "foreign agent," as required by law. He said he worked via consultants and companies that are already registered, and told reporters he had recently set up a public relations firm called Axiomatics to promote Team Jorge with "existing lobby groups."

During calls with undercover reporters, Team Jorge went into specifics about the technology they say the group uses to swing elections. They added that they have six offices and employ at least 100 people, emphasising that they draw on the backgrounds of colleagues with experience in the intelligence services. This pushes Team Jorge's activities far beyond the realm of public relations strategies that are commonly deployed in elections. As far as the financial pickings are concerned, Team Jorge told the reporters they would accept payments in a variety of currencies, including cryptocurrencies such as Bitcoin, or cash. He said he would charge between 6 million euros and 15 million euros for interference in elections.

The information gleaned by the investigative reporters points to one rather disconcerting fact, that there are people out there and they would be there in future too, who would always be ready to interfere in other country's internal affairs and ready to subterfuge the democratic institutions.

But the bigger question is shall we just ignore them calling it scaling another frontier in the technology advancement or shall we start a campaign to ban such illegal and undesirable activities which may one day be able to destabilise the whole global democratic system?

Undercover journalists who carried out the investigation included Gur Megiddo (TheMarker), Frederic Metzger (Radio France), and Omer Benjakob (Haaretz). The journalists were part of a collaborative investigation called 'Story Killers', which was coordinated by 'Forbidden Stories' - an international consortium of investigative journalists that pursue the work of journalists who have been killed or work under threat. As reported, the covert units or contractors, used the pseudonym 'Team Jorge' headed by Tal Hanan, who previously worked as an Israeli special forces operative, and was apparently caught in an undercover sting operation by the journalists posing as potential clients. However, Tal Hanan denies any wrongdoing. But he allegedly told the reporters that his unit's services were available to intelligence agencies, political campaigns, and private companies, and that many European, African, Americans well as Central and South American clients had already used them around the globe.

Their modus operandi is said to involve creating thousands of fake social media profiles on Twitter, LinkedIn, Facebook, Telegram, Gmail, Instagram, and YouTube. These fake accounts, which allegedly used profile pictures from real social media accounts, were also linked to credit cards and could be used to create thousands

of bots that sent mass messages. In one secretly filmed meeting quoted by The Guardian, Hanan is seen boasting that at present his team is involved in one election in Africa, besides two other teams in Greece and the UAE. Boasting further, he said that his team has so far delivered 33 presidential-level campaigns globally, 27 of which were successful. Hanan also reportedly boasted to the undercover reporters that he could hack the email and messenger services of election campaigners, and send messages to their contacts designed to damage their campaign.

The investigators found that Team Jorge's tech toolbox included "a platform of influence" called Advanced Impact Media Solutions or AIMS, which Hanan claims to have sold to the intelligence services of more than 10 countries. The AIMS software is designed to create convincing avatars for social media campaigns. The avatars, or bots, use stolen photos of real people, operate on any social media platform, and can be connected to functioning Amazon and Bitcoin accounts. Hanan told reporters that they relied successfully on imitating human behaviour. Nowadays, most online accounts require phone number and email address verification to keep out bots like those deployed by AIMS. But to overcome that there are websites available, which have been set up specifically to allow one-off SMS-

verification services, for 50 cents or less. Many accounts such as Gmail and WhatsApp can be registered with "verified" phone numbers. Apparently Team Jorge used a service called SMSpva.com for phone number verifications.

Keeping abreast of social media platforms checks, AIMS relied on residential proxies to reroute internet traffic from bots through peoples' homes so it appeared authentic, in order to avoid detection and shut-downs by social media platforms like Twitter and Facebook. This made it difficult for social media platforms to identify a coordinated disinformation campaign. Verification and analysis of the recorded conversations by reporting partners Le Monde and The Guardian identified clusters of avatars, including those seen in Hanan's pitch presentations, that appeared to have been used for coordinated Twitter campaigns. Reporters found over 1,700 Twitter accounts connected to 21 AIMS-related campaigns, whose networks had produced tens of thousands of tweets.

In December last, during an in-person meeting with undercover reporters, Team Jorge showed off a new capability of AIMS: Artificial intelligence tools to generate fake news using specified key words, tone and topic. The identities of Team Jorge members were shrouded in secrecy but reporters managed to piece together some background information on some

## Crisis of Oligarchy

Over the past two decades, Indian multi-billionaire Gautam Adani's close ties to Prime Minister Narendra Modi have helped the Gujarati businessman become Asia's wealthiest person. Adani's meteoric rise, which in some ways eclipsed that of his political mentor, also made him the poster boy for India's growth story - until allegations of fraud and stock manipulation brought his eponymous business empire to its knees. With his conglomerate losing \$110 billion in market value within days, Adani has become a cautionary tale about the perils of cronyism in Modi's India.

The partnership between Adani and Modi goes back to 2002, when Modi - then Chief Minister of Gujarat - faced heavy criticism for failing to contain anti-Muslim mobs that killed more than a thousand people in the state. Following the massacre, Modi was barred from entering the United States and largely abandoned by India's business leaders. Adani, who continued to support Modi and his Bharatiya Janata Party (BJP), was handsomely rewarded for his loyalty. Over the next decade, the Adani group grew at breakneck speed, winning multiple state government contracts and expanding into food imports and exports, coal trading and mining, power, oil and gas exploration, and infrastructure.

Over the years, the relationship became increasingly symbiotic. When Modi was elected prime minister in 2014, he flew to Delhi on Adani's private jet. Adani's proximity to Modi helped his companies win lucrative government contracts and public- and private-sector loans for domestic and foreign ventures, some of them highly controversial. Again and again, the government relaxed regulations or amended rules in ways that benefited Adani's businesses. In 2017, for example, the government designated Adani's power plant in Godda a special economic zone, allegedly tweaking the rules to give the group a \$60 million bonanza. In 2019, Modi's government handed Adani the rights to operate six newly privatised airports, despite the company's utter lack of experience in the sector.

The Adani Group's rapid growth, along with a truly ambitious debt-driven investment programme enabled by spectacular stock-price appreciation, made the company the standard-bearer of the government's capital-investment push, data-industry expansion, and net-zero transition plans. In less than a decade, Adani's fortune grew from \$7 billion to \$120 billion, making him the world's third-richest person (until the group's stock began to tumble in late January, shrinking his net worth by half).

As his economic power grew, Adani became more aggressive in his efforts to suppress criticism of his businesses and of Modi, filing multiple lawsuits against journalists and media outlets that reported on the authorities' preferential treatment of the Adani Group. Late last year, Adani launched a hostile takeover of the Indian broadcaster NDTV, one of the very few remaining platforms for critics of Modi.

For a while, it seemed that Adani could do no wrong. Despite concerns about his empire's debt-fueled growth and unrealistic stock valuation, his economic, political, and media power - and the widespread perception that the Adani Group's success underlay India's economic growth - made him seem unstoppable.

The illusion was shattered on January 24, when the short-selling firm Hindenburg Research published a devastating report accusing the group of "pulling the largest con in corporate history." Following a two-year investigation, Hindenburg accused the conglomerate of engaging in a "brazen stock manipulation and accounting fraud scheme over the course of decades," pointing to 38 Mauritius-based shell companies that were allegedly used to manipulate share prices and siphon money from publicly listed Adani Group companies. While the Adani Group appealed to Indian nationalism, framing the Hindenburg report as a "calculated attack" on India's independence, institutions, and growth story, the market response has been swift and lethal. In early February, Moody's downgraded the ratings outlook for several Adani Group companies and MSCI cut the weightings of four, compounding the conglomerate's troubles. And the rout continued even after the group announced several confidence-building measures, paying back loans worth \$1.1 billion ahead of schedule, halving its revenue growth targets, and holding off on planned capital expenditures.

Modi himself has remained silent, even as the country's opposition parties accuse him of cronyism. The government has claimed that India's "strong" regulatory agencies would deal with this scandal, though their performance so far has been dismal. The Securities and Exchange Board of India, accused of acting as a "silent operator" by several legislators, has issued a tepid press release promising to investigate the allegations and giving the Adani Group six months to respond. The agency did, however, look into the fall in Adani Group stocks and corporate bonds, finding evidence that some short-selling activity originated from outside the country.

Whether or not the Adani Group rebounds, its current troubles must be regarded as an indictment of India's overreliance on a few national champions to drive economic development. This strategy has failed to deliver broad-based and inclusive development, leaving India with disappointing job growth, declining consumption, falling investment rates, and environmental devastation. Instead of relying on industrial conglomerates, the government should use this moment as an opportunity to change course. Encouraging small and medium-size companies and expanding social services would boost job creation and improve economic sustainability.

While Modi's popularity appears to be unaffected by the scandal, it is too soon to assess the political fallout. Modi and the BJP have faced numerous corruption scandals over the years and managed to overcome them all, thanks to their remarkable control of the media. But Adani's downfall could be different, because it discredits a key tenet of Modi's economic philosophy. Lavishing endless financial benefits and regulatory dispensations on a single oligarch, it turns out, is not a reliable development strategy.

## Status of higher education

Higher education has witnessed considerable change over the past decades with increasing enrolment, student mobility, research dynamics and technology. Some 235 million students are enrolled in universities around the world - a number that has more than doubled in 20 years. The last five years marked considerable growth in the number of universities in India. The number of universities and colleges listed on AISHE portal has increased from 864 in 2016-17 to 1113 in 2020-21, i.e. almost 28.8% whereas the number of colleges has increased from 40,026 in 2016-17 to 43,796 in 2020-21, i.e. 9.4%.

THE LAST FIVE YEARS MARKED CONSIDERABLE GROWTH IN THE NUMBER OF UNIVERSITIES IN INDIA

The Education Ministry's budget allocation this year increased by a marginal 8% from ₹1.12 lakh crore from ₹1.04 lakh crore in 2022-23. Of this, the Department of School Education is expected to get ₹68,804 crore and Department of Higher Education ₹44,094 crore. Allocation for higher education increased by 7.9% from ₹40,828 crore (BE) in 2022-23 to ₹44,094 crore in 2023-24. The figures look good but the problems faced by the higher education sector are numerous and much more allocation is necessary to overcome the problems identified by NEP 2020 and to materialise the recommendations.

Everyone talks about the importance of higher education, all over the world but the overall enrolment ratio is 40% with considerable differences between countries and regions. More than 6 million students are pursuing their further education abroad as their own countries are not able to attract them for pursuing higher education. The dark side is that among the world's more than 82 million refugees, only 5% of eligible youth are enrolled in higher education.

The various problems of higher education in India as listed by NEP 2020 are limited accessibility in socio-economically disadvantaged areas, limited teacher capacity, limited institutional autonomy, lesser emphasis on research activities, adequate career management and progression of faculty members, sub-optimal governance and leadership of HEIs, ineffective regulatory system and low standards of undergraduate education.

To overcome the problems, NEP 2020 envisioned some key changes like introduction of multidisciplinary universities and colleges, moving towards a more multidisciplinary undergraduate education, provision for faculty and institutional autonomy, revamping of curriculum, pedagogy, assessment,

and student support, reaffirming institutional leadership positions, establishment of a National Research Foundation, governance of HEIs by independent boards having academic and administrative autonomy and increased access, equity, and inclusion.

During 2020-21, 1113 Universities were listed on the AISHE portal. Of these, 235 belonged to Central government, 422 belonged to state governments, 10 were government aided deemed universities, and 446 were privately managed (unaided). There are 43,796 colleges registered under AISHE belonging to 314 universities. College density, i.e., the number of colleges per lakh eligible population in the age-group 18-23 years varies from 8 in Bihar to 62 in Karnataka as compared to all India average of 31. Most of the colleges run only under graduate level programmes. Only 2.9% of colleges run Ph.D. level programmes and 55.2% of colleges run post graduate level programmes. There are 35.8% colleges, which run only single programme, out of which 82.2% are privately managed. Among these, 30.9% colleges run B.Ed. courses only.

If state wise number of colleges is to be analysed, Uttar Pradesh tops the list with 8114 colleges and

for every one lakh population there are 32 colleges. Similarly, Maharashtra comes second with 4532 colleges and 34 colleges per lakh population. Karnataka comes third with 4233 colleges and 62 colleges per lakh population.

Gross Enrolment Ratio (GER) in higher education, estimated using population projections based on 2011 Census for the 18-23 age group at 27.3 is far lower in comparison to global standards. For Scheduled Castes it is 23.1 and for Scheduled Tribes it is 18.9. GER for male population at all India level is 26.7 whereas for SC males it is 22.4 and 18.8 for ST males. Similarly, GER for female population at all India level is 27.9 whereas for SC females it is 23.9 and for ST females it is 19.1.

Adequate funding is necessary to improve the status of higher education and implement all recommendations of NEP 2020. Apart from funding methodology of implementation assumes priority as different states visualise higher education from their local priorities and formulate policies accordingly. A coordinated mechanism is necessary to get desired results.

Sir, Assam is known all over the world for its one-horned rhinoceros and its flavourful tea but only a few would be aware of the fact that Assam hosts about 50 per cent of the butterfly species found in India. There are about 1500 species found in India and Assam hosts more than 700 of them making Assam, the butterfly capital of the nation. Butterflies are excellent indicators of biodiversity and can serve as early warning signs of nature. The colour of their wings is not just for aesthetic purposes, these wings tell a lot about what is happening in nature. # High drama as Khera nabbed on way to Raipur

New Delhi, Feb 23: Congress leader Pawan Khera was arrested Thursday by Assam Police in connection with an FIR over alleged remarks against Prime Minister Narendra Modi, a day of high drama that began with him being deplaned from a flight to Raipur and his party leaders protesting on the tarmac.

Khera, who was in the headlines this week for apparently fumbling on the prime minister's father's name during a press conference, was released on interim bail till February 28 by a Delhi court later in the evening on the directions

of the Supreme Court.

He had moved the apex court to seek relief in multiple FIRs against him in Assam as well as in the Uttar Pradesh towns of Varanasi and Lucknow. After dictating the order granting interim bail, Chief Justice of India D Y Chandrachud, apparently displeased with the Congress leader's remarks, told senior advocate A M Singhvi, who was representing Khera, "We have protected you (Khera) but there has to be some level of discourse."

"He (Khera) has made statements in a press conference. He has made certain statements which I cannot say in the court but I personally would not have made," Singhvi,

also Khera's party colleague, said in the apex court. Khera, who was deplaned while

he was on his way to the Chhattisgarh capital to attend the party's plenary session, told re-

porters outside the Dwarka court in the evening that the law had come to his rescue and he was grateful the apex court had upheld his liberties.

"I was asked to deplane as if I was a terrorist. This is not the only example of people's rights being curtailed... "They arrested me illegally without serving me any notice," the Congress leader said. Assam Police said in court that Khera had used "derogatory remarks" against a democratically elected prime minister.

His counsel argued that he had apologised for his remarks on the prime minister and the charges against him do not require arrest.

The case against Khera was registered at the Haflong police station in Assam under various sections of the IPC, including 153 B (imputations, assertions prejudicial to national interest), 500 (punishment for defamation) and 504 (intentional insult with intent to provoke breach of peace).

"His (Khera) comments against the PM is one part of the FIR. There are other complaints also. The case is registered under several sections of the IPC," Dima Hasao Superintendent of Police Mayank Kumar told PTL. The complaint, he said, had been filed on Wednesday at the Haflong station by a Samuel Changsan.

# Amritpal's supporters clash with police

Amritsar (Punjab), Feb 23: Radical preacher Amritpal Singh's supporters, some of them brandishing swords and guns, broke through barricades and stormed into a police station complex here Thursday, camping there till they were "assured" that an arrested man would be released.

Three policemen were hurt during the clash, officials said. A large police force kept watch but refrained from taking any action as the preacher, often described as a Khalistan sympathiser, and other protesters stayed put at the Ajnala police station for hours.

Amritsar Police did not immediately make it clear whether any case had been



registered against Amritpal Singh or his supporters over Thursday's violence. Earlier, they staged a protest in the middle of the road at Dhillwan toll plaza in Kapurthala district when they were stopped by police from marching towards Amritsar.

Dubai-returned Amritpal Singh, who heads an organisation called 'Waris

Punjab De', talked to reporters at the police station, issuing an "ultimatum" for the release of his supporter Toofan Singh.

The preacher reportedly issued a threat to Union Home Minister Amit Shah recently, saying he will meet the same fate as that of former Prime Minister Indira Gandhi.

A case was registered against Amritpal Singh and his 30 supporters for allegedly kidnapping and thrashing Barinder Singh, a resident of Chamkaur Sahib in Rupnagar district.

Barinder Singh, in his complaint, had told police that Amritpal Singh's associates had abducted him from Ajnala and took him to an unknown place where he was brutally thrashed.

# Gucci slippers recovered from Sukesh's jail cell

New Delhi, Feb 23: The Delhi Prisons Department raided alleged conman Sukesh Chaudhary's cell in Mandoli Jail here and recovered a pair of Gucci slippers worth Rs 1.5 lakh and two jeans worth Rs 80,000, officials said Thursday.

CCTV footage of the operation being circulated on social media platforms shows Chandrashekhar weeping in front of jailor Deepak Sharma. A senior official said the routine raid, which included the Prisons Department and other security personnel, was conducted on December 15 last.

The Enforcement Directorate (ED) has recently arrested Chandrashekhar in a fresh money laundering case linked to duping for-

mer Religare promoter Malvinder Singh's wife by posing as the Union home and law secretaries.

Chandrashekhar, 33, was taken into custody under criminal sections of the Prevention of Money Laundering Act (PMLA) from a local jail last week. A Delhi

court later sent him to nine-day ED custody. This is the third money laundering case in which the ED has arrested Chandrashekhar. # Drunk man pees on woman's seat

### California may get slammed by storm

**Pierre (US):** A brutal winter storm that trapped drivers on icy roads, blacked out hundreds of thousands of homes, grounded airplanes and closed schools across much of the country was poised to slam California Thursday. "We are in for a VERY busy week!" the National Weather Service bureau in San Diego tweeted. "We have issued warnings for damaging winds, heavy mountain snow, highly hazardous boating conditions and the list goes on."

### 5 killed, 48 missing in mine collapse

**Beijing:** The death toll from the collapse of an open-pit coal mine in Alxa League in north China's Inner Mongolia Autonomous Region has risen to five, with 48 people still missing, state-run China Media Group reported Thursday. The search and rescue operation resumed after they were interrupted by a massive landslide at the rescue site Wednesday. So far, five people have been confirmed dead, and 48 others remained missing, the report said. Six people who were injured in the incident have been taken to the hospital.

### Reporter killed while covering a shooting

**Los Angeles:** A Florida television station identified Thursday a 24-year-old reporter who was fatally shot while covering a shooting death in an Orlando area neighbourhood, as well as its photojournalist who was critically injured in the rampage. Spectrum News 13 reporter Dylan Lyons and photojournalist Jesse Walden were in their unmarked news vehicle on Wednesday afternoon when a man approached and shot them, Orange County Sheriff John Mina said in a news conference. The man then went to a nearby home where he fatally shot a 9-year-old girl and critically injured her mother.

### Netanyahu gets funding boost

**Tel Aviv:** An Israeli parliamentary committee Thursday approved new funding for Benjamin Netanyahu and his family, giving the prime minister a boost in personal spending at a time when he is facing mass protests over his policies and as the economy is on shaky ground.

## Ukraine shuns OSCE gathering in Vienna over Russian presence

**Vienna, Feb 23:** A meeting of the Organization for Security and Cooperation in Europe's parliamentary assembly got underway Thursday without the Ukrainian delegation, which described the presence of Russian lawmakers as "an affront."

Austria's government said that as host nation it was obliged to grant visas to representatives from all OSCE member nations. Ukraine said its delegates wouldn't attend if the Russians were present, as did Lithuania.

The Vienna-based OSCE, whose 57 members include both Ukraine and Russia, was created during the Cold War as a platform for dialogue between East and West.

The group has a wide-ranging mission, including peace, human rights, arms control and other security issues.

Austria had a "duty not to slam the door on diplomacy," Wolfgang Sobotka, the speaker of the Austrian parliament said. "The OSCE, with its inclusive approach and comprehensive security concept, can and above all should be part of a solution to this conflict."

"I do sympathize with the fact that some members find it unbearable to sit in the same room as the aggressors," the OSCE Parliamentary Assembly's president, Margareta Cederfelt, told the opening session. "But for those present today, this is your opportunity to stand up for Ukraine and to confront the lies from the aggressors." A Slovak delegate read

The two-day meeting of the normally low-profile assembly is coinciding with the anniversary of Russia's invasion of Ukraine

The attendance of the Russian lawmakers has overshadowed the event

Austria granted them visas even though they are under European Union sanctions and despite protests from 20 countries including Britain, France and Canada

out a statement from the Ukrainian delegation that said "the presence of these warmongers in Vienna is an affront to everything that the OSCE stands for."

"They are not here for genuine dialogue nor for cooperation," it added. "They are here to spread their propaganda... They are here to try and justify the war crimes they have committed and desecrate the principles of international law and human decency."

During the session, some delegates walked out as Russian lawmakers spoke.

Later Thursday, the head of the U.S. Delegation, Sen. Ben Cardin, told reporters in Vienna that the delegation supported excluding the Russians from the meeting.

"We strongly believe that the Russian parliamentarians, all of whom have been sanctioned by the United States, the six that are here, should not have been permitted visas to come to this meeting," Cardin said.

### Javed Akhtar comes under fire in Pakistan

**Lahore, Feb 23:** A statement made by acclaimed Indian poet and writer Javed Akhtar at the Faiz Festival held in Lahore has Twitter in a frenzy and countless Pakistani celebrities have spoken up, condemning his statement.

During the festival, which went on from February 17 to 19, and days following it, various celebrities shared pictures and videos across various social media platforms sharing their excitement at being honoured by Akhtar's presence at the event, Geo News reported.

However, jubiliations soon soured as a video clip of the Indian poet's speech went viral on social media. In the video, Akhtar can be seen accusing Pakistan of allowing the attackers of the 26/11 Mumbai attacks "roam free" in the country.

The prolific Indian writer, while addressing a session at the festival said: "I am from Bombay (Mumbai) and I saw the attack on my city. The attackers were neither from Norway nor Egypt. Those attackers are still roaming around your country. Therefore, if an Indian has any grievance in their heart, you should not be offended," Geo News reported. As the video went viral, numerous Pakistani celebrities spoke up about the accusation and condemned the implications.

## Gaza rockets, Israeli strikes follow deadly West Bank raid

The bloodshed extends one of the deadliest periods in years in the West Bank, where dozens of Palestinians have been killed by Israeli fire since the start of the year

**Tel Aviv, Feb 23:** Palestinian militants in Gaza launched rockets at southern Israel and Israeli aircraft struck targets in the coastal enclave early Thursday after a gun-battle triggered by an Israeli raid in the occupied West Bank killed 10 Palestinians.

Israeli aircraft then struck several targets in northern and central Gaza, including a weapons manufacturing site and a military compound belonging to the Hamas militant group that rules the enclave. There were no reports of injuries in Israel or Gaza from the rocket attacks or strikes.

The violence comes in the first weeks of Israel's new far-right government, which has promised to take a tough line against Palestinians, and as security forces step up arrest raids of wanted militants in the West Bank. Israel says the raids — begun in the wake of a series of deadly Palestinian attacks last spring — are meant to dis-

"We have a clear policy: to strike terror powerfully and to deepen our roots in our land," Israeli Prime Minister Benjamin Netanyahu told a meeting of his Cabinet. "We will

settle accounts with whoever harms Israeli citizens." Israeli police stepped up security in sensitive areas on Thursday, while Hamas said its patience was "running out." Islamic Jihad, another militant group, vowed to retaliate.

A day after a raid in January on the Jenin refugee camp in the West Bank that killed 10 Palestinians, a Palestinian shot and killed seven people outside a synagogue in east Jerusalem.


An official in the region told Xinhua news agency that the earthquake across the border was felt strongly but no immediate reports of casualties and losses have been received yet.

Currently, power supply and communication in Kashgar are normal. Many counties and cities in Kashgar and nearby areas are within the 300-km radius of the epicentre. An earthquake occurred at 8:37 a.m., according to the China Earthquake Networks Centre (CENC). The epicentre was monitored at 37.98 degrees north latitude and 73.29 degrees east longitude, at a depth of 10 km, according to the CENC.

The territory is surrounded by the towering Pamir Mountains and is home to Lake Sarez. The aquamarine-coloured body of water, formed as a result of an earthquake in 1911, is among Tajikistan's largest lakes.

Tajikistan is highly prone to natural disasters and has a long history of floods, earthquakes, landslides, avalanches and heavy snowfalls.

## Why public health officials are not panicked about bird flu

**Chicago, Feb 23:** A new strain of bird flu that transmits easily among wild birds has triggered an explosive spread into new corners of the globe, infecting and killing a variety of mammals species and raising fears of a pandemic more lethal than COVID-19.

But the very changes that have allowed the virus to infect wild birds so efficiently likely made it harder to infect human cells, leading disease experts told Reuters. Their views underpin global health officials' assessments that the current outbreak of H5N1 poses low risk to people.

Unlike earlier outbreaks, this subtype of H5N1 is not causing significant disease in people. So far, only about a half dozen cases have been reported to the World Health Organization (WHO) in people who had close contact with infected birds, and most of those have been mild.

"We think the risk to the public is low," Dr. Timothy Uyeki, chief medical officer of the U.S. Center for Disease Control and Prevention's (CDC) Influenza Division, said in an interview. The WHO expressed a similar view in an assessment earlier this month.

The way this virus enters and infects cells is one reason for the

## NO RESULTS & HOPE



More than 9 million Ukrainians - mostly women, children and the elderly - made a similar journey to Poland in the weeks and months after the invasion. Many have returned home, but around 1.5 million remain, according to Polish Border Guard estimates. Since the beginning of the war, 76,000 Ukrainians over the age of 60 have registered with the Polish authorities - necessary for refugees to access healthcare and benefits. According to a report nearly two-thirds of respondents over the age of 55 said they would benefit from support in dealing with a mental condition that affected their daily functioning.

## SANCTIONS BY WEST



While there has largely been unity among Western governments on the necessity to punish Russia, there have been differences in the lengths to which countries are willing to go. European and Asian countries are more dependent on Russian oil and natural gas than was the US that made a ban on Russian exports hard for the alliance and forced compromises that took months to forge. Ultimately, the countries in December settled on a \$60 price cap, which some critics said came too late and was too high to significantly hurt Russia. Russia is also seeking deeper ties with countries that have refused to join the sanctions effort. Its exports to Brazil, China, India and Turkey have increased by at least 50% since the war started compared with the previous year.

## PEACEMAKER CHINA!



China's effort to cast itself as a peacemaker on Ukraine reflects an aim to burnish its image rather than a change of stance, Western diplomats and analysts said, as it seeks to establish itself as a leader of a new multipolar world order. Analysts say China's affirmation of its "rock solid" relationship with Russia and the backing of Russia's line on the war undermines its posture of neutrality, as does a US assertion that China was considering providing weapons to Russia, which China denies.

# From tents to tanks

The day after Russia invaded Ukraine, the leaders of NATO's 30 member countries held an emergency summit to address what they described as the gravest threat to Euro-Atlantic security in decades — the launch of what would become the biggest land war in Europe since 1945. With massive displacement of people, disrupted supply chains, spiralling prices, major economies driven to the brink of a collapse, altered power dynamics between leading nations, this war has had a significant global impact that continues to show its effect.

Absent the complete collapse of either the Ukrainian or Russian armed forces, the grim reality is that the war will likely drag on throughout 2023 - and potentially beyond it. Conversely, for Russia to turn the tide it will have to dramatically reverse the abysmal performance of its armed forces. The recent spectacular failure of the Russian assault on Vuhledar in Ukraine's south east, seen by many as the prelude to a Spring offensive, doesn't bode well.


With an estimated 80 per cent of Russia's entire ground forces now engaged in the conflict, plus tens of thousands of newly mobilised conscripts arriving at the front, there's mounting pressure on those at the very top of Russia's military leadership to achieve rapid results.

There's no alternative value proposition for Russia's political elites to remove Putin, and the personal risks for trying it remain very high. For its part, Russian society remains effectively apathetic - if no longer very enthusiastic - about the war.

Now, Russia and China showcased their deepening ties in a series of meetings in Moscow closely watched for signs that Beijing might offer stronger support to the Kremlin. Relations between Russia and the West are at their lowest point since the Cold War, and ties between China and the

## More disastrous path could lie ahead

# War gamble seen as threat to Putin's rule

Vladimir Putin says he learned from his boyhood brawls in his native St. Petersburg: "If you want to win a fight, you have to carry it through to the end, as if it were the most decisive battle of your life."

That lesson, cited in the most recent biography of the Russian President, seems to be guiding him as his invasion of Ukraine suffers setbacks and stalemates. But so far, Putin's gamble in invading his smaller and weaker neighbour seems to have backfired spectacularly and created the biggest threat to his more than two-decade-long rule. Putin laid the foundation for the invasion with a 5,000-word essay in 2021, in which he questioned Ukraine's legitimacy as a nation. That was only the latest chapter in a long obsession with the country and a determination to correct what he believes was a historical mistake of letting it slip from Moscow's orbit.

In Putin's view, an aggressive West wants to crush Russia. His narrative, along with increasingly repressive measures to stifle domestic dissent, has galvanized patriotic support among many of his countrymen. But it runs up against an inefficient, top-down power structure inherited from the Soviet Union, against the in-

terconnected world's porous borders, and against the sacrifices Russians are suffering firsthand. Analysts see several scenarios for Putin, depending on battlefield developments. The scenarios, not mutually exclusive, range from what could be his biggest nightmare - a coup or uprisings like those he saw as a KGB agent in East Germany in 1989, in the USSR in 1991 or Ukraine in 2004 and 2014 -- to winning reelection next year. That would extend what is already the longest rule of any Kremlin leader since Josef Stalin. Meanwhile, Putin has repeatedly said Russia could use "all available means" to protect its territory, a clear reference to its nuclear arsenal.

Russian President Vladimir Putin hoped the invasion would split the West and weaken NATO. Instead, the military alliance has been reinvigorated. A group set up to counter the Soviet Union has a renewed sense of purpose and two new aspiring members in Finland and Sweden, which ditched decades of nonalignment and asked to join NATO as protection against Russia.

The 27-nation European Union has hit Russia with tough sanctions and sent Ukraine billions in support. The war put Brexit squabbles into perspective, thawing diplomatic relations between the bloc and awkward former member Britain. "The EU is taking sanctions, quite serious sanctions, in the way that it should. The US is back in Europe with a vengeance in a way we never thought it would be again," said defence analyst Michael Clarke, former head of the Royal United Services Institute think tank. NATO member states have poured weapons and equipment worth billions of dollars into Ukraine. The alliance has buttressed its eastern flank, and the countries nearest to Ukraine and Russia, including Poland and the Baltic states, have persuaded more hesitant NATO and European



Union allies, potentially shifting Europe's centre of power eastwards. There are some cracks in the unity. Hungarian Prime Minister Viktor Orbán, Putin's closest ally in the EU, has lobbied against sanctions on Moscow, refused to send weapons

to Ukraine and held up an aid package from the bloc for Kyiv. Western unity will come under more and more pressure the longer the conflict grinds on.

## A NEW IRON CURTAIN

China is closely watching a con-

flict that may serve as either encouragement or warning to Beijing about any attempt to reclaim self-governing Taiwan by force. Putin has reinforced military links with international outcasts North Korea and Iran, which supplies armed drones that Russia unleashes on Ukrainian infrastructure. Moscow continues to build influence in Africa and the Middle East with its economic and military clout. # ONGC to invest \$2bn to up oil, gas output

**New Delhi, Feb 23:** India's top oil and gas producer ONGC will invest over \$2 billion in drilling a record 103 wells on its main gas-bearing asset in the Arabia Sea as it pivots a turnaround plan that will add 100 million tonne to production, a company official said.

Oil and Natural Gas Corporation (ONGC) has three main assets off the west coast - Mumbai High, Heera and Neelam, and Bassein and Satellite, which contributed the bulk of 21.7 million tonne of oil and 21.68 billion cubic metres of gas it produced in 2021-22.

"We have released a record 103 locations for drilling of wells on the Bassein and Satellite (B&S) assets over the next 2-3 years," ONGC Director (Offshore) Pankaj Kumar said.

The wells will tap smaller and hereto untapped reservoirs and help raise output.

India imports over 85 per cent of the crude oil, which is converted into fuel such as petrol and diesel in refineries, and roughly half of the natural gas that is used to produce electricity, make fertiliser, converted into CNG for running automobiles and piped to household kitchens for cooking.

ONGC, which reported a gradual decline in output for over a decade primarily because its fields are old and ageing, has now got its act together by working on a comprehensive asset base plan rather than piecemeal field centric approach.

Kumar said B&S asset has several fields including the prime Bassein gas field, D1 and Tapti-

Daman. These currently produce 55,000-56,000 barrels per day (2.8 million tonne) of oil and 28 million standard cubic metres per day of gas.

"We have done a reservoir profiling for the entire asset to plan the drilling campaign," he said, adding new wells will bring additional production that will offset the natural decline in older wells and add to the overall output.

The Daman field alone is projected to contribute 6-7 mmscmd of more gas while the Tapti field may see oil output almost doubling to 30,000 bpd.

ONGC will adopt a similar approach for the rejuvenation of the other two assets in the western offshore.

The government has been pressing state-owned firms to step up efforts to raise domestic output to help cut the \$115 billion import bill

## G20 MEET

### FM for global framework to regulate cryptocurrency

**Bangalore, Feb 23:** Finance minister Nirmala Sitharaman Thursday underlined the need for a global framework to regulate cryptocurrencies besides firming up ways to tackle global debt vulnerabilities and strengthening multilateral development banks.

She discussed these topics during the bilateral meetings with her counterparts, including from US, Japan and Spain, ahead of the G20 ministerial meeting.

The finance ministers of the G20 countries, which is a grouping of developed and developing nations, are here to participate in the two-day meeting of G20 finance ministers and central bank governors (FMCBG) beginning February 24.

Under the G20 Presidency, India will be pressing for a global framework to regulate the cryptocurrencies and ways to tackle the aggravated debt vulnerabilities facing the developing nations, mainly on account of the continuing geopolitical tensions and the pandemic.

It is feared that if left unaddressed, the mounting debt vulnerabilities of developing nations could trigger global recession and push millions to extreme poverty.

The minister has held separate bilateral meetings with several G20 ministers, including US Treasury Secretary Janet Yellen, Finance Minister of Japan Shunichi Suzuki, and Italian Minister of Economy and Finance Giancarlo Giorgetti ahead of the G-20 FMCBG meeting.

She is scheduled to have more than 10 such meetings, including with the Finance Ministers of Indonesia, Canada, Spain,



Argentina and Canada, besides General Manager of the Bank for International Settlements (BIS).

In her meeting with Yellen, the finance minister discussed issues relating to crypto assets, strengthening multilateral development banks and global debt vulnerabilities.

"The two leaders exchanged views on #G20 #FinanceTrack priorities under #G20India Presidency in 2023. The two leaders discussed their perspectives on strengthening #MDB, #GlobalDebt vulnerabilities, #CryptoAssets, and #health, besides the Just Energy Transition Partnership #JETP and possible takeaways for the two sides," the finance ministry tweeted after the meeting.

In a statement, the US Treasury Department said Yellen discussed cooperation on the evolution of multilateral development banks, encouraged strengthened health-finance coordination.

She also thanked India for taking a leadership role on promoting sovereign debt restructuring, while encouraging faster G20 efforts on existing debt restructuring cases.

India has been raising the issue of reforms of the multilateral lending agencies, especially the International Monetary Fund (IMF) and World Bank, to enable them to address the global challenges facing the world economy in the 21st century.

### Zee Enterprises' MD moves NCLAT

**Mumbai, Feb 23:** Zee Enterprises' managing director and chief executive Puneet Goenka Thursday moved appellate tribunal NCLAT challenging the order of the National Company Law Tribunal which admitted an IndusInd Bank plea for insolvency proceedings against the firm.

The appeal seeking relief against the National Company Law Tribunal's Mumbai bench order was filed by Goenka in the National Company Law Appellate Tribunal (NCLAT) Thursday, as per an official statement from the company.



"Goenka is taking all the necessary steps as per law to protect the interests of all stakeholders of Zee Entertainment Enterprises (ZEEL) and to achieve a timely completion of the proposed merger with Culver Max Entertainment," the statement said. The matter pertains to a default of ₹89 crore by Zee Group's multisystem operator arm Siti Networks claimed by IndusInd Bank, for which ZEEL was a guarantor. The ZEEL stock fell 3.35 per cent to close at ₹199 a piece on the BSE Thursday.

**Cape Town, Feb 23:** So near yet so far. It was the case with the Indian team at the Women's T20 World Cup here Thursday as they lost to Australia in the semifinal by just five runs.

Chasing a challenging 173-run target, India eves had a worse possible start as they were reduced to 28/3 inside four overs with the top three batters – Smriti Mandhana (2), Shafali Verma (9) and Yastika Bhatia (4) – back in the hut.

However, skipper Harmanpreet Kaur (52, 34b, 6x4, 1x6) and Jemimah Rodrigues (43, 24b, 6x4) opted for counter-attack approach and took the team close to 100 before the latter got out in the 11th over. Darcie Brown (2/18) broke the 69-run stand.

Richa Ghosh (14) joined her skipper at the middle and the duo stitched together 36 runs before a double blow reduced India to 135/6 at the end of 16th over. Kaur was the first to depart through run out when her bat struck on the ground while going for a run. Richa followed her skipper back to the hut 10 balls later.

With 38 required off the final four overs, India tried their best and the equation came down to 16 off the final over. However, India fell short by five runs.

Earlier, India's shoddy fielding allowed Australia to post a challenging 172/4. The bowling effort also left a lot to be desired as Beth Mooney extended her envious



record against India with a classy 54 (37b, 7x4, 1x6). One of the best power hitters in the game, Ashleigh Gardner, hurt India with 18-ball 31 (5x4) while skipper Meg Lanning (49 n o, 34b, 4x4, 2x6) remained unbeaten to guide her side past 170.

Aussies opted to bat at a sunny Newlands and Kaur, who chose to play the knock-out game a day after suffering from high fever, did not seem to mind Lanning's call.

There was no swing on offer, making life a lot difficult for star pacer Renuka Thakur. It was Mooney who got the boundaries more regularly in her 52-run stand with Alyssa Healy (25) as she manoeuvred the field beautifully with her nimble footwork against the spinners. Shafali Verma dropped a regulation catch off Mooney at long on when she was on 32.

Deepthi Sharma bowled too short in her opening spell. Besides the in-

consistent line and length by the bowlers, poor fielding and catching cost India a lot of runs. Lanning, who was dropped early in her innings, made India pay.

Sneh Rana, playing in place of Pooja Vastrakar, was unfortunate not pick any wicket as she troubled the batters with her flight. She could have had Lanning caught behind in her first over but wicketkeeper Ghosh dropped the chance. Richa also fluffed a stumping chance of Lanning. The last five overs yielded 59 runs for Australia.

**New Delhi, Feb 23:** Young Anish Bhanwala broke the 12-year jinx of an Indian not winning a 25m rapid-fire pistol medal when he bagged bronze in the event on the last day of the ISSF World Cup Rifle/Pistol in Cairo Thursday.

This is the 20-year-old's first senior individual World Cup medal and it came after three hard-fought shoot-offs. Before Bhanwala, the only Indian to have won medals in the event at the international stage was Vijay Kumar, who clinched silver at the 2012 London Olympics and had two podium finishes at World Cups.

Italian Massimo Spinella won gold with 32 hits in the medal



match, while World Championships silver medallist Clement Bessaguet of France fell short by two hits after 40-shots to settle for silver.

Anish's effort meant that India finished the World Cup with seven medals, including four gold, to top the standings. Bhanwala dedicated the medal to his personal coach Harpreet Singh.

# Oversight Committee gets two more weeks to complete probe

**New Delhi, Feb 23:** The Sports Ministry has extended by two weeks the deadline given to the Oversight Committee to submit its report on sexual harassment allegations against WFI president Brij Bhushan Sharan Singh.

The Committee, led by legendary boxer MC Mary Kom, was formed January 23 to investigate into the claims made by country's top wrestlers that Brij Bhushan has sexually harassed several women wrestlers and intimidates the athletes.

The wrestlers had not provided the names of the 'victims'. The committee, which is running the day-to-day functioning of the sports body, was asked to submit its report in four weeks.

The ministry extended the deadline following requests from the committee members and now it will submit its report by March 9. "The Sports Ministry has given a two-week extension to the

Oversight Committee for the submission of its report, following a request," a ministry source told PTI.

The ministry was forced to form the panel after top Indian wrestlers, including Bajrang Punia, Vinesh Phogat, Ravi Dahiya and Sakshi Malik, staged a sit-in protest at New Delhi's Jantar Mantar, demanding that Brij Bhushan be removed from the top post and WFI be disbanded.

The BJP MP was asked to step aside till the completion of the probe into his alleged misconduct. The Mary Kom-led committee has former wrestler Yogeshwar Dutt, former shuttler Trupti Murgunde, SAI member Radhika Sreeman and Rajesh Rajagopalan, ex-CEO, Target Olympic Podium Scheme and CWG gold medallist Babita Phogat as its members.

Since the formation of the committee, the top Indian wrestlers have not competed at the international meets, missing the UWW Ranking Series events in Zagreb and Alexandria.

# Man City held 1-1 by Leipzig in CL last 16

**Leipzig, Feb 23:** Josko Gvardiol stifled the threat of Manchester City star Erling Haaland before scoring himself to earn Leipzig a 1-1 draw in the first leg of their round-of-16 matchup in the Champions League.

The Croatia centre back, nicknamed 'Little Pep' because of the similarities of his last name with that of City manager Pep Guardiola, headed home the equaliser in the 70th minute Wednesday after Leipzig finally got to grips with the English champions.

City dominated the first half without Haaland, their top scorer, getting a sight on goal and Riyad Mahrez netted the 27th-minute opener after Ilkay Gundogan flicked through a pass from Jack Grealish. As Haaland grew frustrated in the second half, City lost control of the game and Leipzig posed more of a threat, creating the better of the chances.

It leaves the match in the balance heading into the second leg in

Manchester March 14 as City continue their bid for a first Champions League title.

Guardiola conducted a mini-debrief with his players on the field after the final whistle, telling them to stay positive after seeing them throw away their advantage after a first-half performance that could have led to more than just Mahrez's 20th Champions League goal.

Haaland had only seven touches before halftime — none of them coming in Leipzig's penalty area — and he had only one opportunity in the whole match, when he got free down the right midway through the second half and snatched at a shot that dribbled wide.

Leipzig's extra intensity and aggression paid off as the German team, a Champions League semi-

finalist in 2020, finally showed why they had lost just one of their 20 previous matches in all competitions.

Ederson was left stranded when Marcel Halstenberg swung over a left-wing cross and 21-year-old Gvardiol got above Ruben Dias to nod the ball into an unguarded net.

### INTER PIP PORTO

After ending his goalscoring drought last weekend, Romelu Lukaku scored late to fire Inter Milan to a 1-0 win over 10-man Porto Wednesday in the first leg of their Champions League round-of-16 matchup.

They were Lukaku's first goals since October and took his tally to just four since returning from Chelsea in the offseason as the Belgian forward has struggled with injury and poor form.

Porto midfielder Otavio was sent off following a second yellow card 12 minutes from time. He had received his first booking for a tussle with Federico Dimarco at the end of the first half.
