PRESS TRUST OF INDIA

New Delhi, Feb 27: A special court sent Delhi Deputy Chief Minister Manish Sisodia to fivedav CBI remand Monday after the agency sought his custody for effective interrogation to unravel the alleged scam in the nowscrapped excise policy for 2021-22

Special judge MK Nagpal passed the order on a plea of the Central Bureau of Investigation (CBI), which produced the AAP leader before him a day after his arrest and sought his five-day custody.

There was a heavy security presence in and outside the Rouse Avenue Courts premises.

During the more-than-an-hourlong hearing, Sisodia's counsel said that it was the lieutenant governor who had approved the changes in the excise policy and that the central probe agency was going after the elected government.

"I (Sisodia) am the finance minister. I've to present the budget...What changed yesterday that the finance minister was to be placed under custody? Was he not available for next days? Or was this arrest done for ulterior motive? This case is an assault on an individual as well as the institution. Remand will send a message, this is a fit case for declining remand,' Sisodia's counsel told the court.



Bhubaneswar, Feb 27: In a fresh ray of hope for the people of the state, surveys have indicated presence of gold reserves in at least three districts of Odisha

Gold deposits have been found in various parts of Deogarh, Keonjhar and Mayurbhanj districts. Steel and Mines Minister Prafulla Kumar Mallik told the Assembly Monday. Replying to a question of BJD

MLA Sudhir Samal, the minister said as per a preliminary survey conducted by the state Directorate of Mines and Geology and the Geological Survey of India (GSI), presence of gold reserves has been found in the Adas area of Deogarh and Gopur, Gazipur, Kusakala, Adal, Saleikana, Dimirimunda and Karadanga area of Keonjhar district.

Deposits of the yellow metal are also found in Jashipur, Suriaguda, Ruansi, Ladelkucha, Maredihi, Suleipat and Badampahar area of Mayurbhanj district, he said.

The Minister's statement about the presence of gold in the three



districts has brought about an excitement in the state.

As per the latest survey conducted by GSI, 1,685 kg of gold is estimated to be present in copper ore at G2 level in Adas area, Mallik said

In addition to it, he said, 6.67 million tonne of copper, 0.638 million tonne silver and 0.10 million tonne nickel have been estimated to be present in copper ore in the region.

The first surveys in these areas were conducted by the Directorate of Mines and Geology and the

The Mines Minister further said two gold-carrying quartz veins were found in Gopur area during a survey conducted by the state Mine and Geology Directorate from 1977-83 and 1989 96. The survey found the presence of 1 gram gold in one tonne of ore. The presence of gold was found 30 to 60 metre below the surface of the earth.

The presence of gold has also been confirmed in Saleikana in Quartz vein on the southern side of Gopur and in Saleikana area. As per a survey conducted during 1970-71, the gold reserve in Saleikana has 1 gram gold per tonne of ore, he said

A survey conducted in the Jashipur-Suriaguda-Ruansi area of Mayurbhanj district by the state Directorate of Mines and Geology found the presence of 0.1 to 2.6 grams of gold per tonne and 0.1 to 0.8 grams of gold per tonne in 2.3 km conglomerate horizon spread over Dhusuri hill, he added.

Failure in NEET drives youth to commit suicide

Bhubaneswar, Feb 27: A 21-yearold youth committed suicide in the state capital following several unsuccessful attempts to clear the medical entrance examination National Eligibility-cum-Entrance Test (NEET). The deceased was identified as Yash Pradhan, who was staying along with his family in an apartment at Sundarpada under Airfield police limits.

Sources claimed that while Yash's father is a reputed author, his mother works as an assistant professor in a law college in Aurangabad, Maharashtra. Yash had earlier appeared for the examination thrice but failed to clear the test every time. He was already in depression over the repeated failures and came under further pressure for the upcoming NEET examination.

Sunday afternoon, Yash was alone at his house as both his father and twin sisters had gone to their native place in Berhampur. He committed suicide by hanging himself with a rope from the ceiling.

His father and sister both tried to contact him over phone for several times but to no avail. They immediately left for Bhubaneswar and reached here in the evening. After breaking into the house, they found Yash's body hanging from the ceiling.-The body was handed over to the family after post-mortem Monday.

New York, Feb 27: The legend of 'Pablo Escobear', a black bear that died after overdosing on cocaine dropped into the Georgia woods from an airplane, is getting a push from the movie 'Cocaine Bear'

"Investigators searching for cocaine dropped by an airborne smuggler have found a ripped-up shipment of the sweet-smelling powder and the remains of a bear that apparently died of a multimillion-dollar high," the Associated Press reported from Blue Ridge, Georgia December 22, 1985.

Police found a sad scene. A 175pound black bear dead near a duffle bag and some \$2 million worth of cocaine that had been opened and scattered over a hillside.

The parachutist Andrew C Thornton II, a former Kentucky narcotics investigator, thought he had found his calling as the leader of a local drug-smuggling ring. Now he was in the middle of his most ambitious drug run yet as he made up his mind to parachute from a twin-engine plane in the dead of night to smuggle the \$15 million worth of Colombian cocaine that was strapped to his body into the United States.

But when Thornton opened his parachute too late September 11, 1985, the free fall from thousands of feet sent him crashing into a backvard in Knoxville. Tennessee. instantly killing him. His unmanned airplane crashed into a North Carolina mountain. Back in Georgia, the bear, examiners said, had overdosed.

The story is in many ways too much. Too absurd. Too '80s. Even the screenwriters of the 'Fast & Furious' movies would think it far-fetched. The stranger-thanfiction tale quickly receded from the headlines and, before some began to stoke the myth of 'Pablo

Escobear', it mostly stayed buried in news media archives until now.

That changed when screenwriter Jimmy Warden delivered to producers Phil Lord and Christopher Miller a script titled 'Cocaine Bear'. They were on board from page one.







Crimes up 65% in 5 yrs

Bhubaneswar, Feb 27: Criminal cases in the state have risen by more than 65 per cent in a span of five years from 2018 to 2022, the Assembly was informed Monday.

While 1,07,408 criminal cases were registered in 2018, the figure was 1,78,190 in 2022, Minister of State (MoS) for Home TK Behera said while replying to a question from BJP member Kusum Tete.

The minister said that while the number of cases in 2019 was 1,21,525, it increased to 1,34,230 in 2020 and 1,55,420 in 2021.

Of the total number of cases in 2022, he said, 1379 were related to murder, 626 dacoity, 2998 robbery, 5467 burglary, 14893 theft, 5352 swindling, 2248 rioting, 3184 rape, 11663 ve-

hicle accident and 1,30,380 miscellaneous Among

these five years, the maximum of 1,470 murder cases were filed in 2020 while the max imum of 3,327 rape cases were recorded in 2021.

the Of 1,07,408 cases

registered in 2018, the numbers of murder, dacoity, robbery, burglary, theft, swindling, rioting, rape, and motor vehicle accident cases were 1378, 558, 2125, 3713, 9069, 2794, 2120, 2502 and 11262 respectively.

However, there was a drop in rape and murder cases in the state in 2022 as compared to the previous year. Murder cases came down to 1,379 in 2022 from 1,394 cases in 2021. Similarly, rape cases came down to 3,184 in 2022 from 3,327 in 2021.

Bhubaneswar: Gopal Das, who killed former health minister Naba Kishore Das, had received one promotion and several rewards including citations 18 times during his service in the Police department.

This was revealed by Minister of State (MoS), Home, Tusharkanti Behera in the

Assembly Monday. Naba Das was killed by the now sacked police ASI Gopal Das January 29. He had fired a bullet at the chest of the minister from a very close range. Though the police arrested the accused from the spot, it is yet to ascertain the motive behind the murder. While replying to a

question of Sundargarh MLA Kusum Tete (BJP), Behera said Gopal Krushna Das had joined the police as a constable in Berhampur July 8, 1992 He was promoted to assistant sub-inspector post in 2009. After his promotion, Das served in different police out-

posts and police stations in Jharsuguda district for 13 years The MoS said Gopal was promoted once and received letters of appreciation 18 times and monetary rewards nine times.

Land sharks target owners staying outside

CRIME BRANCH ARRESTS TWO PERSONS INCLUDING THE MASTERMIND BEHIND THE LAND FRAUD RACKET INVOLVED IN ILLEGAL SALE OF PLOTS IN CAPITAL CITY

Bhubaneswar, Feb 27: The Economic Offence Wing (EOW) of the Crime Branch has arrested two persons including the mastermind behind the land fraud racket involved in the illegal sale of plots posing as the real owners in the City.

The EOW sleuths arrested the mastermind Antaryami Senapati and his aide Ananta Kumar Pradhan February 25, 2023. Senapati works as a Moharir or advocate-clerk while Pradhan is a land broker. The accused were arrested in EOW police station case (7/23) registered on the basis of a complaint lodged by Lipika Das

Lipika alleged in the complaint that she is the bona fide owner of a plot at Malipada Mouza which was sold to Haladhar Dash, an official of Bhubaneswar Municipal Corporation (BMC), by executing a fraudulent sale deed without her

knowledge. The EOW found that an organised racket led by Senapati and other accused persons allegedly sold several such plots using forged documents and impersonating the real owners. They used to target gullible owners who own plots in Capital city but reside outside.

The EOW has so far come across the involvement of the racket in the illegal sale of eight plots in the city without the knowledge of the bona fide owners.

"They also persuaded Gitanjali Mohapatra of Erancha and her husband Brajkishore Senapati (working in CRPF) to purchase two plots in the name of Sabita Sahoo of Hinjilikatu and Anil

f the legal lots the iers Chandra Pattnayak of

Bhanjanagar respectively by preparing fake sale deeds by using forged documents and impersonating the real land owners. They misappropriated the amount of ₹18 lakh towards purchase of the plots. In this connection, Badagada PS case No. 426 dt.12.12.2021 has been registered," revealed

the EOW sources. The accused persons also cheated Ajaya Kumar Senapati, an army man, by fraudulently selling a plot of 2,600 sq ft by impersonating the actual land owner Sarat Kumar Sanabada. Similarly, the fraudsters sold the plot of Satvabhama Das of Dimiri in Govindapur to Damayanti Das, wife of accused Haladhar.

"Whoever has approached Antaryami Senapati or Haldhar Das in connection with land purchase or selling please contact our investigating officer as it is possible that they might have been duped," urged the EOW. The cops also advised the

prospective buyers to check details like age band, gender, state and the last three digits of mobile number of an Aadhaar holder by visiting the website, (https://myaadhaar.uidai.gov.in/verifyAadha ar" before the purchase.

The EOW also advised the buyers to check the genuineness of the Aadhaar card through Aadhaar QR scanner app. "A QR code is put on every Aadhaar card. This code comprises the Aadhaar number holder's name, gender, date of birth, and address, as well as a photograph. The QR code can be read using the Aadhaar QR scanner app, which is available on Google Play and the App Store," the EOW advised.

of someone's genes has dropped dramatically, paving the way for improved disease surveillance. The lower cost has made this technology accessible for people living in poorer economies giving hope that emerging diseases will be spotted


and characterised sooner. The human body is an information keeper. Each of our 30 trillion cells, give or take, keeps information on how body machinery works and passes the information to the next generation in strings of code using only four letters, ACGT. Each stands for a type of molecule called nucleotide. The string has a total length of around 6 billion letters, condensed into 23 pairs of chromosomes that make up the DNA.

Seventy years ago, James Watson

and Francis Crick discovered the shape of DNA and how the ACGT code fitted together. All living things are identifiable by reading their DNA code, or in some organisms their RNA, known as their genome.

In the 1970s Frederick Sanger developed a method, known as sequencing, to read that code. The first reading of a human's DNA was laborious: it took around 10 years to read the majority of the three billion letters.

Now, sequencing is performed regularly for many purposes, from pathogen detection to determining drug resistance to understanding how a disease works. The amount of data a sequencer can produce has become exponential: one platform is able to sequence the whole genome of eight people in 72 hours or less. In 2022's report, the Sanger Institute has sequenced 243,633 human genomes in a record 3.5 years. The enormous data yield has helped to drive sequencing cost to as little as USD\$600 per

inates the logistics of transporting samples to sequencing centres in a more developed country. Only the data can be uploaded to the cloud for analysis in other parts of the world. But the best part of this miniaturisation is that investment starts at USD\$1,000.

This opens many possibilities for disease surveillance. A blood sample can be sequenced to detect

the presence of the genes of diseasecausing agents such as bacteria or viruses in a sick person or even a person with no symptoms.

Whether or not a pathogen will be resistant to a drug can be determined by reconstructing the pathogen's genome post-sequencing. Information about drug-resistance can be obtained in less than half a day. Compare this with the standard process of identifying drug resistance for tuberculosis that needs two weeks to obtain the results.

Drug resistance in falciparum malaria parasite is very important nowadays as it has developed resistance to nearly all antimalarial drugs. As the parasite cannot be reared in the laboratory for traditional drug resistance tests, identifying the mutation-causing resistance with sequencing is vital. The additional benefit of the portable sequencer to read long sequences of DNA is the ability to construct the whole genome of

a pathogen, even without prior knowledge of the infecting organism.

And it is not limited to infectious disease. Although portable sequencing does not have the capability to output a complete human genome, by using targeted sequencing, in which the signal from a particular gene or genes can be amplified beforehand, mutations or alterations in a human gene can be investigated. In non-small-cell lung cancer,

mutation at an amino acid level of a gene can render resistance to specific inhibitors. The fastest way to identify the prospect of failure is by detecting the mutations and modifying the therapy based on this information.

Portable sequencing can usher in the advent of personalised medicine, where a therapy is adjusted based on the genomic information rather than empirical method. Every clinic now has the power to perform sequencing.

Drones to check Rayagada forest fires

Bissam Cuttack, Feb 27: With forest fires starting to rage all across the state even before proper summer sets in, Forest officials across Odisha are concerned. They are now thinking about ways and means to contain the wildfires. Fires have also started to rage at the Bissam Cuttack forest range under Muniguda division in Rayagada district and are posing serious threat to flora and faunas. Forest department officials announced Sunday a slew of measures to contain the fires.

Drone cameras will be used to spot forest fires. Stringent action will be taken against people responsible for starting forest fires in Rayagada district, officials informed. They can be sentenced to three to seven years in prison, officials added.

The drones can play a crucial role in detecting, containing, and extinguishing forest fires, officials pointed out. The drones will be

used to gather situational awareness, which then can be used to direct the firefighters in locating and controlling hot spots. Just like urban fires, wildfires also require monitoring so that firefighters know what they are dealing with.

Giving these informations here, divisional forest officer (DFO) Prasanna Kumar Mishra of

Muniguda division said that forest fires have become a matter of 'huge

concern' for all. Mishra said that many dense areas under Bissam Cuttack forest range are burning and officials are working round the clock to douse those. They are also trying to find out the persons guilty of setting forests on fire. Local villagers are voluntarily helping the officials to douse the fires and they will be given wages, Mishra added.

Mishra said that persons responsible in setting forests on fires will be charged with non-bailable offences. Other than the prison term mentioned above, they will also be penalised with a fine of ₹10,000. Moreover, the identity of the informants will not be revealed and they will be rewarded if they provide correct news.

Mishra also urged people from all walks of life including politicians, public representatives, police and Army personnel to join hands and save forests from being razed. He said that mushrooming of brick kilns, clearing the jungle for mohua collection, shedding of tender kendu leaves and stubble burning on harvested farmlands are some of the reasons for the spread of wildfires in Muniguda forest division areas. He called upon people to stay away from setting the jungles on fire.



magine living with a disease that your doctor has never heard of, or Lonly ever read about as a few sentences in a medical textbook. Imagine it took decades to get a diagnosis, or never getting one at all. Imagine if there were no treatments, no new drugs in clinical trials, and no medical or social services

Farewell to Russia

I has now been a year since Russia, my birthplace, invaded Ukraine. For 365 days, we have been waking up to news of Russian missile strikes, bombings, murders, torture, and rape. It has been 365 days of shame and confusion, of wanting to turn away but needing to know what is happening, of watching Russians become "ruscists," "Orks," or "putinoids." For 365 days, the designation "Russian-American," previously straightforward, has felt like a contradiction in terms.

For those in my situation, some methods of adapting to the new circumstances have come easier than others. Russian books still crowd my bookcase, but I no longer have any wish to re-read them. Chekhov and Nabokov cannot be blamed for the aggression against Ukraine, but it nonetheless has stolen their magic and their capacity to teach. These authors were my friends, as were the old-country rituals like Russian Easter vigils and New Year's screenings of the Soviet classic Irony of Fate. I feel the loss acutely, but perhaps it is for the better. It helps me concentrate on the present.

Other changes have required more soul-searching. Every Russian in the West used to feel like an envoy of a great culture and a great country. Though things had gone badly wrong with Bolshevism and the Gulag, Russia had managed to straighten itself out and rejoin civilisation by the end of the twen-

tieth century, offering its own "special" virtues for everyone else to behold. In the West, the romantic appeal of Russia's stated priorities – communal over individualistic, socialist over capitalist, spiritual over material, heart over head – was so strong that I, too, became convinced of Russia's hidden goodness, even though I had left the country as soon as I could in the 1990s.

Now, I am reminded why. Russia is special, but mainly in the sense that it is uniquely capable of destroying, in a matter of days, what took centuries to build. From Tchaikovsky's harmonies to Pushkin's verses, Russian culture has been besmirched by people whose atrocities have negated their ancestors' achievements. Russia has been dragged back to the barbaric customs of Muscovy, as if the nineteenth century had never happened.

As someone who was shaped by Russian and Soviet literature, I have been made to feel like an unwilling partner to Russian crimes. That is why, since last February, I have abandoned any pretense of being a cultural envoy. I have been an

envoy of nothing – just another immigrant who came to America in search of a better life. In some ways, it has been liberating. I now know that one's search for meaning need not – and sometimes must not – be confined to any cultural tradition.

Still, it isn't easy questioning your own past. Flipping through family albums, we used to see our grandfathers as heroes who had survived the great terror, won the great war, and built a great country. Their lives were the stuff of legends – a perfect twentieth-century tale of sacrifice and fortitude. They suffered so that their grandchildren could live in peace (and "they," of course, included Ukrainians).

But those sacrifices have been squandered. We now must consider the possibility that our grandparents' achievements merely extended the life of a totalitarian monster, imparting to it the legitimacy that it craved. How should we think about the 23-27 million Soviet citizens who died in the twentieth century's war against fascism? Many of them were the grandparents of the twenty-first century's own fascists.

This answer wasn't so straightforward just a few years ago. After the end of the Cold War, Russia seemed like the freest country in the world. It was also believed to be a country capable of repentance. The fact that nobody was called to answer for the communist regime's crimes was viewed as proof of our collective desire for national healing, rather than as a deliberate effort by the new authorities to clear themselves of any blame.

Today, Putin's war on Ukraine is being directed, supplied, and supported by Russians who, like me, lived through perestroika and glasnost. They have wasted that era's promise and built another prison "on the ruins of despotism." What felt like a conscious national choice in the 1990s turned out to be an aspiration of the few. The very idea of "national choice" seems like a hollow concept now. Russians exist only as subjects, their society an atomized mass where some just try to survive, and others cheer on the regime's crimes so that they can forget about their own misery for a while. Those brave few who stand up to defy the system end up being swallowed by it. To be Russian today is to be culturally hollowed out. For those of us with half our lives behind us, it is not as though we can simply adopt a new set of favourite books, movies, or holiday traditions. You can read Gogol and explore Ukrainian folk songs, but you cannot adopt a Ukrainian identity, because it would feel immoral even to try. All you can do is dissolve into the background and hope nobody asks where you got your accent. When you cheer for Ukraine, you do it quietly from the sidelines. What are we to do with our memories, family sagas, and earlier exalted perceptions of our place in the "historical process" (as the Marxists used to put it)? Since the past cannot be canceled, it must be either repressed or deglamorized for the sake of the present and the future. Everything now hinges on the outcome of the war. If Ukraine wins and Putin's regime falls, it may still be possible for Russia to rehabilitate itself someday - as Germany once did. That will be a task for every decent person - Russians and everyone else - to advance when the time comes. But even with a hoped-for Ukrainian victory, there will be no return to the past, when Russia existed as a unique civilization. That Russia, real or imagined, expired on February 24, 2022. Let us drink to the departed.

ROAD TO EMPATHY

he Chief Justice of India. Justice DY Chandrachud, has made some very timely and significant comments on the state of our elite institutions in the light of the suicide of a Dalit student at IIT Bombay on February 12 and an Adivasi student at NLU Odisha last year. Delivering the silver jubilee lecture combined with the 19th convocation address over the weekend at National Academy of Legal Studies and Research (NAL-SAR) University of Law, Hyderabad, the CJI said: "The incidents of suicide of students from the marginalised communities are becoming common. These numbers are not just statistics, they are stories sometimes of centuries of struggles." The CJI asked for institutes of empathy rather than institutes of eminence, setting the tone for what must become a national debate on the State and indeed role of education in modern-day India. This must open questions on how and why the Indian education system has largely failed to deliver graduates informed on ideas of equity and equality, and larger ideas of service, community and values.

Broadly speaking, eminence in the system itself is in doubt, given that many questions have been raised about the readiness of the large number of technically qualified graduates that pass through the system every year to give us, for example, the world's largest scientific and technical manpower. But that only enhances the appeal of a smaller, elite pool that many Indians still thinking highly of. An example is the IITs that have escaped critical scrutiny on the road to building a supposed scientific temper in India that has been encashed by many a graduate to mean a one-way flight to the United States - often for a job and only sometimes an entrepreneurial venture.

The economist Ashoka Mody in an insightful book ('India is Broken') notes, for example, that IITs and other elite places have brought a "shambolic mess." Mody, an IIT graduate, writes: "Rich Indians and senior civil servants sent their children to privileged pri-

vate high schools, whence they either travelled abroad for university or launched into elite liberal arts colleges, the IITs, and the best medical colleges. From there, they joined the civil services, found scarce high-paying private sector jobs, or went abroad to work." This meant "millions of Indian geniuses remained undiscovered" and the best of Indian institutions were starved of faculty and funds, an example being Allahabad University, once considered the "Oxford of the East." Over the years, more jobs have opened up but the imbalance cited by Mody hasn't been fixed; it only got worse.

It is the lasting misfortune of this nation that entrenched privilege of all kinds, caste being a particularly pernicious variety, delivers more privilege, exclusivity and elitism that is normalised in an India sleepwalking into to a disaster of our own making. It is this system that the CJI has spoken against and his framing is particularly useful - institutes of empathy rather than mere eminence – at a time disregard for empathy is killing humanity and indeed everything else progressive and valuable that the India of tomorrow should stand for.

The idea of the eminent elite is antithetical to the idea of empathy. In so far as empathy opens doors to the hearts and minds of the other, it helps make for better inquiry, more openness and adds the missing element of humanity and values to a scientific endeavor that otherwise can go berserk, remain narrow focused with the tendency to bring solutions that are worse than the disease. That makes empathy a good value, indeed a prerequisite, for building a scientific temper. It is a good antidote to the hegemony of mechanistic science, a way out of the reductionist approaches that have landed us in the Anthropocene, and opens the doors to the world of Systems Thinking that tells us that all systems are intelligent and interconnected, and that the earth is alive. This is at the heart of the very Indian idea of Vasudhaiva Kutumbakam – or that the world is one family. This is a very different approach from Francis Bacon's "torture of nature" to force her to reveal her secrets at the start of the Scientific

Revolution. In the immediate context in which the CJI spoke, empathy is the bedrock of social justice. "Societies that empathically attend to the needs of their more vulnerable members are societies that are good for everyone. Data now shows that when empathy levels fall in a society, violence increases, economic inequality increases, instability infiltrates the social institutions, health conditions worsen and educational systems are short-changed... Individual well-being and communal stability suffer under conditions of low empathy and significant economic inequality," to quote the highly-regarded Sage Encyclopedia of Action Research.

The unfortunate part is that the conversations among common Indians, anecdotally speaking, appear not to grasp the deep damage that is being done to the nation by a language that speaks of power, control, growth, confidence and a 'biggie-ness' that celebrates some short-term numbers while the real assets in people and their concerns are trivialised or ignored. There is a culture that refuses to understand the pain of an entire class of population subjugated over the centuries, a harshness that translates in general to every other aspect of Indian life, superimposed on which is the everpresent threat of violence (State and non-State) that makes the claim of a nation that stands for non-violence hollow.

These are big issues that need more debate. What does not need debate is some quick fixes that can answer the immediate problems in our society. As Justice Chandrachud noted in his speech, there is no reason why hostels should be allotted on the basis of marks of students, or results be declared or grades calculated in a manner that can make a set of students feel small. There is no reason why disrespect is tolerated on campuses and in our workplaces. These practices, guided by well written codes of conduct, can be put to an end with clear guide lines and a clear-headed leadership. The problems India faces in areas of caste and various other forms of discrimination will not go away in a hurry. Yet, strong messages and regular reminders can help. In that light, Justice Chandrachud's speech is an important milestone and will be referred to for a long. long time.

Gazebo

Little is known about William Halfpenny, who called himself an architect and carpenter, not even if this was his real name (another architectural writer of the period, Batty Langley, said he was actually called Michael Hoare), nor whether his collaborator John Halfpenny was his son, as some have assumed, or even existed. The word gazebo is equally mysterious. A lot of people have assumed that — like the temples described in the book — it must be of oriental origin. If it is, nobody has found its source. Failing that, etymologists make an educated guess that he named the structure tongue-incheek, taking the ending -ebo from the Latin future tense and adding it to gaze, so making a hybrid word that might mean "I will look".

akistan's catastrophic floods last vear not only reminded us of the perils of climate change. They also exposed the fact that tens of millions of children are being systematically betrayed. The torrential monsoon rains destroyed as many as 27,000 schools and brought students' education to a halt. Worse, despite diligent efforts by United Nations agencies and NGOs, millions of children remain out of school to this day. And with millions of young Pakistanis already excluded from access to education before last year's disaster, the Indian subcontinent now has the largest out-of-school popula-

tion in the world. The link between climate change, forced displacement, and education has never been more glaring. Climate change is increasingly displacing populations on a massive scale, with devastating knockon effects in the form of school closures and other interruptions to education.

Even though developing countries have contributed very little to climate change, it is their children who will suffer the most from it. Almost half of the world's children live in the 33 countries classified as being at "extremely high risk" of being severely affected by climate change. Entire generations face the threat of being uprooted by floods, droughts, or wildfires, all of which will result in a loss of learning and potentially a loss in their lifetime prospects.

In 2021, 95% of all internal displacement occurred in countries on the front line of climate change. In Somalia, for example, drought and famine-like conditions have forced some 2.9 million people from their homes, triggering conflicts over access to food, water, and livelihoods, and adding to the critical need for psychosocial and mentalhealth support. Nor is Somalia alone. Millions more are being affected in similar ways elsewhere.

Official figures tell us that prior to the recent floods in Pakistan, weather-related events were already affecting ten million children around the world each year. But some estimates have painted an even bleaker picture, putting the number at nearly 40 million per year.

Children displaced because of climate change thus represent a growing share of the 222 million crisis-hit boys and girls who require

educational support. These children are increasingly missing out
 on a quality education, and thus are
 left without basic literacy or numeracy skills, let alone the additional qualifications they will need
 to enter the workforce.

The rapidly worsening education crisis challenges us to develop more innovative strategies for ensuring that all children are in school and learning. We will need to devise better, more imaginative ways to deliver education to people on the move. For example, curricula and other materials should be tailored more for a mix of online and in-person delivery, and school buildings should be used more efficiently by introducing double shifts. We also should encourage more safe-school initiatives like those pioneered in Nigeria after the kidnapping of hundreds of schoolgirls.

Once proven effective, these creative solutions will then need to be replicated and scaled up to support refugees and displaced children everywhere. To that end, we also will need to mobilise sufficient financing for vehicles like Education Cannot Wait, the UN's global fund designed specifically to address the link between climate change, forced displacement, and education. ECW has successfully rolled out education programmes in dozens of crisis-affected countries in recent years, and it remains fully committed to addressing "the obstacles that have prevented humanitarian and development actors from delivering quality education in humanitarian crises." To help reach the 222 million young people whose learning has been affected by conflicts and disasters. ECW aims to raise \$1.5 billion for the 2023-26 period - a mere rounding error compared to what governments spend on arms and fossil-fuel subsidies.

To have any hope of achieving SDG4, progress toward returning internally displaced and refugee children to school is essential. With millions of children's futures hanging in the balance, we must ensure access to education in emergencies and support a global fund that works.

Aggressive dogs

Sir, This refers to "Outcry over order to remove stray dogs from road," Orissa POST, Feb 27. The recent news of many children and adults being injured or killed in stray dog attacks across the country has been upsetting. This problem can only be solved by effectively running sterilisation campaign. People who have been bitten by dogs are forced to get rabies shots to protect themselves. Although the vaccine is inexpensive in government hospitals and dispensaries, private hospitals charge ₹1,500-2,000 per dose, which is prohibitively expensive for the poor. It is alleged that the state is not effectively implementing sterilisation campaign for stray dogs. Fast sterilisation campaigns are being recommended as a viable approach by experts. By the way, it's worth wondering why the dog, who has long been a buddy of man, has turned hostile. Dogs have been affected by changes in our dietary patterns. Their gathering can frequently be observed in front of stores that sell meat. Second, they become more hostile due to increasing temperature. If we were to gauge society, we would see a significant increase in the noise produced by vehicles and other machinery. This animal has an acute acoustic sensitivity. Over time, aggressive behaviour develops in dogs that have been beaten or otherwise mistreated by people on city or town streets. Unquestionably, the only way to address this issue is with the aid of nonprofit groups dedicated to raising public awareness about animal conservation and social issues. Abhijit Roy, JAMSHEDPUR



New Delhi, Feb 27: AAP leaders and workers Monday held protests in several states against the arrest of Delhi Deputy Chief Minister Manish Sisodia by CBI, with the party alleging that it was done to divert the public attention from the Adani issue.

'The leader who has been working hard for the development of poor children has been arrested by the CBI. Manish Sisodia's house was thoroughly raided but nothing was found. This is happening to divert the attention of the public from the outrage over Adani," AAP national spokesperson Sanjay Singh told reporters here.

However, BJP leader Gaurav Bhatia said that with its drama, the Aam Aadmi Party is signalling that it won't let probe agencies do their work. Shinde attempts to corner Thackeray group

Mumbai, Feb 27: Attempting to corner the Shiv Sena (UBT) group of MLAs - sitting in the Opposition benches -- the ruling Shiv Sena led by Chief Minister Eknath Shinde has issued a Whip to all the party legislators to remain present during the month-long Budget Session of Maharashtra Legislature which started here Monday.

Shiv Sena's Chief Whip Bharat Gogawale issued the Whip for his party's 40 MLAs and the remaining 16 belonging to Sena (UBT), in the Legislative Assembly.

However, in the Legislative Council, all the 12 MLCs are with Sena (UBT), including Thackeray, who was not present on the first day Monday.

The development came 10 days after the Election Commission allotted the 'original' Shiv Sena name and its 'Bow-and-Arrow' symbol to the Shinde group - which the Thackeray faction has challenged in the Supreme Court.

Opposition disrupts Kerala **Assembly session**

Thiruvananthapuram, Feb 27: The Kerala Assembly was Monday disrupted following heated exchanges between the ruling Left front and the opposition UDF on an adjournment motion by the latter to discuss the alleged police brutality recently against youth wing workers of the Congress and IUML.

Initially the session was stopped by Speaker A N Shamseer for nearly half-an-hour after several MLAs from both the ruling Left front and UDF refused to heed his directions to maintain order in the House by returning to their seats.

The disruption began with several ruling front MLAs interrupting the walkout speech of Leader of Opposition in the state assembly V D Satheesan after the adjournment motion moved by the UDF was rejected by the Speaker in view of the explanations given by Kerala Chief Minister Pinarayi Vijayan.

As the LoP's walkout speech was continuously disturbed despite the Speaker's direction to the contrary, several opposition MLAs trooped into the well of the House and raised slogans, placards and banners in front of Speaker's dais.

Subsequently, the House proceedings were stopped briefly and when it recommenced after around 30 minutes. Satheesan was allowed to continue his speech.

SC JUNKS PLEA ON RENAMING ROADS, PLACES

The top court took an exception to the petitioners 'naming' a particular community as 'barbaric foreign invaders'

New Delhi, Feb 27: The Supreme Court Monday dismissed a plea seeking direction to the Central government to appoint a renaming commission to rechristen cities and places named after foreign invaders.

A bench of Justices KM Joseph and BV Nagarathna also observed that there is no bigotry in Hinduism as it told petitioner-advocate Ashwini Upadhyay: "Don't dig up the past which will only create disharmony... Can't have the country on the boil." "What are you trying to achieve by all this... see our country has so many other problems to attend to and you want the Home Ministry to constitute a renaming commission, to go on renaming places and roads in the country... it is a historical fact that this country has been invaded .. it added.

During the hearing, the bench stressed that India is a secular country and the history of the past cannot be allowed to haunt the present generation. "India is a secular country, this is a secular forum. We are supposed to protect the Constitution and all sections," it said. As Upadhyay argued that it is a matter of dignity



for Indians, Justice Joseph replied: "You are revisiting the past selectively and India today, after the adoption of the Constitution, is a secular country and you are point-

ing fingers at a particular community and you call them barbaric...'

"You run down a certain section of the community which is completely against secularism, India is secular and this is a secular forum.'

Justice Nagarathna said: "Hinduism is a way of life and it is not really a religion and because Hinduism is a way of life, India has assimilated everybody, whether an invader or a friend... and because of that we are able to live together ... the divide and rule started only with the Britishers and that has brought about the chasm in the society...

She emphasised that let us not break it up again by such kind of petitions. Justice Joseph said: "Your concern is about the past. You want to dig it up and place it on the plate of the present generation ... to look at what had happened in the past and re-agitate things which should

be buried. Don't bring disharmony

into the society." The petitioner sought a direction to the Union Home Ministry

to set up a "renaming commission" to find out original names of ancient historical cultural religious places, called after "foreign invaders".

Citing the importance of renaming, the plea argued that it is necessary in order to maintain sovereignty and to secure a right to dignity, right to religion and right to culture guaranteed under Articles 21, 25 and 29 of the Constitution.

The petitioner cited several examples of hundreds of such cities, and places, and sought a direction to the Archaeological Survey of India to research and publish the initial names of ancient historical cultural religious places.







Ateeq Ahmad is Yogi's new target Valley's Pandit employees reiterate relocation demand

THE CHIEF MINISTER **HAS DIRECTED OFFICIALS TO ENSURE** A 'COMPLETE **CRACKDOWN ON ATEEQ AHMAD** AND HIS EMPIRE'

Lucknow, Feb 27: Mukhtar Ansari can step aside. Ateeq Ahmad is now the target of the Yogi Adityanath government in Uttar Pradesh

Ahmad, 62, has over 100 criminal cases lodged against him, including the latest one lodged with the Dhoomanganj police station in Prayagraj Friday in connection with the murder of Umesh Pal, the main witness of the murder of BSP MLA Raju Pal in 2005.

He is presently lodged in Sabarmati jail in Ahmedabad in Gujarat since 2019.

In the Umesh Pal murder case, Ateeq's two sons Umar and Ali, his wife Shaista Parveen, brother Ashraf have also been booked.

Chief Minister Yogi Adityanath has directed officials to ensure a 'complete crackdown on Ateeq Ahmad and his empire.

"Mafia ko mitti mein mila denge," the chief minister said in the UP Assembly Saturday.

A senior police official, who spoke to IANS on condition of anonymity, said, "The Umesh Pal murder will prove to be the proverbial last nail in the coffin for Ateea who has already been under the scanner. His ill-gotten wealth and properties have been seized. To have even dared to plan and execute the murder of Umesh Pal in this government, shows his sense of bravado. We have been asked to demolish the Ateeq Ahmad empire completely.'



Ateeq Ahmad had stepped into the crime world in 1979 after being named as accused in a murder case. He became active in politics in 1989 and made his debut in representative politics in the same vear, winning the Allahabad West assembly seat as an Independent. Later, he retained the Allahabad West seat twice -- 1991 and 1993 -- as

an independent candidate. However, in 1996, he contested on the same seat as SP candidate and won.

After the SP showed him the door in 1998, he joined the Apna Dal (AD) in 1999 and contested from Pratapgarh but lost. He again won the Allahabad West seat in the 2002 Assembly elections on Apna Dal ticket. In 2003, Ateeq returned to the SP fold and in 2004, he won from the Phulpur Lok Sabha constituency - the seat once held by India's first Prime Minister Jawaharlal Nehru.

Ateeq hit the headlines in January 2005, when BSP MLA Raju Pal was shot dead in broad daylight in Prayagraj. A by-election was held on the seat in 2005 and Ashraf won the election defeating BSP candidate Puja Pal, the widow of Raju Pal. In the 2007 elections, Ashraf again contested the Assembly polls from the SP but lost to Puja Pal of BSP. Ashraf was

accused in Raju Pal murder and is presently in Bareilly jail. Five years later, in the 2012 Assembly elections Ateeq again tried his luck from Apna Dal from



the same seat but lost to BSP's Puia Pal by a margin of 8,885 votes. He also contested the Lok Sabha elections in 2014 from Shravasti on SP ticket but lost.

In 2019, while he was still in jail, Ateeq filed nomination from the Varanasi constituency against Prime Minister Narendra Modi but managed to get only 855 votes. According to police records, of

the 100 FIRs lodged against Ateeq, 54 cases are under trial at various courts in the state.

In the sustained drive against gangsters under the Yogi Adityanath government, property worth over Rs 150 crore belonging to Ateeg and his family members under the Gangster Act, has been attached. At one time, Ateeq wielded total control over real estate dealings in Prayagraj, Kaushambhi, Noida, Lucknow and other parts of the country,

The Enforcement Directorate (ED) has been unearthing details about properties and ill-gotten wealth of the family. The Prayagraj district police and Special Task Force of the UP Police are also working overtime to compile details of the cases registered against family members of Ateeq across the state.

As per the police records over 40 criminal cases were pending against Ashraf. In January this year, Ateeq's wife Shaista joined the BSP in presence of senior party leaders and even announced to contest urban

Umesh Pal killing: Accused gunned down in encounter

Prayagraj: Uttar Pradesh police Monday gunned down one of the accused in the sensational February 24 killing of a prime witness in the 2005 murder case of then BSP MLA Raju Pal in an encounter here, an official said. Police claimed that they retaliated when he opened fire at them. Deputy Commissioner of Police Navendu Kumar told PTI that Arbaaz, who was the driver of the white SUV used by the assailants to attack witness Umesh Pal, was surrounded by police teams following an intelligence input. He opened fire on the police and was injured in the ensuing encounter in Nehru Park under Dhoomanganj police station at around 3 pm, Kumar said. He was taken to hospital where doctors declared him dead, the officer said. "Arbaaz was accompanied by two or three other people who managed to escape from the spot. We are trying to track them," the officer added. Umesh Pal and his police security guard Sandeep Nishad were shot dead Friday outside his home in Dhoomanganj area of Prayagraj. Another security personnel Raghvendra Singh, who was injured in the attack, was admitted to SRN Hospital in critical condition and was referred to Lucknow Sunday.

Jammu, Feb 27: Scores of protesting Kashmiri Pandit Prime Minister's Package employees Monday reiterated their demand for relocation outside the valley, saying their worst fears have come true with the latest killing of a community member in Pulwama.

The protesters assembled outside the relief commissioner's office in Jammu and staged a protest against the killing of Sanjay Sharma (40), a bank ATM guard who was shot dead by terrorists in the Achan area of the south Kashmir district Sunday.

"We were apprehensive about something like this, being fully aware of the ground realities. The latest killing has dealt a severe blow to our confidence and further increased our concern over our community members' safety in the valley," Yogesh Pandita, one of the protesters, told reporters.

Reiterating their demand for relocation outside the valley, he said the government's claim about a secure atmosphere for their return to join their duties stands exposed. "The administration choked us financially by stopping our salaries to force us to rejoin our duties. We are afraid of working there given the continued targeted killings," Pandita said.

Hundreds of Prime Minister Package employees belonging to the Kashmiri Pandit community shifted to Jammu in May last year following the killing of their colleagues, Rahul Bhat and Rajini Bala, by terrorists.

While Bhat was shot dead inside his office in central Kashmir's Budgam district May 12, Bala, a school teacher, was gunned down in south Kashmir's Kulgam May 31 last year.

Another protester; Ruban Saproo, said the lieutenant governor-led

Bharatiya Janata Party (BJP), Shiv Sena Dogra Front and Rashtriya Bajrang Dal separately staged protests against targeted killings and demanded adequate security arrangements for the safety of the minority community members in Kashmir. Chanting anti-Pakistan and anti-terrorism slogans, BJP workers staged a protest at Kachi Chawni, the Shiv Sena Dogra Front at Rani Park and the Rashtriya Bajrang Dal near the city bus stand. The protesters burnt effigies of Pakistan for sponsoring terrorism in Jammu and Kashmir.

Dogra Sadar Sabha president and former Jammu and Kashmir minister Gulchain Singh Charak raised questions over the frequent targeted killings in Kashmir despite claims of normalcy. He demanded special security arrangements for the safety of people and adequate compensation to the bereaved family.

The migrants' wing of the People's Democratic Party (PDP) also condemned Sharma's killing and demanded an end to targeted killings.

"Holi in Barsana virtually is a repeat of Holi representing the 'Dwaapar' age with menfolk trying to drench womenfolk with colours and women preventing them through baton attacks. The men protect themselves by carrying leather shields," Raas Bihari, a priest of Ladli temple in Barsana, said.

Legend has it that when Krishna visited Barsana to spray colours on his beloved. Radha and her friends 'playfully' hit him with sticks and drove him out of the town. Lathmar Holi seeks to recreate that.

"Holi in Mathura is celebrated for around 25 days. It is celebrated at different locations in different ways. On Friday, we organised 'Phoolo kee Holi' (Holi of flowers)

Bypolls in 3 Assembly seats held peacefully

New Delhi, Feb 27: Bypolls in three Assembly constituencies in as many states passed off peacefully Monday with around 63-70 per cent turnout, though some technical glitches in EVMs were reported in Tamil Nadu and the ruling TMC in West Bengal alleged that the CRPF was "influencing" voters.

A voter turnout of more than 63 per cent was recorded till 3 pm in the by-election to West Bengal's Sagardighi assembly constituency in Murshidabad district while over 67.96 per cent voting was registered till 5 pm in the Ramgarh assembly constituency bypoll in Jharkhand.

Around 70.58 per cent of the voters cast their ballots till 5pm in the bypoll to Tamil Nadu's Erode East by-election, EC officials said. No untoward incident was reported during the voting at the three places, Election Commission officials said. In West Bengal, the ruling TMC accused the Central Reserve Police Force (CRPF) of trying to influence the electors to vote for the BJP. The opposition BJP, however, charged the TMC with trying to create an issue out of a non-issue. The TMC. which has been winning the seat since 2011, had won it in 2021 too by a margin of nearly 50,000 votes, securing more than 50 per cent of the

While 77 candidates are in fray, the battle is likely confined between the Congress and AIADMK.

Top court extends interim bail to Khera

New Delhi, Feb 27: The Supreme Court Monday extended the period of interim bail granted to Congress leader Pawan Khera in a case related to his alleged objectionable remarks against Prime Minister Narendra Modi till March 3.

The Assam Police arrested Khera in connection with the case last week. A three-judge bench headed by Chief Justice of India (CJI) DY Chandrachud took note of the submissions made by Solicitor General Tushar Mehta, who appeared in the court on behalf of the Assam government, that the state police

wanted to file its reply. Additional Advocate General Garima Prasad, appearing in the matter for the Uttar Pradesh government, said she will also file her response in the matter.

The bench took note of the submissions and fixed Khera's plea for hearing on March 3, making it clear that the interim bail, granted to him February 23, will remain in force till then.

"List Friday. The counter-affidavits (replies of the Assam and Uttar Pradesh governments) to be filed.... Ad-interim protection (interim bail) granted to extend till the next date of hearing," the bench,

Khera was arrested from the Delhi airport after he was de-boarded from a plane that was supposed to take him to Raipur in connection with his alleged remarks against Modi made at a press conference in Mumbai February 17. The Congress leader obtained bail from a magisterial court here February 23 after the CJIled bench granted him the interim bail during an urgent hearing earlier in the day.

"In order to enable the petitioner (Khera) to apply for regular bail before the jurisdictional court, upon the FIRs being transferred to one jurisdiction, we direct that the petitioner shall be released on interim bail by the court of the competent magistrate at Delhi where he is to be produced this evening," the apex court had said.

BUDGET TO KEEP GUJARAT AT FOREFR

lessed are the young for they shall inherit the national debt", said Herbert Hoover, the 31st President of the United States who faced the brunt of the 1929 stock market crash and the Great Depression. The context of his message remains out of reach but the parable of mounting public debt nearer

home sure arouses concern. Gujarat's budget proposals for the financial year 2023-24 have brought home with stunning accuracy that its allocations stand outpaced by its spiraling public debt.

On February 24, the Bhupendra Patel led BJP government in Gujarat presented its first budget after being re-elected with a record breaking

steam roller margin. Finance Minister Kanu Desai presented a ₹3.01 lakh crore budget proposals for the financial year 2023-24. This figure stood outstripped by ₹80,000 crores with its public debt projec-

tion slated to stand at ₹3.81 lakh crores over the same period Though the fiscal deficit of Gujarat remained below the prescribed three per cent of GSDP,

the projected deficit for the 2023-24 stood at 1.75 pc which is slightly higher than the 1.64 per cent in 2022-23. Last year this figure was ₹4,50,000 crores. All is well, as the saying goes.

Lost in the welter of verbiage is the fact that when the BJP first came to power in the state in 1995,the state's public debt was around ₹10,000 crores. By the time Narendra Modi became Chief Minister in 2001-2002, the debt had



risen to ₹45,301 crores. In 2014 when Modi left Gujarat to takeover as Prime Minister in New Delhi, the Comptroller and Auditor General of India(CAG) put the total public debt of the state at

₹2.21 lakh crore. It had ballooned to an all-time of ₹3.2 lakh crore in 2021-22, higher than the annual of ₹2.4 lakh crore for 2022-23.

Last year the CAG had warned that the state was headed for a debt trap because it has to pay back 61 per cent of the debt of over ₹3 lakh crores over the next seven years. In layman's terms, it must repay ₹1.87 lakh crores by 2028. The same report had also pointed out that while the GSDP had grown at a compounded annual growth rate (CAGR) of 9.2 per cent between 2016 and 2021, publc debt has grown at a CAGR of 11.5 per cent.

Official statistics say that the state paid ₹20,293 crores as interest and ₹16,701 crores as principal amount

in 2019-20, while in 2020-21, interest paid stood at ₹22,099 crores and the principal was ₹17,918 crores.

In the run-up to the Gujarat elections last year, Prime Minister Narendra Modi had warned against the rising rash of 'revadis' (freebies at state cost). The pulpit preaching, however, seems to have gone waste in his own home state with his own party government for the 23 per cent increase in budgetary allocation this year is matched by a 19 per cent increase in the quantum of subsidies provided in matching time. The budget documents put this figure at ₹26,511 crores. The crowning irony is that the industrial sector which has been availing incentives and subsidies all

along successive budgets including ₹2300 crores in the preset one, have ₹57,394 crores in pending tax dues, some as old as a decade !

The state seems trapped in a vicious cycle. It borrows to build, then splurges in incentives, subsidies and freebies. It first creates public sector undertakings (PSUs), then over time, renders these establishments sick through mismanagement and thereafter sells the sick shells to stem the rot and 'recoup' in peanuts. The cycle is unending-borrow-build, splurgesell- and all at public cost.

Thus it is that Gujarat has decided to follow the Centre by disinvesting state run companies to meet capital expenditure targets.

Cape CanaveraL, Fla., Feb 27: NASA and SpaceX Monday postponed the launch of a capsule containing two US astronauts, a Russian cosmonaut and a United Arab Emirates crewmate minutes before scheduled lift-off from Florida on a flight to the International Space Station.

The U.S. space agency and SpaceX, the private rocket company founded by billionaire Elon Musk, cited a technical glitch concerning the ignition fluid used to start the spacecraft's engines.

The countdown had seemed to be progressing smoothly until about two and a half minutes before blastoff, when NASA announced on its live webcast that the launch of the four crew members on a six-month science mission would be postponed. The SpaceX Falcon 9 rocket topped with a Crew Dragon capsule had been scheduled for liftoff at 1:45 a.m. EST (0645 GMT) from NASA's Kennedy Space Center in Cape Canaveral, Florida. The first backup launch opportunity for the mission was set for early Tuesday, about 24 hours from the initial attempt to get the rocket off the ground.



London, Feb 27: The UK and the European Union ended years of wrangling on Monday, sealing a deal to resolve their thorny post-Brexit trade dispute over Northern Ireland.

Prime Minister Rishi Sunak and European Commission President Ursula von der Leven signed off on the deal at a meeting in Windsor England. Afterwards Sunak said the pair would hold a news conference on Monday. The government had previously said that would only happen if a deal was struck.

The agreement could end a dispute that has soured U.K.-EU relations, sparked the collapse of the Belfast-based regional government and shaken Northern Ireland's decades-old peace process. Fixing it is a big victory for Sunak - but not the end of his troubles. Selling the deal to his own Conservative Party and its Northern Ireland allies may be a tougher struggle. Now Sunak awaits the judgment of Northern Ireland's Democratic Unionist Party, which is boycotting the region's power-sharing government until the trade arrangements are changed to its satisfaction. Sunak is due to make a statement by Sunak to the House of Commons later setting out details of the deal. Von der Leyen is due to have tea with King Charles III at Windsor Castle, 20 miles (32 kilometers) west of London. Buckingham Palace said the meeting was taking place on the government's advice, leading critics to accuse Sunak of dragging the monarch, who is supposed to remain neutral, into a political row.

Steccato Di Cutro (Italy), Feb 27: The death toll rose to 62 in the migrant tragedy off Italy's southern coast after rescue crews recovered three more bodies on Monday, driving home once again the desperate and dangerous boat crossings of people seeking to reach Europe.

Dozens more were believed to be missing. Children were among the dead after a wooden boat broke up in stormy seas on the reefs near the Calabrian coast on Sunday.

The beach at Steccato di Cutro. on Calabria's Ionian coast, was littered with the splintered remains of the 20-metre (65-foot) boat as well as the belongings the migrants had brought with them. including a toddler's tiny pink sneaker and a yellow plastic pencil case decorated with pandas.

There were only a few life jackets scattered amid the debris. The UN and Doctors Without Borders. which had crews on the scene. said many of the victims were Afghans, including members of large families, as well as tionality to seek asylum in the European Union last year, and have increasingly fled the spiralling security, humanitarian and economic troubles that followed the Taliban takeover in August 2021.

On Monday, two coast guard vessels searched the seas north to south off Steccato di Cutro while a helicopter flew overhead and a four-wheel vehicle patrolled the beach.

Covid likely came from lab leak in China: Report

Washington, Feb 27: The virus that drove the COVID-19 pandemic, killing close to 7 million people globally, most likely emerged from a laboratory leak in China, according to a US media report, citing a classified intelligence report recently provided to the White

Congress

The Huanan market in central China's Wuhan city was the epicentre of the pandemic. From its origin there, the SARS-CoV-2 virus rapidly spread to other locations in Wuhan in late 2019 and then to the rest of the world.

The pandemic's origin has been the subject of vigorous debate among academics, intelligence experts and lawmakers. The findings of the US Department of Energy - a departure from previous studies on how the virus emerged - came in an update to a document from the Office of National Intelligence director Avril Haines, the Wall Street Journal reported on Sunday.

The new report highlights how different parts of the intelligence community have arrived at disparate judgments about the pandemic's origin. The Energy



Department now joins the Federal Bureau of Investigation (FBI) in saying the virus likely spread via a mishap at a Chinese laboratory. Four other agencies, along with a national intelligence panel, still judge that it was likely the result

are undecided.

The Energy Department's conclusion is the result of new intel-

ligence and is significant because the agency has considerable scientific expertise and oversees a network of US national laboratories, some of which conduct ad-

vanced biological research, the report said.

The Energy Department made its judgment with "low confidence," according to people who have read the classified report. The spread of COVID-19, just one in a line of infectious coronavirus to emerge, caught global health bodies unawares in early 2020. Close to 7 million people have died worldwide. according to the World Health Organisation.

US National Security Adviser Jake Sullivan on Sunday said that the intelligence community is divided on the matter while noting that President Joe Biden has put resources into getting to the bottom of the origin question.

Sullivan said that Biden had directed the national laboratories, which are part of the Department of Energy, to be brought into the assessment. "Right now, there is not a definitive answer that has emerged from the intelligence community on this question," Sullivan told CNN.

"Some elements of the intelligence community have reached conclusions on one side, some on the other. A number of them have said they just don't have enough information to be sure."The deadly virus has also disrupted the global economy, trade as well as travel.

The FBI previously came to the conclusion that the pandemic was likely the result of a lab leak in 2021 with "moderate confidence" and still holds to this view.

The National Intelligence ২ Council, which conducts long-term strategic analysis, and four agencies, which officials declined to identify, still assess with "low confidence" that the virus came about through natural transmission froman infected animal, according to the updated report.

With India's economy on the mend following the Covid pandemic, credit offtake has improved and most banks now expect double-digit credit growth for the current financial year ending in March 2023.

Deposit growth, on the other hand, has lagged credit growth for most banks, despite the RBI's ratesetting panel increasing the policy repo rate by 250 basis points since May last year.

Nokia changes iconic logo to signal strategy shift

Barcelona, Feb 27: Nokia announced plans Sunday to change its brand identity for the first time in nearly 60 years, complete with a new logo, as the telecom equipment maker focuses on aggressive growth.

The new logo comprises five different shapes forming the word NOKIA. The iconic blue color of the old logo has been dropped for a range of colours depending on the use.

"There was the association to smartphones and nowadays we are a business technology company,' Chief Executive Pekka Lundmark told Reuters in an interview.

He was speaking ahead of a business update by the company on the



eve of the annual Mobile World Congress (MWC) which opens in Barcelona Monday and runs until March 2.

After taking over the top job at the struggling Finnish company in 2020, Lundmark set out a strategy with three stages: reset, accelerate and scale. With the reset stage now complete, Lundmark said the second stage is beginning.

"We had very good 21% growth last year in enterprise, which is currently about 8% of our sales, (or)

2 billion euros (\$2.11 billion) roughly," Lundmark said. "We want to take that to double digits as quickly as possible.

Major technology firms have been partnering with telecom gear makers such as Nokia to sell private 5G networks and gears for automated factories to customers, mostly in the manufacturing sector.

Nokia plans to review the growth path of its different businesses and consider alternatives, including divestment.

"The signal is very clear. We only

want to be in businesses where we can see global leadership,' Lundmark said.

Nokia's move toward factory automation and datacentres will also see them locking horns with big tech companies, such as Microsoft and Amazon.

"There will be multiple different types of cases, sometimes they will be our partners ... sometimes they can be our customers... and I am sure that there will also be situations where they will be competitors."

The market to sell telecom gear is under pressure with macro environment denting demand from high-margin markets such as North America, being replaced by growth in low-margin India, pushing rival Ericsson to lay off 8,500 employees.

Essar to invest \$3.6bn in energy shift in UK, India

New Delhi, Feb 27: The Essar group Monday announced a \$3.6 billion investment in low carbon energy transition projects in the UK and India including the production of green hydrogen and ammonia over the next five years, as it looks at a new phase of growth.

Essar Group, invested in energy, metals and mining, infrastructure and technology sectors, announced "the formation of Essar Energy Transition (EET) to drive the creation of the UK's leading energy transition hub in North West England.'

"EET plans to invest a total of \$3.6 billion in developing a range of low carbon energy transition projects over the next five years, of which \$2.4 billion will be invested across its site at Stanlow, between Liverpool and Manchester and \$1.2 billion in India," the company said in a statement.

The projects will include 1 gigawatt of blue hydrogen project being pursued by Vertex Hydrogen in the UK, a 1 GW of green ammonia facility targeted at the UK and international markets, and developing 1 MT of low ২ carbon biofuels.

Vertex is building a hydrogen manufacturing unit at Essar's Stanlow refinery complex in the UK. The joint venture, in which Essar Oil UK holds 90 per cent, will pro-duce 1 gigawatt (GW) of hydrogen per year from two units from 2026.

Indore, Feb 27: Ravichandran Ashwin's enviable record in Test matches at the Holkar Stadium could make the Australian bat ters rethink their strategy of playing the high-risk sweep shots, which brought about their downfall in the first two games. Ashwin has 18 wickets in the two Tests he has played at this venue at an average of 12.5 runs.

Australia, who arrived here a week after their second-innings surrender in Delhi, turned up for the net session before their scheduled time.

They were slammed for their

tactics against Indian spinners at the Ferozeshah Kotla with half of the side falling to the poorly-executed sweep shots on a slow and low surface.

Having lost the chance to regain the Border-Gavaskar trophy, Australia looked keen to learn from their mistakes in their threehour-long training session.

Rather than going for the sweep shot, Steve Smith and Co concentrated on front-foot defence against the spinners besides stepping out to hit down the ground. Smith and Usman Khawaja were the first ones to hit the nets and batted for more than an hour against Nathan Lyon and Matthew

Kuhnemann.

One of the best batters against spin in the Australian set-up, Smith's performances have been underwhelming so far and he will be keen to correct that in the game beginning Wednesday. Lyon troubled both Khawaja

and Smith as the duo looked determined to firm up their defence. Most of the aerial hits came off rookie Kuhnemann.

It was an hour of madness at the Kotla that cost Australia the game despite fully understanding the implications of the sweep shots on those Indian pitches offering low bounce.

They will need to trust their

defence a lot more and step out reg ularly to unsettle Ashwin and Co. Such was their frame of mind Monday that Khawaja and Smith returned to the nets for a second stint after all the batters had finished training. This time Khawaja and Alex Carey, who has been dismissed four times playing the same shot with a very low degree of success, concentrated on playing the sweep shot.

Marnus Labuschagne, Travis Head and Peter Handscomb faced off-spinner Murphy and leg-spinner Mitchell Swepson, who has reunited with the squad following the birth of his child.

Handscomb, who has looked the most comfortable against the spinners so far on the tour, came down the pitch every time Murphy and Swepson gave the ball some air.

Head, the most aggressive of the Aussie batters in Delhi, was particularly harsh on Swepson as he slog swept with the spin. Starc bowls full tilt

Left-arm pacer Mitchell Starc, who missed the first two Tests due to a finger injury, will replace skipper Pat Cummins in the playing eleven for the third Test with the latter back in Australia to be with his ailing mother.

Starc said he is not 100 per cent fit yet but bowled to Cameron Green for close to an hour and generated good pace. Lance Morris bowling alongside him and beat Green with his pace and movement on multiple occasions.

Green, who also had a bowl later in the session, is set to play his first game of the series after missing the first two Tests due to a finger injury. With Cummins and David Warner out of reckoning, Green and Starc look like automatic choices to fill the slots.

Barcelona stunned by Almeria in La Liga

Barcelona, Feb 27: Three days after exiting the Europa League, Barcelona had a rare setback in the Spanish league after losing at Almeria 1-0.

Barcelona headed to southern Spain after second-place Real Madrid were held 1-1 by Atletico Madrid Saturday and had the chance to add to its seven-point lead at the top over their fierce rival. Instead, Barcelona flopped to their first-ever loss to Almeria in their 16th meeting. The leaders were unable to

mount a credible fightback despite having ample time to respond to striker El Bilal Touré's goal in the 24th minute. For Barcelona coach Xavi Hernández, his team's "worst game of the season" came just when it could have dealt a serious blow to Madrid's

bid to defend their Spanish title. Barcelona hadn't lost in 13 league games, with only one draw and 12

wins going back to their last defeat at Madrid in October. The unexpected defeat Sunday came after a 1-2 loss at Manchester

United which eliminated Barcelona from the Europa League — after it had failed to advance from the Champions League group phase for a second consecutive year.

The exit from Europe's secondtier competition left Barcelona with the Spanish league and domestic cup titles to play for as they try to make good on their investment in new players last summer using cash it generated from the sale of future television revenues and other assets.

Barcelona will now have to regroup for Thursday's visit to Real Madrid in the semifinals of the Copa del Rey. Almeria moved out of the relegation zone after earning one

of its biggest wins.

After a complacent start by Barcelona, Almeria struck on a quick attack after an inspired Rodrigo Ely tackled Gavi in the hosts' area and booted a long ball forward for Touré to control. The 21-year-old Mali forward exchanged quick passes with Luis Suárez and blasted a powerful strike over Marc-Andre ter Stegen and in off the crossbar.

Almeria pressed the initiative and almost got a quick second goal when Leo Baptistao hit the post in the 27th. Xavi sent Raphinha on at halftime, with Araújo and Marcos Alonso soon following, but his team did not play much better as Almeria held firm in defense. Gavi's shot blocked by Ely in the 59th and a shot by substitute Pablo Torre in the 82nd easily grabbed by Fernando ended up being the most that a disappointing Barcelona could muster.
