

Student found hanging in Berhampur varsity

Berhampur, March 11: A 22-yearold postgraduate student of Berhampur University was found hanging from the ceiling fan of his room at New Gents' Hostel on the institute's campus Saturday, police said.

The deceased was identified as Tarini Prasad Biswal, a native of Tirtol block in Jagatsinghpur district. He was a first year student of Industrial Relations and Personnel Management (IR&PM) department in the university under Gopalpur police station, a police officer said.

"Biswal was alone in his room as his roommate had gone to his native place. His classmates knocked at the door as he did not open the door of his room till late in the morning Saturday," said Gopalpur police station in-charge Sarada Prasanna Das

They grew suspicious and broke open the door only to find him hanging from the ceiling fan. They informed the hostel warden and local police. The hostel warden and a police team rushed to the spot and found him hanging.

Police did not bring down the body but informed his family members about his suicide. The body was found hanging when reports last came in. Police said that the body will be brought down in the presence of his family members after their arrival, OIC Shankar Rao of University police outpost said.

Prima facie, it seems to be a suicide case but the reason for it is not yet known, the officer said, adding further investigation is underway. No case has been registered till the last report came in.

66% income of nat'l parties from unknown sources: ADR

New Delhi, March 11: More than 66 per cent of the total income of seven national parties in 2021-22 came from "unknown sources' like electoral bonds, which accounted for a whopping 83 per cent, according to the Association for Democratic Reforms

(ADR). The seven parties -BJP, Congress, TMC, NCP, CPI, CPI(M) and the National People's Party-collected ₹2,172 crore from unknown sources in 2021-22, the NGO

working for electoral reforms said, citing official data.

The income from unknown sources was 66.04 per cent of their total income. And. ₹1.811.94 crore or 83.41 per cent of the income from unknown sources came through electoral bonds, it said.

The "unknown" sources are income declared in the annual audit report by these parties but without giving the source of income, according to the ADR. At present, political parties are not required to reveal the name of individuals or organisations giving less than ₹20,000 and those who donated via electoral bonds.

The ADR stated such unknown sources include donations via electoral bonds, sale of coupons, relief fund, miscellaneous income, voluntary contributions, and

sources which is 53.45 per cent of the total income of national parties from unknown sources, it said. "This income of BJP is ₹149.86 crore more than the aggregate of income from unknown sources declared by the other six national parties (Rs 1,011.18 crore)," the ADR said.

Nimapara: A woman sarpanch was run over by a speeding truck at Delta Square here, Saturday. The incident took place in the afternoon when Dipa Behera, 32, sarpanch of Biraramachandrapur and a resident of Sadanandpur under Satyabadi block, was on her way home with her nephew, Gulu Behera, in a motorcycle after attending a function here. Dipa, who was riding pillion, fell off the bike near Delta Square. "Before she could stand up, a speeding truck from the opposite side ran over her, killing the woman instantaneously," said an eyewitness. The truck driver, however, fled the spot leaving behind the vehicle. Dipa's nephew lodged a complaint with Nimapara police following which a case has been registered and the truck seized. Dipa's body was sent for autopsy to Puri DHH.

during January and February 2023. Of these, 59 samples were found positive for the H3N2, one for Influenza-A and another for Covid-19, she said.

"Currently, there is 'no definitive treatment available' for the virus and hence, people should strictly follow the Covid guidelines to keep H3N2 at bay," Odisha Public Health Director Niranjan Mishra told reporters here. State Health secretary Shalini

New Delhi: Amid a rise in cases of seasonal influenza subtype H3N2, the Centre Saturday expressed concern over a gradual increase in Covid-19 positivity rate in some states and said it needed to be promptly addressed.

The Centre requested all states and Union territories (UTs) to follow operational guidelines for integrated surveillance of respiratory pathogens presenting as cases of influenza-like illness (ILI) or severe acute respiratory infection (SARI). The states were requested to

take a stock of hospital preparedness such as availability of drugs and medical oxygen, vaccination coverage against Covid-19 and influenza.

'While Covid-19 trajectory has decreased substantially in last few months, the gradual rise in Covid-



19 test positivity rates in some states is an issue of concern that needs to be promptly addressed, Union Health Secretary Rajesh Bhushan said in a letter to states and UTs Saturday.

New Delhi, March 11: Delhi Commission for Women (DCW) chairperson Swati Maliwal Saturday said she was sexually assaulted by her father in her childhood and the trauma led her to fight for the rights of women.

Speaking to reporters after the DCW International Women's Day Awards ceremony here, Maliwal said she faced abuse till the time she was in Class IV.

"I was sexually assaulted by my father when I was a child. I was very small at that time. My father used to beat me up and I used to hide under the bed to save myself," she said. "While hiding under the bed, I used to think how I will teach a lesson to such men who abuse women and children, and how I can help women get their rights," she said.

Narrating her ordeal, Maliwal said that her father would grab her by her braid and slam her \rightarrow against the wall, leading to severe bleeding. "This happened till I was in Class IV," she recalled.

Recently, actor and National Commission for Women (NCW) member Khushbu Sundar said shewas sexually abused by her father at the age of 8.

First trans tea stall at Guwahati station

GUWAHATI: In a landmark initiative, the Indian Railways has set up a tea stall at Guwahati station which will be fully operated and managed by members of the transgender community. The idea to open the 'Trans tea stall' was generated and implemented by the North East Frontier Railway (NEFR) to empower the community, its spokesperson Sabyasachi De said. The NEFR collaborated with All Assam Transgender Association for the initiative, he said. The 'Trans Tea Stall' on platform number one of Guwahati station was inaugurated by NF Railway General Manager Anshul Gupta Friday. Talking to reporters. Gupta said that this is a "first-of-its kind initiative by any government organisation in the country".

Shah to address meet in Dhamnagar March 26

Bhubaneswar, March 11: Union Home Minister Amit Shah is scheduled to address a public meeting in Dhamnagar Assembly constituency in Bhadrak district March 26, a senior BJP leader said.

He will address the rally during his one-day visit to the state under the Pravas programme, state BJP general secretary Lekhashree Samantasinghar told reporters.

"During his visit, Shah will address a public meeting at Sainlapur in Dhamnagar Assembly constituency, which falls under Bhadrak Lok Sabha seat. Before that, he will visit the famous Akhandalamani temple of Lord Shiva," she said.

Shah will also hold a meeting with BJP workers at Dhamnagar before his departure to Bhubaneswar, she said. In Bhubaneswar, Shah is scheduled to meet senior state BJP leaders and party legislators before returning to Delhi the same day, Samantasinghar said.

Shah had last visited Odisha in August last year. He had offered prayers at the Lingaraj temple in Bhubaneswar and visited the Netaji Birthplace Museum in Cuttack. He had also attended several events in the twin cities during his two-day visit.

'Treaty for sustainable space exploration'

cientists are calling for a legallybinding treaty to ensure Earth's Orbit is not irreparably harmed, given the rate of expansion of the global space industry

While satellite technology is used to provide a huge range of social and environmental benefits, there are fears the predicted growth of the industry could make large parts of Earth's orbit unusable.

The number of satellites in orbit is expected to increase from 9,000 today to over 60,000 by 2030, with estimates suggesting there are already more than 100 trillion untracked pieces of old satellites circling the planet.

An international collaboration of experts in fields including satellite technology and ocean plastic pollution said this demonstrates the urgent need for global consensus on how best to govern Earth's orbit. They have expressed their concerns in the journal Science.



While they acknowledged that a number of industries and countries are starting to focus on satellite sustainability, they also said this should be enforced to include any nation with plans to use Earth's orbit. Any agreement, they added, should include measures to implement producer and user responsibility for satellites and debris, from the time they launch onwards.

Commercial costs should also be considered when looking at ways to incentivise accountability. Such considerations are consistent with current proposals to address ocean plastic pollution as countries begin negotiations for the Global Plastics Treaty, they said.

The experts also believe that unless action is taken immediately, large parts of our planet's immediate surroundings risk the same fate as the High Seas where insubstantial governance has led to overfishing, habitat destruction, deep-sea mining exploration, and plastic pollution.

"The issue of plastic pollution, and many of the other challenges facing our ocean, is now attracting global attention. However, there has been limited collaborative action and implementation has been slow. Now we are in a similar situation with the accumulation of space debris. Taking into consideration what we have learnt from the high seas, we can avoid making the same mistakes and work collectively to prevent a tragedy of the commons in space.

Bhubaneswar, March 11: With people of the City preparing to deal with the gradual rise in temperature, the Bhubaneswar Municipal Corporation (BMC) held a review meeting for heatwave preparation Saturday.

At the meeting BMC commissioner Vijay Amruta Kulange asked the municipal officials to take all possible measures to deal with heatwave conditions in the Capital during the ensuing summer.

Addressing the officials, the commissioner said, "Planning should cover everyone in the City and each department needs to extend their support to prevent casualties. The hospitals should be prepared well with weather control center and focus should be on keep-



ing doctors and nurses in hospitals available for treating people affected by the heatwave

Emphasising the need for water kiosks, he directed the concerned officials to ensure availability of regular water kiosks in time especially at places with labourers working in open.

Earlier, keeping in view the heatwave-like condition, BMC had urged all the corporators to open water kiosks in their respective wards at the earliest.

The local civic body had also prepared an action plan to deal with the heatwave condition in City.



The BMC had asked officials to submit the subsection-wise plan and line departments' preparedness at the earliest. After having section-wise plan an SOP will be prepared for citizen awareness. Area wise RWAs, SHGs and social organisations will be requested to support the initiative, the BMC stated.



While influenza is an annual seasonal occurrence, in the present season, a variety of weather conditions and behavioural reasons – less than adequate attention to personal hygiene, coughing without adequate protection, closed indoor gatherings of people, etc. - make the environment conducive to circulation of a number of viral respiratory pathogens like Influenza A (H1N1, H3N2 etc.) and adenoviruses, he mentioned. Under the Integrated Disease Surveillance Programme (IDSP), as reported by states and UTs, an increasing trend of ILI/SARI is being observed across the country, Bhushan stated.

Further, according to integrated sentinel based surveillance of ILI and SARI, an upswing of Influenza A is observed since the latter half of December last. "Of particular concern is preponderance of Influenza A (H3N2) being detected in the samples being analysed in various labs. It should also be kept in mind that young children, old age people and people suffering from co-morbidites are particularly at risk and vulnerable to H1N1, H3N2, adenoviruses, etc," he said.

"In order to limit transmission of these diseases, it is important to raise community awareness regarding adherence to respiratory and hand hygiene and promoting early reporting of symptoms, and limiting contact of those people who are suffering from respiratory illness," Bhushan wrote in the letter. In terms of requisite public health actions, it is essential that state and district IDSP units closely follow the trend of ILI and SARI in their respective areas, monitor the proportion of cases and refer sufficient number of samples for testing for influenza, SARS-CoV-2 and adenovirus. "All states and UTs must in letter and spirit implement 'Operational Guidelines for Revised Surveillance Strategy in Context of Covid-19' which provides for integrated surveillance of respiratory pathogens presenting as cases of ILI/SARI," the letter stated.

3 lakh Olive Ridley turtles Diatom report lay eggs on Nasi-2 island says drowning caused death

Rajnagar, March 11: The mass nesting of endangered Olive Ridley sea turtles began on Nasi-2 island in Gahirmatha Marine Sanctuary, Thursday evening.

Forest officials Saturday claimed that more than three lakh Olive Ridley sea turtles have laid eggs on Nasi-2 island, the favourite nesting place of the endangered species, since March 9.

With DRDO prohibiting visitors, only a handful of forest personnel on turtle protection duty was at the beach to witness this unique natural phenomenon.

As many as 2,14,058 of the turtles laid eggs on the island Thursday. while 88,000 more arrived for mass nesting Friday. It has been almost a month since the marine creatures started gathering on the island but had not laid eggs due to absence of favourable weather conditions.

Finally, the prevalence of dry weather from March 9 and blow of southern wind prompted them to join mass nesting. Lakhs of mother turtles climbed the beach and laid eggs on the Nasi-2 island from Thursday evening which continued till the wee hours of Saturday. Till Saturday, over 3,02,058 turtles

were estimated to have participated in the mass nesting, forest officials said.

Female turtles were seen digging pits by their two hind legs and laving about 100 eggs in the pit. The size of each egg is like a ping pong ball. The egg shell being flexible does not break when the female turtles lay them in the pit. After laying the eggs, they cover the eggs in sand and return to the sea. The hatchlings come out after 45 to 60

days of incubation period. The turtle nests have been counted segment-wise at Nasi-2 beach, said official sources. Forest personnel have put up 3-kilometre fencing to restrict the entry of canines into the Nasi-2 island during the mass nesting. Apart from this, steps have been taken to guard the

nesting grounds to protect the turtle eggs from predators like crows and eagles. Moreover, the DRDO has switched off its bright light on its

testing site at Wheeler island for safe nesting of the turtles Among the nesting grounds in the state, Gahirmatha Marine Sanctuary is said to be the largest rookery for the endangered Olive Ridley sea turtle, which is protected under Schedule 1 of Wildlife Protection Act, 1972 and accorded the highest protection like endangered tigers

As many as 5,01,157 Olive Ridlev sea turtles had come to the golden beach of Nasi-2 within Gahirmatha Marine Sanctuary and laid eggs within three days from March 25 to 28 in 2022, Gahirmatha sanctuary officials said

The Diatoms test is based on the principle that diatoms can be detected in the organs of drowned victims if they aspirated diatom-rich water into the lungs before death. Diatoms are unicellular, photosynthetic and autotrophic organisms that live both in freshwater and saltwater.

Berhampur, March 11: A man at Army Air Defence College (AADC) at Golabandha in Ganjam district was defrauded of ₹2.03.999 by cyber criminals on the pretext of delivering him a parcel on courier, police said Saturday.

The victim was identified as Bikash Ghosh, 41, a native of West Bengal and an inmate at AADC. The matter came to the fore after he lodged a complaint at the Cyber and Economic Offences police station in Berhampur. Police registered a case and launched an investigation but they are yet to nab anyone for the offence.

Police said that Bikash had ordered a parcel through private courier firm DTDC, February 20. However, after the parcel did not arrive in time, he searched on the internet to contact the company and got a phone number which was mentioned as that of the courier firm.

He rang the number and narrated his ordeal after an unknown person picked up the call. The unknown person replied that the parcel was not delivered as Ghosh's address is not registered with a landmark. He instructed him to click on a link sent by him and deposit additional ₹3 as payment for doing the needful. Ghosh followed the person's directions.

Later, he was assured on call that he will receive his parcel the next day However, to his horror he received a message that ₹2,67,999 had been deducted from his two savings accounts in State Bank of India (SBI) and ICICI Bank, February 25. He immediately contacted the banks and asked them to freeze the debit card.

The ICICI Bank authorities froze the debit following which he got back ₹64,300 deducted from his account but failed to get back ₹2,03,999 in the SBI account. Later, he lodged a complaint at the cyber police station.

Basta/Rupsa, March 11: In a shocking incident, villagers stumbled upon a gunny bag containing human skeleton from a pond while drying up the water body to catch fish at Panisulia village under Singla police limits in Balasore district, Saturday.

The recovery of a human skull and bones sparked surprise among the villagers. They informed the police who reached the spot and seized the sack. An investigation was launched and a scientific team was also pressed into service.

Sources said a group of villagers stumbled upon the sack. Saturday morning when they were cleaning the pond to dry it up before catching fish. To their horror, upon opening the sack, they found a human skeleton with clothes tucked inside it. As the news spread, a large crowd gath-



sarpanch Prabhat Das reached the spot and informed the police.

The identity of the deceased is yet to be ascertained but it is being suspected that the person was murdered and then shoved into a sack before being thrown into the pond. The exact cause of death and the identity of the deceased can be ascertained only after the post-mortem report is available, police officials added.

Sources said the skeleton has been sent to the State Forensic Science Laboratory (SFSL). Villagers suspect that the skeleton is of a girl who went missing from the village ered at the spot. On being informed, one and half years back.

Malkangiri, March 11: The divisional forest officer (DFO) in Jeypore of Koraput district has suspended a forester and a woman forest guard with immediate effect until further orders for allegedly demanding and collecting ₹3.20 lakh as bribe for payment of ₹2 lakh exgratia each to kin of eight deceased kendu leaf workers.

The suspended forest officials have been identified as Balimela forester Durga Prasad Navak and a woman forest guard Padmini Patnaik of Kudmulguma under Gumma forest beat of Jeypore kendu leaf forest division in Koraput district.

The two illegally demanded bribe from the innocent tribal people to provide them the ex-gratia amount.

The matter came to the fore after the DFO issued two letters - 78 and 79 dated March 10, 2023 in this regard. Ex-gratia is provided to kendu leaf workers in case of death or permanent disability.



Reports said that eight kendu leaf workers Ramahari Dora, Budri Dola, Lachhman Badnaik, Mohan Singh, Pari Hantal, Brunda Pangi, Ram Khamar and Samari Pangi died following which the kendu leaf department sanctioned ₹2 lakh ex-gratia each to their surviving family members. The woman forest guard visited the houses of the deceased kendu leaf workers for payment of ex-gratia.

There she forcibly demanded

₹40.000 each from the eight families totalling ₹3.20 lakh informing them that she will have to pay it as a bribe to the senior authorities.

On being informed, a social activist Sarat Buruda informed DFO Prafulla Mandal of Jeypore kendu leaf division and demanded an inquiry. In the first phase, the woman forest guard was suspended after she was proven guilty of her involvement. Forester Durga Prasad Navak was also suspended after he was found inmanded payback of the collected bribe amount to the bereaved family members. The DFO has thanked the social activist for highlighting the wrongdoing by engaging officials from other districts.

Based on a complaint, the DFO conducted a probe and placed the two under suspension after a video of the lady forest guard cheating the tribals went viral.

Locals alleged that this is just the tip of the iceberg and welfare funds and ex-gratia of kendu leaf workers are being rampantly misappropriated in other parts of the district.

The social activist has demanded a high-level inquiry to unravel similar misappropriation of welfare funds and ex-gratia in other parts of the district.

Meanwhile, the Nabarangpur kendu leaf division has been directed to conduct further probes into the involvement of more officials in this connection.

Politics of Bigotry

ne party has the monopoly on bigotry in India. If you are not inclined to support the harassment and brutalisation of fellow Indians you could vote for any number of parties. In Tamil Nadu there are the two parties, both factions of the old DMK, in Kerala there are the various Left groups, in Karnataka there is Deve Gowda's Janata Dal (Secular), perhaps the only party in India that advertises its antipathy to communalism in its name. Then you have the various groups that have splintered from the Congress but retained its surname: TMC in Bengal, NCP in Maharashtra and YSRCP in Andhra Pradesh. They are separate parties but have Congress in their name because of brand recognition but also perhaps to assure their followers that their core ideology is not different from that of the mothership. Then nationally there is the Congress of course.

You could vote for PDP or NC in Kashmir (assuming there is ever an election there again) or AAP in Delhi or K Chandrashekar Rao's TRS in Telangana. Even the communally formed parties, like the All India Majlis e Ittehadul Muslimeen (Ittehad means unity) or the Indian Muslim League do not have an agenda that is opposed to inclusive secularism.

None of these parties is perfect and many of them have a history of harassing minorities when in power and being unable to prevent their per-

secution. But there is only one party that actively seeks harassment and if you want that sort of thing then there is only one party for you and that of course is the BJP. No other party seeks to push exclusionary laws on citizenship, on divorce, on food, on segregation as the BJP has done actively especially after 2019. No other party deliberately excludes Muslims: of the BJP's 303 Lok Sabha and 92 Rajya Sabha MPs none is a Muslim. Incredibly, of its more than 1000 MLAs across India there is not a single Muslim. This is deliberate and calculated division of society based on religion that no other party wants to practice, even though it may be rewarding.

The BJP is in some sense resembles parties in the political landscape of Pakistan. There all parties tend to be anti-minority even though the minority population is only around 3 per cent. Six months after Jinnah's passing in 1948 Pakistan's constituent assembly was told that minorities would be allowed the right to practice their religion freely. They were told that the constitution's religious orientation was only to ensure that Muslims would be more devote and conforming. This did not happen of course because the assumption that they were not pious was wrong, and in any case it is not the role of the state. But after it became clear that it was floundering, attention turned to the minorities. A series of laws excluding them from political office and then actively persecuting them came starting in the late 1950s

and by the 1980s it had peaked. Even the socialist ZA Bhutto participated in this out of expediency, with his second amendment that went after the Ahmadiyya community in 1974. In the last couple of decades, this has begun to be reversed to a limited extent. Under Musharraf, the law on fornication was returned from Shariah back to the secular penal code, which Pakistan and Bangladesh share with India. Perhaps it was realised that there was no real benefit to persecution and that the damage to the nation and the state was long term.

In Bangladesh the constitution opens with the Bismillah verse but it also, like India's commits itself in writing to secularism in its preamble. Further down, it says that "the principle of secularism shall be realised by the elimination" of communalism, political status in favour of any religion, abuse of religion for political purpose and discrimination or persecution. Bangladesh is as authoritarian as India is and the political opposition and civil society are harassed in similar fashion. It will hearten Indians to know that Bangladesh is even lower than us in the hated V-Dem liberal democracy index. On Freedom House's Freedom in the World Index also

I would challenge them to look at a video of the Earth's rainfall system, and tell me - what borders do you see? It's a simple answer: there are none. There is only one global system, powered by three beating hearts: the Amazon rainforest, Sub-Saharan Africa, and the Indonesian archipelago. You might call them the rainfall factories of our planet. And they represent a perfect example of Take the Amazon rainforests

for instance. The north-eastern trade winds, as they go over the Amazonas, effectively gather water vapour, around 20 billion tonnes per day, which eventually precipitates in the form of rain across the La Plata Basin. This rainfall cycle or rainfall factory - effectively feeds an agricultural economy of around \$250 billion per annum in Latin America. The question arises. however: how much do Uruguay Paraguay, Argentina, and indeed the State of Mato Grosso in Brazil pay to the State of Amazonas for that vital input to their economy?

Because price is what you pay, and value is what you receive - and nature does not send any invoices. That is the economic invisibility of nature. But it's not just about the Amazonas, or indeed about rainforests. No matter what level you look at, whether it's the ecosystem level, the species level or the genetic level, we see the same problem again and again.

Our mindset as a society nowadays does not recognise public wealth. We are so mesmerised by the magic of markets that we fail to understand value unless it is expressed in economic (\$) terms and traded in some marketplace. And while some of us may inherently understand the value of nature, our systems, unfortunately, do not. The result is that decisions are being made at a policy level, at an executive level, and at a microeconomic level, which are completely oblivious of the huge value being exchanged all the time - the

is the real challenge. That brings me to two key questions for today: What insights can we get by "making the invisible visible"? What actions can these insights inform, and by whom?

As part of a study for The Economics of Ecosystems and Biodiversity project, we looked at what part of the economy is strongly dependent on nature in Brazil, India, and Indonesia, what fraction of GDP this represented and the connection between the economics of nature and the lives of the poor. Even though ecosystem services - benefits that flow from nature to humanity for free – were

not very big in percentage terms of GDP-10, 16, 21% respectively - if we measured how much they were worth to the poor, the answers were more like 90%, 84%, and 79%. So the results were clear - if we destroy nature, we destroy the livelihoods of the poor.

This is a key insight because you can't really have a proper model for development if, at the same time, you destroy, or allow the degradation of, the most important asset for that development - ecological infrastructure that ensures the supply of essentials to poor rural communities.

The reason we are losing nature boils down, in my mind, to one basic problem: our inability to perceive the difference between public benefits and private profits.

There's an example from Thailand where we found that because the value of a mangrove is not that much - it's about \$600 over that of a nine-year horizon used for measurement - compared to its value as a shrimp farm instead (\$9,600 of farm profits) so there has been a gradual trend to deplete the mangroves and convert them to shrimp farms. But, if you look at exactly what those profits are, almost 8,000 of those dollars are, in fact, subsidies. Furthermore. if you account for how much it costs to restore the land back to pro ductive use once salt & chemical

deposition have had their effects that answer is more like \$9,300. And then if you value the invisible benefits of the mangrove in terms of the storm protection, fisheries and fish nurseries, that answer becomes more like \$12,000. So, if you use the holistic lens of public wealth and not just the lens of private profits, you get a completelv different answer, which is that, clearly, mangrove conserva tion makes more economic sense than destruction

Insights like these explain the danger of viewing everything purely from a lens of "private profits" Because of the invisible economics of nature, you forget to account for huge "public losses" and make one wrong decision after another. This is a global story that manifests in many ways across our food systems and our fisheries, but it points to solutions. For example, instead of our current system of industrialised farming, which uses significant chemical fertiliser and pesticide inputs, natural farming is found to offer better solutions that do not harm nature, use less water, sequester carbon, and do not damage human and soil health. The community-managed natural farm ing system in Andhra Pradesh, which is now practised by over 600,000 farmers, is a proven way of providing higher yields and profits to farmers and healthy food to people with none of the serious damages caused by chemical farming

Will good economics solve every thing? I'm afraid not. But these few examples illustrate the importance of understanding and acting upon the invisible economics of nature In doing so, we can better understand the costs of "business as usual" and create the right conditions and policies to mitigate the longer-term damage to nature, the true wealth of future generations.

Gingerly

Gingerly is thought to come from a Latin root meaning "well-born". It has nothing to do with the other sort of root, the tropical spice called ginger. The Latin word was genitus, which is closely connected to other words associated with birth and reproduction, such as genital, congenital and progenitor. Strictly, genitus meant merely "born" or "begotten" (it's the past participle of the verb gignere, to beget) but seems to have implied a person who was born into a noble or wealthy family. After about 1000 years or so, this turns into the Old French gensor, meaning delicate or dainty (from gent, noble) and 500 years later still is first recorded in English in much its modern form. In its early days in English it was associated specifically with dancing or walking. If you did these things gingerly you took small elegant steps. In 1583 a writer referred to such dancers "tripping like goats, that an egg would not break under their feet". As you might gather from this, the word was then rather negative in tone, suggesting a mincing or effeminate way of moving. Our modern sense, of moving carefully so as not to injure oneself, cause damage or make a noise, first appears about 1600.

intelligence officials, and scholars convened in Germany in February for the annual

Munich Security Conference amid a raging land war in Europe and heightened geopolitical tensions. As a result, the focus was on traditional security threats. That is both understandable and disappointing.

While the first anniversary of Russia's invasion of Ukraine dominated the MSC discussions, along with mass migration and the advent of a new cold war, there was little interest in issues like adaptation to climate change and green finance. Given that the MSC's organisers defined the transformation of relations between the Global North and South as one of this year's themes, the lack of interest in mitigating the worst effects of global warming represents a missed opportunity. More importantly, it reflects a profound misunderstanding of the biggest threat facing our planet today.

This is not the first time that the intelligence community has downplayed a serious (albeit nontraditional) threat. Just as the 2019 conference ignored the risk of a pandemic, this year's conference largely ignored the systemic risks

food insecurity, and forced displacement - posed by climate change.

The climate-security failure

But unlike the then-hypothetical threat of a pandemic in 2019, climate change is already wreaking havoc around the world. Forty percent of S&P 500 companies experienced supply-chain disruptions in 2021, and last year's devastating floods in Pakistan are expected to reduce the country's rice production by 7% this year. This will exacerbate food insecurity and fuel political instability in countries that depend on Pakistan for rice imports, such as Afghanistan, Kazakhstan, and Kenya.

As extreme weather events become more frequent and intense, developing countries will likely be hit the hardest. Last year, flooding ravaged the port of Durban, South Africa, cutting off global supplies of cobalt and other commodities. A super typhoon smashing Taiwan or China's industrial heartland would cripple global semiconductor production, just as the devastating floods in Thailand in 2011 disrupted computer hard-drive supplies and caused the prices of cars, cameras, and phones to spike

According to the UN, international finance flowing to developing

programmes is 5-10 times lower than what is needed. And the gap is widening: developing countries' annual climate-adaptation needs are expected to increase to \$160-340 billion by 2030 and to \$315-565 billion by 2050.

Fortunately, governments have become increasingly aware of the urgent need to scale up financing for mitigation and adaptation. But they are not moving fast enough to shore up their supply chains ahead of inevitable disruptions. Last November, for example, the Climate Change Committee, which advises the British government, recommended that the UK offer financial support to countries on which it depends for crucial food imports. In a recent report, the Committee warned that nearly 20% of UK trade relies on climate-vulnerable countries and noted that a spike in foodimport prices would hit the country's poorest the hardest.

This analysis mirrors similar studies conducted in Germany and Sweden that called on developed countries to reduce their exposure to climate risks rather than focus on disaster response. But, at a time when governments are spending billions on bolstering their defence been sluggish at best, even though neglecting this existential threat could have disastrous consequences.

To survive our age of "polycrisis" -accelerating climate change, war, inflation, and the ongoing pandemic - we must make large-scale investments in mitigation and adaptation. Developed countries must also step up and ensure that lowerincome countries on the frontlines of climate change can strengthen their resilience. By funding initiatives like the African Development Bank's Adaptation Fund and the Africa Climate Risk Facility, the international community could provide much-needed protection for the world's most vulnerable populations.

Finally, climate change poses a huge risk to global stability. If we are to build long-term economic resilience, it is in the national-security interest of every country, including the world's richest, to support mitigation and adaptation efforts in the Global South. As we learned during COVID-19, no one is safe until everyone is safe.

The latest report by the US intelligence community states that China will continue its efforts to achieve his vision of making the country emerge as a 'major power' globally by undermining US influence. Xi is keen on 'the great rejuvenation of the Chinese nation' by 2049. The two neighbours have held a series of talks in recent years in connection with the border stalemate, but China has not done enough to reduce the trust deficit as well as hostilities. With Xi more firmly in the saddle, China won't hesitate from making provocative moves in retaliation for the growing closeness between India and the US. While keeping all communication channels open, New Delhi needs to be well prepared militarily as well as diplomatically — for any eventuality.

High temperature and fast wind, or together, are primary natural causes; mitigation measures must be directed against these causes. Nine out of ten causes of forest fire are attributed to human activities like open burns, vehicular use, industry and materials like burning cigarettes. It is of utmost importance to carry out campfires, if any, away from inflammable materials. All fire sources used should be completely extinguished, if possible with a bucket of \rightarrow water. Before forest fire incidents threaten to snowball out of proportion, it is imperative for the Centre to properly employ the two common technologies, Modern Resolution Imaging Spectro-Radiometer and the more sophisticated Polar Oribital Satellite based SNPP-to time.

She had reached the ED office from her father's official residence on Tughlak Road, located about 1.5 kilometres away, around 11 am. Official sources said during the



nine hours she spent at the ED office, she was confronted with the statements made by Hyderabadbased businessman Arun Ramchandran Pillai, an arrested accused in the case who allegedly shares close ties with her, apart

from those of a few others involved in the case. Kavitha's statement was recorded

under the Prevention of Money Laundering Act (PMLA), they said. Pillai, an alleged frontman of the "south group", was arrested by the ED earlier this week.

Pillai, meanwhile, has moved a city court accusing the ED of forging his statements in this matter. There was a heavy presence of Delhi Police and central paramilitary forces personnel for barricading the ED office as the supporters of the Bharat Rashtra Samithi (BRS) leader staged a protest, during both Kavitha's entry and exit from the ED office.

Kavitha recently asserted during a press conference here that she had done nothing wrong and alleged that the BJP-led Centre was "using" the ED as the saffron party could not gain a "backdoor entry" in Telangana.

Air hostess jumps to death

Pulwama widows' row turns violent

Jaipur, March 11: Scores of BJP leaders and party workers courted arrest here on Saturday as part of a protest against the Congress government's "insensitivity" towards the widows of Pulwama martyrs and manhandling of BJP MPs Kirori Meena and Ranjita Koli.

Raiasthan Police early Friday removed the widows of the three CRPF jawans killed in the 2019 Pulwama terror attack from the protest site outside Congress leader Sachin Pilot's house here and shifted them to hospitals near their respective residential areas.

Meena and Koli claimed that they were not allowed to meet the widows by policemen who also misbehaved and manhandled them. The widows have been protesting since February 28 and launched an indefinite hunger strike six days ago, demanding a change in rules so that their relatives and not just children can get government jobs on compassionate grounds.

While the protesters threw stones and broke barricades, police resorted to lathicharge to disperse them as they moved towards Chief Minister Ashok Gehlot's residence. The party held protests in Jaipur and all district headquarters.

In the state capital, the BJP leaders and workers took out a rally from the party headquarters. As some of them broke the barricades and tried to jump over them, they were detained by police and taken different police stations in

New Delhi, March 11: Exceeding the World Health Organization (WHO) ozone limit is associated with substantial increases in hospital admissions for heart attack, heart failure and stroke, according to a new study.

The first evidence making this association is published in the European Heart Journal. Even ozone levels below the WHO maximum were linked with worsened health, the study said. "During this three-year study, ozone was responsible for an increasing proportion of admissions for cardiovascular disease as time progressed," said study author professor Shaowei Wu of Xi'an Jiaotong

"It is believed that climate change, by creating atmospheric conditions favouring ozone formation, will continue to raise concentrations in many parts of the world. "Our results indicate that older people are particularly vulnerable to the adverse cardiovascular effects of ozone, meaning that worsening ozone pollution with climate change and the rapid ageing of the global population may produce even greater risks of cardiovascular disease in the future," said Wu. Ozone is a gas and the main air pollutant in photochemical smog.

Ozone pollution is different to the ozone layer, which absorbs most of the sun's ultraviolet radiation. Ozone pollution is formed when other pollutants react in the presence of sunlight.

These other pollutants are volatile organic compounds and nitrogen oxides which are emitted by motor vehicles, power plants, industrial boilers, refineries, chemical plants, and biomass and fossil fuel burn-

risk of cardiovascular disease. This study examined the association between ambient ozone pollution and hospital admissions for cardiovascular disease, it said.

Data on daily hospital admissions for cardiovascular disease during 2015 to 2017 in 70 cities in China were collected from the two main national health insurance systems. During the study period, the two databases covered approximately 258 million, 25.8 crore, people across the 70 cities, equivalent to more than 18 per cent of China's population

The types of cardiovascular disease included coronary heart disease, stroke and heart failure, plus subtypes such as angina, acute myocardial infarction, acute coronary syndrome, ischaemic stroke and haemorrhagic stroke.

Daily eight-hour maximum average concentrations of ozone, fine particulate matter (PM2.5), inhalable particles (PM10), sulphur dioxide, nitrogen dioxide and carbon monoxide were obtained for each city from the China National Urban Air Quality Real-time Publishing Platform, the study said.

During the study period, there were 64,44,441 hospital admissions for cardiovascular disease in the 70 cities and the average daily eighthour maximum ozone concentration was 79.2 microgram per cubic metre (ug/m3). Exposure to ambient ozone was associated with increased hospital admissions for all cardiovascular diseases studiedexcept haemorrhagic stroke, independent of other air pollutants.

Gandhinagar, March 11: The Gujarat Legislative Assembly has passed a resolution requesting the Centre to take strict action against the British Broadcasting Corporation (BBC) for "tarnishing the image and popularity of Prime Minister Narendra Modi" with its documentary on the 2002 riots in the state.

The controversial two-part series by the BBC titled 'India: The Modi Question' misrepresents the events of 2002 in a malicious and low-level attempt to tarnish India's image globally, BJP MLA Vipul Patel said in the House Friday while moving the resolution.

The documentary claims to have probed certain aspects of the riots, which took place after the Godhra train burning incident, when Modi was the CM of Gujarat.

Patel's resolution was supported by BJP MLAs Manisha Vakil, Amit Thaker, Dhavalsinh Zala and Home Minister Harsh Sanghavi. It was passed by voice vote in the absence of Congress MLAs who were expelled from the House earlier in the day. After passing the resolution unanimously, Speaker Shanker Chaudhary said the attempt by the BBC is 'reprehensible' and is 'condemned vehemently', adding the House passed the resolution to send its message to the Centre.

"India is a democratic country and freedom of expression is at the core of its Constitution, but that does not mean a news media car



act by abusing such freedom. said Patel while moving the private-member resolution in the second sitting of the House.

"If someone behaves or acts like this, then it cannot be taken lightly. BBC is losing its credibility and seems to be working with some hidden agenda against India and the Indian government. Hence, this House requests the central government to take strict action against the mindboggling findings shown in the BBC documentary," Patel said in the Assembly.

Through the documentary, there is a deliberate attempt to "tarnish the image and popularity of Prime Minister Narendra Modi' with an agenda to affect the country's intention to find top place globally, Patel said. He claimed that opposition parties in other countries support the government during such times, but this is not

the case in India, which allowed international organisations like the BBC to get the strength to carry out activities against the country.

Minister Sanghavi said the documentary was not just against Modi but against 135 crore citizens of the country. "The resolution brought by Vipul Patel for strict action is historic...Is it Modi's fault to realise the dream of making Gujarat a riot-free state? Many forces worked to ensure Gujarat does not get a stable government," Sangahvi said in his speech in the House.

He said the 'so-called intellectuals' started hurling one allegation after another against Modi after he took over as the PM. "As 2024 (Lok Sabha polls) approaches, they (opponents) have no other issue against Modi. They used the BBC to make a documentary." Sanghavi added.

Gandhinagar; March 11: Gujarat's law enforcement agencies have seized narcotic drugs worth Rs 4,058.01 crore and liquor valued at Rs 211.86 crore in the state in the last two years till December 31, 2022, the government told the Legislative Assembly Saturday.

More than 3 lakh persons were arrested for liquor and drugs related cases during this period in the state, where the sale and consumption of alcohol is prohibited, it said

Vadodara topped the list among the districts with the seizure of Rs 1,620.7 crore-worth drugs and liquor in two years, followed by Bharuch at Rs 1,389.91 crore and Kutch at Rs 1,040.57 crore, the government said.

"The state's law enforcement agencies seized drugs worth Rs 4.058.01 crore and liquor worth Rs 211.86 crore in two years till December 31, 2022," Minister of State for Home Harsh Sanghavi informed the House in reply to starred questions. The sale and consumption of liquor has been prohibited in Gujarat since its formation in 1960. The amount of IMFL seized stood at Rs 197.45 crore, beer Rs 10.47 crore, and country-made liquor Rs 3.94 crore. Together, agencies seized around 37 lakh bottles of liquor in two years, the data said.

The data relates to 25 out of the total 33 districts in the state. In terms of the seizure of IMFL, Ahmedabad district topped the list. Rs 28.23 crore worth liquor was seized in the district two years, followed by Surat with Rs 21.42crore, Vadodara Rs 14.61 crore, and Rajkot Rs 13.84 crore, it said.

A total of 3,39,244 persons were arrested with seized drugs and liquor in the last two years, while 2,987 others are wanted in these cases, the minister told the House. In response to a separate question, Sanghavi told the Assembly that 184.99 kg of narcotics worth Rs 924.97 crore was seized by the Anti Terrorist Squad (ATS) from the state's coastline and 32 Pakistani nationals, one Afghan and seven

Indians arrested in this connection. Further, 75 kg heroin worth Rs 375.50 crore was seized from Adani port at Mundra in two years till January 31, 2023 and two accused were arrested. In September 2021, the Directorate of Revenue Intelligence (DRI), a central agency, had seized around 3,000 kg of heroin, believed to have originated in Afghanistan and worth about Rs 21,000 crore in global markets, from two containers at the Mundra port. It is said to be the single largest heroin haul in India so far.

tizens secure their online accounts with strong alphanumeric passwords -- which is probably the most

fundamental step to ensure cybersecurity. Even the few who take the trouble of coming up with uneasy-to-crack passwords end up using the same (or similar variations) for several accounts. UP has a record number of cybercrime cases reported due to low level of cyber awareness among victims and law enforcement.

"Using weak and simple passwords is a recipe for data breaches, account takeovers, and other forms of cyberattack."

Cyber experts are of the opinion that while simple passwords are a big 'no', remembering a complex password for every account and website is virtually impossible.

According to cybersecurity firms, people still opt for poorly-thought out passwords like - '123456', 'password', and 'qwerty'. Some even go for '111111', '123456789'.

The negligence is nonplussing



at a time when password security issues account for 80 per cent of all data breaches globally, according to Verizon's 2022 Data Breach Investigations Report.

"People use weak passwords as they are easy to remember. Also, we are often required to change pass-

words frequently, and for convenience, people tend to choose simple variations of their previous passwords, which can also easily be guessed by hackers. One way to deal with the problem is using a password manager, which is a tool that stores all your passwords in a

secure, encrypted database. This way, you only have to remember one master password to access all your other passwords.'

"Another way to create strong and memorable passwords is to use a passphrase. A passphrase is a sequence of words or a phrase that you can easily remember, such as 'mycatiscool23'," said Upendra Upadhyaya, a cyber expert.

However, it is not advisable to save passwords in browsers like Chrome as today's malware programmes can steal saved Chrome and Firefox passwords easily. Using multi-factor authentication, which adds an extra layer of security, can make a huge difference.

Upadhyay said, "It is best to use long passwords with 10 characters or more with a good mixture of letters, numbers (lettersboth uppercase and lowercase), and symbols."

New Delhi, March 11: El Nino and La Nina are climate patterns in the Pacific Ocean that can affect weather worldwide. According to meteorologists, El Nino weather patterns this year may lead to deficit monsoon rainfall.

El Nino is the warm phase of the El Nino Southern Oscillation and is associated with a band of

India this year

warm ocean water that develops in the central and east-central equatorial Pacific, including the area off the Pacific coast of South America. La Nina refers to the periodic cooling of ocean surface temperatures in the central and east-central equatorial Pacific. It has the capacity to alter direction as well as velocity of the trade winds, which trigger the winter season in India. For the third month running, the US government weather agencies on Thursday reiterated the possibility of El Nino conditions developing in late summer this year, which could be an adverse signal for monsoon in

According to meteorologists, the anomaly in temperature and rainfall is the result of alterations in the weather patterns. The intensity as well as frequency of western disturbances was on the lower side this winter season. Climate experts said that anomalies of cool temperature in the Pacific waters are likely to dissolve that will further impact the Indian monsoon adverselv

Western disturbance is known to drive weather activities and



bring winter to Northwest India and the adjoining areas of Central India. Although January saw a good number of active western disturbances, they could not have any impact on the weather across the Indo-Gangetic plains.

An IMD official said that the on-

going trend of above normal maximum temperature can be attributed to the country's deficit rainfall that has been recorded for four consecutive months. Winter rains have been largely evading Northwest, Central, East and Northeast India.

The South Peninsula has been recording some rains on account of few low-pressure areas and depressions forming in the South Bay of Bengal, but their impact was confined to the southern parts only.

"La Nina is a climate pattern marked by colder-than-normal sea surface temperatures in the equatorial Pacific Ocean that tend to suppress global temperatures. However, global warming and changing climatic conditions tend to play a major role, which can be temporarily governed by these ENSO conditions but cannot completely outplay the effects of climate change," said G.P. Sharma, President, Meteorology and Climate Change, Skymet Weather.

second, because Islamabad has refused contacts following India removing Kashmir's special constitutional status.

Tensions between India and Pakistan spiked after New Delhi abrogated Article 370 of the Constitution to revoke the special status of Jammu and Kashmir August 5, 2019. India has categorically told the international community that the scrapping of Article 370 was an internal matter. It also advised Pakistan to accept the reality and stop all anti-India propaganda. India has told Pakistan that it desires normal neighbourly relations with Islamabad in an environment free of terror, hostility and violence.

Japan marks 12 yr anniv of tsunami, nuclear disaster

Tokyo, March 11: Japan Saturday marked the 12th anniversary of the massive earthquake, tsunami and nuclear disaster with a minute of silence, as concerns grew ahead of the planned release of the treated radioactive water from the wrecked Fukushima nuclear plant and the government's return to nuclear energy.

The 9.0 magnitude earthquake and tsunami that ravaged large parts of Japan's northeastern coast March 11, 2011, left more than 22,000 people dead, including about 3,700 whose subsequent deaths were linked to the disaster.

A moment of silence was observed nationwide at 2:46 pm, the moment the earthquake struck.

Some residents in the tsunamihit northern prefectures of Iwate and Miyagi walked down to the coast to pray for their loved ones and the 2,519 whose remains were never found.

In Tomioka, one of the Fukushima towns where initial searches had to be abandoned due to radiation fire fighters and police use sticks and a hoe to rake through the coastline looking for the possible remains of the victims or their belongings. At an elementary school in Sendai, north of Fukushima, participants released hundreds of colourful balloons in memory of the lives lost.



In Tokyo, dozens of people gathered at an anniversary event in a downtown park, and anti-nuclear activists staged a rally.

The earthquake and tsunami that slammed into the coastal Fukushima Daiichi nuclear plant destroyed its power and cooling functions, triggering meltdowns in three of its six reactors.

They spewed massive amounts of radiation that caused tens of thousands of residents to evacuate.

Over 160,000 people had left at one point, and about 30,000 are still unable to return due to long-term radiation effects or health concerns.

Many of the evacuees have already resettled elsewhere, and most affected towns have seen significant population declines over the past decade.

More than 1,300 migrants brought ashore in Italy

Rome, March 11: More than 1,300 migrants have been rescued in three separate operations off the southern tip of Italy, the coastguard said Saturday, two weeks after at least 74 people died when their boat hit rocks near the coast.

Growing numbers of migrant arrivals have piled pressure on Italy's conservative government, which took office last October promising to reduce the flow only to see a sharp increase in such landings this year from both North

Africa and Turkey. The coastguard said one of its vessels had taken 500 migrants off one boat more than 100 miles (160 km) out to sea, and subsequently took

them to the city of Reggio Calabria. A further 379 migrants were removed from a separate vessel in the same vicinity and will be brought to land shortly.

Another packed fishing boat carrying 487 migrants was escorted into the Calabrian port of Crotone, lashed to a tug to help give it stability. More than 17,000 people have

reached Italy so far this year, including around 4,000 this week, compared to 6,000 in the first 2-1/2months of 2022. Hundreds have also died trying to cross the Mediterranean and reach Europe.

MUTINY AT THE BBC Lineker row heats up in UK

London, March 11: Britain's BBC was forced to axe much of its football coverage Saturday as presenters refused to work in a show of solidarity with Gary Lineker. as a row over freedom of speech escalates, throwing the national broadcaster's programming into disarray.

Former England soccer captain Lineker, the BBC's highest paid presenter and the anchor of the football highlights programme "Match of the Day", was taken off air by the broadcaster Friday after he criticised Britain's migration policy earlier in the week.

The row has sparked a debate over freedom of speech and the BBC's neutrality and risks pulling the government into a dispute with one of the country's highest profile

and most popular sports presenters. The BBC said Saturday's edition of "Match of the Day" would

"focus on match action without studio presentation or punditry." Two other BBC programmes, "Football Focus" and "Final Score",

will not air Saturday after presenters including Alex Scott, Jason Mohammad and others said they would not work, while BBC sports radio was hit by walkouts from Mark Chapman and others.

Lineker, 62, had earlier in the

week taken to Twitter to describe new government legislation on migrants as a "cruel policy directed at the most vulnerable people in language that is not dissimilar to that used by Germany in the 30s." Before he can return to presenting, the BBC has said there had to be an agreed position on Lineker's use of social media, prompting accusations from rival politicians and media commentators who said the BBC was bowing to political pressure.

The broadcaster is committed to being politically impartial but has come under pressure from the Conservative government in recent years who accuse it of political bias.

Lineker, who has hosted the BBC's flagship football show for over 20 years, did not say anything about the dispute to waiting media when he left his home Saturday.

Adani seeks to sell stake in Ambuja Cement for \$450mn

New Delhi, March 11: Gautam Adani is seeking to sell a stake in Ambuja Cement for about \$450 million, the Financial Times reported Friday, citing people familiar with the matter.

Adani Thursday made a formal request to international lenders to sell 4% to 5% in Ambuja, his cement business, the report said. The Adani Group did not immediately respond to a Reuters request for comment.

The embattled Adani Group last year acquired Holcim AG's cement businesses in India – Ambuja Cements and ACC Ltd- for \$10.5 billion, its largest-ever acquisition.

Adani's latest move comes as the group seeks to rebuild investor confidence and allay concerns about its debt by pre-paying loans, in the aftermath of a scathing US shortseller report. Hindenburg Research's report alleged stock manipulation and improper use of tax havens, and flagged "substantial" debt levels, which the group has denied.

Gautam Adani and his family have prepaid all borrowings backed by his conglomerate Adani Group's shares, senior executives told investors at a meeting in London, Bloomberg News reported this week.

BILLIONS STRANDED SVB largest US bank to fail since '08

US banks have lost over \$100bn in stock market value over the past two days, with European banks losing around another \$50bn in value

Washington, March 11: Startupfocused lender SVB Financial Group became the largest bank to fail since the 2008 financial crisis on Friday, in a sudden collapse that roiled global markets, left billions of dollars belonging to companies and investors stranded.

California banking regulators closed the bank, which did business as Silicon Valley Bank, Friday and appointed the Federal Deposit Insurance Corporation (FDIC) as receiver for later disposition of its assets.

Based in Santa Clara, the lender was ranked as the 16th biggest in the US at the end of last year, with about \$209 billion in assets. Specifics of the tech-focused bank's abrupt collapse were a jumble, but the Fed's aggressive interest rate hikes in the last year, which had crimped financial conditions in the start-up space in which it was a notable player, seemed front and center.

As it tried to raise capital to offset fleeing deposits, the bank lost \$1.8 billion on Treasury bonds whose values were torpedoed by the Fed rate hikes.

New Delhi, March 11: India and Australia Saturday expressed their commitment for concluding the negotiations for expanding the scope of existing free trade agreement by the end of this year with an aim to push the bilateral trade to \$100 billion.

The issue came up for discussions during the meeting of joint ministerial commission between commerce and industry minister Pivush Goval and his Australian counterpart Don Farrell. Farrell is accompanying Australian Prime Minister Anthony Albanese who is here on an official visit.

On December 29, last year India and Australia implemented an economic cooperation and trade agreement (ECTA) and are now negotiating to expand its scope for a comprehensive economic cooperation agreement (CECA). "ECTA was the first stage of our economic engagement. We are now entering into phase-2 of our discussions where we are looking at much wider ambit of subjects and taking this into a CECA," Goval told reporters here. After the first India-Australia summit talks here March 10 on a range of key issues, Albanese has said that both sides are looking at firming up the ambitious CECA by 2023 while a joint statement mentioned that the two prime ministers tasked the concerned officials to expedite the conclusion of a Migration and Mobility Partnership Arrangement (MMPA)

Sebi resolves 2,672 complaints through SCORES platform

New Delhi, March 11: A total of 2,672 complaints against companies and market intermediaries received through capital markets regulator Sebi's SCORES platform were disposed of in February, according to Sebi data.

At the beginning of February, as many as 2,603 complaints were pending and 2,321 fresh complaints were received during the month, the data released by Sebi Friday showed. These complaints were related

to refunds, allotment, redemption and interest, among others.

The regulator noted that there were seven complaints as of February 2023, which were pending for more than three months. These complaints were related to research analyst, investment adviser, corporate governance/ listing conditions, non-demat, remat and transfer/dividend/rights/redemption.

The average resolution time for a complaint is 30 days, it added. In a separate public notice, Sebi mentioned six entities against



whom complaints have been pending for more than three months on SCORES as of February 2023.

These are Grovalue Financial Services, Analysewise Investment Advisors, Kaushal Mehta. Caledonian Jute and Industries, International Housing Finance Corporation and Brightcom Group Ltd.

SCORES is a redressal grievance system that was launched by the Securities and Exchange Board of India (Sebi) in June 2011.

TAX COLLECTION **REACHES ₹13.73L-CR**

NET DIRECT TAX MOP-UP HAS REACHED 83% OF REVISED ESTIMATE FOR FY23

New Delhi, March 11: Net direct tax collection so far this fiscal grew 17 per cent to reach ₹13.73 lakh crore, which is 83 per cent of the revised target for the full financial year, the Central Board of Direct Taxes (CBDT) said Saturday.

The growth in direct tax mopup, which comprises personal income tax and corporate taxes, was driven by PIT collections.

On a gross basis, the collection grew 22.58 per cent to ₹16.68 lakh crore. Refunds amounting to ₹2.95

lakh crore have been issued during April 1, 2022 to March 10, 2023, which are 59.44 per cent higher than refunds issued during the same period in the preceding year.

Direct tax collection, net of refunds. stands at ₹13.73 lakh crore which is 16.78 per cent higher



than the net collections for the corresponding period of last year.

This collection is 96.67 per cent of the total budget estimates and

83.19 per cent of the total revised estimates of direct taxes for the financial year 2022-23, the CBDT said in a statement.

After adjustment of refunds, the net growth in CIT (Corporate Income Tax) collections is 13.62 per cent and that in PIT (Personal Income Tax) collections including STT (Securities Transaction Tax) is 20.06 per cent, it said.

Ahmedabad, March 11: Shubman Gill gave ample display of his immense talent with a stylish hundred (128, 235b, 12x4, 1x6) but India's batting unit didn't fully press home the advantage, ending the third day at 289/3 against Australia in the fourth Test, here Saturday.

Gill batted for nearly six hours for his knock to justify his selection in playing XI ahead of KL Rahul but India scored only 256 runs in 90 overs. The hosts are still 191 runs behind Australia's first innings total of 480.

Leading the series 2-1, India need a 3-1 series win to qualify for the World Test Championship final. If India lose this match and Sri Lanka win their ongoing series against New Zealand 2-0 then the island nation will qualify for the WTC final against Australia.

In case India play a draw, and Sri Lanka fail to win 2-0, the WTC final will be between India and Australia in June at the Oval.

All eyes will be on Virat Kohli (59 batting, 128b, 5x4), who looked purposeful and confident during his two
