SC rebukes Centre over OROP scheme

New Delhi: The Supreme Court said Monday the Ministry of Defence cannot take law in its own hands by issuing communication on payment of One Rank-One Pension (OROP) arrears in four installments. A bench of Chief Justice DY Chandrachud and Justices PS Narasimha and JB Pardiwala asked the Ministry to immediately withdraw its January 20 communication which said OROP arrears will be paid in four installments. The bench said the Defence Ministry's January 20 communication was completely contrary to its verdict and it cannot unilaterally say it will pay OROP arrears in four installments.

HSBC acquires UK arm of SVB for £1

London: The HSBC said Monday it is acquiring the UK subsidiary of Silicon Valley Bank (SVB) for £1. "This acquisition makes excellent strategic sense for our business in the UK,' HSBC CEO Noel Quinn said in a statement. The move comes after US authorities moved to shore up deposits and stem any wider fallout from the sudden collapse of its parent, tech start-up lender Silicon Valley Bank. As of March 10, Silicon Valley Bank UK Limited had loans of around £5.5 billion and deposits of around 6.7 billion, HSBC said.

Police bust cough syrup gang in Bolangir; 37 held

BANK ACCOUNT OF COMPANY WITH ₹2CR FROZEN

Bolangir, March 13: In a major breakthrough, Bolangir police have busted an inter-state organised cough syrup racket. Officials said Monday that 'Eskuf' cough syrup worth ₹40 lakh were seized and 37 persons arrested in this connection Sunday.

Police have also frozen ₹2 crore in the bank account of M/s Daffodils Drugs Pvt Ltd, the distribution firm for the cough syrup. Bolangir SP Nitin Kushalkar said Monday

during a press conference at the Model Town police station here that members of the group were spread across the country from Himachal Pradesh to West Bengal.

In the first phase, an anti-drug operation team under direct supervision of Kushalkar raided various places and seized 12.960 bottles of cough syrup and nabbed 37 persons involved in the illegal trade. Among those arrested, two are from Uttar Pradesh, five from Cuttack district, six from Bargarh district and 24 from Bolangir district. Contd...P4

New Delhi, March 13: Use of sleep medication and inability to fall asleep quickly are associated with an increased risk of developing dementia over a 10-year period, according to a study published in the American Journal of Preventive Medicine'. Scientists have found a significant link between three measures of sleep disturbance and the risk for developing dementia, a neurodegenerative disease. Dementia can severely cause disorders in the brain that may lead to forgetfulness and also limit social skills.

The researchers associate sleepinitiation insomnia (trouble falling asleep within 30 minutes) and sleep



medication use with higher risk for developing dementia. They also found that people who reported having sleep-maintenance insomnia (trouble falling back to sleep after waking) were less likely to develop dementia.

tant professor at 'SUNY Upstate Medical University' in the US.

The research is the first to examine how long-term sleep disturbance measures are associated with dementia risk using a nationally representative US older adult sample.

Previous research has associated rapid eye movement (REM) sleep behaviour - which is thought to play an important role in memory and learning - less than five hours of sleep, and the use of shortacting benzodiazepines with cognitive decline. The findings for sleep-maintenance insomnia support other recent studies using smaller, separate data samples.

This study used 10 annual waves (2011-2020) of prospective data from

the National Health and Ageing Trends Study (NHATS), a longitudinal panel study that surveys a nationally representative sample of Medicare beneficiaries aged 65 years and older within the US.

The study included only people who were dementia-free at baseline in 2011. There is no cure for dementia and recent pharmaceutical approaches to treat dementia have had limited success, pointing to the importance of preventive approaches to dementia.

"By focusing on the variations in sleep disturbances, our findings can help to inform lifestyle changes that can reduce dementia risk," study co-investigator Margaret Anne Lovier from 'SUNY Upstate Medical University' pointed out.

546 PRISONER DEATHS IN LAST 10 YEARS: BEHERA

Bhubaneswar, March 13: A total of 546 prisoners, including those facing trial have died in different jails of Odisha in the past 10 years, MoS for Home, Tusharkanti Behera informed the state Assembly Monday. Behera informed about the figures

while giving a written reply to a question by BJD MLA Soumya Ranjan Patnaik. He said deaths of 200 prisoners and 346 undertrial prisoners have been reported in different jails of the state from 2013 to 2022. While the deaths of 11 prisoners and 35 undertrial prisoners were registered in 2013, the figures stood at 24 and 49 in 2022. As per the statement of the MoS, 43 prisoners including undertrials

died in 2014, 46 in 2015, 48 in 2016, 47

in 2017, 51 in 2018, 53 in 2019, 78 in 2020 and 61 in 2021. Apart from the above-mentioned demises, 51 custodial deaths were also reported in Odisha during the last 10 years.

Notably, last month, the State Cabinet had decided to provide compensation to the next of kin of prisoners who die inside the jails in the state. The compensation was announced following recommendations of Orissa High Court and National Human Rights Commission (NHRC).

In another reply, Behera said 1,57,432 Bangladeshi refugees are residing in 11 districts of Odisha. The Minister said that Malkangiri district has the highest (1,04,233) Bangladeshi refugees, followed by 46,848 in-Nabarangpur and 4,653 in Khurda.

A meritorious student, who devoted himself to social activities, imbibed the thought of how the future generation can reap the benefits of the efforts through ancient Gurukul system of education and finally started Times Scholars Gurukul (TSG) in 20th century. Chairman-cum-founder of the institution Sarada Prasad Mishra shares with **Orissa POST** his life's ups and downs as he succeeds in helping the institution reach the zenith of success...

How could the imagination of an educational institution take birth when you were engaged in social work? We were quite familiar

with Bhubaneswar as it is my birthplace. I was very much involved in political and social activities along with my studies. Gradually, certain things like creating something new struck me which triggered the birth of a different kind of educational institution. The first-ever Gurukulbased educational institution started in the City at a time when the 20th century educational system was on the wane. The institution started after much deliberations, difficulties and hard work.

How useful is the present education system to the student community?

The system of educating the children is heading in a different direction. Both parents and institutions are worried about good marks. They are never concerned about the fact that skill development is equally essential apart from sheer theoretical knowledge. Good career apart, parents/guardians want their children to be good human beings. Reform in education sector is very much essential failing which the future of the students, in race for good marks, may be pushed into uncertainty. We have to impart the kind of education which the child wants.

Jayanarayan for more clarity on 5T

Bhubaneswar: Senior BJP leader Jayanarayan Mishra Monday raised questions over the state government's flagship 5T initiative, claiming that not much has been revealed so far about its implementation and accomplishments. During the Zero Hour in the Assembly, the leader of opposition also wondered if the initiative, headed by Chief Minister Naveen Patnaik's private secretary VK Pandian, has been floated to undermine the authority of other departments in the state. 5T is a governance model in Odisha, based on teamwork, transparency, technology and time leading to transformation. Most of the departments are now covered under the initiative. "What is 5T? Is it a department? If so, where is its office, at Raiiv Bhavan, Lok Seva Bhavan or Kharavela Bhavan? Was it launched to diminish the authority of other departments? The Odisha government should clarify it," the BJP leader stated. Replying to Mishra's question, government chief whip Prasant Muduli said 5T is not a department, but Chief Minister Naveen Patnaik's vision.

S&ME commissioner-cum-sec retary Aswathy S presented briefs of the budget while enunciating the course of the ongoing initiatives.

"We are also initiating counselling sessions for out of school children over the age of 17 with the support of Skill Development and Technical Education department. The government is prioritising to fill up vacancies through recruitment of over 50,000 teachers in high schools and higher secondary schools," she said.

President of the union Javanta Das said, "The memorandum has been drafted to draw the attention of the state government to the plight of unemployed citizens in the countryside. Over 30 lakh rural labourers have migrated from Odisha to other states in the recent past in search of employment opportunities." He said that such a high number of rural labourers are migrating because MNREGA wages are confined to ₹222 per day and minimum wages for unskilled labourers in Scheduled Employment is ₹337/- per day only in Odisha.

Bhubaneswar, March 13: Expressing concern over the sudden jump in incidents of forest fires in Odisha, Union Minister Dharmendra Pradhan Monday urged Union Forest Minister Bhupender Yaday to prepare a longterm action plan for preventing and mitigating such fires in future.

Pradhan met his cabinet colleague in New Delhi Monday and submitted a letter in this regard.

He urged Yaday to set up an empowered committee with representatives from the central and state forest department officials, environmentalists, and forest conservationists to come up with a detailed long-term action plan for preventing and mitigating future forest fires in the state.

In his letter, Pradhan said Odisha has recorded 871 large forest fires since November 1, 2022, the beginning of the fire seasons. It is followed by Andhra Pradesh (754), Karnataka (642), Telangana (447) and Madhya Pradesh (316)

As on today, there are 1,840 cases of forest fires in the state, out of which 153 have been large scale fires. Further, in the last 24 hours, a massive 1,625 incidents of forest fires have been reported in the state, he pointed out.

Stating about 35 percent of all forest fires in the country are being reported from Odisha, Pradhan said Odisha has reportedly lost 4,000 hectares of forest area due to forest fire in the last four months.

Potable water dream for 50.55% households: Study **NEARLY 6,675 (56.12%) VILLAGERS USE CONTAMINATED WATER FOR CONSUMPTION**

Bhubaneswar; March 13: Over 40 per cent households in 15 districts of the state lack access to safe drinking water, according to a study, whose findings were revealed Monday.

Undertaken by Atmashakti Trust, Odisha Shramajeebee Mancha and Mahila Shramajeebee Mancha between January and mid-February this year. the study reveals that out of 9,37,152 households in 9,856 villages under 866 gram panchayats of 89 blocks in 15 districts, 3,68,694 (40.55 per cent) lack access to safe drinking water.



As per the survey, conducted in Malkangiri, Koraput, Rayagada, Kandhamal, Nayagarh, Nuapada, Kalahandi, Bolangir, Sundargarh, Jharsuguda, Sambalpur, Gajapati, Boudh, Nabarangpur and Deogarh, out of 32,960 tubewells/hand pumps

surveyed, 12,481 (40.93 per cent) were defunct. Also, of 12,478 stand posts, 6,066 (48.6 per cent) have gone kaput.

Nearly 6,675 (56.12 per cent) villagers use contaminated water for consumption. While 28.51 per cent

villagers use muddy water, 29.55 per cent have iron in their drinking water. Out of 9,37,152 households over 15,000 are deprived of regular drinking water sources and are fully dependent on streams, ponds, and chuans (excavated subterranean water).

"Despite implementation of Jal Jeevan Mission and Basudha schemes, safe drinking water continues to elude many rural areas of Odisha. The state government should expedite the implementation of its schemes to address water issues faced by the people," said Ruchi Kashyap, Executive Trustee of Atmashakti Trust.

Such forest fires not only cause irreparable damage to the land's flora and fauna but also pose a threat to tribal and farming communities living on the periphery of forests. It destroys their livelihoods earned from MFPs such as timber, mahua flowers, kendu leaves, and medicinal plants, he said.

Furthermore, it contributes to severe air pollution over urban dwellings and rising temperatures in the state.

"It is imperative to address these ongoing forest fires immediately with swift and coordinated action between the central and state forest departments while coming up with a long-term plan for prevention and mitigation of further forest fires in Odisha." read the letter He suggested Yadav to involve the

local community and rejuvenate the existing water bodies inside the forests to control the fires.

Though the forest and fire de partment have been provided with equipment to deal with forest fires, its reported that most men have not received training on their usage, he alleged. Pradhan further said that helicopters and airborne methods needed to be adopted for dousing the forest fires in some parts as most of these forest areas are still inaccessible to fire vans on ground.

Moreover, the Education minister urged Yaday to convene a meeting with officials of Forest Ministry and the Odisha government for launching urgent measures to contain and subdue the forest fires in the state.

A renowned educationist and a true edupreneur, **Dr Tejaraj Patra** in his conversation with **Orissa POST** says it is still not easy for him to grasp the fact that the same student is now taking the responsibility of hundreds of students, not only as a teacher, but also as their guardian. Excerpts:

- How has been the journey of Newton College of +2 Science so far?
- During my ISc/ (intermediate), I used to spend my time giving private tuitions along with studies. I developed a knack for teaching while passing class after class. After long 30 years of teaching experience and fuelled by the drive to teach, then came the inception of a different kind of institution. Since the establishment of Newton College in 2007, the institute has nurtured a number of meritorious and bright students. As the founder of the college I take pride in the role it has played in moulding those minds.
- What is your take on the National Education Policy (NEP)?

The NEP has touched upon all aspects of education. We hope that it will bring about a shift in tomorrow's education sector making it qualitatively superior. We expect that the policy's implementation will be a welcome step across levels. As an educationist, I welcome the NEP and take its new ways of imparting education as a challenge.

How do you see your opponents in this competitive field?

Competition and competitors are omnipresent. But it is the institute's responsibility to face the competitors. We never count anybody as opponents. Rather, it has been our policy to do things differently, and work hard to bring laurels to the institute keeping faith in between the online and offline modes of education? The medium doesn't matter

as long as the quality of education is optimum. But, the increased distance between the teacher and students does have its cons. Although, the same topics are taught in both mediums, physical presence in classroom is more effective as it comes with the educator's direct supervision. It also makes the student disciplined, which doesn't happen online.

What do you think is the reason behind the growing interest of students and guardians in +2 college education?

Post secondary schooling, the +2 performance of a student carries a lot of importance in the long run. Even the guardians who have high hopes for their kids put much stress on +2 education.

Over 50 students, teacher injured in honeybee attack

GMDC bags 2 coal blocks in Odisha

New Delhi, March 13: Mining PSU Gujarat Mineral Development Corporation (GMDC) Monday said it has emerged as the highest bidder for two coal blocks in Odisha in the recently concluded commercial mine auction.

The PSU won the bids for Burapahar block having a geological reserve of 548 million tonnes (MT) and the Baitarani (West) block having geological reserve of 1,152 MT.

With this development, GMDC's additional 21 million tonne per annum (MTPA) will fuel the country's demand for energy, the PSU said in a statement.

"We are committed to utilising our resources and expertise to develop these blocks to their fullest potential while ensuring the highest standards of safety and environmental sustainability," GMDC Managing Director Roopwant Singh said in a statement.

This expansion will help the PSU go beyond the geographical boundaries of Gujarat, GMDC said.

The state-owned company has five operational lignite mines located in Kutch, South Gujarat, and the Bhavnagar region. GMDC is

Dip in groundwater level sparks alarm in Paradip

VILLAGERS BUY PACKAGED DRINKING WATER TO MEET THEIR NEEDS

Paradip, March 13: Rapid industrialisation and modern lifestyle have led to an acute water crisis in this port town due to a sharp decline in groundwater level, a report said Monday.

The water crisis is not limited to Paradip only but its impact is also being felt in Nuagad and Paradipgad panchayats adjoining the port town. The seriousness of the water crisis can be gauged from the fact that over 90 per cent of the families in these areas are purchasing packaged drinking water (40 litre jars) to meet their water needs as the tube wells have stopped pouring out water.

The sharp decline in groundwater level has sparked alarm among the residents and the authorities. However, the authorities are yet to take up any concrete step to alleviate the suffering of the people.

Some of the functioning tube wells give out water that is unfit for consumption as it is saline and rich in iron content. A villager Pramod Jena of Nuagad village alleged that the water is not only unfit for consumption but leaves stain on clothes and other materials. Clothes of the villagers turn red and black when they try to wash them under the tube well.

According to Jena, Nuagad village comprises 475 families where almost every family is purchasing packaged drinking water for consumption. A woman shopkeeper Soudamini Pradhan said that she sells a van load of water bottles daily in the village.

Another villager Dillip Swain said he had a 1,000 feet deep tube well in his house which his family members were using since a long time. However, water of the tube well has become unfit for consumption since last year as it gives off a pungent smell, a strong metallic and salty taste. The situation is almost same in Paradipgad market area where one can get fresh water only after digging 1,400 feet down. In past, there were as many as 10 rivers and creeks in between these two panchayats. However, these water bodies have been buried after rapid industrialisation took place in the area. Small creeks like Haldipani, Nayanjori and Samukatimunda have vanished

from the area. The only manmade water body Taladanda canal is present which is supplying water to the industrial plants.

The sharp decline in groundwater level is attributed to rampant use of groundwater by large industrial plants in the port town.

A junior engineer Manas Murmu of public health engineering organisation (PHEO) confirmed the development. He said that water level is going down day by day since last three years and regretted that they can do nothing in this regard.

Senior engineer Gangadhar Sethy of Paradip Port pinned the blame on modern lifestyle. He said that before 2000 most people were attending to their daily chores in rivers and other water bodies in the area. A person then was using only five litre of water on a daily basis while now a person uses 220 litre of water to meet his daily needs. He said that people only are responsible for this development while warning that the situation might get worse in future.

SHIELD AGAINST RUINOUS COSTS

t was not like there was no cure. It was not like nothing could be done. It was just a matter of money, and there wasn't enough of it to save Palak (name changed), age 8. Palak was that child who beamed her big smile whenever she saw you. She loved to sing nursery rhymes and play clapping games. And then, she was diagnosed with blood cancer.

It would cost Rs 15 lakh for a cord blood transplant that would ensure that her bone marrow started to make healthy cells instead of cancerous ones. Medicine can now effectively cure not just blood cancers but many serious conditions The costs of these treatments can be high, however. In many areas of Mumbai, Rs 15 lakh won't even buy a small room. But for more than 95% of Indians, not just the very poor, this sum is as out of reach as a flat in the city – just

like it was for Palak's family. But families are not meant to pay these large sums. Health insurance is. That's why it exists. Health insurance is like the extra hull on the Indonesian fishing boat, the Jukong, which 2000 years ago allowed them to sail across the Indian Ocean all the way to Australia. The additional hull gave them peace of mind even when not using it because they knew it could stabilise their boat and prevent it from sinking when the ocean turned fierce.

For every family to have this kind of protection regarding their health in the form of insurance. lakhs of families would have to come together to share in these risks. This is achieved only when everyone is able and willing to buy health insurance and pay the requisite premia. This does not happen naturally, not even in more developed countries. Therefore, governments need to step in to help. Recognising this, most state governments in India already offer free health insurance plans, which are paid for by taxes. These plans

If everybody is automatically enrolled, the need to check and recheck people's identity and enrolment status – a major problem in the current system - will also disappear. Covering the entire population will also allow state governments to use their purchasing power to negotiate lower prices for the most expensive conditions. Keeping prices for the highest-cost conditions at the largest hospitals in check will not only help the plan but also have a cascading effect on all healthcare costs, make ing it much cheaper for them to, eventually, build a healthcare system which covers all conditions.

When the massive shock of blood cancer hit Palak's family, they had no choice but to let her and all of their joy go. The tragedy was that Palak did not have to die. Medicine already had the answers they needed. When it's not medicine falling short but money, the new insurance plans can prevent tragedies like Palak's.

This is a fundamentally different way of addressing the persistent worries that any family suffers from - of a disease that can ruin them financially or force them let a loved one die just because a cure is unaffordable. In other words, such an approach seeks to address the really "big" problems through insurance and works towards solving the "smaller" ones within the healthcare system. It is true that we cannot ignore the more common ailments which too, cause death and devastation in families, but separating the rare high cost treatments from the more routine ones may be one way out of the impasse where both are poorly handled and people regularly die because health is out of their reach.

Trump Vs Pence

elective leaks of classified documents to a chosen media outlet to whitewash ugly truths has, by now, become a well known tactic of powers that be. Misinformation campaigns are launched in order to enhance the image of political leaders in the saddle or ones trying to make a bid to capture power. It is normally left to the people to sift facts from fiction and come to their own conclusions. But, rarely has a key political leader taken upon himself the task of challenging the doctored narrative dished out in this manner as has been done by former US Vice President Mike Pence who tore into his former boss, Donald Trump, 11 March.

Pence chose a well known platform - the Gridiron Club's annual dinner - to launch by far the most scathing attack against Trump for his exhortation to rioters to vandalise Capitol Hill 6 January, 2021 to overturn the verdict of the people in favour of the Presidential candidate Joe Biden. The dinner is a Washington tradition. The Gridiron Club, founded in 1885, just after the election of Grover Cleveland, hosted dinner for every President since then at least once a year. Fifteen journalists formed the club and instituted the formal dinner where top political leaders are expected to deliver speeches laced with humour and wit, cracking jokes at the expense of their rivals and co-travellers. Pence did stick to the format, but cleverly used the platform to strike a sombre note taking on Trump.

This immediately triggered speculation about his motive. Questions are being asked whether he wants to run for Presidency next year as a Republican candidate replacing Trump or is he challenging the narrative being given by pro-Trump Fox News to exonerate the mob that ran amok at Capitol Hill at the behest of Trump.

If Pence's intention is to call a spade a spade, he timed it well since he not only spoke before journalists, but also sought to expose the disinformation campaign by the pro-Trump media organisation. A well known anchor of a show hosted by the media outlet had recently got permission from the House Speaker Kevin McCarthy to use 40 hours of footage on the violence at Capitol. The permission itself is controversial since McCarthy turned down the same request made at the same time by several other media outlets. The Fox News host used the footage selectively to project the perpetrators of the crime as a peaceful mob enjoying a "tour" of the Capitol. With the doctored evidence he has called into question the narrative of reckless violence presented by the Democrats.

On that fateful day, it was Pence's duty to certify the election results in favour of Biden. Trump was instigating him not to do so. But, Pence went ahead with his task and the rioters were baying for his blood. He had to be whisked away to safety by the security. Referring to that incident, Pence told journalists at Gridiron Club that he had not been "afraid", but "angry". "President Trump was wrong. I had no right to overturn the election and his reckless words endangered my family and everyone at the Capitol that day. And I know that history will hold Donald Trump accountable," he declared.

Nor did Pence leave any one in doubt about his rejoinder to the Fox News host's attempt to rewrite the incident. He said, "It was not as some would have us believe a matter of tourists peacefully entering the building. Tourists do not injure 140 police officers, tourists do not break down doors to get to the Speaker of the House or threaten public officials."

These are strong words and solid evidence, indeed, as the death of one police officer and serious head and other injuries of scores of security personnel trying to protect the Capitol are incontrovertible facts that undermine the pro-Trump narrative.

Now, the question is whether Pence's diatribe against Trump after maintaining silence for a considerable period of time is prompted by his desire to run for Presidency. He did give broad hints at the dinner speech that he is willing to do so. He seems to project himself as a sober, balanced Republican who will not be partisan like Trump. He said so in so many words.

It looks like Pence is testing waters and scouting for the support of fellow Republicans after the sentence given by the court recently to the main culprit of the violence proved Trump's exhortation of the rioters is indefensible in the court of law. If he finally takes the plunge, the coming Presidential election will get a new twist.

Gobbledvaook

his is a truly maverick word, not only because it is surprisingly modern and also one whose genesis we can pin down to the day, but also because a maverick coined it -Maury Maverick, a Texan lawyer who was at various times a Democratic Congressman and mayor of San Antonio. He used the word in the New York Times Magazine on 21 May 1944, while he was chairman of the US Smaller War Plants Committee in Congress, as part of a complaint against the obscure language used by his colleagues. His inspiration, he said, was the turkey, "always gobbledy gobbling and strutting with ludicrous pomposity". It met a clear need for a word with which to castigate unintelligible language, especially jargon or bureaucratese, and quickly became part of the language. It is sometimes abbreviated slightly to gobbledygoo. Word coining runs in the Mayerick family, since Maury Mayerick's grandfather, Samuel Maverick, a Texas rancher, was the inspiration for maverick, originally an animal not branded to identify its owner (because Sam Maverick didn't brand his own herds), later an unconventional person, and later still a politician who stands aside from the herd, refusing to conform to the party line.

Gobemouche

English borrowed this potentially useful word from French about two centuries ago, though it has long since abandoned it again. A search of newspaper archives suggests that it's used nowadays merely as a rare word with which to stump contestants in US spelling bees. The French continue to use it, hyphenated, for the bird that we call a flycatcher, appropriately so since it is made up of gober, to swallow, and mouche, a fly. In French it also means a credulous person who accepts everything said to him as the plain truth. Only the latter sense came over into English: These people are great gobemouches; they always report the most incredible things (Travels in the Great Desert of Sahara, in the Years of 1845 and 1846, by James Richardson, 1848). The inescapable image is of a naive individual thunderstruck by the world around him, perpetually open-mouthed in astonishment and ready to swallow whatever came his way, whether flies or tall tales. This sense of the word is said to have been popularised in French through a play of 1759 by Charles Favart, La Soirée des Boulevards, which featured a character named Gobemouche. It's tempting to see a connection between gobemouche and gob, that infelicitous monosyllable which has been a British dialect and slang term for the mouth since the sixteenth century. The latter is most likely from the Gaelic and Irish word for a beak or mouth; if so, then there's indeed a link, as the French gober originated in the related pre-Roman Celtic tongue called Gaulish.

connected by flows of intangibles, services, and talent. From the cloudbased applications that companies use to manage customer relations to the research that led to the development of COVID-19 vaccines, knowledge is binding our world together.

Global flows associated with know-how have taken the baton from manufactured goods, resources, and capital - the primary drivers of interconnection until the late 2000s. Between 2010 and 2019, international trade in services. intellectual property, and education grew twice as fast as trade in goods. Cross-border data flows the fuel of the digital era-have exploded, increasing at an annual rate of 45%. In terms of trade in services, knowledge-intensive categories-including professional, government, IT, and telecommunications services - are growing most rapidly.

Speculation that the world is deglobalising misses the mark: Global integration is evolving, not retreating, in the digital era. Every major world region imports 25% or more (in value-added terms) of at least one important type of resource or manufactured good that

shore locations rose from 5% to 15% between 2000 and 2018. The same is true of the pharmaceuti-

cal industry: Multinationals based in Europe and Asia use R&D performed outside of their home countries for more than half of innovation that produces new patents.

Likewise, highly qualified talent – one of the most important inputs across sectors - is globally mobile. Consider the semiconductor industry. An estimated 40% of high-skill semiconductor researchers working in the US were born in other countries, and foreignborn workers contribute over 80% of semiconductor patents.

Multinational corporations are pivotal players in world trade, accounting for about two-thirds of global exports. They are overrepresented in sectors where intangibles are the most relevant. For example, they account for about 80% of exports in some of the most innovative industries, including transport, pharmaceuticals, and electronics

In knowledge-intensive global value chains, intangibles create highly scalable assets that can be deployed globally at low marginal cost. This, in turn, enables large

and intangibles.

Multinationals have the opportunity to unlock new sources of competitive advantage through increased investment in intangibles, particularly those with the potential to flow across borders. One example is MELLODDY, a public-private partnership coordinated by the AI biotech company Owkin. The project uses decentralised data from ten leading pharmaceutical companies to tweak models that predict molecule behaviour, in the hope of accelerating the drug discovery process. In some cases, investment in intangibles could enable multinationals to implement new business models in sectors that were previously less driven

by knowledge flows. According to MGI research, large companies are well positioned to outperform their peers when they master the deployment of intangibles investment: Firms in the top quartile for growth in gross value added invest 2.6 times more in intangibles than companies in the bottom two quartiles. This suggests new sources of growth for companies grappling with growing economic and geopolitical uncertainty. But there is room for all

consider trade in services, which seem poised to deepen and expand. More economies are undergoing a transition to services, and there is much to gain from further liberalisation, as trade barriers affecting most services are two or three orders of magnitude higher than those for goods. Moreover, further technological advances could make these flows more seamless-the remote-everything of the pandemic era forced companies to provide services virtually, a practice that has become the norm for many services.

The widespread disruption to supply chains caused by the pandemic and Russia's invasion of Ukraine has prompted a new narrative about globalisation in retreat. Considering the full picture of flows, however, suggests that global integration is here to stay, and that knowledge and know-how are now an important part of the way forward. Firms will need to reconfigure value chains in order to capitalise on the growth potential in services, intangibles, and talent.

Sir, The deployment of the personal staff of Vice President Jagdeep Dhankhar in 12 Standing Committees and 8 Departmental Standing Committees of the Parliament has triggered a new controversy. This needless controversy has emerged at a time when there is already a debate going on about the alleged dilution of democratic traditions and values in the country. Giving information about the decision, the Rajya Sabha Secretariat said that the concerned officers have been linked to these committees with 'immediate effect and until new instructions are issued'. As per the instructions, these officers will assist in the functioning of those committees. Obviously, this work includes meetings that are considered confidential in nature. Many experts are calling this move against the accepted traditions and rules of Parliament. This is the first time that staff members of the Rajya Sabha Chairman have been associated with these committees. Usually these responsibilities are given to the officers of the Lok Sabha and Rajya Sabha Secretariat. A clarification has already been given by the Vice President's office. Dhankhar too has admitted publicly that the aim was only to ensure adequate human resources in the parliamentary committees. But the question is more about the method than the intention. New Delhi/Karachi, March 13: An IndiGo plane which took off from Delhi for Doha was diverted to Karachi Sunday night after a passenger fell ill onboard, officials said. The passenger, a Nigerian national aged around 60, was later declared dead on arrival, they said. The officials said the aircraft, A320-271N, which was parked at

the Karachi airport for nearly five hours, returned to Delhi after the authorities in Karachi issued the death certificate of the passenger and all formalities were completed.

An IndiGo spokesperson on Monday said the flight, 6E-1736, operating from Delhi to Doha (Qatar), was diverted to Karachi (Pakistan) due to a medical emergency on board. "Unfortunately, on arrival, the passenger was declared dead by the airport medical team," the spokesperson said in a statement. "We are deeply saddened by the news and our prayers and wishes are with his family and loved ones (of the deceased passenger)," the spokesperson said.

Pakistan Civil Aviation Authority officials in Karachi said the passenger fell ill onboard and the captain requested an emergency landing at the Jinnah International Airport. Doctors from the health department were sent to provide treatment but the passenger had passed away. After the death certificate of the passenger was issued and all formalities were completed, the plane returned to Delhi, the officials said.

Both Lok Sabha and Rajya Sabha were adjourned without transacting any business on the first day of the second leg of the Budget Session following uproarious scenes and repeated disruptions amid vociferous sloganeering by both treasury benches and opposition members.

While in Lok Sabha, Defence Minister and Deputy Leader of the House Rajnath Singh and Parliamentary Affairs Minister Pralhad Joshi led the government's charge against Gandhi, Union minister Piyush Goyal in Rajya Sabha demanded that Gandhi's statements be condemned by the Upper House. Kharge objected to Goyal's statements, citing two previous rulings of the House, and asked Chairman Jagdeep Dhankhar to expunge the remarks of the leader of the House. Speaking to the media outside Parliament, Kharge hit back at the

government for raising the issue of Gandhi's remarks in Parliament. saying those "crushing" democ-

racy are talking of saving it. The BJP onslaught came a day after Prime Minister Narendra Modi lashed out at the Wayanad MP during an event in poll-bound Karnataka for his comments on democracy in India, saying the remarks were an affront to its people. After obituary references in Lok Sabha. Singh stood up and charged

that Gandhi has tried to defame India in London through his remarks on Indian democracy.

"Rahul Gandhi, who is a member of the Lok Sabha, had gone to London and tried to 'discredit' India and said the democratic system in India is completely crumbling. He also said that foreign powers should save India's democracy. He tried to 'deeply hurt' India's honour and prestige," he said. During his recent visit to the UK Gandhi at various interactions alleged that the structures of Indian democracy are under attack and that there is a "full-scale assault" on the institutions of the country. Gandhi had also told British parliamentarians in London that microphones were often 'turned off' in the Lok Sabha when any opposition member raises important issues.

Massive fire engulfs Mumbai slums

Mumbai, March 13: An unidentified person was charred to death, while several families were rendered homeless after a major fire broke out in slums in suburban Malad on late Monday afternoon, a Fire Brigade official said.

The level 3 (major) fire engulfed slums located in the Appa Pada locality in Anand Nagar of the western suburb and has been brought under control, he said.

According to the official. 2.000 to 3.000 hutments spread across an area of 10,000 square metres were gutted in the blaze. "It was a level three fire confined to household articles, electric wiring, electric installation, LPG cylinders, cloths, bed cushions etc," he said. Efforts were on to find out any injured or missing person, the official added.

One person was charred to death while several others were rendered homeless and they have been provided temporary accommodation and food at three places, the official said. The deceased has not been identified yet, he said. Senior civic officials visited the fire site. Smoke billowing out of the area could be seen from several kilometres away. No details were immediately available on the cause of the fire.

urgency of the matter, as there were only 2-3 days left before the legal limit of 24 weeks for medical termination of pregnancy is reached, the superintendent of Nirmal Chhaya Complex, where the girls has been staying since October last year, can sign the consent form. As per a February 24 report of a medical board, the minor was 22-week pregnant and was fit to continue per pregnancy or undergo medical termination of the foetus.

The high court said, being a constitutional court, it was duty bound to see the best interest of the victim. The court was hearing a plea filed by the minor, through her father, for handing over her custody to him. While the matter was pending, the court was informed that the victim was pregnant which led to the formation of the medical board.

Thereafter, the minor and her father told the high court that they were ready for medical termination of pregnancy without any fear.



H3N2 (Health experts call for masks, better hygiene & flu shot

H3N2 AND H3N1 ARE **BOTH TYPES OF INFLUENZA A** VIRUSES, COMMONLY **KNOWN AS THE FLU**

New Delhi, March 13: Even as India is seeing a spurt in Influenza cases, caused by H3N2 virus, health experts Monday have suggested people to take precautionary measures such as use of masks, better hand hygiene, as well as an annual flu shot.

A total of 3,038 lab-confirmed cases of various subtypes of influenza including H3N2 have been



reported till March 9 by the states, January, 1,307 in February, and 486 as per the latest data available on IDSP-IHIP (Integrated Health cases till March 9. "In my opinion, Information Platform). for the time being the government can again make masks mandatory at least in highly vulnerable zones like public transports, hospitals, airports, railway stations and other public conveyances. People should avoid visiting crowded places, or wear a mask whenever in public," Dr. Sunil Sekri, Associate Consultant Internal Medicine, Max hospital, Gurugram, told IANS.

The respiratory virus "spreads through droplets, so which means that the secretions can spread from person to person, and most people touch their nose and mouth at some point, or that secretions can remain on the fingers and when they shake hands with other people", it can likely spread, said Dr Rajeev Jayadevan, co-chairman of the Indian Medical Association's National Covid-19 Task Force, making a case for the need of masks particularly in crowded indoor gatherings

According to data from the Indian Council of Medical Research (ICMR), there has been a combination of respiratory viruses ranging from Covid-19 virus, swine flu (H1N1), H3N2, and the seasonal Victoria and Yamagata lineages of influenza B viruses in circulation. Some of the most common symptoms include prolonged fever, cough, running nose, & body pain. But in severe cases people may also experience breathlessness and/or wheezing.

Meanwhile, the Covid infection has also reported a spike after four months as 524 daily Covid cases

were reported Sunday.

"For the last three years we have

learned how respiratory infections can be prevented. Because the infections go out and come in from the nose and mouth, you need to cover this area and that is masking. Proper masks are needed, particularly when you are in crowded places," said Dr. Iswar Gilada, an infectious disease expert.

"Masking is important particularly for those who are both with comorbidities and the family members of those who are having such kind of people at their home," he said. The experts also suggested people to wash their hands before eating or utilising any public transit with soap or sanitiser to minimise the risk of infection.

Yadav said that the police are unable to find the real accused in the Prayagraj incident and that there was pressure on them to catch and frame anyone. He added that Ahmed's two sons were caught on the first day of the incident itself.

Yadav stated that it is suspected that one of them may have been killed. He said that the Constitution gives every citizen the fundamental right to life and the police cannot just apprehend someone and kill them, as that is a punishable offence.

The SP leader added that those who have done fake encounters will be prosecuted for murder.

He said that the culprits of Umesh Pal murder case should be punished severely but called the policies adopted by the state government destructive.

A senior SP leader said that the party, which has emerged as the largest opposition in the 2022 Assembly elections, does not want to lose the Muslim vote bank as the community has played a big



role in strengthening it.

In the 2017 elections, 24 Muslim MLAs were elected, out of which 17 won on SP tickets, which increased to a total of 34 MLAs being elected in 2022, of which 31 were from SP.

BSP Chief Mayawati raised questions on the encounter of two of the four accused involved in the murder of Umesh Pal and said that the actions taken by the police in this matter have raised doubts within the minds of the people about the rule of law in Uttar Pradesh. She questioned whether the government would repeat the 'Vikas Dubey scandal' to cover up its failures. Mayawati added that the state government is under a lot of tension and pressure, especially regarding the law and order

Umesh Pal in broad daylight.

She said that the whole country had its eyes on the state government on whether it would follow the rule of law or stop crime by killing criminals on the streets.

A BSP leader said that the party would perform well with the strong Dalit-Muslim alliance even if it does not team up with SP.

He added that Mayawati knows that better results cannot be achieved only on the Dalit vote bank, therefore, after the setback in the Assembly elections, BSP has been trying to reconnect with the prominent Muslim community.

Significantly, the BSP was reduced to one seat and 13 per cent vote bank in the Assembly elections. Meanwhile, in the 2019 Lok Sabha elections, 10 BSP MPs won when it was in alliance with SP, prior to which the BSP had zero seats in 2014 Lok Sabha elections. Political experts believe that SP

got the Muslim vote bank in UP in bulk in the 2022 Assembly elections, but could not form the government. The party is now trying to save the vote bank, which is why BSP leaders are giving such statements.

Mayawati has included the Muslim leaders in her party to bring the community's votes in her fold, by campaigning with leaders like Shah Alam aka Guddu Jamali from eastern UP and Imran Masood

Lucknow, March 13: The bulldozer politics that originated in Uttar Pradesh in 2020 has now become the mainstay of the Yogi Adityanath government.

Most governments in the country, mainly the BJP-led ones, are now betting on the bulldozer that is apparently bringing in more bouquets than brickbats.

The bulldozer first gained prominence in the Yogi Adityanath government in July 2020 when this mean machine was used to pull down the house of gangster Vikas Dubey in Bikru village in Kanpur.

President Paudel has traversed a long political journey to make it to the country's highest state position. He spent over a decade in jail. He was a lawmaker six times, a minister five times, and Speaker for one term.

Paudel replaces Bidya Devi Bhandari, whose term ended on March 12. This is the third presidential election in Nepal since the country became a republic in 2008. Paudel had support from eight political parties. Out of 52,628 weightagebased votes, Paudel secured 33,802 while Nembang got 15,518 votes.

The outcome of the Presidential election came as a relief for the government headed by Prime Minister 'Prachanda' as former premier KP Sharma Oli-led CPN-UML withdrew its support to his government following a rift over backing Paudel for the presidential poll. Oli on Monday appointed Nembang as the deputy parliamentary party leader.

Employees appeared to gather at the company's Manhattan headquarters for meetings Sunday, ordering catering from Carmine's, an Italian restaurant, and Starbucks coffee, according to a Reuters reporter on the scene. People trickled out of the building after the news of the closure was announced. Investors were unnerved by the speed at which startup-focused SVB, the 16th largest lender in the US, was toppled by customer withdrawals. The episode last week erased more than \$100 billion in market value from US banks,

US President Joe Biden vowed stiffer bank regulations

Washington: In an extraordinary action to restore confidence in the US's banking system, President Joe Biden's administration guaranteed that customers of the failed Silicon Valley Bank (SVB) and Signature Bank will have access to all their money starting Monday.

In a joint statement, Treasury Secretary Janet Yellen, Federal Reserve Chair Jerome Powell and Federal Deposit Insurance Corporation Chairman Martin J Gruenberg said the FDIC will make SVB and Signature's customers whole.

President Joe Biden declared the US banking system "safe" and vowed stiffer bank regulation, after US regulators were forced to step in with a series of emergency measures after Silicon Vallev Bank and Signature Bank collapse, threatening to trigger a broader crisis. The managers of the banks will

be fired, Biden noted, and investors will lose money. "They knowingly took a risk, and when the risk did-

n't pay off his adjusters lose their money. That's how capitalism works," he said. Biden also promised new regulation after the biggest US bank failure since the 2008 financial

Over \$70bn wiped off global crypto market

The collapse of three banks in the US, including the giant Silicon Valley Bank (SVB), within a week has hammered the global crypto market, wiping off more than \$70 billion as Bitcoin fell below \$20,000 per single coin. On Monday, Bitcoin was hovering around \$18,000 and Peter Schiff, CEO of Euro Pacific Capital, predicted the world's largest cryptocurrency could soon drop below \$4,000.

AMERICA'S \$620BN TICKING TIME BOMB

London, March 13: Banks across the US are sitting on \$620 billion of 'unrealized losses' -- assets which have decreased in value but have not yet been sold -- the head of the Federal Deposit Insurance Corporation warned, the media reported. Yet the revelation about the 'unrealized losses' will only serve to raise concerns about the US banking industry, it reported. The ticking time bomb is due to US banks buying Treasuries and bonds while interest rates were low, but, with interest rates now rising, finding these bonds have declined in value. When interest rates rise, newly issued bonds start paying higher rates to investors, which makes the older bonds with lower rates less attractive and less valuable. Most banks and pension funds are affected. "The current interest rate environment has had dramatic effects on the profitability and risk profile of banks' funding and investment strategies," said Martin Gruenberg, chair of the Federal Deposit Insurance Corporation (FDIC), Daily Mail reported. Speaking March 6, at the Institute of International Bankers, he confirmed the \$620 billion figure. "Most banks have some amount of unrealized losses on securities," he said. "The total of these unrealized losses, including securities that are available for sale or held to maturity, was about \$620 billion at yearend 2022," Daily Mail reported. "Unrealized losses on securities have meaningfully reduced the reported equity capital of the banking industry," he said.

STOCK INDICES WITNESS PLUNGE FOR THE THIRD STRAIGHT SESSION

Mumbai, March 13: Benchmark stock indices Sensex and Nifty declined for a third day on the trot to close at five-month low levels Monday due to a massive sell-off in banking, finance and auto stocks triggered by fears of potential contagion from the biggest bank failure in the US since 2008.

Unabated flight of foreign capital and a weak domestic currency amid global rate hike fears added to the gloom, traders said.

The 30-share BSE Sensex plunged 897.28 points or 1.52 per cent to settle at 58,237.85, the lowest closing level in five months. Only one Sensex stock ended higher while the rest 29 dropped.

The index opened higher and later rose by 375 points to touch a high of 59,510.92 in early trade amid positive Asian markets. However, bears gripped the markets and the index tanked over 1,400 points from the day's high to 58,094.55.

Investors poorer by over ₹4.4L-cr

Domestic equity investors' wealth eroded by more than Rs 4.43 lakh crore Monday as fears of a financial contagion triggered by one of the biggest bank failures in the US roiled market sentiments. Reflecting the massive sell-off across sectors, the total market valuation of BSE-listed companies stood at Rs 2,58,56,295.60, leaving investors poorer by Rs 4.43.023.89 compared to the closing level Friday. The total market valuation was at Rs 2,62,99,319.49 at the end of trading on Friday, when the key index had crashed more than 670 points.

Foreign portfolio investors (FPIs) offloaded shares worth Rs 1,546.86 crore Monday, according to exchange data.

In Asian markets, Shanghai, Hong Kong and Seoul ended in the green, while Tokyo settled lower. European equity markets were trading with significant losses in the afternoon trade.

Retail inflation declines to 6.44% in February

Retail inflation is still above RBI's comfort level of 6%

New Delhi, March 13: Retail inflation dipped marginally to 6.44 per cent in February, mainly on account of a slight easing in prices of food and fuel items though it remained above the Reserve Bank's comfort level of 6 per cent for the second month in a row.

As per the government data released Monday, the Consumer Price Index (CPI)-based inflation was at 6.52 per cent in January and 6.07 per cent in February 2022.

The retail inflation rate for the food basket worked out to be 5.95 per cent in February, marginally lower than 6 per cent in January. It was 5.85 per cent in February last year.

As per the data, vegetable prices dipped by 11.61 per cent on an annual basis, though it recorded a double-digit increase in spices (20.20 per cent) and cereals and products (16.73 per cent).

A decline in inflation was also witnessed in the oils and fats segment. The price rise remained subdued in segments like meat and fish, eggs, pulses and products, sugar and confectionery and nonalcoholic beverages.

On the other hand, the inflation in the fuel and light segment worked



out to be 9.90 per cent in February. Also milk and products, clothing and footwear became dearer during the month.

The data also revealed that inflation in rural areas was higher at 6.72 per cent during the month compared to 6.10 per cent in urban centres

Except for November and December 2022, retail inflation has remained above the RBI's upper tolerance level of 6 per cent since January 2022. The central bank has been mandated by the government to ensure the retail inflation remains at 4 per cent with a margin of 2 per cent on either side.

The Reserve Bank has projected retail inflation at 6.5 per cent for 2022-23, with the January-December quarter at 5.7 per cent.

To contain the rising prices, the RBI has hiked interest rates by 250 basis points since May last year. The latest rate hike of 25 basis points in February took the benchmark policy rate to 6.50 per cent.

The Reserve Bank is scheduled to announce the next bi-monthly monetary policy, the first for fiscal 2023-24, April 6

Centre seeks Parl approval for

additional spending of ₹1.48L-cr

New Delhi, March 13: The Centre Monday sought Parliament's approval for an additional expenditure of Rs 1,48,133 crore for the remaining period of 2022-23, under the second batch of supplementary demands for grants for the current fiscal.

A statement showing the sup-

plementary demands for grants (second batch) for 2022-23, was laid in Lok Sabha Monday.

Out of this amount, government intends to spend a major chunk of funds towards defence pensions, GST compensation to states, fertiliser and urea subsidies, sovereign green fund and universal service obligation (USO) fund of the telecom ministry.

The government plans to spend Rs 21,000 crore on disbursing fertiliser subsidy and Rs 15,325 crore on urea subsidy.

On defence pensions, the government would be spending Rs 🔫 33,718 crore. An amount of Rs 29,616 crore is to be spent on disbursing GST compensation to states.

Under the USO fund of telecom ministry, it intends to spend Rs 25.052 crore. On the sovereign green -(fund, the government will be spending Rs 5,536 crore.

ULTIMATE TEST IS ON

New Zealand's thrilling win over Sri Lanka seals India's World Test Championship final qualification; Rohit's men win Border-Gavaskar Trophy for fourth consecutive time after the final match ends in a draw

Ahmedabad, March 13: On an uneventful day of cricket, India qualified for the World Test Championship (WTC) final and clinched the Border-Gavaskar Trophy for the fourth successive time after the fourth and final match against Australia ended in a drab draw, here Monday.

India's spot in the WTC final against Australia was locked before the post-lunch session when Sri Lanka lost the Christchurch Test to New Zealand by two wickets as Kane Williamson's magnificent hundred steered his side to one of the most thrilling wins in Test cricket. Australia were 175/2 in 78.1 overs in their second innings with a lead of 84 runs when the two teams agreed to settle for a draw.

India have now beaten Australia by an identical 2-1 margin in the last four series – 2017 (home), 2018-19 (away), 2020-21 (away) and now 2023 at home.

It was a 'Memorable Monday' for India as a country in both performing arts and sports with 'RRR's song 'Naatu Naatu' getting the Oscar for the best song and Elephant Whisperers winning the 'Best Documentary Award'.

By the afternoon, cricket added to the list of global accomplishments and now Rohit Sharma _would love to break the decadelong ICC Trophy jinx.

With a featherbed of a track on offer, which former Australian opener Mark Waugh sarcastically said can host a "22-day Test match", an outcome favouring either side

Kiwis give wings to Men in Blue

Christchurch, March 13: Kane Williamson (121 n o, 194b, 11x4, 1x6) and Neil Wagner stole a bye from the last ball of the first cricket Test Monday to beat Sri Lanka by two wickets and emphasize New Zealand's aptitude for extraordinary Test match victories.

The run on the final delivery of the Test not only sealed a memorable win for the Kiwis, but also paved the way for India to WTC final.

Only two weeks after New Zealand beat England by a single run at the Basin Reserve, the Black Caps again played a part in one of the most incredible finishes in Test match history.

Rain seemed to have wrecked the final day of the match in Christchurch when it prevented play in the scheduled first two sessions. When it cleared the umpires announced a single extended session in which New Zealand needed 257 runs to win and Sri Lanka needed nine wickets.

A winning result seemed impossible though the session was extended to at least 52 overs and more than 3-1/2 hours. In what turned into a 50-over match, then a 20-over match.

New Zealand needed 131 runs off the last 20 overs, then 101 off the last 15 with Williamson steering the innings. Williamson had support from Daryl Mitchell (81, 86b, 3x4, 4x6), who made 102 in the first innings. When he was out New Zealand still needed 53 to win. Asitha Fernando howled su

Williamson struck a boundary and there was one run needed off two balls. The next ball from Asitha was short, it passed over Williamson's head as he stood upright but no wide was called. That left the equation as one ball remaining, one run needed.

Williamson played at but missed another short ball and ran through, arriving as the stumps were shattered by a Sri Lanka throw at the non-striker's end. The final and crucial decision was left to the video umpire.

He considered the footage and decided Williamson had made his ground and New Zealand had won by two wickets with no time to spare. New Zealand's winning run chase was its third-largest in Test cricket.

Barca beat Bilbao amid more refereeing storm

Madrid, March 13: Still mired in controversy over their payments to the company of a former refereeing committee official, Barcelona restored their lead over Real Madrid to nine points in the Spanish league Sunday after a late VAR decision went their way.

Barcelona beat Athletic Bilbao 1-0 after video review disallowed an 87th-minute goal by Bilbao forward Inaki Williams for a handball in the buildup. Williams laughed at the decision on Twitter after the game. "We are upset," Bilbao coach Ernesto Valverde said. "Nobody on the field had seen anything, not even the referee or the fourth official or the other assistants."

The review of Williams' goal took nearly three minutes. When the decision was announced, it drew loud jeers from the home fans at San Mamés Stadium.

The controversy came hours after Madrid had announced it would side against Barcelona in the legal proceedings that the rivals are facing over their payments of millions of euros over several years to a company that belonged to the former vice-president of Spain's football refereeing committee.

Raphinha scored the winner in first-half stoppage time with a shot from inside the area after a superb pass by Sergio Busquets. The lineman raised his flag but video review determined the Brazil forward was in a legal position.

There didn't immediately appear to be anything wrong with the goal by Williams, but the referee was asked to look at Iker Muniain's touch of the ball with his arm earlier in the buildup, and it was deemed to have been enough to disallow the goal.
