Mahanadi, Brahmani polluted: Amat

Bhubaneswar, March 14: The water of Mahanadi and Brahmani rivers is polluted due to discharge of waste into the rivers in urban areas, Forest, Environment and Climate Change Minister Pradip Kumar Amat told the Assembly Tuesday

Replying to a question of BJP member Nityananda Gond, Amat said a survey conducted by the State Pollution Control

Board (SPCB) during January to December 2022 found that the **Biochemical Oxygen Demand** (BOD) and TC level were above the prescribed parameter in 22 places of Mahanadi and

Brahmani rivers. Amat said the municipal authorities and the Housing and Urban Development (H&UD) department have directed the officials to set up Sewage Treatment Plants (STPs) for purification of waste water.

At present, five STPs at Bhubaneswar, three in Cuttack, two in Puri and one each at Talcher and Sambalpur have been set up.

In addition to it, 119 Septage Treatment Plants (SeTPs) in 115 urban areas were set up out of which 110 SeTPs have been made operational.

The minister said that the pollution level in water would be reduced after the operational of these projects.

Uproar in House over HSCE absenteeism

Bhubaneswar, March 14: **Opposition BJP and Congress** Tuesday created uproar in the Assembly claiming that the education system in the state has 'crumbled' after a large-scale absence of examinees in the ongoing High School Certificate Examination (HSCE) or matriculation examination.

Raising the issue in the House during Zero Hour, Leader of Opposition (LoP) Jayanarayan Mishra said, "Over 15,000 students did not appear for the ongoing matriculation examination which is highly deplorable.'

Ridiculing School and Mass Education (S&ME) Minister Samir Ranjan Dash for taking photographs with students inside an examination centre, Mishra trained guns at the 5T initiative of the state government.

The LoP was also supported by Congress Legislature Party (CLP) leader Narasingha Mishra, who came down heavily on the state government on the issue.

"It is a matter of great concern. It only shows that the entire education system is crumbling in the



state," the Congress leader said.

After concerns were expressed in the House, the S&ME Minister said due to door-to-door campaigning conducted by his department, the matric exam dropout rate has come down to 2.7 per cent this year from 7.7 per cent reported last vear.

In the academic year 2021-22, out of 5,71,909 students who filled up forms for the Summative Assessment-II, 45,091 remained absent. However, this year, 13,058 out of 5.32.603 registered students remained absent in the first two language tests conducted so far, he said.

The Minister told reporters outside the Assembly that the exact reason behind the large absence of examinees could be known after a detailed inquiry is conducted after the end of the examination.

The department will take up the matter seriously and ascertain the causes behind the absence of examinees, he said.

One of the reasons behind the large-scale absence of examinees could be due to the waiving of examination fees by the state government in wake of the COVID-19 pandemic, the Minister said. Contd....P4

Das added, Private Bus Owners' Association secretary, however, said they have written to the state government expressing willingness to operate buses. Meanwhile, the Commissionerate Police warned of stern action against anyone found disrupting smooth movement of nublic vehicles Wednesday.

META SLASHES 10K MORE JOBS

NEW YORK: Facebook parent Meta is slashing another 10,000 jobs and will not fill 5,000 open positions as the social media pioneer cuts costs. The company said Tuesday it will reduce the size of its recruiting team and make further cuts in its tech groups in late April, and then its business groups in late May. "This will be tough and there's no way around that," said CEO Mark Zuckerberg. The company announced 11,000 job cuts in November.



Jayanarayan: Govt painting schools in Pakistani colours

Bhubaneswar, March 14: Leader of Opposition Jayanarayan Mishra of BJP Tuesday said that many schools in Odisha do not have adequate teachers and the students cannot even identify Odia alphabets but the government was busy painting the school buildings in "Pakistani colours" as part of its transformation programme.

Mishra's comments in the Assembly during Zero Hour sparked a furore with the ruling BJD pointing out that the national flag of India also has green in it, and

All fires on satellite imagery aren't wildfires: Min

All fires detected in Odisha through satellite imagery were not forest fires, Forest and Environment Minister PK Amat said in the Assembly Tuesday amid concerns of the Opposition. He said stubbles being burnt by the farmers to clear their fields after harvesting were also caught by the satellites. "Data received from satellite is not only about forest fires. In many cases, farmers are setting fires to paddy fields after harvesting to clear the land. That's why more fire was seen in the satellite imagery." Amat said. "Forest officials were working to douse the blaze in 98 per cent of the area where forest fires have been reported," he added. Women SHGs and forest protection committees have been asked for help to douse the blaze, the minister said. Congress MLA Suresh Routray and BJP MLA Kusum Tete expressed deep concern over the incidents of fire across the forests in the state.

"Adding a fresh coat of the Pakistani colour to the school building won't yield results. Is this the vision of the government's 5T initiative?" he asked. BJD MLA Arun Sahoo immediately pulled out his mobile phone, and pointed to a photo of India's national flag, stating that Mishra should take note of the colours in it. Speaker BK Arukha, however, asked him not to use mobile phone in the House.

Vegetables, trees, plants and forests are also green in color, Sahu said, adding, "Would you call them Pakistani as well?'

The schools being developed under the '5T' programme – transparency,



Bhubaneswar, March 14: The state government has intensified its influenza-like illness (ILI) and severe acute respiratory infections (SARI) surveillance system following detection of 59 H3N2 cases, a Health department official said Tuesday.

"The H3N2 has similar symptoms of cold, cough and fever like Covid-19 and other adenovirus. In view of the prevailing situation, we have strengthened our surveillance system through district-level disease surveillance units to identify H3N2 cases," said Health Services director Bijay Mohapatra.

'The state has sufficient kits to test Covid-19 virus. If someone is found Covid-19 positive is concerned, the director said, "We have isolation units at secondary and tertiary level healthcare institutions. We have adequate oxygen beds, ICU beds and required medicine to meet any emergency, if it arises."

Asked about whether children are more vulnerable to become serious due to the disease, he said, "We are following the advice of National Centre for Disease Control (NCDC), which is yet to give any guideline in this direction.'

Mohapatra advised people not to take unnecessary medicines without the advice of a doctor, if they develop symptoms. The symptomatic person should isolate himself and

earing an eye mask can potentially enhance cognitive functions of the brain as it blocks ambient light while we sleep, suggests a study. Sleep is crucial for alertness and for preparing the human brain to encode new information. However, ambient light, like an outdoor street light shining through your window, can influence sleep structure and timing

The study, published in the journal Sleep, showed that wearing an eye mask blocks light during night sleep and improves memory and alertness.

"Our findings suggest that wearing an eye mask during overnight sleep can improve episodic encoding and alertness the next day," wrote Viviana Greco, from School of Psychology at University of Cardiff, along with other researchers in the paper.

The team conducted two experiments to understand how sleep masks help. In the first experiment, 94 people in

the age group of 18-35 wore an eye mask while they slept every night for a week and underwent a control condition in which light was not blocked for another week. Five habituation nights were followed by a cognitive battery on the sixth and seventh day.

This revealed superior episodic encoding and an improvement on alertness when using the mask, the researchers said. In the second experiment, 35 people of the same age group used a wearable device to monitor sleep with and without the mask.

This replicated the encoding benefit and showed that it was predicted by time spent in slow-wave sleep.

Furthermore, the benefit to memory was predicted by the time spent in slowwave sleep while wearing the mask.

This suggests wearing an eye mask during sleep is an effective, economical, and noninvasive behaviour that could benefit cognitive function and lead to measurable impacts on everyday life, the researchers said.

electrocution. Speaking to mediapersons, Keonjhar DFO, Dhanraj HD said Tuesday that monitoring the movement of the pachyderms has always been a challenge for the Forest department amid various hazards like railway tracks, electrical wires, open wells and also use of pesticides on farmlands. He said it is not easy to get real time data on elephant movements despite introduction of early warning and voice message systems, patrolling on bikes and on foot.

Dhanraj said the thermal drones have been put in use, since Thursday, last. The drone detects live objects through their body temperatures and the picture of the animal gets flashed on the computer screen. This help officials differentiate between elephants and other animals.

The drones also help in ascertaining the numbers in an elephant herd, the adult members and calves in it. The detection of body temperature enables officials to identify whether an elephant inside the herd is ill or not. The DFO said that the drones are being used to drive the herds away from a potential danger zones.

Koraput, March 14: Where these is a will there is a way. This saying was proved true by three minors who defied age to run 40 kilometres in searing heat as part of a marathon event, recently. The three kids ran from this town to Damanjodi in approximately three hours and their efforts were applauded by all and sundry.

Siblings Yamuna Bahadur (11), Tapasya Bahadur(7) and Hari Bahadur (10) completed the distance by the dint of sheer willpower and perseverence. The two daughters and son of Jeetendra Bahadur, a resident of this city, have always been fascinated by long distance running.

Same-Sex Marriage

The three-judge Bench of the Supreme Court, headed by Chief Justice DY Chandrachud, March 13 referred petitions seeking legal validity of same-sex marriages to a five-judge Constitution Bench. Although the verdict is a long way off yet this is in sharp contrast to the firmness shown by the judiciary in several countries in dealing with the same matter. The apex courts of other countries peremptorily directed the legislatures of respective countries to either frame laws to validate same-sex marriages or the existing ban stood withdrawn. The Indian Supreme Court Bench was expected to have shown more firmness in pronouncing a clear-cut verdict instead of letting a larger Bench take a call. The impression gained is that the order has unnecessarily given a veneer of logicality to the Centre's regressive stand on the issue. The observation of the Bench that the matter raises questions of "seminal importance" and submissions on the issue involve the interplay between constitutional rights and specific legislative enactments, besides the rights of transgender couples, appears to be an exercise in wordplay and legalese. The reluctance to take the government's regressive arguments head-on comes out in the ruling: "Having due regard to the broader context of the petitions and the interrelationship between the statutory regime and constitutional rights, we are of the considered view that it will be appropriate if the issues raised are resolved by a Constitution Bench of five judges of this court having due regard to the provisions of Article 145(3) of the Constitution.

Under Article 145(3), a minimum of five judges should hear cases that involve "a substantial question of law as to the interpretation" of the Constitution.

This is more so when one considers the fact that already 30 countries in the world have allowed same-sex marriages. The highest courts in some of them even set deadlines for their respective legislatures to enact a law validating such marriages or else the ban that had been in force would be null and void. The legislators in some cases preferred not to act at all despite the apex court's ruling and the law recognising same-sex marriages automatically came into force after the deadline expired.

The matter becomes clear in the light of some of the recent cases. On May 17, 2019, Taiwan became the first Asian country to legalise same-sex marriages. The country's parliament passed a Bill to this effect. The vote in Taiwan's Legislative Yuan (the official name of Taiwan's unicameral parliament) was prompted by a 2017 decision by the country's highest court, which struck down a law defining marriage as being between a man and woman. The court gave the nation's legislature until May 24, 2019, to change Taiwan's marriage laws to accommodate same-sex couples.

On 1 January 2019, Austria joined the vast majority of Western European countries in legally validating same-sex marriage. The country had granted gay and lesbian couples the right to enter into a civil partnership in 2010. But in 2017, Austria's highest court ruled that these partnerships were inherently discriminatory. It also ruled that unless the country's legislature passed a law to the contrary, gays and lesbians should be allowed to wed by January 1, 2019. Austria's legislature did not act to counter the ruling, leading to the first same-sex weddings at the beginning of 2019.

In fact, same-sex marriage in India should be a logical corollary to the decriminalisation of Section 377 (homosexuality) made by the apex court in 2018. The argument put forward by the Centre pleading that same-sex marriage is repugnant to India's ethos and tradition shows it is captive in the hands of the ruling party's bigoted ideas about Hindooism.

Hindooism is no prisoner of the past. It is dynamic and known for accommodating all shades of opinions and schools of thought evolving over time. Denying the desires and aspirations of individuals to tie the nuptial knot with same-sex partners is to deny their existence as fellow human-beings.

While opposing the petitions, the government urged the Supreme Court to leave the issue to be decided by Parliament. It has told the top court that a "legislative understanding of marriage in the Indian statutory and personal law regime" refers only to marriage between biological men and women and that any interference "would cause complete havoc." Any recognised deviation can "occur only before the competent legislature," the government submitted.

The judiciary in several countries, which have validated same-sex marriages, did not let the legislatures look at the issue with coloured glasses or settle it with a brute majority. It set a timeframe to either bring suitable legislation granting the right or same-sex marriages would become legally valid. In some cases religious inhibitions against such marriages were not entertained.

STUDENTS AS CONSUMERS

Wery year 15 March is celebrated as the World Consumer Rights Day. The day was inspired by President John F Kennedy's message to the US Congress, sent on the same date five decades ago. He stressed the importance of the rights of consumers. Today most countries have in place the relevant laws protecting the consumers. The day is globally recognised and accredited by the United Nations.

In India, the protection of the rights of consumers is administered by the Consumer Protection Act, 2019. The Act contains various provisions for the protection of consumers and for promoting their rights. Several classes of consumers and almost all types of services are covered under this Act. The term protection in the Act itself shows that the consumer is vulnerable and can be subject to harassment by the seller or the provider of services. The Act assumes that the seller has the power to indulge in unfair practices and mislead the consumer. So, the sole objective of the Act is to safeguard the consumer against the possible unfair practices by the service provider.

Despite having several deliberations on the consumer protection for decades, one bone of contention that still continues is the lack of clarity regarding inclusion of students as consumers under the Act. Is education a service? Is the student a consumer? Can we sue a college or a university for indulging in unfair practices? Several such questions have not been fully resolved yet.

Various courts, including the Supreme Court of India, have sent confusing signals in different cases. Only recently in the year 2020, has the Supreme Court agreed to examine the question as to whether an educational institution or university can be sued under the consumer protection law for deficiency in services. We are still waiting for the court to provide final clarity. Until then ambiguity will prevail.

Ambiguity in law creates an opportunity for exploitation by

the powerful. This is also true in the cut throat competitive world of education, where academic capitalists rule. The new players in the academic ecosystem think and act like corporate entities, where profits drive the organisations. In the pursuit of improving profit margins, these new academic en tities spend crores of rupees on advertisements, infrastructure, and technology to woo students. Such investments are recovered through high fees charged from the students. The high course fee is a manifestation of unfair practices against students in general and economically poor students, in particular. But there is no forum for students to question such unfair practices

In both public and private universities, the students are the victims. In public universities, the indifference of the teachers, and the incompetence of the administration dissuades students from using their freedom of expression. In private universities, on the other hand, the proactive management and the silent self-in-

dulgent academic fraternity persuade the students to sacrifice their right to complain by promising plum corporate jobs. The fear of not getting jobs and the burden of huge loans further act as deterrents for freedom of expression.

No wonder that Chief Justice of India DY Chandrachud and his predecessors had strong words to say about public and private universities, which speak volumes about the condition of students. In February 2023. Justice Chandrachud, in a convocation address, said that the lack of empathy in educational institutions, especially in the premier ones like the IITs, the IIMs and the national law institutes. had an adverse effect on students. Similarly, former Chief Justice of India NV Ramana in 2022, talked about the mushrooming of factories of education which are leading to devaluation of degrees and human resources. Gobo

his word is common in theatre, film, and television but appears here because it looks so odd and unEnglish. It is most often used by lighting technicians to refer to a metal plate with a pattern of holes in it, which is placed in the gate of a spotlight to produce an image or outline on the set. More sophisticated gobos rotate to create moving patterns; some are of glass with complex coloured patterns on them. The word can also be used for a fabric or wood shape placed in front of a light to cast a shadow (in some circles in the US this is called a cookie or a flag instead). But it can also have other senses that relate to some sort of mask: perhaps a shield used to shelter a microphone from extraneous noise or to acoustically separate groups of instruments in an orchestra, or a screen used to shield a lens from light. It has nothing to do with the Japanese vegetable of the same name its origin is somewhat obscure, but it's most probably just a condensed version of go between. Another name for certain types is cucoloris. This is the usual name for a large perforated gobo placed in front of a lamp to project a diffused shadow pattern.

Gobsmacked

Gobsmacked combines the northern English and Scottish slang term gob, mouth, with the verb smack. It suggests the speaker is utterly astonished or astounded. It's much stronger than just being surprised; it's used for something that leaves you speechless, or otherwise stops you dead in your tracks. It suggests that something is as surprising as being suddenly hit in the face. Gobsmacked, like gob itself, comes from northern English and southern Scottish dialects. One reason why it starts to appear in print in the 1980s is that it was used by the writers of gritty television series set in northern cities, such as Alan Bleasdale's Boys from the Blackstuff, about five Liverpudlian tarmac layers, and Coronation Street, set in a fictional suburb of Manchester (Jeffrey Miller included it in his glossary Street Talk – The Language of Coronation Street in 1986). It was taken up shortly afterwards by broadsheet newspapers such as The Times, the Sunday Times and the Independent as well as the Guardian and by politicians who used it to display their demotic credentials. It has since travelled widely.



Melvin Durai MOST RATS ARE

PRO-MASK, BUT ANTI-VAX demic behind us, scientists have brought us some discouraging news: they took samples from 79 residents of New York City and found that 13 of them (16.5 per cent) were carrying the virus that causes COVID-19. These were not just any residents, but some of the most active and enterprising inhabitants of the city, part of a thriving community known as rats.

To be precise, the rats belong to the species known as Norway rat (Rattus norvegicus), which has also been called the brown rat, common rat, street rat, sewer rat, and fast-food rat.

The scientists, who published their findings in mBio, an openaccess journal of the American Society for Microbiology, determined that the rats were exposed to SARS-CoV-2, a strain of coronavirus that causes COVID-19.

As worrisome as this news is, you'll be relieved to know that the health authorities in New York City are doing something about this. They have hired a company to manufacture millions of tiny masks for the rats. Each rat will be required to wear a mask to prevent transmission of the virus.

Getting rats to wear masks will



not be an easy task, of course, but scientists have determined that the average rat is more willing to wear a mask than to get vaccinated. Most rats are pro-mask, but anti-vax.

In a unique experiment, scientists showed rats various pictures to measure their reaction. Rats remained calm when shown a picture of a mask. Their heart rate increased by 40 per cent when they were shown a picture of a syringe, it increased by 60 per cent when shown a picture of a cat, and it increased by a whopping 100 per cent when shown a picture of a cat holding a syringe.

Scientists also tested whether the rats would be willing to be vaccinated by other rats. Their heart rate increased by 30 per cent when they were shown a picture of a

house rat (Rattus rattus) holding a syringe, it increased by only 20 per cent when shown a picture of a fellow Norway rat (Rattus norvegicus) holding a syringe, and it didn't increase at all when shown a picture of Vladimir Putin holding a syringe.

Unfortunately, Putin isn't available to vaccinate rats, at least not outside his country. But even if he volunteered to do so, it would be a gargantuan task, as New York City has almost as many rats as investment bankers.

The cabinet secretary noted that since a hotter than normal summer is expected, states and union territories need to be adequately prepared to meet the associated challenges, according to an official release. The IMD made a presentation on the global weather phenomena and the temperature outlook for the period from March to May. Forecast for the second fortnight of March was also provided. Minimum temperatures are

more likely to be above normal over most parts of the country ex-

cept south peninsular India, where normal to below normal temperatures are likely. The IMD further informed that no significant heat waves are expected during the remainder of March.

39 of world's 50 most polluted cities in India: Report

New Delhi, March 14: The Swiss firm IQAir in its 'World Air Quality Report' released Tuesday ranked India the world's eighth most polluted country in 2022, dropping from fifth place the previous year. In the list of most polluted cities in the world, out of the 50 cities, 39 are in India.

Chad, Iraq, Pakistan, Bahrain, Bangladesh, Burkina Faso, Kuwait, India, Egypt and Tajikistan were the top 10 most polluted countries while Australia, Estonia, Finland, Grenada, Iceland, and New Zealand met the World Health Organization (WHO) PM2.5 guideline (annual average of 5 Aug/m3 or less).

The data from 131 countries was taken from over 30,000 groundbased monitors, either government or non-government operated. As per the report, In India, the transportation sector causes 20-35 per cent of the PM2.5 pollution while other sources of pollution are industrial units, coal-fired power plants and biomass burning.

After the two top most-polluted cities, Lahore in Pakistan and Hotan in China, Rajasthan's Bhiwadi is in third place and Delhi ranked fourth. Delhi's PM2.5 level is almost 20 times the safe limit, the report stated.

Delhi has so far been the most polluted capital in the world and the report made a distinction between greater' Delhi and New Delhi the capital. Both are in the top 10 and the infamous distinction of being the world's most polluted capital goes to Chad's N'Djamena.

National Capital's peripherals-- Noida, Ghaziabad, Gurugram and Faridabad have seen a decline in pollution levels. The report said that there is a 34 per cent decline in Gurugram to 21 per cent in Faridabad if compared to the average PM2.5 levels reported in previous years.

Delhi has seen a decline of eight per cent. The report said that worldwide, poor air quality accounts for 93 billion days lived with illness and over six million deaths each year. "The total economic cost equates



to over \$8 trillion dollars, surpassing 6.1 per cent of the global annual GDP. Exposure to air pollution causes and aggravates several health conditions which include, but are not limited to, asthma, cancer, lung illnesses, heart disease, and premature mortality," the report said.

According to the report, 31 cities including 10 cities in Uttar Pradesh and seven in Haryana, have seen a steep percentage decline in pol-

lution levels. "A total of 38 cities and towns have seen a rise in pollution compared to an average of previous years," stated the report. As per the report, among the

six metro cities, Kolkata was ranked the most polluted after Delhi. However, Chennai was stated to be the cleanest with pollution 'just' 5x the WHO's safe level. The metro cities -- Hyderabad and Bangalore -- saw pollution levels uptick over the average since 2017.

Boy who fell into borewell dies

Pune, March 14: A rescue operation of at least nine hours to save a five-year-old boy who fell into a borewell in a village in Maharashtra's Ahmednagar district proved futile as he was pulled out dead in the wee hours of Tuesday.

The deceased, Sagar Barela, was the son of a sugarcane worker who hailed from Burhanpur in Madhya Pradesh.

The child fell into the borewell in Kopardi village under Karjat tehsil, around 125 km from Pune city, at around 5 PM on Monday, shortly after he got down from a bullock cart, a police official said.

Personnel of the National Disaster Response Force (NDRF), along with local police and district administration personnel, launched an operation to rescue him.

"The boy was pulled out dead from the borewell at around 2 AM on Tuesday," a police official said.

BAR-HEADED GEESE SPOTTED TN AFTER TWO ECADES

Amolraj said: "The bar-headed geese were spotted at Pulicat recently and our team had spotted it in Chennai in December. Interestingly, the barheaded geese were elusive for the past two decades and its presence

These species of geese fly at high altitudes and studies revealed that they have been heard flying across Mount Makkalu, which is the fifthhighest mountain on earth and had apparently been seen over Mount Everest too.

Environmentalists are also keen to study the recent spotting of barheaded geese in Tamil Nadu water bodies. Environmental scientist and researcher with Madurai-based Action Centre for Environmental Protection, Sujith Chandran said that "there seems to be some climatic formation that has led to the presence of bar-headed geese after nearly two decades in water bodies of Tamil Nadu".

"We are closely monitoring this along with a few ornithologists and amateur bird watchers including Sikander, the boatman of Pulicat who had spotted the Barheaded goose a few days ago.'

With the bar-headed geese being spotted in Tamil Nadu water bodies, the presence of ornithologists from many parts of South India has increased in Pulicat to know -(more about the bird and its migratory patterns.

As per the MoU, the Truecaller will display official numbers of Delhi Police representatives on their Delhi Police Directory Services and all verified numbers will have a green badge and a blue tick mark, with a government services tag highlighting it. "The partnership with Truecaller will help the public in identifying verified numbers and protect them from cyber fraud and impersonation scams in the



name of government officials," said Nalwa.

"Delhi Police shall also be regularly sharing a list of phone numbers against which they have received complaints about harassment, scam or issues registered against them with Truecaller to mark them as spam or fraud on the platform to protect citizens and alert them in case these numbers continue to remain active. To thwart cyber threats. Truecaller, in association with Delhi Police, will generate cyber safety awareness by training citizens in Delhi," said Nalwa.

During the function, the Special CP, Singh recalled how the quick response by Delhi Police helped in curbing increasing cyber crimes.

Hosps witnessing spike in H3N2 cases: Doctors

New Delhi, March 14: Delhi hospitals are witnessing a spike in cases of H3N2 virus that triggers symptoms like fever, cold and body aches, but in certain cases, leaves behind persistent cough making patients extremely weak, doctors said.

There has been a nearly 150 per cent rise in patients coming to OPDs with such complaints, they said. Elaborating about the possible reasons behind the surge, Dr Viny Kantroo, Consultant, Respiratory, Critical Care and Sleep Medicine Consultant, Indraprastha Apollo Hospitals, said the outbreak could have been triggered due to seasonal change, mutation of virus and the economy being fully open.

'Children are going to school and they are transmitting it to the elderly. A lot of cross-country travel is happening. In the last two years, Covid was the dominant virus and there were restrictions but with relaxation of norms and return of normalcy, these outbreaks are being observed," she opined.

Delhi government's LNJP Hospital has set up a 20-bed isolation ward in the emergency block for such patients. In accordance with the ICMR guidelines, we have

Explaining about the current strain, Dr Vikas Deswal, Senior Consultant, Internal Medicine, Medanta, Gurugram said the influenza virus is the most prevalent virus that affects our respiratory system, and is present in three different types: A, B, and C.

"Among these, subtype A is the most commonly found. One subtype of the influenza A virus is H3N2, which produces symptoms simi-

ing down guard at this time and said since viruses mutate over time, so it is important to take pre cautions.

"Antibiotics are not effective in treating viral infections such as H3N2 and can be harmful, so people should avoid taking them, especially if they have H3N2.

"The virus spreads through droplets and direct contact, so it is recommended to follow precautions such as avoid touching surfaces, wash hands, follow Covidappropriate behaviour, practice social distancing, wear masks, and avoid going out if experiencing viral symptoms. Additionally, it is important for people to get vaccinated against influenza every year," he said.

New Delhi, March 14: Scientists have determined why smog forms at night during winters in the national capital, contrary to all the rules of atmospheric chemistry.

A team of researchers from the Paul Scherrer Institute (PSI) in Switzerland along with scientist from the Indian Institute of Technology (IIT) Kanpur and colleagues investigated the origin of these extremely high particulate levels in nighttime New Delhi in winter. "The chemical processes that take place in the air at night are unique to the Indian capital and have not been observed anywhere else in the world," said Imad El-Haddad, an atmospheric chemist at PSI and one of the corresponding authors of the study.

ing. In the absence of strict regulations, materials other than wood are also burnt, sometimes including plastic and other waste materials, the resaerchers said.

Such fires produce a mixture of gases containing countless chemical compounds, such as cresol, which our noses associate with the typical smell of fire, as well as sugarlike molecules from the burnt cellulose in the wood, they said. These molecules, the team noted, cannot be seen in the air with the naked eye, even in high concentrations.

However, as night falls the temperature in New Delhi drops so rapidly that some of the gas molecules condense and within a few hours clump together to form particles up to 200 nanometres across, which can be seen as a gray haze, they said.

This process, the researchers said, is very different from that in other places. Beijing, for example, is probably the best-studied megacitv in the world in terms of its air pollution. However, in the atmosphere of the Chinese capital, par-

ticle formation follow different chemical pathways, according to the researchers.

In China, the gases from emissions such as traffic and wood burning react in the atmosphere during the day when they are exposed to light resulting in the formation of less volatile fumes capable of forming particles during the haze, they said. Such a pathway was also expected in New Delhi, however the opposite happens. Haze formation from the condensation of directly emitted fumes occurs at night, without photooxidation, driven by increased emissions together with a sharp decrease in temperatures.

NASA-LED STUDY REVELATION Warming makes droughts, wet events more frequent, intense

DROUGHTS AND FLOODS WILL BECOME MORE FREQUENT AND SEVERE AS OUR PLANET WARMS AND CLIMATE CHANGES. SCIENTISTS HAVE PREDICTED, BUT DETECTING THIS ON REGIONAL AND CONTINENTAL SCALES HAS PROVEN DIFFICULT, THE STUDY SAID

New Delhi, March 14: Major droughts and pluvials - periods of excessive precipitation and water storage on land - have indeed been occurring more often, confirmed a new National Aeronautics and Space Administration(NASA)-led study

Droughts and floods will become more frequent and severe as our planet warms and climate changes, scientists have predicted, but detecting this on regional and continental scales has proven difficult, the study said.

Two NASA, US, scientists examined 20 years of data from the NASA/German GRACE and GRACE-FO satellites to identify extreme wet and dry events, the study published in the journal Nature Water said. Floods and

droughts account for more than 20 per cent of the economic losses caused by extreme weather events in the US each year. The economic impacts are similar around the world, though the human toll tends to be most devastating in poor neighbourhoods and developing nations.

The scientists also found that the worldwide intensity of these extreme wet and dry events - a metric that combines extent, duration, and severity - is closely linked to global warming. From 2015-2021 seven of the nine warmest years in the modern record - the frequency of extreme wet and dry events was four per year, compared with three per year in the previous 13 years.

This makes sense, said the authors, because warmer air causes more moisture to evaporate from Earth's surface during dry events;



warm air can also hold more moisture to fuel severe snowfall and rainfall events.

"The idea of climate change can be abstract. A couple of degrees

droughts and wet periods, which affects people, the economy, and agriculture around the world. Monitoring hydrological extremes is important for preparing for future events, mitigating their impacts, and adapting," said Rodell.

Rodell and study co-author Bailing Li studied 1,056 extreme wet and dry events from 2002 to 2021, as observed by the Gravity **Recovery and Climate Experiment** (GRACE) and GRACE-Follow-On (GRACE-FO) satellites.

The satellites use precise measurements of Earth's gravity field to detect water storage anomalies - specifically, how the amount of water stored in soils, aquifers, lakes, rivers, snow cover, and ice compares to normal, the study said. "It's like watching the level of the water in your bathtub. "You can see how much it rises and falls

without knowing the total amount of water in the tub," said Rodell.

Because GRACE and GRACE-FO provide a new map of water storage anomalies around the world every month, they provide a comprehensive view of the severity of hydrological events and how they evolve over time, the study said.

In their study, Rodell and Li applied an "intensity" metric that accounts for the severity, duration, and spatial extent of droughts and extreme wet events.

They found the global total intensity of extreme events increased 🛁 from 2002 to 2021, mirroring Earth's rising temperatures over the same period.

According to the study, by far the most intense event identified in the study was a pluvial thatbegan in 2019 in central Africa and is still ongoing.

Russian jet collides with US drone over Black Sea

Hong Kong, March 14: A Russian Su-27 fighter jet intercepted and struck the propeller of a US military MQ-9 "Reaper" surveillance drone Tuesday, causing it to crash into the Black Sea in an incident condemned as "unsafe" by the US military.

Two Russian Su-27 jets carried out the intercept of the American spy drone, and one of them collided with it at 7:03 a.m. (0603 GMT). Several times before the collision, the Russian fighter jets dumped fuel on the MQ-9 and flew in front of it in unsafe maneuvers, the US military said in a statement.

"Our MQ-9 aircraft was conducting routine operations in international airspace when it was intercepted and hit by a Russian aircraft, resulting in a crash and complete loss of the MQ-9," US Air Force General James Hecker, who oversees the US Air Force in the region, said in a statement.

"In fact, this unsafe and unprofessional act by the Russians nearly caused both aircraft to crash." There was no immediate comment from Moscow

The US military said the incident followed a pattern of dangerous behavior by Russian pilots operating near aircraft flown by the US and its allies, including over the Black Sea. The Black Sea lies between Europe and Asia and is bordered by Russia and Ukraine among other countries.

PTTs Fawad Chaudhry also asked the party supporters to gather in the streets in a peaceful protest in a show of solidarity with Imran.

Armoured police vehicles had arrived outside Zaman Park with the intention of arresting Imran but a senior Islamabad police official, Deputy Inspector General (DIG) (Operations) Shahzad Bukhari, had refrained from commenting on the case in which officials were acting against the PTI chairman.

However, almost an hour later, police used a water cannon and tear gas against PTI supporters that had gathered outside Zaman Park in droves. Footage broadcast on television showed police slowly inching toward the residence behind an armoured vehicle that was dispersing PTI supporters with a water cannon. Supporters could also be seen pelting stones at the policemen, Dawn reported.

Footage also showed PTI supporters being tear-gassed as police arrived close to the main gate of Zaman Park. The workers, who had covered their faces with pieces of cloth and were carrying bottles of water, continued to pelt stones at officials.

Driver faces murder charges

Toronto: A 38-year-old Canadian man is facing murder charges after allegedly ramming a pickup truck through pedestrians in an eastern Canada town, killing two men and injuring nine people who were walking alongside a road. Since the beginning of the year, a number of streptococcus infections have been recorded across the nation and the majority of cases have involved people eating pork products such as blood pudding, or those who slaughter pigs, Xinhua news agency quoted the local media as saying.

Cyclone Freddy kills 190 in Malawi REUTERS Blantyre, March 14: Cyclone Freddy, one of the most powerful

storms ever recorded in the southern hemisphere, has killed 190 people in Malawi after ripping through southern Africa for the second time in a month, Malawi's government said Tuesday.

The district around the commercial hub of Blantyre was among the hardest-hit. Severe flooding and rain damaged roads and bridges, hampering relief operations.

Washington, March 14: The Environmental Protection Agency Tuesday proposed limiting the amount of harmful "forever chemicals" in drinking water to the lowest level that tests can detect, a long-awaited protection the agency said will save thousands of lives and prevent serious illnesses, including cancer.

The plan marks the first time the EPA has proposed regulating a toxic group of compounds that are widespread, dangerous and expensive to remove from water.

PFAS, or per-and polyfluorinated substances, don't degrade in the environment and are linked to a broad range of health issues, including low birthweight babies and kidney cancer. The agency says drinking water is a significant source of PFAS exposure for people.

"The science is clear that longterm exposure to PFAS is linked to significant health risks," Radhika Fox, assistant EPA administrator for water, said in an interview. Fox called the federal proposal a "trans-



formational change" for improving the safety of drinking water in the United States. The agency estimates the rule could reduce PFAS exposure for nearly 100 million Americans, decreasing rates of cancer, heart attacks and birth complications. The chemicals had been used since the 1940s in consumer products and industry, including in nonstick pans, food packaging and firefighting foam. Their use is now mostly phased out in the US, but some still remain.

The proposal would set strict limits of 4 parts per trillion, the lowest level that can be reliably measured, for two common types of PFAS compounds called PFOA and PFOS. In addition, the EPA wants to regulate the combined amount of four other types of PFAS. Water providers will have to monitor for PFAS.

The public will have a chance to comment, and the agency can make changes before issuing a final rule, which is expected by the end of the year. Water providers will have time to adjust. Environmental and

public health advocates have called for federal regulation of PFAS chemicals for years. Over the last decade, the EPA has repeatedly strengthened its protective, voluntary health thresholds for the chemicals but has not imposed mandatory limits on water providers.

Public concern has increased in recent years as testing reveals PFAS chemicals in a growing list of communities that are often near manufacturing plants or Air Force bases. Until now, only a handful of states have issued PFAS regulations, and none has set limits as strict as what the EPA is proposing. By regulating PFOA and PFOS at the minimum amounts that tests can detect, the EPA is proposing the

tightest possible standards that are

technically feasible, experts said.

SVB's demise disrupts disruptors in tech

Entrepreneurs who had deposited all their startups' money in Silicon Valley Bank are now realising it makes more sense to spread their funds across several institutions

San Francisco, March 14: Silicon Valley Bank's collapse rattled the technology industry that had been the bank's backbone, leaving shellshocked entrepreneurs thankful for the government reprieve that saved their money while they mourned the loss of a place that served as a chummy club of innovation.

"They were the gold standard, it almost seemed weird if you were in tech and didn't have a Silicon Valley Bank account," said Stefan Kalb, CEO of Seattle startup Shelf Engine, during a Monday interview as he started the process of transferring millions of dollars to other banks.

The Biden administration's move guaranteeing all Silicon Valley Bank's deposits above the insured limit of \$250,000 per account resulted in a "palpable sigh of relief" in Israel, where its booming tech sector is "connected with an umbilical cord to Silicon Valley. said Jon Medved, founder of the Israeli venture capital crowdfunding platform OurCrowd.

But the gratitude for the deposit guarantees that will allow thousands of tech startups to continue to pay their workers and other bills was mixed with moments of reflection among of entrepreneurs



and venture capital partners rattled by Silicon Valley Bank's downfall. The crisis "has forced every com-

pany to reassess their banking arrangements and the companies that they work with," said Rajeeb Dey, CEO of London-based startup Learnerbly, a platform for workplace learning.

Entrepreneurs who had deposited all their startups' money in Silicon Valley Bank are now realising it makes more sense to spread their funds across several institutions, with the biggest banks considered safer harbours. Kalb started off Monday by opening an account at the largest bank in the US, JP Morgan Chase, which has about \$2.4 trillion in deposits. That's 13 times

more than the deposits at Silicon Valley Bank, the 16th largest in the US

Bank of America is getting some of the money that Electric Era had deposited at Silicon Valley Bank and the Seattle startup's CEO Quincy Lee expects having no difficulty finding other candidates to keep the rest of his company's money as part of its diversification plan.

"Any bank is happy to take a startup's money," Lee said.

Even so, there are fears it will be more difficult to finance the inherently risky ideas underlying tech startups that became a specialty of Silicon Valley Bank since its founding over a poker game in 1983, just as the advent of the personal com-

puter and faster microprocessors unleashed more innovation.

Silicon Valley quickly established as the "go-to" spot for venture capitalists looking for financial partners more open to unconventional business proposals than its bigger more established peers who still didn't have a good grasp of technology

"They understood startups, they understood venture capital," said Leah Ellis, CEO and co-founder of Sublime Systems, a company in Somerville, Massachusetts commercializing a process to make low-carbon cement. "They were woven into the fabric of the startup community that I'm part of, so banking with SVB was a no brainer.³

Venture capitalists set up their accounts at Silicon Valley Bank just as the tech industry started its boom, and then advised the entrepreneurs that they funded to do the same.

That cozy relationship came to an end when the bank disclosed a \$1.8 billion loss on low-yielding bonds that were purchased before interest rates began to spike upward last year, raising alarms among its financially savvy cus tomer base who used the fruits of technology to spread warnings that turned into a calamitous run on deposits.

Wholesale inflation eases to 2-year low

New Delhi, March 14: The wholesale price-based inflation declined to over two-year low of 3.85 per cent in February on easing prices of manufactured items, fuel and power, even though food articles remained expensive.

This is the ninth straight month of decline in the rate of wholesale price-index (WPI) based inflation. The WPI inflation was 4.73 per

cent in January and 13.43 per cent in February, last year. "Decline in the rate of inflation in February 2023 is primarily con-

tributed by fall in prices of crude petroleum & natural gas, non-food articles, food products, minerals,

computer, electronic & optical products, chemicals & chemical products, electrical equipment and motor vehicles, trailers & semitrailers," the commerce and industry ministry said Tuesday.

The 3.85 per cent WPI inflation is the lowest since January 2021, when the rate of price rise on wholesale basis was 2.51 per cent.

The decline in the rate of price rise was mainly due to a favourable base effect, economists said, adding that going forward, softening commodity prices would help ease WPI inflation further.

However, the future course of food inflation would depend on weather related conditions and timely monsoon

Although inflation in manufactured items softened, in the case of food articles it rose to 3.81 per cent in February, from 2.38 per cent in January.

Inflation in pulses was 2.59 per cent, while in vegetables was (-) 21.53 per cent.



days when claims settlement was a long-drawn process; today insurers are heavily adopting newage technologies and tools to settle claims within a few hours, or even within minutes!

Solvency Ratio: Solvency Ratio reflects the cash inflow of an insurer against their liabilities; it indicates a company's ability to fulfill their liabilities. Simply put it indicates the financial health of the insurer. The insurance regulator, IRDAI mandates all companies to maintain a solvency ratio of 150% or 1.5. A company with a higher solvency ratio is likely to have a better claim paying ability.

Cashless network of the insurer: Every insurer has a list of network hospitals and garages spread across different cities where the insured gets to avail the facility of cashless claim settlement in these empaneled hospitals and garages. The biggest advantage of network hospitals and garages is that the insured gets hassle-free, fast, and quality service without spending anything, unlike the non-network hospital and garages where the insured has to make the initial payment that is later reimbursed by the insurer. The wider the network of the insurer; the better as it makes the entire process much smoother and stress-free for the insured.

Apart from the aforementioned points, it is important to know about the reputation of the insurer, their customer service, and their support before finalising the insurer. We have many insurers, offering different products, and many times these products are surprisingly low-cost. As a buyer, you must exercise due diligence, and do research about your potential insurer. At times, the low pricing is just used to woo a customer, however, at the time of claim, these companies may not be

forthcoming and supportive. On the contrary, the companies with better services might have slightly expensive products but they are also likely to have better claim paying capability, faster services, and a wider network. You should give more weightage to the 'value, which the insurer brings to you rather than just focusing on the 'price.' Always, go with an insurer of repute, someone who is known for their customer support and their overall servicing capabilities. Your insurer should be a company that firmly stands by you during the time of need and settles the claims, swiftly and gracefully.

Virat opens up on low times MI eves seal playoff berth

Ahmedabad, March 14: India's star batter Virat Kohli has admitted that not being able to make any substantial contribution to team India's cause for a long time was "eating him up" and he let the expectations overwhelm him a bit because he was desperate to score a big Test hundred.

In a conversation with head coach Rahul Dravid, the 34-year-old Kohli revealed that the weight of expectations became a bit tough to handle for him.

"Honestly, I've let the complications grow on me a bit because of my shortcomings," Kohli told Dravid in the chat, the video of which was posted by the BCCI on its website.

"The desperation to get to the three-figure mark is something that can grow on you as a batsman. I let that happen to me to a certain extent. But a flip side to it is, I'm not a guy who is happy with 40-45. I take a lot of pride in performing for the team. It's not like when Virat Kohli should stand out. When I'm batting on 40, I know I can get a 150. That was eating me up a lot.

"Why am I not able to get that big score for the team? Because I took pride in the fact that when the team needed me, I stood up, scoring in difficult conditions. The fact that I wasn't able to do that, was bothering me," he added.

Asked by Dravid how tough it was, Kohli said, "If I've to be brutally honest, it does become a little difficult as the moment you step out of the hotel room, right from the guy outside, to the guy in the lift. the bus driver everyone is saying 'we want a hundred'

"So, it does play on your mind all the time but that's also the beauty of playing for so long to have these complications come up and overcome these challenges," Kohli said. Dravid said he was also desper-

ate to see former skipper score that big hundred but it was worth in the end since Kohli delivered a

master class.

"I've seen him as a player, seen a lot of hundreds of him on TV and after I took over the coach about 15-16 months ago, was a bit desperate to see him score a Test hundred and really enjoy it from

the comfort of the dressing room "To be able to enjoy and relax a Test hundred. It was a beauty. You made me wait a long time but it was an absolute privilege to watch an innings and the way you con-

structed it," said Dravid. Before this match, Kohli's last Test century had come in India's

maiden Day/Night Test against Bangladesh in November 2019. Kohli insisted that he never thought "about the milestones".

"A lot of people ask me, 'how do you keep scoring those hundreds'. And I always say a hundred is something that happens along the way within my goal, which is to bat as long as possible for my team."

Kohli credited his fitness to be able to bat in different ways which help him excel in all formats. "I can bat four sessions, I can bat five sessions, that's where the fitness and physical preparation comes into play for me.

"I go into the field relaxed because I know I can bat in many ways. I am not desperate if I play three sessions and feel like I am breaking down and I need to get fast runs otherwise I won't be able to stay out there for long," he said.

"I am pretty happy scoring 30 runs in a session and not hitting a boundary and absolutely not be desperate because I know that boundaries will come and even if I have to play like this I can bat six sessions and get a 150. I have no issue doing that.'

Indian Wells (US), March 14: Defending champion Taylor Fritz routed Sebastian Baez 6-1, 6-2 in the third round of the BNP Paribas Open.

The fourth-seeded Fritz served four aces and won 88 per cent of his first-serve points against the 30thseeded Baez from Argentina Monday. Andy Murray's run ended in a 7-6(8-6), 6-2 loss to 21-year-old Jack Draper. Murray has not won three consecutive matches at a Masters 1000 event since he won the title in Paris in 2016.

Also advancing was Stan Wawrinka, who defeated No.7 seed Holger Rune, 2-6, 7-6(7-5), 7-5. American Tommy Paul beat ninthseeded Hubert Hurkacz, 4-6, 6-2, 6-4.

Rune saved a match point and rallied from 2-5 down to win the second-set tiebreaker. But Wawrinka recovered in the third to send his 19-year-old opponent packing.

Wawrinka reached the fourth round in the Southern California

desert for the first time since 2017, when he lost in the final. He turns 38 next month. No.8 Felix Auger-Aliassime avoided the upset bug and beat Francisco Cerundolo, 7-5, 6-4. In women's action, top-ranked Iga

Madrid, March 14: Real Madrid got used to pulling off dramatic comebacks in the Champions League last season. Now they need to avoid one to keep their title defense going.

It will be Liverpool needing to do something magical at the Santiago Bernabéu Stadium Wednesday to reverse a 5-2 loss from the first leg in the round of 16.

It definitely won't be easy – no away team has ever erased a three-goal loss from the first leg in the Champions League. Only five times the team that lost at home rallied in the second leg, with Manchester United the only one to overcome a two-goal deficit in a round-of-16 matchup against Paris Saint-Germain in 2019.

Liverpool did manage a huge comeback at home in the 2019 semifinals, rallying against another Spanish club, Barcelona. They had lost 3-0 at the Camp Nou before pulling off a 4-0 win in the second leg at home to keep alive a run that eventually ended with the team winning the trophy. Only three other teams overcame a deficit of three or more goals -Barcelona, Roma and Deportivo La Coruña.

Madrid, who beat Liverpool in last season's final for a recordextending 14th European title, pulled off thrilling comebacks on

its way to that final, rallying from behind against PSG in the round of 16, Chelsea in the quarterfinals and Manchester City in the semifinals.

Madrid also rallied against Liverpool in the first leg this season after going down 2-0 in the first half in England, eventually building their comfortable threegoal advantage with two goals each by Vinícius Júnior and Karim Benzema. Éder Militão also scored for Madrid at Anfield.

The only time Madrid failed to advance in the Champions League after winning the first leg on the road was in 2019 when they were eliminated by Ajax in the round of 16. Madrid have won six of their last seven matches against Liverpool in the Champions League, drawing the other one.

The team coached by Carlo Ancelotti ended a three-match winless run with a 3-1 victory over Espanvol at the Bernabéu in the Spanish league Saturday. The coach is expected to have Ferland Mendy and Benzema available after recovering from injuries

Liverpool took another hit to ২ their confidence with a 0-1 loss at relegation-threatened Bournemouth over the weekend, hurting their chances of moving closer to the top four in the Premier League. Mohamed Salah missed a penalty in that game.

HC refuses to interfere with non-selection of boxers

New Delhi, March 14: The Delhi High Court Tuesday refused to interfere with the non-selection of three national champions Manju Rani, Shiksha Narwal and Poonam Poonia for the upcoming Women's World Boxing Championships.

Justice Prathiba M Singh said in view of the medal tally and evaluation forms of the players, no case for interference with the list of boxers selected to represent the country in the sporting event was made out and the petitioners shall continue to remain in the reserve -list for the championship

"The court notices that scope of

interference in a writ petition is limited. The evaluation form has been perused by the court as also the medal tally. The present is not a case for interference under Article 226. The team which has been selected is permitted to go ahead and rep-

resent India," the judge said. The championship is set to take place from March 15 to 31 in Delhi. Earlier, the counsel for the petitioners had said during 2018 to 2022. the performance of the petitioners was better than the selected players who hardly owned any medals.

Tuesday, the counsel for Boxing Federation of India (BFI) said the petitioners' assertion was misleading as the selected players represented

the country in recent events and won medals, including a gold medal Nitu Ghangas clinched in the Commonwealth Games last year.

The court perused the medal tally prepared by the BFI and refused to grant any interim relief to the petitioners. "I have seen the chart. They (selected players) are equally competent," the court stated.

The petitioners also contended that the one of the coaches who evaluated the players in the selection process was not even present during the camp for certain durations. The court granted time to the BFI

to file a response to the petition which has prayed for constitution of a committee for fair selection of players.

The petitioners had approached the HC earlier this month over their non-inclusion and asserted the selection ought to happen on the basis of meritorious performances in the past. The petitioners had told the court they had defeated all those who have been selected at the nationals held in December 2022.

The BFI earlier submitted that winning a gold medal was only one of the qualifying criteria and the players were evaluated at the national camp on the basis of selection criteria for national camps and Worlds. According to the BFI, the new selection policy for the men's and women's Worlds and the Asian Games was followed to pick the national

team and Manju (48 kg), Shiksha (54 kg) and Poonam (60 kg) could not make it to the 12-member side.

According to the new policy, drafted in consultation with High Performance Director (HPD) Bernard Dunne, the boxers underwent an evaluation process for three weeks where they were judged on various parameters. Nine of the 12 national champions were ranked one and qualified for the marquee event.

CWG champion Nitu Ghangas (634), Preeti (623) and CWG bronze medallist Jaismine Lamboria (612), finished ahead of the petitioners - Manju (564), Shiksha (573) and Poonam (567) in the evaluation test and were ranked one
