Drivers' protest hits normal life

People stranded on many routes due to lack of buses while commercial vehicles stopped by protesters at many places in Odisha

POST NEWS NETWORK

Bhubaneswar, March 15: Normal life in many places across Odisha was hit hard Wednesday as a large number of drivers took to the streets across the state paralysing public and commercial transport. To press for their 10point charter of demands, thousands of drivers of public and commercial vehicles launched an indefinite 'quit steering' protest. More than five lakh drivers are taking part in the agitation, officials said.

The agitating drivers have been demanding pension after 60 years of age, death benefits, life insurance, social security, parking and toilet facilities all across Odisha. The drivers resorted to road blocks on most of the national highways, major roads and picketed at different places across the state ncluding capital city Bhubaneswar, Cuttack, Bargarh, Deogarh, Koraput, Dhenkanal, Jajpur, Angul

It should however, be stated that the strike called by the 'Odisha Driver Mahasangha' was not supported by private bus and truck owners, auto-rickshaw drivers and online cabs. However, very rarely was a bus or any other mode of public transport seen on the roads

Balasore, Puri, Berhampur, Rourkela, Sambalpur and other district headquarters since early morning.

"I arrived in Bhubaneswar this (Wednesday) morning and am waiting for a bus to go to my village Betanati in Mayurbhanj district. I do not know when bus services will resume," said a passenger at the Baramunda bus stand. A student planning to travel to Dhenkanal had a similar tale to tell at the Badambadi bus terminus in Cuttack.

Representatives of the drivers' association said that they had no option but to resort to strike as the Odisha government was not paying any heed to their demands despite repeated reminders.

"To put pressure on the government over our longpending demands, we have launched this peaceful protest. We are allowing all emergency service vehicles and schoolchildren and other people who are driving their own vehicles to move around freely," said Prasant Menduli, president of 'Odisha Driver Mahasangha'.

"The state government had assured us that it will form a committee to consider our demands when we were on strike the last time. But no action was taken. We will continue the strike till our demands are met," he said.

Transport Minister Tukuni Sahu said, "A high-level committee will be set up to look into the demands of the drivers. The state government will certainly take positive steps to end the strike. We again appeal to the drivers to call off the strike as the Class-X examination is on.'

In a separate development, the issue of drivers' strike came up in the Assembly too with the BJP and Congress MLAs expressing concern over the disruption of road transport services. Congress Legislature Party (CLP) leader Narasingha Mishra and Opposition (BJP) Chief Whip, Mohan Maji urged the government to resolve the matter and ensure the commencement of public transport at the earliest. Under-construction bridge collapses

Kendrapara, March 15: Labourers engaged in construction of a bridge on Gobari river at Tinimuhani Square in this district, had a close shave after an under-construction bridge collapsed Wednesday morning. Those that were working in the vicinity of the bridge ran for their lives as large portions of cement slabs suddenly came off.

Sources said, the bridge is being constructed over the southern part of Gobari river. Once completed it will serve as a second by-pass road and connect the new Kendrapara bus terminal with the Chati bridge at Tinimuhani. Currently traffic snarls have become a headache for commuters for which the decision to construct a new bridge was taken.

The construction of the bridge is being done by ARSS Infrastructures Ltd under the supervision of the public works



department (PWD). Sources said that fault in construction led to the collapse of the bridge. They informed that within 14 hours of the girder being placed on the pillars, the bridge collapsed. The sources also said that usually 50-60 labourers are present at the construction site. Luckily that was not the case Wednesday otherwise there would

Burning midnight oil not helpful for students

LACK OF REQUISITE AMOUNT OF SLEEP OFTEN CREATES ANXIETY AND STRESS AND THAT MAY HAMPER A STUDENT'S PERFORMANCE

New Delhi, March 15: Exams are a period of acute stress. In fact if one takes into account the life of a student in the 21st century, it can safely be said that they are always at stress. Remember the movie 3 Idiots and how students react to stress!

Some students get extremely stressed and some are able to cope well, remain healthy and perform well in their academics and career. So what is it that actually helps the student to reach that potential?



not count sleep as part of health. In fact, it comes way down in the list of priorities and most students pride themselves for not sleeping during the exams

A large chunk of this idea has

been created by a false belief system which states that the student must revise the exam portion the previous day as part of last minute preparations. For whatever may be the reason, a good night sleep not only the day before the exam, but also one month prior to exam is essential, according to the researchers.

But why is sleep so essential for students and why do researchers assert that on average a good eightnine hours of restful sleep helps students? This is because that amount of sleep is required for optimal functioning of the body and mind.

Good sleep stabilises various facets of the body like blood sugar, insulin level, cholesterol, leptin, ghrelin and cortisol levels. These hormones are essential for proper functioning of the body. However, lack of sleep affects all these issues and weakens both the mind and body of students appearing for the exams. The students lose their retentive powers and hence they cannot do well in the exams, the scientists said in their report.

Increase in cortisol level also interferes with cognition and memory leading to poor recall, confusion and forgetfulness. These create anxiety, nervousness, stress and fear in the mind of the student. And with an anxious mind, it is impossible for a student to perform well in the exams, the researchers said.

Directed by Ashima Chibber the movie, slated to release March 17, talks about the life of an immigrant mother that fights against all odds to win back the custody of her children.









MLAs pitch for salary hike

Bhubaneswar, March 15: Amid rising prices of commodities, MLAs cutting across party lines Wednesday urged Speaker BK Arukha to give a ruling to the government to introduce a Bill in the House for raising the salary and pension of sitting members and ex-MLAs.

The issue was raised during Zero Hour by Congress Legislature Party (CLP) leader Narasingha Mishra which was supported by Opposition Chief Whip Mohan Majhi of the BJP and two BJD members - Amar Prasad Satpathy and Padmanabha Behera.

A committee headed by Satpathy has already submitted a report on a proposal to hike the salary and pension of MLAs and ex-legislators, Mishra said, adding that the state government should consider it and table a Bill so that the House can pass it.

He cited the high inflation rate, particularly the increasing price of petrol and diesel, which added to the "hardships of members to perform their responsibilities".

The travelling allowance of the members should also be raised in view of the

price rise of fuel, Mishra said. According to the existing salary structure, only ₹5,000 is being provided to appoint an assistant, which is grossly in-

adequate, he claimed. "On behalf of all the members, I urge the Speaker to give a ruling to the gov-

ernment to table a Bill in this regard,' Mishra said. Congress whip Taraprasad Bahinipati

also made a similar demand. Opposition Chief Whip Mohan Majhi supported the proposal to introduce a Bill at the earliest as the members and ex-MLAs face difficulties for their day-to-day

Satpathy said, "I have submitted the report and the Parliamentary Affairs

The Odisha government had raised the salaries of MLAs and ministers by over

50 per cent in 2017. Meanwhile, sources said the committee has sent a proposal to the Speaker recommending that an MLA's salary should be hiked from ₹1 lakh a month to ₹2.5

Currently, each MLA gets a package of ₹1 lakh, which includes ₹35,000 as salary

and ₹65,000 as allowances. This excludes a daily allowance of ₹1,500 per day while the House is in session, besides the travel reimbursement

Notably, retail inflation dipped marginally to 6.44 per cent in February, mainly on account of a slight easing in prices of food and fuel items though it remained above the Reserve Bank's comfort level of 6 per cent for the second month in a row. As per the government data released Monday, the Consumer Price Index (CPI)based inflation was at 6.52 per cent in

2,823 schools shut for poor enrolment

January and 6.07 per cent in February 2022

Bhubaneswar: The state government has shut down 2,823 schools having enrolment of 20 or less than 20 students, School and Mass Education (S&ME) Minister Sameer Ranjan Dash said in the Assembly, Wednesday. Replying to a question of Gajapati MLA K Narayan Rao (BJP), the minister said the government has approved consolidation of 4,757 schools having enrolment of 20 or less than 20 students. So far, as per the policy rationalisation and consolidation of schools, 2,823 satellite schools have been merged with the nearby lead schools, he said. Over 2,000 RLBs lack internet connectivity

New Delhi, March 15: At least 2.486 Rural Local Bodies (RLBs) in the state of Odisha are without internet connectivity, the Standing Committee on Rural Development and Panchayati Raj noted and requested the Union government to take concrete steps for providing internet connectivity in

The committee in its report noted that there are 6794 RLBs in Odisha and out of them 4308 RLBs have internet connectivity. The committee observed that the Ministry of Panchayati Raj aims at 'Digitization of Gram Panchayats' by providing broadband connectivity to more than 2.55 lakh GPs of the country in collaboration

"However, the committee acknowledged that progress of the 'BharatNet Project' is not encouraging. Only 80,742 rural local

bodies have active internet connection as on January 21 out of 2,71,102 rural local bodies even though 1.92 lakh Gram Panchavats have been made service ready," the committee noted.

It requested the Ministry of Panchayati Raj to take steps to make all the 1.92 lakh RLBs service ready to have active internet connection during 2023-24 and to connect all GPs with BroadBand connectivity by 2024-25.

The ministry of Panchayati

Raj has informed the committee that it is working with the Ministries of Telecom and IT to provide internet connectivity to RLBs and the target date to reach to all the panchayats is 2024-25. The ministry also informed that in the hilly areas, Northeast areas, and in J&K it will take around

"We hope that in the next six months we will make substantial progress in this regard," the ministry informed.

Govt claims 98% of forest fires doused, task force constituted

Bhubaneswar, March 15: Opposition BJP Wednesday staged a walkout from the Assembly as Odisha Forest minister claimed that the state government has doused 98 per cent of fire incidents in forests and is committed to ensure protection of flora and fauna in different jungles.

The state government's claim was made by Forest, Environment and Climate Change Minister PK Amat who was participating in a debate on admissibility of an adjournment motion notice on the forest fire issue. The minister said that the state government has set up a special technical cell and constituted a task force as part of efforts to extinguish the forest fires. As per their recommendation, a Standard Operating Procedure (SOP) has been issued by the government to control forest fires in

different areas, he said.

Amat said 339 teams deployed for extinguishing forest fires have been provided with vehicles, fire blowers and safety equipment.

Stating that as many as 22,787 hectares of land including forest were hit by forest fire by March 13, 2023, the minister said the forest of ficials have been able to douse jungle blaze in 98 per cent of places. He said of the 22,787 hectares of land, 4,563 hectares was not forest area which is 20 per cent of the total area affected by forest fire.

Amat said that there was no rainfall since October last year and forest fire was mosly "man-made."

The minister blamed the BJP for deducting funds under Forest

Fire Prevention and Management Scheme. While the state should receive ₹72 crore between 2018 and 2023, it received only 26.3 crore "Despite fund cuts, we have been able to douse 98 per cent of forest fire," Amat claimed which irked the BJP members.

BJP members Mohan Majhi and Bhaskar Madehi and Mukesh Mahaling accused the state of telling lies in the House. "Had the state doused 98 per cent of fire, how the fire incidents take place almost on daily basis," Mahaling said, Congress MLA Suresh Routray alleged that there is no effort from the state to douse the forest fire which is evident from the Forest

Mild fever helps clear infections: Study

t may be better to let a mild fever run its course instead of automatically reaching for medication, new research sug-

Researchers from the University of Alberta found that untreated moderate fever helped fish clear their bodies of infection rapidly, controlled inflammation and repaired damaged tissue.

The research showed that natural fever offers "an integrative response that not only activates defences against infection, but also helps control it", said lead author immunologist Daniel Barreda from the varsity.

The study, published in the journal eLife, found that fever helped to clear the fish of infection in about seven days -- half the time it took for those animals not allowed to exert fever.



Fever also helped to shut down inflammation and repair tissues that had been injured

"We let nature do what nature does, and in this case it was very much a positive thing," Barreda said. Moderate fever is self-resolving, meaning that the body can both induce it and shut it down naturally without medication, he explained.

ural fever to humans still have to be confirmed through research, "but because the mechanisms driving and sustaining fever are shared among animals, it is reasonable to expect similar benefits are going to happen in humans," Barreda

That suggests we should resist reaching for over-the-counter fever medications, also known as nonsteroidal anti-inflammatory drugs (NSAIDs), at the first signs of a mild temperature, he noted.

"NSAIDS take away the dis-

comfort felt with fever, but you're also likely giving away some of the benefits of this natural response.

The study helps shed light on the

mechanisms that contribute to the benefits of moderate fever. which "has been evolutionarily

> conserved across the animal kingdom for 550 million years", Barreda "Every animal examined has

this biological response to infection.

Some species, such as fish, reptiles and insects, will even risk predation and decrease their reproductive success to move to temperatures in their environments

One more jumbo carcass found in North Ghumusar

2ND SUCH DEATH IN 2 DAYS; 7 ELEPHANTS HAVE DIED IN 7 MONTHS UNDER THIS FOREST DIVISION

Bhanjanagar, March 15: Two days after the death of a tusker, forest officials have found another decomposed carcass of a female elephant in a forest of Mujagarh range under North Ghumusar forest division here in Ganjam dis-

It is difficult to ascertain the reason behind the animal's death as the carcass has decomposed to a great extent. The elephant bore several injury marks and it was found to have bled and defecated before its death. Forest officials suspect that the animal may have died due to a fight among the herd members

Death of the pachyderm has sparked concern as at least eight elephants have died in Ganjam district in the last eight months, including seven in North Ghumusar division due to different reasons.

Sources said that the carcass of a tusker was recovered near the Jhilimili minor irrigation project under Mujagarh forest range, Monday. The tusker was suspected to have died due to poisoning. Forest officials collected its viscera and



were preparing to send it to $\ensuremath{\mathsf{OUAT}}$ in Bhubaneswar when they were informed about the death of another female elephant.

The female elephant was found dead at Tiliki forest on the Ganjam-Kandhamal district border in North Ghumusar forest division, an official said.

Forest officials rushed to the spot and launched an investigation after seizing the carcass of the deceased female elephant. CCF (Wildlife) Manoj V Nayar, regional chief conservator of forests (RCCF) Prasant Kumar Mishra, DFO Sudarshan Behera, his counterpart in RCCF office RR Pattnaik. ACF Bikram Dev Pattanik, Mujagarh forest ranger Bimbadhar

Sahu, Jagannathprasad ranger Umakant Das, honorary wildlife warden Shulapani Satpathy, former wildlife warden Suresh Swain and Anupam Banerjee reached the spot and took stock of the jumbo death.

The age of the animal was assumed to be around 30 years, and the cause of its death could be ascertained only after post-mortem examination, said divisional forest officer (DFO) Sudarshan Behera. Later, they held a review meeting, while a joint task force team from Bhubaneswar visited the spot and conducted a probe. Later, a post-mortem was conducted and the carcass was buried

Camera traps capture rare wild animals in Atei forest


The camera traps have captured a few schedule-1 species which are on the verge of extinction like Indian gaur, Indian grey wolf, fourhorned antelope, rattle, common palm civet, small Indian civet, ruddy mongoose, grey mongoose, jackal, Indian fox, jungle cat, sloth bear as well as big cats in the jungle.

Apart from these, 21 species of wild animals like spotted deer,

POST NEWS NETWORK barking deer, porcupine, pangolin. Indian hare, wild pig, rhesus macaque were also seen though their numbers are yet to be verified, divisional forest officer (DFO) Dhanraj HD said.

Sources said that Atei reserve forest spread over 1,600 sq km has turned into a safe haven for wildlife. Wild animals feel free to move in the jungle as it is densely surrounded by Similipal, Hadgarh, Satkosia, Revana wildlife sanctuaries and other reserve forests.

However, National Highway-20 and other highways passing through this jungle prove to be deterrent in the free movement of animals. Round the clock movement of iron ore laden



often pose risks for the wild animals. Animal fatalities due to road mishaps while crossing the highwayare very usual.

regular patrolling to keep the animals safe from poachers and other threats. However, it is not easy to monitor the whole jungle due to its enormity. The Forest department should carry out awareness programmes in the area and nab the poachers with the involvement of villagers living on the fringes of the jungle.

Moreover, with summer season drawing near, forest officials should see that wildfires do not spread in the jungle which will only endanger the lives of the wild animals. They should also make sure that the animals do not stray into human habitats facing food and water scarcity in the jungle during summer.

Sundargarh tribal women make eco-friendly leaf plates

Over 2.700 tribal women have been empowered through the initiative

Sundargarh, March 15: Tribal women in Sundargarh have found a new avenue for livelihood assistance through 'Khali Patra' or eco-friendly leaf plate making. There is a rise in demand for the leaf plate prepared from Sal and Siali leaves by these women using modern machines. As a result, over 2,700 women from Sundargarh have engaged in leaf plate making and become self dependent.

The eco-friendly product is being made as part of Van Dhan Vikas Karyakram (VDVK) under Integrated Tribal Development Agency (ITDA) Sundargarh. ITDA further provides necessary training and support to these women, which helps them secure a fair price for their product in the market.

"Earlier, tribal women used to prepare leaf plates by hand and sold it locally which did not earn them a proper price. Keeping this in mind, under VDVK, Women SHG members have been roped in to train them to

prepare eco-friendly leaf plates using modern machines. Market linkage for the same is also being extended by ITDA. In the coming days, the aim is to augment the women's workplace and convert the cottage trade into a Small & Micro Enterprise" informs Project Administrator, ITDA Sundargarh, Ramkrishna Gond.

A total of 18 VDVK units currently function under ITDA Sundargarh. Women SHG members under 9 VDVK units at Balisankra, Tangarpali, Subdega, Lephripara and Hemgir blocks are currently engaged in ecofriendly leaf plate making. Stitching machine, Press and Weighting machine are provided to the women towards the same. ITDA Sundargarh also gives necessary training to the women to operate these machines.

'We have 300 members in our VDVK unit. We do everything from collecting the leaves to developing the finished product. We have got machines for making these ecofriendly leaf plates through ITDA Sundargarh so we can sell the prod-



uct in the market and earn a livelihood," says Secretary of Subdega VDVK unit, Sabita Majhi.

Women of the VDVK unit collect Sal and Siali leaves from the nearby jungles and dry it under the sun to prepare it for stitching. The leaves are first stitched by hand before going through machine stitching. Then, the leaves are put in the press to flatten those and make plates and bowls out of them. Using advanced machines has led to increased efficiency

(VDVK) under Integrated **Tribal Development** Agency (ITDA) Sundargarh

and now, each VDVK unit produces over 1,500 plates and bowls per day. 'There is a demand for the leaf plates being produced by us. We sell the same in the local market as well as take those

to various fairs and festivals. People have

shown a keen interest in purchasing our product. This has also led to an increase in our income," says VDVK unit member Pinky Meher.

Van Dhan Vikas Karyakram (VDVK) has been initiated to provide new avenues of livelihood for tribal men and women using their traditional knowledge and skills. To strengthen the livelihood of tribal women, they are being engaged in new trades outside the traditional work.

Countering Populism

ollowing a year of halting negotiations, six of Turkey's opposition parties have finally united behind a single presidential candidate in the election this May, with the hope of ending Recep Tayyip Erdoğan's increasingly autocratic and repressive two-decade rule. This month, the so-called Table of Six converged on Kemal Kılıçdaroğlu, the leader of the social democratic and secularist Republican People's Party (CHP), after having sidelined younger, more charismatic contenders such as the CHP mayor of Istanbul, who had recaptured the city from Erdoğan's Justice and Development

When an authoritarian populist regime is rigging the democratic game, it is common sense that opposition parties must combine forces to stand any chance of winning elections. But such unity, while necessary, is not sufficient for success; in fact, the hardest part comes after the decision to unite.

Opposition parties that unite to remove a particular leader or party - especially "a populist strongman" – must place that imperative above their other programmatic commitments. After all, populist leaders have a proven track record of undermining democracy, and there is every reason to believe they will do even more damage if re-elected.

For example, Hungarian Prime Minister Viktor Orbán has used the im-

mediate aftermath of unfair elections – when the opposition and civil society were utterly demoralised - to ram through controversial policies and engage in culture-war provocations. Budapest's mendacious memorial to the German occupation, which effectively absolves Hungary of any complicity in the Holocaust, was erected right after the 2014 election.

But, as sensible as this "damage-control" imperative is, it implies that all politics revolves around the strongman. That is exactly what populist leaders want. They excel at using polarisation and personalisation to their own advantage: "It's everyone against me, the only leader who truly represents the people.'

Important recent work by political scientists has shown that not everyone who votes for authoritarian populist leaders is ignorant of or indifferent to their undermining of democracy (not to mention corruption, another hallmark of populist governments). But when confronted with an us-versus-them logic and an opposition coalition whose ultimate intentions are uncertain, they might still opt for what they perceive as the lesser evil.

Moreover, united opposition parties tend to settle on candidates who look a lot like the figure they are opposing, only more democratic Last year, Hungary's opposition alliance agreed to back a conservative Catholic provincial mayor in its effort to remove the far-right populist incumbent. Similarly, successive Israeli

opposition coalitions have sought to beat Prime Minister Binyamin Netanyahu by putting forward tough center-right figures such as the retired general Benny Gantz. The common assumption seems to be that the restoration of democracy is best overseen by old men. It worked for the Democrats in the United States in 2020, and for Western Europe after World War II, when paternalist figures like Konrad Adenauer and Charles de Gaulle dominated German and French politics, respectively.

Yet such strategies often fail, either because they make the opposition look purely reactive, or (less obviously) because they send defeatist signals that the political parameters established by the ruling populists have become the new normal. In Turkey, the Table of Six has so far yielded to nationalist pressure and rebuffed the pro-Kurdish Peoples' Democratic Party (HDP). Similarly, the current opposition to Netanyahu's far-right Israeli government still refuses to include Arab representatives. Strong nationalism – and weak attention to minority rights - is taken as a political given.

Even if anti-populists can unite against a common opponent, changing the parameters of politics is a much more difficult task. Rather than simply appealing to shared dislike of the strongman, they must discuss a broader set of issues and return to questions of policy programmes and basic principles. While ideological heterogeneity can be set aside in the name of defeating a populist incumbent, everyone knows that it will return with a vengeance once that task is accomplished, and this common knowledge leaves voters with doubts about how the coalition would actually govern.

To its credit, the Table of Six has outlined structural reforms that would go a long way toward restoring the rule of law and dismantling the hyperpresidential system that has given Erdoğan virtually unlimited powers. Turkey's Radio and Television Supreme Council and the Council of Higher Education – the kinds of institutions populists specialise in capturing (in the name of "the people," of course) - would become autonomous again. And by committing to rely on impersonal institutions instead of sultan-style rule, the opposition promises a departure from Erdoğan's hyper-inflationary ("unorthodox") economic strategies and erratic foreign policy

But the promise of "institutionalism" is rather abstract, and it can easily be challenged by highlighting high-profile conflicts over policy and (especially) personnel within the heterogenous opposition alliance. To prevail, opposition leaders will have to demonstrate an underappreciated political skill: framing the terms of the election rather than merely reacting to the other side. They cannot simply assume that corruption will topple the ruling party. They also must stress what has gone wrong and find powerful symbols - not just torturously negotiated policy papers - that give a sense of what a different future would feel like. For the Turkish opposition, the recent earthquake - and the regime's failures both before and after that catastrophe – will be an obvious reference point in the run-up to the election. But symbolising a different future is a more demanding challenge.

On Christmas Eve 1940, The Times presented readers with its usual seasonal set of general knowledge questions. One question asked for a definition and derivation of the word godwottery. This was a bit cheeky on the part of the compilers, as the word had appeared in print for the first time only in 1936 and must have been unknown to most readers. Three days later it offered the definition "Contemptuous term for a type of sentimental writing." As Evelyn Waugh's foreign editor in Scoop would have said, "Up to a point, Lord Copper". One sense of the word does indeed refer to language, but to the employment of deliberately archaic vocabulary. That sense was used - possibly for the first time - by the successful British author Norah Lofts in her book Out of This Nettle of 1938 (published in the US under the title Colin Lowrie). In an author's note she said. "I have written this so-called historical novel in so-called modern language", hoping that her readers "will appreciate this lack of 'God-wottery'."



TEESTA'S TROUBLED WATERS

IF FRESHWATER IS THE **'NATIONAL ASSET' FOR** INDIA, IT IS THE **'CENTRAL TO** THE WAY OF LIFE' IN **BANGLADESH**

ndia's recent notice to Pakistan on the Indus Water Treaty has ignited measured discussions in Bangladesh over shared rivers, especially on a potential Teesta river agreement. Furthermore, as the Daily Star, the leading English daily in Bangladesh, reported the proposed two canals to divert water from Teesta Barrage for irrigation in Jalpaiguri and Cooch Behar districts by the West Bengal government have raised concerns in Bangladesh. While the authorities in Bangladesh have maintained restraint in commenting, the public has notably perceived India's monopoly to use waters against the aspirations of downstream farm communities. Can India and Bangladesh resolve substantially and sustainably the long pending issues of sharing of common

Both South Asian countries are facing the twin problems of too much and too little water as the ageold saying in Odia goes due their geographical locations and climatic conditions. Moreover, as we know the Indian sub-continent formed due to geophysical violence (plate tectonic movement) and political violence (war) that had transformed the status of rivers into trans-boundary water bod ies. Consequently, the management of shared rivers has become complicated with competing and conflicting demands by multiple users from wet season to lean season. When India and Bangladesh share 54 common rivers, only a long-term treaty on Sharing Ganges Water at Farakka (1996) and two MoUs - on Fenni River (2019) and on Kushiyara River (2022) have been concluded so far. Bangladesh in general, believes that it has not received its due share of water in spite of being a downstream country and keeping a good neighbourly relation.

After the Partition in 1947, there had been no talks on sharing of eastern Himalavan river waters be tween India and East Pakistan (now Bangladesh) as the Indus water between India and Pakistan. The dispute over Ganges erupted suddenly as a result of India's decision to construct a barrage in West Bengal in 1951, known as the Farakka Barrage, about 10 miles

from the borders with the then East Pakistan. However, the Ganges Water Sharing Treaty, which will be open for review after completion of 30 years in 2026, stipulates the release of water at Farakka during lean period (1 January to 31 May). Despite Bangladesh demanding for a guaranteed minimum flow, without mentioning the term 'minimum guarantee'. India agreed to various measures within the treaty that provide

water security to Bangladesh. After more than two decades of Ganges Treaty both countries signed an MoU in 2019 on Fenni river that originates in south Tripura and forms the international border river and allows withdrawal of 1.82 cusec of water by India for drinking water supply scheme for Sabroom town. Tripura, Another MoU was signed in 2022 on withdrawal of up to 153 cusecs of water each by India and Bangladesh from the common border river Kushiyara during the dry season. India shares flood forecasting data on Ganga-Brahmaputra-Meghna basins with Bangladesh to enable authorities to protect millions of lives and livelihoods.

Since the 1980s, both countries have been trying to resolve Teesta water sharing issues. The Teesta is a tributary of the Brahmaputra and flows through Sikkim and West Bengal before entering Bangladesh, Over the time, sharing of Teesta water has become politically explosive within both countries and diplomatically a hotspot and a blot. The Teesta Water Sharing Agreement was proposed to be signed during the then Indian PM Manmohan Singh's visit to Dhaka in September 2011. Yet, due to West Bengal CM Mamata Banerjee's strong reservations, the agreement is still in a stalemate. In the draft agreement India was willing to share 37.5% of Teesta water while retaining 42.5% during the lean season between December and March. However, Baneriee refused to sign as she was not consulted and the draft treaty was not in the interests of Bengal's farmers. Teesta's flow drastically reduces during the lean period and is vital for irrigating 1.20 lakh hectares in the region where the CM's party is not popular. The CM has been reasoning with various pre-conditions from time to time by avoiding and delaying talks on Teesta. Once, the CM has raised cleaning of the pollution of Mathabanga river (a distributary of Padma/Ganges) as a pre-condition on resumption of Teesta talks in 2018.

Subsequently, India has been engaged in multilayer and multi stakeholder discussions with Bangladesh including Sikkim and West Bengal governments at appropriate level on an early conclusion of agreement on Teesta. Even PM Narendra Modi's visits to Dhaka in 2015 and Bangladesh

PM Sheikh Hasina's visit to Delhi in 2022 could not augur any progress on resolving the Teesta impasse. India maintains that a just sharing of Teesta water, which is acceptable to all parties and protects interests of all parties concerned, will be agreed upon.

Meanwhile, both sides are engaged in advancing some kind of understanding in other transboundary rivers such as Dharla, Dudhkumar, Feni, Manu, Muhuri, Khowai, Gumti, Jaldhaka and Torsa. Both countries have established various joint mechanisms to address the water sharing aspects of all the transboundary rivers. The urgency for a mechanism to address the water sharing was so much that the two countries signed the Statute of the Indo-Bangladesh Joint River Commission (JRC) on November 24, 1972 immediately after signing the friendship treaty in 1971. The JRC is headed by the respective Ministers of Water Resources and functions as a liaison between the two countries. While emphasising on flood control, the JRC's role involves making recommendations, formulating proposals and studying projects, rather than taking decisions and implementing them.

Despite existing bilateral cooperative water mechanisms, both countries have been unable to resolve the downstream trepidations. If freshwater is the 'national asset' for India, it is the 'central to the way of life' in Bangladesh. Water is a highly volatile and emotive issue in Bangladesh.

As India has been harnessing the Teesta in Sikkim with multiple hydel projects, Bangladesh seems edgy by hobnobbing with Chinese 'basket full of aids' to dredge and embank the river, or perhaps, building storages at the border to ward off flash floods. India has conveyed its displeasure. While Sheikh Hasina is facing national elections this year, West Bengal is preparing for panchayat election and Modi faces 2024 general elections. Teesta has to be a flash point between India and Bangladesh.

The SVB crisis & its impact on India

WITH EVERY RATE HIKE BY THE FEDERAL RESERVE, SVB INCURRED MORE AND MORE LOSS

The recent catastrophic collapse of the US-based Silicon Valley Bank (SVB) has put the entire financial market in doldrums. The SVB crisis has highlighted certain major issues in the global banking system. To understand the SVB crisis, we must first understand the basics of banking.

The balance sheet of any bank or the banking system is basically managed by assets and liabilities. For a bank, the deposits in the savings bank account and the fixed deposits (term deposits) of the depositors are liabilities for the bank since they 'owe' the deposit amount (along with the accumulated interest) to the customers. The bank utilises this deposit amount to lend to individuals as well as institutions. The difference in the deposit rate and the lending rate is the margin that the bank earns.

The SVB crisis is a unique one and carries a lot of learning in it. The SVB is the second largest bank failure in the US history after Washington Mutual Bank. The US regulators have taken control over the deposits of close to USD 175 billion under the Federal Deposit Insurance Corporation. Founded in 1983, the California-based bank was considered to be one of the top banks in the US, having thousands of startups as its customers.

The journey of the SVB started

on a promising note since it coincided with the evolution of the 'startup ecosystem' in the US. Most of the startups raised funding and parked their funds in the form of deposits in SVB. The real issue started in the post pandemic phase wherein we witnessed a purple patch for global tech startups. The magnitude of funding raised by these tech startups from venture capitalists (VCs) and other angel investors was something that was unforeseen. The deposit book or in other words, the liability book of SVB ballooned to a different level.

With such a large deposit book, SVB instead of investing in liquid assets, started investing in the US Treasury bonds. Since these bonds are backed by the US government, the risk of default was not there. Hence it was pretty safe to invest in such fixed income products.

By the start of 2022, with the bursting of the 'tech bubble', the startups started facing liquidity crunch. In 2022, when the inflation rate reached an all-time high level, the Federal Reserve started increasing the interest rates. Since interest rates and bond prices are inversely proportional to each other, the value of the government bonds held by SVB went down

When the flow of funds stopped coming to these startups, they started withdrawing the deposits parked in SVB. The bank had no option but to provide the funds to these startups. In order to do that, they had to sell their government bonds at a discounted price (at a loss) on a 'mark-to-market' basis. With every rate hike by the Federal Reserve, SVB incurred more and more loss. This chain of events led to the precarious situation of their balance sheet.

In order to mitigate the loss created due to selling of government bonds at a discounted price, SVB started selling its equity. This created panic in the entire financial system. The startups accelerated the withdrawal of deposits from the bank, which further dented their revival process and resulting in 'bank run'. A 'bank run' occurs when a large number of customers or institutions start withdrawing their parked deposits from a bank

in fear of insolvency or bankruptcy. This led to the plummeting of

share price of SVB by 60% and its subsequent collapse. The regulatory authority i.e., the Federal Deposit Insurance Corporation took charge of the bank. The SVB crisis was not due to any default or creation of NPAs (Non-Performing Assets). It was also not because of any management issues. The crisis was solely due to the inability of the bank to foresee and envision the timing of repayment of the deposits. These deposits must have been invested in liquid or short-term instruments rather than in long duration fixed income products.

Most financial analysts have opined that the impact of the SVB crisis will be very limited on the Indian banking sector, since the exposure is very limited. But markets are driven by sentiments and perceptions and not by actual numbers. The Indian banking sector constitutes almost 1/3rd of the NIFTY index and the impact will be inevitable. It is not a question of 'whether' but a question of 'how much'.

Delhi govt's old excise policy gets 6-month extension

New Delhi, March 15: The Delhi government Wednesday extended by six months its old excise policy, which permits only state corporations to retail liquor in the city, officials said.

The existing excise policy, which was set to expire March 31, will now be valid until September 30.

The decision was taken to ensure the continuity of the existing excise regime while the Excise Department formulates a new policy, the officials said, adding the proposal regarding the extension was approved by Chief Minister Arvind Kejriwal Wednesday. The government has directed the Excise Department to formulate a new excise policy at the earliest.

The government has also announced that five dry days will be observed in the national capital in the next three months. These dry days will take place on account of Mahavir Jayanti April 4, Good Friday (April 7), Eid-ul-Fitr (April 22), Buddha Purnima (May 5), and Eid-ul-Zuha June 29.

During the dry days, the sale of liquor will be prohibited to maintain the solemnity and sanctity of these occasions, the offi-

New Delhi, March 15: Calling for a trust vote merely on the ground of differences between MLAs of a ruling party can topple an elected government, the Supreme Court observed Wednesday, adding the governor of a state cannot lend his office to effectuate a particular result.

"It will be a sad spectacle for democracy," a five-judge constitution bench headed by Chief Justice D Y Chandrachud said while taking forward the hearing on the events that unfolded during the June 2022 Maharashtra political crisis triggered by a revolt in the then undivided Shiv Sena by MLAs loyal to Eknath Shinde.

The bench made the observations after Solicitor General Tushar Mehta, appearing for the Maharashtra governor, narrated the sequence of events and said there were various materials before the governor including a letter signed by 34 Shiv Sena MLAs, a letter from Independent lawmakers withdrawing support to the Uddhav Thackeray government, and another of the Leader of the Opposition that prompted him to order a trust vote. B S Koshyari, who was then the gover-

nor of Maharashtra, had asked Thackeray to face a floor test to prove his majority. Thackeray, however, resigned in the face of imminent defeat, paving the way for appointment of Shinde as the new chief minister. "Difference of opinion among MLAs within a party can be on any ground like payment of development fund or deviation from party ethos but can that be a sufficient ground for the governor to call for the floor test? Governor cannot lend his office to effectuate a particular result. Calling for a trust vote will lead to toppling of elected government," the bench said.

The bench, also comprising Justices MR Shah, Krishna Murari, Hima Kohli

and PS Narasimha said a letter by the leader of opposition does not matter in the instant case because he will always keep on writing that the government has lost majority or MLAs are not happy. The letter from MLAs that there was a threat to their security is also not relevant in this case, it said.

The only thing is that a resolution of 34 MLAs which said that there was widespread discontent among the party cadres and legislators....Is this sufficient ground to call for trust vote? Although, in the hindsight we can say that Uddhav Thackeray had lost the mathematical equation. "But the fact is governor cannot enter this domain which would precipitate the matter. People will start ditching the ruling party and governor will end up toppling the ruling party. This will be a sad spectacle for democracy," the court observed. The bench also said the governor should have questioned the (Shiv Sena) MLAs that they were in a "happy marriage" with the Congress and the NCP for three years and then suddenly what happened in a day that they wanted to go out of the alliance.

"Three years you cohabited in an alliance, and one fine day, you decided for divorce. The rebel MLAs became ministers in another dispensation. Governor has to ask these questions to himself. What were you fellows doing for such a long time and now suddenly you want a divorce," the court said.

On March 2, the Shinde faction had told the top court that the pleas related to the June 2022 Maharashtra political crisis fell within the realm of politics and judiciary cannot be asked to adjudicate the issue. On June 29, 2022, at the height of the cri sis, the apex court had refused to stay the Maharashtra governor's direction to the 31month-old MVA government led by Thackeray to take a floor test.

India invites Pak defence minister

SCO MEET


New Delhi, March 15: India has invited Pakistan Defence Minister Khawaia Asif for a meeting of the Shanghai Cooperation Organisation (SCO) next month along with his counterparts from other member nations of the grouping, people familiar with the development said Wednesdav. The invite to Asif for the April 28

meeting was sent by India in its capacity as current chair of the eight-nation SCO, weeks after a similar communication was sent to Islamabad inviting Pakistan Foreign Minister Bilawal Bhutto Zardari for a foreign ministerial conclave of the grouping that is scheduled to be held in May.

They said Pakistan defence minister Asif was sent an invitation through the Indian high commission in Islamabad for the defence ministerial meeting. India is also set to send separate invites to Pakistan Prime Minister Shehbaz Sharif, Chinese President Xi Jinping and Russian President Vladimir Putin for the annual SCO summit later this year.

The SCO member countries are India, Russia, China, the Kyrgyz Republic, Kazakhstan, Tajikistan, Uzbekistan and Pakistan. While the SCO defence ministers' meeting is scheduled to be held in Delhi, the foreign ministerial conclave is set to take place in Goa in early May. India has already invited Chinese foreign minister Qin Gang for the meeting.

The defence ministers' meeting is set to delve into various issues relating to regional security including the threat of terrorism and the situation in



Afghanistan. The meeting will be chaired by Defence Minister Rajnath Singh, they said.

There was no indication yet from Pakistan on whether Bilawal Bhutto Zardari and Asif will attend the respective meetings. If Asif decides to attend the defence ministerial meeting inperson, it will be the first such visit from Islamabad to India since 2011. The then Pakistan foreign minister Hina Rabbani Khar had visited India that year. Khar is currently serving as the minister of state for foreign affairs. There has been speculation that Pakistan may send Khar for the SCO foreign ministerial meeting. The ties between India and Pakistan came under severe strain after India's warplanes pounded a Jaishe-Mohammed terrorist training camp in Balakot in Pakistan in February 2019 in response to the Pulwama terror attack. The relations further deteriorated after India in August 2019 scrapped the special status of Jammu and Kashmir and bifurcated the state into

two union territories

used Mukkode stones. It was their way of identifying the borders of their land. In accordance to this, the Linga Mudra stones found at Basrur were put to

identify the borders, he said. "The cooperation and support of the public is required to preserve the stone inscriptions, war memorials and border stones of history. The record should be mentioned in the history of our land," Murugeshi said.



New Delhi, March 15: The proceedings in Parliament were disrupted for the third straight day Wednesday as the political slugfest between the BJP and the Congress over Rahul Gandhi's democracy remarks and the Adani issue intensified and the opposition parties took to the streets.

The BJP stepped up the ante against Gandhi, saying India's democracy is not in peril but the Congress party has been brought to "political perish" by the people while the opposition party escalated its offensive, accusing the government of "undermining and weakening" democracy in the country by stalling Parliament to save a businessman.

Congress president Mallikarjun Kharge alleged that the police did not allow the opposition MPs of around 18 parties to march in protest and present their case for a detailed investigation into the Adani issue. Later, opposition leaders emailed a letter to ED Director S K Mishra. The parties told the probe agency that it cannot turn around and abdicate its jurisdiction".

The letter was signed by leaders of the Congress, CPI, CPI-M, JDU, SS (UBT), RJD, DMK, JMM, AAP, IUML, VCK, Kerala Congress and others.

The logjam continued in both Lok Sabha and Rajya Sabha Wednesday. In Lok Sabha, opposition members stormed into the Well of the House, raising placards and slogans, demanding a Joint Parliamentary Committee (JPC) probe into the Adani matter while the BJP slammed Rahul,

Speaker of the House. Lok Sabha Speaker Om Birla repeatedly urged the members to return to their seats and allow the house to run.

Adani Group exercised 'improper influence'

New Delhi: The Opposition in its complaint to the Enforcement Directorate (ED) against the Adani Group Wednesday claimed that the group has exercised "improper influence to obtain concessions and contracts from governments and regulated entities which they are unqualified for". "The Dubaibased Seclink Technology Corporation emerged as the highest bidder with a bid of Rs 7,200 crore in November 2018 tender to redevelop Mumbai's Dharavi area. That tender was cancelled in November 2020 because of delays in the transfer of Railway land. A fresh tender with new conditions was issued in October 2022 which the Adani Group won with a bid of Rs 5,069, lower than the original winning bid by Rs 2,131 crore. The Adani Group has no known experience in urban redevelopment," the Opposition said in its letter to the ED.

Mumbai, Mar 15: Maharashtra has reported two fatalities suspected to be caused by influenza. One of them, a 74-year-old man, died of the H3N2 sub-type while the other victim was infected by coronavirus as well as the influenza virus, state Health Minister Tanaji Sawant told the Assembly Wednesday.

An official said one of the two deceased, a 23-year-old MBBS student, died due to a mixed infection caused by coronavirus and H3N2.

Sawant said state health machinery has been put on alert with 361 cases of influenza infections being reported in the state, and guidelines will be issued in the next two days. The minister also advised the use of masks in crowded places and social distancing.

'Two persons have died due to influenza, including a 23-year-old first-year student of MBBS in Ahmednagar. He tested positive for Covid-19 as well as H1N1 and H3N2 viruses. Another victim is a 74-year-old man from Nagpur who died of H3N2," Sawant said.

Influenza is caused by two types of viruses, H1N1 and H3N2, he said, adding that guidelines will be issued in the next two days after a detailed discussion with Chief Minister Eknath Shinde.

"Influenza has been detected in Mumbai, Pune, Nagpur, Aurangabad, Thane, Sangli, and Kolhapur. There are 303 cases of H1N2 and 58 patients of H3N2, Sawant said. The minister said all district and rural health centres have been activated and put on alert along with oxygen projects. The preparedness will be reviewed every three hours, he added.

Sawant said the symptoms of influenza include fever, cough, sore throat, and pneumonia. "Fever can subside in 48 to 72 hours if Tamiflu is taken with medical advice. Fever and body pains should be treated early," he said and appealed to people to use masks and follow social distancing norms besides maintaining personal hygiene including washing hands etc.

Meanwhile, Ahmednagar district officials have appealed to people not to panic in view of the death of the 23-year-old MBBS student.

Delhi court grants bail to Lalu, family

New Delhi, March 15: Delhi's Rouse Avenue court granted bail to RJD leader and former Railway Minister Lalu Prasad, his wife and former Bihar chief minister Rabri Devi and their daughter Misa Bharti in connection with a case related to the alleged land-for-job scam.

The family appeared before Special Judge Geetanjali Goel around 11 a.m. The 74-year-old former railway minister reached the court on a wheelchair around 10 a.m. A huge number of RJD supporters gathered outside the court as Lalu appeared in the land-for-job

During the hearing, the Judge Goel noted that the CBI had filed its charge sheet without arrest. The court, however, granted bail and directed every accused to furnish Rs 50,000 personal bail bond. The bail plea was not opposed by the CBI. More details are awaited.

The court had February 27 issued summons to them in the case which concerns alleged appointments made in the Railways in exchange for land parcels given or sold to

Lalu Prasad's family while he served as the Union Railway Minister from 2004 to 2009. In its charge sheet, the Central Bureau of Investigation (CBI) said that irregular appointments had been made in the Railways, in violation of the standards and guidelines established by the Indian Railways for hiring. It is alleged that the candidates

gave Lalu Prasad's family members land at extremely reduced prices -- up to one-fifth of the going market rates -- directly or through their close relatives and family members. The CBI had filed the charge sheet in the case on October 10, 2022, against 16 persons including Lalu Prasad's wife Rabri Devi and daughter and sanction was then obtained to prosecute them.

Special Judge Geetanjali Goel of Rouse Avenue Courts had February 27 observed that, prima facie, the on-record report shows that offences have been committed under different sections of the IPC and the Prevention of Corruption Act. Taking cognisance of the said offences, the judge then summoned the accused persons.

China, Russia, Iran hold naval drills

Beijing: Naval forces from China, Iran and Russia countries at odds with the United States - are staging joint drills in the Gulf of Oman this week, China's Defence Ministry said Tuesday. Other countries are also taking part in the "Security Bond-2023" exercises, the ministry said without giving details. Iran, Pakistan, Oman and the United Arab Emirates all have coastline along the waterbody lying at the mouth of the strategic Persian Gulf. "This exercise will help deepen practical cooperation between the participating countries' navies ... And inject positive energy into regional peace and stability,' the ministry statement said.

Iran's fire festival kills 11; 3,500 hurt

Tehran: Eleven people were killed and more than 3.500 injured during celebrations for Iran's traditional fire New Year, state media reported Wednesday. The fire festival, called Chaharshanbe Suri in Farsi, is celebrated every year on the night of the last Tuesday of the Iranian calendar year, which ends March 20. "Since February 20, 26 people have died in incidents related to Chaharchanbe Suri,' including at least 11 on the day of the event along with more than 3,550 injured, emergency services chief Jafar Miadfar told state television.

Islamabad, March 15: In a temporary relief for Imran Khan, a Pakistani court Wednesday ordered the police to stop its operation outside the former prime minister's residence in Lahore to arrest him in a corruption case, amidst clashes between the security personnel and his supporters.

The Zaman Park in Lahore where Khan lives remained under siege for the last two days and the government sent the elite Rangers to aid police teams who struggled Tuesday to muscle their way through a ring of enraged Pakistan Tehreek-e-Insaaf (PTI) supporters to arrest party chairman Khan.

The police, with their riot gear on, closed in on Khan's home to comply with the court orders to arrest the 70-year-old cricketerturned-politician in the Toshakhana case. However, the police withdrew from the area after the Lahore High Court (LHC) ordered them to stop their operation at Zaman Park till 10 am Thursday.

The LHC summoned the Puniab inspector-general, chief secretary and Islamabad police (operations) head on a petition filed by PTI leader Fawad Chaudhry seeking order for the government to stop the police action at Khan's residence.

Khan's party Tuesday challenged the police operation in the Lahore High Court, requesting it to direct the government to end its bid to arrest the party chief.

appeared before the court and told it that police had to launch the operation as Islamabad police had brought an arrest warrant for Imran Khan in the Toshakhana gifts case. at the next hearing March 18. Khan's party claimed that live bullets were fired at the party workers present on the roads leading to

Khan's residence. Fearing the worst, various PTI leaders — including Khan himself – Tuesday appealed to party workers to rush to Zaman Park, where they served as human shields and stood between Khan's residence and the police.

The PTI has declared that it would not let law enforcement agencies arrest Khan as it fears he may be given poison in jail.

Khan was ousted from power in April last year after losing a no-confidence vote, which he alleged was part of a US-led conspiracy targeting him because of his independent foreign policy decisions on Russia, China and Afghanistan.

Since his ouster, Khan has been asking for early elections to oust what he termed an "imported government" led by prime minister Shehbaz Sharif. Sharif has maintained that elections will be held later this year once the parliament completes its five-year tenure

DRONE CRASH INCIDENT

Moscow warns US aircraft away from its air space

WASHINGTON HAS SAID NEITHER IT NOR THE RUSSIANS HAD **RECOVERED THE WRECKED DRONE**

Washington, March 15: Moscow told Washington Wednesday to keep well away from its air space after a US drone intercepted by Russian jets crashed into the Black Sea, the first known direct confrontation between the superpowers since Russia invaded Ukraine.

The US military said the incident was caused by a mid-air collision after two Russian Su-27 fighter planes approached one of its MQ-9 Reaper drones on a reconnaissance mission over international waters.

The fighters harassed the drone and poured fuel on it, before one clipped the drone's propeller, causing it to crash into the sea, Washington said.

'This incident demonstrates a lack of competence in addition to being unsafe and unprofessional," said James B Hecker, commander of US air forces in Europe. White House spokesman John Kirby said US officials had told Russia's ambassador Anatoly Antonov that Moscow should be more careful in international air space.

Moscow denied the aircraft had



collided and said the drone had crashed after "sharp manoeuvres". It said the drone had "deliberately and provocatively" flown close to Russian air space with its transponders off, and Moscow had scrambled fighters to identify it.

The unacceptable activity of the US military in the close proximity to our borders is a cause for concern,' Antonov, the ambassador, said in a statement, accusing Washington of using drones to "gather intelligence which is subsequently used by the Kviv regime to strike at our armed forces and territory" "Let us ask a rhetorical ques-

tion: if, for example, a Russian strike drone appeared near New York or San Francisco, how would the US Air Force and Navy react?" he said, calling on Washington to "stop making sorties near the Russian borders"

The Kremlin said there had been no high-level contacts with Washington over the incident. Bilateral relations were "in a very lamentable state" but "Russia has never refused constructive dialogue, and is not refusing now,' said spokesman Dmitry Peskov.

Freddy toll rises above 270

Blantyre, March 15: Malawi and survivors from Tropical Cyclone Freddy on Wednesday as the death toll rose above 270 from one of the most powerful storms recorded in the southern hemisphere.

Freddy tore through southern Africa for the second time in a month over the weekend and was still causing heavy rain on Wednesday hampering relief efforts.

Malawi's disaster management department said in a statement that the death toll from the second hit stood at 225, up from 190 Tuesday, with 707 people injured and 41 missing.

In neighbouring Mozambique at

least 21 people had died as of Tuesday, according to the disas-


The overall death toll since Freddy first made landfall in February is now estimated at more than 270 in Malawi, Mozambique and Madagascar Malawi's army, police, the local

Red Cross and other aid agencies were conducting search and rescue operations, with commercial hub Blantyre one of the areas hardest-hit. Severe flooding and mudslides have swept away homes, broken

bridges and destroyed roads. Heavy rain has continued to batter the Mozambican port of Quelimane and surrounding areas. "Our priority now, as we take stock to what really occurred, is to

search and rescue people in most devastated areas. We've rescued thousands but thousands more are still unreachable," said disaster agency spokesperson Paulo Tomas by telephone from Quelimane.

Power supplies in Malawi have been severely disrupted by the storm after the national electricity generation company had to shut down major hydroelectric power stations.

Washington, March 15: President Joe Biden's close aide Eric Garcetti is set to be confirmed as US Ambassador to India after the Senate Wednesday voted on the cloture_ motion limiting debate on his nomination, reflecting that the ruling Democratic Party has enough votes for his selection for the key post.

The former Los Angeles mayor's nomination was pending before the US Congress since July 2021 when he was nominated for the prestigious diplomatic posting by Biden. The position has remained

vacant for more than two years. A cloture motion is a procedural motion that limits further debate on the matter at hand. It allows the majority to defeat efforts by the minority to delay or obstruct proceedings on a matter by showing the matter has the support of

a super-majority. The cloture motion on his nomination was passed 52 to 42 votes.

Garcetti's nomination was pending before the **US Congress since July** 2021 when he was nominated for the prestigious diplomatic posting by Biden. The position has remained

Hong Kong, March 15: Concerned by China's shrinking population, political advisors to the government have come up with more than 20 recommendations to boost birth rates, though experts say the best they can do is to slow the population's decline.

China dug itself into a demographic hole largely through its one-child policy imposed between 1980 and 2015. Authorities raised the limit to three in 2021, but even during the stay at home Covid times couples have been reluctant to have babies.

Young people cite high childcare and education costs, low in-

comes, a feeble social safety net and gender inequalities, as discouraging factors.

The proposals to boost the birth rate, made at the annual meeting of China's People's Political Consultative Conference (CPPCC) this month, range from subsidies for families raising their first child, rather than just the second and third, to expanding free public education and improving access to fertility treatments.

Experts took the sheer number of proposals as a positive sign that China was treating its ageing and declining demographics with urgency, after data showed the population shrinking for the first time in six decades last year.

"You cannot change the declining trend," said Xiujian Peng, senior research fellow at the Centre of Policy Studies at Victoria University in Australia. "But without any fertility encouragement policy then fertility will decline even further."

A motion by CPPCC member Jiang Shengnan that young people work only eight hours per day so

they have time to "fall in love, get married and have children." was critical to ensure women are not overworked, Peng said

Giving incentives to have a first child could encourage couples to have at least one child, she said.

Many provinces currently only subsidize second and third children. To help alleviate the pressure



12 companies garner ₹478cr through IPO

New Delhi: The primary market seems to be muted, with companies raising only ₹478 crore through 12 initial public offerings (IPOs) in January. Of the 12 IPOs, only two were of the main board that garnered ₹323 crore, while 10 small and medium enterprises (SME) mobilised ₹155 crore through the initial share-sales, according to the latest data with the Securities and Exchange Board of India (Sebi) showed. In comparison, companies mopped-up funds to the tune of ₹5,120 crore through IPOs in December. Overall, a total of 38 companies collected over ₹57,000 crore in 2022, way lower than the ₹1.2 lakh crore raised by 63 companies in 2021, which was the best IPO year in two decades.

RBI, UAE central bank sign pact

Mumbai: The RBI and the UAE central bank Wednesday signed an agreement to enhance cooperation in various areas, including exploring interoperability of Central Bank Digital Currencies (CBDC). Under the MoU (memorandum of understanding), the two central banks will collaborate on various emerging areas of FinTech, especially Central Bank Digital Currencies (CBDCs) and explore interoperability between the CBDCs of CBUAE and RBI, the Indian central bank said in a statement, According to the statement, the CBUAE and RBI will jointly conduct proof-ofconcept (PoC) and pilot(s) of the bilateral CBDC bridge to facilitate cross-border transactions of remittances and trade. This bilateral engagement of testing crossborder use cases of CBDCs is expected to reduce costs, increase the efficiency of crossborder transactions and further the economic ties between India and UAE, it added.

Edible oil imports rise 12% in Feb

New Delhi: India's edible oil imports rose 12 per cent yearon-year in February to 10.98 lakh tonne on higher imports of crude palm oil, according to industry body SEA. In a statement, the Solvent Extractors' Association of India (SEA) Wednesday said that edible oil imports rose to 10,98,475 tonne in February from 9,83,608 tonne in the yearago period. Imports of nonedible oil fell to 16,006 tonne in February from 36,389 tonne in the same month last year. Total imports of vegetable oils (edible oils and non-edible oils) went up 9 per cent to 11,14,481 tonne in February this year from 10,19,997 tonne a year ago.



Credit Suisse leads Europe bank rout

Europe's bank index has seen more than 120 billion euros evaporate (\$127 billion) in value since Silicon Valley Bank's collapse

Britain, March 15: European bank stocks slumped Wednesday, with embattled Credit Suisse tumbling as much as 30% to another record low, on renewed investor concerns about stresses within the sector triggered by Silicon Valley Bank's sudden collapse.

Regulators and financial executives around the world have sought to assuage contagion fears after tech-focused lender SVB and another US bank failed last week, but worries persist.

The drop in Credit Suisse shares led a 7% fall in the European banking index, while five-year credit default swaps for the flagship Swiss bank hit a new record high, highlighting increasing investor concerns.

The Swiss National Bank declined to comment on Switzerland's second-largest bank, after its largest investor said it could not provide Credit Suisse with more financial assistance because of regulatory constrains.

Germany's financial supervisory authority (BaFin) said it saw no direct risk of contagion and the German banking system appeared robust and capable of digesting higher interest rates.

SENSEX FALLS FOR 5TH DAY

Mumbai, March 15: Benchmark BSE Sensex pared its early gains to close down by 344 points at a five-month low while Nifty slid below the 17,000 level Wednesday due to selling in banking, financial and telecom stocks.

Persistent foreign capital drain from the domestic market and lingering concerns over banks' health and high inflation dented market sentiment, traders said.

Falling for the fifth straight session, the 30-share BSE Sensex closed lower by 344.29 points or 0.59 per cent at 57.555.90 with 21 of its stocks ending in the red. After a gap up opening, the index surged over 570 points to touch a high of 58,473.63 amid positive Asian markets in early trade.

The stock markets, however, lost steam after a weak opening of European stocks which retreated on fears that the European Central Bank may hike rates by 25 basis points.

The Sensex tanked more than 1,000 points from the day's high to hit a low of 57,455.67. Marking its fifth straight day of losses, the broader NSE Nifty declined 71.15 points or 0.42 per cent to end at 16,972.15, with 28 of its stocks ending with losses.

Meanwhile, the rupee declined 25 paise to close at 82.62 against the US dollar Wednesday. International oil benchmark Brent crude gained 0.72 per cent to \$78.01 per barrel. Foreign portfolio investors (FPIs) offloaded shares worth ₹3,086.96 crore Tuesday, according to exchange data.

n the United States, the focus is shifting to the possibility of tighter regulation of banks, particularly mid-tier ones like SVB and New Yorkbased Signature Bank, whose collapses triggered the market tumult. Moody's Investors Service Tuesday revised its outlook on the US banking system to "negative" from "stable", citing heightened risks for the sector. SVB's shutdown prompted President Joe Biden's assurances that the US financial system is safe and emergency steps giving banks access to more funding. In Britain, HSBC's top bosses have called on employees at SVB's rescued UK arm to assure clients "their deposits are safe and loans are supported" as the process of integration following its takeover begins, a memo from the bank showed. And in an attempt to avert a similar crisis down the line, the US Federal Reserve is considering tougher rules and oversight for midsize banks similar in size to SVB. Earlier, the Tokyo Stock Exchange banks index jumped more than 4%, after three straight days of heavy selling. Investors had been particularly concerned about the huge bond holdings of Japan's lenders, but Japanese finance minister Shunichi Suzuki said differences in the structure of deposits, meant local banks would not face incidents similar to SVB.

"In the last couple of days as you might expect we've seen inflows," Hamers said. "It is clearly a flight to safety from that perspective, but I think three days don't make a trend.

Deutsche Bank Christian Sewing said that the German lender has also seen incoming deposits.

Banks from 18 nations open 30 special vostro accounts for trade in ₹

New Delhi, March 15: Several banks, including HDFC Bank and UCO Bank, have opened as many as 30 special vostro accounts as of date to facilitate overseas trade in the rupee, a top government official said Wednesday.

Director General of Foreign Trade (DGFT) Santosh Kumar Sarangi said as of date, some 18 countries have already opened special vostro accounts with Indian "About 30 banks from overseas

countries have signed up with 30 banks on our side, so 30 accounts...The transaction has started in bits and pieces," he told reporters here. Sberbank and VTB Bank - the largest and second-largest banks of Russia, respectively -- are the first foreign lenders to receive the approval after the RBI announced the guidelines on overseas trade in the rupee in July last year.

Another Russian bank Gazprom, which does not have its unit in India, has also opened this account with Kolkata-based UCO Bank.

The move to open the special vostro account clears the deck for settlement of payments in rupee for trade between India and Russia, enabling cross-border trade in the Indian currency, which the RBI is keen to promote.

The RBI has allowed the special vostro accounts to invest the surplus balance in Indian government securities to help popularise the new arrangement.

EXPORTS DIP FOR 3RD MONTH IN A ROW

Trade deficit narrows to \$17.43bn

New Delhi, March 15: Contracting for the third month in a row, India's exports declined by 8.8 per cent to \$33.88 billion in February due to slowdown in global demand, even as the trade deficit touched about a vear low of \$17.43 billion during the month, according to official data released Wednesday.

Imports also declined by 8.21 per cent to \$51.31 billion as against \$55.9 billion recorded in the corresponding month last year.

Cumulatively, however during April-February this fiscal, the country's overall merchandise exports rose by 7.5 per cent to \$405.94 billion. Imports during the period increased by 18.82 per cent to \$653.47 billion.

The merchandise trade deficit for the April-February this fiscal stood at about \$247.53 billion.

The country's exports had contracted by 6.58 per cent to \$32.91 billion in December 2022. In February 2022, the trade deficit was \$18.75 billion. Last time, it was in January 2022 when the trade deficit touched \$17.42

India's imports from Russia jumped about five times to \$41.56 billion during the April-February period of this fiscal due to increasing inbound shipments of crude oil from that country. according to the commerce ministry data. In 2021-22, Russia was India's 18th largest import partner, accounting for \$9.86 billion of imports. From just 0.2 per cent of all oil imported by India, Russia supplied 28 per cent of the total oil imported in January, Russia has become India's fourth largest import source in the first 11 months of the current fiscal. From a market share of less than 1 per cent in India's import basket before the start of the Russia-Ukraine conflict, Russia's share of India's oil imports rose to 1.27 million barrels per day in January, taking the share to 28 per cent, according to energy cargo tracker Vortexa.

Gold imports during April-February this fiscal contracted to \$31.72, as against \$45.12 billion in the same period last year.


