Chargesheet will be filed in time: CM

Bhubaneswar, March 21: The chargesheet in minister Naba Das murder case will be filed within prescribed timeframe, said Chief Minister Naveen Patnaik Tuesday.

Replying to the debate on grants for the General Administration and Public Grievances department in the Assembly, Patnaik said the only statement made so far is by him in front of the House. No police officer or any other authority has briefed anyone including the media

on the sensitive case so far. The probe, Patnaik said, is still under progress and within the time frame given by law for the filing of chargesheet and the same would be done. The CM said, "In this case, we have two objectives — unveil the truth behind this murder and ensure conviction of those involved." He said, "We have followed all scientific procedures involving agencies, including those from other states and Centre." Despite that, the Opposition is accusing the government of hiding something in the investigation which is deplorable and smacks of


political opportunism, he said.

SC upholds OAT abolition

Top court dismisses petition of OAT Bar Association against Orissa High Court's 2021 order that upheld Centre's August 2, 2019 notification on tribunal's abolition

New Delhi, March 21: The Supreme Court Tuesday held that the abolition of Odisha Administrative Tribunal (OAT) by the Union government was constitutionally valid. Observing that the Union gov-

ernment has the power to abolish state administrative tribunals (SATs), a two-judge Bench, led by Chief Justice DY Chandrachud, dismissed the petition filed by OAT Bar Association against Orissa High Court's 2021 order that upheld the notification issued by the Centre's Department of Personnel and Training August 2, 2019, which abolished OAT. "We hold that abolition of OAT

was constitutionally valid. Article 323A (dealing with administrative tribunals) does not preclude the Union of India to abolish SATs. The decision to abolish the tribunal is not violative of Article 14 of the Constitution," the bench said.

The Bench, also comprising Justice Hima Kohli, ruled that the abolition of OAT is not violative of the fundamental right of access to iustice as the Orissa HC has been hearing cases which were pending before the OAT prior to its aboli-

The Centre had established OAT July 4, 1986 following the request of the state government to hear grievances of its employees.

In 2015, the Chief Secretary had requested the Centre to issue a notification under the Administrative Tribunals Act to abolish the OAT. The state government was

the view that the tribunal was unable to serve its original objectives, particularly after the SC gave the judgement in L Chandra Kumar case of 1997. As a result of this judgment,

the very purpose of OAT for speedy redressal of grievances of the state government employees is not fulfilled as any way the aggrieved parties have to approach the HC before approaching the SC for a final verdict, the state government had stated in its letter to the Union government.

In 2019, the appellants filed a writ petition before the Orissa HC for quashing the August 2, 2019 notification and also against the decision taken by the state government. After considering the submissions, the Orissa HC had dismissed the petitions by its common judgment of June 7, 2021.

Only 93 of 1,776 DQ allotments cancelled ments under DQ, only 35 were can-

Bhubaneswar, March 21: The state government has cancelled only 93 houses, plots or flats in the last eight years out of 1,776 allotted under Discretionary Quota (DQ), Housing and Urban Development (H&UD) Minister Usha Devi told the Assembly, Tuesday.



While replying to a question of Congress MLA Narasingha Mishra. the minister said allotment of 1,776 plots/houses/flats were made by Bhubaneswar Development Authority (BDA), Cuttack Development Authority (CDA) and Odisha State Housing Board (OSHB) under the DQ. "Out of which, only 93 allotments were cancelled in the last eight years. And 79 criminal cases have been registered against them after Vigilance enquiry," she said.

Out of 803 DQ allotments made by the BDA, only 48 were cancelled and criminal cases filed against 24 allottees. In CDA, out of 921 allotcelled and 29 criminal cases registered following Vigilance probe.

Similarly, the OSHB has distributed 52 houses, plots and flats under the DQ, of which, only 10 allotments were cancelled so far. The OSHB has registered 26 criminal cases against the allotments.

The minister said the state government has accepted the Tara Dutt Task Force report in the Cabinet in December 2014 and issued necessary instructions in January 2015 which stipulates that BDA, CDA and OSHB should cancel all allotments of plot/house/flat under DQ made after January 1, 1995.

The plots/houses or flats should be resumed to the concerned authorities. Accordingly, action has been taken at the level of developmental authorities and OSHB. she said.

The Task Force report also suggested that cancellation may not be done in respect of the allottee getting only one plot/house/flat through fair means and by following the prescribed procedure and provisions for such transfer.

As a result, many single allottees under DQ took shelter of the court of law for their right, title and interest over the allotted land patch. The Orissa High Court has pronounced judgment in favour of the single allottees.

The Bengal CM is likely to have an hour-long discussion with Puri district officials at 3pm Wednesday, and visit Srimandir to offer prayers at 4pm, the officials said. On Thursday, Banerjee will reach

In the early 1970s, much of Engelbart's original team ended up at Xerox PARC, where they continued their research in humancomputer interaction and kept improving upon the mouse.

While touring the research facility in 1979, Steve Jobs witnessed the concepts of the mouse and the graphical user interface (GUI) in action. Impressed by their userfriendliness, he aimed to simplify and incorporate these intuitive features into Apple's computers.

The Xerox mice cost \$300 apiece, didn't roll around smoothly, and had three buttons.

Jobs wanted a simple, singlebutton model that cost \$15.

Apple licensed Engelbart's mouse patent from SRI for around \$40,000, and Jobs hired the design firm IDEO to bring the mouse to the

Apple's mouse-which used a rollerball mechanism-was introduced with the expensive Lisa computer in 1983, but achieved fame and popularity when the more affordable Macintosh was ঽ

released in 1984. 'Engelbart's invention would, in part, change the course of modern life,' said Bobby Livingston, Executive VP at RR Auction.



Din in House over MLA's remark on bureaucrat

Bhubaneswar, March 21: The Assembly Tuesday witnessed pandemonium with the Opposition BJP raising the issue of a BJD MLA's remark during a bureau-

crat's recent visit to Nabarangpur and the ruling BJD coming down heavily on the Centre's decision to discontinue Pradhan Mantri Garib Kalvan Anna Yojana (PMGKAY).

The issue of the 5T Secretary's visit was raised during Zero Hour when Leader of Opposition Jayanarayan Mishra criticised the remark of a BJD lawmaker who had described the visit as "CMO has come to Nabarangpur on a visit'

Taking a jibe at the BJD MLA for describing the 5T Secretary as the CMO. Mishra asked. "The 5T Secretary can be private secretary to the Chief Minister, but how can he be the CMO (Chief Minister's Office)?

"As we know 5T is being called as team work, technology, transparency, transformation and time limit. Earlier, the BJD leaders claimed that 5T is a concept or a vision of Chief Minister, but now they are claiming that it is CMO," the senior BJP leader said.

Targeting the BJD members, Mishra said: "Earlier, the Odisha government took credit by claiming that it was providing rice at ₹1 and we do not mind if they distribute it for free after the PMGKAY is stopped.'

Pointing out that the cereal was being distributed free of cost due to Covid-19 outbreak, he said, the relief has been stopped as the pandemic is over.

The state government is free to distribute free of cost rice among the people, Mishra said.

Unable to run the proceedings, the Speaker adjourned the House twice till 12 noon and a discussion was later held on the Home department's demand

SC adjourns hearing on Odisha Univ Act

New Delhi, March 21: The Supreme Court Tuesday adjourned the hearing on a petition challenging Odisha University (Amendment) Act 2020 after the University Grants Commission (UGC) sought time to file response on the state government's affidavit.

A two-judge bench of Justices Saniay Karol and Manoj Misra posted the next hearing to April 25. During the hearing, solicitor general Tushar Mehta's office sought time to go through the affidavit filed by Odisha government and to file its response.

Earlier, the Supreme Court had stayed the Odisha Universities (Amendment) Act, 2020 for three

months in May 2022. The apex court in October 2022 extended the stay until further order.

The petitions have been filed in the apex court against the Orissa High Court order of January 2022 wherein the HC had upheld the validity of the impugned act. The HC had observed that the changes made in the procedure of recruitment of VCs and teachers for universities were not unconstitutional.

The UGC had contended that the act is in conflict with the UGC Regulations, 2018, issued under University Grants Commission Act, 1956. The regulations govern the minimum qualification of teachers, manner of appointment of VCs and other service conditions of teaching and non-teaching staff.

DJ Azex died by suicidal hanging: Autopsy report

Bhubaneswar, March 21: Commissionerate Police Tuesday received the post-mortem report of popular DJ Azex aka Akshaya Maharana which confirmed that Azex died of asphyxiation caused by suicidal hanging.

"I talked to the medical officer who carried out the autopsy and also personally went through the post-mortem report of DJ Azex. As per the report, it was a case of suicide and the injuries found in his body are ante-mortem in nature. There are ligature marks on his body indicating suicidal hanging and asphyxiation which was the pri-



mary cause of death," said Capital Hospital director Laxmidhar Sahoo.

Meanwhile, investigating officials probing the matter Tuesday interrogated the girlfriend of Azex at her Info Valley residence here. The questioning continued for more than an hour in which police tried to elicit vital clues regarding her strained relationship with the deceased.

The family members of Azex

accused his girlfriend and her new boyfriend of blackmailing him. The couple was allegedly threatening to make viral some videos of Azex on social media.

Meanwhile, police also received the call detail records of Azex, his girlfriend and the male accused. However, sources in Kharavel Nagar police revealed that the investigating officials are yet to get any conclusive evidence regarding abatement of suicide.

Notably, the body of Azex was found hanging in his room at Kharavel Nagar late Saturday evening. The 29-vear-old was taken to Capital Hospital, where doctors declared him brought dead

Petrol bunk attacker a history-sheeter: Cops

Bhubaneswar: Commissionerate Police Tuesday slapped Section 110 of CrPC against the 24-year-old Bikram Das who, along with two others, was nabbed for assaulting employees of a patrol pump at Kalpana Square under Badagada police station, Monday, Police sources revealed that Bikram is involved in five robbery cases and several other cases in Jagatsinghpur and Bhubaneswar. Bikram and his aides - Manas Barik and Chinmaya Khuntiawere Tuesday produced before the court that sent them to jail. "Manas had come to the Petrol pump and asked the staffers to fuel his bike Monday. Without asking the quantity of fuel, one of the staffers filled petrol worth ₹233," a police official said. After an argument, the staffers emptied the fuel tank while an annoyed Manas left the place leaving his bike there. He turned up there along with his aides armed with weapons and launched an attack.

Centre extends tenure of tribunal

State, in its petition, claimed that Chhattisgarh has constructed several barrages on the river obstructing the water flow to Odisha

New Delhi, March 21: The Union Ministry of Jal Shakti has extended the tenure of Mahanadi Water Dispute Tribunal, constituted to adjudicate inter-state river water dispute, up to December 2024 as the tribunal could not deliver verdict on the issue within the stipulated time, official sources said Tuesday.

According to sources, the Union ministry has extended the tenure of the tribunal till December 14, 2024. The tenure of the tribunal

was ended March 11.

The Mahanadi Water Dispute Tribunal was constituted by the Union government March 11, 2018 for the period of three years following the directions of the Supreme Court to adjudicate dispute between Odisha and Chhattisgarh over the sharing of Mahanadi river water. The Centre in 2021 had further extended the tenure of the tribunal by two years till March 11, 2023 as the tribunal could not deliver verdict in the matter.

Significantly, the Mahanadi

Tribunal has not passed any significant order in the matter till now. The tribunal had in February 2019 reserved its order on the interim application filed by Odisha demanding a specific flow of Mahanadi water to the state during non-monsoon months, November to May, and stay on construction and operation of barrages constructed by Chhattisgarh on the river.

During the last hearing February 13, the tribunal had said that it will undertake the site visit before commencing trial of the Mahanadi water dispute and cross-examination as well as tendering of witnesses. It had asked the counsels of both states to sit with assessors and draw a schedule for the visit.

It is to be mentioned here that Odisha and Chhattisgarh have filed petitions in the Mahanadi water dispute tribunal in respect to sharing of Mahanadi river water. Odisha in its petition claimed that the state of Chhattisgarh has constructed several barrages on the river obstructing the water flow to Odisha. Odisha has sought stay on the construction and operation of barrages being built on the Mahanadi river and also for maintaining specific flow of water during the non-monsoon months, November to May.

In 2022, authorities also demolished what they described as illegal shops and properties, many of them owned by Muslims, in parts of India. 'Human rights activists reported the government was allegedly targeting vocal critics from the Muslim community and using the bull-dozers to destroy their homes and livelihoods' without due process, the US report released Monday added.

Accordingly, the government has sought the opinion of the advocate general. The advocate general opinioned, "Allotments made under the DQ which has been made in terms of the brochure and schemes to persons who are a single allottee by BDA, CDA and OSHB can be considered as genuine and the same can be excluded from the purview of the plots where action has been recommended by the Committee."

Since the allotment to the original single allottee can be construed as valid, the mutations and other post allotment formalities in favour of the legal heirs of such allottees can be considered as proper and valid, the AG said.

The Minister informed the Assembly that the state government agreed to the opinion of the government advocate and revised the resolution following Cabinet approval.

Now, the names of the allottees, getting only one plot/house/flat through fair means and by following the prescribed procedure has been excluded from the list. Names of the genuine allottees, who have transferred the plot, flat or house, have also been excluded from the Task Force report.

INDUSTRY-READY INFRA AT TOP OF AGENDA: DEB

Bhubaneswar, March 21: To accelerate the industrial development of the state, the Industries department has been provided ₹710.20 crore in the State Budget 2023-24, with ₹556 crore being allocated for development of industry-ready infrastructure, an amount about 25 per cent higher than the previous year's allocation, said Industries minister Pratap Keshari Deb here

Addressing the media on the highlights of Budget 2023-24, the minister said that development of world-class industrial infrastructure is one of the major agenda of the state government for which IDCO has already developed various sector-specific industrial parks including the Plastic Park at Paradeep, Aluminium Park at Angul, Seafood Park at Deras and Electronics Park at Bhubaneswar.

"All these projects have been completed and functional. With state of the art infrastructure and attractive land price, these projects are attracting investors to invest in Odisha. In the Seafood Park and Plastic Park, more than half of the leasable area has already been

allotted. In the EMC Park, RBI has started construction of hyper-data centre and other such projects are in pipeline," he added.

Speaking on new initiatives of the department, Deb said that in the coming years, the department has a target for construction of workers' hostel at 13 places having a combined capacity of 26,000 across the state. "Workers' hostel will be a value proposition as a basic infrastructure for MSME and large industries coming to set up units inside government-developed industrial estates. Similarly, government has a target to incur expenditure about ₹200 crore for land bank for procurement of government and private land, making it ready for investors," he said.

For availability of 'plug n play infrastructure' in the state, IDCO has completed modern IT Incubation Centre cum OHUB spreading over 3.57 acre of land and total built up area of 4 lakh square feet. With the infrastructure, other resources to help startups like guidance, tech support, access to investors, and networking have been made available for them to survive and scale. Similarly, IDCO has set up commercial space



at strategic locations at Dhenkanal Tower (close to NH 55) of built-up area of 1.5 lakh square feet and at Jharsuguda Tower (close to SH 10 along Biju Expressway) of built up area 2.5 lakh, informed the minister.

Briefing about several initiatives taken by the government, Department Principal Secretary Hemant Sharma said that more than 5,000 acres of land along the Biju Expressway has been identified for development of some 25 clusters of 10 districts, starting from Rourkela (Sundargarh) to Motu (Malkangiri); special provi-

sion of incentives has been made for units to be set up along Biju expressway in the notified industrial areas; steps have been taken for development of large area industrial estates from surrendered land by PSUs.

MSME sector second largest in providing employment

Similarly, Deb, who is also the
MSME Minister, told the media
that to further strengthen the status of small and medium industries
in the state, the Micro, Small &
Medium Enterprises (MSME) department has been allocated ₹570.35
crore in the 2023-24 State Budget,

an increase of almost 6 times compared to the ₹96.80 crore allocated in 2017.18

The minister informed that a new scheme has been introduced in FY 2023-24 whereby interest on working capital loan, availed from banks by manufacturing MSE's and manufacturing exporters, where cash credit (pre-shipment and packing credit in case of exports) limit is up to ₹10 lakh, shall be fully reimbursed by the state government. And in cases where the cash credit limit exceeds 10 lakh and runs upto 3 crore, the interest on working capital shall be reimbursed to the extent of 25 per cent.

"The reimbursement amount will be credited to the bank account of the beneficiary industrial units directly through the direct benefit transfer (DBT) mode half yearly. The tentative expenditure under this scheme will be ₹150-200 crore in FY 2023-24. There is a provision of ₹10 crore in the B.E of the FY 2023-24 and the requirement of the balance funds will be met in the Supplementary Budget," added the minister.

Saying that MSME is the second largest sector after agriculture in providing employment opportunities in the state, Deb informed that under Odisha MSME Policy, in the current fiscal year about 98 micro and small enterprises have been sanctioned CIS worth ₹20.00 crore as against Budget provision of ₹20.00 crore. Under this scheme, in the fiscal 2023-24, there is a Budget provision

of ₹25 crore. Further Deb added that under Odisha Food Processing Policy (OFPP) 2013 & OFPP 2016, in FY 2022-23 CIS amounting to ₹19.03 crore has been disbursed to sixtynine food processing enterprises against Budget Provision of ₹20.00 crore. Moreover in FY 2023-24, there is a Budget provision of ₹20 crore under this scheme. In the FY 2022-23, subsidies amounting to ₹9.09 crore has been disbursed to 272 eligible enterprises towards Interest subsidy on term loan, reimbursement of net SGST, employment cost subsidy and quality assistance under provisions of industrial policy resolution.

With an outlay of ₹70 crore, decision has been taken for establishment of MSME Park in 30 districts. ₹100 crore has been released to IDCO for establishment of MSME Parks at several places of the state.

Woman fakes pregnancy to get govt benefits

THE LADY HAD UNDERGONE TUBAL LIGATION IN 2017 TO STOP GIVING BIRTH

Malkangiri, March 21: In a surprising incident, a woman allegedly staged a fake pregnancy drama for months together in a bid to avail all the government benefits meant for pregnant women, officials said here Tuesday

The matter came to the fore after reports about the theft of an unborn baby from her mother's womb at the Mathili community health centre turned out to be false after an investigation by the police.

The woman identified as Kaushalya Bhuyan of Birenpalli village under Mathili block in Malkangiri district claimed that she was pregnant a few months back and registered her name with the local auxiliary nursing midwife (ANM) to get all the government benefits. She said Monday that she was experiencing labour



munity health centre.

There a doctor conducted checkup and found out that she was not pregnant. However, Kaushalya and her family members refused to believe the doctor and alleged that the 'unborn' child had been stolen from her womb.

Later, the hospital authorities lodged a complaint at the Mathili

probe and took the woman for another check up to the district headquarters hospital. There also the doctor verified the findings of his counterpart at Mathili and certified that the woman was not pregnant.

When questioned by the police, Kaushalya finally confessed to her wrongdoing. She said she lied all the while only to avail of the gov-

Sources said that Kaushalya even lied to her husband that she was pregnant. She used to visit the ANM worker every month and avail of all the items supplied by the government under its welfare scheme, sources added.

However, Kaushalya's concocted story got exposed when she was admitted to the hospital for childbirth, Monday. What is more surprising to note is that she had undergone tubal ligation in 2017, a surgery to prevent childbirth.

Meanwhile, Malkangiri's chief district medical officer (CDMO) Prafulla Kumar Nanda said Tuesday that an investigation into the matter will be carried out and necessary disciplinary action will be taken against Kaushalya. He added that if any ANM member is found guilty of aiding Kaushalya, then action will also be taken

FARMERS STARE AT BLEAK FUTURE

Unseasonal thunderstorms destroy maize cultivation

Umerkote, March 21: Severe unseasonal thunderstorms that ensued under the influence of the westerly winds has destroyed swathes of maize cultivation here in Nabarangpur district just ahead of its harvest

The crop loss has dealt a major blow to the farmers as they were expecting good returns by selling maize. This has pushed the farmers into distress as they ponder how to repay the loans they had taken to raise the crops and manage family expenses. Fed up over the crop loss, farm-

ers have warned to commit suicide if the state government does not come to their rescue and provide them financial assistance. They now stare at a bleak future as they do not have any other means of livelihood except cultivation.

Sources said that Umerkote block received 64.20 mm rainfall as well as hailstorms during the unseasonal rainfall in last two days. With the wind blowing heavily during the thunderstorms, the entire maize harvest was destroyed. Houses and properties in Umerkote block also suffered damages.

Farmers in Murtuma,



Chilkalpadar, Beheda, Khadka, Silati and Benra areas had grown maize on their farmlands. However. the thunderstorm razed the maize cultivation to dust. The calamity came at a time when fruits had just started appearing on the plants and the farmers were preparing to harvest their crops after a month. However, the thunderstorm destroyed all their hopes and drove them to the streets, they alleged.

A farmer alleged that they had to spend around ₹22,000 to ₹25,000 to raise the maize crops on farmlands having irrigation facilities during this rabi season. They had borrowed the amount but the calamity destroyed all their hopes. They alleged that not a single official from Agriculture and Revenue department has met them to make an assessment of crop loss while they are yet to get any financial assistance for last year's crop loss. They warned they will die by mass suicides if they are meted out with similar treatment this year.

When contacted, chief district agriculture officer Bijay Kumar Pattnaik confirmed the development stating that crop loss has occurred in four blocks of the district. He said that the department officials have rushed to the affected areas to make an assessment of the losses suffered by farmers. He said he will recommend the Odisha government for providing financial assistance as per norms after receiving the reports on crop loss in the affected blocks.

Sex racket busted in Balasore, 13 held

Balasore, March 21: Balasore police busted Tuesday a sex racket in this town. A total of 13 people including traffickers and pimps were arrested in this connection, officials informed. The police also rescued six women including two Bangladeshi nationals following raids at different places. All the accused persons were

Researcher informs about the medicinal value of plants found in the Mali hill range

Koraput, March 21: Hari Pangi, a traditional healer and researcher from Koraput district narrated Tuesday the efficacy of medicinal plants growing on Iswaramali, Deomali and Hatimali hills that form a part of the Malyabant or Mali hill range. Pangi is the director of 'Sri Gupteshwar Herbal Medicine and Traditional Technology Research Institute' which he had founded in 2000 along with nine other healers.

Sources said that the Mali hill range is the elixir of life for the people of 45 picturesque villages nestled in it. The hills, belonging to the state Forest department provide many medicinal plants that residents of the villages



use to cure their ailments. Incidentally the villages are located just five kilometres from Semiliguda town in this district. So many patients from Semiliguda visit Pangi's institute for treating their ailments.

Pangi spoke on the utility of medicinal plants while attending the 'International Visitors Leadership Training



Programme' held recently at the University of Oregon in

At the meeting Pangi spoke elaborately on the harsh heat effects and how climate change is affecting the rich biodiversity and medicinal plants growing on the Mali hill range. He also spoke on the herbs and medicinal plants and their utility in protecting people in rural areas from various diseases Pangi was the only person

from Odisha who was invited to attend this international conference. He drew appreciation after he spoke on the utilities of traditional medicinal plants like Bisalvakarani, Gangasiuli and Kochila and using traditional knowledge to treat thousands of people visiting him from various parts of Odisha.

Pangi said that the 'disharis' (workers in his institute) collect herbs, leaves, roots and flowers from the Mali hill range and use them for making traditional medicines. No Deal for Rohingya

International attention has, for the past few months, been drawn to the possibility of elections in Myanmar under the watchful eye of the military L junta that staged a coup in 2021 to deny an elected government the chance to function. In the process the focus has been shifted from the hapless 1.2 million Rohingya Moslems languishing in squalid, shabby camps in Bangladesh. They, along with about 600,000 others belonging to the ethnic group residing in the Rakhine state of Myanmar, are facing a humanitarian crisis with no solution in sight in the near future. They have virtually become stateless with the Burmese military regime not recognising their citizenship.

On the other hand, neighbouring Bangladesh which has received a bulk of the displaced Rohingya, is unwilling to term them as refugees. The miseries of over a million Rohingya who have gone over to Bangladesh have been compounded by the slashing of their rations in the world's largest refugee camp – Cox's Bazar. Another drastic cut of rations is in the offing. The UN has warned this is a question of life and death. The Rohingya have been staying in Bangladesh since 2017, when the Myanmar military, supported by militias, set fire to their homes and launched a murderous attack to force them to flee Rakhine state

Conditions in Bangladesh have become so bad that the Rohingya refugees have started crossing the sea to Malaysia or Indonesia. Unofficial figures put the death toll in those risky sea voyages at 350 so far. On top of it, the camps at Cox's Bazar have for some time been witnessing fires, the latest of which early this month rendered over 12,000 people shelterless. The meagre possessions that the refugees still had were also destroyed. Added to this is the menace of armed gangs who are operating freely in the area, attacking the refugees, robbing them, sexually abusing women in the camps and running a drug racket that is part of the notorious golden triangle. The Rohingya complain that Bangladeshi police have failed to tackle the problems created by both some locals and rival insurgency groups including the Arakan Army and Arakan Rohingva Salvation Army that are fighting against the military junta.

Bangladesh can hardly be blamed outright for the deteriorating situation. While the country itself needs international funding for sustaining its economy, it has now started seeing the impact of millions of refugees, particularly in the southern part of the country where Rohingya are sheltered in camps. The public sentiment toward the Rohingya is turning from sympathetic to antagonistic.

The Rohingya Moslems are being used by Bangladeshi political parties to serve their respective agenda. The incumbent Awami League government's policies in the initial phase seemed to have been prompted by the prospect of winning international laurels for dealing with one of the worst humanitarian crises. It is now finding the issue a hot potato.

The main opposition party, the Bangladesh Nationalist Party, and other religious parties, are keen on using the Rohingya Moslems' plight in Bangladesh camps to shore up their religious support base. Public opinion is increasingly veering towards repatriation as the ultimate solution.

For this to happen, the military junta in Myanmar has to be forced to create a congenial atmosphere for the return of the Rohingya. This can happen only through international pressure. But, there is little hope that countries such as China, India, Japan or for that matter the US would annoy the junta which serves the interests of these countries in varying degrees. Both China and India have strategic ports and infrastructure connectivity projects in Rakhine state and they can ill afford to alienate the Tatmadaw - the military regime. India provided a free submarine to Myanmar, being the Tatmadaw's third largest arms supplier. About 50 per cent of India's defence sales go to Myanmar

China constitutes Myanmar's economic lifeline and provides a diplomatic shield from international pressure through its veto power on the UN Security Council. Japan likewise pursues its own business interests.

The Rohingya now find themselves trapped, deserted by the international community and forced to live in hunger, disease, malnutrition and different forms of exploitation

mmon Shea, who spent a year reading the Oxford English Dictionary Afrom cover to cover and wrote about it in his book Reading the OED, commented on this word — meaning a surgical sponge that has been left in a patient after an operation — in a piece on the OUPBlog. The surgeon who told him about it called it "a memento that we surgeons sometimes accidentally leave behind to commemorate our presence in some poor patient's abdomen." Formally, it is called a retained surgical sponge, an example of the more general class of retained foreign objects. In both subject and appearance, gossypiboma surely fits anybody's definition of a weird word. Online dictionaries have said that it's an amalgam of words from two languages: Latin gossypium, cotton, and Swahili boma, meaning a place of concealment. However, standard Swahili dictionaries say boma is a raised enclosure of some sort, especially for protective or defensive purposes (it's from a Persian or Farsi word for a garrison or a place of safety). This is surely a false etymology. It is much more likely that gossypiboma was created from the Latin word plus the ending -oma that denotes a tumour or other abnormal growth (as in carcinoma or lymphoma), with a b added to separate the vowels. The ending is appropriate, since such growths can develop around alien material left in the body. This derivation is supported by another word for the situation, textiloma (from textile plus -oma), coined in 1996 in a paper in the Journal of Computer Assisted Tomography by a German radiologist, Lars Kopka, and four of his colleagues. Since surgical sponges are now usually made of synthetic fabrics it's more appropriate than gossypiboma and is becoming the more frequently used word. The earliest known example of gossypiboma was found by reader David Hocken in the title of an article in the journal Radiology in November 1978: Gossypiboma: The problem of the retained surgical sponge.

FIXING PLATFORM ECONOMY



A TAX ON **DIGITAL ADVERTISING IS ONE OF** THE ONLY **PRACTICAL WAYS TO CHANGE THIS EXTRAORDINARILY DESTRUCTIVE BUSINESS MODEL**

(Facebook), Alphabet (Google), Microsoft, Twitter, and a few other tech companies have come to dominate what we see and hear on the internet, shaping hundreds of millions of people's perceptions of the world. In pursuit of advertising revenue, their algorithms are programmed to show us content that will hold our attention - including extremist videos, disinformation, and material designed to stimulate envy, insecurity, and anger. With the rapid development of "large language models" such as ChatGPT and Bard, Big Tech's hold on impressionable minds will only strengthen, with potentially scary consequences.

But other outcomes are possible. Companies could deploy the latest wave of artificial intelligence much more responsibly, and two current court cases serve as warnings to those pursuing socially destructive business models. But we also need public-policy interventions to break up the largest tech companies and to tax digital advertising. These policy levers can help change Big Tech's pernicious business model, thereby preventing the platforms from inflicting so much emotional harm on their users-especially vulnerable young

The legal cases include Gonzales v. Google, which is currently before the US Supreme Court. At issue is the tech industry's insistence that Section 230 of the 1996 Communications Decency Act exempts platform companies from any liability for third-party content that they host. If platforms are acting more like news outlets than mere online repositories when they recommend videos, tweets, or posts, they should be held to the same standard as established media, which, under existing defamation laws, are not allowed to publish what they know to be untrue.

Hence, in a \$1.6 billion lawsuit filed against Fox News, Dominion Voting Systems has uncovered ample evidence that Fox's top onair hosts and executives were well aware (and told each other) that for

mer President Donald Trump's claims of election fraud were entirely false. Dominion thus has a strong claim to damages if it can show that Fox knowingly spread falsehoods about Dominion's voting machines in the 2020 election. Shouldn't online platforms whose algorithms disseminated the same lies be held to the same standard?

Addressing such questions has become even more urgent now that programmes like ChatGPT are poised to reshape the internet. These sophisticated algorithmic recommenders could potentially be trained not to promote extreme content or deliberate lies, and not to encourage extreme emotions. If an algorithm is exploitative or manipulative toward children (or anyone else, for that matter), the responsibility for such harm should lie with the humans in charge. After all, AIs at this level are not operating autonomously of human decisionmaking. To claim otherwise is to grant their creators legal immunity.

Tech companies should no longer be able to excuse their own inattention or negligence by arguing that "there's too much data"

for them to monitor. That wealth of data is the source of their profits, and the sheer abundance of content on their platforms is what makes their AIs so potent. While they should enjoy a reasonable degree of protection against liability for what someone else posts on their site, this should apply only to passive content that the platforms do not in any way recommend to other users. Active content that is algorithmically pushed out to millions of people to generate revenue is a different matter. Indeed, it is just like traditional publishing, only much more powerful.

If a daily newspaper publishes a commentary by a terrorist, some readers will probably stop subscribing. But since most individuals do not want to walk away from their existing online social networks, we need government regulation to re-empower consumers.

First, the largest platform companies should be broken up to create more intense competition between recommendation algorithms and their trainers. But for this to work in the public's interest, platforms also must be required to allow a user's social network to be transferred to a different platform. The same "interoperability" rationale allows you to keep your cell-phone number when you change carriers. Social-media and digital-content consumers should be able to vote with their feet when they don't like what a platform is promoting.

Second, and even more importantly, we need to force an adjustment in the prevailing Big Tech business model, which is based on harvesting vast amounts of user data and monetising it through digital-advertising sales. This business model explains why disinformation, outrage, and insecurity are so prevalent online. Emotional manipulation maximises user engagement, enabling more intrusive data collection and higher profits

A tax on digital advertising is one of the only practical ways to change this extraordinarily destructive business model. It would reduce platforms' temptation to maximise user engagement through emotional manipulation; and, if coupled with limits on data collection, it would provide incentives to develop alternative approaches, such

as subscription-based models. Another advantage of a digital-advertising tax is that it could be set even higher for content promoted to people under 21. Selling cigarettes or alcohol to minors is a serious criminal offense. While it is not feasible to forbid young people from seeing content that damages their mental health, a high rate of taxation on advertising revenues derived from promoting such material is entirely appropriate. The proceeds could be devoted to strengthening mentalhealth programmes, not least those for teen suicide prevention. If there is any doubt about which content is hurting young people, we can just ask the AI recommendation algorithm.

More men need to feel pain of periods

pain recently became the first European country to pass a law allowing employees with particularly painful periods to take three days of paid menstrual leave from work. If the menstrual pain is extremely severe, the paid leave can be extended to five days.

All that's needed is a doctor's note and Spain's social security system will pay for the paid leave.

Needless to say, when this news was discussed on Twitter and other social media, many people were thrilled about it, expressing their support with statements like this: "I love it! Every country should offer menstrual leave. Every planet even."

But many others did not like the idea of menstrual leave, their opposition based largely on the fact that menstrual leave does not, in most circumstances, apply to men. A typical conversation on social

media went like this: Anita: "This is great. Wish I could move to Spain.'

Robert: "You really don't like to work, do you? Just stay at home, watch TV and collect a paycheck." Anita: "Shut up, troll! I bet you've never experienced anything as painful as a period.

Robert: "Of course I have. I've been kicked in the you-know-Anita: "Glad to hear it."

Robert: "You're making fun of my Anita: "I'm sure it hurt, but to

compare it to menstrual pain, you need to be kicked every 10 minutes for three days!

Robert: "Ouch!"

Not every woman suffers from unbearable menstrual cramps, but for a significant number, the pain is so severe that they're unable to perform normal activities for several days a month, according to the American College of Obstetricians and Gynecologists. With three women in my household, I've witnessed this firsthand and felt helpless to do anything except open a bottle of pain medicine. But many men have no clue, apparently. That's why I applaud Sandra Sunny, an aspiring lawyer in Kochi, Kerala, for providing a great service to mankind. She designed a simulator that's allowing men to experience cramps.

"It was a horrible experience," a 26-year-old man named Faheem Rahman recently told The New York Times, "I could not concentrate on anything around me for as long as the cramps lasted."

The simulator, designed as part of a campaign to reduce the social stigma connected to menstruation in India, sends an electric current through wires clamped below a man's navel. It feels like a vibration at first, but when the intensity is increased, the induced cramps cause men to cry out in pain.

"I have so much more respect for my mother, for my sisters," Rahman said. "It's hard for them, that much I know.

It's too bad that the men, soon after experiencing the cramps, were not asked their opinion of menstrual leave. I have a feeling many of them would be supportive, especially if they were still connected to the wires.

Several companies in India are offering paid menstrual leave to their employees. Among them is Culture Machine, a Mumbai-based

digital media company that began offering first-day of period (FOP) leave in 2017.

Some employees may misuse a company's FOP policy, of course, but that's the case with almost any policy. There will always be a few people in every company who try to take advantage of a particular policy, whether it's a sick leave policy, maternity leave policy or FOP leave policy.

Employee: "Sorry, boss, I can't come to work today. FOP.'

Boss: "Okay, Sanjay, I understand. See you tomorrow ... Wait a minute, you're a man. Why are you having FOP?" Employee: "Not me, boss. My

wife. She has FOP, so I'm taking the day off to take care of her." Boss: "But our FOP policy only applies to employees. Your wife is

not an employee." Employee: "My wife and I are one.

It's called a marriage union. What affects her affects me.' Boss: "Nice try, but it won't work.

You'd better get to work soon or we might have our first FOP-related firing.'

New Delhi, March 21: The AAP Tuesday alleged that the Centre conspired to stall Delhi's Budget and said March 21 was a "black day" as an elected government was "prevented" from presenting it in assembly on its scheduled day.

It is "sad and unfortunate" that Delhi's Budget was stalled by the Centre, party leader Dilip Pandey said while addressing a press conference, hours after the ministry approved the Budget. The Aam Aadmi Party (AAP) leader said that an elected government was "prevented" from presenting its Budget in the assembly. "Today is a black day. An elected government was not allowed to present the Budget in the assembly. It never happened in the history of India. The beauty of democracy is that everybody is answerable," he said.

"Its been 10 days, the Delhi Budget was with the Centre. They did not act for the last 10 days. They knew that if they want to stop the budget from being presented, they need to do something at the 11th hour," Pandey said. Claiming that the Centre instead of sending the file back to the Arvind Kejriwal government, forwarded it to the chief secretary, he said this action has "shaken" the roots of

India's democratic systems.

'We claim that India is the biggest democracy in the world... World's most vibrant democratic system. The reason for this claim is that the roots of democratic values are very deep," Pandey said. "The Centre today has tried to dig out the strong roots of democracy. The news is being planted from the Raj Niwas (residence of the Lt Governor). The news is being planted. Useless reasons are being used," he said.

In the assembly Tuesday, Chief Minister Kejriwal said, "The budget had to be presented today. The Centre stopped it. We replied to (Ministry of Home Affairs) MHA's query without making any changes to the budget and they have approved it now. They wanted me to bow down. It's their ego and nothing else." J&K Budget passed in LS

New Delhi: Lok Sabha Tuesday passed a ₹1.185 lakh crore budget for the financial year 2023-24 for the Union Territory of Jammu and Kashmir, amid ruckus by the Opposition over a demand for a Joint Parliamentary Committee probe into the Adani issue. As soon as the House met again at 2 pm after an adjournment, Rajindra Agrawal, who was chairing the proceedings, asked BJP's Jugal Kishore Sharma to initiate the discussion on the budget for the Union Territory, which is under central rule at present. Sharma spoke for a minute after which the process to pass the budget was initiated. The budget for Jammu and Kashmir was passed by a voice vote amid din. Minister of State in the Finance Ministry, Pankaj Chaudhary, moved the proposals related to the Union Territory's budget on behalf of Finance Minister Nirmala Sitharaman. The bill, which was introduced Monday, among other things, provided a thrust on housing in rural areas and water tap connections to 18.36 lakh households in Jammu and Kashmir.

Minister Saurabh Bharadwaj said it was utterly "shameful" that the Budget had been stopped. "This is making a joke of us in front of the entire world. It is shameful that the Centre is stopping the Budget of a small state," he said in a statement.

New Delhi, March 21: The CBI has asked an Interpol body to restore the Red Notice against fugitive diamantaire Mehul Choksi terming its earlier decision to drop his name from the list had "serious shortcomings, procedural violations, overreach of mandate and mistakes".

The Commission for Control of Interpol's Files (CCF) which had removed Choksi's name from the list of fugitives based on his appeal last year is a separate Interpol body which is "not under the control" of the Interpol Secretariat and is mainly staffed by elected lawyers from different countries where people can challenge decisions to declare them fugitives.

Based on repeated appeals from Choksi, who is wanted in the ₹13,000 crore bank fraud in Puniab National Bank and is holed in Antigua and Barbuda after fleeing from India in 2018, the CCF removed his name from the Red Notice list in November 2022, the CBI said.

Red Notice is the highest level of alert by the 195-member strong

International Police cooperation organisation Interpol to locate and provisionally arrest a fugitive pending extradition, surrender, or similar legal action. The CCF which had rejected two previous appeals of Choksi -- in 2018, to not publish his name on the Red Notice list and in 2020, to remove his name from the list -agreed with his fresh plea in 2022, a year after an alleged abduction attempt from Antigua and Barbuda, the agency said.

Choksi had fled from India in the first week of January 2018, days before ₹13,000 crore was detected in the PNB. At the request of the CBI and Enforcement Directorate. Interpol included his name in the list of most wanted fugitives called Red Notice in December 2018.

The CBI had booked Choksi February 15, 2018, and after the CCF decision came, the agency slapped fresh FIRs against him.

Choksi had disappeared from his sanctuary in Antigua and Barbuda in May 2021 to mysteriously appear in neighbouring Dominica where he was detained for illegal entry.

NAXAL VIOLENCE DOWN BY 77 PC

New Delhi, March 21: The violence perpetrated by Naxals has come down by 77 per cent in just over a decade while casualties of the security forces and civilians have also declined by 90 per cent, Lok Sabha was informed Tuesday.

Union Minister of State for Home Nityanand Rai said the geographical spread of violence has significantly reduced and only 176 police stations of 45 districts reported Left Wing Extremism violence in 2022 as compared to a high of 465 police stations of 96 districts

"The number of LWE related violent incidents have come down by 77 per cent in 2022 in comparison to the high of 2010. The number of resultant deaths (security forces and civilians) have also reduced by 90 per cent from an all time high of 1005 in 2010 to 98 in 2022," he said replying to a written question.

The minister said the decline in geographical spread is also reflected in the reduced number of districts covered under Security Related Expenditure (SRE) Scheme. Number of SRE districts reduced from 126 to 90 in April 2018 and further to 70 in July 2021, he added.

"West Bengal is the only state which has not received anything from the Centre. It has not given us our due money. Even in this year's Union budget, there was nothing for our state. "Hence, in protest against the Centre's discrimination against West Bengal, I, as the chief minister, will stage a sit-in demonstration under the statue of Dr B R Ambedkar in Kolkata from March 29 and continue it till the evening of March 30," she told reporters at Dumdum airport. Banerjee, also the Trinamool Congress supremo, said she would also be protesting against the price rise of gas cylinders. After March 30, "we will take this programme from one block (of West Bengal) to another, from district to district", she said. "They have not given our dues. I myself had met the Prime Minister and told him that we are yet to get funds for the 100 days work scheme for six months. I had told Home minister Amit Shah when he had come here for a meeting," she said.

The chief minister said she had written to the central government several times seeking the dues but in vain. Baneriee questioned why West Bengal was not getting its dues even after earning accolades from the Centre alongside UN-ESCO, United Nations and other countries for its performance in dif-

Kanpur, March 21: A research to test the efficacy of use of antibiotics for the treatment of malnourished children has proved that kids do not need antibiotics Doctors at Kanpur's GSVM

Medical College have conducted the research, and as a part of it, they divided 100 malnourished children into a group of two. The first group of 50 children was given regular antibiotics along with a proper diet and IV drips in necessary cases. Meanwhile, the second group

was given the same food and IV drips in necessary cases but none of them were given antibiotics. Sharing the results of the ex-



periment, doctors revealed that both the groups recovered in a similar manner, showing that the use

of antibiotics was not actually nec-In fact, the kids who partic-

ipated in the study -- aged between six and 59 months -- even gained weight and grew in height proportionally. There was no additional ben-

efit of antibiotics. The research conducted by head of paediatrics department Dr Yashwant Rao and his team -has been published in the Indian journal of paediatrics. The research was funded by the

600 'Gajamitras' to protect elephants TN's MSME sector affected

Kolkata, March 21: In order to check the rising incidents of human-elephant conflict (HEC), West Bengal has launched a unique human-driven initiative, named 'Gajamitra (Friends of Elephants)'.

Under this scheme, the state Forest Department has started the process of appointing 600 local youth from HEC-prone pockets both in north Bengal as well as in south Bengal as these 'Gajamitras'

According to West Bengal Forest Minister Jyotipriyo Mullick, the recruitment process has already started. "Once the recruitment process is complete, the selected youths will be provided with android sets with the specially developed Gajamitra App installed there," he said.

The selected youths will procure advance information about the movement of elephant herds, alert the forest department and local people, so that preventive measures can be taken for avoiding HEC, the minister added.

It is learnt that 200 such 'Gaiamitras' will be deputed in the HEC-prone pockets in South Bengal, while 400 will be for North Bengal. "The number is double in case of North Bengal since numerically the incidents of HEC in North Bengal are much higher than in South Bengal," a senior forest de-

partment official said.

The districts in South Bengal to be covered under the 'Gajamitra' scheme include West Midnapore, East Midnapore, Bankura, Purulia. The districts in North Bengal that will come under its purview are Darjeeling, Jalpaiguri and Alipurduar: "Despite lesser number of districts in North Bengal being HEC prone, still incidents on these counts are much higher," the offi-

Considering that incidents of HEC are higher in North Bengal, the forest department in association with the railways has earmarked another project on this count in the region. The project is installation of a sensitive sensor alarm system along the railway tracks running through the jungles of the Terai and Dooars region in north Bengal to prevent

elephant deaths after colliding with speeding trains.

"This initiative is mooted considering that a vast portion of these railway tracks pass through the forests that have a number of crucial elephant corridors," the official said.

Explaining how this sensor alarm system will work, the official said that upon arrival of elephant herds near the rail tracks, the system will send alerts to the nearest railway station as well as to the nearest forest range office.

"On receiving the alert the nearest railway station will send an alert to the drivers of the trains moving in the region, so that they slow down and prevent collision with the tuskers. On the other hand, on receiving the alarms the forest department personnel posted at the nearby range office will take precautionary measures to ensure the elephant herd safely moves away from the railway tracks,' the official said

As part of the pilot project, the system will be installed covering a distance of approximately 50 km from Diana River Bridge at Nagrakata in Jalpaiguri district to Matharihat in Alipurduar. "This area is especially notorious for HEC," he said. As per the latest statistics, during the last three years 11 elephant deaths due to train accidents have been reported from West Bengal.

Chennai, March 21: The Micro, Small, and Medium Enterprises (MSMEs) of the two major industrial hubs of Tamil Nadu --Coimbatore and Tiruppur -- are hit as the migrant workers from North India have not returned after vacation.

Several MSME industries in Coimbatore are not able to meet the deadline of orders and this has affected the business. K.M. Guruswamy, owner of KRM industries, Coimbatore which is an MSME outfit taking sub-contract of major companies said, "The MSME sector is facing difficulty in these areas as there is a staff shortage. Most of the migrant workers, who had left home for Holi, have not come back. Many have not returned due to the fear of false news that was spread about the migrant workers being attacked in the state."

However, C. Sivakumar, President of Coimbatore Tiruppur District Micro and Cottage Entrepreneur Association (COTMA) said that this was a regular phenomenon during the Holy holidays. He said that there is around six lakh migrant workforce in Coimbatore and Tiruppur areas and that 35 to 40 per cent of the workforce leaves



for home during the period and they return a bit late.

Kolkata, March 21: The state Sunderbans development affairs department and disaster manage ment department will jointly conduct an audit of the embankments to counter the menace of crop damage due to saline water entering farmlands from damaged river embankments in the Sunderbans area of West Bengal.

The decision was taken after the state Sunderbans Development Affairs minister Bankim Hazra and the state disaster management minister Javed Ahmed Khan made a visit to those areas in Sunderbans where the problem of damage of crops due to flow of saline water following damage of river embankments is quite acute.

"Both the ministers agreed that a permanent solution to the damage of river embankments need to be achieved to stop this crop damage. However, in order to find that solution it has to be found out why the river embankments are



getting damaged every year despite repeated repairs. Hence the decision was taken to conduct an audit of the embankments in the region and accordingly take corrective measures," local Trinamool

Erode to get wildlife sanctuary soon

Erode (TN), March 21: Forest officials and public alike welcomed the announcement of a new wildlife sanctuary in Erode district following a statement made during the presentation of the Tamil Nadu Budget 2023-24.

When the state Budget was presented in the Assembly on Monday. it was declared that a new wildlife sanctuary called 'Thanthai Periyar Animal Sanctuary' will be formed in 2023-2024 and this is the 18th such sanctuary in Tamil Nadu, forest officials said on Tuesday. There are two existing wildlife sanctuaries in the district -- Vellode Birds Sanctuary and Sathyamangalam Tiger Reserve (STR)

The sanctuary will be formed over 80.567 hectares of forest land located in Gobichettipalayam and Anthiyur taluks of the district, but the headquarters of the new sanctuary will be decided by the government

In the proposed sanctuary, the animal populations would mainly comprise elephants, tigers, leopards, panthers, wild boars, and deer.

Forest officials said there are 21 different mammals, 139 bird species and 118 types of butterflies that would also inhabit the proposed sanctuary, which now exists in Erode District Forest area. The officials added that during last year's animal census, movement of nine tigers was noticed.

Migration of animals from STR and also from neighbouring Karnataka was noticed in Erode District Forest Division. Burgur, Thattakarai, Thamaraikarai, and Bejelatti are the main forest areas where the tribal population is high.

Chandigarh, March 21: Punjab Police arrested four people Tuesday for allegedly helping radical preacher Amritpal Singh escape their net and released seven photographs of the Khalistan sympathiser, including some in which he is not wearing a turban, to seek public help to nab the fugitive.

He was initially in his Mercedes vehicle but later switched to Brezza sports utility vehicle during police action against him Saturday. In a new photo that appeared on social media, Amritpal Singh could be seen riding pillion on a bike wearing a pink turban and black goggles, suggesting that he tried to change his appearance to get away from the eyes of police. In a CCTV footage, he could be seen sitting on the bike. In another CCTV footage of the Jalandhar toll plaza, which appeared on social media on Tuesday, showed Amritpal Singh escaping in the Brezza SUV.

Addressing the media here, Inspector General of Police (Headquarters) Sukhchain Singh Gill said the four arrested persons helped the fugitive escape in a sports utility vehicle. During their questioning, it came to the fore that Amritpal Singh went to a gurdwara in Nangal Ambian village in Jalandhar, police said. "There he changed his clothes, and wore a shirt and pant, and escaped along with three others on two bikes," said Gill.

The IG said efforts are on to nab him and 154 people have been arrested so far in this connection.

He said the National Security Act has been invoked against Amritpal Singh and a non-bailable warrant has been issued against him. Gill said Amritpal Singh's uncle Harjit Singh and driver Harpreet Singh have been booked in a separate case for taking shelter at the residence of Manpreet Singh, the sarpanch of Uddowal village in Jalandhar, at gunpoint

Kavitha submits phones to ED

New Delhi, March 21: BRS leader K Kavitha Tuesday was quizzed for about 10 hours on the third day of her deposition before the Enforcement Directorate even as she submitted some mobile phones used by her to the agency in connection with the Delhi excise policy linked money laundering case.

The MLC daughter of Telangana Chief Minister K Chandrashekar Rao reached the ED office in central Delhi from the Tughlaq Road official residence of her father around 11:30 am and left shortly after 9:40 pm. Before she entered the agency's office here, Kavitha flashed some mobile phones kept in a transparent sheet, and said she was going to submit them to the ED. The agency took the phones on record. However, sources indicated that they were "wiped clean".

In a letter written to the investigating officer of the case, the 44year-old leader of the Bharat Rashtra Samithi (BRS) said: "These phones are submitted without prejudice to my right and contentions and larger contentions whether a woman's phone can be intruded, in the teeth of her right to privacy."

Referring to the agency's allegation in its first charge sheet filed in this case last year that she was using at least two mobile numbers whose IMEI changed 10 times, Kavitha said, "It is baffling to note as to how, why and under what such circumstances the agency made such allegations when I was not even summoned or asked any



Sisodia seeks bail



New Delhi, March 21: Former Delhi Deputy Chief Minister Manish Sisodia Tuesday sought bail from a city court, saying he was neither a flight risk nor the CBI has found anything incriminating against him in its probe into the alleged in regularities relating to the excise policy, which, he added, was formulated "purely in

the normal course." Special Judge M K Nagpal, who deferred the hearing on Sisodia's bail plea till March 24 for clarification and submissions, meanwhile issued

a notice to the Enforcement Directorate and sought its response by March 25. The money-laundering case being probed by ED is an offshoot of the main case registered by the CBI.

During the hearing, which continued for more than an hour, the lawyers for the senior AAP leader said there was no documentary evidence of him receiving "kickbacks" and the allegation that the accused destroyed documentary evidence was "vague". Senior advocates Davan Krishnan and Mohit Mathur, appearing for Sisodia, said the accused cooperated in the probe and none of the searches led to the seizure of any incriminatory evidence and moreover, there was no further need for his custodial interrogation by the CBI.

The CBI, so far, has quizzed Sisodia in its custody for seven days. The senior lawyers said Sisodia was not a flight risk and regarding the allegations that the accused manipulated the excise policy, there was no documentary evidence of receiving kick-

They said changes March 17, the in the excise policy were made court extended the "purely in the ED custody of the AAP normal course' leader by five days and that it was a government policy, till March 22 which was approved by the Delhi lieutenant

Strong tremors jolt parts of north India

New Delhi, March 21: Strong tremors jolted parts of north India, including Delhi-NCR. Tuesday night as an earthquake of magnitude 6.6 struck the Hindu Kush region in Afghanistan.

Panic-stricken people rushed out of buildings as the earthquake struck around 10.20 pm and was also felt in Jammu and Kashmir, Haryana, Punjab and Rajasthan. There was disruption in mobile

services in some parts of the Jammu region immediately after the earthquake, an official said. There was no immediate report of any loss of life or property. According to an automated report generated by the National Centre for Seismology, the 6.6 magnitude quake struck 133 km southeast of Fayzabad in Afghanistan.

The earthquake was at a depth of 156 km. A Noida resident said he first noticed the dining table shaking.

'Soon after we saw that the fans were also shaking. The earth-

quake was strong in terms of intensity and stayed for a longer period," the resident of Hyde Park society in Noida said.

A cab owner in Delhi said he felt the earthquake while he was waiting for passengers.

"I was waiting for passengers and suddenly my car started shaking. I immediately shouted and told my friends about it," said cab owner Ramesh Pawar, who was near Connaught Place in central Delhi, Jvoti, a resident of Laipat Nagar in south Delhi, said she was watching television when she suddenly saw the TV and sofa were shaking.

Initially, she ignored it but when her husband alerted her, she and her family members rushed out of

"I ignored it initially but as soon as my husband alerted, I felt the earthquake too. This time it was strong and the sofa I was sitting on started shaking a bit. We rushed outside our home. Thankfully, we are on the ground floor, so in such situations, we have an easy escape," she said.

SC asks Centre to consider less painful method

New Delhi, March 21: The Supreme Court Tuesday said it is open to set up a panel of experts, while asking the Centre to initiate a discussion and collect relevant information to examine if there is a less painful method alternative to hanging by the neck to execute the death penalty.

A bench headed by Chief Justice of India DY Chandrachud said one of the aspects could be to look at the matter from the point of view of science and technology.

The Chief Justice queried if there was a method which is consistent with human dignity and socially acceptable, based on today's knowledge of technology and science.

'Do we have any data either in India or overseas relating to the circumstances as they transpired in the execution of sentence of death with alternate methods?"

The bench, also comprising Justice PS Narasimha, said: "alternatively, do we constitute a committee, thinking it aloud, not passing an order now. Committee to reflect on it. We can have two national law universities to be on the committee, experts dealing in execution of the sentence of death... We can also have people drawn from medical sciences, maybe one or two professors or doctors from AIIMS. We can have other distinguished people from the country."

The top court allowed Attorney General (AG) R. Venkataramani time till May to ascertain if any study has been conducted to find a

more humane method of execution. The apex court was hearing a writ petition by advocate Rishi Malhotra seeking a direction for quashing of the provision con-

tained under Section 354(5) of the Criminal Procedure Code as ultra vires the Constitution and especially Article 21 being discriminatory and also in contravention of the constitution bench judg-

ment in Gian Kaur's case. Malhotra contented that he is challenging the method of execution of death sentence in India i.e. by hanging by the neck till the pris-

The plea, citing Kaur's judgment, said: "the Right to Life including the Right to Live with human dignity would mean the existence of such a right up to the end of natural life. This also includes the right to a dignified life up to the point of death including a dignified procedure of death. In other words, this may include the right of a dying man to also die with dignity when his life is ebbing out."

In october 2017, the apex court had issued notice to the Centre noting the contention of the petitioner that the convict whose life has to end because of the conviction and the sentence should not be compelled to suffer the

Top court commutes death penalty of minor's murderer

The Supreme Court Tuesday commuted the death sentence of a man, convicted for kidnapping and killing a seven-year-old boy in Tamil Nadu in 2009, to 20-year imprisonment without remission. A bench headed by Chief Justice of India DY Chandrachud and comprising justices Hima Kohli and PS Narasimha said: "We are of the view that even though the crime committed by the petitioner is unquestionably grave and unpardonable, it is not appropriate to affirm the death sentence that was awarded to him. As we have discussed, the 'rarest of rare' doctrine requires that the death sentence not be imposed only by taking into account the grave nature of crime but only if there is no possibility of reformation in a criminal."

The suspension of the Pinduoduo app -- mainly used in China -- comes amid heightened US-China tensions over Chinese-owned apps such as TikTok, which some US lawmakers say could be a national security

peared before the Lahore High Court's (LHC) Justice Baqir Naqvi in the NAB investigation in Toshakhana case. The court granted him protective bail till next Tuesday

"Mr Khan told the court today that he came to the court 'secretly' as a heavy contingent of police was deployed near to his house to stop him from reaching the court," a court official said after the hear-

ing. Khan, 70, said he has no issue to appear in any case but during his appearance in court the government should make sure no chaos is created.

The number of cases registered against the PTI chief in the last 11 months of the PMLN-led government has swelled to around 100. Unlike his recent appearances in courts, Khan on Tuesday was not accompanied by party workers to the LHC from his Zaman Park res-

The PTI appears to have changed its strategy on Tuesday regarding sending a huge number of its workers along with the party chairman to the LHC apparently after the law enforcement agencies intensified crackdown on them.

The Punjab and Islamabad police have arrested over 500 PTI workers from different parts of the province. Police said the arrested PTI workers were wanted in the recent incidents of violence in Lahore and Islamabad.

Japan PM's Ukraine visit upsets China

Beijing, March 21: China Tuesday hit out at Japan after its Prime Minister Fumio Kishida made a surprise visit to Ukraine and overshadowed Chinese President Xi Jinping's meeting with his Russian counterpart Vladimir Putin in Moscow, saying Tokyo should do more to de-escalate the situation rather than aggravating it.

Beijing was caught by surprise as Kishida, who was on an official visit to New Delhi from March 19 21, entered Poland from India using a secretly chartered plane instead of the standard government aircraft, Japanese TV channel NHK reported.

The chartered plane left Tokyo's Haneda Airport at around 8 pm on Sunday, about three hours before a government plane carrying Kishida departed for India.

After wrapping up his scheduled events in India, the Prime Minister secretly boarded the waiting plane in the early morning hours of Tuesday, the Japan Times daily quoted an NHK report.

If found to have lied deliberately, he could be suspended or even lose his seat in Parliament.

Guidance had been followed at all times did not turn out to be correct."

But he said his statements "were made in good faith and on the basis of what I honestly knew and believed at the time. I did not intentionally or recklessly mislead the House." The committee will quiz Johnson in person on Wednesday afternoon about "partygate," the scandal over gatherings in government offices in 2020 and 2021 that breached the government's pandemic restrictions.

Police eventually issued 126 fines over the late-night soirees, boozy parties and "wine time Fridays," including one to Johnson, and the scandal helped hasten the end of his three years in office.

Trump failed to disclose gifts worth \$250,000

The report is titled "Saudi Swords, Indian Jewelry, and a Larger-than-Life Salvadoran Portrait of Donald Trump: The Trump administration's Failure to Disclose Major Foreign Gifts."

GRIM Months after Pak floods, millions lack safe water: UN

Islamabad, March 21: The United Nations children's agency Tuesday warned that after last summer's devastating floods, 10 million people in Pakistan, including children, still live in flood-affected areas without access to safe drinking water.

The statement from UNICEF underscored the dire situation in impoverished Pakistan, a country with a population of 220 million that months later is still struggling with the consequences of the flooding, as well as a spiraling economic crisis. The floods, which experts attribute in part to climate change, killed 1,739 people, including 647 chil-

dren and 353 women. So far, less than half of UNICEF's

funding appeal for Pakistan — 45 per cent of USD 173.5 million — has been met. According to the agency, before the floods struck last June, water from only 36 per cent of Pakistan's water system was considered safe for human consumption. The floods damaged most of the

water pipelines systems in affected areas, forcing more than 5.4 million people, including 2.5 million children, to rely solely on contaminated water from ponds and wells, UNICEF said.

"Safe drinking water is not a privilege, it is a basic human right," said Abdullah Fadil, the UNICEF representative in Pakistan. "Yet, every day, millions of girls and boys in Pakistan are fighting a losing battle against preventable wa-

terborne diseases and the consequential malnutrition."

"We need the continued support of our donors to provide safe water, build toilets and deliver vital sanitation services to these children and families who need them the most," Fadil added. Amid the crisis. Pakistan faces uncertainty about a bailout from the International Monetary Fund. Analysts say the revival of the USD 6 IMF bailout, which was signed in 2019, would help Pakistan. If the global lender released a key installment of the package, it would encourage other international financial institutions to help the country, they say.

At a U.N-backed conference in Geneva in January, dozens of countries and international institutions



pledged more than USD 9 billion to help Pakistan recover and rebuild from the floods. But most of the pledges were in form of project loans, and the projects are still in the planning stages.

Prime Minister Shahbaz Sharifs government is also facing a surge in militant attacks and political instability as his predecessor, Imran Khan, is campaigning for early elections. Sharif has rejected the demands by Khan, who was ousted in a no-confidence vote in Parliament last April.

Sharif seeks political and economic stability to ensure speedy reconstruction in the flood-hit areas, where the weakest and the children are paying the price.

"In flood-affected areas, more than 1.5 million boys and girls are already severely malnourished, and the numbers will only rise in the absence of safe water and proper sanitation," UNICEF said. The floods caused more than USD 30 billion in damages as large swaths of the country remained under water for months, forcing millions to live in tents or make-shift homes near stagnantwaters that led to the spread of

Tata Motors hikes CV prices by 5%

Mumbai: Tata Motors Tuesday announced increasing the prices of commercial vehicles by up to 5 per cent from April 1. The price increase comes in the wake of the implementation of the more stringent BS-VI phase II emission norms from next month, it said. The price increase will be applicable across the entire range of commercial vehicles, with the exact amount varying according to the individual model and variant, the company said in a statement. "Tata Motors will be implementing a price increase of up to 5 per cent on its commercial vehicles, starting from April," the company said. Tata Motors said it is upgrading its entire vehicle portfolio to conform to the stricter emission norms, which are set to come into force from April 1.

Windfall tax on diesel export up

New Delhi: The government has hiked the windfall profit tax on export of diesel to Re 1 per litre while the levy on domestically produced crude oil has been cut by a fifth, according to an official order. The levy on crude oil produced by companies such as Oil and Natural Gas Corporation (ONGC) has been reduced to ₹3,500 per tonne from ₹4,400 per tonne, the order dated March 20 said. The government raised the tax on export of diesel to Re 1 per litre from ₹0.50, and the same on overseas shipments of ATF remains at nil. The new tax rates come into effect from March 21, the order said.

Mumbai, March 21: Indian lenders are capable of enduring any potential contagion effects emanating from the US banking turmoil and UBS' recent takeover of embattled Swiss lender Credit Suisse given their manageable exposures to their global counterparts, S&P Global Ratings said Tuesday.

"Strong funding profiles, a high savings rate, and government support are among the factors that bolster the financial institutions we rate," the rating agency said.

S&P also said Indian banks had sufficient buffers to withstand losses on their sizable government securities portfolio due

Analysts have said that Indian banks are now in a better position to withstand stress given their current capital levels and healthy asset quality.

S&P said that only a significant escalation of the current crisis would force it to change its view.

RBI sees no big hit

MUMBAI: India's economy is gathering steady pace and is unlikely to face major repercussions from the recent global financial turmoil, the Reserve Bank of India said in its bulletin released Tuesday. "Unlike the global economy, India would not slow down - it would maintain the pace of expansion achieved in 2022-23," the RBI said in its State of the Economy article in the bulletin. "We remain optimistic about India," it added. The central bank's nowcast of real GDP growth for the fourth quarter of the current 2022/23 year stands at 5.3%, it said. RBI said, while the direct impact of the recent bank collapses in the United States or economic activity could be limited, markets are bracing for tighter financial conditions which could present a trade-off between financial stability concerns and monetary policy. "Yield curves are in deep inversion and the future looks darker than it did just a few weeks ago in early February," the RBI wrote, referring to the overall

India resists UAE calls for more air access

New Delhi, March 21: India is not looking at increasing air traffic rights for the United Arab Emirates, despite calls by Gulf carriers, and wants its domestic airlines to offer non-stop long haul flights, civil aviation minister told Reuters in an interview Tuesday.

The UAE has urged India to increase the maximum number of seats between the two countries by 50.000 a week from about 65.000 a week today, but Jyotiraditya Scindia said: "at this point we're not looking at increasing it."

India is one of the world's fastestgrowing aviation markets where demand for air travel is outstripping the supply of planes. But the bulk of India's international air traffic is currently carried by Gulf airlines such as Emirates and Qatar Airways, powered by efficient hubs like Duhai and Doha. The Indian government wants to recapture



widebody planes to meet demand. Air India last month placed a record order for 470 jets and is making an aggressive push in the international market by offering fliers, especially the Indian diaspora. non-stop flights to long haul des-

tinations in the United States. Scindia said Air India's widebody plane order and IndiGo's plans to fly twin-aisle planes were signs the 'transition' has begun.

"The minute you give direct connectivity to international locations directly from Delhi, any passenger is going to prefer a direct connect, rather than going through another country's hub," he said at his New Delhi office.

India is mobilising to handle the transportation needs of its population of 1.3 billion by building new airports in the country's remotest parts, while also expanding capacity at metro hub airports like Delhi and Mumbai.

BSNL expected to become profitable by FY27, says DoT

New Delhi, March 21: The Department of Telecom has sought ₹33,111 crore for payment of adjusted gross revenue dues of staterun BSNL which is likely to be made in the upcoming April-June quarter, according to a Parliamentary panel report.

In a submission to the Standing Committee of Communications and Information Technology, the Department of Telecom shared that against the proposal of ₹39,725.07 crore for 2023-24, ₹66,691.82 crore has been allocated to it in the budget.

"The increased amount is towards the payment of AGR Dues to BSNL, which is a part of its revival package. The Department had proposed an amount of ₹33.111.00 crore for the AGR Dues. The payment will be made once BSNL claims the amount and is most likely to happen in the first quarter of FY 2023-24,' the DoT informed in a written

reply to the panel. The Finance Ministry has allocated a total of ₹1,08,153.25 crore under Budget Estimates for 2023-24 to the DoT comprising ₹41,461.43 crore under revenue section and ₹66,691.82 crore for capital section accounts. The government had allocated ₹44,720 crore for capital infusion in the state-run BSNL and MTNL for the current fiscal which was revised to ₹33,269.01 crore and out of the total allocated fund ₹23,873.44 crore have been spent till December 2022.

The DoT has informed the panel that the techno-commercial bids of TCS and ITI were opened by BSNL on November 23 and financial bids of January 13 for procurement of 4G equipment and as per the cabinet approval Group of Ministers will approve the process of procurement.





Commonwealth Games champion Nitu Ghanghas (48kg) won her bout with a first round against Sumaiya Qosimova of Tajikistan, while last year's bronze medallist Manisha Moun (57kg) got the better of Nur Elif Turhan of Turkey in the third round.

Jaismine (60kg) came from a round down to overpower Mijgona Samadova of Tajikistan. Shashi Chopra (63kg), however bowed out of the tournament after going down 0-4 to Mai Kito of Japan. It was the second RSC win in as many bouts for Nitu in the tournament. Nikhat took a few seconds to de-

cipher her opponents game plan before attacking. She used her nimble feet to duck away from Herrera's counter attacks.
