Samal appointed Odisha BJP chief



Bhubaneswar: Newly-appointed BJP president in Odisha, Manmohan Samal asserted Thursday that the

saffron party will form the government in the state in 2024. Samal (64) was named chief of the BJP's Odisha unit and he replaces Samir Mohanty. "The next election will be fought by the people and they will bring the BJP government to power," Samal stated. "I thank PM Narendra Modi, BJP president JP Nadda and Union Home Minister Amit Shah for reposing trust in me. Our team will ensure that the BJP is in the power after 2024 elections," Samal, who is a former minister told reporters here.

Road sealed to protect Khandagiri-Udayagiri

Bhubaneswar: The ASI has sealed the Khandagiri-Udayagiri approach road in a bid to protect the monument from vibration stress and pollution due to vehicular movement. Earlier, the BMC had suspended movement of vehicles in a trial mode during the Hockey World Cup, However, it was opened again after the end of the tournament. "This has been done to protect the heritage structures from wear and tear due to pollution," an ASI official informed here Thursday.

No hike in power tariff for FY 23-24

Bhubaneswar, March 23: In what can be termed as a huge relief for consumers, there will not be any changes in electricity tariff in the state this year. The Odisha State **Electricity Regulatory Commission** (OERC) has decided to keep the domestic as well as commercial tariffs unchanged, officials said

With no changes in the tariffs, per unit charge will remain unchanged at ₹3.00 for the first 50 units for consumers. In the 50-200 units slab, the rate will be ₹4.00 per unit. From 200 to 400 units, users will be charged ₹5.80 per unit, while consumption above 400 units will be charged at ₹6.20 per unit.

"For domestic consumers, the delayed payment surcharge (DPS) has been waived off. So, the penalty levied after the rebate date will not be charged. Rural consumers will get 10 paisa per unit rebate in tariffs," OERC secretary Priyabrat Patnaik informed Thursday.

The OERC issued its order on retail power tariff after hearing the ARR and tariff applications of discoms like GRIDCO, OHPC, OPGC, OPTCL and SLDC, sources said.

The commission heard the matter through public hearings between February 13 and March 4. It had convened the State Advisory Committee meeting March 15. After hearing all the stakeholders, the OERC decided not to increase the power tariff, officials said.

Rahul gets 2 yrs in jail

CONGRESS LEADER PULLED UP FOR 'WHY ALL THIEVES HAVE MODI SURNAME' COMMENT MADE IN 2019

Surat, March 23: A court in this Thursday Congress leader Rahul Gandhi to two years in jail in a 2019 criminal defamation case filed against him over his 'why all thieves have Modi surname' remarks.

Rahul, who was present in the court when the verdict was pronounced, reacted later by quoting Mahatma Gandhi in a tweet in Hindi about truth and non-violence. The court of Chief Judicial

Magistrate HH Varma, which held Rahul guilty under IPC sections 499 and 500, also granted him bail and suspended the sentence for 30 days to allow him to appeal in a higher court, the Congress leader's lawyer Babu Mangukiya said.

As per the 'Representation of the People Act', a person sentenced to imprisonment of two years or more shall be disqualified from the Parliament 'from the date of such conviction' and remain disqualified for another six years after serving time. However, legal experts pointed out that Rahul will not be disqualified as a Member of Parliament if the appellate court stays the conviction and suspends



Sources in Congress said that Rahul will not attend Parliament till his appeal is heard while the party has called a meeting Friday morning to assess the situation in the aftermath of the verdict

the two-year jail term awarded to him The Congress said Rahul will file an appeal against the Gujarat court verdict, with a host of its leaders, including party president Mallikarjun Kharge and general secretary Priyanka Gandhi Vadra speaking out angrily on the matter. The BJP on the other hand said, the 'people will teach Rahul a lesson for defaming the nation'.

In his first reaction to the court's verdict, Rahul quoted Mahatma Gandhi in a tweet in Hindi about truth and non-violence. "My religion is based on truth and nonviolence. Truth is my God, nonviolence the means to get it -Mahatma Gandhi," the Congress leader tweeted.

In a tweet in Hindi, Kharge said, "Coward, dictatorial BJP government is incensed at Rahul Gandhi and Opposition because we are exposing their misdeeds and demanding a JPC. Under its political bankruptcy, the Modi government sends police, ED and imposes cases on political speeches. We will appeal in the higher

1 killed, 4 hurt Naveen, Mamata to work as two families fight over land

Angul, March 23: A man was killed and four persons sustained critical injuries after members of two families clashed over a longstanding land dispute at Badahinsar village under Jarpada police limits in this district, Thursday morning. The deceased was identified as Nabeena Sahu, 65, a native of the village. Police said they have arrested the murder accused Raghunath Sahu, 62, his wife Srimati Sahu, 55 and son Manas, 28, in this connection.

According to reports, the families of Nabeena and Raghunath had a long-standing dispute over possession of a small piece of land. Trouble started when Nabeena was digging a hole on the disputed portion to install a cement pole, Thursday morning.

Raghunath's son Manas opposed the move which led to an altercation and it soon turned into an ugly fight. Suddenly Nabeena and his son Anil attacked Manas and his wife Tapaswini. An enraged, Raghunath rushed to the spot with a crowbar and hit Nabeena on his head following which the latter collapsed and died on the spot.

The injured members of the two families are undergoing treatment at the DHH here, police said.

Bhubaneswar, March 23: Odisha Chief Minister Naveen Patnaik and his West Bengal counterpart Mamata Banerjee said Thursday that they had resolved to make the federal structure of the country 'strong and permanent'. The statement came after a much awaited meeting of the two chief ministers held at the conclusion of Banerjee's three-day visit to the land of Lord Jagannath.

Addressing reporters at the end of the meeting at the Naveen Niwas Patnaik's residence in this city with Banerjee beside him, the Odisha CM said, "We resolved to make the federal structure of the

There was no other political discussion." Banerjee seconded Patnaik and said, "I strongly support what Naveen ii said and I appreciate his efforts.

However, even though speculation remained rife that the meeting was part of Banerjee's plan to form an opposition (third front) with regional players minus the Congress, both CMs said that there had been no such discussion.

Banerjee was specifically asked about any discussion on formation of a possible third front for the next election. "Why are you in a hurry for the election? Still one year is there,' Banerjee shot back.

Indian rivers at peril as glaciers melt quick

■The UN chief has warned that unless measures are put in place to prevent the rapid melting of glaciers many low-lying countries may disappear forever

United Nations, March 23: The United Nations has warned that should the glaciers continue to melt as quickly as is happening at the moment, a number of major Himalayan rivers may face reduction in flow and even completely dry up in the foreseeable future. This observation was made by UN Secretary General Antonio Guterres while addressing a gathering about climate change. "Major Himalayan rivers like the Indus, the Ganges and Brahmaputra, all hugely important for India, could see reductions in their flows as glaciers and ice sheets recede over the coming decades due to global warming," Guterres said at a function Wednesday evening here on the 'International Year of Glaciers' Preservation' function.

"Glaciers are critical to all life on earth. Over centuries, they carved out the landmasses we call home. Today, they cover 10 per cent of our world. Glaciers are also the world's water towers. However, the way glaciers are melting is not good at all. Water level in many rivers including the Ganges may



reduce drastically," the UN chief pointed out.

Guterres also voiced concern

that human activity is driving the planet's temperature to dangerous new levels and 'melting glaciers are the canary in the coalmine'. Antarctica is losing an average of 150 billion tonne of ice mass every year while the Greenland ice cap is melting even faster -

losing 270 billion tonne per year. In Asia, 10 major rivers originate in the Himalayan region, supplying freshwater to 1.3 billion people living in its watershed.

"As glaciers and ice sheets continue to recede over the coming decades, major Himalayan rivers like the Indus, the Ganges and Brahmaputra will feel the impact seeing their flows reduced and some may even dry up at places, Guterres said. "The recent floods in Pakistan are an example as to how disaster looms large when ice melts quickly," he added. **Contd...P4**

PARL PANEL PITCHES FOR MORE POWER TO CBI

New Delhi, March 23: On a day nine states, including Chhattisgarh, Jharkhand and West Bengal, have withdrawn general consent to the Central Bureau of Investigation (CBI) to probe cases, a Parliamentary panel said Thursday that the exist-

ing law governing the probe agency has 'many limitations' and there is a need to enact a new legislation to define its sta-

tus, functions and powers. According to Section 6 of the Delhi Special Police Establishment (DSPE) Act, 1946, CBI needs the consent from the respective state governments for conducting investigation in its jurisdiction. However nine states have withdrawn the consent, Union Minister Jitendra Singh told the Rajya Sabha. The other states that have withdrawn consent are Kerala, Meghalaya, Mizoram, Punjab, Rajasthan and Telangana, the min-

The move comes in the wake of 9 states not allowing the CBI to probe cases in






Pradhan writes to Union min, CM

Bhubaneswar, March 23: Senior BJP leader and Union Minister Dharmendra Pradhan has written letters to his Cabinet colleague Bhupender Yadav and Chief Minister Naveen Patnaik urging them to take steps to address human-elephant conflict in Odisha. In his letter to Yadav and Patnaik,

the Union Education Minister has expressed deep concern about the escalating number of elephant deaths, and straining elephanthuman conflict in the state.

Over the past decade, Odisha has witnessed loss of 784 elephants, with 245 of these deaths occurring in the last three years alone, he said

"The month of March this year has been particularly devastating, with seven elephant deaths being reported – the highest in the past three years. Sadly, most of the deaths are due to poaching, electrocution or train/road accidents," Pradhan said.



and Patnaik, the Union **Education Minister** has expressed deep concern about the escalating number of elephant deaths

Citing state Assembly data, he said that altogether 2,776 wild animals, including 416 elephants, have been killed in the past five years (2017-18 to 2021-22) in Odisha. Further, Pradhan mentioned that 669 people and 741 domestic animals died, and 9,151 houses were damaged due to elephant attacks.

"Elephant conservation is of paramount importance to Odisha. as these majestic animals are an integral part of our ecological balance, cultural heritage, and the state's identity. The well-being of these creatures is essential for maintaining the health of our forests and the livelihood of local communities that rely on them," he said. Stating that the Union govern-

ment has shown commitment to wildlife conservation, Pradhan said the Centre's efforts in expanding the protected area network and launching project elephant have set a strong foundation for the protection of these gentle giants.

Considering the critical situation in Odisha, he sought the intervention of the Ministry of Environment, Forest, and Climate Change and Odisha government to ensure the harmonious coexistence of humans and elephants in Odisha.

No proposal for metro train in Bhub: Centre

New Delhi: Union Housing and Urban Affairs Ministry Thursday denied receiving any proposal from the Odisha government for Metro Rail Project in Bhubaneswar. Minister of State for Housing and Urban Affairs Kaushal Kishore informed the Lok Sabha that as per the Metro Rail Policy, 2017, the state government is responsible for initiating metro rail projects. He said the Centre considers financial assistance for such projects based on feasibility of the proposal and availability of resources, as and when posed by the concerned state

government.

STF rescues 2 pangolins, nabs 2 traffickers

Bhubaneswar, March 23: The Special Task Force (STF) of Odisha Police has arrested two wildlife criminals and recovered two pangolins from their possession.

STF sources here Thursday said on the basis of reliable information, the STF conducted a raid with the help of forest officials of Boudh forest division March 22 evening near Boudh bypass and nabbed two wildlife criminals - Uchhab Kanhar and Prasant Kumar Behera.

During the search operation, two live pangolins weighing 13 kg



and 10 kg respectively along with other incriminating materials were recovered from their possession.

The accused persons could not produce any authority in support of the possession of the two live pangolins. The STF registered cases U/s 379/411/120(B) IPC r/w. Sec.51 of Wild Life (Protection) Act, 1972 against the two wildlife criminals. The two accused persons will be forwarded to the SDJM court of Boudh. The live pangolins were handed over to Boudh DFO for safe custody.

The Indian pangolin (Manis crassicaudata), also called thick-tailed pangolin, scaly anteater and 'bajrakapta' is a solitary, shy, slowmoving, nocturnal mammal. It is a schedule-I protected animal under the Wild Life Protection act, 1972.

Schedule I provides absolute protection - offences under these are prescribed for the highest penalties.



Bolangir, March 23: Illegal acquisition of farmlands of poor farmers in and around the underconstruction Lower Suktel Irrigation Project in Bolangir district has kicked off a row, a report said Thursday.

The rich as well as land brokers are acquiring these farmlands in connivance with revenue officials. sub-registrar and town planning officials through fraudulent means and later selling them as housing plots to interested buyers. It is suspected that a large amount of money has been given as kickbacks to carry out this fraud

This has come at a time when a former tehsildar and revenue official in Bolangir district had to go to jail over land fraud. These land grabbers are alleged of violating the Odisha Real Estate Regulatory Authority (ORERA) rule and selling lands to people at very high prices than the market

rate. They have increased the land price in comparison with the money paid to the oustees as compensation for the Lower Suktel Irrigation Project.

Meanwhile, the construction of the spillway and soil embankment of Lower Suktel dam is underway in the district, the report said.

After becoming functional, the project will provide irrigation facilities to 40,000 hectare of farmlands from Magurbeda to Loisingha. Bolangir, Puintala in Bolangir district and in areas under Tarava tehsil of Subarnapur district on the downstream of Suktel river.

All the roadside farmlands have been divided into housing plots with information plaques with 'plot for sale' written on them



Kalinganagar, March 23: Jajpur district still paints a picture of neglect with fresh cases of malnutrition being reported from Ghati Sahi village under Ranagundi panchayat of Danagadi block in the district.

The incident has surfaced years after the non-descript Nagada villages hogged the headlines in 2016 following the death of over 20 children due to malnutrition.

This has been reported from the family of Banku Hembram, a casual labourer in the village. Banku's family consists of his wife Tulasi Hembram and nine children.

Among the nine children, seven are daughters and the rest two are sons. However, with meager earnings Banku finds it difficult to meet his family expenses. The family manages to get food to eat only in the first half of the day while the next half is spent in hunger.

Sources said one of his sons has died few days back. Now, two of his daughters, Kuni Hembram and Shanti Hembram, have been rendered bedridden as a result of severe malnutrition.

Banku has only a ration card in his name as government assistance but he never gets any ration through the card. The two girls make arrangements to send the

Bolangir, March 23: Known as an Ayurvedic paradise with abundant flora and fauna, the Gandhamardan hills spread over Bolangir-Bargarh districts, have now been designated a Biodiversity Heritage Site (BHS).

trict and Mahendragiri Hill Range in Gajapati.

The forest is spread over two districts - Bargarh and Balangir and is a treasure trove of medicinal plants, the notification said. It has some 1.055 plant species that include 849 angiosperms, 56 pteridophytes, 40 bryophytes, 45 lichens and two gymnosperms and 63 species of macrofungi.

Similarly, it boasts of some 500 species of animals that include 43 mammal species, 161 birds, 44 reptiles, 16 amphibians, 118 butterflies, 27 dragonflies and 7 damselflies and 83 species of spiders.

This apart, two historical monuments including the famed Nrusinghanath temple located on the northern slope and Harishankar temple located on the southern slope of the foothills of Gandhamardan have immense cultural significance. These two hill shrines are the two major pilgrimage sites of Odisha.

Hiuen Tsang in his chronicles had described this hill shrine as a Buddhist

heritage site named Parimalagiri. "At present, the rich biological resources of this cultural landscape are under pressure due to various anthropogenic and climatic factors, and the traditional ecological knowledge associated with the bio-resources of the hill is declining. The long-term protection, conservation and management of biological resources of the Gandhamardan Hills is of utmost significance for the state," read the notification.

BSF unearths Red dump in Balimela reserve forest

Malkangiri, March 23: The **BSF** Operational Party Thursday recovered a Maoist dump in Balimela reserve forest in the general area in Odisha-Andhra Pradesh border

BSF sources said a special operation was launched by 88 Bn BSF Thursday on the basis of information about dump of arms of Maoist in Balimela reserve forest. The BSF successfully recovered a Maoist dump in Balimela reserve forest area and recovered three steel tiffin IEDs, two SBML gun, one barrel of SBML, two empty fired case of SBML, 11 36HE grenades, 28 non-electric and six electric detonators.

Balimela reserve forest has been the safe haven for Maoist outfits since long due to topographical reasons and

favourable atmosphere. BSF troops and police are actively operating in the area to curb Maoist menace in the region and create a sense of security among the local populace so that Maoist ideology would not spread out

anymore. Recovery of such a huge dump of IEDs, explosives and SBML guns during ongoing TCOC and Saheed Diwas (observed by Maoist outfit March 23) would certainly demoralise the Maoist cadres and their sympathisers, BSF claimed.

Invest In Water

ogether with air, water is arguably the planet's most important natural resource. Functioning water systems are one of the technological pillars of civilisation, which often makes a water crisis a matter

Today, about two billion people lack access to safe drinking water, and roughly half the world's population experiences severe water scarcity for at least part of the year. Our limited freshwater resources are already overburdened by growing populations and water-thirsty economies. By 2030, global water demand will have exceeded the sustainable supply by 40 per cent. As demand for water grows and temperatures rise, water scarcity will threaten more lives and livelihoods - and thus the stability of societies around the world.

How can we turn the tide so that water empowers communities, secures our economies, and keeps the planet livable? As with global public goods such as a clean environment, there is a tendency to focus on the costs of improvement today, rather than on the greater long-term benefits of investing in the preservation of natural resources. The water sector today is underfinanced and chronically short of capacity to meet demand. But if we want to achieve the Sustainable Development Goal (SDG) of ensuring clean water and san-

itation for everyone, we must increase current global spending on water fourfold, to more than \$1 trillion per year (1.21 per cent of global GDP). We also must make up for the \$470 billion we lose every year through flood damage and poor irrigation.

By protecting the environment and the climate, every cent invested in the water sector boosts our economies, now and in the future. When the European Investment Bank provided a €200 million (\$215 million) loan to Jordan last December to finance a desalination plant on the Red Sea and a pipeline to the capital, Amman, the country's planning and international cooperation minister, Zeina Toukan, described these projects as crucial for both water security and comprehensive economic development. We all need to adopt similar thinking about how we value and manage water.

As with many other challenges, the public sector cannot fill this large investment gap alone. Businesses have an important role to play. According to the CDP, a not-for-profit organisation that collects environmental-impact data, more than \$300 billion of business

value is at risk globally if no action is taken to address water scarcity. Yet it will cost only one-fifth of that total – \$55 billion – to tackle the problem.

If businesses deploy new technologies to reduce their water consumption and to exploit wastewater as a source of energy, heat, nutrients, and materials, they can reduce their environmental footprint and free up more water for use by others. The CDP values such "water-related opportunities" at \$711 billion, reflecting not just savings on water use but also the growth of longterm potential markets in water-smart technology and the benefits of better community relations. Because water is cheap in most parts of the world, businesses often have little incentive to invest in saving water or in boosting the efficiency of water-intensive production processes

To persuade the private sector to focus on water-system preservation, we first need to start thinking of money spent on water as a real investment, rather than as a cost that can never be recovered. Second, the right value must be assigned to this water in order to create the necessary incentives for users and businesses to use it more efficiently, and for preservation to be economically rewarding. In the case of water, this requires a delicate balancing act, because affordable access to drinkable water and sanitation is a recognised human right - which means it is non-negotiable. Third, global cooperation and new cross-border programmes to mobilise greater investments in water would overcome market failures and prevent water from being politicised and weaponised.

This week's United Nations 2023 Water Conference in New York, the first such gathering since 1977, is a unique opportunity to discuss water security and to tackle the crisis head-on and to acknowledge that water investment is as critical to a sustainable and just economy as is clean-energy investment. We can establish new guidelines for fixing the water cycle and ensuring a more holistic approach to sustainable development everywhere, from the Netherlands and Luxembourg to Nigeria and Laos. And we must find more ways to incentivize water financing from public and private sources that are willing to wait for their investments to bear fruit.

Water is what will carry the SDGs across the finish line. We must finally start recognising it as a fundamental part of our investment portfolios, and put it at the centre of our economic policies.

THE 'REAL' REFORMS

LACK OF ACCOUNTABILITY HAS MADE RENT-SEEKING WIDESPREAD AND FREEWHEELING

The nation is going through a tough debate on the merits of a new pension scheme versus the old scheme that offered defined benefits to retirees. There is much pull for reservation and quotas for newer groups based on various criteria. And the government faced serious opposition for reworking the scheme for hiring jawans on short tenures. In each of these, and many other similar situations, the tension is about a cash-strapped government being asked to hand out solutions and salaries on an unending basis, harking back to the days when governments were looked up to as providers rather than enablers. 'Competitive Populism' is overtaking 'Fiscal Prudence'. The economic reforms were supposed to have changed that but they clearly didn't, given the way our reforms have panned out. So now, we hear of "second generation" reforms - more opening up, more withdrawal of government from services and more dependence on private players under liberalised frameworks. But the root question that remains unasked is simple: Why do we think economic reforms, version 2.0, will deliver when the first round under an experienced economist like Dr. Manmohan Singh fell short?

Here, we need to turn the focus to bigger questions - on the readiness and robustness of our institutions, the quality of our governance systems and the mindsets with which these systems operate to deliver to the common man and to cut out the rent seekers that abound in the system. It is time to look at the biggest of these systems and reorient or fix them, before we can unleash any new round of reforms. Good governance after all is at the root of any system that thrives to the benefit of all its members, and this is as much true for small groups as it is for a large society or a nation state. Today, there are many questions on our governance standards, leading to the big question of the day: Have we met the promises with which India became a free nation 75 years ago and constituted itself into a sovereign, socialist, secular, demo-

cratic republic?

As Dr. Babasaheb Ambedkar had pointed out right in the Constituent Assembly, "... however good a Constitution may be, it is sure to turn out bad because those who are called to work it. happen to be a bad lot. However bad a Constitution may be, it may turn out to be good if those who are called to work it, happen to be a good lot." In the same speech, he warned against "hero worship", and the "grammar of anarchy", and of the dangers of equality written down in the Constitution but the reality of all-pervading inequality in social and economic life.

How have we stood up to these threats over the years? Are our governance standards being strengthened or are they falling behind and failing us? It might be use ful to undertake a comprehensive and dispassionate review of where the nation stands after 75 years of independence in terms of delivering justice, liberty, equality and fraternity - the watchwords of our Constitution.

The most important institutions for the efficacious delivery of those egalitarian values are the judiciary, the civic administration and the law & order system in the country. Take the judiciary. The dictum, "justice delayed is justice denied," appears true in a significant number of cases in India. Delivery of justice is expensive and is getting more so, excluding the vast population of low economic means to approach the system and demand justice,

let alone secure it. The National Judicial Data Grid has a dashboard of pending cases; it shows a pendency of 42.7 million cases, over 70% of them over a year old as of March 2023

Consider the civic administration, which facilitates the quality of life, living and opportunity. The common man is aggrieved by the functioning of the civic administration. It is clear that the 'haves' garner disproportionate resources and opportunities and the 'havenots' have to struggle to be treated equally. This applies to providing of social infrastructure like water, sanitation, health, education et al as also for pursuing a vocation and profession. We see an imbalance of facilities between slum and non-slum populations even in glitzy urban centres like Mumbai.

Similarly, the treatment of the common man by the police administration to ensure the safety of life, liberty and property are unequal. People with means and manoeuvrability often get away with misdemeanours, even heinous ones, and the ordinary person is sub-

jected ill-treatment and harassment. A broad analysis of the functioning of these institutions suggests two fundamental constrictions. First, the design of these institutions is an inheritance of the colonial era. Over the decades, demands on these institutions have multiplied and varied. The marginal tweaking in the design and the functioning of these institutions undertaken so far are wholly inadequate to deliver the expected outcomes. Secondly, most

of those with authority and dele gated power at the outposts have become centres of rent-seeking. Lack of accountability has made rentseeking widespread and free wheeling. There is no gainsaying that the setting is used by the people of means with unrestrained zeal to benefit themselves or work with impunity in the face of all manner of violations.

India must now look to re-engineering the design of these institutions forthwith. Whereas rentseeking is a human phenomenon and almost impossible to eliminate entirely, it can be minimised by a) education, b) accountabile ity (with tough and swift action to set out examples), c) transparency and d) the use of technology. In case if the deficit is not addressed with missionary zeal, people's faith, which is already sinking, will dissipate completely.

Henry Clay (April 12, 1777 – June 29, 1852), the American attorney and Statesman, once observed "Government is a trust, and the of ficers of the government are trustees; and both the trust and the trustees are created for the benefit of the people." To live-up to this trust calls for some fundamental change in our approach to reforms. Many of the politico-economic pundits talk of second-generation reforms but restrict their recommendations to supplementary reforms of factors of productivity. The second-generation re forms call for a rewiring of the entire institutional framework, if we indeed seek to build a great nation. We must preserve independence, allow institutions to work freely and forcefully but keep a sharp eye for systems that build power only to exploit the people and self-perpetuate themselves. All institutions should work to serve the ordinary citizen. We need to work hard to achieve this and to meet our obligations of building an egalitarian society full of justice, liberty, equality and fraternity. I will attempt to discuss some solutions in a later piece.

Is faster adoption necessarily better?

A POLICY FOR INCREASING ADOPTION TO REDUCE THE NUMBER OF CHILDREN IN INSTITUTIONAL **CARE IS AN ABSURD ASSUMPTION**

uring the last Winter Session platform. Unlike the previous prac-panacea. It is complex especially in the best interest of the children. of Parliament. Union Minister for Women and Child Development Smriti Irani highlighted the new regulation intended to expedite the adoption process. The Minister underscored the policy change that has speed up the adoption of 580 children including 'hard-to-reach' in older age groups - out of close to 900 pending cases in courts. Some might find the development positive and promising. However, it is unfair to reduce children's lives to faceless numbers and ignore the fundamentals

of the changes. Since 2000, the enactment of the $\label{eq:Juvenile Justice} \ \ \text{United Care and Protection}$ of Children) Act or, JJ Act 2000 carved out a legal and structural space to establish a secular adoption system. The Act has introduced several amendments such as broadening the field of prospective adopters to promote in-country adoption in the best interest of the child. Following a significant reformation in 2015, with stringent policy changes to expedite adoptions, the country witnessed a sharp rise in prospective adoptive parents; almost tenfold of available adoptable children. Interestingly, the policy shift popularised with a narrative of 'transparency and accountability' was launched with a centralised digital

interaction and professional discretion of social workers, which is critical to successful adoption. Further, the new regulation notified in September 2022 aims to speed up court procedures - as the best solution for children - empowering district magistrates to issue adoption orders, the power, which was earlier vested in the judiciary since the JJ Act, 2000 came into force. A careful examination of the

deliberate destabilisation of institutional practice, undermined professional autonomy, and shifting policy priorities to advance domestic adoption does not seem to be wholly compassionate. The pronunciation of the so-called 'best interest of the child principle' serves rather more to the best interest of the state. It not only gives parental right to people deemed responsible but also removes itself from the primary responsibility and corresponding obligation to protect families from separation. In the name of children's welfare, the state seems to portray adoption as a problem situated not within the inadequate social protection system but within the family and individuals.

As an alternative way to form a family, adoption is not a risk-free in Indian context, with implications for all concerned in the adoption triad - the adoptee, the birth family, and the adoptive family – that endure for decades, often lifelong. As India follows a 'closed adoption', it severs the ties between a birth parent and the child. Further, because of the cultural importance attached to the primacy of biological connectedness, the adoptive family lives in an essentially unwelcoming environment by challenging the biological version of kinship to create a legitimate one. Unlike the days when infant adoption was a norm, these days majority of children placed for adoption are above three years in age.

A 'hard to place' child is over the age of six, differently-abled, and with special needs. In such a scenario, promoting adoption with a 'happy ever after' narrative, the government overlooks the unique characteristics of the adoptive family and complexities of adoptive kinship. It requires specialised service, structured pre and post adoption support, and meaningful engagement between adoption triad to ensure permanency and stability for children. Inadequacies in the current policy are evident as nearly 7% children annually experience unsuccessful adoption - certainly not

to reduce the number of children in institutional care is an absurd assumption. There is a need to weigh up the opportunities and challenges of adoption in relation to other options, such as kinship care, foster care, sponsorship, and legal remedies like custody and guardianship, which can provide safety and stability for children without a severe break with key relationships. Rushing to speed up adoption by ignoring the significance of professional discretions. the complexities adoption poses, and being out of line with the emotional realities for most involved is too stark. Further, there is a dearth of research to inform adoption policy and practice in India. Without evidence, voices of all concerned. the piecemeal arrangements made for adoption in its current form and existing policy is not only unethical but dangerous. It is perhaps timely to move away from 'closed adoption' and consider the concept of openness and what might be needed to support it being done carefully for adoption to be ex-

Water-stressed nation

Sir, This refers to "India at severe water crisis risk: UN," Orissa Post, March 23. India's dependence on an increasingly erratic monsoon for its water requirements increases this challenge. Climate change is likely to exacerbate this pressure on water resources, even as the frequency and intensity on floods and droughts in the country increases. The country has 18 per cent of the world's population, but only 4 per cent of its water resources, making it among the most water-stressed in the world. Groundwater is one of the most important sources for irrigation as well as for rural and urban domestic water supply. However, overexploitation of this valuable resource has led to its depletion. Continuous piped water supply has been a pipedream for fast-urbanising Indian cities. Most urban households receive water for a couple of hours a day at most, and often only on a few days a week. This particularly affects the poor, women and children, who spend time and money securing water for their daily needs. Add to this, rainfed agriculture in India is a risky enterprise, owing to uncertainties in rainfall, coupled with periodic dry spells and heavy cyclones and floods during the monsoon season. Another worry is as water runs out, the country may have to confront a series of associated problems: food insecurity, vulnerability during heatwaves, disease due to deteriorating sanitation and regional conflicts over water access



New Delhi, March 23: The moratorium on opening of new engineering and technical colleges, which was put in place three years ago, will be lifted from the 2023-24 academic session, the All India Council of Technical Education (AICTE) announced Thursday.

The council has also done away with the minimum land requirement criterion for starting or running technical institutions. The technical education regulator had imposed a two-year ban from the academic year 2020-21 on opening of new engineering institutes due to a declining number of admissions in engineering programmes.

"Moratorium for establishing new institution in engineering and technology has been lifted from AY (academic year) 2023-24. However, for establishing a new institution in engineering and technology, preference shall be given to the applicant offering courses in multi-disciplinary area in-line with NEP (National Education Policy) 2020 in STEM," the AICTE said in its new approval guidelines.

How new medtech is helping India fight tuberculosis?



New Delhi, March 23: Advances in medical technologies, that came with the inclusion of Artificial Intelligence (AI), Machine Learning, Internet of Things (IoT), and deep tech, have revolutionised diagnosis of tuberculosis (TB) - the world's largest infectious disease killer -- in India, said experts Thursday ahead of the World Tuberculosis Day.

World Tuberculosis Day is observed every year March 24. "Yes! We can end TB!" is the theme for this year, and urges leaders from around the world to act to stop the TB epidemic.

The disease is preventable, treatable, and curable, but early diagnosis remains the key. Accurate diagnosis of TB early in the infection cycle can help accelerate therapy and curb the spread of the disease. "Given the current infrastructure in India, the early diagnosis of TB continues to be the biggest hurdle in treatment compliance. For TB to be completely eradicated, we need a public health infrastructure that is equipped to detect infectious pulmonary cases early before the disease has a chance to spread," Pavan Choudary, Chairman, Medical Technology Association of India (MTaI), told IANS.

AI and ML have shown more promise in automating early detection, more than the traditional screening for TB via a simple lung X-ray. AI-powered deep learning neural networks are increasingly being used to analyse



medical images, such as chest radiographs or x-rays.

"Modern advances in digital radiology, AI/ML and Nucleic Acid Amplification techniques have now come together to proTB afflicts more than 10 million

India contributes to over 30 per cent of the global TB burden

■ In 2021, India had estimated 30 lakh new TB cases. About 38 per cent of the global TB deaths took place in India

structure," Chandrasekhar Nair, Director & CTO, Molbio Diagnostics, told IANS.

"India is the first country globally to roll out point of care molecular detection of TB as a replacement to sputum smear microscopy even at remote locations across the country. This results in very early diagnosis of TB patients and their enrollment in the cascade of care of the National TB elimination programme," he said.

Further, India has deployed digital health platforms like India's 'Nikshay' which integrate all TB patient diagnosis and monitoring data, including patient nutrition, have started making a significant difference in the management of TB care in India.

A few states in India have also integrated private players for lastmile delivery of TB drugs. Various adherence solutions from the lowcost 99 dots using SMS services, video observed therapy to IoTbased pill boxes are improving adherence to therapy and leveraging technology to provide analternative to directly observed therapy methodology.

Telangana not to send crop loss report to Centre: KCR

CM disapproves of the present system whereby the state government had to report to the Centre about crop losses and a Central team would then visit and assess the damage, following which financial assistance is announced after six months

Hyderabad, March 23: The Telangana government will not send any report to the Centre on crop damage caused by recent unseasonal rains, in protest against the Central government's unhelpful attitude towards reports sent earlier, Chief Minister K Chandrasekhar Rao said Thursday, even as he announced financial assistance of Rs 10.000 per acre for farmers. Rao inspected the crops damaged due to recent unseasonal showers and hailstorms in Khammam, Mahabubabad and other districts.

Speaking to reporters in Khammam district, the CM alleged that the present policies of the Centre were not helpful to farmers in times of crop losses and that they benefited insurance companies instead. "The previous Central governments were



like that, and (with) the present Central government, it is like (the message is) falling on deaf ears. Not much use telling them (about losses to farmers)," he said.

Rao said the country requires a 'new integrated agriculture policy'. He disapproved of the present system whereby the state government had to report to the Centre about crop losses and a Central team would then visit and assess the damage, following which financial assistance is announced after six months.

The incumbent NDA government's attitude is such that they are only interested in politics and not bothered about farmers, he alleged.

'So, we don't intend to send a report to the Centre, as a protest. Because nothing was given on the basis (of reports) sent earlier," he said. As per the Centre's present rules, the compensation given to

farmers is inadequate, he said. The amount is just over Rs 3,000 per acre for maize and Rs 5,400 for paddy.

The Chief Minister announced financial assistance of Rs 10,000 per acre to farmers to enable them to recover their losses and resume farming. Rao said the government would also provide relief to tenant farmers who suffered crop loss.

According to him, this decision was made based on the representation of the state minister and other public representatives in Khammam district and also the leaders of the CPI and CPI(M) who were present during the CM's inspection of damaged crops.

According to Rao, crops in over two lakh acres were damaged and the state government would sanction Rs 228 crore immediately to provide financial assistance to

Massive breach: Data of 16.8cr people leaked

Hyderabad, March 23: A massive data breach that has implications for national security was unearthed by Cyberabad Police here, who arrested seven people of a gang allegedly involved in the theft and sale of sensitive data of the government and important organisations, including details of defence personnel as well as the personal and confidential data of about 16.8 crore citizens.

The accused persons were found selling more than 140 different categories of information, which include sensitive information such as details of defence personnel and the mobile numbers of citizens and NEET students, among oth-Cyberabad Police Commissioner M Stephen Raveendra told reporters here Thursday. Seven data brokers were arrested from Delhi, police said adding that the accused had been operating through three companies (call centres) in Noida and other places. So far it has been found that the accused sold data to at least 100 fraudsters. Investigations

are still on, police said.

Sensitive data of defence personnel containing their ranks, email ids, place of posting, etc was found available with the accused, Commissioner Raveendra said.

"This will have serious national security implications. The data of defence and government employees can be used for espionage; to impersonate them and commit serious offences that may jeopardise national security. We are in the process of finding out how this data got leaked and who are the insiders who are doing it," he added.

The accused were also found selling information in categories such as Energy and Power sector, PAN card data, Government employees, Gas and Petroleum, HNIs (High Net-worth Individuals), demat accounts, student databases, women databases, data of people who have

applied for loans and insurance, and credit card and debit card holders (of private banks), WhatsApp users, Facebook users, IT organisation employees, frequent flyers etc.

The arrested were selling the data through a search engine company and similar platforms, police said. These accused aggregated the data leaked from different organisations and having registered themselves as service delivery agents sold the data to cyber criminals after sending them sample data, police said

The matter came to light after a complaint was lodged with the Cyber Crime wing of Cyberabad Police about the sale and purchase of confidential and sensitive data, even as police had also been investigating how cyber criminals were getting access to data.

The data of NEET students, with

their names, mobile number and their residential address, was also found with the accused. A PAN card database containing sensitive information on the income, email ids, phone numbers, and ad-

dresses of citizens was also found. Government employees' names, mobile numbers, categories, dates of birth etc were also found in a database, apart from a list of gas and petroleum companies with similar details of their staff, Raveendra said. As many as 1.2 crore WhatsApp users and 17 lakh Facebook users had also been targeted in the data theft, with information on login id, IP, city, age, email id, phone number found in the possession of the accused, police said.

Further, a mobile number database of three crore individuals, probably leaked from telecom service providers.

A give-&-take that keeps 'khejri' trees, farmers in good nick

Lakhs of khejri trees are found in the fields of Rajasthan, but they did face an existential crisis about three decades ago due to pest attacks

Sri Ganganagar, March 23: For the farmers of Rajasthan, khejri (Prosopis cineraria) is much more than the state tree. It serves as fodder for livestock, firewood for house holds, vegetable for personal consumption and manure for fields.

Lakhs of kheiri trees are found in the fields of Rajasthan, but they did face an existential crisis about three decades ago due to pest attacks. The crisis is not vet over, but the tree's existence is intact due to the coordinated efforts of farmers and government departments. A pathologist with the forest protection division of Jodhpur-based Arid Forest Research Institute (AFRI), Dr Sangeeta Singh says that they had launched a seven-year research in 2010 to understand the factors contributing to the mortality of khejri trees and offer possible solutions.

"We concluded that there are two biotic factors -- a root rot fungus (Ganoderma lucidum) and a root borer (Acanthophorus serraticornis) -- behind this issue. We also studied the abiotic factors at play, including falling water level and ploughing of fields with tractors." Once the research concluded, the AFRI issued advisories and shared solutions with farmers to ensure the protection of khejri trees, while also promising returns to them. The advisory told farmers



not to prune trees every year, and instead do it every alternate year. Trees that were fully damaged

were destroyed along with their roots so that the infection does not spread. Soil treatment and Bavistin insecticide in small quantities were also used from time to time.

Farmer Sitaram Sengwa from Jodhpur's Palri Ranavata village said he kept spraying insecticides that the scientist recommended and got good results. "I have planted thar shobha khejri, developed by the ICAR-Central Institute for Arid Horticulture, Bikaner. Fortunately, there is no pest infestation on it so far." Dhannaram Nayak, the secretary of Nagaur-based NGO Urmul Khejadi Sansthan said farmers dig pits around the trees and provide pesticides and water, which reduce pest infestation. "Sadaram, a farmer who passed away two years ago,

used to put millet husk instead of pesticides, which made the trees healthier," he added.

Krishnakumar Saharan from Saharan ki Dhani in Hanumangarh said unlike in the past, farmers take care to not disturb the khejri plant while ploughing the fields. "Sometimes, we remove them and

replant in another place," he said. The tree has great significance in rituals too, be it birth, marriage or death. "Green khejri twigs are placed in an urn filled with water as part of the nahaun ritual following childbirth. The tree's wood is used for havan (a fire ritual) for marriage ceremonies. It also forms the funeral pyre," said Nayak, a resident of Jhareli.

Every part works

Lakhs of khejri trees are present in the districts of Nagaur,

Bikaner, Ajmer, Churu, Barmer, Jaisalmer, Jodhpur, Pali, Sirohi, Hanumangarh, Sriganganagar, Jaipur, Karauli, Sikar and Jhunjhunu due to the community involvement.

"Khejri is a friend of farmers." They complement each other. When other trees wilt in the scorching desert heat, evergreen khejri shelters humans, animals and birds, Padma Shri Himmataram Bhambhu said. Farmers sell the legume (sangri) as a vegetable and leaves (loong) as livestock fodder. Chinkara, black buck and nilgai from the wild also feed on its leaves. while birds make nests on the tree. Joshi, a farmer from Halasar in Churu district, has 110 bighas of land. He gets sangri, loong and firewood in abundance from about 500 khejri trees present in his plot. Jagdish Nayak of Nagaur also gets

similar benefits.

Khejri's bark and flowers have been in use for several centuries to cure various diseases. "In Vedas, it is mentioned as shami tree. According to scriptures, it can treat conditions related to phlegm and bile. Mix its bark with hartal (a mineral) and apply to remove unwanted hair. Its leaves and bark are used to treat diarrhoea, dysentery, piles and worm infection. It is useful in the treatment of respiratory and skin diseases and blood gall as well," Gopal Sharma, Assistant Director, Department of Ayurveda, Nagaur, said.

Positive effect on crops

According to Kashiram Saharan, an elderly farmer from Saharan ki Dhani in Hanumangarh district, 78 khejri trees are present in his 60 bighas of land. "In the fields with khejri, yields from crops such as pearl millet and cluster beans are

excellent," he claimed. Confirming this, Dr Sangeeta Singh explained, "Rhizobium bacteria attach themselves to the roots of leguminous plants and help fix atmospheric nitrogen, which is converted into ammonia. Khejri roots also have this bacteria's presence, which helps the plant to utilise the produced ammonia for its growth.

Thanks to its numerous benefits. people love khejri. Last year, when 250 khejri and rohida trees were cut in Badi Sid in Jodhpur for a proposed solar power plant of AMP Energy Green Four Private Limited, the community launched an agitation and moved the NGT. Based on a report, the NGT held the company guilty of illegal felling and imposed a fine of Rs 2 lakh. It also ordered that the company should plant 2,500 trees.

Brahmins and Vaishyas are the big vote-bank of BJP in Mewar. After Kataria's appointment, the BJP was searching for a strong face in Mewar. In such a situation BJP has tried to strengthen itself in this belt by giving new responsibility to Joshi.

Udaipur, Rajsamand, Chittorgarh and Banswara districts have a sizable vote bank of Brahmins and Vaishyas. Hence, the party was looking for a right candidate to go with social engineering.

CP Joshi had participated in the Vipra Mahapanchayat held in Jaipur on Sunday. In the Mahapanchayat, he spoke on ways and means of protecting the Sanatan and working in the interest of the society and not criticise the leaders of the society without any reason.

Now by making him the state president, the BJP has tried to give a message to the Brahmin voters. Brahmins have been the biggest core voter of BJP. In such a situation, this appointment is being considered important. In the history of more than 42 years of BJP, the state president in Rajasthan



has ruled the state from this community for over 22 years.

CP Joshi met Prime Minister Narendra Modi and BJP national president JP Nadda as soon as he became the state president.

Meanwhile, all eyebrows are now being raised if the new appointed president will be able to check the factionalism which came out at different places in the party.

Several groups in the party had become the worry for the central leadership in Delhi. While the ruling Congress has been talking of repeating its government, the BJP was finding it difficult to resolve its factions.

Now, the party has tried to lure Brahmin voters who were disappointed due to lack of representation of leaders from their community. Also it has tried to protect the Mewar 'citadel' which has been bringing victory for BJP in assembly as well as Lok Sabha polls.

SHGs HELP TRIBAL WOMEN TASTE FREEDOM FROM PATRIARCHY

Udaipur; March 23: Indira Meena's world turned upside down when her partner deserted her eight years ago. A resident of Paduna in Udaipur's Girwa tehsil, Indira was 17 when she left home for him.

Now 27, she is trying to survive as a single mother with son Anil, who studies in Class 2. "I was not legally married to him," Indira, who works as MGNREGA mate in her village, said. Last year, she formed the Bharti Swah Sahayata Samuh, a self-help group (SHG) with 16 members. "We focus on savings and small businesses," the feisty woman said. There are 22 such SHGs in her village.

Paduna is a part of Udaipur's Zawar mines area, where non-profit Manjari Foundation (under Hindustan Zinc's CSR programme) has helped form 394 SHGs. Their

present total savings stand at Rs 2,71,30,341. They function much like the groups formed under the Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM), helping women open bank accounts in the SHGs' names and gain access to loans.

According to the Ministry of Rural Development, 777 SHGs got revolving funds worth Rs 116.6 lakh in Udaipur's Girwa tehsil. In 2022-23, 380 SHGs availed of loans worth Rs 5.09 crore while 1499 have outstanding loans of Rs 7.97 crore.

The SHG women not only make small contributions weekly, but also take part in social campaigns and help those in distress

When Manjari's lead Rampal Meena visited Zawar in 2016, he recalls he could not even meet the women due to patriarchal restrictions. However, the much-needed change became visible after sus-



tained gender sensitisation programmes. "Our staff started visiting houses and enlisted the support of village heads. Now, women hold four meetings every month," Rampal said.

Towards self-realisation

An Adivasi from the Meena community and a mother of four, Mangli Devi (55) resides in Amarpura, located about 10 km from Paduna. "I was married off at 14. At that time, I did not know that marriage at a tender age is harmful," she said.

The change in attitude was initiated by a few women who arrived from Dhaulpur district to explain SHG's functioning to the village women, whose lives centred around cooking, grazing goats, working in fields and collecting firewood from the forest while on the lookout for leopards. It's a big concern that women here have been more prone to leopard attacks due to the nature of their work which requires them to go into the forest in the early hours looking for firewood. According to data provided by the Udaipur forest division, five women received injuries and three died in leopard attacks in the area in 2020-21. In the same period, five men were injured.

Women have grown confident that they do not keep a veil at all times. Even its length has reduced.

Rameela Meena, who is educated up to Class 8, was often criticised for not bearing a child after being married for five years. She also had to put up with a mother-in-law who scolded her for not keeping a veil.

Women have learnt the art of earning money. A woman in Rameela's group bought a baby goat for Rs 5,000 and sold it later for Rs 14,000. SHG linkage helped Rameela build a new house and buy a car, which her husband drives for tourists in Udaipur. She took Rs 20,000 from the samuh for the house. The second-hand car was bought at Rs 5 lakh on a bank loan. The repayment of only about Rs 1 lakh is

pending at present. "I had nothing when I started out with only Rs 20 as savings amount per week," Rameela said.

Taking a stand

Amarpura's Sharda Swah

Sahayata Samuh was formed April 25, 2017, with 13 members. Though the women started with savings, they gradually took a stand against domestic violence and child marriage. Mangli pointed out that realisation dawned upon women when they attended training sessions. In cases of violence, they try to intervene collectively. "We try to stop men from beating up wives and aim for a resolution. When a Paduna resident was ousted from home by her motherin-law, we called the police.'

The collective might of SHGs came to the fore in Indira's case.

About 25 women intervened, went to the police station and demanded that Indira be paid a monthly allowance for her son. It worked as her estranged partner now pays Rs 3.000 per month, said Amri Devi. Indira's neighbour who had set up-Lakshmi Maata Samuh about six years back.

Meghalaya CM tables Budget

Shillong: Meghalaya Chief Minister Conrad K Sangma Thursday tabled a ₹1,592 crore deficit budget for the 2023-24 fiscal, proposing no new tax, and asserted that efforts will be made to make the state a 'billion-dollar' economy. The chief minister said the estimated GSDP for the FY 2023-2024 is pegged at ₹46,600 crore with an expected growth rate of 11.5 per cent. The fiscal deficit is 3.42 per cent of the state's GSDP - ₹41.779 crore for the current financial year. Presenting the Budget in the Assembly, Sangma said the estimated receipt is about ₹21,781 crore of which revenue is likely to be ₹19,414 crore excluding the borrowings of ₹2,339 crore.

Explosives recovered in Gadchiroli district

Gadchiroli: Explosives and other articles suspected to be hidden by Naxalites were recovered from near a village in Maharashtra's Gadchiroli district, police said Thursday. A special squad conducting an anti-Naxalite operation in Nelgunda village under Bhamragadh taluka found claymore mines, two cooker bombs, steel pipes and three bundles of electric wires, among other articles, at two separate roads, Wednesday, said a press release issued by Gadchiroli Superintendent of Police Neelotpal's office.

LS passes ₹45L-cr Budget

New Delhi, March 23: Lok Sabha Thursday approved the Union Budget envisaging an expenditure of around ₹45 lakh crore for the fiscal year starting April 1 without any discussion, as the Opposition continued to create ruckus over demand for a JPC probe into allegations against the Adani Group.

The Lower House of Parliament took up the Demands for Grants and Appropriation Bills after two adjournments as the ruling and Opposition MPs engaged in a matching duet over demands for an apology by Rahul Gandhi and the Adani issue.

Most of the second leg of the Budget Session has been washed out due to the protest by both sides and it was one of the rare occasions when the Budget was passed without any discussion.

Soon after the Lok Sabha reassembled at 6 pm after two adjournments, Speaker Om Birla put the Opposition's cut motion or amendments to the government spending plan to vote which was rejected by voice vote. This was followed by Finance Minister Nirmala Sitharman moving the demands for grants for 2023-24 and relevant Appropriation Bills for discussion and voting.

Birla applied guillotine and put demands for grants of all ministries for voting. The demands were passed as the Opposition MPs trooped into the Well of the House

shouting slogans. Prime Minister Narendra Modi was present during the passage of Budget for 2023-24.

The entire exercise was over in 12 minutes completing twothird of the parliamentary approval for the Budget for 2023-24.

The current Parliament session is scheduled to end April 6. There is speculation that the duration of the session may be curtailed after completion of the budgetary



Gadkari unveils road projects in Jharkhand

LAND ALLOTMENT FOR LAWYERS' CHAMBERS

Can't assert right on land: SC on SCBA plea

New Delhi, March 23: The Supreme Court Thursday said the Supreme Court Bar Association (SCBA) cannot assert a right to the entirety of the land measuring 1.33 acres which was allotted by the Centre for housing the apex court archives for converting it into a chamber block for lawyers

A bench, headed by Chief Justice of India DY Chandrachud and comprising Justices Sanjay Kishan Kaul and PS Narasimha. said the apex court discharges both judicial and administrative functions and the discharge of its functions implicates diverse stakeholders including lawyers, litigants and the staff engaged in activities of the Supreme Court.

"A holistic view has to be taken on the allocation of available resources by balancing the needs of stakeholders both for the present and the future. These are matters which cannot be resolved by the application of judicial standards and have to be taken up on the administrative side of the Supreme Court, Administrative functioning and decision-making, which the current issue requires, cannot be moved to the judicial side," it said.

The bench said: "We therefore are unable to subscribe to the reliefs which have been sought in the petition under Article 32. However, we leave it open to the Supreme Court of India on its administrative side to take appropriate decisions bearing in mind the needs of the institution for the present and the future and the interest of all stakeholders.

The top court said the SCBA cannot assert a right over entire land admeasuring 1.33 acres situated near the ITO, which has been allotted by the Union government for housing the **Supreme Court Archives, for** converting it into a chamber block for lawyers

The top court was hearing a plea by the SCBA to convert the land, allotted to the top court, for the construction of chambers for lawyers

During the hearing, senior advocate and SCBA President Vikas Singh had submitted that the Additional Registrar of the Supreme Court informed the SCBA that 0.50 acres out of 1.33 acres of land have been earmarked for construction of a lawyers' chamber block, subject to a change of use.

He added that since only 400 to 500 chambers can be constructed on the land which has been earmarked, the entirety should be utilised for the construction of chambers for lawyers who are an integral part of the justice deliv-

'No increase in rate of hospitalisation or death'

New Delhi, March 23: Amid a gradual rise in daily Covid-19 cases, the Union Health Ministry said Thursday that the XBB.1.16 subvariant of Omicron might be the dominant virus strain in the country but there has been no reported increase in the rate of hospitalisation or death so far.

Health Secretary Rajesh Bhushan said 344 samples have tested positive in the last three months -January, February and March—for XBB.1.16 after whole genome sequencing. The subvariant has been found in states such as Maharashtra



(105), Telangana (93), Karnataka (57), Gujarat (54) and Delhi (19). "Omicron and its sub-lineages continue to be the predominant variant. No evidence of an increase in hospitalisation and/or mortality has been reported," Bhushan said.

He said XBB.1.5 and XBB.1.16 are variants of interest and under intense scientific scrutiny but they are not a "cause of immediate concern". India has reported an uptick in daily coronavirus cases over the past week. Maharashtra, Gujarat, Kerala and Karnataka are among the states reporting a rise in the cases, according to the Health Ministry.

On Thursday, the Health Ministry data showed the country recorded 1,300 new coronavirus cases, the highest in 140 days. It showed that the active cases in the country have increased to 7,605. On March 13, India reported 444 new Covid-19 cases while the active cases stood at 3,809. As the virus becomes endemic, it generates a large number of variants and since the emergence of Omicron in 2021, close to 1,000 of its lineages have been assigned, which include approximately 100 recombinant variants, he said.

Man hurls acid on wife inside court complex

Coimbatore, March 23: A man allegedly threw acid on his wife at the district court complex suspecting her of being in an illicit relationship with another person, leaving the woman scarred.

Kavitha had reached the court premises to appear in a theft case, police said. She was arrested in August 2016 for stealing 10 sovereigns of gold chain from a bus passenger and the case was going on in the First Judicial Magistrate Court. She was out on bail.

Writhing in pain, Kavitha sustained serious burn injuries below the neck and ran for safety even as a woman lawyer standing nearby covered her upper body with a cloth. She was rushed to the government hospital where doctors stated she had already suffered 80 per cent burn injuries, police said.

Webb captures swirling sand clouds on distant planet

New Delhi, March 23: Scientists have observed swirling motions of clouds of sand in the atmosphere of a distant planet, having a 22hour day and orbiting two stars over a 10,000-year period.

The researchers used the stateof-the-art telescope to study the motions of the clouds which were bringing hotter material up and pushing colder material down on the planetary mass companion VHS 1256 b, about 40 light-years away from Earth.

Identifying for the first time the largest ever number of molecules at once on a planet outside our solar system, the team also discovered clear detections of water. methane and carbon monoxide with Webb's data, and found evidence of carbon dioxide. The study is published in The Astrophysical Journal Letters

This result speaks to the incredible combination of capabilities that is offered by JWST, and a huge amount of credit goes to the hundreds of engineers, technicians, and scientists that have worked over the last 20 years to make JWST a reality," said Sasha Hinkley, professor at the University of Exeter.

Owing to the planet's low gravity, its clouds of sand, or silicate clouds, appear and remain higher in its atmosphere, making it easier for the telescope to detect them. The planet is also considered to be a "young planet" at only 150 million years old, by the study.



This is another reason that its skies are turbulent, the study said.

"We've identified silicates, but better understanding which grain sizes and shapes match specific

types of clouds is going to take a lot of additional work. This is not the final word on this planet - it is the beginning of a large-scale modeling effort to fit Webb's complex data,

said lead author Brittany Miles of the University of Arizona, US.





Palestinian killed

Jerusalem: Israeli security forces killed a Palestinian militant during a raid in the northern West Bank Thursday, Palestinian health officials said, the latest escalation of violence in what has been the deadliest start of a year for Palestinians in the occupied territory in more than two decades. Israeli forces stormed into the northern city of Tulkarem, home to an emerging militant group with ties to the armed offshoot of the nationalist Fatah party. The Palestinian Health Ministry said that 25-year-old Amir Abu Khadija was shot multiple times in the head and legs.

Sri Lanka imports eggs from India

Colombo: Sri Lanka has imported two million eggs from India to ensure food security in the crisis-hit island nation, Trade Minister Nalin Fernando said Thursday. Fernando told Parliament that the shipment imported by the State Trading General Corporation had arrived and the stocks would be released in the market within three days. The decision to import eggs was based on a decision by a cabinet committee to ensure food security, Fernando said.

Eight more **Marburg cases**

Nairobi: Equatorial Guinea has confirmed another eight cases of the "highly virulent" Marburg virus, a deadly hemorrhagic fever with no authorised vaccine or treatment. The World Health Organization on Thursday said that brings the country's total number of cases to nine in the outbreak declared in mid-February. There are two known current outbreaks of Marburg on the African continent. Tanzania this week announced eight cases of Marburg, including five deaths.

SUNAK RELEASES TAX RETURNS

London, March 23: Prime Minister Rishi Sunak has released his tax returns, revealing that the British-Indian leader paid more than GBP 1 million to the Exchequer since becoming a frontline politician in 2019.

The tax release is part of a transparency commitment the UK premier made in November last year. Sunak, among the wealthiest British politicians, on Wednesday, revealed that he earned a total of GBP 4.766 million between 2019 and 2022 and paid GBP 1.053 million in tax - at a tax rate of around 22 per cent.

Over the last tax year, when he was the finance minister, the 42-yearold leader paid GBP 325,826 in capital gains tax and GBP 120,604 in UK income tax on a total income of GBP 1.9 million. "I published my tax returns in the interests of transparency, as I said I would, and I am glad to have done that," Sunak said during a visit to north Wales on Wednesday.

"I think ultimately what people are interested in is what I am going to do for them," he added. Sunak



worked in finance before entering politics and he and his family are thought to own several properties. including a Grade II-listed manor house in his North Yorkshire con-

stituency, the BBC reported. Sunak came under pressure to publish his tax returns after his financial affairs came under the spotlight during the Conservative Party leadership election campaign last year, which he lost to Liz Truss before being elevated as Prime Minister after Truss' short-lived tenure at 10 Downing Street.

Chinese diplomats oppose US military presence in Philippines

Manila, March 23: Chinese diplomats expressed their strong opposition to an expanded United States military presence in the Philippines in closed-door talks with their Filipino counterparts on Thursday in Manila, a Filipino official said, underscoring the intense US-China rivalry in the region.

The Philippine official, who attended the meeting, told The Associated Press about China's intense objections on condition of anonymity for lack of authority to discuss what transpired at the

start of the two-day talks.

The Filipino diplomats responded by saying the decision to allow an expanded American military presence was in their national interest and would boost Philippine capability to respond to natural disasters, the official said, suggesting it was not aimed at China.

Chinese Vice Foreign Minister Sun Weidong and Philippine Foreign Undersecretary Theresa Lazaro led the talks aimed at assessing overall relations between the two sides amid thorny issues, including Beijing's alarm over a Philippine decision to allow the US military to expand its presence to a northern region facing the Taiwan Strait and escalating spats in the South China Sea.

The discussions on Friday will focus on the long-seething territorial spats in the disputed waterway, according to the Department of Foreign Affairs in Manila. The back-to-back meetings are the first under President Ferdinand Marcos Jr., who took office in June. He met Chinese President Xi Jinping in a state visit to Beijing in January, where both agreed to expand ties pursue talks on potential joint oil and gas explorations and manage territorial disputes amicably.

In early February, the Marcos administration announced it would allow rotating batches of American forces to indefinitely station in four more Philippine military camps. Those are in addition to five local bases earlier designated under a 2014 defence pact between the longtime treaty allies. Marcos said on Wednesday the four new military sites would include areas in the northern Philippines

Protesters, police clash across France

Paris, March 23: Protesters angry with President Emmanuel Macron and his plan to raise the pension age blocked access to an airport terminal, sat on train tracks, clashed with police and threw projectiles at a police station in a day of demonstrations across France.

Police fired tear gas at protesters in the western city of Nantes. In Rennes, they used water cannon, BFM TV footage showed. Also in the west in Lorient, Ouest-France newspaper said projectiles triggered a brief fire in the yard of a police station.

Roissy-Charles De Gaulle airport outside Paris was hit by wildcat action by workers. Near Toulouse in the southwest, burning piles of debris blocked traffic on a highway and sent plumes of smoke into the sky.

"There is a lot of anger, an explosive situation," the leader of the hardline CGT union, Philippe Martinez, said at the start of a rally in Paris. Union leaders called for calm but were angry with what they called Macron's "provocative" comments.

Macron broke weeks of silence on the new policy to say he would stand firm and the law would come into force by the end of the year. He compared the protests to the January 6, 2021, storming of the U.S. Capitol. Opinion polls have long shown that a majority of voters were opposed to delaying retirement age by two years to 64.

Voters were further angered by the government's decision last

week to push the pension changes through parliament without a vote and by Macron's comments on Wednesday. "I'm on strike to protest against the pensions reform, but also against what is happening in the government," 27-year-old Air France programming officer Lucile

Bidet said at a rally in Nantes. "They're not listening to the people anymore." "He's the one setting the country on fire," the CGT's Celine Verzeletti told France Inter radio station. Electricity output was also cut Thursday as unions raised pressure on the government to withdraw the law. Flight services will continue to be reduced at the weekend, the civil aviation authority said.

Protests also targeted oil depots and blocked an LNG terminal in the northern city of Dunkirk. Protests against the new law, which also accelerates a planned increase in the number of years one must work to draw a full pension, have drawn huge crowds in rallies organised by unions since January.

Most have been peaceful but anger has mounted since the government bypassed a vote in the lower house of parliament, where it does not have an absolute majority and was not sure to get enough support. Since then, the past seven nights have seen demonstrations in Paris and other cities with rubbish bins set ablaze and clashes with police.

The latest wave of protests rep resents the most serious challenge to the president's authority since the "Yellow Vest" revolt four years ago.



PROTESTS CONTINUE Israel okays law protecting Netanyahu

Tel Aviv. March 23: Israel's parliament Thursday passed the first of several laws that make up its contentious judicial overhaul as protesters opposing the changes staged another day of demonstrations aimed at raising alarm over what they see as the country's descent toward autocracy.

Thousands of people protested throughout the country, blocking traffic on main highways and scuffling with police in unrest that shows no sign of abating, especially as the overhaul moves ahead. Prime Minister Benjamin Netanyahu's coalition approved legislation that would protect the Israeli leader from being deemed unfit to rule because of his cor-

ruption trial and claims of a conflict of interest surrounding his involvement in the legal changes.

Critics say the law is tailor-made for Netanyahu, encourages corruption and deepens a gaping chasm between Israelis over the judicial overhaul. The legal changes have split the nation between those who see the new policies as stripping Israel of its democratic ideals and those who think the country has

been overrun by a liberal judiciary. The government's plan has plunged the nearly 75-year-old nation into one of its worst domestic

crises. "Either Israel will be a Jewish, democratic and progressive state or religious, totalitarian, failing, isolated and closed off. That's where they are leading us," Tzipi Livni, a former foreign minister and a prominent supporter of the protest movement, told Israeli Army Radio.

The opposition is rooted in broad swaths of society — including business leaders and top legal officials. Even the country's military, seen as a beacon of stability by Israel's Jewish majority, is enmeshed in the political conflict, as some reservists are refusing to show up for duty over the changes. Israel's international allies have also expressed concern.

Ramadan begins in Mideast amid high costs, hopes for peace

Khartoum (Sudan), March 23: The first daily fast of the Islamic holy month of Ramadan began Thursday, as hundreds of millions of Muslims worldwide enter a fourweek period of worship.

The observance comes at a time when numerous countries and governments across the Middle East are taking tentative steps towards calming enduring conflicts and crises made more acute by the costly war in Ukraine and a devastating earthquake in Turkey and Syria that killed over 52,000 people.

During the coming four weeks, hundreds of millions of Muslims will abstain from food and water from dawn to dusk, before gathering with family and friends for indulgent nighttime meals. According to Islam, fasting draws the faithful closer to God and reminds them of the suffering of the poor.

In Sudan's capital, families prepare and sell culinary delights weeks in advance to mark the break of the fast each evening, a meal known as Iftar. The food and drink of choice for nighttime feasts across households in the Islamic African nation include assida, a semolinabased flour dish, and a sugary fermented drink called, "sweet bitter." Both are recipes that date back generations.

"Those who can't afford don't have to pay," said Fatima Mohammed Hamid, who sells the food items from her small home on Tuti island, just north of the Sudanese capital of Khartoum. In



addition to fasting, charity giving is another of Islam's five pillars. During Ramadan, mosques and charities regularly provide meals for the poor at long tables that



Overnight leader Tvesa Malik (77) ran into rough weather in the final round and was fourth, while amateur Vidhatri Urs (76) and Asmitha Sathish (73) were tied for fifth.

Sneha Singh, who had a disappointing week in tied 21st place, continues to lead the Hero Order of Merit. Vani, who won Rs 2,84,000 from the season's highest purse of Rs 23 lakh, moved into third place, while Seher Atwal is second.
