

#### **5k lightning strikes** in Bhadrak; 5 dead

Bhadrak: Five persons were killed Wednesday in separate incidents of lightning strike in Basudevpur locality of Bhadrak district. The Basudevpur locality was hit by 5,000 lightning strikes in just 30 minutes, informed Umasankar Das of the IMD regional centre in Bhubaneswar. "More than 5,000 lightning strikes today just in 30 minutes near Basudevpur of Bhadrak. It is beyond one's imagination the vulnerability associated with the thundercloud and how fatal it could be!!!," Das said in a Twitter post. "As per local information, five people died because of this severe lightning," he said in another tweet.

New Delhi, March 29: National Payments Corporation of India (NPCI) said Wednesday that there is no charge for bank account to bank account-based UPI payments or normal UPI payments. However, interchange charges are only applicable for prepaid payment instruments (PPI) merchant transactions and there is no charge to customers, NPCI clarified in a statement. Earlier there was confusion that customers will be charged for all UPI transactions.

NPCI has permitted the PPI wallets to be part of interoperable UPI ecosystem and levied 1.1 per cent charge on unified payment interface (UPI) transactions above ₹2,000 while using PPI

"The interchange charges introduced are only applicable for the PPI merchant transactions and there is no charge to customers, and it is further clarified that there are no charges for the bank account to bank account-based UPI payments,' the NPCI said.

With this addition to UPI, the customers will have the choice of using any bank account, RuPay Credit card and prepaid wallets on UPI-enabled apps, it added.

In recent times, UPI has emerged as the preferred mode of digital payment by offering free, fast, secure and seamless experience. Traditionally, the NPCI said, the most preferred method of UPI transactions is linking the bank account in any UPI-enabled app for making payments which contribute over 99.9 per cent of total UPI transactions. The interchange fee varies for the

different categories of merchants. It ranges from 0.5% to 1.1%. For telecom, education, and utilities/post office, the interchange fee is 0.7% while for supermarkets the fee is 0.9% of the transaction value.

When contacted, Sahid Nagar police station IIC Manoj Satapthy said that Praina in her note has said that she took the extreme step due to pressure in studies and her inability to do well in the exams.

State to get 1K solar cold rooms this yr

## India saw 7 lakh malware attacks in 2022: Report

The report reveals a 16% rise in malware attacks, underscoring the need for ongoing vigilance and collaboration to safeguard critical industries

ndia experienced approximately 7 lakh malware at-Ltacks in 2022, up from 6.5 lakh in 2021, with the banking sector being the most vulnerable to these attacks, totalling 44,949 incidents, a report revealed Wednesday

The top six sectors affected by malware in India in 2022 were banking, government, manufacturing, technology, healthcare, and finance.

However, there was a slight decline in the number of malware detections across the six critical sectors, indicating that appropriate measures are being taken, according to the report by global cyber-security firm Trend Micro.

In 2022, there were a total of

1,49,83,271 ransomware threats globally. with 38.06 per cent of the attacks targeting Asia, and 10.51 per cent of those attacks being detected in India.

"The report reveals a 16 per cent increase in malware attacks, underscoring the need for ongoing vigilance and collaboration to safeguard critical industries

such as banking, government, and manufacturing in India," said Vijendra Katiyar, country manager for India & SAARC, Trend Micro.

In 2021, the top three sectors affected by ransomware were banking, government, and manufacturing, but the trend shifted in 2022 when the Indian government sector became the most affected, followed by manufactur-

Globally, cyber-threat detections hit a record 146 billion in 2022

The report mentioned a massive 55 per cent increase in overall threat detections in 2022 and a 242 per cent surge in blocked malicious files, as threat actors indiscriminately targeted consumers and organisations across all sectors.

There was an 86 per cent increase in backdoor malware detections. These backdoors primarily targeted web server platform vulnerabilities.

"A surge in backdoor detections is particularly concerning in showing us their success in making landfall inside networks." said Jon Clay, VP of threat intelligence at Trend Micro.

# Unclean fuel, fast food behind heart diseases in India

A MAJORITY OF THE POPULATION OF INDIA RESIDES IN RURAL AREAS AND USES UNCLEAN FUELS FOR COOKING AND OTHER PURPOSES, EXPOSING THEM TO HARMFUL SMOKE EMITTED FROM BURNING THEM

Jose of unclean fuel causing indoor air pollution and sedentary lifestyle, with the increased adoption of fast-food culture, are some of the reasons behind rising heart diseases in India, according to a study released by the Indian Institute of Technology (IIT) Mandi Wednesday. Cardiovascular diseases (CVDs)

are a leading cause of mortality worldwide, claiming lives of around 17.9 million people annually.

Data from the ICMR and Registrar General of India shows that India accounts for approximately 60 per cent of the world's heart disease burden.

To identify the most significant risk factors for CVDs in the country, the researchers analysed data from more than 59,000 individuals aged 45 and above in both rural and urban India.

Their findings, published in the Current Problems in Cardiology journal, suggest that older adults in India are prone to physiological risk followed by genetic, indoor environmental, and behavioural risk factors.

"There are several traditional risk factors for CVDs, including high systolic blood pressure, low HDL cholesterol, obesity, unhealthy food, poor nutritional status, age, family history, physical inactivity, smoking, and alcohol consumption," said Ramna Thakur, IIT

Mandi, in a statement. "Additionally, exposure to air pollutants is another significant risk factor. We aimed to cluster these risk factors into different groups and identify the exclusive individual effect of each group on CVD prevalence among adults aged 45 and above in India," she added.



The study found that environmental exposure is a significant risk factor for the occurrence and progression of CVDs in older adults in India.

A majority of the population of India resides in rural areas and uses unclean fuels for cooking and other purposes, exposing them to harmful smoke emitted from burning them. The study also identified behavioural risk factors such as physical inactivity leading to CVDs. The study showed that the effect of physiological factors, which include diabetes, high cholesterol, depression, and being overweight or obese, is particularly serious. The sedentary lifestyle of people, the adoption of fast-food culture, and urbanisation are some of the reasons for the prevalence of these physiological factors.

To reduce indoor air pollution and safeguard public health, the study recommends promoting the use of cleaner technology such as liquified petroleum gas, solar, electricity, and biogas.

Engaging in light to moderate physical activity in middle or older age has a considerable positive impact on the reduction of the risk of cardiovascular disease and overall mortality.

Risk awareness programmes associated with alcohol and tobacco use could also be an effective method to curb their use and reduce the probability of getting diagnosed with CVDs, the researchers said.

# **Decline in water level of** Luna river sparks concern

Drinking water supply to Kendrapara town and irrigation at farmlands may get seriously hit

Kendrapara, March 29: With the water level in Luna river declining day by day, a serious drinking water scarcity stares at the face of Kendrapara residents.

The decline in water level will not only trigger a drinking water shortage in the town but is also likely to leave the farmlands uncultivated due to lack of water for irrigation.

Reports said that water level of Luna river flowing through the Kendrapara district has been declining since December, 2022. Environmentalists said the development was due to rampant and illegal mining of sand from the riverbed.

They alleged that water level has been declining due to illegal sand mining which is likely to change the course of the river. The development has sparked concern in the area. Local intelligentsia said that the problem can be resolved by linking all the seven rivers flowing through the district.

Khitish Kumar Singh of Khadianga area in the town said that drinking water is supplied to the residents in Kendrapara town through a pump house established at Kalapada near the Luna river bank. However, the portion of the river near the pump house has already

Alarmed over the development, the PHD and Irrigation department officials dug up a channel of 150 metre length from the opposite side of the river till the pump house for lifting of the river water.

dried up from January, this year.

The river water after being lifted by the motor pump is processed and supplied as drinking water to the residents of Kendrapara town. However, the channel is also drying up slowly creating concerns that a drinking water scarcity is looming over the resi-

dents of Kendrapara town. If the

situation does not improve then water supply to Kendrapara town might get seriously affected within the next 15 days. A local intelligentsia Santosh Kumar Panda said that check dams have been constructed on Luna river at Padagayaspur, Gayaspur, Thauri, Chadheiguan, Rajgarh and Angulai in the district for supply of drinking water to the residents and for providing irrigation facil-

ities to the farmlands. However, the water level of the river declining even before the start of the summer season is quite alarming. The fall in the river's water level may deprive the farmlands of irrigation facilities for which around 10,000 hectare of farmlands risk remaining uncultivated.

Former Zilla Parishad member Ganesh Chandra Samal said that the 73-km-long Luna river which flows through Kendrapara district was the hub of marine trade during the British rule. However, lack of renovation, illegal sand and soil mining and encroachments have spelt disaster for the river. As a result, the river is now changing its course.

The residents of Kendrapara district are dependent on agriculture for their livelihood. In the absence of any other viable irrigation facility, the farmers here depend on river water to irrigate their farmlands. However, they lack drainage facilities to discharge the leftover water from over 15,850 hectare of farmland. Moreover, 32,350 hectare of farmland in the district is saline while 34,952 hectare is flood affected. This apart, over 84,910 hectare of farmland in the district is prone to droughts. There have been consistent demands in the Zilla Parishad meetings to devise a plan for proper management of the rivers and canals flowing through the district. However, these pleas are vet to be addressed.

Social activist Pratap Kumar Tripathy said that earlier Luna river water used to help in cultivation of paddy during kharif season and cash crops like jute, groundnuts and sugarcane during the rabi season. However, farming has been seriously hit in the district due to sharp decline in the water level of Luna river. Moreover, construction of dams by the Chhattisgarh government on the upstream of Mahanadi has also

contributed to the situation. Farmer leader Bidhu Bhsuahn Mohapatra said that linking of all seven rivers in the district only can help resolve the situation.

When contacted, executive engineer Umesh Chandra Sethi said that various schemes have been launched for development of the Luna river and the residents will soon reap its benefits.

Jharsuguda, March 29: Two persons have been arrested for their alleged involvement in the abduction and murder of a 15-year-old boy, police said here Wednesday. The deceased, identified as Samarth Agrawal, son of Sunit Agrawal of Sarbahal locality of this district, was recovered from Bheden area of Bargarh district. Among the two arrested is the mastermind of the crime, police said.

The kid was abducted March 27 following which a ransom call of ₹50 lakh was made to the parents of the victim. "We have apprehended two persons on the intervening night of March 28 and 29. The accused persons have been identified as Amit Kumar Sharma and Dinesh Agarwal," informed Jharsuguda SP Parmar Smit Parshottamdas at a press conference here.

The SP said that the police had received a report March 27 that a 15-yearold boy had gone missing at around 3.30pm. "The missing boy's father received a call at around 8.30pm on the same day and the caller had demanded a ransom of ₹50 lakh for releasing the child," the SP added.

Parmar Smit stated one of the ac cused, Sharma, was well-acquainted with the family of the boy. As a result, the boy had gone with them willingly. When the boy's father did not respond to the ransom call, the two accused decided to kill him. The boy was murdered in the late hours of March 28, Parmar Smit stated.

# **Crisis & Bailout**

The shotgun wedding of UBS and Credit Suisse was hastily arranged in the spirit of ensuring our collective safety. As Swiss National Bank Chair Thomas Jordan noted, Credit Suisse's size and global network makes it "a global systemically important bank," and having UBS take it over - thereby forestalling a bankruptcy - "ensures that the systemically important function remains secure." Might we dare to hope that a similar sense of urgency and ambitious deployment of resources be brought to bear on the compounding crises confronting more than half of the world's low-income countries? The government-brokered UBS-Credit Suisse merger was uncharacteristic for the Swiss, and not only because it was concluded on a Sunday, normally Switzerland's enforced day of rest. The government invoked emergency laws to override shareholders' right to vote on mergers, and wrote down all of Credit Suisse's additional tier-one (AT1) bonds - some \$17 billion worth – running the risk of years of litigation.

Some fear that these actions will tarnish Switzerland's reputation with investors. Maybe they will. But if the merger succeeds in stabilising the financial system, it will be more than worthwhile for us all. The reality is that this outcome is not guaranteed, but not because of any flaw in the authorities' decision-making or, indeed, any factor that the authorities can control. The bot-

tom line is that complex systems are unpredictable, and even well-crafted inter-

ventions can fall short. Such uncertainties did not deter the Swiss government from showing extraordinary lead ership at a moment when it was needed. And comparable uncertainties did not stop major economies' from mobilising more than \$15 trillion in short-term stimulus funding to protect themselves from systemic risks during the pandemic. The same goes for protecting the economy from longer-term shortfalls. For example, the European Union deployed nearly \$900 billion for post-pandemic economic development, and the United States and China mobilised trillions of dollars for investment in infrastructure and green technologies. Such interventions may not guarantee a secure fu ture, but they are crucial nonetheless.

Similarly bold leadership is now needed to tackle the challenges facing increasingly vulnerable low-income countries, notably those facing the multifaceted crisis in sovereign debt, high and rising poverty, food insecurity, and social and political instability - all of which are being exacerbated by the Ukraine war-together with the mounting effects of climate change. But, so far, such leadership is nowhere to be found.

Instead, rich-country governments have offered an agonisingly slow, fragmented, and unambitious response to these mutually reinforcing crises, with other G20 countries that could make a difference - including China,

India, Russia, and Saudi Arabia - also slow to act. Advanced-economy leaders offer well-rehearsed justifications for their inaction, pointing out, for starters, that they have their own problems, not least high inflation and tightening fiscal constraints, which are fueling popular frustration and political turmoil.

The same leaders voice concerns about "moral hazard." They argue that the governments of countries in need have themselves to blame for their current mess. These governments have taken on too much debt, according to this view, and have failed to serve their populations properly, which suggests that they are likely to squander whatever relief they receive.

But it is the third reason for slow, incremental action in addressing the challenges facing low-income countries that is the most absurd. Behind closed doors, rich-country governments have in effect concluded that the debt distress faced by more than 60 per cent of these countries (and more than 25 per cent of emerging economies) does not pose a systemic threat. So, while they are willing to act quickly in bailing out domestic banks-even midsize institutions - they have concluded that offering significant debt relief to dozens of debtdistressed countries with hundreds of millions of vulnerable citizens is not

**SUMMER THOUGHTS** 

he hot summer days are unceremoniously back! With the daytime temperatures inching to 400C so early in the season, the current season promises to be painfully hot. Scientists are attributing this unusual situation to a relatively recently known phenomenon called global warming which is emerging as perhaps the greatest environmental challenge of the twentyfirst century. According to IPCC, our planet has warmed by 0.6 degree C over the last century and it is projected that the Earth's mean temperature is likely to rise 2.4 to 4.8 degree C by the year 2100. This will seriously upset the delicate ecological balance of the planet and the basic life support system of our biosphere. The consequences are catastrophic some of which are already becoming visible: melting of glaciers and rising of sea level, climate change and its manifold impacts like change in precipitation patterns, untimely monsoon onsets, increase in extreme weather conditions like floods. droughts, heat waves, hurricanes and long term effects like lowering of agricultural yields, species extinction, increase of vectorborne diseases, and social conflicts over issues like water. The fact that 11 of the warmest years of the past 125 years occurred only after 1990 with 2005 being the warmest on record tells amply the extent of nature's fury

This has gravely affected the lives and livelihoods of people around the world. A man in the Maldives worries about relocating his family due to sea level rise, a farmer in Kansas struggles for bread as prolonged periods of drought ravaged his crops, a fisherman on the Niger river wonders why his fishing net has gone empty, a child in New Jersey worries how she lost her home to a super-storm and a woman in Bangladesh struggled to get fresh water due to more frequent flooding and cyclones: these are a few of the enormously many victims of global warming.

Intense heat waves in 2003 took a toll of around 35,000 people in Europe including 15,000 lives in France alone, About 700 million people in India depending directly on climate-sensitive sectors such as agriculture, forests and fisheries for livelihood will directly face the brunt of climate change induced by global warming. Even animals are not spared the wrath of nature. The polar bear in the melting ice sheets of the Arctic, the Royal Bengal tiger in India's fragile mangrove forests of the Sundarbans, the right whale in the plankton-poor waters of the warming North Atlantic, and the orangutan in Indonesian forests segmented by frequent bushfires and droughts are some of the survivors of this telltale story

Global warming has proved to be harsh on Odisha. Atmospheric temperature is consistently surging with summer seasons turning out to be painfully unbearable. Low pressure weather conditions and depressions are becoming regular incidents causing unpredictable rainfall patterns across the state much to the woes of farmers. Who can forget the scorching hot summer days of 1998 when hundreds of people died of sunstroke and the devastating Super Cyclone of 1999 that claimed thousands of lives in

coastal Odisha. The sea has also posed a serious threat to the state. The Bay of Bengal is expanding towards the coastal landscape at an alarming rate taking many vil-

lages and farmlands into its grip. Scientists have reached a consensus that the emission of certain greenhouse gasses (like carbon dioxide, methane, nitrous oxide) is responsible for this unusual warming of our planet. These gases have never been a threat to mankind since the long history of our planet as they used to trap some of the Sun's radiant heat and help maintain minimum temperature on Earth (18 degree C) necessary for survival of life. Without these gasses, the Earth would have been incredibly colder with its mean temperature dropping to -26 degree C where no life could exist! However, these gases are constantly accumulating in our atmosphere far beyond the safety limit since the Industrial Revolution of the eighteenth century. These are mostly produced by the burning of fossil fuels like coal and petroleum which were initially used as raw materials for giant hungry machines of various industries and later for generation of electricity and other forms of energy and as fuels for automobiles. While the increase of carbon dioxide in our atmosphere

is 11%, methane accounts for a whopping 149% since the Industrial Revolution.

While greenhouse gas emissions account for three-fourths of global warming, deforestation also is responsible to a great extent. Forests used to absorb large quantities of carbon dioxide from the atmosphere and keep its level in control. As forests are cleared every day to give way for concrete jungles, car bon dioxide absorption on the planet is seriously affected leading to its uncontrolled build-up in the biosphere. Some global warming also results from melting of Arctic sea ice which has been a key fac tor in stabilising the global climate. Melting of sea ice (ice is a good reflector of radiant heat) reduces the amount of solar energy reflected back into space thereby contributing to global warming.

Keeping these grave conse quences in mind, world leaders have met at several forums in the past to find a solution to the menace greenhouse gasses with the Rio Summit in 1992 serving as the launching pad. The Paris Agreement signed in 2015 by 196 parties at the COP21 was a landmark event as it. for the first time put a legally binding international obligation on nations to combat climate change by limiting global warming to well below 2 degree C and pursuing efforts to limit it to 1.5 degree C. The Glasgow Climate Pact that followed during the COP26 ended in a less stringent greenhouse gas emission cuts from coal power owing to objections from countries like India and China.

Given turbulence in global po litical scenario, there is hardly any sight seen for a lasting solution in near future. Our mantra should be to "think globally and act locally." We should cut down our energy consumption at individual levels and use appliances that are more energy efficient.

Early this March, the UN-sponsored Conference on Marine **Biodiversity of Areas Beyond** National Jurisdiction (BBNJ) successfully concluded a treaty, named informally as the high seas biodiversity treaty or high seas treaty. When world leaders are sceptical about 'global governance' the high seas treaty upholds multilateralism. The BBNJ Treaty is a major step forward in contributing to governance of the global commons. After the historic UN Convention on the Law of the Sea (UNCLOS) adoption in 1982, the entire ocean world is not under legal regulations, especially oceans beyond national jurisdictions that consist of exclusive economic zones (EEZs) and continental shelves. High seas or open seas are neither regulated nor protected. Out of 362 million sq.km of ocean area or 72% of Earth's surface, approximately 200 sq.km or more than 60% are high seas. Despite being extremely biodiverse, only 1.44 % of high seas are currently regulated or protected. As of

Major achievements for the Global South especially small island countries from the BBNJ Treaty are access to and use of marine genetic resources; conduct of EIAs in areas beyond national jurisdiction and capacity-building and transfer of marine technology. A compromise deal on financial commitment by developed countries for capacity building projects aimed at marine conservation was key to the treaty's success. The treaty would aim for protecting 30% of the ocean by 2030 as famously campaigned worldwide as "30 by 30" The treaty is crucial for addressing the triple planetary crisis of climate change, biodiversity loss and pollution. The treaty needs to be ratified, adopted, accepted or accessioned by 60 member countries to become enforceable. Let's hope the last 'global commons' won't become a 'tragedy of commons' during the implementation of the agreement.

worth the cost. It is entirely possible that many actors do not fully understand the systemic implications of simmering crises - particularly debt distress in low-income countries. The crises are happening "over there" - in places whose physical remoteness and apparent economic and financial unimportance makes them seem irrelevant.

'Over there-ism" will be our downfall. If short-term political and business interests trump longer-term imperatives like preventing continuous waves of debt crises, it will become harder to act collectively to mitigate climate change, ensure food security and political stability, and devise meaningful approaches for dealing with the rising number of refugees. Of course, poorer populations are already feeling the effects of these problems. But for those who could make a difference, they remain far away.

Rich-country governments might not recognise - or want to acknowledge - the systemic implications of the risks gathering at the nexus of sovereign debt, climate change, poverty, and political instability. #### Ground zero

t was used first about the dropping of the atomic bombs on Japan at the end of World War II; at least, its first appearance — about a year after the events - is in this connection: There is reason to believe that, if the effects of blast and fire had been entirely absent from the bombing, the number of deaths among people within a radius of one-half mile from ground zero (the point on the ground directly under the bomb's explosion in the air) would have been almost as great as the actual figures (Syracuse Herald Journal, 1 July 1946). More recently, the term has taken on various other associations: it became a jargon term for the focus of any momentous or damaging event. such as the epicentre of an earthquake or the place at which a tornado touches down. "It just so happened we raised the exact amount of money to meet the purchase price," O'Toole says. "Now we're back to ground zero, and we have to start over again" (Pittsburgh Tribune-Review, 14 Dec. 2008). The devastating effects of the attacks on the twin towers of the World Trade Center on 11 September 2001 reminded people of the aftermath of a nuclear attack. The term was applied to the site within hours, to the extent that it looked for a while as though it would displace the older meanings entirely.



**NOW, WITH THE HIGH SEA TREATY, THE OCEANS WILL BE GOVERNED** UNDER INTERNATIONAL LEGAL REGIMES

MPA is essentially a space in ocean where human activities are more strictly regulated than the surrounding waters. Now, with the high sea treaty the oceans will be governed under international legal regimes.

We are all aware that the high seas provide numerous ecosystem services that benefit humankind More than 3 billion people depend on marine and coastal resources for their lives and livelihoods. The ocean absorbs 30% of carbon dioxide produced by humans, as the largest carbon sink, safeguarding the impact of climate change. Around 270,000 species have been identified in the high seas so far, millions more are there in the abyss vet to be discovered.

Despite the market value of the coastal and marine resources and industries being \$3 trillion per year, i.e., 5% of global GDP, the ocean is always in constant threat from anthropogenic activities. It is conservatively estimated that each year humans dump nearly 8 million tonne of plastic waste and discharge 80% of wastewater untreated which are detrimental to marine life and dependent communities. Marine living resources are critical but threatened by illegal, unreported and unreg-

left untouched as free for all. However, after the 40th anniversary of adoption of UNCLOS, the success of the BBNJ reaffirms the importance and relevance of multilateral cooperation in establishing a rules-based ocean regime. From the outset, countries agreed that there can be no exploitation without regulations that ensure high environmental standards.

Initially, India and China were cautiously engaged in the negotiation process of BBNJ. During the informal working group discussions, the positioning of the lead parties was an indication of the uphill task for a consensus agreement. While India batted for rights associated with high seas, freedoms must not be limited by MPAs and other areabased conservation measures. With

#### Arbitrary move

Sir, The 1.1% surcharge proposed by NPCI on UPI transactions from April 1 is arbitrary and clearly against the financial interests of the public. The real-time transaction facility offered by UPI gateways promotes cashless payments. ### SC refuses to entertain pleas for gender-neutral laws *The bench was hearing* petitions seeking a

New Delhi, March 29: In a significant development, the Supreme Court Wednesday thwarted an attempt to get a direction to the Centre to frame uniform religion and gender-neutral laws governing subjects such as marriage, divorce, inheritance and alimony by refusing to entertain a batch of petitions, saying it cannot direct

Parliament to legislate. A bench comprising Chief Justice DY Chandrachud and Justices PS Narasimha and JB

Pardiwala took note of the submissions made by Solicitor General Tushar Mehta that the issue falls under the domain of the legislature and hence, the pleas cannot be entertained

Disposing of a total of 16 petitions, including those filed by Bharatiya Janata Party (BJP) leader Shazia Ilmi and lawyer Ashwini Upadhyay, the top court said, "After taking a considered view of the pleadings and submissions, we are not inclined to entertain the petitions under Article 32. The grant of relief in these proceedings necessitates a direction for enactment of laws -- gender-neutral and religion-neutral legislation as the



petitioner has described it." "This lies exclusively within the domain of the legislature. It is an established position that a mandamus cannot be issued to the legislature to enact laws," it said. The bench also refused to direct

the Law Commission to prepare a report on such laws as sought in

the petitions. "As far as a direction to the Law Commission to prepare a report is concerned, we see no reason to entertain the request. Ultimately, the issue of making a law will fall under the legislative domain.... The petitions are disposed of," it ordered. The bench, however, allowed

Upadhayay, the lead petitioner, to take the recourse available to him to seek the framing of such laws. It, however, kept a petition moved by a Muslim woman, having individual grievances, alive.

The bench was hearing petitions seeking a direction to the government for enacting uniform religion and gender-neutral laws on a wide variety of issues.

Upadhyay had filed five separate petitions seeking directions to the Centre to frame such laws on divorce, adoption, guardianship, succession, inheritance, maintenance, marriageable age and alimony. Earlier, the top court had asked whether it could hear a range of pleas, including PILs, seeking a direction to the Centre to frame uniform religion and gender-neutral laws governing issues such as marriage, divorce, inheritance and alimony.

Upadhyay, in August 2020 filed a public interest litigation (PIL) matter seeking "uniform grounds for divorce" for all citizens, in keeping with the spirit of the Constitution and international conventions.

He filed another PIL through advocate Ashwani Kumar Dubey seeking uniform "gender and religion-neutral" grounds for maintenance and alimony for all citizens In another PIL, he sought the removal of anomalies in the laws governing adoption and guardianship and to make them uniform for all citizens.

He also filed a petition seeking the removal of anomalies in the succession and inheritance laws and making them uniform for all.

# As UP state bird sarus crane numbers go up, experts red flag safety issues

#### INDO-ASIAN NEWS SERVICE

Lucknow, March 29: The debate on sarus crane - the state bird of Uttar Pradesh - has intensified in the state, with the ruling BJP and the Opposition parties engaging in a political slugfest over the issue of safety of such wild bird species.

Recently, Mohammed Arif (30), a resident of Mandka village in Amethi, came into limelight after his pictures and videos with a sarus crane went viral on social media, following which he was also interviewed by several media outlets.

Samajwadi Party's chief Akhilesh Yaday, who came to Amethi a few days back, also went to Mandka and met Arif. After learning about the sarus crane, the state Forest Department took custody of the bird from Arif. Since then, the matter has gathered steam across political circles

According to the Forest Department, as per the census done in June 2022, there are 19,180 sarus cranes spotted in the state. Etawah and Auraiya have the highest 4,437 sarus cranes. In December 2021, the number of sarus cranes in the state was 17,665. The counting of this stork bird could not be done in 2020 due to the Covid-19 pandemic.

Abu Arshad, Wildlife Warden-Endangered Project at state Forest Department, says that the sarus crane is the tallest among the flying birds in the world. Its height is up to five to six feet while the male and female sarus cranes look alike. The Gruidae species are the only birds that breed in the southern part



#### Akhilesh, Arif not allowed to meet sarus at Kanpur zoo, told bird is in quarantine

Kanpur: Samajwadi Party president Akhilesh Yadav and Amethi's Arif Khan Gurjar, who cared for an injured sarus crane for a year before it was taken away by forest officials much to his dismay, were not allowed to see the bird at the Kanpur zoo with officials telling them it was under quarantine. The crane lived with Gurjar in Amethi district's Mandkha village like a family member for months. But last Tuesday, forest officials shifted it to the Samaspur Bird Sanctuary in Rae Bareli so that it could live in its natural environment. It was subsequently moved to the zoo here. Yadav, during his Kanpur visit Tuesday, went to the zoo with Arif to see the bird but they returned disappointed. The Samajwadi Party chief was told that the bird is under 15-day quarantine and a team of doctors is keeping a close watch on its health, a senior forest department official said, requesting anonymity. The official, however, added the two spent about an hour there and saw the sarus on CCTV screens. The SP chief criticised the government for taking away the bird from Arif and sending a legal notice to him.

The Wildlife Warden said that the Amethi incident has led to an impression that since the sarus cranes are living together with human beings, their natural habitat has been affected and is not getting requisite nutrients for its growth. Experts have advised to keep these birds in the zoo. It is an offence to catch, touch and disturb such endangered birds and their eggs.

Dr Brajendra of Lucknow Zoo says that sarus crane is considered a sensitive bird and does not eat potato and rice. It is very important to receive the requisite diet so that this bird can remain healthy. They usually eat grass, grains etc. They eat about 500 to 700 gram of food at a time.

Ashok Kashyap, another Lucknow Zoo veterinarian, says, "If you domesticate any animal or bird, it starts getting attached to you emotionally. But you cannot do this for long since there is a change in their wild nature due to which they can attack human beings which can be fatal."

Kaushalendra Singh, a member of Uttarakhand Wildlife Board, says, "Sarus crane is a protected bird. If the bird is found in an injured state, a person must inform the Forest Department. Their natural behaviour must not be disturbed... If they come in contact with humans regularly, they will not breed ...?

Though the by-election will have no impact on the present government which enjoys a comfortable majority in the 403-member UP assembly, it assumes significance as the two major political players in the state, BJP and Samajwadi Party, will be going all out for the win, especially SP which will be out to test its popularity one year into the formation of second Adityanath government.

After defeating Azam Khan in his stronghold Rampur, BJP will be looking forward to making a clean sweep by annexing the Suar seat too.

BJP recently demolished over a four-decade-old SP leader's hold on Rampur Sadar assembly seat and it would be interesting to see whether his son's seat too goes out of the family hands.

In the 2022 assembly polls, Abdullah Azam had defeated BJP ally Apna Dal (S) candidate Haider Ali, son of Congressman and a known critic of Azam's family, Kazim Ali Khan, by over 60,000 votes.

Earlier in 2017, Abdullah had won the seat by defeating BJP's Laxmi Saini by over 53,000 votes.

But on both the occasions, he got disqualified — in the first instance, because of an alleged anomaly in his birth certificate and in second, due to his conviction in the 15-year-old Chhailet incident.

Chhanbey reserved seat had been won by Rahul Kol, a son of former Robertsganj MP Pakauri Lal Kol, in 2017. He won it again in 2022 as a candidate from Union minister of State Anupriya Patel headed Apna Dal (s), which is an ally of the ruling BJP.

#### Govt introduces Forest (Conservation) **Amendment Bill in LS**

New Delhi, March 29 : Environment Minister Bhupender Yadav introduced an amendment bill in Lok Sabha Wednesday that seeks to bring clarity to the country's forest conservation law and exempt certain categories of lands from its purview to fast-track strategic and security-related projects

of national importance. Yadav introduced the Forest (Conservation) Amendment Bill, 2023, amid slogan shouting by opposition members demanding a joint parliamentary committee probe into the Adani issue.

The bill was then sent to a joint committee of both the Houses for discussion. The committee consists of 19 Lok Sabha members, 10 Rajya Sabha members and two members to be nominated by the Lok Sabha speaker.

According to the government, the bill seeks to clarify the scope of applicability of the Forest (Conservation) Act. 1980, on various lands. It seeks to broaden the horizons of the Act, keeping in view India's aim to increase forest cover for creation of a carbon sink of additional 2.5-3.0 billion tons of CO2 equivalent by 2030.

### Medical services hit in Rajasthan as docs protest

New Delhi, March 29: Researchers have developed a three-dimensional (3D) paperbased portable device that can detect adulteration in milk within 30 seconds.

The test, which could be performed at home, can detect multiple commonly-used adulterating agents including urea, detergents, soap, starch, hydrogen peroxide, sodium-hydrogen-carbonate and salt, among others,

#### Saudi joins SCO

Riyadh: Saudi Arabia's cabinet approved Wednesday a decision to join the Shanghai Cooperation Organization, as Riyadh builds a long-term partnership with China despite US security concerns. Saudi Arabia has approved a memorandum on granting the kingdom the status of a dialogue partner in the Shanghai Cooperation Organization (SCO), state news agency SPA said. The SCO is a political and security union of countries spanning much of Eurasia, including China, India and Russia. Formed in 2001 by Russia, China and former Soviet states in Central Asia, the body has been expanded to include India and Pakistan, with a view to playing a bigger role as counterweight to Western influence in the region. Iran also signed documents for full membership last year.

SL cuts fuel price

The gaping hole 20 times larger than Earth and is unleashing solar winds of 2.9 million kmph supposed to hit our planet Friday

Washington, March 29: A huge 'hole' about 20 times the size of Earth has torn through the Sun, the second in less than a month. Scientists from American space agency NASA spotted this massive black region on the Sun, according to a report. Called the "coronal hole", it looks like certain potion of the Sun has vanished. The appearance of the hole

prompted US federal agency NOAA to issue an alert for geomagnetic storms. According to news.com.au, the gaping hole is unleashing solar winds of 2.9 million kmph towards Earth, which will hit our planet Friday.

The coronal hole was discovered by NASA's Solar Dynamics Observatory (SDO) March 23 near the Sun's South Pole. The situation is being moni-

tored to assess the impact these solar winds will have on our planet. said the report. The continuous flow of charged particles from the Sun are known to impact the Earth's magnetic field, satellites, mobile phones and GPS.

These holes allow solar wind (or geomagnetic storms) to escape more readily into the space, which are ranked from G1 to G5 - with the



latter being the most powerful. Because of the giant hole on the Sun's surface, solar winds are hurtling towards the Earth can potentially take down our satellites and other vital pieces of tech.

"The current coronal hole, the big one right now, is about 300,000 to 400,000 kilometres across. That is about 20-30 Earths lined up back-to-back," Alex Young from NASA Goddard's Heliophysics

#### Science Division told Business Insider.

On March 24, the first coronal hole caused dazzling auroras that filled up the night sky with electric purples and greens. They were triggered by a G3 storm, which is a strong solar storm capable of disrupting electrical systems and satellite operations, in-

cluding orientation problems. According to NASA, coronal holes appear as dark areas in the solar corona in extreme ultraviolet (EUV) and soft X-ray solar images. They appear dark because they are cooler, less dense regions than the surrounding plasma and are regions of open, unipolar magnetic fields. These holes can develop at any time and location on the Sun, but are most prevalent and stable at the solar North and South poles.

EU removes Pakistan from list of 'High-Risk Third Countries'

Islamabad, March 29: The EU has removed Pakistan from its list of "High-Risk Third Countries' that do not have a robust antimoney laundering and countering terrorist financing regime, a move welcomed by Prime Minister Shehbaz Sharif Wednesday as a major development which would facilitate the cash-strapped country's businesses.

The developments come as a much-needed breather when Pakistan faces an economic crisis.

The EU's delegation in Pakistan termed it an "important positive step" for Pakistan.

"In line with last year's FATF (Financial Action Task Force) decision, the EU has decided to remove

Pakistan from its list of countries with high risk regarding money laundering and financing of terrorism," it said on Twitter.

It was referring to the decision by the global money laundering and financing watchdog, the **Financial Action Task Force** (FATF), to remove Pakistan from its list of countries under "increased monitoring".

In a statement announcing the news, Pakistan's Ministry of Commerce said the listing of Pakistan in 2018 had resulted in creating a regulatory burden affecting Pakistani companies doing business with the 27-member bloc.

Pakistan was included on the list in 2018, placing the country under additional regulatory restrictions.

The list includes countries that the European Union considers to have strategic deficiencies in their anti-money laundering and counterterrorism financing frameworks.

Sharif in a Twitter post said that the decision would facilitate the country's businesses, individuals and entities. "De-listing of Pakistan from EU's updated list of high-risk third-countries is a major development which would facilitate our businesses, individuals and entities," he tweeted.

PM Shehbaz also said it was a reflection of the government's unwavering resolve to further strengthen the Anti-Money Laundering and Countering the Financing of Terrorism (AML/CFT) regime.

Gun violence of all types has gone up exponentially as 13 school shooting incidents were reported in and 129 mass shootings so far in 2023

There are about 120 guns for every 100 Americans, according to the Switzerland-based Small Arms Survey, No other nation has more civilian guns than people. And about 44% of US adults live in a household with a gun, and about one-third own one personally.

Almost a third of US adults believe there would be less crime if more people owned guns, according to an April 2021 Pew survey. However, multiple studies show that where people have easy access to firearms, gun-related deaths tend to be more frequent, including by suicide, homicide and unintentional injuries. Meanwhile, mass shootings continue to drive demand for more guns.

It is unsurprising that the US has more deaths from gun violence than any other developed country per capita. The rate in the US is eight times greater than in Canada, which has the seventh highest rate of gun ownership globally; 22 times higher than in the European Union and 23 times greater than in Australia, according to Institute for Health Metrics and Evaluation data from 2019.

Russia, China bolster usable N-arms in '22

Oslo, March 29: The world's number of operational atomic warheads increased in 2022, driven largely by Russia and China, a new report out Wednesday said as nuclear tensions have risen since the war in Ukraine.

The nine official and unofficial nuclear powers held 9,576 ready-touse warheads in 2023 -- up from 9,440 the year prior, according to the Nuclear Weapons Ban Monitor published by the NGO Norwegian People's Aid.

Those weapons have a "collective destructive power" equal to "more than 135,000 Hiroshima bombs,' the report said.

The figures are published as Moscow has repeatedly raised the nuclear threat in connection to its invasion of Ukraine and Western military aid to the Eastern European country.

On Saturday, Russian President Vladimir Putin announced that he had agreed with Minsk to deploy "tactical" nuclear weapons in Belarus, a country on the EU's doorstep. The additional 136 warheads to the ready-to-use global nuclear stockpile last year were attributed

to Russia, which has the world's

He also rejected a plea by Khan's lawyer to allow the former PM to appear March 30 when the prosecution lawyer opposed the move by saying that he should have appeared by the deadline of the arrest warrants.

Yangon: Myanmar's juntastacked election commission Tuesday announced Aung San Suu Kyi's National League for Democracy party would be dissolved for failing to reregister under a tough new military-drafted electoral law, state media said.

Sao Paulo, March 29: Brazil's government Tuesday reported the 700,000th death from Covid-19 in the South American nation, which has the second most victims of the virus after the United States.

Brazilian health experts say most people dying of Covid-19 in recent days are either unvaccinated or suffer from other debilitating diseases. The vaccine currently available in every health care unit in Brazil could have changed the lives of families who lost beloved ones in

the pandemic, said the country's Health Ministry.

Health Minister Nisia Trindade criticized former President Jair Bolsonaro for his handling of the pandemic. Bolsonaro, who became ill with Covid, later declined to take the coronavirus vaccine and flouted health restrictions.

'We have to look at the past, but at the same time we have to say the health ministry cannot make the mistake of not coordinating, not taking care, not treating (the disease). We need to be united so new tragedies do not happen," Trindade said.

Miguel Lago, executive director of Brazil's Institute for Health Policy Studies, which advises public health officials, said the figure is a reminder of the country's obligation to punish those who failed to act against the virus or sabotaged those who were trying.

#### Seventh round of coal mine auctions

New Delhi: Defence Minister Rajnath Singh Wednesday launched the seventh round of auctions for commercial mining of coal blocks, putting 106 mines under the hammer. # **ANTI-COMPETITIVE PRACTICES NCLAT upholds fine on Google**

NCLAT upholds CCI's ₹1,338cr fine on Google and grants partial relief on four grounds

New Delhi, March 29: An appellate tribunal Wednesday handed out a mixed verdict on Google's alleged anti-competitive practices in the android mobile devise case - upholding a fine of ₹1,338 crore but scrapping conditions like allowing hosting of third-party app stores on its Play Store.

While upholding the fine imposed by the CCI for exploiting its dominant position in Android, the NCLAT struck down anti-trust regulator order that had said Google will not restrict the removal of its pre-installed apps by the users. Notably, the NCLAT in its 189-

page order, upheld CCI's six directions, including one in which Google was asked to allow the users during the initial device setup to choose their default search engine. and another that made it clear that OEMs cannot be forced to pre-install a bouquet of apps.

Google said it is reviewing the NCLAT order and is in the process of evaluating legal options. A two-member bench of the

National Company Law Appellate Tribunal (NCLAT) has asked Google to implement the direction and deposit the amount in 30 days.

The appellate tribunal said "the impugned order of the Commission is upheld except the four directions" issued and added that Google is "thus not entitled for any other

relief except for setting aside the above four directions"

"The Appellant (Google) is allowed to deposit the amount of penalty (after adjusting the 10 per cent amount of penalty as deposited under order dated January 4, 2023) within a period of 30 days from today," it said. On October 20 last year, the

Competition Commission of India (CCI) slapped a penalty of ₹1,337.76 crore on Google for anti-competitive practices in relation to Android mobile devices. The regulator also ordered the internet major to cease and desist from various unfair business practices. This ruling was challenged be-

fore the NCLAT, which is an appellate authority over the orders passed by the CCI.

#### **NEW DIRECTIONS**

The NCLAT order passed Wednesday marks one of the most high-profile anti-trust battles in the Indian market, involving the tech giant and CCI, and concludes over a month-long day-to-day hearing by the appellate tribunal on the directions of the Supreme Court.

Out of the 10 directions issued by the CCI on October 20, 2022, to Google, the NCLAT upheld the six directions and said it "is allowed 30 days time to implement the measures' One of the important directions

#### Govt plans to raise ₹8.88lakh-cr from market in H1 FY24

New Delhi, March 29: The Centre plans to raise ₹8.88 lakh crore through market borrowing in the April-September period of 2023-24 to fund the revenue gap to push\_ economic growth, the Finance Ministry said Wednesday.

Out of gross market borrowing of ₹15.43 lakh crore estimated for FY2023-24, ₹8.88 lakh crore or 57.5 per cent is planned to be borrowed in the first half (H1), it said. The borrowing is scheduled to be completed in 26 weekly tranches of ₹31.000-39,000 crore, it said, adding that the borrowing will be spread under 3, 5, 7, 10, 14, 30 and 40-year securities. **Finance Minister Nirmala** Sitharaman had in the Budget for FY24 reduced the fiscal deficit or the gap between expenditure and revenue to 5.9 per cent of the GDP for FY24 against 6.4 per cent in the current financial year. To finance the fiscal deficit in 2023-24, net market borrowing from dated securities is estimated at ₹11.8 lakh crore. "The share of borrowing under different maturities will be 3 years (6.31 per cent), 5 years (11.71 per cent), 7 years (10.25 per cent), 10 years (20.50 per cent), 14 years (17.57 per cent), 30 years (16.10 per cent) and 40 years (17.57 per cent)," the statement said. The issuance of Sovereign Green Bonds will be announced in the second half (H2) of FY 2023-24, it added.

# HUMANITY Musk, experts call for pause in 'giant AI experiments'

SINCE ITS RELEASE LAST YEAR. MICROSOFT-BACKED OPENAI'S CHATGPT HAS PROMPTED RIVALS TO ACCELERATE DEVELOPING SIMILAR LARGE LANGUAGE MODELS, AND COMPANIES TO INTEGRATE GENERATIVE AI MODELS INTO THEIR PRODUCTS

Paris, March 29: Billionaire mogul Elon Musk and a range of experts called Wednesday for a pause in the development of powerful artificial intelligence (AI) systems to allow time to make sure they are safe.

An open letter, signed by more than 1,000 people so far including Elon Musk and Apple co-founder Steve Wozniak, was prompted by the release of GPT-4 from San Francisco firm OpenAL

The company says its latest model is much more powerful than the previous version, which was used to power ChatGPT, a bot capable of generating tracts of text from the briefest of prompts. "AI systems with human-com-

petitive intelligence can pose profound risks to society and humanity. said the open letter titled "Pause

Giant AI Experiments". "Powerful AI systems should

be developed only once we are confident that their effects will be positive and their risks will be manageable," it said.

Musk was an initial investor in OpenAI, spent years on its board, and his car firm Tesla develops AI systems to help power its selfdriving technology, among other applications.

#### 'Trustworthy and loyal'

The letter quoted from a blog written by OpenAI founder Sam Altman, who suggested that "at some point, it may be important to get independent review before starting to train future systems". "We agree. That point is now," the authors of the open letter wrote.

'Therefore, we call on all AI labs to immediately pause for at least 6 months the training of AI systems more powerful than GPT-4."

They called for governments to step in and impose a moratorium was signed by prominent critics as if companies failed to agree. The six months should be used to develop safety protocols, AI governance systems, and refocus research on ensuring AI systems are more accurate, safe, "trustworthy and loyal" The letter did not detail the dan-

gers revealed by GPT-4.

But researchers including Gary Marcus of New York University, who signed the letter, have long argued that chatbots are great liars and have the potential to be superspreaders of disinformation.

However, author Cory Doctorow has compared the AI industry to a "pump and dump" scheme, arguing that both the potential andthe threat of AI systems have been massively overhyped.

Mumbai, March 29: Rohit Sharma knows a thing or two about winning IPL trophies and having been there and done that on five occasions for Mumbai Indians, public expectation is the last thing to make him wary.

The most successful captain in the history of IPL with five championships, Sharma knows that Mumbai Indians as one of the title contenders comes enters any tourney with a baggage of hype and hoopla.

And that's what a protective skipper wants to shield the youngsters in his side from as one can easilv get overawed by the sense of occasion

"Expectations will always be there whenever we go out to play, not just in the IPL. Having played for so many years it does not bother me and I am not worried about what the people are expecting me to do," Sharma said at the season opening media conference organised by MI. "We know that we have to do our best and win the trophy. To keep thinking about it all the time is to put pressure on yourself," the skipper said.

Dewald Brevis, Tilak Verma will all be playing their second season but for young Cameron Green with a multi-million dollar deal. IPL will be a different beast altogether.

"I don't want to put too much pressure on them (youngsters) right now. Closer to our first game, we will give them that specific roles. Obviously leading up that first game, guys pretty much know what we are expecting from them,' Sharma explained.

The Argentine captain trails only two players on the list of most goals scored for national teams in official matches; Portugal's Cristiano Ronaldo, with 122, and Iran's Ali Daei, with 109.

# BAKINA SECURES 12TH STRAIGHT

Miami Gardens, March 29: Reigning Wimbledon champion Elena Rybakina extended her winning streak to 12 matches by delivering 10 aces — her fourth consecutive outing with at least that many — in a 6-3, 6-0 victory over 25th-seeded Martina Trevisan in the Miami Open quarterfinals.

Rybakina has 46 aces through four matches at the hard-court tournament in Florida and a WTAleading 201 this season.

The 23-year-old, who represents Kazakhstan, improved to 20-4 in 2023, including a run to the Australian Open final in January and a title at Indian Wells, California, last week

She is trying to become only the fifth player to win the women's trophies at Indian Wells and Miami in the same season. Top-ranked Iga Swiatek did it a year ago; she withdrew from Miami this time because of a rib injury.

Alcaraz, who returned to No.1 in the ATP rankings last week, got past Australian Open semifinalist Tommy Paul 6-4, 6-4 to set up a meeting against Fritz, the topranked American man and seeded ninth in Miami.

Fritz compiled twice as many winners, 22, as unforced errors, 11, and only dropped serve once during a 6-3, 6-4 victory over No.7 Holger Rune. That put Fritz into his first quarterfinal in seven appearances in Miami - and his first matchup against Alcaraz, a 19year-old from Spain who won the US Open in September for his first Grand Slam title.

No.10 Sinner eliminated No.6 Andrey Rublev 6-2, 6-4. Sinner's next opponent will be Emil Ruusuvuori.
