FELLING OF TREES FOR PURI CHARIOTS BEGIN

Berhampur: The ritual of felling trees for construction of the three chariots for Rath Yatra festival in Puri started Thursday in the North Ghumusar forest range in Ganjam district. Two dead 'Phasi' trees identified by the Shree Jagannath Temple Administration (SJTA) were cut in the Central Kalimba forest amid chants of 'Jai Jagannath' and other rituals. A total of 29 trees in the Central Kalimba, Tarasinghi and Mujagada forests have been chosen for felling.

According to tradition, the logs will be sliced as per specified numbers of pieces for the commencement of chariot construction from the day of Akshay Tritiya. Traditionally, 865 logs of 'Dhaura', 'Phasi' and 'Asana' trees are used in the construction of the three wooden chariots of the Holy Trinity.

FIRE IN FERRY KILLS 31 IN PHILIPPINES

Manila: A ferry carrying about 250 passengers and crew caught fire in the southern Philippines and 31 people drowned or died in the blaze the bodies of whom were found later, Governor Jim Hataman of the southern island province of Basilan said Thursday. Many of those

rescued had jumped off the 'MV Lady Mary Joy 3' in panic at the height of the fire and were plucked from the sea by the coast guard, navy, another ferry and local fishermen. However, 17 people are still missing, so the toll may go up," the official added. Eighteen of bodies were found inside an airconditioned cabin of the burnt boat. another official said. The ferry was en route to Jolo town in Sulu province from Zamboanga.

BJD tells Union Minister to understand the difference between crime and lawlessness

Bhubaneswar, March 30: Ahead of the Jharsuguda bypoll, the BJP and BJD got engaged in a war of words Thursday on Twitter over the prevailing law and order situation in Odisha. Union Minister and senior BJP leader Dharmendra Pradhan along with MLA Suryabanshi Suraj were involved in a battle of words with BJD's Sasmit Patra on the microblogging platform.

Pradhan targeted the Odisha government over the alleged kidnap and murder of 15-year-old Samarth Agrawal of Jharsuguda, just two months after the brutal murder of the then Health Minister and local MLA Naba Kishore Das (January 29).

Alleging lawless in Odisha is a reality, Pradhan said it is high-time for the BJD government to recognise their faults. "The murder of young Samarth exactly two months after the broad daylight killing of Minister Nabha Das exposes the Odisha government's tall claims on rule of law," Pradhan said.

'Gruesome incidents like the above mentioned murders have shocked everyone and weakened the trust of people of Odisha. No amount of empathy will bring solace to young Samarth's family. The Odisha government must ensure safety of citizens," Pradhan added.

Senior BJD leader and Rajya Sabha member Sasmit Patra countered Pradhan's statement saying BJP-ruled states like UP, MP and Maharashtra have more murder cases than Odisha in 2021.

"Don't insult the peace-loving Fire personnel haul up a woman who had people of Odisha by branding them as lawless. Don't insult Odisha for your petty political narrative. It is surprising to see that despite you having been a Minister for so long, you are still unaware about the difference between lawlessness (law and order) and crime," Patra said. "Please don't try to mislead and do politics on sensitive matters of crime," Patra added. As per the NCRB Report (2021), in BJP-ruled states like UP, MP, Maharashtra, Assam and Haryana more rape cases have been reported than Odisha, the BJD MP said. Reacting to Patra, BJP legislator Suraj said, "People of Odisha are peace-loving and do understand what lawlessness and crime mean. Safety and security of citizens is one of the most important functions of a government. Odisha government has been a complete failure in this aspect.'

Evan Gershkovich was detained in the Ural Mountains city of Yekaterinburg while allegedly trying to obtain classified information, the Federal Security Service, known by the acronym FSB, said Thursday here. The service, which is the top

"It is not about a suspicion, it is about the fact that he (Evan) was caught red-handed. The media house however, rub-

bished the Russian claims. "The Wall Street Journal vehemently denies the allegations from the FSB and seeks the immediate release of our trusted and dedicated reporter, Evan Gershkovich. We stand in solidarity with Evan and his family," the newspaper said.

The arrest comes at a moment of bitter tensions between the West and Moscow over the war in Ukraine and as the Kremlin intensifies a crackdown on opposition activists, independent journalists and civil society groups. Contd....P4

Thirteen women and a man died in the accident, Madhya Pradesh Home Minister Narottam Mishra told reporters in Bhopal. "Five people are still missing and the chances of their survival is slim," he added.

The CM later said he has ordered a probe into the incident. According to Chouhan, 19 persons were rescued and taken to the hospital and all of them are responding well to treatment. Chouhan also announced financial assistance of ₹5 lakh each to the kin of the deceased and ₹50.000 for the injured.

Nearly 30-35 devotees fell into the well after the accident at the temple, said Indore Police Commissioner Makrand Deoskar citing eyewitness accounts. Earlier, a witness had put the number at 25.

An eyewitness said that during the religious programme, there was a huge crowd of devotees on the roof of the 'bawdi'. As the structure could not bear the load of so many people, it caved in, he said. After the accident there was utter chaos as people started looking for their family members who were present on the premises at the time of the tragedy.

Idlis titillate taste buds across India



New Delhi, March 30: What was a typical South Indian food, a couple of decades back, has now become popular across India irrespective of the taste buds. Idlis have now become the go-to food for all and sundry because it is easily available and very easy to digest. Today idli, a dish composed solely of rice and fermented lentils, is most popular and has replaced many traditional breakfast diets, in various parts of India.

Thursday was celebrated as the 'World Idli Day' and on the occasion a food delivery company said that it has served 33 million plates of idlis in the last 12 months. This is just the figure that is available from one company; so one can imagine what will the total amount be if all the other services are taken into account.

"Forget delivery services; just think about all the roadside vendors



who sell idlis and also the people who go to hotels and order the item, the figure for the last 12 months shall be staggering indeed," a food blogger was quoted as saying on 'NDTV'. Today it can safely be said that idli and Chennai. However, the cities of Delhi, Kolkata, Kochi, Mumbai, Coimbatore, Pune and Vizag are a close second.

The prize of the highest idli buver in the last 12 months goes to a resident of Hyderabad. The 'Swiggy' user ordered the maximum number of idlis last year, spending a whopping ₹6,00,000 on this delicacy. What's more, this user ordered 8,428 plates of idlis, including orders placed for friends and family while travelling across cities like Bangalore and Chennai.

An analysis of food habits of people across 10 different cities has revealed an interesting fact. The most popular time for ordering idlis is between 8.00am and 10.00am. RLY MIN ALLOTS ₹300 CRORE FOR **CUTTACK STATION**

Cuttack, March 30: The Cuttack railway station will be modernised as a world-class facility at an expenditure of ₹303 crore, Railways Minister Ashwini Vaishnaw said Thursday during a programme here.

'Cuttack railway station will be redeveloped as a world-class station and ₹303 crore has been sanctioned for the work. This year, a record 400km of railway tracks have been laid in Odisha. Earlier, in 2009-14, a mere 50 km was being constructed annually," the Railway Minister pointed out. He said that after work at the Cuttack station is completed it will have all the modern facilities that passengers need.

Satamile, March 30: In yet another incident of man-animal conflict, two women were trampled to death Thursday by a tusker while collecting mohua flowers at a jungle near Dudurkote village under Hindol forest range in Dhenkanal. The deceased have been identified as Puti Samal, 84, wife of late Mangulu Samal and Agari Majhi, 73. wife of Naba Maihi both residents of Dudurkote village in the district

According to reports, the two women had gone to the forest to collect mohua flowers when they were attacked by a tusker which chased them and trampled them to death. Being old, both could not run quickly and died on the spot. Family members and others rushed to the spot to rescue the two, but by then they had succumbed to their injuries.

The incident sparked tension in the area as kin and villagers put up the bodies at Tarini Square and staged a road blockade on Puruna Katak-Sambalpur road. They demanded ₹50 lakh compensation to the families of the deceased and job for one of the family members.

On being informed, forest ranger Lohit Rath, SDPO Deepak Jena reached the spot and tried to placate the protestors. The agitators relented after more than five hours after the ranger and SDPO announced that ₹4 lakh financial assistance will be given to families of both the deceased at one go. Police and Forest department officials have initiated an investigation into the tusker attack and the bodies have been sent for post-mortem.

It should be stated here that in the last 10 years a total of 925 people have lost their lives in Odishadue to elephant attacks as per information shared in the Assembly.


₹1.84cr NGT fine for Bargarh legacy waste

Bhubaneswar, March 30: The National Green Tribunal (NGT) has directed the state government to pay Rs 1.84 crore for the remediation of huge legacy waste dumped by Bargarh Municipality in Ward No.15 of the town during last 10 to 15 vears.

The environment watchdog asked the government to deposit the amount in an Escrow account to be utilised by Bargarh Municipality for treatment of the legacy waste which the civic body could not do "due to financial constraints".

"The amount of Rs 1, 84, 42,800 shall be deposited by the State Government in an ESCROW ac-



Act, 2016," the Tribunal ordered. Notably, the tribunal issued the orders while hearing a petition filed by seven people who alleged that the municipality was using a place in Ward No.15 as dumping ground causing air, water and soil pollution in the area. The petitioners, through advocate Sankar Prasad Pani, also alleged that

count to be utilised for the remediation measures for treatment of the legacy waste as well Bio-mining and all other remedial measures as may be required for Bargarh Municipality," (sic) the tribunal instructed.

The municipality has been directed to complete the treatment of legacy waste through bio-mining/micro composting centres/material recovery facilities by December 31, 2023. It asked the civic body to construct a boundary wall around the dumping sight within two months till the clearing up of legacy waste.

The green panel has also directed the municipal body to install and make operational the proposed five sewerage treatment plants (STPs) of 125 KLD by the stipulated period.

The tribunal said that the legacy waste caused severe damage to environment and people living around garbage and untreated municipal waste water is being released into Jeera River flowing through the Bargarh town.

Subsequently, the tribunal constituted a committee comprising Bargarh Collector, scientists from Odisha State Pollution Control Board and Central Pollution Control Board, and the executive officer of Bargarh municipality to look into the allegations.

The committee in its report noted that Bargarh Municipality has dumped around 51,476 tonne garbage for over 10-15 years on a land measuring 1.59 acres in Ward No. 15. Bargarh town generates around 35.5 tonne municipal waste every day, it said.

It pointed out that the municipality is liable to pay over Rs 1.54 crore at the rate of Rs 300 per tonne of garbage as environment compensation and Rs 30 lakh for failing to set up STP.

Cuttack Sadar. March 30: In a tragic incident, a 40-year-old man died of electrocution while he was connecting a pump set to an electricity point at Mallipur village under Kishannagar police limits, Thursday.

New Delhi, March 30: The government has exempted basic customs duty on all drugs and food for special medical purposes imported for personal use for treatment of rare diseases.

The import duty waiver will come into effect from April 1.

Also, the government has exempted Pembrolizumab (Keytruda), used in treatment of various can cers, from basic customs duty.

Drugs/medicines generally attract basic customs duty of 10 per cent, while some categories of life saving drugs/vaccines attract a concessional rate of 5 per cent or nil, it said. "The Central government

has given full exemption from basic customs duty on all drugs and Food for Special Medical Purposes imported for personal use for treatment of all Rare Diseases listed under the National Policy for Rare Diseases 2021," a finance ministry statement said. Food for Special Medical Purposes is a food formulation intended to provide nutritional support to persons who suffer from a specific disease, disorder or a medical condition, as a part of their dietary management.

In order to avail this exemption, the individual importer has to produce a certificate from Central or State Director Health Services or District Medical Officer/Civil Surgeon of the district.

While exemptions have already been provided to specified drugs for treatment of Spinal Muscular Atrophy or Duchenne Muscular Dystrophy, the government has been receiving many representations seeking customs duty relief for drugs and medicines used in treatment of other rare diseases. Drugs or Special Foods required for the treatment of these diseases are expensive and need to be imported.

"By blocking the activity of these proteins, we were able to reduce scarring on the heart and induce a 50 per cent improvement in overall heart function in mice that have undergone a heart attack," said Colas

While being primarily focused on heart cells, the scientists determined that AJSZ could be found

in all cell types, suggesting it to be a promising treatment target for a variety of diseases.

'This breakthrough is a significant step forward on our way to turning these promising biological concepts into real treatments, said Colas.

The next steps in the research involve exploring multiple options to block AJSZ proteins from functioning.

"We need to find a way to inhibit these proteins in a way we can control to make sure we are only reprogramming the cells that need it," said Colas.

'We will be screening for drugs that can help us inhibit these proteins in a controlled and selective manner in the coming months,' said Colas.

About the study, Colas said, "Helping the heart heal after injury is an important medical need in its own right, but these findings also pave the way for wider applications of cell reprogramming in medicine.'

No penalty on contractor sans notice: SC to state

New Delhi, March 30: The Supreme Court has rejected the petition of Odisha government against the Orissa High Court order that junked a penalty slapped by the state 'unilaterally' on a contractor while extending the work period.

A two-judge SC bench of Justices MR Shah and BV Nagarathna observed that the state government cannot levy penalty on the contractor while granting extension of time without putting him to notice.

"The High Court has rightly set aside the penalty levied while granting extension of time. Under the circumstances, the present appeals fail and the same deserve to be dismissed and are accordingly dismissed," the SC said. A contractor was awarded the tender for developing Khariar-Boden-Sinapali Road in Nuapada district. Although the work was supposed to be completed finished it in March 2014.

The contractor had applied for extension of time. The time extension was approved by the appropriate authority in 2019. Although the authority allowed the time extension without price escalation for 2009 to 2014, it levied 0.25 per cent penalty on work done during the extended period without even hearing the contractor's version, it was learnt.

The contractor moved HC challenging the 'unilateral' penalty. The HC granted relief to the contractor by setting aside the penalty imposed by the state. The state, however, approached the SC challenging the HC order.

The question before the SC was that whether the Odisha government is justified in levying the penalty unilaterally while granting extension of time in favour of the contractor when he failed to complete the work within stipulated time and subse-quently, completed it after the period prescribed under the contract.

treatments The entire cost of the procedure will be borne by the state government through Vidaan scheme

healthcare centres of the state on PPP mode in partnership with Bhubaneswar-based InDNA Laboratory. Odisha State Medical Corporation Limited (OSMCL) has signed an agreement with inDNA for several medical colleges and hospitals in the state

According to sources, the samples will be collected from these institutions, tested in the InDNA

Laboratory at Bhubaneswar, and test reports would be sent back to the institutions. The cost of the entire procedure will be borne by the state government through the Nidaan scheme.

Notably, molecular tests of tumors are advanced tests that can help in understanding the tumor biology and planning the treatment more precisely for targeted therapies. As they are expensive and require specialized laboratories with expert technicians, this initiative of the government will be of immense help to cancer patients. The laboratory was selected

through an open tender by (OSMCL), which has signed agreements with InDNA for SCB, MKCG, VIMSAR, PRMMCH, FMMCH, BBMCH, SLNMCH, Capital Hospital and RGH Rourkela.

The facility will be fully functional in these institutions shortly.

Detecting coral reef biodiversity in seawater samples Minor goes missing in Daya river

nvironmental DNA. or eDNA. - extracted from a litre of surface seawater, provides for a more effective and accurate means to measure coral reef biodiversity, according to a new research.

EDNA refers to the DNA that living creatures release into the environment, through skin, waste products, and mucus.

The research from Okinawa Institute of Science and Technology (OIST), Japan, paved the way for large-scale comprehensive surveys of coral reefs to take place, rather than relying on scientific scuba diving or snorkeling for obtaining direct observations. Scientific divers have confirmed the method to work through observations made in the same area of ocean.

The method is described in the journal Proceedings of the Royal Society B: Biological Sciences.

Owing to global warming and other bleaching-causing factors, survival of many coral reefs has been threatened. "Beautiful coral reefs in subtropical and tropical seas account for only 0.2 per cent of the entire ocean," said co-author Nori Satoh, Principal Investigator of OIST's Marine Genomics Unit. "However, they are the most bio-



diverse areas of the oceans, home to about 30 per cent of all marine life," said Satoh

The first step towards the conservation and protection of coral reefs involves understanding the make-up of a coral and how it changes over time. By analysing the eDNA extracted from seawater, without having to enter water, a clear picture of the organisms inhabiting that part of the ocean can be formed. Previous methods involved scientific scuba diving and snorkeling to record the species and the changes over time, which were time consuming, expensive, and labour intensive

The researchers tested the effectiveness and accuracy of these new tools by conducting a largescale survey of the ocean surrounding Okinawa using both the eDNA method and scientific divers. Over a four-month period, from early September to late December 2021, 62 sites from around the main Okinawa Island were surveyed

and two to four dominant coral genera at each reef were recorded.

'We found that the eDNA analysis matched that of the direct scientific observations with more than 91 per cent accuracy," said OIST Research Scientist, Koki Nishitsuji, first author of the paper. "In fact, 41 out of the 62 sites

were identical. The eDNA method indicated the presence of five dominant coral genera at all 62 sites surveyed. What's more the results of the environmental DNA method suggest the presence of corals never before recorded along the coast of Okinawa," said Nishitsuji. PTI



BJD banks on Naba's kin, 3 hope for saffron ticket

Sambalpur, March 30: The Election Commission of India (ECI) has announced May 10 as the date for by-election to the Jharsuguda Assembly segment, Wednesday. The date when the announcement was made coincides with that of the assassination of former state health minister Naba Das who was representing the Jharsuguda Assembly segment in the state Assembly.

Das was murdered January 29 and his death has just completed two months when the ECI announced the date of by-election to the constituency. According to data available from 2019 elections, the Jharsuguda Assembly segment has 20,23,225 voters. In this election, BJD candidate Naba Das won by receiving 98,620 votes, BJP's Dinesh Jain got 52,921 votes and Congress candidate Mahendra Nayak received only 18,823 votes. While the ruling BJD is banking

on the family members of the slain minister to win the poll, saffron leader Tankadhar Tripathy is the front runner for the ticket from BJP.

The date of announcement of the bypoll has sent chatters abuzz in the area and warmed up politics in Jharsuguda Assembly segment. The filing of nominations for the election will begin April 20, withdrawal of nominations will be allowed from April 23 and the polls will be held May 10. The counting of votes and declaration of the winner are slated for the same day, May 13.

Gujarat man found dead in Bolangir

Bolangir, March 30: An elderly man who had taken a house on rent just two days back at Rajivnagarpada in this town was found dead in the house, Thursday. The matter came to the fore after

Fown police recovered the body of the man, Thursday afternoon. According to the house owner, the deceased identified him as Rai Bharadwaj, 58, of Nabarangpur while taking the house on rent two days back. The house owner grew suspicious and informed the Town police after man did not open the door for a long time Thursday morning. Town police recovered the body lying on a cot inside the bedroom in the presence of Puintala tehsildar Rohit Bhoi officiating as magistrate. The body was sent for post-mortem to Bhima Bhoi Medical College and Hospital (BBMCH) in Bolangir and an investigation was launched. It is said that BJD is certain to give ticket to the slain leader's daughter Deepali Das or his son Vishal Das.

On the other hand, BJP's state secretary Tankadhar Tripathy is the front runner for the ticket. Two other BJP leaders Dinesh Jain and Trinath Goel are also aspiring for the ticket. Trinath is a new entrant in BJP from BJD. Mahendra Nayak is the frontrunner from the Congress ticket.

Naba Das's daughter Deepali said that the date when her father died is the day of sorrow for the whole family. Her father died on the same date when the ECI announced the date for the bypoll. Her father's contribution for Jharsuguda was immense and he was always with the residents of Jharsuguda.

She will work with the person who will be announced as the party candidate by the BJD party supremo and Chief Minister Naveen Patnaik. She said that they are with the people and will work for them. One who will get the party ticket is certain to win in the election. "The love of Jharsuguda residents and the blessings of Chief Minister are with my family," she added.

BJP's state secretary Tankadhar Tripathy said that BJP is a democratic party. The candidate selection is done by the party's Parliamentary board and there is no family-based politics in BJP. All will support the candidate who will be given the ticket by the party.

"Our party will not fight the elections to fulfill someone else's dream. Our party will fight the elections to fulfill the dreams and the aspirations of the residents of Jharsuguda and will certainly win," he said.

Woman beaten to death by hubby

SIMULIA: In a shocking incident, a drunken man allegedly beat up his wife to death over a tiff late Wednesday night at Chhatrapur village under Simulia police limits in Balasore district. Police reached the spot and sent the body for post-mortem. The accused husband was arrested as he confessed to his crime during interrogation. A scientific team was also pressed into service and a case was registered in this connection. Police said that the couple consumed liquor from a liquor shop at Kalasuni Square, Wednesday evening. Later, while returning home, they fought over some issue on the road. Their fight took an ugly turn as Bira lost his cool and beat up his wife with a stick and dumped her on the farmland after tying her limbs with a piece of cloth and returned home.



construction and incomplete work on highways and roads have turned out to be the major factors behind the ever increasing rate of road mishaps in Keonjhar district as 17 black spots were identified on National Highway-20 and National Highway-520 passing through the district.

Reports said 95 per cent of the accidents are occurring on the NH-20 and NH-520 that pass through the district.

The two wheeler riders are the major contributors to road mishaps due to driving under the influence of alcohol, rash driving, speeding and overtaking of vehicles on front. Illegal parking of vehicles on the roadside is another reason behind the rise in mishaps. It is alleged that error in road construction and incomplete road works on NH-20 and NH-520 (Panikoili to Rimuli and from Rimuli to Rajamunda) that pass through the district have led to a spurt in mishaps.

According to a government report, 349 persons lost their lives in 669 road accidents that took place from January to November, 2022. As many as 460 individuals were rendered disabled after losing their limbs or due to serious physical impairment due to accidents.

In 2021, 316 persons lost their lives in 621 roads mishaps in the district while 495 were permanently disabled.

When contacted, regional transport officer (RTO) Gopal Krushna Das said that raids are being conducted in intervals to check road mishaps. Moreover, steps like cancellation of driving licenses and road permits are also being taken. He urged the commuters to be aware and protect themselves by observing the traffic rules and cooperate with the transport department to reduce the road accidents and the related loss of life and property.

Millennium-old stepwell discovered in Chanditala

THIS COULD VERY WELL BE THE LARGEST STEPWELL IN THE WHOLE OF ODISHA, SAYS INTACH COORDINATOR ANIL DHIR

Jajpur, March 30: An ancientera stepwell has been discovered in Chanditala village under Barchana block of Jajpur district by the members of Indian National Trust for Art and Cultural Heritage (IN-TACH), a culture and heritage research institute. INTACH project coordinator Anil Dhir informed that the well dates almost a millennium back.

Heritage researcher Deepak Kumar Nayak, and history enthusiast Suman Prakash Swain along with INTACH coordinator Dhir have carried out a primary investigation/ review of the stepwell with the help of the locals.

The ancient well is situated on a rectangular area of 120 feet length

and 35 feet breadth at the foot of the Sikharchandi hillock at Chanditala village, researcher Nayak said. It has been built with red laterite stones in the form of a stepwell using ancient architecture.

Notably, stepwells with a long corridor of steps that descend to the water level, are examples of the many types of storage and irrigation tanks that were developed in different parts of India, mainly to cope with seasonal fluctuations in water availability.

In Odisha, other such age-old wells are found at Udayagiri Buddhist corridor, Dalijoda jungle, Nilagiri royal palace, Baideswar temple and Koshaleswar temple premises. But the recently discovered well at Chanditala is the biggest and deepest of them all in



size. One can draw water with ease from the well by descending almost 80 feet deep into the well by the help of the steps. Chanditala villagers are using the water from this stepwell till date.

The well may have been constructed towards the end of the Soma dynasty or the beginning of the Ganga empire in erstwhile

The ancient well is situated on a rectangular area of 120 feet length and 35 feet breadth at the foot of the Sikharchandi hillock at Chanditala village

Odisha as gauged by the historical evidences and archaeological remains found from the Sikharchandi shrine atop the mound. Going by the findings, it is estimated that the well was dug 900 to 1,000 years back, said Nayak.

INTACH coordinator Anil Dhir dubs the discovery as a marvel of

Odisha's ancient architecture. For hundreds of years without any care the architectural wonder has been lying unattended but has overcome the test of time. This could very well be the largest stepwell in the whole of Odisha. But the state Archaeology department is yet to take up any developmental work for the preservation of the well.

The well has found its name as 'Dedhasura-Bhaibohu' well among the villagers. One side of a wall needs a little repair. The state Archaeology department and Tourism department should conduct a detailed research on the ancient well and take steps for its conservation and publicity. IN-TACH will immediately intimate—(the state Culture department on the major discovery, Dhir said.

Authoritarian Drift

ast week, the International Criminal Court indicted Russian President Vladimir Putin for war crimes, alleging that he is responsible for the /forceful removal of Ukrainian children to Russia. This means that the ICC's 123 member states now have an obligation to arrest Putin if given the chance. It is a groundbreaking development. Although diplomatic engagement with Putin has always been difficult, he has now evolved fully into a ruthless and unbridled tyrant.

Worse, Putin's conduct is symptomatic of a broader trend. Around the world, democracy is increasingly under siege. The latest report on "The Global State of Democracy," issued by the International Institute for Democracy and Electoral Assistance, documents an alarming erosion of democratic institutions worldwide. Over half of the 173 countries investigated in 2022 registered significant assaults on democracy. From Afghanistan to Nicaragua, "almost half of all authoritarian regimes have worsened," the authors conclude. In the Asia Pacific region, only 54 per cent of people live in a democracy, and almost 85 per cent of those live in countries where democracy is weak or sliding toward authoritarianism.

This is a worrisome trend. In a globalised world, the task of containing rising authoritarianism cannot be left to individual countries. As we can see

from recent global supply-chain disruptions with Russia's war in Ukraine exacerbating food shortages and inflation in Africa - the fallout from authoritarianism can be felt far and wide. The question, then, is what international organisations like the ICC can do about it.

So-called strongmen who are actually full of insecurities have a natural propensity to morph into tyrants. From Hugo Chávez in Venezuela to Robert Mugabe in Zimbabwe and Recep Tayvip Erdoğan in Turkey, recent history features many leaders who may have come to power with good intentions, but turned worse over time, often ending up with blood on their hands.

I was alerted to this danger firsthand following a meeting with Nicaragua's dictator, Daniel Ortega, in Managua in September 2013. Having admired his overthrow of Anastasio Somoza's corrupt regime during my student years, I had long wanted to meet him. When given the chance, I enjoyed a long discussion about the Sandinista revolution and the challenges facing Nicaragua. Since then. however, sordid revelations about Ortega's tyranny have emerged. I did not realise it at the time, but the man I met was no longer the man who had overthrown Somoza. He had become the very thing he had once opposed. How did this happen? We know from political science and economics that answers to big macro questions are often embedded in micro factors, and Ortega's case is no exception. If you are a political leader, there comes a time when you must decide whether to try to pro-

long your time in office. And since politics is a nasty game no matter who you are, there is always a temptation to cross an ethical line – whether by raising money from cronies with the promise of favours, using official agencies to target opponents, or other nefarious means.

The decision depends on the gap between the utility that the leader gets from remaining in office and the utility the leader gets from being out of office. The wider the gap, the greater the leader's effort to stay in office.

As I argue in a recent paper, however, this calculation involves a serious, but common, mistake, which behavioural economists often refer to as "dynamic inconsistency." The problem lies in omitting a longer-term perspective. The more political leaders indulge in intrigue and evil to remain in office, the worse their exit option becomes. Prolonged abuse and intrigue increase the likelihood of law-enforcement investigations of the leader's behaviour (or violent retribution from political opponents) when the leader is out of office. That brings us back to the ICC's arrest warrant. Putin tested the limits of international justice for many years, and now there is an official effort to hold him to account. For that reason, he will now be even more

IT'S NOW OR NEVER

t is encouraging to hear the Intergovernmental Panel on Climate Change (IPCC) come out with periodic reports warning of the consequences of global warming. There can be no denying of the disastrous consequences that are already being felt due to climate change but the actions being taken by nations, though to a great extent satisfactory, do not fulfill the requirements that need to be brought in place.

The recently released IPCC Synthesis Report at Interlaken, Switzerland has come forward with a summary of all reports produced since 2015 on the reasons and consequences of global temperature rise due to anthropogenic emissions. Experts are of the opinion that this is the most comprehensive look to date at the causes of global warming, the impacts the rising temperatures are having on people and ecosystems across the world, and strategies that need to be adopted to counter this situation. Leading climate scientists say keeping warming to 1.5 degrees Celsius required deep, rapid and sustained greenhouse gas emissions reduction in all sectors. Keeping in view the planned fossil fuel infrastructure - coal-fired plants, oil wells, factories, cars and trucks – will already produce enough carbon dioxide to warm the planet roughly 2 degree C, these projects need to be cancelled, retired early or otherwise cleaned up to keep warming below that level. The report underlined that "10% of households with the highest emissions per person contributed 34-45% of all household emissions while the bottom 50% contribute 13 to 16%." India has been emphasising the importance of mindful and deliberate utilisation of natural resources against mindless and wasteful consumption.

Obviously, consumption inequality needs to be addressed through policy, infrastructure and technology access, which is a major message of the report. But to implement such things is an uphill

task. The rich would continue to consume more as, not just the Western world, but even countries like India are into unbridled materialism where we need more than we can consume.

It is not just talking of the bottom 25% of people globally, but it is also talking about the top 10% of the households, who have a disproportionate consumption and contribution to growing emissions. It is significant that the report stressed that fossil fuel use is overwhelmingly driving global warming. In 2019, around 79% of global greenhouse gas emissions came from energy, industry, transport and buildings and 22% from agriculture, forestry and other land use. It has rightly been pointed out that at current levels of warming - even after various nations have taken and announced strategic action – food production is starting to come under strain while pollution levels are on the rise. The world is still producing more food each year, thanks to improvements in farming technologies but climate change has slowed the rate of growth, the report pointed out quite rightly. One cannot doubt the fact that in populous countries like India, food security is at risk as the growth of population is on the rise.

The last conference at Sharm el-Sheikh in Egypt in November brought up the issue of loss and put severe financial pressure on the developing world. In such a situation, the oft-re-

peated slogan of sustainable development is rather difficult to achieve in view of developmental activities in and around forest areas. Added to this, as far as India is concerned, it is becoming very difficult to tackle natural disasters like floods, cyclones, affecting lakhs of people who reside near coastal areas. For them sustainable development is a myth as they are affected almost every year.

India's efforts in tackling climate change have been carried out to the extent possible, especially in areas like renewable energy but pollution in metros or combating floods remain a big problem. Moreover, if expansion of coal-based plants is stopped, as suggested in the part, it would have a grave impact on the economy. In this connection, it needs to be stated that biodiversity for the country is crucial not just because of ecosystem services but also be cause it directly supports the livelihood of large swathes of people and this challenge India must take.

Though the Union Environment Minister recently claimed that India has achieved close to 27% of the area under conservation with its protective area network that includes reserved forests, national parks, wildlife sanctuaries, mangroves, Ramsar sites and eco-sensitive zones, the path to sustainability is long. Research and innovation need to be explored for more efficient transport and energy policies with an eye on curbing environmental degradation. The Mission LIFE movement, launched by Prime Minister Modi in October last year, aiming towards environmentally conscious lifestyle must become a reality if we are serious about achieving the sustainable path of growth.

In order to retain or claim power, politicians trigger violence, hostilities, animosities, and mistrust in society and divide people on political and religious lines. This contributes to a spike in hate crimes. The pleasure of childhood is snatched under the guise of building a lucrative career. The weight of books is more than the weight of children. Instead of playing with friends, they spend time with smartphones. They are not taught moral values or about the grim reality of life. So, in different stages of life, they fail to cope with the grim reality of life and sometimes commit suicide when things don't move the way they desire. However, we should not be hopeless. According to Jason Silva, there are sides of us that are quite brutal and selfish, but nature has given us many gifts among them something known as the helper's high: the neurobiology of helping others. According to neuroscientists, altruism — the practice of con-

cern for welfare of others — may be more hardwired in our brains than previously thought. Neuroscience has demonstrated that giving is a powerful pathway for creating more personal joy. Helping others impacts our brain in many positive ways. When we help others, our brains release oxytocin, serotonin, and dopamine. These hormones have the effect of boosting our mood. The first key issue is how to cultivate and promote virtuous character and behaviour. Being virtuous generally makes people feel better. Happier people are more likely to help others. If we compare one society with another, we can see that countries with superior social norms tend to achieve higher levels of well-being. As identified by Aristotle in the Nicomachean Ethics, a society, where the average citizen exhibits strong virtues and high 'eudaimonia', will also be one where the average citizen experiences high life satisfaction. He defined 'eudaimonia' as "the activity of the soul according to virtue." High average 'eudaimonia' requires a virtuous character, including moderation, fortitude, a sense of justice, an ability to form and maintain friendships, as well as good citizenship in the political community.

In today's interconnected world, such behaviour has global fallout and thus needs to be addressed by the United Nations and organisations like the ICC. Determining precisely what to do will require much deliberation, but the need to expand the scope of international law - or even enshrine it in a global constitution - is obvious, as is the need for a UN that can uphold minimal principles. While there is much to discuss in the future, one immediate imperative is term limits. Whether to institute them should no longer be considered a question to be decided by the country concerned. Given the global dynamics of unchecked power within any given country, we all have an interest in using international law to change the incentives that lead politicians down the road to authoritarianism. There is significant variation in term limits. It is time now to create a uniform standard with which to hold countries accountable.

■ Grub

You might not like to learn that it's the same word as that for a caterpillar or other insect larva, though you will be relieved to hear that it has nothing to do with actually eating them. The source is the old Germanic word meaning to dig (which is also the source of grave). The verb to grub came first in English, around 1300, and meant just what it still does: to break up the surface of the ground or to clear the ground of roots and stumps. Derived from it is our adjective grubby for somebody or something that is dirty and the Australian term grub for a person who is unclean or who has messy habits. The connection with food is the idea of animals foraging for food. In their wild state, for example, pigs grub for edible roots and the like. The larval sense comes from this, because grubs often feed in leaf litter or around roots. The slang sense of human food appears around the middle of the seventeenth century and is also linked to grubbing in the ground for something to eat. Interestingly, in case you should think that slang words must either soon transform themselves into standard English or quickly vanish again, grub has remained slangy - at best informal - in all the years since, as have compounds like grubstake (from the nineteenth-century goldfields practice of investing in a prospector by providing him with money to buy food). Grub has also had several other slang senses that have not survived, such as that for a dwarfish, mean, slovenly sort of person, or someone of small abilities who can survive only by the most menial sort of work.

Growing inequality has made people hopeless, and desolate, especially who are deprived of getting their fair share of economic progress. The demonstration effect - the habit of people imitating the superior consumption pattern of others makes people more disheartened when they fail in their efforts.

The disintegration of joint families and the escalation of generation gap have made many mirthless. Due to the hustle and bustle of life, children don't get emotional support from parents, while parents get neglected in their twilight years.





Hoshiarpur, March 30: Police Thursday deployed a drone in a village in Hoshiarpur district where some suspects had abandoned their car following a chase two days ago, as radical preacher Amritpal Singh remained untraceable.

Cops deployed in and around Marnaian village were also checking vehicles in the search of the radical preacher. With police resuming their search in the area, they deployed a drone in the village, sources said. There was, however, no official comment on it from the police department. Paramilitary personnel have also been deployed in and around the village. Earlier, the Punjab Police had launched a massive search operation in the Hoshiarpur village and many adjoining areas following inputs that the radical preacher and his aides could be in the area. The Hoshiarpur action began as police chased a car, which some sources said may have carried Amritpal Singh and his aides, Tuesday night. They abandoned the vehicle at the village and disappeared. There were also reports that the suspects could have used another car to escape. Police have also conducted a door-to-door search operation but no success has been achieved vet. Amritpal Singh remains untraceable since the police crackdown against him and members of his pro-Khalistan 'Waris Punjab De' outfit began March 18, about three weeks after he and his supporters stormed into the Ainala police station near Amritsar to secure the release of an arrested man. The preacher escaped the police net in Jalandhar district March 18, switching vehicles and changing appearances. He and his associates

They have been accused of trying to revive terrorist activities in Jammu by carrying out recruitment.

New Delhi, March 30: The Defence Ministry Thursday signed contracts with Indian shipyards for acquisition of 11 next generation offshore patrol vessels (OPVs) and six next generation missile vessels at an overall cost of nearly ₹19,600 crore, an official statement said.

The contract for acquisition of 11 OPVs under Buy (Indian-IDDM) category was signed with Goa Shipyard Ltd (GSL) and Garden **Reach Shipbuilders and Engineers** (GRSE). Kolkata at a total cost of ₹9,781 crore. Of the 11 ships, seven will be indigenously designed, developed and manufactured by GSL and four by GRSE. The delivery of the ships is scheduled to commence from September 2026. Officials said that the acquisition

of these ships will enable the Indian Navy to maintain its combat capability and meet various operational requirements such as antipiracy, counter-infiltration, anti-poaching, anti-trafficking, non-combatant evacuation operations, search and rescue (SAR), protection of offshore assets etc. The construction of these ships

will generate an employment of 110 lakh man-days over a period of seven and half years. The contract for acquisition of six next generation missile vessels (NGMVs) was signed with Cochin Shipyard Ltd (CSL) at a cost of ₹9,805 crore. The delivery of ships is scheduled to commence from March 2027. The NGMVs would be heavily

armed war vessels incorporating stealth, high speed and offensive capability. The primary role of the ships would be to provide offensive capability against enemy warships, merchantmen, and land targets.

These ships will be capable of conducting maritime strike operations, anti-surface warfare operations and would be a potent instrument of sea denial for enemy ships, especially at choke points. In the defensive role, these ships would be employed for local naval defence operations and seaward defence of offshore development areas. The construction of these ships will generate an employment of 45 lakh man-days over a period of nine years. The indigenous manufacturing of these vessels will encourage the active participation of Indian shipbuilding and associated industries, including MSMEs.

Sun emits powerful solar flare, causes blackouts: NASA signals, and pose risks to spacecraft and astronauts.

he was quoted as saying to Business Insider: Earlier this week, the Earth witnessed a geomagnetic storm of magnitude G4, the strongest in nearly six years, causing auroras all over the US, NOAA said

The storm's unexpected ferocity not only made auroras visible as far south as New Mexico in the US, but it also forced spaceflight company Rocket Lab to delay a launch by 90 minutes, Space.com reported. According to scientists, more such solar storms are expected because the Sun is gearing up to a peak of activity, which happens about every 11 years. According to Mathew Owens, a professor of Space Physics at the University of Reading, such holes are more likely to appear, because the Sun is gearing up to apeak of activity, which happens about every 11 years.

Idukki (Kerala), March 30: Protests broke out in several parts of this high range district Thursday with locals taking to the roads and blocking traffic, aggrieved over the Kerala High Court's decision not to permit capture of 'Arikomban', a wild tusker, for the time being.

The High Court had Wednesday constituted a five-member expert committee to take a decision on what action should be taken with regard to Arikomban, so named as it raids ration shops and houses for rice. The panel has to communicate its decision to the court by April 5, till when capture of the elephant has been prohibited.

The court only permitted tranquilizing and radio collaring of the tusker if it forayed into inhabited areas despite the best efforts of the forest and wildlife personnel to deter it from doing so. Protesting against the court's decision, people of several panchayats of the district came out onto the roads and blocked traffic in some areas, according to TV visuals. The protesting public, including women and children, demanded that the elephant be removed from the area.

After news of the verdict spread, local residents of Chinnakanal and nearby places in Idukki district expressed disappointment regarding it and said they would hold protests till the tusker was removed from there.

They told scribes that they would not allow the forest and wildlife officials as well as the Kumki elephants, used for trapping wild pachyderms, to leave the area till Arikomban is removed from there. The people asked those advocating the elephant's interests to come there and stay in the area for a night with their families to understand the plight of the local residents.

The court had last week stayed the state government's order to tranquilise and capture Arikomban till March 29. The court's order had come on a PIL moved by two animal rights groups -- People for Animals (PFA), Trivandum Chapter and the Walking Eye Foundation for Animal Advocacy.

New species of bent-toed gecko discovered in Kerala

Thiruvananthapuram, March **30:** Scientists have discovered a new species of ground-dwelling gecko, a species of lizard, from the coastal forests of northern Kerala.

The beautifully-patterned Cyrtodactylus (Geckoella) chengodumalaensis is a small, nocturnal species that is found on the ground among leaf litter and rocks in forests and partially human altered landscapes like orchards and other areas with canopy cover.

The Chengodumala or Coastal Kerala Geckoella is endemic to low hills and coastal forest in northern Kerala and is known from scattered localities spanning a maximum of 120 km distance in Kozhikode, Malappuram, Palakkad, and Thrissur districts.

Chengodumala is a midland hillock in Kozhikode district, and also the type locality for Cnemaspis chengodumalaensis

(Chengodumala dwarf gecko). The second new species of gecko



to have been described from Chengodumala highlights the fact that biodiversity of these low-elevation hillocks is understudied, with many more species remaining to be discovered.

Chengodumala and other coastal hills in northern Kerala are under immense pressure due to illegal mining and indiscriminate logging and protection of these unique habitats that support endemic biodiversity is imperative. The paper describing the new species was published in Journal of Herpetology, an international publication of the Society for the Study of Amphibians and Reptiles, US.

Thiruvananthapuram, March 30: Thankachan, 54, hailing from Nattasserv village in Kerala's Kottayam district, is struggling to squeeze through the household items that are stacked up in a tiny room in his house. The other room and the kitchen of his house were completely damaged in the worst floods that the southern state had witnessed in 2018.

He and his wife have not got a new house as part of the government's flood rehabilitation programme and are struggling in a partially damaged house. "They will have to pull out two dead bodies from this house if something happens again," says Thankachan as his wife Aswathy, who is ill, looks on. He is not in a position to even think of experiencing another flood or any other extreme weather event.

Concerns of people like Thankachan who live in vulnerable areas may grow as a study conducted by the leading scientific institutes predicts floods, flash floods, landslides, and a substantial rise



in temperature in the southern state in the coming years due to climate change effects.

"There is going to be a 16 per cent increase in rainfall-either the total amount of rainfall, or average annual rainfall-by the end of this century," says Prof K P Sudheer, Ex-Officio Principal Secretary and Executive Vice President of Kerala State Council for Science, Technology, and Environment (KSCSTE). Sudheer was quoting the findings of a study done in 2023 that the KSC-STE has conducted jointly with the Centre for Water Resources **Development and Management** (CWRDM) and the Institute of Climate Change Studies (ICCS) based on the UN's 6th Assessment Report on Climate Change.

This study is yet to be submitted to the government. An increase in annual rainfall with a reduction in rainy days, increased rainless days leading to drought spells,

increase in both maximum and minimum temperatures that could considerably alter the seasons and crop patterns in the state are some of the scary findings that the study has predicted.

"Increased rainfall is probably positive news. But our findings indicate that this increased volume will be delivered in fewer days compared to our usual rainy season. That means the intensity of the rainfall is going to go up," Sudheer said, indicating that there is an increase in extreme weather events in the state. "It is expected that there will be a 20 per cent increase in extreme events," he added.

'We analysed around 21 ensemble climate projections given by the 6th Assessment Report, then what we did is, we used these projections, did the complete analysis in a scientific way, and ran it through a model to understand what the water availability scenario in Kerala is," Sudheer said. The study has also predicted a

possible increase in the maximum temperature to the tune of 1.7 degrees centigrade and also in the minimum temperature an increase by 1.9 degree centigrade, which indicates that there is a shift in the range of temperature. "While extreme events occur for a few days in a year, what is more, startling to note is that the temperature is going to substantially increase," Sekhar Lukose Kuriakose, Member Secretary of the Kerala State Disaster Management Authority (KSDMA) and Head Scientist of State Emergency Operations Centre, said.

He said after KSDMA "pushed" the Indian Meteorological Department to establish a denser weather station network in Kerala post the 2018 and 2019 floods, and got 100 automatic weather stations established in the state, they could now monitor temperature at 100 different locations in the state. "Now we are measuring the temperature at 100 locations, and suddenly, we, the state government, and IMD themselves realised that there are places in Kerala that have far higher temperature potential, where temperatures soared up to 39-40 degrees-

centigrade just in the beginning of March," Kuriakose said.

MALEGAON SC junks Purohit's plea for discharge from case

New Delhi, March 30: The Supreme Court has junked a plea filed by Lieutenant Colonel Prasad Shrikant Purohit seeking discharge in the 2008 Malegaon blast case.

A bench of Justices Hrishikesh Roy and Manoj Misra refused to interfere with the high court order. "The challenge here is to the order of the High Court whereby it was observed that sanction is not needed under Section 197(2) of the CrPC for the prosecution of the petitioner as his impugned conduct does not pertain to any of his official duties. "Having noted the basis of the impugned judgment, we see no reason to interfere with the same and accordingly, the Special Leave Petition is not entertained." the bench said. The top court, however, clarified that the trial court



should not be influenced by observations in the high court's order. "The observation made in the impugned order for the purpose of examining the issue of sanction should not prejudice either the prosecution or the defence, in the proceedings before the trial court, the bench said.

Supermassive black hole discovered for the 1st time

New Delhi, March 30: Astronomers have discovered one of the biggest black holes inside a galaxy hundreds of millions of light years from Earth, through gravitational lensing for the first time, throwing the field open for detecting more black holes and in-

vestigating their origins. Gravitational lensing is where a foreground galaxy bends the light coming from a more distant object and magnifies it.

The researchers, led by Durham University, UK, by closely examining how light is bent by the black hole, found an ultramassive black hole with a mass of over 30 billion times the mass of our Sun in the foreground galaxy - a scale rarely seen by asThe researchers found an ultramassive black hole with a mass of over 30 billion times the mass of our Sun in the foreground galaxy

tronomers, they said in a study.

The findings are published in the journal Monthly Notices of the Royal Astronomical Society. This is the first black hole found using the technique, whereby the team simulated light travelling through the universe hundreds of thousands of times, they said.

They also said that each simulation included a different mass black hole, which changed light's journey to Earth.

A representational image of a black hole

When the researchers included an ultramassive black hole in one of their simulations, the path taken by the light from the faraway galaxy to reach Earth matched the path seen in real images captured by the Hubble Space Telescope, they said.

A gravitational lens occurs when the gravitational field of a foreground galaxy appears to bend the light of a background galaxy, mean-

ing that we observe the background galaxy more than once. The lens also magnifies it, allowing scientists to study it in enhanced detail. "Most of the biggest black holes that we know about are in an active state, where matter pulled in close to the black hole heats up and releases energy in the form of light, X-rays, and other radiation.

ing makes it possible to study inactive black holes, something not currently possible in distant galaxies.

"This approach could let us detect many more black holes beyond our local universe and reveal how these exotic objects evolved further back in cosmic time," said tentative and will depend on availability. London, March 30: Former IPL chief Lalit Modi, accused of financial irregularities in India, launched a scathing attack on Rahul Gandhi on Thursday and threatened to take the senior Congress leader to court in the UK over his 'Modi surname' remark. Lalit Modi, 59, also hit out at the Congress party for referring to him as a "fugitive of justice" even though he had never been convicted of any charges.

In a series of tweets, which lacks punctuation and grammar, Lalit Modi also hailed himself as the man behind the "greatest sporting event in this world," claiming that it has generated close to USD 100 billion. He also posted images of his grandparents to say that his family has done more for India

than the Gandhi family. "I see just about every Tom, Dick and Gandhi associates again and again saving I am a fugitive of justice. Why? Pak passes bill to curb powers

Islamabad: Pakistan's Parliament Thursday passed a bill to curb the powers of the chief justice of the Supreme Court regarding suo motu cases and the constitution of benches, in a significant move to rein in the top judiciary amid criticism by the Opposition. Minister for Law and Justice Azam Nazeer Tarar introduced 'The Supreme Court (Practice and Procedure) Bill, 2023' on Thursday in the Senate, a day after it was passed by the National Assembly - the lower house of the parliament. There were 60 votes in favour of the bill and 19 against it. The bill will now be presented to President Arif Alvi for his assent. If the president does not give his approval within 10 days, it will be deemed to have been given.

Nine dead after helicopters crash

Fort Campbell (US), March 30: Nine people were killed in a crash involving two Army Black Hawk helicopters in Kentucky, a military spokesperson said.

Nondice Thurman, a spokesperson for Fort Campbell, said Thursday morning that the deaths happened the previous night in southwestern Kentucky during a routine training mission.

A statement from Fort Campbell says the two HH-60 Black Hawk helicopters, part of the 101st Airborne Division, crashed around 10 p.m. Wednesday in Trigg County, Kentucky.

The 101st Airborne confirmed the crash about 30 miles (48 kilometres) northwest of Fort Campbell. The crash is under investigation. "Right now our focus is on the Soldiers and their families who were involved." the statement added.

Kentucky Gov. Andy Beshear had said earlier that fatalities were expected, adding that police and emergency officials were responding."The crash occurred in a field, some wooded area,' Kentucky State Police Trooper Sarah Burgess said at a news briefing. "At this time, there are no reports of residence damage.

Fort Campbell is located near the Tennessee border, about 60 miles (97 kilometres) northwest of Nashville, and the crash occurred in the Trigg County, Kentucky, community of Cadiz. New Delhi, March 30: Embattled Adani Group is looking at a 20 per cent growth in earnings across businesses spanning from sea ports to airports, edible oil and commodities, energy, cement and data centres, to repay about \$23 billion of debt over the next 3-4 years in a comeback strategy, sources said.

Adani group executives have met bankers, bond holders, analysts and investors from Singapore to the US in the last three weeks to address stakeholders' concerns in the aftermath of a damning US short seller report that ripped off \$135 billion in market value of listed companies of the conglomerate.

Sources aware of the development said Adani at these roadshows presented the growth story of the sprawling conglomerate that is refocusing its energies on higher efficiency in business and bringing down debt rather than breakneck speed expansion.

The group saw a 20 per cent growth in EBITDA or earnings before interest, taxes, depreciation, and amortization, helping it pare debt. Between 2013 and 2022, earnings grew by 22 per cent year-onadar

year. And a 20 per cent growth will help bring down the debt-to-EBITDA ratio from 7.6 per cent to 3 per cent by 2025, they said

Debt/EBITDA is a ratio measuring the amount of income generated and fund available to pay down debt before covering interest. taxes, depreciation, and amortization expenses. Debt/EBITDA measures a company's ability to pay off its incurred debt. A high ratio Adani group's current EBITDA stands at ₹61,200cr while its net debt stood at ₹1.89L-cr (about \$23bn)

Since then, it has repaid \$500mn of debt and will repay most of the remaining debt in the next 3-4 years using earnings growth

About 37% of current debt is in bonds. 31% is owed to public sector banks and another 8% to private Indian banks

result could indicate a company has a too-heavy debt load.

Sources said the company management told investors that once the revenue increases, the debt ratio will come down.

In the January 24 report, Hindenburg Research had flagged "substantial" debt levels at the group while alleging accounting fraud and the use of offshore shell companies to inflate stock prices.

While the group denied all Hindenburg allegations, calling them "malicious", "baseless" and a "calculated attack on India", the report triggered a run on stocks of 10 group companies. Group's founder and chairman Gautam Adani, 60, a first-generation entrepreneur, was third richest in the world before the Hindenburg report. He now is ranked at No 21.

Prior to the Hindenburg report, CreditSights, a Fitch Group unit, had in September last year stated that the group was "deeply overleveraged" as it used debt to expand an empire centred on ports and coal mining to include airports, data centres and cement as well as green energy.

The comeback strategy revolves around focussing on bringing efficiencies in operations, suspending debt-driven new projects and

reining in expenses. It has already suspended work on a \$4-billion greenfield coal-to-polyvinyl chloride project at Mundra in Gujarat. scrapped a \$850-million coal plant purchase, decided not to bid for a stake in state-backed energy trading firm PTC, and is dialing back on aluminium and steel projects. Promoters have already paid

off all of the \$2.15 billion loans taken pledging their shares in the conglomerate. This followed Adani March 2 selling shares worth \$1.87 billion in flagship incubating firm Adani Enterprises Ltd, Adani Ports and Special Economic Zone Ltd, Adani Transmission and Adani Green Energy Ltd (AGEL) to GQG Partners.

Sources said the group's dollar debt is hedged and the recent interest rate hikes have no impact on debt costs and servicing.

is in force till March 31, 2022. The term of the previous five year policy had ended in March 2020. However, it has been extended repeatedly in wake of Covid outbreak and resulting lockdowns.

The last extension was given in September 2022 till March 31, 2023. Goyal will announce the foreign

trade policy which is expected to outline the vision statement for taking India's goods and services exports to \$2 trillion by 2030.

The country is likely to end this fiscal year with total exports of \$760 billion as against \$676 billion in 2021-22

India's trade has been hit by supply chain disruptions and slowdown in global trade amidst ongoing Russia-Ukraine war. Sources said the new policy is

likely to incorporate WTO-compliant export promotion measures. Speaking at an event in Mumbai, Goyal said that amidst all the eco-

nomic challenges faced by many countries, India is the bright spot, which almost everybody recognises and respects.



FUND RAISE THROUGH IPOs MORE THAN HALVES TO ₹52,116CR IN FY23 FROM AN ALL-TIME HIGH COLLECTION OF ₹1,11,547CR IN FY22

Mumbai, March 30: The total amount raised through initial public offerings (IPOs) more than halved to ₹52,116 crore in FY23 from an all-time high collection of Rs 1,11,547 crore in the previous fiscal, according to Prime Database.

Pranav Haldea, managing director of Prime Database Group, said ₹20.557 crore which is 39 per cent of the total amount raised in FY23 was by LIC alone, without which the IPO fundraising would have been just ₹31,559 crore in the year. Yet, FY23 is still the third highest in terms of IPO fund-raise, he said. Overall public equity fundraising also dropped by 56 per cent to



₹76,076 crore in the reporting year from ₹1,73,728 crore in FY22.

While IPOs were worth ₹54,344 crore in the year, total fund raising through the capital markets stood at ₹85,021 crore, of which ₹11,231 crore were from the offer for sale route, ₹9,335 crore were from QIPs/InvITs/REITs of which Rs 1,166 crore were from InvITs/REITs, taking the total equity fund raising to ₹76.076 crore.

A total of ₹8,944 crore were mobilised through public bonds, taking the total through IPOs and bonds to ₹85,021 crore. As against this, FY22 saw ₹1,12,512 being raised from IPOs, ₹4.314 crore via SME issue, ₹14,530 crore through OFS. ₹28.532 crore through QIPs/InvITs/REITs of

firms hit the listing process in FY23, much lower than **53 IPOs in FY22**

which ₹13,841 crore were from InvITs/REITs, taking the total equity capital mop-up to ₹1,73,728 crore. The year also saw ₹11,710 crore being raised via public bonds, adding which the total capital markets funding reached ₹1.85.438 crore

However, despite being hit by the Covid pandemic, FY21 was the best in overall capital markets performance with the total fund mobilisation from the market scaling to an all-time high of ₹2,00,812 crore, boosted by a record ₹28,440 crore through OFS, ₹33,515 crore InvITs/REITs and ₹15,029 crore of FPOs including from SMEs.

The main-board IPOs included the country's largest ever issue by Life Insurance Corporation,

followed by Delhivery (₹5,235 crore) and Global Health (₹2,206 crore). The average deal size hit a high of ₹1,409 crore.

As many as 25 of the 37 issues came in just three months of the year (May, November and December) and the fourth quarter was the lowest in the last nine years. Only 2 of the 37 issues (Delhivery & Tracxn) were from new-age technology companies compared to five such companies raising ₹41,733 crore in FY22, pointing towards the slowdown in IPOs from this sector.

Overall public response was also moderate with only 11 issues receiving good response of over 10 times subscription and two of them got more than 50 times, while 7 issues were oversubscribed by more than 3 times. The balance 18 issues were oversubscribed 1-3 times.

In comparison to FY22, the response of retail investors also moderated with the average retail applications dropping to just 5.64 lakh from ₹13.32 lakh in FY22 and from 12.73 lakh in FY21. LIC got the highest retail applications (32.76 lakh) followedby Harsha Engineers (23.86 lakh) and Campus Activewear (17.27 lakh).

Miami Gardens, March 30: Sorana Cirstea advanced to her first semifinal of Miami Open-a WTA 1000 event - in a decade, beating Australian Open champion Aryna Sabalenka 6-4, 6-4 at the Miami Open.


LIFETIME BAN FOR TENNIS UMPIRE LONDON: A tennis umpire from

Fabián Carrero was found to have committed 16 breaches of tennis' anticorruption program across eight matches in tournaments held in the Dominican Republic in November and December 2019. Carrero manipulated the match scoring in a handheld device "to facilitate guaranteed betting wins on specific points," the International Tennis Integrity Agency said in a statement. He has been suspended since March last year while the case proceeded. He can no longer officiate or attend events organized by tennis governing bodies.

Spain-Serbia matchup in Davis Cup draw

LONDON: The draw for the group stage of the Davis Cup Finals set up a possible meeting between No.1 Carlos Alcaraz and No.2 Novak Djokovic as Spain and Serbia were placed in the group. Spain will host Group C, which also includes the Czech Republic and South Korea, in Valencia in September. The United States will face two-time champion Croatia along with Finland and the Netherlands in Group D. That group will be hosted by Croatia, although the city and venue has yet to be announced. Defending champion Canada, which won the tournament for the first time last year, is in Group A along with host Italy, Sweden and Chile. Group B consists of host Britain, last year's runner-up Australia, France and Switzerland. The top two teams in each group advance to the Final 8 tournament in Malaga, Spain, in November. Spain beat Serbia in last year's group stage, when neither Djokovic nor Spain's Rafael Nadal took part. Alcaraz, who reclaimed the No. 1 ranking from Djokovic this month, was in the Spain team last year but did not play against Serbia.
