## **Atiq's son, aide killed** Boat capsize: in UP police encounter Four missing

Lucknow/Jhansi, April 13: Gangster-turned-politician Atiq Ahmad's son Asad and an accomplice, both wanted in the Umesh Pal murder case, were killed in an encounter with the Uttar Pradesh Police in Jhansi Thursday, officials said.

"Asad and Ghulam were wanted in the Umesh Pal murder case of Prayagraj and were carrying a reward of Rs 5 lakh each. They were killed in an encounter with an UP STF team.' said Special Director General (Law and Order) Prashant Kumar.

"Sophisticated foreign made weapons were recovered from the accused. Further details are awaited," he said, adding the Uttar Pradesh Special Task Force team was led by deputy superintendents of police Navendu Kumar and Vimal Kumar.

The encounter took place on a day Ahmad was presented before the court of Chief Judicial Magistrate in Prayagraj in the murder case and was sent to 14-day judicial custody.

Visuals showed two bodies lying beside a motorbike at the site of the alleged encounter. An

ambulance later took them away

STF officials said Asad and Ghulam were on the run since the murder of Umesh Pal February 24. Several STF teams were pressed to track them down.

Thursday, they were trying to flee on a motorcycle when they were intercepted by an STF team in Jhansi, the officials said, adding they opened fire on the personnel and were killed in retaliatory firing.

Umesh Pal, a key witness in the 2005 murder case of then BSP MLA Raju Pal, and his two police security guards were shot dead outside his home in Prayagraj's Dhoomanganj area February 24 this year.

His wife Jaya Pal had filed a case on February 25 against Atiq Ahmad, his brother Ashraf, Asad, Ghulam and others.

Reacting on the news of encounter, Umesh Pal's family thanked Chief Minister Yogi Adityanath and the police administration.

'Whatever they have done is right. He (the CM) has punished the killer of his daughter's husband. I express my gratitude. He is like a father. Justice has been done," Jaya told the media, adding she hoped strict action would be taken against other accused.

Deputy Chief Minister Keshav Prasad Maurya congratulated the Uttar Pradesh Police and the STF for the action. "Nobody will touch you if you don't commit a crime. And nobody will be spared if they commit a crime," he told PTI.



#### FEMA case filed against BBC India

New Delhi, April 13: The Enforcement Directorate has registered a FEMA case against news broadcaster BBC India for alleged foreign exchange violations, official sources said Thursday, two months after the Income-Tax department surveyed its office premises in Februarv.

A deputy managing editor of the news company has deposed before the agency.

The ED has called for documents and the recording of statements of some company executives under provisions of the Foreign Exchange Management Act (FEMA), the officials said. The probe is essentially looking at purported foreign direct investment (FDI) violations by the company, they said.

February 14 this year, the I-T department conducted survey operations at the London-headquartered broadcaster's offices in Delhi and Mumbai as part of an investigation into alleged tax evasion. The survey went on for three days.

The action had led to a sharp political debate with the ruling BJP accusing the BBC of 'venomous reporting' while the Opposition questioned the timing - weeks after the broadcaster aired a two-part documentary, 'India: The Modi Question'.

## **Net shutdown in Sambalpur**

POLICE SEIZE PETROL BOMBS; 40 PLATOONS DEPLOYED TO MAINTAIN PEACE

Sambalpur/Jevpore, April 13: Internet services have been suspended for 48 hours in violencehit Sambalpur, while Section 144 has been imposed in Jevpore, though with some relaxations, as a precautionary measure on the eve of Hanuman Jayanti, Thursday. The state government suspended internet services in Sambalpur district from 10am, Thursday to check the spread of rumours which could incite fresh rioting after a Hanuman Jayanti procession a day before had turned violent. Some 43 persons have been detained so far for the violence which broke out Wednesday which also resulted in injuries to at least 10 police personnel including a policewoman. However, the number of civilians injured in the incident is yet to be made public. "The situation is critical and miscreants are circulating false and inflammatory messages through social media to disturb public order in Sambalpur district," the notification issued by Additional Chief Secretary, Home Department, DK Singh, prohibiting internet use and access in

In the wake of the Sambalpur violence, the Koraput district administration clamped Section 144, though with some relaxations, in Jeypore Sub-Division in view of possible breach of peace. The restrictions are in force from 3pm Thursday and will continue till 9am, April 20.

Bhubaneswar, April 13: The Chief Electoral Officer (CEO), Odisha Nikunja Bihari Dhal issued formal notification for byelection to Jharsuguda Assembly seat, Thursday.

The seat of Naba Kishore Das, in the Legislative Assembly of

Odisha, elected from 07–Jharsuguda Assembly Constituency has fallen vacant on

January 30, 2023 due to his sudden demise. The byelection is to be held for the purpose of filling the said vacancy, read the notification.

Byelection to the Assembly constituency will be held May 10 while the result will be declared May 13.

All three major parties in Odisha

BJD, BJP and Congress – have named debutants as candidates

for the bypoll The ruling Biju Janata Dal (BJD) was the first party to announce its candidate for the by-poll. The BJD has nominated slain Minister and late MLA Naba Kishore Das' daughter Dipali for the crucial byelection.

#### JHARSUGUDA BYPOLI

The Congress has nominated Tarun Pandey, son of ex-MLA of the area, Birendra Pandey, as its candidate for the byelection.

Similarly, the BJP has nominated its young leader Tankadhar Tripathy for the byelection. Tankadhar, a former state president of BJP Yuva Morcha, has been campaigning in the area follow-

ing the murder of Naba Das. Dipali and Tripathy have already begun campaigning in the Assembly segment following the demise of Naba Das.

BJD sources said Dipali's candidature is aimed at drawing sympathy votes. Eyeing for a good margin win, the BJD has appointed three very senior leaders and a

dozen of other leaders including ministers as observers for the bypoll. The party has prepared a strategy to reach each and every voter

of the constituency ahead of the voting day.



Portland (Maine), April 13: Somewhere in a remote stretch of forest near Maine's border with Canada, rocks from space crashed to Earth and may be scattered across the ground — just waiting to be picked up. A museum says it'll pay out a \$25,000 reward to whoever finds the remains.

The unusually bright fireball could be seen in broad daylight around noon Saturday, said Darryl Pitt, chair of the meteorite division at the Maine Mineral and Gem Museum in Bethel.

NASA said the falling meteors was observed on radar — a first for Maine - and witnesses heard sonic booms. The museum wants to add to its collection of Moon and Mars rocks, Pitt said, so the first meteorite hunters to deliver a 1-kg specimen will claim the \$25,000 prize.



According to Pitt, the fact that radar detected the fiery descent assures the meteorites can be found on the ground.

'With more people having an awareness, the more people will

NASA said on its website that the "meteorite masses calculated from the radar signatures range from 1.59g to 322g although larger masses may have fallen."

NASA said four radar sweeps found "signatures consistent with falling meteorites, seen at the time and location reported by eyewitnesses." The Maine Mineral and Gem Museum maintains an extensive collection of specimens, including the largest intact Mars rock on Earth.

The museum is asking meteorite hunters to brush up on what meteorites look like before searching, so they know what they're looking for, and avoid private property unless they have permission.

Pitt said the museum is also looking to purchase any other spec-He said the specimens "could easily be worth their weight in gold."

Now, the assistance has been hiked from ₹2,000 to ₹3,000 for rural areas and from ₹3,000 to ₹4,000 for urban and Puri Swarga Dwar.

To facilitate it, the state government has constituted a revolving fund of ₹15,000 in each gram panchayat.

It is worth mentioning that Harishchandra Yojna expenses are being met from the Chief Minister's Relief Fund (CMRF). So, in total, ₹10.19 crore has been sanctioned from the CMRF for the revolving fund of all panchayats across the state.

Gram panchayat extension officer or any other block-level extension officer has been given the responsibility to supervise this new process.

#### SAMBALPUR VIOLENCE

Bhubaneswar, April 13: Odisha BJP president Manmohan Samal Thursday urged the state government to form a high-level panel to probe the communal violence that erupted in Sambalpur Wednesday evening.

"A motorcycle rally taken out to mark Hanuman Jayanti celebrations in Sambalpur town was going on peacefully Wednesday evening. However, the manner in which some anti-social elements pelted stones, attacked people with swords, hit them with lathis, and burnt their vehicles was very painful and condemnable," Samal said in

a press statement here. More than 10 policemen and those who took part in the rally were injured in the incident.

"Who is disturbing peace-loving Odisha and why the state government is tight-lipped is a big question," Samal said.

"Though a day has passed since the incident, why is the Chief Minister, who also holds the home portfolio, silent?" the



BJP leader questioned. Though a few policemen were deployed for the rally, they remained silent spectators during the violence, the BJP leader alleged.

Samal also asked whether there is pressure on the police not to arrest the rioters from the ruling party.

The state BJP chief also said that if Odisha police are incapable, the state government should immediately request the Union government to deploy central forces. Similarly, senior BJP leader and

Union minister Dharmendra
Pradhan alleged that the law and
order situation has completely collapsed in Odisha.
"Police personnel getting in-

jured in a clash is a classic case of deterioration in the law and order

situation in the state," he said, adding that the Odisha government has failed to maintain law and order in Sambalpur, a city where Hanuman Jayanti celebrations are being held for a long time.

Not only the police, several civilians were also attacked and left injured in the incident, Pradhan said.

Reacting to Pradhan's statement, BJD spokesperson Shreemayee Mishra said, "The law and order situation is worse in the BJP-ruled states like Uttar Pradesh, Karnataka, Maharashtra and even in Madhya Pradesh from where Pradhan has been elected to the Rajya Sabha."

Such incidents are sensitive matters and should be dealt with restraint rather than by politicising them, Mishra said.

## 10 Sohela Bar Association members say sorry to SC

**New Delhi, April 13:** At least 10 members of Sohela Bar Association in Bargarh district have tendered unconditional apology before the Supreme Court for their involvement in strikes and picketing which resulted in disruption of court work.

Advocates Surendra Nath Panda, Bikash Chandra Bhoi, Sushanta Kumar Panigrahi, Rudradash Meher, Chandrakanta Barik, Ashok Kumar Barik, Bhubaneswar Barik, Mirza Akbar Beig, Raj Kishore Mahapatra and Birendra Panda submitted an affidavit in the apex court tendering unconditional apology.

The advocates submitted that the apology may be treated as an 'unequivocal condemnation of assault on the justice delivery system' that was manifested through agitations and resultant disruption of the courts. The advocates also submitted an undertaking that



the matter April 17.

Earlier, the Supreme Court had in February refused to consider the unconditional apology tendered by the advocates, allegedly involved in vandalism and strikes at district courts.

The SC had held that it is too early to consider these unconditional apologies and that it would watch if the apology is coming from heart or merely an attempt to escape contempt proceedings.

Along with the apology, the apex court had also directed the advocates to submit an undertaking that they would not indulge in any such acts in future.

Bhubaneswar, April 13: Railway Protection Force (RPF) officials Thursday seized suspected explosives from the general coach of Konark Express (Train no.11019) at Bhubaneswar Railway station during the wee hours of Thursday. Sources said the RPF has

launched an investigation after registering a case in this regard under Sections of 153,164 and 147 of the Railways Act.

The cleaning staffers of Bhubaneswar Railway station heard some sound from the general coach of Konark Express parked at Platform No-2 of the station. Later, they rushed to the coach and found smoke billowing out of the coach. Informed, ASI Sk A Salim of

RPF entered the coach where he spotted some plastic cylinder type materials lying scattered on the upper berth of the said general coach.

The RPF during checking found eight Red Parachute Signal Rockets, 15 Rocket Parachute Flares and one Path Finder Sart from the coach.

"On preliminary enquiry it came to notice that these are used for long range distress signaling on ships, life boats and life rafts," said the RPF sources.

The sniffer dog squad also reached the spot and conformed after examination that recovered

materials are highly inflammable. "We have taken serious note of the recovery of the suspected explosive from the train. We have been checking the CCTV footage of different stations to ascertain the accused carrying the materials in the express train, said Srinibas Patnaik, IIC RPF, Bhubaneswar.

## 'Attach Rose Valley's assets worth ₹6cr'

**Bhubaneswar, April 13:** The Odisha Protection of Interests of Depositors (OPID) court, Cuttack, has confirmed the ad-interim order issued by the state Finance department regarding attachment of movable and immovable assets worth over ₹6 crore belonging to M/s Rose Valley group in connection with a multi-crore chit fund scam.

The tainted group had allegedly collected more than ₹450 crore from gullible depositors across the state through various ponzi schemes.

The investors who were defrauded by the sham company had first filed a case (182/13) at Soro police station in Balasore May 10, 2013. Later, the Economic Offence Wing (EOW) of state Crime Branch took up the probe registering a case (15/13) in this regard a few days later.

The depositors had alleged in their complaint that Rose Valley Hotels and Entertainments illegally collected public money by promising high rate of interest even though they didn't have any permits from the regulatory authorities.

"The company was taking deposits camouflaging the same as advance payment for hotel booking under holiday package, while issuing provisional certificates. The Rose Valley group of companies, without any authorisation either from RBI or SEBI, was collecting public deposit under its different schemes with its 65 branches in Odisha alone," revealed EOW in a press note.

vealed EOW in a press note. The EOW submitted five chargesheets against M/s Rose Valley group of companies, its directors, Goutam Kundu and Sibamoya Dutta, regional, branch managers Bikramjit Bhoumik and Badal Kumar Kar under various sections of the IPC, PCMCS (Banning) Act, 1978, and the OPID Act.

The agency also unearthed large sections of movable and immovable assets acquired by the company directors through the firm or in their name using money illegally collected from the depositors. Later, EOW had sent three ad-interim proposals to the state government for attachment of the illgotten properties of the Rose valley group.

Subsequently, the state Finance department issued ad-interim orders for the attachment of properties. Out of the three orders, the 1st and 2nd ad-interim proposals had been made absolute earlier by the Cuttack OPID Court attaching assets worth 95 crore.

Notably, Subrata Mohanty worked as the special public prosecutor in this case.

Keonjhar, April 13: Forest officials Thursday arrested a youth from Bansapal block in Keonjhar district on charge of keeping an endangered parakeet as his pet after he uploaded a video of his pet parrot on YouTube.

The accused was identified as Chinmay Mohanta, 25, of Kumundi village under Bansapal block in the district. He was arrested by the Forest department on charges of violating the Wildlife Protection Act, 1972.

Forest officials said that it is an Alexandrine parakeet which is listed on Schedule-2 of Wildlife Protection Act, 1972. Mohanta is accused of preparing videos of the bird and uploading them on social media platform such as YouTube. In one of the videos uploaded on

YouTube, Mohanta is seen teaching the bird to speak while in another he is seen giving tips on how to hold the bird without getting bitten. The video came to the notice of honorary wildlife warden

ACF Ashok Kumar Das said a case has been registered at forest range office at Bhuyan-Juang Pidha range and the bird was seized along

with its cage. The accused youtuber has been arrested and the mustard oil, a mobile phone, and an iron rod have also been seized in this connection.

Keonjhar DFO HD Dhanraj confirmed the development and said an investigation was conducted and the video Mohanta had uploaded on YouTube was checked thoroughly before arresting him and seizing the bird.

Mohanta admitted to his wrongdoing stating that he will not repeat such mistakes in future.

Notably, Keonjhar district is covered by dense forests and has numerous species of birds including parrots in its jungles. These parrots build nests on big trees and lay their eggs. Poachers catch these birds alive and sell them in local markets to interested people at prices ranging from ₹200 to ₹500. The birds are also smuggled outside the state for a premium. With the Forest department turning a blind eye to such incidents, unabated poaching of these rare birds has led to a decline in their population.

Keonjhar: The body of a missing 8-year-old boy was recovered Wednesday. Evidence of Russian atrocities in Ukraine - including murder, rape. torture, and attacks on civilians, civilian infrastructure, and other non-military targets - continues to accumulate. Just last month, a United Nations-backed inquiry published a report accusing Russia of war crimes and possible crimes against humanity. While the ICC indictment is unlikely to be the only legal action brought against Putin and his cronies, it is the first. The ICC prosecutor has ensured that Putin will go down in history as the first leader of a permanent member of the UN Security Council to be indicted for an international crime.

The move is not merely symbolic. Those who think imprisoning Putin is an impossibility should recall that Liberian war criminal Charles Taylor is currently serving a 50-year sentence in a British prison, and former Serbian leader Slobodan Milošević died in prison in The Hague while on trial for war crimes. And those who think that the arrest war-

rant will have no impact on the accused should take note of reports of growing dissent within Putin's leadership cabal, with insiders no doubt fearing that they will soon face indictments as well.

Admittedly, while the ICC president has moved unusually quickly and issued a statement of intent to arraign Putin in The Hague, Putin is unlikely to leave himself open to arrest by entering any of the 123 states that are signed up to the ICC. Sadly, Russia does not recognise the ICC (nor does the United States). So, given that US President Joe Biden has welcomed action, despite opposing the ICC, how can the world add to the pressure on Putin and his cronies?

The crime of aggression - beginning with the invasion of Crimea in 2014 - is Putin's "original sin," the font of all the recent atrocities. As University College London law professor Philippe Sands has argued, aggression would be more straightforward to prosecute than war crimes and crimes against humanity, because it can be linked directly to the Kremlin.

The ICC's mandate does not extend to prosecuting the crime of aggression, but a special international tribunal can be created with an ex-

plicit focus on this "leadership crime." The tribunal's work would complement and give weight to that of the ICC.

The encouraging news is that all major European countries, as well as the European Union and the Council of Europe, have endorsed Ukrainian President Volodymyr Zelenskyy's request that Putin and his circle be prosecuted for the crime of aggression. A tribunal could be constituted in the coming months.


But American support will be vital to the success of such a tribunal. Biden need not fear that supporting an investigation into Putin would tilt the scales - which he has so carefully calibrated - from support for Ukraine's defense to active aggression against Russia. After all, the US has regularly supported special tribunals - notably for Cambodia, Lebanon, Rwanda, Sierra Leone, and the former Yugoslavia - to prosecute international crimes. And US prosecutors were at the forefront of the Nuremberg trials, carried out by the International Military Tribunal to prosecute and punish leading Nazis after World War II. The same went for the International Military Tribunal for the Far East, which carried out the "Tokyo trials" of Japanese war criminals.

Both tribunals were founded upon the 1941 Declaration of St. James's Palace. or London Declaration, in which the Allied powers agreed that there would be no safe haven for those guilty of aggression. This would likewise form the basis of the special tribunal tasked with investigating and prosecuting Putin.

Concerns that such a tribunal would open the door for prosecutions relating to conflicts like the Iraq War are also unfounded. The special tribunal on crimes of aggression in Ukraine would be a response to Zelenskyy's explicit request, made on behalf of Ukraine's government and people. The tribunal's authority would be derived from Ukrainian law, together with the prohibition on crimes of aggression inherent in international law. And the body would focus exclusively on the situation in Ukraine, where the evidence of wrongdoing arguably - and unlike in many other conflicts - meets the very high standard of proof required. Nor will the prospect of a trial make Putin less willing to contemplate peace talks. I dealt directly with him, as both finance minister and prime minister of the United Kingdom, not least over the assassination in 2006 of the UK-nationalised Russian defector Alexander Litvinenko. Those experiences taught me that the only language Putin understands is that of power. He will not view pulled punches as an olive branch worth taking, but as yet more appeasement born of weakness In the face of Russian brutality, Ukrainians have stood united and fought valiantly. The rest of the world - led by the US - must show the same courage and resolve to ensure that justice is served, beginning with Russia's top leaders. America has willed the end-accountability for Putin and his cronies. Now it must join Europe in supporting the means.

it is customary to recall his legacy at seminars, lectures, and exhibitions. But this year, while remembering his passionate voice for social justice, we should also acknowledge the sense of trepidation that has come to haunt these celebrations. An apprehension has arisen that the political and social fronts of the Dalit movement have deviated from the core values the nationalist icon espoused and the critical engagements that shaped his life. Now, sixty-two years after Ambedkar's passing, we must acknowledge the tremendous changes in Dalit politics and society that led

to the present-day conditions. By the late 1920s Ambedkar got actively involved in Dalit politics. He had prescribed two paths through which Dalit could solve their socio-economic issues -- agitational politics and secondly, through parliamentary representations. While addressing the gathering in the Constituent Assembly in 1950 Ambedkar observed, "Political democracy cannot last long without social democracy. Social democracy means a way of life which recognises liberty, equality and fraternity as the principles of life." After 72 years, this idea still stands very much relevant.

After Babasaheb, under the able leadership of Kanshiram and Khaparde, the BAMCEF was constituted in 1973. The objective behind having this party was to unite SC, ST, OBC and minority employees and create a think tank of intellectuals to materialise the motto of 'pay back to the society' Subsequently, for the formation of Bahujan Samaj Party, Kanshiram made BAMCEF a shadow organisation in 1985. Consequently, Kanshiram could win the support of all members of BAMCEF and had considerable influence in Maharashtra and a huge fan base in Uttar Pradesh. After Kanshiram, BSP witnessed the leadership of Prakash Ambedkar in Maharashtra and Mayawati in Uttar Pradesh, but they have failed critically to have that influence among Dalit masses. The reasons could be ab-

sence of support from the Dalit community, lack of agency and recognition within the party. And when a situation like this arises, the leaders from the upper caste parties play their leadership role. It should be noted here that the Dalit intellectual class has been mute spectators to their sufferings and uncritical of the upper caste leadership. MC Rajah, a Member of

Legislative Council in 1922, first demanded reservation of seats for panchamas in government institutions, and local bodies and

municipalities. The demand for separate electorate and reservation of seats in legislative council, and local bodies has been brewing since the 1920s had first manifested in being represented in the Simon Commission. Yet the leaders had differed if it was just about representation from depressed classes or for a separate electorate. The Rajah-Moonje pact was a testimony to it, and was considered detrimental for the depressed classes. Later in 1932, Ramsay MacDonald Award was created to provide depressed class choices in the legislature of Provinces and extra vote in a special depressed class constituency. This later culminated in Poona Pact 1935 yielding reservation of seats for depressed classes. It was considered as a well-founded safeguard against discrimination on the basis of caste, religion and race, and has shaped reservation politics till now.

What about the need for representation to be decentralised? The leadership and recognition is being located at the few ghettos of power and policymaking. Decentralisation, not just in terms of effective distribution of public goods and services, but also of assertion, the voices of elected women representatives, being accepted and acted upon. Aren't the actual spaces of assignments turning into another battleground of favouritism and discrimination in governance? The burning issues of the present day go beyond the subjects of reservation, untouchability and representation to that of institutional suicide/killing, Dalit women getting raped and killed, and the very frequent death cases of septic tank workers. As per the data of Ministry of Social Justice and Empowerment, from 2017-2022, there have been 400

deaths of Dalit labourers. The representation has become purely lineage, family, urban, situated and mostly Delhi centric rather than representing diverse social, economic, political, regional backgrounds. Amidst all this, can we make the assertion if every house manual scavenger, cleaner of drains, trash picker, is part of these celebrations, or we remain entangled in the questions about which Dalit's interests?

In the 18th March 1956 speech in Agra, Ambedkar expressed his concerns about the plight of rural landless labourers and blamed the educated middle class Dalits for being self-centered and selfish. He warned the gathering by saying, "Today my position is like a pil-

lar, supporting huge tents. I am worried about the time when this pillar will not be in its place. Dadasaheb Gaikwad took this warning to heart and organised various land movements and led the Republican Party of India. It's noteworthy that RPI suffered from bifurcation twice. This fractured condition of Dalit movement gave rise to Dalit atrocities, unemployment issues and frustration amongst Dalits. The Dalit Panther Movement was an off-shoot of the resentment and disenfranchisement of the Dalit youth slum-dwellers. Raja Dhale and Namdev Dhasal were quite instrumental in organising the masses and they started posing questions to both Dalit and non-Dalit leaders. But with the passage of time they suffered ideological rifts within the movement. Gail Omvedt in her article titled 'Amebekar and after: The Dalit Movement in India' writes: "Dalit movement has failed to show the way to transformation because of late these movements are turning themselves into pres-

sure groups.' Post Independence, the Constitution had made certain provisions such as Article 16, 46, 335 to safeguard the interests of Dalits. women, children and minorities within democratic framework However, if we do an analysis of the data that was released recently by the Union Minister of State for Education we could find that 19,000 students from SC, ST and OBC cat egory have dropped out of institutes like IIMs, IITs and other Central varsities from 2018-2023. We keep revisiting history, but we all the time fail to acknowledge our own his torical mistakes that still haunt a large section of the society.

It will be a meaningless tribute to Babasaheb if we ignore the rudimentary questions of caste, egalitarian social order, social democracy. The present times require renewal of Bahujan autonomy, assertion and inclusion of Dalit independent movement with varied issues, then only we would be able to fulfil the dreams of Ambedkar of a more democratic

#### Haptic

his is a good example of a relatively unusual scientific word that in recent years has become more widely known through a specific use. It refers to the sense of touch or tactile sensations. It appeared near the end of the nineteenth century, at first as a medical term. It was coined from the Greek haptikos, able to sense or touch, which derives from the verb haptein, to fasten. It's closely related to the rare English prefix hapto-, as in haptotropism for the reflex action in plants such as honeysuckle or bindweed that causes them to twist around objects they touch. At one time, people most often came across the word in connection with hard contact lenses, which were described as *haptic* because they were moulded exactly to fit the shape of the eyeball. In the past couple of decades, haptic has become more widely used in the world of immersive virtual-reality computer systems by those who design techniques and tools that reproduce the sense of touch. Joysticks and the like are now being designed so that they feed tactile information back to the user about the way the system is functioning. An object that has been visualised on a computer may soon be capable of being felt as well as seen. Such tools are commonly known in the business as haptic devices.

**THE INDIAN** PATENTS ACT **CONTAINS SOME** IMPORTANT **SAFEGUARDS DESIGNED TO ENSURE THAT FRIVOLOUS PATENT APPLICATIONS ARE NOT GRANTED AT THE COST OF PUBLIC HEALTH** 

n 23 March, 2023, the day before the World Tuberculosis (TB) Day, the Indian Patent Office rejected the Johnson and Johnson's (J&J) patent application to extend its patent on Anti-TB drug, Bedaquiline, beyond July this vear. The World Health Organization has introduced Bedaquiline as standard treatment in 2018 for treatment of resistant TB. The patent of the parent molecule is scheduled to expire in July and the company has been attempting to prolong its monopoly by claiming a patent of its salt which the Indian Patent Office has now rejected. This is evergreening of patent.

Before the introduction of Bedaquiline, it was a long and tormenting treatment for drug resistant TB. Twenty months long treatment with serious adverse effects including permanent hearing loss and psychosis was the practice. Bedaquiline based treatment is short and devoid of adverse effects associated with multi-drug resistant TB treatment. India along with China and Russia contributes more than the half of the global multi-drug resistant TB cases. There are an estimated 130,000 cases of drug resistant TB every

year and less than 30% of these patients are in appropriate treatment. Government (National TB Elimination Programme) procures Bedaquiline at a cost of \$350 for a six month course. This is not available for private use. The cost is expected to come down once generic manufacturers are permitted to manufacture making the treatment 80% cheaper.

J&J filed the patent application for Bedaquiline fumarate salt along with the Tween 20, a known wetting agent in 2009. It is very interesting to note that two surviving TB patients: Nandita Venkatesan, a twotime TB survivor, and Phumeza Tisile, TB survivor from South Africa, filed pre-grant opposition in 2019. On hearing both parties, the patent office rejected the secondary patent of Bedaquiline fumarate on the ground of lack of inventive step. The fumarate salt was already mentioned in the earlier patent application. The use of Tween 20 as a pharmaceutical wetting agent is well known. While rejecting the patent claim of J&J, the patent office observed that there is no proof of fumarate salt of Bedaquiline and Tween 20 provides better therapeutic efficacy. The company has

shown improved bioavailability and improved bioavailability is not same as improved therapeutic efficacy. The Indian Patents Act contains some important safeguards designed to ensure that frivolous patent applications are not granted at the cost of public health. These include Section 3(d) of the Patents Act, which prevents many "new forms" of known substances from being patented unless there is a significant improvement in efficacy and Section 3(e) of the Act. which prevents "mere admixtures" of substances from being patented. The patent claim of the company is rejected based on Section (d) and 3 (e) of Patent Act. This is the health safeguard the Indian rule

makers kept in the Act. Worldwide TB is the leading cause of death and 1.6 million people died from the disease in 2021. Bedaquiline is the lifeline of TB treatment. Prior to introduction of this medicine, for almost 50 years there was no new anti-TB drug. It was not the investment of the company alone that has contributed to the development of Bedaquiline. there have been many public funding for its development and clinical trial. The public funding is reported to be five times more than J&J's investment in developing this drug. The company did not consider the public funding but continues its attempt to monopolise the drug. The order has broken the monopoly of a company over the life saving medicine. Had the company won the case, patent protection would have extended until 2027, further delaying the prospects of generic version.

The decision of the patent office is widely hailed and this would help the introduction of generic version. In addition to immediate benefit to TB patients of reduction of cost of resistant TB treatment, the recent patent office's ruling would encourage the patient groups to fight against the monopoly of big pharmaceutical companies' attempt to go for evergreening of patents, even if there is no support from others including the generic pharmaceutical companies. Patients' interest prevailed over profit of patents. This would help the country to eliminate TB well before the target of Sustainable Development Goal. 2030

#### Solar power boost

Sir, India's solar energy market is the third-largest globally, with a capacity of over 64,380 MW as of February 28, 2023. The Indian government has implemented policies and initiatives to promote solar energy, including subsidies, tax incentives, and net metering policies. The Kisan Urja Suraksha Evam Utthaan Mahaabhiyan (KUSUM) scheme aims to install 30.8 GW of solar capacity by 2022 for farmers. Under KUSUM, farmers are incentivised to install solar panels on their farmland, generating electricity for their own use and selling excess power to the grid. The scheme provides a 30% subsidy for solar pumps and financial support for grid-connected pumps. India is expected to install 16.8 GW of new solar capacity in 2023, including 14 GW of utility-scale solar projects and 2.8 GW of rooftop solar projects. India has introduced policies to encourage development of solar parks and net metering for rooftop solar installations. Various schemes support installation of solar panels in public buildings and agricultural fields. Ministry for New and Renewable Energy has stated that by 2026, India will have the capacity to manufacture solar modules worth 100 GW per year, making India a net exporter of solar power. Lucknow, April 13: Gangsterpolitician Atiq Ahmad's son Asad and an accomplice, both wanted in the Umesh Pal murder case, were shot dead in an exchange of fire with the Uttar Pradesh Police near Jhansi Thursday, officials said.

The alleged encounter took place apparently at the time Ahmad was in a Prayagraj court, where he was presented before the Chief Judicial Magistrate in connection with the same murder and remanded to 14-day judicial custody. The court also allowed a five-day remand for the UP Police to question him.

The Samajwadi Party and the Bahujan Samaj Party have demanded an investigation into the Jhansi shootout, suggesting that the state's Special Task Force staged a fake encounter.

Two other men have been shot dead in separate encounters with police since February 24, when Umesh Pal, a key witness to a 2005 political murder; and two policemen deployed to protect him were killed by gunmen in Prayagraj.

Atiq Ahmad, a former SP legislator, had earlier expressed apprehension that he himself could be killed by UP Police while being brought to Prayagraj from the Ahmedabad prison, where he was lodged in connection with another case. When he was being taken to



the city for Thursday's court appearance, he made a similar remark. The officer said a British Bulldog revolver and a Walther pistol were recovered.

Deputy Chief Minister Keshav Prasad Maurya also praised the STF and the UP Police. "Nobody will touch you if you don't commit a crime, and nobody will be spared if they commit a crime," he told PTI. Umesh Pal's family thanked Aditvanath and the police.

"Whatever they have done is right,' his wife Jaya Pal told reporters. Terming Adityanath a father figure, she said, "He has punished the killer of his daughter's husband. I express my gratitude," she said. "Justice has been done."

Umesh Pal's mother said, "The two gunners who were killed in broad daylight today had committed a sin. They have been punished today. We have faith, we will get complete justice." SP president Akhilesh Yadav slammed the state government. "By conducting fake encounters, the BJP government is trying to divert attention from real issues. The BJP does not believe in courts at all. Today's and other reoughly investigated and the culprits not spared," he tweeted in Hindi. "Those in power do not have the right to decide what is right or wrong. The BJP is against brotherhood," Yadav said.

BSP leader Mayawati linked the Jhansi encounter to the gunning down in 2020 of gangster Vikas Dubey, who had allegedly planned the ambush and killing of eight policemen in Kanpur.

She said a high level inquiry is necessary to get at the truth of Thursay's encounter. After the Umesh Pal murder, Akhilesh Yadav had flagged the law and order issue in the state assembly.

In the heated debate, CM Adityanath had then accused his party of "garlanding" gangsters like Atiq Ahmad and said the government will ground the mafias to dust ("mittee me mila denge")

In February and March, two men who allegedly took part in the Prayagraj shooting were gunned down in separate police encounters. One of them, Arbaaz, allegedly drove the car in which the gangsters came to kill Umesh Pal. The other, Usman, was allegedly among those who fired at him.

#### Atig has admitted to links with ISI, Lashkar: **UP** police chargesheet

PRAYAGRAJ: Gangster-turnedpolitician Atiq Ahmad has confessed that he has direct connections with Pakistan's Inter-Services Intelligence (ISI) and terror outfit Lashkar-e-Taiba, as per the chargesheet filed by UP Police.



"I have no dearth of weapons because I have direct connections with Pakistan's ISI and terror or ganisation Lashkar-e-Taiba. Weapons from Pakistan are dropped on the Punjab border with the help of drones and local connections collect them. Terrorists in Jammu and Kashmir get weapons from this consignment. If you take me with you, I can help you recover that money, arms and ammunition used in the incident," the chargesheet mentions Atiq Ahmad as saying.

This is bound to increase troubles for the gangster whose entire family is listed as his gang members.

The Chief Judicial Magistrate's court Thursday sent Atiq Ahmad and his brother Ashraf to four-day police custody in the Umesh Pal murder case. The police custody of the duo started from 5 p.m. April 13 till 5 p.m. April 17. On March 28, Atiq Ahmad was convicted by an MP-MLA court and sentenced to rigorous life imprisonment in the abduction case of now-dead Umesh Pal.

## ASAD AHMED Oppn demands probe SC slams Lalit Modi over post on judiciary

**SENIOR ADVOCATE AM SINGHVI SAYS THE FORMER CRICKET ADMINISTRATOR MUST PUBLISH HIS APOLOGY ON ALL SOCIAL MEDIA** ACCOUNTS

New Delhi, April 13: The Supreme Court Thursday came down heavily on ex-IPL commissioner Lalit Modi over his remarks against the judiciary made in social media posts and directed him to tender an unconditional apology on social media platforms and national newspapers.

Observing that Modi is not above law and the institution, a bench of Justices MR Shah and CT Ravikumar warned any repeat of such conduct will be viewed verv seriously.

The apex court also directed him to file an affidavit before it tendering an apology and stating no such posts will be made in future which would tantamount, even remotely, to tarnishing the image of the Indian judiciary.

"We have gone through the counter affidavit filed by the respondent (Modi). We are not at all satisfied with the explanation given. We are of the view even the clarification would tarnish the image of the judiciary.

"Counsel for respondent A M Singhvi has stated at bar that an unconditional apology would be tendered in all social media where he has followers and leading newspapers at Delhi, Mumbai, Bangalore, Madras and Kolkata editions," the bench said while posting the matter for further hearing April 24.

At the outset, senior advocate Ranjit Kumar, appearing for CU Singh who has filed the contempt plea, submitted that Modi had made a tweet March 30, 2023 which tarnished the image of judiciary. He made scandalous remarks against judges and the apology expressed is to avoid punishment, Singh said. Claiming Modi has three million followers on Twitter and four million on Instagram, Singh said the former cricket administrator must publish his apology on all social media accounts.

As senior advocate AM Singhvi, representing Modi, started making his submissions, the top court made scathing observations against the ex-IPL boss.

The bench said, "What does he mean by the statement that judges are in pockets of so and so? Does he think that the judiciary is weak? Where is the apology to the court? First you file an unconditional apology.

Otherwise you are in contempt. Apology must be made in public. He should say I have trust in the Indian judiciary.



Bahubali is now spotted even during day time at Samayapuram village in Mettupalayam area of Coimbatore district.

R. Velmurugan, a farmer at Samayapram, said, "Bahubali created havoc here two years before and the forest department had then tried to capture him, but it did not

materialise. However, now it has come back after two years and is spotted even during day time. We demand the forest department to capture the elephant.

The wild tusker, according to Mettupalayam range forest officials is moving inside the forest area adjacent to Samayapuram, Nellithurai and Nellimalai.

Forest officials said that the animal has come out of the forest land in March even as water is available in the forest area where it is located. The forest department said that it was studying the behavioural practices of this particular elephant. Maize is a major attraction for the elephant and it is grown in good quantities on the banks of the Bhavanisagar river in the Mettupalayam area.



Delhi government counsel Santosh Kumar Tripathi said the government is providing books and study material, and from the next academic session, it would also give uniforms to the students. The government lawyer stated from next year the heads of schools can procure uniforms from the market after a survey has been carried out and the cost approved by the authorities. In the meantime, it would provide cash for the purchase of uniforms.

"You are not supposed to pay in

the matter, said a paltry sum of Rs 1,500 was given annually to the EWS category students which "makes a mockery of the EWS children". The same amount was also reimbursed to private unaided schools, the lawyer said.

Maintaining that Delhi is not special and must comply with the mandate of law on providing aid to EWS students, the court asked when certain schools were providing uniforms to EWS students why can't the government.

'We will ensure uniforms are supplied. We will monitor this," the bench, also comprising Justice Subramonium Prasad, said and listed the case for further hearing on August 25. In August 2014, the high court had said it was the duty of the state government and the schools to ensure that free textbooks, uniforms etc are made available to children belonging to the EWS category.

It had then noted that out of 68,951 EWS category children studying in private schools in session 2014-15, roughly about 51,000 children were without textbooks and uniforms. The high court had observed that such a situation was "wholly unacceptable".

Senior advocate Mukul Rohatgi representing the Vokkalinga and Lingayat community members, strongly opposed any interim order in the matter. Rohatgi said unless something is going to happen, it would be highly unfair if stay is granted.

New Delhi, April 13: Time-restricted fasting, an eating pattern whereby people limit their food consumption to certain hours of the day. could cause fertility problems, according to a new research conducted in zebrafish.

The research team, led by University of East Anglia (UEA), UK, also said that it was important that they observed some of the negative effects on eggs' and sperms' quality after the fish returned to their normal levels of food consumption.

They further said that despite being conducted in fish, the study



highlighted the importance of considering not just the effect of fasting on weight and health, but also ple are doing it to lose weight and on fertility. The study is published in the journal Proceedings of the organisms respond to food shortages Royal Society B. can affect the quality of eggs and

sperm, and such effects could potentially continue after the end of the fasting period," said Alexei Maklakov, professor from UEA's School of Biological Sciences.

To find out what happened when individuals were exposed to food during and after a period of fasting, the researchers measured how males and females zebrafish (Danio rerio) allocate resources to body maintenance versus production and maintenance of sperm and eggs. They also studied the quality of the resulting offspring.

'What we found is that timerestricted fasting affects reproduction differently in males and females. Once the fish returned

to their normal feeding schedule, females increased the number of offspring they produced at the cost of egg quality resulting in reduced quality of offspring. The quality of male sperm also decreased.

"These findings underscore the importance of considering not just the effect of fasting on body maintenance but also on the production of eggs and sperm," said Edward Ivimey-Cook, from UEA's School of Biological Sciences. He also said that more research was needed to understand how long it took for sperm and  $\operatorname{egg}\nolimits \operatorname{quality}$  to return back to normal after the period of fasting.

"Also, we cannot send any documents to our consulates, Gerry s, or to your home address. We understand that this will cause inconvenience. However, the safety of our applicants and staff members is of the highest priority," it said. The notice also stated that any questions regarding the re-opening of the mission cannot be answered at the moment.

## Lanka may export 1,00,000 endangered monkeys to China

Colombo, April 13: Cash-strapped Sri Lanka is exploring the possibility of exporting 1.00.000 endangered monkeys to China, one of its largest bilateral lenders, the agriculture minister has said.

The toque macaque is endemic to Sri Lanka and classified as endangered on the International Union for Conservation of Nature (IUCN) red list. Sri Lanka's agriculture minister Mahinda Amaraweera has asked officials to study China's request to procure toque macaques, news portal Economy Next reported on Wednesday.

"They want these monkeys for their zoos," the minister was quoted as saying. The minister said the request for 1.00.000 monkeys to be exhibited at over 1,000 Chinese zoos could be considered, given the large macaque population in the country, the report said.

been made at a time when the local authorities have taken several measures to contain the monkey population, the report said. Sri Lanka bans almost all live animal exports and the proposed sale comes at a time when the country faces its worst-ever economic crisis.

The country, however, removed

several species from its protected list this year, including all three of its monkey species as well as peacocks and wild boars, allowing farmers to kill them. Sri Lanka will look to fulfill this request from China considering that Beijing is one of Sri Lanka's biggest bilateral lenders.

China on Wednesday said it was willing to negotiate a medium and long-term debt disposal plan with Colombo in a "friendly manner" to enable the crisis-struck island nation to achieve debt sustainability. Chinese Foreign Ministry spokesperson Wang Wenbin said Beijing was committed to waiving off the principle and the interest of the debt for two years.

"As a bilateral official creditor, the Export-Import Bank of China has clearly stated in the financing support document issued to the Ministry of Finance of Sri Lanka

that it will extend the maturity of Sri Lanka's debts due in 2022 and 2023," Wang said.

In January this year, China gave debt-ridden Sri Lanka the financing assurances required by the International Monetary Fund (IMF) to unlock the bailout package, days after India strongly backed the island nation's efforts to secure the loan from the global lender to recover from its worstever economic crisis.

In March, the IMF approved a USD 3 billion bailout programme to help Sri Lanka overcome its economic crisis and catalyse financial support from other development partners, a move welcomed by Colombo as a "historic milestone" in the critical period. The IMF bailout, the 17th in Sri Lanka's history, was approved following prolonged discussions over Colombo's unsustainable debt.

Indian startups raised a total of \$2.8 billion in funds in the first quarter of 2023, a massive 75 per cent decrease compared to the same period in the previous year (\$11.9 billion), as rising inflation and interest rates continue to impact investments significantly amid a deepening funding winter.

There were no new unicorns created in the January-March period, compared with 14 unicorns in Q1 2022, according to the report by Tracxn, a leading global market intelligence platform. The funding volumes contracted due to the reduction in latestage funding, which declined by 79 per cent in the first quarter (\$1.8 billion) compared to Q1 2022.

Early-stage rounds saw funding of \$844 million, a drop of 4 per cent compared to Q4 2022 but a drop of 68 per cent compared to Q1 of 2022. Late-stage rounds in Q1 of 2023 saw funding of \$1.8 billion. a decline of 79 per cent compared to Q1 of 2022 and a 23 per cent drop compared to Q4 last year.

"I am delighted to share with you the outstanding export performance for 2022-23, with India's overall exports scaling new heights at \$770 billion, registering 14 per cent growth over the previous year and



#### China's share in import basket dips

China's share in India's import basket has declined to 13.79 per cent in 2022-23 from 15.43 per cent a year ago, with inbound shipments of major items like fertilisers and electronic goods coming from alternative markets, the Commerce Ministry said Thursday. However, in absolute terms, the total imports from China increased to \$98.51 billion during the financial year ended March against \$94.57 billion in the previous fiscal. India's exports to China fell to \$15.32 billion in FY23 from \$21.26 billion a year ago, showing a negative growth of nearly 28 per cent, the data showed. Imports of electronic goods from China have seen a year-on-year decline of around \$2 billion in 2022-23 (April-February). Import share from China in electronic goods has also declined from 48.1 per cent in 2021-22 (Apr-Feb) to 41.9 per cent in 2022-23 (Apr-Feb). Imports have been shifted towards Singapore, South Korea and Vietnam. A significant fall in share from China was seen in imports of fertilizers -- from 21.9 per cent in 2021-22 (Apr-Feb) to 13.9 per cent in 2022-23 (Apr-Feb) and this accounts for around half a billion fall in imports from China. A major chunk of the demand for fertilizers has shifted toward Russia where import share has increased from 5.21 per cent to 17.2 per cent in 2022-23 (Apr-Feb).

## REAL MADRID SEE OFF CHELSEA Aman bags Asian C'ships gold

Madrid. April 13: Karim Benzema struck yet again against Chelsea, and Real Madrid are a step closer to eliminating the English club for the second straight season in the Champions League

Vinicius Junior thrived with two assists and Marco Asensio also scored in Madrid's 2-0 win in the first leg of the quarterfinals Wednesday in the latest meeting between the last two European champions.

Chelsea played the final halfhour with 10 men after Ben Chilwell was sent off for stopping a Madrid breakaway. It was a second consecutive defeat for new Chelsea interim manager Frank Lampard after he replaced Graham Potter amid the team's disappointing results. The second leg is next week at Stamford Bridge.

Benzema scored his sixth goal in five matches against Chelsea by hitting the open net off the rebound of a save by Kepa Arrizabalaga after an attempt by Vinicius from close range in the 22nd minute at the Santiago Bernabeu Stadium.

Benzema had scored four times against Chelsea in the last-eight last season, including the decisive goal in extra time in the second leg in Madrid. He had a hat trick in the first leg in London. The French veteran has scored 20 goals in 27 matches against English opposition. His last 14 goals in the competition have come in the knockout stage

Asencio netted the second in the 74th after another assist by Vinicius,

Astana, April 13: Aman Sehrawat clinched India's first gold medal at the ongoing Asian Wrestling Championships after beating Kyrgyzstan's Almaz Smanbekov in the 57kg category here Thursday.

Sehrawat, who continued to impress on the senior circuit, beat Smanbekov 9-4 in the summit bout on the penultimate day of the championships. Sehrawat, who trains at Delhi's famed Chhatrasal Stadium, had earlier beaten Japan's Rikuto Arai 7-1 in the quarterfinal before defeating China's Wanhao Zou 7-4 in the semifinal.

Two other Indians also reached the bronze-medal round here Thursday. Deepak Kukna (79kg) and Deepak Nehra (97kg) will fight for bronze medals after losing their respective semifinals even as Anuj Kumar (65kg) and Mulayam Yadav (70kg)



could not reach the medal round. With Sehrawat's gold, India have won 12 medals so far in the competition. The Greco-Roman wrestlers won four medals while the women grapplers grabbed seven.

#### NO CONCRETE EVIDENCE AGAINST WFI CHIEF: SOURCES

NEW DELHI: No concrete evidence of sexual harassment has been found against Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh, who was accused of exploitation by the country's top wrestlers, it has been learnt. In an unprecedented move, top achievers such as Vinesh Phogat, Bajrang Punia and Sakshi Malik staged a sit-in protest at Delhi's Jantar Mantar in January and accused the WFI boss of sexual exploitation and intimidation. The wrestlers had demanded that WFI be disbanded and its president be removed. The Sports Ministry had formed a five-member oversight committee, headed by legendary boxer MC Mary Kom, on January 23 and asked it to submit its findings in one month. Later, it extended the deadline by two weeks and also added Babita Phogat to the probe panel as its sixth member on the insistence of the protesting wrestlers. The committee submitted its report in the first week of April but the ministry is yet to make its findings public. However, multiple sources confirmed that the wrestlers could not prove the sexual harassment allegations against the WFI boss after several hearings. "The wrestlers could not prove their sexual harassment allegations. During the probe, it was alleged that one female physio (name withheld) was asked by Brij Bhushan to give him massage to treat his back pain last year in Bulgaria during a competition. However, during the hearing, the same physio denied any such happening," a source told PTI Thursday. "Instead, she revealed that all Brij Bhushan wanted was a pain killer for headache and when she offered one, and was accompanied by a female coach at that time, the WFI boss even refused to take tablet 'disprin'. It was male coach Anil who had actually helped Brij Bhushan." WFI officials, however, did not make any official comment when approached.
