#### **DA CASE**

#### **Pradeep Panigrahy** chargesheeted by Vig

Bhubaneswar, April 22: The state Vigilance Saturday submitted a 3,000-page chargesheet against Gopalpur MLA Pradeep Panigrahy and his wife before the special Vigilance court here in connection with a disproportionate asset

The Vigilance claimed in the chargesheet that Panigrahy illegally amassed assets worth Rs 9,18,13,007 beyond his known sources of income.

Following the orders of the Odisha Lokayukta, the anti-corruption wing of state government registered a case (6/2021) under Sections 13(2) and 13(1)(b) of the Prevention of Corruption Act, 1988 at the Vigilance cell police station October 4, 2021 on charges of possessing disproportionate assets during his tenure as a public servant.

"During the course of investigation, house searches were conducted and relevant materials, documents and information relating to assets, income and expenditure were collected. After completion of investigation, Panigrahy was found in possession of assets to the tune of Rs 9, 18, 13,007, which he could not explain satisfactorily. His spouse was also found liable for abetting the offence. Accordingly, the investigation report was filed before the Hon'ble Lokayukta 9.06.2022," the Vigilance department claimed in a press note.

Subsequently, the Lokayukta went through the investigation report produced by the Vigilance and April 20, 2023 it asked the Vigilance to submit the chargesheet against Panigrahy and his spouse before the Special Court, Vigilance, Bhubaneswar. The chargesheet reportedly contains detailed evidence collected by the Vigilance against Panigrahy and his wife in the DA case. Panigrahy was earlier arrested by Crime Branch on charges of forgery, criminal conspiracy and various cybercrime related offences December 3, 2020 and lodged in Jharpada special iail.

#### **3 BJB STUDENTS INJURED IN CLASH**

low by April 22. "I have paid the price for speaking the truth, I am ready to pay any price," he said, adding he would continue to raise issues of price rise and corruption with double the

Saturday morning, Gandhi moved out all his belongings from the bungalow where he had been staying for almost two decades.

Gandhi, his mother Sonia Gandhi and sister Priyanka Gandhi Vadra visited the bungalow in the morning. He handed over keys of the vacated house to officials of the Central Public Works department

He also shook hands with CPWD officials and thanked them.

Talking to reporters while leaving the bungalow, he said, "I have

no problem even if it has been snatched away from me. This house was given to me by the people of India. I will stay with the former Congress president (Sonia Gandhi) at 10, Janpath for some time and then find some other way.

Privanka Gandhi Vadra said her brother was very courageous and "not scared of anyone and he will continue his struggle"

## Hailstorms in state for next 3 days: IMD The weatherman says heatwave conditions have abated

from Gangetic West Bengal, Bihar and Odisha

Bhubaneswar/New Delhi, April 22: The India Meteorological Department (IMD) Saturday said most parts of India including Odisha will have a sigh of relief for the next few days from the searing heatwave conditions that had rattled people this week.

The weather office storms are very likely to occur in parts of Odisha over the next three days, in Bihar for the next two days, and Monday in Vidarbha. Heavy rainfall is expected in parts of Tamil Nadu and Kerala Sunday and in Odisha Monday.

This apart, duststorm is very likely to occur at isolated places in south Haryana, northeast Rajasthan and west Uttar Pradesh Sunday.

Skymet said scattered rainfall is expected in the entire Northeast, West Bengal, Jharkhand, Chhattisgarh and Telangana. Thunderstorms with patchy rain may occur over the western Himalayas, parts of Haryana, Punjab, Bihar, southeast Uttar Pradesh, southeast Madhya Pradesh, Andhra Pradesh and south-interior Karnataka.

Farmers should use hail nets to protect orchards in sub-Himalayan West Bengal and Sikkim and Odisha. The IMD said Saturday

that heatwave conditions abated from Gangetic West Bengal, Bihar and Odisha.

The IMD has advised farmers should undertake harvesting of matured rice, maize, groundnut and ragi in Andhra Pradesh; rice in Kerala and keep the harvested produce in safer places.

It said a cyclonic circulation lies over northwest Madhya Pradesh and another over interior Tamil Nadu. A trough of relatively low pressure runs from northwest Madhya Pradesh to south Tamil Nadu across Telangana. Private forecaster Skymet Weather added another trough extends from northeast Bihar to Odisha via Jharkhand.

Weather experts say a trough usually brings cloudy conditions and rain, leading to a drop in temperatures.

According to the IMD, several parts of India had been experiencing heatwave conditions for the past few days. High temperatures in the northern and central plains had forced the local administrations to either change the timings or shut the schools until the weather improves. Even in the eastern hills, tea growers complained of relatively high temperatures and prolonged dry spell resulting in crop loss during the ongoing flush season.

### **BIDEN TO VISIT INDIA IN SEPT**

Washington, April 22: US President Joe Biden is looking forward to travelling to India in September, his administration's point person for South and Central Asia has said, observing that 2024 is going to be a "big year" for the India-US relationship.

India's leadership in the G-20 further broadens its capacity to stand as a force for good in the world, the official said.

"This is gonna be a big year. Of course, India is hosting the G-20. This year, the United States is hosting APEC. Japan is hosting the G7. We have lots of our QUAD members who are taking on leadership roles. And it provides opportunities for all of us to bring our countries closer together," Assistant Secretary of State for South and Central Asia, Donald Lu, told PTI in an interview Thursday.

"I know our President is looking forward to travelling to India in September. That will be his first trip to India as part of the G-20 Leaders Summit. We're really excited about what's to come in the next few months," he said.

# Students outshine ChatGPT in accounting

ALTHOUGH RESEARCHERS TERMED CHATGPT'S PERFORMANCE AS 'IMPRESSIVE', THEY FOUND THAT IT OFTEN PROVIDED EXPLANATIONS FOR ITS ANSWERS, EVEN IF THEY WERE INCORRECT

New Delhi, April 22: Contrary to the popular belief that artificial intelligence (AI) is better than human intelligence, researchers in United States have found that students have scored an overall average of 76.7 per cent as compared to ChatGPT's score of 47.4 per cent in accounting exams. Researchers, however, said that

ChatGPT's performance was "impressive" and that it was a "game changer that will change the way everyone teaches and learns - for the better."

The researchers from Brigham Young University (BYU), US, and 186 other universities wanted to know how OpenAI's technology would fare in accounting exams. They have published their findings in the journal Issues in Accounting Education.

nancial, and managerial assessments. Researchers think this could possibly be because ChatGPT struggled with the mathematical processes required for the latter type. The AI bot, which uses machine learning to generate natural language text, was further found to do better on true/false questions (68.7 per cent correct) and multiple-

choice questions (59.5 per cent), but

struggled with short-answer questions (between 28.7 and 39.1 per cent). In general, the researchers said that higher-order questions were harder for ChatGPT to answer. In fact, sometimes ChatGPT was found to provide authoritative written descriptions for in-

correct answers, or answer the same question different ways. They also found that ChatGPT often provided explanations for its answers, even if they were incorrect. Other times, it went on to select the wrong multiple-choice answer, despite providing

accurate descriptions. Researchers importantly noted that ChatGPT sometimes made up facts. For example, when providing a reference, it generated a real-looking reference that was completely fabricated. The work and sometimes the authors did not even exist.









# **BJP missive to Shah** seeking NIA probe

Bhubaneswar, April 22: The Odisha unit of BJP Saturday wrote a letter to Union Home Minister Amit Shah, requesting him to take steps for an inquiry by NIA into the violence in Sambalpur during Hanuman Jayanti cele-

In a letter signed by BJP's state unit president Manmohan Samal and several party MPs and MLAs, they urged the Centre to direct the state government to take necessary measures to 'restore law and order in Sambalpur' and ensure 'communal harmony' in the western Odisha city.

'We strongly condemn the heinous act of communal violence and demand an impartial investigation by the NIA to unravel the conspiracy behind the incident, and strict action against the perpetrators," the party said

The BJP's state leadership also urged the Centre to ask the state government to take immediate steps to prevent the recurrence of such incidents in Odisha in future

BJP leaders also alleged that the law and order situation has 'deteriorated' in Sambalpur following clashes 'due to the orchestrated violent attack' on a motorcycle rally two days before the Hanuman Jayanti April 14.

"The coordinated attack on the bike rally April 12 had left several persons, including some policemen, grievously injured. The incident also led to torching of shops, vehicles and private properties in Sambalpur," the letter said.

The western Odisha city had witnessed a clash between two communities during a motorcycle rally in the run-up to Hanuman

As the clash spilled over to the streets, many vehicles were damaged and some shops were set

### Saffron party doesn't want normalcy to return: BJD

Bhubaneswar: Reacting strongly on BJP's letter to Union Home Minister Amit Shah, BJD senior vice president Prasanna Acharya said that Odisha BJP leaders never wanted normalcy to return to violence-hit Sambalpur town.

Due to the strong and wholehearted resolve of the people of Sambalpur and resolute efforts of the police and administration, normalcy is returning to Sambalpur. But, unfortunately the Odisha BJP leaders never wanted normalcy and their statements were always aimed at ensuring that this issue simmers, Acharya alleged

Having failed in their initial attempts, Odisha BJP leaders have been now trying to flare up the issue through various means, he alleged.

Odisha BJP called for a bandh

in this sensitive matter which affected the lives and livelihood of poor people of Odisha. Now they are again trying to affect the lives and livelihood of peace-loving people of Odisha through such activities, said another BJD vicepresident Debi Prasad Mishra.

"The people of Odisha are peace loving and Odisha is a peaceful state but BJP in state has been constantly insulting the people of Odisha by calling them lawless," he said.

The people of Odisha want peace and people of Sambalpur want normalcy which does not fit into the agenda of Odisha BJP. Therefore, they are consistently trying to insult and demean the people of Odisha and 4.5 crore Odias while at the same time using various means to keep the sensitive issue of Sambalpur on the boil, Mishra further alleged.

As many as 10 police personnel and around 12 Hanuman Jayanti coordination committee members were injured in a stone pelting incident during the clash.

The saffron party also claimed that a tribal youth was killed and several others were injured in another attack by a mob in Sambalpur April 14, the day Hanuman Jayanti was celebrated.

The administration has clamped the curfew in Sambalpur soon after the incidents and suspended internet services in the locality.

The violence and arson in Sambalpur during the Hanuman Jayanti procession and a day before has exposed the poor intelligence network of the Odisha Police and the lack of foresight on its part to ascertain the consequences of inadequate security arrangement

during the festival, the BJP leaders said in the letter.

'The Odisha Police has miserably failed to follow the advisory issued by the Ministry of Home Affairs for smooth organisation of Hanuman Jayanti processions,' the letter said.

As per an FIR lodged by the police, around 200 people of a particular community armed with swords, iron rods and sticks attacked the motorcycle rally April 12. The police have admitted that the communal riot was pre-planned. The attackers also raised certain objectionable and anti-national slogans to incite communal violence, the party said.

'Such sloganeering by the mob is not acceptable and amounts to crime that needs to deal with strict laws." the BJP said in the letter.

# NHRC for ₹3 lakh ex gratia in Keonjhar schoolgirl's death

Bhubaneswar, April 22: The National Human Rights the Chief Secretary to provide Rs 3 lakh as compensation to the next of kin of a 13-year-old tribal girl, who died owing to 'negligence' of her school authorities in Keonjhar late December 31, 2019 night.

The commission's move came in response to a petition filed by rights activist Himanshu Sekhar Nayak January 17, 2020 – the day this media highlighted the issue.

Nayak had informed the commission that Tapaswini Hembram, Class-V student of Ramachandrapur Ashram School under Patna police limits in Keonjhar, died December 31, 2019 due to the negligence of the school authorities as they did not provide medical intervention to the minor

Although the girl was down with

diarrhoea, the school authorities asked her family to take her back home instead of arranging medical care for her. With no option in hand, the victim's father Nabin Hembram, a resident of Balipasi under Sadar police limits in Keonjhar, brought her back home, where her condition deteriorated. "The victim was later rushed to the district headquarters hospital (DHH), where she was declared 'dead on arrival'," said the peti-

tioner, quoting the victim's father. In February 2020, the commission had directed the School and Mass Education (S&ME) department Principal Secretary as well as the Keonjhar superintendent of police (SP) to file an action-taken report (ATR) in this regard within four weeks.

The SP informed the commission that it was the responsibility of the school headmaster to ensure healthcare facilities to the girl. However, to no avail. "Rs 25,000 has been provided to the deceased's kin from the Keonjhar Red Cross fund," the SP informed the NHRC.

The commission, however, asked the Chief Secretary as to why Rs 3 lakh as compensation should not be granted in the case

In response, the Special Secretary of the ST&SC Development department informed the NHRC that there is no guideline of the state for such compensation.

Observing that the human rights of the schoolgirl has been violated, the apex rights body asked the Chief Secretary to provide Rs 3 lakh as compensation to the next of kin of the girl and submit a compliance report in this regard within six weeks.

state. In a notification, NCERT said, 'National

# **Sharecroppers shy away from cultivation**

### SHARECROPPERS IN KENDRAPARA ARE SLOWLY BECOMING AVERSE TO FARMING AS LAND OWNERS CLAIMING THEMSELVES AS FARMERS ARE GRABBING ALL THE BENEFITS OF VARIOUS GOVT SCHEMES

Kendrapara, April 22: Sharecroppers are slowly moving away from cultivation in this district as the benefits of state and Centre-sponsored schemes are not available to them with land owners grabbing all the aid.

Reports said the Department of Agriculture and Farmers Empowerment distributed ₹877 crore under Kalia scheme to over 43 lakh small and marginal farmers during the Odisha Day celebrations this year.

Similarly, Chief Minister Naveen Patnaik has sanctioned funds for the development of the farming community under statesponsored Krushak Yojana, Odisha Jackfruit Mission and Odisha Millet Mission. However, the steps taken by the Chief Minister have failed to reach the sharecroppers in Kendrapara district.

Sharecroppers are slowly becoming averse to cultivation this

year as the land owners claiming themselves as farmers are grabbing all the benefits of statesponsored Kalia scheme and Centre-sponsored PM Kishan Yojana. Similarly, banks are not willing to sanction loans to the landless sharecroppers

Moreover, they face problems in selling the harvested crops every year during both kharif and rabi seasons and often resort to distress sale of their produce due to a lack of support mechanisms.

Farmer leader Bijay Kumar Parida said 70 per cent of the total farmland in this district is cultivated by sharecroppers. They take the land on lease from the owners for a period of one year for which they contribute half of the harvested paddy and two-fifth of rabi crops to the land owners. Sharecroppers have to take great risks in raising the crops and bear all the brunt starting from natural calamities to distress sale, but the land owners



time of need. They also face a lot of hurdles in getting a bank loan and while selling their harvested crops, he added.

Pramod Kumar Sahu, president of Krushak Vikash Samabaya Samiti said only 15 per cent of small and marginal farmers carry out cultivation on their own land

is cultivated by the sharecroppers.

The state government is taking various steps for the growth and development of the farmers but it is yet to identify the sharecroppers engaged in cultivation in the district. As a result, they fail to get any bank loan, crop insurance, or the benefits of various welfare schemes aimed at the farmers

He said that the state government at first needs to make an enumeration of the sharecroppers so that they do not feel left out in availing the benefits of various welfare schemes.

Gayadhar Dhal, president of Kendrapara Zilla Chashi and Shramika Sangha, said that the state government had convened a meeting to identify sharecroppers in 2015. In the meeting, it was discussed to include the sharecroppers in various district-level schemes and other social security schemes. Since then, eight years have passed but no step has been taken yet in this regard.

A land owner Trilochan Jena of Indupur village under Kendrapara block said there are some roadblocks in giving legal sanction to the sharecroppers. These are the period of contract between the land owners and sharecroppers and whether the land owners should get money or share from the harvested crops.

These issues need to be discussed threadbare before arriving at any conclusion. Jena said that people will get interested in cultivation only when a law is enacted for the sharecroppers but the right of ownership of the land also needs to be protected.

A farmer Satyabrata Senapati of Mahakalapara said that land is a family property which acts as an asset during any emergency. This is the reason for which people purchase land. He said if a law is enacted and land is given on lease to the sharecroppers then it will be difficult for the land owners to sell off the land during any family problem and may give rise to disputes between the family members.

Amiya Behera of Dumuka village under Marshaghai block said sharecroppers are not inclined to take up cultivation due to distress sales, failure to get any assistance during natural calamities and lack

## 5 staffers suspended in Bolangir civic Man killed in body for embezzling old-age pension jumbo attack

Bolangir, April 22: The district Collector here has ordered for suspension of five employees of the Bolangir Municipality on charge of swindling old-age pension money meant for senior citizens during the Covid-19 pandemic, a report said

The embezzlement of old-age pension which remained suppressed for three years has come to light during an audit. However, the executive officer of the civic body instead of taking legal action against the accused employees had only ordered for recovery of the funds from them. Apprised of the development,

Bolangir Collector Chanchal Rana ordered for suspension of the five employees. The development has sparked shockwaves in this town. The Collector has also directed to initiate process for their dismissal. As per reports, the accused had

misappropriated money to the tune



of ₹12 lakh during the lockdown for Covid-19 pandemic in 2020-21 FY.

As people were staying in their homes and maintaining social distancing, the civic body employees were asked to make proper distribution of the old-age pension. Some of the employees thought it as an opportunity and gobbled up the pension money. The incident took place in 2020 but was covered up. Three years later, an audit was conducted which exposed the fraud and found out that ₹12 lakh has

been misappropriated. The matter came to the fore after two of the employees were asked by the Municipality authorities to cough up the amount they have swindled.

As a result, one Ashish Mohapatra paid ₹1.05 lakh and another employee, Ashok Kumbhar, paid ₹20,600 towards recovery of the old-age pension money embezzled by them. Though the municipality asked

them to refund the money, no action was taken against the errant officials. Efforts to contact the municipality executive officer Sami Reddy Jayashree on her phone (9937995835) proved futile as she did not respond to the call

Meanwhile, the municipality authorities are yet to issue any statement in this connection and were unavailable for comments.

# Facor plant fire: 2nd worker dies

Bhadrak, April 22: Yet another worker, who was undergoing treatment at a hospital in Mumbai after being critically burnt in a fire mishap at Facor plant at Randia area in Bhadrak district, succumbed to his injuries, Friday night.

The deceased worker was identified as Bijay Mohapatra of Barpada in Bhadrak district. He was undergoing treatment at the National Burns Centre in Mumbai. The other deceased worker Ratikanta Sutar of Koranta village had died April 16. The two had sustained critical burn injuries while charging the blast furnace at the Facor plant at Randia in Bhadrak district

Sources said that the body will be brought to Bhadrak tomorrow after a post mortem in Mumbai Saturday. News about the death of the sec-

ond worker triggered tension at his village as well as at the plant site in Randia.

Reports said that Bijay and Ratikanta sustained critical burn injuries after fire sparkles fell on them at the plant April 11. The two were initially rushed to Bhadrak headquarters hospital and later taken to a private hospital in Bhubaneswar. They were airlifted to Mumbai for treatment through a green corridor created to the Bhubaneswar airport after their conditions deteriorated.

In view of gravity of the situation following death of the second worker, the district administration has further extended the promulgation of prohibitory orders till 6am of April 25 from 6am of April 22.

# **Lack of Optimism**

ew India is again the world's most populous nation. Old India was also the most populous place in the world till 1947 so this is in that sense not new. If the idea is that political boundaries do not affect historical nations then India has always been the place with the most people.

But political boundaries are real and the rest is imagined so let us pretend we are here for the first time. Some two decades ago India announced it had crossed 100 crore people and Atal Bihari Vajpayee was the Prime Minister. A randomly selected baby was declared the one billionth child (though on a smaller scale, there was pomp and ceremony about everything then also) and a new era was declared. In those days India used to conduct the census so the outside world was not required to inform us that we have crossed China. Around that same time, APJ Abdul Kalam wrote a book called 'India 2020 about how we could and likely would become a developed nation by 2020. It had chapters on how this could be achieved. I went back to it recently and it is striking how innocent it is. As we can see around us, none of the things it foresaw or hoped for happened. We bumble along as we always have though the slogans keep changing. We are in Amritkaal now and if there is a baby declared officially as the one that helped us overtake China then it will need to be given an assessment of

where we stand. The first point is on demographic dividend, which arrives when the majority of the population is of working age. We entered this period a few years ago but have not reaped a dividend. The reason is that there are few jobs for those who are available to work. But those available for work are only 40 per cent of the population over 15. Indian women in particular have fallen out of the workforce in larger numbers proportionally than Pakistani and Bangladeshi women. However, this is not only about gender but the whole population.

A few days ago the Wall Street Journal published an article with the headline 'India's population surpasses China's, shifting the world's center of gravity'. The article explained that India had "added zero net jobs over the past decade" though over 100 million (10 crore) new people entered the labour force.

The total number of Indians employed in 2022 (40.2 crore) was fewer than those with work in 2017 (41.3 crore). Not only have we not added new jobs we have lost some of those we had.

The reason is that Indians are not investing as much as they used to in the future. The

Economic Times carried a story in September 2022 headlined 'India's investment rate declines to 31% of GDP from 39% peak'. World Bank figures show that India's private sector share of gross fixed capital formation fell from 31 per cent of GDP in 2011 to 22 per cent in 2022.

We can ask why. The answer is that there is lack of optimism about the future and a lack of confidence. If we ask why this is the case we will be led to answers we will not like, which have to do with social strife and the focus of the government. Large numbers of Indians including those we are bullying and harassing will not invest in a future that they think is bleak. This also explains the record number of millionaires feeling India, and presumably adding to the heat of nationalism from abroad, this time holding their European and American passports.

On 20 April 2023 the Financial Times, the other major global business daily, published an editorial headlined 'India's democratic backsliding'. This editorial was also ostensibly about India's population story but the paper's editorial board wanted to communicate something else, which our media does not tell us.

The advantage India has, or rather Indian governments have, is that all nations think purely or mostly in self interest when it comes to interna-

At a time when inflation is high, when there is war in Europe again and thina has become the primary threat. India is seen as a count would be nice if India were to reflect the values of pluralism and openness that it claims to hold, but it is fine if doesn't fully. There is some element of internal pressure on other democracies to tell wayward liberal states to get back in line. However, this has its limits and in a time of global crises the limits have shrunk. We should assume then that, despite the harsh words in the reputable press of the outside world, we can carry along in our reverie of being Vishwaguru in Amritkaal.

Happily it does not require the world to hold a mirror up for us. We can look at ourselves and understand easily if we choose to be honest about where we find ourselves three quarters of a century after Independence. Our Constitution and its values are not at the core of our politics. If anything we are drifting away from that core faster than we ever have been without any inkling of what we are moving towards.

The arrival of this news of being the world's most populous nation should be seen in the light of this reality.

#### Hebetude

one of those eternal human states — dullness or lethargy — for which another good descriptor always comes in handy. It has been around since the seventeenth century in a rather poetical or literary way. It derives from Latin hebet-, the stem of hebes, blunt or dull (so it is unconnected with the Greek goddess Hebe, whose name comes from the Greek word for puberty or adolescence). The Romans used their word for the state of knife blades and the like, but also for somebody who was dull or stupid. In English it has always had this figurative meaning. The noun's heyday began in the nineteenth century and it is still going strong among those writers who like to extend their readers' word power. It is also a term in psychology for apathy and emotional dullness. It was a favourite word of Joseph Conrad, as in Nostromo: "From that solitude, full of despair and terror, he was torn out brutally, with kicks and blows, passive, sunk in hebetude". It made an appearance in August 2001 in the columns of The Washington Post: "Too many Americans slouch toward a terminal funk of hebetude and sloth." There are several related words, now rare, including the adjective hebetudinous, the abstract noun hebetudinosity, dullness or obtuseness, and the verb hebetate, to make dull or blunt.

# XI'S PREDICAMENT

**IF TAIWAN WERE TO FALL** TO CHINA, THE **AUSTRIA-SIZED ARUNACHAL PRADESH COULD BECOME THE CHINESE GOVERNMENT'S NEXT TARGET FOR** 'REUNIFICATION'

Three years after China stealthily began encroaching on India's territory in the Himalayas, no end is in sight for the two countries' border standoff. While the rival military buildups and intermittent clashes have received little attention in the West, the escalating border confrontation has set in motion a long-term rivalry that could reshape Asian

By locking horns with China despite the risk of a full-scale war, India has openly challenged Chinese power in a way no other world power, including the United States, has done in this century. Chinese President Xi Jinping's strategic overreach has caused India to shift away from its previous appeasement policy and accelerate its military buildup, turning a potential partner into an enduring foe, while appearing determined to forestall a Sinocentric Asia.

Similarly, Xi's muscular revisionism and geopolitical ambitions have forced Japan and Australia to readjust their strategic frameworks and work to counter China's expansionism in the Indo-Pacific. By drawing up plans to double defense spending by 2027, Japan has effectively abandoned its pacifist postwar nationalsecurity policy. Australia, for its part, has renounced its previous hedging approach and joined the AUKUS defense pact with the US and the United Kingdom.

China's attempt in spring 2020 to occupy hundreds of square kilometers in the icy borderlands of India's northernmost Ladakh region, at a time when India was enforcing the world's strictest national lockdown, amounted to a cynical effort to exploit the COVID-19 pandemic to further Xi's strategic aims. But Xi miscalculated when he assumed that China could force India to accept the new status quo as a fait accompli. Since then, India has more than matched China's military deployments, fueling the largest-ever military buildup in the Himalayas, one of the world's most inhospitable re-

defenses by opening up a new front in the eastern Himalayas, more than 2,000 kilometers from China's 2020 land grabs. In December 2022, a Chinese incursion into the strategically crucial border state of Arunachal Pradesh was repelled by Indian forces, reportedly with help from US intelligence.

In an effort to strengthen its territorial claim and provoke India China has Sinicized the names of sites in Arunachal Pradesh. Calling Arunachal Pradesh "South Tibet," the Chinese government has asserted that the sprawling state more than twice the size of Taiwan - is "Chinese territory" and that Sinicizing Indian lands is its "sovereign right.

All this has given India a stake in Taiwan's continued autonomous status. If Taiwan were to fall to China, the Austria-sized Arunachal Pradesh could become the Chinese government's next target for "reunification." China's annexation of Tibet in 1951 proved to be one of the most significant geopolitical developments in post-World War II history, giving China common borders with India, Nepal, Bhutan, and northwest Myanmar.

A Chinese takeover of Taiwan could lead to a similar geopolitical reordering, enabling Chinese naval forces to break out of the "first island chain" and easily access the Pacific.

China's claim that Taiwan has 'always been" part of China is historically dubious. Taiwan did not become a Chinese province before the late nineteenth century and China lost control of the island just eight years later, when the Qing Dynasty ceded it to Japan in perpetuity following its defeat in the 1895 Sino-Japanese War. But in laying claim to Taiwan, Xi is working to complete Mao Zedong's expansionist vision of a "Greater China.'

Similarly, Tibet is the key to Chinese expansionism in the Himalayas despite the fact that it was a part of China only when China itself was occupied by outsiders like the Mongols and the Manchus. Because it cannot claim any Han-Chinese connection, its territorial claims in the Himalayas rest on alleged Tibetan ecclesial or tutelary links. Even tiny Bhutan has not been spared; China has been nibbling away at its border-

Against this backdrop, India's willingness to stand up to China is crimping Xi's expansionist agenda. As Admiral Michael M. Gilday, the US Navy's chief of naval operations, put it last year, India presents China with a "twofront" problem. "They [Indians] now force China to not only look east, toward the South China Sea and the Taiwan Strait, but they now have to be looking over their shoulder at India," he said.

Moreover, the Sino-Indian rivalry has flared up at a time when China's economy is running into long-term constraints, including a shrinking and rapidly aging population and slowing productivity growth. By contrast, India, which has one of the world's youngest populations with a median age of 28.4, is reaping a demographic dividend. While its GDP is still smaller than China's, it is the world's fastest-growing major economy.

Given that its military is the world's most experienced in hybrid mountain warfare, India has an edge in the high-altitude Himalayan environment. Moreover, in contrast to India's all-volunteer military, the Chinese People's Liberation Army largely relies on conscripts who ostensibly "volunteer" for two years of service after they reach the age of 18. That helps explain why China has chosen to engage in stealth encroachments rather than direct combat

The current military stalemate in the Himalayas serves as yet another reminder that Xi has picked a border fight with India that he cannot win. With the US-China rivalry deepening, the last thing China needed was to make a permanent enemy of its largest neighbour. Ultimately, bringing India and America closer could prove to be Xi's lasting legacy - an unintended consequence that threatens to undermine his regime's aggressive irredentism.

# **Early warning: First defence in Kerala climate disasters**

ELONGATED LIKE A BITTER GOURD AND STRETCHING ACROSS SOUTH-WESTERN INDIA, THE STATE OF KERALA IS AMONG THE MOST VULNERABLE REGIONS TO CLIMATE CHANGE, INCREASINGLY FACING EXTREME WEATHER **EVENTS, BE IT CYCLONES, FLOODS OR HEAT, WITH EACH PASSING YEAR**

Kochi, April 22: For deep sea fishermen Charlene Lenis, Jerome Beji and their 10-person crew, knowing when a cyclone is approaching can spell the difference between life and death

When Cyclone Tauktae in 2021 was nearing the fishing grounds off the southern coast of India, the weather agency sent out a message about the major storm. The fishers had been at sea two days and immediately returned to port after getting the satellite phone warning.

"We are gillnet fishers and we always travel as a troupe of boats. At least one boat will have a satellite phone," said Lenis, who primarily catches tuna, sharks and other big

The India Meteorological Department (IMD) as well as the Kerala government have increased infrastructure for cyclone warnings since Cyclone Ockhi in 2017, which killed 245 fishermen out at sea. Just a vear later, unprecedented flooding left Kerala reeling with thousands of crores in damage, including in its largest city Kochi.

Ramping up ways to warn people about extreme weather disasters is becoming increasingly important for India —the world's most populous nation and one of the most vulnerable to climate change.

In a recent visit to India, United Nations Secretary General Antonio Guterres said the World Meteorological Organisation will invest USD 3.1 billion (approximately Rs 25,000 crore) to set up early warning systems across the world. According to the WMO, nearly half the world's countries — most of them low-income countries and small island states — do

not have any early warning systems. "Countries with limited early



mortality eight times higher than countries with high coverage,' said Guterres

Elongated like a bitter gourd and stretching across southwestern India, the state of Kerala is nestled between the biodiversity-rich Western Ghats and the Arabian Sea. The state is also among the most vulnerable regions to climate change, increasingly facing extreme weather events, be it cyclones, floods or heat, with each passing year.

From a meteorological perspective, the state occupies a special position too. Arrival of the annual monsoons, critical to the Indian economy and agriculture, is declared on the subcontinent only after the rains make landfall in Kerala, usually in June.

Rajeevan was among senior officials in-charge when weather calamities such as Cyclone Ockhi and the 2018 floods struck Kerala. "While things are better, there is still a lot of scope for improvement, he said. It is important to ramp up communications systems, so the information reaches the people who

need it the most. Such as fishers.' The Cyclone Warning Division of the IMD at its New Delhi headquarters is the beating heart of India's cyclone forecasting. The division receives data from satellites, local offices, doppler radars and allied agencies such as the National Centre for Medium Range Weather Forecasting and the National Centre for Ocean Information Services.

When a storm is approaching, the division resembles a command centre for emergency operations with scientists working around the clock to monitor and relay information to regions likely to be affected.

Based on this information, thousands of people are moved to safer ground and fishers are called back from sea or prevented from going out. Since it was established over two decades ago, the division has been instrumental in saving countless Indian lives from extreme weather.

"When there is a cyclone, a bulletin is issued eight times a day, which includes warnings to fishermen, ports, and coastal weather bulletins," IMD chief Mrutyunjay Mohapatra said.

Mohapatra earned the moniker "cyclone man of India" after accurately predicting the path of powerful Cyclone Phailin that hit the coast of Odisha in 2013. "We have also increased the frequency of the warnings and make sure the information reaches fishers and others who need it as soon as possible," he added.

Despite the weather agency's efforts, the deadly toll of extreme weather is increasing in India. According to a 2022 report by the IMD, more than 2,000 people died in the country due to extreme weather events. Another report found that 2022 was among the warmest years on record for Kerala. The state lost 56 lives to extreme weather last year, according to Kerala government's Institute for

In an effort to reduce damage from extreme weather, the central forecasting agency established a separate cyclone warning centre in Kerala in 2018. This serves not only Kerala but also neighbouring Karnataka and the island of Lakshadweep in the Indian Ocean. The country, now, has seven weather warning centres.

The Kerala government, which faced flak for its handling of Cyclone Ockhi as well as devastating floods in 2018, also subscribes to private weather companies such as Skymet Weather that provide additional forecasting. It is one of India's first states to subscribe to private weather services.

One UN report estimated that the 2018 floods caused damages to the tune of USD 4.4 billion (approximately Rs 36,000 crore) in the state, and officials said Kerala needs that much for recovery.

Kollam MP NK Premachandran said that despite state and Central government claims, information about extreme weather is still not reaching people early enough.


Regardless of such shortcomings, fishers who venture out to sea off Kerala's coasts welcome the state's extreme weather warnings.

Increasing fuel costs, depleting fish numbers and increasing number of boats is making fishing harder, said Charlene Lenis, a captain who has been fishing for the last 35 years.

Despite the risks, Lenis says he plans to continue with fishing and these warnings are keeping him and others just a little safer than before. "Having these systems is at least making sure we are not risking our lives as much as we used to when we go out to sea. Our families have a little more confidence that whenever we go out to sea, we will most likely return home safely," he said.

"Only Shettar has joined the Congress, not our vote bank or the party workers. BJP will retain power with a thumping majority," Shah said.

On denial of tickets to senior state BJP leaders, Shah said that various factors are taken into account before preparing the list of candidates.

"The nominees should not be tainted, they should be respectable candidates. Those who have been denied tickets have been convinced about the party's decision," the Home Minister said.

Shah also clarified that one can't brand all the leaders who were denied tickets as tainted.

To accommodate new faces and the new generation, many sitting MLA were not given tickets, he said, adding that the change infused in Karnataka BJP is minimal.

Former Karnataka Chief Minister and senior BJP leader Shettar recently quit the party and joined the Congress after being denied ticket for the May 10 Assembly elections. Former Deputy CM Laxman Savadi has also jumped ship to the Congress for the same reason.

Shah, who arrived in Bangalore Friday evening, conducted a marathon meeting of party leaders that continued till 3am Saturday, during which he gave them specific tasks to ensure victory of the party. He also advised the party leaders not to be over confident and to shed their negative

He also said that the defectors should be taught a lesson in the elections, sources said.

"Last week, President, BJP state committee, Kerala had received a letter written in Malavalam threatening the life of Hon. Prime



Minister of India by using suicide bomber," the intelligence report

The report also said the veracity of the letter and the person behind it were under investigation.

Surendran alleged that the leak of the intelligence report from the police was a grave mistake and it

should be probed. The 49-page report gives details of the names of the officials on duty, their roles, the detailed programme chart of the Prime Minister among other mat-

Union Minister of State V Muraleedharan also slammed the alleged leak of the ADGP (Intelligence) report and said it was a serious matter.

The Chief Minister should explain how a report on the security detail of the Prime Minister was leaked and going viral on WhatsApp. This means the state home department is in shambles," Muraleedharan alleged.



#### Dowden named **UK Deputy PM**

London: The British government named Oliver Dowden deputy prime minister Friday, replacing Dominic Raab who resigned earlier in the day following a report into claims he bullied colleagues. As deputy prime minister. Dominic Raab had no formal powers but stepped in for the prime minister if he was away from parliament or incapacitated. Oliver Dowden currently serves as cabinet office minister in Rishi Sunak's government. #### **China, Philippines** to work together

Manila: China's foreign minister said Saturday his country is willing to work with the Philippines to resolve their differences, as tensions rise over Beijing's behaviour in the disputed South China Sea and Manila's deeping military cooperation with the US. Foreign Minister Oin Gang held talks in Manila with his Philippine counterpart. #### **Australia eases** citizenship for NZ

Sydney: Australia announced Saturday a direct pathway to citizenship for New Zealanders living in the country, reversing controversial visa rules a day before a visit by New Zealand Prime Minister Chris Hipkins. Hipkins, set to visit Queensland state's capital Brisbane Sunday, hailed the move as "the biggest improvement in the rights of New Zealanders living in Australia in a generation". The changes, effective from July, meant New Zealand citizens living in Australia for four years or more could apply for citizenship without having to become permanent residents first, Australian Prime Minister Anthony Albanese said.



Polls repeatedly show a clear majority of Americans support continued access to safe abortion, even as conservative groups push to limit the procedure -- or ban it outright



Two conservative justices disagreed with the decision in the most significant abortion case to reach the nine-member court since it overturned the constitutional right to the procedure 10 months ago.

Without commenting on the merits of the case, the decision by the nation's highest court means that mifepristone, which accounts for more than half of the abortions in the United States, will remain available while the case plays out in an appeals court.

The Justice Department of President Joe Biden had filed an emergency appeal asking the Supreme Court to block the lower court rulings that would have banned or limited use of mifepristone.

The case stems from a ruling by a US District Court judge in Texas, in a lawsuit brought by antiabortion groups, that would have banned mifepristone, which was approved by the Food and Drug Administration (FDA) in 2000.

An appeals court blocked a ban on the pill, but imposed tough restrictions on access, after which the

The Supreme Court decision effectively freezes the lower court rulings pending an appellate court hearing of the appeal from the Justice Department and mifepristone manufacturer Danco Laboratories

Reacting to the Supreme Court move. Biden said the lower court decisions "would have undermined FDA's medical judgment and put women's health at risk.

"As a result of the Supreme Court's stay, mifepristone remains available and approved for safe and effective use while we continue this fight in the courts,' Biden said in a statement. "I will continue to fight politically-driven attacks on women's health.'

'Deeply misguided' Since the Supreme Court overturned the landmark Roe v Wade ruling that enshrined the constitutional right to abortion for half a century, 13 states have banned abortion and it has been severely restricted in others. Opposition to the legal assault

on the abortion pill is being spearheaded by the Justice Department, which argued that the initial ruling by the federal judge in Texas was based on a "deeply misguided assessment" of the pill's safety. Mifepristone is one component

of a two-drug regimen that can be used through the first 10 weeks of pregnancy. It has a long safety record, and the FDA estimates 5.6 million Americans have used it to terminate pregnancies since it was approved.

Since last year's Supreme Court decision, 12 US states have put in place outright bans while many others prohibit abortion after a certain length of pregnancy. The latest Republican-led move came in Florida, where Governor Ron DeSantis April 13 signed a law banning most abortions after six weeks of pregnancy.

### **Sudan fighting on** despite ceasefire

Khartoum, April 22: Sudan's army said Saturday it had agreed to help evacuate foreign nationals as sporadic gunfire and air strikes echoed across Khartoum despite promises by warring sides to cease fire for three days after a week of strife that has killed hundreds. The statement citing army chief

Abdel Fatteh al-Burhan came after promises by rival Rapid Support Forces (RSF) leader Mohamed Hamdan Dagalo, known as Hemedti, to open airports for evacuations. Sounds of fighting continued

overnight but appeared less intense Saturday morning than on the previous day, a Reuters journalist in Khartoum said. Live broadcasts by regional news channels showed rising smoke and the thud of blasts.

The army and the paramilitary RSF, which are waging a deadly power struggle across the country, had both issued statements saying they would uphold a threeday ceasefire from Friday for Islam's Eid al-Fitr holiday

Sudan's sudden collapse into warfare has dashed plans to restore\_ civilian rule, brought an already impoverished country to the brink of humanitarian catastrophe and threatened a wider conflict that could draw in outside powers.

There has been no sign vet tha either side can secure a quick victory or is ready to back down and talk. The army has air power but the RSF is widely embedded in urban areas including around key facilities in central Khartoum.

The World Health Organization reported Friday that 413 people had been killed and 3.551 injured since fighting broke out. The death toll includes at least five aid workers in a country reliant on food aid.



## Russia crosses new lines to crush Putin's enemies

Putin's position is not now under threat but history is not short of examples of former political detainees - from Vaclav Havel in Czechoslovakia and Nelson Mandela in South Africa to Chile's Michelle Bachelet - who have swapped prison for the presidency

London, April 22: With virtually all the Kremlin's opponents already jailed or in exile, and liberal press outlets and human rights groups forced to shut down, it might have appeared that years of repression in Russia had achieved their objective.

But in the space of just three weeks, Russia's security services and courts have crossed several new thresholds in their campaign to destroy perceived enemies, spies and traitors.

The March 29 arrest of Wall Street Journal reporter Evan Gershkovich sent a chilling warning to the few remaining Western journalists in Russia about the risks of travelling, talking to sources and simply doing their jobs. The last time Moscow had held an American journalist for alleged espionage a charge that Gershkovich, his



strongly reject - was 1986, when the country was still under Soviet communist rule.

Then Monday, opposition politician Vladimir Kara-Murza was jailed for treason and spreading "false information" about Russia's war in Ukraine. His 25-year sentence was three times longer than any previously imposed for speaking out

against the Russian invasion. The following day, supporters

of Alexei Navalny, the most prominent critic of President Vladimir Putin who is serving 11-1/2 years for alleged fraud and contempt of court, said he had been beaten by prison guards for the first time and faced new charges carrying five more years for thwarting prison

The Kremlin says it has no say over court decisions and Navalny's treatment is a matter for the prison service. Putin has told Russians that the West is seeking to use traitors as a "fifth column" to sow discord and ultimately destroy Russia.

Since mid-March, Russia's parliament has also broadened censorship laws on what people can say about its armed forces and voted to extend the punishment for treason to life imprisonment instead of 20 years.

This week another opposition politician, Ilya Yashin, lost his appeal against an 8-1/2 year sentence for spreading "false information" about the armed forces.

"There is a move towards a real kind of totalitarian regime. It was perceivable already one year and a half ago but now it's become fullscale," said Nicolas Tenzer, senior fellow at the Center for European Policy Analysis and a personal friend of Kara-Murza.

#### **ARREST WARRANT**

The trend has accelerated since March 17, when Putin was accused of war crimes by the International Criminal Court. Though dismissed by Russia as legally void, given it is not a member of the ICC, the arrest warrant highlighted the fact that Putin has no way back - and therefore nothing to lose - when it comes to relations with the West.

"It seems that Putin really doesn't care about what the West is thinking... He just wants to go allout in his repression and in his war," Tenzer said.

### New Zealand exports its last livestock as ban takes effect

The ban comes after the sinking of livestock carrier Gulf Livestock 1 in 2020, carrying over 6,000 cattle bound for China, resulting in the death of all animals on board

Wellington, April 22: New Zealand's last exports of livestock by sea have been completed and live exports have ceased, its agriculture minister said Friday, as it fully implemented a ban on export shipments of animals on the grounds of their welfare.

The government announced in 2021 that shipping animals offshore, largely for building herds in trading partners like China. would be halted but farmers would be given two years to transition out of the profitable export business.

Our position on the map means that the journey to northern hemisphere markets will always be a long one and this brings unavoidable animal welfare challenges,'



Agriculture Minister Damien O'Connor said in a statement announcing that live exports had ceased.

Live exports by sea have contributed about 0.32% of New Zealand's primary sector export revenue, which includes farming and mining, since 2015. The total value of live animal exports in 2022 was NZ\$524 million (\$322.78 mil-

New Zealand said in 2020 it was reviewing live exports when it introduced interim measures following the capsizing of a ship bound for China that killed nearly 6,000 cows and 41 of the 43 crew members.

#### ICICI Bank profit **jumps 27% in Q4**

Mumbai: ICICI Bank Saturday reported a 27 per cent jump in its March quarter net profit on a consolidated basis to ₹9.852.7 crore on handsome growth in core earnings boosted mainly by lending rate hikes. On a standalone basis, the largest private sector lender reported a nearly 30 per cent jump in its standalone net to ₹9,121.87 crore, its highest ever for a three-month period. Powering the profit was the best growth in the core net interest income (NII) at 40 per cent to ₹17,667 crore, driven by a widening of the net interest margin to 4.90 per cent as against 4 per cent in the yearago period, and a nearly 19 per cent jump in advances. Its executive director Sandeep Batra told reporters that nearly half of its loans are linked to the repo rate, and get automatically repriced with every rate hike by the Reserve Bank, whereas the deposit rates increase with a lag, which helped the margins. Batra said the NIMs are near the peak and there will be a downward bias on the same, as the deposit rates in the system catch up. # Int'l trade in ₹ soon

Promoting international trade in the domestic currency will help in protecting the rupee from volatility and reduce cost of doing business in the global markets

Rajkot, April 22: Commerce and Industry Minister Piyush Goyal Saturday expressed hope that traders will soon be able to settle foreign trade in the rupee currency as several banks from different countries are opening special Vostro accounts with Indian banks.

The Reserve Bank of India (RBI) has approved 60 requests to open Special Rupee Vostro Accounts (SRVAs) of correspondent banks from 18 countries, including the UK, Singapore, and New Zealand.

The RBI, he said, is in discussion with the central banks of other countries on the matter. "We will soon start seeing operationalisation of this rupee trading in international trade with several countries," Goyal told reporters here.

He also said that negotiations for free trade agreements (FTAs) with developed regions like the European Union, the UK, and Canada are in "advanced" stages.

Groups including European Free Trade Association Free Trade Agreement (EFTA), Gulf Cooperation Council (GCC) and Eurasian Economic Union (EAEU) are also keen to start talks for similar pacts with India.

"The whole world wants to have a comprehensive economic partnership agreement with India," the minister said

### Pichai reaps over \$200mn in 2022 amid cost-cutting

Washington, April 22: Alphabet Inc Chief Executive Sundar Pichai received total compensation of about \$226 million in 2022, more than 800 times the median employee's pay, the company said in a securities filing Friday.

Pichai's compensation included stock awards of about \$218 million, the filing showed. His salary, however, has remained steady at \$2 million for the past three years, according to reports.

The pay disparity comes at a time when Alphabet, the parent company of Google, has been cutting jobs globally, The Mountain View, California-based company announced plans to cut 12,000 jobs around the world in January, equivalent to 6% of its global workforce.

Early this month, hundreds of Google employees staged a walkout at the company's London offices following a dispute over layoffs.

On January 20, Google CEO confirmed in a letter to employees that about 12,000 people will be laid off globally, accounting for more than 6 per cent of the total workforce.

Amid layoffs, tech giant Google is also creating several cost-cutting measures such as cutting down on free snacks and workout classes for its existing employees, the media reported.

The company's micro kitchen that provides free snacks like cereal, espresso, and seltzer water have been closed on days that typically have a significantly lower volume.

The company also discontinued spending on personal equipment like laptops, according to an internal memo.

Google India terminated more than 400 employees and some of the impacted workers took to LinkedIn to share their plight.

Chennai, April 22: The full reopening of the economy last year, cyclical recovery in consumption, increased private sector capex, and acceleration on government spending will contribute for 6.2 per cent growth in India's gross domestic product (GDP) in FY24, said Morgan Stanley in a report.

According to Morgan Stanley, the key for sustained domestic demand is a pickup in capex, which will help create more jobs, thus leading to a virtuous cycle of more jobs-to-higher income-higher savings-higher investment.

The headline consumer price index (CPI) print for March was in line with expectations.

"We expect inflation to decelerate more decisively in the quarter ending June, to below 5 per cent, supported by favourable base effect and moderating commodity prices. Inflation for April is currently tracking at 4.7 per cent YoY. We expect inflation to average around 5.5 per cent in F2024. with risks skewed to the downside from lower commodity prices," Morgan Stanley said.

On the Reserve Bank of India's (RBI) action on repo rate, it expects the rates to be on hold in calendar year 2023 as inflation will remain below the 6 per cent mark decisively and cuts to happen in the first quarter of 2024.

"Indeed, we expect inflation to track below 5 per cent in QE June and see downside risks to our forecast of inflation averaging 5.5 per cent in F24. While in our base case we expect a shallow rate cut cycle to start from 1Q24, we see risks of the same starting earlier based on an improving inflation outlook," the report notes.



Moscow, April 22: Russia's richest people added \$152 billion to their wealth over the past year, buoved by high prices for natural resources and rebounding from the huge loss of fortunes they experienced just after the Ukraine war began, Forbes Russia said.

Russia has 110 official billionaires in the list, up 22 from last year, according to Forbes' Russian edition, which said their total wealth increased to \$505 billion from \$353 billion when the 2022 list was an-

nounced. The list would have been longer

Global founder Yuri Milner, Revolut founder Nikolay Storonsky, Freedom Finance founder Timur Turlov, and JetBrains co-founders Sergei Dmitriev and Valentin Kipvatkov - renounced their Russian citizenship, Forbes said.

"Last year's rating results were also influenced by apocalyptic predictions about the Russian economy," Forbes said, adding that the total wealth of Russia's billionaires was \$606 billion in 2021, before the war began. After President Vladimir Putin

# Double delight for Jyothi in archery WC

Antalya, April 22: Indian compound archer Jyothi Surekha Vennam displayed some flawless shooting as she grabbed individual and mixed team gold medals in the World Cup Stage 1 here Saturday.

Jvothi and her debutant partner Ojas Deotale narrowly missed a world record when they tamed Chinese Taipei 159-154 in the compound mixed team final to open India's account with a gold in the morning session. While Jyothi had all perfect 10s in her eight arrows, the 20-year-old Deotale missed the centre once, in the final end when he shot a 9. The Indian duo missed the world record score of 160/160 by just one point.

This was also India's second ever World Cup gold medal in the mixed compound team event. Jyothi and veteran Abhishek Verma had clinched their maiden gold in World Cup 3 in Paris last year.

Returning in the afternoon session, the 2021 World Championship silver medallist Jyothi clinched her maiden individual gold at the showpiece with a lopsided 149-146 win over Sara Lopez of Colombia. The win avenged Jyothi's Yankton

World Championship 2021 defeat when she lost to the Colombian opponent in the final 144-146. **PERFECT CHEMISTRY** The new-look Indian pair hardly

looked short on experience and hit the centre an incredible 15 times from 16 arrows to defeat their 12thseeded rivals in a lopsided final. The second seeded Indian duo drilled 15 perfect 10s, of which 12 times they hit the X (closer to the centre).

## **Indian swimmer Aryan** equals WR at Sea of Galilee

Jerusalem, April 22: Indian swimmer, Aryan Singh Dadiala, Friday, equalled the existing world record of the fastest male swimmer to swim the Sea of Galilee, braving extreme weather conditions.

Sea of Galilee is the second lowest water body in the world, approximately 214 metres below sea level, and poses multiple challenges such as whirlpools and indefinite wind storms.

Dadiala, 21, who set a world record in November 2022 in Goa finishing 32 km open water sea swimming in 5 hours 36 minutes, is the first Asian swimmer to swim the Sea of Galilee. He started his swim at 5.18 am Friday when it was pitch dark and extremely cold and finished the challenging swim at 11:33 am, equalling an existing world record of the fastest male swimmer to swim the Sea of Galilee in his very first attempt.

The record for the fastest one-way swim was set by Guy Cohen in 2017 in his seventh attempt, as per records shared with PTI by Aryan's



father, Surjeet Dadiala.

The event was observed and certified by Galilee Marathon Swimming Association, Israel and flagged off by Indian diplomat Pawan K Pal, who leads the public diplomacy division at the Indian embassv in Tel Aviv.

"Aryan Singh Dadiala, a 21 yr old Indian swimmer breaks barriers and swam across the #SeaofGalilee (20.5 km length) in 6hrs 15 mins," a tweet from the Indian mission said.

Aryan said that he took up the challenge in order to "strengthen India and Israel relationship". He said that he is "extremely impressed" with the vision of Prime Minister Narendra Modiji's – the first Indian Prime Minister to visit Israel in 2017.
