lease period (30 years), the lessee and the department may mutually agree to extend the lease period by another 30 years. The lessee will not be required to pay any additional premium for such extension. Only the rate of biennial escalation in the annual lease rental shall be negotiated for the additional lease period, they said.

The lessee will have to design, redevelop, upgrade, augment, finance, manage, market, operate, maintain and repair/refurbish the property and project assets at its own expenses in accordance with the prescribed provisions, standards and specifications, applicable laws,

terms of applicable permits and good industry practices.

The lessee, if required, may demolish a part or whole of the property, other than BN Palace Paralakhemundi, for re-development purposes with prior approval from the department

For BN Palace, the lessee can develop the property into a Heritage Hotel without compromising the heritage nature of the property and in compliance with the norms specified in guidelines for Classification of Heritage Hotels issued by the Union Ministry of Tourism.

Asked about the threat aspects, the Navy chief spoke of both conventional and non-conventional threats, besides those emerging from what he described as "silent and inclusive paradigm" resulting in a "web of threats" that are emerging

The Indian Navy's role is to protect, promote and preserve national interests in the maritime domain, wherever they are, and it assesses the threats and challenges

On a daily basis, it is being seen that there is a certain amount of contestation happening at sea. It is well below the threshold of conflict, but possibility of a full-fledged can-

As far as their visit to ports in Pakistan are concerned, "we are seized of it, and keep a watch on it," he said

Admiral Kumar said the Pakistan Navy is modernising itself at a good pace and seeks to become a 50platform force in 10-15 years, and they are adding new corvettes and frigates to their fleet.

As far as China is concerned, in the last 10 years, a large number of ships and submarines have been commissioned by it in the last 10 vears, the third aircraft carrier is under construction, and much larger destroyers they are working on, he said, adding, "we feel this will plateau at some time".

China rover finds evidence of water in Mars

THE FINDING HIGHLIGHTS NEW AND POTENTIALLY FERTILE AREAS IN THE WARMER REGIONS OF MARS WHERE CONDITIONS MIGHT BE SUITABLE FOR LIFE TO EXIST. THOUGH MORE STUDY IS NEEDED

Cape Canaveral, Fla, April 29: Water may be more widespread and recent on Mars than previously thought, based on observations of Martian sand dunes by China's rover.

The finding highlights new, potentially fertile areas in the warmer regions of Mars where conditions might be suitable for life to exist, though more study is needed.

This news comes days after mission leaders acknowledged that the Zhurong rover has yet to wake up since going into hibernation for the Martian winter nearly a year ago. Its solar panels are likely covered with dust, choking off its power source and possibly preventing the rover from operating again, said

Zhang Rongqiao, the mission's chief designer. Before Zhurong fell silent, it observed salt-rich dunes with cracks and crusts, which researchers said were likely mixed with melting morning frost or snow as recently as a few hundred thousand years ago.

Their estimated date range for when the cracks and other dune features formed in Mars' Utopia Planitia, a vast plain in the northern hemisphere: sometime after 1.4 million to 4.00.000 years ago or even younger. Conditions during that period were similar to now on Mars, with rivers and lakes dried up and no longer flowing as they did billions of years earlier. Studying the structure and chemical makeup of these dunes can provide insights into "the possibility of water activity" during



this period, the Beijing-based team wrote in a study published in Science Advances "We think it could be a small amount

... no more than a film of water on the surface," co-author Xiaoguang Qin of the Institute of Geology and Geophysics said in an email.

The rover did not directly detect any water in the form of frost or ice. But Qin said computer simulations and observations by other spacecraft at Mars indicate that even nowadays at certain times of year, conditions could be suitable for water to appear.

What's notable about the study is how young the dunes are, said planetary scientist Frederic Schmidt at the University of Paris-Saclay, who was not part of the study. "This is clearly a new piece of science for this region," he said in an email.

Small pockets of water from thawing frost or snow, mixed with salt, likely resulted in the small cracks, hard crusty surfaces, loose particles and other dune features like depressions and ridges, the Chinese scientists said. Contd....P4

Bhubaneswar, April 29: The India Meteorological Department (IMD) Saturday said a low pressure area is likely to take shape over south Bay of Bengal (BoB) around May 5.

Speaking to media in New Delhi, IMD director general (DG) Mrutyunjay Mohapatra said a low pressure area is likely to develop over south BoB around May 5. There is a possibility that the low pressure area may intensify into a depression, he said.

"However, only after formation of the low pressure, we can say whether it will further intensify into a cyclone or not," said Mohapatra.

On the likelihood of its further intensification into a cyclone, the IMD DG said a clear picture of the system can be known only after the low pressure forms. It is expected to emerge around May 1, he informed the media.

Making it clear that no forecast about any cyclone has been made so far, the IMD DG appealed to the people not to panic.

Mohapatra further informed

clones during May in the pre-mon soon season in the region, he maintained.

Meanwhile, the weather office said that parts of eastern India, including Bihar, Jharkhand and Odisha, are likely to face abovenormal temperatures in May with a likelihood of heat wave conditions on some days

However, parts of northwest and west-central India may experience warmer nights and below-normal temperatures during the day, the India Meteorological Department said in the monthly outlook for temperature and rainfall for May.

It said normal to above-normal rainfall is expected in the northwest and west central parts of the country in May, including in Punjab, Haryana, Rajasthan and parts of western Uttar Pradesh. Large swathes of the northeastern region, Kerala, Andhra Pradesh and south Karnataka, are expected to witness below-normal rains.

According to the weather office, the average rainfall in May is likely to be 91-109 per cent of the Long

Bhubaneswar, April 29: The state government has enhanced the base remuneration of tutors, senior residents (SRs) and junior residents (JRs) working in medical college and hospitals (MCHs), Health and Family Welfare (H&FW) commissioner-cum-secretary Shalini Pandit said Saturday.

According to Pandit, the state government has also approved location-based incentives for the MCH teachers posted in far flung areas

"The enhancement of base remuneration and location-based incentives will help attract best teachers to the state-run MCHs and will subsequently go a long way improving healthcare in Odisha," Pandit pointed out.

She said for location-based incentives, places have been cate-



gorised under three zones.

"While Koraput, Nabarangpur, Malkangiri, Rayagada, Bolangir, Nuapada, Kalahandi and Kandhamal fall under Zone-A. Keonjhar, Boudh, Balasore, Gajpati, Sonepur, Deoghar, Bargarh, Sambalpur, Jharsuguda, Angul, Sundargarh and Mayurbhanj come under Zone-B," the H&FW commissioner-cum-secretary said.

Similarly, Zone-C has Dhenkanal, Puri, Nayagarh, Kendrapada, Jajpur, Bhadrak and Jagatsinghpur, Pandit said, pointing out that there

The rover has now provided "evidence that there may be a wider distribution of this process on Mars than previously identified." said Trinity College Dublin's Mary Bourke, an expert in Mars geology.

So, there is a large presence of Chinese vessels in the Indian Ocean Region, and India Navy keeps track of it, the Navy chief said. "So, we refine our plans, actions that are required to be taken. and this also feeds into our capability development," the Navy chief said.

Later, in response to a query from audience on Chinese research vessels, Admiral Kumar said, these vessels have the ability to track and collect electronic signals.

When they operate, close to "our areas of national interest", the Indian Navy keeps an eye, and it has its ships which "monitor them very, very closely'

On a question on whether modernisation and capability development has any link with threat assessment, he said, modernisation is part of the process and not threat-driven. And, a Navy has to be a "well-balanced force", so, it's not about nuclear subma-

rine vis-a-vis aircraft carrier, as each of the two bring their own capabilities and they are "not either/or", Admiral Kumar said.

On Atmanirbhar Bharat, he reiterated that the Indian Navy has "committed to the national leadership that we (Navy) will be fully Atmanirbhar by 2047".

38 villages in Ganjam get revenue status under FRA

Ganjam, April 29: As many as 6,000 villagers who live in 38 forest and unsurveyed villages in Ganiam district will be benefited as their villages have been granted revenue status under the Forest Rights Act and Orissa Survey and Settlement Act.

In a major development, the Ganiam District Magistrate recently announced the conversion of these 38 forest villages into revenue villages after approval from the Board of Revenue, Odisha.

These are now revenue villages under Section 2 (14) of the Orissa Survey and Settlement Act, 1958 and in pursuance of Section 3(1)(h) of the Scheduled Tribes and other **Traditional Forest Dwellers** (Recognition of Forest Rights) Act. 2006 or FRA, the notification by the Magistrate stated.

These villages have received their new status after over five years with the process to achieve it being started in 2017, according to a statement by the district administration.

This has come as a sigh of relief for the dwellers as previously they required permission from the Forest department even for a small developmental activity to be taken up in these villages. The villages are identified as 'zero' villages in the census report, but inhabited by people.

The newly recognised revenue villages are spread across two subdivisions — Chhatrapur and Bhanjanagar. While 13 of these villages each are in Sorada and Polasara tehsils, seven are situated in Dharakote tahsil and five in Kodala tehsil. With these 38 unsurveyed villages in Ganjam district getting revenue status, only one unsurveyed village is left in the district to be mainstreamed.

Previously, 14 other forest villages of three Odisha districts -12 in Dhenkanal and one each in Angul and Deogarh-have already been converted into revenue villages. Notably, there are as many as 458 forest and unsurveyed villages in Odisha, as per state government data.

Barna Baibhaba Panda, Senior Programme Manager, Foundation for Ecological Security (FES), which facilitated the process of conversion under FRA, said, "Life is tough in

unsurveyed villages. Most of these villages do not have basic facilities such as drinking water supply, schools and anganwadi centres and more importantly an allweather road.

However, the residents of the villages, mostly tribals, will now be able to avail of all government benefits such as rights over land and employment guarantee under MGNREGS, caste, income and residence certificates and the right to purchase and sell land without depending on permissions of the Forest department. Government institutions can also be established now in these villages

It should be noted that the 1878 amendment to the Forest Act divided India's forests into three categories - reserved, protected, and village forests.

According to the new regulations, some people were allowed to live in restricted forests as long as they offered the Forest department free labour to chop and transport trees and guard the forest against fires. These woodlands eventually earned the name 'forest villages'

The former United Progressive Alliance government in 2013 acknowledged the settlement and conversion of all forest villages and unsurveyed villages into revenue villages under Section 3(1)(h) of the FRA, 2006.

One dead, 9 hurt in 2 separate mishaps

Bhadrak: At least one person died and nine other sustained serious injuries in two separate road accidents which occurred Saturday in Bhadrak district. As per sources, one accident took place near Bhandaripokhari tehsil office in the morning when a car coming from Balasore collided with a speeding truck. One person died on the spot and four others were injured. The injured were admitted to the Bhadrak district headquarters hospital for treatment. A separate accident took place near Tisalpur Square under Bhadrak Rural police limits where a truck from Kolkata carrying chickens from Odisha overturned after hitting a stationary truck on the road. Five persons in the truck, who hail from West Bengal, were injured in the accident. They were first admitted to the Bhadrak DHH and later three of them were shifted to SCB Medical College and Hospital in Cuttack as their condition deteriorated.

LOOT, MURDER OF GOAT TRADER

7 arrested, 2 pistols seized [§]

Sundargarh/Lefripara, April 29: Police have arrested seven persons in connection with the loot and murder of a goat trader near Suruguda Tarini temple in Sundargarh district, April 13. Two bikes, two country-made pistols along with six rounds of live cartridges, seven mobile phones, and ₹9,500 in cash were also seized from their possession.

Addressing a presser here Saturday, Sundargarh SP Pratyush Dibakar informed that the accused have been identified as Sudhir Kisan of Chaunrdhal village under Bhasma police limits. Pramod Majhi, Sujit Majhi, and Pradip Singh of Gudiali village

under Rajgangpur police limits, Kheswar Gop and Arun Oram of Gumla in Jharkhand and Mohanty Badaik of Salangabahal under Raiboga police limits. Reports said, three miscreants

on a bike had followed goat trader Pravat Naik and two of his associates who were going to the Handipani goat bazaar on a motorcycle April 13 morning. They threatened Pravat to stop showing him the pistol near the temple.

Failing to stop Pravat, they kicked his motorcycle following which he fell down and tried to escape with the bag containing money.

The miscreants fired while Pravat was trying to flee with the money bag killing him on the spot. They looted the money bag which reportedly contained ₹9 lakh.

Following the incident, Sundargarh SP formed a team headed by SDPO Himanshu Chandra Behera to nab the culprits. The SP told reporters that the incident was pre-planned and the motive of the accused was loot and as Pravat resisted, they fired at

him leading to his death. He said that the accused persons had even done a recce before committing the crime.

Woman, 3 sons get life term in 2018 murder case

Bhawanipatna, April 29: A woman and her three sons were awarded life imprisonment by the Additional District Judge (ADJ) of Dharmagarh in Kalahandi district for killing a peon posted at Atigaon RI office under Junagarh police limits over land dispute in 2018. The court has also imposed fine

of ₹50.000 each on all four convicts. Falling to pay the fine amount, the jail term of the convicts will be increased by a year each.

The convicts have been identified



as Kuchita Dandasena, and her three sons Pita Dandasena, Radhu Dandasena and Jadu Dandasena. As per sources, the victim peon, Chhayakanta Dandasena, was hacked to death by the three sons after getting instructions from their mother in 2018. Sources further added that at that time Kuchita and her sons

were trying to build a house on a piece of government land near the RI office. When the peon Dandasena objected to them he was murdered, added the source. The police at that time had registered a murder case and arrested all four of them.

abka Saath is a lie or a delusion. More likely a lie because exclusion is deliberately perpetrated and institutionalised in the BJP. It has no Muslim MP or MLA but says Sabka Saath. Its ministers garland those who are convicted of lynching minorities, but it says Sabka Saath. Who is it fooling? Nobody, but it wants to say the words because it is not honest. Or perhaps it was a nice-sounding jumla at the time. Or perhaps that time was not right for the party to openly claim what it really stands for. Whatever we conclude as the reason, it is inescapable that the slogan itself is untrue because the numbers do not lie. Beti Bachao is not a convincing phrase in the mouths of those who free convicted rapists for coldly-calculated political benefit. Beti Bachao is a jumla when BJP supporters, national heroines in their field, must sit in protest to beg for action against their oppressor. The government is reluctant to act because the man is a long-term party MP and it senses there might be political benefit in not acting. This is the only reason it looks away from, and in that sense condones and encourages harassment of India's daughters. And it claims to promote Beti Bachao, though in court it is unwilling to reveal the reasons for choosing to release rapists. Again, mark the reluctance to reveal oneself honestly.

In how many democracies is the political rhetoric this disjointed from the

reality of the nation? One cannot think of any, really. Of course hypocrisy and lies are a part of all political activity, and that is the reason why many people are not attracted to it. But this level of fake piety and pretend virtue while the deception is visible for all to see is likely unique to us and that is why we have to talk about it.

It is remarkable that a political party can do this and assume it can get away with it forever, but such is the arrogance of power and this time the delusion is likely real. On the one hand there is a mass media that is feeding at the trough and happy to be seen as a cheerleader for the government, if not aching to be an actual part of the official propaganda machine. From them we can expect no honest survey or assessment. Add to this a set of the world's most craven celebrities, film stars, musicians and cricketers. Unwilling to stand up even for their own when they are tortured and persecuted. Both too afraid to speak and too selfish and greedy to put at stake the riches they have gathered through their fame. And so externally there is no large dissenting, authoritative and popular voice to point out that what is being shown as day is really night. And on the other the leader is shielded by those who

line up to say in public the opposite of what is manifest and apparent and what probably even they believe to be true. This works in particular with those leaders who have convinced themselves that they can only ever do the right thing. They want to be shown the evidence of this and there is no shortage of people available to do this.

If the leader holds gigantic rallies when the second wave of the pandemic devastates the land, the aides will prove that his rallies do not spread COVID. The BJP first passed a resolution, just before the second wave started, declaring that the Prime Minister had defeated the COVID pandemic and then deleted the resolution from its website.

When religious bigotry is exposed as the fundamental pillar of BJP politics, they will show that in the distribution of entitlements, the party does not discriminate against minorities (as if such a thing were even possible, and as if anyone had ever accused them of doing this, but let us set that aside for now). If joblessness and low wages are being experienced by crores of people and being reported on daily, they will conjure data that show this is not the case and India is in fact not only marching into 'amritkaal' but already in it. The government's own data that shows poverty increasing and consumption, including on food, decreasing between 2012 and 2018 is discarded because it is inconvenient. COMPANIES WITHOUT DETAILED TRANSITION PLANS IN PLACE CAN EXPECT REGULATORY AS WELL AS LEGAL ACTION, AS

SAYING & DOING

udging by the growing number of companies vowing to reduce their greenhouse-gas emissions to zero these days, it may seem like the corporate world is finally taking the climate crisis seriously. According to the Net Zero Tracker, more than onethird of the world's largest publicly traded companies have announced such targets, up from one-fifth in late 2020.

While some of these corporate pledges appear to be genuine, others are clearly a fig leaf to obscure pollution as usual. One can easily imagine an oil executive telling an airline boss: "A net-zero target, some ads featuring trees, and everyone will love us."

If that was the plan, it is rapidly falling apart, owing to a slew of regulatory decisions and court actions that signal a crackdown on corporate greenwashing. And last year's report by the United Nations High-Level Expert Group on Net-Zero Emissions Commitments, which provided detailed recommendations for maintaining the integrity of such pledges, heralds limits on companies' ability to make promises they have no intention of keeping.

New regulations in France and the United Kingdom, for example, aim to prevent advertisers from making extravagant claims about the carbon neutrality of their products. Research commissioned by the UK's Advertising Standards Authority (ASA) found that when people hear such a claim, they assume that an absolute reduction in emissions has occurred. So, the ASA's updated guidelines instruct companies to avoid claiming carbon neutrality if the emissions associated with the advertised product were merely offset.

The French climate law, passed in 2021 and amended last year, goes further. To claim carbon neutrality, the product must be neutral across its entire life cycle. Companies must disclose how emissions were avoided, reduced, and offset (the order is important). They must also show how these offsets qualify as measurable, verifiable, permanent, and additional. Companies that get it wrong could face a €100,000 (\$110,000) fine for misleading consumers.

Underlying this trend is the obvious mismatch between what some companies say and what they do. After all, one does not need to be a sleuth to figure out that when a company can claim that a barrel of oil, a cargo of liquefied natural gas, or some tar sands bitumen is carbon-neutral, something has gone wrong.

A spate of recent lawsuits promises to draw a line in the (tar) sand. Over the past year, companies such as food giant Danone Waters, cement maker Holcim, oil companies TotalEnergies, BP, and Shell, cosmetics manufacturer Beiersdorf (Nivea), and KLM have been sued in various countries for making misleading sustainability claims. The Australia Institute, a nonpartisan think tank, has filed a complaint with the Australian Competition and Consumer Commission claiming that the government's own certification scheme. Climate Active, is misleading under national consumer law, because it assures people that products are carbon-neutral when they are not.

Companies' net-zero pledges look just as flimsy under scrutiny. For example, a recent report by the Corporate Climate Responsibility Monitor examined the net-zero plans of 24 major corporations purporting to be "climate leaders" and found numerous flaws. loopholes, and omissions. On average, according to the report, these companies will cut just 36% of their emissions by their netzero target year. Moreover, their plans imply a median reduction of 15% by the end of the decade. rather than halving emissions, as the current science says is necessary. Similarly, an earlier report by CDP found that fewer than one in 200 companies that submitted climate data to its environmentaldisclosure platform have devised credible transition plans.

The UN group's recommendations, commissioned and endorsed by Secretary-General António Guterres, are a potential game changer. As they become mainstreamed, companies will no longer be able to claim that they have a credible net-zero plan unless they have set a decarbonisation pathway compatible with the 2015 Paris climate agreement's targets. Such plans must include measures to reduce emissions along the entire value chain, phase out fossil fuels, invest in renewable energy, abstain from lobbying for high-carbon industries, disclose emissions annually, have reductions data independently verified, and so on. An ad campaign, a cheery speech, and some tree-planting will no longer do.

Companies without detailed transition plans in place can expect regulatory as well as legal action, as more and more countries re quire corporations to disclose climate-related risks. The European Union, India, New Zealand, and Switzerland are expected to join the UK and China by introducing such measures this year, followed by Canada and South Korea in 2025 The International Organization for Standardization has also recently published its own set of net-zero guidelines, providing regulators with clear rules and criteria for credible climate strategies.

But if the world is to achieve net-zero emissions by 2050, regulators must insist on independent verification of corporate claims, interim targets, and binding commitments to phase out fossil fuels. In countries where national net-zero plans rely on offsets and wishful thinking, citizens must use all the legal tools at their disposal possible to force their governments to do the hard work that a credible decarbonisation path demands.

While there is still much work to be done, a carbon-neutral future is within reach. Net-zero targets now cover 91% of global GDP, compared with 16% just four years ago. But to have any hope of meeting the Paris agreement's targets, the first step is to ensure that governments and companies are setting realistic goals that they can back up with credible data. We can see the right path ahead, but the right decisions are still needed to ensure it is taken.

Hippodroming

he original hippodromes were chariot-racing circuits of classical Greece (the term is from hippos, horse, plus dromos, a race or course). The term was imported from France to Britain in the early nineteenth century for a related spectacle and was later applied in Britain to a theatre that offered a varied bill. Hippodromes, these days conventional theatres, survive in some British cities, notably London, Bristol and Birmingham. In America travelling entertainments often advertised themselves grandly as hippodromes after the French model. An early example was Franconi's Hippodrome, which ran in New York for two seasons in 1853 and 1854. Contemporary illustrations show that this featured indoor chariot races in a circuit similar to those of ancient Greece. The idea was taken up by travelling shows, which often advertised themselves as both circuses and hippodromes. Since the original circus was the Roman equivalent of the hippodrome, that sounds like an etymological tautology, but they were different entertainments. The circus rings featured the familiar animal acts, clowns and acrobats and were surrounded by a hippodrome track. Since the races on these hippodromes were designed as entertainments rather than serious sporting contests, we may guess that who won and lost was supervised by the management to maximise the audience's pleasure. When serious contests were fixed, it wasn't a huge jump for people to call the practice hippodroming. The first examples date from the 1860s. A direct link with horses was quickly lost, since even early examples refer to boxing, athletics and other sports. In the twentieth century, car and aeroplane racing were added. The term was still occasionally to be found as late as the 1970s.



Would the economic fundamentals change with the Karnataka elections? They just might. The Assembly polls have drawn a serious debate on the GST rates. The clamour is now for one rate against the four prevailing.

The issue has become a key controversy and has been blamed for high prices even as collections are swelling to almost an average of ₹1.40 to 1.50 lakh crore a month. The issue has been catching up the imagination of the business class, which is bearing the brunt. The penalty provisions are stated to be atrocious and any failure, even for ignorance of the law, means extraction of heavy multiple penalty payments.

The traders are raising the issue. This resulted in the issuance of 869 corrective notifications, 143 circulars and 38 orders. It's a complicated task for seeking correction. The pleas have to include all the points to justify an argument that should have been a natural process. Since the GST structure is turning political and many state elections follow, the victory or loss in Karnataka would not bury the hatchet. Whosoever wants to be in the saddle, has to drastically change the law. Indian businesses would prefer to have the changes fast.

The FICCI says there is no need for a separate classification for capital goods, input and input services in the GST laws. It reiterates that for minimising disputes, the scope for interpretation should be eliminated.

The CII is for the central government reducing the 28% GST rate and decriminalisation of the said law. It suggests that the applicability of the prosecution provisions must not be on the basis of the total amount of the evasion of the tax but "on real intent to evade the taxes along with a certain percentage of the tax payable."

The ASSOCHAM is for further streamlining the system. Almost all want fuel being covered by GST to reduce the tax burden on fuel. Petroleum fuel has 32% cess; till November 4, 2021, excise duties were ₹27.90 per litre on petrol and ₹21.80 on diesel. It was cut to ₹19.90 and ₹15.80 respectively. It has a heavy component of road cess too. The amount being collected by the Centre as excise duty/cess for each litre of petrol is ₹32.90 and ₹31.8 per litre on diesel. There is a com-

ponent of state taxes on average of be 25 to 29%.

The break-up of retail prices of petrol and diesel in Delhi, shows that around 54% of the retail price of petrol comprises Central and states taxes. In the case of diesel, this is close to 49%. If it is subsumed in GST, as suggested by most business associations, it would substantially lower the fuel price. The Centre and many states have reservations.

This is no more an economic issue but is turning political as the Congress is raising it frequently during election campaigns. It has taken the affront to change the law to suit the needs of the people and possibly put it in tune with what the UPA had envisaged. Raising it at a rally on April 24 at Beglavis's Ramduraga, Congress leader Rahul Gandhi said the party would effectively change the law. He promised to change the GST structure and ensure remunerative prices to farmers if his party "is elected to power at the Centre." Further, he said that contrary to the concept of the GST to help all, it has been "brought only to help the influential and it is complicated. Small businesses have been shut. We shall

better farm marketing too." Rahul asserts, "There will be one tax and it will be a minimum." He says the current slabs 5, 12, 18 and 28% would be done away with.

and 28% would be done away with. His party is for a maximum slab of 18%. But that is a catch. An 18% high cannot be the one rate. The minimum now is too high at 5%. It has to come down to 2%. So, the debate will go on, but it creates pressure for change.

The simple looking issue has touched the sentiments of the voters, more so as the BJP has not challenged the Congress contention. The BJP is facing sharp attacks on its governance issues in the state amid many allegations. The Congress is also raking up the issues of destruction of the medium and small industries, breakdown of trust between the states and the Centre and "consensus' in GST as a sham as the "Centre pushes through decisions."

Since then, counter-charges have become acerbic. Whatever be the results, it is certain that the GST might go through drastic changes.

Country's first cable-stayed rail bridge in Reasi completed

Jammu, April 29: The work on the country's first cable-stayed railway bridge at Anji Khad in Reasi district of Jammu and Kashmir has been completed, Railway Minister Ashwini Vaishnaw said. The completion of the bridge drew praise from Prime Minister Narendra Modi who is keenly monitoring the Udhampur-Srinagar-Baramulla Railway Link (USBRL), which will provide rail connectivity between the Kashmir Valley and the rest of the country.

"In 11 months, India's first cablestayed rail bridge (Anji Khad) is ready...," Railway Minister Ashwini Vaishnaw tweeted on Friday, sharing a video of the completed bridge. The total length of the cable strand used in the bridge is 653 km.

Reacting to Vaishnaw's tweet, the prime minister wrote "excellent". The completion of Anji Khad bridge, having a single pylon with a height of 331 metres above the river bed on Udhampur-Srinagar-Baramulla Rail Link (USBRL), is yet another major breakthrough achieved by the Indian Railways, which is expecting to complete the ₹37,000 crore project by the

end of this year. Minister of State for Railways Darshana Vikram Jardosh, who recently inspected the USBRL project by visiting various key locations including Anji Khad bridge and the



nearby iconic Chenab bridge, termed the completion of the country's first cable-stayed bridge as "an-

congratulated everyone for successfully installing all 96 cables of the bridge in a record time of 11 months. This asymmetrical cable-stayed bridge crosses the deep gorges of Anji river, a tributary of river Chenab," she said.

Jardosh said the bridge connects tunnel T2 on the Katra side and Tunnel T3 on the Reasi side. "It has been the PM's vision to make Indian railways the best in the world. Overcoming geographic and climatic challenges, our engineers and railway officials have conquered the invincible," the minister said.

Described as a "true engineering marvel", the bridge has 48 cables each on lateral and central spans with work on its pylon started in 2017, officials said, adding the pylon is standing 191 metre from its foundation level.

They said it is the second highest railway bridge after the iconic arch bridge over Chenab at Kauri, which is the highest railway bridge in the world being 359 metres above the river bed level -- 35 metres higher than the iconic Eiffel tower in Paris.

Anji Khad bridge has a total ২ length of 473.25 metres, while the length of the viaduct is 120 metres. The central embankment has a length of 94.25 meters, the officials said. They said the bridge has been designed to handle heavy storms of strong winds and even explosions.

"The court of Additional Sessions Judge/First MP-MLA Court Durgesh also imposed a fine of Rs 5 lakh on Mukhtar and Rs 1 lakh on Afzal," ADGC Criminal Neeraj Srivastava said. Afzal, the MP from Ghazipur,

was produced in the court, while his brother Mukhtar attended the proceedings via video conferencing. Afzal was later taken into custody and sent to jail.

The verdict could lead to Afzal losing his Lok Sabha membership. According to the Representation of the People Act, any member will be disqualified if convicted and sentenced to imprisonment for two years or more

Congress MP Rahul Gandhi (from Wayanad in Kerala) and UP legislators, including Azam Khan (Rampur), his son Abdullah Azam (Suar) and BJP's Vikram Saini (Khatauli-Muzaffarnagar), had recently lost their memberships under the provisions of the same Act.

two. After hearing the arguments of both the sides, the court reserved its decision which was pronounced Saturday.

After the court's verdict, Rai's nephew Anand Rai expressed his gratitude to the court as well as Chief Minister Yogi Adityanath. He said, "Today, (Yogi) has made Uttar Pradesh fear-free, whereas in the previous governments of the opposition, goons used to act like mafia.

Mukhtar is presently lodged in Banda jail. He had been an MLA for five consecutive terms from Mau Sadar assembly seat in neighbouring Mau district of Uttar Pradesh. The gangster-politician did not

contest the 2022 assembly elections and his seat was won by his son Abbas Ansari from the Suheldev Bharatiya Samaj Party.

Hyderabad, April 29: The recent evidences from the archaeological site at Pattanam, on the South-Western coast in Kerala's Ernakulam district, and their ancient DNA analyses strengthen the belief of historians that Pattanam played an 'instrumental role' in trade and cultural exchanges between India and the Middle East and others, scientists said Friday.

The archaeological site at Pattanam is believed to be part of the ancient port city of the Muziris. Historians consider the city of Pattanam to have played an instrumental role in trade and cultural exchanges between India and the Middle East. North Africa and the Mediterranean regions.

The belief stems from the classical Greco-Roman records as well as Tamil and Sanskrit sources.

"The recent and more conclusive archaeological evidences from Pattanam, and their ancient DNA analyses led by chief scientist at CSIR-Centre for Cellular and Molecular Biology (CCMB) Kumarasamy Thangaraj and PJ Cherian strengthen the belief, and is now published in the journal, Genes," the city-based CCMB said in a release.

At the Pattanam Archaeological Site, scientists and archaeologists have found, among others, human bones, storage jars, a gold ornament, glass beads, stone beads, utilitarian objects made of stone, copper and iron, pottery, early Chera coins, brick wall and a sixmeter-long wooden canoe parallel to the wharf structure about 2.5



m below surface level, it said. "These structures indicate a

vast 'urban' settlement. The excavations suggest that the site was first occupied by the indigenous 'Megalithic' (Iron Age) people, followed by the Roman contact in the Early Historic Period. It appears that the site was continuously occupied at least from the 2nd century BC to the 10th century AD,' said PJ Cherian, from PAMA Institute for the Advancement of Transdisciplinary Archaeological the city of Pattanam to have played an instrumental role in trade and cultural exchanges between India and the Middle East, North Africa and the Mediterranean regions

Fortunately for the task force team, the elephant did not go deeper inside the forest, and the first tranquiliser shot was done at 11.55 AM. The first booster dose was shot at 12.40 PM and another five boosters were given subsequently.

The elephant, however, put up

great resistance when the Kumki elephants tried to push him into the vehicle.

The task force members also could not cover its eyes with a black cloth, a procedure usually done during animal rescue, to keep it calm.

The officials used the arm of an earthmover to reach the top of the animal in the truck to fix a GPS-enabled radio collar, which was insisted on by the Kerala High Court. Mission Arikomban had gone through several controversies, with animal rights activists opposing the move of the forest department to capture and tame it to become a Kumki elephant at Kodanad Elephant centre in Ernakulam district.

They petitioned the High Court, and the court, after hearing the plea, stopped the department's move.

Padlocks on girls' graves to avoid rape in Pakistan

EVEN DEAD ARE NOT SPARED IN PAKISTAN AS WOMEN'S BODIES HAVE BEEN UNEARTHED AND DESECRATED ON MULTIPLE OCCASIONS IN THE PAST

Islamabad, April 29: In a shocking revelation, more and more people are keeping the graves of women members of family under lock and key as necrophilia cases are on the rise in Pakistan, according to reports.

While necrophilia cases have been reported in Pakistan before too, some social media users, including activists and authors, raised the matter once again.

That a woman is raped every two hours in a country taking great pride in its family-oriented values has been hammered to the point of repetition in our collective conscience. But the heart-wrenching sight of padlocks on the graves of females is enough for the entire society to hang its head in shame and never dare to look at the so-called vessels of honour, read Daily Times editorial.



Harris Sultan, an ex-Muslim atheist activist and the author of

the book "The Curse of God, why I left Islam" blamed hardline Islamist ideology for such depraved acts. "Pakistan has created such a horny, sexually frustrated society that people are now putting padlocks on the graves of their daughters to prevent them from getting raped. When you link the burga with rape, it follows you to the grave," Sultan tweeted Wednesday.

This is being done as a desperate bid to ensure the sanctity of dead bodies in case some randy monsters cherry-pick them to satiate their lust. Considering the rampant rise in necrophilia, one can't help but understand the urge to protect loved ones, reported Daily Times. Another Twitter user Sajid

Yousaf Shah wrote, "The social environment created by #Pakistan has given rise to a sexually

charged and repressed society, where some people have resorted to locking their daughter's graves to protect them from sexual violence. Such a connection between rape and an individual's clothing only leads to a path filled with grief and despair.

The scariest necrophilia case ever reported in Pakistan was in 2011 when a gravekeeper named Muhammad Rizwan from North Nazimabad, Karachi was arrested after he confessed to raping 48 female corpses. Rizwan was caught running away after desecrating a corpse. He had caught the attention of nearby grave diggers and some other people.

According to National Commission for Human Rights, more than 40% of Pakistani women have experienced some form of violence at least once in their lifetime.

US confiscates Iran oil cargo on tanker

Washington, April 29: The U.S. confiscated Iranian oil on a tanker at sea in recent days in a sanctions enforcement operation, three sources said, and days later Iran seized another oil-laden tanker in retaliation, according to a mar-

As oil markets remain jittery, the cargo seizure is the latest escalation between Washington and Tehran after years of sanctions pressure by the US over Iran's nuclear program. Iran does not recognise the sanctions, and its oil exports have been rising.

Tehran says its nuclear program is for civilian purposes while Washington suspects Iran wants to develop a nuclear bomb.

Maritime security company Ambrey said the US confiscation took place at least five days before Iran's action Thursday. "Ambrey has assessed the seizure by the Iranian Navy to be in response to the US action," it said in an advisory to clients. "Both tankers were Suezmax-sized. Iran has previously responded tit-for-tat following seizures of Iranian oil cargo.

The sources familiar with the matter, who declined to be identified due to the sensitivity of the issue, said Washington took control of the oil cargo aboard the Marshall Islands tanker Suez Rajan after securing an earlier court order. The tanker's last reported posi-

US set to modernise H-1B visa registration

US DETECTS FRAUD & ABUSE IN COMPUTERISED H-1B LOTTERY SYSTEM

Washington, April 29: A US federal agency has announced plans to modernise the H-1B registration process after detecting abuse and fraud by some companies to artificially boost their chances of winning the coveted visa for their skilled foreign workers in the computerised drawing of lots.

The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise. Technology companies depend on it to hire tens of thousands of employees each year from countries like India and China.

In an unusual statement, US Citizenship and Immigration Services (USCIS) Friday said, based on evidence from the Financial Year 2023 and Financial Year 2024 H-1B cap seasons, it has already undertaken extensive fraud investigations and denied and revoked petitions.

The USCIS, the federal agency that awards H-1B visas, said it is in

the process of initiating law enforcement referrals for criminal prosecution. It said that it has found that a small number of companies are responsible for entering the same applicants into the lottery multiple times, with the alleged goal of artificially boosting their chances of winning a visa.

'The H-1B programme is an essential part of our nation's immigration system and our economy, and the USCIS is committed to implementing the law and helping meet the ever-changing needs of the US labour market," it said. "We are working on an upcoming H-1B modernisation rule that will propose, among other improvements, bolstering the H-1B registration process to reduce the possibility of misuse and fraud in the

H-1B registration system," it added. The USCIS said during the registration period for the FY 2024 H-1B cap. it saw a significant increase in the number of registrations submitted compared to prior years. It said there were 7,80,884 applications for H-1B visas in this year's computergenerated lottery, against 4,83,927 in 2023 and 3,01,447 in 2022 and 2,74,237 in 2021. The number of registrations tied to people who applied more than once rose to 408,891 this year from 165,180 last year and 90,143 the year before, it said. H-1B visas are issued for three years and can be extended another three years.

Sperm donor ordered to stop after over 500 kids

The Hague, April 29: A Dutch court Friday ordered a man who judges said had fathered between 500 and 600 children around the world to stop donating sperm.

The 41-year-old Dutchman, identified by de Telegraaf newspaper as Jonathan Meijer, was forbidden to donate more semen to clinics, the court ruling said. He could be fined 100,000 euros (\$110,000) per infraction.

parents who already had children by him. The decision came after a civil case started by a foundation representing the interests of donor children and Dutch parents who

New Delhi, April 29: Market Regulator SEBI has moved the Supreme Court seeking a six-month extension to complete its probe into the allegations of stock price manipulation by the Adani group and any lapses in regulatory disclosures.

The top court had March 2 asked SEBI to probe the matter within two months and also set up a panel to look into the protection of Indian investors after a damning report by a US short seller wiped out more than \$140 billion of the conglomerate's market value.

In an application moved before the court, SEBI submitted that for ascertaining possible violations related to "misrepresentation of financials, circumvention of reg-

of transactions", it would take six more months to complete the exercise.

"Pass an order extending the time to conclude the investigation as directed by this Court by the common order dated March 2 by a period of 6 months or such other period as this court may deem fit and necessary in the facts and circumstances of the present case,' the plea said.

The apex court while directing the setting up of a six-member committee headed by former apex court judge Justice A M Sapre for the assessment of the extant regulatory framework and for making recommendations to strengthen the process said it was appropriate to set up such a panel of experts in order to protect Indian investors which has been witnessed in the recent past.

The court-appointed Justice Sapre panel is to be provided assistance by the Centre and other statutory agencies including the SEBI chairperson.

On February 10, the top court had said the interest of Indian investors needs to be protected against market volatility in the backdrop of the Adani Group stocks rout and asked the Centre to consider setting up a panel of domain experts headed by a former judge to look at strengthening the regulatory mechanism.

The Centre had agreed to the apex court's proposal to set up a committee, to be headed by a former Supreme Court judge, to go into the regulatory regimes.

Till now, four PILs have been filed in the top court on the issue by lawyers ML Sharma and Vishal Tiwari, Congress leader Jaya Thakur and Mukesh Kumar, who claims to be a social activist.

FPIs remain net buyers in April

New Delhi, April 29: Foreign portfolio investors (FPIs) have remained net buyers in Indian stock markets for the second straight month, latest data from the National Securities Depository (NSDL) noted. FPIs bought assets worth ₹7,695

crore in Indian stock markets in April 2023 till April 27, as per the data.

In March, they bought assets worth about ₹7,936 crore in Indian stock markets. They were net sellers in the initial two months of the year. In January and February FPIs sold equities worth ₹28,852 crore and ₹5,294 crore, respectively. NSDL data showed. Foreign investors were apparently cautious amid risks from the then volatility in Indian stock markets

Barring some exceptions, FPIs had been selling equities in the Indian markets for over a year, which started in October 2021 for various reasons.

In 2022, foreign portfolio investors sold ₹121,439 crore worth of stocks in India on a cumulative basis, data available on the NSDL website showed.

"There were huge deliverv volumes in stocks like HDFC Bank. HDFC and Tata Motors. It can be



safely assumed that bulk of this delivery buying was done by FPIs. FPIs have also increased their holding in ITC. Stocks in which FPI holding is steadily rising are showing resilience even during market weakness," VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services recently said in a note.

The banking crisis in the US that emanated after the collapse of Silicon Valley Bank in early March and the relatively strong economic outlook for India seemed to have made renewed appetite for domestic stocks.

Shares of the bank closed down 43%, worsening a stock rout that has wiped out 75% of its value this week. The stock lost more than half of its value on Friday and touched a record low of \$2.99. At its lowest, the bank had a market capitalization of nearly \$557 million, a far cry from its peak valuation of more than \$40 billion in November 2021.

Brij Bhushan 'ready for probe but won't resign'

Gonda (UP), April 29: Facing allegations of sexual harassment by seven women wrestlers, WFI chief Brij Bhushan Sharan Singh Saturday said he is ready for "any kind of investigation" but won't resign from his post as it would mean he has accepted the charges against him.

"I am completely innocent and have full faith in Supreme Court and Delhi Police. I am ready to face any kind of investigation," Singh told reporters at his residence in Bishnoharpur, about 40 km from Gonda city. "Resigning as president of Wrestling Federation of India is not a big deal for me, but I will not resign as a criminal."

Taking a strong exception to Congress leader Priyanka Gandhi Vadra's meeting with the wrestlers Saturday morning, Singh said, "Todav it has been seen who is be hind this controversy. I have been saying from the beginning that an industrialist and the Congress have a hand in this. They are upset with me." He, however, did not elaborate. Priyanka Gandhi visited the wrestlers at Jantar Mantar in New

Delhi and expressed solidarity with them, accusing the govern ment of "protecting" the WFI chief. Several wrestlers have resumed

their agitation and sat on a dharna since April 23, demanding that an FIR be filed against the "Gonda strongman". They also demand that Singh be removed from all posts he holds. The Congress has said that he should be arrested immediatelv

Friday night, Delhi Police registered two FIRs against Singh. While the first FIR pertained to allegations of a minor wrestler and was registered under the POCSO Act, the second was related to outraging modesty.

"I'm not a criminal. Resigning means I have accepted their allegations," Singh, the BJP MP from Kaiserganj in Uttar Pradesh, said. He claimed all the demands of women wrestlers have been accepted. "An FIR has been lodged against me, yet they are sitting on dharna. Why?" he asked.

Singh, a sixth-term lawmaker, said his tenure as the WFI chief is complete and he will automatically resign with the election of the new president. He is only playing the role of a "caretaker" till the

election. Singh has completed 12 years as WFI chief and is ineligible to contest for another term. He asked why are the wrestlers still sitting on dharna now when an FIR has been registered against him. "Why are they constantly speaking against Prime Minister Narendra Modi and the Sports Ministry?"

Singh said the ongoing dharna by the wrestlers is not a protest of sportspersons but a protest of the "conspirators". "They did not wait for the investigation report to be made public and went to the Supreme Court and there raised a new allegation. They are saying that the sport has to be saved but they are not saving the game (by doing this). They have caused a huge loss in the last four months," he said.

He also asked if he had been sexually abusing players for 12 years, why they never took a complaint to the police station, federation or the government till date.

"They went straight to Jantar Mantar," he said.

Singh said he has submitted an audio clip to the probe committee, in which a man is heard speaking about arranging a girl to implicate him. Stressing that he fully respects the decision of the Supreme Court and the government, Singh alleged the protestors are coming up with new demands everyday.

"First they demanded an FIR and now that the FIR has been lodged, they are demanding to put me in jail. I am a member of Lok Sabha. It has not been by the grace of Vinesh Phogat (one of the wrestlers protesting at Jantar Mantar) but the people of my area have made me an MP," Singh said. Claiming that the entire Haryana

and UP "akhadas" are with him, the MP said it is only "one family's akhada" which is against him. "I have full faith in the law of the land. I will definitely be proved innocent. It has been troubling me for a long time. I and my family are being abused. Our supporters are also being targeted but my supporters and family have full faith that I am innocent. Soon, the country will also come to know about it,"

he added.
