The accused initially told the police that he was a CMO official who had come to watch a movie with the woman. #### 'Sangh propaganda': Vijayan slams makers of 'The Kerala Story'

Thiruvananthapuram, April 30: Kerala Chief Minister Pinarayi Vijayan Sunday slammed the makers of 'The Kerala Story' film, saying they were taking up the Sangh Parivar propaganda of projecting the state as a centre of religious extremism by raising the issue of 'love jihad' -- a concept rejected by the courts, probe agencies and even the Union Home Ministry.

Vijayan said that the trailer of the Hindi film, at first glance, appears to be 'deliberately produced' with the alleged aim of creating communal polarisation and spreading hate propaganda against the state



#### **Curfew lifted** in Sambalpur

Sambalpur: Curfew has been withdrawn from all areas of violencehit Sambalpur as the law and order situation has 'improved' and there is 'no apprehension of breach of peace,' according to a notification. However, restrictions on meetings and rallies will remain in force, and written permission from the district administration will be required to organise such events, it said. The curfew was imposed in six police station areas following a clash between two groups during Hanuman Jayanti celebrations in Sambalpur city mid of April. Several people and 10 police personnel were iniured while many shops were set on fire in the violence.

## **State to build India's first** colony for climate victims

Bhubaneswar, April 30: The Satabhaya Bagapatia colony in coastal Kendrapara district is the first rehabilitation colony in the country that will be developed to rehabilitate people affected by climate change.

Chief Minister Naveen Patnaik has allocated over ₹22 crore in the first phase to develop the Satabhaya Bagapatia Rehabilitation Colony as an ideal colony.

On the instructions of the Chief Minister, 5T Secretary VK Pandian had visited Kendrapara for two days April 27 and 28. During the visit, Pandian had met the displaced people settled there and

about their opinions on the

government's plans for develop-

ing the area. Acting on the 5T Secretary's feedback, the state government has decided to develop dams and fences, housing for the beneficiaries, livelihood programmes, roads, drinking water facilities, electricity, and panchayat houses. In addition, it has been decided to provide the people at Satabhaya

## PUNJAB GAS LEAK LEAVES 11 DEAD

All the victims belonged to Uttar Pradesh and Bihar and had been working as migrant

Ludhiana, April 30: Eleven people, including three children, died allegedly after inhaling toxic gas in the city's thickly populated Giaspura locality Sunday, with high levels hydrogen sulphide detected in the air and authorities suspecting it was emanating from a sewer.

Four more persons, who were taken ill, are undergoing treatment at a hospital, officials said. adding the area was sealed, the residents were evacuated and a National Disaster Response Force (NDRF) team was at the spot following the incident.

A magisterial inquiry has been ordered into the incident while the

Ludhiana Police has registered an FIR against unknown persons.

In the air quality sensors used by the NDRF team, high levels of hydrogen sulphide have been detected and this gas might have led to the tragic incident, according to an official release issued by the district administration.

The officials said they suspect that the poisonous gas was released after some chemical was disposed of in the sewerage in the area.

Giaspura is a thickly populated area with a migrant population. Several industrial and residential buildings are located there. All the victims belonged to Uttar Pradesh and Bihar and had been staying in Ludhiana.

The incident came to light Sunday morning when some people who came to a local grocery store to buy milk started fainting. Four persons died on the spot while others were rushed to the hospital.



## Odisha doc gifts his village no-fee world-class school

New Delhi/Bhubaneswar, April **30:** A doctor, who worked as a labourer during his childhood in Berunapadi village in Keonjhar district, has gifted his village a nofee world-class school.

About 15 years after completing his studies at the All India Institute of Medical Sciences, Delhi and starting practice in the national capital, Dr Pradeep Sethi went back to his village, encouraged villagers about education and bought land to build an international school

Many villagers joined him and donated their land to start the school, after which a big educational institution was built.

According to Dr Sethi, he did not want his effort to be limited to only one school.

The institution equipped with world-class facilities will have an expert faculty from abroad and celebrities like Jubin Nautiyal, Sonu Nigam for teaching music, former Indian cricket



team captain Ravi Shastri for sports, and Rajiv Bajaj for

The school has been built for children who are extremely poor and unable to afford education. Presently, this school is built on 10 acres which will later be extended to 20 acres

The school can enroll around 2,500 students.

According to Dr Sethi, no fee is charged from any student for any work in the school. Many skill development and placement courses will be developed in the institution which has Classes from I-XII. Around 50 more classrooms are being added to the school.

The school's director said that the educational institute seeks to replicate the academic standards of Ivy League universities like Stanford and Harvard.

Besides, many professional courses have also been introduced here like fisheries, information technology and science, among others.





Bhubaneswar, April 30: As many as 19 630 water hodies in Odisha are not in use on account of being dried up, siltation, salinity and destruction beyond repair, according to India's first-ever census of water bodies conducted by the Ministry of Jal Shakti.

As per the census, West Bengal, Uttar Pradesh, Andhra Pradesh, Odisha and Assam are the top five states in terms of number of water bodies. They constitute around 63 per cent of the total water bodies in the country.

According to the data, Odisha has 1,81,837 water bodies. While 1,78,054 (97.9 per cent) are in rural areas, 3,783 (2.1 per cent) are in urban

"1,62,207 (89.2 per cent) water bodies are in use, whereas 19,630 (10.8 per cent) are not in use on account of drving up, siltation, salinity, destruction beyond repair and other reasons," according to the census. As many as 92,575 (50.9 per cent) of water bodies are privately owned, while the remaining 89,262 (49.1 per cent) are under public ownership.

By location, 56,900 (31.3 per cent) water bodies are located in tribal areas. The remaining 1,24,937 (68.7



per cent) are mainly in droughtprone, flood-prone and Naxal-affected areas

There are a total of 7,109 natural and 1,74,728 man-made water bodies in the state. Out of 7,109 natural water bodies, 6,915 (97.3 per cent) are located in rural areas whereas the remaining 194 (2.7 per cent) are in urban areas.

Similarly, out of 1,74,728 manmade water bodies, 1,71,139 (97.9 per cent) are located in rural areas and 3,589 (2.1 per cent) are in urban

Only 5,445 (3 per cent) water bodies in Odisha are covered in the district irrigation plan/state irrigation plan. Among these, 44.9 per cent (2,444) are tanks, 39.1 per cent (2,129) are ponds and the remaining 16.0 per cent (872) are lakes, reservoirs, water conservation schemes/percolation tanks and check dams

Commenting on the census,

As per India's first-ever census of water bodies conducted by the Ministry of Jal Shakti, West Bengal, Uttar Pradesh, Andhra Pradesh, Odisha and Assam are the top five states in terms of number of water bodies

water activist Ranjan Panda said Odisha has a large number of water bodies as zamindars and community leaders have dug many ponds across the state. Besides, several water bodies have been created under government schemes and programmes.

However, the government needs to come up with a specific policy or programme for conservation and redevelopment of the water bodies. the 'Waterman of Odisha' said.

This apart, there is a need to conduct another survey of the water bodies which have been destroyed or dried up. Accordingly, an action plan should be prepared for revival of such water bodies, suggested Panda.

## Ponzi: EOW nabs 3 in UP

Bhubaneswar, April 30: The Economic Offences Wing (EOW) of Odisha Crime Branch (CB) has arrested three persons in Uttar Pradesh on charges of duping people through an online platform promising high returns on investments, an official said Sunday

According to EOW sources, Sachin Pal, Ankush Singh and Kuldeep have been arrested in Vijaynagar under Ghaziabad police limits of Uttar Pradesh April 28 under Sections 419, 420, 467, 468, 471 and 120B of the Indian Penal Code and 66(C) and (D) of the Information Technology (IT)

Soon after the arrest, they were produced before the court of CJM, Ghaziabad and were brought to Bhubaneswar on a three-day transit remand for their production before the court of SDJM. Bhubaneswar, an official said.

About the case, the official said Parthasarathi Pattnaik of Bhubaneswar had approached them alleging that a digital marketing platform -www.r46.in - has been cheating the general public



in the name of giving extra income through digital marketing.

Pattnaik said he had invested ₹6.5 lakh through the website, and his total commission along with invested amount was being reflected as ₹7.31 lakh in the wallet of the website, said the official, adding that when Pattnaik wanted to withdraw the amount, he was not allowed by the website.

The website had a Telegram channel 'eBay Official work channel No.7' with a rolling subscriber base of more than 65,000 members.

"During the investigation, it was found that www.r46.in is a fake website developed by fraudsters. It was being managed from people outside India," said the official.

They used hundreds of shell companies/mule accounts to make a complex layer of money transactions and misappropriated the amount.

Sachin and Ankush have handed over their SIM cards and bank accounts to Kuldeep, a fraudster operating from Rajasthan, for illegal channelization of money for a monthly remuneration of ₹30,000.

During the investigation, it was found that ₹3.32 lakh and ₹1.5 lakh have been illegally transacted from the amount deposited by Pattnayak, the official pointed out.

## Need to ensure welfare of workers in informal sector, say experts

Bhubaneswar, April 30: Labour, one of the factors of production other than capital, has always been identified by economists as a crucial ingredient for economic development of any country. India, being world's most populous country, is home to a large workforce working in sectors ranging from construction to consultancy services.

May Day or International Labour Day is celebrated every year May 1 to honour and appreciate the contribution of workers everywhere. On the eve of the occasion, Orissa POST talks to experts to understand what policy measures are needed to enhance safety and overall wellbeing of the working class.

#### Govt should hold a census of informal workers

Umi Daniel, director of the migration and education unit at Aide et Action, a non-profit organisation working in Odisha, says, "Workers in informal sector and those who are employed precariously are being neglected hugely nowadays. These workers and their

families have suffered immensely during the pandemic and yet to recover fully from the economic shocks. Majority of them are migrants who are struggling to access social security and other entitlements both at the source and destination states. Government should carry out a census of all who are engaged in informal, precarious and gig economy, and formulate a comprehensive social security policy to safeguard the rights and entitlements of these invisible workers who are contributing hugely to the economy."

#### State policy for migrant workers need of the hour

Saroj Barik, a labour rights activist and expert, says, "Major junk of labourers from Odisha are engaged in the unorganised sectors both within and out of the state. They are still struggling to access basic social protection and welfare schemes. Labourers in rural areas are not getting the standard minimum wages due to absence of policy for the workers of unor-

ganised sector.' He further adds, "No mecha-

nism for monitoring of labour markets (haat) at urban locations and lack of basic services at addas are making people vulnerable to exploitation. Uncertainty of job assurance during need at villages is triggering rural to urban labour migration. Migrant workers are still out of the Odisha Building & Other Construction Workers Welfare Board (BOCWB) fold and there are also issues in registration and claiming of benefits due to the activity of middlemen.'

Barik also suggests, "We need state action plan for protection and welfare of unorganised sector labourers as per the Unorganised Workers Act 2008, as directed by the honorable High Court of Odisha. State policy for protection and welfare of migrant workers is highly required as Odisha is a major source of interstate migrant workers in India."

#### **Need to ensure minimum wage**

Suresh Panigrahi, secretary of All India Kisan Sabha Odisha state council, says, "Minimum wage for all categories of workers should be ₹26,000 per month. But an unskilled worker in our state is getting just ₹345 daily which is very less. So increase of minimum wage as per consumer price index is single biggest issue of workers in our state.'

#### Informal sector workers must be identified

Highlighting the problems of workers of the informal sector, Naba Kishore Pujari, a social activist. savs, "The misery of labourers working in the informal sector, such as ragpickers, is manifold. They don't get a labour card due to the lack of identity. It's high time they must be identified and provided with all government benefit like others so that they too can lead a life of dignity.

## 'Didi libraries' promote reading among children

Patna, April 30: In a bid to promote in children of villages the habit of reading, the Bihar government has started 'Didi ki library', established under Jeevika.

The first Didi ki library or community library in Singheshwar was inaugurated by Chief Minister Nitish Kumar February 10.

At least 100 such libraries have been opened in 32 districts.

Community Library and Career Development Centres (CLCDCs) have also been set up in many blocks of the state.

Till now, 63 government buildings

have been taken over for this purpose, while the remaining 37 are being developed in private houses hired by Jeevika.

The building marked for the operation of CLCDC has a hall, which can accommodate about 30-40 people and two rooms, in which one room is used as a physical and digital library-cum-office and the other room is used as a study room.

The hall is used for other teaching-training activities including conducting digital and physical

classes as per the requirement. Books for preparation of various higher education entrance exams including class 9th to 12th textbook, e-books and notes are avail-

able in the library. Rohan Rai, a resident of Singheshwar, who works as a labourer said that girls were not able to study properly at home. The library is helping in promoting education among rural children who, for various reasons, did not get time and facilities for studying at

their homes.

He said that such a facility in the village would be effective in the field of education of girls.

# Banks urged to share data on failed pension transfers

Bhubaneswar, April 30: To reduce inconveniences faced by the beneficiaries, Social Security and Empowerment of Persons with Disabilities (SSEPD) department secretary Bhaskar Sarma recently urged banks to share transaction data on social security pensions provided by the government.

At a bankers' meet held to discuss issues regarding easy monitoring of transaction, presiding over the meeting, Sarma raised concern over inconveniences faced by beneficiaries of direct benefit transfers (DBT) during cash withdrawal at business correspondent (BC) points due to failure in Aadhaar authentication.

"It was highlighted that banks can fetch the data of DBT failure instances through the Aadhaar network both in cases of National Social Assistance Programme (NSAP) and Madhu Babu Pension Yojana (MBPY) as all DBT transactions are registered in bank server with Aadhaar," said an official.

Data on such failures can then be shared with the department on real time basis for monitoring,

Meanwhile, users are also using their smartwatches for connectivity - interacting with notifications from social media as well as messaging and calling friends, family and coworkers

'Smartwatch users are overwhelmingly satisfied with their devices, citing health and fitness

tracking, as well as notification access, as central uses. This suggests that there is room to educate consumers on the benefits of smartwatches in everyday life and further drive the adoption of the form factor," said senior analyst Arushi

Additionally, 77 per cent of the respondents stated that Apple was the most preferred brand for their next smartwatch.

"The share of respondents willing to pay \$500 or more for their next smartwatch was double the share of those who stated they spent \$500 or more on their current smartwatch, suggesting rising ASPs for the segment," the report mentioned.

#### Bhitarkanika to remain closed for 3 months for crocs' nesting

Rajnagar, April 30: The Bhitarkanika National Park (BNP) and Bhitarkanika Wildlife Sanctuary under this block in Kendrapara district will remain closed for tourists and locals for a period of three months from May 1 to July 31 in view of the mating and nesting season of saltwater

Domestic and foreign tourists will not be allowed to visit the crocodile-infested areas during the breeding season of the crocodiles. This was stated by DFO Sudarshan Gopinath Yadav of Mangrove Forest Division (Wildlife), Rajnagar to mediapersons here, Saturday. Entry of visitors will be restricted at Bhitarkanika, Dangamala and Ragadapati forest blocks under

The restrictions are imposed every year during the mating season as noise created by boats and intrusion of visitors can disturb the reptiles' breeding and nesting activities.

The reptiles build their nests at safe spots about 3 feet from the shore or river banks inside

mangrove forests or Kharkhari leaves. Female crocodiles build nests to lay their eggs and if they sense any harm during this period they do not mind attacking to save their eggs.

Forest officials said once the reptiles are disturbed during the nesting and breeding period they become more violent and the majority of crocodiles-attack occur during the nesting season.

Local forest dwellers have also been prohibited from entering the area for collection of forest produce such as honey and firewood.

Notably, Bhitarkanika is located in the estuarial region of Brahmani-Baitarani rivers in Kendrapara district. It is the only rainforest in the state famous for estuarine crocodiles. The BNP authority spotted 122 nests of estuarine crocodiles in the Kanika, Gahirmatha, Mahakalapara and Rajnagar wildlife forest ranges during last year's census

A mineral expert Jyoti Rout said that the Mines department should make efforts to transport the iron ores in coordination with the Ministry of Railways and Indian Bureau of Mines.

Commenting on the issue, Banshapani railway station manager Dibakar Chandra Mishra said as the dump and loading rules (the moment minerals brought from mines in a truck are unloaded on a railway siding and reloaded in railway wagons within a scheduled time) apply to railway sidings and the Railways charges ₹175 per wagon per day if the minerals are piled up on the siding for a scheduled period. Each wagon is loaded

with over 60 MT of minerals. As the minerals are lying abandoned on the railway sidings for over a decade, it will be highly expensive to pay the penalty and transport the minerals elsewhere, Mishra added.

Gadadhar Padhan and Parikhita Karna have not only been able to earn a descent income from marigold floriculture but also become an example for others to emulate by giving employment to some youths in their farms.

The two after completing graduation tried to get into government service but in vain. Later, they got the inspiration for marigold cultivation from social media platform YouTube.

They bought marigold saplings spending from their own pockets and planted them on five acre of



land. What is noteworthy is that they did not use any chemical fertilizer or pesticide and used only organic manure to grow the flower

## Hate Speech

he Supreme Court's direction to all states and Union Territories to register cases on their own against those making hate speeches is a very welcome step. This development, to rein in hate mongers, has been damaging the social fabric of this nation for the past few years because all this hate being generated is for political gains only. In the absence of stern measures from the police and judiciary the perpetrators of such crimes have been emboldened. They are using this laxity to whip up religious sentiments each time a major election is held in the country so as to polarise voters on communal lines and reap electoral dividends. This trend has assumed serious proportions since 2014 and even top leaders keep delivering incendiary speeches with communal overtones with impunity.

The Bench of Justices KM Joseph and BV Nagarathna extended its October 21, 2022 order, earlier limited to directing police only in Delhi, Uttar Pradesh and Uttarakhand to take suo motu action in cases of hate speech to all states and Union Territories. What is of significance is the addition to this order that says any hesitation to act in accordance with this direction will be viewed as contempt of court and appropriate action shall be taken against the erring officers. Such action will be taken irrespective of the religion that the maker of the speech or the person who commits such act belongs to. The sweeping order should be viewed as being intended to preserve the country's secular character as envisaged by the Preamble of the

The problem of applying the existing legal provisions to prevent hate speech is that the affected people more often than not hesitate to lodge complaints for legal remedies fearing for their safety. The Bench has correctly understood the situation which is why Justice Joseph said that many a time people may not come forward to complain. To protect the people from harassment by the offenders the apex court has said in its order that police themselves should take action. It goes without saying that public good has prompted the Bench to issue such a direction. However, can any police officer of any state demonstrate an overreach of this nature if the party in power in that state is ambivalent, if not outright supportive, to such crimes.

Another important aspect of the order is the warning issued by the Bench that delay in registering hate speech cases would be treated as contempt of court. This has been necessitated by the reluctance of the police and the administration to take cognisance of glaring instances of incendiary speeches by high profile politicians.

Now that the apex court has put the onus of taking action against perpetrators of hate speech on the police and the state administration, it is expected and hoped that the political standing of the violators would not weigh on the law enforcing agencies. Such directions from the judiciary prove that not all institutions in this country will fall by the way.

#### ■ Hocus-pocus

ocus-pocus is nowadays applied to meaningless talk or activity or to anything, speech or action, that's designed to stop you seeing what the politician or salesman is really up to or what's actually happening. This budget, like so many before it, is an act of deception, a piece of political hocus-pocus designed to make us believe councillors are spending our money wisely (Ottawa Citizen, 31 Jan. 2010). It comes, of course, from an incantation used by conjurors to suggest that they are evoking some magical spell or mystical force that causes the seemingly impossible to happen. It appeared in the early seventeenth century and was referred to in a number of plays of the period. The first was this, in which a Dutchman, an absurd character called Vangoose, is speaking: If it goe from de Nature of de ting, it is de more Art: for deare is Art, and deare is Nature: vow sall see. Hochos-pochos, PaucosPalabros (The Masque of Augeres by Ben Jonson, 1622). A famous appearance is in the title of the first book ever published in English about conjuring, Hocus Pocus Junior, The Anatomy of Legerdemain, of 1634, which was popular and went through many editions. In his book Magic on the Early English Stage of 2005, Philip Butterworth identifies the previously unknown author of this little book as William Vincent, a famous conjuror of his time, who was appointed as juggler to King James in 1619 and who used the stage name Hocus-Pocus. At this time there was no formal separation between jugglers, rope-dancers, conjurers and other performers, whose acts were summarised as "feats of activity". Vincent did them all and was particularly known for his ability to swallow and regurgitate daggers.A later writer described his act: I will speak of one man ... that went about in King James his time ... who called himself, The Kings Majesties most excellent Hocus Pocus, and so was called, because that at the playing of every Trick, he used to say, Hocus pocus, tontustalontus, vade celeriterjubeo, a dark composure of words, to blinde the eyes of the beholders, to make his Trick pass the more currantly without discovery (A Candle in the Dark: or. a Treatise Concerning the Nature of Witches and Witchcraft, by Thomas Ady, 1655). Vincent certainly popularised the term and became identified with it. He may well also have invented it; we have no way of knowing. What is also unknown is where it came from. Many people today believe it originated in a corrupted form of the words of the consecration of the host in the old Latin mass: hoc est (enim) corpus (meum), "this is my body", an idea first aired by John Tillotson, Archbishop of Canterbury between 1691 and 1694. But as this was part of an anti-Catholic sermon, it may be taken with a fair-sized pinch of salt. Another possibility, suggested in current Oxford dictionaries, is the nonsense Latin phrase hax pax max Deus adimax. Whatever the source, hocus-pocus was at first a term for jugglers and conjurers as well as a conjuror's incantation. Later in the century it evolved to mean a trick or deception. It may also be the source of another common English word, since some authorities suggest that at the end of the following century its first element was contracted to make hoax.

## **INNOVATE AGAINST INJUSTICE**

progressed exponentially over the past halfcentury. And yet, the persistence of health inequality limits the potential benefits of scientific and technological advances that could save or improve lives.

The debate over the allocation of vaccines and therapeutics during the COVID-19 pandemic is a vivid example of this inequality. In September 2022, WHO Director-General Tedros Adhanom Ghebreyesus stressed yet again that ending the pandemic requires equitable access to vaccines; at the time, only 19 per cent of the population in low-income countries were inoculated, compared to 75 per cent in high-income countries.

Despite this imbalance, richer countries suffered greater losses of life years per capita than poorer countries – a paradox highlighting how health inequality exists at many levels. In the United States, for example, cumulative data show that people of colour experienced higher rates of COVID-19 infection and death than white people. The disparity can be traced to social determinants of health, the non-medical factors that play a critical role in clinical outcomes. Suffering from institutional and structural discrimination, reduced health literacy, or cultural and language barriers makes it difficult to live the longest, healthiest life possible.

Reducing health inequality and helping underserved populations requires innovators to focus on these issues. There are still many diseases for which suitable therapeutic interventions are limited or do not exist. This is particularly true for rare genetic disorders, but also for more common ailments: impediments to patients' adherence to the existing treatment regimens for hypertension, for example, can adversely affect outcomes.

The biotech industry needs to allocate sufficient funding for research and development related to



The biotech industry is not doing enough to mitigate the social determinants of disparities in health outcomes and access to innovative medical treatments. Companies could address these harmful imbalances with equitable R&D funding, an inclusive approach to clinical trials, and investment in compassionate-use programmes

diseases that disproportionately affect specific ethnic communities. While we frequently say that communicable diseases know no borders, genetic and non-communicable diseases unfortunately do discriminate. In today's age of medical innovation, groundbreaking advances that could help these patients are within our grasp.

In a similar vein, we must rethink how we conduct clinical trials. We need to include diverse communities that are representative of the disease condition. Studies should take into consideration participants' socioeconomic and insurance status, and they should be designed to recruit people from underrepresented groups. Developing culturally appropriate and relevant recruitment materials, minimising travel time to trial sites, reducing the frequency and number of assessments, allowing for telehealth visits where appropriate, and introducing creative ways to target, gather, and disseminate information are all steps in the right direction.

Moreover, regulators and health-

care authorities can do more to encourage innovation that helps to address societal challenges. As advances in precision and genetic medicines and technologies continue, public and private organisations must work collaboratively to ensure that these breakthrough treatments are available to all who need them. Creative pricing and reimbursement strategies could enable equitable and sustainable access for patients and health systems. For example, the Value-Based Negotiation Framework, which my company supports, aims to address some of the challenges related to reimbursement in Europe. The framework lays the foundation for quicker negotiations between payers and manu-

innovative products. Finally, biotech companies can and should be responsible corporate citizens. That means invest ing in organisations working to address the social determinants of health – the stark disparities in income, education, transportation,

facturers with a view toward in-

creasing patient access to

exposure to violence, and more and to provide equitable access to diagnostics and therapies. The global nonprofit Acumen, for example, uses its patient capital model to invest in enterprises focusing on meeting the needs of low-income consumers, from housing to alternative energy and water.

Merck has been advancing this work for over a decade through their Merck for Mothers programme, which aims to promote safe and high-quality maternity care around the world. Sanofi Global Health, a nonprofit unit that Sanofi established in 2021 also supports underserved communities by selling medicines at affordable prices in 40 lower-income countries.

The biotech industry must continue to expand compassionateuse programmes and collaborate with nonprofit organisations that provide access to essential treatments. There are enough successful industry programmes from which to gain insights and identify best practices, such as Gilead's partnerships with generic manufacturers to produce high-quality, low-cost medicines, or Merck's agreement with the Medicines Patent Pool to diversify the supply of prescription drugs for low- and

middle-income countries. We must approach health inequality with the same passion, determination, and innovation that we apply to the development of medicines. Today's yawning gaps in access and outcomes are all the more unfair for being avoidable. And, as we saw during the pandemic, they are a problem for everyone. Collective action to improve health-care equity, including by addressing its social determinants, can extend and improve the lives of millions of people. That is the goal that all health-care companies should strive to achieve.

## Whither dignity of labour

he dignity of labour is a concept that indicates that all types of jobs are equally important. In other words, dignity of labour means respect and value given to all forms of work. According to Dr Martin Luther King Jr., "No work is insignificant. All labour that uplifts humanity has dignity and importance and should be undertaken with painstaking

A decent or living wage is the most important ingredient of the dignity of labour. That dignity is annihilated when one does not get her rightful share. Ensuring decent work and inclusive growth through sustainable wage policies is a widely shared objective across many countries. The Preamble to the International Organisation (ILO) Constitution calls for "the provision of an adequate living wage" and the ILO Declaration on Social Justice for a Fair Globalization adopted by the International Labour Conference at its 97th Session in June 2008 calls for wage policies that "ensure a just share of the fruits of progress to all, and a minimum living wage to all in need of such protection." But this is an illusion as many labourers are struggling to get minimum wage.

A minimum wage is the lowest amount a worker can be paid hourly determined by law. A living wage is the amount an individual or family would need to make to avoid living in poverty and afford adequate shelter, food, and other necessities. This amount is usually higher than the minimum wage and is not mandated by law. A fair wage is something that is more than the minimum wage. It is derived as a mean between the minimum wage and the living wage.

What is perturbing is that according to Global Wage Report 2020-21: Wages and Minimum Wages in the Time of COVID-19 published in 2021 by the ILO, Indians are among the most overworked workers globally while earning the lowest minimum statutory wage in the Asia-Pacific region, barring Bangladesh. India ranks fifth among countries with long working hours, often stretching up to 48 hours a week, if not more,

The estimates reveal that an average worker in China works 46 hours a week, 36 hours in the United Kingdom, 37 hours in the United States and 36 hours in Israel, Only Gambia, Mongolia, Maldives and Qatar have average working hours longer than India.

What is distressing is that according to the ILO's Global Wage Report 2022-2023, it was for the first time in this century that real global wage growth has been negative despite the positive increase in nominal wages. The global monthly wages fell in real terms to minus 0.9% in the first half of 2022. Among advanced G20 countries, real wages in the first half of 2022 are estimated to have declined to minus 2.2%, whereas real wages in emerging G20 countries grew by 0.8%, 2.6% less than in 2019.

According to the data of the Ministry of Statistics and Programme Implementation, in India, the nominal wages rose to ₹17,017 per month in 2021 from ₹4,398 in 2006. But when inflation is factored in the real wage growth in India plunged to minus 0.2% in 2021 from 9.3% in 2006. In China, the growth decreased from 5.6% in 2019 to 2% in 2022. The ILO says that inflation and

a global slowdown in economic growth due to the war in Ukraine and the global energy crisis are causing a "striking fall" in real monthly wages in many countries. Other reasons for falling/stagnant wages since 2008 include the recession - triggering unemployment and downward pressure on wages. The erosion of real wages comes in addition to significant wage losses incurred by workers and their families during the COVID-19 crisis.

However, a waning in trade union membership, enlarged labour markets flexibility with the ability of owners to hire and fire easily, a new gig economy and inadequate bargaining power of workers, and increased inequality with a relatively higher share of GDP growth going to company profit rather than wages are responsible for the decline of real wages

Inflation is also biting into the\_\_ purchasing power of minimum wagers. What is disconcerting is that the rise in nominal wages is not adequate to offset the rise in the cost of living. The cost-of-living crisis has been ranked as the most severe global risk over the short term by the World Economic Forum's Global Risky Report 2023. When Indian workers are already among the lowest paid and with highest working hours with no leisure, the government has come up with new labour code that enhance the working hours per day to 12 hours for each of the four days of the week. This may be within the prescribed limit of 48 hours per week but is inhumane and beyond the capacity of workers. This will lead not only to profit maximisation but also to exploitation.

Things look gloomier as more than 91% of Indian workforce belongs to the informal economy with no guaranteed minimum wage or social security. The recent change in labour laws along with the new labour code will not only rob workers' dignity but also create a big pool of servile, obsequious workers who can't raise their voices against injustice and exploitation and misrule of the government. There is an urgent need for well-designed policy measures to maintain the living standards of wage workers and their families. The writer is an

The nanomedicine market in India is expanding rapidly, with numerous applications in healthcare, consumer items, energy, and the military sector. Several Indian companies and research institutions are actively engaged in the development and commercialisation of nanomedicine products, with significant support from the Indian government.

#### 4 children killed

Sahibganj: Four children were killed in a lightning strike in Jharkhand's Sahibganj district Sunday, police said. The incident happened at Babutola in Radhanagar police station area in the afternoon when the children, in the age group of 9-11, were playing in a mango orchard, they said. "Four children were killed, while one was injured. The injured child is undergoing treatment at a hospital, Superintendent of Police Anuranjan Kispotta said.

#### Man booked

Guna: A man was booked in Guna in Madhya Pradesh for allegedly giving triple talaq to his estranged wife, a police official said. Triple talaq, also called 'talaq-e-biddat', is a practice by which a man could divorce his wife by pronouncing the word 'talaq' three times without citing any reason for this act. The Supreme Court in 2017 termed triple talaq as violative of Article 14 of the Constitution and the Union government in 2018 brought in the Muslim Women (Protection of Rights on Marriage) Act, which banned the method and stipulates a jail term of three years and fine for anyone practising instant talaq.

#### Two men die

Nagpur: Two men died during sleep after inhaling smoke caused by a fire in their room located on the premises of a school in Nagpur city of Maharashtra on Sunday. police said. The deceased duo was identified as Aman Tiwari (18) and Akash Raiak (23). both hailing from Seoni in Madhva Pradesh. The incident occurred on Saturday night when the refrigerator in the room caught fire due to a short circuit. The blaze also gutted a sofa set.

#### Woman arrested

New Delhi: A 38-year-old woman was arrested for allegedly cheating an advocate on the pretext of offering her a travel package for a trip to Gujarat, police said Sunday. The accused, Paulina, is a resident of northwest Delhi's Indira Vikas Colony, they said. Paulina and her husband Ricardo Gomes operated from Delhi and Kolkata, respectively. Gomes has been arrested by Maharashtra Police. The couple has duped many people on the pretext of offering attractive trave packages, they said.

Kota (Rajasthan): A 28-yearold man Sunday died while trying to save his wife who had fallen into a pond while bathing in a village in Rajasthan's Bundi district. The deceased has been identified as Kailash Gurjar, a resident of Guda village, SHO (Dabi) Dharmaram said.



New Delhi, April 30: The Supreme Court is scheduled to hear on Monday a batch of pleas, including one filed by the Editors Guild, challenging the validity of the colonial era sedition law.

The Centre is expected to apprise the court of the steps taken so far with regard to reviewing the contentious penal provision. On October 31 last year, the top court had extended its May 11 direction putting on hold the sedition law and the consequential registration of FIRs while granting additional time to the government to take "appropriate steps" for reviewing of the provision.

According to the apex court's website, a bench comprising Chief Justice D Y Chandrachud and Justice J B Pardiwala has listed as many as 16 petitions challenging the validity of the law for hearing.

The central government, which has to review the provision, on October 31 last year, had told the bench that it be granted some more time as "something may happen in the winter session of Parliament".

General Attornev Venkataramani had said the issue has been under consideration of authorities concerned and moreover, there is "no reason to worry" in view of the May 11 interim order, which put the use of the provision

"Mr R Venkataramani, the attorney general, submits that in terms of the directions issued by this court in order dated May 11, 2022, the matter is still engaging the attention of the relevant authorities. He submits that some addi-



tional time be granted so that appropriate steps can be taken by the government," the bench had

"In view of the interim directions issued by this court...Dated May 11, 2022, every interest and concern stand protected and as such there would be no prejudice to anyone. At his request, we adjourn the matter to the second week of January 2023," it had said.

In response to a query on whether the government had issued any communication to states on the penal provision, Solicitor General Tushar Mehta had said the directions in consonance with the apex court's order have been sent to the chief secretaries of states

In the landmark order passed on May 11, the court had put the contentious law on hold till the Centre completed its promised review of the colonial relic and also asked the Union and state governments not to register any fresh case invoking the offence. It had also directed that the ongoing probes, pending trials and all proceedings under the sedition law will be kept in abevance across the country and those in jail on sedition charges could approach the court for bail.

## K'taka's Korati-Kolhar curd hub facing fodder shortage

Vijayapura (Karnataka), April 30: Dairy farmers in Kolhar taluk here were thrilled when Prime Minister Narendra Modi, during an election campaign, tasted the famous 'Korati-Kolhar curd' they produced, but are unsure of how long they can continue their livelihood of buffalo rearing as they are facing acute fodder shortage.

The Prime Minister was in Vijayapura district of Karnataka on Saturday for campaigning ahead of polls on May 10.'Korati-Kolhar curd', which is made from buffalo milk and solidified in a speciallymade earthen pot, is popular in Karnataka for its unique taste and thickness. This curd has been sold in Kolhar for over a decade now and

it is tastier and cheaper than the modern, processed ones.

Former Prime Minister Atal Bihari Vajpayee, national leaders like B C Khanduri, Buta Singh and most recently J P Nadda and Rajnath Singh have tasted this curd. No wonder, tourists on the Hubli-Humnabad National Highway-218 stop here to get a taste of the homemade curd sold in earthen pots.

"A local leader asked me to supply Korati-Kolhar curd that will be served as one of the items as part of northern Karnataka cuisine to the Prime Minister. I supplied 60 small earthen pots of curd, which was tested in the lab before serving it to the PM," curd outlet owner Rajashekar Mallikarjun Guddadur said.



A fourth generation member running a curd shop on NH-218, Guddadur says he was "very happy" when the curd from his outlet was tasted by the Prime Minister. Given its rising popularity, Guddadur said there is a huge demand for this special curd on NH-218 itself

but laments that the supply has not been enough. The reason for the shortage being dairy growers in the village finding it difficult to scale up curd making due to lower milk production in Kolhar town.

"For a buffalo to give good quality and quantity of milk, the fodder is the key. Dairy growers are finding it hard to get quality fodder for their buffaloes and therefore not rearing more animals," said Guddadur, who sells about 500 pots a day at his shop.

What goes into this curd that makes it delicious is nothing but nutritious fodder that buffaloes eat and that helps give good quality milk with which curd is made.

'Earlier, we used to feed residues of some locally grown pulses and maize crops. There used to be enough open fields for grazing. Now, all this has been reduced. Farmers are only growing commercial crops like sugarcane leaving no space for livestock grazing. This has created a fodder shortage here," said dairy farmer Hanumantha Nyamagonda Nyamagonda used to rear 10 buf-

faloes a few years back and now has only four such animals due to difficulty in arranging good quality fodder from faraway places. Parushuram Gani, a dairy farmercum-local journalist, said the place used to be an arid area till the availability of backwater from the Almatti dam and implementation of irrigation projects. This encouraged farmers to go for sugarcane and other commercial crops here, creating fodder problems.

## Space in Kuno National BJP connects with women, docs, engineers Park 'inadequate' for cheetahs: Ex-WII dean

According to some experts, a cheetah needs about 100 square kilometre area for its movement. The KNP is spread over an area of 748 sq km and has a buffer zone of 487 sq km

Bhopal, April 30: Madhya Pradesh's Kuno National Park (KNP), which has seen the death of two cheetahs in less than a month, has "inadequate space" for these felines brought from Africa, a former official of the Wildlife Institute of India has claimed.

The National Tiger Conservation Authority (NTCA), which is overseeing the ambitious cheetah reintroduction project in the country, has called a meeting in New Delhi on Monday in the wake of the death of two cheetahs out of the 20 felines translocated to KNP from Namibia and South Africa over the last eight months, an official said.

The Wildlife Institute of India's (WII) former dean Yadvendradev Vikramsinh Jhala, who was part of the cheetah project in the past, told PTI that KNP has "inadequate space" for these animals.

"A 750 sq km area alone is not sufficient...We have to make (more than one) cheetah populations and manage it like a metapopulation where you move animals from one place to another. It is very essential to establish a second, third population." he said

"Kuno is a protected area, but the landscape in which cheetahs can live in Kuno is spread over 5.000 sq km, which includes agricultural parts, forested habitats, communities living within the area," he said. If the cheetahs adapt to this environment, they will be able to thrive in the KNP, he said.

"So, it all depends on how we manage the communities, ecotourism, giving them incentives, making sure that (human-animal) conflict levels are appropriately compensated if there are any," Jhala said. Asked about the population (theory), he said KNP is one site, Mukundara Hills Tiger

Reserve (in Rajasthan) is one site, Gandhi Sagar Sanctuary and Nauradehi Wildlife Sanctuary in MP are two other sites. "Each of these sites in itself is not viable. To shift one or three cheetahs after one, two generations from here to there is called metapopulation management so that there is genetic exchange. This is an important exercise. Without this. we can't manage cheetahs in our country," he said.

'Without this, we can't have viability in the long run," Jhala added. One of the eight Namibian cheetahs brought to KNP. Sasha. aged more than four-and-a-halfyears, died of a kidney ailment at the park on March 27.

The KNP witnessed cheetah fatality in less than a month as a six-year-old male feline named Uday, translocated from South Africa in February, died April 23. Another cheetah, named Siyaya, recently gave birth to four cubs in KNP.

Besides, cheetah Pavan, has strayed out of the KNP multiple times, while cheetah Asha has wandered out of the park twice. Earlier this month, the MP forest department wrote a letter to the NTCA seeking an "alternate site" for the translocated cheetahs.

## MP police get tough on modified vehicle silencers

Bhopal, April 30: The Madhya Pradesh government has implemented the rules of Section 182 A (3) of Motor Vehicle Act, 1988, according to which, manufacturing and sale of modified silencers for vehicles will be a punishable of-As per the police, the first of its

kind rules have been introduced in Madhya Pradesh aiming to prohibit the sale of components or parts of vehicles that can harm the human health and violate the traffic laws. The violation of the rules will amount to the imprisonment of one year along with a heavy fine up to ₹one lakh. With the implementation of the

rules, police have also begun search operations of the vehicles' components manufacturing units, garages and car decorators, and the shops selling modified vehicle silencers across the state. The first such search operation was carried out in Bhopal a couple days ago, during which car decorators for modified silencers were confiscated. Following which, a Bhopal district court dealing with cases related to Motor Vehicles Act, imposed a fine of ₹one lakh against a shop owner for selling the silencers.

Anurag Sharma, Additional Commissioner of Police (traffic /crime) of Bhopal said the implementation of Section 182 A (3) of Motor Vehicle Act, 1988 has became the need of hour in order to pun a ban on manufacturing and selling of the vehicle components that are

from acute pneumonic symptoms, the doctors present at the CHC referred the child to the Datia district hospital after preliminary treatment. The helpless mother kept

waiting for '108 Ambulance' for more than three hours despite the doctors repeatedly making phone calls.

It was more shocking that there were two ambulances (funded out of the MLA Local Area Development Fund) parked at the CHC, but their services weren't reportedly provided to the hapless mother, as she couldn't afford to pay the bill.

After repeated phone calls, 108 ambulance arrived after three hours, but till then the child had died in her mother's lap. Renu, the mother of the deaceased child, blamed the inadequate treatment at the CHC and delay in ambulance behind her child's death.

## Woman alive, but declared 'dead' for pension

Jaipur, April 30: Eighty-five-year old Gattu Devi who lives in a village in Rajasthan's Ajmer district with her family was in for a shock when she learnt that her widow pension was stopped by the government declaring that she was dead.

A resident of Banjari village under Todgarh tehsil, the grandmother of three received her last pension of ₹1,500 in February 2022, which too she discovered recently.

"We did not check the account as we thought the pension was being deposited regularly for the past many years. I went to the panchayat samiti and realised that my mother was declared dead and pension was stopped in February last year," Chunnilal Regar, Gattu Devi's son said.

The authorities of the Department of Social Justice and Empowerment have initiated an inquiry to ascertain the loophole that led to the mistake. In the meantime, the department has verified Gattu Devi's identity and said her pension along with the arrears will be released next month. According to officials, the octogenarian was declared dead by the panchayat samiti without verifi-

The inquiry revealed that the verification was pending due to an amendment in Jan Aadhar Card (ID for the citizens of Rajasthan) by the pensioners in April 2023. The Jan Aadhar team has been asked to complete the verification work at the earliest. After which, the department has activated the pension account and from next month, the pension will be resumed. #### 229 Indians return from Sudan

New Delhi, April 30: India brought home another batch of 229 people Sunday under its mission to evacuate stranded Indians from violence-hit Sudan.

The fresh batch of evacuees arrived in Bengaluru, a day after 365 people returned from the African country to Delhi."#OperationKaveri One more flight brings back 229 passengers to Bengaluru," External Affairs Minister S Jaishankar wrote on Twitter. Under the evacuation mission.

754 people arrived in India in two batches on Friday. The total number of Indians who have been brought back home from Sudan now stands at 1,954, according to official data.

The Indians were brought back from the Saudi Arabian city of Jeddah where India has set up a transit camp for the evacuees. The first batch of 360 evacuees returned to New Delhi in a commercial plane on Wednesday

The second batch of 246 Indian

evacuees arrived in Mumbai in a C17 Globemaster aircraft of the Indian Air Force (IAF) on Thursday. Under "Operation Kaveri". India has been taking its citizens in buses from the conflict zones of Khartoum and other troubled areas to Port Sudan from where they are being taken to Jeddah in the IAF's heavylift transport aircraft and the Indian Navy's ships.

From Jeddah, the Indians are being brought back home in either commercial flight or IAF's aircraft. India has set up separate control rooms in Jeddah and Port Sudan, and the Indian embassy in Khartoum has been coordinating with them, besides being in touch with the headquarters of the Ministry of External Affairs (MEA) in Delhi.

Sudan has been witnessing deadly fighting between the country's army and a paramilitary group that has reportedly left around 400 people dead. Jaishankar announced the launch of "Operation Kaveri" on Monday to bring back stranded Indians from the African country.

#### **Building collapse: Toll rises to six**


The owner of the ill-fated building in Wardhaman Compound in Valpada in Mankoli has been detained, officials added.

He returned to Kathmandu on board the Nepal Airlines' regular flight after being discharged from the hospital following his "successful" treatment.

#### **Small plane** crashes, 1 killed

Los Angeles: One person was killed after a small plane crashed in a mountainous area here in Los Angeles, authorities said. The incident was reported about 8:09 p.m. local time (0309 GMT on Sunday), according to the Los Angeles Fire Department (LAFD). Air Traffic Control asked the LAFD to check a large swath of mountainous territory in the area after they reportedly lost radar contact with the small single-engine airplane believed to be travelling between two Los Angeles-area airports -- Santa Monica Airport and Van Nuys Airport.

#### British-Indian jailed

London: An Indian-origin crime boss, who conspired to buy and supply Class A drugs and guns on an encrypted communications platform, has been jailed for more than eight years, UK's National Crime Agency (NCA) said. Officers found that Raj Singh, 45, of Surrey in south east England worked with Waqas Iqbal, 41, to buy and sell Class A drugs and firearms.

## Emergency aid supplies reach Sudan Ukraine claims it

Cairo, April 30: An aircraft carrying eight tons of emergency medical aid landed Sunday in Sudan to resupply hospitals devastated by more than two weeks of fighting between forces loyal to rival generals.

More than two-thirds of hospitals in areas with active fighting are out of service, a national doctors' association has said, citing a shortage of medical supplies, health workers, water and electricity.

On Sunday, the aircraft carrying medical aid took off from Jordan and landed in the city of Port Sudan, said the International Committee of the Red Cross.

The supplies, including anaesthetics, dressings, sutures and other surgical material, are enough to treat more than 1,000 people wounded in the conflict, the ICRC said.

'The hope is to get this material to some of the most critically busy hospitals in the capital" of Khartoum and other hot spots, said Patrick Youssef, ICRC's regional director for Africa.

The Sudan Doctors' Syndicate, which monitors casualties, said Sunday that over the past two weeks, 425 civilians were killed and 2,091 wounded.

The Sudanese Health Ministry Saturday put the overall death toll, including fighters, at 528, with 4,500

#### Pope urges unity in final Mass in Hungary

Budapest (Hungary), April 30: Pope Francis urged Hungarians to open their doors to others Sunday, as he wrapped up a weekend visit with a plea for Europe to welcome migrants and the poor and for an end to Russia's war in Ukraine.

Francis issued the appeal from the banks of the Danube as he celebrated Mass on Budapest's Kossuth Lajos Square, with the Hungarian Parliament and Budapest's famed Chain Bridge as a backdrop.

The celebration provided the vi-



sual highlight of Francis' threeday visit that has been dominated by the Vatican's concern for the plight of migrants and the war in neighbouring Ukraine.

Citing local organisers, the Vatican said some 50,000 people attended the Mass, more than 30,000of them in the square, on a brilliantly sunny spring morning.

Among them were President Katalin Novak and Hungary's rightwing populist prime minister, Viktor Orban, whose lukewarm support for Ukraine has rankled fellow European Union members.

Francis has expressed appreciation for Hungary's recent welcome of Ukrainian refugees. But he has challenged Orban's hardline anti-immigration policies. which in 2015-2016 included building a razor wire fence on the border with Serbia to stop people from entering. Upon arrival, Francis urged Hungary and Europe as a whole to welcome those who are fleeing war, poverty and climate change, calling for safe and legal migra-

The generals, both with powerful foreign backers, were allies in an October 2021 military coup that halted Sudan's fitful transition to democracy, but they have since turned on each other.

Ordinary Sudanese have been caught in the crossfire. Tens of thousands have fled to neighbouring countries, including Chad and

The "road of life" is a vital road between the ruined Bakhmut and the nearby town Chasiv Yar to the west - a distance of just over 17 km (10.56 miles).

Ukraine's top military command said in its daily update on Sunday that its forces had repelled 58 Russian attacks over the past day along the part of frontline stretching from Bakhmut through Avdiivka and on to Maryinka further south in the Donetsk region.

If Bakhmut fell, Chasiv Yar would probably be next to come under Russian attack according to military analysts, though it is on higher ground and Ukrainian forces are believed to have built defensive fortifications nearby.

Yevgeny Prigozhin, founder of Russia's Wagner Group, who has often claimed unverifiable successes, said that his forces have advanced some 100 to 150 metres (109 to 164 vards) in Bakhmut, leaving iust under 3 square km of the city in Ukrainian hands. But he said he

"It would have had been five times fewer if we had more ammunition." Prigozhin said in an audio statement published on the Telegram messaging app of his press service on Saturday evening.

Separately, in a nearly 90-minute video interview with Russian military blogger Semyon Pegov published on Saturday, Prigozhin threatened to withdraw troops from Bakhmut, saying they had enough ammunition left only for days.

"If the shortage of ammunition is not replenished, then ... most likely, we will be forced to withdraw part of the units," Prigozhin said, quoting a letter he said was sent to Russia's Defence Minister Sergei

Shoigu, giving an April 28 deadline. It was not immediately known when the interview was recorded.

Prigozhin has often said the regular armed forces are not giving his men the ammunition they need and has sometimes accused top brass of betraval.

## Sunak to read from biblical book at King Charles' Coronation

London, April 30: Rishi Sunak will read from the biblical book of Colossians at the Coronation of King Charles III in keeping with the recent tradition of British Prime Ministers giving readings at State occasions, the office of the Archbishop of Canterbury revealed as part of the official Liturgy for the religious ceremony at Westminster Abbey here on May 6.

Sunak, Britain's first Prime Minister of Indian heritage and a practicing Hindu, reading from a biblical book will resonate with the multi-faith theme being struck for the Christian ceremony.

Lambeth Palace, the office of the Archbishop of Canterbury -

Reverend Justin Welby, said that members of other faith traditions will play an active role in the service for the first time.

'The Archbishop of Canterbury has selected a new Epistle for this Coronation, which will be Colossians 1:9-17. This passage has been chosen to reflect the theme of service to others, and the loving rule of Christ over all people and all things, which runs through this Coronation Liturgy," Lambeth Palace said.

"Following recent tradition of British Prime Ministers giving readings at State occasions - as Head of the host Nation's government - this will be read by Prime Minister Rishi Sunak," it said.

By longstanding tradition, the Archbishop of Canterbury au-

thorises a new Liturgy - or the form according to which a public religious worship takes place - for every Coronation. The three oaths the King at the heart of the service remain unchanged, including the promise to maintain "the Protestant Reformed Religion". The overall theme of the

New Delhi: Nine of the top-10 most valued firms together added Rs 1.84.225.43 crore in market valuation last week. with Reliance Industries Limited and State Bank of India emerging as the biggest gainers, in an overall bullish equity market trend. #### **Leather industry** seeks more time

New Delhi: Industry players and exporters of footwear have urged the government to immediately extend the implementation of the q control order (QCO) by 12 months as the businesses are not yet prepared to follow the norms. According to the 'Footwear Made from Leather and Other Materials (Quality Control) Order, 2022', which will come into force from July 1, manufacturers have to modify their processes to comply with the new standards. This includes establishing testing laboratories, obtaining BIS licences, and adhering to the rules for issuing the ISI mark. Economic think tank GTRI said that these changes require time and investment, and most manufacturers may be unable to meet the timelines.

# India, Russia explore

The countries are looking at possibility of accepting RuPay and Mir cards for hassle-free bilateral payments

New Delhi, April 30: India and Russia will explore the possibility of accepting RuPay and Mir cards in each other's country for hassle-free payments amid sanctions imposed by the West on Moscow. In the recent high level Internal

Governmental Commission meeting on Trade, Economic, Scientific, Technological and Cultural Cooperation (IRIGC-TEC), it was discussed and agreed to explore the opportunity of allowing acceptance of these cards, sources said.

The mutual acceptance of RuPay (India) and Mir cards (Russia) will help Indian and Russian citizens to make hassle-free payments in Indian rupees and Russian ruble in their respective countries, sources said.

The meeting, co-chaired by External Affairs Minister S Jaishankar and Russia Deputy Prime Minister Denis Manturov. also agreed to explore the possibility of interaction of Unified Payments Interface (UPI) of National Payment Corporation of India and the Faster Payments System (FPS) of the Bank of Russia.

Besides, it was also agreed to look at adopting the Russian financial messaging system, Services Bureau of Financial Messaging System of the Bank of Russia, for cross border payments.

Currently, overseas payments from India and vice versa are through the SWIFT network. At the given point when sanctions are imposed, sources said, it would



not be feasible for India to opt for other than SWIFT network.

Recently, Prime Minister Narendra Modi and Singapore Prime Minister Lee Hsien Loong launched the cross-border connectivity between UPI and PayNow.

Linkage of India's Unified Payments Interface (UPI) and Singapore's PayNow now allows people in the two countries to undertake faster and cost-efficient digital transfers. It will also help the Indian diaspora in Singapore, especially migrant workers and students, through instantaneous and low-cost transfer of money from Singapore to India and vice versa.

The PayNow-UPI linkage is the world's first real-time payment systems linkage to use a scalable cloudbased infrastructure that can accommodate future increases in the volume of remittance traffic.

To begin with, the State Bank of India, Indian Overseas Bank, Indian Bank and ICICI Bank will facilitate both inward and outward remittances while Axis Bank and DBS India will facilitate inward remit-

The UPI was launched in 2016, and since then it has emerged as the most popular and preferred payment mode pioneering personto-person and person-to-merchant transactions, accounting for 75 per cent of the total digital payments.

## new payments mode RBML, Nayara price fuel at market rates

A fall in international oil prices over the last six weeks to \$78 per barrel has helped bring the PSU pump-matching retail rates at par with cost

New Delhi, April 30: India's private fuel retailers -- Reliance-bp and Russia's Rosneft-backed Nayara Energy -- have begun pricing petrol and diesel at market rates for the first time in over a year after a fall in global oil prices cut losses, sources said.

Reliance BP Mobility Ltd (RBML), a joint venture between Reliance Industries Limited and UK's bp, Nayara Energy and Shell sold petrol and diesel at huge losses as they tried to match the below-cost frozen rates of dominant public sector retailers. The losses were despite pricing fuel at slightly higher rates than state-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum

Corporation Ltd (BPCL). Nayara, the largest private fuel retailer that owns over 7 per cent of India's 86,855 petrol pumps, started pricing petrol and diesel at market rates sometime in March and RBML's 1,555 petrol pumps are selling diesel at par from this month.

With oil prices dropping to \$78 per barrel this week from being high, RBML is offering Re 1 per litre discount over public sector undertaking (PSU) rates, at select petrol pumps, they said, adding the joint venture however continues to price petrol at rates higher than PSU competition.

While the softening international oil prices had rekindled hopes for a revision in retail prices



by PSU, an oil ministry official stated that a cut in rates is now likely immediately as IOC, BPCL and HPCL are yet to fully recoup the losses they incurred on selling petrol and diesel at rates below cost last year. The three public sector retailers

have broken even on petrol but there are some losses on diesel, the official said.

Sources said diesel at all Jio-bp outlets is now at par with PSU competition or at market price.

However, Jio-bp -- the brand under which RBML retails fuel isn't selling regular diesel but high performance diesel designed for Indian vehicles and roads to give better fuel economy. The diesel is laced with specially developed additives for Indian roads and driving conditions to produce high performance, they said, adding Jio-bp was selling premium diesel at rates that are equivalent to ordinary diesel at PSU pumps

State-owned IOC, BPCL and HPCL first froze petrol and diesel rates for 137 days beginning early November 2021 when five states

rates of PSUs, private retailers scaled down retail operations to cut losses. RBML alone was incurring Rs 700 crore loss a month at the peak while Russia's Rosneftbacked Nayara Energy raised prices of petrol and diesel by up to Rs 3 a litre over and above the PSU rates, to cover for some losses.

Sources said private retailers contend that PSU oil marketing companies control over 90 per cent of the market and are the price-setters, leaving no room for them in fixation of the retail selling price of petrol and diesel

PSUs have not increased fuel rices in line with escalating international crude prices eventually leading to huge under-recoveries (losses) for all fuel retailers since February 2022.

Under-recoveries or difference between cost and retail price was Rs 13.08 per litre for petrol and Rs 24.09 per litre for diesel at one point of time. Private retailers time and again

highlighted the losses they incurred on fuel sales but the oil ministry dismissed them, saying Reliance exported diesel to Europe and other countries at highly lucrative prices but was rationing supplies at its petrol pumps.

Nayara Energy owns 6,386 petrol pumps in the country. IOC, BPCL and HPCL own 78.501 out of 86.855 petrol pumps in the country.

After announcing new monetising features for content creators, the Twitter CEO is now aiming to help media houses amid a global meltdown that has seen several publications paying off employees and shutting down pro-

"Rolling out next month, this platform will allow media publishers to charge users on a per article basis with one click," said Musk.

This will enable users who would not sign up for a monthly subscription to pay a higher per arti-

cle price for when they want to read an occasional ar-

"Should be a major win-win for\_\_ both media organisations and the public," Musk added.

Earlier Saturday, Twitter said that creators across the globe can now sign up and earn a living on Twitter via the 'Monetization' tool. Musk said that all proceeds will

go to content creators and Twitter will keep nothing for now. 'We will keep 10 per cent after

12 months, but iOS/Android subscription fees drop from 30 per cent to 15 per cent in year 2, so still a net gain to creators," the Twitter CEC announced.

For many, "this represents a vital source of income and enables them to put more time into creating great content for you," he added. Meanwhile, Twitter has also applied 'Community Notes' to ads.

If it can maintain its momentum, India will overtake Germany as the world's fourth largest economy in 2026 and knock Japan from the number three spot in 2032, according to analysis by the Centre for Economics and Business Research, CNN reported.

India's working-age population stands at more than 900 million, according to 2021 data from the Organisation for Economic Cooperation and Development. In the next few years, its workforce could be bigger than China's, according to Capital Economics, CNN reported.

## Foreign investors pump in ₹11,630cr in equities

New Delhi, April 30: Foreign portfolio investors (FPIs) infused Rs 11,630 crore in the Indian equity markets in April on the reasonable valuation of stocks and appreciation in the rupee

This came after FPIs infused a net sum of Rs 7,936 crore in equities in March, mainly driven by bulk investment in the Adani Group companies by the US-based GQG Partners. However, if one adjusts for the investments of GQG in Adani Group, the net flow was negative.

According to data from the depositories, FPIs started the current financial year on a positive note, and invested Rs 11,630 crore in Indian equities in April.

In the first half of April, FPIs showed strong buying activity, indicating a renewed sense of optimism in the Indian equity market. However, this optimism was dampened in the third week of the



month due to concerns about ele vated interest rates and weak economic indicators in the US.

Apart from equities, FPIs have put in Rs 805 crore in the debt market during the period under review.

With this, FPIs have taken out Rs 14,580 crore from equities in 2023 so far and invested Rs 4,268 crore in the debt markets during the period.

Overall, FPIs pulled out a net sum of Rs 37,631 crore from Indian equities in 2022-23 on aggressive rate hikes by central banks globally and a record Rs 1.4 lakh crore in 2021-22. Before these outflows, FPIs invested a record Rs 2.7 lakh crore in equities in 2020-21 and Rs 6.152crore in 2019-20.

## Nagal clinches India's first Rome ATP Challenger title

Rome. April 30: India's tennis ace Sumit Nagal became the country's first player to win an ATP Challenger event on European clay court, pulling off an upset win over higher-ranked Dutchman Jesper de Jong here Sunday.

The 25-year-old Nagal defeated de Jong, more than 100 places above the Indian in the ATP singles rankings, 6-3 6-2 to clinch his third ATP Challenger title and the first since the triumph in Buenos Aires in 2019. Nagal, ranked 347th in the world,

had little difficulty overcoming his Dutch opponent three years younger and currently ranked 234th in the world. A regular member of the Indian

Davis Cup squad, Nagal had to play six tough matches, including two rounds of qualifiers, en route to the final.

He defeated Italy's Jacepo Berretini in the first round of qualifiers before overcoming a tough

challenge from Norway's higherranked opponent Victor Durasovic (ATP rank 302) in a gruelling threesetter to secure a place in the main round. The 2015 Wimbledon boys' doubles title winner then thrashed home favourite Francesco Maestrelli (ATP rank 172) in the first round before blanking wildcard Fausto Tabacco of Italy 6-3, 6-0 to secure a berth in the quarter-finals.

Nagal, who had defeated Uzbekistan's Denis Istomin in the first round of the 2020 Tokyo Olympics before going down to Russian ace Daniil Medvedev in the second round, defeated another higher-ranked opponent in Netherlands' Max Houkes to secure a place in the semi-final in the Rome event.

Pitted against a tough Belgian opponent in Joris De Loore, seeded eighth, the Indian lost the opening set against the 198th ranked player 2-6, before winning the next two 7-5, 6-4 to make it to the title

When the start lights turned on one by one and eventually went out, pole-sitter Leclerc jumped out of his grid slot to maintain the lead into Turn 1, with Perez holding P2.

An incredible scrap ensued between Verstappen and the faststarting George Russell, with the pair going side-by-side through the opening sequence of corners before the Mercedes nosed ahead of the Red Bull at Turn 3.

#### Liren becomes China's 1st **World Chess Champion**

Paris, April 30: Ding Liren became China's first world chess champion Sunday after a rapidplay tie-break victory over Russia's Ian

Nepomniachtchi in Kazakhstan. Ding, 30, takes over as winner of the World

Chess Championship from Norway's Magnus Carlsen, who chose not to defend his title after a 10-year reign.

He and Nepomniachtchi had finished on seven points each after the 14 first-stage games played in the Kazakh capital Astana. Each won three, while the other eight ended in a draw. For the tie-break stage of the match, also in Astana. The contenders then played a tie-break round, in which they had only 25 minutes to make their moves, plus an additional 10 seconds for each move played. Carlsen, considered

one of the greatest players of all time, had held the World Chess Championship title since 2013 and will remain the world's toprated player. The two-million-
