## Stay prepared: Naveen to officials amid cyclone fear

■ Collectors of 18 coastal and adjoining districts are on alert, says SRC Satyabrata Sahu

Bhubaneswar, May 2: Amid India Meteorological Department's (IMD) prediction of a possible cyclonic circulation over southeast Bay of Bengal around May 6, Chief Minister Naveen Patnaik Tuesday asked officials to stay prepared for any eventuality.

Chairing a high-level meeting to review the state's preparedness to deal with a cyclone, Patnaik recalled cyclone Fani, which hit the Odisha coast May 2, 2019, and said determination of the path of cyclones during summer is difficult. He asked the officials to be prepared for any eventuality.

He advised officials to shift people who live in low-lying areas to cyclone shelters, if necessary, and formulate plans for relief and restoration works in the aftermath of a cyclone. Patnaik asked Chief Secretary PK Jena to review the situation regularly, and Special Relief Commissioner (SRC) Satyabrata Sahu to work in coordination with all departments and districts.

LEISURE

An official of the Regional Meteorological Centre in Bhubaneswar said the IMD has not yet predicted any cyclone.

The likely cyclonic circulation May 6 will lead to a low-pressure area in the next 48 hours. The low-pressure area has to further develop into a depression and then deep depression, before it can become a cyclone, he said. Jena said the government will work to ensure 'zero casualty' if a cyclone hits the state.

"All Collectors have been alerted in this regard. The cyclone shelters are in readiness while more safe places, including school buildings, have been identified," he added.

Sahu said 24x7 control rooms have already been made operational in all districts.

"The Collectors of 18 coastal and adjoining districts have been told to remain prepared," he said. At least 17 National Disaster Response Force (NDRF) and 20 Odisha Disaster Rapid Action Force (ODRAF) teams have been kept on standby, he said. **Contd...P4**

This will be the first visit by a president to the park, which is spread over an area of 2,750 km.



# No multiple plot allotments: HC

Cuttack, May 2: In a significant ruling, the Orissa High Court has asked the state government to ensure that the development authorities do not allot multiple plots to individuals, said officials Tuesday. The HC's direction came while

hearing a petition filed by an employee of Bhubaneswar Development Authority (BDA) challenging the development authority's decision to reject allotment of a second plot in his favour. According to sources, the peti-

tioner, a junior assistant with BDA, had availed a plot in Kalinga Nagar area of the City under discretionary quota. Later, he transferred the plot to Farhat Nizami on the consent of the development

The petitioner was also in possession of a commercial plot at Chandrasekharpur allotted by the BDA September 15, 2001 under the District Centre Commercial Plotted Development Scheme. He had again approached the BDA for a plot which the latter rejected.

# PAWAR TO QUI AS NCP CHIEF

Nephew Ajit says the 4-time Maharashtra CM needs two to three days to revisit decision

Mumbai, May 2: Nationalist Congress Party (NCP) supremo Sharad Pawar Tuesday announced he has decided to step down as chief of the party he founded and helmed since 1999, in a dramatic move that could have a bearing on national and Maharashtra politics ahead of the 2024 Lok Sabha elec-

The announcement by Pawar at an event in Mumbai to release the updated version of his Marathi autobiography stunned leaders and workers of his party, and many were seen crying and pleading with the 82-year-old wily Maratha strongman to reconsider the surprise decision.

A meeting of a committee of party leaders -- which Pawar said should decide on the election for his successor - was held at his residence later, after which his nephew Ajit Pawar announced that his uncle will need two to three days to 'think over' his decision.

The decision by one of the tallest Opposition leaders in the country who could bring their parties together against the BJP ahead of the Lok Sabha elections also comes amid intense speculation over Ajit Pawar's next political move.



"I am with you, but not as NCP chief," Pawar, the master of twists and turns known for his deft political manoeuvring, told the emotional party workers. He had formed the NCP after he was expelled by the Congress for raising the issue of Sonia Gandhi's foreign origin.

The announcement by the NCP president, a key Congress ally, came less than a fortnight after his daughter and Lok Sabha member Supriya Sule indicated there will be two political 'blasts' in 15 days, one in Delhi and another in Maharashtra.

Many NCP workers refused to leave the venue of the book launch event even after Sharad Pawar left for his residence. They also threatened to go on a hunger strike. One even threatened to kill himself if Pawar did not relent. Contd...P4

## **DGP** to ensure arrest of drunk drivers

Bhubaneswar, May 2: In a bid to curb road mishaps and fatalities, the state government has asked Director General of Police (DGP) Sunil Kumar Bansal to ensure that those driving vehicles under the influence of alcohol or drugs are arrested.

In a letter to the DGP, Transport and Commerce Secretary Usha Padhee said that drunken driving is one of the reasons for occurrence of accidents in the state.

During the Zero Fatality Week observed in April first week, 1,257 cases of drunken driving have been detected by the RTOs and 133 such cases have been detected by the police. But such offenders have not been arrested, she said.

Padhee said the Supreme Court Committee on Road Safety has directed the Odisha government to prosecute the offender (on drunken driving case) and seek imprisonment as prescribed under MV Act, 1988 even for the first offence. The committee has also directed for suspension of driving licence for a period of not less than three months. For detection of drunken driving, she said, adequate number of breath analysers have been provided to police stations and RTOs.

The DGP was instructed to issue necessary instructions to all police stations of the state not to compound the drunken driving cases and arrest the drunken drivers.

Seoul, May 2: Italian artist Maurizio Cattelan's \$120,000 signature piece 'Comedian', a banana duct-taped to a wall, is in the headlines again after a South Korean student ate away the artwork's 'pricey fruit' at a museum in Seol, saying he was hungry after skipping breakfast.

Noh Huyn-soo was filmed brazenly removing the banana, which was duct-taped on to a wall at the Leeum Museum of Art in Seoul, unpeeling it and eating it in front of stunned onlookers before reattaching the banana skin to the wall using the same tape and walking off with a satisfied grin, The Guardian reported.

The incident was recorded by a friend of Noh, a student at Seoul National University, and lasted for over a minute.

When the museum asked Noh why he ate the banana, he replied



that he was hungry after skipping breakfast, according to the Korea Herald. He later told the broadcaster KBS that he thought 'damaging a work of modern art could also be interpreted as artwork' and that he came up with the idea to reattach the peel as 'a joke'

He added, "I thought it would be interesting ... isn't it taped there to be eaten?'

The banana, part of Cattelan's Comedian installation, gets replaced every two or three days.

Cattelan, a sculptor and performance artist based in New York, was reportedly informed about the incident and simply replied, "No problem.'

This was not the first time someone thought the artwork was ripe for picking.

During the work's debut exhibit at Miami Art Basel in 2019 a banana was removed and eaten by the performance artist David Datuna, The

'Hungry' South Korean student eats \$120,000 artwork Guardian reported.

> The first and second editions on display at Miami Art Basel both sold for \$120,000 and another was put up for sale for \$150,000 before Datuna showed up to eat the 'pricy

> "I have travelled in 67 countries around the world in the last three years, and I see how people live,' Datuna said, adding, "Millions are dying without food. Then he puts three bananas on the wall for half a million dollars?'

> Another one of Cattelan's viral artworks was a solid 18-carat-gold toilet 'entitled' America, valued at around \$6 million. It had been first installed at New York's Guggenheim in 2016 and was open to use by visitors. Later in 2019, it was stolen from the birthplace of Winston Churchill at Bleinheim Palace in England where it was being exhibited. It has never been found, the CNN reported.







## When Ray called Indian audience 'backward, unsophisticated'

Mumbai: May 2 marked the 102nd birth anniversary of legendary filmmaker-writer-sketch artist Satvajit Ray He is renowned for classic films such as Pather Panchali (1955), Charulata (1964), and Ghare Baire (1984) among many others. The filmmaker is also known to speak his mind. On his birth anniversary, here's a look at his statements regarding the audience. This was at a time when he recalled facing backlash for the Sharmila Tagore-starrer Devi.

Satyajit talked about the film in his 1960 film to French journalist

Pierre Andre Boutang in 1989. Sharmila played the role of a young woman who is seen as an avatar of the goddess Kali in the film that also featured Soumitra Chatteriee and Chhabi Biswas.

Satyajit said in the old interview, "I once made a film called the goddess Devi, it dealt with religious dogmatism, it didn't attack religion as such, it attacked dogmatism, the extreme form of religion...But people (are) writing in the papers that 'Oh! Mr Ray is not a Hindu, he is making such films against Hinduism'. But they





## **State sees record GST mop-up in April**

Bhubaneswar, May 2: Odisha has registered the highest-ever gross goods and services tax (GST) collection of ₹5,035.74 crore during April 2023, official sources said Tuesday

The collection to be retained by the state, consisting of Odisha GST (OGST) and integrated goods and services tax (IGST) settlement, has recorded a growth of 40.43 per cent during April 2023 with collection of ₹2,359.17 crore, as against collection of ₹1,680.00 crore during April last year.

This growth has primarily been due to buoyancy in the services sector as well as growth in the trad-

The total collection from goods that are not subsumed under GST, i.e. petroleum products and liquor

for human consumption, stands at ₹264.42 crore during April 2023 as against ₹232.92 crore from those goods during April last year, with a growth of 13.52 per cent.

Similarly, during April this year, the collection under all Acts monitored by the Commissionerate of

CT & GST, Odisha, including GST/ VAT/ Entry Tax / Profession Tax is ₹2,661.92 crore, in contrast to that of ₹1,947.21 crore last year,



## SC miffed over delay in SJTA chief taking charge

New Delhi, May 2: The Supreme Court has expressed its displeasure over the Odisha government's submission before it that the newly-appointed fulltime chief administrator to Shree Jagannath Temple Administration (SJTA) would take charge after completion of the chariot festival scheduled for June this year.

During the hearing Monday, Odisha advocate general Ashok Parija submitted in the Supreme Court that the order has been passed for the appointment of permanent chief administrator. However, the full-time chief administrator would take charge after the chariot festival is over, the state government submitted.

The apex court, though, informed the state government to let the permanent chief administrator take the charge.

"No no... Let him take the charge. If Works department secretary as in-charge CAO is doing good. You get the assistance of that CAO also. But let him (permanent chief administrator) take the charge,' Justice MR Shah said.

Significantly, senior advocate Ranjeet Kumar, amicus curiae to assist the court in the matter, submitted that he received the status report filed by the Srimandir Managing Committee Monday morning and sought time to go through the report.

It's a comprehensive affidavit of 30 pages. I need time to go through it." Kumar submitted.

A two-judge bench headed by Justice MR Shah granted a week's time to Kumar and adjourned the

matter to Monday. The apex court also observed that it would pass further orders for compliance of the 2019 directions if required.

Earlier, the state government and Srimandir Managing Committee had filed separate action-taken reports with respect to the apex court's directions dated 2019. The managing committee had informed the SC regarding the steps it has taken in compliance with each direction issued by the court.

## ₹10cr corpus fund for industries in jails

Bhubaneswar, May 2: In a major boost to prisoners' rehabilitation, the state government has constituted a corpus fund of ₹10 crore for the strengthening of industries in the prisons across the state. The Home department in a notice has also specified the rules and guidelines regarding the administration and functioning of the corpus fund.

The fund will be managed by an entity called 'Corpus Fund Management Committee' comprising various officials like Director General of Prisons, additional director general (ADG) or inspector general (IG), deputy inspector general (DIG), representatives of Finance and Home departments and senior superintendents of jails. The DG, Prisons will head the committee as the president. Experts having domain expert-

ise in various industries will be included in the committee too. The committee headquartered at the office of Prisons DG will meet once in every quarter.

Similarly, an executive committee set up at the prison level



will administer the amount received from the corpus fund for functioning of jail industries. The committees will consist of superintendents, jailors and other staffers of local prisons.

The jail authorities have been asked to open a zero balance subsidiary account in the name of Odisha Prisons Corpus Fund.

"The respective superintendent/jailor-cum-superintendent of Prison Industry shall furnish a detailed proposal through the senior superintendent addressed to the President, Odisha Prisons Corpus Fund duly justifying the requirement of the funds on advance (interest free) basis for existing or newly proposed Prison Industries," the Home department notification reads.

Following the receipt of the proposal, the Corpus Fund Management Committee, will examine the proposal and sanction the amount if it feels satisfied with the same. The officials have been strictly instructed to not utilise the money sanctioned from the corpus fund for any other purpose other than setting up of or strengthening of existing industries.

Notably, industries have been functioning at different jails to impart vocational training in vari-

## Raw deal for Berhampur MLAs

been winning this seat since 2000 till date. BJD's Ramesh Chandra Chyau Patnaik won the seat four times in succession from 2000 to 2014. Then in 2019 BJD's Bikram Kumar Panda emerged victorious. However, despite holding supremacy, BJD winning candidates

have never been given ministerial

berths in the state Cabinet. This has

raised questions in the minds of

political analysts. Late Lingaraj Panigrahi, former Chief Justice of Orissa High Court, was elected as an MLA in the 1957 elections during Congress rule in the state. He was appointed as a Cabinet Minister in Housing, Education and other departments. Similarly, Krushna Charan Patnaik who won on a Congress ticket in 1980 from Berhampur was appointed as a minister for two years during the first term of the Janaki Ballav Patnaik-led government.

The last time Congress won in the Berhampur Assembly constituency was in 1985 when Youth Congress leader Shiba Shankar Sahani emerged victorious. Since

then the fortunes of Congress has only gone downhill in the Berhampur seat. Retired police officer Binayak Mohapatra won on a Janata Dal ticket from this seat and also became a minister in the government headed by Biju Patnaik. That was probably the last time that a Berhampur lawmaker was appointed minister.

The most unlucky winner from this constituency must be Ramesh Chandra. Despite winning four successive times on a BJD ticket, he was never made a minister. To add to his miseries, his one time political rival Panda was nominated on a BJD ticket from the Berhampur constituency. Panda won, but even he was not given a ministerial berth.

It should be stated here that former Kodala MLA Ramakrushna Patnaik was made a minister twice – once during Biju Patnaik's tenure as Chief Minister and then once in the Naveen-led government. However, he fell out of BJD's favour. Similarly, Digapahandi MLA Surya Narayan Patra got ministerial berths four times and was also appointed Speaker of the Odisha Legislative Assembly after BJD emerged victorious in the 2019 elections. Currently Bhanjanagar MLA Bikarm Keshari Arukh is the Speaker of state Assembly. Chikiti MLA Usha Devi has got a Cabinet berth a number of times and is now the Minister of State for Housing and Urban Development department.

Many have been left wondering as to why Berhampur lawmakers are being deprived of a ministerial berth for quite a substantial period of time when others from the same district have

## Melanistic tiger found dead in Similipal

**INJURIES SUGGEST IT WAS ATTACKED BY ANOTHER BIG CAT OVER TERRITORY**

Baripada, May 2: A rare melanistic tiger was found dead Monday in the core area of Similipal Tiger Reserve in Mayurbhanj district, an official said Tuesday. On being directed by Principal Chief Conservator of Forests (PCCF) Sushil Kumar Popli, a team has reached Similipal and launched

Preliminary reports indicate that the dead tiger suffered injuries while fighting with another big cat and that led to its death, said Prakash Chand Gogneni, field director of Similipal Tiger Reserve. However, only after the post-mortem report is available, one can ascertain the reasons behind the death of the melanistic tiger. "Injuries suggest that the deceased animal was bitten by another tiger," Gogneni said. "Prima facie, it appears to be the result of infighting between two male tigers over territory," he added.

Popli told the media that the carcass of the tiger was found Monday morning at Naana range, under south division in the core area of



Similipal. The tiger was aged around 3-3.5 years, he added.

On being informed, members of National Tiger Conservation Authority (NTCA), joint taskforce members, Gogneni, deputy director Samrat Gouda, three ACFs, veterinarians Dr Piyush Soren and Dr Bibhu Prasad Das rushed to the spot and launched an investigation. The samples of the dead tiger were collected and sent to the OHAT laboratory in Bhubaneswar for examination. Later, the carcass was cremated at the spot.

Notably, black or pseudomelanistic tigers, with a distinctive dark stripe pattern, are very rare. They have only been found in Similipal till date.

In a separate development, Forest department officials of south division reported about a tusker carcass lying at Dhuduchampa area under Naana range. They said that the tusks of the elephant were missing which indicates that the animal was killed by poachers. However, there was no official confirmation about the incident.

## Rairangpur gears up for Prez visit

Bhubaneswar, May 2: President Droupadi Murmu will make her maiden visit to Rairangpur, her native place in Mayurbhanj district this week, since assuming office. She will also go on a tour of Similipal National Park later this week, officials said. Her visit to the national park, a tiger reserve that covers an area of 2,750km, will be the first by a President of the India, the officials said. Murmu will pay the three-day

visit to her home district from May 4 and visit her in-law's village Pahadpur in Rairangpur subdivision. The President will reach Kalaikunda Air Force station in West Bengal, May 4, and from there travel by helicopter to Badampahar helipad and reach Pahadpur the same day, an official informed.



Murmu had visited the state twice earlier since assuming office in July 2022. However, this time her visit will be confined to Mayurbhanj district only.

According to the schedule made available to the media, the President will visit the memorial of her husband Shyamcharan Murmu and her two sons and attend various programmes at Rairangpur. She is also slated to lay the foundation stones of two projects at Pahadpur

and spend the night at Rairangpur Inspection Bungalow, the officials said. She will visit Simlipal National Park May 5 and spend the entire day there.

Murmu will visit Baripada, the Mayurbhanj district headquarter town and attend the convocation of Maharaja Sriram Chandra Bhanja Deo University the next day (May 6) before winding up her visit and returning to Delhi.

Meanwhile, the president's proposed visit has created a flutter among the people of the locality. The entire Pahadpur village is undergoing a complete makeover with kutcha roads leading to it being concretised and her in-law's house renovated. ## Over 2 crore Olive Ridley hatchlings born at 'Nasi-2'

PNN & AGENCIES

Kendrapara, May 2: Over two crore hatchlings of the endangered Olive Ridley turtles have emerged at the mass nesting site 'Nasi-2', the world's largest rookery of the species in Gahirmatha Marine Sanctuary, officials said Tuesday.

Rajnagar Mangrove (Forest) and Wildlife Division DFO Sudarshan Gopinath Jadhav said Tuesday that within a span of four days from April 29 to May 2, the hatchlings emerged, marking the culmination of the annual rendezvous of the marine species. The hatchlings after a brief period on the beach entered the sea.

This year a total of 5.12.175 Olive Ridley turtles came on shore at 'Nasi-2' for mass



nesting and laying of eggs March 9 to March 13. However, officials pointed out that 20 per cent of the eggs were destroyed as many turtles laid eggs at the same spot, in the process breaking those that had been laid earlier. Also crows and seagulls gobbled up a large number of eggs.

Female Ridley turtles generally lay 100-120 eggs in one go and then they return to the sea. They lay the eggs in a haphazard manner so as to confuse predators about the location of the eggs. The hatchlings emerge after a period of 45-55 days.

Officials said Forest department personnel are deployed on the beach to protect the eggs and the newborn hatch lings. Once hatched, the turtles dig their way to the surface and enter the ocean.

Many experts believe that once the hatchlings emerge from the sand, some form of imprinting on the earth's mag netic field occurs inside them. This guides the hatchlings back to the same breeding areas when they become adults. It is one of Nature's rare phenomena where the hatchlings grow without their mother. Hence their mortality rate is very high. Out of every 1,000 hatchlings only one manage to attain adulthood, officials informed.

## **Religious Shield**

ot much is known about the religious aspect of Russia's invasion of Ukraine as the focus has, so far, been on military prowess of the warring nations and tactical advantages gained or lost on the soil of Ukraine. That it has also been turned into a religious war came to the fore when the religious head of the Russian Orthodox church, Patriarch Kirill recently exhorted the church's followers fighting in the frontlines to care for "God's truth". He sermonised that the church must play its part in the battle against the secularising forces of the liberal West so as to preserve "Holy Rus(sia) and our people, living by God's law". President Vladimir Putin's Russia is now relying on religion to tip the balance in its favour. This is the tactic that Putin has been using for years to wean away Ukraine's population who follow the Orthodox church in Russia's favour.

Patriarch Kirill has understandably become a religious pariah in the global Orthodox church for taking sides with Putin in the war in Ukraine. This has caused a setback to Kirill's goal of turning the war into a struggle on behalf of "Holy Rus", which is an imaginary spiritually unified territory that includes Ukraine and Belarus.

The development has not gone down well with Ukraine's President Volodymyr Zelenskyyi and the majority of Ukraine population. This is evident from the fact that a Bill has been placed in the Ukrainian parliament that aims at closing down Ukrainian Orthodox Church (UOC) which is under the jurisdiction of the Moscow patriarchate. There have been reports that the UOC harbours some pro-Putin sympathisers. They are being purged. Churches and monasteries associated with the UOC across Ukraine are being transferred to the smaller independent Orthodox Church of Ukraine (OCU). Priests and monks known to be owing allegiance to Moscow have been served with an eviction notice. Interestingly, around three-quarters of Ukrainians follow the Orthodox Church, but a recent poll has revealed only 4% of them formally identified with the UOC. Far more believers now follow the independent church, OCU.

The development could worry Putin as it comes in the wake of Finland having been inducted into the North Atlantic Treaty Organization (NATO). Putin used the alibi of Ukraine's move to become a NATO member for declaring war against Ukraine. But, as the war progressed without any sign of decisive victory for Russia, more countries close to Russia have started lobbying for NATO membership. Finland became the 31st member of NATO prompting US Secretary of State Antony Blinken to say at the ceremony in Brussels that both Finland and the NATO alliance were "stronger and safer" with the inclusion of the new member. The decision was taken, in a clear snub to Putin, to strengthen the alliance's collective defence and enhance its ability to respond to security challenges in the Euro-Atlantic area. Russia's further invasion into Ukraine last year precipitated the very thing President Putin wanted to avoid - a stronger and more unified Transatlantic

Similarly, Putin's strategy to use the Orthodox Church to influence Ukraine's majority population subscribing to that denomination of Christianity has seemingly backfired. Putin and Patriarch Kirill hoped that a pro-Moscow version of conservative Christianity could serve as the spiritual anchor of a forcibly reconstituted "Russian" world incorporating Kyiv.

The UOC has been acting as an instrument of Russian soft power and influence in Ukraine. It has formed an important link of a common religious heritage in the region going back to a thousand years. But, Putin's keenness to use it to advance his agenda on Ukraine has resulted in weakening its appeal. It now stands hugely diminished and discredited

## ■ Auxetic

Common sense says that when you stretch a substance, say a piece of rubber, it becomes longer in the direction of the pull but thinner in the transverse directions. But there are a very few substances such that when you pull on them they actually increase in cross-section. These oddities are said to be auxetic. The word in this sense is believed to have been coined by Professor Ken Evans of Exeter University in an article in Nature in 1991. Such auxetic substances, which now include certain ceramics and polymers, have potential as molecular sieves and filters, as cushioning (for example, inside crash helmets), and possibly other uses still being investigated. The word itself is far from new. It has been used since medieval times as a term in rhetoric in which repetitive language is used to amplify or magnify a statement. In plant physiology, auxetic substances tend to increase cell growth without cell division; the related term auxin refers to a substance that does this, also called a plant hormone. All these terms stem from the Greek word meaning "increase; grow". The noun is auxesis.

reader queried this odd-looking word, meaning a pretender to Awisdom. A friend had suggested to him that the link with a measurement of land was that it alluded to a person having broad expanses of sagacity. Ho, ho. Although some experts do profess themselves baffled by the acre part of this word, we know where it comes from - the Middle Dutch wijsseggher, a soothsayer, a wise sayer. The first part is from the same source as our wit. It first appeared in English in a scurrilous ballad of 1595 that had the catchy title A Quest of Enquirie, by women to know, Whether the Tripe-Wife were trimmed by Doll. A tripe-wife was a tripe dresser, in this case a well-to-do London widow who sold her wares from a stall; the trimming referred to the cheating of her by one Doll Phillips, who pretended to be a fortune teller who could tell her which of her suitors she was to marry. The story was based on real events, though embroidered. We know that the Dutch pronunciation had already changed, since in the ballad it's given as wise-aker. The shift from Dutch to English is a good example of a common form of folk etymology, in which an odd or foreign word is changed until it looks familiar, even if its parts make no real sense. The word seems never to have been used in English in the literal sense of a wise person that it had in Dutch, perhaps because of the traditional enmity between the two nations that led to a series of disparaging terms such as Dutch courage. It has always meant a person projecting an unjustified appearance of wisdom or specialist knowledge - a wiseacre pontificates on a subject despite being ignorant about it. In the US it can also mean someone regarded with irritation because he's a knowall or makes sarcastic comments, a smart alec or wise guy. At one time the home of the Royal Society in London, Gresham College, was called Wiseacres Hall by those sneering at its intellectuality.

ollowing the Election Commission's (EC) announcement that voting for 224 Assembly seats in Karnataka will take place on May 10 and the vote counting will take place on May 13, a flurry of hectic electoral activity is apparent among the state's major and minor political parties which have been girding up their loins to leave nothing to chance to get another crack at power. Undoubtedly, the results of the upcoming elections remain a mystery until May 13; however, there are many factors that may help to shed light on these hopes. Many political commentators be lieve that the two main issues in the 2023 Karnataka Assembly elections will be religion and caste, along with two other issues, such as alleged corruption in government projects and the administrative and civic problems in Bangalore.

The majority of pre-election polls in February and March predicted a close race between the BJP and the Congress, with neither party winning a majority by a significant margin, while in the second half of April, the majority of these pre-election polls indicated that Congress has a significant lead over the BJP and had chances of forming its own government.

### BJP's Dilemma

A number of issues, including an anti-incumbency wave, serious corruption allegations, the disillusionment of senior BJP state leadership with the central leadership, and fierce party infighting, particularly over the distribution of tickets, face the BJPled government in Karnataka. The so-called bitcoin scandal, 40% commission fees on government tenders, and alleged misappropriation of funds during the COVID-19 pandemic have all put the Karnataka government in the crosshairs of Congress and JD(S). In addition to Congress' "PayCM" campaign, chief minister Bommai is blamed for subpar leadership and deteriorating infrastructure.

The incumbent BJP is blamed for bad governance, and crumbling infrastructure in addition

to Congress' "PayCM" campaign in the wake of some significant Lingavat leaders defecting to the Congress after growing disenchanted with the BJP, along with growing disenchantment of the Vokkaligas and Lingayats and other minorities with the BJP. The BJP is heavily reliant on PM Modi to win over voters, but Karnataka has previously supported different governments at the national and state governments.

Even in the past, the B.IP's dependence on PM Modi's blitzkrieg campaigning has not helped the party to win elections of its own, and the majority of the BJP "achievements" highlighted by Modi in the state are funded by the federal government. The perception that Modi has "tolerated" corruption by Karnataka's own chief minister and other leaders is also problematic. Additionally, the whirlwind campaigning style of Rahul Gandhi, Priyanka Gandhi Vadra, Congress president Kharge and other state Congress leaders with their primary focus on basic local issues, has not only dashed the hopes of the BJP of turning the campaign into a contest between Rahul

Gandhi versus PM Modi but has also taken the wind out of the BJP's sail and keeping PM Modi out of campaigning for most of April and only enabling him to campaign just a week before the state goes to polls on May 10.

### **Congress Stratagem**

The forthcoming election in Karnataka is more prestigious for Congress because Mallikarjun Kharge, the new party president, is a native of the state. Congress is making a strong push because it cannot take anything for granted. The four carefully chosen electoral promises made by the Congress—Gruha Jyoti (200 units of free electricity); Gruha Lakshmi (Rs 2,000 per month for women who are the head of household); Anna Bhagya (10 kg of rice per month for BPL cardholders); and Yuva Nidhi (Rs 3,000 per month for unemployed young people with graduate degrees)—have already had a positive impact.

According to some experts, Congress could make a change to benefit the farmers by granting their long-standing request for an MSP guarantee, successfully mobilizing the OBCs, SC, ST, and mi norities who make up the bottom

two-thirds of Karnataka's social pyramid. Given the presence of JDS, the possibility of vote splitting by AIMIM and SDPI, and the unease in the Muslim community over how elected Congress MLAs joined the BJP last time, it cannot take Muslims for granted Nevertheless, Congress leaders' frequent interpersonal meetings with the local populace, including housewives, students, and farmers, are proving crucial in winning over the greatest number of voters in the state who cross the sect and caste lines. A choice between a BJP government with a 40% commission and a Congress government with five guarantees has been made available by Congress.

### **Way Forward**

In the lead-up to the Lok Sabha elections, some experts have hailed the upcoming state Assembly elections as the proverbial "semifinal." While acknowledging that Karnataka cannot decide the Lok Sabha election or serve as a gauge of public sentiment in the north and west of India, where the BJP sweeps the Lok Sabha elections, these experts believe that what happens in Madhya Pradesh, Rajasthan, and Chhattisgarh in December of this year will have a greater impact on the parliamentary elections. However, Karnataka is the pivotal battle that will determine the political course of the following year. The defeat of the BJP in Karnataka could symbolise the rejection of its divisive and hateful policies and put pressure on the Modi administration regarding the Adani issue.

On the other hand, a Congress victory in Karnataka will expand democratic space, and additional victories for the party in Rajasthan, MP, Chhattisgarh, and MP will make it difficult for the BJP to win elections. Congress will then be able to carve out its own political space for the 2024 Lok Sabha elections by leading a broad coalition of non-BJP parties.

## Simple rules to stay off the no-fly list

he United States has a nofly list, but is considering a ilar to India's no-fly list.

The current list, administered by the Federal Bureau of Investigation (FBI), is for anyone connected to terrorism or suspected of such ties. As reported by the Associated Press, Congress is considering a proposal to create a no-fly list for unruly passengers, particularly those who've been violent on a plane.

"Strong penalties are needed to curb violent and unacceptable behavior," said Cher Taylor, a Frontier Airlines flight attendant who witnessed one passenger assaulting another in 2021. "Bad behavior should not fly."

Yes, bad behavior should be grounded. Too many people just don't know how to behave on a plane. The media has informed us about the most flagrant cases, but did you know that 149 passengers have been placed on India's no-fly list in the last three years? These people are not allowed to board a plane. Is this fair? Perhaps so, but I think we should give them a chance to fly again, as long as they all take a flight together. Let them see what it's like to share a flight with jackasses. We could also put cameras everywhere and create a reality TV show called "Imbecile Airlines."

Of course, many of the 149 pas-

sengers are no longer on the no-fly list. Depending on the severity of their offences, passengers are placed on the no-fly list for as little as three months or as long as a lifetime. Threatening to hijack a plane gets you a lifetime ban; threatening to hijack the liquor cart gets you three months.

Nobody wants to be on a no-fly list, but people often don't think about the consequences of their actions. That's why I'd like to offer some simple rules that will help you stay off the list:

1. Do not urinate on your fellow passengers. This may seem like an obvious thing, but there have been at least four instances in the

last six months of Indian men relieving themselves on fellow passengers. As far as I'm concerned, the perpetrators deserve to be banned from flying for at least 10 years. I consider myself a peaceful man, but if someone urinated on me or a family member during a flight, the newspaper headline would say: "Urination on Plane Results in Ruination of Face.'

2. Keep it in your pants. This rule is connected to the previous offence, but also to another offence: exposing yourself to fellow passengers. Whether this happens accidentally or deliberately, it's something you want to avoid. Trust me, people don't want to see it, at least

if a passenger says to you, "I've rect response is, "Only if you want to be sued."

3. Do not do any pinching. No matter how attractive the flight attendants might be, do not try to pinch them. This also applies to your fellow passengers, as well as their belongings. Keep your hands and other body parts to yourself. Resist the temptation to flirt with anyone on the flight. Remember: they can't easily walk away. But they can easily slap you.

4. Do not make any threats. This includes bomb threats or threatening the life of any passengers. Occupying a cramped plane with hundreds of strangers can be stressful, but you need to be patient and considerate. Don't pull someone's hair over a reclined chair. Don't practice "tit for tat" or even "spit for spat."

5. Do not fly drunk. Drinking in excess before flying (or during a flight) is never a good idea. The more you drink, the less you think. Being under the influence of alcohol or even drugs can lead to many other problems. You might as well call the Directorate General of Civil Aviation and put yourself on the no-fly list. Why wait until you've done something stupid, like sleeping on the floor in the aisle?



When Tajpuriya saw the attackers, he ran to the cell of a fellow inmate, named Rohit, who tried to save him by closing the gate of his cell. However, the cell could not be locked from inside and the assailants barged into the cell. In this process, Rohit too got injured, police officials said, adding that the deceased received "92 stab" injuries, citing a preliminary postmortem report.

## Centre calls for curb on outdoor ads of betting, gambling platforms

New Delhi, May 2: The Centre on Tuesday asked state governments to crack down on outdoor advertisements of gambling and betting platforms which have started appearing on hoardings and auto-

rickshaws across the country. In a letter to chief secretaries of states and Union territories, Information and Broadcasting secretary Apurva Chandra asked them to take "appropriate action" to curb outdoor advertisements of gambling and betting platforms.

"Advertisements of online betting are misleading, and do not appear to be in strict conformity with the Consumer Protection Act 2019, Advertising Code under the Cable Television Networks Regulation Act, 1995, and advertisement norms under the Norms of Journalistic



Conduct laid down by the Press Council of India under the Press Council Act, 1978.

"Since betting and gambling are illegal in most parts of the country, they pose financial and social economic risk for consumers, especially the youth and children,' Chandra said.

The Ministry of Information and Broadcasting had issued advisories to private television channels, digital news publishers and lishing and broadcasting advertisements of such platforms. Advertisements of gambling and betting platforms had appeared

in a section of the media -- print, digital and television -- which prompted the government to issue "While such advertisements have been largely curbed in mainstream print, electronic and digital media.

it has now come to the notice that some betting and gambling platforms have started using outdoor media such as hoardings, posters, banners, auto-rickshaw branding to promote their websites/apps in India," the advisory stated.

"Accordingly, it is requested that appropriate action may be taken to curb outdoor advertisements of betting and gambling platforms," it said.

## SC removes 6-month waiting period for divorce


New Delhi, May 2: The Supreme Court held Monday it has the discretion of exercising the plenary power it commands under Article 142 of the Constitution to dissolve a marriage on the ground of "irretrievable breakdown", and the authority to dispense with the 6-month waiting period mandated under the Hindu Marriage Act, 1955 while granting divorce with mutual con-

The apex court made it clear that contesting parties cannot directly approach it and seek dissolution of marriage on the ground of irretrievable breakdown by filing a writ petition under Article 32 of the Constitution.

Article 32 gives Indian citizens the right to seek constitutional remedy from the Supreme Court if they have been deprived of their fundamental rights.

Article 142 of the Constitution deals with enforcement of decrees and orders of the apex court to do "complete justice" in any matter pending before it. As per Article 142(1), a decree passed or an order made by the apex court is executable throughout the territory of India. Section 13-B of the Hindu Marriage Act deals with divorce by mutual consent and sub-section (2) to this provision provides, after the first motion has been passed, the parties would have to move the court with the second motion, if the petition is not withdrawn in the meanwhile, after six months and not later than 18 months of the first motion.

A five-judge Constitution bench headed by Justice S K Kaul said Article 142(1) of the Constitution, which gives "wide and capacious power" to the apex court to do complete justice should be exercised in



a legitimate manner and with caution, as its verdict ends the litigation between parties

It said grant of divorce by the apex court on the ground of irretrievable breakdown of marriage is not a matter of right, but a discretion which is to be exercised with great care and caution, keeping in mind several factors ensuring that

'complete justice' is done to both

The bench was dealing with questions, including whether the top court can grant divorce in exercise of power under Article 142(1) of the Constitution

when there is complete and irretrievable breakdown of marriage in spite of the other spouse opposing the prayer.

'This question is also answered in the affirmative, inter alia, holding that this court, in exercise of power under Article 142(1) of the Constitution of India, has the discretion to dissolve the marriage on the ground of its irretrievable breakdown," said the bench, also comprising Justices Sanjiv Khanna, A S Oka, Vikram Nath and J K Maheshwari.

"This discretionary power is to be exercised to do 'complete justice' to the parties, wherein this court is satisfied that the facts established show that the marriage has completely failed and there is no possibility that the parties will cohabit together, and continuation of the formal legal relationship is unjustified," it said.


Commenting on the verdict, senior advocate and Supreme Court Bar Association President Vikas Singh said he is against the judgement and the reason is that perhaps twice the Bills were moved in Parliament to amend the Hindu Marriage Act to include the aspect of 'irretrievable background' of marriage as a ground of divorce and Parliament rejected it twice.

Rukhsana Mehmood, wife of local MLA Iqbal Mehmood Barq, has also announced that she would support independent candidate Farhan

Recently, the veteran politician had made headlines for showering praises on Bahujan Samaj Party (BSP) supremo Mayawati Describing Mayawati as a political personality, Barq went on to say the country needs a leader like her. He said as a Muslim, he supports her.

Four-term MLA and five times MP Barq had defected from the SP ahead of the 2014 Lok Sabha polls,

In Shahjahanpur, the SP faced major embarrassment when Archana Verma, daughter-in-law of four-time MLA and two-time MP late Ram Murti Singh Verma despite being declared official party candidate for the post of Shahjahanpur municipal corporation may, defected to the BJP and filed her nomination papers for the mayor's post as the saffron party candidate.

## International airports on high alert

Customs and DRI officials have deployed special squads at all four airports and extra vigil is in place after the seizure of the exotic animals at the Chennai airport

kingsnakes green anacondas and chameleons were also seized from the woman's checked-in bag and separate suitcases. Customs officials intercepted the woman after specific inputs on her arrival that she was car-

rying the exotic animals with her. After a long time, pet traders sent contraband from Malaysia rather than from Thailand which was earlier the hot spot for smuggling of exotic animals.

Sources in the airport said that the snakes are being smuggled as they don't need food and even ven-

tips that more such smuggling of exotic species would take place through Tamil Nadu airports.

Customs officials said that airports in Tamil Nadu are targeted by smugglers as passengers from far eastern countries like Malaysia and Thailand to India are mostly from Tamil Nadu. The smugglers, according to the customs officials have tried a different airport to mislead the officials at Chennai.

According to officials, five seizures of exotic species have been made since January 1, 2023, from Chennai airport.

## TN to set up ATS UPPSC to give second chance to failed candidates

Prayagraj (UP), May 2: The Uttar Pradesh Public Service Commission (UPPSC) is working to secure the future of candidates who qualify for the interview stage of Combined State/Upper Subordinate Services Examination, commonly known as UPPSC, but fail to clear it.

The commission has decided to secure jobs for such candidates in the private sector, said a senior official of the commission. It will now prepare certified data of all such candidates after taking their consent. It will upload their names, phone numbers and other details on its website so that private firms and agencies can invite such meritorious candidates for jobs, he added.

Every year, lakhs of candidates apply for the coveted PCS exams. It is after clearing preliminary and mains exams, that they are selected for the interview round, but very few of them finally get selected against posts on offer. However, clearing the mains and qualifying for interview is also considered exceptional achievement in terms

of potential of the candidates. According to official sources, the data would mention the name and phone number of the candidate along with their academic details and the same would be available on the commission's website, so that private firms and agencies can invite such



meritorious people for jobs.

UPPSC officials said that work has been started to implement this system and candidates are being contacted. Since private agencies are in need of hiring capable candidates, the step would prove a milestone in bridging the gap be-

tween demand and supply. The commission will even contact the agencies to fulfil the task. Along with this, cooperation will also be taken from the state government to prepare private agencies to hire the potential candidates as per the requirement of the respective industry or agency, said a senior UPPSC official.

He further said. "The commission believes that the candidates who are completing the journey till the interview, are quite capable. Since only a few meritorious come out successful in this tough three-layered selection process, this initiative will serve two purposes-- one this will prevent students going into depression by giving them job and will also serve the requirement of

the industry." The commission is preparing to include a column related to obtaining consent from the candidates in the application for the main examination in the upcoming PCS recruitment itself.

If a candidate, going to appear in the Main Examination wants his/her name and roll number to be included in the authenticated data, he/she will have to fill the consent column in the application.

Lucknow, May 2: Bulldozers will roll and rumble once again in Uttar Pradesh but this time the "action" will be against encroachments on government lands, parks and ponds in areas under the jurisdiction of urban local bodies.

According to a state government spokesman, necessary instructions have been given to the authorities concerned to identify illegal constructions and encroachments.

Information regarding the encroachments must be updated on the 'Anti Land Mafia' (IGRS) web portal with the help of the revenue department, the instructions



said. A government order issued to this effect made it clear that it will be the responsibility of every civic

body to provide the information to the director. Directorate of Local

"All encroachments on government lands will be removed," a senior government official said when asked if bulldozers would be used. So far, bulldozers were largely used in the state to raze properties of criminals.

The campaign against land mafia has been underway since 2017, when the BJP government under Chief Minister Yogi Adityanath was formed for the first time.

The Revenue Department, which has been undertaking the antiland mafia campaign since 2017, has constituted a four-level task force to review the drive at the state, divisional, district and tehsil levels.

Chief Secretary Durga Shankar

Mishra is chairman of the state level 'Anti Land Mafia Task Force', while principal secretaries of urban development and other departments are its 'state-level' members.

In a recent review meeting of the task force, it was found that information on the portal about illegal encroachments on public lands in cities and towns was negligible. This was the reason, perhaps, why fresh instructions were issued in this regard.

Some BJP leaders feel that the government's decision to remove all illegal encroachments, in spite of the upcoming civic polls, only showcases its resolve to act against all those who violate the law.

head of pulmonary and critical care department, KGMU, said, "Asthma deaths are preventable with early diagnosis and proper treatment. India shares 20 per cent of average 2.5 lakh asthma-related deaths reported globally in a year.'

He further said, "Due to lack of equipment and awareness, almost 70 per cent of patients remain untreated. FENO testing machine will not only help in diagnosis but will also give accurate results in one attempt as it is a handheld device used to measure nitric oxide in patients."

"In spirometry, patients have to consider many points to get accurate results, like wearing loose clothes, avoid eating and drinking for at least two hours before the test, and stop medicines and use of inhaler before the test," he added.



## Muslim body moves SC seeking stay on release of The Kerala Story

New Delhi, May 2: A Muslim body Tuesday moved the Supreme Court seeking a direction to the Centre and the Central Board of Film Certification (CBFC) to not allow the screening and release of the movie "The Kerala Story" at theatres and on OTT platforms.

The Jamiat Ulama-I-Hind said the film, which is slated to be released May 5, is likely to cause "hatred" and "enmity between different sections of society" in the country.

Earlier in the day, a bench of justices KM Joseph and BV Nagarathna refused to entertain a plea filed in the hate speeches case that sought a stay on the release of the movie, saying the petitioner can approach the high court or appropriate forum as the film has been certified.

The Jamiat in its writ petition filed through advocate Ejaz Maqbool said, "The movie demeans the entire Muslim community and it will result in endangering the life and livelihood of the petitioners and the entire Muslim community in our



country and this is a direct infringement under Articles 14 and 21 of the Constitution of India."

It said the movie demeans the entire Muslim community, particularly the Muslim youth, and it will result in endangering the life and livelihood of the entire community in the country. This also is a direct infringement under Article 19(1)(g) of the Constitution of India, the Jamiat said in its petition.

The plea said the crux of the movie's trailer is that Hindu and Christian girls in Kerala are being converted to Islam by extremist clerics and trafficked to Afghanistan to ISIS while outwardly friendly Muslim youths classmate abet the same by luring them.

# Centre may form panel to probe 'execution by hanging'

The top court March 21 had said it may consider setting up of a committee

of experts to examine whether execution of death row convicts by hanging was proportionate and less painful and had sought "better data" from the

New Delhi, May 2: The Centre Tuesday informed the Supreme Court that the government is considering appointing an expert committee to examine whether a less painful method of execution than hanging by the neck, for prisoners on death row, can be found.

Attorney General (AG) R. Venkataramani, representing the Centre, submitted before a bench headed by Chief Justice of India D.Y. Chandrachud and comprising Justice J.B. Pardiwala that deliberations are going on and if



the court would take up the matter after a week, then he can return with a response.

"I have suggested (forming a committee) and we are working towards that and gathering some names," he said. The Chief Justice, recording Venkataramani's statement, said that "the AG states that the government is considering the appointment of committee", and scheduled the matter for further hearing in July.

On March 21, the Supreme Court said it was open to set up a panel of experts, while asking the Centre to initiate a discussion and collect relevant information to examine if there is a less painful method alternative to hanging by neck to execute the death penalty.

A bench headed by the Chief Justice had said one of the as-

pects could be to look at the matter from the point of view of science and technology. He further added that is there a method which is consistent with human dignity and socially acceptable, based on today's knowledge of technology and science? "Do we have any data either in India or overseas relating to the circumstances as they transpired in the execution of sentence of death with alternate methods?" the bench queried.

The apex court was hearing a writ petition by advocate Rishi Malhotra seeking a direction for quashing of the provision contained under Section 354(5) of the Criminal Procedure Code as ultra vires the Constitution and espe cially Article 21 being discriminatory and also in contravention of the constitution bench judgment in Gian Kaur's case.

The plea, citing Kaur's judgment, said: "the Right to Life including the Right to Live with human dignity would mean the existence of such a right up to the end of natural life.

This also includes the right to a dignified life up to the point of death including a dignified pro-

## No relief for Rahul in 'Modi surname' case

Ahmedabad, May 2: The Gujarat High Court Tuesday refused to grant interim relief to Congress leader Rahul Gandhi on his plea for stay of conviction in a criminal defamation case over his "Modi surname" remark, saying it will pass its final order post-summer vacation.

Counsel for Gandhi (52), Abhishek Manu Singhvi, cited "extreme urgency" to request from the court for an interim or a final order after arguments from both sides in the matter concluded during the day.

The court of Justice Hemant Prachchhak, however, said no interim protection can be granted at this stage.

Justice Prachchhak said he will pass a final order only after going through the records and proceedings, and posted the matter for verdict after reopening of the HC postsummer vacation, which will be from May 8 to June 3. Advocate Nirupam Nanavati, who appeared for Gujarat Bharatiya Janata Party (BJP) MLA Purnesh Modi, the original complainant in the case, also opposed Singhvi's prayer for in $terim\,relief\,\,to\,the\,disqualified\,Lok$ Sabha MP. The Surat trial court had March 23 sentenced the former

the Prime Minister's "Mann Ki Baat' programme. Sherpuria's presence was also noticed at the Prime Minister's programme at ISRO in Ahmedabad, wherein he is reported to have expressed his willingness to manufacture 75 nano satellites, say published reports which also point to the presence of ruling party leaders at his residence to offer condolences when his father passed away Another report has it that he had lent Rs 25 lakh as 'unsecured loan' to Manoj Sinha, before the 2019 elections which he had contested from Gazipur. He has half a dozen books to his credit including one on Prime Minister Narendra Modi. In summation, he thus successfully managed to create a façade of a doo-gooder-phi-

lanthropist who actually seemed to be a self-proclaimed fixer but was in actual fact a conman. The FIR mentions his involvement in money laundering, bank loan defaults by his companies .

The philanthrophic face of this alleged con-kin was reflected through the establishment of Sanjay For Youth, an organisation that ran campaigns for unemployed youth, green environment and even for freedom fighters. He is reported to have used this organizational structure for money laundering and even for siphoning money from corporates. A network of shell companies aided the cash conversion.

Gullible individuals or even troubled corporates capitulating to such characters is under-

standable. What is not, however is that Sanjay was felicitated with an award presented to him at the hands of industrialist Ratan Tata at the 2012 Vibrant Gujarat Summit, which is an official event of the Government of Gujarat, according to published reports.

Interestingly, Sanjay had established a firm, Kandla Energy and Chemicals Ltd (KECL) March 7, 2005. The State Bank of India (SBI) had granted financial assistance of Rs 171.85 crores to it in January 2013. It was classified as a NPA for non-payment of debt in July 2014. The matter figured before the National Company Law tribunal (NCLT) wherein the SBI had put the firm's dues owed to it at Rs 349.12 crores as December 31, 2022.

Minneapolis: A former Minneapolis police officer who held back bystanders while his colleagues restrained a dying George Floyd has been convicted of aiding and abetting manslaughter. Tou Thao, who already had been convicted in federal court of violating Floyd's civil rights, was last of the four former officers facing judgment in state court in Floyd's killing. ## **Sudanese flood port** city, borders with Egypt

Cairo, May 2: Sudanese fleeing the fighting between rival generals in their capital flooded an already overwhelmed city on the Red Sea and Sudan's northern borders with Egypt, as explosions and gunfire echoed Tuesday in Khartoum.

Many exhausted Sudanese and foreigners arrived in Port Sudan, the country's main seaport, joining thousands who have waited for days to be evacuated out of the chaos-stricken nation. Others have been driven in packed buses and trucks, seeking shelter in Egypt, Sudan's northern neighbour.

'Much of the capital has become empty," said Abdalla al-Fatih. a Khartoum resident, "all (residents of) our street fled the war.' The fighting, now in its third week, has turned Khartoum and its neighbouring city of Omdurman into a battlefield. Fierce clashes taking place inside residential neighbourhoods that have become "ghost areas", residents say.

The conflict, which capped months of worsening tensions, pits the military, led by Gen. Abdel-Fattah Burhan, against a rival paramilitary group called the Rapid Support Forces, commanded by Gen. Mohamed Hamdan Dagalo.

Al-Fatih's family managed to get out of Khartoum over the weekend after they spent the past two weeks trapped in their home in Khartoum's neighbourhood of Kafouri, a major flashpoint since the fighting broke out on April 15.

They arrived in Port Sudan late on Monday, after an exhausting 20-hour trip, he said.

There, they found thousands, including many women and children, camping outside the port area. Many had been there for more than a week, with no food and other services, he said.

## 7 bodies found in US search for missing teens

Henryetta (US), May 2: Authorities searching a rural Oklahoma property for two missing teenagers discovered the bodies of seven people on Monday, including the suspected remains of the teens and a convicted sex offender who was sought along with them, the local sheriff said.

Okmulgee County Sheriff Eddy Rice said the state medical examiner will have to confirm the identities of the victims, but "we believe that we have found the persons". He said the bodies were believed to include those of 14-year-old Ivy Webster and 16-year-old Brittany Brewer, along with Jesse McFadden, the felon authorities had said the teens were travelling with.

"We are no longer looking," Rice said. "We believe to have found everything that we were seeking this morning. Our hearts go out to the families and friends, schoolmates and everyone else." He declined to



provide details of how they died or

other details. The bodies were found during a search near the town of Henryetta, a town of about 6,000 located about 90 miles (145 kilometres) east of Oklahoma City, Oklahoma State Bureau of Investigation spokesman Gerald Davidson said.

A missing endangered person advisory had been issued earlier in the day for the two teenagers before it was cancelled on Monday afternoon by the Oklahoma Highway Patrol. The advisory for Webster and Brewer had said they were reportedly seen travelling with McFadden, who was on the state's sex offender registry. Oklahoma Department of Corrections prison records show McFadden was convicted of first-degree rape in 2003

As part of India's commitment towards capacity building of Sri Lanka Armed Forces, Chief of Air Staff of the Indian Air Force presented AN-32 propellers to ensure high operational readiness of the aircraft held with Sri Lanka Air Force.

## Palestinian hunger striker dies in Israel prison

Jerusalem, May 2: A high-profile Palestinian prisoner died in Israeli custody Tuesday after a hunger strike of nearly three months, Israel's prison service announced. His death set off a rocket barrage from the Gaza Strip and raised fears of a further escala-Khader Adnan, a leader of the

militant Islamic Jihad group, helped introduce the practice of protracted hunger strikes by individual prisoners as a form of protest against Israel's mass detention of Palestinians without charge. On Tuesday, the 45-year-old became the first long-term hunger striker to die in Israeli custody.

In response to his death, Palestinian militants in Gaza fired



22 rockets toward populated areas in southern Israel, seriously wounding a 25-year-old man and moderately wounding two others at a construction site in the city of Sderot, Israel's rescue service said, identifying all three as foreigners. Their nationalities were not immediately clear.

Air raid sirens sounded and Israeli municipal councils opened public bomb shelters. The reverberations and shrapnel punched a hole into the street and charred cars, footage showed. Four rockets were intercepted by Israel's Iron Dome missile defense system, authorities said.

"This is an initial response to this heinous crime that will trigger reactions from our people," a coalition of Gaza-based Palestinian militant groups, led by the enclave's Hamas rulers, said.

Palestinians called for a general strike in the West Bank and the Gaza Strip and protesters rushed to Israeli military checkpoints in the occupied territory, slinging stones at Israeli soldiers.

Israeli forces fired tear gas and rubber bullets at crowds gathered at the northern entrance to the West Bank city of Ramallah, Early Tuesday, Palestinian militants in Gaza fired another volley of rockets that landed in empty fields in Israel, Islamic Jihad said that its "fight continues and will not stop."

Palestinian prisoners are overseen by Cabinet minister Itamar Ben-Gvir, an ultra-nationalist politician who has tightened restrictions on the Palestinian inmates. including shortening their shower time and closing prison bakeries. Ben-Gvir said Tuesday that prison officials must exhibit "zero-tolerance toward hunger strikes and unrest in security prisons" and ordered prisoners be confined to their cells.

As Israeli-Palestinian violence has spiked, the number of administrative detainees has risen to more than 1,000 over the past year, the highest number in two

## Ukrainian farmer comes up with novel way to demine his fields

Hrakove, Ukraine, May 2: A Ukrainian farmer has come up with a novel way to remove mines left in his fields after Russia's invasion -- he's kitted out his tractor with protective panels stripped from Russian tanks and operates it by remote control.

After Russian forces were driven back from parts of eastern Ukraine by a Ukrainian counteroffensive last year, mines remained in many fields, making it perilous for farmers to sow grain

for the next harvest. Fields around the village of

Hrakove are no exception. Oleksandr Kryvtsov, a general manager at his agricultural company, decided he couldn't wait for help from overworked official deminers to clear his field.

Instead, he designed a remotecontrolled tractor that could withstand blasts. Using armour from damaged Russian military vehicles to protect the body of his tractor, he bought a system that would enable one of his team to operate the tractor remotely from a digger's bucket suspended in the air nearby.

"We started doing this just because the crop-sowing time has

### **Google pays entire** penalty to CCI

New Delhi: In probably the first case of a Big Tech giant paying a penalty to the Indian regulators as the government aims to bring a new Digital India Act, Google has paid the entire penalty amount of ₹1,337.76 crore imposed by the Competition Commission of India (CCI) in the Android case. Reliable sources said Tuesday that the entire penalty amount has been deposited in the Consolidated Fund of India, within the 30-day deadline given by the National Company Law Appellate Tribunal (NCLAT) in its order. The Indian market regulator had imposed the penalty on Google in October 2022 for allegedly exploiting its dominant position in the Android market. Earlier this year, Google announced to comply with the CCI's directives for Android. "The CCI's recent directives for Android and Play require us to make significant changes for India, and we've informed the CCI of how we will be complying with their directives," Google had said in a statement.

### **Coal India output** rises 7.7% in April

New Delhi: CIL, the world's largest coal miner, Tuesday said coal production rose 7.7 per cent in April and supplies to users shot up just as summer began. In a statement, Coal India Ltd (CIL) said it logged an impressive 31 per cent growth in overburden removal (OBR) in April compared to the same month a year ago. "This helps in stepping up production in the upcoming monsoon months,' it said. The company logged a whopping 44 per cent yearon-year growth in supplies to non-regulated sector (NRS).

### **Tata Steel profit** falls 84% in **Q**4

New Delhi: Tata Steel Tuesday posted a steep fall of 84 per cent in its consolidated net profit at ₹1,566.24 crore during the quarter ended March 2023, dragged by lower income. The steel major had reported a net profit of ₹ 9,835.12 crore in the yearago quarter, it said in a BSE filing. Tata Steel's total income trimmed to ₹ 63,131.08 crore from ₹69,615.70 crore in January March period of the financial year 2022-23. The company's total expenses rose to ₹59,918.15 crore from ₹ 57,635.79 crore a year ago. The board of the company also recommended a dividend of ₹3.60 per equity share of Re 1 each to the shareholders for FY23, the filing said.

## First Republic: 3rd US bank collapse since '08

The banking turmoil erupted from the closure of Silicon Valley Bank and Signature Bank in March, causing depositors to flee regional lenders and fueling fears that the crisis could engulf other midsized banks

Washington, May 2: Shares of several regional lenders fell Monday after the collapse of First Republic Bank, the third major casualty of the biggest crisis to hit the US banking sector since 2008.

A deal was announced earlier Monday that allows for an orderly failure of First Republic. Under the terms, JPMorgan Chase & Co will pay \$10.6 billion to the US Federal Deposit Insurance Corp (FDIC), which took FRC into receivership, for most of the failed

JPMorgan acquired about \$173 billion of First Republic's loans, \$30

billion of securities and \$92 billion in deposits. Shares of JPMorgan Chase rose 2.14%, making the largest US bank the top gainer on the Dow Jones Monday.

Mid-cap banks, which have client deposits parked in interest ratesensitive investment portfolios such as mortgage bonds, are also facing a massive challenge due to aggressive monetary policy tightening by the US Federal Reserve. Their portfolios are now worth far less than what they valued them at in their books

Bangalore, May 2: Cash-strapped Indian airline Go First filed for bankruptcy proceedings Tuesday, blaming "faulty" Pratt & Whitney engines for the grounding of about half its fleet.

The filing with the National Company Law Tribunal comes after Pratt & Whitney, the exclusive engine supplier for the airline's Airbus A320neo aircraft fleet, refused to comply with an order to release engines to the airline that would have allowed it return to full operations, the company said.

..in the absence of Pratt & Whitney not providing the required number of spare leased engines in accordance with the order issued by the emergency arbitrator. Go First is no longer in a position to continue to meet its financial obligations," the airline said.

The airline, formerly known as

craft "due to Pratt & Whitney's faulty engines" increased from 7% of its fleet in December 2019 to 31% in December 2020 and 50% in December 2022, the airline said.

The groundings cost Go First ₹10,800 crore in lost revenues and additional expenses, it said.

They also resulted in an erosion in Go First's market share to 6.9% in March from 8.4% in January, latest data from the Indian aviation regulator showed.

The airline was seeking to raise funds and Indian conglomerate Wadia Group was reported to be in talks to either sell a majority stake or completely exit its shareholding.

"The airline said the groundings had also driven some lessors to repossess aircraft, draw down letters of credit and notify further withdrawal of aircraft," the airline said. Go First, however, said the filing does not mark the end of the airline.

tice to Go First after the airline decided to cancel flights for two days amid a severe financial crunch. The crisis-hit airline has cancelled all their scheduled flights for May 3 and 4 without any prior intimation, the Directorate General of Civil Aviation (DGCA) said.

## GST mop-up rises to all-time high in April

**GST COLLECTION AT ₹1.87 LAKH CRORE IN APRIL**

New Delhi, May 2: GST collection in April rose by 12 per cent annually to over ₹1.87 lakh crore, touching an all-time monthly high, showed finance ministry data released Monday.

The previous monthly high Goods and Services Tax (GST) collection was in April 2022 at about ₹1.68 lakh crore.

Hailing the record GST collection, Prime Minister Narendra Modi in a tweet said, "Great news for the Indian economy! Rising tax collection despite lower tax rates shows the success of how GST has increased integration and compliance.

The gross GST revenue collected in the month of April 2023 is ₹1,87,035 crore of which CGST is ₹38,440 crore, SGST is ₹47,412 crore, IGST is ₹89,158 crore (including ₹34,972 crore collected on import of goods) and cess is ₹12,025 crore (including ₹901 crore collected on import of goods), the finance ministry said in a statement.

The revenues for April 2023 are 12 per cent higher than the GST revenues in the same month last year.

During the month, the revenues from domestic transactions (including import of services) are 16 per cent higher than the revenues from these sources during the same month last year, it said.

April 2023 saw the highest-ever tax collection on a single day on April 20. A sum of ₹68,228 crore was paid through 9.8 lakh transactions on that day. The highest



same date) was ₹57,846 crore through 9.6 lakh transactions.

The ministry also said the number of e-way bills generated in March 2023 was 9 crore, which is 11 per cent higher than 8.1 crore e-way bills generated in February 2023. During April, the government set-

tled ₹45,864 crore to CGST and ₹37.959 crore to SGST from IGST.

The total revenue of the Centre and the States in April 2023 after regular settlement is ₹84,304 crore for CGST and ₹85,371 crore for the SGST

Commenting on the GST numbers, Assocham President Ajay Singh said that the highest ever collection in April marks an excellent beginning of fiscal 2023-24. "The GST numbers are indicative of robust growth of the Indian economy, on the back of a strong pick-up in consumer demand," he said.

The total gross collection for the 2022-23 fiscal stood at ₹18.10 lakh crore. 22 per cent higher than the previous year. GST came into force July 1, 2017, subsuming a plethora of indirect taxes.

## **Factory activity hits** 4-month high in Apr

Bangalore, May 2: India's factory activity expanded at its quickest pace in four months in April, driven by solid growth in new orders and output, a private survey showed Monday, signaling resilient demand and an encouraging outlook.

The survey results suggest India will continue to be one of the fastestgrowing major economies despite slowing global growth that has undermined momentum across several other countries

The Manufacturing Purchasing Managers' Index compiled by S&P Global increased to 57.2 last month\_ from March's 56.4, remaining above the 50-mark separating growth from contraction for a 22nd month and confounding expectations in a Reuters poll for a fall to 55.8.

Both new orders and output s at their fastest pace since December, and that helped firms resume hiring during April, following the first decline in 13 months in March. Foreign demand also expanded at the fastest pace in four months in April and optimism improved.

The survey showed input costs rose at a faster pace in April, although improving demand meant firms were able to pass on some of that burden to customers.

## **Automakers witness** flat CV sales growth

hicles (CV) sales fell slightly sharper than the usual 40% to 50% drop between March and April due to prebuying in March, However, CV volumes for fiscal year 2024 could possibly recover to pre-Covid levels on strong demand expected due to a line-up of government infrastructure projects, analysts said.

In the CV segment, market leader Tata Motors posted a 52% decline in sales from a month ago, while sales of Eicher Motors Ltd and Ashok Leyland Ltd trucks and buses declined 45% and 53.4%, respectively

On a year-on-year basis, however, Tata Motors reported a 28%



decline in sales, while Eicher and Ashok Leyland registered a growth of 18.1% and 5% Two-wheeler makers TVS Motor

Co Ltd and Eicher's Royal Enfield, which are more urban-focused, reported a 4% and 18% YoY growth in April sales, helped by affluent buyers.

However, Hero, which caters more to the rural segment, saw a 3.1% decline in domestic sales owing to slowdown in demand recovery due to unseasonal rains. In the passenger vehicles cate-

gory, top carmaker Maruti Suzuki

saw a 12.6% increase in domestic

sales, while Tata Motors reported

a 13% rise, including electric



cent of their match fees for breaching Article 2.21 of IPL code of conduct, which relates to public acts of misconduct, unruly public behaviour and inappropriate comments detrimental to the interest

Kohli seemed to be referring to the spat with his former India and Delhi state teammate when he said "vou got to take it, otherwise don't give it", after the match.

"That's a sweet win boys. A sweet win. Let's go. If you can give it, you got to take it. Otherwise don't give it," Kohli said in a video published by his team on YouTube, where he was seen celebrating with the rest of the RCB

The trigger was probably the interaction between Kohli, who seemed animated throughout the fielding innings of RCB, and LSG opener Kyle Mayers.

While the players were shaking hands after the match, LSG bowler Naveen-ul-Haq – who was also fined 50 per cent of his match fee – and Kohli were seen exchanging words



and RCB's Glenn Mexwell separated them. This was followed by Gambhir pulling away Mayers while the latter was speaking with

Just after that, Gambhir was seen charging towards Kohli even as LSG players, including the injured captain KL Rahul, tried to restrain him. Eventually, Kohli and Gambhir got involved in a heated argument with players from both

sides surrounding them. Gambhir looked the more animated of the two and was repeatedly held back from charging towards Kohli by the LSG players and support staff. This was after the two had shaken hands.

Initially, Kohli was seen holding Gambhir's shoulder, but as the exchange continued, veteran spinner Amit Mishra, RCB captain Faf

du Plessis and LSG assistant coach Viiav Dahiva stepped in to separate the duo.

After the altercation, Kohli was also seen talking to LSG skipper Rahul. Kohli and Gambhir have had a history of face-offs. They were also involved in a face-off 10 years ago in the IPL during RCB's match against Kolkata Knight Riders in Bangalore

The last time when LSG and RCB clashed in Bangalore in this edition, Gambhir had gestured towards the Bangalore crowd with a 'shut up' sign.

RCB director of operations Mike Hesson said the ugly incident could have something to do with that match at Chinnaswamy Stadium April 10, when LSG won by one wicket off the last ball.

"I guess after the last match at

the last ball, it always felt like we were really desperate to get this one. So I think you probably saw a little bit of that boil over tonight, Hesson said in the video posted on RCB Twitter handle.

Du Plessis, on his part, said he has no problems with a pumped-up Kohli. "That's the best version of Virat, isn't it?" Du Plessis said in the video. "To see him pumped up like that. That's when he's at his best. It's really awesome to be a part of it. My job is to keep things calm on the field, which I thought

we did really well. Former India captain Anil Kumble was, however, not impressed with the behaviour of Kohli and Gambhir, saying showing emotions in the way it happened on Monday was "unacceptable".

Sameer Mohanty and Sushil Barik were the top scorers for ECoRSA contributing 22 runs each. Subham Nayak (4/27) and Sai Prasad Acharya (3/8) shared seven wickets between them.

In response, Odisha Postal found themselves in a spot of bother, losing 5 wickets for 50 runs. However, Subham (28 n o) and Debasish Samantaray (18 n o) ensured victory with an unbeaten 38 run partnership. For ECoRSA, Jayant Behera (4/23) was excellent with the ball.

## **OZ TO BECOME NO.1 TEST SIDE**

Dubai, May 2: India have overtaken Australia to regain the number one position in the ICC men's Test team rankings following the annual update that drops results from the 2019-20 season and reflects all series completed since May 2020. India's rating points have moved

up from 119 to 121 as their 2-0 defeat to New Zealand in March 2020 no longer figures in the rankings, which assesses series completed prior to May 2022 at 50 per cent and subsequent series at 100 per cent.

Australia have slipped from 122 to 116 rating points. The other rankings too remain unchanged.

In the men's T20I team rankings, India have consolidated their position at the top, increasing their lead over second-placed England from six to eight points. New Zealand have overtaken Pakistan and South Africa to third position
