Pak minister visits India after 12 years

Benaulim (Goa): Pakistan foreign minister Bilawal Bhutto Zardari arrived here Thursday to attend a conclave of the Shanghai Cooperation Organisation (SCO), in the first such high-level visit to India from the neighbouring country since 2011. Zardari's visit comes amid continued strain in ties between India and Pakistan on a number of issues including Islamabad's continued support to cross-border terrorism. "On my way to Goa, India. Will be leading the Pakistan delegation at the Shanghai Cooperation Organisation CFM. My decision to attend this meeting illustrates Pakistan's strong commitment to the charter of the SCO," Zardari tweeted ahead of his arrival here. I look forward to constructive discussions with my counterparts from friendly nations," he added.

2 more tourists meet watery grave in Puri

Puri: Two tourists met their watery grave Wednesday while taking a bath in the sea in Sector 13 near Swargadwar locality of this town. One of the deceased has been identified as Arindam Das while the identity of the other is yet to be ascertained. Both were from Howrah district of West Bengal. The two along with other friends had gone into the sea when they were swept away by a huge wave. The bodies were fished out later by lifeguards. It should be stated here that Wednesday, a man and his minor son drowned in the sea in the same sector. They were also from West Bengal.

DRDO scientist held

Pune: A scientist working for the Defence Research and Development Organisation (DRDO) was arrested Wednesday here by the Maharashtra Anti-Terrorism Squad (ATS) for providing confidential information to a Pakistani agent, officials said Thursday. However, they refused to disclose the identity of the person as it may hamper allegedly in touch with an agent of a 'Pakistan intelligence operative' through WhatsApp and video calls, an ATS official said. It was a case of honeytrap, he added. "The scientist, by misusing his position, was passing information to the enemy that can pose a threat to India," the ATS official said.

NMA nod to Puri pilgrim shelter

Puri, May 4: The National Monuments Authority (NMA) has issued a 'no objection certificate' (NOC) for construction of a pilgrim shelter and an administrative building in the regulated zone around the Srimandir, an official said Thursday.

The height of the structures has been limited to 13 metres. This apart, the NMA also allowed the renovation of 20 mutts, which were demolished during the 'Parikrama' programme, a component of state's ambitious Heritage Corridor project, said Shree Jagannath Temple Administration (SJTA) chief administrator, Ranjan Kumar Das.

The NMA, Das said, has also allowed construction of another pilgrim reception complex near Kakudikhai. The NOC has been received by the state Culture department, the Srimandir administrator informed

Earlier, the administration of the 12th century shrine had filed detailed project report (DPR) of the proposed administrative building, pilgrim reception centres along with location of the proposed construction sites in the regulated

After a Manipur High Court order directed the BJP government to include 'Meitis' in the list of Scheduled Tribes, the Nagas, Zomis and Kukis opposed this decision and launched protests which escalated into large-scale riots

Imphal, May 4: The Manipur government Thursday issued 'shoot at sight' order in 'extreme cases' to contain the spiralling violence in the state between tribals and the majority 'Meitei' community which has displaced over 9,000 people from their villages. Fifty-five columns of the Army and Assam Rifles have been deployed to contain widespread rioting that broke out across Manipur. The Army also kept some 14 columns on standby for deployment in case the situation flares up once again, a Defence spokesperson said.

The Centre, which is monitoring the situation in Manipur, also dispatched teams of the Rapid Action Force (RAF), a specialised force to handle riots, for deployment in violence-hit areas of the Northeastern state. The teams have already landed in here.

Clashes broke out Wednesday and escalated Thursday with counter-attacks being mounted by

to earlier attacks, after Naga and Kuki tribals organised a 'Tribal Solidarity March' to protest moves to give Scheduled Tribe status to the majority Metei community. The 'shoot at sight' order issued

Thursday by the Governor of the northeastern state said all magistrates could issue the order when persuasion, warning and reasonable force 'have been exhausted and the situation could not be controlled'.

The Army and Assam Rifles staged flag marches in Khuga, Tampa, Khomaujanbba areas of Churachandpur. Flag marches were also carried out in Mantripukhri, Lamphel, Koeirang area of Imphal Valley, and Sugnu in Kakching district, the Defence spokesperson informed.

Underlining the gravity of the violence, Union Home Minister Amit Shah spoke Thursday to Manipur Chief Minister N Biren Singh and took stock of the situation in the state.

Singh urged people to maintain peace. "Precious lives have been lost, besides damage of properties, which is very unfortunate. The violence was the result of misunderstanding in the society. The state government is taking all steps to maintain the law and order situation and to protect the lives and properties of the people," the Manipuri CM said.

Singh also informed that alives have been lost in the violence, but at the moment details of the deaths are 'not available'.

The 'Tribal Solidarity March' was organised by the All Tribal Student Union Manipur (ATSUM) in the 10 hill districts of the state Wednesday to protest the demand of non-tribal 'Meiteis', who account for 53 per cent of Manipur's population, for Scheduled Tribe (ST) status. The tribals account for 40 per cent of the state's population.

The 'Meitei' community accounts for 53 per cent of Manipur's population, but is confined to about 10 per cent of the state's territory. The tribals, on the other hand, make up for less than 50 per cent of the population, but dominate 90 per cent of Manipur's territory. However, 'Meitis' dominate about two-thirds of the 60member Assembly and thereby are quite powerful.

Sedative kick for Rayagada addicts

Youths are turning to 'Fortwin' and 'Phenergan' injections as they are cheap and easily available across the counter

Rayagada, May 4: Youths in Rayagada district are increasingly falling prey to sedatives like 'Fortwin' and 'Phenergan' injections which are used to cure sleeplessness, vomiting, headaches and acute pain, sources said Thursday. They added that these two medicines have emerged as the main alternative for addicts.

Both 'Fortwin' and 'Phenergan' are not available across the counter without a doctor's prescription. This is because of the side-effects that happen due to the medicines. However, the addicts have found a way to get the two drugs through various means. Also unscrupulous shopkeepers are ready to supply the medicines once they are promised a few extra bucks.

The rampant sale of these two injections in complete violation of norms, has led to a spurt in their use in this district. The use of these



rural areas with people of the 20-40 years age group falling prev to addiction. They are using insulin syringes to inject the drug into their body without realising that they are inviting a slow death.

According to an investigation conducted by Orissa POST the drug addicted youths in the industrial areas of this district and Muniguda towns are using 'Fortwin' and 'Phenergan' injections to satiate their urge as the two drugs are available at cheap rates. A 2ml vial of 'Phenergan' costs ₹13.40, while the market price of 'Fortwin' is ₹5.90. As a result, addicts of this district are turning to these districts to get a kick. Contd...P4

Wrestlers threaten to return awards

New Delhi, May 4: Hurt by the boorish behaviour of the Delhi police, protesting wrestlers Thursday threatened to return their medals and awards including the Padma Shri to the government. They said these honours serve no purpose if they have to endure such humiliation.

Around 11.30pm on Wednesday, a scuffle broke out when the wrestlers were bringing in folding beds for sleeping and the on-duty police personnel began enquiring about that as rules do not permit bringing in such things at the protest site.

Vinesh Phogat and Sakshi Malik claimed that they were abused and pushed by male police officers, leaving them in tears. Two wrestlers, including Sangeeta Phogat's brother Dushyant, suffered injuries.







Prez lays stone for Skill Training Hub

Bhubaneswar, May 4: President Droupadi Murmu, who is on a three-day visit to Mayurbhanj, laid the foundation stones for Skill Training Hub and community centre at her hometown Pahadpur in the tribal-dominated district, Thursday.

Among others, Governor Ganeshi Lal, president of L&Tfunded Prayas Trust - Meena Subrahmanyan, officials of L&T and Odisha-based non-profit SLS Trust attended the event.

L&T has partnered with SLS Trust to establish the Skill Training Hub on a five-acre land for providing underprivileged youth from the region training in construction skills, and in turn, make them self-reliant.

The Skill Training Hub will encompass an administrative-cum-institute building, multipurpose hall, e-learning hall, digital training room, separate hostels for boys and girls, dining halls, four practice yards for masonry and a dedicated workshop for practicing pipe welding.

As per the provisions of an MoU signed with SLS Trust, L&T will establish and run the Skill Training Hub for five years. After that, it will be taken over by SLS Trust. The handing over process will start in the fourth year, it was learnt.

Training programmes at the Skill Training Hub will focus on masonry, bar bending, scaffolding, plumbing, pipe welding, and digital skills. Funded by L&T under its CSR initiatives, the project will cost around ₹15 crore, which includes the operational expenses for four years.

Bhubaneswar, May 4: To save the life of a young woman, a group of doctors at the City AIIMS performed surgery for a rare variety of larynx (voice box) cancer (adenoid cystic carcinoma). The 25-year-old woman from

Jagatsinghpur was afflicted with an advanced stage of the cancer at the junction of food and wind pipes, causing her difficulty in both breathing and swallowing Unlike the usual types of cancer, hers was resistant to radiother-

apy and chemotherapy. With progression of the diseases, the voice, respiration and food intake for the patient became more and more challenging. Prior to coming to AIIMS Bhubaneswar, the lady had con-

sulted at multiple hospitals for over a year seeking treatment. With no other option in hand, the surgeons at AIIMS operated on her with a newer approach. A group of 10 doctors compris-

ing the ENT, surgical gastroenterology took 14 hours to perform the challenging procedure.

The ENT surgeon removed the voice box (larynx), upper part of the wind pipe (trachea), pharynx, upper part of food pipe (esophagus) and part of the thyroid gland.





AIIMS Bhubaneswar executive director Ashutosh Biswas congratulated the team of doctors for this life saving surgery.





All cyclone-prone districts are kept in a state of readiness. District administrations along with the NDRF, ODRAF, and others are in readiness for any possible eventuality.

May 8 last year, cyclonic storm 'Asani' had developed in the Bay of Bengal but later fizzled out and later crossed the Andhra Pradesh coast as a depression. The severe cyclonic storm 'Yaas' made landfall in Odisha's Balasore district on the morning of May 26, 2021, while Cyclone Amphan made landfall between the Sagar islands of West Bengal and the-Hatiya islands of Bangladesh on the evening of May 20, 2020.

Bhubaneswar, May 4: The Commissionerate Police has arrested the owner of a fake job consultancy firm for duping two job aspirants of Rs 25 lakh on the pretext of facilitating them to get jobs in the police department.

The 21-year-old accused was identified as Debabrata Palei of Krushnapur village under Rairangapur rural police limits in Mayurbhanj district.

Debabrata had opened a job placement agency at Saptasati Vihar in Palasuni area under Mancheswar police limits here. As per sources, the firm was involved in supplying manpower to various industries

like BPO, call centres, telecom, plant sector, engineering, automobiles, industries, clerical, data entry, aviation, and retail.

Based on the complaint lodged by one of the victims, Balaram Pradhan of Angul in March this year, Mancheswar police registered a case (188/23) and arrested the accused following initial

The complainant had recently come across some job advertisements placed by the fake firm on various social media platforms.

He also found that one of his friends Mrityunjaya was assured by the accused of help to get selected as constable in Odisha Police force. Later. Balaram too contacted Debabrata who asked him to meet the accused at his office in Palasuni.

Accordingly, Balaram along with his father and elder brother met Debabrata March 17, 2023

"Debabrata had taken Rs 2 lakh from Balaram in March. Later he also managed to convince two others of the same village to pay money to his firm D2s Placement Service for job of constables. The two friends of Balaram gave money to Debabrata who collected a total Rs 13 lakh from the trio," said a senior police officer.

Adding further he said, "When the examination results for constable posts came out, the victims found that they were not selected for the job. Upon asking, the accused asked them to pay Rs 50,000 more as their names were withheld. The trio started enquiring soon to find that they were cheated by the accused.'

ILS scientists develop health promoting probiotic bacteria

Bhubaneswar, May 4: The Institute of Life Sciences here, a centre of eminence in biotechnology research, has put forward a novel initiative involving microorganisms to improve the health and nutritional standards of tribal communities of

Some three years back, under the leadership of former ILS director, late Ajay Parida, the Department of Biotechnology, government of India, had extended support for an ILS flagship programme on tribal health and nutrition. Under the programme, scientists were to study different factors that can improve the wellbeing of the tribal peo-

In one of the studies under this programme, the ILS team explored the use of microorganisms, known as probiotics

Probiotics are microbes that provide health benefits to humans when taken in diet in adequate amount. These organisms are known to be useful in prevention and control of health problems

Eli Lilly's Alzheimer's drug slows cognitive decline by 35%

experimental Alzheimer's drug slowed clinical decline by 35 per cent compared to placebo. and resulted in 40 per cent less decline on the ability to perform activities of daily living, said the company announcing phase-3 trial results.

The drug, donanemab administered intravenously once a month, works by removing plaque build ups in the brain known as amyloid -- a hallmark of Alzheimer's disease.

The phase-3 trial involved more than 1,700 patients with early symptomatic Alzheimer's disease.

Nearly 47 per cent of participants on donanemab showed no decline on a key measure of disease severity at one year (compared to 29 per cent of participants on placebo).

Further, as Donanemab cleared amyloid levels, 52 per cent of participants stopped their course of treatment by one year and 72 per cent by 18 months.

The study also enrolled a smaller number of people with high levels of tau, representing a later stage of disease progression.

A 35 per cent slowing in cognitive and functional decline was seen in the group with intermediate levels of tau, whose disease hadn't progressed as far. When this intermediate group was combined with the group with higher levels of tau. the figure was 22 per cent. The results have not been peer-reviewed or published in a journal.

"This is the first Phase-3 trial of any investigational medicine for Alzheimer's disease to deliver 35 per

Rasulpur, May 4: As many as 1,500 weavers at Gopalpur village under Prathamakhanda panchayat of this block in Jajpur district have been left without any work following the closure of over 3,000 looms due to acute shortage of tussar cocoons, a report said Thursday

This has robbed them of their livelihood as many of them are now withdrawing from what has been their profession for generations. They are now in search of alternatives to eke out a living despite good demand for tussar clothes in the market.

Left with no option, weaver leaders Gobind Chandra Das, Pratima Nirupama Das, Pranakrushna Dutta, Surendra Das. Antarvami Dutta, Ashok Kumar Guin and Ramesh Das have warned to take to the streets for fulfillment of their demands.

Gopalpur tussar cloth is made from the cocoons of the tropical tussar silk worm and distinguished by its rich texture, subtle sheen, and delicate drape. The cloth is known for its breathability and comfort, making it an ideal wear in warm and humid climates.

The weavers alleged that the clo sure of the looms due to raw material shortage has put them on the crossroads of life with many of them abandoning their ancestral occupation and shifting to other jobs.

This has happened as the raw material supplier Odisha Cooperative Tussar and Silk Federation Ltd prices of cocoons and make a proper price fixation so that they are not put into difficulty.

The weaver families have demanded supply of solar lights under state sponsored 'Rajya Bana Jyoti Yojana' as the solar lights supplied to them under Central grant in FY 2018-19 developed snags.

This has put them in a fix as the weaver clusters are not included under state sponsored 'Rajya Bayan Jyoti Yojana'. They have called for a change in the rules to include the clusters to avail the benefits of state sponsored schemes.

They alleged that the state government has made it a point to give loan to the weavers under its Balia Yojana. However, the stiff condition has made it difficult for them to avail a loan under the scheme and demanded to simplify the rules to help them avail the benefits. They also demanded to equate the pension of weavers with the pension for artistes by reducing the age bar of weavers under Baristha Bunakar Sahayata Yojana.

Apart from this, they also urged to allow weavers for construction of workshop in their own residence who do not have separate land for the purpose. Among others, they demanded payment of their bills within a fortnight of purchase of their tussar and other clothes as well as establishment of a cotton thread and cloth bank by state-owned Boyanika. The establishment of an ESI hospital in Gopalpur area also finds place

Reports said that the managing director of Serifed and Utkalika Saroj Kumar Patel and deputy director of Cuttack textile division Ashutosh Mohanty visited Gopalpur village in April and took stock of the problems faced by the weavers. The two senior officials also assured for supply of tussar cocoons which is yet to be realised.

A Serifed official said that they are collecting tussar cocoons from Sukinda area which will soon be supplied to the weavers in Gopalpur. Now all eyes are on Serifed as to when the office will supply the tus-

Triple murder case: 2 including nephew held

Bargarh, May 4: The district police cracked the triple murder case of a man and his two wives at Akhiphuta village under Bheden police limits in this district with the arrest of two persons including a nephew of the victims, Thursday.

The victims identified as Tankadhar Sahu and his two wives Droupadi and Madhavi were murdered in cold blood late April 17 night. Their mutilated bodies were recovered in a pool of blood the next day. Anam was arrested from Gandapada village under Bolda police limits in Chhattisgarh where he was staying by changing his name as Rahul.

The accused were identified as Anam Sahu, 27, alias Basudev, a nephew of the victim Tankadhar and Sraban Rana, 37, a resident of Bolda in Mahasamund district in Chhattisgarh, Anam after murdering Tanakdhar and his two wives had stolen gold ornaments from their house and sold it to Rana. He committed the murder over greed for Tankadhar's properties and to avenge the insult he had received from Tankadhar.

A gold chain weighing 7.5 gram,

stained clothes were seized from his possession. Bheden police produced the two accused in the court in this connection. The two were remanded to Bargarh subjail custody after their bail pleas were rejected.

This was stated here by Bargarh SP PS Meena at a press meet held at the district police headquarters in Bargarh, Thursday.

₹30,000 from Tankadhar's house and fled but was caught red-handed by Sareipali police in Chhattisgarh for helmetless driving. On being informed, Tankadhar paid the fine and brought back the scooter. He even informed Anam's family members about his wrongdoings.

Later, seething in revenge Anam killed Tankadhar and his two wives and fled the scene, the police said.

Ganja worth ₹1cr seized; man held

Berhampur, May 4: The Excise department Thursday seized ganja worth ₹1 crore from a truck during smuggling at Dhanaghar near Chikiti in Ganjam district. The Excise sleuths have also seized a car and two bikes, and arrested the kingpin Bikram Kumar Subudhi (26) of Adasingi village under Digapahandi police limits.

Three other associates of Subudhi, who were involved in the smuggling, were able to give the sleuths a slip. During interrogation with the arrested smuggler, police came to know that the seized truck load of ganja would have been smuggled to Mumbai. The contraband was kept at Kanisi area after being illegally procured from Gajapati district.

It was brought from Kanisi to Chikiti Wednesday and then loaded in the truck for smuggling. Bikram was forwarded to court Thursday. Excise inspector Hrudaya Chandra Samanta informed that the estimated cost of seized ganja along with truck and bikes is ₹1 crore.

Andhra again strays into Kotia

Pottangi, May 4: There is no let-up in illegal incursion by neighbouring Andhra Pradesh in Kotia panchayat under this block in Koraput district as the latter continued to make inroads into the area.

Triggering a fresh controversy, the ITDA project officer (PO) of Parvathipuram Manyam district in the neighbouring state Wednesday visited Phatusineri village under the panchavat and discussed various welfare schemes floated by their government with the villagers.

Visit of the ITDA PO comes a day after the Andhra Pradesh deputy Chief Minister P Rajanna Dora visited Kotia panchavat and tried to lure the villagers with benefits of various welfare schemes floated by their government.

ITDA PO C Bishnu Charan and assistant project director Y Satvam Naidu and other officials later took stock of teh turmeric grown by the villagers. They discussed the modalities as to how the turmeric could be sold in Andhra Pradesh market. Then they held discussions



with the officials and asked them to ensure that the farmers get the right price for their produce.

Besides, they assured the women of the village that monetary assistance will be provided for turmeric farming, sources informed.

Despite stiff opposition from the Odisha government. Andhra continues to intrude into the Kotia region and entice the locals.

Recently, stickers of Andhra Pradesh Chief Minister YS Jagan Mohan Reddy were seen being put up on the pucca houses constructed

under Biju Pucca Ghar Yojana in Talaganjeipadar village in Kotia which only escalated the contro-

versy further. Similarly, the recent visit of Andhra deputy chief minister Peedika Rajanna Dora to Kotia had sparked controversy. Dora was found sensitising the villagers about various welfare schemes of the YSR Congress party government during his visit to the disputed region.

However, despite regular straying by Andhra Pradesh into Kotia panchayat neither the district administration nor the block administration is taking any serious step to thwart the evil plan of the neighbouring state.

Bumpy Road Ahead

The Spring Meetings of the World Bank and International Monetary Fund usually provide a platform for various organizations, policymakers, and commentators to reflect on the state of the global economy, offer assessments of the previous year's developments, and forecast what lies ahead. This year's meetings, which took place in Washington in April, were accompanied by grim predictions that underscored the growing likelihood of a prolonged global recession.

While many analysts previously assumed that the confluence of crises that the world has faced over the past three years – the COVID-19 pandemic, supply-chain disruptions, the war in Ukraine, and the resulting inflation crisis and financial turmoil – would have a significant but ultimately transitory effect on the global economy, new data suggest that the current economic upheaval will last longer than initially expected.

The IMF's World Economic Outlook and Global Financial Stability Report suggest a difficult road ahead, warning that "the fog around the world economic outlook has thickened." The rapid succession of large interest-rate hikes by the US Federal Reserve and other major central banks has caused public and private sector debts to increase to their highest levels in decades, enhancing the risk of financial instability. The world's advanced economies,

which grew by 2.7% in 2022, are projected to grow by just 1.3% this year. While the IMF expects Asia's emerging and developing economies to expand by 5.3% in 2023 (compared to 4.4% last year), India's growth forecast has been revised down to 5.9% (compared to a 6.8% growth rate

A new book by the World Bank is even more pessimistic, warning that the global economy could be on the brink of a "lost decade." Based on a comprehensive database of estimates of potential growth covering 173 countries, the authors project that annual global growth will fall to a three-decade low of 2.2% and remain weak for the rest of the decade. While the wealthy may have the means to weather the storm, the same cannot be said for the world's poor and lower-middle classes, who will be hit hardest by the coming downturn

To comprehend the full ramifications of the current moment, we must look beyond the immediate consequences of COVID-19 and issues that have been festering for decades, including climate change and the social and political disruptions caused by rapid technological innovation. Navigating our way out of today's "polycrisis" and restoring global growth, though possible, will be extremely challenging for two key reasons.

the war in Ukraine and confront underlying First, as the World Bank report highlights, many countries are experienc-

ing an alarming trend of declining investment. While fiscal and monetary policies certainly play a role, I believe that the root cause of weak investment is the increasing politicization of economic policy, which has fueled a widespread loss of trust in governments and undermined confidence in their ability to solve the problems that matter.

India is a case in point. Since 2012, private-sector investment as a share of the Indian GDP has steadily declined. The World Bank and other experts attribute this trend to political polarization and a growing lack of trust. While public investment has increased dramatically over the past decade, this can be a dangerous trend: When the government has disproportionate control over investment, it often leads to a surge in cronyism. Russia, where an oligarchy rapidly emerged by currying favours with political leaders in exchange for lucrative contracts and sweetheart privatization deals, offers a stark example

The second challenge is that introducing any corrective policy would require a concerted, multi-country effort. The interconnectedness of global supply chains means that any disruption has widespread and powerful knock-on effects, and the growing use of economic sabotage as a war tactic underscores the urgency of multilateral cooperation on a treaty promoting the protection of economic assets

Achieving a prosperous, peaceful world also requires stepping up efforts to meet climate goals and stem the increase in economic inequality within and between countries. Owing to advances in digital technology and the globalization of supply chains, such challenges are beyond the reach of individual countries acting alone. To address these global issues, governments must coordinate their monetary, fiscal, and security policies. To be sure, this will not be easy. But the alternative – a future of sluggish growth, political instability, and environmental catastrophe – is simply too dire to contemplate.

At sixes and sevens

his expression is commoner in the UK and Commonwealth countries than in the US. It can mean something that's in a state of total confusion or disarray, or people who are collectively in a muddle or at loggerheads about how to deal with some situation. For example, a British newspaper article in 2002 reported that the Conservative opposition had accused the Government of being "at sixes and sevens" over what to do with the rail network. But what could possibly be the sixes and the sevens that are involved? There are two old stories that try to explain this. One tries to find it in the King James Version of the Bible; Job 5:19 has "He shall deliver thee in six troubles; yea, in seven shall no evil touch thee", a couplet that makes no sense to us today and which doesn't seem to link to any known use of the expression. The other story, more common and very widely believed, traces it back to a dispute between two of the ancient livery companies in the City of London. These companies, trade guilds, grew up from the latter part of the twelfth century as associations to protect their members' interests. (They were called livery companies because members had the right to wear a distinctive costume or livery.) There was a lot of squabbling with other guilds about precedence in the early days. One especially troublesome dispute concerned the Merchant Taylors Company, whose members were tailors, and the Skinners Company, whose members controlled the trade in furs. In 1484 the then Lord Mayor, Sir Robert Billesden, settled the dispute in a judgement of Solomon by ruling that the two companies should alternate between the sixth and seventh positions in successive years, a ruling still in force. This might seem to settle the matter. What could be clearer? The two companies were permanently at sixes and sevens with each other.

CULTURAL DIFFERENCES IN RAISING CHILDREN SEEM TO BE AMONG THE REASONS FOR THE STATE **STEPPING INTO HOMES AND TAKING AWAY CHILDREN**

ast month a film released in theatres recounting an immigrant Indian mother's struggle to win back the custody of her children from the Norwegian foster care system. The box office returns in India have not been so enthusing, but it is the most-watched South Asian film in Norway and has articulated the tussle of mostly immigrant parents against childcare services in Nordic and European countries. The Norwegian Embassy in India has dismissed the film based on the 2022 book The Journey of a Mother by Sagarika Chakraborty as a "fictional representation" of the case that was resolved a decade ago in cooperation with Indian authorities and noted that the reason for placing children in alternative care is only if they are subjected to "neglect, violence or other forms of abuse.'

Regardless of the dismissal, the film Mrs. Chatterjee vs Norway has drawn attention to the many custody battles that are going on between parents and childcare services. One of them is the current confrontation between Berlin Child Services and the Shah family.

The case was taken up with Germany in December 2022 when External Affairs Minister S Jaishankar raised the issue with his German counterpart Annalena Baerbock.

Cultural differences in raising children seem to be among the reasons for the State stepping into homes and taking away children. It is a matter that has been raised in the Shah vs Germany case. "The German child services are completely insensitive to the baby's cultural and religious identity, insisting on a meat diet for her though she comes from an observant Jain family," says an online petition "Save Ariha" by the child's parents who are engaged in a struggle to get their daughter back from Germany. Ariha Shah is a little over the age of two. The toddler has spent most of this time in the care of Berlin Child Services which last month filed a civil custody case to terminate the parental

rights of Dhara and Bhavesh Shah, her mother and father. Ariha was taken away on suspicion of sexual abuse, following what the family says is an accidental injury while in her paternal grandmother's care. That was referred to doctors who in turn called in the child services. The worried parents have said in the online petition, that the lawsuit could go on for two or three years giving child services the advantage of the "continuity principle" of the law in Germany under which if a child has spent a significant time with the stateappointed carer, it is said to be settled there and should not be shifted back to the parents, even if they are found to be fit.'

Figures from Destatis, the German national statistics agency, show that 77.645 children and young people were in State care in 2015-16. In contemporary Germany with its population of over 83 million, there are 50,364 children and young people living in family foster care. Norway has as many as 12,000 children living in State and foster care, a rather high number for a population of not more than 5.5 million. This draws from concerns that place the rights of the child above all else. Sweden. Norway, Iceland, Estonia and Portugal offer the best familyfriendly policies among 31 rich countries according to a new UNICEF report based on their national family-friendly policies. Among the most family-friendly countries, Norway, in 1981, was the first to appoint a child ombudsman, to protect the rights of the child. Yet Norway also faces a dis-

proportionately high number of child welfare cases and a number of them, fiercely contested by parents, have found their way before the European Court of Human Rights. The Court has deemed as central Article 8 of the human rights convention, which covers the right to respect for private and family life. In recent years, the ECtHR has accepted 39 cases involving the Norwegian Child Welfare Services for hearing. Of the nine cases the Court has ruled on, a violation of the right to family life has been found in seven cases. A total of 52 judgements have been passed against Norway throughout the Court's history. These high numbers show the country's failure to safeguard the right to family life in child welfare cases

According to BBC, as the Norwegian media began investi-

gating a story it has ignored, it has been found that children with more likely than other children in Norway to be forcibly taken from their families. A Norwegian-Chinese couple has had their baby taken away with questions over parenting which include the time the child spent with her Chinese maternal grandmother after birth. a common practice in Asian countries. Critics say Barnevernet, the Norwegian Child Welfare Services agency, is too quick to remove the children of immigrants. In the 2011 removal of two children from their Czech parents due to allegations of sexual abuse, the par ents were eventually exonerated but the State refused to return the children and has now terminated their parental rights. The workings of child welfare in Norway prompted strong criticism from former Czech President Milos Zeman. Heads of State of Poland and Romania have also voiced disapproval in cases involving their nationals.

The problems that arise often require government intervention. Like the issues flagged by Indian migrant workers in the Gulf. For instance, when Prime Minister Modi toured the Gulf countries in 2018 there were demands, especially by workers, for support from home. The Indian diaspora the largest in the world and topmost contributor to home remittances. wanted steps to improve job security in host countries through intervention from the Indian government.

In cases of families on work stints abroad, it may help if the Central government intervened by providing counselling and support through Indian embassies well before parenting runs into trouble, especially in Nordic and European countries. A kind of family ombudsman in embassies could be a guide and referral point for Indian parents in order to prevent visits from child welfare services that may not end well.

Intrusions have increased manifold with an ascending trend in fatalities and destructions. A State Wildlife Organization report reveals that during the last decade, the numbers of people killed and injured on account of elephant encounters have

na, causing ca- was 1.27 lakh acres of cultivated land belonging to 2.95 lakh farmers. A total of 12,638 houses, consisting of 4,793 fully and 7845 partially, have been destroyed. A whopping ₹157 crore was paid as compassionate allowance. The report clearly reflects that erstwhile harmonious living has been disturbed drastically.

The reasons behind the collapse of an age old empathetic relationship are many and varied. The most prominent one among them is the diminished, degraded, and disintegrated habitat that was once nurturing wild animals smoothly. This has happened due to the injudicious, indiscriminate and irretrievable use of forests for infrastructure development, which shrinks the moving space for these big animals.

The elephant is a long distance migratory megaherbivore. It requires a large, compact home range for daily needs of 1.5 to 2.0 quintals of green branches, twigs, climbers, grasses and 150 to 200 litres of water, which is collected through wandering for 16 to 18 hours a day over a forested stretch of about 10 sq km. The scarcity of food has compelled the pachyderms to enter farmlands and houses time and again. Such ingress into human

Being cornered, the hostile pachyderms started invading agricultural fields and grain storage places. Depredation and devastation have made people develop an antagonistic mindset towards elephants, considering them animals of nuisance, and adopt forceful drive operations by hook or crook using detrimental methods like electric current shock, throwing burning objects, and attacks with deadly weapons and poisons. Such retaliatory coercive action has enraged the elephants, and they have become violent and aggressive.

Relentless retaliation could not provide any respite from suffering but rather aggravated it, for which the people are in a state of disgust and despair. An environment of unrest has emerged, leading to agitation among locals, who are blaming the forest department

elephants into human habidation damage in the said period the dwellers have turned into have become restless and impaof the danger rather than insisting on a quick fix. They are not only panicked but also perplexed.

> Everyone wants a rapid solution. But everyone should know that it's a time-consuming process. A three tier remedial measure is suggested to address the present crisis. Retrieval of straved herds should be given top priority and taken up as emergency operations, emphasising zero casualties and minimising damage. Allowing an invasive animal to pass unobstructed through its self chosen path by simply watching with patience at a safe distance is the best option. Barriers like a solar fence, trench, and repellant crop in the border area could be short-term steps to restrict entry into human settlements. Rejuvenation of parent habitats through enrichment of palatable vegetation and perennial water sources is essential. All these measures should be taken simultaneously

> Besides, a concerted, coordinated, and combined effort of frontline forest staff and inhabitants is a must for effective and long-lasting mitigation.

Underrepresentation of women

Sir, Women's equal participation and leadership in political and public life are essential to achieving the Sustainable Development Goals by 2030. However, data show that women are underrepresented at all levels of decision-making worldwide including government leadership as well as political participation, and that achieving gender parity in political life is far off. Data from 136 countries shows that women constitute nearly 3 million (34 per cent) of elected members in local deliberative bodies. Only two countries have reached 50 per cent, and an additional 20 countries have more than 40 per cent women in local government. Regional variations are also noted for women's representation in local deliberative bodies, as of January 2022: Central and Southern Asia, 41 per cent; Europe and Northern America, 36 per cent; Oceania, 32 per cent; Eastern and South-Eastern Asia, 28 per cent; Latin America and the Caribbean, 25 per cent; Sub-Saharan Africa, 25 per cent; Western Asia and Northern Africa, 18 per cent. This lack of representation can be attributed to gender bias within political parties and the perception that women are not as electable as men. Thus, the inequality needs to be balanced before the next century.

Fog in Delhi

New Delhi: From a foggy morning to a sultry afternoon, Delhi's weather Thursday summarised the atypical patterns of the last 15 days and perplexed the residents. After a long spell of rain Wednesday, the minimum temperature plummeted to 15.8 degrees Celsius Thursday. making it the third coldest May morning since 1901 when the IMD started keeping weather records. Dense fog smudged landmarks in the morning as visibility levels dropped to 100 metres around 5:30 am in Safdarjung, according to the weather office. Harsh sunshine and high humidity troubled the residents during the day. Humidity levels oscillated between 80 per cent and 100 per cent at most places in the city.

Patna HC stays Bihar govt's caste survey


Patna, May 4: The Patna High Court Thursday ordered a stay on the caste survey being conducted by the Bihar government.

Hearing a bunch of petitions, a division bench of Chief Justice K Vinod Chandran and Justice Madhuresh Prasad directed the state government to immediately stop the caste-based survey, and ensure that the data already collected are secured and not shared with anybody till final orders are passed.

The court has fixed July 3 as the next date for the hearing. "We are of the considered opinion that the petitioners have made out a prima facie case against the continuation of the process of caste-based survey, as attempted by the state of Bihar. There is also the question raised of data integrity and security which has to be more elaborately addressed by the state," the court said

While, Prashant Kumar Shahi, Advocate General (AG) along with his team of lawyers argued on behalf of the state government, senior advocates Abhinav Srivastava, Dhananjay Kumar Tiwari and others represented the petitioners during the argument.

During arguments, counsels for the petitioners relied on the decision in National Legal Services Authority (supra) to point out that the transgenders' individual identity and entity were compromised by putting them together as a caste. Though they have been qualified as a backward community for the purpose of getting state relief, there is no reason to put them in a single caste category, which caste

It was pointed out that though the government has clarified that transgenders would not be classified as a caste, the classification remains in the guidelines issued by the state government, which prejudices them, one of the lawyers of the petitioners told the court.

"Prima facie, we are of the opinion that the state has no power to carry out a caste-based survey, in the manner in which it is fashioned now, which would amount to a census, thus impinging upon the legislative power of the Union Parliament," the HC said.

"Both result in an analysis of the data collected; which in the case of a 'census' are empirical, while in a 'survey' are mostly logical conclusions. The present exercise by the state of Bihar can only be seen as an attempt to carry out a 'census' under the name of a 'survey", it said.

The HC also observed that the notification issued by the state government does not disclose any perceivable object for carrying out such a survey.

Technician killed, two pilots injured as **Army copter crashes**

Jammu, May 4: An Army helicopter crashed after a "hard landing" in a forested area in the upper reaches of Jammu and Kashmir's Kishtwar district Thursday following a technical fault, killing a technician and injuring the two pilots on board, officials said.

The advanced light helicopter (ALH) Dhruv on an operational mission came down on the banks of a river in Marwah area, cut off from the district headquarters due to heavy snow. A court of inquiry has been ordered and further details are being ascertained, the Army said in a statement.

Thursday's crash was the fifth involving Army helicopters in Jammu and Kashmir since 2021. In a statement, the Udhampur-based Northern Command said, "At about 1115 hours on 04 May 2023, an Army Aviation ALH Dhruv helicopter on an operational mission made a precautionary landing on the banks of Marua river in the Kishtwar region of Jammu and Kashmir.

The pilots had reported a technical fault to the Air Traffic Controller (ATC) and proceeded for a precautionary landing, it said. "Due to the undulating ground, undergrowth and unprepared landing area, the helicopter apparently made a hard landing. Immediate rescue operations were launched and Army rescue teams reached the site," the statement said.

The injured were evacuated to the command hospital in Udhampur, where the technician Craftsman Anil-succumbed to his injuries, the Army said.

New Delhi, May 4: The **Enforcement Directorate Thursday** filed a fresh charge sheet in the Delhi excise policy-linked money laundering case naming AAP leader and former Delhi deputy chief minister Manish Sisodia as an accused in the case for the first time, official sources said.

Sisodia was arrested by the ED in this case March 9 from Tihar Jail and he is currently in judicial custody. The 51-year-old Aam Aadmi Party leader was first arrested by the CBI, which is also probing this case. This is the fourth supplementary and overall fifth charge sheet or prosecution complaint filed in the case by the ED before a designated special Prevention of Money Laundering Act (PMLA) court in Delhi. The agency has called Sisodia a "key conspirator" in this case. It had alleged, in the previous charge sheets, that the liquor policy 'scam' was a "conspiracy" undertaken by some of the big political leaders of the AAP and the so called 'South Group' comprising BRS leader K Kavitha, YSR Congress MP Magunta Srinivasulu Reddy and others who "used" proxies and dummies to conceal their involvement.

New Delhi, May 4: The Supreme Court Thursday junked an election petition challenging the election of DMK MP Kanimozhi from Tamil Nadu's Thoothukudi constituency in 2019.

Kanimozhi's election was challenged by a voter, A Sanathana Kumar, on grounds that she failed to mention her husband's Permanent Account Number (PAN) in her election affidavit disclosing family assets.

A bench comprising justices Ajay Rastogi and Bela M. Trivedi allowed the appeal filed by DMK leader against the Madras High Court order, which refused to dismiss the petition against her election. "In that view of the matter, election petition...filed by the respondent-elec-

tion petitioner deserves to be dismissed, and is accordingly dismissed. The impugned judgment of the High Court is set aside. The appeals stand allowed accordingly." said the top court. The top court noted that at the

time of scrutiny of the nomination paper and the affidavit in the Form 26 furnished by the appellant-returned candidate, neither any objection was raised, nor the returning officer had found any lapse or non-compliance of Section 33 or Rule 4A of the Rules (Rule 4A of the Conduct of Election Rules 1961).

The bench said if according to the respondent-election petitioner, the appellant-returned candidate had suppressed the PAN of her spouse and also about the non-payment of income tax of her spouse in the foreign country, it was obligatory on the part of the election petitioner to state in the election petition the PAN of the spouse of the returned candidate in India which

was suppressed by her. Also, how the other details furnished about her husband in the said Form No. 26 were incomplete or false, it added.

sco MEET Jaishankar holds talks with Chinese counterpart

Benaulim (Goa), May 4: External Affairs Minister S Jaishankar Thursday conveyed to his Chinese counterpart Qin Gang the importance of resolving the eastern Ladakh border row and ensuring peace and tranquillity along the Line of Actual Control (LAC) for normalisation of bilateral ties.

Jaishankar held nearly one-hour talks with Qin at Taj Exotica Resort in this sea-side village on the sidelines of a meeting of the Council of Foreign Ministers of the Shanghai Cooperation Organisation (SCO).

In a tweet, the external affairs minister said the focus remained on resolving outstanding issues and ensuring peace and tranquillity in the border areas. "A detailed discussion with State Councillor and FM Qin Gang of China on our bilateral relationship. Focus remains on resolving outstanding issues and ensuring peace and tranquillity

in the border areas," he said. Jaishankar said the discussions were also held on issues relating to the SCO, G20 and BRICS (Brazil-

Russia-India-China-South Africa). People familiar with the talks said the discussions centred around the border row and Jaishankar insisted on its early resolution.

There was no official readout on the meeting from the Indian and Chinese sides. The meeting between the two foreign ministers was their second in the last two months. The Chinese foreign minister visited India in March to attend a meeting of the G20 foreign ministers. On the sidelines of the meeting, Jaishankar held talks with Qin during which he conveyed to his Chinese counterpart that the state of India-China relations is "abnormal" because of the lingering border row in eastern Ladakh.

Last week, Defence Minister Rainath Singh told his Chinese counterpart Li Shangfu at a meeting that



Vijayan seeks Vande Bharat's halt in Tirur

Thiruvananthapuram, May 4: Kerala Chief Minister Pinaravi Vijavan on Wednesday wrote to Union Railway Minister Ashwini Vaishnaw seeking a halt for the Thiruvananthapuram-Kasargod Vande Bharat Express at Tirur and Thiruvalla stations, a day after the High Court dismissed a petition seeking the semi high-speed train's halt there.

On Tuesday, the Kerala High Court turned down the plea, saying that halting points of a train are determined by the Railways and no one has a vested right to demand at which station a particular train should stop.

The train completes its around 500 km distance in 7 hours 50 minutes with halts at Kollam, Kottavam. Ernakulam Thrissur, Shornur, Kozhikode, Kannur and Kasargod,

Of the 14 districts of the state the train halts at nine districts and it has no stop in districts like Alappuzha, Thiruvalla and Malappuram, though it passes through these districts, while it doesn't pass through Idukki and Wayanad districts.

In Vijayan's letter to Vaishnaw, he has requested for stops at Thiruvalla (Alappuzha district) and at Tirur in the Muslim domi nated Malappuram district.

'It would be beneficial for the Indian Railways to get more revenues if halts are allowed at Tirur and Thiruvalla from where a good number of people travel all across the state and request to consider this," said Vijayan in his letter.

Kerala's first Vande Bharat Express was flagged off on April 25 by Prime Minister Narendra Modi from Thiruvananthapuram Railway Station.

Students to be encouraged to take up vocational courses

Prayagraj (UP), May 4: With less than 1 per cent of total students registering for vocational courses in class 10 and class 12 exams of UP Board, officials of the state's Secondary Education Department have now issued orders for efforts to be made to encourage more and more students to take them up.

The board spends lakhs of rupees getting question papers of these subjects made annually. The officials concede that the situation needs to be redressed as the entire focus of the central and state governments is on skill development and providing employment-oriented education to students.

Mahendra Dev, the director of secondary education, has sent a letter to all district inspectors of schools (DIOSs) instructing them to register the maximum number of students possible for these vocational courses

Vocational education scheme is operational in 892 government and government-aided secondary schools of the state, the official added. The letter points out that guest subject experts have brought to the notice of senior officials that principals of many schools do not take admission of students in these vocational subjects due to their own wilful or negligent attitude. This is leading to a low count of registration in these trade subjects

Some principals have even initiated process for closing down



these trade subjects in their campuses after first, not giving admission to interested students in these approved trades, and adjusting the admitted students in other subjects deliberately. The letter further points out that there is a provision to admit a minimum of 25 students or even 10 students under special circumstances in these trades.

DIOS of Prayagraj, P.N. Singh, said that instructions have been received to ensure admission of maximum number of students in vocational courses."The responsibility of the principals of the schools concerned where the number of students will be less will also be fixed as part of this exercise to encourage students to opt for vocational trade subjects on offer at class 10 and class 12 lev-

Although vocational courses have been available for UP Board students for years now, courses in trades of plumber, solar-powered equipment repairing, disaster management and electrician were started for high school students only in 2023. However, out of 31.16.454 students who registered for class 10 exams in 2023, not even one took admission in any of these

Many other vocational subjects on offer at high school level also did not fare well like health care which had just four students, automobile which had eight, retail trading which had 19, mobile repairing which had 22 in and even IT that attracted mere 38 students across the state. The number of students enrolling for intermediate-level vocational courses was also very less in 2023.

ment," said Sharma. "Delayed diagnosis and lack of awareness regarding correct treatment is one of the leading causes for poor results in treatment. Increased awareness both among common people and medical staff would benefit will the cancer patients," said Abhishek Shukla, secretary general association of international doctors.



Congress general secretary Priyanka Gandhi Vadra tagged a video of wrestlers breaking down and said it was sad to see the tears of female sportspersons who brought laurels for the country with hard work and dedication.

Congress' media department head Pawan Khera in a tweet said. "Mr Prime Minister, it will take you just 15 min to visit these wrestlers at Jantar Mantar. Show some sensitivity.'

Addressing a press conference along with Olympic bronze medal-winning boxer Vijender Singh, AICC secretary Amrita Dhawan said what the Delhi Police did with the noted wrestlers is "unprecedented and shameful".

Hitting out at the Centre over the scuffle, West Bengal Chief Minister Mamata Banerjee said "disrobing" the honour of India's daughters in such a manner was utterly 'shameful".

Tamil Nadu Chief Minister M K Stalin hit out at Prime Minister Modi over the alleged manhandling of protesting wrestlers in Delhi, saying contrary to the PM's "false promises" on empowering

Apex court again refuses plea against 'The Kerala Story'



New Delhi, May 4: The Supreme Court Thursday rebuffed a fresh attempt by a petitioner seeking a stay on the release of the film 'The Kerala Story, saying that a filmmaker invests a lot of money and time in making a movie and actors also put in a lot of work, and the market will decide if it is not up to the mark.

A bench headed by Chief Justice of India D.Y. Chandrachud and comprising Justices PS. Narasimha and J.B. Pardiwala said: "One, the CBFC has released the film; two, the Kerala High Court declined to stay the film; and three, yesterday we said we are not going to entertain a petition under Article 32. Now, after these steps have been completed and now for us to hear an application like this is not proper.'

During the hearing on the plea, filed by journalist Qurban Ali, the bench emphasised that before rushing to the court against the movie. a thought should be given about the filmmaker and actors and how many times will this be challenged? The bench told petitioner's counsels, senior advocate Huzefa Ahmadi

and Shoeb Alam, to look at the filmmaker, he cannot be made to face courts for the release of his film and the Kerala High Court had applied its mind while refusing interim relief of staying the film release. Ahmadi submitted that a letter was sent to the acting Chief Justice of Kerala High Court, who said that a bench has been constituted.

The registry later informed the petitioner that the bench will not hold sitting on Thursday and also the Kerala High Court is on summer vacation, Ahmadi contended.

However, the apex court refused to entertain the plea against the

The bench pointed out that the petitioner initially tried to challenge the release of the film through an interlocutory application in a pending hate speech case, which was turned down by another bench.

On Wednesday, the Supreme Court refused to entertain a plea by the Jamiat Ulama-i-Hind seeking a direction to the Centre and others not to allow the screening or release of the movie in theatres, OTT platforms and other avenues, and also that the trailer should be removed from the Internet.

The encounter took place on the day of polling for the first phase of the urban local body elections in the state. The Yogi Adityanath government's major poll plank has been its "strict" handling of law and order.

Days earlier, gangster-politician Atiq Ahmad's son Asad Ahmad and his accomplice were shot dead in an exchange of fire with the Uttar Pradesh Police. A couple of days later, Atiq Ahmad and his brother Ashraf Ahmad were gunned down in Prayagraj by three men while they were being escorted to a hospital by the police.

Additional Director General of Uttar Pradesh STF Amitabh Yash said, "Anil Dujana, a wanted criminal, was surrounded by our team led by Additional SP of UP STF Brijesh Singh, in a village in Meerut Thursday afternoon. He fired at our team to escape and was killed in retaliatory firing."

The police recovered two pistols and several cartridges from Dujana's vehicle, the officer said, but did not clarify if Dujana was alone or was accompanied by some of his gang members.

Dujana had over 60 cases, including 18 of murder, lodged against him in western Uttar Pradesh districts and Delhi, police said.



Cigarette butts leak deadly toxins into environment: Study

New Delhi, May 4: Cigarete filters leak thousands of toxins and plastic fibers into the environment that are toxic to aquatic larvae, according to a study that calls for these filters to be completely

A research team at the University of Gothenburg in Sweden found that microfibers and the chemicals that leak out of the filters in cigarette butts are toxic to aquatic larvae.

"The filter is full of thousands of toxic chemicals and microplastic fibers, so it's not just any piece of plastic that's being discarded into the environment. It's hazardous waste," said Bethanie Carney



Almroth, Professor of Ecotoxicology

at the University of Gothenburg. The study, published in the journal Microplastics and Nanoplastics. tested the effects of the toxins that

are found in the filter after smoking, as well as the substances that are in the filter from the start, on aquatic mosquito larvae

It found that the toxins lead to a

The study found that the toxins lead to a 20 per cent higher mortality rate among mosquito

Previous research has shown that the toxins in the filters also have adverse effects on many other aquatic organisms

For example, fish can die if they are exposed to concentrations corresponding to the toxins exuded by barely two cigarette butts in one liter of water for four days

20 per cent higher mortality rate among mosquito larvae. Previous research has shown that the toxins in the filters also have adverse effects on many other aquatic organisms.

For example, fish can die if they are exposed to concentrations corresponding to the toxins exuded by barely two cigarette butts in one liter of water for four days. "Cigarette filters are also a major source of the microplastics that find their way into our environment—something we know has a major negative impact on biological life. The EU has already classified cigarette filters as hazardous waste," said Almroth.

The researchers also observed in the study how smokers in Gothenburg behave when it's time to put out their cigarettes. It turns out that many people throw their cigarette butts on the ground even if there are ashtrays nearby.

Qin to visit Pak

Putin should be sentenced for 'criminal actions': Zelenskyy

The Hague, May 4: Ukrainian President Volodymyr Zelenskyy said Thursday he was convinced that Russian President Putin would face an international war crimes court when Ukraine wins the war that has been raging for over a year.

In a speech titled "No Peace without Justice for Ukraine" given in The Hague, the city that hosts the International Criminal Court, Zelenskyy said that Putin "deserves to be sentenced for these criminal actions right here in the capital of the international law." 'And I'm sure we will see that

happen when we win. And we will win," he said. The ICC has issued an arrest warrant for Putin for alleged war crimes in Ukraine, relating to the abduction of children. The ICC cannot prosecute the crime of war aggression itself. Zelenskyy's speech was an appeal for a fullfledged tribunal to prosecute that overarching crime, a heart-felt plea for a special tribunal for aggression.

"If we want true justice, we should not look for excuses and should not refer to the shortcomings of the current international law but make hold decisions that will correct that shortcomings that unfortunately exist in international law.

Zelenskyy's speech came a day after he denied that Ukrainian forces were responsible for what the Kremlin called an attempt to assassinate Putin in a drone attack on Moscow. The Kremlin promised retaliation for what it termed a "terrorist" act.

Putin's spokesman Thursday ac-

Meanwhile, Ukraine's military claimed three Russian drones that hit the southern city of Odesa early Thursday had "for Moscow" and "for the Kremlin" written on them, seemingly referring to the strikes in Moscow. Also, Kviv was the target of an air attack for the third time in four days

In total, Ukraine's Air Forces intercepted 18 out of 24 Iranianmade drones launched by Russian forces in various regions. No casualties were reported. Zelenskyv was welcomed outside the ICC building by the court's president, Poland's Piotr Hofmanski. Staff crowded at windows to get a glimpse of Zelenskyy's arrival and raised a Ukrainian flag next to the court's own flag outside the building.

Judges at the ICC last month announced they had found "reasonable grounds to believe" that Putin and his commissioner for children's rights were responsible for the unlawful deportation and transfer of children from occu-

pied areas of Ukraine to Russia. But the chances of Putin standing trial in The Hague are remote. The court does not have a police force to execute its warrants, and the Russian leader is unlikely to travel to any of the ICC's 123 member states that are under an obligation to arrest him if they can.

Israeli forces kill **3 Palestinians**

Nablus, May 4: Israeli troops Thursday killed three Palestinian militants wanted in connection with a shooting attack that killed a British-Israeli woman and two of her daughters, the Israeli military said, the latest bloodshed in a relentless wave of violence.

In a rare daytime incursion launched as residents were starting their day, the military said forces entered the heart of the flashpoint city of Nablus and raided an apartment where the men were located. Troops and the suspects exchanged fire and the three men

The military said the men were behind an attack last month on a car near a Jewish West Bank settlement that killed the British-Israeli mother and two of her daughters. It said two of the men were members of the Hamas militant group. It described the third man killed as a senior operative who had assisted the other suspects.

In a statement after the raid, Hamas claimed all three men, identified as Hassan Qatnani, Moaz al-Masri and Ibrahim Jabr, as members and claimed responsibility for the April attack, Israeli shells ripped through the roof of the gunmen's safe house in the heart of Nablus' Old City, leaving nothing but twisted metal, cement blocks and torn mattresses still stained with blood scattered over the rubble. A couple hours after the army withdrew, young men collected scores of ejected bullet shell casings from the narrow alleys.

The violence in Nablus comes at a particularly sensitive time in the region, days after a prominent Palestinian prisoner who was staging a lengthy hunger strike over his detention died in Israeli custody.

20,000 YEARS OLD PENDANT FOUN

THE RESEARCHERS WHO FOUND THE PENDANT, WHICH WAS DETERMINED TO BE 19,000-25,000 YEARS OLD, USED GLOVES AND FACE MASKS WHEN EXCAVATING AND HANDLING IT, AVOIDING CONTAMINATION WITH MODERN DNA

Washington, May 4: Inside a Siberian cave that has been an archeological treasure trove, an elk's canine tooth - pierced to become a pendant - was unearthed by scientists with care to avoid contaminating this intriguing artifact made roughly 20,000 years ago.

The pristine collection of the pendant from Denisova Cave paid dividends. Scientists on Wednesday said a new method for extracting ancient DNA identified the object's long-ago owner - a Stone Age woman closely related to a population of hunter-gatherers known to have lived in a part of Siberia east of the cave site in the foothills of the Altai Mountains in Russia.

The method can isolate DNA that was present in skin cells, sweat or other bodily fluids and was absorbed by certain types of porous material including bones, teeth and tusks when handled by someone thousands of years ago.



Objects used as tools or for personal adornment - pendants, necklaces, bracelets, rings and the like - can offer insight into past behavior and culture, though our understanding has been limited by an inability to tie a particular object to a particular person.

"I find these objects made in the deep past extremely fascinating since they allow us to open a small window to travel back and have a glance into these people's lives,' said molecular biologist Elena Essel of the Max Planck Institute for Evolutionary Anthropology in Germany, lead author of the study published in the journal Nature.

The researchers who found the pendant, which was determined to be 19,000-25,000 years old, used gloves and face masks when excavating and handling it, avoiding contamination with modern DNA. It became the first prehistoric artifact linked by genetic sleuthing to a specific person. It is unknown whether the woman made or merely wore it.

Essel said in holding such an artifact in her own gloved hands, she felt "transported back in time, imagining the human hands that had created and used it thousands of years ago.

"As I looked at the object, a flood of questions came to mind. Who was the person who made it? Was this tool passed down from one generation to the next, from a mother to a daughter or from a father to a son? That we can start addressing these questions using genetic tools is still absolutely incredible to me," Essel added. The pendant's maker drilled a hole in the tooth to allow for some sort of now-lost cordage. The tooth alternatively could have been part of a head band or bracelet.

Our species Homo sapiens first arose more than 300,000 years ago in Africa, later spreading worldwide. The oldest-known objects used as personal adornments date to about 100,000 years ago from Africa, according to the University of Leiden's Marie Soressi, the study's senior archeologist.

Denisova Cave long ago was inhabited at different times by the extinct human species called Denisovans, Neanderthals and our species. The cave over the years has yielded remarkable finds, including the first-known remains of Denisovans and various tools and other artifacts.

The new nondestructive research technique, used at a "clean room" laboratory in Leipzig, works much like a washing machine. In this case, an artifact is immersed in a liquid that works to release DNA from it much as a washing machine lifts dirt from a blouse.

WHO fires scientist who led COVID search

Geneva, May 4: The World Health Organisation says it has fired the scientist who led a high-profile delegation from the UN health agency to China two years ago to jointly look into the origins of the coronavirus pandemic, citing sexual misconduct. Peter Ben Embarek, who led the WHO side of a joint team with scientists in China, was dismissed last year, the health agency said.

WHO says it has stepped up efforts to root out sexual abuse, exploitation and harassment in recent months after a string of cases and incidents were reported in the press. "Peter Ben Embarek was dismissed following findings of sexual misconduct against him and corresponding disciplinary process,' said spokeswoman Marcia Poole ঽ said in an email. "The findings concern allegations relating to 2015 and 2017 that were first received by the WHO investigations team in 2018." She said other allegations could not be fully investigated as the "victim(s) did not wish to engage with the investigation process.'

India, Russia shelve talks to settle trade in rupees

New Delhi/Mumbai, May 4: India and Russia have suspended efforts to settle bilateral trade in rupees, after months of negotiations failed to convince Moscow to keep rupees in its coffers, two Indian government officials and a source with direct knowledge of the mat-

With a high trade gap in favour of Russia, Moscow believes it will end up with an annual rupee surplus of over \$40 billion if such a mechanism is worked out and feels rupee accumulation is 'not desirable, an Indian government official, who did not want to be named, told Reuters.

India's finance ministry, the Reserve Bank of India and Russian authorities did not immediately respond to requests for comment.

The rupee is not fully convertible. India's share of global exports of goods also is just about 2% and these factors reduce the necessity for other countries to hold rupees.

India started exploring a rupee settlement mechanism with Russia soon after the invasion of Ukraine in February last year, but there has been no reported deal done in rupees. Most trade is in dollars but an increasing amount is being carried out in other currencies like the UAE dirham.

The two sides have spoken about facilitating trade in local currencies but the guidelines were not formalised.

Russia is not comfortable holding rupees and wants to be paid in Chinese yuan or other currencies, a second Indian government official

"We don't want to push rupee settlement any more, that mechanism is just not working. India has tried everything we could to try and make this work but it hasn't helped," a third source who is directly aware of the developments said.

Since Russia's invasion of Ukraine February 24 last year, India's imports from Russia have risen to \$51.3 billion until April 5, from \$10.6 billion in the same period in the previous year, according to another Indian government official.

Discounted oil has constituted a large part of India's imports, surging twelve-fold in the period. Exports from India in the same period fell

Another official said both countries have started looking for alternatives after the rupee settlement mechanism did not work out but did not give details.

TRADE ON TRACK

The sources said trade with Russia has been continuing despite sanctions and payment issues.

"Right now we are making some payments in dirham and a few other currencies but the majority is still in dollars. Settlement is happening in different ways, third party countries are also being used," one of the government of ficials said.

Indian traders are currently also settling some of the trade payments outside Russia, the officials said.

Third-parties are being used to settle trade with Russia. There is no ban on transacting with other countries over SWIFT. So payments are being made to a third country which route it or offset it for their trade with Russia, the other official said.

On whether money was also being routed via China, the official said, "Yes, including China."

Ola Electric, Ather to refund charger cost to e-scooter buyers

"While there is no legal compliance requirement to bundle chargers, after discussions with MHI and in larger interest of the EV ecosystem, we recently made the change to bundle the charger with the vehicle," it said.

It further said, "In order to be fair to the customers who had bought the vehicle prior to this change, we have decided to refund the invoiced amount of the chargers for vehicles bought before April 12, 2023."

Govt directs firms to cut cooking oil prices

The food ministry said that international prices of imported edible oils are on a downward trend which gives a positive scenario for the edible oils sector in India



New Delhi, May 4: The Centre Thursday asked edible oil companies to cut the prices of cooking oils in line with the fall in global prices for the benefit of consumers.

A major importer of edible oils, India imported cooking oils worth ₹1.57 lakh crore during 2021-22 marketing year (November-October).

It buys palm oil from Malaysia and Indonesia while soyabean oil is being imported from Argentina and Brazil.

The decline in the price of edible oils should be passed on to consumers expeditiously, Food Secretary Sanjeev Chopra said during a meeting with leading industry representatives here.

Representatives from Solvent Extraction Association of India (SEA) and Indian Vegetable Oil Producers' Association (IVPA) were present at the meeting to discuss further reduction in the retail prices of cooking oils amidst a fall in the global prices, an official statement said.

Mother Dairy, which sells cooking oils under Dhara brand, Thursday said it has reduced the maximum retail prices by ₹15-20 per litre and the new stock will hit the market next week.

As per the government data, the

retail price of packed groundnut oil Thursday stood at ₹189.13 per kg, mustard oil ₹150.84 per kg, vanaspati ₹132.62 per kg, soyabean oil ₹138.2 per kg, sunflower oil ₹145.18 per kg and palm oil ₹110.05 per kg.

The food ministry said that international prices of imported edible oils are on a downward trend which gives a positive scenario for the edible oils sector in India.

The industry informed that the global prices of different edible oils have fallen by USD 200-250 per tonne in the last two months but it takes time to reflect in the retail markets and the retail prices are expected to come down shortly, the statement said.

Edible oil associations have been advised to take up the issue with their members immediately and ensure that the MRP (Maximum Retail Price) of each oil be reduced in line with the decline in the international prices of edible oils with immediate effect.

Besides, the food ministry has asked for lowering the price at which edible oils are supplied to distributors by manufacturers and Whenever a reduction in price

to distributors is made by the manufacturers refiners, the benefit should be passed on to the consumers by the industry.

Go First suspends sale of tickets till May 15



New Delhi, May 4: Crisis-hit airline Go First has suspended sale of tickets till May 15 and is working to refund or reschedule existing bookings for future dates, aviation regulator DGCA said Thursday.

The Directorate General of Civil Aviation (DGCA) had issued a show cause notice to the airline after it suddenly decided to cancel flights for three days starting May 3.

Go First has intimated that they have suspended sale of their flights till 15 May 2023 and are working to refund or reschedule for future dates, the passengers already booked to fly with them, the regulator said in a statement.

New Delhi: The National Company Law Tribunal (NCLT) Thursday reserved its order on the cash-strapped airline Go First's plea seeking voluntary insolvency resolution proceedings. India's exports likely to touch \$900bln in 23-24: exporters

(FIEO) Overseas demand remains strong in many markets, he added.

Trade Minister Piyush Goyal urged exporters to explore new markets, however, in view of the possible impact of war in Ukraine and a global slowdown.

"The times ahead are going to be very, very tough," Goyal said speaking at an industry event late Wednesday, while warning of the fallout from the conflict. Prime Minister Narendra Modi's

government has set an export target of \$2 trillion by 2030, offering benefits to boost exports of electronics, engineering, pharmaceutical, and other goods

India has not explicitly condemned Russia's February 2022 invasion of Ukraine and has called for dialogue to resolve hostilities.




The Titans, on the other hand, have to get over their lacklustre batting display against the Capitals where they failed to chase down 130.

Haaland breaks EPL Spotlight on Neeraj in Diamond League opener record in City victory

Manchester, May 4: A new Premier League goals record for Erling Haaland and three more points for title-chasing Manchester City. The Norway striker has scored 35 times in his first season playing in English football's top division – surpassing the previous singleseason record that was jointly held by Alan Shearer and Andy Cole.

Haaland still has five more games to add to his remarkable total and left the field to a guard of honour from his teammates after the final

While the Golden Boot for the country's leading scorer is certain to come Haaland's way, bigger prizes are also in sight, with City edging closer to a third straight title after a 3-0 win against West Ham.

Haaland's goal in the 70th-minute put City 2-0 up after Nathan Ake had opened the scoring in the 50th. Substitute Phil Foden added a third with a deflected effort in the 85th.

The win moved City back to the top of the standings, a point above Arsenal, which had gone to the summit after a 3-1 win against Chelsea Tuesday. Pep Guardiola's defending champions also have a game in hand on their title rival.

While the result suggested a routine win for City, West Ham proved to be frustrating opponents for the

Doha, May 4: Competing for the first time as Diamond League champion, star javelin thrower Neeraj Chopra will be up against his familiar nemeses in the first of the prestigious meetings series Friday. as he aims to begin a 'long' season, studded with top international events, with a strong performance.

The 25-vear-old Chopra, also a 2022 World Championships silver winner, faces the likes of reigning world champion Anderson Peters of Grenada and Tokyo Olympics silver medallist Jakub Vadlejch of Czech Republic in a star-studded field at the Qatar Sports Club.

Chopra, who has a personal best and national record of 89.94m, had finished fourth with 87.43m in 2018 in the only other participation in the Doha Diamond League. He could not take part here last year due to lack of "overall fitness and strength".

Despite missing the Doha leg, Chopra went on to script history one after the other last year. He became the first Indian Diamond League champion after winning the 2022 grand finale in Zurich in September: A month before that, he became the first Indian to win a Diamond League Meeting in

Chopra last month said that he was feeling better "physically and technically" at the corresponding point in time, but it will not be easy for him to win the top prize in the season-opening Diamond League here, going by the incredible competition seen here last

Peters had produced the fifthlongest throw in history by hurling the spear to 93.07m, a mark just outside German Thomas Rohler's 93.90m, a meeting record set in

Vadlejch, who finished second behind Chopra in Tokyo Olympics and won a bronze in the 2022 World Championships, also recorded a personal of 90.88m here last year in his first ever throw over 90m.



Alongside the decorated trio, the Doha Meeting will also have European champion Julian Weber of Germany, who has a personal best of 89.54m, 2012 Olympic champion Keshorn Walcott (PB 90.16m) of Trinidad & Tobago and former

world champion and 2016 Olympic silver medallist Julius Yego (PB 92.72m) of Kenya.

"This is my first competition of the season. It's always good when you have great competitors," Chopra

"Vadlejch has already thrown 88.38m in Potchefstroom (South Africa, on April 18), so I think tomorrow will see great competition. Also, Doha is famous for 90m throws. So we will see, hopefully tomorrow will have great results for all."

One of the targets for Chopra, the first Indian Olympic gold medallist in track and field, this year will be to cross the 90m mark, the gold standard in the world of javelin, but whether he can achieve the feat in his first competition of the season remains to be seen.

Last month, he said he would also be looking to cross the coveted mark this year, though he is not putting himself under pressure to achieve the feat.

The Diamond League is track and field's most prestigious series sitting in the top tier of World Athletics' one-day competitions. The 2023 Diamond League comprises 13 meetings, starting with the Doha event leading up to the twoday Diamond League Final in Eugene, USA, September 16-17.

quarterfinals. Earlier in the day, Govind (48kg) and Deepak (51kg) kicked off their respective campaigns with identical victories.

Govind, who has had an outstanding year so far with a gold at the National Championships and a silver at the 74th Strandja Memorial, continued his rich vein of form as he made light work of Mehron Shafiev of Tajikistan to se-

cure a 5-0 win. Deepak, on the other hand, was also at his attacking best as he ousted Luis Delgado of Ecuador with his supreme technical ability to seal an emphatic victory by unanimous decision.

Govind will next face the topseeded Sakhil Alakhverdovi of Georgia who won bronze at the last World Championships while Deepak will take on the Tokyo Olympics bronze winner and reigning world champion Saken Bibossinov of Kazakhstan.
