Campaign ends for Jharsuguda bypoll

Jharsuguda: The high-decibel campaign for the May 10 bypoll in Jharsuguda assembly seat ended at 6pm Monday, officials said. Campaigning was intense as this is the last poll before the general elections next year. Poll officials have reached Jharsuguda Engineering School from where they will collect their equipment and leave for polling booths. As many as 2,21,070 people are eligible to exercise their franchise in 253 booths. Voters comprise 1,10,320 men, 1,10,687 women and 63 of the third gender.

Bengal govt bans 'The Kerala Story'

Kolkata: West Bengal Chief Minister Mamata Banerjee Monday ordered an immediate ban on the screening of the controversial film 'The Kerala Story' to avoid "any incident of hatred and violence", a senior official said here. Action will be taken against any theatre found showing the film, the official said. Earlier in the day, Banerjee described 'The Kerala Story' as a distorted movie, aimed at defaming the southern state. 'The Kerala Story', directed by Sudipto Sen, depicts how women from Kerala were converted to Islam and recruited by IS terrorist group. The film was released May 5.

Guv seeks report on power outage

Bhubaneswar: Governor Ganeshi Lal Monday sought a report from the state government on the nineminute power blackout during President Droupadi Murmu's speech at a university's convocation in Baripada. The governor, who is also the chancellor of the universities asked Chief Secretary PK Jena and Vice Chancellor of Maharaja Sriram Chandra Bhanjadeo University, Santosh Tripathy, to file a detailed report on the power disruption in the auditorium while the President was delivering her speech May 6. The governor has sought the report from the authorities within seven days. Tripathy confirmed receiving a letter from the Raj Bhavan and said he will submit the reply

SC settles Srimandir matter after 5 years

The issue reached the apex court in June 2018 with the petition filed by Mrinalini Padhi highlighting difficulties faced by the visitors at Srimandir, and their harassment by the Sevaks of the temple. New Delhi, May 8: After almost five years and 26 sittings, the Supreme Court Monday closed proceedings in a public interest litigation (PIL) which highlighted the difficulties faced by devotees at Srimandir in Puri and sought directions for better management of affairs at the 12th century shrine.

A two-judge bench of Justices MR Shah and CT Ravikumar took on record the affidavit filed by Shree Jagannath Temple Managing Committee in compliance with the Supreme Court judgement of November 2019 and disposed of the PIL filed by Mrinalini Padhi and other applications filed in the court.

The top court, however, made it clear that if anyone finds out that the directions of the apex court are not complied with, it will be open to file an application in the Orissa High Court on the same. The apex court also asked the high court to

During the hearing, amicus curiae and senior advocate Ranjeet Kumar submitted that he has certain apprehensions with respect to the affidavit filed by the temple managing committee saying the committee has made tall claims. Kumar suggested that he along with advocate Priya Hingorani be allowed to visit Puri to check ground realities. He also highlighted the issues related to Records of Rights of Shree Jagannath temple property and related to inventory of Ratna Bhandar.

However, the bench was reluctant to go into the aspects of inventory of Ratna Bhandar.

"That is the problem. Ratna Bhandar is very difficult to open. We don't accept that but we cannot play with fire. It says that if it is opened then something can happen. We don't want to enter into that arena. We don't want to be part of that. Whatever good is going on, let the good things go on," the bench observed.

MOCHA LIKELY IAF's MiG-21 crashes in Raj TO SPARE STATE killing 3 civilians; pilot safe

Bhubaneswar, May 8: Cyclone Mocha brewing over Bay of Bengal is likely to spare Odisha according to prediction made by the India Meteorological Department (IMD).

Odisha is experiencing hot and sultry weather, which is likely to continue for four more days, the Met office said Monday.

IMD Director General is experiencing Mrutunjay Mohapatra hot and sultry said the possible cyclone weather, which is forming in the Bay of Bengal will not have any direct impact on Odisha or any other state on the east coast as the system is likely to move towards the Bangladesh-Myanmar coast. Special Relief Commissioner (SRC) Satyabrata Sahu said in a Twitter post, "#Heatwave conditions, high day temperatures likely to prevail

over various parts of the state to-

morrow (9th May) as per alerts communicated by @mcbbsr.'

Regional Meteorology Centre, Bhubaneswar Director HR Biswas said that most parts of the state are likely to experience temperatures two to three degrees Celsius above normal during the next two days with no large change thereafter.

Consequently, the mercury may soar to 40 degrees Celsius or more at a few places during the next four to five days.

Odisha is likely to exlikely to continue for perience hot and disfour more days comfort weather during this period. People are advised to take precautionary measures while going outside,

Biswas said As many as 14 places across the state Monday recorded temperatures above 40 degrees Celsius with Boudh becoming the hottest place in Odisha at 42 degrees Celsius.

Jaipur/New Delhi, May 8: A MiG-21 fighter aircraft of the Indian Air Force (IAF) crashed on a house in Hanumangarh district of Rajasthan Monday, leaving three women dead and as many others injured on the ground, officials

The pilot sustained minor injuries in the crash that took place at around 9:45am, the IAF said.

The plane was on a routine training sortie from the Air Force Station at Suratgarh in Ganganagar district. which is close to Hanumangarh.

"Soon thereafter, the pilot experienced an onboard emergency, following which he attempted to recover the aircraft as per existing procedures," the IAF said in a statement.

"Having failed to do so, he initiated an ejection, sustaining minor



injuries in the process. The pilot was recovered from about 25 kilometres North East of Suratgarh base," it said. The IAF said the "wreckage of the aircraft fell on a house in Bahlol Nagar in Hanumangarh district, unfortunately leading to the loss of three lives.

"The IAF regrets the loss of lives

and offers its deepest condolences to the bereaved families. A Court of Inquiry has been constituted to ascertain the cause of the accident," it said. IG, Bikaner range, Om Prakash said the pilot made all efforts to avert human casualties and crash-landed the plane on the

HACKED TO DEATH POST NEWS NETWORK

EX-SAMITI MEMBER

Kamakhyanagar/Bhuban, May 8: A former samiti member of Dighi panchayat under Bhuban block and Kamakhyanagar police limits in Dhenkanal district was brutally hacked to death late Sunday night in an organised attack by miscreants over past enmity and political rivalry.

The deceased was identified as Sarbeswar Rout, 55, of the village. Kamakhyanagar police registered a case and launched an investigation over a complaint lodged by his son Sujit Rout. Meanwhile, police have detained five persons and interrogated them in this connection.

The brutal killing of the former public representative has sparked shockwaves in the dis-

trict. Police handed over the body to his family

members after conducting a postmortem, Kamakhyanagar IIC Sarat Chandra Mahallik said.

According to the complainant, his father was elected as a Samiti member in 2017 elections and had served as the village committee president earlier. During the tenure of Rout as the village committee president. a local youth Ajay Swain, son of Mayadhar Swain was always opposing the former in various developmental works and used to give him murder threats. The incident occurred when Rout was returning home on his motorcycle from his cashew orchard Sunday night.

Miscreants waylaid him near Jamunalia and attacked him with sharp-edged weapons and lathis. Family members received a phone call about the attack at around 10.55pm and rushed to the spot. They rescued him in a crtical condition and admitted him to the Dhenkanal DHH where doctors pronounced him dead on arrival. Familymembers have demanded stringent action against the culprits.

Bhubaneswar, May 8: High-decibel campaign for the May 10 Jharsuguda by election came to an end Monday evening the result of which will be declared May 13.

A total of nine candidates are in fray for the bypoll. All the three principal political parties - BJD, BJP and Congress – have nominated fresh candidates

BJD nominated ex-minister Naba Das's daughter Dipali Das while BJP fielded Tankadhar Tripathy and Congress nominated Tarun Pandey, the son of ex-MLA of Jharsuguda Biren Pandey

BJD president and Chief Minister Naveen Patnaik along with several ministers, MLAs and senior party leaders were campaigning for Dipali while Union Ministers Dharmendra Pradhan and Bishweswar Tudu, BJP vicepresident Baijayant Panda, state president Manmohan Samal, many BJP MPs. MLAs and leaders have joined the campaigning trail for party candidate Tripathy. State Congress president Sarat

Pattanayak and some party leaders campaigned for Tarun.

Meanwhile, the Election Commission has made all arrangements for smooth conduct of the bypoll. Speaking to mediapersons here about the preparedness, Chief Electoral Officer (CEO) Nikunja Bihari Dhal said polling parties, EVMs, election materials and security arrangements – all are in place for the bypoll.

Dhal said voting is going to b held at 253 booths in 197 locations. As many as 2,21,719 voters (1,10,619 males, 1,11,037 females and 63 trans genders) will exercise their franchise for the byelection.

In all 253 booths web casting has been planned. Apart from that, 69 micro observers will be deployed and extra central armed police force (CAPF) deployment will be done in appropriate locations, he said.

The CEO informed that a total of 1,814 police personnel (including 155 police officers, 17 platoon of armed police, 323 havildars/constables and 205 home guards) and seven companies of CAPF are being deployed for the poll. The CAPF are being deployed in 144 booths.

In a precautionary measure, 171 licensed arms have been deposited in concerned police stations. About 1,903 persons have been booked under preventive sections of 107 & 116 of CrPC while 112 non-bailable warrants have been executed, he added. Polling parties pertaining to 227 out of 253 booths (mostly the rural and distant places) have been dispersed Monday from Engineering School, Jharsuguda. The remaining 26 polling parties for the pink booths will be dis-

Braille dummy ballot papers have been made available with each presiding officer for helping visually challenged voters. Poll day being declared as a paid holiday for all the government emplovees as well as private employees who are voters in the constituency.

For transportation of persons with disabilities (PwD) voters from their houses to booths and back, 2,539 vahan passes have been issued, 118 auto-rickshaws have been arranged.

As many as 40 model booths with facilities like ramps, temporary shed, separate queues, drinking water, volunteers for PwD and senior citizens etc. will be operating on the poll day. Similarly, 26 pink booths especially in urban areas totally manned by trained lady polling officers will be opened.

Till now. 12 complaints on violation of model code of conduct have been received from political parties which were sent to district election officer (DEO) for enquiry and in most of the cases after due enquiry action has been taken, Dhal said.

'The law and order is fully under control. We are committed to a free, fair and peaceful election on May 10," the CEO added.

IISER Bhopal creates molecules emitting near-infrared light

The discovery could potentially extend the use of organic light-emitting devices beyond visible light, with implications in a range of applications from medical equipment to advanced security gadgets

esearchers at the Indian Institute of Science Education and Research (IISER) Bhopal have created a new family of organic molecules that

emit light in the near-infrared (NIR) range, opening possibilities for organic light emitting devices (OLEDs) for various applications.

Light-emitting diodes or LEDs are tiny devices that are commonly used in applications such as television screens, gadget displays and others. They are different from traditional filament bulbs in that while bulbs emit light when heated, LEDs emit light when electricity (in the form of electrons) passes through them.

OLEDs are a form of LEDs where the light emitting materials are organic molecules -- chemicals made largely of carbon and hy-

drogen. Although visible light-emitting OLEDs have already found mass ap-

plication in displays for gadgets, televisions, and lighting, producing NIR-emitting OLEDs is challenging due to their unique molecular energy structure.

Light-emitting molecules generate light when electrons fall from a high energy state (HOMO) to a low energy state (LUMO) inside the

molecule, and the colour of the emitted light depends on the energy difference between the two states The energy difference in organic molecules corresponds to visible light, making visible light-emitting OLEDs easier to design.

The team at IISER created new organic molecules that have a very low-energy LUMO. This means that the energy difference between LUMO and HOMO is smaller, resulting in near-infrared light.

We have achieved a nitro group containing polycyclic aromatic molecules that exhibit fluorescence (light emission) in the near-IR wavelengths," said Prof Jeyaraman Sankar, IISER Bhopal, in a statement. The team's new approach to obtaining stable electron-deficient molecules with NTR emission using nitration as a strategy is unique and has been published in the journal of the Royal Society of Chemistry Chemical Science

The innovation lay in fine-tuning the structure of the nitro-groupcontaining molecules that typi cally do not fluoresce and are therefore usually non-light-emitting. Another challenge is to position the emission in the near-IR region. The team engineered the struc-

ture of the molecules such that they emit near-IR light. In addition, the synthesised molecules show strong electron affinity values, excellent stability, and structural rigidity. The fluorescence quantum yields

(the amount of near-IR light emitted) are among the best for any known near-IR light-emitting electron-deficient materials, the team said.

Apart from their use in OLED applications, the strong electron affinity, NIR emissive nature, high stability and redox robustness of these molecules make them excellent candidates for catalysts.

3 held for attacking girls' hostel inmates

Bhubaneswar: The twin city Commissionerate Police Monday arrested three persons on charges of attacking inmates of a girls' hostel in Nayapalli area here Friday. The accused were identified as Shasikant Bhoi, 20, Sania Das, 22, and Sanjay Behera, 37, of Bhoi Sahi under Nayapalli police limits. According to Nayapalli police sources, the incident took place when Nilabati Swain, the girls' hostel owner, was chitchatting with her friend May 5 evening. "Swain saw one of the accused pelting stones towards the hostel and passing lewd comments at the inmates. As she objected to it, the accused hurled stones en masse. Later, they barged into the hostel and assaulted the inmates," an official said, quoting Swain's complaint. On the basis of the complaint, Nayapalli police registered a case (176/23) and arrested the accused Monday. Sources in police said that manhunt is on to arrest seven accused on the run. "We will soon launch a special drive and check whether the owners of ladies hostels are following all the security measures as prescribed in the guidelines. Elephant deaths in Kuldiha spark concern

POST NEWS NETWORK Nilgiri, May 8: The Odisha gov-

ernment is spending huge amount of money for the protection of elephants in the state. However, deaths of nine elephants in the last 14 months in Kuldiha Wildlife Sanctuary under this block in Balasore district has become a matter of concern and frustration for Forest department officials.

The death of a female elephant Sunday in Kuldiha Wildlife Sanctuary is a case in point. The animal died in a jungle under Hatikholia forest segment of the



sanctuary. The animal was suffering from a deep wound on one

of its legs. It was undergoing treatment for the last one month under the supervision of the Forest department. However, despite all efforts it succumbed to its injury.

Forest department officials and members of the joint task force led by DFO Khuswant Singh, Balasore ACF Sovan Diganta Chand and Kuldiha ranger Ananta Kumar Jena cremated the animal after conducting a post-mortem. They said that the actual cause of the elephant's death can only be ascertained once the post-mortem

Nature lovers and wildlife enthusiasts have alleged that while the Forest department is terming the animal's death 'natural', it is not doing enough to find out the real reason behind the demise of the pachyderm. Locals claimed that the animal might have died due to anthrax infection. All have demanded a high-level inquiry behind the frequent deaths of elephants.

INTACH seeks heritage tag for Paralakhemundi railway station



Bhubaneswar, May 8: The Odisha chapter of the Indian National Trust for Art and Cultural Heritage (INTACH) has sought heritage status for the state's first railway station at Paralakhemundi. In a letter to Railway Minister Ashwini Vaishnaw. INTACH, Odisha chapter convener, AB Tripathy has urged the former to consider the heritage and historical relevance of the railway station and take the initiative for setting up a museum and a photo gallery.

An expert team from IN-TACH, Bhubaneswar, comprising Anil Dhir, Deepak Nayak. Kumar Conservation Architects Satyam Jyoti and Bishnu Mohan Adhikari recently visited Paralakhemundi in Gajapati district and submitted a report on the existing and the newly-coming up railway station. The recommendations of INTACH suggest that the old heritage railway station should

not be demolished "The new building coming up is on a raised platform and

overshadows the existing heritage structure. The old station is still in a very good shape and does not need much restoration. This old station should be given a 'Heritage Tag' and preserved as it is. It is not only of importance to Odisha, being the first railway station of the state, but is an important landmark of the nation," Tripathy said in the letter.

INTACH also said that the Railways should consider running a new train from Baripada to Paralakhemundi connecting north and south Odisha. This will be a fitting tribute to two pioneers of the Railways in Odisha, Maharaja Goura Chandra Gajapati and Maharaja Sriram Chandra Bhanj Deo. This can be a heritage train which will traverse the length of Odisha touching the historic cities of Balasore, Cuttack, Bhubaneswar, Berhampur and others, the

organisation added. INTACH also suggested that the Paralakhemundi railway station should be included in the 'Ramayana Circuit'. "The Mahendragiri Hills, which are a bio-diver-

sity, heritage and pilgrim age site, have the nearest railhead at Paralakhemundi. The hills have some of the old est temples of India which find reference both in the Ramayana and Mahabharata," INTACH said.

"A train which may be called 'Mahendragiri Express' should run from Paralakhemundi and Ayodhya which will boost tourism and pilgrimage to the district," INTACH stated.

The 1899-built 'Royal Carriage' used by the Royalties of Paralakhemundi which is kept at the Narrow Gauge Railway Museum at Nagpur too should be brought back for display at the Station, the letter read.

"There are many other artefacts relating to the PLR, kept at the Nagpur Museum. These include signalling and electrical equipment, scales, uniforms, insignias, German silver cutlery, and royal embellishments. They should all be brought back," INTACH said. "The goods shed at Paralakhemundi station is a unique heritage structure which needs preservation," the letter further stated.

INTACH is also bringing out a pictorial book on the history and heritage of the 'Paralakimedi Light Railway' which will be released when the new Railway Station is inaugurated, Tripathy told mediapersons.

Joda mining: Government incurs losses worth crores

Non-implementation of statutory rules leads to closure of 59 mines

POST NEWS NETWORK

Joda, May 8: A total of 59 mines out of the 90 under Joda mining circle in Keonjhar district are lying closed due to a host of statutory regulations, sources have informed. As a result, both the Centre and the Odisha government are losing revenues worth several crores of rupees.

Moreover, the provision of separate rules for the payment of mining premiums has led to a decline in competition in the mining and industrial sectors. This has resulted in losses for the new leaseholders, experts pointed out.

According to information available from the Mining department, the 59 mines are lying closed due to delays in approval of a series of statutory regulations like the Forest Conservation Act, the Environment Clearance Act and the Plan of Indian Bureau of Mines (IBM).

The concerned ministries of the Union government give approval to these regulations on the recommendations of the state government. However, due to lack of proper



coordination between the Odisha government and the Centre and the absence of proper follow up by the leaseholders, 59 mines have failed to get approval for operation.

Among the 31 mines that are in operation in the Joda mining circle, 10 have been acquired through auction by the leaseholders after 2020. Over 874.84.000 lakh MT minerals have been mined in 2022-23 FY and 718.34,000 lakh MT minerals transported to various destinations. This has resulted in collection of ₹16,894 crore as revenue. However, had the other 59 mines been in operation, revenues could have gone up manifold.

The Odisha government and its allied bodies are not the only ones suffering from revenue losses, the collection of the National Minerals Exploration Trust (NMET) has also declined. On the other hand. leaseholders who got the mines through auction are paying higher premiums to run those. The leaseholders of the remaining 21 mines whose tenures are in force have been exempted from paying premiums. They are only paying rev-

enues and their share to DMF. When contacted, mine owner and scribe Sirish Chandra Mohanty said that the Centre should implement its 'One Nation, One Tax' rule which will usher in healthy competition and transparency in the mining and industrial sectors.

Art & Propaganda

There was a time when a debate raged over whether art should be created for art's sake or whether art should be used as a propaganda tool. The proponents of the former believed art should be free from attempts to send out any overt messages and it should be enjoyed for its intrinsic beauty and worth. Trying to apply it to real life situations and draw practical lessons from it would be limiting the scope of art. But, those who differed from this view of artistic creations were of the opinion that art would be meaningless if it is divorced from reality and is not used to illuminate socio-economic-political conditions of life. The two differing schools of thought on art were accepted as two approaches to man's artistic activities and everyone was free to subscribe to either of the two perceptions according to one's tastes and inclinations. The debate ended there without causing any storm or heartburn. In reality, however, that debate will never end for humanity.

Times keep changing. Art - making films in India in particular - is now being used not simply to reflect real life, but to be a slave to political masters to suit their interests of capturing power by influencing the electorate's mind with overt political messages. The BJP leadership realised about the grip the Bombay movie industry had on the average north Indian film goer that it just could not pass it up without tinkering with that icon of pop culture.

It happened late last year, when the film - The Kashmir Files - was used as a political propaganda to propagate the ruling dispensation's narrative on Jammu & Kashmir. This resulted in drawing sharp criticism from the head of the jury of the prestigious International Film Festival of Goa, the Israeli director Nadav Lapid. He lashed out at the authorities for including the film in the festival as he found it "vulgar" and without artistic merit. All the jury members, except one from India, countenanced the opinion of Lapid, saying he had only articulated the consensus reached by the jury. The only Indian member in the jury, Sudipto Sen, struck a jarring note by claiming that Lapid was speaking in his personal capacity and his criticism did not reflect the views of the jury. The other members, who had by then left the country, soon rallied behind Lapid and called Sen's bluff.

The same film director is once again at the centre of yet another controversy over a similar propaganda film of his making– The Kerala Story. The film too has received the seal of approval of the ruling dispensation. Ahead of the Karnataka Assembly Election, it has become a poll issue after Prime Minister Narendra Modi referred to the movie in his election speeches. BJP national president JP Nadda watched the movie in Karnataka and said the movie exposes a new kind of terrorism which involves no ammunition. "There is a new type of terrorism which is without ammunition. The Kerala Story exposes that poisonous terrorism," Nadda said.

Information and Broadcasting Minister Anurag Thakur said those who are opposing The Kerala Story are supporters of PFI and ISIS. The Madhya Pradesh government of the BJP has exempted the film from entertainment tax.

The PM, other ministers of his Cabinet and many BJP MPs had urged the whole nation to watch The Kashmir Files and the party-controlled state governments exempted that film from tax.

As it happened in the case of The Kashmir Files, The Kerala Story is similarly being accused of distorting facts to give a wrong picture of reality in Kerala so as to demonise the minority community and the BJP's opponents. The film puts incendiary dialogue in the mouth of a character - a woman ISIS activist radicalizing women - to abuse Hindoo gods and Jesus Christ and glorify Islam. The Kerala Story had initially also claimed that 33,000 women have been trained by the ISIS and thousands of Moslem women from Kerala were inducted into the ISIS. Later on that figure was reduced to a mere 3 in the YouTube promo of the movie. Kerala chief minister Pinarayi Vijayan called it a propaganda of the Sangh Parivar. Congress MP Shashi Tharoor said the claim that 33,000 women have been trained by the IS is

The teaser of the film used in its trailer with the claim of the fictitious number was dropped soon, lending credence to the political intent of the film. The question that arises at this stage is why the film director has had often to resort to lies and prevarication. He lied when he claimed Lapid's opinion on The Kashmir Files was his personal one which gave the government some breathing space to train its guns on the jury head. Interestingly, the Union Govt itself had chosen Lapid as the head of the Goa jury. Now, Sudipto Sen's movie gives unsubstantiated number of women in Kerala having been lured by the ISIS. The film itself deals with the cases of only three women from Kerala, while projecting Kerala to be a "powder keg" so far as ISIS activities are concerned.

The Supreme Court, in the meanwhile, has ordered the police forces of all states to start suo motu case against attempts to dish out hate speech to cause religious disaffection and vitiate communal harmony. It is to be pondered how films or any other so-called artistic work having potential to whip up communal sentiments should be dealt with in the coming days.

■ Hoodwink

he original sense of hoodwink was to prevent somebody seeing by covering their head with a hood or blindfolding them. Our main sense now is a figurative one derived from it, to deceive or trick (as we might also say, to pull the wool over someone's eyes), which appeared in the early seventeenth century. There's no problem with the first part, but wink here isn't in the sense we use now of closing and opening one eye quickly as a signal of some sort. When it first appeared, in Old English in the form wincian, it meant to close both eyes for some reason, or to blink, or close the eves in sleep (hence forty winks). A hoodwink forcibly lost somebody the power of sight as though they had closed their eyes. And hoodwink was long ago an alternative name for blind man's buff. When we say that somebody winks at some offence, meaning that they connive at it, we're also using a relic of the same sense. And long before wink became a flicker of one eyelid it meant a significant glance instead. If you find something written before the nineteenth century that says one person winked at another, a glance is what's meant - both indicate that the person is sending a message, but the method is slightly different. Today's meaning first appears in The Pickwick Papers by Charles Dickens, 1837: "Mr. Weller communicated this secret with great glee, and winked so indefatigably after doing so, that Sam began to think he must have got the 'tic doloureux' in his right eyelid.'



THE KARNATAKA PARADOX

SOCIAL INDICATORS AND HOW THEY ARE MOVING HAVE HARDLY BEEN DISCUSSED DURING THE CAMPAIGN THAT IS ROLLING ON **SUPERCHARGED BY A DIVISIVE AGENDA**

ithout delving into what the Karnataka elections hold and which way the wind will blow, it can be safely said that this is an election that has significance well beyond the immediate. In fact, rarely has a state election been as important for the nation as the one in Karnataka now. Most observers (irrespective of political leanings) would agree that the results of this election will carry significant implications for Indian politics into 2024 and beyond.

This is a place of privilege for the state and its electorate of over 52 million. It also places an enormous responsibility on the people of Karnakata, a state that has been a pioneer in science, technology and innovation. In popular Indian imagination, the state continues to be at the top in building new and modern tech-based solutions. The state has 42% of India's total of 95 unicorns. It has over 13,000 start-ups now. More than 40 years ago in this state was etched the story of Infosys that went on to showcase India as a global software services powerhouse, kickstarting (alongside TCS and others) a revolution that has over five million people in direct employment and many times that number indirectly. Infosys and its bestknown founder N R Narayana Murthy popularised messages of integrity and how a straight path can help build a long-term business. These stories have been told again and again in educational and business institutions across India. They marked a modern story of growth with values.

Every student in India knows these stories. They showcase Karnataka as a state that looks to the future and pushes ahead to meet the needs of a bold, modern, globalised India where Indians are not only the consumers but important suppliers of talent and ideas. It epitomised professional excellence, a spirit of service as well as resilience and humility.

Yet, this is also the state that

has hit the national headlines for other reasons, like the ugly controversy force-created by interested groups on whether girls can wear the hijab in colleges - the so-called hijab row. The pictures and utterances that emerged at the height of the controversy in February 2022 presented Karnataka in a less than favourable light, a state that was seen a recent increase in cases of communal violence. Last year, the state Home Minister Araga Jnanendra told the Assembly that the state had recorded 63 instances of communal violence since January 2019 (January 1, 2019 to February 15. 2022), with no convictions as of February 2022. This translated to one communal disturbance every 18 days in a little over three years.

The last days of a bitterly contested and important election are once against seeing the push towards a communal agenda, with the BJP putting its energies in defence of the Bairang Dal. Prime Minister Narendra Modi himself led with 'Bajrang Bali Ki Jai' and asked voters to chant the same as they cast their vote. It is clear that the veneer, if any, is gone and the appeal on religious grounds is as direct as it gets. One reason could be the BJP's worry that it is losing ground. It thinks that a dose of religion will help it sail through in the face of challenges like internal local area squabbles within the BJP and the Congress hammering away on the monumental corruption that has allegedly become the signature of the BJP rule in Karnataka. The BJP push back is on a point in the Congress manifesto that promises "decisive action as per the law including imposing a ban" on organisations like the Bajrang Dal and the PFI, which have been known to be spreading hatred.

Herein lies the paradox of Karnataka. The rest of educated India knows the state mostly through the stories of its tech leaders and the vibrancy of Bangalore, which has sometimes been voted as the top city to work for many and certainly for IT professionals. A visitor to Bangalore will note the energy and the frenetic pace that makes the city tick. People from across the country flock here, and grow their careers here. On the other hand, the state

has become a tinderbox of com munal strife. True, the politics of the state has changed, the BJP has taken power and grown roots but equally a section of the people has taken to the new and acerbic messaging that pits one against the other. The hijab row had political motivations but it also had to have people on the ground warming up to the message. While it is fair to argue that a lot of the strife is politically created, the headline mes saging is equally that the politics of Hindutva has entered the South, and Karnataka is its gateway.

In the process, the message of growth with values may be lost. In the absence of a robust political adoption and translation, that story has not seeped in. Today, headline growth is up but the story beneath the surface is different. The Economic Survey document of the state government noted that percapita Gross State Domestic Product (GSDP) of ₹3.05 lakh (estimated for FY22) is the highest among the top five Indian states Yet, other critical indicators have not kept up. For example, NFHS data show that Karnataka has fallen over the years in national ranking in terms of stunting in children (low height-for-age). Height-for-age is a measure of linear growth retardation and cumulative growth deficits. In Karnataka, 35.4% of children were stunted in 2019-21. According to a report, this ranked 24 out of the 30 States, falling three spots in 2019-21 from 2015-16. The point is that social indicators and how they are moving have hardly been discussed during the campaign that is rolling on supercharged by a divisive agenda.

The results will help navigate this complex territory. They will speak for now. In doing so, they will cast their long shadow on the 2024 national elections as well.

SPECTRUM CONSTITUTIONAL MONARCHY

Long live the kings & the queens

IN OUR ERA, THE **SYMBOLIC UNITY PROVIDED BY MONARCHY CAN LIMIT THE MOST PROBLEMATIC FORMS OF POPULISM**

is officially coronated, the "empire on which the sun never set" is looking a little shabby. In addition to the United Kingdom, 14 former British colonies still maintain Charles as their monarch and head of state, but many of his subjects around the world are reconsidering the arrangement.

Barbados became a republic in 2021, and Jamaica has initiated a similar process of constitutional reform. Others might soon follow. Why should countries from Belize to Tuvalu maintain as their nominal head of state an old white man living in a middling power far away from them?

Americans, of course, find it difficult to understand why anyone would accept hereditary rulers, or why a purely ceremonial office has any value. But constitutional monarchy is alive and well in some of the world's most developed countries. It should be jettisoned only after careful consideration of its significant benefits.

Start with what a constitutional monarchy is not: absolute monarchy, in which kings and queens actually exercise real power. Eight countries, mostly oil-rich states in the Middle East, remain absolute

Constitutional monarchies must also be distinguished from republics, in which the head of state is either elected by the people or by their representatives in parlia-

s Britain's King Charles III ment. Heads of state in republics serve only for a limited term. whereas a monarch typically holds the job for life.

So defined, constitutional monarchy is not a rare phenomenon: there are currently 34, representing 18% of the roughly 193 independent countries. These are an extraordinarily successful set of countries by any standard, including most of Scandinavia, Japan, and the Benelux countries, as well as Charles' domains of Australia. Canada, and New Zealand.

According to the Economist Intelligence Unit Democracy Index 2022, ten of the world's top 20 democracies are constitutional monarchies, as are nine of the 20 richest countries. And eight of the ten most enduring national constitutions provide for a monarch.

The surviving monarchies have done so mostly because, over a long period of time, they yielded power to legislative assemblies elected by the people. This process of political reform started with Magna Carta in England, and played out in the nineteenth century in most other countries.

When monarchs resisted encroachments on their power, they usually lost their thrones - and sometimes their heads. When they yielded, they became figureheads, but also signaled to conservatives that their interests were secure.

Monarchs also provide a form of political insurance, being able to step

in during periods of national crisis. A famous example is King Juan Carlos I of Spain, who helped thwart a coup d'état launched in his name in 1981. He went on television and ordered the armed forces to return to their barracks, even as he was communicating individually with key generals, which helped prevent them from coordinating among Some supposedly constitutional

monarchs, however, have been known to abet coups against their own governments. Instead of act ing like King Juan Carlos to undermine military coup-makers, Thailand's King Bhumibol Adulvadei assented to ten coups during his 70-year reign. And Queen Elizabeth's representative in Australia, Sir John Kerr, provoked a constitutional crisis when he ordered the removal of the elected prime minister. Gough Whitlam, in 1975.

In their role in investing governments in parliamentary systems, monarchs can sometimes make subtle decisions that help political parties overcome deadlocks. In other crises, the monarch can act as a focal point for national resistance to invaders. During World War II, Norway's King Haakon VII refused to recognise the government of the Nazi collaborator Vidkun Quisling, instead choosing to leave his country for the duration of the war. Monarchs can also protect miwhom they alone can protect from the elites, and demonise their opponents as "enemies of the people." Such claims, however, are ineffective under a constitutional monarchy. As Jamaicans and others consider whether to join Prince Harry in leaving the Crown behind, they

would do well to consider why constitutional monarchy has remained so successful in the twenty-first century. King Charles might appear to be the vestige of an archaic system, and no doubt his realm will shrink in the coming years. But it will not disappear, and for his remaining subjects that may be a very good thing.

Highway hypnosis





Israeli minister to visit India

New Delhi: Israeli Foreign Minister Eli Cohen will begin a three-day visit to India Tuesday to explore ways to expand bilateral ties and prepare ground for Prime Minister Benjamin Netanyahu's trip to New Delhi this year. Five cheetahs to be released in KNP

New Delhi: Five cheetahs three females and two males will be released from the acclimatisation camps into free-ranging conditions in Madhya Pradesh's Kuno National Park (KNP) before the onset of the monsoon in June, the Union Environment Ministry said Monday. Animals are generally not released into the wild during the monsoon season as harsh weather conditions make it difficult for them to find food and shelter and adapt to their new environment. The ministry also said the cheetahs will be allowed to move out of KNP and will not necessarily be "recaptured unless they venture into areas where they are in significant danger".

Woman arrested

Aizawl: A 37-year-old woman was arrested with heroin worth ₹1.5 crore in Aizawl, the Assam Rifles said Monday. The arrest was made in a joint operation by the Assam Rifles, Mizoram Police and Central Young Mizo Association (CYMA) in Bawngkawn area on Saturday, it said.

Bangalore/New Delhi, May 8: As the row over Karnataka's "sovereignty" remark escalated with the BJP on Monday moving the Election Commission seeking an FIR against Sonia Gandhi and her party's derecognition, the poll panel asked the Congress to clarify and rectify the party's social media post attributed to Sonia Gandhi.

The EC sent a letter to Congress chief Mallikarjun Kharge after the BJP complaint regarding a tweet that appeared on the official Twitter handle of the Indian National Congress on May 6. In its complaint, the BJP has alleged, "Karnataka is a very important member state in the Union of India and any call to protect the sovereignty of a member state of the Union of India amounts to a call for secession and is fraught with perilous & pernicious consequences.'

The BJP also alleged in its complaint to the EC that the tweet is violative of the mandatory oath undertaken by the political parties under section 29A (5) of the Representation of the People Act, 1951 at the time of registration.

"In view of the above, you are requested to clarify and take rectification measures in respect of the social media post which has been put up on the INC Twitter handle and attributed to Chairperson, CPP," the EC letter read. A former Congress chief, Sonia Gandhi is currently

Sisodia's judicial custody extended

New Delhi, May 8: A Delhi court Monday extended till May 23 the judicial custody of former deputy chief minister Manish Sisodia in a money laundering case related to the alleged excise scam.

Special Judge M K Nagpal extended the custody of the AAP leader after he was produced before the court on expiry of his judicial custody granted earlier.



The court noted the submission of the Enforcement Directorate's Special Public Prosecutor N K Matta, who submitted that the agency has filed a supplementary charge sheet against the accused, which is scheduled for consideration on May 10.

The court had earlier dismissed Sisodia's bail plea, saying "the case of economic offences has serious repercussions upon the general public and society at large as the evidence collected during investigation speaks volumes of his involvement in the commission of the said offence"

The ED on March 9 arrested Sisodia in the liquor policy case. Sisodia was arrested by the CBI earlier in its ongoing investigation of a case related to alleged irregularities in the framing and implementation of the Delhi Excise Policy 2021-22.

He is currently in judicial custody in both cases.

On the last day of the campaign for the May 10 assembly elections in Karnataka, Surjewala said Prime Minister Narendra Modi should speak out on corruption charges against his party's government and added that excuses cannot be the refuge of the BJP in this

"We reject the fakery and falsehood being perpetuated by PM as he refuses to answer a single question on why BJP is denigrating the 'swabhimaan' of Karnataka,' the Congress leader said when asked about the BJP's charge on "sovereignty" remark.

Another blast near Golden Temple

Amritsar, May 8: A low-intensity explosion occurred Monday on a heritage street near the Golden Temple here, the second in the area in less than 30 hours, prompting authorities to further step up

One person was injured in the blast that took place 6.15 am on the road that is dotted with shops and food joints and witnesses heavy footfall every day. Forensic teams reached the spot soon after the explosion and police held a flag march as additional security personnel were deployed in the area.

No detonator has been found and it appears that the explosive was kept in a container, Director General of Police (DGP) Gauray Yaday said, adding it is too early to say whether the blast was someone's "mischief" or there's a terror angle to it. Yaday, who visited and inspected the spot, said one person was injured in the explosion.

The explosive was very crudely made and assembled. Though no shrapnel was used, there was a



chief said two explosions in the area are being "scientifically investigated". "Our forensic team is present on the spot," he said."We have not found any triggering device or any detonator." Yaday said referring to the two incidents.

The DGP said the absence of a triggering mechanism means it was a crude device. It appears that the explosive was kept in a container and a thread was hanging out of it and a passerby may have accidentally pulled the thread and the device fell, caus-

"At this moment, we are not ruling out anything...It could be someone's mischief, but it is too early to say whether it is a mischief, or there is a terror

angle to it," he said, referring to the two incidents. Yadav said the purpose by any mischief monger could also be to disturb the peaceful atmosphere of the state. But all these things are being investigated, he added. The DGP said CCTV footage is being scanned and details are being sought from evewitnesses



New Delhi, May 8: More than 2.7 crore passengers could not travel by train in 2022-23 despite buying tickets because of being waitlisted according to the response to an RTI query, indicating shortage of trains on busy routes in the country.

During the last fiscal year, this number stood at 1.65 crore. According to a reply to an RTI plea filed by Madhya Pradeshbased activist Chandra Shekhar Gaur, the Railway Board said that in 2022-2023, a total of 1.76 crore

Passenger Name Record (PNR) numbers, against which 2.72 crore passengers were scheduled to travel, were automatically cancelled due to being waitlisted.

In 2021-2022, a total of 1.06 crore PNR numbers, against which 1.65 crore passengers were scheduled to travel, were automatically cancelled. After cancellation of PNRs. the ticket fare is refunded to the passengers. The inability to provide confirmed tickets to passengers has been a recurrent problem with the national transporter.

In 2014-15, the number of cancelled PNRs stood at 1.13 crore,

14 Haryana villages new hotspots of cyber fraudsters

Gurugram, May 8: Fourteen villages in Haryana's Nuh district are emerging as new hotspots of cybercrime, and mostly the youths there are indulging in the crime by using stolen high-end mobile

This was disclosed by the police after questioning 125 cybercriminals, who were apprehended by as many as 102 teams comprising over 5.000 police personnel. The raids were conducted in 300 locations in the 14 villages April 27.

The police raided the 14 iden tified villages in the Pinangwa, Punhana, Ferozepur Jhirka, Nai, Aminabad, Tirwara, Jaimat and Bichhore areas. The police had earlier identified Khedla, Luhinga

Khurd, Luhinga Kalan, Gokalpur, Godhola, Aminabad, Mahu, Gulalta, Jaimat, Jakhopur, Nai, Tirwara, Mamlika and Papda as cybercrime hotspots.

The police said the accused cheated people on the name of selling vehicles on OLX, seeking KYC data, offering loans and even sextortion.

A senior police officer said earlier illiterate youths, who were involved in vehicle theft, phone snatching, cattle smuggling and other crimes, have shifted to cybercrime in the past two years after being



Take security, relief measures, says SC

SC refuses plea by jailed YouTuber PRESS TRUST OF INDIA

New Delhi, May 8: In a setback to jailed Bihar YouTuber Manish Kashyap, the Supreme Court on Monday refused to entertain his plea challenging invocation of the stringent National Security Act (NSA) against him for allegedly circulating fake videos of migrant labourers being attacked in Tamil Nadu.

You have a stable state, the state of Tamil Nadu. Can you circulate anything and create disguiet in the state. We cannot be lending our ears to all this," a bench headed by Chief Justice DY Chandrachud said.

The bench, also comprising justices P S Narasimha and J B Pardiwala, however, granted Kashyap the liberty to challenge the invocation of the NSA at an appropriate judicial forum preferably in the high court. It also rejected the plea for clubbing all 19 FIR's against him and their transfer to Bihar.

'We are not inclined to entertain the plea," the bench said while rejecting the vehement submissions of senior advocate Maninder Singh, appearing for Kashvap who is presently lodged in Madurai jail of Tamil Nadu. Refusing to quash Kashyap's detention under the NSA, the bench said it cannot be hearing this kind of petition.

The counsel for Kashyap said the accused had made the alleged videos for his YouTube channel based on media reports published in certain newspapers.



Fire in gold mine kills at least 27

Lima: A fire broke out deep in a gold mine in southern Peru and killed at least 27 workers during an overnight shift. Peruvian authorities reported. The Yanaquihua mining company said in a statement that a total of 175 workers had been safely evacuated after the accident, which happened late Friday or early Saturday. It said the 27 dead worked for a contractor that specializes in mining. Government officials said the cause of the incident was under investigation. Russia attacks Ukraine with huge drone swarm

Kyiv, May 8: Russia launched its biggest swarm of drones for months against Ukraine Monday, the eve of Russia's May 9 holiday celebrating the defeat of Nazi Germany, which Kyiv marked a day earlier in a symbolic new break with Moscow.

Kyiv's mayor said Russia had fired 60 Iranian-made kamikaze drones at Ukrainian targets, including 36 at the capital, all of which had been shot down. Debris hit apartments and other buildings, injuring at least five people in the capital.

A food warehouse was set ablaze by a missile in the Black Sea city of Odesa, where officials reported three people were injured.

It was the biggest drone swarm yet in a renewed Russian air campaign unleashed 10 days ago after a lull since early March.

The German army's 1945 surrender took effect late at night May 8 in Berlin, when it was already May 9 in Moscow, the date that became the Soviet holiday.

Russia foreign ministry spokeswoman Maria Zakharova said that by changing the date, Zelenskyy had betrayed the memory of Ukrainians who fought the Nazis.

"What is worse than an enemy? A traitor. That is Zelenskyy, the embodiment of Judas in the 21st century," she said.

Coronation celebrations conclude with 'Big Help Out' volunteering



IRAN HANGS TWO MEN IN BLASPHEMY CASE

Dubai, May 8: Iran hanged two men Monday convicted of blasphemy, authorities said, carrying out rare death sentences for the crime as executions surge across the Islamic Republic following months of unrest.

The two men executed, Yousef Mehrad and Sadrollah Fazeli Zare, died at Arak Prison in central Iran. They had been arrested in May 2020, accused of being involved in a channel on the Telegram message app called "Critique of Superstition and Religion," according to the US Commission on International Religious Freedom, Both men faced months of solitary confinement and could not contact their fami-

lies, the commission said. The Mizan news agency of Iran's judiciary confirmed the executions, describing the two men as having insulted Islam's Prophet Muhammad and promoted atheism.

Mizan also accused them of burning a Quran, Islam's holy book, though it wasn't clear whether the men allegedly did that or such imagery

was shared in the Telegram channel. Mahmood Amiry-Moghaddam, who leads Iran Human Rights, decried the executions as exposing the "medieval nature" of Iran's

Already, at least four people $charged\ over\ alleged\ crimes\ from$ the demonstrations have been put to death. The protests, which reportedly saw over 500 people killed and 19,000 others arrested, marked one of the biggest challenges to-Iran's theocracy since the 1979 Islamic Revolution.

New Delhi: The deal activity in the global technology services sector has softened, with over 150 transactions announced in the first quarter of 2023 compared to 270-plus deals in Q1 2022 and over 220 in the first quarter of 2021. according to an EY-Nasscom report. The report - Mergers and Acquisitions (M&A) Trends and Outlook in the technology services sector noted that in 2022, the technology service sector proved to be a year of paradoxes. Despite signs of a slowdown at the end of the year and in Q1 CY23, the technology service sector witnessed a surge in M&A and private equity deals, reaching a total of over \$57 billion in 2022, which was more than double the amount seen in 2020 (at over \$27 billion).

Pound hits over one-year high

Singapore: Sterling hit an over one-year high against the dollar Monday as the greenback began the week under pressure, with traders betting it might have peaked along with US interest rates while keeping a wary eye on looming inflation and loans data. The pound poked its head as high as \$1.2668, its highest since April 2022, and was last trading a touch below that, up 0.26% on the day. Unclaimed bank Recovery hits turbulence

Lessors seek deregistration of 36 Go First aircrafts

Mumbai, May 8: In less than week of cash-strapped Go First cancelling all its flights, lessors have sought deregistration of a total of 36 planes with requests coming for taking back 13 more aircraft Monday.

With the National Company Law Tribunal (NCLT) yet to pronounce its verdict on Go First's petition seeking voluntary insolvency resolution proceedings, the airline on Monday requested the tribunal for an early decision saying lessors have started deregistering aircraft.

The tribunal agreed to look into Go First's request.

Lessors have approached the Directorate General of Civil Aviation (DGCA) to deregister another 13 aircraft of Go First, as per an update with the regulator Monday. Earlier, lessors applied for deregistration of Go First's 23 planes.

On May 2, also the day when the Wadia group-owned airline filed for voluntary insolvency resolution proceedings, its Chief Executive Officer Kaushik Khona told PTI that of the total 55 aircraft in its fleet, provisions of the Aircraft Rules, 1937, for its failure to continue the operation of the service in a safe. efficient and reliable manner, according to a source. The DGCA has asked the carrier to submit its reply within 15 days of the receipt of the show cause notice, and further, a decision



New Delhi, May 8: Russian investors are flocking to Indian capital markets with three entities in Russia having registered with Sebi as foreign portfolio investors (FPIs) amid sanctions imposed on the nation in response to the war against

All the three investors which obtained FPI licence from Sebi are based in Moscow. Alfa Capital Management Company is registered in both category-1 and category 11. Besides, one individual Vsevolod Rozanov has been registered in category-1, latest data with the National Securities Depositories showed.

Further, the licence issued to them is valid for three years till early



2026, it added. Experts believe that Russian in-

vestors are exploring Indian markets in the wake of sanctions imposed on the country by the US and European Union following Russia's invasion of Ukraine in February 2022.

VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said the sanctions imposed on Russia, particularly the weaponization of the dollar, has led to new economic and financial developments

Alternatives to the dollar as reserve currency are being seriously

debated. Russian investors- individuals and institutions-looking to invest in the Indian capital market have to be seen in this context, he explained. Further, he believes that geographical diversification is good for India too.

"With a sharp increase in India's crude oil imports from Russia, Russia's bilateral trade surplus with India has increased significantly. There is little opportunity for Russia to increase its imports of Indian goods and services to utilise this balance fully."

India could range from \$20-30 billion indicating that Russian portfolio investments in India may be substantial in the near future.

Apart from Russia, there are at least 16 China-based institutions that have got permanent registration as FPIs in India. Besides, there are 217 Hong Kong-based entities registered as FPIs in India and 124 from Taiwan, the data showed.

In terms of numbers, the US has the largest number of registered FPIs (3,485) followed by Luxembourg (1,353), Canada (825), Ireland (738), the UK (684), Mauritius (589) and Singapore (567).

Together, these ten countries account for 83 per cent of the overall asset under custody of FPIs of ₹50.85 lakh crore.

It was a complete 'RRR' show by KKR as skipper Nitish Rana's half century (51, 38b, 6x4, 1x6) and Andre Russell adding muscle (42, 23b, 3x4, 3x6) to the chase of 180 enabled Rinku to finish off the game.

Earlier, Varun Chakravarthy (3/26) once again brilliantly spearheaded their bowling department as KKR put up a tidy bowling show to restrict PBKS to a below-par 179/7 after the visitors opted to bat on a slow wicket.

In reply, KKR show batting show was led by Rana's stellar effort when he promoted himself to No.3 and laid the foundation. On a wicket where the odd ball was gripping and batters struggled to find their timings, Rana stiched a crucial fiftyplus stand with Venkatesh Iyer (11) before Russell and Rinku Singh sealed the issue.

Needing 56 off 28 balls after Rana became Rahul Chahar's (2/23) second victim, Russell went ballistic against Sam Curran smoking him for three sixes in four balls in a 20-run over to change the equation in favour of KKR who needed six off the last over.

But death over specialist Arshdeep Singh who had six to defend took it down the wire with four off first four balls. Arshdeep has often floundered of late failing to nail his vorkers.

There was more drama when Russell was ran out in the penultimate ball as a calm-headed Rinku once again came to KKR's rescue sealing the win with a boundary off the last ball. The duo off Russell and Rinku put together 54 runs off just

Their second win in a row pushed KKR (-0.079) past Royal Challengers Bangalore (-0.209) to top-five on net run-rate as five teams are locked a mid table rush for playoff with 10

Skipper Shikhar Dhawan (57, 47b, 9x4, 1x6) anchored the show in a Virat Kohli-like innings the other day against Delhi Capitals but the lefthander could never take off and was dismissed by Rana. Dhawan put together 53 runs partnership with Jitesh (21).

Rana smartly bowled Chakravarthy once inside the powerplay and then in the 8th, 13th and 17th over as he finished his quota, cleaning up Rishi Dhawan with a wrong one. Rishi (19) had his intention clear smashing Chakravarthy for a six in the first ball, but the KKR spinner had the last laugh.

Mumbai, May 8: With the race for playoffs intensifying, captain Rohit Sharma's form with the bat and bowling in the death overs will be a huge concern for hosts Mumbai Indians when they meet Royal Challengers Bangalore in a midtable IPL clash here Tuesday.

With 184 runs in 10 matches at a forgettable average of 18.39 and a solitary half-century, Sharma is enduring a second consecutive poor season with the bat. For the sixth-placed Mumbai Indians to move up in the points table, it is imperative that their best batter in the line-up fires.

Sharma's role in this IPL has been to provide brisk starts at the top, and at times he has had some success too, but consistency has deserted the right-arm batter whose early dismissal in huge chases has only added pressure on a relatively new batting line-up, which fortunately, from MI's point of view, has delivered too.

Mumbai Indians' head coach Mark Boucher admitted a few games ago that consistency could get compromised if any batter goes out of his way to look for runs, but for Sharma, one of the highest run-getters in the IPL, it is becoming a pattern.

However, with Sharma not firing at the top, MI have had the likes of Ishan Kishan, Suryakumar Yadav and Cameron Green consolidating in the middle while Tilak Varma and Tim David have also found their groove as finishers late in

At the same time, Mumbai



having conceded four consecutive totals in excess of 200 while bowling first, two of which were recorded on flat decks here at the Wankhede Stadium.

Miami Gardens (Florida), May 8: Max Verstappen used an easy drive to keep Red Bull undefeated on the season, as the reigning twotime Formula One champion drove from ninth to the victory at the Miami Grand Prix.

Red Bull has won all five races so far this season, and teammate Sergio Perez's second-place finish in Miami was the fourth 1-2 finish for Red Bull this year. Verstappen has three wins this season, while Perez, the pole sitter in Miami,

The win was the 38th of his career for Verstappen, who tied Sebastian Vettel for most victories for Red Bull. At this pace, he'll smash Vettel's record by the end of what many critics are already complaining is a boring Red Bull-dominated season.

Red Bull boss Christian Horner praised Verstappen's poise over the 57-lap race that gave him his second consecutive victory in Miami. Red Bull has said it will allow Verstappen and Perez to cleanly race for the championship, and Perez seemed poised to take the points lead in Miami by starting from the pole.

Verstappen held a six-point lead in the standings over Perez at the start of the race, but was relegated to a ninth-place starting position because qualifying was cut short before his final qualifying attempt by a Charles Leclerc crash.

But the Dutchman had no problem driving through the field. He went from ninth to sixth in the first four laps, using a pass of two cars in one corner to gain ground. He was fifth by the ninth lap, fourth on Lap 12 and finally behind Perez

Verstappen took the lead when Perez pitted on Lap 20 and he held nearly a 18-second lead with 15 laps remaining. When he finally made his pit stop, Verstappen returned to the track in second but only 1.6 seconds behind Perez.

It took him just minutes to pass Perez for the win, taking the lead in a wheel-to-wheel battle with nine laps remaining. Although Verstappen has won from a lower starting position before, he becomes the first driver since Niki Lauda in 1984 at the French Grand Prix to win from ninth.

The victory also came on the anniversary of the 2016 announcement that Verstappen was being promoted from the junior team to Red Bull ahead of the fifth round of that season.

Verstappen now holds a 14-point lead over Perez in the standings. Perez finished second, a full 5.3 seconds behind Verstappen. Fernando Alonso was third for Aston Martin but finished 26 seconds behind. It was the fourth podium in five races for the resurgent Spaniard.
