

CBSE results may come today


Bhubaneswar: The Central Board of Secondary Education (CBSE) is expected to announce the results of Class-X and Class-XII board examinations shortly. In fact, some sources said Thursday that the results will be declared Friday. CBSE will upload the results on its official websites *cbse.gov.in* and *results* cbse.gov.in. Other than the official website, the students can also access their results through the 'UMANG App' and 'Digilocker'. Officials said a total 1.17 lakh students from the three states of Odisha, Jharkhand and Chhattisgarh had appeared for the Class-X exams while 93,726 students had registered for Class-XII exams this year.

Maoists murder former sarpanch in Kandhamal

Phulbani: A tribal leader was shot dead allegedly late Wednesday night by Maoists in Kandhamal district, police said Thursday. The murder happened in Saulipada village, they informed. The deceased, identified as Subal Kanhar, was a former sarpanch, said Tapan Kumar Nahak, the IIC of Phiringia police station. A group of 10 armed Maoists stormed the village and barged into Kanhar's house. They dragged Kanhar to the outskirts of the village where they shot him dead, police sources said. The Maoists suspected that Kanhar was working as a police informer, they added.

Shinde wins Sena battle

Despite asking his bête noire Shinde to resign on moral grounds, it is the second bitter blow for Uddhav Thackeray and his faction having lost the Sena bow and arrow symbol earlier.

New Delhi, May 11: What started as an intense political fight between Shiv Sena patriarch Uddhav Thackeray and his former party colleague Eknath Shinde ended in a victory of sorts for the latter Thursday, The Supreme Court said Shinde will continue as the Chief Minister of Maharashtra and added that it cannot restore the then Maha Vikas Aghadi (MVA) government led by Uddhav as he resigned without facing a floor test in June last year. Yes, the court did pull up former Maharashtra Governor Bhagat Singh Koshyari and said he did not have reasons based on objective material before him to arrive at the conclusion that former chief minister Thackeray had lost the confidence of the House. However, it did not matter much to Shinde or to his deputy Devendra Fadnavis, both of who expressed 'satisfaction' at the apex court's decision In a unanimous verdict on a batch of pleas related to the political crisis that led to the fall of the three-party MVA government following a revolt by the Shinde faction in the Shiv Sena, a five-judge Constitution bench headed by Chief Justice DY Chandrachud held that the then Speaker's decision to appoint Bharat Gogawale of the Shinde faction as the Whip of the

Shiv Sena in the Maharashtra Assembly was 'contrary to law'. However, all those observations were overshadowed as the Supreme Court allowed the Shinde-led government to continue. The bench said, "The governor

was not justified in calling upon Mr Thackeray to prove his majority on the floor of the House because he did not have reasons based on objective material before him to reach the conclusion that Mr Thackeray had lost the confidence of the House. However, the status quo ante cannot be restored because Mr Thackeray did not face the floor test and tendered his resignation."

The bench, also comprising Justices MR Shah, Krishna Murari, Hima Kohli and PS Narasimha, said, "The political imbroglio in Maharashtra arose as a result of

party differences within the Shiv Sena. However, the floor test cannot be used as a medium to resolve internal party disputes or intraparty disputes. Also neither the Constitution nor the laws enacted by Parliament empower the governor to enter the political arena and play a role (however minute) either in inter-party disputes or in intra-party disputes."

However, Justice Chandrachud, who wrote the 141-page verdict on

a five-judge constitution bench headed by Chief Justice DY Chandrachud, said the Union Territory of Delhi has 'sui generis (unique) character' and refused to agree with the 2019 judgement of Justice Ashok Bhushan that the Delhi government has no power over the issue of services. **P7**

'The post of Chief Minister of the state of Maharashtra fell vacant after the resignation of Mr Thackeray June 29, 2022. Patnaik informed Modi that the site clearance for Puri airport from the Ministry of Civil Aviation is pending since September, 2022 and requested that the same may be expedited.

"I have just met the PM. The topic of discussion was mainly about Odisha's demands which include an international airport in Puri. We have already outlined the boundary of the proposed airport in Puri," the CM said.

During the meeting which lasted 15 minutes, Patnaik requested for the completion of eight national highway projects which were started in 2017-18 in Odisha. He also demanded opening of more bank branches in around 3,954 gram panchayats of the state.

Imran's arrest illegal, release immediately, says Pakistan SC

Islamabad, May 11: In a major relief for Imran Khan, Pakistan's Supreme Court declared Thursday the former prime minister's arrest 'illegal' and ordered his immediate release after he was produced before a bench on its orders. A threemember bench, comprising Chief Justice Umar Ata Bandial, Justice Muhammad Ali Mazhar and Justice Athar Minallah, issued the verdict while hearing a petition against

his arrest from the Islamabad High Court premises Tuesday The bench, while hearing the Pakistan Tehreek-e-Insaf chairman's plea against his arrest in the Al-Qadir Trust case, expressed anger at the way he was taken into custody by paramilitary Rangers and ordered the National Accountability Bureau (NAB) to produce him before it at 4.30pm (local time).

Khan was brought to the court in heavy security. As he entered the courtroom, it was closed, and subsequently, the bench resumed the hearing of the case. "It is good to see you," Chief Justice Bandial told Khan. After a brief hearing, the court declared that Khan's arrest was 'illegal' and of no consequence and ordered that he should be set free

immediately The court also directed him to go to the Islamabad High Court (IHC) and seek further legal recourse Friday. "You will have to accept whatever the high court decides," the top judge said.

During the hearing, Khan told the court that he was 'kidnapped from the court' when he was preparing for the biometric attendance before filing an appeal in a case. Khan claimed he was subjected to violence, saying that he had been beaten with clubs



Bhubaneswar, May 11: Odisha continued to reel under intense heat as at least 16 stations recorded temperatures above 40 degrees Celsius, and of those places, six saw temperatures above 42 degrees Celsius Thursday.

With the India Meteorological Department (IMD) predicting a further rise in temperature in 23 of the 30 districts in the state, Special Relief Commissioner (SRC) Satyabrata Sahu reviewed the situation and asked the authorities to remain prepared.

79.21% VOTER TURNOUT IN JHARSUGUDA BYPOLL

Bhubaneswar, May 11: A total of 79.21 per cent of 2.21 lakh voters exercised their franchise in the bypoll held for the Jharsuguda Assembly segment Wednesday, an election official said here Thursday.

Odisha prohibits use of crates in pig farming

Bhubaneswar, May 11: The State Animal Welfare Board (SAWB) has asked the chief district veterinary officers (CDVOs) to ensure that no pig farms use gestation and farrowing crates in farming.

Following an appeal by People for the Ethical Treatment of Animals (PETA), India, and other rights groups to prohibit the manufacture, sale, and use of these restrictive crates in pig farming, the SAWB joint director has asked all CDVOs to prohibit the sale and use of crates in pig farms in compliance with the Prevention of Cruelty to Animals Act, 1960. According to the SAWB, stringent action will be taken against any pig farm using crates through an

action-taken report (ATR) submitted to the director of Animal Husbandry and Veterinary Servicescum-member secretary of the SAWB.

The circular cites Section 11(1)(e)of The Prevention of Cruelty to Animals Act, 1960, which prohibits the confinement of any animal to a receptacle that fails to offer a reasonable opportunity for movement, such as gestation and farrowing crates

"Confining animals in this way

is illegal, a position that has been confirmed by the Indian Council of Agricultural Research's National Research Centre on Pig, which is reiterated here in the circular," said a government official.

Odisha is the latest of 21 states and union territories to issue directions against keeping pigs in these contraptions. Other governments that have issued circulars include Andhra Pradesh, Assam, Chhattisgarh, Delhi, Goa, Gujarat, Himachal Pradesh, Karnataka, Madhya Pradesh, Maharashtra, Manipur, Meghalaya, Mizoram, Punjab, Rajasthan, Sikkim, Telangana, Uttarakhand, Uttar

Pradesh, and West Bengal. "PETA India commends Odisha for standing up for countless pigs and vowing to take action against

violators who subject mother pigs to the severe cruelty of crates,' says PETA India advocacy officer Farhat Ul Ain.

Gestation crates (aka 'sow stalls') are metal cages, essentially the size of a pig, with concrete or slatted floors. These devices confine pregnant sows, who are typically transferred to farrowing crates to give birth and are kept in them until their piglets are taken away. These crates suffocate the animals and are often described as inhumane.

57% of all fraud incidents in India are 'platform' frauds

ore than half of all fraud incidents in India were 'platform' fraud, a novel form of economic crime that involves fraudulent activities associated with social media, e-commerce, enterprise and finTech platforms, said a PwC India report Thursday.

The onset of the pandemic has led to an increase in platform fraud, said the second edition of PwC's Global Economic Crime and Fraud Survey 2022 India Insights, titled 'Platforms The new frontier of fraud in India'.

The surge in remote work, e-commerce, delivery applications and contactless payments has further contributed to the rise of this type of fraud. 57 per cent of all fraud incidents in India were platform fraud, it said.

It further said more than 26 per cent of Indian organisations lost over USD 1 million due to platform fraud, and 44 per cent of the perpetrators were found to commit fraud for financial gain.

PwC said it surveyed 111 organisations across India from diverse industries such as technology, financial services, banking and capital markets, consumer products and retail, education, and healthcare.

Puneet Garkhel, Partner and Leader, Forensics Services, PwC India, said Indian consumers and organisations have been rapidly

embracing new platforms over the past few vears.

On average, an Indian company operates with five different platforms as part of its regular business activities today. The emergence of and surge in e-commerce, contactless payments, home delivery models, remote working, etc., have not only led to various platform-based innovations but also opened avenues of entry for fraudsters, he said.

Organisations need to be cognizant of these evolving threats and adequately invest in fraud prevention and detection strategies to safeguard themselves, Garkhel added.

The report said four out of every 10 platform frauds in India were conducted by internal perpetrators.

Moreover, 26 per cent of platform frauds involved collusion between internal actors and external perpetrators, it said, and added that this implies that if companies have stronger internal controls in place, over two-thirds of all platform frauds can be mitigated.

As per the report, financial frauds on transactions made to or from platforms accounted for 89 per cent of all platform frauds. These frauds vary from basic unauthorised digital purchases to more complex identity theft and triangulation fraud. IANS

Sleep apnoea linked to deteriorating brain health Cracker explosion sparks fire at govt guarter in City

aving sleep apnoea and spending less time in deep sleep has been linked to developing brain biomarkers associated with an increased risk of stroke, Alzheimer's disease and cognitive decline, according to a new research.

Researchers involved in the study said that it did not prove these sleep disturbances to cause the changes in the brain, or vice versa, but only that there was an association.

They have published their study in the journal Neurology.

The study looked at sleep factors and biomarkers measuring of the health of the brain's white matter, which is important to connect different parts of the brain.

One of the biomarkers, white matter hyperintensities, is tiny lesions visible on brain scans. White matter hyperintensities become more common with age or with uncontrolled high blood pressure. The other biomarker measures the integrity of the axons, which form the nerve fibers that connect nerve cells.

"These biomarkers are sensitive signs of early cerebrovascular disease," said study author Diego Z. Carvalho, of the Mayo Clinic in Rochester, Minnesota, and a member of the American Academy of Neurology

"Finding that severe sleep apnea and a reduction in slow-wave sleep are associated with these biomarkers is important since there is no treatment for these changes in the brain, so we need to find ways to prevent them from happening or getting worse," said

Carvalho. The researchers studied 140 people with obstructive sleep apnea with an average age of 73 who had a brain scan and also an overnight study in a sleep lab. The participants



cent had severe sleep apnea.

The sleep study examined the time people spent in slow-wave sleep, which is also called non-REM stage 3, or deep sleep, and considered one of the best markers of sleep quality. The researchers found that for every 10-point decrease in the percentage of slowwave sleep, there was an increase in the amount of white matter hyperintensities similar to the effect of being 2.3 years older.

The same decrease was also associated with reduced axonal integrity similar to the effect of being three years older.

People with severe sleep apnea had a higher volume of white matter hyperintensities than those with mild or moderate sleep apnea. They also had reduced axonal integrity in the brain.

'More research is needed to determine whether sleep issues affect these brain biomarkers or vice versa," Carvalho said. "We also need to look at whether strategies to improve sleep quality or treatment of sleep apnea can affect the trajectory of these biomarkers. PTI

Development has taken a backseat in this village identified as Pidhapokhari under Kalimati panchayat of the block. It is alleged that the village has been missing the development goals due to government apathy and neglect. In this village, the majority of the residents live below the poverty line despite being placed at only 25 km distance from the block headquarters and eight km from the panchayat headquarters.

The incident came to light after reports highlighted the plight of malnourished children in another village under Joda Mining area. The district administration had intervened then and admitted the children in nutrition resources centre (NRC) at Barbil in Keonjhar district.

NHRC seeks ATR on death of pregnant minor girl student

Kendrapara, May 11: The National Human Rights Commission (NHRC) has sought for an Action Taken Report from Gajapati District Collector and the Superintendent of Police on the death of a pregnant minor student in the district.

The apex rights body sought the ATR May 9 after human rights activist Radhakant Tripathy moved the NHRC alleging that one minor Dalit girl, studying in Class VIII of Jhirjira Ashram School run by the ST/SC Development department in Gajapati district, died due to medical negligence May 6 last while undergoing treatment at the District Headquarter Hospital. Tripathy said the victim girl



was found four months pregnant. It is alleged that the school authorities did not inform the parents about

her pregnancy earlier. Tripathy contended that the death of a pregnant student in the present case poses serious questions of violation of human rights. He sought intervention of the Commission inter-alia for legal action against the wrong doers, compensation to the bereaved family and proper counselling, mental care, and regular medical checkups.

The NHRC sought for the reports within four weeks and forwarded the copy of the petition to the Odisha Chief Secretary and the DGP for information and further action.

The petitioner requested the NHRC to investigate the case and ensure legal action against the wrong doers, compensation to the bereaved family and proper counselling.

Authoritarian Hangover

This month's presidential election in Turkey, followed by October's parliamentary vote in Poland, could continue a trend that began in 2020 with Joe Biden's victory over Donald Trump in the United States and continued last year with Luiz Inácio Lula da Silva's triumph over Jair Bolsonaro in Brazil. Both elections provided a powerful sense that the tide was turning against populist authoritarians.

For democratic forces, however, electoral success is only the first step. After all, it is only when an authoritarian government is toppled that the hard work of institutional reconstruction begins

But how can those spearheading that process possibly succeed, when major political forces refuse to accept the fundamentals of a competitive electoral system? This is largely uncharted territory. The late-twentieth-century "third wave" of democratisation comprised almost exclusively what we can call "cooperative" transitions. Whether the political forces behind the falling regime negotiated the transition, or were routed from power, they acquiesced to – and sometimes came to support – a new democratic order.

In Poland, for example, General Wojciech Jaruzelski, the de facto leader of the Polish People's Republic, accepted the role of president in 1989, as part of a deal with the Solidarity movement. In Chile, General

Augusto Pinochet took a lifetime seat in the senate after stepping down in 1990. By the middle of that decade, former communist figures were winning free and fair elections in Central European countries – and accepting the outcome when they lost.

Unfortunately, modern autocrats like Trump and Bolsonaro have adhered to a very different, "non-cooperative" model. While both eventually ceded power (if sullenly and with some violence), neither they nor their supporters have given up on the goal of entrenching authoritarian rule.

Nearly three years after Trump's decisive electoral defeat, many of his supporters still insist that the vote was "stolen." Trump, the frontrunner to win the Republican Party presidential primary, setting up a rematch with Biden next year, has vowed to purge "demonic forces" from US democratic institutions. "Either the deep state destrovs America, or we destrov the deep state." he declared before a cheering crowd last month at a rally in Waco, Texas. The United States is not alone. The com-

ing clash between Poland's ruling Law and Justice (PiS) party and liberal opposition forces will be the third since 2007. The first ended in the opposition's favour, as the PiS government collapsed due to infighting.

The victorious coalition, led by Donald Tusk (who would go on to become president of the European Council), then faced a dilemma: pursue retribution for PiS wrongdoing, such as well documented abuse of power by PiS' infamous Minister of Justice

Zbigniew Ziobro, or opt for a light-touch approach in the interest of political harmony. Tusk's administration chose the latter option, and PiS leaders were never held accountable.

This enabled PiS to dedicate itself to cultivating a robust grassroots movement deeply hostile to the democratic order. Like Trump, PiS mobilised its supporters around a "Big Lie," but not about election rigging. Instead, PiS claimed that the plane crash that killed former PiS leader Lech Kaczyński in 2010 was no accident, but rather an assassination orchestrated by Russian President Vladimir Putin, Tusk, or both.

The details of the PiS Big Lie - again, much like the Trumpian one change constantly. But the point is not to convince people, least of all skeptics. Repetition of any variant of the story is a performative act, intended to erode the legitimacy of liberal opponents and democratic institutions. And the plan worked: the conspiracy theory about the crash became a staple of the voting bloc that brought PiS back to power in 2015. Having faced no accountability for their first stint in power, PiS reappointedZiobro as minister of justice. Tusk pledges to adopt a tougher stance if the opposition wins in October – an uphill fight, given the uneven playing field PiS has created. In a playful reference to PiS's 500+ programme - which provided cash transfers to parents – Tusk promises to pursue the so-called Cell+ programme, aimed at purging Polish politics of those who have deceived or stolen from the public. It is easy to see why Tusk would advocate such an approach. But as the University of Chicago's Monika Nalepa and others have warned, blanket purges of former authoritarian apparatchiks can exacerbate social cleavages, increasing the risk of reprisal and escalation. This is precisely why Tusk took a softer line last time.

OF HAPPINESS & HUNGER

t was more than surprising to hear Anurag Thakur, the Union Minister for Information and Broadcasting, stating a few days back that "we are on a par with any developed nation." He further observed that "India has everything that any developed nation in the world has." Perhaps this is the best comfort he can provide to the poor and the impoverished, the unemployed and the unhappy millions, who have to struggle for an existence. Not just Thakur but even Prime Minister Modi has been lauding the country's achievements by failing to accept the ground reality of not just poverty but social discord, violence and hatred that has permeated the country in recent times.

Very close to Thakur's statement was the release (on March 20) of the World Happiness Report which ranked India at a low of 126 out of 137 countries. As per the report, a publication of the UN Sustainable Development Solutions Network, based on global survey data from people in over 150 countries, India is far unhappy than terribly strife-ridden or nearly bankrupt countries such as Ukraine, Iraq, Palestine, Myanmar, Bangladesh, Sri Lanka and Pakistan. It may be mentioned here that last year a Global Hunger Index ranked India at 107 out of 121 countries behind North Korea, Ethiopia, Sudan, Rwanda, Nigeria, and Congo. These are no indicators of a developed State, and that development has reached to the lowest tiers of society.

Another very startling finding that goes counter to Thakur's observation is that nearly two among 10 infants or toddlers in India face the risk of not receiving any food whatsoever for a full day, according to a study that also revealed virtually no change in this measure of food deprivation. It found that

the proportion of children between six months and 23 months who hadn't eaten any food with substantial calorific content increased from 17.2% in 2016 to 17.8% in 2021. Researchers, who extracted data from the government's own family health surveys, stated that they generated the country's first estimates for the prevalence of 'zero food' children that underline the need to redesign food practices to reach some of the most vulnerable households. It may be mentioned here that UP had the highest prevalence (27.4%) of 'zero food' children followed by Chhattisgarh (24.6%), Jharkhand (21%), Rajasthan (19.8%) and Assam (19.4%).

These have not come to light as health experts have conveniently measured malnutrition only through reductions in stunting and wasting levels among children. "The data contained some-

thing unusual and unexpected we don't expect young children between six months and 23 months to go entirely unfed for a whole 24 hours," said SV Subramanian, a professor of population health at Harvard School of Public Health,

who led the study. Added to all this, one cannot brush aside the recent tweet of Congress leader Rahul Gandhi that "income of the poor is down by 50%, middle class down by 10% and rich increased by 10%. Reports have suggested that over 80% of Indians suffered a loss of income since COVID-19 broke out. As I have mentioned in several

of my articles, the understanding of development by the planners is flawed as, in any particular case, the number of beneficiaries of a project are rarely taken into consideration. The much-hyped rural employment programme is not being expanded on the one

hand, and on the other the Union Budget has been curtailed and it is not possible to provide employment for more than 35 days a vear.

It may be pertinent here to refer to the well-known economist, Meghnad Desai's recent book titled 'The Politics of Political Economy: How Economics Abandoned the Poor', wherein he concludes the need for promot ing a more humane economy. He talks about the provision of a basic income for all and provides some ideas on how to make it feasible. The now well-known universal basic income is opposed on two grounds – fiscal difficulty in raising resources for distribution and the possibility of people losing the incentive to work. It needs to be mentioned here that capitalism may never be able to come up with full employment or zero poverty. Keeping this in view, there is need to evolve a strategy free from the clutches of vested interests who are keen to sustain poverty and inequality in society.

At such a juncture, the future looks grim and dark. Liberal democracy is completely paralysed as social structure is controlled by half-educated sycophants and the economy controlled by a coterie of rich corporations, who are allegedly corrupt but loyal to the party in power. The socio-economic parameters are on decline, while history is being rewritten by ignorant sycophants. The prevailing system of garnering votes by hook or by crook without bothering to understand the real future of the country is a big mistake by whichever government is in power. The question arises where will this lead us to?

The SDG that India does not care enough

he Goal 10 of the Sustainable Development Goals (SDGs) which aimed at reducing income inequalities (10.1), promoting socioeconomic inclusion (10.2).

The World Inequality Report (WIR), 2022 has brought out how the bottom 50% of the world share 8.5% of total income while the top 10% have the lion's share of 52%.

Wilkinson, in a lovely book 'The Spirit Level,' (2009) brings out how developed countries like the USA with income inequality (41%) are afflicted with a higher level of health and social problems compared to countries like Sweden with lower inequality (31%). Walter Scheidel in a perceptive book 'The Great Leveler' (2017) brings out how the average tax rate on the top 1% of households has come down from 42% to 27% during 1980-2013. This was the time when Reaganomics ruled the roost, with the tax rate at the top coming down drastically. In the Indian context, land reform measures like land ceiling and consolidation of holding have come as a cropper due to inept implementation and vested interests stymying implementation. Further tax rates at the top income bracket have come down from 60% in 1980 to 30% by 2003. Wealth tax was abolished by Arun Jaitley in the 2016-17 Budget. Quite clearly, India has been following Reaganomics and not Piketty. An increase in income inequality in India is not an accident of history but a feature of market economics, which benefits the rich corporates and neglects the bottom 50%

risk-taking. The long-term solution seems to be to adopt the capability approach of Amartya Sen which aims at removing barriers to equal opportunity. While universal access to school education has been achieved, quality education remains dodgy as brought out by successive ASER surveys on the impact of the RTE Act 2009. Piketty in his recent book 'Capital & Ideology' rightly argues that early intervention in primary education is "the best way to correct scholastic inequality between students from different social backgrounds." Goal 10 of SDG harps on a combination of equal opportunity, inclusive policy, and fiscal policy as the critical kingpins for minimising inequality. India's record in terms of ensuring equal access, and having programmes like ICDS, and SSA are edifying. However, the quality dimension is severely lacking as the State does not invest enough in education and health as is being recommended by various committees and evidenced in best global practices. It is only through robust political will and a collaborative approach of government, corporates and local community, a more equitable and just society can be a reality.

Because non-cooperative transitions leave democrats with no good options, an alternative path is needed. In Poland, we advocate deep political reform, based on the principle of power-sharing between progressive and conservative forces. The non-partisan initiative we co-founded, including more than 100 Polish intellectuals from across the political spectrum, has now released a detailed proposal to guide such efforts.

Far from giving progressives everything they want, the proposal aims to offer everybody, including conservatives who currently see authoritarian populism as their only path to policy influence, a stake in Poland's future. It remains to be seen how PiS and the democratic opposition will respond.

The idea of fundamentally reforming democratic governance in response to conservative grievances tends to trigger resistance, and not just in Poland. In the US, progressives fear a new constitutional convention. But unless we give our conservative compatriots reasons to support the democratic order, our countries will remain unstable. Here and there, progressive mobilisation may succeed in halting democratic backsliding. But, in the long run, strong democracies will always require committed, majority support from voters and parties across the political spectrum.

ensuring equal opportunity (10.3), and adopting fiscal and social policies that promote equality (10.4), clearly irked right-leaning economists, who believe in the power of the market to maximise wealth creation through economic efficiency rather than economic equity and socio-economic inclusion, championed by left-leaning academia.

Marx was the first to make a clarion call for a classless society as he had noticed how the capitalist economy was exploitative of labour and contained the seeds of its own destruction. The Russian Revolution of 1917 and the disintegration of the USSR in 1991 prompted Fukuyama to conclude in his book 'End of History' that liberal democracy and free market have ended the binary debate of capitalism vs socialism. It was the seminal work of Thomas Piketty 'Capital in the 21st Century' (2013) that clearly demonstrated how the hypothesis that increasing prosperity will lead to a reduction of income inequality is not borne out by facts. SDG 10 carries in its womb the angst of Piketty and Nobel laureates like Krugman, Stiglitz and Abhijit Banerjee and hopes of a more egalitarian world.

In terms of wealth distribution, the asymmetry is even more stark, with the bottom 50% owning 2% of immovable assets while the top 10% own 76%. In the case of India, the bottom 50% used to own 21% of total income in 1990, which has come down to 12% in 2022. The share of the top 10% has gone up from 32% (1990) to 58% in 2020. Both Banerjee and Piketty in their editorial remarks to WIR implore all countries, including India, to increase the tax rate on the super-rich and impose a suitable wealth tax.

While there is unanimity among countries to achieve all the SDGs there is an ideological divide as to whether the State should adopt a fiscal policy to decrease income inequality. The pro-market lobby believes that inequality is inevitable and may even be beneficial. They believe that social leveling adds to economic stagnation as it caps aspiration and removes incentives for hard work and excellence. Milton Friedman believes that equality is less important than economic freedom. On the other hand, leftleaning analysts believe that inequality breeds resentment, hostility, and strife. The poor feel disempowered and marginalised. Richard

Doc's killing outcome of systemic failure: HC

Kochi, May 11: The Kerala High Court Thursday said the killing of a 23-year-old doctor at a taluk hospital in Kollam district of the state a day ago by a man she was treating was the outcome of a "systemic failure" and "cannot be brushed

aside as an isolated incident". A special bench of Justices Devan Ramachandran and Kauser Edappagath directed the state police chief to "ensure that security is provided to all hospitals in the manner as is legally possible so as to prevent any further incidents of attack".

The court said as far as the incident in question was concerned, "there was little doubt that the killing of a doctor by a person who was in custody or police -- be that as an accused or in any other capacity -- points strongly at systemic failure". "This is a gruesome incident which should never have happened," it added.

The bench further said that as matters stand now, lack of protocols or their insufficiency cannot be used as a reason to justify another attack. The court observed that the manner in which the accused - G Sandeep, a school teacher by profession -- was produced in the taluk hospital for treatment "was a recipe for disaster" and it was a "miracle" the nurses attending to him were not attacked.

'We therefore, direct that every protocol that is applicable for production of an accused or persons in custody before magistrates shall apply to presentation of such persons before doctors, healthcare professionals or hospitals concerned," it said. The bench also noted that it was informed that even the protocols regarding producing accused before magistrates are "extremely wanting" and it was only due to "providential grace" that any judicial officers have not been attacked.

Shinde said, "The government we formed was within the legal and constitutional framework. The Supreme Court has now put its stamp on it. Earlier, people used to derive pseudo-pleasure by calling our government an unconstitutional alliance." Shiv Sena (UBT) leaders have often called the Shinde government "unconstitutional".

The veteran politician said, "The BJP's strategy is to break smaller parties and form the government if they cannot win on their own. This is not good for democracy.' Pawar declined to say more on the SC observation that Thackeray had resigned on his own. "Let bygones be bygones. From here, Congress, Shiv Sena (UBT) and the NCP will work together and face the elections." Shiv Sena (UBT) MP Sanjay Raut said if the

top court has observed that Sunil Prabhu of the Thackeray faction of the Sena remains the official whip, then as per its observation, 16 rebel MLAs, including Chief Minister Shinde, stand disqualified from Assembly.

Reacting to the ruling, Narwekar asserted the SC has upheld his stand on the disqualification of MLAs in its verdict on the political crisis. Narwekar, currently in London, told a regional news channel, "The Supreme Court in its order stated that it would be the Speaker's prerogative to take a call on the disqualification plea submitted against the 16 MLAs, including Chief Minister Shinde. I have been consistently saying that it would be the speaker of the assembly who will decide (on this matter).' The Shinde government may

have survived after the Supreme Court verdict but it has lost the moral right to continue in office, NCP leader and former minister Jayant Patil said in Sangli.

The observation by the bench came after one of the advocates appearing for the petitioners referred to the verdicts, including in the Triple Talaq case, and said once the top court gave a declaration to pass a law penalising this, it was a matter for "fairly easy legislative consensus'

"That is not something which the court can presume that we will decide whether to give a declaration or not on how we anticipate the Parliament ... Is likely to respond" said the CJI, who was heading the bench, which also comprised Justices SK Kaul, SR Bhat, Hima Kohli and P S Narasimha

During the hearing, the bench heard the rejoinder submissions advanced by senior advocates, including A M Singhvi, Raju Ramachandran, KV Viswanathan, court will not be able to foresee, envisage, comprehend and deal with its fallout. "Our new enforcement will reduce the current calling rate by at least 50 per cent and we expect to be able to control the current incidence effectively. We will continue to work relentlessly towards ensuring a safe experience for our users," a company spokesperson said in a statement.

Earlier in the day, Minister of State for Electronics and IT, Rajeev Chandrasekhar, said that the IT Ministry will send a notice to



WhatsApp on the issue of spam calls from unknown international numbers, stressing that social media platforms are responsible for ensuring the safety and trust of users. These spam calls with interna-

tional numbers, mostly from African and Southeast Asian countries, along with fake messages from unknown users, flooded WhatsApp users in India. The spam calls showed country

codes of Indonesia, Vietnam, Malaysia, and Ethiopia, among others. Most of these calls started with +251 (Ethiopia), +62 (Indonesia), +254 (Kenya), +84 (Vietnam) and other countries.

WhatsApp said that international scam calls are a new way that bad actors have recently adopted. By giving a missed call, they lead curious users to call or message back only to get scammed.

"We continue to provide several safety tools within WhatsApp like Block and Report, consistently build user safety education and awareness, as well as, proactively weed out bad-actors from our platform. However, bad actors find different ways to scam users," the company spokesperson noted.

Lucknow, May 11: A total of 833 persons have been arrested in 427 cases registered in the past two years under the Prohibition of Unlawful Conversion of Religion Act, 2020 that is now back in focus with the release of the movie 'The Kerala Story' that highlights the same issue.

The Act came into effect in Uttar Pradesh on November 27, 2020. According to a government spokesperson, at least 427 cases related to conversion were reported in the state between January 1, 2021, and April 30, 2023, in which 833 arrests were also made.


Varanasi (UP), May 11: Those wanting to take a holy dip in the Ganga river here will soon get the facility to a changing room on the floating jetty.

TERROR FUNDING CASE NIA carries out raids at multiple **locations in Kashmir**

Srinagar, May 11: The National Investigation Agency Thursday carried out raids at 11 locations in Budgam and Baramulla districts of Jammu and Kashmir in a terror funding case linked to the proscribed group Jamaat-e-Islami (JeI).

"A total of 11 locations came under NIA's scanner in Thursday's searches in the case in which the JeI is accused of engaging in separatist and secessionist activities even after being declared an unlawful association under the UA(P) Act since its proscription 28th February 2019," the agency said in a statement.

The NIA had earlier charge sheeted four people in the case that was registered in 2021. In recent days, the federal agency has tightened the noose around terror funding activities by groups involved in anti-India activities, while strengthening the security apparatus in the Valley. "The searches, conducted at the premises of members and sympathis ers of JeI, J&K, led the agency to the recovery of several digital devices and incriminating material," the agency said.

Investigations so far by the NIA, which had suo moto registered the case on February 5. 2021, have revealed that JeI (J&K) has been collecting money ostensibly for charitable purposes, such as promotion of health and education. It has instead been using the collected funds for carrving out unlawful activities.

The NIA has also found that JeI members have been collecting money, both within and outside India, through donations, particularly in the form of zakat, 'mowda' and 'Bait-ul-Mal' (Muslim community fund).



'Blood delivery by drones will be reality soon'

New Delhi, May 11: Blood delivery through drones can soon be expanded to the whole country, a senior official said after the Indian Council of Medical Research successfully conducted a trial run of blood bag delivery by drones under its iDrone initiative Thursday.

The initiative was in continuance with the national mission of expanding the drone ecosystem in India. The 'i-DRONE' was first used by ICMR during the Covid-19 pandemic for distributing vaccines to hard-to-reach areas.

"Today, we are transporting blood and blood-related products which are supposed to be kept at a low temperature. After the experiment, we found that not only can we maintain the temperature but there was also no damage to the products transported.

"We sent another sample through an ambulance and if there are no differences in the samples sent using the two modes then drones will be used all over India," said Dr Rajiv Bahl, the director general of ICMR.

Peace activist wins World Food Prize

Kyiv, May 11: The British government announced Thursday it was giving long-range cruise missiles to Ukraine to help drive out Russia's occupying forces, just as Kyiv delayed a possible counteroffensive more than 14 months after the Kremlin's full-scale invasion as it awaits the delivery of more Western weapons.

UK Defence Secretary Ben Wallace told lawmakers in the House of Commons that Britain is donating Storm Shadow missiles, a conventionally-armed deep-strike weapon with a range of more than 250 kilometres (150 miles).

That means it can hit targets deep behind the front line, including in Russia-occupied Crimea. UK media reported that Ukraine has pledged not to use the missiles to attack Russia itself. Wallace said the missiles "are now going into or are in the country itself.

Ben Hodges, a former US Army Europe Commanding General, tweeted: ""Well done UK!" "This will give Ukraine capability to make Crimea untenable for Russian forces" and would force a Russian rethink of where to position its Black Sea fleet, he added.

Muharrem Ince, the leader of the centre-left Homeland Party, was one of four contenders running for president in the May 14 election. Turkiye will also be holding a parliamentary election at the same time. Ince had come under intense criticism for splintering the votes of the six-party Nation Alliance, which has united behind the candidacy of main opposition party leader Kemal Kilicdaroglu, and of possibly forcing the presidential race into a second-round.

UK gives missiles; Kyiv delays counteroffensive

Ukraine's Western allies have sent the country 65 billion euros in military aid to help thwart the Kremlin's ambitions and with no peace negotiations on the horizon the alliance is gearing up to send more

UK Defence Secretary Ben Wallace told lawmakers in the House of Commons that Britain is donating Storm Shadow missiles, a conventionally-armed deep-strike weapon with a range of more than 250 kilometres

Western weapons including tanks and long-range precision artillery. The announcement came shortly after Ukrainian President Volodymyr Zelenskyy said his country's military needs more time to prepare an anticipated counteroffensive aimed at pushing back Russian occupying forces and opening a new chapter in the war more than 14 months after the Kremlin's full-scale invasion

Zelenskyy said in an interview broadcast Thursday by the BBC that it would be "unacceptable" to launch the assault now because too many lives would be lost.

"With (what we have) we can go forward and be successful, Zelenskyy said in the interview, according to the BBC. "But we'd lose a lot of people. I think that's unacceptable," he was quoted as saying. The interview was reportedly carried out in Kyiv with public service broadcasters who are members of Eurovision News, including the BBC. "So we need to wait. We still need a bit more time,' Zelenskyy was quoted as saying.

A Ukrainian fightback against Russia's invasion has been expected for weeks. Ukraine is receiving Western training as well as advanced weapons for its troops as it gears up for an expected assault.

While a counterpunch is possible as the weather in Ukraine improves, there has been no word on when it might happen. Zelenskyy's remarks could be a red herring to keep the Russians guessing, and ammunition supply difficulties faced by both sides have added more uncertainty

A claim by the Ukrainian military on Wednesday that it had advanced up to two kilometres (1.2 miles) around the hotly contested eastern city of Bakhmut brought speculation that the counterof fensive was already underway.

But Serhii Cherevatyi, spokesman for Ukraine's Operational Command East, told The Associated Press that the attack was not the "grand counteroffensive, but it's a harbinger showing that there will be more such attacks in the future.'

The Kremlin's forces are deeply entrenched in eastern areas of Ukraine with layered defensive lines reportedly up to 20 kilometres (12 miles) deep. Kyiv's counteroffensive would likely face minefields, anti-tank ditches and other obstacles

By the end of 2022, 5.9 million people had been forced to move inside Ukraine because of Russia's invasion, bringing the global total of people internally displaced by conflict and violence to more than 62 million, an increase of 17 per cent since 2021. Aircraft lessors raise alarm Wheat output may cross govt estimate

New Delhi, May 11: The world's second largest aircraft lessor, SMBC Aviation Capital, has warned that India's decision to block leasing firms from reclaiming Go First planes will jolt the market and spark a confidence crisis, legal papers show

SMBC, along with firms such as Jackson Square Aviation and Bank of China Aviation, raised the alarm after India's National Company Law Tribunal (NCLT) gave Go Airlines (India) Ltd bankruptcy protection to allow it to revive itself, but barred lessors from repossessing planes.

A boom in traffic in the world's third-biggest aviation market prompted record jet orders but two major airline failures, of Kingfisher Airlines in 2012 and Jet Airways in 2019, have taken some of the shine off the market

"Lessors and international aircraft owners see India as a risky jurisdiction for aircraft leasing, after the failures of Jet and Kingfisher," SMBC told the tribunal ahead of a hearing Friday where it seeks to quash Go First's bankruptcy protection.

"The admission of the petition (seeking protection) will further shake confidence of the international aviation industry," it added in a filing to the tribunal that has not been made public but was re-

Kolkata, May 11: Yashasvi Jaiswal (98 n o, 47b, 12x4, 5x6) continued his sensational run in the IPL by smash ing the fastest fifty - 13 balls - in tournament history after Yuzvendra Chahal became the all-time leading wicket-taker as Rajasthan Royals cruised to a nine-wicket win over Kolkata Knight Riders to resurrect their playoff hopes here Thursday.



Chahal became IPL's leading wicket-taker before completing a brilliant 4/25 as RR restricted KKR to a below-par 149/8 at the Eden Gardens

On a day KKR batters struggled to time the ball, 21-year-old Jaiswal showed the way by bringing up fastest fifty in the history of IPL. With the modest chase, Jaiswal remained two runs shy of a century as RR cantered to victory 13.1 overs. Skipper Sanju Samson (48 n o, 29b, 2x4, 5x6) gave fine support to the southpaw as the duo shared an unbroken matchwinning partnership of 121 runs off just 69 balls.

The win with 41 balls to spare also took them to third spot (12 points from 12 matches), giving a massive boost to their net run-rate (0.633) as the playoff race heats up. It is all but over for KKR who slipped to seventh place (10 points, 12 matches).

Jaiswal made his intention clear in the first over itself when KKR skipper Nitish Rana made a bold move to bowl himself. Jaiswal 26

PCB threatens Inter beat Milan 2-0, to move out of inch closer to final Asian sports body

Milan, May 11: Inter Milan over powered AC Milan early and held on to win the first leg of their Champions League semifinal derby 2-0, leaving the Nerazzurri on the brink of a return to European foot ball's showpiece event for the first time since 2010.

Edin Dzeko and Henrikh Mkhitaryan scored two goals in three minutes to put Inter firmly in command and the visitors could have added more in a dominant first-half performance.

The second leg is Tuesday, in what will surely be another special European night at San Siro. The winner will face either Real Madrid or Manchester City, who drew their first leg 1-1.

There was an electric atmosphere at San Siro for the semifinal

that had been dubbed the "Euroderby" in Italy. The two clubs met in the Champions League last four stage 20 years ago — with Milan winning on away goals and going on to beat Juventus in the final for their sixth of seven titles.

The match was expected to be cagey and tight but Inter got off to the perfect start as they took the lead in the eighth minute. Hakan Calhanoglu whipped in a corner from the left and Dzeko managed to get in front of Davide Calabria to hook a vollev into the top right corner.

And Inter doubled their lead just three minutes later. Federico Dimarco's low pass was wisely left by Lautaro Martinez for Mkhitarvan to lift over Mike Maignan. Milan had only conceded one goal in their past six Champions League matches.

Indians held their own to pull off a nerve-wracking 16-14 win and finish top of the podium.
