

### **POACHER GUNS DOWN SIMILIPAL FOREST GUARD**

Baripada, May 22: A forest guard on duty at Bounsakhala beat under Bangiriposhi range in south division of Similipal Tiger Reserve died after being shot at by a poacher, Monday evening.

The deceased forest guard was identified as Bimal Kumar Jena of Bhanjapur area. The incident happened while he was on duty at Chakidi range. Police and forest officials from Bangiriposhi, Baripada and Bhanjapur rushed to the spot and started an investigation.

After hearing a loud gun shot, other forest personnel reached the spot and found Bimal lying in a pool of blood. The poachers fled the spot after seeing the officials.

Bimal had recently married a lady forest guard. After getting the news, his wife came to the forest range of fice directorate and lost her senses Immediately she was rushed to PRM Medical College and Hospital. Bimal's body was sent to PRM Medical College and Hospital, and post mortem will be conducted, Tuesday. "This is for the first time that a forest person nel was shot at by a hunter in Similipal forest. Following the incident we have immediately launched a search operation, which is underway at night," a senior official of Baunsakhala beat said.

Notably, then Speaker Arukha along with two controversial ministers Samir Ranjan Dash (School and Mass Education) and Srikanta Sahu (Labour and Employees' State Insurance) had resigned from their positions. May 12. Besides, the then Health Minister Naba Kishore Das was murdered January 29 this year, creating another vacancy in the Cabinet.

However, it has not yet been made clear who will be the next Speaker of the State Assembly The probable names making the rounds for the Speaker's post are: Prafulla Samal, Debi Prasad Mishra, Amar Prasad Satpathy, Snehangini Chhuria and Badri Narayan Patra.

Patnaik had effected a complete reshuffle of his Cabinet last time in June 2022. So, this was the second reshuffle of his Cabinet in this term.

New Delhi, May 22: Days ahead of the opening of the new Parliament building, a controversy has erupted as the Congress Monday accused the government of disrespecting Constitutional propriety and demanded that President Droupadi Murmu should do the inauguration instead of Prime Minister Narendra Modi.

Congress chief Mallikarjun Kharge said that the then President Ram Nath Kovind was not invited for the new Parliament's foundation laving ceremony in December 2020 and claimed that President Murmu is not being invited for the inauguration of the new Parliament building.

"The Modi Government has repeatedly disrespected propriety. The Office of the President of India is reduced to tokenism under the BJP-RSS Government," the Congress president said in a series of tweets.

Noting that Parliament is the supreme legislative body while the President is the highest Constitutional authority, he said she alone represents the govern-

ment, the Opposition, and every citizen alike.

"She is the First Citizen of India. Inauguration of the new Parliament building by her will symbolise the government's commitment to democratic values and Constitutional propriety," Kharge said.

Prime Minister Modi will inaugurate the new Parliament building May 28 following an invitation by Lok Sabha Speaker Om Birla.

Former Congress president Rahul Gandhi and several opposition leaders have said that the President should inaugurate the new Parliament House rather than the PM. Congress senior spokesperson Anand Sharma told a press conference that the government and the Prime Minister should urge the President in this regard and she as head of the institution of Parliament be accorded that honour





## **Free crop insurance for 3 yrs**

Bhubaneswar, May 22: Crop insurance will be completely free for farmers for the next three years, Cooperation Minister Atanu Sabyasachi Nayak said here, Monday.

Presenting the performance of his department at a meeting reviewed by Chief Minister Naveen Patnaik, Nayak said the government will pay the farmers' share of premium (2 per cent of sum assured) for the next three years crop insurance cycle - Kharif 2023 to Rabi 2025-26

He said crop insurance under Pradhan Mantri Fasal Bima Yojana (PMFBY) was made optional for loanee farmers from Kharif-2020 As many as 84.45 lakh farmers applications have been enrolled during 2022-23 under PMFBY.

During 2021-22, 31.93 lakh farmers' application count got the claim benefit and ₹1,166.02 crore of claim was paid to these farmers.

The minister said during 2023-24, the government has planned to bring more transparency in implementation of crop insurance scheme and enhance the insurance coverage to over 15 lakh farmers.

During Kharif-2022, crop loan of ₹8,710.78 crore has been disbursed to 18.02 lakh farmers. During Rabi 2022-23, crop loan to the tune of

The minister said as per the election manifesto, interest-free crop loan limit has been enhanced from ₹50,000 to ₹1 lakh from Kharif-2022 and around 7 lakh additional small and marginal farmers have benefited from this scheme during the season. Under the scheme, a total of 32.44 lakh small and marginal farmers of the state have availed Rs13,974.60 crore of in-

terest-free loan during 2022-23. Number of farmers availing crop loans has gone up from 6.40 lakh in 2000-01 to 34.57 lakh in 2022-23. The amount of loan extended to farmers has increased from ₹438.36 crore to ₹16,683.57 crore during the period. Out of the functional 2,710 PACS

New Delhi, May 22: Following the Supreme Court's May 15 observation, the Orissa High Court has directed its registry to ensure bail applications arising out of the same FIR are placed before one judge.

The HC has directed the stamp reporting section to verify if other bail applications arising out of the same FIR were disposed of earlier and also indicate the dates of disposal along with the name of judges.

Bail pleas, including interim bail applications, shall be listed before the judge who at the earliest decided any of the earlier bail applications. In case of unavailability of judge who decided the earlier bail applications, the plea shall be listed before the regular bench as per roster. the HC said.

"If no previous bail application under Section 438 or 439 of CrPC arising out of an FIR has been disposed of by any bench (even if filed), the subsequent bail application shall be listed before the ros-

### the SC observed.

'Such a practice leads to anomalous situation. Certain accused are granted bail whereas certain accused for the very same crime having similar role are refused bail,' the SC bench said.

It quashed the January 31, 2023 order and remanded the matter back to the high court.

"The high court is requested to consider the effect of the orders passed by the other coordinate benches and pass orders afresh..., it said.

"The registrar (judicial) of the registry of this court is directed to forward a copy of this order to the registrar general of the Orissa High Court, who is requested to take note of the aforesaid and consider passing appropriate orders so that contrary orders in the same crime are avoided." the bench said.

### 4 of notorious 'Bawariya' gang held

Bhubaneswar; May 22: The special squad of twin city Commissionerate Police arrested four members of notorious 'Bawariva' or 'Kachha-Banian' gang involved in a series of chain snatching cases in the City for a few months now, Monday.

The miscreants were nabbed from a hotel near the Puri railway station on their way to the City.

The arrested were identified as Pradeep Kumar, Vikash, Rabi Kumar and Babu Ram. All belong to Jhinjhana region of Shamli district in Uttar Pradesh.

According to sources, the bikeborne robbers, who were active in Balasore, Bhadrak, Cuttack, Bhubaneswar, and Puri, mostly



targeted women outside of their home in the wee hours either for morning walk or to pluck flowers. And they usually tampered the number plates of their vehicles by scratching the digits to avoid identification.

"They used to keep their motorcycles in parking area and use them in morning hours to commit crime. They stayed in hotels and changed location from one city to other after every crime to avoid police chase and arrest," an official said. The official informed that the members of the gang disposed of the stolen gold ornaments in UP and repeated the same process within a period of 15 to 20 days, using trains to travel to different parts of India.

The officials found that the dreaded criminals were involved in as many as 28 snatching cases in

Cuttack, Bhubaneswar and Bhadrak town between February 2022 and May 2023.

Notably, the gang members operate in all major cities of the country having their transit base in Delhi. And they became a headache for the twin city police after a series of snatchings in Badagada, Nayapalli, Saheed Nagar and Bharatpur areas of the City between February and May 2023.

"We appeal to the citizens not to come out in the wee hours of the day, especially alone. Please remain alert when going out for walk, plucking flower and fetching articles in the morning. Don't expose gold ornaments to avoid becoming a target of snatchers," said DCP Prateek Singh Monday.

Bhubaneswar, May 22: In a bid to curb rising mishaps on highways, the state government has directed director general of police (DGP) Sunil Bansal to take necessary steps to enhance the performance of highway patrol teams

Commerce and Transport Principal Secretary Usha Padhee has written a letter to the DGP in this regard, Monday.

As per the direction of the Supreme Court Committee on road safety, and for reduction of road accidents and fatalities, highway patrol has been rolled out in five vulnerable stretches of roads in the state covering 36 mini stretches. For this purpose, Rs 10 crore has been provided to the state police, Padhee said in her letter.

ing, the Police Commissioner has requested provision of highway patrol vehicles for the stretch from Manguli to Malipada. The Bhubaneswar DCP has also requested to provide three highway patrol vehicles for the stretches from Nakhara to Jayadev Vihar, Jayadev Vihar to Pitapalli and Hi-Tech Square to Uttara Square.

It is a fact that the stretch from Khurda to Chandikhole on NH-16 is a highly vulnerable stretch. As per road accident data, 12 per cent of road fatalities occur there out of the total fatalities in the entire stretch under the National Highways Authority of India, she said.

In this context, the Transport department has provided three more highway patrol vehicles to the Commissionerate of Police, she pointed out. As the stretches proposed by the Bhubaneswar DCP are smaller in area, the deployment plan of highway patrol vehicles may be modified to cover more areas especially in Cuttack police district, Padhee said.

As per crime branch data, a total of 6,923 traffic violations have been detected by the patrol teams during March 2023.

On an average, only 6.4 cases of violations have been detected per day by each patrolling team, which is not at all satisfactory, she said.

During April 2022 to March 2023, a total of 55,007 traffic violation cases were detected by the highway patrol teams, which was not satisfactory. Therefore, the Principal Secretary requested the DGP to instruct all the SPs/DCPs to personally monitor the performance -( of highway patrol teams and improve their performance.

### Heart attack patients with strong legs have better prognosis

eople with strong legs are less likely to develop heart failure after a heart attack, according to research

Myocardial infarction is the most common cause of heart failure, with around 6-9 per cent of heart attack patients going on to develop the condition. Previous research has shown that having strong quadriceps is associated with a lower risk of death in patients with coronary artery dis-

The new study, presented at the Heart Failure 2023, a scientific congress of the European Society of Cardiology (ESC) in Prague tested the hypothesis that leg strength is associated with a lower risk of developing heart failure after acute myocardial infarction.

"Quadriceps strength is easy

and simple to measure accurately in clinical practice. Our study indicates that quadriceps strength could help to identify patients at a higher risk of developing heart failure after myocardial infarction who could then receive more intense surveillance," said Kensuke Ueno, a physical therapist at Kitasato University's Graduate School of Medical Sciences in Japan.

The researchers included 932 patients hospitalised in 2007 to 2020 with acute myocardial infarction who did not have heart failure prior to the admission and did not develop heart failure complications during their hospital stay. The median age was 66 years and 753 participants (81 per cent) were men

Maximal quadriceps strength was measured as an indicator of leg



strength. Patients sat on a chair and contracted the quadriceps muscles as hard as possible for five seconds. A handheld dynamometer attached to the ankle recorded the

maximum value in kg. The measurement was performed on each leg and the researchers used the average of both values. During an average follow-up of Myocardial infarction is the most

per 1,000 person-years in those with low strength. Compared with low quadriceps

strength, a high strength level was associated with a 41 per cent lower risk of developing heart failure.

The investigators also analysed the association between quadriceps strength as a continuous variable and the risk of developing heart failure.

Each 5 per cent body weight increment in quadriceps strength was associated with an 11 per cent lower likelihood of heart failure.

While the findings need to be replicated in other studies, "they do suggest that strength training involving the quadriceps muscles should be recommended for patients who have experienced a heart attack to prevent heart failure,' Ueno said.

The matter came to the fore again after local police arrested Monday the husband of a sarpanch of Bhatakumarada panchavat on charges of assaulting the family members of Yudhistir Nahak and a murder bid on his father.

### G7 & Ukraine War

The most symbolic element of the just concluded G7 summit in Hiroshima is that it took place in the city which, along with Nagasaki, are the only places in the world that had actually experienced the horrors that nuclear weapons can cause. A key agenda of the summit was the ongoing Russia-Ukraine war in which Russia has been constantly threatening use of its nuclear power to crush Ukraine. Some of the survivors of the nuclear attack on Hiroshima in 1945, who were interviewed by the international media on the occasion, cautioned the world against a second nuclear holocaust citing the horrific sufferings they and their families had suffered in 1945

Ukraine's President Volodymyr Zelenskyy, who was invited to the summit, has for some time been performing shuttle diplomacy visiting countries in Europe and the Middle East. His presence at the G7 meeting certainly put some pressure on the countries of the block - the US, UK, France, Germany, Italy, Canada and Japan to rally behind Ukraine in a more effective manner to confront Russia. In fact, it has increasingly become clear to Zelenskyy that it is not enough to get the West's support to his country in the fight against Russia. He also needs to convince countries, including India, which have close ties with Russia for supply of food and arms, to force Russia to stop the war. It is this reason which prompted Zelenskyy to meet Indian Prime Minister Narendra Modi on the sidelines of the summit so as to impress on him the need to support his country. It is to be noted that India has, till date, avoided any condemnation of Russia's invasion.

That the G7 summit made the Ukraine-Russia war a top item on its agenda became clear when the US President Joe Biden announced that his administration had given the go ahead for training of Ukrainian pilots in the use of US made F16 fighter jets. In fact, Zelenskyy's in-person attendance at one of the world's premier diplomatic gatherings is meant to galvanize attention on his country's 15-month fight against Russia. Even before he landed in Japan, the G7 nations had unveiled a slew of new sanctions and other measures meant to punish Moscow and hamper its war-fighting abilities.

It is this support that caused worries to both Russia and China. Russian Foreign Minister Sergey Lavrov criticized the G7 summit for aiming to isolate both China and Russia. The task, he charged, had been set "loudly and openly" to defeat Russia on the battlefield, and then eliminate it as a geopolitical competitor. He went further to complain that the decisions taken at the summit were aimed at "the double containment of Russia and China."

China followed up Russia's belligerent response with an open threat to the bloc not to try to intimidate it. China's Foreign Ministry said time has changed and a handful of Western countries can no longer meddle in other countries' internal affairs and manipulate global affairs. In an unambiguous statement China has warned the G7 members to stop ganging up to "bludgeon other countries" and asked it to focus on addressing the various issues confronting the world.

Though the G7 summit had no specific agenda on China, the very fact that it was held in Japan and leaders of the Quad grouping – US, Japan, India and Australia - also had a meeting sent a clear message to China that they would resist any Chinese attempt to forcibly take over Taiwan. While this was happening, the 18th India-China Corps Commander level meeting had a proposal pushed by China's PLA to create a 15-20 km wide Buffer zone between the two militaries. It may be noted that this whole area where China proposes the buffer zone is totally Indian territory, as claimed by sources.

There are deep lessons for India to learn from this Hiroshima meeting. Russia's invasion of Ukraine should impart the greatest learning. The inherent strength of a socially united country which had built its own military strength has helped sustain Ukraine to survive the terrible might of one of the world's most powerful armed forces for over a year. Only after it demonstrated to the world that it could withstand the invasion did friendly nations pitched in to help. US is now saying it will train Ukranian pilots to fly F 16 jets. This help comes after more than one year of bitter war.

India has remained steadfast in its stand not to condemn the Russian invasion. Although no one has bothered to complain, the cold shouldering of India at this G-7 meet was palpable. This might have serious fall out for India in the future should China ever increase its belligerence towards India. Without strengthening the Indian military while joining Quad, the nation might be inviting trouble from the neighborhood. If China decides to undertake large scale military action against India, help from outside might be slow or extremely delayed in landing up. India's stand in relation to the Russian invasion of Ukraine may not be forgotten by the Western Bloc easily in the near future. India's diplomacy can no longer be person centric. There is no

live down. Demonetisation is one of these memories, etched into the psyche of the nation as a step that led to widespread disruption, the loss of lives and the derailment of the Indian economy. So, it's not surprising that the withdrawal of the ₹2000 denomination notes brings back ugly reminders of that dreaded demonetisation which the former Prime Minister Dr Manmohan Singh described as "organised loot and legalised plunder," his harshest comment on the Modi establishment. Everyone knew that this fear would come rushing back as the ₹2000 banknote is laid to rest. The Reserve Bank of India made it a point to put it in its headline for the press release, circular and the associated FAQs to that the notes will continue to be legal tender.

The caution and the qualification were necessary because of fears that the move will be misread. To be sure, this time it's not a case of demonetisation but a planned withdrawal from circulation, pending which the note remains legal tender. Citizens have time till September 30 to deposit the notes into their accounts or exchange the notes with other denomination notes at bank counters. The exchange comes with a slight hurdle though – only up to ₹20,000 at one go to avoid disruption at bank branches. There is no limit for deposits, with applicable KYC norms.

To put it in the words of the RBI: "With a view to minimise inconvenience to the public, to ensure operational convenience and avoid disruption of the regular activities of bank branches, all banks may exchange ₹2000 banknotes up to a limit of ₹20,000/- at a time." One way to look at it is that the RBI wants an orderly exchange that is not disruptive. The flip side of this view is that it appears quite easy to disrupt Indian banking and branch operations with Indian notes! In general, the ₹2000 note with its unique purple colour will go down as the shortest-lived Indian

currency note in the history of Independent India at least.

The withdrawal of the high denomination note is a step in the right direction. The high currency note was introduced as a desperate measure to fill the vacuum caused by the sucking out of almost all cash from the Indian system in a nation that till then (and even now in many parts) lives on cash transactions. Yet, it was clear early on that one purported aim of the demonetisation programme, which was to flush out black money from the system, was defeated with the introduction of the high currency note. It is easier to hoard cash when it is in a higher denomination. Consequently, any discouragement towards cash holding should mean that the bulk of the currency should be in smaller denominations. Across the developed world, notes are not issued in higher denominations. For example, in the United States, the Federal Reserve Board currently issues banknotes in denominations of 1, 2, 5, 10, 20, 50 and 100 dollars. Higher denominations were last printed in 1945 and discontinued way back in 1969.

In India, demonetisation was announced on 8 November, 2016. As of March 2017, the then newly introduced ₹2000 banknote accounted for over 50% of the value of total value of currency in circulation but just 3.3% of the total volume of currency in circulation. The note fulfilled an urgent need to feed a cash-starved nation. Over time, however, the note's commonplaceness has been brought down in a planned glide that saw the numbers - value of the notes and their volume – come down. Printing of the notes stopped in 2018-19.

This has been a case of wise and pro-people decision-making, quite the opposite of the suddenness with which some other policy measures of the government have been announced, notably demonetisation and the lockdown when COVID-19 had just begun to erupt.

There are lessons to be learned from the introduction as well as the withdrawal of the ₹2000 note, the first of which is that the objective of the decision is lost when the disruption it causes is heavy. If the policy was meant to flush out black money (none of which was found), then the introduction of the high currency note was a textbook case of what is not to be done to encourage black money and hoarding, but had to be done simply to ease the immediate pain.

### Hypernova

Sometimes the super- prefix just isn't extravagant enough, or it's been Sused already, or linguistic inflation has set in. This term seems to be a product of all three, since it is an even more spectacular cosmic event than the well-known supernova. But perhaps the superlative is warranted in this case, as the last such event spotted from Earth was widely reported as being so intense that if it had happened near to us we would have fried (luckily, it happened long, long ago in a galaxy far, far away). Such cataclysmic explosions - the biggest bangs since the Big Bang, NASA called them, with perhaps permissible overstatement - are about a hundred times as powerful as the biggest supernovae and may be caused by the total collapse of a very large star. They have been suggested as a possible origin of intense bursts of gamma rays that have been observed by space-borne detectors since the 1970s. In January 1999 the source of one was seen for the first time as it was happening. By this time, theorists had built up a picture in which GRBs [gamma-ray bursters] result from the collision of two high-density neutron stars or from a "hypernova" – the total collapse of a very massive star (Science, Mar. 1999). Really big stars such as Eta Carinae may go out in an even more spectacular explosion called a hypernova. Such a hypernova could produce another phenomenon known as a gamma-ray burster, which sends powerful gamma radiation out into space (Minneapolis Star Tribune, Jun. 1999).

### Farmer's 'suicide': NHRC issues notices

New Delhi, May 22: The National Human Rights Commission (NHRC) has issued notices to the Uttar Pradesh Police and the chief secretary of the state over the "suicide" of a 45-year-old farmer after police allegedly forced a compromise with the perpetrators of the kidnapping and rape of his minor daughter.

The commission has sought a report in the matter from the police and the chief secretary within four weeks.

It said it has taken suo motu cognisance of a media report, according to which the man committed suicide after the police allegedly forced a compromise with the perpetrators of the kidnapping and rape of his minor daughter in Pilibhit district of

Uttar Pradesh. The victim reportedly belonged to a Scheduled Caste (SC) community.

"The commission has observed that the contents of the media report, if true, amount to a violation of human rights. Accordingly, it has issued notices to the Chief Secretary, Government of Uttar Pradesh, and the Director General of Police, Uttar Pradesh, calling for a detailed report within four weeks, it said in a statement.

The report should also include the present status of the matter and disbursement of the monetary relief to the victim under SC/ST (Prevention of Atrocities) Rules, 1995.

The commission would also like to know about the action taken against the delinquent officer responsible for the tragedy, it added.

### Honour SC verdict on Delhi services: Cong to Centre

New Delhi, May 22: The Congress asked the Centre Monday to honour the Supreme Court verdict on Delhi services and said a final call on supporting the legislation that seeks to replace the ordinance in Parliament would be taken after discussions with like-minded political parties.

Sources said the Congress may consider opposing a bill, when it is introduced in Parliament, seeking to replace a Union government ordinance on Delhi's services matters, but noted that a final call would be taken after consultations with other parties.

While a united Opposition has 111 MPs in the Rajya Sabha, the ruling BJP and its allies have almost an equal number of MPs. Senior Congress spokesperson Anand Sharma said his party welcomed the Supreme Court decision when it came. "Today too, we have the same view that the Supreme Court decision was right. The Constitution bench has given a detailed judgment on the Delhi issue and the government should honour that," Sharma said when asked about the ordinance. The sources in the Congress, meanwhile, said the party may oppose the bill when the government brings it in Parliament to replace the ordinance.

Sharma said the government has brought an ordinance as well as sought a review of the Supreme Court's May 11 judgment.

"It is very clear that the Constitution bench of the Supreme Court had come out with a very detailed judgment and also, its interpretation of the constitutional positions and the rights of states and elected governments. It was



a larger question, it was not only limited to those parts of the judgment, not confined in my view only to Delhi, it was about India being a country," he said.

The Congress leader said under the Constitution, the government has the authority to bring an ordinance, but in this instance, it has also decided to file a petition for a review of the top court verdict.

"Since this is a Constitution bench judgment, it is only a Constitution bench which will revisit (the verdict). And we will await what the Constitution bench decides in this matter and we leave it at that," he said.

Prodded further on whether the Congress will oppose the bill to replace the ordinance, Sharma said, "Let us cross the river when it comes.

"I would expect that the Congress leadership, the Congress president, who is also the leader of the opposition in the Rajya Sabha, and the leader of the Congress in the Lok Sabha, along with the leaders of all other political parties, will discuss this matter as and when the session is convened, but we do hope that since it is the Constitution bench and the government has gone backthere, the Supreme Court will come out with its view," he added.

### **DOCUMENTARY ON PM MODI Delhi HC issues summons to BBC**

New Delhi, May 22: The Delhi High Court Monday issued notice to the British Broadcasting Corporation (BBC) on a plea by an NGO seeking damages, claiming its documentary "India: The Modi Question" casts a slur on the reputation of India and makes false and defamatory imputations against Prime Minister Narendra Modi and the Indian judiciary.

The plea said BBC (UK) is the national broadcaster of the United Kingdom and has released the news documentary – "India: The Modi Question" -- which has two episodes and BBC (India) is its local operations office. It said the two episodes have been published in January 2023. The petitioner has sought dam-

ages of Rs 10,000 crore in favour of the NGO and against the de-

fendants on account of the "loss of reputation and goodwill caused to the Hon'ble Prime Minister of India, the Government of India, the Government of the State of Gujarat as it was during the period of the Gujarat Riots, and also the people of India".

The documentary relates to the 2002 Gujarat riots when Modi was the state's Chief Minister. The high court said, "Issue notice to the respondents through all permissible modes," and listed it for further hearing September 25.

The government had banned the documentary soon after it was released. Senior advocate Harish Salve, appearing for the NGO, said the suit against the BBC is in relation to the documentary which has "defamed" India and the whole system including the judiciary.

### Delhi civic body bans acid for toilet cleaning

DELHI SWELTERS IN SCORCHING HEAT

New Delhi, May 22: The Municipal Corporation of Delhi (MCD) has issued an order recently prohibiting the use of acid for cleaning public toilets operated by it, the Delhi Commission for Women (DCW) said Monday.

The MCD cited the Supreme Court order of 2013 that prohibited the over-the-counter sale of acid across India in the wake of raising incidents of acid attack.

"So, the provision for penalty for not using acid for cleaning purpose of toilet is, hereby, abolished/repealed from the contract. The agency/operator shall use alternate toilet cleaning material in place of acid. Violation of the instruction will attract penalty including confiscation of acid from the premises," the MCD order read.

The civic body directed all officers, field staffers and agencies concerned to ensure that "acid shall not be used for any cleaning purpose of toilets and public con-

On April 6, the DCW inspected an MCD-run toilet for women near the G B Pant Hospital in Daryaganj and found a 50-litre canister containing acid. The panel was informed by the sanitation staff that acid is purchased every month to clean toilets.

Senior MCD officers appeared before the commission and stated that no guidelines have been issued by the civic body to prevent

the use of acid for cleaning public toilets.

The also referred to a term of the contract agreement between the MCD and the cleaning agency which states that in case acid is not used to clean toilets weekly, a penalty of Rs 1,000 per day shall be

imposed on the agency. DCW chief Swati Maliwal expressed her displeasure over the present state of affairs where the MCD has "illegally" directed the usage of acid to clean 308 public toilets.

Following directions from the panel, the MCD issued an order May 18 which states that the said provision of the contract (which encourages use of acid) has been repealed and if any person is found using/storing acid in toilets, then action shall be taken against the agency.

### Tripura govt to refurbish old capital complex area

Agartala, May 22: The Tripura government has decided to refurbish the old capital complex area near Agartala to boost tourism, officials said.

The old capital complex, which includes a palace, Chaturdasha Temple, a museum and other structures, in Puran Haveli area in Puratan Agartala, around 8 km from the state capital, will be renovated and the entire area beautified as part of the Rs 20-crore project, they said. Maharaja Krishna Manikya Debbarma had constructed the complex and the temple in 1760 after shifting his capital from Udaipur, around 60 km away, when it fell into the hands of invader Samser Gaji and his army. The Manikya kings shifted the capital from Puran Haveli to Agartala in 1838. "The temple draws devotees from across Tripura and neighbouring Assam and Bangladesh during the seven-day 'Kharchi Mela' held in the months of June and July. The state government will secure a loan from the Asian Development Bank (ADB) for the renovation of the historical site," state Tourism Minister Sushanta Chowdhury said.

## PIL filed against exchanging ₹2,000 notes without ID PRESS TRUST OF INDIA

New Delhi, May 22: The Delhi High Court will hear Tuesday a public interest litigation against permission to exchange Rs 2,000 denomination banknotes without obtaining any requisition slip and identity proof.

The plea was filed by lawyer Ashwini Kumar Upadhyay Monday. Upadhyay mentioned the case before a bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad for an urgent hearing today itself. The court, however, declined the request.

The petitioner contended in his plea that notifications by the RBI and SBI enabling exchange of Rs 2,000 currency notes without requisition slip and identity proof were arbitrary, irrational and offend Article 14 (equality before law) of the Constitution of India.

The petition said a large amount of currency notes has reached either individuals' locker or "hoarded by the separatists, terrorists, Maoists, drug smugglers, mining mafias & corrupt people". The petition said cash transac-

tions in high value currency are the main source of corruption and are used for illegal activities like terrorism, naxalism, separatism, radicalism, gambling, smuggling, money laundering, kidnapping, extortion, bribing and dowry, etc., and

the RBI and SBI should ensure that

Rs 2,000 denomination banknotes are

deposited in bank accounts alone.

"Recently, it was announced by



the Centre that every family should have Aadhaar card and bank account. Therefore, why RBI is permitting to exchange Rs 2.000 banknotes without obtaining identity proof. It is also necessary to state that 80 crore BPL families receive free grains. It means 80 crore Indians rarely use Rs 2,000 banknotes. "Therefore, petitioner also seeks direction to RBI and SBI to take steps to ensure that Rs 2,000 banknotes are deposited in bank account only," the plea stated.

Depositing Rs 2,000 currency notes in bank accounts will ensure those having black money and disproportionate assets are identified easily, the plea said. On May 19, the Reserve Bank of India (RBI) had announced withdrawal of Rs 2,000 currency notes from

circulation, and said existing notes can either be deposited in bank accounts or exchanged by September 30. The banknotes in Rs 2.000 denomination will, however. continue to be a legal tender, the RBI said in a statement. In order to ensure operational convenience and to avoid disruption of regular activities of bank branches, the RBI said exchange of Rs 2.000 bank notes into bank notes of other denominations can be made up to a limit of Rs 20,000 at a time at any bank starting from May 23.

In a communication to chief general manager of all its local head offices, State Bank of India (SBI) informed that the facility of exchange of Rs 2,000 notes by public up to a limit of Rs 20,000 at a time will be allowed without obtaining any requisition slip.

### **Gujarat ATS arrests** 4, busts Qaeda unit

Ahmedabad, May 22: The Gujarat Anti Terrorist Squad (ATS) has busted an Al-Qaeda module and arrested four members who hail from Bangladesh but have been living illegally in Ahmedabad, an official said Monday.

The preliminary investigation has revealed that the four members of the proscribed terror outfit were trained by their handlers based in Bangladesh before the quartet was sent to India. They were tasked with raising funds for Al-Qaeda's illegal activities, radicalising local youths and persuading them to join the terror outfit, said Deputy Inspector General, Gujarat ATS, Deepan Bhadran.

They were arrested from different parts of Ahmedabad under the relevant sections of the Indian Penal Code and sections 38, 39 and 40 of the Unlawful Activities (Prevention) Act (UAPA), Bhadran said at the ATS headquarters.

The four alleged members of Al-Qaeda are identified as -Mohammad Sojib, Munna Khalid Ansari, Azharul Islam Ansari and Mominul Ansari.

"Based on a specific tip-off, we first picked up Sojib, who used to live in the Rakhial area of Ahmedabad, for questioning. Sojib told us that he and three others are part of Al-Qaeda's network and were taking instructions from their Bangladesh-based handler Shariful Islam. Through Islam, these youths met one Shayba, head of Al-Qaeda's operations in Bangladesh's Mymensingh district," said Bhadran

### HC allows minor, impregnated by brother, to undergo abortion

Kochi, May 22: The Kerala High Court has allowed medical termination of pregnancy of a minor girl who was impregnated by her own brother, saying that various social and medical complications are likely to arise if abortion was not permitted

Justice Ziyad Rahman said that even according to the report of a medical board, constituted to examine the girl, continuation of the over 32 week pregnancy was likely to cause grave injury to the social and mental health of the 15-year old victim. "Considering the fact, the child is born from his own sibling, various social and medical complications are likely to arise. In such circumstances, the permission as sought for by the petitioner to terminate the pregnancy is inevitable. "Upon perusal of the medical report, it is evident that the child is physically and mentally fit for medical

termination of pregnancy. It is also stated that continuation of pregnancy is likely to cause grave injury to the social and mental health of the child," the court said.

It also said there was a possibility that the girl would give birth to a live baby according to the medical board. 
### Delivery man falls from 3rd floor while fleeing dog

### **3 Palestinians killed** in West Bank clashes

Tel Aviv: Three Palestinians were killed in an Israeli army raid in a West Bank refugee camp early Monday, Palestinian health officials said, while the Biden administration sharply condemned Israel's latest act of settlement expansion.The Palestinian Health Ministry said the three men were killed during a raid in Balata, a refugee camp near the city of Nablus. ## **US debt crisis can impact world**

Washington, May 22: If the debt crisis roiling Washington were eventually to send the United States crashing into recession. America's economy would hardly sink alone. The repercussions of a firstever default on the federal debt would quickly reverberate around the world.

Orders for Chinese factories that sell electronics to the United States could dry up. Swiss investors who own US Treasurys would suffer losses. Sri Lankan companies could no longer deploy dollars as an alternative to their own dodgy currency.

The Republicans have threatened to let the government default on its debts by refusing to raise the statutory limit on what it can borrow unless President Joe Biden and the Democrats accept sharp spending cuts and other concessions.

Feeding the anxiety is the fact that so much financial activity hinges on confidence that America will always pay its financial obligations. Its debt, long viewed as an ultra-safe asset, is a foundation of global commerce, built on decades of trust in the United States.

A default could shatter the USD 24 trillion market for Treasury debt, cause financial markets to freeze up and ignite an interna-



tional crisis The threat has emerged just as the world economy is contending with a panoply of threats — from surging inflation and interest rates

to the ongoing repercussions of Russia's invasion of Ukraine to the tightening grip of authoritarian regimes. On top of all that, many countries have grown skeptical of America's outsize role in global finance.

In the past, American political leaders generally managed to step away from the brink and raise the debt limit before it was too late. Congress has raised, revised or extended the borrowing cap 78 times since 1960, most recently in 2021. Yet the problem has worsened.

Partisan divisions in Congress have widened while the debt has grown after years of rising spending and deep tax cuts. Treasury



Announcing the development plan, Modi said India has decided to establish a super-specialty cardiology hospital in Fiji and will assist in setting up dialysis units in all the 14 Pacific island countries. He also announced that sea am-

bulances will be provided to all the 14 Pacific island countries. To boost healthcare in the Pacific region, we have decided to establish a super-specialty cardiology hospital in Fiji. This hospital will be equipped with trained staff, modern facilities, and infrastructure, and it will serve as a lifeline for the entire region," Modi said. He said the Indian government will bear the full cost of this

mega greenfield project. The prime minister also proposed to bring similar Jan Aushadhi Centers to the region.

Climate change to push 30% species over tipping points: Study

Kyriakos Mitsotakis confirming Monday he would not try to build a coalition government — despite having dominated the ballot hours earlier by the most decisive margin in half a century.

With 99.70% of the votes counted, New Democracy has 40.79% and 146 seats, five short of a majority, winning in 58 of the country's 59 constituencies. Svriza got 20.07% and 71 seats, while Pasok came in third at 11.46%

Geneva, May 22: Climate change is likely to abruptly push up to 30 per cent of species over tipping points as their geographic ranges reach unforeseen temperatures, according to a study.

The researchers found that if the planet warms by 1.5 degrees Celsius, 15 per cent of the species they studied will be at risk of ex-

periencing unfamiliarly hot temperatures across at least 30 per cent of their existing geographic range in a single decade.

However, this doubles to 30 per cent of species at 2.5 degrees Celsius of warming, they said. The study, published in the journal Nature Ecology & Evolution, analysed data from over 35,000 species of animals -- including mammals, amphibians, reptiles, birds, corals, fish, cephalopods and plankton -and seagrasses from every continent and ocean basin, alongside climate projections running up to 2100. The researchers investigated

when areas within each species' geographical range will cross a threshold of thermal exposure, defined as the first five consecutive vears where temperatures consistently exceed the most extreme monthly temperature experienced

by a species across its geographic range over recent history (1850-2014). Once the thermal exposure threshold is crossed, the animal is not necessarily going to die out, but there is no evidence that it is able to survive the higher temperatures, according to the re searchers.

The research projects that for many species there could be an abrupt loss of habitat due to future climate change, they said. The researchers found a con-

sistent trend that for many animals, the thermal exposure threshold will be crossed for much of their geographic range within the same decade.

The study suggests that once a species is suffering under unfamiliar conditions, there may be

very little time before most of its range becomes inhospitable. The researchers hope that their study could help with targeting conservation efforts, as their data provides an early warning system showing when and where particular animals are likely to be at risk.

### 2mn killed in damages from extreme weather

N early 12,000 extreme weather, climate and water-related events over much of the past half-century around the globe have killed more than 2 million people and caused economic damage of \$4.3 trillion, the U.N. Weather agency said Monday. The stark recap from the World Meteorological Organization came as it opened its four-yearly congress among member countries, pressing the message that more needs to be done to improve alert systems for extreme weather events by a target date of 2027. The Geneva-based agency has repeatedly warned about the impact of man-made climate change, saying rising temperatures have increased the frequency and intensity of extreme weather including floods, hurricanes, cyclones and drought. WMO says early warning systems have helped reduce deaths linked to climate and other weather-related catastrophes

## **Retailers see red in pink**

Rush to exchange ₹2,000 notes spills to many routes as people are flocking to petrol pumps, jewellery and electronic shops to avoid a visit to banks

### AGENCIES

New Delhi, May 22: The acceptability of pink notes in the denomination of ₹2,000 has come down drastically after the government decided to withdraw them from circulation and gave a fourmonth window for the same.

Retail outlets in the country are witnessing a surge in the number of receipt of such high denomination notes led by panic as people are trying to avoid standing in long queues in the banks.

In many parts of the country, medium and small shopkeepers have stopped accepting ₹2,000 notes on the excuse that they do not have the change. It is only the multibrand showrooms that are accepting these pink notes.

'There is a sudden rush of customers who want to pay with ₹2.000 notes. Since the panic, we are also being cautious and do not want to stock up on these notes," said the owner of a grocery store.

A manager of a private sector bank's Kasha branch in south Kolkata said that, the receipts of ₹2,000 denomination notes had been marginally higher at 10, compared to seven to eight on normal working days. "The panic and rush that were witnessed after the demonetisation in 2016 were nowhere witnessed on Saturday. Probably, from Monday, the number of de-



posits of pink notes might increase." he added

### **GOLD, ELECTRONIC RUSH**

The Reserve Bank of India's decision to withdraw ₹2,000 currency note has triggered panic buying of gold jewellery in many cities including Delhi, Mumbai, and Surat. Jewellery shops and shops selling electronics, however, are making most of the withdrawal

#### PANIC AT PETROL PUMPS

Cash transactions have sharply risen at petrol pumps and cashpaying customers are using ₹2000 notes in nine out of ten cases following Friday's withdrawal of the high-value banknote, the All-India Petroleum Dealers Association (AIPDA) has said.

"The RBI decision to withdraw ₹2000 note has again created the same difficult situation at petrol pumps across the country as was faced during the 2016 demonetization drive," AIPDA said.

Petrol pump dealers said cash sales before the surprise announcement Friday of the withdrawal of the ₹2.000 note was only 10 per cent which has now increased to 90 per cent as customers were using the withdrawn note to make small purchases of ₹100/200, expecting petrol pumps to return change

Most of the petrol pumps have stopped accepting the high currency denomination but some are accepting the currency but only if the customers' fuel bill is more than ₹1000. Some petrol bunks even displayed boards to the effect. The Tamil Nadu State Transport

Corporation, Tirunelveli, has issued a circular instructing bus conductors not to accept ₹2,000 denomination notes from passengers or exchange the same for lower value note. Retail outlets and fuel stations have also stopped accepting ₹2,000 denomination notes.

Food delivery platform Zomato Monday said a whopping 72 per cent of users that opted for cash on delivery option while ordering their food paid with ₹2.000 notes since the Reserve Bank of India (RBI) announced the withdrawal of these notes May 19. There are also reports that food delivery boys, however are refusing to accept ₹2,000 notes if a customer opts for cash on delivery. Meanwhile analysts and bankers

note that the decision to withdraw highest denomination currency note from circulation is likely to improve banking system liquidity, bringing down recently elevated short term rates.

Once the final takeover is done, the facility is likely to manufacture new Apple products that may include the upcoming iPhone series.


'With the new make-in-India potentially entry to mid-level iPhone 15 series, the Tata Group will make a modest beginning in this new partnership," according to Prabhu Ram, Head, Industry Intelligence Group, CMR. "We anticipate a remarkable growth trajectory for the Tata Group in the coming years as they gain expertise and experience in high-end iPhone manufacturing," he told IANS.



While the majority of the Indian team players are going into the title clash after two months of IPL, only three WTC-bound Australians played in the richest T20 league. Last week, the great Ricky Ponting said the Aussies will be mentally better prepared for the final but the Indians will have valuable game time behind them.
