Bhubaneswar, May 29: To woo voters ahead of 2024 elections, the state government Monday announced a new rural housing scheme 'Мо Ghara' Approximately 4 lakh people will be covered under the new scheme for which the government will bear ₹2,150 crore in two years.

On the occasion of completion of the fourth year of the fifth term of his government, Chief Minister Naveen Patnaik Monday chaired the state Cabinet meeting, in which 18 important proposals including 'Mo Ghara' housing scheme were approved.

State Panchayati Raj and Drinking Water Minister Pradip Kumar Amat said the Cabinet has approved the new housing scheme called 'Mo Ghara' (my home) to provide financial assistance to meet the aspirations of the lower and lower middle-income house holds of rural Odisha.

The scheme will cover all such families who were left out in the existing housing schemes due to stringent eligibility criteria or due to insufficient allocation and also those who had received housing assistance of smaller amounts in the past and now want to upgrade or expand their houses. he said.

This is a credit-linked housing scheme with capital subsidy which is fully funded from the state Budget. This scheme aims at construction/up-gradation and completion of houses, Amat said.

Under the scheme, a beneficiary can avail housing loan up to ₹3 lakh which can be repaid in 10 years excluding 1 year moratorium period in easy installments. They can opt for one of the four slabs of the loan amount-Rs 1 lakh, ₹1.5 lakh, ₹2 lakh and ₹3 lakh, he pointed out. For loan amount of ₹1 lakh,

₹1.50 lakh, ₹2/3 lakh, the state government will provide subsidy of ₹30,000, ₹45,000, and ₹60,000, respectively. However, the family headed by SC/ST and PwD, will get an additional subsidy of ₹10,000.

In order to further reduce the financial burden for the beneficiaries, the registration fee and stamp duties required during mortgage of title deed have been waived off by the state government, Amat said.

Further, he said, the legal consultation fee is also standardised to ₹1,000 maximum, which the state government will reimburse to the banks.

A dedicated web portal https://rhodisha.gov.in/moghara will be launched for filing of online applications, monitoring and implementation of the scheme. The eligible people can submit their applications through this portal from June 16, 2023, the minister added

girl was stabbed over 20 times and bludgeoned to death by a youth in a busy bylane as passersby looked on in northwest Delhi's Shahbad Dairy area - an incident that has drawn massive outrage as the video of the horrific killing appeared online. Delhi Police said the

birthday party of her friend's child when she was accosted by the accused in the densely populated neighbourhood, they said.

A nearly 90-second video of the incident that was shared online showed the accused pinning the victim to a wall with one hand and stabbing her repeatedly. He did not stop even when the girl slumped to the ground, jabbing the knife into her over 20 times, kicking her and then slamming a cement slab on her repeatedly. In a shocking display of public apathy, people can be seen passing by, with some bystanders staring in alarm, but not doing anything to stop the brutal attack.



The accused is seen walking away from the victim in a casual manner only to turn back and again hit her with the slab before leaving the site.

### **CBI books Rolls** Royce for scam in AJT purchase

New Delhi, May 29: The CBI has filed a corruption case against British aerospace and defence company Rolls Royce PLC, top executives of its Indian unit and arms dealers for alleged kickbacks in the procurement of Hawk 115 Advanced Jet Trainer aircraft for the Indian Air Force and Navy, officials said.

The CBI has registered a case against Tim Jones, Director Rolls Royce India, alleged arms dealers Sudhir Choudhrie and his son Bhanu Choudhrie, Rolls Royce Plc and British Aerospace Systems under IPC section 120-B (criminal conspiracy), 420 (cheating) and provisions of Prevention of Corruption Act after completing a six-year-old preliminary enquiry registered in December 2016.

Email sent to Rolls Royce seeking comments remained unanswered.



A British court order in 2017 also mentioned the alleged involvement of intermediaries and payment of commission by the company for swinging the deal, they said.

It is alleged that during 2003-12, these accused entered into a conspiracy with unidentified public servants who abused their official positions in lieu of huge bribes, commissions and kickbacks paid by Rolls Royce to approve the aircraft purchase.

The company paid intermediaries, even though the agreements, integrity pacts and associated documents of the deal prohibited such payments, the CBI FIR has alleged.

The Cabinet Committee on Security (CCS) had approved the procurement of 66 Hawk 115 AJTs September 3, 2003, under which 24 BAE Hawk 115Y AJTs in flyaway condition with all the accou trement along with material for 42 aircraft to be manufactured by HAL were cleared for GBP 734.21 million, equivalent to ₹5,653.44 crore (calculated at ₹77 per GBP), ২ was sanctioned.

Balasore, May 29: Police arrested a man Monday for trying to kill his 20-day old newborn by injecting a poisonous liquid into her body simply because he did not want a daughter. The incident has been reported from Singiri village under Nilagiri police limits in this district. Police are now questioning the accused, identified as Chandan Mahana, as to why he tried to commit such a heinous crime.

Residents of the village said that Chandan had married Tanmayi last year. The couple was blessed with a child 20 days back. Tanmavi incidentally was residing at the house of her parents after childbirth.

Dad jabs poison into 20-day old girl

Chandan's father-in-law Bhagirathi Singh informed that he had come to their residence Sunday. "He seemed aloof from the moment he arrived," he said. "He was near the newborn when the latter started wailing in agony. Initially when asked, he did not confess that he had injected poison into the body of my granddaughter," he added.

Tanmayi meanwhile stated that after persuasion, Chandan confessed that he had used a syringe to inject poison into the newborn. Hearing this, other family members immediately rushed the infant to a hospital in this town. Currently the newborn is admitted to the ICU and is undergoing treatment.

Meanwhile, police detained Chandan after a complaint was lodged They said Chandan has confessed that he tried to kill the newborn as he wanted a son and not a daughter.

## 'Indian GPS' satellite successfully put into orbit

■ *It is for the first time* that an indigenously developed rubidium atomic clock has been used in a mission in a departure from imported ones used earlier AGENCIES

Sriharikota (Andhra Pradesh), May 29: India successfully put into orbit the first of its second generation navigation satellite NVS-01 Monday in a copy book style.

The launch of the 2,232 kg NVS-01 is significant as it would ensure the continuity of NavIC (Navigation with Indian Constellation) services -- an Indian regional satellite navigation system, providing accurate and real-time navigation. Simply put, NavIC is an Indian 'GPS' - Global Positioning System. Signals from NavIC are designed to provide user position accurate to better than 20 metres and timing accuracy better than 50 nanoseconds.

At the end of a 27.5 hour countdown, the 51.7 metre tall, 3-stage Geosynchronous Satellite Launch Vehicle with a cryogenic upper stage, lifted off at a prefixed time of 10.42 am from the second launch pad at the spaceport here, located about 130 km from Chennai. This was GSLV's 15th flight. Breaking free of the earth's gravitational pull the rocket went

up and up with a bright orange fire at its tail. At the rocket mission control room Indian space scientists at ISRO were glued to their computer screens watching the



rocket's flight progress. Just over 19 minutes into the flight the rocket slung NVS-01 into

the Geosynchronous Transfer Orbit (GTO) from where the satellite will be taken up to its final position.

The Indian satellite navigation system NavIC consists of nine satellites -- seven in orbit and two as substitutes. NVS series of satellites will sustain and augment the NavIC with enhanced features.

The NVS-01 with a mission life of 12 years is powered by two solar arrays capable of generating power up to 2.4kW and a lithium-ion battery during the eclipse.

This series has payloads that operate on L1, L5 and S bands thereby widening its services.

The L1 navigation band is popular for providing Position, Navigation and Timing (PNT) services for civilian users and for interoperability with other Global Navigation Satellite System (GNSS) signals, ISRO said. Monday's success came after the GSLV F10 debacle, as an anomaly in the cryogenic stage of the launch vehicle in August 2021, following which the then mission could not be fufilled.

Be that as it may, ISRO had used imported atomic clocks on all the nine navigation satellites it had launched earlier. Each satellite had three atomic clocks

It was said the NavIC satellites were performing well until the atomic clocks in IRNSS-1A failed.

Sources in ISRO had earlier said some of the atomic clocks in a couple of other satellites too were not functioning properly. The clocks are used for precise time and location.

Currently there are eight first generation NavIC satellites in orbit.

"They were heading towards Andarpur from Matrubhawan when they couple couldn't proceed as the road was closed. There was no warning about the under-construction open end of Taladanda. Ignorant about the open end, the man (Gyanaranjan) reversed the vehicle which veered into the canal, said an eye witness who was first to inform the police.

Police reached the spot and recovered a lifeless Gyanaranjan and his injured wife.

Anjana is undergoing treatment at SCB Medical College and Hospital (SCBMCH). The vehicle has been brought out of the canal. Rs 2 lakh in cash has been recovered from the car," said ACP Amarendra Panda.

# 1,500 new bridges on cards: Minister

Bhubaneswar, May 29: In a bid to boost rural connectivity, the state government is planning to construct 1,500 new bridges under Biju Setu Yojana (BSY) with an outlay of Rs 6,000 crore in the next 5 years. This was revealed during a review meeting taken by Chief Minister Naveen Patnaik here Monday.

Patnaik reviewed the progress of Rural Development (RD) department as part of the department-wise performance review. After the review, RD Minister Pritiranjan Gharai and principal secretary Sanjay Kumar Singh presented the details of the achievements against the promises made in the election manifesto and highlighted the transformational initiatives taken by the department.

Addressing a press meet held at Geeta Govinda Sadan, Gharai said that the department budget has increased 25 times to Rs 7,500 crore in 2023-24 as against Rs 305 crore in 2000-2001.

Till date, the department has constructed 2,241 bridges under different schemes while another 1,304 bridges are at various stages of construction. In the road sector. 1,03,731 kms are maintained by the department by providing allweather connectivity to 18,161 habi-

tations. More than 10.000-km roads have been constructed using green technologies. Similarly, 8,700 buildings of Odisha Adarsha Vidyalayas (OAVs), Industrial Training Institutes (ITIs), colleges & schools, multipurpose cyclone shelters and Health department buildings have

been constructed. As against the manifesto for 2019-2024, commitments were made for 750 bridges under BSY and the department has so far constructed 679 bridges. However, 900 bridges will be constructed by March 2024.

Similarly, 6,247-km roads have been constructed under Mukhya Mantri Sadak Yojana (MMSY) and other State Plan schemes against the commitment of 3,000 km.

The department also targets to construct another 6,000-km roads under MMSY by March 2024.

This apart, 27,079 km of roads have been constructed under PMGSY while the department targets to construct another 7,643 Km under PMGSY by March 2024 totalling 34,722 kms.

Highlighting the transformational initiatives of the department, the minister said that till 2000, the department had constructed only 58 bridges.

At present, the department has constructed 2,241 bridges while another 1,304 bridges are at various stages of construction.

# **Disappearing Jajpur** wetlands spark concerns

WETLANDS ARE IMPORTANT AS THEY MAINTAIN BIO-DIVERSITY AND ALSO HELP IN WATER CONSERVATION



#### POST NEW NETWORK

Jajpur, May 29: The fast disappearance of wetlands in this district has become a cause for concern. The wetlands play an important role in maintaining bio-diversity, helps in water conservation and purification and also in controlling floods. They also hold the key to climate regulations

However, now the very existence of the wetlands is in danger due to change in land status, discharge of solid and liquid wastes by industrial firms that have mushroomed in the district. Also pollution is eroding and destroying wetlands rapidly Environmentalists have pointed out that wetlands need to be safeguarded for protecting the environment.

As per reports Jajpur district is spread over an area of 2.885 square kilometres. Out of this total area, 15,714 hectares are wetlands. Among them, 380 wetlands are more than 2.25 hectares in size while the remaining 2,169 are less than 2.25 hectares.

and Climate Change Ministry directed all state governments March 8. 2022 to identify and demarcate the wetlands on the basis of Wetland **Conservation and Management** Rules-2017. It should be stated here that the State Wetland Management Authority (SWMA) held its last

meeting, August 17, 2019. During the meeting a technical committee was formed comprising officials of Forest and Environment, Water Resources, Housing and Urban Development, Panchayatiraj and Drinking Water, Revenue and Disaster Management and Fisheries departments. The panel was asked to identify all the wetlands in Odisha and submit a report so that a special action plan could be prepared for their protection and preservation. However, the efforts of the committee have been pretty disappointing to say the least.

The Union Forest, Environment and Climate Change Ministry had included Sukinda creek (Pata) in the Wetland Atlas of India in 2010.

It had shown that the wetland was spread over 400 acres even though the record of the Odisha government says that 'Sukinda Pata' encompasses an area of 6,000 acres. The Sukinda creek is found on land belonging to the Solagadia, Labang, Sorisha, Marthapur, Baliposhi, Gotua, Kimbhiragadia, Marutikar, Jagadiha and Chakua revenue mouzas. It extends from the west of Brahmani river to Jokadia and Mundomal in the east. Nothing was done however, to rectify the mistake in the Wetland Atlas.

The Gonda nullah, which is alwavs in the news for pollution due to discharge of toxic effluents by industrial firms, originates from the hills in Sukinda and neighbouring Keonjhar district. During floods, the Sukinda creek remains submerged in the water of Gonda nullah. Moreover, the district has also several other prominent wetlands like Mantira Pata, Gadamadhupur Pata, Jenapur Pata, Sorisha Pata and Bena Pata. However, these wetlands are slowly losing their existence as development works are being undertaken. The importance of wetlands in

maintaining bio-diversity and environment cannot be ignored. Various plants, insects, aquatic animals, reptiles, birds, fishes and mammals depend on these wetlands for their habitat and food Members of Kalinganagar Surakshya Samiti have demanded action to protect the wetlands in

Jaipur district. They have written to the Principal Secretary, Forest, Environment and Climate Change Ministry, Jajpur Collector and DFO, Cuttack to look into the matter and restore the wetlands to their original glory.

## BJP woman leader murdered in Keonjhar

Keonjhar, May 29: Miscreants allegedly bludgeoned a lady BJP leader to death at Binida village, under Pandapada police limits and Ghatagaon block in this district, late Sunday night. The deceased was identified as Satyabhama Singh (45), a former samiti member of Binida panchayat and BJP vicepresident of Pandapada zone. She is also a pala artiste and had carved a niche for herself in the district with her performances.

It is suspected that Satyabhama might have been murdered either over personal enmity or political rivalry. Sources informed Monday that she was not on good terms with another fellow pala artiste. The killing has spread shockwaves in the area.

On being informed, police recovered her body from a ground



about 100 metres away from her residence, Monday. Keonjhar Sadar SDPO Mahendranath Murmu, Pandapada police sub-inspector Ramachandra Mohanta reached the spot and launched an investigation into the murder. A forensic team was also pressed into serv-

ice. The SDPO said that very soon the accused will be identified and arrested. The actual reason behind the murder can be ascertained only after the post-mortem report is available, the SDPO added. As per the police report,

Satyabhama had gone to a nearby Radha Krishna temple to participate in a 'Sankirtan' performance, Sunday evening leaving behind her elderly mother at home. The programme got over around 9.30pm and all the performers left for their respective residences. Satyabhama's mother initially waited for her, but then went off to sleep thinking that she might have stayed back at the temple.

Satyabhama's death came to the fore only after some villagers spotted her body lying in a pool of blood near her residence. Later her family members informed the police regarding the murder. It is suspected that more than one people might be involved in the crime.

A delegation of BJP members led by Maheswar Sahu, president of 'Nari Surakshya Samiti' visited the village Monday to meet the bereaved family. Sahu demanded a proper probe into the case and arrest of the persons involved in the gruesome murder.

Sources said that in the first phase 4,000 saplings were planted while in the second, the remaining 20,000. They pointed out that after the saplings were planted, Forest department staff failed to take care of those in a proper manner. During investigation, it was found that fencing put around the plantation area had also snapped enabling entry of domestic animals. They ate up a sizeable portion of the saplings. Locals have demanded a probe into the misappropriation of funds and stringent action against erring officials. The then forester Malaya Sahu said that the saplings withered as it did not rain for a period of over six months. Anandapur DFO Abhaya Kumar Dalai pointed out that the scorching heat has resulted in destruction of a large number of saplings. He added that the Forest de-

he BJP never tires of accusing the Congress and other Opposition parties of internationalising the Kashmir issue. But, the Centre has needlessly tried to do the same by organising the three-day-long G20 tourism working group meeting in Srinagar last week. The ostensible reason for taking over 60 delegates from G20 countries there was to showcase Jammu & Kashmir and Ladakh as a peaceful territory with huge potential for investment. If economic wellbeing is one of the main agenda of G20, the entire country, as a profitable destination, should have been promoted and not just one state. That makes the very attempt, to make J&K the focus of the tourism meet, suspect.

Much before the event took place, Pakistan had first tried to raise the issue of the abrogation of Article 370 and bifurcation of the former state of J&K as an illegal act. The Indian response of not bothering about the hue and cry made by Pakistan on the ground that the latter does not belong to the G20 group is inconsequential. The fact that Pakistan could drag the Kashmir issue into international focus discredits the Indian government somewhat. Predictably, China followed Pakistan and sought to reinforce Pakistan's arguments with the claim that the event was being organised in a disputed territory. Both Pakistan and China had previously made unwarranted references to the conversion of J&K state into an Union Territory.

This resulted in China promptly announcing its boycott of the meeting. This had a chain reaction in the international arena and Turkey and Saudi Arabia sent out signals they were following in the footsteps of China.

What is even worse is that the government's action gave the UN special rapporteur on minority issues, Fernand de Varennes, an opportunity to slam the Centre's handling of the Kashmir imbroglio. Criticising the venue of the meeting he said the meeting would support a "facade of normalcy" while "massive human rights violations" continue in the region. India's mission at the UN in Geneva rejected the statement as "baseless" and "unwarranted allegations." But, the whole episode was uncalled for.

That the narrative of peace and stability in J&K since the abrogation of Article 370 is suspect was unnecessarily brought under international scrutiny. For the G20 tourism meet India's elite National Security Guard, including its counter-drone unit and marine commandos, were deployed to help the police and paramilitary forces to secure the event venues. The main city of Srinagar appeared calm as the event started. The roads were unusually clean. Most of the usual security checkpoints had been removed or camouflaged with G20 signs. Officials said hundreds of officers were specially trained in what they called "invisible policing" for the event. However, authorities did not take chances and shut many schools in the city.

The measures taken during the programme contrasted sharply with the visible security imposed in the days before the event. A massive security cordon was placed around the venue on the shore of Dal Lake, with elite naval commandos patrolling the water in rubber boats. The city's commercial centre was spruced up.

It would be naive for the Centre to think that international delegates would have been convinced with a stage managed show that peace had returned to the region. The G20 includes the world's 19 wealthiest nations plus the European Union, together accounting for 85% of global economic output and two-thirds of its population.

India has got the responsibility of hosting the G20 summit as a routine rotational chair system. But, the BJP-led-government has been from the beginning projecting it as if it is an international recognition of Prime Minister Narendra Modi's leadership. The reason is not far to seek. Lok Sabha election will be held in 2024 and the government has failed on the economic front with a series of disastrous policies, including an ill-conceived demonetisation, botched up GST and record unemployment. The G20 summit offered an opportunity to the government to divert the people's attention from the bread and butter issues and project their mascot as an international leader. However, the fallout for India on the long run has been bad.

AI can perform tasks that individuals are loathe to do. It can also deliver education and health care to millions of people who are neglected under existing frameworks. And it can greatly enhance research and development, potentially ushering in a new golden age of innovation. But it also can supercharge the production and dissemination of fake news; displace human labour on a large scale; and create dangerous, disruptive tools that are potentially inimical to our very existence.

Specifically, many believe that the arrival of artificial general intelligence (AGI) - an AI that can teach itself to perform any cognitive task that humans can do will pose an existential threat to humanity. A carelessly designed AGI (or one governed by unknown 'black box' processes) could carry out its tasks in ways that compromise fundamental elements of our humanity. After that, what it means to be human could come to be mediated by AGI.

Clearly, AI and other emerging technologies call for better governance, especially at the global level. But diplomats and international policymakers have historically treated technology as a "sectoral" matter best left to energy,

After all, AI and other emerging technologies will dramatically change the sources, distribution, and projection of power around the world. They will allow for novel offensive and defensive capabilities, and create entirely new domains for collision, contest, and conflict including in cyberspace and outer space. And they will determine what we consume, inevitably concentrating the returns from economic growth in some regions. industries, and firms, while depriving others of similar opportunities and capabilities

open societies possibly at stake, it is in democratic countries' interest to develop a common approach to AI regulation. Governments are now acquiring unprecedented abilities to manufacture consent and manipulate opinion. When combined with massive surveillance systems, the analytical power of advanced AI tools can create technological leviathans: all-knowing states and corporations with the power to shape citizen behaviour and repress it, if necessary, within and across borders. It is important not only to support UNESCO's efforts to create a global framework for AI ethics, but also to push for a global Charter of Digital Rights.

The thematic focus of tech diplomacy implies the need for new strategies of engagement with emerging powers. For example, how Western economies approach their partnerships with the world's largest democracy, India, could make or break the success of such diplomacy. India's economy will probably be the world's third largest (after the United States and China) by 2028. Its growth has been extraordinary, much of it reflecting prowess in information technology and the digital economy. More to the point, India's views on emerging technologies matter immensely. How it regulates and supports advances in AI will determine how billions of people use it.

Engaging with India is a priority for both the US and the European Union, as evidenced by the recent US-India Initiative on Critical and Emerging Technology (iCET) and the EU-India Trade and Technology Council, which met in Brussels this month. But en suring that these efforts succeed will require a reasonable accommodation of cultural and economic contexts and interests. Appreciating such nuances will help us achieve a prosperous and secure digital future. The alternative is an AI-generated free for all.

his is connected with Native Americans, though nobody seems to know quite how. The first reference that we have is from a book with the title A Snow Storm as it affects the American Farmer, which was written by a French-American farmer named J H St John de Crèvecoeur in about 1777. In it he said "Then a severe frost succeeds which prepares it to receive the voluminous coat of snow which is soon to follow; though it is often preceded by a short interval of smoke and mildness, called the Indian Summer". There are several explanations for where the phrase came from, mostly put forward in the early nineteenth century, which suggested the term was of sufficient antiquity by then that its origin had gone out of living memory. William and Mary Morris suggest it came about because the word "Indian" had been adopted as a term among early colonists to describe something false, or a poor imitation of the real thing, as in Indian corn or Indian tea. Whatever the reason, this name for a short period of fine weather at the end of autumn is now the standard term, even in Britain, where older names such as St Luke's summer. St Martin's summer or All-Hallown Summer are now obsolete or rare.

#### Informavore

his word is always applied to human beings. By analogy with terms like herbivore and carnivore, it seeks to suggest that we are a species that lives by processing and communicating information. It's not a particularly appropriate linguistic analogy as a matter of fact, as the only thing all these words have in common is the suffix -ivore. That's a close relative of our voracious, and comes from the Latin vorare "to devour". So it properly refers to consumption rather than manipulation. Though it's sometimes said that we humans devour information, we actually process it, not consume it. Cognitive scientists usually take informavore to refer to our ability to manipulate representations of the outside world inside our heads and to transmit information to each other through language. These are regarded by many as the crucial abilities that distinguish modern humans from all other species. The word is sometimes used in connection with the huge growth in information media in the developed countries in the latter part of this century.

Even it has inflicted war on some countries, and spurred terrorist activities. It preaches to other countries how to manage their economies and avert sovereign debt default. But it is never free from economic crises because of its capitalistic system that strives on deceit, fraud, exploitation and greed.

Recently the US economy was inundated by a banking crisis with three major banks collapsing or taken over by other financial behemoths. Now, the looming debt ceiling crisis threatens the supremacy of US economy and darken its economic horizon.

In other words, in January 2023, US debt ceiling crossed its maximum limit of \$31.4 trillion. If the US doesn't raise debt ceiling, the treasury may run out of cash and the country may defaults in loan payments.

In order to raise debt ceiling, approval of Congress is necessary. But Republicans, who lead the narrow majority in the House of

House Republicans are stubborn and demanding cuts of up to \$130 billion, with spending next year capped to 2022 levels. They also want a clawback of unspent pandemic aid dollars. But they don't want to cut military expenditure. This means health, education and other social security and welfare expenditure will be trimmed which will have detrimental impact on poorer sections of society. But Democrats rejected the proposed cuts and want the Republicans to sign off on a no-strings-attached hike, as they have dozens of times in the past increased debt ceiling too.

If the problem is not solved and the US defaults, the impact would be vicious, destructive to the US economy in particular and world economy as a whole. Experts predict the US credit rating would get hit and GDP would decline.

Interest rates have already been steadily rising due to 10 consecutive rate hikes by the Federal Reserve to tame inflation. Another shock like a debt default would increase interest rates further and likely trigger a recession. The cost of borrowing may be too high which will squeeze economic activities and investment. Tax payers

ket would also be devastatingly affected. The stock prices would also likely plummet and cause havoc on retirement savings. Moody's predicted that under a prolonged default scenario, stock prices would plummet by one-fifth, obliterating about \$10 trillion in household wealth. An estimated 2.7 crore Americans would be dragged into poverty without social security.

The real solution to tackle the current gridlocked situation is to raise resources by taxing the rich and the corporates. One of the main reasons for the US debt crisis is cutting the tax both for the rich and the corporates as part of tickle down theory since the Regan era in the 1980s. Trickle-down theory is an economic strategy where taxes levied on the high-income group are curtailed. This theory is based on the belief that huge corporations, wealthy individuals, entrepreneurs, and investors would reinvest tax savings to generate more employment opportunities. But this is not true.

In 1981, Regan reduced tax rate from 70 per cent to 50 per cent, but in two years revenue collections declining 9 per cent. Bush (2004-2012) was also responsible for massive tax cuts that led to deficit and increase

from 39.5 per cent to 35 per cent. Donald Trump also resorted cutting tax to benefits of rich and corporates. In his era of tax cuts, Democrats say, \$3.5 trillion debt has been added. Pandemic stimulus package is also another cause for spike in the debt. The US had budget surplus of \$ 0.24 trillion in 2000. Due to tax cuts and concessions to rich and corporates in 2022, the budget deficit reached \$1.367 trillion. The higher deficit means higher borrowing. To accommodate higher debt due to revenue losses spurred by tax cuts, the US Congress had to in-

crease debt ceiling umpteenth times. Tax cuts for affluent individuals and corporates adversely affect the economy by raising inequality. Now America is paying a heavy price for embracing tax cuts for the rich. Other countries including India emulating the us are facing mammoth inequality. Now is the time to tax the rich and borrow less. Only the rich are benefited by debt induced growth while the poor bear the burden through cut in welfare expenditure.

New Delhi, May 29: The Election Commission has asked chief electoral officers of poll-bound states of Madhya Pradesh, Chhattisgarh, Telangana, Rajasthan and Mizoram to carry out a fresh

special summary revision to update the electoral rolls. In its May 24 dated letter to the five chief electoral officers (CEOs), the poll body said the assembly polls in these states are "due later this year" It also cited provisions of

the Representation of the People Act to state that the electoral roll should be revised with reference to the qualifying date before each assembly election of a state. Till recently, January 1 was the only qual-

ifying date for those turning 18 to regist as voters, but following changes in the ele tion law, January 1, April 1, July 1 a October 1 are the four cut-off dates no Earlier, those turning 18 on or after Janua 2 year had to wait for the entire year to re

ister as voters. The term the legislative assembly Mizoram ends December this year. The Mizo Nation Front is in power in t northeaster state.

New Delhi, May 29: Congress leaders from Delhi and Punjab met the party leadership here in separate meetings Monday, and suggested them not to support the Aam Aadmi Party on the Delhi services Ordinance issue, sources said. Congress president Mallikariun Kharge had convened a meeting of leaders from both states on seeking their opinion on the matter. Former Congress president Rahul Gandhi was also present during

the meetings. The sources said a majority of the leaders told the leadership to have no truck with Arvind Kejriwal, calling him a "Bteam" of the BJP and claiming he harmed the Congress' interests not only in Delhi and Punjab but other states as well. Sources said the meeting comes in the wake of Kejriwal requesting a meeting with Kharge and Gandhi to seek their support against an Ordinance brought by the Centre which effectively nullified a Supreme Court order that gave to the Delhi government the power of transfer bureaucrats in the city.

Kharge has reportedly conveyed to Keiriwal he will take a call on the matter after having a word with state party leaders. The sources said the Congress leadership will also meet party leaders from other states before deciding its position. Puniah Congress president Amrinder Singh Raja Warring told reporters after the meeting they have put across their views before the party high command and left the final decision to it. "All the leaders have said the party high command will decide and we have left it to party chief Mallikarjun Kharge to take the final decision," Raja Warring told reporters after the meeting.

## Use lesser groundwater in farming in Bengal: Study

Kolkata, May 29: A recent study by a group of environmental scholars and researchers from two leading institutions from West Bengal and one from Australia has suggested lesser use of groundwater in farming to prevent arsenic exposure for farm products, especially in case of rice.

The study paper by scholars and researchers from the School of Environmental Studies, the National Institute of Biological Genomics and Australia's University Of Newcastle pointed out that since groundwater is more prone to arsenic exposure, farm products produced by using that

water also become prone to the

To prevent this, the report has suggested stressing on rainy season farming so that rainwater can be used. This remedy is extremely important considering that West Bengal is among those states which have extremely high arsenic concentration in groundwater. Historically as many as 83 blocks scattered over seven districts in West Bengal have arsenic levels in groundwater higher than the permissible limits.

The report, published in science magazine "Environmental Science & Pollution Research", suggests if rice is cooked using arsenic-free water equivalent to three times of the quantity of rice being cooked, the level of arsenic



exposure in that cooked rice comes down substantially. It has also suggested that since

selenium acts as instruments for combating arsenic, selenium fertilisers should be extensively used while paddy farming. The research on this count was

conducted on paddy varieties collected from Kolkata, North 24 Parganas, and West Midnapore. The research has revealed that of these varieties collected, the danger of arsenic exposure is maximum and also alarming in North 24 Parganas. While that from Kolkata is prone to moderate exposure, the one from West Midnapore is relatively safe on this count.

In 2020, following a reach jointly conducted by the West Bengal Agriculture Department and National Botanical Research Institute of Lucknow, the state government announced the development "Muktoshri", a variety of rice that is resistant to arsenic.

## Tourists heading to Shimla to escape heat

#### Shimla, May 29: Occupancy in hotels has increased to about 90 per cent in Shimla during the weekend as vacationers are making a beeline to the 'queen of hills' to escape the scorching heat.

While the hotel occupancy here went up Saturday, the summer rush during weekdays is yet to pick up, vice president of Shimla Hotel and Restaurant Association Prince Kukreja said.

The peak summer tourist season starts from April 15 onwards till June 15 in Himachal Pradesh. The summer vacations in the schools in the plain areas also start from May end and a large number of people take to the hills to beat the heat.

The majority of the people are coming on short notice and there is a decline in advance bookings, Kukreja said. The room occupancy is about 80-90 per cent on weekends but it drops to 30-40 per cent during the weekdays, said M K Seth, president of the **Tourism Industry Stakeholders** Association.

A total of 1,57,335 vehicles entered and exited Shimla from Shoghi Barrier on Chandigarh-Shimla road since May 22 out of which 30 per cent of vehicles (46.998) moved

He said that the accommoda tions running without permission and under 'Bed and Breakfast' (B&B) schemes have become a bane for the hotel industry in Shimla. The tariffs of registered hotels are fixed by the Tourism Department but the online operators are booking rooms in private flats, homes, bungalows, and villas and misleading the tourists by offering heavy discounts, hitting the hotel industry hard, Seth said

Shimla, May 29: A majority of Himachal Pradesh's population lives in rural areas and is directly or indirectly associated with agriculture and double their income, the government is promoting integrated and holistic agricultural activities under the Him Unnati scheme.

Kolkata, May 29: West Bengal Chief Minister Mamata Baneriee's proposal to create a 'Green Cracker' cluster in the state to accommodate the workers currently employed in the mushrooming illegal fire-cracker factories has raised the eyes of the environmentalists.

They feel that it is doubtful how far the Chief Minister's proposal will be practical, considering the

sound decibel norms imposed by the West Bengal Pollution Control Board (WBPCB) According

to environmentalist and green technologist Somendra Mohan

Ghosh, while regular fire-crackers emit around 160 decibels of sound, green crackers produce between 110 and 125 decibels of sound.

"However, the WBPCB imposed sound limit for crackers in the state is 90 decibels. In such a sit-

uation, the question is how to build the cluster that will ensure manufacturing of green crackers within the prescribed sound decibel limit," he said.

In fact, in October last year, a section of WBPCB officials too had expressed apprehension over green crackers coming from outside the state to be noisier than the prescribed sound decibel limit in West Bengal. Environmentalists like Ghosh admit that often

## Prince Dwarkanath Tagore's favourite well restored

Kolkata, May 29: Maheshmunda in Jharkhand is more than 300 km from Kolkata (Howrah) by rail. No rail link existed between this nondescript location (now a census town) and the then capital of the British Raj 200 years ago.

Yet, pots of water from a certain well in Maheshmunda would make their way to the Jorasanko Thakurbari in central Kolkata -birthplace of Nobel laureate Rabindranath Tagore -- to meet the whims of Prince Dwarkanath Tagore who believed that the water was pure and helped in digestion. Prince Dwarkanath Tagore was

the grandfather of Rabindranath Tagore and among the first Indians to plan a railway line in the country way back in the 1840s.

His company Carr, Tagore and Company was subsequently merged with East Indian Railway (EIR) predecessor of Eastern Railway (ER) -- that finally launched rail services from Howrah in 1854,



nearly eight years after his death. Maheshmunda is now a rail station in the Madhupur-Giridih Section of ER's Asansol Division and that well that has water with 'medicinal properties' is part of it. No wonder, ER has restored it.

"We have no clue whether the water of this well has medicinal properties but people from far and wide do travel to Maheshmunda to taste it. "Till a few years ago, when water pipelines had not been laid, this well would serve the needs of the local population. It is also true that a section of the Bengal gentry would travel to Madhupur and Giridih for a change of air (hawa bodol) and a taste of the water that supposedly improved their diges-

15 year old son to break her down. Besides rape, torture also forms an intrinsic part of the 'treatment' meted out to the minor. Investigators speak of at least ten cases and suspect very many more as their net widens to pull in many more on the rim. The racket which has spread its tentacles into neighbouring Maharashtra and Rajasthan has been flourishing unhindered in Gujarat for almost a decade as the case of one of the minors sold into marriage to 15 men over eight years brings out. A veritable market auction was being carried out at some place on the Rajasthan side of the Gujarat-Rajasthan border with aagents from across the country involved in the bidding process. The price ranged anywhere from ₹2 to 4 lakhs.

According to senior journalist DP Bhattacharya who had extensively reported on the demographic changes taking place in the coastal district of Kutch said that in the decade ending 2012 hundreds of bangla-speaking muslim women

had been trafficked from Bengal and Bangladesh to Kutch where they were sold as brides to meet the unmarried's hunt for wives propelled by a skewered sex ratio.

However the Ahmedabad racket under police investigation differs from the Kutch case as it has dark criminal antecedents. The married minors were kept track of by the criminal masterminds and at an appropriate time after they had won the confidence of the family, they were forced to decamp with cash and valuables, in effect, turning them into accomplices in crime. The investigating teams are still to trace the bulk of the minors, though the kingpin has admitted that many of these trafficked minors were forced into marriage twice in the course of an year.

#### Saudi executes two Bahraini men

Kyiv, May 29: Explosions rattled Kyiv during daylight Monday as Russian ballistic missiles took aim at the Ukrainian capital, hours after a more common nighttime barrage of the city by drones and cruise missiles.

Russian forces fired 11 ballistic and cruise missiles at Kyiv at about 11:30 a.m. (0830 GMT; 4:30 a.m. EDT), according to Ukraine's chief of staff. Valerii Zaluzhnvi. All of them were shot down, he said, and puffs of white smoke could be seen in the blue sky over the city from street level.

Debris from the intercepted missiles fell in Kyiv's central and northern districts during the morning, landing in the middle of traffic on a city road and also starting a fire on a building's roof, the Kyiv military administration said. At least one civilian was reported hurt.

#### Uganda enacts harsh anti-LGBTQ law

Kampala (Uganda), May 29: Uganda's President has signed into law tough new anti-gay legislation supported by many in this East African country but widely condemned by rights activists and others abroad.

Ukrainian Foreign Minister Dmytro Kuleba warned against indifference, saying the repeated strikes on civilian areas amounted to "war crimes." "Russia's drone and missile attacks on peaceful Ukrainian cities cannot be seen as usual, no matter how frequent they grow," he tweeted in English.

The coast guard issued a safety warning for ships in the area on those dates because of the possible risks from falling debris. Japan's coast guard coordinates and distributes maritime safety information in East Asia, which is likely the reason it was the recipient of North Korea's notice.

To launch a satellite into space, North Korea would have to use long-range missile technology banned by UN Security Council resolutions. Its past launches of Earth observation satellites were seen as disguised missile tests.

Japan's Chief Cabinet Secretary irokazu Matsuno said the launch

would violate UN resolutions and

was a "threat to the peace and safety of Japan, the region and the international community." Japan has already been on standby for falling missile debris from North Korean launches earlier this year and has deployed missile defence systems such as land-to-air PAC-3 and ship-to-air SM-3 interceptors in southwestern Japan

and in the East China Sea. Matsuno said it was possible the satellite would enter or pass above Japan's southwestern islands including Okinawa, where the United States has major military bases and thousands of troops. South Korea warned Monday that North

Korea will face consequences if it goes ahead with its launch plan in violation of the UN Security Council resolutions that ban the North from conducting any launch using ballistic technology.

"Our government strongly warns North Korea against a provocation that threatens peace in the region and urges it to withdraw its illegal launch plan immediately," a ministry statement said. It said South Korea will cooperate with the international community to resolutely cope with any North Korean provocation.

Earlier this month, North Korean state media reported leader Kim Jong Un had inspected a finished military spy satellite at his country's aerospace centre and approved the satellite's launch plan. Monday's launch notice did not specify the

He said his son will be replaced with another secretary, Takayoshi Yamamoto, on Thursday.

Kishida acknowledged that he had briefly greeted the guests but said he didn't stay at the dinner party. He said he severely reprimanded his son for the party, but that failed to quell ongoing criticism from opposition lawmakers andpublic outrage which have pushed down his support ratings.

## Nepal honours climbers to mark 70th anniv of Everest conquest

Kathmandu, May 29: Nepal honoured record-holding Sherpa guides and climbers Monday to celebrate the 70th anniversary of the first ascent of Mount Everest by Edmund Hillary and Tenzing Norgay.

On May 29, 1953, Hillary, a beekeeper from New Zealand and his Sherpa guide Norgay scripted history by becoming the first human beings to scale the treacherous terrains of the world's highest moun-

tain peak. Thousands of Sherpa guides and government officials participated in a rally here to mark the 70th anniversary. They waved banners that read "Save the Himalayas." Among those honoured include Sherpa guides Kami Rita, who climbed Everest for a record 28 times, and Sanu Sherpa, who climbed all the world's 14 highest peaks twice.

Hari Budha Magar, who became the first double above-the-knee amputee to climb Everest, was also honoured by Nepal's Tourism Minister Sushila Sirpali Thakuri.

On the occasion, a silver badge encrypted with the logo of Everest was distributed to dozens of Nepalese and foreign Everest summiteers. Those receiving the badge include an Indian citizen, who climbed the 8,848.86 metres-high Everest in 2021. Russian, North American and

French climbers were also bestowed with this honour."For the first time, we are honouring local and foreign climbers who have climbed Everest with medals," Mohan Lamsal, the general secretary of the Nepal Mountaineering Association, said.

A special programme was also organised to honour the families

of Norgay and Hillary, officials said. Since their herculean efforts seven decades ago, 7,621 mountaineers have scaled Everest.

Over 600 have scaled Everest during this spring season, according to Nepal's Department of Tourism. The climbing season begins in March and ends by the end of May, following which monsoon winds and melting temperatures make it hazardous for climbing.

Nepal has so far opened 414 mountains for climbing. Eight of the 14 mountains higher than 8,000 metres in the world are in Nepal. In commemoration of the day when Hillary and Norgay climbed Mt Everest, the Nepal government celebrates May 29 every year as Mt Everest Day.

New Delhi, May 29: The solar capacity addition in India fell by 48 per cent year-on-year to 1.9 GW in January-March period of 2023. according to Mercom India Research.



The country had added 3.6 gigawatt (GW) of solar capacity during the same period in 2022, the research firm said in its latest report.

"India added 1.9 GW of solar capacity in the first quarter of calendar year 2023, a 48 per cent decrease year-over-year (YoY) compared to the 3.6 GW added in Q1 2022," the report titled 'Q1 2023 India Solar Market Update' said.

On a quarter-on-quarter (q-o-q) basis, the installations were 30 per cent lower compared to the 2.7 GW solar capacity installed in October-December period or fourth quar-

Out of 1.9 GW, large-scale solar projects accounted for 74 per cent of installations, with rooftop solar making up an additional 26 per

India's cumulative installed solar capacity currently stands at 64.5 GW. As of March 2023, the country's utility-scale project development pipeline stood at 58 GW, with an additional 58 GW of proj-

an important milestone in 2022, setting a new record with 13 GW of capacity added.

However, in 2023 the additions are expected to be lower as commissioning deadlines for several projects have been moved to next\_ year. Besides, a number of projects are facing delays due to land and transmission issues. Mercom India said.

New Delhi, May 29: Foreign direct investment (FDI) into India declined by 22 per cent to \$46 billion in 2022-23, dragged by lower inflows in computer hardware and software, and automobile industry, according to the Department for Promotion of Industry and Internal Trade (DPIIT) data.

The FDI inflows stood at USD 58.77 billion during 2021-22.

Total FDI inflows, which include equity inflows, re-invested earnings and other capital, declined by 16 per cent to \$70.97 billion in the last fiscal as against \$84.83 billion in 2021-22.

During April-March 2022-23, Singapore emerged as the top investor with \$17.2 billion FDI.

It was followed by Mauritius (\$6.13 billion), the US (\$6 billion), the UAE (\$3.35 billion), the Netherlands (\$2.5 billion), Japan (\$1.8 billion), UK (\$1.73 billion), Cyprus (\$1.27 billion), Cayman island (\$772 million), and Germany (\$547 million), the data showed.

The FDI inflows have contracted in 2022-23 from Mauritius, the US, the Netherlands, the Cayman Islands, and Germany.

tious in the pursuit of their growth strategies, pricing and portfolio composition.

Over-aggressive growth, underpricing or over-pricing of products both on the credit and deposit sides, concentration or lack of adequate diversification in deposit/ credit profile can expose the banks to higher risks and vulnerabilities," he said.

The governor also said that while the Reserve Bank has nudged banks to adjust their business strategies in some cases where they were creating "avoidable vulnerabilities" by being aggressive, the central bank does not interfere in the commercial decisionmaking of the banks.

Employees cannot be rewarded for increasing short-term profits without adequate recognition of the risks and long-term consequences, Das said.

In the remarks that come weeks after turbulence in the American banking sector, Das also asked bank boards to be wary about basic aspects like asset-liability mismatches, saving as suboptimal ALM can lead to serious liquid-ity risks and destabilising effects on the bank itself.
