

Audi chaiwalas give a taste of luxury

Mumbai, June 2: While most people associate a high-end car like Audi with luxury and comfort, for Mannu Sharma and Amit Kashyap, it proved to be an inspiration to set up their own tea stall.

Sharma and Kashyap have been selling tea for ₹20 from the trunk of the luxury car, worth ₹70 lakh, in the plush neighbourhood of Lokhandwala in the western suburb of Andheri for the last six months and they recently went viral on social media. The cutting chai is a staple on the streets of Mumbai and is available at humble establishments called 'tapris' (stalls) throughout the city.

"We were just taking a stroll at night and craving a cup of tea, but we could not



find a place at the time. That's when we thought of opening our own stall here," said Sharma, who hails from Haryana.

It is not just the duo's unique idea of selling 'OD Tea', short for on drive tea, from their Audi that has gone viral on social media, but it is also the taste of their product that has drawn customers. "I have been coming here to have tea for the last two months because it tastes amazing. Every time I pass by this area, I have to have their tea," one of the customers said.

Before starting their tea venture, Sharma who hails from Hisar, Haryana was a working professional in Africa, while Kashyap, a native of Punjab, is now a stock market trader by morning and a tea seller by evening.

"By selling tea in our Audi, I think we have proved wrong the thinking that only people who are financially not very well off take to selling tea. A person who rides a cycle also consumes tea and a person who drives a Jaguar can also enjoy our tea," Sharma said. The two friends are now basking in the love that they have received on social media and from their customers, and plan to open 'OD tea' franchises in the future, starting in Mumbai.







Bhubaneswar, June 2: The state government has disbursed more than ₹11,600 crore to farmers under Krushak Assistance for Livelihood and Income Augmentation (KALIA) scheme since 2018.

This was revealed by Agriculture & Farmers' Empowerment Minister Ranendra Pratap Swain after a review meeting chaired by Chief Minister Naveen Patnaik here Friday.

Swain informed the media that KALIA scheme was introduced in 2018 to provide support to cultivators for cultivation for small and marginal farmers and livelihood support for landless agricultural households for taking non-farm activities

Till now, 43.04 lakh small and marginal farmers, 18.72 lakh landless agricultural households and 1,624 students have been assisted under the scheme. Financial assistance of more than ₹11,600 crore has been extended for the purpose, he said.

Odisha has been transformed from a net food grain deficit state into a surplus state. Now, Odisha is the fourth largest contributor to the paddy procurement pool of Food Corporation of India (FCI), he said. The minister said that food grain production in the state reached 136.07 lakh tonne in 2022-23, a twofold rise as compared to 55.35 lakh

tonne in 2000-01. Similar progress has also been achieved with regard to vegetable production in the state that touched a high of 98.52 lakh tonne during FY 2022-23 which is almost thrice that of 33.37 lakh tonne vegetables produced during 2000-01, Swain

Swain attributed the significant rise in production to state government's initiatives.

'Early breeding programme was introduced for fish seed availability. Biofloc Technology (BFT) was introduced to enhance fish production up to 30 times more than pond aquaculture. Until now. 12.035 biofloc tanks have been established. Reservoir Cage Culture Policy has been introduced to lease out reservoirs to entrepreneurs for cage culture," the F&ARD minister said.

Odisha has become self-sufficient in poultry meat production. The state has recorded a 21 per cent rise in poultry meat production – from 102 thousand tonne in 2019-20 to 123 thousand tonne in 2022-23, Swain said.

Swain attributed the growth in production to introduction of multiple poultry development schemes by state government. At least 4,000 women self-help groups (SHGs) have established broiler farms in the last three years.

"Easing out of application process has been made for establishment of poultry units through GO-SUGAM. Odisha Poultry Policy 2015 has been implemented to provide support to poultry farmers. Poultry has been declared agriculture by the

state government for reduction of electricity tariff for poultry farmers. In the last two years, 50,000 rural families have been supported for backyard poultry farming," the F&ARD minister said.

Similarly, Odisha has registered a 4.7-time rise in egg productionfrom 730 million in 2000-01 to 3,475 million in 2022-23. Egg production, which was 64 lakh per day in 2018-19, reached 96.58 lakh a day in 2022-23, Swain said, adding that subsidv has been enhanced from ₹50 lakh to ₹1 crore. The state government aims at establishing 60,000 rural backyard poultry units in the current year.

There has been a 167 per cent rise in budgetary provision for planned expenditure in F&ARD sector in the last four years—from ₹477.41 crore in 2018-19 to ₹1,274 crore in 2023-24.

Start Bargarh–Nuapada rly line work, Centre told

Bhubaneswar, June 2: The state government has urged the Ministry of Railways to take up the construction of a new railway line from Bargarh Road to Nuapada Road via Padampur in western Odisha.

Chief Secretary Pradeep Kumar Jena has recently written a letter to Railway Board chairman Anil Kumar Lahoti in this regard.

State-run Odisha Rail Infrastructure Development Limited (ORIDL) has already prepared the detailed project report (DPR) and submitted it to the

To make the project financially viable, the state government has made a commitment to provide land free of cost for the project and ₹300 crore as grant, he said. Considering these financial assistance from the government of Odisha, the project is financially viable with a rate of return (RoR) of 12.44 per cent, as shown in the

DPR. The need for a railway line between Bargarh Road and Nuapada Road via Padampur has been felt for a long time. The government of Odisha has been highlighting this issue for more than a decade, Jena said in his letter.

The Ministry of Railways had conducted a survey of this line but later shelved the project citing lack of guaranteed traffic and non-participation of state government in the project, he said.

Later, ORIDL was later asked to evaluate the project and the DPR based on the in-principle approval of the ministry, has been prepared

and shared with the state government.

"Since state government has come forward to participate in this project by way of providing land free of cost and financial grant of ₹300 crore making the project financially viable, the DPR is forwarded to Ministry of Railways with a request to sanction the project and take up the construction work at their end at the earliest,' he added.

Notably, the Ministry of Railways has notified construction of the new railway line project.

In December 2022, during Padampur bypoll, Bargarh-Nuapada railway line via Padampur took center stage as both BJP and BJD indulged in blame game over delay in commissioning of the project.

Govt funds to DRSCs for less road fatalities

Bhubaneswar, June 2: Concerned over the rising number of road ac cidents in Odisha, the state government is going to provide funds to the District Road Safety Committees (DRSCs) to make small interventions for reductions of accident-related fatalities in the state.

In a letter Commerce and Transport principal secretary Usha Padhee requested all Collectors, SPs and DCPs to submit their proposals suggesting their requirement of funds by June 20. In view of the importance of the issue, it has been decided to provide funds to the DRSCs to take up initiatives for reduction of accidents and fatalities, she said.

Small interventions like painting of medians, pasting of reflective tapes, holding awareness programmes, and installing CCTV cameras for deterrence may have





significant effect in improving road safety in all the districts, she said. These initiatives are important

for the districts having major state, national highways and urban centres. As per official reports 5,467 per-

sons were killed in road accidents in 2022. It was 7.6 per cent higher than the deaths recorded in road accidents the previous year. Surprisingly, in January and February, 2023, the fatalities grew by 24.91 per cent compared to the corresponding period in 2022.

It has been observed that, there is growth in fatalities by more than 50 per cent in districts including Deogarh, Gajapati, Jagatsinghpur, Jajpur, Jharsuguda, Kendrapara, Khurda, Malkangiri and Nuapada, Padhee said in the letter.

"All the districts are being impressed upon from time to time to initiate education, engineering, enforcement and emergency care measures for reduction of road accidents and fatalities in the districts," she said adding that all districts have been requested to hold meeting of district road safety committees once in every month to review the road safety scenario.

₹3 crore corpus fund to 3 major medical colleges

Bhubaneswar, June 2: Researchers at Siksha 'O' Anusandhan (SOA) Deemed to be University here have developed simple and economical pharmaceutical formulations to treat various chronic medical conditions, with the institution recently signing technology licensing agreement with the National Research Development Corporation (NRDC) of the Science and Technology Ministry for development of the formulations.

The formulations are designed to treat dry eye, throat infections and mitigate long-term adverse effects associated with cancer treatment, leader of the research team and SOA'S School of Pharmaceutical Sciences' professor Goutam Rath informed.

The preservatives used in formulations used to treat eye conditions actually lead to ocular discomfort or at times permanent visual deformities following prolonged use," Rath said.

"Our innovation offers a preservative free long lasting artificial tear produce which would reduce the dose and toxic adverse effects of preservatives for long term use," he said adding it would remain effective for longer period

and the user would not have to use the drop frequently during the day.

Generally, the ocular drops used get wasted as hardly ten per cent of a drop is retained. But the new formulation would create a film which would prevent any such loss, he said.

Pointing out that the gargle medicines being prescribed for throat infections had limited impact for about 15 to 30 minutes requiring multiple use to alleviate discomfort, Rath said the team has developed a mucoadhesive extended release gargle spray which offer long term effect of about four hours upon a single use. The research team has also developed artificial saliva which can be of great help to cancer patients who are on chemotherapy.

The members of the research team include Goutam Ghosh, professor, Biswakanth Kar, associate professor, Debasmita Dubey, research scientist, Vineet Kumar Rai, project scientist, Deepak Pradhan, senior project associate, Priyanka Dash, assistant professor, Chandan Das, assistant professor, Jitu Haldar and Tushar Kanti Rajewar, both Junior research fellows, Ivy Saha and Ritu Mohanti,

Odisha to bear uneven cost of climate transition: Study

The estimated costs and benefits of climate transition in India are very unevenly distributed across regions, according to a study which calls for urgent policy instruments to compensate for this disparity.

The study shows that the negative effects are heavily concentrated in already poorer states in eastern India that are highly involved in coal-mining, including Jharkhand, West Bengal, Odisha, and Bihar.

Jobs would be lost, the burden on poorer households would increase, and energy-intensive industries would come under pressure in this region, the researchers said. The researchers noted that India is taking the first steps towards a climate transition with volume targets for the upscaling of renewable energies, a modest turnaround in coal-fired power generation, and plans for carbon pricing in the form of emissions trading.

"This huge country with its 29 federal states and seven union territories already has large regional wealth disparities," said Jose Ordonez, who led the study as part of his doctoral thesis at Mercator Research Institute on Global Commons and Climate Change (MCC) in Germany.

'We determine the scenario of an ambitious climate transition for the individual geographical units, and examine the combined effect on income distribution, employment and industrial competitiveness," said Ordonez, who is currently working at the EU Commission's Joint Research Centre in Spain.

This yields an important finding for central government: without compensatory measures, the gap between poor and wealthy regions threatens to widen significantly, the researchers said.

The study, published in the journal Energy Policy, used an inputoutput model fed with empirical data to map the direct distributional effects of policy measures. The researchers assume there



will be an extensive effort towards climate protection, including a complete coal phase-out, the massive expansion of power generation from solar and wind, a national carbon price of USD 40 per tonne for private households and companies, and the abolition of energy subsidies.

The overall effect of this package on the individual regions, on a qualitative scale from "very disadvantageous" to "very favourable," is key, according to the researchers.

The researchers examined the combined effect of transition on income distribution, employment and industrial competitiveness

Climate transition would have to be accompanied by new social and industrial policies to make it enforceable in the struggle between competing interest groups, and to overcome regional resistance

"From the political economic perspective our work provides an important starting point for the further development of climate transition in India," said Jan Steckel, head of the MCC working group Climate and Development and one of the co-authors.

"It helps us understand how winners and losers of climate policies are distributed in India. A strong regional concentration of shortterm losers can lead to major problems in the political process of implementing climate protection. This has already been shown, for example, in the struggle to phase out coal in Germany," Steckel said.

The researchers emphasise that the climate transition would have to be accompanied by new social and industrial policies in order to make it enforceable in the struggle between competing interest groups, and in order to overcome regional resistance.

This can be done, for example, using carbon price revenues, by careful siting of fossil-free energy production, or through compensation payments for the coal phaseout, they said.

It can also provide orientation for coal phase-out in return for financial aid from western industrialised countries, following the example of South Africa, Indonesia, and Vietnam, the researchers added.

Void in Doha

or nearly two months, the position of Indian ambassador in Doha has remained unoccupied, leaving a big void in the diplomatic representation of India in Qatar. After the previous ambassador Dipak Mittal returned to India and joined the Prime Minister's Office (PMO), the appointment of his successor has been eagerly awaited. While speculation points to Vipul, the Joint Secretary (Gulf) as a likely replacement, no formal announcement has been made by the Ministry of External Affairs (MEA)

However, the absence of an Indian ambassador in Doha is not merely a bureaucratic matter. It has real and significant consequences for the individuals directly affected by it. Specifically, the families of eight naval veterans who have been held in solitary confinement in Doha since August last year, are feeling an overwhelming sense of helplessness. The lack of an Indian ambassador has made it difficult for them to access information about the wellbeing and legal status of their loved ones.

With charges already framed and the trial underway against these veterans under Qatari law, their families are increasingly anxious about their situation. Without a designated point of contact, they find themselves lacking a go-to person who can provide them with clarity and guidance regarding the path ahead.

In this time of uncertainty, the MEA needs to recognize the urgency of the matter and promptly appoint a competent and capable ambassador to Doha. The presence of a dedicated ambassador will not only provide a channel of communication for the families of the detained veterans but also enable effective engagement with Qatari authorities to ensure fair treatment and due process for the accused individuals.

Women dominate UPSC civil services exams

A seismic shift is occurring within the realm of Indian bureaucracy. There

is a change in the air. The recent UPSC Civil Services exam results have unveiled a groundbreaking development - the top four positions have been claimed by women. Ishita Kishore secured the first rank, followed by Garima Lohia, Uma Harathi and Smriti Mishra.



Among the top 25 successful candidates, 14 are women, marking the second consecutive year in which women have dominated the highest ranks.

This transformative trend underscores the remarkable progress made by women in civil services, with their representation increasing significantly over time. The ascent of women has been an arduous journey. Women have overcome formidable challenges, from Anna George Malhotra, the first woman to join the IAS in 1951 to the current wave of trailblazing candidates. The remarkable statistics speak for themselves, as over one-third of the 933 recommended candidates this year are women, a substantial increase compared to the mere 20 per cent from two decades ago.

By securing leadership positions in the civil services, these accomplished young women bring with them fresh perspectives, empathy and a nuanced understanding of the diverse challenges that governance entails. This surge in women's presence signifies a major shift in the traditionally male-dominated bureaucratic landscape. Their contributions will likely pave the way for a more inclusive and comprehensive governance framework.

A boozy conundrum

In a move that could spare police personnel of the Prohibition Enforcement Wing (PEW) of Tamil Nadu Police from unexpected dance-offs, the Director General of Police (DGP) C Sylendra Babu has sent a memo to police personnel to resist the temptation of being deployed on any other duties. The directive has been communicated to all commissioners and superintendents of police across the state.

The PEW officers have apparently been pulled in every other direction, assigned tasks that have absolutely nothing to do with their original purpose. The oppression faced by Jews in developed Western countries nowadays is somewhat more ambiguous, because Jews also tend to occupy positions of privilege (economically, culturally, and so forth), and the association of the Jews with wealth and culture ("Hollywood" as Jewish) in the public imagination is itself a source of classic anti-Semitic tropes. The EJA worries that this combination of oppression and privilege makes anti-Semitism just another form of racial hatred, not only comparaeducation, and political influence) is thus the very resource of anti-Semitism: being perceived as privileged makes Jews a target of social hatred.

Problems arise when one tries to use the exceptional status of anti-Semitism to support a double standard, or to prohibit any critical analysis of the privileges that Jews, on average, enjoy. In a 2020 Der Spiegeldialogue on anti-Semitism and the Boycott. Divestment Sanctions (BDS) movement against Israel, one finds the dictum that, "The Jew, and not the potential anti-Semite, determines who is an anti-Semite" ("We r Antisemitist, bestimmt der Jude und nicht der potenzielle Antisemit"). But if that is the case, should we not apply the same principle to Palestinians in the West Bank? Solely by dint of being Palestinian, they are being deprived of their land and basic rights.

But, more than that, the EJA's stance relies on its own intersectional framework. Any analysis of the privileged positions held by some Jews is immediately de nounced as anti-Semitic, and even critiques of capitalism are rejected on the same grounds, owing to the association between 'Jewishness" and "rich capitalists." The Marxist thesis that anti-Semitism is a primitive, distorted version of anti-capitalism is thus inverted: anti-capitalism is a mask of anti-Semitism.

If the implication is that Jewishness is both exceptional and inextricably bound up with capitalism, aren't we just left with an age-old anti-Semitic trope? Do we not directly provoke the poor and oppressed to blame the Jews for their misfortunes? Other Jewish organizations should reject the EJA stance, not because of some obscene need for "balance" between different forms of racism, but to advance the very struggle against anti-Semitism.

Vape

Oxford Dictionaries announced today (18 November) that they have made vape their international Word of the Year 2014. This odd little word, with its compounds, has risen from almost total obscurity to high fashion in less than half a decade. The award has been made because its use has more than doubled in the past year alone. It's now widely known that if you vape, you inhale and exhale the vapour produced by electronic cigarettes (e-cigarettes or e-cigs). These contain a solution of water and glycerin plus nicotine and flavourings. This mixture is passed over a hot filament to deliver it as a vapour. Using an e-cigarette makes you a vaper. The action is vaping, and a single inhalation and exhalation is a vape. The first e-cigarettes were put on sale by a Chinese company in 2003. They were initially marketed as ways for smokers to cut down their tobacco consumption or kick the habit altogether. Instead, they came to be widely used by smokers and non-smokers alike because they seemed to be a cleaner and more healthy alternative to traditional cigarettes. This is denied by many health experts and their advertising and use are being restricted in some jurisdictions. It seemed inappropriate to describe using them as smoking and so these new terms were created, obviously enough from vaporise or vaporiser. One reason for the increasing popularity of vaper is that e-cigarette smokers are banding together, using it as a self-identifying term, to campaign against proposed EU rules banning many e-cigarettes because their nicotine levels are too high.

But MS Dhoni is a different kettle of fish and humility personified.

in 2011, despite his spectacular innings and finish through a helicopter six, he allowed Sachin to hog all the limelight, though he had fared badly in the finals. Dhoni in the post-match conversation also confessed that he was overwhelmed by the reception that he received and possibly his eyes were wet. Unlike Imran's pedigreed indifference to his teammates after winning WC-1992, the small-town boy from Ranchi has always valued friendship, loyalty and discipline as the sine qua non of excellence in a team game. Dhoni has given space to each of his teammates to perform at their best. Most importantly, humility rather than hubris, has been the leitmotif of his unique journey as a captain, wicketkeeper and finisher par excellence. No wonder his appeal transcends Chennai and swathes all cricket grounds in India with a veil of yellow. He is the Don of Cricket Captains and his swan song could not have been more apocalyptic.

Law Commission backs sedition law

New Delhi, June 2: The Law Commission has proposed retaining the penal provision for the offence of sedition, saving repeal ing it altogether can have serious adverse ramifications for the security and integrity of the country, prompting a push back by the Congress amid government assertion that the recommendations were "persuasive" and "not binding".

The Commission, chaired by Justice Ritu Raj Awasthi (retd), also suggested increase in the minimum jail term for sedition offences from the present three years to seven years, seeking to bring it in consonance with the scheme of punishment provided for other offences under Chapter VI of the Indian Penal Code (IPC) which deals with offences against the state.

Section 124A of the Indian Penal Code dealing with sedition is at present under abeyance following directions of the Supreme Court is-

sued in May, 2022. Amid allega-



tions of misuse, there have been demands for repeal of the provision.

The Congress accused the BJP government of planning to make the sedition law more "draconian" and giving a message ahead of the general elections that it will be used against opposition leaders. Union Law Minister Arjun Ram Meghwal said the Law Commission recommendations made in its report 'Usage of the Law of Sedition' were "persuasive and not binding" and an "informed and reasoned" decision would be taken after consultation with all stake-

holders.

The Commission also said that sedition being a "colonial legacy' is not a valid ground for its repeal It said repealing the provision on the mere basis that certain countries have done so is essentially turning a blind eve to the glaring ground realities existing in India and that it can be retained with certain safeguards to prevent its misuse.



The Commission also suggested changes to the phrasing of Section 124A and added words "a tendency to incite violence or cause public disorder". It said the qualifying words "tendency to incite violence" would mean "mere inclination to incite violence or cause public disorder rather than proof of actual violence or imminent threat


Ozone layer recovery delayed, surface UV radiation rising

THE STUDY, PUBLISHED IN THE JOURNAL ADVANCES IN ATMOSPHERIC SCIENCES ANALYSED SATELLITE DATA AND MODEL SIMULATIONS TO ASSESS LONG-TERM **CHANGES IN OZONE AND SURFACE UV LEVELS AROUND THE GLOBE**

New Delhi, June 2: The ozone layer is not healing as quickly as expected, leading to higher levels of surface ultraviolet (UV) radiation in recent years, according to a study.

Despite projections that the ozone layer would fully recover by mid-century, researchers found rising UV radiation levels in the tropics and northern mid-latitudes after 2010, posing risks to human health and the environment.



The study, published in the journal Advances in Atmospheric Sciences, analysed satellite data and model simulations to assess long-term changes in ozone and surface UV levels around the globe.



"We observed a decrease in ozone levels and an increase in UV radiation over latitudes between 30 degrees South-60 degrees North after 2010," Xia said.

"Especially in the Northern Hemisphere, the rising magnitude of surface UV radiation

from 2011 to 2020 reached 0.5-1.4 per cent per year-this should not be neglected," he added.

The researchers noted that continuous monitoring of ozone and UV radiation levels is important to better understand why ozone recovery is delayed and whether this trend will continue

Policymakers and the public should be aware of and prepare for the harmful effects of enhanced surface UV radiation on the environment, agriculture, and public health, they said.


The findings are a sobering reminder that ozone layer restoration is a complex process affected by factors like global warming-and full recovery remains uncertain.

Continued research and implementation of policies like the Montreal Protocol -- a treaty designed to protect the ozone layer by phasing out the production of numerous substances that are responsible for its depletion -- are critical to reverse this worsening trend, reducing UV exposure, and protecting life on Earth in the coming decades.



Delhi records coldest May in 36 yrs

New Delhi, June 2: Delhi recorded its coolest May in 36 years with excess rainfall bringing the average maximum temperature down to 36.8 degrees Celsius this time, the India Meteorological Department (IMD) said Wednesday.

Kuldeep Srivastava, the head of the regional forecasting centre of IMD, said Delhi had recorded an average maximum temperature of 36 degrees Celsius in May 1987. "The average maximum temperature of 36.8 degrees Celsius in May this year is the lowest since then," he said.

Delhi recorded maximum temperatures above the 40-degree mark for just nine days in May with heat wave conditions affecting some parts of the national capital for two days. "The Safdarjung Observatory, which is representa-



tive of Delhi, has not recorded any heat wave in the pre-monsoon season this year. This has happened for the first time since 2014," Srivastava said. The weather station recorded 13 heat wave days in the pre-monsoon season last year -- nine in April and four in May. It saw just one heat wave day during this period in

2021, four in 2020 and one in 2019. The threshold for a heat wave is met when the maximum temperature of a station reaches at least 40 degrees Celsius in the plains, 37 degrees in the coastal areas, and 30 degrees in the hilly regions, and the departure from normal is at least 4.5 notches. This is also the fourth highest rainfall in the month after 165 mm in 2008, 144.8 mm in 2021 and 129.3 mm in 2002, according to IMD data.

The city logged more than 20 mm of rainfall in April, the highest in the month since 2017, and heat wave conditions at iso lated pockets.

Meteorologists attributed the excess rainfall and below-normal temperatures this pre-monsoon

May, generally the hottest month in Delhi with a mean maximum temperature of 39.5 degrees Celsius, recorded 111 mm of rainfall this time, which is 262 per cent more than the long-term average of 30.7 mm

season (March to May) to higherthan-usual western disturbances -- weather systems that originate in the Mediterranean region and bring unseasonal rainfall to northwest India.

"Usually, five to six western disturbances are recorded in the northern plains in April and May. This time, we saw 10 western disturbances, mostly strong ones," said Srivastava. "This is unusual. However, we cannot link it to climate change in the absence of data. There is no definite trend," he said.

Delhi recorded 184.3 mm of rainfall this pre-monsoon season (March to May) which is 186 per cent more than normal rainfall, according to the IMD.



Told to pay for excess baggage, woman claims bomb in bag

Mumbai, June 2: Upset over being asked to pay for excess baggage, a female traveller at the Mumbai international airport declared that her bag contained a "bomb", causing a brief frenzy among the security staff before she was taken into custody, an official said Friday.

A search of her baggage was conducted and there was nothing suspicious in it, the official said. The incident took place May 29 when the woman, a homemaker from South Mumbai, was scheduled to go to Kolkata with her husband and children to meet her mother, he said.


After reaching the check-in counter, she asked an airline employee for a boarding pass and handed over two bags to the staff. As per the airline's rules, a single bag with a maximum weight of 15 kg is allowed to be checked in for each domestic flyer.

Since the woman's bags weighed a total of 22.05 kg, she was asked to pay for excess baggage, he said. However, the woman allegedly refused to pay for the additional weight and got into an argument with the airline staff.

She later claimed that one of her bags contained a bomb, the official said. Though the on-duty Central Industrial Security Force (CISF) personnel checked her bag and found nothing suspicious in it, the woman's claim sparked panic at the airport for some time, he said.

The woman was then handed over to the Sahar police, which registered a first information report (FIR) against her for "endangering lives and safety of others", he said.

Most tobacco quitters in India from UP: Survey

New Delhi, June 2: A survey of calls received by the central government's National Tobacco Quit Line Services (NTQLS) has shown that most of the tobacco quitters in the country are from Uttar Pradesh.

The survey findings were released by the Vallabhbhai Patel Chest Institute (VPCI) on 'World No Tobacco Day' observed on May 31. The VPCI survey based on NTQLS data revealed that 71.39,473 interactive voice response (IVR) calls were received till April 30, 2023 since May 30, 2016.

Out of the total number of IVR calls received by this centre, 20.43,227 calls were counselled, including 9,96,302 inbound calls, 26,80,657 outbound calls, and 3,91,160 registered by the call centre. Most of the callers were from the state of Uttar Pradesh, it said.

According to the survey, 1,56,644 (40 per cent) individuals studied had successfully given up tobacco use. Of these, the maximum 1,23,508 calls were received from Uttar Pradesh. Dr Raj Kumar, director, Vallabhbhai Patel Chest Institute said, "I would like to work with two objectives: firstly, those who have not started using tobacco should not start; secondly, those who have started by mistake should quit.

"And if you need any kind of help in quitting, we are ready to help. There is a team of National



Tobacco Quit Line Service (NTQLS) always ready to help you by providing the right kind of inthat men make up the highest percentage of callers at 98 per cent, followed by transgenders at 5 per cent of the total population, while women comprise the lowest, that is, 2 per cent.

The highest number of tobacco consumers (1.74.097) surveyed were educated till class 10. Besides providing relief to a large number of patients in the community suffering from chest diseases, VPCI runs the National Tobacco Quitline Service (NTQLS), an initiative of the Ministry of Health and Family Welfare.

The NTQLS has been working for the last seven years to help people get rid of tobacco and smoking addiction. "The counselling and guidance provided by NTQLS call centre has been very useful to those who are tobacco users, but want to quit at the earliest," Kumar said.

The NTQLS was inaugurated by then Union health minister J P Nadda in 2016. Though this service was initially established with six counsellor stations, it was later expanded in 2020 by then Union Minister of State for Health, Ashwini Kumar Choubey.

At present, the number of counsellors and other staff at NTQLS has increased to 64. The toll free number to contact the centre is 1800112356. Its three satellite centres are operating at NIMHANS Bengaluru; Dr B Borooah Cancer-Institute. Guwahati: and Tata Memorial Center, Mumbai.



Washington, June 2: Fending off a US default, the Senate gave final approval late on Thursday to a debt ceiling and budget cuts package, grinding into the night to wrap up work on the bipartisan deal and send it to President Joe Biden's desk to become law before the fastapproaching deadline.

The compromise package negotiated between Biden and House Speaker Kevin McCarthy leaves neither Republicans nor Democrats fully pleased with the outcome.

But the result, after weeks of hard-fought budget negotiations, shelves the volatile debt ceiling issue that risked upending the US and global economy until 2025 after the next presidential election. Approval in the Senate on a bipartisan vote, 63-36, somewhat reflected the overwhelming House tally the day before, relying on centrists in both parties to pull the Biden-McCarthy package to passage — though Democrats led the tally in both chambers.

Senate Majority Leader Chuck Schumer said ahead of voting that the bill's passage means "America can breathe a sigh of relief." Afterward he said, "We've saved the country from the scourge of default." Biden said in a statement following passage that senators from both parties "demonstrated once more that America is a nation



that pays its bills and meets its obligations — and always will be." He said he would sign the bill into law as soon as possible. "No one gets everything they want in a negotiation, but make no mistake: this bipartisan agreement is a big win for our economy and the American people," the president said.

The White House said he would address the nation about the matter at 7 pm EDT Friday. Fast action was vital if Washington hoped to meet next Monday's deadline, when Treasury has said the US will start running short of cash to pay its bills, risking a devastating default. Raising the nation's debt limit, now \$31.4 trillion, would ensure Treasury could borrow to pay already incurred US debts.

In the end, the debt ceiling showdown was a familiar high-stakes battle in Congress, a fight taken on by McCarthy and powered by a hardright House Republican majority confronting the Democratic president with a new era of divided government in Washington.



Modi to address joint session of US Congress

Washington, June 2: Prime Minister Narendra Modi will address a joint session of the US Congress on June 22 during his official state visit to the country and will share his vision of India's future and speak on the global challenges facing the two countries, top congressional leaders announced on Friday.

President Joe Biden will host Prime Minister Modi for an Official State visit to the US, which will include a state dinner, June 22. The statement was signed by House Speaker Kevin McCarthy, Senate Majority Leader Chuck Schumer, Senate Republican Leader Mitch McConnell and House Democratic Leader Hakeem Jeffries. This will be the second time that Modi will be addressing a joint meeting of the US Congress. He addressed the US Congress during his visit to the US in June 2016.

"Based on our shared values and commitment to global peace and prosperity, the partnership between our two countries continues to grow. During your address, you will have the opportunity to share your vision for India's future and speak to the global challenges our countries both face," the congressional leaders said in their statement.

Modi, during his address in 2016 spoke on issues ranging from climate change to terrorism, defence and security cooperation to trade and economic relationship between India and the US. Modi was the fifth Indian Prime Minister to address a joint session of the US_ Congress seven years ago.

Others included Manmohan Singh (July 19, 2005), Atal Bihari Vajpayee (September 14, 2000), P V Narasimha Rao (May 18, 1994) and Rajiv Gandhi (July 13.

Islamabad, June 2: Consumer inflation in Pakistan raced to 38 per cent in May, the highest annual rise in prices on record, driven mainly by skyrocketing costs of food, house rents, electricity and gas bills, and transport, official data revealed. The May reading exceeded the Finance Ministry's projection of 34-36 per cent for the month and comes as political turmoil continues to roil the country.

Years of financial mismanage ment, rupee depreciation and the government's failure to unlock IMF funding have also played a role in taking annual price hikes to such record highs, Dawn reported.



Official data showed that the average price of a 20 kg wheat flour bag more than doubled to around 2,700 PKR in May compared to the

Paris, June 2: The United Nations food agency's world price index fell in May to its lowest in two years, as a slump in prices of vegetable oils, cereals and dairy outweighed increases for sugar and meat.

The Food and Agriculture Organization's (FAO) price index, which tracks the most globallytraded food commodities, averaged 124.3 points in May against a revised 127.7 for the previous month, the agency said Friday. The April reading was originally given as 127.2. FAO's cereal price index dropped by nearly 5% in May from the prior month, pressured by ample supply prospects and the extension of the Black Sea Grain Initiative allowing shipments from Ukraine. But international rice prices con-

tinued to increase in May, partly due to tighter supplies in some exporting countries, said FAO. The agency last month expressed concern over rising prices of the staple.

FAO's vegetable oil price index slid almost 9% month on month, reflecting large oilseed supplies and weak demand for palm oil while global dairy prices eased over 3% amid a seasonal upturn in northern hemisphere milk out-

"Despite being provided ample opportunities and sufficient time to ensure compliances, SILIC has failed to comply with directions of the authority and take any affirmative steps to protect the interests of its policyholders," the regulator said.

Mumbai, June 2: Cash-strapped Go First, which is undergoing voluntary insolvency resolution process, plans to restart operations with 26 planes and 152 daily flights. and has submitted the revival plan to aviation regulator DGCA, according to a source.

Besides, the airline is in discussions with lenders for funds to meet the working capital requirements.

The airline stopped flying from May 3 and is yet to pay some senior level executives and pilots.

On the condition of anonymity, the source said the carrier's salary outgo is around ₹30 crore per month and currently, the workforce is around 4,700 as many have put in their papers in one month.

The source said the airline management is awaiting the nod from the Directorate General of Civil Aviation (DGCA) for the revival plan and operations will resume soon after the regulator's approval.

The Mumbai-based airline's senior executives have held discussions with senior DGCA officials on the revival plan.

"As per the plan provided to the DGCA this week, Go First is looking to recommence operations with a fleet of 26 aircraft, of which 22 will be engaged in active operations and 4 will be kept as spares," the source told PTI.

With this fleet, the airline will be operating 152 flights per day, the source added. Prior to grounding May 3, the airline was operating around 200 flights daily.

New Delhi, June 2: Streaming giants Netflix, Amazon and Disney Friday privately discussed a possible legal challenge and other ways to stall India's new tobacco warning rules, amid fears they will need to edit millions of hours of existing web content, sources said.

The pushback is the latest headache for streaming giants in India, a top growth market. Companies often face legal cases and police complaints their content sometimes hurt religious sentiment, and many have self-censored content over the years.

As part of India's anti-tobacco drive, the health ministry this week ordered streaming platforms should within three months insert static health warnings during smoking

scenes. Also, India wants at least 50 seconds of anti-tobacco disclaimers, including an audio-visual, at the start and in the middle

Paris, June 2: The French Open crowd was not happy with American player Taylor Fritz after he beat one of their own - indeed, their last man in the bracket - so they booed and whistle relentlessly. Fritz's response? He told them to shush. Over and over again.

Fritz, a 25-year-old from California who is seeded No.9 at Roland Garros, got into a backand-forth with the fans at Court Suzanne Lenglen after his 2-6, 6-4, 6-3, 6-4 comeback victorv over 78th-ranked Arthur Rinderknech in the second round Thursday night

Rinderknech attempted a lob that landed long on the last point, and Fritz, who had been running toward the baseline to chase the ball, immediately looked up into the stands and pressed his right index finger to his lips to say, essentially, "Hush!"

He held that pose for a bit as he headed back toward the net for a postmatch handshake, then spread his arms wide, wind-milled them a bit as if to egg on the rowdiness, and yelled: "Come on! I want to hear it!"

During the customary winner's on-court interview that followed, more jeers rained down on Fritz, and 2013 Wimbledon champion Marion Bartoli kept pausing her attempts to ask a question into her microphone.

So Fritz again said, "Shhhhh!" and put his finger toward his mouth, while Bartoli unsuccessfully tried to get the spectators to lower their decibel level. More boos. More whistles.

And the awkwardness continued as both Bartoli and a stadium announcer kept saying, "S'il vous plaît" — "Please!" — to no avail, while Fritz stood there with his arms crossed.

A few US supporters with signs and flags drew Fritz's attention from the front row, and he looked over and said to them, "I love vou guvs." But the interview was still on hold.

Bartoli tried asking a question in English, which only served to draw more boos. So Fritz told her he couldn't hear her. Bartoli moved closer and finally got out a query - but it didn't seem to matter what her words were.

Fritz, who has been featured on the Netflix docuseries about tennis called "Break Point," had his hands on his hips and a message on his mind — one reminiscent of Daniil Medvedev's contretemps with fans at the 2019 US Open.

Coco win after long wait

Coco Gauff thought she was about to head out on the court to play her second-round match at the French Open. "I was probably about 70 per cent done with my warm-up," last year's runner-up at Roland Garros would say later.

Made sense: In the contest preceding hers in Court Suzanne Lenglen Thursday, No.8 seed Jannik Sinner was serving for the victory while up 5-4 in the fourth set against Daniel Altmaier. Then Sinner was one point away. Except he couldn't convert that match point — he had a chance for a putaway overhead, and instead basically sent the ball right at Altmaier, whose forehand in response hit the top of the net tape and fluttered past Sinner — or another that arrived soon after.

They would play on for another 1 hour, 43 minutes, until Altmaier finally cashed in his own fifth match point with a 111 mph ace down the middle to seal the 6-7(0-7), 7-6(9-7), 1-6, 7-6(7-4), 7-5 victory.

So how did Gauff whittle away the time? Watching Sinner vs Altmaier, for one thing. Snacking, for another - on a fruit salad made by her dad, with cantaloupe, pineapple and watermelon. And, well,

Bangkok, June 2: Star Indian shuttler Lakshya Sen stormed into the semifinals of Thailand Open Super 500 tournament with a straight game demolition of Malaysia's Leong Jun Hao in men's singles here Friday.

The 21-year-old from Almora punched the air after unleashing a jump smash which sealed his 21-19, 21-11 win over the qualifier from Malaysia in the quarterfinals. The win helped him to enter the last four for the first time this season, having come close in Indonesia Masters, where he exited in the quarterfinals.

The Indian, whose ranking has slipped to World No.23 from a career-high of six following belowpar performances this season, will take on either fifth seed Lu Guang Zu of China or Thailand's second seed Kunlavut Vitidsarn in the semifinals.

Kiran George's giant run, however, came to an end after he went down 16-21, 17-21 against Toma Junior Popov of France in another men's singles match.

It was an exciting contest as Lakshya and Leong kept pushing each other from the start. But after a 10-11 deficit at the interval, the Indian fell behind as the Malaysian managed to hold a 16-10 lead.

But Lakshya then changed gears, stepping up the pace in the rallies to restore parity at 17-17 before pocketing the opening game as Leong looked tired.

After the change of ends, he kept a tight grip on the rallies as his returns were sharper and precise. Soon he led 11-8, before breaking off at 13-11. He accumulated the next 11 points in a jiffy to emerge winner.

New Delhi, June 2: The two FIRs registered by Delhi Police against outgoing WFI chief and BJP MP Brij Bhushan Sharan Singh based on complaints of six adult wrestlers and father of a minor narrate several alleged instances of sexual harassment, inappropriate touching, groping, stalking and intimidation by him at different times and places including in foreign

countries, over a decade. The Delhi Police had April 28 registered the two FIRs at Connaught Place police station, including one by the father of a minor wrestler invoking POCSO Act that entails prison term up to seven years on conviction. The FIRs registered following a Supreme Court order have charged Singh under various IPC sections including assaulting a woman to outrage her modesty (Section 354), sexual harassment (354 A), stalking (354 D) that are punishable with jail terms of two-three years. The FIR filed by the six wrestlers also names Wrestling Federation of India (WFI) secretary Vinod Tomar as an accused. In the FIR filed on the basis of complaints by the adult wrestlers, one of them alleged, "While I was training, the accused called me separately, to which I refused since the accused was touching other girls also inappropriately. However, I was again called by the accused who then pulled up my T-shirt and slid his hand down my stomach and put his hand on my naval on the pretext of checking my breath. "It was during my stay in hotel

that I noticed that all the female athletes used to travel in groups whenever they left their respective rooms in order to avoid meeting the ac-

cused alone. The second wrestler alleged, 'While I was stretching/warming up on the ground on a mat, the accused came there and stood on the side watching me.

"While I was lying down on the mat, the accused came near me and suddenly, to my shock and surprise, leaned in on me and in the absence of my coach and without seeking my permission pulled up my T-shirt and placed his hand on my breast and slid it down my stomach on the pretext of examining/checking my breathing and touched me inappropriately." Another wrestler alleged she was harassed during a team photograph clicked. "While I was standing in the last row and waiting for the other wrestlers to take their position, the accused came and stood alongside me. To my shock and surprise, I suddenly felt a hand on my buttock. I immediately looked back and to my horror, the accused had placed his hands on my buttock ... "However, when I tried moving away, I was forcibly held by my shoulder by the accused. Somehow, I managed to get free from the clutches of the accused," she al-


