RBI likely to keep rates unchanged

Mumbai, June 6: The Reserve Bank of India's rate-setting Monetary Policy Committee (MPC) began de liberations Tuesday amid expectations that the central bank will keep the benchmark interest rates un changed at 6.5 per cent on the back of easing retail inflation and the need to push economic growth.

Headed by Reserve Bank of India (RBI) Governor Shaktikanta Das, the six-member MPC will meet for three days and the decision would be announced Thursday, June 8.

After the last MPC meeting in April, the RBI paused its rate hike cycle and stayed with the 6.5 per cent repo rate. Prior to that the central bank had cumulatively hiked the reporate by 250 basis points since May 2022 in a bid to contain inflation.

The MPC is meeting in the backdrop of CPI inflation declining to an 18-month low of 4.7 per cent in April. Das recently indicated that the May print would be lower than the April numbers. The CPI for May is scheduled to be announced June 12. On expectations from the MPC, Rumki Majumdar, Economist, Deloitte India said, "We expect a pause in this meeting as growth concerns cannot be overlooked. With the global economy slowing down, there are risks that the slowdown contagion may impact us." Globally, there are signs that the central banks may also take a pause or go with fewer hikes as runaway inflation takes a breather, Majumdar said, and added this will further help the RBI to maintain the status quo.

BALASORE TRAGEDY State's toll 39; CBI begins probe

Bhubaneswar, June 6: The state government revised the death toll in the Balasore train crash to 288, which includes 39 from Odisha so far, while the Central Bureau of Investigation (CBI) started its probe into alleged criminal negligence leading to the mishap after registering an FIR, Tuesday.

Speaking to reporters, Chief Secretary Pradeep Kumar Jena said 275 deaths were confirmed till Monday, and after verification of bodies, the figure was raised to 288.

Jena said 205 bodies of the total 288 have been identified so far and handed over to their families. The remaining 83 bodies were kept at AIIMS-Bhubaneswar and other hospitals for identification, he said. "People are facing difficulties in identifying the bodies as they are in

SMOKE TRIGGERS PANIC IN TRAIN

Bhubaneswar: The Secunderabad-Agartala Express was halted at Berhampur railway station around noon as passengers alerted railway officials about smoke emitting from an air-conditioning unit inside a coach, Tuesday, officials said. Although the smoke was controlled immediately, the panic stricken passengers refused to travel in the coach fearing another electrical breakdown. They demanded a replacement of the coach. Some passengers first noticed smoke in the B-5 coach and raised an alarm. Following this, most of the passengers reportedly got down and refused to reboard the train, an official said.

Imphal, June 6: A Border Security Force (BSF) jawan was killed and two Assam Rifles personnel injured in an encounter with suspected Kuki insurgents in Manipur's Serou area early Tuesday, officials said.

The exchange of fire between the two sides took place in a school in Serou area of Sugnu in Kakching district, the officials said.

A BSF official said suspected Kuki miscreants resorted to indiscriminate and heavy firing targeted at BSF troops deployed at the Serou Practical High School around 4.15am.

Constable Ranjit Yadav sustained a bullet injury during the gunfight and was evacuated to Kakching's Jivan Hospital where he was declared dead, the official said.

The government had reported the toll figure of 288 earlier as well, but then revised it downwards to 275, stating that some of the bodies were counted twice. It was then raised to 278 and further to 288 again Tuesday.

According to Jena, 39 out of the 288 have so far been found to be Odisha residents. "While eight were from Bhadrak, two were residents of Jajpur. 14 hailed from Balasore, nine from Mayurbhanj, two from Khurda, one from Keonjhar and three belonged to Cuttack." said the Chief Minister's Office. Chief Minister Naveen Patnaik sanctioned Rs 1.95 crore as ex-gratia to the families of 39 deceased persons from Odisha.

The registration of an FIR is the starting point of the CBI investigation because the agency cannot collect any document or material, question witnesses, record statement or conduct searches without it. The agency, which has little expertise in dealing with the functioning of railways, may need the help of rail security and forensic experts to get to the bottom of the case.

The CBI took over the case (64) registered by the Cuttack GRP June 3 under Sections 337, 338, 304A and 34 of IPC, and 153, 154 and 175 of the Railways Act.

According to the procedure, the CBI re-registers the local police case as its own FIR and starts the probe. It can add or remove a charge from the FIR in its charge sheet filed after its probe.

World's oldest-known burial site found in SA

South Africa, June 6: Palaeontologists in South Africa said they have found the oldest-known burial site in the world, containing remains of a smallbrained distant relative of humans previously thought incapable of complex behaviour.

Led by renowned palaeoanthropologist Lee Berger, researchers said they discovered several specimens of Homo naledi-a tree-climbing, Stone Age hominid-buried about 30 metres (100 feet) underground in a cave system within the Cradle of Humankind, a UNESCO world heritage site near Johannesburg

"These are the most ancient interments yet recorded in the hominin record, earlier than evidence of Homo sapiens interments by at least 100,000 vears." the scientists wrote in a series of yet to be peer reviewed and preprint papers to be published in eLife.



The findings challenge the current understanding of human evolution, as it is normally held that the development of bigger brains allowed for the performing of complex, 'meaningmaking' activities such as burying the dead.

The oldest burials previously unearthed, found in the Middle East and Africa, contained the remains of Homo sapiens -- and were around 100,000 years old.

Those found in South Africa by Berger, whose previous announcements have been controversial, and

his fellow researchers, date back to at least 200,000 BC.

Critically, they also belong to Homo naledi, a primitive species at the crossroads between apes and modern humans, which had brains about the size of oranges and stood about 1.5 metres (five feet) tall.

With curved fingers and toes, toolwielding hands and feet made for walking, the species discovered by Berger had already upended the notion that our evolutionary path was a straight line. Homo naledi is named after the

'Rising Star' cave system where the first bones were found in 2013.

The oval-shaped interments at the centre of the new studies were also found there during excavations started in 2018.

The holes, which researchers say evidence suggests were deliberately dug and then filled in to cover the bodies, contain at least five individuals.

Bhubaneswar, June 6: Chief Minister Naveen Patnaik Tuesday was in all praises for the people of Odisha and the state administration for the rescue and treatment of the June 2 mishap victims.

He also said, "It has manifested the compassion and humanity of the people of Odisha. Doctors, medical students, general public....all had one thing in mind.... Let's save life... as many as we can. And we have saved more than a thousand lives. People providing support to rescue operations, the long queues for blood donation are rare sights but invaluable. I am proud of my

people. I am proud of Odisha." The CM said the state adminis tration came into action mode the very moment the news came around. "Ministers, top officers, supporting staff.....all were at the site of accident and health centres, making arrangements and monitoring the rescue and treatment operations," he added. Speaking to media at Cuttack, Mamata said, "There are so many people from West Bengal traveling in the express trains. We are calling everybody; somebody is receiving and somebody is not. So far, 103 bodies have been identified, of which 83 have been received and others are under process while another 31 are still missing."

Besides, more than 200 people are under treatment in different hospitals of Odisha and West Bengal. Of them, 93 are under treatment in Odisha hospitals, she said.

Asked about her reaction to the CBI probe, Mamata said, "I don't want to say anything. Truth must come out. Let the truth prevail; it

must not be suppressed."

On the death toll, she said. "It is not the time for arguments. So many people have died. Let the truth come out. 'Trust' & 'distrust' buttons may help curb fake news

he addition of 'trust' and 'distrust' buttons on social media, alongside standard 'like' buttons, could help reduce the spread of misinformation, finds a new experimental study.

Incentivising accuracy cut in half the reach of false posts, according to the findings published in eLife.

"Over the past few years, the spread of misinformation, or 'fake news', has skyrocketed, contributing to polarisation of the political sphere and affecting people's beliefs on anything from vaccine safety to climate change to tolerance of diversity. Existing ways to combat this, such as flagging inaccurate posts, have had limited impact," said Professor Tali Sharot at University

"Part of why misinformation spreads so readily is that users are rewarded with 'likes' and 'shares' for popular posts, but without much incentive to share only what's true

"Here, we have designed a simple way to incentivise trustworthiness, which we found led to a large reduction in the amount of misinformation being shared," Sharot said

For the study, the team sought to test out a potential solution, using a simulated social media platform used by 951 study participants across six experiments. The platforms involved users

sharing news articles, half of which were inaccurate, and other users could react not only with 'like' or 'dislike' reactions, and repost stories, but in some versions

Carbon stored by fungi could be key to reaching net-zero

new study has quantified the fungi in the soil globally to be storing over 13 gigatons of carbon, roughly 36 per cent of yearly global fossil fuel emissions, a finding it said could prove crucial to reach net-zero goals.

The study is a meta-analysis of hundreds of studies looking at plant-soil processes to understand how much carbon is being stored by the fungi on a global scale, conducted by an international team of scientists including those from University of Sheffield, UK.

Mycorrhizal fungi have been known to support life on land for at least 450 million years and make up vast underground networks all around us - even forming beneath roads, gardens, and houses, on every continent on Earth.

The study equated the amount of carbon stored to roughly 36 per cent of yearly global fossil fuel emissions - more than what China emits each year.

Given the crucial role of fungi in cutting carbon emissions, researchers are now calling for them to be considered in biodiversity and conservation policies.

"Mycorrhizal fungi represent a blind spot in carbon modelling, conservation, and restoration - the numbers we've uncovered are jawdropping, and when we're thinking about solutions for climate we should also be thinking about what we can harness that exists already."

"More needs to be done to pro-

tect these underground networks

- we already knew that they were

essential for biodiversity, and now we have even more evidence that they are crucial to the health of our planet," said Katie Field, Professor of Plant-Soil Processes at the University of Sheffield and co-author of the study.

The researchers are now investigating how long the carbon is stored by the fungi in the soil, and are seeking to further explore the role that fungi plays in Earth's ecosystems.

"We always suspected that we may have been overlooking a major carbon pool.

"A major gap in our knowledge is the permanence of carbon within mycorrhizal structures. We do know that it is a flux, with some being retained in mycorrhizal structures while the fungus lives, and even after it dies.

Man finds 'dead' son alive in Balasore morgue

Balasore, June 6: Resident of Howrah district in West Bengal, Helaram Mallik travelled 235km to Balasore in search of his son. He did not know that a 'miracle' of sorts was waiting for him. Mallik found his son alive in a makeshift morgue along with the bodies of those deceased in the horrific train accident, June 2.

After pulling out his 24-year-old son Biswajit from the heaps of dead bodies inside the makeshift morgue at Bahanaga High School, Helaram rushed the former to the Balasore district headquarters hospital before shifting him to the SSKM hospital in Kolkata. Biswajit, who suffered multiple bone injuries in his limbs, has already undergone two surgeries.

"I saw the news (accident) on TV and called Biswajit to find out if he was okay.

He did not initially pick up the calls and then when he did, I could hear a feeble voice on the other side," Helaram, who runs a kirana shop, said.

On the same night (June 2), Helaram and his brother-in-law Dipak Das left for Balasore in an ambulance, "We could not find him as calls to his mobile went unanswered. We visited different hospitals but Biswajit was nowhere. We then went to the morgue at Bahanaga High School but were denied entry initially. Suddenly, there was an altercation among a few people followed by a commotion. Suddenly, I spotted a hand and knew it was my son's. He was alive," Helaram informed.

Without wasting a moment, Helaram took his 'almost unresponsive' son to Balasore DHH where he was administered a few injections. Then Helaram decided to take his son to Kolkata and now Biswajit is much better.

SURVIVING THE POLYCRISIS

a 🔘

e are living in troubled times. Too much is happening too fast. People are confused. The Columbia University economic historian Adam Tooze has, indeed, popularised a word for it. He calls it a "polycrisis." The polycrisis has many sources. In my opinion the main source of the polycrisis afflicting the world today is artificial intelligence. Climate change comes second, and the Russian invasion of Ukraine qualifies as the third. The list is much longer but I'll focus on these three. That should help reduce the confusion.

AI shocked the world when Microsoft made ChatGPT freely available to the public through an associated company called OpenAI. That was in November 2022. ChatGPT posed an existential threat to Google's business model. Google went into overdrive to release a competing product as soon as possible.

Shortly thereafter, Geoffrey Hinton, who is generally considered the godfather of AI, resigned from Google so that he could speak openly about the risks posed by the new technology. Reversing his previous position, he took a very dim view of AI. He said that it could destroy our civilisation. Hinton pioneered the development of neural networks that can understand and generate language and learn skills by analysing data. As the data grew, so did the capacity of AI's so-called large language models.

This made a big impression on Hinton. "Maybe what is going on in these systems is actually a lot better than what is going on in the brain," he said. As they become more powerful they also become more dangerous, he claimed. In particular, he warned against fully autonomous weapon systems – killer robots, he called them.

I grew up before AI was invented. That made me a great believer in reality. I realised at a relatively early age how difficult it is to understand the world I was born into, and I looked to reality to provide me with moral guidance. We. human beings, are both participants and observers in the world in which we live. As participants we want to change the world in our favour; as observers we want to understand reality as it is. These two objectives interfere with each other. I regard this as an important insight which allows me to distinguish between right and wrong. AI destroyed this simple schema AI helps closed societies and poses a mortal threat to open societies. That's because AI is particularly good at producing instruments of control that help closed societies to surveil their subjects

because it has absolutely nothing to do with reality. AI creates its own reality and when that artificial reality fails to correspond to the real world – which happens quite often - it is discarded as hallucination. This made me almost instinctively opposed to AI and I wholeheartedly agree with the experts who argue that it needs to be regulated. But the regulations have to be globally enforceable because the incentive to cheat is too great; those who evade the regulations gain an unfair advantage. Unfortunately, global regulations are unattainable because the world is dominated by a conflict between two systems of governance which are diametrically opposed to each other. They have radically different views on what needs to be regulated and why.

I refer to the two systems of governance as open and closed societies. I define the difference between the two as follows: in an open society the role of the state is to defend the freedom of the individual; in a closed society, the role of the individual is to serve the interests of the rulers. AI is developing incredibly fast, and it is impossible for ordinary human intelligence to fully understand it. Nobody can predict where it will take us. But we can be sure of one thing: AI helps closed societies and poses a mortal threat to open societies. That's because AI is particularly good at producing instruments of control that help closed societies to surveil their subjects.

The second element in the polycrisis is climate change. The global climate system has been disrupted by increased human intervention, particularly the large-scale use of greenhouse gases, carbon dioxide, and methane. The 2015 Paris

agreement set a target of 1.5° Celsius above pre-industrial times. That is now bound to be transgressed: in spite of all the efforts to fight climate change, the rate of

warming is actually accelerating. Two highly respected climate scientists, David King, a former chief scientific adviser to the UK government, and Johan Rockström of the Potsdam Institute, have warned that this could trigger tipping points and lead to the collapse of life on earth.

There would be a collapse of all the big biomes on planet Earth – the rainforest, many of the temperate forests - abrupt thawing of permafrost, we will have complete collapse of marine biology, we will have a shift of large parts of the habitability on Earth," Rockström said. "Over one-third of the planet

around the equatorial regions will be uninhabitable because you will pass the threshold of health, which is around 30°C.

Unfortunately, when fighting climate change interferes with people's livelihood, they want to protect their livelihood. Farmers in Germany and the Netherlands are up in arms against regulating nitrogen emissions because these regulations prevent them from keeping cows. They have mobilised, winning elections and shaking the European Union. I should also mention the desire of oil companies to continue making a profit. We are way behind schedule in

fighting climate change. We ought to do everything that climate scientists deem necessary - reduce emissions deeply and rapidly, remove excess greenhouse gases from the atmosphere, and refreeze the Arctic. To do this, we must gain the approval of indigenous communities. All this has to be

done as soon as possible.

This brings us to the third component of the polycrisis. The Russian invasion of Ukraine came as a negative shock to the world, disrupting food supplies and causing major geopolitical realignments. Having said that, the actual outcome is much better than could have been expected. The Ukrainian army put up heroic resistance and, with strong support from the US and Europe, turned things around. The Russian army proved to be a paper tiger, badly led and thoroughly corrupt. The Wagner Group, a private mercenary army, propped up the invasion for a period, but in the end, they too failed to defeat Ukraine.

As a result, Ukraine is now ready to launch a counterattack as soon as all of the equipment it has been promised by the West is delivered. Biden has even agreed that Ukraine should be given F-16 fighter planes. I believe the counterattack will be successful. The target will be the Crimean Peninsula the home base of the Russian Navy By destroying the already damaged land bridge with Russia, Ukraine could turn a strategic asset into a strategic liability, because Crimea has no water. With

the land bridge destroyed, Crimea will depend on Ukraine for water. Many parts of the Russian Federation are already chafing under President Vladimir Putin's despotic regime, and this development may cause them to reject it altogether. Putin's dream, a revived Russian Empire, could dis-

integrate and no longer pose a threat to Europe and the world. The end of the war in Ukraine will come as a positive shock for the

world. This may provide an opportunity for Biden to lower the tension between the US and China, which is itself in the midst of an economic decline that may make President Xi Jinping more receptive to an accommodation with the US. Biden is not seeking regime change in China; all he wants is to reestablish the status quo in Taiwan.

A Russian defeat in Ukraine, and a lessening of Sino-American tensions, may create room for world leaders to focus on fighting climate change, which is threatening to destroy our civilisation. But there is only a narrow and winding path that leads to this outcome.

Moscow, it explodes the myth of invincibility carefully built by Putin. There were also reports of a fire at an oil refinery in the southern Russian Krasnodar region, started by a drone. The raid on Moscow did not cause as much damage as alarm. It is highly embarrassing for Putin to find ordinary Russians being greeted with such strikes close to their homes. This punctures the illusion Putin has so carefully created to hoodwink his own people. It is difficult for him now to pretend things did not happen when his people can see them from their windows. Most analysts believe the drone attacks are part of a strategy to force the Kremlin to divert resources and attention away from the frontline in advance

of a Ukrainian counteroffensive to recapture occupied territory. It is therefore all the more necessary to get facts about the war. For Putin the invasion of Ukraine was a dire necessity to create a buffer zone in view of Ukraine's highly probable induction into NATO. He was convinced he could do so easily. Obviously, his intelligence agencies did a shoddy job as they were unable to assess the resolve of the Ukrainians to defend their territories. The supply of arms and ammunition and sophisticated air power by the US-led West has further upset Putin's calculations.

It could be that if he is cornered, Putin may exercise the nuclear option that he has so long been threatening to intimidate the West. The need of the hour for the global community is to persuade Putin to go to the negotiation table and end the war.

The country that can make it possible is China. But, the latter seems to have other ideas. When the economy of Russia and the West are getting hit daily due to the war, China is consolidating its own economy with its plan to overtake the US and become the largest economic power in the world.

Jackanapes

A jackanapes is a cheeky or impertinent person. The most widespread story A connects the origins of this word with William de la Pole, Duke of Suffolk. He was steward of the Royal Household under Henry VI, but was accused of treason and banished in 1450, only to be murdered at sea off Dover. His emblem was an ape's clog and chain (a clog here being not a type of shoe but a heavy block of wood to stop the animal escaping). This led to his being described in a scurrilous poem the year before his death as ape-clog and posthumously as Jack Napes. Though Jack Napes might therefore seem to derive from the ill-fated duke, something that has often been assumed, the experts are sure that it came from another source and was applied to the Duke because of his odd emblem. The real origin probably lay in a playful name for a tame ape, in which the second part was a case of metanalysis (in which an ape has been turned into a nape), with an s on the end to make it match other surnames of the period, like Jacques or Hobbes. It went through various forms until it settled down to its modern spelling. The idea behind it moved from a pet name for an ape to a man acting in some way like an ape. The OED gives the sense in one of its wonderful definitions as "One who is like an ape in tricks, airs, or behaviour; a ridiculous upstart; a pert, impertinent fellow, who assumes ridiculous airs; a coxcomb.'

Jackpot

The word has always had associations with gambling, at first not the big lotteries of today with their rollover jackpots, but with the game of poker. In its early days in the US in the 1820s, poker was a gambling game for four players using a deck of only 20 cards; its reputation was commonly as a crooked game for cheats and hustlers. Its rules evolved very quickly through the following decades. Players began to use the full deck of 52 cards so more could take part in a game and, around the 1860s, some bright spark had the idea of improving the game by introducing a rule that nobody could open the betting unless his hand contained two jacks or better. If, after the usual rounds of dealing extra cards, nobody else had a hand good enough to bid, the player with the good hand took the accumulated stakes, which obviously enough became known as the jack pot. This version of the game took a while to catch on. Though the term is first recorded in an issue of The National Police Gazette in 1865, it doesn't appear with any frequency until the middle 1870s. The term began to be applied to lotteries only around the start of the twentieth century.

Shoddy construction

Sir, This refers to "Guard feared dead in Bihar bridge collapse," Orissa Post, Jun 6. It is a relief that about 100 lives of poor labourers were saved from the clutches of death in the unfortunate incident in which one guard feared dead. "A team of Delhi Police visited Gonda and recorded statements of Singh's associates and those working at his house, including his driver. This is being done as part of further investigation to collect evidence and corroborate versions of the witnesses with that of Singh and the complainants in the case," an official said. The team checked their IDs and noted their addresses while recording the statements, police added. Over 125 people, including family members and associates from both sides, have been interrogated and their statements were recorded. Singh has been questioned twice, sources said. Technical, digital and manual evidence have been collected. It is shifting focus from safety to all kinds of conspiracy theories like deliberate interference," she told reporters.

At a time when the Railway Minister should resign by taking moral responsibility, new theories are being created to "divert" attention. There is not even an 'A' of accountability of this government, she asserted.

The Congress spokesperson claimed that the Odisha train occurred due to interlocking and signal failure and also due to low track maintenance but the government is trying to divert attention.

The June 2 train crash in Odisha involving two passenger trains and a goods train killed 288 people and injured more than 1,100

said, "Even before the Commissioner of Railway Safety has submitted his report on the Balasore train disaster, a CBI inquiry is announced."

Ramesh also raised the issue of the 2016 Kanpur rail accident in which 150 lives were lost, and noted that the NIA is yet to come out with its report.

Lucknow, June 6: Uttar Pradesh tops in child vulnerability index in relation to climate change. As per the Disaster Scorecard for states and union territories of India Report brought out by the Union ministry of home affairs, Uttar Pradesh has the highest Child Vulnerability Index of 4.61.

It is followed by Bihar (4.54) Rajasthan (4.49), Madhya Pradesh (4.48), Andhra Pradesh (4.37), Assam (4.27) and Chhattisgarh (4.00). The state also ranks high on the disaster risk index whereas its disaster resilience index was low.

To note, disaster risk index refers to the average risk of death in a geographical region in large or medium-scale disasters such as earthquakes, tropical cyclones and floods. It is derived from meteoro logical data tabulated between 1980 and 2000. In India, UP ranks among the top three on the count.

The capacity of communities to prepare, absorb and recover from natural hazard events, and the capacities of communities to learn, adapt and transform towards resilience defines the disaster re-

Gyan Singh, sub-divisional forest officer, said: "The crane is a beautiful state bird. It is about four feet in height, and its feet and neck are considerably long. The bird lays eggs at the end of the summer season and beginning of rainy season. It eats insects that are harmful to agricultural crops, which is why cranes are called farmers' friends.

"I have instructed my staff to keep a vigil on the places where cranes live. If anyone is found hurting them or damaging their habitats, stern action will be taken.

"As per a census carried out last year, there are over 17,000 cranes in Uttar Pradesh. Of them, the highest number of cranes are found in districts Etawah (3,293), and Mainpuri (2,737).



ARANMULA MIRRORS UNDER THREAT

Pathanamthitta (Kerala), June 6: Aranmula mirrors, a metallurgical wonder and GI-protected centuries-old handicraft from Kerala, whose priced pieces adorn the British Museum and Buckingham Palace, is now under threat from the effects of climate change.

The 2018 floods and the extreme rainfall events that continue to trouble Kerala have depleted a key raw material — the clay from the river Pamba's basin - used to create the casts that make the one-ofits-kind handicraft, say its craftsmen

Known as the Aranmula Kannadi (mirror) in Malayalam, as it is a product of the temple town of Aranmula in Pathanamthitta district, the metal alloy mirror was given a geographical indication tag in 2004-2005 for its super exclusivity. Made by the finest craftsmen for generations, the unique product has been given on many occasions as a gift to heads of state visiting India by Indian authorities. Prime Minister Narendra Modi, on his visit to the UK in November 2015, presented an Aranmula Kannadi to then British First Lady

Samantha Cameron.

But now the artisans who make the true-reflection mirror are finding it hard to source the clay with the requisite qualities, as the past few years' floods and landslides in the area have changed the chemical and physical properties of the soil in Aranmula village

Manoj and his family live in a house close to the river Pamba in Aranmula, where the mirror-making unit is also located. His house, a one-storied building, was completely submerged in water during the 2018 floods.

'The floods have deposited



huge amounts of silt on the soil, causing damage to the original soil here, which is essential for making Aranmula

mirrors," Manoj said. The Kerala Soil Survey Department also con-

firms the changes in the chemical and physical properties of the soil in flood-affected areas of Kerala.

"Our study after the 2018 floods in 13 districts has identified significant changes in soil quality. The quality of the soil in the Pamba

basin, where Aranmula is located. has deteriorated significantly," V Justin, Assistant Director, Soil Survey Department, Pathanamthitta, said.

Extreme rain events can worsen the situation, he adds. Top soil erosion and silt deposits during flash floods could cause a major problem in areas like Aranmula. If these areas get flooded again, more silt will get deposited and contaminants could further alter the soil characteristics, he said.

"Large quantities of sand, silt, and clay were seen deposited on the surface soils of the affected panchayats. The thickness of deposition varied from 2cm to 10cm. Soil crusting was also reported from

was a change in the texture of the soil, from clay loam to sandy clay loam. The study also identified increasing acidity in the soil after the floods as a major problem and found that there was a great imbalance in the chemical components in the soil

"The soil we use should have the right level of stickiness so that the cast would hold properly in extreme temperatures. The soil we get now cracks easily, and that damages our mirror while moulding," Sooraj Acharya, who runs Sundar Handicrafts, one of the 26 traditional mirror-making units left in Aranmula, said.

The clay discs made from the soil -- which is now often turning into a grainy paste -- and are baked at a high temperature, are integral to getting a good-quality mirror. These discs are reused several times, and if the quality of clay is not good, they can crack, leaking out the hot metal mixture for the mirror from the clay cast.

A mixture of tin and white lead for the mirror is filled up in the clay

cast, containing the clay discs, and then heated up. Once the metal mixture is melted, the clay cast is turned over, allowing the melted metal mixture to flow into the space between the discs. It is then cooled and taken out.

"A smooth-surfaced mirror has to come out, and for that the quality of the clay cast and discs is paramount. With the present soil quality, we lose at least 10 to 15 mirrors when we cast 50 of them, Sindhu G, president of the association of Aranmula Mirror workers, and a traditional mirror maker, said. The metals used and their proportion in the alloy are secrets that have traditionally been passed down through generations.

Though the Soil Survey Department has been studying the deterioration of soil quality in Kerala after the floods and due to the effects of climate change, they are yet to take up the concerns of the Aranmula mirror workers.

'We were unaware of the problems faced by the artisans due to the deteriorating soil quality. We will propose a detailed study in this regard with the permission of the director and will explore means to conserve the required quality of the soil for the artisans of Aranmula," Justin said.

FUGITIVE BROTHERS FROM INDIA FLOURISH IN NIGERIA

New Delhi, June 6: The selection of a firm owned by the family of the Sandesara brothers branded as fugitives by India to drill wells for the project is just the latest sign of how Nigeria has provided the brothers a haven, effectively insulating them from troubles back home, a media report said.

Now, as newly elected President Bola Tinubu sets ambitious targets for Nigeria's hydrocarbons sector, companies created by the brothers, Nitin and Chetan Sandesara, seem poised for an increasingly prominent role -- especially as international oil giants such Shell Plc and ExxonMobil Corp. retreat from the West African country, said the Bloomberg report.

"This discovery will provide a multiplicity of opportunity and great prosperity for Nigeria," Tinubu said at a November 2022 event. Sworn in May 29, he was the ruling party's presidential candidate at the time. The state's partners in the multibillion dollar project in the impoverished, landlocked corner of the country is a company founded



by two brothers from India.

The Sandesara brothers, Guiarati businessmen who left India in 2017, denv cheating their lenders and say they are victims of political persecution. Having ventured into the Nigerian oil industry almost 20 years ago when they won two onshore licenses in the delta, the brothers -- faced with problems in India -- have shifted their focus to Lagos. They even applied for Nigerian citizenship, according to the Central Bureau of Investigation (CBI), Bloomberg reported.

Lung cancer pill cuts risk of death by half: Study

New Delhi, June 6: A once-daily pill halved people's risk of dying from a common lung cancer when they took the drug after tumour-removal surgery, trial results from a global study shows.

The research, published recently in The New England Journal of Medicine, found that taking the drug osimertinib after surgery dramatically reduced the risk of patients dying by 51 per cent.

The resaerchers randomly assigned eligible patients in a 1:1 ratio to receive osimertinib (80 mg once daily) or placebo until disease recurrence was observed. Of 682 patients who underwent

randomisation, 339 received osimertinib also known as Tagrisso and made by AstraZeneca, and

The research found that taking the drug osimertinib after surgery dramatically reduced the risk of patients dying by 51%

343 received placebo. In the primary analysis population, an estimated 85 per cent of patients treated with osimertinib were alive at five vears compared to 73 per cent on placebo, the researchers said.

In the overall trial population, an estimated 88 per cent of patients treated with osimertinib were alive at five years compared to 78 per cent on placebo, they said. The study found that osimertinib reduced the risk of death



by 51 per cent compared to placebo in both the primary analysis population, the researchers said.

'These highly anticipated overall survival results, with 88 per cent of patients alive at five years,

are a momentous achievement in the treatment of early-stage EGFR-mutated lung cancer," said principal investigator in the trial, Roy S. Herbst, Deputy Director and Chief of Medical Oncology at Yale Cancer Center and Smilow Cancer Hospital, US.

'These data underscore that adjuvant treatment with osimertinib provides patients with the best chance of long-term survival,' Herbst said. Susan Galbraith, Executive Vice President, Oncology R&D, AstraZeneca, said osimertinib cut the risk of death by more than half in the adjuvant setting, further establishing this transformative medicine as the backbone treatment for epidermal growth factor receptor (EGFR)mutated lung cancer.

"These results emphasise the importance of diagnosing patients with lung cancer early, testing for EGFR mutations and treating all those with an EGFR mutationwith Tagrisso (osimertinib)," Galbraith said.

Bankers await cues on RBI's liquidity approach WB offers dim outlook

Mumbai, June 6: The Reserve Bank of India's policy review Thursday will be closely watched for cues on its approach towards liquidity, even as policy interest rates are likely to remain unchanged, at least three bankers said.

Banks in India have been reluctant to park their surplus liquidity with the Reserve Bank of India (RBI) for longer periods of time to avoid the risk of a potential shortfall - an approach the RBI would like changed as surplus money in the system could potentially prove inflationary.

Last week the RBI offered to withdraw 2 trillion rupees via 14day variable rate reverse repo auctions - the preferred tool to absorb liquidity for longer periods - after the banking liquidity surplus swelled to 2.4 trillion rupees (\$29.06 billion). Banks, however, parked just a fourth of that amount.

A second VRRR auction of 1 trillion rupees was announced Monday - this time for just 4-days, but was not fully subscribed.

"Banks are not parking funds with the RBI because they are unsure about how long the surplus liquidity will last." said Soumvaiit Niyogi, a director of the core analytical group at India Ratings & Research.

'They would rather give up earning a few extra basis points on their surplus than risk a shortfall due to unanticipated swings in liquidity," he said.

Earlier in May, overnight rates spiked after the liquidity surplus dropped unexpectedly, forcing banks

to borrow from the market.

A treasury official at a large private bank said that apart from unpredictable government spending and forex market intervention, a recent decision to withdraw 2.000rupee denominated notes was among factors that have added to the volatility.

"There is an opportunity cost for banks to park that liquidity for 14-days because they give up options to invest this elsewhere such as in treasury bills," the official said, declining to be identified as he is not permitted to speak to the media.

The 91-day T-bill yield remains above 6.75%, while commercial paper of state-run companies offers around 6.95%

Some banks are also reluctant to tap the central bank's marginal standing facility (MSF), where it offers funds if banks run short of liquidity as their boards and auditors tend to question the use of the high-cost fall-back facility, the banker quoted above said.

"PSU banks want to avoid using MSF ...(and) choose to keep funds with them and go for the lowly-rewarding standing deposit facility (SDF)," treasury head of a state-run bank said.

Communication from the central bank to "de-stigmatise" the MSF window will help, the private bank official said.

The repo rate stands at 6.50%, while SDF and MSF stand at 6.25% and 6.75% respectively.

Another official at a private bank said overnight VRRR would be welcome but the central bank may be reluctant to offer it. The RBI and banks were "feeling their way through" the current liquidity condition, he said.

Washington, June 6: The global economy is likely slowing sharply this year, hobbled by high interest rates, the repercussions of Russia's invasion of Ukraine and the lingering effects of the coronavirus pandemic.

That's the latest outlook of the World Bank, a 189-country antipoverty agency, which estimates that the international economy will expand just 2.1% in 2023 after growing 3.1% in 2022.

Still, the bank's latest Global Economic Prospects report, which it issued Tuesday, marks an upgrade from its previous forecast in January.

That estimate had envisioned worldwide growth of just 1.7% this year.

The Federal Reserve and other major central banks have been aggressively raising interest rates to combat a resurgence of inflation, set off by a stronger-than-expected rebound from the pandemic recession, persistent supply shortages and energy and food price shocks caused by the Ukraine war.

But the global economy has proved surprisingly resilient in the face of higher borrowing costs. and the World Bank predicts that growth will accelerate to 2.4% in 2024

The United States has continued to generate unexpectedly robust job gains — employers added 339,000 workers in May, far more than though the Fed has raised its benchmark rate 10 times in the past 15 months.

In its report Tuesday, the World Bank upgraded its forecast for U.S. Economic growth this year to 1.1%.

Though weak, that is more than double the growth the World Bank had envisioned in January.

The eurozone, which represents the 20 countries that share the euro currency, is expected to post collective growth of 0.4% this year.

That, too, marks a slight upgrade: In January, the World Bank had expected no growth at all for the eurozone this year. Europe, struggling with higher energy prices caused by the Ukraine war, enjoyed relief from a surprisingly warm winter, which reduced demand for heat.

The World Bank upgraded its 2023 outlook for China after Beijing late last year relaxed its draconian zero-COVID policies, which had restricted travel and hammered its economy.

The world's second-biggest economy is now expected to grow 5.6% in 2023, up from 3% last year.

The World Bank envisions Japan's growth decelerating to 0.8% this year from 1% in 2022.

It foresees India's growth slowing to a still-strong 6.3% from 7.2% last year.

Mumbai: Leading non-bank lender IIFL Finance is tapping the debt market to raise up to Rs 1,500 crore by selling NCDs, offering up to 9 per cent in return to investors. The primary issue of secured redeemable non-convertible debentures (NCDs) is for Rs 300 crore, with a green-shoe option to retain oversubscription of up to Rs 1,200 crore, totalling Rs 1,500 crore, offering up to 9 per cent for a 60-month tenor. The bonds are also available in 24 months, 36 months tenors. The interest will be paid annually, on a maturity basis and with a monthly option for 60-month tenure, group chief financial officer Kapish Jain said.

HZL disinvestment: Govt woos investors

New Delhi: The government is likely to begin international roadshows starting with the US this month for the sale of its residual 29.54 per cent stake in erstwhile public sector company Hindustan Zinc Ltd (HZL), an official said. The government had decided to exit the zinc maker last year but the plan hit a roadblock because of the firm's owner, billionaire Anil Agarwal's Vedanta Ltd proposal. Vedanta wanted to sell its global zinc assets to HZL in a move that many analysts saw as an attempt to tap into the erstwhile staterun firm's huge cash pile. The government, which has a directorial position on HZL, opposed the move over valuation concerns.

Byju's disqualifies US lender for 'predatory' tactics

New Delhi: Byju's has skipped payments due on a USD 1.2 billion loan and instead disqualified the US lender for 'predatory' tactics, the education technology startup said Tuesday. Byju's filed a suit against investment management firm Redwood saving the US entity purchased a significant portion of the loan while primarily trading in distressed debt, which was contrary to the conditions of the term loan facility. Byju's, which provides services to more than 150 million students around the world, did not pay USD 40 million in interest due Monday on the USD 1.2 billion loan. In a statement, the startup said it has elected not to make further payments on the USD 1.2 billion so-called term loan B (TLB) and that it filed a suit in the New York Supreme Court. The lenders in March unlawfully accelerated the loan due to certain alleged non-monetary and technical defaults, it said adding that the lenders undertook unwarranted enforcement measures, including seizing control of its US unit -- Byju's Alpha and appointing its management.

The company emphasised that it drew upon its past decades of product design during the years it spent working on the Vision Pro, which Apple said involved more than 5,000 different patents.

with 12 cameras, six microphones and variety of sensors that will allow users to control it and various apps with just their eyes and hands. Apple also developed a technology to create three-dimensional digital version of each user to display during video conferencing.

If the new device turns out to be a niche product, it would leave Apple in the same bind as other major tech companies and startups that

have tried selling headsets or glasses equipped with technology that either thrusts people into artificial worlds or projects digital images with scenery and things that are actually in front of them — a format known as "augmented reality."

Facebook founder Mark Zuckerberg has been describing these alternate three-dimensional realities as the "metaverse." It's a geeky concept that he tried to push

into the mainstream by changing the name of his social networking company to Meta Platforms in 2021 and then pouring billions of dollars into improving the virtual technology.

But the metaverse largely remains a digital ghost town, although Meta's virtual reality headset, the Quest, remains the top-selling device in a category that so far has mostly appealed to video game players looking for even more immersive experiences. Cook and other Apple executives avoided referring to the metaverse in their presentations, describing the Vision Pro as the company's first leap into "spatial computing" instead.

The response to virtual, augmented and mixed reality has been decidedly ho-hum so far. Some of the gadgets deploying the technology have even been derisively mocked, with the most notable example being Google's internet-connected glasses released more than a decade ago.

After Google co-founder Sergey Brin initially drummed up excitement about the device by demonstrating an early model's potential "wow factor" with a skydiving stunt staged during a San Francisco

tech conference, consumers quickly became turned off to a product that allowed its users to surreptitiously take pictures and video. The backlash became so intense that people who wore the gear became known as "Glassholes," leading Google to withdraw the product a few years after its debut.

Microsoft also has had limited success with HoloLens, a mixed-reality headset released in 2016, although the software maker earlier this year insisted it remains committed to the technology.

The anticipation that Apple's goggles are going to sell for several thousand dollars already has dampened expectations for the product. Although he expects Apple's goggles to boast "jaw dropping" technology, Wedbush Securities analyst Dan Ives said he expects the company to sell just 150,000 units during the device's first year on the market — 🗦 a mere speck in the company's portfolio. By comparison, Apple sells more than 200 million of its marquee iPhones a year. But the iPhone wasn't an immediate sensation, with sales of fewer than-12 million units in its first full year on the market.

Collapse of major dam in Ukraine triggers emergency

Kyiv, June 6: The wall of a major dam in southern Ukraine collapsed Tuesday, triggering floods, endangering Europe's largest nuclear power plant and threatening drinking water supplies as both sides in the war rushed to evacuate residents and blamed each other for the destruction.

Ukraine accused Russian forces of blowing up the Kakhovka dam and hydroelectric power station on the Dnieper River in an area that Moscow controls, while Russian officials blamed Ukrainian bombardment in the contested area. It was not possible to verify the claims.

The potentially far-reaching environmental and social consequences of the disaster quickly became clear as homes, streets and businesses flooded downstream and emergency crews began evacuations; officials raced to check cooling systems at the Zaporizhzhia Nuclear Power Plant; and authorities expressed concern about supplies of drinking water to the south in Crimea, which Russia illegally annexed in 2014. Both Russian and Ukrainian authorities brought in trains and buses for residents. About 22,000 people live in areas at risk of flooding in Russian-controlled areas, while 16,000 live in the most critical zone in Ukrainian-held territory, according to official tallies. London, June 6: Prince Harry Tuesday became the first senior British royal to give evidence in a high court trial in over 100 years as he appeared in the witness box here to allege "utterly vile" unlawful information gathering, including by phone hacking, by journalists working for the Mirror Group Newspapers (MGN)

Quake strikes Haiti; three dead

Port-Au-Prince: An earthquake with a preliminary magnitude of 4.9 struck southern Haiti early Tuesday, killing at least three people and injuring several others, authorities said. The quake struck before dawn near the southern coastal city of Jeremie at a depth of six miles (10 kilometers), according to the U.S. Geological Survey."I thought the whole house was going to fall on top of me," Eric Mpitabakana, a World Food Program official in Jeremie, said.

Zelenskyy said in October his government had information that Russia had mined the dam and power plant. But Kremlin spokesman Dmitry Peskov called it "a deliberate act of sabotage by the Ukrainian side ... aimed at cutting water supplies to Crimea".

2.3 bn people globally use polluting fuel to cook: Report

United Nations, June 6: Up to 2.3 billion people around the world are still using polluting fuels to cook and 675 million don't have electricity, according to a report released Tuesday by five international organisations.

The report said that at current rates, 660 million people are proiected to be without electricity and 1.9 billion won't have clean cooking

opportunities by 2030. That's the target date to achieve a United Nations goal set in 2015 "to ensure access to affordable, reliable, sustainable and modern energy for all."

The report by the International Energy Agency, International Renewable Energy Agency, U.N. Statistics Division, World Bank and World Health Organisation said that at the midway point toward the goal, the world is not on track to reach the energy target, which will negatively impact the health of millions and accelerate climate change.

'The energy crisis sparked by Russia's invasion of Ukraine continues to have a profound impact on people all around the world," International Energy Agency Executive Director Fatih Birol said in a statement. "High energy prices have hit



the most vulnerable hard, particularly those in developing

economies." He said that while the transition to clean energy is hap-

pening faster than people think, a great deal of work is still needed to provide it to the billions still living without it.

According to the report, global access to electricity increased from 84% in 2010 to 91% in 2021, but the pace of growth slowed in 2019-2021, which includes the start of the COVID-19 pandemic. While the electrification of rural areas contributed to progress, there is still a large gap in urban areas, it said.

More than 80% of those without electricity — 567 million in 2021 - lived in sub-Saharan Africa, similar to the deficit in 2010, it said. The report also found that up to 2.3 billion people still use polluting fuels and technologies, including firewood.

Francesco La Camera, directorgeneral of the International

Renewable Energy Agency, said: "Cost-competitive renewable energy has yet again demonstrated remarkable resilience, but the poorest in the world are still largely unable to fully benefit from it.'

According to estimates by WHO in 2019, 3.2 million premature deaths every year were attributable to household air pollution from polluting fuels and technologies. WHO Director-General Tedros Adhanom Ghebreyesus said investing in clear and renewable solutions to achieve universal energy access "can play a crucial role in protecting the health of our most vulnerable populations.

Guangzhe Chen, the World Bank's vice president for infrastructure, called for urgent efforts "to ensure that the poorest andhardest-to-reach people are not left behind.
