#### Egypt's highest honour for Modi

Cairo, June 25: Prime Minister Narendra Modi was Sunday conferred with the 'Order of the Nile', Egypt's highest honour, by President Abdel Fattah El-Sisi here.

Instituted in 1915, the 'Order of the Nile' is conferred upon heads of states, crown princes, and vice presidents who offer Egypt or humanity invaluable services. The 'Order of the Nile' is a pure gold collar consisting of three-square gold units comprising Pharaonic symbols.

The first unit resembles the idea of protecting the state against the evils, the second one resembles prosperity and happiness brought by the Nile and the third one refers to wealth and endurance. The three units are connected to one another by a circular gold flower decorated with turquoise and ruby. Hanging from the collar is a hexagonal pendant decorated with flowers of the Pharaonic style, and turquoise and ruby gems. In the middle of the pendant, there is a protruding symbol representing the Nile that brings together the North and

#### China aiding Pak build defence infra along LoC

New Delhi, June 25: China has been helping the Pakistan Army build its defence infrastructure besides providing Unmanned Aerial and Combat Aerial Vehicles, setting up communication towers and laying underground cables along the Line

of Control, officials said. This, according to the officials, is part of efforts to further shore up China's position as an all-weather friend of Pakistan while ensuring the safety of the growing Chinese enclaves on Pakistan-occupied Kashmir (PoK) set up on the pretext of securing the China-Pakistan Economic Corridor (CPEC) road and hydel projects built in the occupied territory.

The officials said that the recently developed SH-15, a 155 mm truck-mounted howitzer gun, has also been spotted at some places along the LoC after it was displayed on Pakistan Day last year.

Some intercepts suggested that Chinese troops and engineers were setting up infrastructure along the LoC, including building underground bunkers, the officials said.

The Army has officially maintained silence on the issue but has been constantly updating the intelligence agencies, sources said.

# Fraud racket in name of NCB, ED, CBI busted Tribals against UCC 2/3rd of ₹2,000 notes returned in a month

Bhubaneswar, June 25: The Economic Offences Wing (EOW) of Crime Branch has claimed to have busted a cyber fraud racket involved in duping gullible people of crores of rupees by faking courier services and blackmailing victims in the name of NCB, CBI, ED and other agencies.

The EOW registered a case on the basis of a complaint filed by Ratna Tripathy of Nayapalli area here and froze 17 bank accounts involved in the financial fraud. Tripathy received a phone call from a person, who introduced himself as an employee of FedEx, Hyderabad, telling her that a parcel containing six passports, a laptop, five ATM cards and 150 gm drugs had been sent to her but have been intercepted by NCB, Mumbai officials.

to come to NCB Cell of Mumbai to prove her point or she can connect to one Gill, purported head of NCB Mumbai, over Skype. The caller threatened her by saying that if she ignores this she would be prosecuted under NDPS and money laundering cases. Ranchi, June 25: More than 30 tribal organisations in Jharkhand Sunday decided to urge the Law Commission to withdraw the idea of Uniform Civil Code (UCC), as it may put tribal identity in danger in the country. They also decided to launch an agitation against the fresh consultation on the UCC by the Law Commission.

Representatives of more than 30 tribal organisations gathered in Ranchi under the banner of Adivasi Samanwai Samiti (ASS) to discuss UCC. They expressed apprehensions that the UCC might dilute several tribal customary laws and rights. The 22nd Law Commission of India June 14 sought fresh suggestions

They fear that two tribal laws -- the Chota Nagpur Tenancy Act and the Santhal Parganas Tenancy Act -- may get affected due to UCC. The two laws provide protection to tribal lands

As per some tribal customary laws, women are not given ancestral land rights after marriage. After UCC, this law may get diluted

from various stakeholders, including public and religious organisations on the UCC.

"In the meeting, we have decided to write to the Law Commission urging it to withdraw the idea of UCC, as it may put the identity of tribals in danger across the country," ASS member Dev Kumar Dhan told PTI. The tribal bodies would stage a demonstration against the UCC near Jharkhand Raj Bhavan July 5 and submit a memorandum to the Governor. "We will urge the Governor to request the Centre for withdrawal of the

idea of UCC," he said. Dhan, who is also the convener of Adivasi Mahasabha, alleged, "It appears to be a conspiracy to abolish tribal customary laws, Chotanagpur Tenancy (CNT) and Santhal Pargana Tenancy (SPT) Acts, Wilkinson Rule, PESA law, rules for Fifth Schedule Area, marriage and divorce laws of tribals on the pretext of UCC.

Dhan said that if their demand was not considered, the tribals from across the country would also stage a demonstration in New Delhi.

Tribals are deeply connected with their lands. CNT and SPT provide protection to tribal lands.

Mumbai, June 25: Reserve Bank Governor Shaktikanta Das has said that within a month of the recall order, more than two-thirds of the ₹2,000 currency notes have returned to the system.

In a surprise move, but as part of the clean note policy, the Reserve Bank had May 19 ordered the recall of the ₹2,000 banknotes worth around ₹3.62 lakh crore.

June 8, announcing the second monetary policy review of the fiscal. Das had said around ₹1.8 lakh crore worth of the ₹2,000 notes have been returned, accounting for approximately 50 per cent of the notes in circulation as of March 31, of which 85 per cent were in deposits and the rest in exchange.

lakh crore (as of March 31, 2023) of the now-recalled 2000 banknotes have come back to the system as of mid-last week, Governor Das told PTI Bhasha in an interview at the RBI headquarters last week

Of the total money that has come back to the system, as much as 85 per cent are in deposits and the rest in currency exchanges, he explained.

Though the central bank has set September 30, 2023, as the last day for exchange/deposits, Das said the deadline is not something cast in stone and that, people need not hurry.

### Spoken by lakhs of tribals, Soura awaits recognition INDO-ASIAN NEWS SERVICE

Bhubaneswar, June 25: Seven decades after Independence, Soura, a tribal language spoken by over five lakh people of a Particularly Vulnerable Tribal Group (PVTG) of Odisha, is awaiting its place in the 8th Schedule.

Odisha has the third highest tribal population in the country and is home to 62 types of Scheduled Tribe communities, of which 13 are of PVTGs. The Soura tribe is one of them and they reside mainly in the districts of Rayagada, Gajapati and Koraput. They are also present in Srikakulam, Vizianagaram and Visakhapatnam districts of Andhra Pradesh

According to the local tribal community leaders, the indigenous language is being used by the community from one generation to another. The idea for writing a Soura script came to Malia Gomango but was invented by his son-in-law Mangei Gomango

It is believed that the Sorang Sompeng alphabet came to Mangei Gomango in a vision June 18, 1936. He also founded a religious order dedicated to Akshara Brahma, a stone scripted with Soura letters

The Soura or Sabar community people believe that the script is God's gift to them. Now, it has been developed as the temple of Matarabnam in Marichaguda which played a great role in the invention of the script.

Mangei Gomango was instrumental in promoting it by setting up a letterpress which produced many books. So, his community people give respect to him as their Guru and he is popularly known as Pandita Sabara Mangei Gomango. He passed away in 1980.

Each of Sompeng's 24 letters is named after a god or goddess of the Hindu religion. Like most native scripts of India, Sorang Sompeng is an abugida where alphabetic letters have a single inherent vowel that can be replaced by the presence of another vowel character. There are 10 digits in the language from 0 to 9.

From the invention of the script, Mangei and other leaders of the tribal community have been demanding inclusion of the language in the 8th Schedule of the Constitution of India.

Former Odisha Chief Minister Giridhar Gamang, ex-minister late Bhagirathi Gamango, prominent researcher Gabriel Boya and others have contributed to the promotion of the language.

In 2020, Giridhar Gamang had written a letter to Prime Minister





## **Denial of freedom fighter** pension: NHRC for action

Bhubaneswar, June 25: The National Human Rights Commission (NHRC) has directed the Chief Secretary of Odisha to initiate an inquiry and take appropriate action against the officials responsible for denial of freedom fighter pension to Meera Devi, who died of Covid after being deprived of her legitimate right. The commission issued the order while hearing a petition filed by Supreme Court lawyer and rights activist Radhakanta Tripathy in June 2021

February 8, 2023, the apex rights panel had directed the Bhadrak Collector to provide complete administrative assistance to 87-year-old Meera Devi, spouse of Late Gour Chandra Mohapatra and the youngest daughter-in-law of Late Laxmikanta Mohapatra, the writer of the state anthem "Vande Utkala Janani", to do the needful as per the requirements of Freedom Fighters and Rehabilitation (FFR) Division,

Ministry of Home Affairs (MHA). The copy of the proceeding



was also forwarded to MHA and the Chief Secretary for information and ensuring compliance of direction of the com-

The Bhadrak Collector informed the commission that the requisite documents of the victim have been submitted to the under secretary of FFR Division for grant of dependent SSSY Pension in favour of Meera Devi.

The MHA under secretary acknowledged the receipt of requisite documents, but expressed his inability towards the sanction of grant as the complainant stated in his letter submitted December 15, 2022 that the victim had died during the pendency of her complaint before this commission. The DM & Collector, Bhadrak, has also been asked to verify the same.

'In pursuant to further direction of the NHRC, report dated 18.04.2023 of ADM, Bhadrak and report dated 17.05.2023 of DM, Bhadrak was received," Tripathy said.

The Collector, during inquiry, found that Meera Devi had expired June 15, 2021 at AMRI Hospital, Bhubaneswar – just a day after the NHRC took cognisance of the case. He also allegedly mentioned in the report that complete administrative assistance has been provided to Meera Devi.

"It raised the question as to how the signature and related documents of a dead person could be attested by a revenue authority," Tripathy alleged.

The documents duly attested by Deputy Collector includes attested copy of specimen signature, identification marks, selfphotograph, affidavit, date of

birth, family details etc. These reports are really contradictory in nature. The Chief Secretary of Odisha is recommended to look into the same and take appropriate action against the officials, if found guilty," the rights body said.

## SC stays part of Orissa HC order

New Delhi, June 25: Taking note of the fight over the custody of a girl child, the Supreme Court has stayed a part of the Orissa High Court order which had directed the adoptive parents to handover the kid to her biological father.

"There shall be an interim stay of the direction of the High Court directing the petitioners herein to handover custody of the minor child, namely... To respondent No.2 (the biological father) until further orders," a vacation bench comprising Justices B V Nagarathna and Manoj Misra said in its order Friday.

The top court was hearing an appeal filed by the adoptive parents of the girl, who is now about 12-year old, assailing the Orissa High Court order of April 3 asking them to handover the child to her biological father.

Deciding to examine the plea in the interest of the child, the top court issued the notice to the person, who claims to be the biological father. Earlier, the father had moved the high court seeking custody of the child by filing a plea of habeas corpus (bring the person) under the 'parens patriae (parent of the nation) jurisdiction.

## Exercise, resoluteness can rout drug abuse: Experts

Bhubaneswar, June 25: On the eve of International Day against Drug Abuse and Illicit Trafficking or World Drug Day, a few experts and fitness freaks opined that regular exercise. counselling and a resolute stand to quit substances can help prevent drug abuse.

World Drug Day is observed June 26 every year to strengthen action and cooperation in achieving a world free of drug abuse. This year's theme is "People first: Stop Stigma and Discrimination, Strengthen Prevention".

The consequences of drug abuse are far-reaching, leading to deteriorating health, broken relationships, and a loss of productivity. The United Nations General Assembly, by the resolution 42/112 of December 7, 1987, decided to observe June 26 as the International Day against Drug Abuse and Illicit Trafficking as an expression of its determination to strengthen action and cooperation to achieve the goal of an international so-

ciety free of drug abuse. The aim of this year's paign is to raise awareness about the importance of treating people who use drugs with respect and empathy; providing evidence-based, voluntary services to all; offering alternatives to punishment; prioritising prevention; and leading with compassion. The campaign also aims to combat stigma and discrimination against people who use drugs by promoting language and attitudes that are respectful and non-judgemental.

**Orissa POST** spoke to a couple of experts who have successfully helped many people quit addiction and offered them a second chance of life. Samarpan, an initiative towards drug rehabilitation in Bhubaneswar since 2007, has helped heal a lot many. Founder-director of Samarpan, Prabhu Dutt Patel said, "As per research and experience, 10-

It is very important for both the patient and the family to step out of denial mode and make life better. Societal and family denial is what makes it all worse. Patel added.

Priyanka Singhdeo, a fitness enthusiast, said, "Regular exercise is a powerful tool for drug addicts who are struggling to overcome the bad phase. It will redirect their focus towards a positive outlet. Engaging in physical activities not only improves overall health but also helps in rebuilding self-confidence, reducing stress and enhancing mental well-being. As per studies, it has been observed that regular workouts can alter dopamine processing, potentially making exercise feel more pleasurable than drugs. By embracing fitness, individuals battling addiction can find solace, strength and a new sense of purpose on their path to recovery. If a person is working towards overcoming the addiction, he or she should get involved in workouts and program it meaningfully to allow it to work.'

Pratik Behera, a final year B-

tech student of Bhubaneswar, said, "I was a victim of drug addiction, I've done it for 10 years during my college life and it took me six weeks on and off to quit it. I would say it is all in mind when you're absolutely determined to quit. Fitness and psychological support have been\_ of great help for me throughout. After quitting, I've never

felt withdrawal syndromes.' Renowned psychiatrist of the Capital city Amrit Pattajoshi said, "Alcohol and drug addiction affect one's brain and behaviour. When you're addicted to drugs, you can't resist the urge to use them, no matter how much harm the drugs may cause.

Drug addiction isn't about just heroin, cocaine, opioids or any other illegal substance. You can get addicted to alcohol, nicotine and other legal substances, he

"Our brain is wired to make us want to repeat experiences that make you feel good," said Pattajoshi. Drugs flood your brain with a chemical called dopamine. This triggers a feeling of intense pleasure, he added.

"When you use drugs for a long time, it can cause changes in the brain's chemical systems and circuits as well. If drug use is out of control or causing problems, please consult a doctor,"

#### **How Murmu missed** the most important call

New Delhi, Jun 25: Droupadi Murmu was not a frequent mobile phone user and probably "missed the most important call of her life" - that from the Prime Minister's Office to inform her about her nomination as the official NDA candidate for the president's post, claims a

But her former officer on special duty in Jharkhand, Bikash Chandra Mohanto, came running to Murmu's house with his phone in hand, saying he had received a call apparently from the Prime Minister's Office (PMO) and was asked to connect with her.

This incident of June 21, 2022 finds mention in the biographical work "Droupadi Murmu: From Tribal Hinterlands to Raisina Hill" by journalist Kasturi Ray, published recently by Rupa.

Through interviews and analysis, Ray tracks Murmu's life, following her through school and college, from being a teacher to social worker, councillor to minister, from taking charge as the governor of Jharkhand to becoming India's first tribal president. On that day in June last year, Murmu was in Odisha's Rairangpur, 14 km from her native village Uparbeda and nearly 275 km from capital Bhubaneswar. The BJP was to announce the NDA's presidential candidate. All were waiting for an official announcement.

"Unfortunately, Murmu and her family were not able to watch the news because of a power cut. Yet the indications were apparent. The sense of serendipity was palpable," the book says.

### Organs of brain-dead patient save four lives

Bhubaneswar, June 25: In a first in the state's medical history, multiple organs retrieved from a brain-dead patient at the SUM Ultimate Medicare (SUMUM) hospital here were rushed to three different cities, for transplantation Saturday, providing a new lease of life to four critical

Multiple organs, including two kidneys, lungs and a liver were retrieved from Prasenjit Mohanty, the brain dead patient, with the approval of his family, while excellent coordination through government agencies enabled the organs to be flown to two private hospitals in New Delhi and Kolkata for transplantation, informed SUMUM

Chief Executive Officer Swetapadma Dash Sunday.

The police created a green corridor in Bhubaneswar for transporting the organs in two ambulances from the hospital to the Biju Patnaik International Airport from where the same were flown to the two cities accompanied by outstation med-

Of the two kidneys, one was transplanted on a waiting patient at SUMUM last night while another was taken to the SCB Medical College and Hospital at Cuttack for transplantation on another patient.

The two lungs were flown to a private hospital at Kolkata to help the critical condition of a 16year-old boy suffering from paraquat poisoning who has been enduring a challenging 45-day wait for the organs while being supported by ECMO. The liver was transported to another private healthcare facility in New Delhi, saving another critical patient.

"Forty three-year-old Mohanty, who had suffered severe head injury after a fall, had been admitted to SUMUM June 22 and underwent emergency brain surgery," said Somnath Prasad Jena, Consultant Neurosurgeon at

"Though his condition somewhat improved following the surgery, it deteriorated subsequently and an Apnea test conducted June 23 yielded a positive result signifying that the patient was brain dead. A second test was done after six hours which confirmed the earlier report." Jena said.

Dash said when the family members were informed about they offered to donate his organs as it could help to save the lives of others

"It was a momentous decision and we salute Mrudumanjari Mohapatra, wife of the patient, for her bold decision to donate the organs as there is cultural resistance to such practice in the society,' she said.

The hospital alerted the State Organ and Tissue Transplant Organisation (SOTTO) and subsequently information reached the Regional Organ and Tissue Transplant Organisation (ROTTO) and National Organ and Tissue Transplant Organisation (NOTTO).

Medical teams from Kolkata and New Delhi reached SUMUM Saturday and a 20-member team comprising surgeons from SUMUM and outstation doctors retrieved the required organs following proper procedure

## The folly of making art with text-to-image generative AI

cial intelligence isn't new. It's as old as AI it-

What's new is that a wave of tools now let most people generate images by entering a text prompt. All you need to do is write "a landscape in the style of van Gogh" into a text box, and the AI can create a beautiful image as instructed

The power of this technology lies in its capacity to use human language to control art generation. But do these systems accurately translate an artist's vision? Can bringing language into art-making truly lead to

artistic breakthroughs? I've worked with generative AI as an artist and computer scientist for years, and I would argue that this new type of tool constrains the creative process.

When you write a text prompt to generate an image with AI, there are infinite possibilities. If you're a casual user, you might be happy with what AI generates for you. And startups and investors have poured billions into this technology, seeing it as an easy way to generate graphics for articles, video game characters and advertisements.

In contrast, an artist might need to write an essaylike prompt to generate a high-quality image that reflects their vision - with the right composition, the right lighting and the correct shading. That long prompt is not necessarily descriptive of the image but typically uses lots of keywords to invoke the system of



what's in the artist's mind. There's a relatively new term for this: prompt engineering. Basically, the role of an artist using these tools is reduced to reverse-engineering the system to find the right keywords to compel the system to generate the desired output. It takes a lot of effort, and much trial and error, to find the

right words. To learn how to better control the outputs, it's important to recognize that most of these systems are trained on images and captions from the internet. Think about what a typical image caption tells about an image. Captions are typically written to complement the visual experience in web browsing.

For example, the caption might describe the name of the photographer and the copyright holder. On some websites, like Flickr, a caption typically describes the type of camera and the lens used. On other sites, the caption describes the graphic engine and hardware used to render an image

So to write a useful text prompt, users need to insert many nondescriptive keywords for the AI system to create a corresponding image. Today's AI systems are not as intelligent as they seem; they are essentially smart retrieval systems that have a huge memory and work by association.

Is this really the sort of tool that can help artists create great work? At Playform AI, a generative AI art platform that I founded, we conducted a survey to better understand artists' ex-

periences with generative AI. We collected responses from over 500 digital artists, traditional painters, photographers, illustrators and graphic designers who had used platforms such as DALL-E, Stable Diffusion and Midjourney, among others.

Only 46 per cent of the respondents found such tools to be "very useful," while 32 per cent found them somewhat useful but couldn't integrate them to their workflow. The rest of the users - 22 per cent - didn't find them useful at all.

## **Development still a misnomer** in Tumuni village near Nagada

**BASIC FACILITIES ELUDE OVER 280 PEOPLE OF 29 FAMILIES RESIDING IN** TUMUNI VILLAGE CLOSE TO THE NAGADA CLUSTER OF VILLAGES

Jajpur, June 25: It has been seven years since the hilltop Nagada villages under Chingudipala panchayat in Sukinda block of Jajpur district hit the headlines for death of children owing to malnutrition.

The state government claims to have brought about rapid development in the field of healthcare, education, communication and power supply facilities in Nagada cluster of villages. However, not much has changed if we take a closer look at the lives of people living in nearby vil-

Reports said that a road is yet to be constructed to Tumuni and Guhiasal villages as people continue to travel on the hilly tracts to reach the villages

A disabled social activist Mantu Das took a tour of the villages by walking on the hilly tracts to get a taste of the life of the residents after reports were published in a premier Odia

Mantu walked through the hilly terrain and reached the Tumuni village where he met the family members of some Juang tribals. He returned and shot a memorandum containing nine point charter of demands to the principal secretary of Rural Development department demanding devel-

opment of Tumuni village. On receipt of the letter, deputy secretary Shibaram Hembram diRural Works department to pre-

pare a report on bringing in de-

velopment in Tumuni area.

Meanwhile, a road has been constructed to Nagada three years after the malnutrition deaths. However, the residents of Tumuni and Guhiasal villages continue to live a cursed life of obscurity and drudgery.

According to ground zero reports of Mantu Das, over 280 people of 29 families reside in Tumuni village. Drinking water facility is yet to be available for which villagers continue to depend on the polluted water of a hilly stream. They are left without a drop of water when the hilly stream dries up during

Risking their lives, they walk through a dense forest to fetch water from a nearby village. The villagers often lose their lives or get critically injured while travelling through the forest to fetch water from the nearby village.

Institutional delivery is a misnomer in this village due to lack of communication facilities. The death of two pregnant women Kandiri Pradhan and Jatri Pradhan during delivery due to lack of necessary healthcare facilities are cases in this point.

There exists a hospital at nearby Kaliapani which is about 21 km from the village. However. lack of awareness has deprived the villagers from availing the

The village has an Anganwadi

centre but the Anganwadi worker visits it once or twice a month. The Anganwadi centre, often remaining close, has deprived the women and children in the villages the benefits of government welfare schemes.

There is a ration centre at Naliadaba which is about three to four km from the village. However, the villagers do not visit the centre due to lack of communication facilities.

Most of them have received a job card under rural job scheme MGNREGS but they have failed to reap its benefit as a contractor Sanjay Mohanta has allegedly kept the cards with him and refusing to return those

Villagers Tankar Pradhan, Khetra Pradhan, Madhusudan Pradhan, Jamuni Pradhan, Odia Pradhan, Bitu Pradhan, Buduni Pradhan, Dina Pradhan, Dashumatia Pradhan, Subuni Pradhan and Machu Pradhan alleged they have demanded their cards back several times but in vain as the contractor threatens them whenever they raise the issue with him.

This is indicative of serious irregularities plaguing the implementation of Centre-sponsored rural job scheme in the

The area is also home to large numbers of dropouts as there is no primary school in the village and nearest school is situated at a faraway place. Das has demanded before the state government to ensure drinking water supply, a good road, holding of regular health camps, keeping the Anganwadi centre open every day, recovery of the job cards of the poor villagers from the contractor and door to door supply of rations.

When contacted, Gyana Ranjan Nayak, executive engineer of rural works division in Jajpur said that he is not aware about construction of any road to Tumuni and Guhiasal villages and can only speak on the issue after making a proper enquiry.

Rourkela, June 25: In good news for Rourkela residents, work on the much awaited Koel river barrage has finally begun, thus ending the uncertainty over the fate of this vital project.

'The work on the barrage has started and it started sometime back," said Sanatana Sahu, executive engineer, Rukuda irrigation project who has the additional charge of Koel river barrage. Already 5 mts foundation work on the upstream cutup point has started, informed the EE. "The work permit was given to two agencies September 21 and work will be completed on the project March 27, 2025. And they will do the work in EPC mode and this includes planning and designing." The total project cost is Rs 311 crore out of which Rs 4.5 crore is meant for maintenance for the next five

The Koel barrage became a sentimental issue ever since the foundation stone was laid by CM Naveen Patnaik July 9, 2013 on the bank of Koel near Koelnagar. This project will solve the water woes of a large area, including Koelnagar, some of the sector areas of Rourkela Steel Plant (RSP), NIT Rourkela, Jhirpani rural water supply project, Jagda, besides helping in irrigation and also for the new industrial park, which is coming up in Riun and Kacharu areas. It will be of immense help to over a lakh dependents solving their various demands.



However, the project got mired in controversy and a big question mark remained hung over its

certainty. Even it became a symbol of failure and the step-motherly attitude of the state government towards Rourkela thus causing much discomfort for the BJD here. At one point in time, the project was almost on the verge of cancellation. The plaque, which the CM had laid has even vanished from the pedestal. "I had never lost hope in it because I kept on fighting for the project even though it is not under my constituency. I kept on following it and had never lost hope in it because I have full faith in my leader," said Minister for Labour Sarada Nayak.

Finally, the project was shifted upstream nearly two kilometres to Hamirpur. The main reason for transferring it to another place was the lack of sufficient government land and also the water storage capacity. "Private land acquisition would have led to many issues so the final decision was taken to shift it to a place where there will be least issues regarding land," said the minister. The EE speaking about the technicality of the issue explained, "The water storage capacity at its originally planned place was very less and here it is much more. The height of the barrage is

7 meters. And the width is 7.5 meters. "There are twenty one barrage gates and eight sluice gates. And the water storage capacity if you look at the area wise then it will extend for more than four kilometres extending upstream. This will definitely help a very large area in irrigation even during peak summer," said the EE.

### Give and Take

outh Africa's President Cyril Ramaphosa hit bull's eye when he lashed out at the rich countries for their failure to deliver the promised \$100 billion in annual climate finance by 2020. He was speaking at French President Emmanuel Macron's just concluded summit for a new global financing pact in Paris. It is true that a number of commitments made by developed countries towards climate change caused by their reckless carbon emissions have not been fulfilled. Ramaphosa was at his emphatic best when he said it is one thing for developed countries to promise to "make this available and that available" and another to translate the promise into action.

Developing nations at the summit called for a "transformation" of the world's financial system. The two-day summit organised in Paris to expedite efforts to unlock trillions of dollars required to tackle climate change barely addressed the underlying problems preventing developing countries from investing in development alongside climate measures, especially with their crushing debt levels. Barbados Prime Minister Mia Mottley, who co-hosted the summit alongside Macron, made the right noise when she called on the participants to chalk out a concrete path to transformation and not merely talk on reforming the global

The summit made several announcements such as the International Monetary Fund's (IMF) declaration of reaching the target of making \$100 billion in special drawing rights (SDRs), a reserve currency, available to climate-vulnerable countries. The World Bank also said developing nations hit by climate disasters would be able to suspend debt

The International Energy Agency had made it clear in 2021 that developing new fossil fuel resources struck at the root of efforts to restrict global heating to below 1.5C, a dangerous threshold beyond which lie the most disastrous climate impacts. Yet, the oil and gas industry does not seem to care. Last year alone, it pledged half a trillion dollars for new capital expenditure on future drilling and extraction. It made a profit of \$4 trillion. No one denies the fact that without energy development, aspirations and basic present and future needs cannot be fulfilled. But, producing it from coal, oil and gas without developing sustainable energy sources is one of the major causes of the current climate emergency. The right strategy would be to consider climate. energy and development as interconnected. But, this has become increasingly more difficult to achieve in the post-COVID situation which hit poor nations hard with record levels of debt. The Russia-Ukraine war has compounded matters in the form of rise in interest rates and cost of living. Some developing countries are reportedly spending nearly five times of their health budgets on meeting debt obligations.

The tardiness of the IMF in ensuring rich countries meet the target of setting up \$100 billion climate fund for poor countries is in sharp contrast to the trillions of dollars mobilised in an instant to bail out finance houses during the financial meltdown of 2008. It is unacceptable that years are needed to raise funds to address the climate emer-

Efforts by leaders in North America and Europe of reshaping their energy systems by using key raw materials from poorer nations for producing clean energy should be based on give and take. Poorer countries possessing the minerals should be helped to overcome the three structural deficiencies that block their development, namely a lack of food and energy sovereignty and low value-added manufacturing. This can be done in return for sharing their minerals

Unless a mechanism to this effect is created, the rush for clean energy would lead to corrupt deals as are done by fossil fuel companies which buy off politicians and recklessly damage the environment.

The French initiative as exhibited in the summit is only one step in the long journey of reconfiguring decades-old institutions to finance efforts to keep the earth's temperature below disaster levels.

his rare word for the practice of wearing labrets just might be on the point of a renewed burst of usage because of the craze for body piercing. A labret, from the Latin for "lip", is an ornament worn through the upper or lower lip, originally used in reference to several South American, African and other peoples who wore such ornaments (often of stone, gold, or rock crystal). It seems to have been coined around 1884 by the American scientist Dr William Healey Dall, the first man to make a systematic exploration of the then new US territory of Alaska. A later appearance of the word name-checks him: But Eskimo women, in company with their husbands, had a more barbarous fashion than tattooing, called by Dall "labretifery." So far as is known, it was practised only by those living west of the Mackenzie River; indeed, the habit prevailed much more widely among the men (Women of all Nations, by Thomas Athol Joyce and Northcote Whitridge Thomas, 1942). Labretifery combines labret with Latin fer-, to carry, bring, or bear, plus the abstract noun suffix "-y".

#### ■ Lackadaisical

This word is delightfully evocative, bringing to mind some languid person lolling on a couch while all around goes to ruin, so accurately evoking its modern idea of somebody who lacks enthusiasm and determination or is carelessly lazy. It owes its origin. strangely enough, to an old saying of regret or dismay, lack-a-day!, a shortened form of alack-a-day! Alack dates back to medieval times, and probably comes from a dialect word lack that is variously interpreted as failure, fault, reproach, disgrace, or shame. So alack-aday! originally meant "Shame or reproach to the day!" (that it should have brought this upon me). But over time it became weakened until it became no more than a vapid and vacuous cry when some minor matter went awry. At some point in the eighteenth century, the form lackadaisy appeared, with lackadaisical coming along shortly afterwards for somebody who regularly used the cry. At first it meant that the person was feebly sentimental rather than lazy. The first person recorded as using it was Laurence Sterne. in his Sentimental Journey of 1768: I took hold of her fingers in one hand, and applied the two forefingers of my other to the artery. - Would to heaven! my dear Eugenius, thou hadst passed by, and beheld me sitting in my black coat, and in my lack-a-day-sical manner, counting the throbs of it, one by one, with as much true devotion as if I had been watching the critical ebb or flow of her fever. Later it moved towards the idea of somebody who was affectedly languishing, and thence to someone merely lazy.

## **ENSURING FOOD FOR ALL**

**RESPECT FOR HUMAN RIGHTS MUST FORM THE BASIS OF ANY EFFORT TO REDUCE ACUTE** HUNGER

Brazilian President Jair power in January 2019, one of his first acts in office was to abolish the National Food and **Nutrition Security Council** (CONSEA), a globally lauded body that had significantly reduced food insecurity. It was a huge step back for the country. which the United Nations Food and Agriculture Organisation (FAO) had removed from its

People immediately mobilised to protest Bolsonaro's decision. including by organising impressive public meals held on the streets of many cities – a national banquetaço. Gathered around tables laden with healthy food, communities' resistance simultaneously celebrated and reclaimed the right to adequate food and nutrition.

Immediately after Luiz Inácio Lula da Silva was sworn in as Brazil's President in January, he reinstated CONSEA, which one of us (Recine) heads and which will meet the people's conference later this year to hear proposals.

This spirit of resistance - if replicated elsewhere - could transform food systems worldwide and ease the global hunger crisis that the pandemic, climate shocks, and conflict have exacerbated. As UN Special Rapporteur on the Right to Food, another of us (Fakhri) attributed rising rates of hunger to "systemic violence and structural inequality in food systems," which are "a central feature of a global economy that is supported by relationships of dependence among individuals, countries, international financial institutions, and corporations.

An estimated 258 million people faced acute food insecurity in 2022, the highest number on record since the Global Report on Food Crises began reporting data in 2017. In his introduction to this year's GRFC report, UN Secretary-General

António Guterres said the current crisis required "fundamental, systemic change.'

An approach based on humanrights principles is essential to bringing about this change. In Brazil, the scandalous increase in food insecurity during Bolsonaro's presidency resulted from policies that neglected marginalised people and violated their rights. As a result, the newly reinstated CONSEA is advocating for policies that fight hunger and address its root causes such as structural racism and gender inequalities. We cannot continue supporting unsustainable food systems that concentrate power and wealth in the hands of a few.

The UN's Right to Food Guidelines, adopted by FAO in 2004, outline how to address the structural causes of discrimination and inequality in food systems. These guidelines pioneered the implementation of economic, social, and cultural human rights and have inspired countless national policies and legal reforms. They also sparked the development of a full body of human rights-based norms and policies adopted by the UN Committee on World Food Security (CFS), the UN General Assembly, and other UN agencies, including for women, peasants, indigenous peoples, fishers, and other constituencies.

In Brazil, national and international efforts have translated these principles into a suite of domestic policies and programmes aimed at overcoming gender and racial discrimination, ensuring decent incomes and social protection, and securing the land and water rights of women, peasants, indigenous peoples, pastoralists, and fishers. These efforts have also resulted in agroecology and food-sovereignty initiatives that actively involve civil-society groups and ordinary citizens, as well as school-meal programmes sourced from family farms.

But Brazil is far from being an outlier: other governments are enacting similar reforms. Local, regional, and national food-policy councils are being established globally, and parliamentary alliances are working to enact right-to-food legislation in many countries.

Scaling up these efforts will require significantly greater policy coordination among all levels of government. The UN Human Rights Council and the

CFS have stressed the need for a coordinated response to the ongoing food crisis. But, at the same time, civil society, indigenous peoples, and academics have warned against the corporate capture of food governance and called for a UNwide corporate accountability framework.

There is growing momentum for change ahead of the 75th anniversary of the Universal Declaration of Human Rights, which will be commemorated in December. And the right to adequate food and nutrition, in particular, could be at the top of the agenda. In late June, the German government will host the "Policies against Hunger" conference; this year's edition will focus on rights-based approaches to the transformation of food systems. With the UN High Commissioner for Human Rights having proposed a human-rights economy, and with Brazil preparing to assume the G20's rotating presidency in 2024, we may see ambitious proposals to advance the right to food internationally.

Food systems' profound inequality, structural discrimination, and systemic violence have persisted for too long, and ordinary citizens around the world are demanding change. A transformation on this scale requires close collaboration be tween the diverse mix of people who are engaging in creative forms of resistance, as well as progressive governments that are ready to listen to them and represent their interests. Respect for human rights must form the basis of any effort to reduce acute hunger. It is the only way to create a sustainable and equitable system that provides adequate food for all.

### Universal sanitation: Where do we stand? -

vestment in sanitation tends to decrease \$5.5 health costs by preventing diseases. Similarly, the Joint Monitoring Programme (JMP) of UNICEF and WHO reported that the same \$1 outlay in water and sanitation generates \$430 economic returns by increasing production efficiency. But when we evaluate the present settings of sanitation facilities, still 1.7 billion people worldwide do not avail basic sanitation facilities (WHO). Surprisingly, 494 million people globally defecate in the open. The situation is grave in developing countries like India. The recently published NFHS -5 report shows that about 19% of the total population (and 26% in rural areas) in the nation uses open space till now instead of latrines. It has also been documented that only 69% of the masses have access to improved sanitation facilities. Unavailability of sanitation facilities creates a vicious cycle of illness and poverty. The high incidence of infant mortality and significant wealth dispari-

Here the question arises that what are the factors that ob-

struct in accessing sanitation facilities? Firstly, a gap is observed between policy preparation and implementation process. Inadequate research on the aspects is the foremost reason which generates the policy gap Second are the inconvenient policy interventions which are sup ply-prone rather than demanddriven. The deficiency of demand occurs because of a lack of awareness, insufficient subsidies, poorly planned distribution of subsidies, and lack of trust in government programmes. On the flipside, the supply side challenges arise because the policies are primarily governmentled rather than people-centred.

Considering the importance of sanitation, ensuring sustainable management of water and sanitation has been included as one of the Sustainable Development Goals (SDGs), with a target to achieve universal sanitation covpath and to provide basic sanitation facilities, the government of India has also been adopting various policy measures from time to time -- Total Sanitation Campaign in 1999, Nirmal Gram Puraskar in 2003, and Nirmal Bharat Abhiyan in 2012. A very recent initiative of the present NDA government, Swachh Bharat Abhiyan (2015), targeted universal sanitation and the end of open defecation by 2019. But the recently published JMP data shows that universal coverage of sanitation in schools needs a three-fold increment at current rates globally and about 100-fold in LDCs (JMP, 2022). However, under the Swachh Bharat Mission, 100 million toilets have been constructed in rural India which is appreciable. But from the operation perspective, the ease of use has not met the expectations. The very common challenges

are improper construction of bathrooms with meagre funds, the elevation of twin-pit latrine which needs emptying of toilets, and the absence of water supply. The other reasons are the less-decision-making power of women (patriarchal behaviour);

ative to men. The prevalence of inferior belief, in which a few sections of the society believe that emptying the latrine tank is the work of a particular community, is also an issue in the installation and management of twin-pit latrines.

In view of the mentioned challenges, adequate research and investigation need to be commenced to comprehend people's awareness, attitude, and activities on the basis of region, class, category, income, and education. Technological interventions and social innovations (like advertisement through social media and nudging) are also essential to streamline the implementation process. Besides, understanding behaviour, constructing mental model are apposite for the success of programmes. Moreover, need-based intervention is indispensable to realise the objective of universal coverage as it generates a virtuous cycle in ensuring good health, well-being, and human resources development.

If DMK and its allies, who form the Secular Progressive Alliance (SPA), garner maximum seats in 2024 elections, it will be a major boost for the Opposition at the centre and the ruling front of Tamil Nadu as the front is far ahead of the NDA alliance of AIADMK-BJP in the state

Chennai, June 25: The Dravida Munnetra Kazhagam (DMK), which is aiming to win all 39 Lok Sabha seats in Tamil Nadu and one seat in Pondicherry in 2024, is trying to take up a major role in next years general elec-

Tamil Nadu, the opposition is likely to get a large number of seats from Kerala, where the opposition in all probability will win all the 20 seats. However in Karnataka, Telengana and Andhra Pradesh, the possibility of the opposition winning the maximum number of seats

In the 2019 general elections, BJP could win only four seats in Telengana out of the 17 seats and won 27 in Karnataka while losing the 2023 assembly elections. BJP stands a chance to win at least half of the seats. Situation in Andhra Pradesh is different with the ruling YSR Congress party winning 22 of the 25 seats.

YSR Congress party has also not participated in the opposition unity meet in Patna like the BRS party. Telengana Chief Minister K Chandrashekar Rao has a different agenda and has travelled across the country to represent himself as the Prime Ministerial

Other than Kerala and Tamil Nadu, the opposition may not get maximum seats from South India making Stalin a major player for the opposition unity. After the arrest of Tamil Nadu Minister Senthil Balaji by the Directorate of Enforcement (ED),

Pertinently, OPS is from the powerful Thevar community which has considerable sway in South Tamil Nadu and can decide the fate of several seats in the districts like Madurai, Tirunelveli, Kanniyakumari, Theni and

Sasikala's nephew and former MLA TT V Dhinakaran who was also expelled from the AIADMK, floated the Amma Makkal Munnetra Kazhagam (AMMK) party which has also considerable influence in South Tamil Nadu. Add to this, the alliance between AIADMK and the BJP is rickety with the BJP State President K. Annamalai time and again coming out against the AIADMK

The AIADMK and BJP even had a public spat with each other showing that all is not well with the AIADMK-BJP alliance in Tamil Nadu. Given the rift, there are less chances of this alliance winning seats in 2024 general elections in

## Savarkar controversy starts to heat up

Lucknow, June 25: The inclusion of a chapter on freedom fighter Vinayak Damodar Savarkar in the list of "great personalities" for UP Board students, has reignited an old controversy. While the Samajwadi Party has demanded that lessons on socialist thinker Dr Ram Manohar Lohia and SP patriarch Mulayam Singh Yadav should also be made a part of the state board curriculum, Congress stated that the move will have a negative impact on the students. BJP defended the

Deputy chief minister Brajesh Pathak said: "Savarkar made important contribution to the country's history but his contributions were deleted by previous governments." Samajwadi Party leader and spokesperson IP Singh said: "I would also say



that Ram Manohar Lohia and Mulayam Singh Yadav, too, should be included in the U.P. Board syllabus.

Samajwadi Party's national secretary Rajendra Chaudhary said: "We do not consider this stance and behaviour of the UP

government proper."

Targeting the government, UP Congress's minority wing chairman Shahnawaz Alam said: "His inclusion in the UP Board syllabus would cast a negative impact on students." Former Congress MLC Deepak

Singh said that he would write to Governor Anandiben Patel about BJP's attempts to tinker with history. "While the country's first Prime Minister Jawaharlal Nehru, who is widely hailed as the architect of modern India, is missing from the list, Savarkar is there. Though it is the government's prerogative to include whosoever they want to in the course curriculum, we will certainly draw the Governor's attention towards such brazen attempts to tinker with country's history," he said.

Earlier, in January 2021, Deepak Singh had also opposed another decision by the UP government to include Savarkar's portrait in the picture gallery at the state's Legislative Council. Congress MLA Aradhana Misra 'Mona' reacted sharply to the remarks of the state's secondary education minister Gulab Devi who had said that Nehru was not included in the list of great personalities as he had not made any sacrifice.'

"I think from instilling scientific temper, from IITs to IIMs, from space to infrastructure, Nehru's contribution shines through all. So how can anyone deny his contribution? Will you also forget that he was the country's first Prime Minister." she said, adding that the party would strongly oppose such moves.

Bahujan Samaj Party (BSP) chief Mayawati, however, has not commented on the Savarkar issue but has hit out at the Telangana government for "tampering with the Preamble".

#### TN fails to replace damaged shutters in reservoirs





Imphal, June 25: Security forces in Manipur's Imphal East district apprehended a dozen of militants of the Kanglei Yawol Kanna Lup (KYKL) outfit Saturday, but had to hand over all of them to local leaders after a mob, led by women, surrounded the forces and prevented them from going ahead, an official said.

According to a defence spokesman, after Saturday midnight the Army and the Assam Rifles, acting on specific intelligence inputs, launched an operation at Itham village in Imphal East district and the area was cordoned off before the actual search commenced to avoid inconvenience to the locals.

'The operation resulted in the apprehension of 12 KYKL cadres along with arms, ammunition and war-like stores. Self-styled Lt Col Moirangthem Tamba alias Uttam was also among the 12 militants. He was the mastermind of an ambush on the 6th battalion of the DOGRA in 2015," the spokesman said.

A mob of around 1500 people, led by women and local leaders, immediately surrounded the area and prevented the security forces from continuing the operation despite repeated appeals.

The spokesman said that keeping in view the sensitivity of use of kinetic force against large irate mob and envisaged casualties due to such action, the officer on ground made a considerate decision to hand over all 12 KYKL militants to local leaders.

#### Woman electrocuted to death at rly station

New Delhi, June 25: A 34-yearold woman died of electrocution after accidentally coming in contact with a live wire at the New Delhi Railway Station complex Sunday morning amid rainfall, police said.

The incident has prompted the concerned authorities to conduct a safety audit of all electric poles and electricity infrastructure to prevent any such incident in the future, they said.

The incident took place near exit gate number 1 of the station when Sakshi Ahuja, the victim, along with her family was on her way to board a train to Chandigarh, they said. She was with her father, mother, brother, sister, and two children at the time of the incident.

Ahuja was a teacher in Lovely Public School, Priyadarshani



Vihar, Laxmi Nagar, police said. As per a preliminary enquiry, it was raining and Ahuja was walking towards the station when she lost her balance and grabbed an electricity pole to break her fall when she came in contact with some exposed wires, a senior police officer said.

A police team led by Assistant Sub-Inspector Gaikwad reached the spot and rushed Ahuja to the Lady Hardinge Medical College Hospital, where doctors declared her brought dead, said Apoorva Gupta, Deputy Commissioner of Police (Railways). Her body has been shifted to a mortuary.

Ahuja's sister, Madhvi Chopra, has filed a complaint alleging negligence on the part of the authorities, she said.

### Monsoon covers Delhi, Mumbai together for first time in 62 years

New Delhi/Mumbai, June 25: The monsoon Sunday covered both Delhi and Mumbai together for the first time since June 21, 1961, the India Meteorological Department (IMD) said.

While it hit the national capital two days before schedule, its entry into the financial capital is two weeks late, the Met office said. "It is the first time since June 21, 1961, that the monsoon arrived in Delhi and Mumbai at the same time," said DS Pai, a senior scientist at the India Meteorological Department

The Safdarjung Observatory, Delhi's primary weather station. logged 48.3 mm rainfall in the 24 hours ending at 8.30 am Sunday. The Dhansa weather station logged around 80 mm, Jafarpur and Lodi Road around 60 mm each, Ayanagar and Mungeshpur around 50 mm each and SPS Mayur Vihar 40 mm, according to the IMD

The Met office termed the monsoon activity over Haryana, Chandigarh and Delhi as 'vigorous'. According to the IMD,

monsoon activity is considered 'vigorous' if the recorded rainfall is more than four times the normal or it is fairly widespread or widespread.

In Mumbai, the Colaba Observatory, representative of the island city, recorded 86 mm rainfall in the 24-hour period ending at 8.30 am on Sunday while the Santacruz weather station, representative of the suburbs, registered 176.1 mm in the same period, according to the IMD.

The northern limit of monsoon has now passed through Veraval, Baroda, Udaipur, Narnaul,

Ambala and Katra. Conditions are favourable for further advance of the monsoon into some more parts of Gujarat, Rajasthan, Haryana, Punjab and the remaining parts of Jammu and Kashmir during the next two days, the IMD said in a noon update.

Normally, the monsoon reaches Kerala by June 1, Mumbai by June 11, and the national capital by June 27. The trajectory that the monsoon followed this year is unusual.

#### **MQ-9B DRONE PURCHASE FROM US**

### **Centre trashes costly deal claims**

New Delhi, June 25: India is yet to finalise the cost and specific terms of purchase of 31 MQ-9B long endurance drones from the US and it will examine the "best price" offered by the manufac-

turer to other nations before concluding the procurement, the defence ministry said Sunday while trashing reports in a section of social

media on the price as well as the acquisition process.

It said the Acceptance of Necessity (AoN) accorded to the procurement by the Defence Acquisition Council (DAC) noted the estimated cost of USD 3,072 million (one million=10 lakh) as provided by the US government, adding the price will be negotiated once policy approval from Washington is received.

The DAC headed by Defence Minister Rajnath Singh on June 15 accorded the AoN or initial ap-

proval for acquisition of 31 MQ-9B High Altitude Long Endurance (HALE) drones from the US under the foreign military sale (FMS) route.

The AoN included the of unmanned aerial vehicles to be procured along with associ-

ated equipment. India and the US firmed up the drone deal during Prime Minister Narendra Modi's high-pro-

PM Modi's individual graph as the most popular leader of the world is rising and leaders across the globe appreciate India's growth story. But those handling BJP's election strategy for the 2024 Lok Sabha polls are a worried lot as BJP has not been winning elections in states; be it Himachal or Karnataka. In 2014, Modi won on anti-corruption plank and in 2019, Balakot air strikes played a decisive role following the Pulwama tragedy killing 40 CRPF jawans. In both these polls, the Opposition was fragmented barring a few states like UP. But 2024 is different. It is almost certain that major players in the Opposition have taken a decision in principle to contest Lok Sabha polls unitedly as far as possible. The Congress collapsed in the 90s with the rise of Mayawai and later

not only in states but in Lok Sabha polls as well dumping the Congress. Later, upper castes including Brahmins voted for the BJP. Sources in the Modi dispensation say that during the past nine years, the PM had never imposed President's rule in any state. It is reminded that there was extreme pressure to dismiss the Mamata Banerjee government in the wake of massive violence in West Bengal. It was stated that in Manipur, President's rule was imposed 10 times between 1967-2002 by various governments at the Centre. However, his government would help the state to restore normalcy as the President's rule is no solution. The President's rule was invoked in a couple of states under Modi as the ruling Congress MLAs quit or withdrew support by the alliance partners. Arunachal Pradesh, Pondicherry, Uttarakhand and Jammu & Kashmir faced this situation. Even Delhi witnessed a brief stint of President's rule as Arvind Kejriwal himself quit in 2014 and no other party was in a position to form the government.

Islamabad, June 25: Pakistan's army claimed Saturday that two civilians were killed by Indian forces in the disputed Himalayan region of Kashmir, the first such conflict since a ceasefire in 2021 between the two nuclear-armed South Asian neighbours.

In an interaction with an international media group, the Taiwanese foreign minister said the countries having stakes in the South China Sea must join hands in combating the challenge emanating from China's rising military muscle-flexing in the region and that Taiwan is ready to share its experience in dealing with the Chinese threat.

There have been growing global concerns over China's sweeping claims of sovereignty over all of the South China Sea, a huge source of hydrocarbons. Several countries in the region including Vietnam, the Philippines and Brunei, have counterclaims.

The Taiwanese foreign minister said time has come for democratic countries to join hands to face the common challenges from China including through sharing of resources with each other.

"China is trying to secure ports along the Indian Ocean -in Myanmar, Pakistan, Sri Lanka

China considers Taiwan as part of its territory. The selfgoverned democratic island has positioned itself as a democratic power that is ready to contribute its part in the world's fight against China's expansionism.

China's ruling Communist Party says Taiwan is a province of the country and has repeatedly warned that the island must unite with China, by force if necessary. Beijing has threatened to attack if Taiwan declares formal independence or delays talks on unification

Wu said China was responsible for the crisis in Sri Lanka as well as that Beijing does not care about the financial situations in these nations. It is repeating the same model in Myanmar and some other countries.

'We should pay close attention to these developments. This is also something I am sure the Indian government is paying very close attention to and in that regard, I would like to say that the federal democracies facing common challenges from the PRC (People's Republic of China), need to work with each other,' he said.

The Taiwanese foreign minister said the growing Chinese military activities in the South China Sea should be a matter of concern to all countries in the region.

"If you look at China's naval activities in the South China Sea, it is something for all of us to feel worried about. From the data that I can see, from the briefings that I received, I can say that there are more than a dozen Chinese military vessels that are patrolling the South China Sea region. And it is not only the military vessels. China also has a large number of maritime militia with fishing boats. There are hundreds of them and they listen to orders of the PLA (People's Liberation Army)," he said.

He said there is a possibility of Indonesia, Vietnam and Malaysia facing the same problem and that "this requires all of us to find ways to deal with the challenges posed by the Chinese in the maritime domain.

### Modi, El-Sisi raise ties to 'Strategic Partnership'

Cairo, June 25: India and Egypt Sunday elevated their relationship to a 'Strategic Partnership' as Prime Minister Narendra Modi and President Abdel Fattah El-Sisi held wide-ranging talks with a particular focus on enhancing political and security cooperation.

Modi, who is visiting Egypt at the invitation of President Sisi. held one-on-one conversation with El-Sisi during which they also took stock of what is happening on important issues of the region and the world.

Addressing a media briefing on the visit by Modi, the first bilateral visit by an Indian Prime Minister to Egypt in 26 years,



Foreign Secretary Vinay Kwatra said four MoUs and agreements were signed, including the "most important and landmark" one on the "Strategic Partnership" between India and Egypt

"The two leaders had a private one-on-one conversation during which, following up on the India visit of President Sisi earlier this year, the two leaders discussed a whole range of bilateral cooperation and also took stock of what is happening on important issues of the region and the world," Kwatra said.

"It was clear from those discussions and the MoU and agreements signed later on that the two leaders gave a particular focus on enhancing the political and security cooperation, defence collaboration, trade and investment ties, scientific and academic collaboration and strengthening of people to people ties,' he said.

Besides the agreement on strategic partnership, the two countries also signed three more pacts on -- agriculture and allied sectors; protection and preservation of monuments and archaeological sites; and competition law, the Foreign Secretary said.



#### **India to resolve** sugar dispute

New Delhi: India is in negotiations with Brazil to resolve a sugar dispute at the World Trade Organisation (WTO) and the commerce ministry is coordinating with concerned departments for the same, government sources said. India is also following a similar process for other complainants of the sugar dispute at the Genevabased WTO, they said. In 2019, Brazil, Australia and Guatemala dragged India into the WTO's dispute settlement mechanism alleging that New Delhi's sugar subsidies to farmers are inconsistent with global trade rules. Brazil is the largest producer and exporter of sugar in the world. India is the world's second-largest sugar producer after Brazil.

#### Adani eyes ₹90K-cr EBITDA in 2-3 yrs

New Delhi: Embattled Adani group is eyeing a 20 per cent year-on-year growth in pre-tax profits to reach ₹90,000 crore EBITDA in 2-3 years on the back of robust growth in businesses ranging from airports to energy, according to a company note. Earlier this month, the group repaid loans aggregating \$2.65 billion to complete a prepayment programme to cut overall leverage in an attempt to win back investor trust post a damning report of a US short seller. The ports-to-energy conglomerate is now looking at robust growth in sectors such as airports, cement, renewables, solar panels, transportation and logistics, and power and transmission, it said adding several of Adani's new infrastructure investments will also begin to fructify and generate cash in the coming years.

## World economy at critical juncture: BIS

Despite the relentless rise in rates over the last 18 months, inflation in many top economies remains stubbornly high, while the *jump in borrowing costs* triggered the most serious banking collapses since the financial crisis 15 years ago

London, June 25: The world's central bank umbrella body, the Bank for International Settlements (BIS), called Sunday for more interest rate hikes, warning the world economy was now at a crucial point as countries struggle to rein in inflation.

The global economy is at a critical juncture. Stern challenges must be addressed," Agustin Carstens, BIS general manager, said in the organisation's annual report published Sunday.

The time to obsessively pursue short term growth is past. Monetary policy must now restore price stability. Fiscal policy must consolidate.'

Claudio Borio, the head of BIS's monetary and economics unit, added there was a risk an "inflationary psychology" was now setting in, although the bigger-than-expected rate hikes in Britain and Norway last week showed central banks were pushing "to get the job done" in terms of tackling the problem.

Their challenges are unique by post-World War Two standards though. It is the first time that, across much of the world, a surge in inflation has co-existed with widespread financial vulnerabilities

#### **Creditors greenlight** ₹425cr revival plan

New Delhi, June 25: Creditors of cash-strapped airlines Go First have approved interim finance of ₹425 crore aimed at reviving the airline. While an inprinciple approval for the interim finance has been granted, the plan is subject to the boards of the respective banks approving the same.

Central Bank of India, Bank of Baroda, and IDBI Bank are the consortium lenders to the airline. They will seek board approvals to sanction the interim finance. Post which DGCA approvals will be sought to start the airline's operations.

The low-cost carrier's resolution professional Shailendra Ajmera had sought ₹425 crore in interim finance from the airlines financiers to get a revival plan going that could help restart operations, multiple reports said

The requirement for financing could expand based on certain contingencies such as the availability of working engines for the aircraft and ticket cancellations, the reports said.



Go First reportedly plans to resume operations in July and operate 78 daily flights with 22 aircraft. Aircraft of the cash-strapped carrier have been grounded since May 3.

The Go First bankruptcy filing lists Central Bank of India , Bank of Baroda, IDBI Bank and Deutsche Bank among its creditors, which are owed ₹6,521 crore in total.

Early this May, Go First filed for bankruptcy at the National Company Law Tribunal (NCLT) and suspended its flight operations due to rising losses, primarily due to delays in the delivery of Pratt and Whitney's engines leading to the grounding of a portion of its fleet.

### Will strive to get CPI down to 4%, says Das

RBI chief exuded confidence that the economy will grow at 6.5% in FY24

Mumbai, June 25: Governor Shaktikanta Das has said the Reserve Bank will strive to get headline inflation to its 4 per cent target but flagged El Nino as a challenge to its efforts.

In an exclusive interview with PTI Bhasha at his office here, Das exuded confidence that the economy will grow at 6.5 per cent in FY24, as estimated by the RBI earlier.

'We continue to be watchful on the inflation front. We expect inflation to be at 5.1 per cent in FY24, and we will continue to strive and get it down to 4 per cent," he added.

On the high borrowing costs, Das said interest rates on loans may have a direct relation with inflation, and if inflation cools down on a durable basis, people can expect lower interest rates on loans.

The governor explained that the Russia-Ukraine war, which led to a shoot-up in the commodity prices, led to a surge in inflation. but added that crude prices are not a concern from an inflation perspective now as they've come down to \$76-76 a barrel. Food inflation has also come

down, Das said, adding that measures like the Food Corporation of India releasing wheat and rice stocks have also helped. Targeted cuts in duties on certain products have also helped, he added. When asked about the chal-

lenges on the inflation front, Das pointed to 2-3 factors like the volatile international situation due to geopolitics and the monsoon situation domestically.

New Delhi, June 25: Bajrang Punia's claim that 'I asked him to concede wrestling bouts on purpose' is nothing but a 'blatant lie', London Olympics bronze medallist Yogeshwar Dutt said Sunday as the mud-slinging match between the top wrestlers of the country continued.

Bajrang, in a live social media address, had claimed Saturday that the London Olympics bronze medallist several times asked him to lose matches on purpose in the past. "I never told him to lose any match. It's a blatant lie," Yogeshwar said when asked about Bajrang's claim. "During the (2016) Olympic

qualification, he (Bajrang) was part of the 65kg trials but we were not pitted against each other. Amit Dhankar had defeated him. In the final bout, I fought against Amit. In the Pro Wrestling League, we fought against each other. There I won 3-0. If I wanted, I could have scored more and everybody knows that it was a show fight," added the Olympic medallist.

Dutt, who is now a BJP leader, said he always took Bajrang on foreign training trips as his sparring partner. "Before 2016 Olympics whenever I went abroad I took Bajrang along with me. Yogeshwar feels that Bajrang is just trying to settle scores against him by levelling such false allegations after they decided to split in 2018. After that he got angry with me and we stopped talking to each other," Yogeshwar claimed.

# 'Disappointing not to win Champions League with PSG'

LIONEL MESSI, WHO HAS SIGNED UP FOR THE MLS, RECALLS **HIS TENURE WITH PSG** 

Buenos Aires, June 25: Lionel Messi has called his start at former club Paris Saint-Germain (PSG) 'very tough and disappointing'. He has also dubbed two successive failed Champions League bids a 'massive disappointment'.

"I came to Paris because I liked the club, because I had friends in the dressing room... it seemed easier for me to adapt rather than another destination I could have gone to," Messi told 'beIN Sports' in an interview which was aired Sunday.

"In reality, it was a very tough adaptation, much harder than I expected... with a new game plan, new teammates, a new city. I arrived late, I didn't have a preseason. The start was difficult for me, my family," added the Argentine legend.

Messi, 36, signed for PSG in the summer of 2021 after 17 seasons at Barcelona, but will now head to Inter Miami in the MLS after quitting the French capital.

Messi's first season, during which he scored 11 goals in 34 games for PSG, was made harder after he contracted Covid during the winter break back in



Argentina, meaning he was sidelined for a month.

"It took me time to get back my original and physical form, Messi admitted. He added that the 2022 World Cup in Qatar – which Messi won with Argentina-also took its toll on his body.

"It's not an excuse but the World Cup played a big role in my form and the team. Some came back later than others, some were injured, like Neymar. I think, generally, the level of Ligue 1 and the Champions League was affected by the World Cup," added Messi.

Messi confessed that Champions League losses to Real Madrid in 2022 and Bayern Munich this season were a 'massive disappointment'. There were even sections of PSG fans who turned on Messi whistling at him from the stands.

#### Neymar fined again

Rio de Janeiro: Environmental authorities in Brazil have fined Neymar a second time Saturday after their orders to halt an unlicensed construction project at his mansion just outside this city were ignored, officials said. The Brazil and Paris Saint-Germain (PSG) star was already facing a fine of at least five million reais (USD 1 million) after authorities said they had found 'various environmental infractions' Thursday at his luxury property in the resort town of Mangaratiba, where workers were building an artificial lake and beach. The environmental authorities however, did not disclose the amount of fine Neymar would have to pay while the footballer's manager said it was an

'unspecified amount'.

#### **Mohun Bagan recruit** Albanian striker Sadiku

Kolkata: Indian Super League (ISL) champions Mohun Bagan's attacking line got a huge boost with the arrival of premier Albanian centre forward Armando Sadiku. The 32-year-old, who grabbed the headlines by scoring the solitary goal in Albania's historic win over Romania in Euro 2016, has penned a two-year contract, the Mariners announced Sunday. With the addition of Sadiku, Mohun Bagan will now have a lethal attacking line-up with Hugo Boumous and Dimitri Petratos already in their ranks. The club is also likely to rope in A-League's (Australia's top-tier) Central Coast forward Jason Cummings. Sadiku last played for La Liga 2 side FC Cartagena and has a current market value of Rs 5.6 crore, according to the website 'transfermarket'.

#### Sarfaraz non-selection for 'multiple reasons'

New Delhi: Sarfaraz Khan's nonwest indies tour was criticised by none other than Sunil Gavaskar but BCCI sources claimed that his below-par 'fitness level' as well as alleged 'off-field conduct' has influenced the decision.
