Sensex ends above historic 65K mark

Mumbai: Benchmark equity indices continued their rally Monday, with the BSE Sensex ending above the 65.000 mark for the first time ever. propelled by a rally in global equities and persistent foreign fund inflows. Hectic buying in index majors Reliance Industries, ITC and HDFC twins also added to the market momentum, traders said. Rallving for the fourth straight session, the 30-share BSE Sensex jumped 486.49 points or 0.75 per cent to settle at its all-time closing high of 65,205.05. During the day, it rallied 581.79 points or 0.89 per cent to its lifetime intra-day high of 65.300.35.

Odisha Police to guard Similipal

Bhubaneswar, July 3: The state government has deployed police personnel to provide protection to Similipal Tiger Reserve (STR) in Mayurbhanj district, as the protection assistants and non-gazetted forest officials are on a cease-work strike. In another house of the village. the police found 110 pangolin scales, the SP said. The owner of the house, who is allegedly a poacher, managed to escape. Stating that the operation was launched in the wake of poachers killing two forest officials in Similipal National Park, the SP warned the villagers to surrender all illegal weapons in their possession by July 31. Otherwise, strong action will be taken against them, he said

As their condition was weak financially, it was very difficult for Balaram to meet the daily expenses of his family. In search of a job, Balaram went to Chennai leaving his familv back in village.

However, it was of no help as his financial condition did not improve even after he joined work in Chennai which in turn gave way to disputes in the family. An ugly spat broke out between the couple over telephone, Sunday night. Subsequently, Rashmita jumped into a well along with the three kids to commit suicide.

RIVAL NCP GROUPS GO ON SACKING SPREE IN MAHA

Mumbai, July 3: A full-blown intra-party tussle broke out in the NCP as rival factions went on a sacking spree Monday to tighten their grip over the organisation and sought disqualification of lawmakers in each other's camps, a day after sudden induction of Ajit Pawar as deputy CM caused a political upheaval in Maharashtra.

Soon after NCP president Sharad Pawar removed party working president Praful Patel and general secretary Sunil Tatkare for engaging in "antiparty" activities, the faction owing allegiance to Ajit Pawar hit back by sacking state unit president Jayant Patil and

making new appointments. Patel appointed Ajit Pawar as the leader of the NCP legislature party.

The tit for tat actions came a day after Ajit Pawar joined the Eknath Shinde-BJP government as deputy chief minister along with eight other NCP MLAs who were inducted as ministers. Sharad Pawar, in a tweet, said, "I, as the National President, of Nationalist Congress Party hereby order the removal of the names of Shri Sunil Tatkare and Shri Praful Patel from the Register of Members of NCP Party for anti-party activities.' He tagged Patel, a Rajya Sabha MP who was appointed as NCP

CBI files chargesheet against Yadav family

New Delhi, July 3: The CBI has filed a chargesheet against Bihar Deputy Chief Minister Tejashwi Yadav, his father and former railways minister Lalu Prasad and mother and former chief minister Rabri Devi in connection with the landfor-jobs scam case, officials said Monday.

The chargesheet, which also names 14 others, is the second charge sheet in the case. It has been filed on the basis of documents and evidence that surfaced after the first charge sheet was submitted in the case, they said.

Besides members of the Yadav clan, the CBI has also named AK Infosystems and several middlemen in the case, they said. The chargesheet was filed in a special CBI court.

The officials said the second chargesheet was filed as the alleged roles of the accused could not be completed by the time the initial report was filed.

The CBI has alleged that favourite candidates were appointed in the railways in violation of norms and procedures, without any advertisement or public notice. During Lalu Prasad's tenure as minister in the UPA government from 2004 to 2009.

The agency claims that substitutes from Patna were appointed in various zonal railways located in Mumbai, ২ Jabalpur, Kolkata, Jaipur and Hazipur.

As a quid pro quo, the candidates, either directly or through their immediate family members, allegedly sold land to Lalu-Prasad's family members at highly-discounted rates.

Origin of Indian Ocean's giant gravity hole revealed

THE 'GRAVITY HOLE', A COLOSSAL AND ENIGMATIC PHENOMENON IN INDIAN OCEAN, HAS INTRIGUED SCIENTISTS FOR LONG

New Delhi, July 3: A team of Indian scientists has identified what caused the giant "gravity hole" covering more than three million square kilometres in the Indian Ocean.

Known as the Indian Ocean geoid low (IOGL), it is Earth's most prominent gravitational anomaly, where the gravity is lower than average, thus making the sea level there 106-metre lower than the global average.

The study published in Geophysical Research Letters, showed that the IOGL is a consequence of mass deficit inside the Earth's mantle beneath the Indian Ocean.

Previous studies on the gravity anomaly focused solely on its present-day state, without delving deeper into its origins. However, this new research utilised over a dozen computer models to provide insights into the ancient forces that shaped the IOGL.

Scientists from the Indian Institute of Science (IISc) in Bangalore reconstructed the last 140 million years of plate tectonic movements and ran computer simulations to trace the origin of the "gravity hole"

They found that some sections of tectonic plates have sunk through the mantle under Africa, generating plumes from under the Indian Ocean.



"Here we assimilate plate reconstruction in global mantle convection models starting from 140 Ma and show that sinking IOGL is Earth's most prominent gravitational anomaly, where the gravity is lower than average, thus making the sea level there 106-metre lower than the global average

Scientists from IISc, Bangalore reconstructed the last 140 million years of plate tectonic movements and ran computer simulations to trace the origin of the 'gravity hole'

slabs from the long-lost Tethys sea, which once separated the supercontinents of Gondwanaland and Laurasia,

perturbed the African Large Low Shear Velocity province and generated plumes beneath the Indian Ocean, which led to the formation of this negative geoid anomaly," the scientists wrote in the study

They explained that the interplay of these processes beneath the Indian Ocean might have determined the position and shape of the IOGL.

'These plumes, along with the mantle structure in the vicinity of the geoid low, are responsible for the formation of this negative geoid anomaly," lead author Debanjan Pal and Attreyee Ghosh from the IISc wrote in the study. According to the scientists, the IOGL likely took its present shape about 20 million years ago, when the plumes started to spread within the upper mantle. And it will probably last as long as mantle material flows. "When the temperature anom-

alies causing this low geoid shift out of the present-day location, the geoid low will start to dissipate," Pal was quoted as saying to the Scientific American.

As further research explores the secrets hidden within the depths, scientists hope to unravel more mysteries surrounding this awe-inspiring phenomenon. The 'gravity hole' serves as a reminder that the Earth still holds many enigmas, waiting to be explored and understood.

State gets 50 more paperless courts

Cuttack, July 3: Orissa High Court Chief Justice S Muralidhar, in presence of HC Artificial Intelligence and Information Technology (AI&IT) Committee chairman Ś Talapatra, inaugurated 50 paperless courts covering 23 districts of the state on digital mode, Monday.

The Chief Justice of India had inaugurated 34 paperless courts covering 30 districts of Odisha September 17, 2022.

During the National Conference on Digitization, Paperless Courts and e-Initiatives organised by the HC in Cuttack May 5 and 6 this year, Justice Muralidhar had pledged to open 100 paperless courts in Odisha within three months.

With this, the number of paperless courts in the state stands

Speaking on the occasion, the HC CJ said inauguration of 50 paperless courts is yet another milestone crossed by the Odisha judiciary. The HC has plans to unveil 50 more such courts within a month. he said.

Justice Muralidhar said master trainers and the technical team, headed by the Central cers on paperless courts. He complimented the judiciary for taking the lead in adopting tech-



nology for functioning of courts. He said the Covid-19 pandemic has accelerated the use of technology in judiciary, and technology would change the way judicial officers approach their work.

It leaves a positive impact on the mindset of the judge." Citing the issue of digital di-

vide among lawyers, the HC Chief Justice said free bookmarked softcopies of the paper books supplied by lawyers would be provided to them which would be a great incentive for younger lawyers to get on to e-mode. He emphasised on the impact

of paperless court on the reconfiguration of space and the whole architecture of the courts. Thanking Odisha Computer Application Centre (OCAC) for the technical support, Justice

Muralidhar said all the measures of digitisation, e-filing and paperless courts are to make access to justice more affordable, more efficient and more effective.

GUIDELINES ON PREVENTION OF VECTOR (MOSQUITO) BORNE DISEASES

Writing to the CM, Pradhan said the dam which was built on the Brahmani river in 1980s is the second largest dam project in Odisha. Due to the project, the state's irrigation and hydro power generation potential has increased substantially.

As per the instructions of the Chief Minister, in September 2010 the compensation amount required to pay the displaced families was estimated at Rs 152 crore. But regrettably, this money has not reached the victims till date, Pradhan said in his letter.

He has sought the intervention of the Chief Minister to provide land pattas to these families and accord revenue village status to the villages where they are staying now.

Vigilance unearths three more plots, ₹1.2 crore of OAS officer

Bhubaneswar, July 3: Vigilance sleuths Monday claimed to have found more assets belonging to former Nabarangpur additional subcollector Prasanta Kumar Rout, who has been arrested on charges of possessing disproportionate assets (DA) worth over Rs 5 crore June 24 this year.

Vigilance sources said during interrogation of the tainted Odisha Administrative Service (OAS) officer, three more plots in the name of his spouse have been unearthed.

"Rout had confessed to have deposited Rs 1.2 crore in six benami accounts opened in the name of multiple individuals. Moreover, the OAS officer, who was given compulsory retirement by the state



government June 27, had also been maintaining a locker with UCO Bank's Bhadrak branch," said a senior Vigilance official.

The anti-corruption wing sleuths claimed to have recovered cash amounting to Rs 3,02,30,800 from Rout's residence in Bhubaneswar and Rs 77 lakh from his Nabarangpur residence during raids June 23

The OAS officer was also found to have owned five plots, including four in Cuttack and Bhubaneswar, a 'benami' plot at Umerkote in Nabarangpur district, bank and insurance deposits amounting to over Rs 92.34 lakh, vehicles, jewellery and household articles worth over Rs 27.27 lakh.

A day later, Rout was arrested for possession of DA worth Rs 5,21,09,659 which is 506 per cent of his known sources of income.

Rout has been booked under various Sections of the Prevention of Corruption (Amendment) Act, 2018.

Soon after, the state government ordered compulsory retirement of Rout 'in line with its zero-tolerance policy towards corruption'.

Due to onset of monsoon rain across the state there is possibility of increase in mosquito breading and spread of diseases like Malaria, Dengue, Japanese Encephalitis, etc. The following preventive measures may be taken to get rid of the above diseases.

- Drain out stagnant water from the vicinity atleast once a week.
- Clean the flower vase, cooler, water tank and defrost-collectionchamber of the freeze etc., weekly.
- Damage or displace the rejected container, bottle, old tyre, coconut cell, earthen pot & bamboo stumps.
- Keep your house premises clean.
- Use mosquito net regularly. It is better to use fine nets at window-sil to prevent mosquito entry.
- Wear full-sleeve dresses.
- Mosquito repellants may be used in need.
- In case of fever, shivering, pain in joint / muscle / eye, immediately test blood and get treated at the nearest health facility.

Bhubaneswar, July 3: Like every year, with the arrival of monsoon, the state has witnessed a rise in dengue cases. As many as 185 cases have been registered in 16 districts, with Khurda, which hosts the Capital city, reporting 96 cases, informed Public Health director Niranjan Mishra here Monday

Though the majority of the cases (more than 50 per cent) are from Khurda, 12 cases are from Jajpur, 10 from Balasore and the remaining are from the other districts. A total of 11,464 persons have been tested for the disease, out of them 185 have tested positive. During the corresponding period last year, 5,981 people were tested, out of whom 353 had came positive.

"Despite double the number of persons tested, the test positivity rate is very low," said Mishra,

Childhood pleasure reading boosts mental wellbeing later: Study

CHILDREN WHO BEGIN READING FOR PLEASURE EARLY IN LIFE TEND TO PERFORM BETTER AT COGNITIVE TESTS AND HAVE BETTER MENTAL HEALTH WHEN THEY ENTER ADOLESCENCE

hildren who start reading for pleasure early in life tend to perform better at cognitive tests and have better mental health when they enter adolescence, according to a study of more than 10,000 young adolescents. In the study, published in the

journal Psychological Medicine, researchers included 10,243 par-

ticipants, and found reading about 12 hours a week was linked to improved brain structure.

It led to a positive performance in adolescence on cognitive tests that measured such factors as verbal learning, memory and speech development, and at school academic achievement. These children also had better mental wellbeing, as assessed using a number of clinical scores and reports from parents and teachers, showing fewer signs of stress and depression, as well as improved attention and fewer behavioural problems such as aggression and rule-breaking.

Children, who began reading for pleasure earlier, also tended to spend less screen time -- for example watching TV or using their smartphone or tablet -- during the week and at weekends in their adolescence, and also tended to sleep longer.



Brain scans taken in adolescence, showed that children read at an early age had moderately larger total brain areas and volumes, including in particular brain regions that play critical roles in cognitive functions.

and creativity, increases empathy and reduces stress. But on top of this, we found significant evidence that it's linked to important developmental factors in children, improving their cognition, mental health, and brain structure, which are cornerstones for future learning and well-being," said Professor Barbara Sahakian from the Department of Psychiatry at the University of Cambridge. Reading for pleasure can be an

important and enjoyable childhood activity. Unlike listening and spoken language, which develop rapidly and easily in young children, reading is a taught skill and is acquired and developed through explicit learning over time. During childhood and adolescence, our brains develop. making this an important time in which to establish behaviours that support our cognitive development and promote good brain health.

"We encourage parents to do their best to awaken the joy of reading in their children at an early age. Done right, this will not only give them pleasure and enjoyment, but will also help their development and encourage longterm reading habits, which may also prove beneficial into adult life," added Professor Jianfeng Feng from Fudan University in Shanghai. IANS

DISCHARGE OF POLLUTANTS IN THE RIVERS AFFECTING THE GROWTH OF PLANTS AND FOLIAGE

Kendrapara, July 3: Lack of adequate rainfall despite the arrival of southwest monsoon in the state has resulted in acute water scarcity in this district, sources said Monday.

Even the Brahmani, Baitarani and Mahanadi river systems flowing through the Bhitarkanika National Park in this district have dried up considerably. To compound problems, the release of polluted materials into the will harm the rivers Bhitarkanika wetlands that are known for their rich bio-diver-

sity, sources pointed out. Environmentalist Khitish Kumar Singh said that even the Orissa High Court has expressed concern over ingress of polluted water in Bhitarkanika. Amicus Curiae in the case, Mohit Agarwal, has also expressed serious con-

cerns on the development. Khitish pointed out that Brahmani river water is the major



lifeline for the Bhitarkanika wetlands. He pointed out that various industrial units, including a well-known aluminum plant regularly discharge pollutants in the Brahmani river. Among the three river systems, the Brahmani is the most polluted, said Khitish.

Harmful and toxic chemicals like fluoride, nitrogen, cyanide, chromium, fly-ash and other chemicals along with coal and various effluents are released into the Brahmani. Further polluting of the river water takes place due to mushrooming of illegal prawn gheries, rampant movement of fishing boats and denudation of forest cover by illegal Bangladeshi immigrants, Khitish said.

"The Bhitarkanika wetlands have survived because till now the supply of fresh water has not been severely hampered. The wetlands get their share of fresh water from seven rivers including the Brahmani, Baitarani and Mahanadi. However. polluted material in the Brahmani can hinder the flow of fresh water. If it happens, then it will be the doomsday for Bhitarkanika," Khitish said.

Environmentalist Hemant Kumar Rout said that lack of fresh water will result in destruction of mangrove forests in Bhitarkanika. The forests act as a shield in protecting human habitats from natural calamities like cyclones.

Rout pointed out that the prin-

cipal rivers like Mahanadi, Brahmani and Baitarani as well its distributary Kharasrota are slowly losing their fresh water due to pollution. The construction of Kalma and other barrages by the Chhattisgarh government has affected the flow of fresh water into the Mahanadi. Without proper supply of fresh water, the growth of plants and foliage in Bhitarkanika will be seriously hampered, Rout added.

Educationist Bhuban Mohan Jena pointed out that the construction of a mega reservoir on Mahanadi for supply of drinking water at Santara under Kujang block in neighbouring Jagatsinghpur district will also affect the flow of fresh water into Bhitarkanika wetlands that are on the downstream of the river. The reservoir will also supply drinking water to around 200 villages in Mahakalpara and Marshaghai blocks in Kendrapara district.

Moreover, construction of a reservoir on Baitarani near Jajpur town and development of two mega drinking water projects and two irrigation facilities on its distributary Kharasrota in Kendrapara district will also hinder the flow of fresh water into Bhitarkanika wetlands, opined Jena.

STP lies under-utilised due to public apathy

Rourkela, July 3: The newly-done sewage treatment plant (STP) at Balughat on the bank of Brahmani river here is unable to function at its full capacity. Sources however said that it is not due to any technical fault.

Built at a cost of ₹240 crore the entire system is meant to service a large locality including Udit Nagar, Civil Township, Chhend Colony, Basanti Colony, Panposh and Orampara. "The project has the capacity to cover 12,000 households." said superintendent engineer (SE) of the Sewage Board here, Basant K Dakia.

"The STP has a capacity of 40 million litres per day, but currently we are receiving just eight million litres. This is because only 1,450 households have connected to the plant," Dakia added.

Explaining the low connectivity Dakia said the end users, 'are not showing enough interest'. Others attributed the low connectivity, due to



the desire to get everything for 'free'. One of the users of the system however, pointed out that most of the residents are not aware that the connectivity is free of cost. "When you apply for power or water connection you pay a charge but here there is no issue. Despite this, the residents are showing very flimsy grounds for not availing the STP system," the user added.

However, there is also a catch involved. Connectivity to the STP is free of cost. However, each and every household will have to bear the expenses of getting connected to the STP or the nearest manhole.

However, it is a one-time expense, which people should utilise, pointed out Dakia.

'We are providing residents with technical assistance while they are getting the connection done. In some cases even our person visits the spot to help out," Dakia added.

The official also informed that his department is keen to get every household connected. "We are conducting meetings, door-to-door campaigns to develop awareness among the people about the utility of the STP. I am hopeful that very soon many more people will get connected to the system," Dakia said.

andhian thought, institutions and the Mahatma himself are under unprecedented attack today. From positions of power in government to poisoned minds among activists and a wide variety of loose cannons, Gandhi and his ideas are routinely run down and presented using narrow lenses designed to mispresent and even demonise the Father of the Nation. It is no surprise that Gandhians are aghast. But there is also a sense of despondency, fatigue and resignation at the ferocity of the attacks and the sheer volume of venom that is spewing out across media channels. What should Gandhians do? How should they respond?

Ironically, these were precisely the questions at the centre of a discussion for a conference that was planned and scheduled by Mahatma Gandhi himself to be held at Wardha on February 2, 1948. The context was different though - to consolidate efforts in post-Independent India. Gandhi was assassinated three days before that conference, which then was rescheduled to March and carried the theme: Gandhi is gone. What should we do now? That conference from March

13-15, 1948 marked the birth of the Sarva Seva Sangh. Among those present were Prime Minister Jawaharlal Nehru, Education Minister Maulana Azad, Congress president Rajendra Prasad as the Chair, and those like Acharya JB Kripalani, JC Kumarappa, Jayaprakash Narayan, Vinoba Bhave, who spoke "with candour, self-criticism, and a refreshing objectivity that (did) not exempt even their martyred mentor," as an account in the book 'Gandhi is Gone. Who Will Guide Us Now' (Editor Gopalkrishna Gandhi, published by Permanent Black) put it. Sardar Vallabhbhai Patel was to

There is no question that this anti-Gandhi direction is despicable. Every effort must be made to resist it. Yet, the anti-Gandhi thinking is by all accounts flour-

and stood for continued to play out in the India that bought more modernity, more liberalisation and an economic boom riding on consumerism as a key marker of success. All of this may have accelerated recently but the trendline has been in the direction of the slide for a long, long time. Some trace it back to the rejection of Gandhi's ideas in 'Hind Swaraj' by Nehru. Today, violence is deeply embedded in the Indian State, increasing exponentially over the years. Justice is difficult to get, particularly for the under-privileged. Power speaks and the reality is that truth can be crushed with this power, at least in the short-run.

There is hardly a Gandhian organisation that called out this trendline of decline over the years. It is one thing to be episodic and pick events, and quite another to look at the thematic collapse that has brought us here. New leaders have not been nurtured. New and excit ing material is not brought to the classrooms. Challenges are suppressed rather than allowed to flourish. In an insightful paper published almost a decade ago, the Gandhian Dr Sudarshan Iyengar wrote: "Many (Gandhian) institutions ... appear in peril. Their core seems to have weakened, reflecting both poverty of thought and rigidity in practice. There is limited availability of committed persons ... In general, broad social support for Gandhian ideas and work, except for benign social service, is almost non-existent." At the 1948 conference, Rajendra Prasad had said: "The nation's moral fibre has gone slack." We could say that again and again.

Linhay

his is a lean-to shed with an open front. It's mainly an English West Country word, from the counties of Somerset, Dorset, Devon and Cornwall, However, it has also been recorded in Northern Ireland and Northumberland. which suggests it derives from an ancient English word once more widely distributed. The Oxford English Dictionary tentatively suggests the Old English hlinian, to lean. A related West Country word, mowhay, means a stack-yard or other enclosure. A mow is a heap of some item, usually a useful crop such as hav, wheat, or barley (it seems to be related to words in Swedish and Norwegian but is otherwise obscure in origin). The second element is from Old English and means an enclosed space (it derives from the same root as hedge, which could at one time mean any enclosing barrier, not necessarily a row of bushes or small trees). So a linhay is a leaning enclosed space. It has largely been the preserve of writers about the West Country, such as R D Blackmore, in whose Lorna Doone, set on Exmoor, the word may be found a number of times: "That faithful creature, whom I began to admire as if she were my own (which is no little thing for a man to say of another man's horse), stopped in front of a low black shed, such as we call a 'linhay." Thomas Hardy used it many times in his books set in the fictional Wessex, in reality Dorset. This is in The Return of the Native: "To dissipate in some trifling measure her abiding sense of the murkiness of human life she went to the 'linhay' or lean-to-shed, which formed the root-store of their dwelling and abutted on the fuel-house." Other writers with West Country connections who used it include Eden Phillpotts, John Galsworthy and Sir Arthur Quiller-Couch. Like Blackmore and Hardy, most felt the need to explain this dialect word. These days it seems to crop up most often in the names of selfcatering cottages converted from old barns. An older spelling is linny or linney, which more accurately reflects the way it is said.

■ Linsey-woolsey

Back in Tudor times in England there was a coarse linen material called linsey, whose name was formerly believed to have come from the dialect word line for linen, but is now thought to be from Lindsey, the name of the village in Suffolk where it was first made. Linen was woven with wool to make a less costly fabric that became known as linsey-woolsey, with the ending of wool changed to make a rhyming couplet. Henry Smith, who was a Church of England clergyman and a renowned preacher - he was known as Silver-Tongued Smith - included this comment in his sermon. A Preparative to Marriage, that was published in 1591: "God forbad the people to weare linsey wolsey, because it was a signe of inconstancie." He was referring to the Biblical prohibition against wearing clothes made from a mixture of linen and wool. Rather later, linseywoolsey became an inferior coarse cloth of wool woven on cotton. You can tell its humble status from Elizabeth Gaskell's mention of it in Sylvia's Lovers of 1863: "How well it was, thought the young girl, that she had doffed her bedgown and linsey-woolsey petticoat, her working-dress, and made herself smart in her stuff gown, when she sat down to work with her mother."

While we make our own sacrifices for the war effort, we fail to see that the gains will be appropriated by others.

Can we avoid this trap? On June 20-22, 2023, the pan-European organisation Europe, a Patient held discussions in London on the need to protect Ukrainian communities from economic exploitation after the war. Such initiatives are needed more than ever, because support for Ukrainian defence must go hand in hand with ecological and social-justice concerns. All are equally important for the country's future.

Around the same time, wildfires in Canada ended up smothering New York City under a cloud of brown smoke, giving the city's residents a taste of what people across the Global South know all too well. While paying lip service to the climate crisis and ecological break down, rich Western countries continue to do little about them. This blinkered perspective is not confined to the right and the corporate sector. Many on the left today claim to support peace while favouring compromise with brutal, revisionist authoritarian regimes.

To understand this "pacifist" opposition, we should return to the situation at the begin ning of World War II, when there was also a right-left coalition opposing US involvement in foreign wars. Then as now, the "pacifists" argued that the situation in Europe did not concern America. They harbored strange sympathies for the aggressor, and they claimed that going to war would merely enrich the military-industrial complex. When Nazi Germany told the United Kingdom, in the summer of 1940, that it wanted

commentator Patrick J. Buchanan offered a version of this argument in 2008, arguing that if Winston Churchill had accepted Hitler's 1940 offer, the Holocaust would have been less severe. Moreover, just as Churchill led the British Empire to ruin by causing unnecessary wars with Germany, the argument goes, US President George W. Bush led the US to ruin by following Churchill's example. Like many on the left, Buchanan does not believe the US should

offer guarantees to countries where it has no vital interests. One hears a new variation of this motif in the context of the Ukraine war. Supposedly, the Soviet Union's disintegration had the same effect as the Versailles Treaty: it created a predictable desire for revenge against the victors of the last war.

As in the past, this new rightleft alliance is guided by conspiracy theories, like those peddled about vaccines by Robert Kennedy, Jr., and Donald Trump's followers. It denounces anti-COVID measures as an instrument of control. It rejects helping Ukraine, since that would serve the NATO military-incourse, overtly optimistic. It implies that we do not have to address any new dangers; we can carry on as if they do not exist. It is a product of populism on both the left and the right, and it is one of the main reasons why we are now in a "democratic recession."

To escape our predicament, we cannot just cling to multiparty liberal democracy. Rather, we must find new ways of building social consensus and establishing active links between political parties and civil society. The immediate task is to oppose the new leftright populists, and that may require aligning with exponents of capitalist liberal democracy - just as WWII-era Communists fought alongside Western "imperialist" democracies against Fascism, knowing full well that imperialism was their ultimate enemy. These were strange bedfellows, but they at least could see what was really going on.

SC seeks updated status report from state govt

New Delhi, July 3: The Supreme Court Monday called for an updated status report from the Manipur government after its claim that the situation was improving in the north-eastern state after clashes broke out between the Kuki and Meitei communities.

A bench, led by Chief Justice of India (CJI) DY Chandrachud was hearing the application filed by NGO Manipur Tribunal Forum seeking deployment of the army in tribal areas to control the conflict.

"The situation is improving but slowly. CAPF companies have been deployed. The curfew has been reduced to 5 hours. There is an improvement,' Solicitor General Tushar Mehta, representing the state govern-

ment, informed the court.

On the contrary, senior advocate Colin Gonsalves argued that several militant group leaders were openly threatening to annihilate the Kukis.

He said that Sunday night, three Kukis were killed, including one being beheaded.

The SG opposed Gonsalves claims and said that "communal angle" should not be given, adding that "real human beings are being dealt with.³

"We will look at the report now. We will take this up Monday," said the top court while adjourning the matter for July 10.

It directed the state government to include details like rehabilitation camps, law and order situation, and recovery of arms in its status report.

Manipur's lifeline NH-2 reopens after 54 days 'Monsoon Trekking' in Goa

The economic blockade imposed by various organisations in the wake of the ethnic violence has been lifted

Imphal, July 3: After 54 days movement of vehicles carrying essentials resumed along the Imphal-Dimapur National Highway (NH-2) as the economic blockade, imposed by various organisations in the wake of the ethnic violence in Manipur, was lifted Sunday.

Officials in Imphal said that with the reopening of the NH-2 (via Nagaland), the lifeline of Manipur, the supply of essentials, food grains, transport fuels and life saving drugs would be easier in all the 16 districts of the northeastern state.

After the blockade of the NH-2 since early last month, Manipur was fully dependent on the Imphal-Jiribam National Highway (NH-37) through southern Assam in procuring essentials, food grains, transport fuels life-saving drugs and other ma-



terials from other states of the country. The United People's Front (UPF) and the Kuki National Organisation (KNO), in a joint statement, said that they decided to lift the blockade of the national highway passing through Kangpokpi district to ensure uninterrupted supply of essential commodities in Manipur.

The development comes, notwithstanding the anger and

various civil society organisations, village chiefs, youths and women leaders on several occasions. It highlighted that Manipur has been witnessing ethnic violence between Meiteis and Kuki-Zo communities since May 3 and recurring violence has led to loss of precious lives and destruction of property besides hundreds being injured and thousands being displaced.

The ongoing conflict has dis turbed the traditional communal harmony in the state, the statement said, claiming that the Kuki-Zo people have suffered immensely in continued offensives by miscreants and have urged the authorities to protect their lives and properties.

The Kuki-Zo organisations had earlier met the Union Home Minister and requested him to provide security in the vulnerable villages in the bordering and foothill areas, the statement said.

'We were ramping up in 2019-20, when the pandemic came in. Post COVID-19, we were servicing a lot of retail and F&B businesses in Manipur. We are the first from the Northeast to be a part of the Open Network for Digital Commerce (ONDC).'

'We are now questioning ourselves if it was the right decision to come back and start a business in Manipur. Our intention was to uplift our state and bring in the brighter side. That's why I came back," he said.

Stating that the deadly clashes and mistrust among communities have caused long-lasting damage to industries, Sundeep said that it is also affecting the lives of common people.

"Those who are in hospital, elderly and minor patients, are not getting money. Their treatment is affected. This is a very painful situation here. I am not talking about one community. Even though I am a Meitei, the violence is affecting every community in Manipur," he said.

The entire unit has faith in Sharad Pawar's capabilities to rebuild the party even after such moves by some leaders, D'Souza said.

In a presentation during the meeting, Law Commission officials said 19 lakh suggestions have been received so far in response to its public notice on June 14. The exercise will continue till July 13. Sources said 17 out of 31 members of the panel attended the meeting.

Uniform Civil Code is aimed at replacing personal laws based on religions, customs, and traditions with one common law for everyone irrespective of religion, caste, creed, sexual orientation, and gender. Personal laws and laws related to inheritance, adoption and succession are likely to be covered by a common code.

Implementation of a UCC has

been part of BJP election manifestos and Prime Minister Narendra Modi while addressing BJP workers in Bhopal last month made a strong push for it, asking how can the country function with dual laws that govern personal matters, and accused the Opposition of using the UCC issue to "mislead and provoke" the Muslim community.

Uttarakhand is already in the process of implementing its common code. Opposition parties, however, had attacked the prime minister for his comments on the UCC with the Congress saying he was making such remarks only to divert attention from real issues such as unemployment and the Manipur violence. AIMIM leader Asaduddin

Owaisi asked whether the country's pluralism would be "snatched away" in the name of UCC. In its consultation paper issued on August 31, 2018, the 21st Law Commission headed by Justice BS Chauhan (retd) said while the diversity of Indian culture can and should be celebrated, specific groups or weaker sections of the society must not be "dis-privileged" in the process.

Islamabad, July 3: Terror activities in Pakistan have soared by 79 per cent during the first half of 2023, a media outlet reported, citing a statistical report released by independent think tank Pakistan Institute for Conflict and Security Studies

(PICSS) The think tank voiced alarm in its report, stating that at least 271 militant attacks took place during the last 6 months, resulting in the loss of 389 lives and injuring 656 individuals.

The situation in the same timeframe last year was way better as compared to the current, as

the first half of 2022 saw 151 attacks and 293 deaths, and 487 injuries, The News reported.

These figures represent a staggering 79 per cent increase in militant attacks during the first half of this year compared to the corresponding period last vear. Furthermore, the latter half of 2022 recorded 228 attacks, resulting in 246 fatalities and 349 injuries. Thus, the first six months of 2023 witnessed an 18 per cent rise in attacks compared to the latter half of 2022. accompanied by a 58 per cent increase in fatalities and an 88 per cent increase in injuries,

the media outlet reported. Pakistani security forces have



also stepped up their response against terrorism and killed at least 236 militants across the country while 295 suspected militants were also arrested dur-

'Pak set to become 4th biggest IMF debtor'

Islamabad: Debt-trapped Pakistan will become the fourth largest IMF borrower in the world after receiving a fresh loan of USD 3 billion in the next nine months under the standby arrangement reached with the global lender. Pakistan will move to the fourth place in this list when it receives another \$3 billion in the next nine months under the Stand-By Arrangement made with the Washington-based global lender Thursday. The deal, which still needs to be approved by the IMF'S board, comes after an eight-month delay. Earlier, in terms of loans from the IMF, Argentina ranked first with \$46 billion, Egypt stood in second place with \$18 billion, Ukraine came in third with \$ 12.2 billion, Ecuador took the fourth spot with \$ 8.2 billion, and Pakistan was at fifth position with \$ 7.4 billion.

The Israeli military said it struck a "joint operations center" which served as a command center for fighters from the Jenin Brigades, an armed unit comprised of fighters from different militant groups. It declined to specify whether Monday's strike also involved a drone.'

At least five Palestinians were killed and 28 injured in the attack that began at about 1 a.m. Monday, with the death toll likely to rise, the Palestinian health ministry said, The Guardian reported. The incursion into Jenin is the first since the 2002 Battle of Jenin during the second intifada, when more than 50 Palestinians and 23 Israeli soldiers were killed in over a week

of fighting, including 13 Israeli soldiers in a single incident. Monday's incident brought the death toll of Palestinians killed this year in the West Bank

NATO's military plans to defend against Russia

Brussels, July 3: Russia's armed forces are bruised but by no means beaten in the war in Ukraine, a top NATO military officer said Monday, as he laid out the biggest revamp to the organisation's military plans since the Cold War should Moscow dare to widen the conflict.

"They might not be 11 feet tall, but they are certainly not 2 feet tall," the Chair of the NATO Military Committee, Admiral Rob Bauer, told reporters. "So, we should never underestimate the Russians and their ability to bounce back." Bauer said that NATO's new planning is based on the strength of the Russian army before President Vladimir Putin launched the war on Ukraine almost 17 months ago.

'What we see in general is that the Russians are careful around NATO. They are not for seeking a conflict with NATO. I think that is a sign that they are very, very busy," he said. "In the land domain, I don' think they have a lot of forces available to do anything to anyone else."

Vilnius lies around 35 kilometers (22 miles) from the Belarus border.

Lithuania wants to have a permanent NATO presence on its territory. Germany signaled last week that it would be prepared to base soldiers there if requested. For the moment, though. Singapore, July 3: The target of keeping long-term global warming within 1.5 degrees Celsius (2.7 Fahrenheit) is moving out of reach, climate experts say, with nations failing to set more ambitious goals despite months of record-breaking heat on land and sea.

As envoys gathered in Bonn in early June to prepare for this year's annual climate talks in November, average global surface air temperatures were more than 1.5C above pre-industrial levels for several days, the EU-funded Copernicus Climate Change Service (C3S) said.

Tata hikes PV prices again

Bangalore: Tata Motors said it will increase prices of its passenger vehicles by an average 0.6% across models and variants from July 17 Monday. The price hike is meant to offset the residual impact of past input costs, the company said in a statement. Tata Motors had announced price hikes of 1.2% in January and 0.6% in April, citing increased input costs and regulatory changes, respectively. Mumbai, July 3: Hinduja group owned IndusInd International Holdings (IIHL), the promoter of IndusInd Bank, Monday announced a \$1.5-billion capital raising plan to fund the proposed acquisition of Reliance Capital and increase its stake in the lender.

The board of the Mauritiusregistered IIHL also decided to increase its holding in the fourthlargest private sector lender to 26 per cent from the present 15 per cent, a statement issued from Port Louis said.

It can be noted that June 29, the lenders to the crippled Reliance Capital accepted the revised ₹9,661 crore bid by IndusInd Bank

IIHL had made the highest cash offer of ₹9,661 crore in the auctions and secured as much as 99 per cent of the lenders' votes. The bid also includes the ₹500crore cash balance with RCap going to the lenders, taking the overall recovery to ₹10,200 crore or about 65 per cent of ₹16.000 crore principal secured debt the crippled company owed to lenders

"The decision to raise \$1.5 billion opens boundless opportunities to expand our business horizon in the country and also other global geographies, in the BFSI sector. Our aspirations will not be capital constrained as raising capital is not an issue at all for us." chairman of IIHL Ashok P Hinduja was quoted as saying in the statement.

The board also approved increasing its shareholding in IndusInd Bank to 26 per cent from the current 15 per cent.

The statement claimed that global sovereign funds and private equity funds have expressed interest in participating in the fundraising/bank's growth story.

The statement further said the group is likely to take IIHL public next year. The board also approved a buyback scheme for partial dilution for its original shareholders at \$20

Across the euro zone manufacturing contracted faster than initially thought, as persistent policy tighten ing by the European Central Bank squeezed finances, and in Britain the pace of decline steepened as optimism faded. In Asia, while factory activity expanded marginally in China it contracted in Japan and South Korea as Asia's economic recovery struggled to maintain momentum.

The surge in input buying underscored the optimism and proactive stance of manufacturers, as they sought to capitalise on favourable market conditions and obtain resources to support production growth

Govt calls off Pawan THIRD FAILED Hans disinvestment ATTEMPT

New Delhi, July 3: The government Monday decided to call off the strategic disinvestment of Pawan Hans as the successful bidding consortium Star9 Mobility Pvt Ltd was disqualified in view of pending legal cases, making it the third unsuccessful attempt to privatise the helicopter service provider.

The government owns a 51 per cent stake in Pawan Hans. while public sector oil major ONGC holds 49 per cent. In December 2020, the government had invited EoI (expression of interest) for selling Pawan Hans along with ONGC's stake.

The government had in April last year decided to sell the helicopter service provider for ₹211.14 crore to Star9 Mobility Pvt Ltd -- a consortium of Big Charter



Private Ltd, Maharaja Aviation Private Ltd and Almas Global **Opportunity Fund SPC.**

However, in May the sale process was put on hold after it came to light that the lead member of the winning bidder consortium -- Almas Global Opportunity Fund SPC -- has a case pending against it at the National Company Law Tribunal (NCLT).

In a statement, the Department of Investment and Public Asset Management (DIPAM) Monday said the government has examined the adverse orders of NCLT and NCLAT.

Mumbai, July 3: As much as 76 per cent of the ₹2,000 currency notes in circulation have either been deposited or exchanged at banks, the Reserve Bank of India (RBI) said Monday and asked the public to turn in the remaining notes before September 30.

In a statement, RBI said 87 per cent of the notes returned have been deposited in bank accounts by public while the remaining 13 per cent were ex-

changed by them in other denominations.

76% of ₹2,000 notes returned to banks: RBI

The central bank, in a surprise move, May 19 announced withdrawal of ₹2.000 notes from circulation but gave public time till September 30 to either deposit such notes in accounts or exchange them at banks.

Unlike the November 2016 shock demonetisation when old ₹500 and ₹1,000 notes were invalidated overnight, the ₹2,000 notes will continue to be a legal tender till September 30.

The total value of ₹2,000 banknotes in circulation, which amounted to ₹3.62 lakh crore as March 31, 2023, had declined to ₹3.56 lakh crore as at the close of business May 19, 2023.

"According to the data received from the banks, the total value of ₹2,000 bank notes received back from circulation after the announcement on May 19 is ₹2.72 lakh crore up to June 30, 2023.

Further, RBI said that data collected from major banks indicates that out of the total bank notes in ₹2.000 denomination received back from circulation, about 87 per cent is in the form of deposits and the remaining around 13 per cent has been exchanged into other denomination bank notes.

"Members of the public are requested to utilise the next three months to deposit and/or exchange the ₹2,000 bank notes held with them to avoid any rush in the last few days before September 30, 2023," it added.

It may be noted that RBI has not yet clarified what would be the status of ₹2,000 notes in private hands after September 30.

After announcing demonetisation in 2016, the government had made it an offence to hold the withdrawn ₹500 and 1,000 notes (beyond a specified limit) after expiry of the deposit deadlines.

BLUE TIGERS FACE KUWAIT IN THE FINAL FOR THEIR NINTH SAFF CHAMPIONSHIP CROWN India eye cloud '9'

Bangalore, July 3: Defending champions India would look to preserve a proud record and add a ninth title to their shelf when they face a tough Kuwait in the SAFF Championship final here Tuesday.

India were stretched to a penalty shootout by Lebanon in the semifinals before winning 4-2, while Kuwait had to wait till extra time to eke out a 1-0 victory over Bangladesh.

In fact, this will be the second time India will face Kuwait in the tournament. They had played out a 1-1 draw in an acrimonious Group A match last week.

India might just appear to have a slight upper hand in front of a hugely partisan home crowd at the Kanteerava Stadium. But there is a worrying aspect. Will India be able to give their best in the final after they were made to toil for two matches in succession?

India assistant coach Mahesh Gawli sought to allay such concerns. "I'd like to say that if you get one week, you can't do anything. But when you get one month or more you work more on fitness," said Gawli.

"I think we had almost 50 days. Our strength and conditioning coach, Luka Radman, has done a wonderful job. We have seen our players playing without injuries, and there have been no cramps as well. In the final, India will also be

boosted by the return of key defender Sandesh Jhingan. He had missed the semifinal against Lebanon owing to two accumulated yellow cards against Pakistan and Kuwait. Anwar Ali had replaced

Jhingan in the line-up against Lebanon in the semifinals, and he did an excellent job in thwarting Lebanese advances.

Head coach Igor Stimac will be absent from the India dug out in this match as well after he was slapped with two-match ban by the SAFF disciplinary committee. Stimac had received his second

red card of the tournament during the match against Kuwait. Earlier, he was slapped with a red card in India's tournament

opener against Pakistan. However, India, under the talismanic Sunil Chhetri, had shown a streak of determination to rise above obstacles. After scoring in three successive matches in the group stage, Chhetri was

not able to find the back of the net in the semifinals against Lebanon. Of course, he converted a penalty in the shootout, but the striker would like to make a heftier contribution in the summit clash.

India would also hope that Sahal Abdul Samad, Mahesh Singh and Udanta Singh will continue to be energetic on the field, feeding Chhetri with those dreaded crosses.

Mahesh, who is usually deployed as a winger, was fielded behind Chhetri against Lebanon to add more support to the skipper. Gawli indicated a continuation of that strategy in the final as well.

"We wanted him to play there (in wings) and feed the wingers and Sunil Chhetri. He was doing that. We kept Ashique (Kurunivan) on the left because



of the physicality, and he was doing well. He was running a lot. We did not want to change that," Gawli said. But the Indians know that Kuwait are a battlehardened side, and nothing less than their best would suffice.

Pride of playing for WI has to be brought back: Formers

Bangalore, July 3: For those who have seen the glory days of West Indies cricket, the sight of them missing the bus to ICC World Cup 2023 was deeply painful.

The legendary Gordon Greenidge and Joel Garner know the feeling of winning a World Cup. They were part of Clive Lloyd's invincible outfit that lifted the trophy in 1979, beating England at Lord's.

When PTI reached out to the legendary duo, the feeling of disappointment was very evident after the West Indies failed to qualify for the 50-over World Cup in India.

See! I don't watch too much cricket these days, especially the white ball ones. Earlier a West Indies defeat used to hurt a lot but now it doesn't that much as our standards have fallen over the years. But yes, a World Cup without the West Indies is quite unimaginable.



We have no more depth to hit," Greenidge told this agency.

The view of the 72-year-old former West Indies opener found an echo in Garner's words. "We are not what we were, right! Earlier, there used to be a lot of pride in playing for the West

Indies. It was our motivation. Now, the young players are getting more attracted to T20 leagues. No blame on them as everyone looks around for security," said Garner. "Our generation also did not

get too much money; it came

mainly from County cricket. But now this generation of cricketers has many avenues to earn, and they cannot be blamed for using them. The pride of playing for the West Indies has to be brought back," added the 70vear-old Barbadian

When the West Indies failed to enter the Super 12 of ICC T20 World Cup 2022, then Cricket West Indies president Ricky Skerritt had promised a thorough investigation and revamp. But going by the recent occurrences, nothing much has evolved since. Understandbly, Skerritt is disappointed. So, what is the way forward

for the West Indies to regain their pomp? "I have always said that we need to pick the right teams, ensure availability of the best players for big tournaments and practice games ahead of them. It assures cohesion.

"It assures that we remain competitive and if you are not competitive enough then the big teams might not be interested in playing against the West Indies. Crowd will stay away from the stadiums. We will go down the pecking order. It should not happen," Skerritt notes.

His words hold a lot of truth

in them as West Indies' preparation for the World Cup qualifiers was bordering on the doltish. For the qualifiers, which are being held in Zimbabwe, the West Indies played practice matches in the UAE. The conditions in both the nations are as different as chalk and cheese. It has been often said that

former players are not actively involved in the development of cricket in the Caribbean, leaving the young cricketers with no one to look up to.

"We are around. We are willing to help. But there has to be a proper definition of roles as clarity in communication is very important. I don't think there is any scarcity of talent in the West Indies.

"But we need a proper system to keep the young players motivated and focused. It is an effort to be made by all the stakeholders, not just by one section or one person," said Garner. Cricket lovers from around the world will be hoping for that!

Philipsen wins 3rd stage, but Yates keeps overall lead

Bayonne (France), July 3: Belgian cyclist Jasper Philipsen won the third stage of the Tour de France in a bunched sprint Monday, while Adam Yates of Britain kept the race leader's yellow jersey.

The 25-year-old Philipsen was expertly led to the front by his Alpecin–Deceuninck teammate Mathieu van der Poel and comfortably held off German rider Phil Bauhaus and Australian Caleb Ewan as they dashed to the line.

Danish sprinter Fabio Jakobsen was fourth ahead of Belgian standout Wout van Aert. They all clocked 4 hours, 43 minutes, 15 seconds on the 193-kilometer (120-mile) route from Amorebieta-Etxano in Spain's Basque country to Bayonne in France.

Yates maintained his six-second lead over two-time Tour winner Tadej Pogacar and his twin brother Simon Yates in third. Defending -(champion Jonas Vingegaard of Denmark stayed sixth.
