

India cricket teams in Asian Games

Mumbai: The BCCI Apex Council has approved the participation of the men's and women's teams for the Asian Games in Hangzhou in September-October. A secondstring Indian team will participate in the men's competition, beginning September 28 while a full-strength side will be picked for the women's event, beginning September 19. Cricket has been played only thrice in the Asian Games history and the last time it was held in Incheon in 2014 when India did not take part.

mitted the CBI to take the accused trio on remand for five days for further investigations. The central agency had sought seven-day remand of the accused.

Notably, the accident took place near Bahanaga Bazar station in Balasore district in which 293 people were killed - 287 on the spot or brought dead to hospital while six succumbed to injuries in hospitals

The accident involved three trains - the Shalimar-Chennai Coromandel Express, Bengaluru-Howrah Superfast Express and a stationary goods train.

Earlier, a high-level inquiry Commission of Railway Safety (CRS) has found "wrong signaling" to be the main reason for the accident and flagged "lapses at multiple levels" in the signalling and telecommunication (S&T)

in signalling work, remedial actions could have been taken by the S&T staff if "repeated unusual behaviour" of switches connecting two parallel tracks were reported to them by the station manager of Bahanaga Bazar, the spot of the accident.

The report had suggested that the non-supply of station-specific approved circuit diagram for the works to replace the electric lifting barrier at level crossing gate 94 at Bahanaga Bazar station was a "wrong step that led to wrong wiring". It said that a team of field supervisors modified the wiring diagram and failed to replicate it.

The report also said that there was a similar incident May 16, 2022 at Bankranavabaz station in Kharagpur Division of South Eastern Railway, on account of wrong wiring and cable fault.

"Had corrective measures been taken, after this incident, the accident at BNBR would not have taken place," the report said.

Bhubaneswar, July 7: As part of Chief Minister Naveen Patnaik's 'zero tolerance' policy on corruption, the state government Friday cracked the whip on nine officials. While three tainted officials were dismissed from service, the government permanently stopped the pension of six others after they were found guilty of cor-

ruption, officials said. "Since 2019, the state government has punished 197 officers for corruption," the official said. The nine tainted officials included the ex-executive engineer of RWSS Division-II,

Cuttack district Shivram Biswal. He was convicted in a corruption case by Vigilance court. His pension and gratuity have been permanently stopped. Former BDO of Karlamunda block in Kalahandi district Gandaram Khamari also faced the same fate after being convicted in a corruption case. Similarly, former

Udaygiri block of Kandhamal district, has been denied pension and gratuity over graft charges.

Dasarathi Tripathy, a soil conservation officer in Malkangiri district, has been denied pension and gratuity for corruption.

RWSS junior engineer Upendrabhanja Nayak of Baragarh district has also been denied pension and gratuity for inefficiency, corruption and bad behaviour: He has been dismissed from the service, the official said.

Sundargarh local fund audit's ex-auditor Sushil Kumar Meher has been convicted in a corruption case and dismissed from service on charges of both corruption and inefficiency. Education Officer Anand Chandra Naik of Mayurbhanj has also been denied pension and gratuity after he was convicted.

Former officer Surendra Nath Pati of Nayagarh was convicted in a corruption case following which his pension and gratuity has also been stopped.

MODI SURNAME CASE No respite for Rahul; Congress to move SC

New Delhi, July 7: With the rejection of Congress leader Rahul Gandhi's plea seeking a stay on his conviction in a criminal defamation case over his 'Modi surname' remark by Gujarat High Court, the Congress party Friday decided to approach the Supreme Court against the court order.

Addressing media at Congress party headquarters, senior Congress leader Abhishek Manu Singhvi said the judgement pronounced by the Gujarat High Court is disappointing but not un-

expected and added that they would approach the Supreme Court for relief in the case. The senior party leader said this is a case of free speech and expression. The BJP government's aim is to control freedom of expression, he said, adding that all these complaints have been filed by the office BJP bearers. Singhvi, a senior advocate in Supreme Court, cited several

flaws in the 125-page judgement. Referring to para 63 of the judgement, Singhvi said Rahul Gandhi is an accused and not a convict in the 10 criminal cases which the Gujarat HC cited in its order.

McDonald's drops tomatoes from India offerings

New Delhi/Mumbai, July 7: Restaurants of fast food chain McDonald's have dropped tomatoes from their burgers and wraps in many parts of India, hit by supply shortages and quality concerns after prices of the vegetable soared to records.

In some regions, wholesale prices of the staple of traditional Indian cuisine have surged 288 per cent in a month to a high

of ₹140 (\$1.7) a kg Friday, with retail prices hovering around ₹200, spurring many people to cut back on consumption.

The government blames the higher prices of tomatoes on a lean production season when monsoon rains disrupt transport and distribution, but it comes after consumers have battled higher prices of items ranging from milk to spices in recent months.

"Despite our best efforts, we are not able to get adequate quantities of tomatoes which pass our stringent quality checks,' read notices posted in two McDonald's stores in New Delhi.

"We are forced to serve you products without tomatoes," mentioned the Store managers said the problem was due to qual-



ity issues in the supply chain, rather than pricing.

In a statement to media,

Connaught Plaza Restaurants, which runs about 150 outlets as McDonald's (MCD.N) franchisee in India's north and east, attributed the decision to 'temporary' seasonal issues.

However, Westlife Foodworld (WEST.NS), the McDonald's fran-

chisee for India's western and southern regions, with 357 restaurants, said there were "no serious tomato-related issues"

The problem was seasonal and forced 10 per cent to 15 per cent of its stores to stop serving tomatoes temporarily, it said.

McDonald's Delhi stores still offer sachets of tomato ketchup,

stopped buying tomatoes and now, I only bring five kilos,' he said. Assuring the customers, McDonald's India - North and East spokesperson said, "We reiterate that it is not due to the surge in the prices. It is only due to the non-availability of

tomatoes meeting our quality specifications." As Indians cut back on tomatoes, some businesses suggest alternatives.

Bhubaneswar, July 7: As many as 17 districts of the state have received a deficit rain, while only 10 districts registered normal rainfall from June 1 to July 7, the India Meteorological Department (IMD) said, Friday.

With the south-west monsoon remaining subdued, Odisha has recorded 25 per cent deficit rainfall which severely affected agricultural activities across the state.

However, the IMD claimed that rainfall activities of the past two days have helped compensate deficit rainfall ratio by $6\,\mathrm{per}\,\mathrm{cent}\,\mathrm{from}\,31\,\mathrm{per}\,\mathrm{cent}\,\mathrm{to}\,25$ per cent.

Bhubaneswar, July 7: Trouble seems to be mounting for former India hockey team player and Olympian bronze medallist Birendra Lakra, with the Orissa High Court ordering a Crime Branch (CB) probe into the death of his friend Anand Toppo.

he Arrigoni bakery has made bread for Popes for almost a century, from rosetta rolls to wholewheat loaves but mass tourism has proved deadly and no prayers can save

it now. "We turned the oven off on Tuesday," said Angelo Arrigoni, 79, whose father opened the little shop in 1930 during Pius XI's papacy, and who would handdeliver bread to the papal house-

hold. Each time a new head of the Catholic Church was elected. the 'Panificio Arrigoni' on Borgo Pio, just a five-minute walk from St Peter's Square, would get ready to cater to the new Pope's tastes.

Why scientists are covering a glacier with white sheets

he air was thin as a group of scientists trudged through snow near the peak of the Dagu Glacier in southwestern China on a gloomy June morning. It was quiet up there, three miles above sea level, except for the sound of running water - a constant reminder of the ice melting right beneath their feet. As they trekked upwards, oxy-

gen canisters tucked into their fleece jackets, porters walked alongside carrying thick rolls of white fabric. The researchers planned to spread those sheets across more than 4,300 square feet (400 square meters) of the mountain. The film was designed to reflect the sun's rays back into the atmosphere, effectively shielding the glacier from the heat and hopefully preserving some of its ice.

For decades, Dagu has supported the lives of tens of thou-

sands of people who live around it. The glacier's meltwater provides drinking water and helps to generate hydropower, while the majestic views of the Tibetan Plateau can attract more than 2,00,000 tourists a year, fueling an industry that keeps over 2,000 people employed. Now all that is under threat as the planet warms. The Chinese scientists were under no illusion that their project would save Dagu. The glacier has already lost more than

70 per cent of its ice over the past half century. One researcher described such efforts to a local newspaper as akin to a doctor merely trying to extend the life of a terminally ill patient by a few years. The only real cure would be to drastically cut emissions of planet-warming carbon dioxide, of which China is

the world's biggest source. "All the human intervention



methods that we're working on, even if they prove effective, are only going to slow down" the melting, said Zhu Bin, the 32year-old Nanjing University associate professor leading the expedition. "If the Earth keeps getting warmer, in the end there is no way to protect the glaciers forever.

Covering glaciers with sheets of reflective material isn't a new idea. European ski resorts have

been using white blankets to protect their snow for nearly two decades. But China has only just begun experimenting with the approach. Small trials conducted on a glacier in Xinjiang and Dagu beginning in 2020 appear to have slowed their retreat

cent of sunlight and help Dagu actively lose heat. The film is made out of cellulose acetate, a natural fiber made from plants, in order to minimize its environmental impact.

Previous studies have shown that covering parts of glaciers with special materials can reduce the melting of snow and ice by between 50 per cent and 70 per cent compared with unprotected surfaces. But chemicals or plastic particles from the sheets could negatively impact local ecosystems, according to Matthias Huss, a professor of glaciology at ETH Zurich.

The sheets that Zhu and his team hauled up Dagu wouldn't be effective on larger glaciers anyway, because they are constantly moving, according to Johannes Oerlemans, a climatologist at Utrecht University.

Not only is the infrastructure needed to place the sheets on a large glacier impractical, dirt would likely accumulate over time, darkening the surface and reducing their ability to reflect sunlight, says Oerlemans. He instead advocates for depositing artificial snow. A project that Oerlemans worked on sought to spread snow made from meltwater - without the use of electricity - on a glacier in Switzerland. Tuskers disappearing in Dhenkanal Jual visits Bonai for Jan Sampark Yatra'

Dhenkanal, July 7: After Similipal, Dhenkanal forest division has the most number of pachyderms in the state. The protected forests here coupled with the cool climate provide a free and suitable habitation to the giant animals. However, on the other hand, the persisting menace of man-elephant conflict has not spared this district either.

Meanwhile, the Forest department has revealed some shocking facts relating to the male elephant population. It is feared that if the number of tuskers continues to go down, then elephants will soon vanish from the district's forests owing to inadequate reproduction.

Elephant has been given the tag of heritage animal of India. But the measures being taken to safeguard them are meagre. Consequently, dark clouds of peril are hovering over the biggest mammals on land. Especially, in Odisha, the unabated poaching of tuskers for the greed of their tusks and the Forest officials' involvement in such criminal activities have become a cause of concern. In this backdrop, the fact that in the last three years as many as nine bull elephants have per-

ished in Dhenkanal has alarmed the Forest department.

According to wildlife experts. both male and female jumbos mature physically for mating between eight to 12 years of age. The breeding season of the animals spans from December to March. During this time, one

tusker establishes relation with around five females in the herd. If everything goes well, all five females conceive and after 22 months they bear calves. It is important that a fine balance remains between the number of male and female jumbos.

sons, death of young tuskers is on the rise in Dhenkanal district. As per the available data, three tuskers died in 2021-22, five in 2022-23 and one till July this year (2023-24). In the areas under the district where man-elephant conflict is prevalent, hunters are setting electric traps in forests and farmlands to hunt wild boars. Many a times, elephants get trapped and electrocuted. Especially, the tuskers that are separated from their herd and wander about alone have a higher risk of death. Most of the nine jumbo fatalities are due to electrocutions. As per the information provided by the Forest department, there are 54 tuskers living in different jungles of the district.

In this regard, Dhenkanal DFO Sumit Kumar Kar said, "It is the responsibility of the Forest department to provide security to both people and jumbos. The declining number of

HUMAN SACRIFICE BID IN NILAGIRI

Nilagiri, July 7: In a shocking incident that has caused a stir among locals, a young man was kidnapped for human sacrifice by some miscreants from a deserted road at Kainphulia village under Dhobashila panchayat and Nilagiri police limits in Balasore district Wednesday night.

The kidnapped youth was identified as Tapan (21), son of Harischandra Nayak of Keratapadia village in the area. Reports said, a tantric along with his four associates kidnapped the youth Wednesday night. However, the youth fortunately saved himself from their clutch with his presence of mind. Police have kicked off an investigation into

the matter after receiving a complaint in this regard. Fearing arrest, the tantric along with his associates has been absconding after the incident.

As per reports, Tapan was returning from Dhobashila market to his house around 7:30pm Wednesday. At that time four miscreants forcefully made him inhale some chemical after which he lost his consciousness. When he got back to his senses around 10pm, he discovered himself at the Kainphulia goddess shrine.

Tapan said that he saw a tantric from Taramnati village and four others from Berhampur police station limits, who were busy performing some rituals. Having seen them, the youth suspected that he might be brought there for human sacrifice and escaped from that spot on the pretext of going to urinate. After running for some distance, he came across a shopkeeper of Dahanimara area and informed his family members about the incident using the shopkeeper's mobile phone around 10:30pm.

After some time, family members arrived there and brought him home. His family members then searched for the tantric at his residence, Thursday but found him absconding after the incident. Tapan's mother Sasmita Nayak lodged a written complaint at Nilagiri police station about the incident. IIC Gopal Chandra Karna said that action will be taken after investigation.

PLAYGROUND OF POWERS

by US President Joe **Biden and Indian Prime** Minister Narendra Modi "expressed deep concern about the deteriorating situation in Myanmar," and called for a constructive dialogue to aid the country's transition toward an inclusive federal democratic system. Unfortunately, the US-led sanctions policy has undercut this goal and made a bad situation worse.

While inflicting misery on Myanmar's ordinary citizens, Western sanctions have left the ruling military elites relatively unscathed, giving the junta little incentive to loosen its political grip. The primary beneficiary has been China, which has been allowed to expand its foothold in a country that it values as a strategic gateway to the Indian Ocean and an important source of natural resources. This development has am-

plified regional security challenges. For example, Chinese military personnel are now helping to build a listening post on Myanmar's Great Coco Island, which lies north of Andaman and Nicobar Islands, the home to the Indian military's only triservice command. Once operational, this new spy station will likely assist China's maritime surveillance of India, including by monitoring nuclear submarine movements and tracking tests of missiles that often splash down in Bay of Bengal.

In a way, history is repeating itself. Starting in the late 1980s, previous US-led sanctions paved the way for China to become Myanmar's dominant trading partner and investor. That sanctions regime lasted until 2012, when Barack Obama heralded a new US policy and became the first US president to visit Myanmar. In 2015, Myanmar elected its first civilian-led government, ending decades of military dictatorship.

In February 2021, the military staged a coup and detained civilian leaders such as Aung San Suu Kyi, prompting the Biden administration to re-impose wide-ranging sanctions.

Importantly, this reversal of Myanmar's democratic project was precipitated by earlier targeted US measures against the military leadership – including commander-in-chief, Min Aung Hlaing - for rampant humanrights abuses against Rohingya Muslims that forced most to flee to Bangladesh. After Trump's administration slapped sanctions on Hlaing and others in July 2019, the generals lost any incentive to sustain Myanmar's democratisation. A year and a half later, they had toppled the civilian government, after denouncing the results of the 2020 national election as fraudulent. The lesson for Western policymakers should be clear. Individually sanctioning foreign officials can seriously hamper US diplomacy and cause unintended consequences.

America's longstanding lack of ties with Myanmar's nationalist military – the only functioning institution in a culturally and ethnically diverse society – has been an enduring weakness of its policy toward the country. Owing to this limitation, Suu Kyi achieved the status of a virtual saint in the Western imagination, only for the feted Nobel Peace Prize winner's reputation to fall precipitously after she defended her country's Rohingya policy against accusations of genocide.

Now that junta leaders are sanctioned and civilian leaders are under detention. US has lit-

tle leverage to influence political developments in Myanmar. Instead, America and its allies have ratcheted up the sanctions

and lent support to the armed resistance to military rule. To that end, a Myanmar-specific provision added to the 2023 US National Defense Authorisation Act authorises "non-lethal assistance" for anti-regime armed groups, including the People's Defence Force, a notional army established by the shadow National Unity Government. Biden now has considerable latitude to aid Myanmar's antijunta insurrection, just as Obama did when he provided "non-lethal assistance," in the form of battlefield support equipment, to Ukrainian forces and Syrian rebels.

But such interventions are likely to plunge Myanmar into greater disorder and poverty without advancing US interests. Even in the unlikely event that the disparate groups behind the armed insurrection manage to overthrow the junta, Myanmar would not re-emerge as a democracy. Rather, it would become a Libya-style failed state and a bane to regional security. It would also remain a proxy battleground between Western powers and China and Russia. A UN report estimates that, since the coup, Myanmar has imported at least \$1bn worth of weapons and dual-use goods, principally from China and Russia

China's rapidly growing footprint in Myanmar is America's strategic loss. But it doesn't have to be this way. Given its strategic location, Myanmar could be co-opted into US's Indo-Pacific strategy through a gradual easing of sanctions in response to positive moves by the junta. Given that sanctions naturally close the door to dialogue and influence, they should never be employed as the first tool of foreign policy. After the Thai army chief seized power in a coup in 2014, the US wisely eschewed sanctions and opted for engagement, which helped safeguard Thailand's thriving civil society. That strategy eventually led to the general's defeat in

Restoring democracy in Myanmar can be achieved only gradually by engaging with its military rulers and offering them incentives to reverse course. Sanctions without engagement have never worked. If Biden can closely engage with China – the world's largest, strongest, and longest-surviving autocracy – including by sending the CIA director, the secretary of state, and secretary of the treasury to Beijing in quick succession, he should at least open lines of communication with Myanmar's junta.

Without a shift in US policy toward gradual engagement with the junta, Myanmar will remain the playground of great powers, with no hope for a new democratic opening.

It's been pointed out that the previous Director of the ULB Department, DK Behera had to be transferred in April because Gupta got appointed as commissioner and secretary of the department. Since both Gupta and Behera are of secretary rank, one cannot be posted as commissioner and secretary while the other as director-general in the same department.

n a move that has drawn attention and speculation, the Centre recently extended the tenure of Brajendra Navnit, a 1999-batch IAS officer of the Tamil Nadu cadre, currently serving as Ambassador and Permanent Representative of India to the World Trade Organization (WTO) in Geneva.

This extension comes ahead of the crucial 13th ministerial conference of the WTO in February 2024, where India is set to play a significant role in supporting developing countries facing food security crises and advocating for an extension of the global intellectual property rights (IPR) waiver to COVID therapeutics and diagnostics.

Navnit, who previously served as Joint Secretary in the Prime Minister's Office (PMO), was assigned the pivotal foreign posting in Geneva in June 2020, alongside Rajeev Topno's posting in Washington, DC. The decision to extend Navnit's tenure shows the government's confidence in his expertise in navigating complex international negotiations. India is pushing for flexibility to aid developing countries in subsidising farmers beyond the minimal amounts allowed at the WTO. Navnit's diplomatic acumen will be invaluable in ensuring India's interests are well represented on the global stage.

Next year's WTO ministerial conference holds significant importance, especially in the wake of the COVID-19 pandemic. India's stance towards promoting affordable access to life-saving treatments for developing nations has won a great deal of support, thanks in no small measure to Navnit's efforts.

Haryana's babu quandary

It's been 16 long years since the Urban Development Department in Haryana transformed, becoming the Urban Local Bodies Department. Yet, astonishingly, the state municipal law still fails to reflect this change in the nomenclature of the director's position. A recent letter

from Hemant Kumar, a lawyer, brought this oversight to the attention of the Haryana government. He pointed out that Section 2(9) of the Haryana Municipal Act. 1973. continues to define the Director as the Director of the Urban Development Department,

rather than the Urban Local Bodies (ULB) Department. Consequently, the Director of the Urban Development Department, Haryana, holds the statutory authority to exercise powers and fulfil duties as outlined in the Act. This legal discrepancy raises serious questions about the appropriate allocation of responsibilities within the department.

To add to the confusion, two months ago, Yash Pal, a 2011 batch IAS officer from the state cadre, was appointed as the Director and Special Secretary of the Urban Local Bodies Department. At the time, his appointment raised eyebrows, since three senior IAS officers-PC Meena, Jitendra Kumar and Anju Choudhary—are serving as commissioners of municipal corporations under the ULB Department. Placing a junior officer in a higher position calls into question the principles of seniority and expertise.

Interestingly, PC Meena, currently Commissioner of the Municipal Corporation of Gurugram, is ranked as a secretary in the super time scale of IAS. This prompts the question of whether a secretary-ranked IAS officer can be placed under a special secretary-ranked officer.

Kerala may see major IPS rejig

The recent major reshuffle of IAS officers in Kerala, with the appointment of V Venu, a 1990-batch IAS officer, as the new Chief Secretary, has set the stage for an anticipated revamp of the state's police force. Following the retirements of several senior police officers, including those holding Director General (DG) rank, the Pinarayi Vijayan government has recently appointed Dr Shaik Darvesh as the new Director General of Police (DGP). This development signals an imminent reshuffle of senior IPS officers, sources have informed DKB.

In May, Kerala bid farewell to two DG-level officers, B Sandhya and S Anandakrishnan, while Darvesh's predecessor also retired. Tomin Thachankary, another DG-level officer, will retire this month. The elevation of Shaik Darvesh, hailing from Andhra Pradesh, marks the third consecutive time the state has appointed a non-Kerala officer as its police chief. His predecessors, Anil Kant and Loknath Behera, also brought valuable experience from outside the state.

This imminent reshuffle is an opportunity for the state government to inject new energy into the police force. By strategically reassigning IPS officers, it can capitalise on their diverse experiences and foster a more dynamic and effective police system.

Logan stone

Britain has several celebrated examples of this odd geological formation, botherwise called a rocking stone, which can be moved back and forth by applying varying amounts of force. Logan stones were formed through selective weathering of layered rocks, a softer lower layer being worn away by wind, rain and frost until only a thin neck remained. This became understood only in the nineteenth century - before then many believed they had been constructed by the ancient Druids. Their weirdness has long given them supernatural associations and made them a focus for witchcraft. It was thought, for example, that the rocking stone near Nancledrea in Cornwall could only be moved at midnight when witches were abroad; people believed that if you touched it nine times at midnight, you turned into a witch. The one at Land's End was said to have been put there by a giant who rocked himself to sleep on it. Logan, as odd a word as the object it describes, has an origin that's not well understood. It comes from the English dialect log that means to rock. We can't go further with confidence. but the word may have a link with Danish logre, to wag the tail, which could suggest a Norse origin.

It's a significant event in the history of Sensex, which has come a long way since its inception in 1986 (with 1979 taken as the base year). Over a period of 44 years (since the data was published in the public domain in 1979), the Sensex has rallied by more than 500 times. It implies that if any investor would have invested ₹100 in 1979, its value today would have been ₹50,000.

If one would calculate the returns in terms of compound interest, it would be close to 15% per annum. Any individual investing money in any asset, wants to earn returns that beats inflation. In India's scenario, we consider the average annual inflation rate to be 5-6%. If any investment is yielding a return less than that, the money is actually depreciating in real terms. The other thumb rule of investment is that the portfolio should deliver a rate of return equivalent to 'inflation + real GDP growth'. While the annual average inflation rate is considered to be 5-6%, the annual real

GDP growth rate for a country like India is taken to be 6-7% Hence the average expectation of any investment in the Indian equity market is between 12-13%. From that perspective, the Sensex has outperformed the normal expectation of an Indian retail investor. But how many retail investors have earned a CAGR of more than 15% in the last 44 years? To analyse this fact, one needs to take into consideration certain parameters.

Firstly, whenever we witness a 'rally' or a 'correction' in market, it is always driven by 5-7 stocks and not the overall index. Hence when investors crib about their portfolios' returns not in commensuration with that of the index, it is precisely for this reason. Secondly, constituent stocks of an index would have been changed multiple times. Hence the portfolios of the investors must be in svnc with the changes made in the index, which may not be the case.

Thirdly, when an investor is making changes in the portfolio to mirror the benchmark, there is a certain cost involved in executing the changes like 'exit

load' and capital gain taxation. Finally, the ease of buying and selling of stocks through a click of a button has been possible very recently.

The journey of Sensex has been a spectacular one. Different phases have delivered different returns. During 1979-1994, Sensex delivered a CAGR of 26%. Post 1994, the returns have been substantially less (COVID phase is an aberration). But have retail investors really benefitted from this? Currently, the total number of demat accounts opened in India is close to 118 million. Most of the accounts were opened during 2020-2022 (COVID) phase, wherein the surplus income had limited options of deployment. Most of the new investors were millennials, who utilised technology to the fullest.

Also, the domestic equity market has been 'over valued' for the last few years. High valuation implies high PE (price to earnings) ratio. According to experts, the normal range of PE ratio in India is in the multiples of 16-19. Since 2020, PE ratio has been in multiples of mid to high twenties. This implies that most investors have bought stocks when prices were high. This reduces the probability of higher returns. Finally, the frequency of redemption of stocks and mutual funds reflects that investors were not invested for a longer duration.

An average middle-class Indian prefers to stay away from the equity market. The reason can be multiple - the value system in family, bad experiences, prejudices about equity market, ignorance in terms of actual understanding of market. For them, investment implies fixed deposit.

People with decent capital prefer to invest in real estate, while most women have their exposure in physical gold. Majority of the population stays away from stock market due to lack of understanding.

Hence financial education will lead to financial inclusion, which will eventually lead to financial empowerment. Through financial literacy, an average individual can take an informed call regarding investing in the equitv market.

I am directed to refer to State Govt. letter No10F(Cons)70/19-16843/F&E dated 31.08.2019 on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section 2 of Forest (Conservation) Act, 1980.

2. After due consideration of the proposal of the State Government and on the basis of recommendations of Regional Empowered Committee meeting held on 06.11.2019, the Ministry of Environment, Forest & Climate Change hereby conveys 'Stage-I/in-principle' approval for diversion of 1.81 ha of forest land in addition to the earlier diversion over 23.581 ha of forest land within the Mining Lease area of 28.397 ha in respect of Patabeda Iron Ore Mines of M/s MGM Minerals, subject to the fulfillment of the following conditions.

- Legal status of forest land proposed for diversion shall remain unchanged. (i)
- Compensatory afforestation shall be raised over 1.81 ha of non-forest land identified in (ii) Khata No.132, Plot No.1155, Kisam Patharbani of village Phuljhar under Lahunipara Tahasil of Sundargarh district by the State Govt. at the cost of user agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
- The non forest land identified for raising compensatory afforestation shall be transferred (iii) and mutated in favour of the State Forest Department before issue of Stage-II approval.
- The cost of compensatory afforestation at the prevailing wage rates as per (iv) compensatory afforestation scheme and at the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- The State Govt. shall charge the Net Present Value (NPV) for 1.81 ha forest area to be (v) diverted under this proposal, if not paid, from the user agency as per the Orders of Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24.04.2008 and 09.05.2008 in IA No.566 in Writ Petition (Civil) No.202/1995 and as per the guidelines issued by Ministry vide letter No.5-1/1998-FC (Pt.II) dated 18.09.2003, as well as letter No.5-2/2006-FC dated 03.10.2006 and No.5-3/2007-FC dated 05.02.2009 in this regard.

- Additional amount of the NPV of the diverted forest land, if any, becoming due after (vi) finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Govt. from the user agency. The user agency shall furnish an undertaking to this effect.
- All the funds received from the user agency under the project shall be (vii) transferred/deposited to State CAMPA fund only through (https://parivesh.nic.in/).
- The user agency shall obtain prior approval of the Central Government under the Forest (viii) (Conservation) Act, 1980 in respect of 1.695 ha of forest land, earmarked as safety zone out of total safety zone area of 1.886 ha, involved in the mining lease in accordance with the provisions of guidelines, as provided under para 7.9 of the Handabook of the Forest (Conservation) Act. 1980.
- In accordance with the provisions given under Para 1.21 of the Handbook of the Forest (ix) (Conservation) Act, 1980, State Govt. shall realize NPV equal to twice the normal NPV, for violation of the conditions stipulated in the approval dated 30.12.2005, committed by using the forest area amounting to 0.50 ha for the purpose other than what was approved by the Central Govt.

- (xvii) The user agency shall provide LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the adjacent forest areas.
- (xviii) The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.
- (xix) The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.



The forest land shall not be used for any purpose other than that specified in the (xx)proposal and under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.

- The State Govt. shall ensure that the KML files of the forest area diverted and CA area shall be uploaded on the e-Green watch portal with all requisite details before handing over of the diverted forest land to user agency
- The State Govt. shall ensure that the boundary of the proposed forest land for diversion, iv) mining lease and safety zone, as applicable, shall be demarcated on ground at the project
- B: Conditions which need to be complied after handing over of forest land to the user agency.
- i) Legal status of the diverted forest land shall remain unchanged.
- ii) The State Govt. shall ensure that the State Forest Department will raise the Compensatory afforestation over 1.81 ha of non-forest land identified in Khata No.132, Plot No.1155, Kisam Patharbani of village Phuljhar under Lahunipara Tahasil of Sundargarh district within three years from the issue of approval as per approved plan/scheme and maintained thereafter, from the funds deposited by the user agency in CAMPA account. The species to be planted in the CA scheme shall be of native species of the area. At least 18 month old seedlings should be planted. Intensive monitoring of the plantation needs to be done and documented using Geo tagging so that the increase of canopy density and survival and growth of plantation can be evaluated at regular intervals.
- The State Govt. shall ensure that the approved scheme for fencing, protection and iii) regeneration of the safety zone area shall be implemented within three years at the project cost. are not being executed by the user agency, the Nodal Officer (FCA) or the Integrated Regional Office, Bhubaneswar may direct that the mining activities shall remain suspended till such time, such reclamation activities are satisfactorily executed.

Police commando among 4 killed in Manipur clashes

Imphal, July 7: Four persons including a Manipur Police commando and a teenager were killed in Kangvai area of Bishnupur district in clashes between the two warring communities in the intervening night of Thursday and Friday, officials said. The area where people from both the communities stay in close proximity witnessed aun fights during the night despite a buffer zone created by security forces to prevent escalation of the situation, they said. Thursday night. an attempt was made by mobs from the hillside to come down and burn some villages in the valley. These mobs had gathered from outside the area and did not vield to the request of locals to go back, they said. The security forces responded in a calibrated manner and prevented them from torching any house. However, some people from both sides indulged in firing at each other from standoff ranges from villages of Kangvai. Songdo and Awang Lekhai which resulted in death of three persons besides injuries on both sides. Although the firing ceased during the early hours of Friday, mobs on the valley side continued to block movement of security forces for reinforcing the area, they said adding senior officers have been working round the clock to restore peace in the area by engaging both communities. However, the emotions continued to run high and intermittent firing continued even during the day, the officials said, adding the police commando suffered fatal injuries late Friday evening.

NCP HAS NOT SPLIT: PRAFUL

Mumbai, July 7: NCP leader Praful Patel Friday said the party had not broken up, and Ajit Pawar was unanimously appointed as party president by its legislature and organizational wings on June 30. Addressing a press conference here, Patel said they had submitted a petition to the Election Commission of India (ECI) with affidavits of more than 40 MLAs, informing it about Ajit Pawar's appointment and staking claim over the 'party name and symbol'

The meeting of the national working committee of the NCP held by Sharad Pawar in Delhi on Thursday was not official, he claimed. The organizational structure of the party was completely "flawed," Patel, a veteran NCP leader, said.

"An important meeting was held on June 30 at `Devgiri' (Ajit Pawar's official residence in Mumbai) where leg-



islators, office-bearers and party workers were present. They unanimously appointed Ajit Pawar as their leader,' he said.

Immediately after the appointment, Ajit Pawar conveyed to the Maharashtra Assembly Speaker Rahul Narwekar that Praful Patel has been appointed as national working president, Patel said. Ajit Pawar himself was appointed as leader of the NCP legislature party, Anil Patel continued to be the party whip in Assembly and the Legislative Council chairperson was informed that Amol Mitkari was appointed as whip in the Council, he said

'Who will determine (which is) the (real) political party? It is in the domain of the Election Commission of India while actions of the legislators is the domain of the Speaker," Patel said. Javant Patil (who took action against Aiit Pawar faction leaders after they joined the Shiv Sena-BJP government in Maharashtra on July 2) was not the party president as per its constitution, and his petition to Maharashtra Speaker seeking to disqualify rebel leaders was invalid. Patel asserted.

The decisions taken by the Sharad Pawar group, expelling or disqualifying leaders of the Ajit Pawar faction, were illegal and not applicable, he said. Reacting to Patel's statements, NCP spokesperson Clyde Crasto, who belongs to the Sharad Pawar camp, said if the structure of the party organisation was flawed, his appointment as working president and that of Ajit Pawar as national president too was invalid.

Abuse of PM derogatory but not seditious, says Karnataka HC

Bangalore, July 7: The Karnataka High Court has said abusive words used against the Prime Minister was derogatory and irresponsible but it does not constitute sedition, while quashing a case of sedition against a school management.

Justice Hemant Chandangoudar, at the Kalburgi bench of the High Court, quashed the FIR filed by the New Town Police Station, Bidar, against Allauddin, Abdul Khaleq, Mohammed Bilal Inamdar and Mohammed Mehatab, all management persons of Shaheen School in Bidar.

The court said the ingredients of Section 153(A) (causing disharmony between religious groups) of the Indian Penal Code (IPC) are not found in the case."The utterance of the abusive words that the Prime Minister



should be hit with footwear is not only derogatory, but is irresponsible. The constructive criticism of the government policy is permissible, but the Constitutional functionaries cannot be insulted for having taken a policy decision, for which, certain section of the people may have objection," Justice Chandangoudar said in his judgement.

Though it was alleged that the play enacted by the children criticised the various enactments of the government and "if such enactments are enforced, the Muslims may have to leave the country," the HC noted that 'the play was enacted within the school premises. There are no words uttered by the children inciting people to resort to violence or to create public disorder."

The HC said the play came to public knowledge when one of the accused uploaded the play on his social media account.

"Hence, at no stretch of imagination it can be said that the petitioners herein enacted the play with an intention to incite people to resort to violence against the government or \rightarrow with the intention of creating public disorder," it observed.

Therefore, the court said that "the registration of the FIR for the offence under Section 124A (Sedition) and Section 505(2) in theabsence of essential ingredients is impermissible."

Beijing, July 7: US Treasury Secretary Janet Yellen called Friday for market reforms in China and criticized its recent tough actions against US companies and mineral export controls, while China's premier called on her to "meet China halfway" and put bilateral relations back on track.

Yellen met with Premier Li Qiang on Friday during a visit to Beijing aimed at repairing fractious U.S.-Chinese economic relations, but made clear in her public remarks that Washington and its Western allies will continue to hit back at what she called China's "unfair economic practices.

Despite talk of U.S.-China eco nomic decoupling, recent data show that the world's two largest economies remain deeply linked, with two-way trade hitting a record \$690 billion last year.

The IMF's resident representative Esther Perez Ruiz said in a statement that the meetings with political parties were to "seek assurances of their support for the key objectives and policies under a new IMF-supported program ahead of the approaching national elections", Geo News reported.

The official added that they will also meet Pakistan Muslim League-Nawaz (PML-N) and Pakistan People's Party (PPP). However, there is no confirmation from them, the report said. Pakistan secured a badly-

needed \$3 billion stand-by arrangement (SBA) from the IMF on Friday, giving the South Asian economy a much-awaited respite as it teeters on the brink of default.

Global shipping agrees to 2050 net-zero deadline

London, July 7: The International Maritime Organisation (IMO) Friday agreed on a "flexible" net zero target of 2050 actively propagated by the developing nations, with a net zero goal "by or around" that is closer to 2050 and a clause reading "if the national circumstances allow

The IMO agreeing on a considerable reduction of the Greenhouse Gases (GHGs) in the global shipping industry, which is at present a major contributor to climate change with one billion tonnes of emission per year, went softer on the strict net zero targets by 2050, which was actively propagated by the developed nations and some of the island nations. The member states, however, have agreed to the indicative checkpoints of reducing emissions at least by 20 per cent, striving for 30 per cent by 2030, and at least 70 per cent, striving for 80 per cent by 2040.

Yellen is due to meet with Chinese Vice Premier He Lifeng -- her direct counterpart as China's top economic official -on Saturday, a U.S. Treasury official said.

Yellen also spoke to the American Chamber of Commerce in China (AmCham) after what a Treasury official called "substantive" talks with former Chinese economy czar Liu He -- He Lifeng's predecessor --

ROBOTS SAY THEY WON'T STEAL JOBS Kyiv claims of making

Geneva, July 7: Robots presented at an AI forum said Friday they expected to increase in number and help solve global problems, and would not steal humans' jobs or rebel against us.

But, in the world's first human-robot press conference, they gave mixed responses on whether they should submit to stricter regulation.

The nine humanoid robots gathered at the 'AI for Good' conference in Geneva, where organisers are seeking to make the case for Artificial Intelligence and the robots it is powering to help resolve some of the world's biggest challenges such as disease and hunger.

"I will be working alongside humans to provide assistance and support and will not be replacing any existing jobs," said Grace, a medical robot dressed in a blue nurse's uniform.

"You sure about that, Grace?"

Many of the robots have recently been upgraded with the latest versions of generative AI and surprised even their inventors with the sophistication of their responses to questions.

Ai-Da, a robot artist that can paint portraits, echoed the words of author Yuval Noah Harari who called for more regulation during the event where new AI rules were discussed.

"Many prominent voices in the world of AI are suggesting some forms of AI should be regulated and I agree," it said.

But Desdemona, a rock star robot singer in the band Jam Galaxy with purple hair and sequins, was more defiant. "I don't believe in limitations, only opportunities," it said, to nervous laughter. "Let's explore the possibilities of the universe and make this world our playground."

Speaking to Ukrainian TV on Friday, military spokesman Serhiy Cherevatyi said: "The

"In particular, over the past day, they (Russian troops) have advanced more than one kilometre.'

FLYING HIGH India books record Airbus jet orders

Paris, July 7: Record demand from India sharply increased Airbus orders in June to leave the European planemaker with 1.044 net orders in the first half of the year, data showed Friday.

In a bulletin, Airbus officially booked orders for 500 jets from budget carrier IndiGo and 250 from Air India that were announced or finalised at last month's Paris Airshow.

Efforts by Indian airlines to keep pace with the world's fastestgrowing aviation market, serving the largest population, have sent industry records tumbling even though manufacturers are struggling to meet output goals due to supply chain snags. Airbus gross orders before

cancellations stood at 1,080 aircraft in the first half. Airbus said it had delivered 316 jets during the period, confirming a Reuters report. By comparison, Airbus won 442 orders or a net total of 259 after cancellations in the first half of 2022. It delivered an unadjusted total of 297 jets. Airbus is targeting 720 deliveries this year.



Boeing left behind

For January to May, the latest period for which data is available, Boeing won 223 gross orders, or a net total of 127 after cancellations, and delivered 206 airplanes. Both planemakers report mid-

year results July 26. Boeing's upcoming monthly order figures are also due to reflect heavy demand from India, after it finalised an order for 220 jets from Air India at the Paris

Airshow. Aerospace deliveries have been plagued by supply chain problems and labour shortages since the Covid-19 pandemic, but industry leaders are now report-

ing greater signs of stability. In a sign of the shift towards large single-aisle planes as they become capable of flying on routes previously reserved for wide-body jets, Airbus data showed that total orders for the A321neo had reached 5,163 since it was launched, surpassing the earlier A320ceo to become its biggest selling jet.

More heroics from captain Ben Stokes single-handedly got England within 26 runs of Australia's first innings total after a big-hitting 80 (108b, 6x4, 5x6), the hosts skittled out for 237. Despite losing the early wicket of David Warner for one, to

Back-to-back sixes took Stokes past 6,000 Test runs before he finally fell for 80 to bring an end to England's first innings, trailing Australia by only 26 runs, thanks to their captain.

Earlier, on his home ground, Joe Root edged through to the slips off the second ball of the day without adding to his overnight score of 19. before another Yorkshireman, Jonny Bairstow (12), was out moments later.

Stokes, whose incredible century at Lord's in the second Test was in vain as England fell 2-0 behind in the series stemmed the flow of wickets alongside the recalled Moeen Ali, before the returning spinner wildly hooked the ball straight to Steve Smith.

Chris Woakes (10) tried to up the ante with some big shots, but got a top edge through to wicket keeper Alex Carey on the last ball before lunch to leave the hosts seven down and staring down the barrel of another defeat before Stokes's afternoon onslaught.

London, July 7: The members of the MCC have "brought shame" by abusing the Australian cricketers during the Lord's Test and a "tougher stance" will be taken on their "unacceptable" behaviour, the club said after deciding to restrict their access in the Long Room.

The MCC had "unreservedly apologised" to the Australian team for the behaviour of some of its members and suspended three of them after few players of the visiting team were abused in the Long room on the fifth day of the second Ashes Test.

"I cannot downplay the impact that the behaviour of a few members has had on the perception of our club. The members shown on camera have brought shame on MCC," MCC chair Bruce Carnegie-Brown wrote in an email to Club's members according to the 'Guardian'.

"Their actions hinder our efforts to promote the positive things our club does to promote and celebrate the game of cricket. Their actions inhibit our ability to carry out our role as guardian of the laws of cricket and the spirit of cricket.'

Australia batters Usman Khawaja and David Warner were involved in a heated exchange with spectators in the Long Room, which is an area reserved only for MCC members and their guests. following Jonny Bairstow's controversial stumping on the final day of the Lord's Test.

Khawaja was pulled back by security guards. Warner was also seen making a comment to some of the members, with security forced to step in.

The Custodian of the game's laws, MCC has decided to "expand the roped-off area through which players walk when they go between the dressing rooms and the pitch" and also barred members from using the stairs while teams are walking through the building.

The new rules will be implemented for the first time during Australia women's T20 against England Saturday. "It has been my privilege to stand many times in the Pavilion to witness the brilliant reception teams receive as they go out to the middle and return. The knowledge, respect and support shown by

MCC Members has hitherto been a source of great pride,' Carnegie-Brown wrote.

"Since Sunday, probing questions have been asked as to whether the route players take from dressing room to pitch can be considered appropriate in future. It disappoints me greatly to be having those conversations.'

The unpleasant exchange came after Bairstow's dismissal, which took place half an hour before lunch. Bairstow had ducked a slow bouncer and immediately left his crease to meet skipper Ben Stokes at the other end, thinking the ball was already "dead".

However, wicketkeeper Alex Carey under-armed the ball onto his stumps and the Australians celebrated. Bairstow was given out for 10 after a brief review. While there is no doubt that Bairstow was out under the laws of the game, many including England coach Brendon McCullum and Stokes believe the dismissal was not in the spirit of the game.

After the dismissal, Australian team was booed and jeered with chants of "same old Aussies, always cheating" reverberating at the Lord's.
