LADY COP HELD FOR TAKING BRIBE

Bhubaneswar, July 13: Vigilance officials Thursday arrested a woman cop deployed at Saheed Nagar police station while taking bribe from a lady. The woman was allegedly paying a bribe of ₹15,000 to clear her name as an ac-

cused in a harassment case. The arrested cop was identified as Mamata Bastia who works as an ASI in Commissionerate Police, Mamata has been posted at the police station for the last 18 months.

Sources claimed that 72-yearold Subhashri Mishra, from whom the bribe was demanded, and her tenant have been at loggerheads for the last couple of years. A case in this regard has been pending in a local civil

court since long. Both the parties had numerous arguments over non-payment of rent since 2018. Few days back, they again had an argument and the tenant moved the court against Mishra.

Following directions of the court, Saheed Nagar police registered a complaint case in this

regard last month. Police during the probe found that allegations against Mishra were fabricated.

However, Mamata who was the investigating officer (IO) of the case, asked the septuagenar-

ian lady to pay ₹15,000 or face arrest. Mishra then informed the Vigilance officials. Accordingly a trap was set and Mamata was caught red-handed while accepting the bribe at Mishra's residence.

10 more GPs brought under SETU scheme in **Swabhiman Anchal**

Bhubaneswar, July 13: Odisha Chief Minister Naveen Patnaik directed officials Wednesday to add 10 more gram panchayats (GPs) in cut-off Swabhiman Anchal to the socio-economic transformation and upliftment (SETU) scheme for development in Maoist-infested Malkangiri district. Patnaik also doubled the scheme's fund from ₹50 crore to ₹100 crore.

As per the order issued by the CMO, nine GPs namely Andrapalli, Jodamba, Raligada, Panasput, Badapada, Gajalmamudi, Papermetla, Jantri and Dhuliput under Chitrakonda block and Nakamamudi under Korukonda block will be benefitted after coming under the SETU scheme. Sources said that to tackle the Maoist menace the Odisha government is emphasising on development of these areas.

Patnaik also approved an additional ₹9.60 crore under the scheme for development and expansion of paramilitary forces deployed in Swabhiman Anchal. The forces will be utilised to maintain law and order in the entire Anchal.

The move came following a field visit of 5T Secretary VK Pandian and other senior government officials to Chitrakonda block in Malkangiri district March 28 this year. Pandian held detailed discussions with local people and promised them that development work will continue as promised by the state government.

It is worth mentioning that nine cut-off GPs of Chitrakonda block is connected by Gurupriya Setu, the bridge constructed over the Gurupriya river in 2018. The SETU scheme is being executed for social_ and economic development of people residing in Swabhiman Anchal since that year, officials said.

It should be stated here that since the implementation of the SETU scheme in Swabhiman Anchal in 2018, the Odisha government has spent more than ₹110 crore to develop the infrastructure of the area including road connectivity. Substantial amounts of money have also been spent on the development of the education system for the kids residing in the area.

Jolt to research as **Centre stops funds**

Since March 2023, most research institutes including IITs have not received any financial grant from central agencies which has hindered their functioning

New Delhi, July 13: Research bodies are facing a lot of problems since the flow of funds from central agencies has stopped since April this year. This development comes amid the backdrop of the Centre promising more funding for the research bodies by setting up the National Research Foundation (NRF). Many research bodies are currently spending out of their own pockets while project staff has not received salaries for more than three months, according to reports on various national news websites.

Senior Congress leader P Chidamabram took a swipe Thursday at the Centre on this issue and said that maybe the government will coin a new slogan - 'minimum funds, maximum research'.

The problem has increased manifold with the Centre formulating a new method of transferring funds to elite institutes including the IITs and the Indian Institute of Science (IISc). All such institutes have been asked to open zero balance accounts and

the money gets deposited in it only after expenses have been incurred. Sadly, deposits have also stopped for the last three months beginning this fiscal.

"My last grant came in March 2023. Since then we have been told that unless we clear all the projects that we have got, there will not be any annual grant," BHU senior scientist SC Lakhotia was quoted as saying by a website. This is an issue with every Indian scientist working in the Department of Science and Technology (DST) or Department of Biotechnology (DBT). I have been paying my project staff

Deal finalised for 26 Naval Rafale jets, 3 subs

New Delhi, July 13: The Centre cleared Thursday proposals to procure 26 Naval variant of Rafale jets from France and three French-designed Scorpene class submarines. The procurement proposals were approved by the Defence Acquisition Council (DAC) headed by Defence Minister Rajnath Singh, the Defence Ministry said.

Four of the 26 Rafale-M jets, the naval variant of the deck-based platform, will be trainer aircraft, sources in the ministry informed. The delivery of the aircraft will begin within three years of signing of the contract, they said.

Bangkok, July 13: A Japanese tourist reaches into a baggie of cannabis he's just bought in a weed shop, pulling out a gram of buds to chop down in a small black grinder, before rolling them neatly into a joint. The slight spillage onto the table and his cough as he lights up and inhales deeply betray the fact the Defence Ministry said. until two weeks ago, he had never

tried marijuana.

Most Asian nations have strict drug laws with harsh penalties. Thailand's de facto legalisation of marijuana last year has brought a wave of tourists from the region like the visitor from Japan, intrigued by the lure of the 'forbidden' leaf.

"I was curious about how I would feel after smoking," said the 42-year-old tourist who spoke on condition that his name will not be used for fear his experimentation here could lead to legal issues at home. "I wonder why Japan bans it? I wanted to

try it," he pondered. Even as more countries around the world legalise marijuana, Thailand has been the outlier in Asia, where several countries still have the death penalty for



some cannabis offences.

Singapore has already executed two people this year for trafficking marijuana and its Central Narcotics Bureau has announced plans to randomly

test people returning from Thailand. Japan does not have the death penalty for drug offences, but has warned that its laws on cannabis use may apply to its nationals even

Thailand 'high' over new weed laws when they are abroad.

It's no wonder that weed dispensaries here say that customers from Singapore, Japan and China are among the most cautious. They ask questions about how long traces of the drug remain in the system and whether there

are detox products. Thailand's cannabis industry has grown at lightning speed, with weed dispensaries now almost as common as the ubiquitous convenience stores. Through February, nearly 6,000 licenses for cannabis-related businesses have been approved, including more than 1,600 in this city alone, ac-

cording to official figures. There are no figures on how many tourists come specifically to smoke marijuana, but shop owners say most have a go.

Flood warning: Odisha among top 5 states

72% DISTRICTS IN INDIA EXPOSED TO EXTREME FLOODS BUT ONLY 25% OF THEM HAVE EARLY WARNING SYSTEMS. CLAIMS A REPORT BY THE COUNCIL ON ENERGY ENVIRONMENT AND WATER

New Delhi, July 13: An estimated 72 per cent of districts in India are exposed to extreme flood events but only 25 per cent of them have level flood forecasting stations, or early warning systems, a new report said Thursday, adding that Odisha is among the best-performing states in terms of flood warning. According to the report by in-

dependent policy research think tank The Council on Energy Environment and Water (CEEW). despite high exposure to floods Assam, Bihar, Uttar Pradesh, Odisha, and Sikkim are the bestperforming states in terms of flood early warning systems

The report showed that Himachal Pradesh, currently battling massive floods, is among the states with the lowest availability of EWS. Uttarakhand, on the other hand, is moderately exposed to extreme flood events but has a high availability of flood EWS, it said. Delhi, in the throes of severe

flooding due to a raging Yamuna, is moderately exposed to extreme floods and has a moderate level of resilience through EWS.

Approximately 66 per cent of individuals in India are exposed to extreme flood events. However, only 33 per cent of them are covered by flood EWS. Moreover, 25 per cent of the Indian population is exposed to cyclones and their impacts, but cyclone warnings are available to 100 per cent of the exposed population, the re-

Research shows that 97.51 million people in India are exposed

to extreme flood events, and most districts are exposed to more than one extreme event, highlighting the importance of making EWS available to all in the country, especially in the states and districts most exposed to its impacts, the report said.

It said that more than 88 per cent of the Indian states exposed to floods and 100 per cent of the states exposed to extreme cyclone events have a high teledensity ratio, which means to access early warnings through telecommunications.

The recent floods in India and Cyclone Biparjoy have once again shown the importance of investing in EWs, said Vishwas Chitale, senior programme lead, CEEW. "The country is rapidly expanding its early warning coverage by embracing transformative technologies. However, as we witness swapping patterns in the climatic extremes in the country, where previously drought-prone areas are now facing floods, all states need to ramp up their early warning systems to safeguard lives and livelihoods," he said.

According to him, states should leverage state-of-the-art technologies to build inclusive, impact-based multi-hazard early warning systems that involve the local communities for lastmile connectivity.

"Intensifying adaptation finance for enhancing disaster preparedness is the need of the hour," he said.

A CEEW study released in 2021 found that 27 of 35 Indian are vulnerable to extreme hydromet disasters and their compounding impacts. Eighty per cent of India's population resides in these vulnerable re-

HC records highest case disposal in first half of '23

Cuttack, July 13: With a net improvement of 14.66 per cent in clearance rate over the last year. the Orissa High Court has recorded the highest disposal of cases in the first half of 2023, compared to those of 2021 and 2022, revealed case statistics published by the court for the period from January to June, 2023.

During the period, 49,635 cases were instituted, while 62,869 cases were disposed of at a caseto-clearance rate of 126.66 per cent. Compared to this year's numbers, in the first half of 2022, 53,155 cases had been instituted with 59,850 cases being disposed of at a case-to-clearance rate of 112.59 per cent and similarly, in the first half of 2021,

with 39,259 cases being disposed of at a case-to-clearance rate of 92.85 per cent.

Notably, the disposal rate dropped in May and June, 2023, as the court was in summer vacation with only the vacation courts functioning during the period. However, excluding these two months, the case clearance rate from January to April 2023 was 141.71 per cent.

To bring the performance of the state judiciary to public domain, the Orissa High Court has been publishing the case statistics on its website. "It can be seen from the first half yearly statistics of 2021, 2022 and 2023 that irrespective of the institution of cases, the disposal has steadily grown every year and half of 2023," said a court official.

On comparison of the statistics of the first halves of 2022 and 2023, it can be seen that 3,019 more cases have been disposed of with a net 14.66 per cent improvement in clearance rate. The rate of increase in disposal in 2021 in comparison to that of 2020 was 42.58 per cent, and the rate of increase in 2022 in comparison to 2021 was 52.44 per cent.

Similarly, the rate of increase in disposal in 2023, in comparison with 2022, has been 5.04 per cent, said the official. The number of judgements delivered by the HC in the first halves of 2021, 2022 and 2023 has also steadily grown every year.

CRUT General Manager (P&A) Dipti Mahapatro said, "CRUT. which runs Mo Bus service in the urban pockets of Odisha since 2018, has closed another tender process of adding 200 e-buses by 2024.

Mahapatro, however, clarified that a few e-buses will be running by the end of this year, and all arrangements are being made for the purpose.

"Due to less number of original equipment manufacturers (OEMs) in India, the process will take a little more time. After the bid was finalised, we are now awaiting the government nod for this big-budget project. After the approval of the same, it will take another 6-8 months to get all the 200 e-buses,' Mahapatro said.

Your canine friends can pave way for cancer cure

New York: In a breakthrough research, US scientists have identified dog genes that can hold potential cure for cancer in

A team from Broad Institute of Massachusetts Institute of Technology (MIT) and Harvard University and the University of Georgia, conducted the largestever genomic sequencing study of canine tumours.

The study, published in the journal Scientific Reports, examined real-world clinical genomic data from 671 pet dogs with cancer across the US and analysed tumour samples to identify genetic mutations driving canine cancers.

These samples were then compared to a large database of



nearly 25,000 human tumour samples to identify overlapping mutations between the two

The researchers identified 18 mutation 'hotspots' that are likely primary drivers of canine cancers. Although 10 of these hotspots have not been previously reported in humans, the remaining eight were shared by humans and dogs.

Many of these hotspots can also be targeted with small molecule drugs that are already approved for human cancer pa-

tients. This means canine cancer patients will have increased access to highly effective precision treatments that can replace or augment traditional one-sizefits-all approaches such as chemotherapy, radiation, or sur-

At the same time, the genetic data from canine tumours can accelerate the development of precision cancer drugs for humans. The findings also showed several previously unreported mutation hotspots in canine cancers, demonstrating their ability to reliably predict whether a tumour is somatic or germline based on tumour tis-

sue alone. "This study provides the most comprehensive genomic sequencing data on canine cancers, including several previously unsequenced types, and serves as a much-needed resource for comparative oncology," said Shaying Zhao, a professor at the University of Georgia and a co-author of

By addressing the significant gap in genomic data on canine cancers, this study also ushers in an era of precision veterinary medicine through clinical genomics.

Prior to this study, fewer than 2,000 canine tumours had been genetically sequenced. This study alone increased the number of canine tumours that have been sequenced by more than 33 per cent, the researchers said. IANS

As per sources, he had allegedly duped a private hospital in Thane area of Maharashtra and a construction firm in Hyderabad on the pretext of providing them loans to the tune of Rs 200 and Rs 300 crore respectively.

Bhubaneswar, July 13: The state government has decided to bear farmers' share of the premium under the Pradhan Mantri Fasal Bima Yojana (PMFBY) crop insurance scheme from this Kharif season, the state Cooperation department informed Thursday.

The decision has been taken to ensure that the small and marginal farmers do not get deprived of the benefits of the scheme for lack of premium money. "Such a transformative decision has been taken by the government in the interest of the farmers so that it would increase the coverage of farmers and culti-

The Pradhan Mantri Fasal Bima Yojana (PMFBY) is being implemented in the state since Kharif 2016 to protect farmers

vated areas, official sources said.



against potential losses to their crops due to uncertainties of the weather. Under this crop insurance scheme, the final yield of the farmers' is insured along with losses due to prevented sowing, mid-season adversity, localised calamities, and postharvest damages.

'The Odisha government has decided to continue with the PMFBY insurance cycle from Kharif 2023 to Rabi 2025-26. The scheme is being implemented by insurance companies selected once every 3 years through an open bidding process from among the companies empanelled by the Central government," informed the official. Under the scheme, the farm-

ers usually pay a premium of 2 per cent of sum-insured (SI) for Kharif and 1.5 per cent of the SI for Rabi for all crops except commercial crops, for which they pay 5 per cent of the SI. The differential premium amount is paid as a subsidy and shared equally by the Central govern ment and the state government.

This year, a fresh insurance cycle has started, with four insurance companies that have been selected through e-tender: Agricultural Insurance Company of India Ltd, SBI General Insurance Company Ltd, Future Generali India Insurance Ltd and Reliance GIC

Ltd for this cycle. 'This premium subsidy extended by the state government is over and above the normal state subsidy under the scheme. However, this benefit has been limited to 2 hectares (5 acres) per farmer, so that the resources of the state are targeted more towards the small and marginal farmers," said the official.

Farmers will have to enroll under the scheme to avail the benefit. And to validate the bank accounts, ₹1.00 will be debited from their accounts as a token.

'Dogs too are prone to cardiac problems'

Bhubaneswar, July 13: Dogs, a man's most faithful friend, too are prone to cardiac problems.

As they cannot communicate, the owners of the canines are often unaware of their heart ailments, which can be either congenital or acquired like humans, experts attending the two-day national symposium on canine cardiology said here.

"It is observed that cardiac disease is common in dogs whose life span ranges between 12 to 15 years. The cardiac issues often set in when the animal is barely five to six years of age. Bramhadev Pattnaik, dean of the Institute of Veterinary Science and Animal Husbandry (IVSAH) under SOA deemed uni-

versity here, said Wednesday. What is required is timely diagnosis and pet owners need to observe whether their dogs are showing signs of fatigue, are unable to walk properly, refusing food or not responding to the owner's commands, he said.

Since it is difficult to ascertain whether a pet dog has cardiac problems, it is required to get the animal go through regular cardiac health check-ups. New diagnostic techniques could be used to identify the problem, he said. "Even dogs have pacemakers these days," he said speaking of advancement in techniques.

Y Vijay, said there is need to raise awareness about the subject and owners of dogs have to understand their pets' symptoms.

Scientists identify paths for reducing air pollution in India

esearchers have evaluated the contribution of various emission sectors and fuels to small particulate matter (PM2.5) for 29 states in India and six surrounding countries, identifying potential pathways to reduce air pollution and improve population health across South Asia.

The results, published recently in the journal Environmental Science & Technology, identify primary organics—organic particles emitted directly into the atmosphere from various sourcesas the main drivers of high concentrations of PM2.5 in these countries.

PM2.5 are fine inhalable pollution particles, with diameters that are generally 2.5 micrometers and smaller.

'Countries in South Asia have substantial emissions and associated air pollution and mortality burden," said study first author Deepangsu Chatterjee, a doctoral student at Washington

University in St. Louis, US.

'Our study shows that over 1 million deaths in South Asia attributable to ambient PM2.5 in 2019 were primarily from residential combustion, industry and power generation, Chatterjee said

The study found that solid biofuel is the leading combustible fuel contributing to the PM2.5attributable mortality, followed by coal and oil and gas.

"Air pollution, both indoors and outdoors, is the leading risk factor for death in South Asia," said study co-author Michael Brauer, professor at the University of Washington and the University of British Columbia, Canada. "Understanding the major contributing sources is a critical first step towards management of this serious problem," Brauer said.

A major challenge in evaluating the impacts of PM2.5 is to understand how it is produced and distributed over time.



The researchers combined global emission inventories. satellite-derived fine surface particulate matter estimates and state-of-the-art global scale modeling capabilities to develop regional simulations

They also accounted for longrange transport to understand how different emission sectors and fuels contributed to PM2.5 and associated mortality rates "Advances in modeling at-

mospheric composition with constraints from satellite remote sensing enabled our assessment of the sources of PM2.5 across South Asia," said Randall Martin from the Washington

Chatterjee also noted that PM2.5 mass composition in South Asia is driven by primary organics across major contributing sectors.

A few other notable features include high contribution from coal in central and eastern India, higher household air pollution in north-east and central India, biofuel contributions in Bangladesh and open fires in Myanmar, the researchers said.

"This study shows that the air pollution problem in South Asia is not just an urban scale problem, so policies targeted at urban scale development will not be enough to mitigate the national level PM2.5 exposure," Chatterjee said.

The researchers suggest several strategies for future interventions throughout South Asia, including policies encouraging the replacement of traditional fuel sources with sustainable sources of energy.

Prime accused Gopal produced in court

Jharsuguda, July 13: Mystery continues to shroud the murder case of former state health minister Naba Kishore Das as Crime Branch sleuths produced the sacked police SI Gopal Das in the JMFC court at Jharsuguda,

Gopal Das is the prime accused in the case. Police brought Das to Jharsuguda from Choudwar Circle Jail in Cuttack under tight security, Wednesday and produced him in the court, Thursday

The JMFC court heard the matter for 10 minutes and transferred the case to District & Sessions Judge Court, Jharsuguda. It was learnt that the state Crime Branch will soon file the chargeframe in the case before the District Judge, Jharsuguda. On the other hand, accused Gopal agreed to contest



the case in coming days before the judge. The defendant's lawyer Dayanidhi Chand said that the sacked SI Gopal was produced in the JMFC court where he expressed his interest to fight the case in coming days before the magistrate, Thursday.

The JMFC court has transferred the matter to the court of district judge and a copy of the

chargesheet has been given to the accused SI. The hearing in the case will start after the charge-

frame in the case. Meanwhile, 166 days have passed since the incident but the Crime Branch is vet to unravel the mystery behind the murder. The chargesheet mentions that the accused SI murdered Naba Das over personal

reason but the Crime Branch has failed to clarify as to why a police SI thought of killing a person who was then the state's health minister

The Crime Branch submitted the 534-page preliminary chargesheet at Jharsuguda JMFC Court in the Naba Das murder case, May 26. The agency had prepared the chargesheet on the basis of the statements recorded by 89 witnesses including IO Ramesh Dora, DSP of the Crime Branch, and reports of the scientific team.

While the college authorities have termed the girl's death as suicide, family members cried foul alleging that she was forced to commit suicide due to mental pressure and torture by college authorities.

The case was registered against warden Chandrika after senior police officials intervened over a complaint filed by Manoj Kumar Mohanty, uncle of the deceased.

Family members have expressed their resentment over the case being registered against only the hostel warden while excluding the name of the college

Righting Past Wrongs

t long last, European countries have begun to grapple with their colonial legacies. In the Netherlands, the government has issued lan apology for the country's role in the global slave trade, and the king has "asked for forgiveness." The United Nations Special Rapporteur on the Rights of Indigenous Peoples has urged Denmark to "address the negative impacts" of its colonisation of Greenland. And in the United Kingdom, media outlets, the Church of England, and cities like Manchester have acknowledged the hard truth: their wealth and power were built on the backs of enslaved people.

While these efforts are rightly recognised as historic, they have also been criticised for a lack of consultation with affected communities and an apparent reluctance to provide meaningful reparations. In fact, these statements and apologies often sidestep the question of what reparations should entail, rendering them toothless gestures of pseudo-ac-

To be sure, the discussions such public apologies spark help raise the public's awareness about the horrors of colonialism. The conversations they nurture are crucial, and the fact that they are occurring in Europe's most venerable institutions - royal palaces, museums, cen-

turies-old foundations, businesses, and media conglomerates – is a testament to the relentless efforts of organisers and communities to keep history from being swept under the proverbial rug.

But we must be wary of what Georgetown University's Olúfémi O. Táíwò calls "elite capture," whereby potentially transformative and liberating concepts are stripped of their radical content and appropriated by the political, social, and economic forces they target. In many ways, the reparations discourse is already being co-opted

While important, none of the recent acknowledgments and apologies seeks to tackle the living legacy of slavery, colonialism, imperialism, and the extractive capitalism that they underpinned. Official apologies can serve as a good starting point, but those in positions of power must not be permitted to use the process of reckoning with the atrocities of colonial plunder to evade real accountability.

Focusing solely on memorialising and apologising for historical injustices without acknowledging their enduring effects risks perpetuating structural inequalities. Colonialism undergirded the international economic order. The over-policing of Black youth, disproportionately high mortality rates among non-white mothers, workplace discrimination, migrants' limited access to social services, and the necrop

olitics of "Fortress Europe" are all part of the legacy of the racist imperialism upon which Europe's wealth was built.

To address these systemic injustices, we must recognise that the emphasis on financial restitution in current debates about reparations is a problem. If we are not careful, governments and institutions could use this money-centric definition of reparations as a cop-out. As we know from international law, countries often prefer to pay damages for their human-rights violations rather than take meaningful steps such as revising laws, policies, and practices

This is not to downplay the vital role of wealth redistribution in building a just world. But financial settlements that seek merely to placate those who call for justice are not the same as redistributive policies that target systemic inequality. So far, European governments and institutions have been more than eager to blur the distinction between the two.

As Esther Stanford-Xosei and the Pan-Afrikan Reparations Coalition in Europe have argued, the financial aspect of reparations "will be meaningful only if it serves the holistic purpose and strengthens the integral whole of our self-repair process." In other words, any form of reparations must enable communities to reclaim power, dignity, and stewardship over their shared wealth and resources. If reparations are solely focused on the past, we risk neglecting the present and weakening their emancipatory potential. A more historically informed approach would view reparations as part of a larger project.

Much like the broader struggle for racial, social, economic, and climate justice, the purpose of reparations is to help build a more equitable world. The transition to such a world will not be costless and will undoubtedly require sacrifices. Reparations should ensure that these

costs are distributed fairly rather than provide a monetary band-aid. To bring about a more just future, we must first meet the most urgent needs of communities grappling with the lasting legacies of colonialism. This means dismantling the unequal power structures in our legal, education, health-care, and political systems, as well as our workplaces and public services.

By adopting a community-oriented approach to addressing structures of oppression, we can ensure that marginalised groups have equal access to essential public goods. But we must also be willing to challenge the inherently harmful and extractive systems that we often

Simply put, we can no longer accept that any framework, institution, or process that affects marginalised communities is established or operated without their meaningful participation. Rectifying historical injustices is not just about righting past wrongs. To create a more equitable society, we must also address colonialism's ongoing effects.

CYCLISTS TEND TO KNOW ABOUT THEIR NEIGHBOURHOOD BETTER, **PARTICIPATE IN A CIRCULAR ECONOMY AND SPEND MORE MONEY IN** THE LOCAL **ECONOMY**

√he harsh summer is over. We can assume the rest of the year is good for cycling in Bhubaneswar. Cycling is not only a healthy way of getting around, but also a very sustainable one. At the same time, cycling offers a plethora of benefits that are hard to deny. Cycling is one of the most complete exercises and brings health and economic benefits in any given city. Then, why don't more people bicycle to work? How do we make Bhubaneswar more appealing to cyclists?

New research found it has a lot to do with the cities in which people live. Even 20 minutes of cycling per day can increase the blood flow in the body and improve lung capacity. But we live in a city where many face obesity related complications, waiting for medical attention to deal with diabetics, blood pressure, depression. Many of have pedalled the last time decade ago or in their schools days, while an accessible and a cheap sport like cycling would have avoided their obesity.

Bhubaneswar now adding metro to its larger public transport system sounds great. But if expenses of one pillar of that metro get invested in cycling infrastructure then a substantial burden on metro would be taken by cycling. Cycling is always an affordable and safe mode of transport in Bhubaneswar when compared to other forms of mobility. Citizens looking to cut down on unnecessary costs can save a lot by running errands on their bicycle. Travelling by bicycle also helps reduce carbon

footprint.

Not everything starts and ends with good memories, there are some risks attached to cycling. Bhubaneswar residents lack cycling awareness, which means that drivers and pedestrians are often not aware of cycling laws and regulations, which leads to confusion. A lack of cycling infrastructure in Bhubaneswar, such as dedicated lanes, traffic lights, signage, and parking spaces, do substantially add up to the reasons why people stop choosing the bicycle as a mode of transport.

The COVID-19 pandemic has motivated many people throughout the world including Bhubaneswar to initiate cycling. New pop-up bicycle lanes came up in Paris, Milan, Mexico City, and countless other cities have

provided a safe space to try out this mode of transport. This drastically reduced risk of contagion. Even though Bhubaneswar didn't offer much benefit to cyclists with pop-up lanes research found restrictions in vehicular movement in major streets unofficially became pop-up lanes for cyclists that witnessed surge in cycling during the pandemic.

Bhubaneswar can take cue from car-free Sundays of Bogotá, Colombia, where one or several main streets remain closed to vehicular traffic on Sunday afternoons. Instead, the streets belong to pedestrians, cyclists, and all other kinds of non-motorised transport. Bogotá has also shown that cycling infrastructure can overcome class differences and improve the sense of community. This makes

cycling a democratic form of transport, while also being extremely sustainable.

Various researches has been proven cycling improves the health of citizens, reducing the chance of heart disease by as much as 52% and some cancers by up to 40%. Similarly, it reduces the risk of type-two diabetes and stroke, supports mental health, and increases happiness levels. Bhubaneswar can learn this from the Netherlands where more than 70% of children cycle to schools and it is no coincidence that they are among the happiest and healthiest children in the

Cyclists tend to know about their neighbourhood better, participate in a circular economy and spend more money in the local economy. Some people who don't ride a bicycle -- safety is their biggest concern. They were afraid of vehicles on the road and crimes.

If politicians, bureaucrats, engineers, and town planners want to increase the percentage of people living happily, then they must ensure commuting by bicycle is safe, should focus on protected bicycle lanes, bicycle paths, and bicycle parking just like they have for cars Such measures will ensure that Bhubaneswar takes care of its cyclists, Finally, Bhubaneswar needs to incentivise its citizens to take bicycle rather than car for 5 to 10 km trips. This will lead to a transformation towards a greener, healthier, and fairer mobility.

Chennai, July 13: The Tamil Nadu Water Resources Department has floated tenders for the restoration of the twin lakes in Chennai and the work is likely to commence by August.

The twin lakes, commonly known as Retteri, will be desilted and cleared of encroachments. A Department official said that an invasive species of water hyacinth which reduces oxygen supply and creates breathing difficulty for fish has occupied a large portion of the lakes.

The water hyacinth, according to the official, also acts as breeding ground for mosquitoes. The twin water bodies comprise the Madhavaram inlet channel and Manali lake and according to Department officials, an amount of Rs 44 crore have been sanctioned for the restoration work.

According to officials, a portion of the lake is occupied by 40 illegal structures and these have

to be removed first. On the western side, the Department will construct a wall for a distance of 3 km and to prevent garbage

Towards the eastern side, pillars will be installed and a fence erected. The water level in the twin water bodies is presently 32 million cubic feet and the Department will dig deep to increase the holding capacity to 45.13 mcft

One million liters of water a daywas pumped from the twin lakes by the Metrowater to its Kolathur plant and from their water supplied to the houses in the vicinity of the lake. However, this is not being done due to illegal encroachments and dumping of garbage in the lake.

Sources in the Department said that after the restoration work is completed water will again be pumped to the Kolathur plant and after treatment supplied to locals in the vicinity of





Delhi court convicts former MP Vijay Darda, ex-coal secv HC Gupta

New Delhi, Jul y13: A Delhi court Thursday convicted seven accused, including former Rajya Sabha MP Vijay Darda and excoal secretary H C Gupta in a case related to irregularities in the allocation of a coal block in Chhattisgarh.

In the 13th conviction in the coal scam, the scandal which rocked the erstwhile Manmohan Singh government, Special Judge Sanjay Bansal also convicted Darda's son Devender Darda, two senior public servants K S Kropha and K C Samria, M/s JLD Yavatmal Energy Pvt Ltd and its Director Manoj Kumar Jayaswal.

The court held the accused guilty of criminal conspiracy (punishable under Section 120-B of IPC) and cheating (punishable under section 420 of IPC), and under relevant sections of the Prevention of Corruption Act.

The judge will hear argument on quantum of punishment July 18. The court accepted the submissions made by senior Public Prosecutor A P Singh that the CBI was able to prove its case bevond all reasonable doubts.

Law Commission receives more than 50L responses

New Delhi, July 13: With the deadline to respond to the politically-sensitive issue of uniform civil code (UCC) ending Friday, the Law Commission has so far received over 50 lakh views online on the subject.

Besides online responses received on its website, the Commission has also received "hard copies", sources said Thursday, adding that the final number would be much higher. Some organisations have approached the law panel seeking personal hearing on UCC.

While it scrutinises the responses, it would take a call on inviting the organisations for a personal hearing, the sources said. On June 14, the Law Commission initiated a fresh consultation process on the Uniform Civil Code (UCC) by seeking views from stakeholders, including public and recognised religious organisations, on the politically sensitive issue.

Earlier, the 21st Law Commission, the term of which ended in August 2018, examined the issue and solicited the views of all stakeholders on two occasions. Subsequently, a consultation paper on "Reforms of Family Law" was issued in August 2018.

"Since more than three years have lapsed from the date of issuance of the said consultation

paper, bearing in mind the relevance and importance of the subject and also the various court orders on the subject, the 22nd Law Commission of India considered it expedient to deliberate afresh over the subject," the panel had said in a 'public no-

Appearing before a parliamentary committee earlier this month, representatives of the law panel had defended the fresh consultation exercise, noting that the preceding commission had brought out its suggestions in 2018 and its term had also come to an end. That is why, they have begun a fresh initiative which is essentially "informational"

In its consultation paper issued on August 31, 2018, the previous Law Commission headed by Justice B S Chauhan (retd) said while the diversity of Indian culture can and should be celebrated, specific groups or weaker sections of the society must not be "disprivileged" in the process.

It said the Commission dealt with laws that are discriminatory rather than providing a uniform civil code "which is neither necessary nor desirable at this stage". The consultation paper said most countries are now moving towards recognition of difference, and the mere existence of difference does not imply discrimination but is indicative of a robust democracy.

NCCF TO SELL **TOMATOES AT DISCOUNTED RATES IN NCR**

New Delhi, July 13: National Cooperative Consumers' Federation of India (NCCF) will kick start on Friday the sale of tomatoes via mobile vans in Delhi-NCR at a discounted rate of ₹90/kg to provide relief to the consumers, top government officials said Thursday.

In Noida, tomatoes will be sold at the NCCF office at Rajnigandha Chowk and also through mobile vans in Greater Noida and other locations, they said.

NCCF will start the sale in other cities such as Lucknow, Kanpur and Jaipur during the weekend, they added. Cooperative NCCF and NAFED have received a mandate from the central government to sell tomatoes as there has been a sharp rise in the retail prices of the key kitchen staple up to ₹224 per kg in several___ parts of the country.

Speaking with PTI, Consumer Affairs Secretary Rohit Kumar Singh said, "NCCF will start selling tomatoes at a discounted rate of ₹90/kg from tomorrow. A good quantity of supplies has been procured from the producing centres. The Centre is subsidising tomatoes by more than 30 per cent from the prevailing market rates to provide relief to the consumers, he said.

Elaborating on the retail operation, NCCF Managing Director Anice Joseph Chandra said, "We have fixed the price at ₹90 per kg, while the procurement rate is ₹120-130 per kg. The losses will be absorbed by the central government.

In Delhi, NCCF will start the sale Friday morning at 11AM in all 11 districts through 30 mobile vans. About 17,000 kg of tomatoes will be sold on the first day, she said. On Saturday, NCCF plans to

sell about 20,000 kg of tomatoes and the quantity will be increased to 40,000 per day as the sale picks up, she added

ISRO aims to master soft landing on lunar surface

Sriharikota (AP), July 13: As the scientific community is waiting with bated breath aiming for the successful third edition of India's moon mission, Chandrayaan-3 Friday, here is a quick look at how the country's lunar expedition evolved over the years.

The Chandrayaan programme was conceived by the Government of India and formally announced by former Prime Minister, the late Atal Bihari Vajpayee August 15, 2003.

Subsequently, the hardwork of the scientists paid off when the maiden mission onboard lifted off October 22, 2008.

According to the Indian Space Research Organisation, PSLV-C11 was an updated version of the standard configuration of a PSLV. Weighing 320 tonnes at lift-off, the vehicle used larger strap-on motors to achieve higher payload capability.

It carried 11 scientific instruments built in India, the United States of America, the United Kingdom, Germany, Sweden, and Bulgaria. Noted scientist Mayilsami Annadurai from Tamil Nadu led the project as the Mission Director of the Chandrayaan-1 mission.



12 killed, 5 injured

Islamabad: At least 12 Pakistani soldiers were killed and five injured in separate encounters with militants in the country's Balochistan province, the Army has said, the heaviest single-day loss suffered by the military in the restive region. The attacks occurred on Wednesday in the Sui and Zhob areas of the province, the Inter-Services Public Relations (ISPR) - the Army's media wing-said in a statement. At least seven militants were also killed in the two encounters. Unidentified gunmen attacked security forces conducting an operation in Sui, killing at least three soldiers and injuring five.

UK visa fees, health surcharge to rise

London: The fees and health surcharge paid towards the UK's state-funded National Health Service (NHS) by visa applicants from around the world, including Indians, are set to rise "significantly" to meet the country's public sector wage increase, Prime Minister Rishi Sunak said Thursday. The British Indian leader, who was under pressure to accept the recommendation of an independent review of pay for teachers, police, junior doctors and other public sector workers, confirmed a hike between 5 and 7 per cent across the board. However, he stressed that this would not be met with higher government borrowing for fear of further stoking high inflation and therefore the costs would need to be found elsewhere.

Kim vows to boost nuclear capability

Seoul (South Korea): North Korean leader Kim Jong Un vowed to further bolster his country's nuclear fighting capabilities as he supervised the second test flight of a new, powerful intercontinental ballistic missile designed to strike the mainland United States. state media reported Thursday. Kim's statement suggested North Korea would ramp up weapons testing activities to expand its arsenal in response to recent US steps to enhance its security commitment to ally South Korea.

Harris sets another record in US history

Washington, July 13: Kamala Harris has set another record in US history when she matched a 191-year-old record of casting tie-breaking votes as a vice president and backed the nomination of Indian-origin Kalpana Kotagal to be a member of a fed-

Harris, who made history as the first woman or person of colour in 2020, equalled the record held by Senator John C Calhoun, a Democratic-Republican who served as vice president to John Quincy Adams and Andrew Jackson from 1825 to 1832.

On Wednesday, Harris, 58, cast her vote on cloture for the nomination of Kotagal, a diversity, equity, and inclusion expert to serve as a member of the Equal Employment Opportunity Commission. The US Equal **Employment Opportunity** Commission is responsible for enforcing federal laws that make it illegal to discriminate against a job applicant or an employee because of the person's race, colour, religion, sex, national origin, age (40 or older), disability or genetic information.

Harris broke a 50-50 tie on a vote in the Senate on the nomination of Kotagal, to bring her total of tie-breaking votes cast as vice president since she assumed office to 31. That matches the record set by Calhoun, a Democratic-Republican and an avowed proponent of states



20 drones shot down over Kyiv

Kyiv, July 13: Ukrainian officials said air defences shot down 20 Iranian-made drones fired by Russia mostly at the Kyiv region early Thursday, but wreckage fell on four districts of the capital, wounding two people and destroying several homes.

The latest barrage by the Kremlin's forces began shortly after midnight, and explosions shook different parts of the city. Two people were hospitalised with shrapnel wounds, authorities said. In the capital, rescuers extinguished a fire in a 16-story building, as well as in a non-residential building, the Interior Ministry said. Debris also smashed into the frontage of a 25-story apartment building, it said.

Russian strikes have become a grim part of everyday life in Ukraine over the almost 17 months of the war. Meanwhile. a senior officer leading Russian forces against Kyiv's recent counteroffensive in southern Ukraine, Lt. Gen. Oleg Tsokov, was reportedly killed by a Ukrainian missile strike.

Tsokov died when the Ukrainian military struck the city of Berdyansk on Tuesday with UK-supplied Storm Shadow missiles, according to retired Gen. Andrei Gurulev. who commanded the 58th Army in the past and currently serves as a lawmaker. Russia's Defense Ministry hasn't reported Tsokov's death.

Thailand's Pita defeated in parliament in bid for PM



Bangkok, July 13: Thailand's Pita Limjaroenrat failed Thursday in his initial bid to become Thailand's next Prime Minister, after he was thwarted in a high-stakes parliamentary vote that included a host of no-shows and nearly 200 abstentions.

The leader of election winners Move Forward was unopposed in the contest but struggled to muster the required support of more than half of 749-member the bicameral parliament. despite the backing of his eightparty alliance.

Another vote is expected to

be held next week, which Pita can contest if nominated again. The progressive Move Forward party and its alliance partner, Pheu Thai. thrashed conservative promilitary parties in the May 14 election, seen widely as a resounding rejection of nearly a decade of government led or backed by the royalist military.

Thursday's vote was a critical test of Pita's political clout and a gauge of the opposition to his party's anti-establishment agenda, which includes removing the military from politics, curbing business monopolies and amending a law that prescribes long jail terms for insulting the monarchy.

His defeat was the latest blow in a torrid two days for the 42year-old, U.S.-educated Pita, who saw two legal complaints against him gain momentum on the eve of the vote, including a recommendation to disqualify him, prompting hundreds of demonstrators to gather and warn of moves afoot to keep Move

Thursday. According to "credible information" obtained by the UN Human Rights Office, the bodies of the 87 people, some of whom belong to the ethnic African Masalit tribe, were dumped in a one-metre (around three-foot) grave just outside the West Darfur city of Geneina.

The first 37 bodies were buried on June 20, the UN agency said in a statement from Geneva. The next day, another 50 bodies were dumped at the same site. Sudan has been rocked by violence since April 15 when tensions between the military and the paramilitary Rapid Support Forces erupted into open fighting.





TESLA IN TALKS TO SET UP FACTORY TO MAKE ABOUT HALF MILLION EVS ANNUALLY IN INDIA

Bangalore, July 13: Tesla is discussing an investment proposal with the Indian government to set up a factory with an annual capacity to produce about half a million electric vehicles. reports said Thursday, citing government sources.

The company, led by billionaire Elon Musk, is also looking at using India as an export base to ship cars to countries in the Indo-Pacific region, the re-

The starting price for the vehicles will be ₹20 lakh (\$24,400.66), the report added, which is more than double of India's cheapest EV, MG Comet, and ₹5 lakh costlier than Tata Nexon EV, the topselling electric car in the country.

Last year, Tesla's India entry plans were stalled after the country's government refused to lower import taxes on its cars. The country levies as much as 100% import tax on electric vehicles.

India was keen for Tesla to manufacture vehicles locally, but the company said it wanted



to export its cars first to the country so that it could test the strength of demand.

In renewed efforts to enter the domestic market with a change of stance, Tesla held discussions in May with officials about incentives being offered by the government for its cars and battery manufacturing.

The Indian commerce and industry ministry is leading the talks this time and hopes to put together a "good deal", while maintaining a level-playing field as talks now involve both local manufacturing and exports.

India's finance ministry is not considering any duty waivers for Tesla. Revenue Secretary Sanjay Malhotra told Reuters

In the past, talks between the U.S. carmaker and the Indian government have involved seeking customs duty waivers for importing its electric vehicles. which was rejected by India.

Last month, Tesla CEO Elon Musk said Indian Prime Minister Narendra Modi was pushing the car maker to make a "significant investment" in the country, adding that such an announcement was expected soon.

DOMESTIC AIRLINES REGISTERED AN ANNUAL GROWTH OF 32.92% AND MONTHLY GROWTH OF 18.78% DURING JAN-JUNE

New Delhi, July 13: Passengers carried by Indian domestic airlines during January-June 2023 $\,$ were 760.93 lakh, as against 572.49 lakh during the corresponding period of 2022, Directorate General of Civil Aviation (DGCA) said.

Earlier June 15, DGCA data said that during January-May 2023, the passengers carried by Indian domestic airlines were 636.07 lakh, as against 467.37 lakh during the IndiGo leads in corresponding pe-

riod of 2022. by Air India, AirAsia May, 132.14 lakh passengers were India, Vistara, Akasa Air lakh passengers carried by Indian and SpiceJet in June domestic airlines. They registered

an annual growth of 36.10 per cent and monthly growth of 15.24 per cent.

The overall cancellation rate of scheduled domestic airlines for the month of May 2023 was just 0.44 per cent. It is to note that Go First stopped operations May 3.

During May 2023, a total of 556 passenger-related complaints were received by the scheduled domestic airlines. The number of complaints per 10,000 passengers carried for the month of May 2023 was 0.42.

The country's domestic air passenger traffic grew 18.78 per cent to around 1.25 crore in June compared to the year-ago period, according to official data released Thursday.

In June, IndiGo, Air India, Vistara, AirAsia India and Akasa Air saw an increase in their respective market share amid the grounding of budget carrier Go First. However, SpiceJet's market share continued to decline and fell to 4.4 per cent last month whereas it stood at 7.3 per cent in January this year.

'Foxconn backing out of chip JV credit negative for Vedanta'

Chennai, July 13: A decision by Taiwan's Foxconn to withdraw from a \$19.5 billion semiconductor joint venture with Vedanta is a "credit negative" for the Indian conglomerate's UK parent Vedanta Resources, debt research firm CreditSights said Thursday.

Earlier this week, Foxconn said it had withdrawn from the JV, dumping a deal they had signed last year to set up semiconductor and display production plants in India. Vedanta Wednesday said it would still enter the space this year having lined up partners.

CreditSights had previously expected a "minimal credit impact" on Vedanta Resources based on the old arrangement, as Volcan, Vedanta's holding entity was undertaking the semiconductor investments.





Women wrestlers write to PM, IOA, SAI demanding fair **Asian Games trials**

New Delhi, July 13: Several women wrestlers, including winners from Commonwealth Games and Asian Championship, Thursday wrote to Prime Minister Narendra Modi, the Indian Olympic Association (IOA) and the ad-hoc panel running the WFI, requesting "fair trials" for Asian Games amidst reports that the six protesting grapplers may be given exemption.

The 24 women wrestlers from Sir Chhotu Ram Akhada in Rohtak, who also wrote to SAI Director General Sandeep Pradhan, have conveyed that they won't accept two-stage trial or any another relaxation given to the protesting grapplers.

The IOA-appointed ad-hoc panel has announced that Asian Games trials will be held July 22-23 but did not reveal the criteria. The wrestlers are even preparing to hit the roads for a fresh protest and approach the judiciary if any discriminatory decision is taken by the IOA adhoc committee.

Panel head Bhupender Singh Bajwa had June 16 conveyed to the six protesting wrestlers -Bajrang Punia, Vinesh Phogat, Sakshi Malik, Sangeeta Phogat, Satvawart Kadian and Jirender Kinha – that they will have to compete in just one final bout against the winners of the initial trials.

According to sources, the ad-hoc panel is deliberating over a criteria which will exempt current Olympic and World Championship medallists from the trials, which will benefit Bajrang, Vinesh and Ravi Dahiya. The IOA has to submit the names of the participating wrestlers by July 23.

"Even if only three Olympians were to be given concessions, this would be wrong to the youngsters," the wrestlers said in the letter that was also marked to Home Minister Amit Shah and Sports Minister Anurag Thakur.

ASIAN ATHLETICS CHAMPIONSHIPS

Yarraji 1st Indian to bag eves' 100m hurdles gold

Bangkok, July 13: India bagged three gold and two bronze medals on the second day of the Asian Athletics Championships with Jyothi Yarraji becoming the first from the country to secure top podium finish in women's 100m hurdles in the continental showpiece here Thursday.

The 23-year-old Yarraji opened India's gold medal account in the championships as she clinched her maiden yellow metal in a major international event.

Ajay Kumar Saroj ran a brilliant tactical race to win the men's 1500m gold before Commonwealth Games silver medallist Abdulla Aboobacker added a yellow metal for the country by clinching the men's triple jump event. It was an impressive show by the Indians as they won three gold medals out of 10 on offer Thursday.

Quartermiler Aishwarya Mishra (53.07 seconds) and Tajaswin Shankar were the other medal winning Indians on the day, with a bronze in women's 400m final and gruelling men's

In fact, it was the maiden international medal for both Aishwarva and Teiaswin in the senior level in their respective events, competing in their maiden international event. Tejaswin had won a high jump bronze in the Commonwealth Games but had taken up to decathlon last year

It was a close 100m hurdles for Yarraji as she clocked 13.09 seconds ahead of two Japanese runners Terada Asuka (13.13s) and Aoki Masumi (13.26s) on a rain-drenched track at the Supachalasai Stadium. The event had long been dominated by the Japanese and Chinese in the championships.

Yarraji's national record stands at 12.82 seconds. She had won gold in the National Inter-State Championships last month in 12.92 seconds but the wet track, after rain lashed the stadium, was not ideal for a fast time.

In the men's 1500m, the 26year-old Saroj ran a brilliantly executed race as he came out of nowhere in the final bend to go past two opponents and win the gold. He clocked 3:41.51 seconds, two and half seconds outside his personal best of 3:39.19 which he had recorded last month in an event in USA.

It was the third medal on the trot and second gold for Saroj, who had trained in the USA in May, in the Asian Athletics Championships. He had won gold in the 2017 edition in Bhubaneswar and silver in 2019

For Aboobacker, it was his season's best effort of 16.92m that fetched him the gold, ahead of Ikehata Hikaru (16.73m) of Japan and Jangwoo Kim (16.59m) of Korea. The 27-year-old began with a foul but cleared 16.92m in his fourth attempt for the gold.

Vondrousova ends Svitolina run

Czech's bid to become 1st unseeded woman to claim Venus Rosewater Dish continues

London, July 13: Czech Republic's Marketa Vondrousova showed there was no room for any gushing sentiment as she ended the remarkable run of new mum Elina Svitolina with a 6-3, 6-3 victory to reach the Wimbledon final for the first time Thursday.

In the run-up to a first All England Club women's semifinal featuring two unseeded players, Vondrousova said the Ukrainian was "incredible", "amazing", "a fighter" and "a superwoman" for reaching the last four of a Grand Slam nine months after giving birth to daughter Skai.

But that did not stop Vondrousova ending Svitolina's dreams and she now stands one win away from completing her own phenomenal comeback story after two wrist surgeries following her runner-up finish at the French Open in 2019.

"I cannot believe it. I am very happy that I made the final. Elina is such a fighter and a great person. It was a tough match. I am very happy," said Vondrousova.

She will be bidding to become the first unseeded woman to lift the Venus Rosewater Dish when she faces Tunisian sixth seed Ons Jabeur in Saturday's final.

EQUAL PRIZE MONEY FOR MEN, **EVES AT ICC'S GLOBAL EVENTS**

Durban, July 13: The ICC Thursday announced equal prize money for men's and women's teams at its global events in a bid to bring in pay parity, ushering in a new era in world cricket. In the last 50 over men's World Cup, champions England got USD 4

million and runners-up New Zealand received USD 2 million.

'The International Cricket Council (ICC) today announced equal prize money for men's and women's teams at ICC events. The decision was taken at the ICC Annual Conference in Durban, South Africa and ensures the ICC Board fulfilled its commitment to reaching prize money equity by 2030 well ahead of sched-

ule," the ICC said in a statement. "Teams will now receive equal prize money for the equivalent finishing position at comparable events as well as the same amount for winning a match at those events," it further stated.

Belleville en Beaujolais (France), July 13: Ion Izagirre gave his Cofidis team, and Spain, their second victory in this year's Tour de France when he won the 12th stage after a late, brutal attack Thursday.

The Basque rider went solo in the last short climb of the day, 30km from the finish, and never looked back to claim a second career Tour stage win.

Izagirre, who won the 20th stage of the Tour in 2016 in Morzine, is the second Spanish rider to win this year after Pello Bilbao Tuesday and the second for the Cofidis team after Victor Lafay in the second stage. Spain had not won a Tour stage since 2018 and French
