Sepoy on Srimandir duty suspended over bribery for 'darshan'

Puri, July 22: At a time when devotees are only allowed to enter Srimandir through Singhadwar, the eastern gate, a sepoy of Indian Reserve Battalion-3, Koraput was suspended Saturday for receiving bribe from a devotee to facilitate darshan of deities at the Srimandir here.

The sepoy, identified as Subhasish Das, was suspended by Puri Superintendent of Police Kanwar Vishal Singh for dereliction of duty.

According to sources, Das, who was deployed at the western gate of the 12th century shrine, was seen receiving money from a devotee. The devotee, after having darshan, was seen handing over cash to Das at the western gate, the video of which has gone viral.

Meanwhile, questions are being raised on the policy of the temple administration as entry is restricted to Singhadwar only.

Additional SP Sushil Kumar Mishra has directed Srimandir security officer Koushik Nayak to conduct a detailed probe into the incident and submit

Now, CBSE pupils can learn in Odia

Bhubaneswar, July 22: In a major step taken in accordance with New Education Policy (NEP)-2020, the CBSE through a circular dated July 21 has allowed its affiliated schools to use their mother tongue language as an optional medium of instruction from pre-primary to Class XII in addition to other

existing options. Schools may explore the available resources, consult with experts in the field, and collaborate with other schools to share best practices to make multilingual education in CBSE schools a reality, the board said adding that the NCERT has taken this serious task on highest priority so that textbooks in 22 scheduled languages can be made available to all students from next session.

Notably, there are approximately 300 CBSE-affiliated schools across the state. Among those are the Odisha Adarsha Vidyalayas (OAVs), Jawahar Navodaya Vidyalayas (JNVs) and Kendriya Vidyalayas (KVs).

'Will enhance critical thinking of students'

nion Education Minister Dharmendra Pradhan Saturday said the decision of the Central Board of Secondary Education (CBSE) to use mother tongue as an optional medium of teaching up to Class XII will enhance critical thinking of the students. Citing an example, he said. "In Odisha, the CBSE school students can learn subjects like mathematics and environmental science in Odia language. Learning through Odia language will be an optional for the students in addition to Hindi or English." The main objective of the move is that the students learn the subjects properly without any doubt and language should not be a barrier in learning, Pradhan said.

cation and utilisation of mother tongue as a medium of instruction which include availability of skilled teachers capable of teaching multilingual subjects, the creation of high-quality multilingual textbooks and time limitation, especially in two-shift government schools. According to some CBSE-affiliated schools' authorities, the move, despite seeming problematic initially,

will help the students to a great extent in the long run, especially those kids who face difficulty while being taught in English

or Hindi medium. Principal Kasturi Khadanga of Dream India School in Cuttack's Netaji Nagar said, "The move is in line with the NEP-2020 objective of giving regional languages a boost. This will not be very difficult as teachers in the schools are able to deliver classes in both English and Odia. However, children who want to be taught in Odia must make it clear during admission process.

Ipsita Das, principal of DAV Public School at Unit-8 in Bhubaneswar said that not all students are bound to choose Odia as their medium of learning. Only those who want to take classes in Odia will be given the chance to study in their mother tongue. However, there is a need of discussion with the parents before implementing this move, she added. Odisha Parents' Association was of the opinion that the decision is easier said than done. However, it may also prove to be a boon for the children who are weak in English. P3

SHORT TAKES

Survey for error-free electoral roll begins

Bhubaneswar: A month-long survey in order to prepare an error-free electoral roll ahead of the General Election next year started across Odisha. State Chief Electoral Officer NB Dhal said the survey which started from July 21 will continue till August 21 next month all over Odisha covering all 30 districts and 147 Assembly constituencies. Over 37,606 Booth Level Observers (BLO) will conduct door-to-door surveys for a month. The main purpose of the survey is to enlist eligible voters and remove errors from the Electoral Rolls, he said.

Russian strikes kill at least 8 civilians

Kyiv: Russian attacks on 11 regions across Ukraine overnight killed at least eight civilians and wounded others, authorities said Saturday, as fierce fighting continues in Ukraine's attempts to dislodge Russian forces from territory they have occupied. The regional prosecutor's office in the eastern Donetsk region said that at least four people, including a married couple, were killed as Russian forces Friday night shelled the settlement of Niu-York. Also Saturday morning, Ukraine's interior ministry said that two civilians died as Russian forces Friday struck Kostiantynivka, a city in the Donetsk region, from multiple rocket launchers.

MANIPUR SHAME

Oppn MPs to press for PM's statement

New Delhi, July 22: Amid the stalemate in Parliament over holding a debate on Manipur violence. MPs of various opposition parties have planned a protest Monday near Mahatma Gandhi's statue in the Parliament complex to press for the prime minister's statement on the issue in both houses.

Sources said leaders of various opposition parties who have now formed the INDIA alliance will meet in the chamber of Leader of Opposition in Rajya Sabha Mallikarjun Kharge and will discuss their further strategy in Parliament.

After the meeting at 10am Monday, July 24, the leaders will hold a protest near the Gandhi statue before entering both houses.

The government has agreed to hold a short-duration discussion on the Manipur issue with the Home Minister replying to it, but the opposition is adamant on its demand for the prime minister's statement first, especially after a video of two women being paraded naked and assaulted in a Manipur village appeared on social media.

Also, the opposition wants a debate allowing all parties to speak without any time restrictions and has been holding protests on the issue since the Monsoon

They also added that strict security measures have been taken in all vulnerable locations of the state, which has been on the boil since May 3. Earlier in the day, a 19-year-old man was arrested.

position of running away from a debate on the all-important issue and has questioned their seriousness towards it.

Both Lok Sabha and Rajya Sabha have failed to transact any business amid the stalemate between the opposition and the government over the Manipur issue.



Batagai (Russia), July 22: Stunning drone footage has revealed details of the Batagaika crater, a kilometre-long gash in Russia's Far East that forms the world's biggest permafrost crater.

In the video two explorers clamber across uneven terrain at the base of the depression, marked by irregular surfaces and small hummocks, which began to form after the surrounding forest was cleared in the 1960s and the permafrost underground began to melt, causing the land to sink.



NAVEEN REPLACES BASU AS 2ND LONGEST-SERVING CM

Bhubaneswar, July 22: Odisha's Naveen Patnaik Saturday became the second longest-serving Chief Minister in the country, replacing West Bengal's Jyoti

Former Sikkim Chief Minister Pawan Kumar Chamling still holds the record of being the longest-serving Chief Minister in the country. He was the Chief

Minister of the Himalayan state from December 12, 1994 till May 27, 2019 - more than 24 years.

Patnaik, the five-time Chief Minister of Odisha, took charge March 5, 2000, and holds the post for 23 years and 138 days.

Basu served as the Chief Minister of West Bengal from June 21, 1977 to November 5, 2000, which was 23 years and 137 days. Patnaik is also the third leader after Chamling and Basu to become the Chief Minister of a state for five consecutive times. If the ruling BJD wins the 2024 elections, Patnaik will be the longest-serving Chief Minister in India.

BJD vice president Prasanna Acharya said, "We are happy that our Chief Minister has crossed the record of West Bengal's former CM Jyoti Basu. I am sure that Patnaik will break all the records of the past, and will emerge as the longest-serving CM."

Congress leader Santosh Singh Saluja said, "We congratulate Naveen Patnaik for becoming the second-longest-serving CM, but we are pained that Patnaik is not doing anything during his term."

Senior BJP leader Suresh Pujari said history will not remember how long one serves as the Chief Minister, but how one creates history within a short span of time.

Bhubaneswar, July 22: The state government's own revenue collection till June 30 of financial year (FY) 2023-24 has dipped by 2.39 per cent as compared to the revenue collected during the same period of the last fiscal.

According to official sources, the state government has generated ₹22,780.70 crore revenue during the first quarter of the current fiscal. The revenue generation has come down due to a contraction in mining royalty collection.

The own non-tax revenue collection has witnessed a contraction of 18 per cent during the first quarter of this year as compared to the previous year. The sources also said that total own non-tax revenue collection stood at ₹10,658.55 crore till June 2023 as against ₹13,040.65 crore during the corresponding period of the previous year. This contraction is primarily because of a shortfall in mining revenue, the sources said.

Mining revenue has decreased by 15.33 per cent during the first three months of FY 2023-24.

However, total own tax revenue of the state government has registered a growth of 17.73 per cent upto June of the current financial year as against the same period of last fiscal.

Man arrested with deer, leopard hides

Bhubaneswar, July 22: The Special Task Force (STF) of Crime Branch has arrested one wildlife criminal and seized three leopard hides, as many deer skins, and other incriminating materials from his possession during a raid near Madanpur Rampur in Kalahandi district here, police said Saturday.

The accused has been identified as Khageswar Putel, 56, of Gunangbeda area under M Rampur police limits.

Following a tipoff, the STF sleuths with the help of local police carried out raided Sripali Chhak on Madanpur Rampur-Narla State Highway-6A and arrested the accused wandering there suspiciously. The cops later recovered three leopard hides and three deer skins and

other incriminating materials during the When asked, the accused failed to produce any official document in support of his possession of the prohibited wildlife parts. The cops Saturday arrested the accused by registering a case (14/23) under sections 379, 411, 120(B) of the IPC and 51 of the Wildlife (Protection) Act, 1972. He was produced before a local court that later

sent him to judicial custody. "The skins will be sent to Director, WII, Derhadun for biological examination. Investigation is going on," STF stated in a press note here

TEACHERS, STUDENTS

Bhubaneswar, July 22: In a major move to promote multilingual education, the Central Board of Secondary Education (CBSE) has allowed schools to offer education in 22 scheduled Indian languages, including Odia.

Currently, in majority of CBSE affiliated schools the medium of instruction is English and, in some, Hindi.

OrissaPOST spoke to teachers, students and parents about the possible impact of the CBSE move on education.

Welcoming the CBSE initiative, Principal of SAI International School, Nilakantha Panigrahi said the introduction of regional languages at school level will make education more accessible to all. 'Learning in one's regional language can enhance communication and it will constrict language barrier in learning which is prevalent at present. This can foster a more conducive learning environment, leading to increased participa-

tion and engagement. Moreover, he said it will help in cognitive development of students, improve their problem-solving skills and creativity. It will also reduce dropout rates in rural

areas and improve retention rate. raising the literacy rate in India.


Poly Patnaik, founder and principal of Mother's Public School, said that the decision will be helpful in imparting education properly to students as they will be able to understand and gain knowledge if they get it in their own language, "Students in rural Odisha will stand benefitted," she added.

Educationist and chairman of Odisha Parents Federation, Basudev Bhatta said the CBSE step will help in improving the level of education. He added that the state government must take steps to help all block-level schools to get CBSE affiliation so that the students get NCERT textbooks in their own language.

Meanwhile, Awdhesh Kumar Sahu, a Class XI student, said multilingual study is a positive step. "Obviously it is good for those who are not comfortable in English," he said.

Sneha Priyadarshini, a Class X student, said education in multiple languages is good for the growth of students.

Sujata Subudhi, a parent, said the system will help in improving Odia oration of students who otherwise struggle to speak in their own state language fluently.

People with heart disease suffer from sleep problems

fect the production of the Lsleep hormone melatonin in the brain, are the major reason why people with cardiac problems find it hard to sleep, ac-

cording to a research. Around one third of people with heart disease suffer from sleep problems such as sleep apnea, insomnia, waking up throughout the night and restless legs syndrome.

The study led by a team from University of Munich (TUM) in Germany showed that heart diseases affect the production of the sleep hormone melatonin in the pineal gland, located inside the brain. The link between the two organs is a ganglion in the neck region. Melatonin is produced in the

pineal gland. Like the heart, it is controlled through the autonomic nervous system, which regulates involuntary processes in the body. The related nerves originate in the ganglia, among other places. Particularly important for the heart and pineal gland is the superior cervical

ganglion. 'To get a clear sense of our results, imagine the ganglion as an electrical switch box. In a patient suffering from sleep disturbances following a heart disease, you can think of a problem with one wire causing a fire to



break out in the switchbox and then spreading to another wire," said Stefan Engelhardt, Professor of Pharmacology and Toxicology at TUM. The team discovered that macrophages -- cells that eat dead cells - accumulate in the cervical ganglion of mice with heart disease.

These cause inflammation and scarring in the ganglion and the destruction of nerve cells. In mice, as in humans, long fibres extending from these nerve cells, called axons, lead to the pineal gland. At advanced stages of disease, there was a substantial decrease in the number of axons connecting the gland to the nervous system.

There was less melatonin in the bodies of the animals and their day/night rhythm was disrupted.Comparable organic effects were seen in humans. The team investigated the pineal glands in nine heart patients. Compared to the control group, significantly fewer axons were

As with the mice, the superior cervical ganglion in the humans with heart disease showed scarring and was noticeably enlarged. The researchers assume that the negative effects of the dead axons become permanent at an advanced stage.

"In an early stage we were able to return melatonin production in mice to the original level by using drugs to destroy the macrophages in the superior cervical ganglion," said first author Dr Karin Ziegler,. "First, this demonstrates the role of the ganglion in this phenomenon.

And second, it inspires hope that we can develop drugs to prevent irreparable sleep disturbances in heart disease." The researchers believe the study shows new hope for a large number of heart patients that a treatment will be found for sleep disturbances and that ganglia could become important from a diagnostic standpoint.

Talcher, July 22: A public hearing camp for environmental clearance on expansion of Bharatpur Opencast Project (OCP) of Mahanadi Coalfields Ltd (MCL) under Talcher coalfields in Angul district was held at Jagannath Kalakendra here,

Angul ADM Rajanikant Singh presided over in the meeting and the affected villagers of Nakeshpasi, Niladripur, Satyabadipur,

Kishorechandrapur, Sarang, Tileipasi, Khajuria, Prasannagar, Solada, Danra, Joragadia (partial) and Khurian (partial), public representatives, local intelligentsia and members of various voluntary outfits attended the meet and voiced their opinions on the mine expansion.

The villagers and various stakeholders expressed their support to the expansion of the mines while a few apprehended that it might affect the environment. However, majority of the villagers supported the project as it is believed to create employment opportunities in the region. They requested the authorities to ensure that the expansion does not affect the environment and take step to resolve the education, drinking water, rehabilitation and resettlement issues.

The MCL in a press release said that the Bharatpur opencast mine will be expanded to 1556.94 hectares from its lease area of 972.42 hectare. The annual production capacity of the mines will increase to 20 million tonne after acquisition of an additional 629.52 hectare of land.

The project will create direct employment opportunities for 490 people and indirect opportunities for 1,600, claimed the authorities

Jajpur, July 22: In order to alert people in advance about flood, the state water resources department will build 14 more forecasting systems in Baitarani and Budhabalanga rivers, a report said.

Six systems will be built on the Baitarani river basin in Jajpur and Bhadrak districts while eight will be in place on the Budhabalanga river basin spread in Balasore and Mayurbhanj

Baitarani has a catchment area of 13,482 sq.km. The six automatic water level recorders (AWLRs) will be constructed at Akhua Biridi bridge in Jajpur district, Bankasahi, Pangata, Chandbali and Rajghat bridge in Bhadrak district and one at Jalasuan Patna station in Keonjhar district.

Similarly, eight AWLRs will be built on 4,838 sq.km catchment area of Budhabalanga at Nalua, Central Division, Betanoti, Suliapada, Jambhira, Barang side in Mayurbhanj district and at Kanshabansha and Totapada

stations in Balasore district. This World Bank aided project will be set up at a cost of ₹1279

As a result, the flood fore

casting systems when built will greatly help in flood management. Reports said that the state government had sanctioned ₹9.90 crore for the construction of the right embankment of Baitarani river from Ranpur to Mathurapur bridge while it sanctioned ₹8.80 crore for construction of the left embankment from Daspari to Astaka in

Bhdrak district. Earlier, it had sanctioned ₹9.96 crore for construction of embankment at Balarampur, Balipatna, Hemantpur to the right of Baitarani river. The three projects when completed will help in flood control in Korei and Dasarathpur blocks in Jajpur district and in Bhandaripokhari block of Bhadrak district, the water resources department said.

The flood in August 2020 was

one of the most severe ones in Baitarani and Brahmani rivers in the 21st century. This flood affected over 10 lakh people residing in 612 villages and one ward of 143 panchayats in all blocks and one municipality area in Jajpur district. As many as 25 breaches occurred and 12

ahead of every rainy season. On the other hand, the government has planned for integrated river management and construction of barrages but these are yet to be implemented.

The illegal sand mining and disposal of waste from mines and industrial firms is burying up the riverbed. The people of Jajpur and Keonjhar districts have been agitating to resolve the issues. The state government has constructed 210 km and 180 km of river embankments to the right of Baitarani River, to the left of Brahmani, Kharasrota and Budhabalanga rivers and to the right of Birupa river. However, it has failed to ensure that breaches do not occur on these embankments.

It is alleged that the Baitarani riverbed is shrinking as several developmental works have been undertaken on the river basin, which is in Jainur district.

Attack by smugglers leaves two excise sleuths critical

Man kills wife over trivial issue

Talagaon, July 22: A man axed his wife to death over a minor issue here in Boudh district, Saturday. The deceased was identified as

Dullabha Naik (37) of Gandapaju village under Talagaon panchayat of Harbhanga block.

As per the report, Dullabha requested her husband Kishori to go to the forest to bring bamboo so that she could make some handicraft items, as the couple makes a living by selling these crafts. However, the latter was reluctant, and an argument broke out between the two over the issue. Kishori suddenly lost his cool and assaulted his wife with an axe. Dullabha died on the spot.

Spotting the event, some villagers tried to overpower Kishori



but failed. Later, they informed the police. A team led by SDPO S Barala, Purunakatak IIC Jyotshna Kaunri, and Adenigarh police outpost in-charge Brahmananda Pradhan reached the spot and arrested the accused. Police seized the murder weapon and the body, which was sent to Boudh DHH for post-mortem. A murder case was registered.

The couple has a 17-year-old daughter and an 11-year-old son. The villagers demanded assistance from the administration for the children who became helpless following the incident.

Delayed restoration of 'Dhyanchand' irks locals

Rourkela, July 22: It was on the 12th of last month that the statue of a hockey player, which was erected near the Rourkela Airstrip during the World Cup, came crashing down with the first nor-westerly. Soon, an inquiry committee was formed, with sub-collector Rourkela heading it. And more than a month has passed and everybody here is waiting keenly for the report but in vain.

'They are taking time to give a plausible logic to the wrongdoing in the statue erection for that they are taking so much time," said a local in Chhend.

The committee also has one NIT professor, SE R&B Sundergarh, SE RD Rourkela



and EE R&B Rourkela as members. On being brought to the attention of the sub-collector Abhimanyu Majhi, he said, "The investigation is complete. And the report is under preparation. When asked about the likely date of submission, he said, "Maybe in a week we will submit the report to the authorities for action at their end.'

Reacting to the development, the legend's son Ashok Kumar said, "Let's forget that it's the statue of a legend. It still belongs to a hockey player. How can one keep it lying around for so long without really bothering about reinstallation? This is really an insult.'

In fact, the administration is reluctant to identify the statue. When questions were raised about whether it was that of hockey great Major Dhyanchand there was no concrete answer. However, the place has been named Dhyanchand Square.

When this was brought to the notice of the sub-collector he said, "The square can be named after the hockey great but the statue can be of anyone.

Reacting to this Dhiren Senapaty, state spokesperson of BJP, said, "Everyone knows that the statue belongs to the hockey great. But, why the board is so small that hardly anyone can notice that the square has been named after Major Dhyanchand."

SAND MAFIA POLLUTING SANKH

BLACK CHARCOAL, AN INDUSTRIAL RESIDUE OF SPONGE IRON **UNITS, BEING DUMPED IN THE** RIVER DELIBERATELY

Rourkela, July 21: The unabated dumping of black charcoal, an industrial byproduct from the sponge iron plants, is posing severe environmental hazards to Sankh river, one of the major tributaries of Brahmani river.

Locals, who didn't want to be identified, said the sand mafia is responsible for the pollution as well as illegal lifting of sand from the



river bed. "They have been doing this with impunity," said one of them. Elaborating further, he said, "The mafias have made roads on the river bed using large cement hume pipes so that they can cross to the other side of the river and

mine sand sans permission. A visit to the spot confirmed that black charcoals have been kept on the river bed. When asked, another local said, "These are put on the river bed for construction of makeshift roads for sand extraction. They also put large hume pipes on the river bed for passage of water and they construct roads using the same industrial waste to reach the other side of the river." The makeshift bridge is not visible at this moment due to the increase in water inflow. "Just fifteen days back the bridge was visible," he informed.

One person has been awarded the lease of Vedvyas side of Sankh river for mining sand. However, there are always complaints of excessive mining and at the same time, the presence of many op-

erators, the sand mafias. Black charcoal is causing problems for the locals who depend on the river for irrigation, fishing, bathing and domestic use. "Now, we are experiencing severe itching after taking bath in the river and the water is not safe for drinking purpose," said a person who stays nearby. Even the availability, variety and quality of fish in the river have also been affected.

When this was brought to the notice of tehsildar Lathikata Nandita Kujur, she informed that she was in know of things and taking necessary actions against it. "It came to my notice only yesterday and now I am investigating it. I asked the RI for a spot visit and he did that yesterday. He confirmed the dumping of black charcoals in the river," she said. When asked about the steps taken in this regard, she said, "I talked to the leaseholder who is outside at this moment and ordered him to take immediate action to clean whatever has been dumped is there. He said he would do it." "I have brought this to the notice of the state pollution control board officials and have asked them to take necessary actions," she added.

hat is gained when I avoid acknowledging that I have a problem? And what, if anything, is lost? The Prime Minister conceded there was violence in Manipur after 79 days of pretending that there wasn't. A video that was two months old and produced outrage that returned Manipur to the public debate forced him to speak. The Chief Justice of India also said angry words and the police in Manipur, which had been dormant for all that period, immediately made arrests on a case it had ignored

Why did it take all this time? It did because the Prime Minister demoted the issue and signalled to the rest of the BJP and the pliant media not to speak about it. When the incident, and others like it, were actually happening, he was in Bangalore holding road shows. He put off one road show, not because of Manipur but because it would clash with exams and he did not want to inconvenience students. He continued

After that he went abroad a couple of times, attending parties and watching parades. Within India he continued his routine of train flagging-off and inaugurations and felicitations of people on their birthdays and so on. He made not a single reference to Manipur. The ques-

tion is, again, what does one gain in not acknowledging that there is a problem even if the problem is obvious to everyone else?

The first thing is to signal that it is not my problem. If my house is on fire then I will rush to save it. If my family is under attack, I will hasten to protect it. If I not only do not act, but if I pretend as if nothing happened then I do not concede that it is my problem. And therefore I do not have to solve it.

That is the second advantage: I avoid having to deal with a difficult situation immediately and it is possible that it will go away on its own. In a previous column I spoke about how this was the tack the Prime Minister used during the second wave of the COVID pandemic. Normally visible every day at some event whether physically or virtually, he disappeared for 20 days after cancelling his Bengal rallies While hundreds of thousands of people perished, desperate without oxygen and the crematoria overflowed, he was gone.

He returned three weeks later when things were better and fewer people were dying and made a show of having "high level meetings." A BJP resolution from earlier in the year that said that India had defeated the pandemic under Modi was removed from the party's website. Once the wave

subsided, he moved on from the subject completely. He also did the same thing after Galwan. There has been no military briefing more than three years after the clash. The only brief statement he made on the issue came after days of silence and then he was silent about it again.

The third advantage that I have in not acknowledging a problem is that in some sense I can keep my image intact. My followers and devotees (who number many in the case of the Prime Minister) will not have to suffer the trauma of seeing me accept that something wrong has happened under my watch. The other benefit of this is that because their devotion continues, I can also accept to myself that I have done nothing wrong. If so many people continue to believe in me, then my actions are right and so are my acts of inaction.

What else? There may be some smaller benefits. Perhaps some people only remember the bluster of claims and not the avoidance of bad news. How many times have we heard that India is the fastest growing economy? Many continue to believe we are, but, as a newspaper reported on 22 July: "India is no more the fastest-growing large economy. Saudi Arabia is with 8.7 per cent growth in 2022, followed by Vietnam at 8 per cent. In the first quarter of 2023, the Philippines bettered India, at 6.4 per cent.

If I avoid talking about "fastest growing" at this point completely and surface when again a few years later, then many will feel that I have always been on top.

Let us now turn to what is lost when I, as leader, avoid acknowledging that there is a problem. The first is that the problem will continue and often, as was the case in Manipur, it will get worse. How many more people died, how many more women and girls were assaulted, how many more houses were burnt because the Indian government ignored the problem? Perhaps the historians will tell us because most of our media

The second one is that people will take advantage. Why should the Chief Minister of Manipur resign when there is no problem according to the Prime Minister himself? When there was some external pressure, he made a drama of resigning but remained because he was smart enough to know that he could use the silence to his advantage and he did.

The third one is that the nation, this nation, can continue in its stupor that it is marching towards greatness and not be distracted by the fires that are burning inside. Perhaps this behaviour of avoidance comes from cold calculations made by the Prime Minister, or perhaps it comes from instinct. Whichever is true, there is sufficient evidence in year 10 to show what its benefits to him are and what its damage to us.

Today's desk dictionaries often include this word, defining it as boldly disrespectful or impudent, not because it is current — it's archaic, last used unselfconsciously in the seventeenth century - but because it was once common enough that readers are still likely to encounter it. Some writers such as Sir Walter Scott — have since borrowed it to provide a bit of period flavour in historical novels. It's formed from the equally archaic apert, from Latin apertum, open, through French. The oldest English sense was 'public, plain, unconcealed', but this shifted over time until it came instead to mean outspoken and later insolent. Our word seems to have been created from apert in either the sense of a person who is outspoken or clever, since the mal-prefix means 'improperly, badly, wrongly', so creating malapert, of somebody improperly outspoken or inappropriately clever. We still know apert in its aphetic form pert, which retains the idea of insolence, though weakened into cheekiness or impudence. The idea was personified into Jack Malapert, an insolent person, which is in one of the first printed books in English, Caxton's Book of Curtesye of about 1477-78. In modern form, the line

would be "Don't play Jack Malapert, that is, don't be presumptuous".

probably be forgotten. Earlier this month, another gruesome story made headlines. On a Saturday evening, a 45vear-old woman was sowing paddy in her field in Mehandipur, a village in Bihar's Khagaria district when she was attacked and killed over a protracted land dispute. Four men on two bikes stopped by her field, beat her to death, gouged out her eyes and cut off her tongue. She died on the spot. Her family held five of their neighbours responsible for the crime. The accused had been arrested for killing the victim's husband and brother-in-a-law nine years ago and were now out on bail. The horrific crime led to protests by villagers who blocked the highway and refused to cremate the body till the killers were arrested. They relented only after assurances of stringent action. The story was soon deluged in the heavy rains that left Delhi flooded.

Violence of course takes on many hues. Violence is written



Even in a country where violence is the language of power and an instrument of control used by the powerful against the weak, some cases cross all sane limits and bring a level of shock that stirs us to ask some searching questions

into many actions and sometimes policies that are legitimised in the name of keeping peace but are violent in themselves. Inequality is also violence. But wild, violent, in-vourface violence of the kind seen in some of the crimes that continue to happen, particularly against women, indicates that the nation isn't really progressing, never mind what the GDP numbers may say. They show a new normalisation of the toxic cocktail of power, anger and hatred along with a deadening of the soul. And since these cases are not infrequent. they indicate that 75 years after Independence, the bulwark of the democratic system which rests on ideas of justice and good governance practices is not holding up. Worse, this violence is carried out in open spaces, in front of eyewitnesses and sometimes in broad daylight before a crowd. A woman was attacked last December in a crowded market in Bihar's Bhagalpur, with her ears, hands. legs cut off with a chopper used

to slaughter chicken. Her eyes were gouged out. The victim died in hospital. Shortly thereafter, so did her story.

The main reasons for crimes in Bihar were given as property disputes while the reasons in the Manipur case are political. Sometimes wild and extreme forms of violence carry undertones of local power structures that perpetrate this monstrosity to kill and maim but

more importantly to subjugate and warn others to fall in line. But what is worrying is that most of us have this propensity to turn our heads away in cases where intervention may have helped. Eye witnesses rarely help. We may not rush to blame them. The attacks in the other cases of violent crime cited here were probably so swift and horrifying that those around might have been too stunned to intervene or even react. That hopefully is an explanation for evewitnesses not taking any action to help victims. But they are also indicative of "the violence in our bones," as

the title of a book puts it. It suggests: "the mounting data on violence may have turned us into cynics, we seem to accept that violence is endemic to the project of living together."

Violent crime has the further fallout of creating insecurity for all those who will probably never encounter a case of violence on the streets. For example, a survey in the UK in 2021 reported that as many as 49% of women out of the 16112 contacted, felt unsafe walking alone after dark in a busy public place, like a high street or a railway station. In India, the capital city itself has red flags. According to NCRB, Delhi is the most unsafe city in India for women.

It is of course important to study the numbers and analyse the big picture. It is equally important to hold the law-andorder machinery to account. But all of it is one aspect, the aspect of the normal course of business. It still cannot account for the idea of brazenness, the nature of wildness and the complete collapse of humanity that comes with some of these crimes that cause alarm. A murder will add to one number of the statistics of murders. A murder after which the victim's eyes are gouged out also adds one to the total. Both are classified as violent crime but that does not help us understand or analyse the issue. Some cases open to issues of psychopathology save that in most of the cases we see, the criminals are not insane. They are in fact telling us about the society we have created They are telling us that we may be failing in many ways, and we better sit up and take note.

The spectre of populist nationalism

pain's general election as enemies of the state. Sunday matters not just for the country's future but also for the future of Europe. A defeat for socialist Prime Minister Pedro Sánchez would likely propel the extreme right-wing Vox party from back street demagogues to parliamentary power, and if, as is widely expected, Vox and the Popular Party (PP) enter into a coalition government, it will mark the end of Spain's long aversion to far-right politicians, which has endured since the death of Generalissimo Francisco Franco in 1975.

Should Vox become part of Spain's government, its chilling, hyper-nationalist, anti-LGBTQ, anti-feminist, and antiimmigrant agenda would push Europe one step further into a right-wing abyss. The capitulation to Vox by Spanish centerright conservatives, who have traditionally rejected alliances with the far-right but are now desperate to return to power, would reverberate across the continent, particularly given that Spain recently assumed the pres-

idency of the Council of the EU. This alignment between Spain's conservative and farright parties has resulted in an election campaign dominated by culture-war issues. Lurid Vox propaganda has demonised immigrants, gays, and feminists, portraying Sánchez and his party

In reply, Sánchez has characterised the upcoming election. which follows the Socialist Party's poor showing in local and regional elections in May, as an existential battle for the future of Spanish democracy. And now, the socialist former PM José Luis Rodríguez Zapatero has raised the stakes, claiming that "the center-right no longer exists," only the ultra-right, and that having abandoned the center, PP "has gone off the map."

The right's embrace of the culture wars is a deliberate strategy to obscure the threat that their neoliberal economic policies pose to living standards and social equity. The PP's agenda, which is taken straight from the Reagan-Thatcher playbook, seeks to abolish Spain's current wealth tax, slash the personal income tax, privatise the country's util-

ities, and cut social security. At the same time, the PP's focus on culture-war issues is aimed at diverting attention from the economic achievements of Sánchez and his coalition as well as his green agenda. Since taking office in 2018, Sánchez's government has made significant strides in reducing high levels of

inequality and poverty in Spain. Moreover, Sánchez has successfully brokered an inflationstabilising agreement on wages, endorsed by both unions and employers, calling for a 4% wage increase in 2023 and 3% increases in 2024 and 2025, and, currently, the country has the highest growth rate and one of the lowest inflation rates in the eurozone.

Spain is far from the only European country where the rise of the extreme right poses a threat. Across the continent, the growing popularity of far-right parties has driven previously moderate parties to embrace extreme positions. In Germany, the nativist Alternative für Deutschland, now rising in the polls, is pushing Christian Democratic Union and its Bavarian sister party, the Christian Social Union, further to right. And in Finland, the ultraconservative Finns Party has formed a coalition government with the center-right, forcing it to pursue tough anti-immigration policies. A similar pattern can be observed in other Western European countries from Sweden to Austria, and it may appear in next year's European Parliament elections. And, of course, Italian PM Giorgia Meloni, leader of the Brothers of Italy, is further right than any leader Italy has had since Benito Mussolini.

The emerging symbiosis between Europe's far-right movements has been supported by wealthy allies in the US. In September 2022, representatives from 16 European nativist par-

ties, including Poland's ruling__ Law and Justice, Slovak populists led by ex-PM Robert Fico. and former Slovenian PM Janez Janša's far-right movement, gathered in Miami for National Conservatism Conference, where the keynote speaker was Florida Governor Ron DeSantis, who is also a Republican presidential candidate and Donald Trump impersonator.

The Florida conference bore a striking resemblance to another far-right summit organised by the same group and held at Rome's Grand Hotel Plaza in February 2020, just before the

COVID-19 pandemic. Ironically, each member of this unlikely global coalition of antiglobalists claims to speak for their own country's unique cultural heritage and their desire to be free from international entanglements while simultaneously using identical us-versusthem xenophobic rhetoric to stoke nativist fears. It has been 175 years since Karl Marx heralded a spectre haunting Europe. Today, however, it is not the spectre of communism, as Marx had hoped, but that of populist nationalism. The outcome of Spain's election could highlight the gravity and urgency of the threat.

Rap on knuckles

Sir, The Supreme Court has done well to rap the Centre on the knuckles over the worrying rate of cheetah deaths in Kuno National Park. Gujarat tribal belt to Wooed by BJP & SP, small parties look to big bargains observe bandh today

Opposition Congress decides to support the bandh in protest against the ruling BJP's 'failure' to control the situation in the north-eastern state

Ahmedabad, July 22: A bandh will be observed in the tribal belt of Gujarat Sunday in protest against the ethnic violence and atrocities on women in Manipur, a tribal leader said.

The opposition Congress has decided to support the bandh in protest against the ruling BJP's 'failure' to control the situation in the north-eastern state, a party spokesperson said Saturday.

Several tribal outfits, including Adivasi Ekta Manch, have come together to call for a shutdown in the tribal-dominated districts of Gujarat.

"Sunday, a bandh will be observed in the tribal belt in Gujarat as per the call given by the tribal community to protest against violence and atrocities against women in Manipur; Madhya Pradesh urination incident, and atrocities on tribals in Gujarat,' said tribal leader Praful Vasava who recently resigned from AAP.

He said the call for a shutdown is not announced under the banner of any single organisation or a political party but with the consensus of various tribal and other socio-political organisations. "Several tribal



organisations have given a call for a bandh to protest against the Central government's stance on Manipur. They requested Congress for support to the bandh and the party has decided to fully support it. The BJP is responsible for the situation in Manipur," said Gujarat Congress spokesperson Manish Doshi.

A video shot May 4 surfaced last Wednesday, showing two women from one of the warring communities in Manipur being paraded naked by a few men from the other side, sparking national outrage. Gujarat accounts for around 8% of the ST population of India which is mainly concentrated in the eastern districts of the state.

More than 160 people have lost their lives, and several have been injured since ethnic violence broke out in Manipur May 3, when a 'Tribal Solidarity March' was organised in hill districts to protest against Meitei community's demand for ST status.

Lucknow, July 22: In Uttar Pradesh, small parties are making big bargains ahead of the 2024 Lok Sabha elections.

The two major political parties - the ruling BJP and Samajwadi Party - are going out of their way to win over these parties that are mostly caste-specific and have limited area of influence.

Political experts feel that the bigger parties are invariably gripped by a sense of insecurity that makes them sew up alliance -- some of which may not bring any benefit.

An example of this is the ruling BJP that has a strong presence, but is still looking to further consolidate its position by wooing smaller parties.

The BJP has the Apna Dal (S) and Nishad Party as its allies, but wants to win over other parties. The BJP has already brought back the Suheldev Bhartiya Samaja Party (SBSP) into

The Samajwadi Party, meanwhile, is said to be trying to bring back estranged allies like the Mahan Dal and Janwadi Party. The SP already has the rival Apna Dal faction, led by Krishna Patel, as an ally.

Its biggest ally is the Rashtriya Lok Dal (RLD) that wields influence in western UP.

The small parties draw their strength from the fact that they represent various caste and subcaste groups. The bigger parties feel that by bringing these parties into their fold, they will earn their caste votes.

The Apna Dal, for instance is a Kurmi-based party that has made inroads into the Kurmi community which happens to be the second largest caste block in the OBC category.

While the Apna Dal founder Sonelal Patel could never win an election himself, his daughter Anupriya Patel, now a Union minister, has led the party to greater success.

The Apna Dal contested two seats and won both in 2014 and then repeated the feat in 2019. It now has 12 members in the UP Assembly.

Under the leadership of Anupriya Patel, the party has built up a strong organisation in almost every district and has earned the reputation of being a no-hassle ally.

The BJP has benefited from Kurmi votes because of Apna Dal.

The SBSP, led by Om Prakash Rajbhar -- a former auto driver and then a sub-inspector -- meanwhile, is a Rajbhar-centric party that claims influence on seats like Ghosi, Ghazipur, Lalganj, Ballia, Jaunpur, Azamgarh and Ambedkar Nagar.

The SBSP was a BJP ally in 2017 assembly polls but parted ways on a bitter note in 2019, only to return to the saffron fold

Its president Sanjay Nishad is a minister in the Yogi Adityanath government and his son Parveen Nishad is a MP while his younger son Sarvan Nishad is an MLA.

Sanjay Nishad has not won an

election himself but claims that he wields influence on 27 Lok Sabha seats in UP.

The Samaiwadi Party, on the other hand, is in alliance with RLD which banks on support from Jats in western UP. The RLD has given a push

to the Samajwadi Party which was facing rough weather in western UP after the Muzaffarnagar riots of 2013.

However, the alliance is now facing turbulence because RLD wants to join hands with the Congress for the 2024 polls but SP is not enthused by the idea.

Though both parties deny it, speculations are rife that RLD may ultimately opt for an alliance with the Congress if the SP does not relent.

The Mahan Dal, which had contested the 2022 Assembly polls in alliance with the SP, has now announced unconditional support to the BSP.

AMU examining records of student held for ISIS 'link'

Aligarh, July 22: The authorities at Aligarh Muslim University are examining the records of Faizan Ansari, the 19-year-old student arrested by the NIA for allegedly being an ISIS member, a senior official at the institution said Friday.

The entire record of Ansari alias Faiz is being examined by the university authorities. A clearer picture of his antecedents should be available once the institution resumes regular functioning after the summer vacations, Aligarh Muslim University Proctor Mohammad Waseen told PTI. The 19-year-old student was arrested by the National Investigation Agency (NIA) for allegedly being a member of global terrorist group ISIS after searches at his home in Jharkhand and rented accommodation in Uttar Pradesh, a spokesperson of the federal anti-

terror agency said on Thursday. The arrest followed an ongoing crackdown against ISIS modules operating in the country after the registration of a case to thwart any terror attack, the

official added. Waseen said Ansari secured admission in the university's BA (Economics) course last year. He had also applied for accommodation in a university hostel but "since there was no vacancy in the hostel allotted to him, he



did not reside on campus" and was staying in a rented accommodation.

The university is checking its records to determine if Ansari had appeared for the annual examinations in June. He had appeared for the first semester examination earlier this year, the proctor said.

Thursday, the NIA official said the searches at Ansari's home in Jharkhand's Lohardaga district and rented room in Aligarh were conducted on July 16-17 during which several electronic devices, incriminating material and documents were seized.

Ansari, along with his associates and other unknown individuals, had hatched a criminal conspiracy to support ISIS activities in India and disseminate the outfit's propaganda over social media. The conspiracy was aimed at carrying out violent terror attacks in India on behalf of ISIS, the agency

spokesperson had said. Investigations revealed that Ansari and his associates had pledged their allegiance to ISIS, the official had said.

Agra's shoe industry on a warpath over BIS tag

Agra, July 22: Shoe factories in Agra are on a warpath protesting the imposition of BIS (Bureau of Indian Standards) certification.

The shoe units observed a total shutdown Monday and the owners held a series of meetings Tuesday.

"We all strongly oppose the BIS imposition and are unable to apply it on our own made shoes," factory owners said.

Most of the industries in Agra produce hand-made shoes and as these shoes are mostly made in small and cottage industry units, it is not possible to impose these rules here, the protesters said.

"This is my request and demand from our government that BIS should be removed from handmade footwear," a shoe manufacturer said.

An association's representatives said: "We demand that this is not just a shoe, it is the livelihood of millions of families who make it in small houses and this is the source of their livelihood. Our demand is that micro and small MSME units that make shoes for the common man should be kept free from BIS.

How visa applicants fall prey to fraud in Gujarat-

FRAUDSTERS MAKE **UNAUTHORISED BIOMETRICS ENROLMENT OF 28 UNSUSPECTING VISA APPLICANTS WANTING TO MIGRATE TO CANADA**

Ahmedabad, July 22: The Ahmedabad police have arrested three persons, including two employees of a visa outsourcing firm, for carrying out unauthorised biometrics enrolment of 28 unsuspecting visa applicants wanting to migrate to

Canada, an official said. Based on a complaint given by VFS Global, a visa outsourcing and technology services firm having its centre on Ashram Road here in Ahmedabad, the police crime branch here July 16 registered a case against four persons - Melvyn Christy, Sohil Dewan, Mehul Bharwad and an

unidentified man. While Christy and Dewan work at VFS Global's visa application centre in Ahmedabad, Bharwad is a former employee of the firm. They were booked on the charges of cheating, criminal breach of trust, forgery and criminal conspiracy, police said.

Following an investigation, the city crime branch Wednesday arrested Christy, Dewan and Bharwad, the police said in a release. As per the laid down procedure, Canadian visa applicants are required to give their biometric information, such as fingerprints, at the VFS Global's visa application centres only after getting an appointment letter or biometric instruction letter, the police said.

July 5, the Canadian High Commission, through an email, informed the company that it has received biometric data of 28 persons from VFS Global's visa application centre in Ahmedabad, but appointment letters to these persons were never issued by the Canadian au-

After going through the CCTV cameras of the centre, the company officials learnt Christy and Dewan carried out the biometric enrolment of these 28 persons without the knowledge of the officials, the police said.

It was also revealed the 28 persons were given forged appointment letters because the official data of the company did not reflect the names of these

Following the arrest of the trio, it was revealed that Bharwad, who works for an immigration agent, had approached the two VFS Global employees with an offer to carry out biometric enrolment of 28 persons sans enrolment letters, and offered to give ₹5,000 to ₹7,000 per

person, the crime branch said. Christy and Dewan called these 28 persons on different dates and enrolled their biometrics without any valid documents. To dodge the security set up, the duo used to take these persons inside the office from other entry points instead of the main entry door, said the release.

Talking to reporters, Prabuddha Sen, Chief Operating Officer (South Asia), VFS Global, said the 28 persons were duped by the agent because they were under the impression that the appointment letters given by the agent were altered using software. "The agent gave them a forged letter to claim their applications for Canada immigration have moved forward and now they need to give their biometric data at their centre, he said. This is another incident of unsuspecting visa applicants falling prey to fraudulent or grey operators who are taking advantage of the high demand for outbound travel from India, he said.

Sen said the company has hired the services of former IPS officer Muktesh Chander to keep a tab on such activities.

A day after the FIR was reg istered, a person approached the VFS Global office here saying he was among those 28 persons who had given biometrics as instructed by his immigration



44-yr-old man gets death penalty

Idukki (Kerala): A special POCSO court here Saturday sentenced to death a 44-yearold man for murdering a minor boy, and awarded him iail term till the end of his natural life for raping the victim's minor sister two years ago. Idukki Fast Track Special Court Judge T G Varghese gave capital punishment to Idukki resident Sunil Kumar for the murder of his nephew, the sixyear-old boy, and sentenced him to cumulative imprisonment of 92 years including four life terms in the 2021 case registered at the Vellathooval police station. The sentences will run concurrently. However, the court also said the convict will remain in iail for the remainder of his natural life.

Maha rains: More than 100 rescued

Yavatmal: Around 110 people stranded due to floods in Mahagaon tehsil of eastern Maharashtra's Yavatmal district were rescued on Saturday, officials said. Besides the State Disaster Response Force (SDRF), a Mi-17 V5 chopper of the Indian Air Force was also pressed into service for the rescue operation at Anandnagar Tanda village, district collector Amol Yedge said. The SDRF shifted the stranded people to safe places and the rescue operation was over, he

India gifts INS Kirpan to Vietnam

New Delhi: India Saturday gifted its in-service missile corvette INS Kirpan to Vietnam in reflection of growing bilateral strategic and defence partnership amid common concerns over China's increasingly aggressive behaviour in the South China Sea. It is for the first time that India handed over a fully operational corvette to any friendly foreign country, officials said. Navy Chief Admiral R Hari Kumar, currently on an official visit to Vietnam, presided over the ceremony at Vietnamese deep water bay of Cam Ranh where the frontline warship was handed over to Vietnam People's Navy.

Naxalite killed

Bijapur: A Naxalite was killed in an encounter with security personnel in Chhattisgarh's Bijapur district Saturday, a police official said. Arms ammunition and Maoist-related materials were recovered from the encounter site at a forested hill, he said. Blood stains found at the spot suggest that 3-4 Naxalites were either killed or injured in the gunfight but their colleagues managed to drag them inside the forest, the official said, adding that the search operation was underway in the area.

Oppn, govt slugfest over Manipur intensifies

New Delhi, July 22: The political war of words over Manipur intensified Saturday with the BJP raising the incidents of atrocities against women in West Bengal and Rajasthan and questioning the "silence" of the opposition, which termed it as a diversionary tactic to avoid debate on the situation in the northeastern state.

While the opposition has been demanding a statement from Prime Minister Narendra Modi on Manipur inside Parliament followed by an unhindered debate in both houses, the government has accused the opposition of running away from such a debate by putting conditions and alleged that they lack seriousness on the issue

The BJP fielded Union minister Anurag Thakur who alleged that there is a long list of heinous crimes against women in states ruled by opposition parties such as Rajasthan, West Bengal and Bihar, but they were playing politics over the Manipur

Jaipur, July 22: Hitting back at Prime Minister Narendra Modi for mentioning Rajasthan in his statement on the Manipur incident, Chief Minister Ashok Gehlot Saturday said he has "hurt the self respect" of Rajasthan.

While condemning the incident of Manipur where two women were paraded naked and molested, Modi on Thursday made a reference to states like Rajasthan and Chhattisgarh in the context of law and order. "The prime minister has hurt the self respect of Rajasthan," Gehlot said here.

He said Modi finished his speech within a few seconds on the Manipur issue, on which he should have held meetings to review the situation and how it can be controlled. He also took a dig at Modi's remark that the Manipur incident has put 140 crore Indians to shame.

"One hundred and forty crore people of the country are not feeling ashamed but they are saddened by the deeds and negligence of the Modi government,' Gehlot said. He said Modi did not utter a word on this issue for 77 days but after the Supreme Court raised the matter, he completed the formality and finished his speech within a few seconds.

On the opposition BJP targeting his government on several issues including law and order and paper leaks, Gehlot said, "They are spoiling the atmosphere, they have nothing to say. They just talk rubbish." Gehlot said that the BJP is only trying to create a terrifying environment in the state. "Madhya Pradesh is now first in the country for crime against women. BJP-ruled Uttar Pradesh is number one in abduction and murder of women. Gujarat recorded the highest number of custodial deaths and Madhya Pradesh had the highest number of POCSO cases," he said.

Girl, man stripped, beaten up in Bihar

A search is on to apprehend the three persons who assaulted the minor and the accused, the SP said, adding, a preliminary investigation reveals that the incident took place on Thursday. "The police are examining the video and have also sent clothes of the two persons and other evidence recovered from the spot for forensic examination," Kumar said.

A team under the supervision of a senior women police officer has been constituted to investigate the case, the SP said. 'Medical examination of the victim is also being conducted. Her statement will also be recorded before the magistrate,"

Motive necessary for commission of crime if no witness: SC

New Delhi, July 22: The prosecution will have to establish motive for commission of crime if there is no evewitness of an incident, the Supreme Court has said while acquitting a man convicted in a 2008 murder case.

A bench of justices Vikram Nath and Ahsanuddin Amanullah noted that all the witnesses have stated that there was no enmity between the petitioner and the deceased. "Once there is no eyewitness of the incident, the prosecution will have to establish a motive for the commission of the crime inasmuch as in a case of direct evidence, motive may not have a major role," the bench said.

"If there is no motive setup or proved and there are direct eyewitnesses, motive may lose its importance but in the present case as admittedly no one has seen the occurrence, the motive has an important role to play," it said.

The observations came while hearing a plea by a man challenging an order of the Chhattisgarh High Court which confirmed his conviction under section 302 (murder) of the Indian Penal Code and the sentence to undergo life imprisonment along with fine.




According to the prosecution, the uncle of the deceased lodged a complaint that his nephew, while he was returning home, was assaulted by the appellant. He further claimed that when he rushed to the place of occurrence, he saw the accused running away and the murder weapon was lying there.

The top court said the testimony of the deceased's uncle was not reliable and could not have formed the basis of conviction. It said apparently, he was influenced by a sarpanch whose active participation in the proceedings subsequent to the incident cannot be ruled out.

"The medical evidence did not support the prosecution case as the weapon of assault could not have caused injury on the deceased as noticed in the postmortem report," the court ob-

"There was no motive as to why the appellant would commit the murder of an acquaintance and a friend for no reason. The defence version that the deceased was under the influence of alcohol and could have tripped and fallen on a sharp object resulting into the antemortem injury reported in thepost-mortem was quite possible," the bench said.

Biden brings CIA chief to cabinet

Washington: US President Joe Biden Friday said he had asked CIA Director William Burns to become a member of his cabinet, elevating one of his closest advisers on national security and foreign policy, "Under his leadership, the CIA is delivering a cleareyed, long-term approach to our nation's top national security challenges," Biden said in a statement, referring to Burns' approach to Russia's invasion of Ukraine and US competition with China, Burns is not the first CIA director to attain cabinet status. Former President Bill Clinton also named his CIA directors -John Deutch and George Tenet - to serve in his cabinet, as did Ronald Reagan with William Casey.

Lula stricts gun laws in Brazil

Brasilia: Brazil's President Luiz Inacio Lula da Silva signed a decree Friday tightening restrictions on civilian access to guns in Brazil, in a move aimed at reversing the profirearms policies of his rightwing predecessor Jair Bolsonaro. The decree reduces the number of guns civilians can possess for personal safety from four to two, reduces the allowed ammunition for each gun from 200 rounds to 50 and requires documentation proving the need to hold the weapons. It also bars civilians from owning 9 mm pistols, restricting them to members of the police and military.

Moscow, July 22: A drone attack on an ammunition depot in Crimea prompted authorities to evacuate everyone in a fivekm (3.1-mile) radius and briefly suspend road traffic on the bridge linking the peninsula to Russia, the Moscow-installed regional governor said Saturday.

Sergei Aksyonov said there was an explosion at the depot in Krasnohvardiiske in central Crimea but reported no damage or casualties. Footage shared by state media showed a thick cloud of grey smoke at the site.

Aksyonov blamed it on a Ukrainian drone attack. There was no immediate comment from Kyiv.

Russia seized and annexed Crimea from Ukraine in 2014, eight years before launching its full-scale invasion of the country.

The brief halting of traffic on the Crimean Bridge, about 180 km (110 miles) to the east of the drone incident, came five days after explosions there killed two people and damaged a section of roadway - the second major attack on the bridge since the start of the war.

The 19-km (12-mile) road and rail bridge is a vital logistics link for Russian forces, and is also heavily used by Russian tourists who flock to Crimea in Russia accuses Ukraine of

carrying out the attacks on the bridge. Officials in Kyiv have welcomed them, without directly claiming responsibility.

"Remembering the supreme sacrifices by Indian soldiers, the Commune of Monotone (in Italy) and Italian military historians have unveiled the 'VC Yeshwant Ghadge Sundial Memorial' at Montone (Perugia, Italy), as a tribute to the Indian troops who fought during Italian Campaign, during the Second World War, and to honour Naik Yeshwant Ghadge, Victoria Cross, who was killed in action fighting on the heights of Upper Tiber Valley, the statement said.

Neena Malhotra, Ambassador of India in Italy, and the Indian defence attaché represented India during the ceremony.

"Indian soldiers played a central role in the Italian Campaign during the Second World War. wherein more than 50,000 Indian Army soldiers from 4th, 8th and 10th Divisions were involved," the ministry said.

Out of the 20 Victoria Crosses awarded in Italy, six were won by Indian soldiers. Indian soldiers suffered 23,722 casualties, of which 5,782 made the supreme sacrifice, and are commemorated in the 40 Commonwealth War Graves spread all over Italy, it added.

In order to make this memorial a participative endeavour, an Indian Army plaque has been placed at the memorial commemorating the gallant sacrifice of all ranks of the Indian Army who fought in the Italian Campaign, officials said.

Baghdad, July 22: Tensions flared again in Iraq Saturday over a series of recent protests in Europe involving desecration of the Quran, Islam's holy book, which have sparked a debate over the balance between freedom of speech and religious sensi-

Hundreds of protesters attempted to storm Baghdad's heavily fortified Green Zone, which houses foreign embassies and the seat of Iraq's government, early Saturday following reports that an ultranationalist group burned a copy of the Quran in front of the Iraqi Embassy in the Danish capital, Copenhagen. Security forces Saturday

pushed back protesters, who blocked the Jumhuriya bridge leading to the Green Zone, preventing them from reaching the Danish Embassy.

Elsewhere in Iraq, protesters

burned three caravans belonging to a demining project run by the the Danish Refugee Council in the city of Basra in the south, local police said in a statement.

The fire was extinguished by civil defense responders, and there were "no human casualties, only material losses," it said.

Iraq's prime minister has cut diplomatic ties with Sweden in protest over the desecration of the Quran in that country.

An Iraqi asylum-seeker who burned a copy of the Quran during a demonstration last month in Stockholm had threatened to do the same thing again Thursday but ultimately stopped short of setting fire to the book.

He did, however, kick and step on it, and did the same with an Iraqi flag and a photo of influential Iraqi Shiite cleric and political leader Muqtada al-Sadr and of Iran's supreme leader Ayatollah Ali Khamenei.

N Korea fires cruise missiles

Seoul, July 22: North Korea fired several cruise missiles toward its western sea Saturday, South Korea's military said, marking the second launch event this week apparently in protest of the docking of a nucleararmed US submarine in South

While adding to its barrage of missile launches in recent months, North Korea remained publicly silent for a fifth day on the fate of an American soldier

who bolted into the North across the heavily armed Korean border this week.

South Korea's Joint Chiefs of Staff said the launches were dedid not immediately report how many missiles were fired or how far they flew. It said the US and South Korean militaries were closely analysing the launches.

On Wednesday, North Korea fired two short-range ballistic missiles from an area near its capital, Pyongyang. They flew about 550 kilometers (341 miles) before landing in waters east of the Korean Peninsula.

The flight distance of those missiles roughly matched the distance between Pyongyang and the South Korean port city of Busan, where the USS Kentucky Tuesday made the first visit by a US nuclear-armed submarine to South Korea since

US sends first Navy warship to foreign port Malaysia shuts music fest

Sydney, July 22: The United States commissioned a warship in Sydney, Australia, Saturday, the first time a US Navy vessel joined active service at a foreign port, as the two close allies step up their military ties in response to China's expanding regional reach.

The Independence-class littoral combat ship - named after a Royal Australian Navy cruiser that was sunk while supporting the US Marine landings on Guadalcanal in 1942 - was commissioned at a ceremony at an Australian naval base on Sydney Harbour, officially joining the US Navy's active fleet.

The ceremony comes amid the biennial Talisman Sabre military exercises between the US and Australia, seen as a show of force and unity as China increasingly asserts power in the Indo-Pacific.

The exercises, taking place in various locations across Australia over two weeks, include mock land and air combat, as well as amphibious land-

In addition to Australia and the US, forces from Canada, Fiji, France, Germany, Indonesia, Japan, New Zealand, Papua New Guinea, the Republic of Korea, Tonga and Britain are taking

As part of the war games, the Japan Ground Self-Defense Force (JGSDF) Saturday launched a

ICICI beats hopes

Mumbai: ICICI Bank beat firstquarter expectations Saturday as higher interest income and loan growth helped deliver a record net profit for India's second-largest private lender. Net profit rose 39.7% to ₹96.48 billion for the April-June quarter, beating the ₹91.8 billion expected by analysts Refinitiv IBES data showed. Net interest income - the difference between interest earned and paid - rose 38% to ₹182.27 . billion as ICICI's net interest margin expanded to 4.78% from 4.01% a year earlier. The Mumbai-based lender's total advances grew by 20.6% largely led by retail loans, while deposits grew 17.9%

Kotak's big jump

Mumbai: Fourth largest private sector lender Kotak Mahindra Bank Saturday reported a massive 67 per cent on-year jump in standalone net income at ₹3,452 crore for the June quarter. India's coal mining bet stumbles

Bankers' wariness is partly seen stemming from India's parallel push to boost green energy - which raises questions about coal's long-term viability - and from global investors' demands for lenders to limit their fossil fuel exposure

Mumbai, July 22: India's drive to ramp up coal output to meet growing energy demand is faltering due to banks' reluctance to finance newly auctioned mines, though most lenders remain far from ditching fossil fuels for good, analysts and officials said.

Of the 87 mines auctioned to private companies in the past three years in a push called 'Unleashing Coal" - part of India's energy self-sufficiency plans - only four are operating, with the rest awaiting financing, a federal coal ministry official said, asking not to be named.

Coal officials and banking executives in the world's secondlargest coal producer discussed the issue at a June meeting called by the government in a bid to ease the funding deadlock.

Past legal troubles on mine block allocations also explain funders' caution, analysts said.

"Going forward, everyone knows coal is a financially risky bet," said Saurabh Trivedi, research analyst with the Institute for Energy Economics and Financial Analysis (IEEFA).

Global investors who fund private banks increasingly consider coal "a no-go asset class" as they align with ESG (Environmental, Social and Governance) values, Trivedi added.

Climate campaigners and investors are asking banks globally to rein in funding to coal, oil and gas - the leading sources of



the man-made greenhouse gas emissions heating up the planet, but reports suggest money continues to flow.

India's central bank cautioned banks in its bulletin last vear to limit their exposure to fossilfuel related industries and to boost green finance in a larger push to mitigate climate-related financial risks.

Still, only one Indian bank -Federal Bank, a private bank headquartered in southern Kerala - has put coal on its exclusion list for loans, according to energy think-tanks.

Elsewhere in Asia, 41 financial institutions implemented formal coal exit policies in 2022, up from only about 10 between 2013 and 2019, with Japan and South Korea front-runners, found an IEEFA analysis released in

COAL OR RENEWABLES?

Besides growing global pressure for banks to shun coal, the financing delays to new mines reflect bankers' concerns about the granting of environmental permits that are required by miners prior to acquiring land - used by banks as collateral.

Such concerns were addressed at last month's meeting.

"We made the banks aware of the (land acquisition) process and we are hopeful they will finance these new miners," the coal ministry official said.

The banking sector has been more cautious about granting loans to coal miners since 2014, when India's Supreme Court scrapped all but four of 218 coal blocks allocated by the government since 1993, describing the allocations as illegal.

India's simultaneous push to build its renewable energy capacity to 500 gigawatts (GW) by 2030 may be another factor turning bankers away from coal, energy experts said.

Consulting firm Climate Trends assessed project finance loans to 42 coal and renewable energy projects in India - which has set a net-zero goal by 2070 that reached financial closure in 2021 and found that all the investment had gone to renewable energy projects.

TRANSITION PLAN?

But India's government says the nearly 90 newly auctioned mines in the world's most populous country will help meet its ever-growing energy demand as crippling heatwaves and growing consumer numbers make thermal plants hungry for more coal.

"There is a gap of 200 million tonne in the domestic coal capacity and consumption. We're filling that gap from coal imports currently. These mines are important," said the official.

The government estimated these new mines would collectively generate ₹332 billion in revenue and provide employment to more than 300,000 people.

Such policies mean that despite a nascent shift in thinking, most banks remain coalfriendly and are yet to work out their transition plan away from the polluting fuel, analysts say.

India's largest bank - the State Bank of India - remains a key funder of coal projects - even as its annual reports of the past two years show a drop in funding for coal to Rs 50 billion from Rs

GO FIRST GETS CLAIMS WORTH \$2.9 BILLION

Mumbai, July 22: Go Airlines Ltd has received claims worth Rs 240 billion (\$2.9 billion) from operational and financial creditors so far as part of the carrier's ongoing insolvency, two banking sources told Reuters.

The process is in line with procedural requirements under Indian law which allow every creditor a right to payment and remedy by submitting claims if a company is under bankruptcy. Once the claims are filed, the resolution professional has to check its authenticity. "Claims from the lenders are

around Rs 50 billion, while lessors' claims amount to Rs 180 billion so far," a banker with a state-run bank, who has exposure to Go Airlines said, after a meeting of the committee of creditors Friday.

The bankers did not wish to be identified because they were not authorised to speak to the media.

Go Airlines, which operated the Go First carrier, filed for bankruptcy protection in May blaming "faulty" Pratt & Whitney engines for the grounding of about half its 54 Airbus A320neos.

The Raytheon-owned engine maker has said the claims are without merit.

The company earlier this month invited investor interest in the company through a court-appointed administrator. The last date to submit an expression of interest (EoI) is August 9."The airline has received 40 queries on EOIs from potential bidders, but no formal submissions have been made as vet." the second banker said.

'Export curbs on rice put

Traders say while global prices will go up because of India's export ban, local rates are likely to drop

Mumbai, July 22: India's decision to ban non-basmati white rice exports will spur traders to cancel contracts to sell around 2 million metric tonne (MT) of the grain, worth \$1 billion, on the world market, dealers said Friday.

India, which accounts for 40% of world rice exports, Thursday ordered a halt to its largest rice export category to calm domestic prices, which climbed to multi-year highs in recent weeks as erratic weather threatens production.

Anticipating that the government would impose restrictions on rice exports, traders have obtained letters of credit (LCs), or payment guarantees, over the past few days, said a Mumbai-based dealer with a

global trade house. "But the trade wasn't expect-

ing the government to impose restrictions so soon. It was expecting them to come into effect in August or September. As a result, these traders have no choice but to use the force majeure clause to cancel the contract," he said.

Force majeure refers to unexpected external circumstances that prevent a party to a contract from meeting their obligations. Four dealers confirmed that export contracts of around 2 MT of rice, worth \$1 billion, are at the risk of being cancelled.

On Thursday, the government said the ban would be effective from July 20, and only vessels currently loading would be allowed to export, not future shipments backed by LCs.

"Traders typically sign contracts in advance, so the contracts signed for the next few months cannot be executed now,' Nitin Gupta, senior vice president of Olam Agri India Ltd told

India eves tie 3rd ODI with Bangla

Mirpur, July 22: India botched up an easy run chase as a tenacious Bangladesh rallied to tie the final ODI as well as the threematch series here Saturday.

Needing 10 runs from 19 deliveries with four wickets in hand, India looked on course to a comfortable win. However, the visitors suffered a batting collapse towards the end to lose their last four wickets within the span of 16 balls while chasing 226 for victory.

India were all out of 225 in 49.3 overs and with the scores levelled and the scheduled time over, the match was called a tie as the two sides shared the trophy.

India collapsed from 191/5 in the 42nd over to 217/9 in the 48th, but the last-wicket pair of Jemimah Rodrigues (33 not out) and Meghna Singh (6) took the team close to the finish line.

But with one run needed to win off the last four balls, Marufa Akter had Meghna caught behind as half centuries by Smriti Mandhana (59, 85b, 5x4) and Harleen Deol (77, 108b, 9x4) went in vain. The duo had stitched a 107-run stand for the third wicket after India were reduced to 32/2.

After Mandhana's departure in the 29th over, Deol stitched small partnerships of 21 and 31 with captain Harmanpreet Kaur (14) and the experienced Jemimah to help India inch closer to the target. Deol was finally out in the 42nd over and it was left to Rodrigues to hit the required runs, but all she could do was watch as wickets tumbled at the other end.

Earlier, opener Fargana Hoque became the first Bangladesh woman player to hit an ODI century (107, 160b, 7x4) as she led a solid batting display to power the hosts to a competitive 225/4.

Opting to bat first, Bangladesh managed to play a calculated and risk-free innings for major part with Fargana producing a fine innings. Fargana stitched a steady 93run opening stand with Shamima Sultana (52, 78b, 5x4) to lay the platform for the 200-plus score. For India, Rana (2/45) and Devika Vaidya (1/42) were among wickets.

Labuschagne made a defiant 111 to nudge his side closer to a draw that would see Australia retain the urn. But he was finally removed about 15 minutes before tea when he nicked Root's occasional off-spin to Jonny Bairstow, who gathered well at the second attempt.

That left the tourists on 214/5, 61 behind England having ended day three 167 adrift. Root bowled only because of bad light, with the umpires deciding that conditions were too gloomy for the seamers, but his unpredictable offerings provided the biggest threat and he was unlucky not to have Labuschagne caught at slip on 93.

Marsh was not out on 31 at tea having eaten up 107 deliveries for his side in a knock that forced him to curb most of his attacking instincts. Cameron

Satwik-Chirag stuns Wei Keng-Chang duo

Indian World No.3 pair seals 21-15, 24-22 victory over Chinese 2nd-ranked pair to reach Korea Open badminton final

Yeosu (Korea), July 22: Star Indian pair of Satwiksairaj Rankireddy and Chirag Shetty entered the final of Korea Open super 500 badminton tournament with a thrilling straightgame win over World No.2 Chinese pair of Liang Wei Keng and Wang Chang here Saturday.

The World No.3 Indian pair notched up a 21-15, 24-22 win over the second seeded Chinese in a 40-minute duel at the Jinnam stadium. It was Satwik and Chirag's first win over the Chinese pair following two earlier defeats.

Satwik and Chirag, who has won the Indonesia Super 1000 and Swiss Open Super 500 titles this year, will be up against either top seeds Fajar Alfian and Muhammad Rian Ardianto of Indonesia or Korea's Kang Min Hyuk and Seo Seung Jae in the summit clash.

The Chinese, who have won the Thailand and India Open this year, came into the match with a 2-0 head-to-head record but it was a different day as the Indians produced a fine show to reach their second successive final, having won the Indonesia Open in their last tournament in June.

Both pairs engaged in short rallies and pounced on anything weak. The result was the pairs moved neck-and-neck from 3-3 to 5-5. India had a slender 7-5 lead but Liang unleashed a precise smash between the two. The Indians, however, managed to hold on to a three-point cushion at the interval once Liang found the net.

The lead swelled to 14-8 with the Chinese finding the net and going long. Satwik then dished out his trademark smash but the Chinese duo got a couple of points, mainly due to Chirag's judgement error on the backline.

Another smash going to net from Liang and it was 17-11 up for Indians, who soon made it 19 12 with Satwik producing an accurate cross court return. Satwik and Chirag had six game points after Wang sent one to the net. The Indians squandered one before sealing the net when Liang failed to negotiate a serve.

The second game was no different with both the pairs alternatively taking points, moving from 2-2 to 8-8. Soon the Indians grabbed two quick points with Chirag leading the charge. The Chinese then hit wide to give an 11-8 advantage to the Indians at the break.

After resumption, Wang's backhand went to net as the Indians soon jumped to 14-9. A cross court return by Wang and Liang's brilliance in the front court kept the Chinese in the hunt as it was 12-14. The Chinese kept breathing down their neck till 17-15 before Liang unleashed a smash as the match headed to a tight finish.

The Indians regained the twopoint lead after the Chinese went wide but Liang once again pounced on a weak return at the net and then sent down another jump smash to claw back at 18-18. After missing a few match points, India grabbed their fourth match point and converted it. He soon broke into his trademark dance.

I know she is pretty good and has many medals but she must fight against us in the trials," she said, adding that she will now gear up for the World Championship trials.

FAIRYTALE BEGINNING FOR MESSI

ARGENTINE'S SENSATIONAL FREE-KICK ON DEBUT SEALS INTER MIAMI VICTORY OVER CRUZ AZUL

Fort Lauderdale, July 22: Some people paid hundreds of dollars to be able to say they were in the stadium for Lionel Messi's debut for Inter Miami. Some paid thousands for their seats. The team's owners committed well over USD 100 million just to have a chance at moments like this. So far, it looks like money well spent.

From the you-can't-make-thisup department, Messi capped the opening night with his new club by delivering the unforgettable. His magical left foot sent a free-kick into the upper left corner of the net in the 94th minute Friday night, giving Inter Miami a 2-1 win over Mexican club Cruz Azul in a Legends Cup

"What I saw was the goal," Messi said in an on-field interview amid the postgame celebration. "I saw the goal. I knew that I had to score." He makes it sound so easy. Made it look so easy, too.

The game's greatest active player — a seven-time Ballon d'Or winner and a World Cup champion — sent the ball over a wall of four Cruz Azul defenders for the winning goal, unquestionably the greatest moment in

The Herons' brief history.

Fireworks shot into the night sky, and play resumed for roughly a minute before the referee's whistle blew. "It's a movie that we have seen before," Inter Miami coach Tata Martino said.

Messi was a showman throughout his debut for his Major League Soccer (MLS) club. He waved at fans while he was seated on the bench. Waved at them while he was warming up. Waved at them while he was ac tually in the game.

And if that wasn't enough, he saved his best moment for the end. He watched the ball sail into the net, something he's done about 800 times before for club and country, then sprinted to the right corner of the field and leaped into the arms of teammates.

The team's owners — David Beckham, Jorge Mas and Jose Mas—were waiting as he left the pitch; Jorge Mas planted a kiss onto the superstar's sweat-coated cheek. Some Cruz Azul players stood in silence and just watched; they'll have a story to tell, too, about how it took an incredible Messi moment to defeat them.

Nobody even left their seats when the halftime whistle blew. The reason: Messi was on the field. He warmed up for about 5



minutes during intermission with the other reserves before they all left for the locker room.

That's when the fans, finally, could put their phones down and take a breath. Temporarily, anyway. The wait was officially on: When was Messi coming in? He resumed warm-ups while the second half was getting under way, jogging around behind the end line near Miami's supporter

section, and fans roared in delight when he gave them a wave.

And about eight minutes into the second half, the answer: It was Messi time. Messi checked in early in the second half with Inter Miami leading 1-0. He hugged the player he was replacing, midfielder Benjamin Cremaschi, then trotted onto the field as the estimated crowd of 21,000 all seemed to be standing, almost all of them with phones out to chronicle the moment.

Had he missed the free-kick, the game would have gone to a penalty shootout. Instead, Messi ended it on his terms.

The first Inter Miami goal of the Messi era was scored by Robert Taylor, who took a long cross from Robbie Robinson, moved into the box and sent a low drive off the inside of the far post and into the back of the net

for a 1-0 lead late in the first half. Messi leaped from his seat, threw his hands in the air, applauded several times and broke into a wide smile. Cruz Azul tied the game shortly after Messi checked in and had plenty of chances to take a late lead. But the final act belonged to Messi, a storybook ending if there ever was one.

It was a gathering of GOATs at Messi's debut match: LeBron James and Serena Williams were there — like Messi in football, they're in the conversation of "greatest of all time" when it comes to the NBA and tennis.

Music legends Gloria and Emilio Estefan showed up, as did Miami Dolphins quarterback Tua Tagovailoa, and Kim Kardashian arrived saying one of her sons had a particular reason why he had to attend.
