

Parl logjam on Manipur

HOUSE SUSPENDS AAP MP SANJAY SINGH FOR REST OF THE MONSOON SESSION

New Delhi, July 24: Relentless protests from Opposition members demanding a statement from the Prime Minister Modi on Manipur issue Monday marred proceedings in both the Houses and Aam Aadmi Party MP Sanjay Singh, one of the more vocal voices in Rajya Sabha, was suspended for the rest of the Monsoon Session for repeatedly 'violating' the directives of the Chair.

The suspension came after Leader of the House Piyush Goyal moved a motion in this regard and it was adopted by the House by voice vote. Before that, Rajya Sabha chairman Jagdeep Dhankhar named Singh for his 'unruly behaviour' and cautioned him. Opposition parties condemned the action against Singh and accused the government of trying to throttle their voice.

With protests ruling the day inside both Houses despite attempts by Dhankhar and Defence Minister Rajnath Singh to end the impasse, charge and countercharges flew thick and fast outside Parliament as the two sides targeted each other.

Since the session began July 20, little work has been done in Parliament. Opposition members have seized on the viral video of two women stripped and paraded by a mob from another community in the violence-hit state to corner the government. While the government has expressed its willingness to a debate on the situation in the BJP-ruled state, the Opposition has made a statement from Modi a precondition for any discussion on the issue, accusing him of insulting Parliament by speaking to the media on the matter and not in either of the Houses.

As slogan-shouting by Opposition members, many of whom were in the Well, continued in Lok Sabha, Shah spoke briefly, questioning their intent despite his willingness to debate.

Rajya Sabha Chairperson Jagdeep Dhankhar also held a meeting with Opposition leaders in this regard as well. In Lok Sabha, the government succeeded in transacting some legislative business amid uproar, with three Bills in-

Pune, July 24: A 57-year-old assistant commissioner of police (ACP) allegedly shot his wife and nephew dead with a gun before shooting himself fatally at his home in Maharashtra's Pune city Monday, an official said.

The incident took place at around 3.30am at ACP Bharat Gaikwad's bungalow in Baner area. The reason behind the incident was yet to be ascertained, the official from Chaturshringi police station said.

SC halts Gyanvapi survey

New Delhi, July 24: In a relief to the Gyanvapi committee, the Supreme Court Monday halted till 5pm July 26 a 'detailed scientific survey' of the ASI to determine if the mosque located next to the Kashi Vishwanath temple in Varanasi was built upon a temple, saying 'some breathing time' needed to be granted to appeal against the

Taking up the plea moved by Anjuman Intezamia Masjid (AIM) of the Gyanvapi mosque for an urgent hearing, the top court directed the Allahabad High Court to hear the appeal before its 'status quo' order expires Wednesday evening.

The apex court's order came at a time when a 30-member team of the Archaeological Survey of India (ASI) was inside the mosque complex to carry out the survey. A Varanasi court directed the

ASI Friday to conduct the survey -- including excavations, wherever necessary -- to determine if the mosque was built at a place where a temple existed earlier.

"We permit the petitioners to move the high court in the exercise of its jurisdiction under Article 227 of the Constitution or the appropriate proceedings to challenge the order of the learned district judge of Varanasi. Having regard to the fact that the order of the district court was pronounced at 4.30 pm on July 21 and the survey is in the process of being carried out, we are of the view that some breathing time should



move the high court, seeking_ appropriate reliefs.

'We direct that the impugned order of the district judge shall not be enforced till 5 pm on July 26. In the meantime, should petitioners move the high court with the petition or application under Article 227, the registrarjudicial shall ensure that it is placed before an appropriate bench according to the roster of work so that it can be heard before the order of the status quo, which has been granted by this court, comes to an end," or dered a bench comprising Chief Justice D Y Chandrachud and Justices J B Pardiwala and Manoj Misra.

The bench directed Solicitor General Tushar Mehta, who appeared in the court on behalf of the Uttar Pradesh government, to immediately convey the order to the ASI officials working at the site.

At the outset of the day's proceedings, the plea was mentioned by senior advocate Huzefa Ahmadi, who was representing the mosque committee, for an immediate stay of the ASI work, saving that the task has been undertaken in a "tearing hurry", without affording the time to the aggrieved party to file an

Meanwhile, a team of Rajasthan police reached the home of Anju in Bhiwadi to enquire about her after the media reports.

Her husband Arvind told police that she left home Thursday

on the pretext of going to Jaipur, but the family later came to know that she was in Pakistan. 'She left home saying she has to meet her friend. I talked to her

on WhatsApp a few days ago and got to know that she was in Lahore," Arvind told police, adding that they married in 2007 and have been living together since then.

"Anju's husband said that she left home Thursday. She had a valid passport," Assistant Superintendent of Police Bhiwadi Sujit Shankar said.

He said that the family has not given any complaint regarding the matter. The couple works in private firms in Bhiwadi and has a 15-year-old girl and a six-year-old son.



Arvind told the media at his home that his wife told her sister that she was in Lahore and later he also spoke to her.

He said he will talk to her and will ask her to return, asserting that he was hopeful that she would return home.

He said her passport was issued in 2020 as she wanted to apply for a job abroad.

Arvind said he had no idea that she was in touch with anv-

one on social media. A senior UP police official said Anju was born in Kailor village in Jalaun district located in the Bundelkhand region of Uttar Pradesh but has nothing to do with the village. Kailor is located around 70 kilometres from the district headquarters in the Madhavgarh development





Look-out Circular issued against Chinese national

Bhubaneswar, Jul 24: The Bureau of Immigration (BOI) under the Union Ministry of Home Affairs (MHA) has issued a Look Out Circular (LOC) against Chinese national Guanhua Wang, one the main accused in the mega online Ponzi

The LOC has been issued on request of the Economic Offence Wing (EOW) of Odisha Police, an official statement said, adding that a case has been registered under different sections of IPC such as Section 66-C & 66-D IT Act



and Section 6 OPID Act.

The case relates to the pan-India online Ponzi scam involving fraud and siphoning of hundreds of crores rupees out of India using a complex network of mule bank accounts, shell companies/firms and crypto-

Forty-year-old Guanhua Wang is a resident of Hangzhou city of

A top EOW official told **OrissaPOST** that the unit has started process for the issuance of lookout circulars against two more Chinese nationals in the multi-crore digital financial fraud case. The scammers used a similar modus operandi like Wang and opened bogus firms in Bangalore. Investigation so far has revealed that the bulk of money generated through the fraud was siphoned off to China using crypto currency. The Bureau of Immigration (BoI) has issued LOC against at least 11 fugitives wanted by EOW in various multi-crore financial frauds between 2022 and July 24, 2023.

LOC process starts for 2 more Chinese nationals

In 2019, he formed a company Bettec Technologies Private Limited' at Bangalore's Dickenson Road.

EOW also claimed that he controls at least two other Bangalorebased companies through his mule directors 'Gamecamp Solutions Private Limited' and 'Byrontec Technologies Private Limited'.

Stating that Wang visited India 6 times between 2019 and 2020, the EOW said he is working/running this scam from China with the help of many India-based associates who look after the managing/arranging of mule bank accounts, shell companies/firm and crypto-traders, Whatsapp/Telegram group tutors/administrators, and also running advertisements using morphed photos of celebrities.

Initial investigations suggest siphoning of more than Rs 100 crore by his company using such methods. EOW has frozen around Rs 70 lakh from his company's ac-

PRESIDENT'S VISIT: SECURITY BEEFED UP IN TWIN CITY

Bhubaneswar, July 24: The Commissionerate Police (CP) here has made elaborate security arrangements in view of President of India Droupadi Murmu's three-day state visit starting Tuesday. Speaking to mediapersons, DCP Prateek Singh Monday said the arrange-

ments have been made as per the Blue Book protocols.

Singh said that arrangements have been completed for the deployment of police personnel for root lining, President's carcade, smooth traffic and parking in the city during the visit. 36 platoons of police force will be deployed for security arrangement in the city, he said.

Response Teams, two Special Tactical Units will be engaged for the security of President Murmu during her visit. This apart, CP has deployed 12 additional DCPs, 25 ACPs, 40 inspectors, 120 SIs and ASIs to supervise the security arrangements. Similarly, 160 traffic personnel and 150 home

guards and Fire Services per

sonnel will be deployed during the President's visit.

Opposition slams govt over HC bench delivers 75 OSSC question paper leak

Bhubaneswar, July 24: Opposition BJP and Congress Monday slammed the state government over the OSSC question paper leak issue and demanded proper investigation to bring to book all involved in the

The Odisha Staff Selection Commission (OSSC) had conducted the main written examination for recruitment of 1,008 JE (civil) Group-B posts in different offices of the government of Odisha July 16, 2023.

However, the examination was cancelled following the leak of the question paper and the OSSC decided to conduct a fresh exam September 3.

BJP spokesperson Anil Biswal asked how the question paper was leaked to the middlemen of Bihar and Andhra Pradesh. "Did present OSSC chairman Abhay, who is a former DGP, not know the modus operandi to be followed when such a complaint was received," he further asked.

Questioning the role of the state government in the case, the BJP leader demanded an SIT probe and said OSSC officials involved in the scam be brought

under the ambit of probe. Speaking in a similar vein, state Congress president Sarat Pattanayak wondered how the question paper was leaked when the BJD government made tall claims about 5T and transparency.

"There is 5T but no transparency in the government. Someone from the OSSC must be involved there. Otherwise, how did the question papers get leaked," he asked.

Reacting on this issue, BJD spokesperson Lenin Mohanty said many such scams have been reported in BJP ruled states, but no action has been taken. "They are now politicising the issue when nine persons have already been arrested on the basis of the enquiry report of the gov-

Meanwhile, irate JE (civil) job aspirants staged a protest before the OSSC office here and demanded strong action against all those, including officials, involved in the scam.

'We first waited for year for the examination. Now, after completion of the prelims examination, the question paper of the main exam was leaked. The exam got cancelled and a fresh date was announced. Who will ensure the question paper will not be leaked before the next examination date," asked a

The prelims exam for the post was held in June this year and over 5.000 students qualified for the main written test which was

conducted July 16, he said The aspirants alleged that the question paper could not have been leaked without the involvement of OSSC officials. Therefore, all should be brought under the purview of investi-

gation, they demanded. The names of the students, who got the question paper prior to the exam, should be published and they should be banned from appearing the examination for three-four years, they demanded.

Cuttack, July 24: In a record of sorts, a division bench of the Orissa High Court (HC) Monday delivered 75 judgments in criminal appeal matters, mostly related to murder cases.

The feat was achie days before the court celebrates 75 years of establishment.

The bench comprising Justices Debabrata Dash and Sanjeev Kumar Panigrahi started functioning from 10.30 am through a hybrid arrangement in which the parties appeared both in virtual as well as physical mode.

By the evening, verdict of all the listed 75 cases were delivered, and the packed courtroom broke into thunderous applause.

The appeals were filed through State Legal Services Authority

(SLSA). "In my 32 years of practice in Orissa High Court, I had never

seen judgments being delivered in such a large number of criminal cases on a single day. A record was created today and this rare feat will make the 75thanniversary celebrations of the High Court memorable," said advocate B K Ragad, who appeared in two cases during the



judgments in one day

The high court was established on July 26, 1948 with only four judges, including Chief Justice Bira Kishore Ray. The then Chief Justice of the Federal Court of India, HJ Kania had inaugurated it. The strength of the Bench has since been increased to 28 in the last 75 years.

The appeals that were cleared on Monday were pending for several years.

In most cases, the court confirmed the sentences awarded by lower courts and in several other matters, death sentences were commuted.

The bench, in several cases, raised concern over the standard of investigation by the police and the faulty presentation of the case by the prosecution.

In one case holding a death to be homicidal, the convicts were set free because of incompetency on the part of investigating police officers.

LIMATE CHANGE MAY BE CHANGING COLOUR OF OCEANS

limate change has likely changed the colour of the Earth's oceans significantly over the past two decades. according to a study

The research, published recently in the journal 'Nature', detected changes in ocean colour over the past 20 years that cannot be explained by natural. year-to-year variability alone.

These colour shifts, though subtle to the human eye, have occurred over 56 per cent of the world's oceans - an expanse that is larger than the total land area

on Earth, the researchers said. The team of researchers from the Massachusetts Institute of Technology (MIT), US, the National Oceanography Center in the UK and others found that tropical ocean regions near the equator have, in particular, become steadily greener over time. According to the researchers, the shift in ocean colour indicates that ecosystems within the surface ocean must also be chang-

ing, as the colour of the ocean is

a literal reflection of the organ-

isms and materials in its waters. It is not certain how exactly marine ecosystems are changing to reflect the shifting colour, the researchers said, adding, however, human-induced climate

change is likely the driver. "I have been running simulations that have been telling me for years that these changes in ocean colour are going to happen," said study co-author Stephanie Dutkiewicz, senior research scientist in MIT.

"To actually see it happening for real is not surprising, but frightening. And these changes



are consistent with man-induced changes to our climate, Dutkiewicz said.

The ocean's colour is a visual product of whatever lies within its upper layers. Generally, waters that are deep blue reflect very little life, whereas greener waters indicate the presence

The team analysed measurements of ocean colour taken by the Moderate Resolution Imaging Spectroradiometer (MODIS)

aboard the Aqua satellite, which has been monitoring ocean colour for 21 years. MODIS takes measurements in seven visible wavelengths, including the two colours researchers traditionally use to estimate chlorophyll.

The researchers carried out a statistical analysis using all seven ocean colours measured by the satellite from 2002 to 2022 to

They first looked at how much the seven colours changed from region to region during a given year, which gave them an idea of their natural variations.

The team then zoomed out to see how these annual variations in ocean colour changed over a longer stretch of two decades. This analysis turned up a clear trend, above the normal yearto-year variability.

Heavy rains till Wednesday: IMD

DUE TO LOW PRESSURE AND SUBSEQUENT DEPRESSION SQUALLY WEATHER WITH GUSTY SURFACE WIND SPEED REACHING 45 TO 55 KMPH IS TO BE EXPERIENCED ALONG AND OFF ODISHA COAST BETWEEN JULY 25 AND 27

Bhubaneswar, July 24: With the formation of a cyclonic circulation over the Bay of Bengal, which is likely to intensify into a low pressure and subsequently get the shape of a depression, the IMD Monday forecast intense rainfall for two days from Tuesday.

The cyclonic circulation lays over the Bay of Bengal off the coast of south Odisha and north Andhra Pradesh.

"Under its influence, a Low-Pressure Area is likely to form over the same region.... The system is likely to concentrate into a depression around July 26," the IMD said in its evening bulletin.

The IMD bulletin said heavy rainfall (7 to 11 cm) is likely to occur in Malkangiri, Koraput, Nawarangapur, Rayagada, Gajapati, and Ganjam till Tuesday morning with light to moderate rain or thundershower at most places in the south interior Odisha.

The IMD has also issued an Orange warning (Be Prepared) for the next two days. It said that on July 25, heavy to very heavy rainfall (7 to 20 cm) may occur at



isolated places in Gajapati, Ganjam, Puri, Malkangiri, Koraput and Rayagada districts.

It issued a Yellow warning (Be updated) of heavy rainfall in Nabarangpur, Kalahandi, Kandhamal, Bolangir, Nayagarh, Khurda, Cuttack, Jagatsinghpur and Mayurbhanj districts.

Light to moderate rain or thundershower is also a possibility at most places in south and coastal Odisha and at many places in other parts of the state, the IMD

July 26, heavy to very heavy rainfall may occur at isolated places in Malkangiri, Koraput, Nabarangpur, Kalahandi, Nuapad and Balangir.

There is also a forecast for heavy rainfall (7 to 11cm) at one or two places in Rayagada, Gajapati, Kandhamal, Ganjam, Nayagarh, Boudh, Cuttack, Dhenkanal, Angul, Sambalpur, Sonepur, and Bargarh.

Light to moderate rain or thundershower is very likely to occur at most places in the state on this day.

Due to low pressure and subsequent depression along with strong monsoon flow, squally weather with gusty surface wind speed reaching 45 to 55 kmph is to be experienced along and off Odisha coast between July 25

The weather office also asked fishermen not to venture into the sea during this period.

The IMD warned of water logging in low-laying areas, poor visibility during intense spells of rain and traffic congestion in urban areas and the possibility of wall collapse of vulnerable kutcha houses.

Higher PHDI scores were associated with a 15 per cent lower risk of death from cancer or cardiovascular diseases, a 20 per cent lower risk of death from neurodegenerative disease, and a 50 per cent lower risk of death from respiratory diseases.

However, Bui cautioned that the PHDI does not necessarily reflect all food items and their relationships with all major diseases in all countries, as it may vary with specific health conditions, religious restrictions, or food accessibility.

The findings were presented at the ongoing NUTRITION 2023, the flagship annual meeting of the American Society for Nutrition held from July 22-25 in Boston, US.

Fate of cardiac care hosp pushed into uncertainty

Sambalpur, July Construction of a super specialty cardiac care hospital in Jharsuguda district has been pushed into uncertainty with shifting of the equipment installed in the hospital to other hospitals, a report said Monday.

War of Wheat

ussia has hit back at the US-led West which has imposed tough sanctions on it for invading Ukraine in February 2022. This time, it has not used its war machine much. It has decided to cut off the food supply line, especially wheat, from Ukraine to Europe, Africa and China most of which sails through the Black Sea. The action has already affected grain exports, but what is of greater concern is the prospect of soaring grain prices across the world that is going to hit poorer countries hard in the coming days.

The new problems cropped up after Russia ended last week the Ukraine grain-export deal nearly a year into the agreement. The pact — brokered by the United Nations and Turkey — has ensured the safe passage of almost 33 million tons of crop exports via the Black Sea since it was signed in July 2022. It has helped world food and other commodity prices ease from the record levels reached initially immediately after Russia invaded Ukraine. However, in recent months it has been affected by red tape and slow vessel inspections by Russia. According to the terms of the agreement, Russia was to oversee the movement of ships to ensure weapons were not carried on board. Moscow had repeatedly threatened to leave the pact, citing obstacles to its own exports. It last agreed to a two-month extension in May, which ended last week. Russia's decision will affect supplies to countries such as Spain, Egypt and China, apart from having a chain reaction on the food situation in the rest of the world.

Moscow's explanation for pulling out of the deal is far from convincing. Russia has complained that it hasn't got its due out of this Black Sea agreement so far. Moscow also argues that strike by shippers in Crimea and uncertainty about insurance coverage have prompted it to take the decision. Right from the start of the agreement, Russia has been blackmailing the West. Soon after it was signed, there was a Russian strike in the port of Odessa. In November 2022, Moscow briefly suspended the deal following the attack on a Russian naval base in Crimea.

Food grains shipped from Ukraine under the deal helped world food prices come down by about 20 per cent, according to the UN's Food and Agricultural Organisation (FAO). An estimated 43 per cent of the foodstuff exported from Ukraine during the past one year went to developed countries and 57 per cent to developing countries. These statistics indicate what leverage Russia can get by breaking this supply chain. Both the developed and developing countries will reel under soaring foodgrain prices after the supply is stopped.

Russia is also complaining about the impact of Western sanctions on its own agricultural exports, even though Russian agricultural products have been kept out of the purview of the sanctions regime. Moscow is demanding that the Agricultural Bank of the Russian Federation be reconnected to Swift, the service essential for crossborder payments. It demands the lifting of restrictions on marine insurance, which, according to it, affects its agricultural products. But, the whole purpose of the blackmail, it seems, is to put pressure on the West to ease the constraints imposed on Moscow, especially on its oil exports.

It seems like apart from getting the Western sanctions loosened, Russia wants to disrupt world grain prices. After a record 2022 harvest, Russia is awash with stock. As a result, in case of disruption of wheat supply, Russia would not be as affected as the rest of the world. Such a situation could offer Russia the opportunity to try and force the West to at least scale down its sanctions.

It is a cynical game that Russia is playing. But, everything, as the bard

alarkey is meaningless talk, nonsense or foolishness. It's still known in the US and to a lesser extent in the UK and elsewhere, but where this odd-looking word comes from is decidedly uncertain. What we do know is that it began to appear in the US in the early 1920s in various spellings, such as malaky, malachy, and mullarkey. Its first known user was the cartoonist TA Dorgan, in 1922, but it only began to appear widely at the end of the decade. By 1930, Variety could pun on it: "The song is ended but the Malarkey lingers on." Various theories have been advanced. Eric Partridge pointed to the modern Greek word malakia but he formed a group of one. His later editor, Paul Beale, noted the London expression Madame Misharty, the personification of sales talk, exaggerated claims, and wild predictions, a name that was supposedly that of a fortune teller. But this is stretching a possible linguistic link to breaking point and, in any case, we know it started life in North America. Others point to the family name Malarkey, though who the eponymous member of the tribe might have been whose Irish-derived gift of the gab could have given rise to the name remains unknown. Jonathon Green likewise suggests a Irish origin in mullachan, a strongly-built boy or ruffian, though this, too, seems a stretch of meaning. We'll just have to settle for the unsatisfactory "origin unknown".

allemaroking was the carousing of seamen on board Greenland whaling Ships. You must agree that no true student of the English language can afford to be without this choice specimen of exact usage. Not, you will note, just any seamen aboard any ships, but whalers in the Greenland waters, who were - it seems - always ready for a bit of merry-making in between hunting the Greenland right whale. The whale's name was another term from the same fishery, too mundanely derived to deserve much attention from word historians, since it was merely the whale found around Greenland that was the right one to hunt, mainly because it floated when dead. Mallemaroking owes its survival almost entirely to its curious form and peculiarly precise nature. There is small chance that you will find it unselfconsciously used as the right word in the right place. It is the preserve almost solely of those wordsmiths who write about weird words, a sad degeneration of status in whose reduction my own small part is all too obvious.

WAIT FOR JUSTICE

THERE IS AN **IMPRESSION** THAT THE ELITE **CAN JUMP QUEUES AND GET INSTANT HEARINGS** WHILE THE **MASSES HAVE TO WAIT**

uring 2023, India became the country with the highest population in the world and will probably remain so for the next century and beyond, unless it breaks up into smaller nations. India having survived in one piece, despite its incredible diversity on every dimension, be it language, religion, cuisine, race, ethnicity, culture, and creed, is itself a miracle of the modern world. The Soviet Union broke up into 10 countries. Canada almost broke up in the 1960s due to the two-language diversity, French and English. Our own twin born on the same day, split into two. So, India's survival and progress as a unified nation state for 75 years is a major reason to celebrate. Should we also celebrate the fact that we are also the most populous nation? That is a double-edged sword. For a nation's development the most crucial resource is human capital. But the same demographic dividend can become a disaster if no investment is done in enhancing human capital and there are no productive opportunities for the young. This is the economic challenge. India's economy also crossed the \$3 trillionmark four years ago. It has been among the fastest growing major economies, and hence racing ahead. In 2023 it pipped the UK to become the fifth largest economy, and is expected to reach rank 3 in coming years, as boldly asserted by our Prime Minister in his speech before the US

But there is another milestone that we crossed last month, of which we cannot feel proud. India now has more than 5 crore pending cases across all courts. Thanks to digitalisation, we can see a running ticker on the ecourts website. As on July 23, the pendency was 6.06 million cases in High Courts and 44.3 million cases in District and Taluka

Congress last month. The fast

growth will soon lead us to the

major milestone of \$5 trillion.



One of the pernicious effects of pendency is on those who are in prison and are called 'undertrials'. These are all technically innocent people since they have not been proven guilty

courts. Three years ago, in a speech at NALSAR University, the Chief Justice said that total pending cases was 32.45 million. That implies a growth of nearly 18% every year. The economy is growing at 6%, the population at 0.8%, but the backlog of cases is growing at 18%. The aggregate caseload data can be broken up into how many cases are pending for less than one year, how many between 1 to 3 years and so on. A whopping 25% of all cases are pending for more than five years. As per a 2018 report from the PRS Legislative Research, one fourth of all cases with HCs were pending for more than 10 years. That aggregate number is more than one million. Allahabad HC had the highest pendency of more than 7 lakh cases. There is now detailed and extensive data in digital form with the National Judicial Data Grid. So. one can slice and dice the data and gain many such insights.

There is delay in processing both civil and criminal cases. In the lower judiciary between 70 to 80% of pending cases are criminal ones, but the ratio becomes reverse in the HCs. One of the pernicious effects of pendency is on those who are in prison and are called 'undertrials'. These are all technically innocent people since they have not been proven guilty. Nearly 4 of the 5 lakh people who are thus incarcerated are undertrials, i.e. held without a conviction. Their liberty has been denied since the judicial system is unable to process their cases. In an even more bizarre twist, there are people who have been in prison for a duration longer than the time they would have to serve had they been convicted as guilty. These are extreme examples and a blot on our democracy. But even the large pendency of all others is a black mark. Justice delayed is justice denied. The average time taken to dispose cases in India is 30 months as compared to 6 months in the European Union, as per the Economic Survey of 2019, published by the Union Finance Ministry. India's ease of doing business record is tarnished because of the shoddy speed of dispute resolution.

So, what are the reasons for the increasing backlog? The first reason is the inadequate number of judicial officers. Across the board there are an average of 20% unfilled vacancies, and these are much more in higher judiciary. Just filling these posts can close the gap

between new caseload and dis posal rate of existing caseload. The second reason sounds silly but is serious and was quoted by the CJI. In a speech last December, he said that 6.3 million cases have been considered delayed due to non-availability of counsel. And another 1.4 million cases are delayed as they await some kind of document or record. This is unacceptable inefficiency, especially when the whole system is being made digital. The third reason for piling up of cases is due to misaligned incentives, especially when a government officer is involved. For instance, if a lower tribunal gives an order against the income tax claims of the government, the officer involved will almost surely appeal even if it is an open and shut case. This is for fear of being accused of corruption or of collusion. A fourth reason for delay could be the arbitrary discretion in the listing order of cases There is an impression that the elite can jump queues and get instant hearings while the masses have to wait. A fifth reason for piling of cases is the absence of arbitration and mediation as a credible first option. In fact, in developed countries like the USA (which is quite litigatious), if a criminal case goes to trial, there is a 90% chance that the defendant will be found guilty, and that too in quick time. Hence many cases do not go to trial and end up with out of court settlements. In India thanks often to shoddy preparation, the cases going to trial offer a more than 50% of acquittal.

Judicial reform which can speed up the delivery of justice, give meaningful out-of-court settlement options for redress, and also fully use the power of digital and artificial intelligence is the need of the hour.

The International Covenant on Economic, Social, and Cultural Rights, adopted by the UNGA in 1966, called on signatories to ensure an equitable distribution of world food sup-

plies in relation to need. The oil-supply shocks and stagflation of the mid-1970s shifted the momentum away from state-led, rights-based governance to neoliberalism as the dominant policymaking paradigm. This approach was based on the misguided beliefs that unfettered markets allocate resources most efficiently; economic globalisation benefits all countries; and the private sector provides goods and services more

From the 1980s, the neoliberal structural-adjustment programmes imposed by the World Bank and the IMF on cashstrapped countries, coupled with the advent of the WTO, restricted the policy space of governments in the Global South. The adjustment programmes called for governments to roll back regulations that were deemed a hindrance to free trade and to open their markets to imports of subsidised food products.

> The resulting globalised, corporate-led industrial food system, which promised to improve food security worldwide, has been a dismal failure. Citizens have been left to pay the price for neoliberal policies: fragile supply chains, workers without rights, a worsening climate crisis, severely diminished biodiversity, reduced access to healthy food, unsustainable diets, and extreme economic inequality. With hunger and malnutrition on the rise, it is time for a radical course correction.

> Reforming the global industrial food system will be difficult, in part because it is characterised by an extremely high concentration of power in the hands of a few multinational agribusiness companies. Only a handful of firms dominate the

global grain and fertilizer markets, a position that has enabled COVID-19 and following Russia's full-scale invasion of Ukraine.

Backed by powerful commodity-exporting countries, neoliberal policies have promoted industrial production of export crops at the expense of domestic food production by smallholders, transforming Global South countries into food importers vulnerable to price spikes. Financial power also buys narrative power, which can be used to praise the latest food tech.

În 2010, World Economic Forum launched what has come to be called a multi-stakeholder approach to governance in which everyone has a seat at the table. But this framework is far less inclusive than it sounds. When the roles, responsibilities, and interests of different actors are ignored, and power imbalances are disregarded, MNCs inevitably prevail over the less powerful, and government accountability and human rights are set aside.

Inviting corporations to join the decision-making process tips the scales in favour of industrial, chemical-heavy monoculture – a move justified by the neoliberal narrative that we desperately need to harness corporate in-

crease food production. In realprofiteering when supply chains ity, the world produces more than break down, as they did during enough to feed everyone; the problem is unequal access, which requires political, not technical, solutions. The UN Food Systems Summit in September 2021 was the apotheosis of "multi-stakeholderism." Organised without a mandate from governments, and with strong participation by agrifood corporations and the Gates Foundation, the summit did not address the right to food and, in the words of Michael Fakhri, UN Special Rapporteur on the Right to Food, was disconnected from "people's real needs."

Many civil-society organisations have contested both events. These groups prefer platforms like the UN Committee on World Food Security, which includes constituencies most affected by food insecurity, focuses on the structural causes of hunger and inequality, and promotes accountability by reserving voting for governments.

Determining how to achieve adequate food for all is the right of citizens and the duty of governments. Those concerned with making profits should have no place at the table.

Mystic composer

Sir, Centuries have rolled by since the lifetime of one of the chief founding-proponents and the Pitamaha of Carnatic music Saint Purandara Dasa, but his birthplace still remains a mystery. In fact, to explore definitive archaeological evidence regarding the birthplace of this great composer, the Karnataka government, during the summer of 2020, undertook some field research. However, till date neither has there been any concrete evidence nor any update on this research work that would put an end to all speculations about the composer's birthplace. Inscriptional evidence strongly suggests that Purandara Dasa was born in 1484 CE at Keshayapura in Thirthahalli, Karnataka, Though there were theories that his native town was Purandaragad near Pune, it was later considered a historical mistake. Purandara Dasa was a wealthy diamond merchant from Karnataka who gave away all his material riches to become a Hindu monk. His compositions are mostly in Kannada and some are in Sanskrit too. These details add credence to Purandara Dasa's birthplace at Keshayapura and confirm that the mystic poet wholly belonged to Karnataka.

Conspiracy on to topple

'This is your right': TN CM on ₹1,000 aid for women

Dharmapuri, July 24: Tamil Nadu Chief Minister MK Stalin Monday inaugurated a camp here to facilitate registration of applications by women to avail the Rs 1,000 monthly basic income scheme, a flagship programme of the ruling DMK regime set to be launched in September.

Launching the registration exercise, Stalin described the scheme as revolutionary that would lead to a new renaissance in the lives of crores of women. The Rs 12,000 payout per annum would be great support for women, a symbol of development. It would help them improve their standards of living, lead a life of self-respect and eradicate poverty.

The government had announced that the scheme would be implemented from September 15, the birth anniversary of former Chief Minister and Dravidian icon CN Annadurai, also the founder of the DMK.

The Chief Minister said these goals embodied the ideals of the Dravidian model good governance inspired by reformist leader Periyar E V Ramasamy, Dravidian icon CN Annadurai and late Chief Minister Karunanidhi, after whom it has been named.

The Rs 1,000 Kalaignar assistance scheme would be a re-



markable initiative among all the social justice schemes implemented in Tamil Nadu, Stalin reiterated. For the scheme, Rs 12,000 crore would be set apart next year.

Stalin, also the chief of ruling DMK, referred to the Opposition criticism vis-a-visthe scheme.

"They (AIADMK) said DMK captured power through false assurances. We would have given (Rs 1,000 assistance) after assuming power. However, the state finances were in bad shape

and the country was gripped by the coronavirus pandemic," the CM said.

Now, the scheme is set to be launched September 15 after corrective action on the fiscal front to an extent, he underlined, apparently blaming the previous AIADMK regimes (2011-21). The CM, without naming anyone said some were involved in false propaganda against the scheme and asserted that it would be implemented

In order to recognise and give respect to the hard work of women for their families, the DMK had promised Rs 1,000 monthly assistance for them. The scheme registration event symbolised the commencement of fulfillment of the assurance made to the people.

"You should remember that this is your right; you need not regard this as assistance provided by the government," he said

Following the launch, the amount would be credited (DBT) to the bank accounts of beneficiaries and there is no scope for 'any wrongs' at all. "I firmly believe

through this great scheme, the socio-economic status of women in Tamil Nadu will develop to a huge extent." Stalin said.

He recalled that in 2021, immediately after assuming

charge as the chief minister, the first official file he signed was the scheme to provide fare-free travel to women in state-run town buses.

"Every day, 36 lakh women use the fare-free bus services and so far women have used the services for 283 crore times," he said adding the free service helped women save Rs 800-Rs 1,000 per month and that is the most significant aspect.

He also listed a slew of other welfare schemes like the Rs 1,000 monthly aid scheme for girl students, the breakfast plan for government school students.

July 7, Stalin, in a review meeting here advised officials to ensure that not a single eligible person is left out of the scheme's ambit. District collectors should ensure that marginalised sections of society such as those living on streets, tribals and sanitary workers are benefitted.

Even if prospective beneficiaries from marginalised sections do not have requisite documents like ration and Aadhar cards, facilitation should be extended to them to get such documents.

The other aspects in respect of eligibility is the stipulation that applicants should have completed 21 years of age and only one woman/woman-head from a family that has a ration card could apply to avail the Rs 1.000 monthly support.

K'taka govt: Shivakumar

Bangalore, July 24: Karnataka Deputy Chief Minister DK Shivakumar Monday said a conspiracy has been hatched 'outside' to topple the Congress government in the state.

Speaking to reporters here, he said, "We will see. We too have certain information. It is their strategy. Instead of doing it in Bangalore, they are doing it outside."

"Sitting in Singapore, the plan is being made to ensure the fall of the majority government. He is strategising from Singapore as per the inputs I have got. Instead of making plans in Bangalore, a foreign land is preferred."

According to sources, Shivakumar made the remarks in reference to former Chief Minister HD Kumaraswamy, who is currently on a trip to Singapore for a medical checkup.

Tamil Nadu has 22 coastal erosion spots, says research

Chennai, July 24: The National Centre for Coastal Research (NCCR) which has done a comprehensive study on the erosion of Tamil Nadu coast has found that there are 22 hotspots in the state vulnerable to erosion.

The study also revealed that Kancheepuram and Thiruvallur districts of the state are most vulnerable to sea erosion.

Of the 22 hotspots vulnerable for erosion, in Tamil Nadu, eight are in these two districts. The study also found that districts like Nagapattinam,

Ramanathanapuram, Tiruvarur, Thoothukudi and Kanniyakumari are losing the coast line in a fast manner. Tamil Nadu is in the process of preparing a comprehensive shoreline management plan on the basis

of the study by the NCCR. NCCR has used the inputs from IIT, Madras, Public Works Department and the Tamil Nadu state fisheries department for preparing the comprehensive study on erosion in the state coast. According to highly placed sources, the NCCR will be recommending different solutions to prevent erosion that include hard structures like groynes and seawalls in CRZ-2 or developed areas. Soft and nature based solutions will be used in CRZ-3 areas (undisturbed areas).

It may be noted that the National Green Tribunal (NGT) has given a stay order against construction of any hard anti-erosion structures till there is an approved shoreline management plan. The NCCR is also cautious on the construction of hard structures like groynes as this would lead to the shifting of problem from one spot to another spot

Bangalore, July 24: The Central CEN Crime Police Station here has registered a First Information Report against unknown suspects after the press relations officer of the High Court of Karnataka lodged a complaint about threats to the lives of several judges, besides himself, police said Monday.

K Muralidhar lodged a complaint July 14. He had received messages on the WhatsApp messenger from an international number at around 7 PM on July 12. His mobile number is the one provided to him officially by the High Court.

The message in Hindi, Urdu and English allegedly threatened to kill Muralidhar and six judges of the High Court including Justice Mohammed Nawaz, Justice HT Narendra Prasad, Justice Ashok G Nijagannavar (retired), Justice HP Sandesh, Justice K Natarajan and Justice B Veerappa (retired)



through a 'Dubai gang', police said.

The message also had five suspicious mobile phone numbers and contained the threat.

The FIR registered July 14 states that the threat message demanded a ransom of Rs 50 lakh to be paid to a bank account in Pakistan.

After registering the FIR under Sections 506, 507 and 504 of the Indian Penal Code and Sections 75 and 66(F) of the Information Technology Act, the police have submitted it before the 1st Additional Chief Metropolitan Magistrate Court, they said.



Four dead in building collapse

Junagadh: Four bodies were recovered from the rubble of a two-storey dilapidated building that collapsed Monday afternoon in Gujarat's Junagadh city and the search and rescue operation to locate more people who may be trapped was underway, officials said. The building on Datar Road collapsed at around 1pm, the incident coming two days after the city saw very heavy rains that caused widespread flooding. "Four bodies have been recovered so far from the rubble. The search and rescue operation is underway. We cannot say how many people are feared trapped in the debris," Inspector Nirav Shah of A Division police station said.

Meghalaya CM's office attacked

Menstrual hygiene: **SC** warns states

New Delhi: The Supreme Court Monday warned the states, which are yet to submit their response to the Centre on forming a uniform national policy on menstrual hygiene for girls studying in schools, it will take recourse to the "coercive arm of law" if they failed to do so by August 31. The warning came after the Centre informed the apex court it has so far received the response of only four states. A bench headed by Chief Justice D Y Chandrachud directed the states and Union Territories (UTs), which have failed to submit their responses to do so positively by August 31.

Asiatic lion dies

Amreli: An Asiatic lion, which was injured after being hit by a goods train in Gujarat's Amreli district three days ago, died while undergoing treatment, an official said Monday. An Asiatic lion was killed and another injured after they were hit by a goods train near Uchaiya village of Rajula taluka in Amreli in the early hours of July 21.

SC refuses to put Assam delimitation exercise on hold

New Delhi, July 24: The Supreme Court Monday refused to stay the ongoing delimitation of Assam's 14 Lok Sabha and 126 assembly seats by the Election Commission and sought the response of the Centre and the poll panel on a batch of petitions on the issue.

A bench of Chief Justice D Y Chandrachud and Justices J B Pardiwala and Manoj Misra, however, agreed to examine the constitutional validity of Section 8A of the Representation of the People Act, 1950 empowering the Election Commission to undertake the delimitation of constituencies.

"At this stage when delimitation has commenced, having due regard to issuance of the draft proposal on June 20, 2023, it would not be proper to interdict the process at this stage. Hence while reserving the constitutional challenge, we are not issuing any orders restraining the Election Commission to take any further steps," the bench said in its order.

The bench took note of the submissions of senior advocate Kapil Sibal, who was appearing for the political parties which have filed the petitions, that now all states will follow suit and take steps since the way has been cleared for the delimitation exercise for states like Arunachal Pradesh and Nagaland.

"We will list this immediately after the Delhi services ordinance case," the CJI said. Ten leaders representing nine op-

position parties in Assam Congress, Raijor Dal, Assam Jatiya Parishad, CPI(M), CPI, TMC, NCP, RJD, and Anchalik Gana Morcha- recently filed a plea in the top court challenging the ongoing delimitation process.

Two other pleas are also pending before the court on this issue. The petitioners have specifically challenged the methodology adopted by the poll panel and its proposals notified on June 20, 2023. One of the pleas challenged section 8A of the Representation of People Act, 1950, based on $which \, the \, poll \, panel \, exercised \, its \,$ power to conduct the delimitation process in Assam.

NIA to probe Ram Navami violence

New Delhi, July 24: The Supreme Court Monday refused to entertain a plea by the West Bengal government challenging the Calcutta High Court order handing over the probe of incidents of violence in March and April this year during Ram Navami celebrations in the state to the NIA.

A bench headed by Chief Justice DY Chandrachud noted the validity of notification issued in May by the Centre under section 6(5) of the NIA Act has not been challenged in the matter. Section 6 (5) of the NIA Act says if the central government is of the opinion that a scheduled offence has been committed which is required to be investigated under this Act, it may, suo motu (on its own), direct the agency to investigate it.

The bench, also comprising Justices J B Pardiwala and Manoi Misra, observed that at this stage the court is not called upon to either decide on the sufficiency of the allegations or their veracity. The remit of this court would be to determine as to whether exercise of its jurisdiction by the Central government under section 6 (5) is so completely extraneous to the powers conferred upon it by section 6 (5) so as to warrant intervention by this court," the bench said

When the ex-minister reached the assembly during Zero Hour BJP MLAs had already raised the issue of the diary, which Gudha had talked about a day earlier.

He said all the cheetahs are healthy. The cheetahs whose radio collars have been removed are identified as Gouray, Shourya, Pavan, Pavak, Asha and Dheera, the release said. "For the purpose of health examination by the veterinary team of Kuno along with experts from Namibia and South Africa, radio collars of six cheetahs have been removed," stated the official release issued on Saturday.

Under Project Cheetah, a total of 20 radio-collared animals were imported from Namibia and South Africa to KNP Later, four cubs were born to the Namibian cheetah 'Jwala'. Out of these 24 felines, eight including three cubs have died.

However, officials are not counting the lone surviving cub among the cheetahs. According to them, the current number of cheetahs in KNP is 15.

he law may be an ass but it kicks butt. Thus it was that a bunch of flog-happy cops who last October played God to handsome applause from their political bosses find themselves staring down the wrong end of the justice dispensing barrel now.

The Gujarat High Court was not a wee bit amused when a contempt of court application filed by some members of the minority community, arrested for stone pelting and allegedly flogged in public came up before it this month. "The application cannot be rejected without verification of facts", a division bench of Justices A.S. Supehia and M.R. Mengdey said while ordering an inquiry by the chief judicial magistrate of Kaira district and directing that a pen drive containing video and photographs of the incident be made available to the judicial officer. They had been arrested for allegedly pelting stones at a garba in a village.

A subsequent inquiry by the Inspector General of Police had, prima facie, brought out involvement of six of the 13 cops but was silent about the role of the rest. The report has to be filed in three weeks and the matter comes up for hearing on August 8. Soon after a video of the flogging incident went viral, Gujarat Home Minister Harsh Sanghavi had appreciated and praised the state police for their action. "The Gujarat police has done a nice job and the people should express their gratitude towards it on social media", he has been quoted as



saying in media reports. BJP general secretary, Pradipsinh Vaghela opined likewise."If such things happen, the police should act similarly", he went on record stating. Former IPS officer Kiran Bedi who was also Puducherry Lt. Governor till 2021, however slammed the Gujarat police for the public flogging. "The police cannot take the law

into their hands", she articulated on record. The utterance of the Home Minister, who is a constitutional post holder, is also fraught with a potential recoil effect if it comes within the ambit of a judicial evaluation.

This is not the sole case of public flogging by the Gujarat cops involving the minority community members. Last week (July 17), the Gujarat High Court issued notice to the state government for its reply on a PIL seeking an inquiry into a June 16 incident of public flogging of alleged rioters in the Junagadh mob violence.

The PIL by Lok Adhikar Manch and Minority Coordination Committee through advocate Anand Yagnik seeks registration of an FIR against police personnel and officers responsible for

the incident and for ransacking of moveable property of suspects allegedly involved in the violence.

Violence broke out in Junagadh on June 16 following the issuance of demolition notice by local civic body to certain Islamic religious places on the ground that they were encroaching on public roads. Stone pelting erupted. A bystander was killed and some policemen injured. Arrests were made and videos of the flogging of people in front of the dargah were

Israeli Parl passes law to limit judicial power

Jerusalem, July 24: Israeli Parliament Monday approved a contentious law that prevents judicial checks on political power and forms a key part of Prime Minister Benjamin Netanyahu's plan to reshape the country's justice system, after weeks of unprecedented protests that have crippled the Jewish state.

Multiple last-minute attempts within the Knesset to amend the bill or to come to a broader procedural compromise with the opposition failed.

A series of ideas for unilaterally softening the legislation, discussed by Prime Minister Netanyahu and key coalition leaders even as the Knesset was preparing to vote, also led

The vote followed almost 30 hours of continuous floor debate that began on Sunday morning. During that period, hundreds of thousands of protesters took to the streets, both for and against curbing judicial checks on political power. The Times of Israel newspaper reported.

According to the law's text, courts are prohibited from exercising any scrutiny over the "reasonableness" of cabinet and minister decisions, including appointments and the choice to not exercise vested authorities,

it said. The protesters have been demanding that the government shelve its contentious judicial overhaul initiative that will curtail the power of the courts to oversee the executive and legislative branch's decisions.

The "reasonableness" bill would remove the power of the Supreme Court to overturn government decisions which it deems to have gone too far.

Prime Minister Netanyahu, 73, was discharged from the hospital Monday after undergoing a successful procedure to implant a pacemaker, just ahead of a critical vote in the Knesset. Congratulating coalition party

leaders, Justice Minister Yariv Levin after the final vote, said that it was the "first step" towards correcting the judicial system. "In an extraordinary move, we took the first step in the historical process of correcting the

judicial system and restoring the powers taken from the government and the Knesset over many years," Levin said.

North Korea fires ballistic missile

Seoul. July 24: North Korea fired at least one ballistic missile into its eastern sea, South Korea's military said Tuesday, adding to a recent streak in weapons testing that is apparently in protest of the US sending major naval assets to South Korea in a show of force.

South Korea's Joint Chiefs of Staff did not immediately say where the weapon was launched from and how far it flew.

The launch came hours after South Korea's navy said a nuclear-propelled US submarine the USS Annapolis — arrived at a port on Jeju Island. The arrival of the USS Annapolis adds to the allies' show of force to counter North Korean nuclear threats. Last week, the USS Kentucky became the first US nuclear-armed submarine to come to South Korea since the 1980s. North Korea reacted to its ar-



rival by test-firing ballistic and cruise missiles in apparent demonstrations that it could make nuclear strikes against South Korea and deployed US naval vessels.

New Delhi, July 24: More than four crore income tax returns (ITRs) have been filed so far for fiscal 2022-23 and more than half of them have been processed leading to issuance of 80 lakh refunds, CBDT chairperson Nitin Gupta said Monday.

Gupta also said that the "shortage of manpower (in the department) at every level was impeding our efforts to give even better results" as he urged the Union finance minister for a 'quick approval" of the department's cadre restructuring proposal.

He was speaking at an event held here to mark the 164th Income Tax Day. The Central Board of Direct Taxes (CBDT) is the administrative authority for the I-T department.

Gupta said the direct tax collection, that includes personal income tax and corporate tax among others, has been making "remarkable" strides as the department collected more than ₹16.61 lakh crore in taxes during 2022-23 fiscal and this was 17.67 per cent higher as compared to the preceding year.

This collection "surpassed" both the budget and revised estimates set by the government for revenue collections under the direct taxes category and this is a testament of the hard work of our cadre, he said.

'We are currently growing at the rate of 16 per cent (for direct tax collection) over the last year. We had 7.78 crore income tax returns filed during 2022-23 financial year and this was an increase of 6.5 per cent over the previous year," the CBDT head said.

The deadline for filing ITRs for different categories of taxpayers is a week away at July 31.



ITC to hive off hotels biz

New Delhi, July 24: Diversified entity ITC Ltd Monday said it will demerge its hotels business by incorporating wholly-owned subsidiary ITC Hotels Ltd, paving way to attract appropriate investors and strategic partners.

With the company's hotels business maturing over the years, the company said the vertical is ready to chart its own growth path as a separate entity in the fast-growing hospitality industry.

"The Board of Directors of ITC Ltd at its meeting held on July 24, 2023, evaluated and discussed various alternative structures for the hotels business. After due consideration, the board accorded its in-principle approval to the demerger of hotels business under a scheme of arrangement," the company said in a regulatory filing.

Its board has also approved the incorporation of the whollyowned subsidiary ITC Hotels Ltd, which will handle its hotels and hospitality business.

ITC said it will hold about 40 per cent stake in the new entity and the balance shareholding of about 60 per cent would be held directly by the company's shareholders proportionate to their shareholding in it.

The scheme of arrangement shall be placed for approval of the board at its next meeting to be convened August 14, 2023.

ITC said, "The demerger will help the new entity in attracting appropriate investors and strategic partners/collaborations whose investment strategies and risk profiles are aligned more sharply with the hospitality in-

Besides, it said, "The proposed reorganisation would ensure continued interest of the com-

It added two new brands,

'Mementos' in the luxury lifestyle segment and 'Storii' in the premium segment recently to offer varied experiences to new age travellers.

In 2017, ITC had decided to adopt an 'asset-right' strategy which envisages a substantial part of incremental room additions to accrue through management contracts.

As per data available on BSE, in the year ended March 31, 2023 ITC's hotel business had clocked a revenue of ₹2,689.12 crore, up from ₹1,347.66 crore in FY22.

"After 2 years of pandemic led disruptions, the Indian hospitality industry has bounced back strongly with significant improvement in room rate and occupancy. ITC's hotels business has also emerged stronger and has delivered robust growth and margin expansion in FY 2022-23 and is well poised to sustain the growth momentum," the company said.

New Delhi, July 24: The government has ratified the rate of interest at 8.15 per cent rate on deposits under the Employees Provident Fund scheme for the financial year 2022-23. Retirement fund body EPFO

March 28, 2023, had marginally raised the interest rate on employees' provident fund (EPF) deposits to 8.15 per cent for 2022-23 for its over six crore subscribers. As per an official order issued

Monday, the EPFO has asked the field offices for crediting the interest at 8.15 per cent on EPF for 2022-23 into the accounts of members.

The order came after the finance ministry's concurrence to the EPF rate of interest approved by EPFO trustees earlier in March this year.

In March 2022, Employees' Provident Fund Organisation (EPFO) had reduced the interest rate on EPF deposits for 2021-22 to a four-decade low of 8.10 per cent from 8.5 per cent in 2020-21.

This was the lowest since 1977-78, when the EPF interest rate stood at 8 per cent.

Hussain backs Anderson

London, July 24: Former England captain Nasser Hussain has said he would play veteran fast bowler James Anderson in the fifth and final Ashes Test at The Oval starting from Thursday unless he thinks that his time in international cricket is over.

Anderson was rested for England's three-wicket win at Headingley but returned to their side for the fourth Test at Manchester to pick figures of one for 81 in 37 overs. In the ongoing series, Anderson has taken just four wickets in three matches at an average of 76.75.

"What I do know is that Anderson has had two or three average games this summer and, over the course of his career, he has tended to bounce back from such displays, so I would play him unless he himself feels that he is finished at international level. Only the individual knows when the time is right to retire, whether they are physically and mentally done.'

'Yes, Anderson's wickets cost 32 runs apiece there, considerably more expensive than his career mark of 26 — but four months ago he was the No.1-ranked bowler in the world and although it might be the oldest cliche, class is permanent," wrote Hussain in his column for Daily

Anderson will be facing tough competition from Ollie Robinson or Josh Tongue to hold on to his place in the playing eleven for The Oval Test, during which he will be turning 41.

"There are only so many times you can go to the well, only so many times you get out of bed, strap those bowling boots on and go again.'

"That point will come for



Anderson, but I don't see in his body language that he's running on empty. He's just performing a bit below par. When a great is a bit below par, it would be very unfair — wrong, in fact — to leave him out. Great cricketers just deserve that little bit more, in keeping with their mighty efforts," added Hussain.

In 182 Test appearances, Anderson has picked 689 wickets. Hussain feels Anderson could have made an impact if he was

played at Headingley. "But I do know that in this series, the first two pitches were unresponsive, with no lateral movement. I couldn't think of a worse combination for someone like Jimmy.

'Remember, he missed out on the spiciest pitch of the series at Headingley. I don't see a massive drop-off in his pace, he just hasn't done as much with the ball this year as in previous years and I cannot put my finger on why. Maybe it's not a summer of swing.'

"My gut feeling looking at him is that he is not a cricketer who is done, but the England selectors should pick what they believe is their best team and avoid any thoughts of heading down the romantic route. Now they must pick their best side, in the knowledge that for the last 15 years Anderson has always been in it," he conPRESS TRUST OF INDIA

Sindhu, Prannoy keen to regain lost touch



Tokyo, July 24: Fresh from their Korea Open triumph, Satwiksairaj Rankireddy and Chirag Shetty will look to continue their dream run, even as the focus will be on the struggling PV Sindhu and HS Prannoy in the Japan Open Super 750 badminton tournament, beginning here Tuesday.

The 2022 Commonwealth Games-winning Indian doubles pair of Satwik-Chirag Sunday stunned World No.1 pair of Fajar Alfian and Muhamad Rian Ardianto in a hard-fought final to extend their winning streak to 10 matches.

They have been in the form of their career, winning the Swiss Open, Asian Championships and Indonesia Open this year as the third-seeded Indians face Leo Rolly

Indonesia in the opening round.

Exactly a year before the Paris Olympics, the biggest talking point in the Indian badminton circuit has been that of the wobbly form of Sindhu. The twotime Olympic medallist and former World Champion has been a shadow of her past post her injury rehab and has dropped to World No.17 following her first round exits in six of the 12 BWF World Tour events this year.

The latest was in Korean Open last week where she lost to lowerranked Pai Yu-Po under the guidance of her high-profile new coach Muhammad Hafiz Hashim, the 2003 All-England champion.

Sindhu has been error-prone and struggling to finish points even against lower-rung players. She will have to work on her fast, attacking game to up the

This time, Sindhu's opening round hurdle will be Zhang Yi Man, against whom the Indian won in the Malaysian Open quarters, en route to her semi-final finish in May this year.

With the latest win, Sindhu has a 2-2 win-loss record against the 20th ranked Chinese, and she would look to make up the lost ground. But should Sindhu overcome the first round hurdle, she is likely to be up against her nemesis Tai Tzu Ying who has beaten the Indian nine times in a row in recent past in her 19-5 win-loss record.

Prannoy, who won his maiden BWF World Tour title at the Malaysia Masters in May, remained India's top-ranked player but dropped two spots to 10th. Prannoy, who lost in the second round at the Korea Open last week, is seeded Li Shi Feng of China.

Kidambi Srikanth is up against Chou Tien Chen of Chinese Taipei. If they overcome their respective opening round hurdles, Prannoy and Srikanth will clash in the battle for the quarterfinals where either of them may face the toughest test, up against top-seeded Viktor Axelsen.

The tournament will also mark the return of ace youngster Lakshya Sen, who took a break and skipped Korea Open after winning the Canada Open earlier this month.

Upcoming youngster Priyanshu Rajawat and Sen are up against each other in an all-Indian opening round clash. Should Sen get past Rajawat, he may face a tough test in secondseeded Anthony Sinisuka Ginting of Indonesia in the next round.

Siraj's spell in the morning session allowed India to bowl out the West Indies for 255 in their first innings. In the series opener. India defeated the West Indies to secure their first win of the WTC 2023-25 cycle.


AKSHAY CLINCHES HIS FIRST PGA TOU

Truckee (California), July 24: Akshay Bhatia birdied the closing hole in regulation, then capitalised in sudden death when Patrick Rodgers found a divot in the fairway to win his first PGA Tour title at the Barracuda Championship Sunday.

The 21-year-old Bhatia, who turned pro at 17, earned full status on tour and a spot in the FedEx Cup playoffs. He had been playing under special temporary membership since his runner-up finish at the Puerto Rico Open in March.

"It's obviously been a really tough road. I've had a lot of up, a lot of down. A lot of good, a lot of bad," Bhatia said. "But I knew I was going to get here. It was just matter of time. For it to happen this year with special temporary membership and now to get to play all these events and



to get it done today was, I can't even describe it.

Bhatia converted a birdie from about 15 feet on the par-4 18th

hole at Tahoe Mountain Club to finish with 40 points under the modified Stableford scoring system that awards five points for eagle and two for birdie while deducting a point for bogey and three for double bogey. The slender left-hander had nine points on Sunday. He made double bogey on the par-4 fifth hole, then made six birdies without a bogey from there.

That was good enough to match Rodgers, who missed a birdie attempt from roughly the same distance on the 18th. Rodgers scored six points in the final round, with one birdie and two bogeys on the back nine for zero points.

In the playoff, Rodgers' tee shot on the 18th settled in a divot and he chunked his approach. His pitch was well short and he two-putted for bogey. Bhatia left his birdie putt just short and tapped in for the victory.

HISTORIC FINISH

Hoylake (UK): India's Shubhankar

Sharma produced the best-ever result by an Indian at golf's oldest Major, the Open Championships, as he finished tied-eighth here Sunday. Sharma, playing his third Open, was the only player on the final day logging a bogey-free round of 1-under 70 for a total of 5-under 279. He finished Tiedeighth, earning a recall to the Open in 2024 also. Sharma's result was also the second best by an Indian in any Major behind the T-5 by Anirban Lahiri at the 2015 PGA Championships. Jeev Milkha Singh was also T-9 at the 2008 PGA Championships. The previous best by an Indian at an Open was T-27 by Jyoti Randhawa in 2004 at Royal Troon, where the Open returns next year. The runaway winner was the short lefthander from the United States.
