20 DIE IN MAHA **CRANE MISHAP**

Mumbai, August 1: At least 20 persons, including 10 labourers, were crushed to death and three others injured as a girder launcher collapsed during the construction of a viaduct for the Samruddhi Expressway in Maharashtra's Thane district early Tuesday morning, officials said.

The girder launcher along with a segment launcher (crane), weighing 700 tons, came crashing down from a height of 35 metres, the Maharashtra State Road Development Corporation (MSRDC) said in a release.

The deceased included two engineers, said the MSRDC, the executing agency of the expressway project that links Nagpur with Mumbai.

Thane police registered an offence against two contractors for allegedly causing death by negligence following the inci-

The incident occurred sometime after midnight at Sarlambe village in Shahapur tehsil, around 80 km from Mumbai.

The three injured persons were being treated at Chhatrapati Shivaji Maharaj Hospital at Kalva in Thane.

FRESH VIOLENCE ROCKS HARYANA

Gurugram/Chandigarh, August 1: Mobs killed a cleric in a late night attack on a mosque, torched an eatery and vandalised shops as communal violence that began in Haryana's Nuh spilled over into Gurugram, taking the death toll to five, police said Tuesday.

A mob set fire to an under-construction mosque in Gurugram's sector 57 and shot dead the naib imam past Monday midnight. And two more men succumbed to

their injuries after the previous day's Nuh attack.
Over 50 people, including 10 policemen, were injured in Mod in Nuh, a police officer said. Haryana Chief Minister Manohar Lal Khattar called the attack a part of a larger conspiracy, while the Vishva Hindu Parishad

demanded a probe by the National Investigation Agency. Authorities clamped a curfew Tuesday morning in Nuh district. Security forces held flag marches in adjoining districts as well and several peace committee meetings

On Tuesday afternoon, a mob shouting 'Jai Shri Ram' slogans set fire to a roadside eatery in Gurugram's Badshahpur. A couple of shops in the market nearby were also vandalised, police said.

The fire brigade doused the flames. When police reached the spot, the rioters - said to be around 70 - fled on their motorcycles and other vehicles, officials said.

Traders downed shutters along the 20-km Badshahpur-Sohna road, protesting over the Nuh violence.

In Delhi, VHP joint general secretary Surendra Jain claimed the attack was carried out against Hindu devotees "in a pre-planned manner" and was "incited" by some Congress leaders from Haryana.

BJD supports NDA on Delhi services ordinance, opposes no-confidence motion against Modi govt

New Delhi, August 1: Shedding its equidistance stance, the Biju Janata Dal (BJD) Tuesday extended its support to the Bill replacing the Delhi services ordinance in a boost to the treasury benches, especially in Rajva Sabha, and also backed the BJPled NDA government against the no-confidence motion brought by Opposition parties.

BJD is the second party after the YSR Congress among those not formally aligned with either the BJP or the Opposition to announce support to the Centre on the Government of National Capital Territory of Delhi (Amendment) Bill, 2023, dealing a blow to the Opposition's efforts to stitch together a majority in the Rajya Sabha where the treasury benches lack a ma-

jority on their own. On Tuesday, when the government was facing ferocious attacks from Opposition parties challenging the 'legislative competence' of the Parliament to bring the Bill, the BJP-led government found an unusual but firm support from BJD MP Pinaki Misra. "The government has

Around 109 MPs comprising those from the 26-member opposition bloc INDIA besides the BRS and some Independents are expected to vote against the Bill.

Of the 26 parties from the Opposition grouping, at least 18 have a presence in the Rajya Sabha and have 101 MPs collectively.

With the BJP having 305 members on its own in Lok Sabha, the government faces no threat from the Opposition on either the Bill or the no-confidence motion. The BJD has 12 members in the Lower House.

Meanwhile, hitting out at BJD over its support to the NDA government in Parliament, Congress campaign committee chairperson in Odisha Bijay Patnaik claimed the BJD has 'surrendered' before the BJP. "Now, the BJD stands exposed. It's not with the INDIA alliance and has surrendered before the BJP," he said. Patnaik also said that BJD considers women of the state as its vote bank. "It claims that it has the highest respect for women. Then what about the women of Manipur?"

BJPMP from Bargarh, Suresh Pujari, said, "We urged all the House members to support the NDA on the Delhi services ordinance. When the Centre has been ensuring all-round development of Odisha, how could the BJD refrain from supporting it?"

HIGHEST AUG RAIN IN CITY SINCE 1997

Bhubaneswar, August 1: Odisha received heavy rainfall due to the prevailing weather conditions, with the state capital Bhubaneswar witnessing a record rainfall of 259.2mm in the last 24 hours till 8.30am, Tuesdayhighest in August since 1997, the regional centre of the IMD said.

"This was the highest rainfall Bhubaneswar has received in the month of August to date. It broke the previous record of 254.2 mm of rainfall received August 20, 1997," said US Dash, a scientist at the Regional Meteorological Centre, Bhubaneswar.

Odisha received heavy rain as a well-marked low pressure area in the Bay of Bengal first intensified into a depression and later into a deep depression Tuesday, the IMD said.

The weather office said that rough sea conditions will prevail and warned fishermen against venturing into the sea till Wednesday afternoon.

The weather office said that under its impact, squally conditions are likely to prevail, with wind speed reaching 45-55 kmph, gusting up to 65 kmph along and off Bangladesh-West Bengal coasts. The wind speed is likely to increase to 55-65 kmph, gusting to 75 kmph over the next 12 hours.

TOP COURT RAPS STATE POLICE, SUMMONS DGP

New Delhi, August 1: Observing there is complete breakdown of law and order and constitutional machinery in Manipur, the Supreme Court Tuesday rapped the state police for 'tardy' and 'lethargic' probe of incidents of violence, especially those targeting women, and summoned the DGH to answer its queries August 7.

Excoriating the law enforcement machinery over unbridled ethnic violence, it said the state police have completely lost control over the law and order situation, and sought details from the state government in a "tabulated format" segregating cases involving murder, rape, arson and loot, destruction of house and property, places of worship, and outraging of modesty of women.

The Centre, represented by Attorney General Venkataramani and Solicitor General Tushar Mehta, urged the bench headed by Chief Justice DY Chandrachud that instead of the two FIRs related to a video showing women being paraded naked by a mob, all 11 out of 6,523 FIRs linked to violence against women and children may be transferred to the CBI and tried out of Manipur.

Hearing a clutch of petitions on the mayhem in the northeastern state, a bench, also comprising justices J B Pardiwala and Manoj Misra, said it was considering setting up a committee comprising former high court judges to monitor the probe and the subsequent trial in all FIRs as it will be difficult for the CBI to handle them alone.

'World's oldest man' dies at 127

Jose Paulino Gomes reportedly lived through both world wars & 3 global pandemics

Minas Gerais (Brazil), August 1: A man widely believed to be world's oldest has died at the ripe age of 127, Mirror reported quoting local media in his home country of Brazil.

Jose Paulino Gomes passed away Friday — one week shy of turning 128 at his home in Pedra Bonita, a Brazilian municipality in the state of Minas Gerais.

According to reports, the centenarian was still riding horses up until four years ago, it said.

According to his 1917 marriage certificate from Pedra Bonita's registry office, Jose was born August 4 1895. If his claim about his age is correct, that would mean Gomes was born before the death of Queen Victoria, living through both World Wars and three global pandemics.

Willvan Jose Rodrigues de Souza, who is a legal adviser to Cartorio Silva, said, "According to the record, he got married at 22 years old. It is presumed that he was indeed born before 1900. Men rarely got married at 17.


The current record holder, according to the Guinness World Records, is Spain's Maria Branyas Morera, who is 115. Records over Gomes's age, however, clash with previous records which state French woman Jeanne Calment to have been the oldest person to have lived, dying aged 122 in 1997. It's unclear whether his age will be looked into and verified by Guinness World Records.

Jose's granddaughter Eliane Ferreira said, "Here in the countryside, people are usually registered when they are older. There are several cases with incorrect documentation. But his docu-

mentation showed he was younger than he actually was.

'There is a lady nearby who is 98 years old. She says she knew him when he was just a boy. That's when we became curious to confirm his age and looked up the registry office to find out what was correct," Ferreira said, adding, "He definitely was over 100 years old, at least 110. Now we need to know how it will be recorded on the death certificate.

Widower Gomes had previously worked as an animal tamer, his family said. He leaves behind seven children, 25 grandchildren, 42 great-grandchildren, and 11 great-greatgrandchildren.



CB officer for hotel cybercrime plaints

Bhubaneswar, August 1: Amidst the rising incidents of cyber fraud hitting the hotel industry, the Crime Branch (CB) of state police and Odisha Hotel & Restaurants Association of Odisha (HRAO) have decided to appoint separate nodal officers to establish better cooperation between police and hotels for information sharing and prompt action against cyber criminals.

The decision was taken during a meeting between senior CB officials and office bearers HRAO at the Cyber Complex here Tuesday.

The HRAO will appoint 2-3 professionals having technical expertise while a dedicated CB official will work as nodal officer for better coordination and detection of cybercrime cases, it was decided.

This apart, hotel authorities will also be trained by the police to tackle cybercrime activities in hotel industry.

"During the meeting it was decided to appoint nodal officers from both sides for prompt flow of information and swift action on the part of police. CID-CB will organise training session for hotel staff to update them about handling such cases and help-

ing the tourists," informed CB sources. The CB officials also urged the HRAO to inform police whenever they come across any cyber fraud incident concerning hotel room booking at the earliest for necessary legal action. The HRAO members were asked to sensitise tourists regarding the fraud during online booking.

The CB sought cooperation of hotel owners for better handling of such cases as many tourists who were cheated during online booking through fake websites rarely lodge any complaint with the police. Only two such cases relating to cyber fraud in hotel booking concerning two leading hotels of Odisha have been registered at the Cyber police station.

"It was ascertained that those two were not isolated incidents. There have been some more reported/ nonreported occurrences over a period of time," CB sources added.

The meeting chaired by CB-CID Additional DG Arun Bothra was attended by Shefeen Ahmed K IGP CB, and others. JK Mohanty and Jonathan Raul, chairman and vice-chairman of HRAO, along with others participated in the meeting.

Notably, the HRAO had recently sought intervention of the state government over the harassment caused to hoteliers and tourists during investigation of cyber offences. The HRAO alleged that cyber criminals are creating false websites in the name of various hotels and collecting money by confirming rooms without the knowledge of the real hotel man-

After that, scores of aspirants for the posts of ULB accountants staged a demonstration in front of their examination centre at Bhadrak Autonomous College July 30 alleging

'question paper leak'. The aspirants claimed that the question papers were leaked as they had noticed that the seal of the papers had been broken before the commencement of the examination. This also added to their resentment, the source added. One of the protesting aspirants alleged that government jobs are being sold out. He stated that there should be transparency in conduct of examinations by OSSC.

"The cause of fear is known to them. The Congress will hit the street and expose the link between the BJD and BJP. BJD is maintaining a double standard," he said.

Congress campaign committee chairperson in the state Bijay Patnaik claimed the BJD has "surrendered" before the

alliance and has surrendered before the BJP," he said.

Patnaik also said that BJD considers women of the state as its vote bank. "It claims that it has the highest respect for women. Then what about the women of Manipur," Patnaik asked.

BJD is the second party after the YSR Congress among those not formally aligned with either the ruling BJP or the opposition to announce support to the Centre on the Government of National Capital Territory of Delhi (Amendment) Bill, 2023, dealing a blow to the opposition's efforts to cobble together a majority in the Rajya Sabha where the treasury benches lack a majority on their own.

BJD has nine MPs in Rajya Sabha. YSR Congress also has as many MPs in the Upper House and the total support of their 18 MPs makes the passage of the Bill all but certain in the House.

"It will create an eco-system to facilitate research and studies anchored around preservation, promotion and propagation of the tribal language. Besides, activities such as publication, content creation and recognition will get momentum," Scheduled Caste and Tribes Development Minister Jagannath Saraka told reporters after the Cabinet meeting.

According to Falguni Sabar, a researcher from Gunpur, the lack of popularity also means that many tribal children drop out of school. "The only way this will

change is if the language is propagated with the government and community help," says Anusuya Gomango of Gulumunda Pakka village.

There are efforts to launch textbooks in the Saora language in government schools. Sabar of Soura Rella village says the new efforts will help tribal children learn their language in school.

Brundaban Sabar of Perupango village says dropout rates will decrease, which will help in reduction of tribal illiteracy. "Thus education will be easy for tribal children if every subject textbook will be published in their script. It will help in preservation and promotion of tribal culture," he adds.

However, the fight for prominence is not new for the Saora

A peek into history The Saora language belongs

to the Austroasiatic language family and is primarily spoken by the Saora tribal community. "Saora is one of the oldest

tribes in India and is also known by different names Savaras, Sabaras, Saura and Soura. Saoras belong to a primitive tribal group and stay in parts of Rayagada, Gajapati and other parts of Odisha, numbering somewhere around 10 lakh," says researcher Akhyaya Sabar.

Mangei Gomango of Marichaguda near Gunupur discovered the Sorang Sompeng script. The script has been passed down through generations within the community, its origins deeply rooted in cultural history.

Farmers claimed that they can be benefited if the state government implements the MSP for turmeric.

Sources said turmeric cultivated in Kandhamal district has been grown in this region for centuries by the tribals. The cultivation methodology adopted by the tribals is organic and environmentally resilient having high productivity. The turmeric grown here has very high curcumin content which is rich in anti-oxidant.

The turmeric is grown here in organic method. It has anti-inflammatory, antimicrobial and antioxidant properties which are effective treatment for a variety of skin conditions and stomach related ailments.

The curcumin present in the turmeric has the capacity to prevent dreaded diseases like cancer. The turmeric is manufactured, processed and marketed by Kandhamal Apex Spices Association for Marketing (KASAM).

The outfit has opened a small sales centre in Daringbadi and is selling the product. Tourists from in and outside of the state have a huge crush for Kandhamal turmeric. They never forget to buy it when they visit Daringbadi.

A handful of women self-help groups are processing the harvested turmeric and selling it in various fairs and tourist sites and earning handsome money. However, the farmers engaged in turmeric cultivation are always at the receiving end. They often resort to distress sale and sell it to middlemen and traders at throwaway prices due to lack of processing facilities and incentives for them by the state gov-

Bhitarkanika is home to 70 per cent of India's estuarine crocodile or saltwater crocodiles, conservation of which was started in 1975.

According to Bhitarkanika National Park authorities, mammals found in the place are leopard, wild boar, jungle cat, fishing squirrel, gangetic dolphin while reptiles found comprise turtles including Olive Ridley sea turtle, crocodile, lizard, water monitors, python, and king cobra. Around 166 species of birds have been spotted in the park.

Bhitarkanika is one of the richest storehouses of mangrove genes. Researchers have come across 11 of the 70 mangrove species, which were facing threat of extinction in the world, in the national park.

Culvert collapse: Three engineers suspended

Rayagada: The state government Tuesday suspended three engineers of Rayagada Rural Development department after five persons were killed when an under-construction culvert collapsed at Uparsaja village under Kalyansinghpur block of the district Monday. The suspended engineers are: Executive engineer Pradip Kumar Mohanty, assistant executive engineer Venkat Raman Muduli and junior engineer Rajesh Kumar Mandal of Rayagada RD department. Five persons including four minors were killed after the under-construction culvert over a nullah collapsed on them while they were bathing. Among them, two persons were a man and his minor son and another two were siblings. The deceased were identified as Lachhendra Miniaka, 50, his son Prince Miniaka, 4, two siblings Charan Miniaka, 8, and Suman Miniaka, 5, and another child Manok Kulesika, 5, of the area. Sources said Charan and Suman had recently lost their father. Heartbroken, their mother tried to commit suicide by consuming poison. She was rescued and admitted to the Kalyansinghpur Community Health Centre.

any disturbing questions arise out of the Supreme Court order granting bail to activists Vernon Gonsalves and Arun Ferreira in the Bhima Koregaon violence case in which several activists and lawyers were arrested in 2018 on the charge of being part of a Maoist conspiracy. There has been suspicion that the whole case was engineered to throttle free speech and spread terror among people by brandishing the stringent anti-terrorism law, the Unlawful Activities Prevention Act (UAPA.) A new term – urban Naxalite - was coined by right-wing forces to demonise such activists and advocates of free speech. The government machinery was deployed, armed with the draconian UAPA, to incarcerate government critics so that they languished in prison for years on end and thereby break the backbone of protests.

But, the SC order granting bail to the two accused tends to emphasise the fact that denial of bail should not be the norm. This is because mere preliminary assessment may expose the weaknesses of a case filed under UAPA. The law is open to be abused since it is extremely difficult – well nigh impossible – to get bail once its serious provisions are slapped on an accused. Under Section 43D(5) of the Act, no court can grant bail if there are reasonable grounds to believe the accusation is true. What is more, an apex court judgment in 2019 has ruled there cannot be a detailed analysis of the evidence at the bail stage and bail must be decided only on the "broad probabilities" of the case.

The legal position being that, it is, indeed, remarkable that the Supreme Court has now granted bail to Gonsalves and Ferreira on merits. The Court's analysis is revealing. While there was no credible evidence that the accused were part of a conspiracy, the Court has found that even the letters, in which their names figured, contained only thirdparty responses and none was recovered from them. What strengthens the cause of liberal thinking is the ruling that "mere participation in seminars by itself cannot constitute an offence under the bail-restricting Sections of the UAPA, with which they have been charged.'

The significance of the bail accorded by the court is that this is the first time in the Bhima Koregaon violence case that a court has recorded a finding that the accusations may not be true. This may have far-reaching consequences. By slapping UAPA on an accused the investigation agencies and the government more often than not tend to send the message across that they have strong evidence to buttress their case, while in reality the material they have on hand turns out to be too weak to prove one guilty. The bail granted to some other accused in the Bhima Koregaon case seems to point to the inescapable conclusion that the UAPA often becomes a tool to torture free thinkers and government critics into silence. For example, among those arrested in this case, lawyer Sudha Bharadwaj was released on "default bail", since the charge sheet could not be filed within the stipulated time. This only strengthens suspicion that there was no case against her at all. Telugu poet Varavara Rao got the benefit of bail on medical grounds. Writer and scholar Anand Teltumbde was released by the Bombay High Court which came to the conclusion that there was no solid evidence that he had received funds from a co-accused, as claimed by the police. The most tragic case was that of Jesuit Father Stan Swamy who was suffering from Parkinson's disease and died while in custody at the age of 84. The disease incapacitated him, yet the jail authorities did not allow him even to drink with a straw or sipper until there was a nation-wide outcry against the inhumanity.

The NIA had relied on letters and witness statements to claim that Gonsalves and Ferreira were part of a conspiracy and recruitment of persons to commit terrorist acts. But, the Bench of Justices Aniruddha Bose and Sudhanshu Dhulia found the evidence too weak. This only shows exaggerated and malafide claims by the prosecution in this case cannot bear judicial scrutiny. On top of it, there are reasons to suspect that some of the purported evidence may have been remotely planted on computers used by the accused. The revelation of the government's buying of the Israeli spyware, Pegasus, shows such ma-

nipulation of evidence is in the realm of possibility. The latest bail calls for a review of the mindless application of UAPA

in general and a re-assessment of the Bhima Koregaon case in particular.

Backronym

backronym (sometimes bacronym) is a reverse acronym. To create one, you take a word that isn't an acronym and create a fictitious expansion for it. Some backronyms are designed as mnemonics. A classic example is the Apgar score to test the health of newborns. It was named after the American physician Virginia Apgar but to help student doctors and nurses remember the system, it has been changed to the acronym "Appearance, Pulse, Grimace, Activity, and Respiration". Similarly, the US Amber Alert programme is said to mean "America's Missing: Broadcast Emergency Response", though it was actually named after a missing child. Amber Hagerman. Backronyms are frequently humorous — Microsoft's Bing, some quip, is actually an acronym for "Because It's Not Google"; world-weary sailors say navy really means "Never Again Volunteer Yourself", some car owners hold that Ford stands for "Fix Or Repair Daily". Many of this type are actually reinterpreted acronyms, included by courtesy in the backronym collection because nobody has yet come up with a different -nym for them. For example, the name of the one-time Belgian national airline Sabena (which derives from "Société Anonyme Belge d'Exploitation de la Navigation Aérienne", bless the guy who shortened it) was said to be an acronym for "Such A Bad Experience, Never Again."

■ Zograscope

he zograscope, consisting of a lens and mirror on a wooden stand, was a device of the eighteenth century for viewing what were called perspective prints - pseudo-stereoscopic images - sometimes also known as vues d'optique. It was named the Zograscope for reasons that are now lost to us. though it was also more variously and prosaically called a diagonal mirror, an optical pillar machine or an optical diagonal machine. The picture to be viewed was placed on a table and observed through a slanting mirror by means of a lens large enough to allow both eyes to see the picture at once. Its curved edges distorted the image to give a surprisingly good sensation of depth. The surviving examples are highly collectible pieces of elegant mahogany furniture, designed for the drawing rooms of well-to-do families who desired the latest in technology for their after-dinner entertainment. They wanted, to quote a catalogue of 1784, to look at "remarkable Views of Shipping, eminent Cities, Towns, Royal Palaces, Noblemen and Gentleman's Seats and Gardens in Great Britain, France and Holland, Views of Venice, Florence, Ancient and Modern Rome, and the most striking public Buildings in and about London". These pictures were available at a price of a shilling plain or two shillings coloured, a substantial sum for the period.

ASIA'S NET-ZERO TRANSITION

sian countries' ability to thrive in the world economy over the next few decades hinges on their capacity to sustain their competitive advantages through continuous innovation. But to meet their commitments under the 2015 Paris climate agreement, the region's economies must overhaul their production, consumption, and resourceallocation strategies, potentially postponing the long-anticipated "Asian century."

With the latest Inter-governmental Panel on Climate Change report showing that global warming is on track to rise 1.5° Celsius above pre-industrial levels within the next decade, the urgent need to accelerate efforts to mitigate climate change has moved to the forefront of

the international policy debate. In March, shortly after the United Nations warned that the "climate time bomb is ticking," a gathering of central bank governors from member states of the Association of Southeast Asian Nations (ASEAN) underscored the importance of aligning national policies to support the green transition. Two weeks later, the Spring Meetings of the World Bank and International Monetary Fund focused on the need to reform global institutions to address the climate threat. And at the end of April, more than 100 central bankers and regulators convened in Singapore to explore ways to reach the annual target of \$9.2 trillion in green investments required to achieve net-zero emissions by 2050

Amid conflicting domestic and global priorities, varying levels of climate-risk awareness, and a dearth of comprehensive climate data, the policy debate has been shaped by countries that are better equipped to manage the effects of climate change. Consequently, while the scientific and policy consensus is that cutting greenhouse-gas emissions is the only way to avert climate catastrophe, the impact of emission cuts on Asia's economies re mains uncertain.

There are two main approaches to cutting emissions:

reducing economic activity to lower energy demand and implementing industry-specific measures to mitigate emissions. It is easy to see why the first option, which means accepting slower economic growth, is a non-starter for many emerging and developing economies. But with fossil fuels accounting for more than 80% of energy use in China, Japan, South Korea, and ASEAN countries - collectively known as ASEAN+3 - the second path would have profound economic implications as well.

The most likely shock would be an increase in the cost of living. To discourage the use of fossil fuels, governments must make them more expensive, starting with the elimination of the energy subsidies that played a crucial role in supporting consumer spending across the region during the energy price shocks of early 2022.

But even if ASEAN+3 policvmakers resist domestic calls to impose a carbon tax, they may be compelled to act, owing to rapidly shifting climate policies elsewhere, such as the European Union's Carbon Border Adjustment Mechanism, which imposes tariffs on carbon-intensive imports. Either way, Asian exporters will face higher production costs and could be at risk of losing their long-established positions in global trade and supply chains.

Moreover, reducing greenhouse-gas emissions would require the retirement of many of the region's coal-fired power

plants well before they reach even half of their projected lifespan. On average, coal power plants have an operating life of roughly 55 years. While early retirement may not present significant challenges in Europe and the United States, where the average age of a coal-fired plant is about 34 and 41 years. respectively, the average coal plant in ASEAN+3 countries is just 11 years old

In addition to its significant costs, retiring coal-fired power plants could disrupt livelihoods and communities across the region. To mitigate the adverse socio economic effects of this shift, Asian policymakers must ensure a just transition that considers the impact on affected communities. But, given the potential impact of the net-zero transition on ASEAN+3 countries' finances, energy prices, and exports, the region will most likely face a period of challenging economic conditions before experiencing any improvements. Still, the net-zero transition is an unavoidable necessity. By taking proactive measures and facilitating the allocation of public and private funding to where it is needed most, ASEAN+3 policymakers could allay the potential impact and sustain the region's economic prosperity without undermining global climate-mitigation efforts.

To be sure, in recent years ASEAN+3 governments have made significant progress in promoting sustainable and green finance. But the lack of adequate

transparency, incentives, and data impedes policymakers' ability to establish a "greenium" that investors would be willing to pay for the perceived advantages of investing in environmentally friendly instruments.

The lack of a unified global approach to transition financing, which aims to help "brown" (carbon-intensive) sectors become greener, poses another challenge for policymakers. For example, an emissions-reduction project that meets the criteria for a bank loan in ASEAN+3 countries might not qualify for a similar loan in Europe. In the absence of global transition taxonomy, many for eign investors are understandably reluctant to bear the risk of policy uncertainty and rep utational harm associated with funding the region's "brown' sectors, despite their economic significance.

With the window for decisive climate action rapidly closing, some may question whether the "Asian century" is already passé. But while the shift away from fossil fuels may impede ASEAN+3 countries' progress toward achieving long-term economic prosperity, the net-zero transition is also a unique opportunity for Asian economies to boost growth and job creation. Countries such as China, with its flourishing electric-vehicle industry, and Vietnam, with its expanding solar capacity, are already capitalizing on growing demand for green energy.

Mobilizing capital is crucial to achieving net-zero emissions. As William Shakespeare reminds us, "If money go before, all ways do lie open." To create a greener and more resilient region, we must reimagine climate finance in a way that aligns with the unique characteristics of ASEAN+3 economies and unlocks their tremendous potential.

Women's World Cup provides lots of thrills

Women's World Cup, partly because there have been lots of goals scored, allowing countries from every continent to enjoy victories.

Actually, that's not quite true: the continent of Antarctica did not send a team, giving the flimsy excuse that it's too cold to play football. The World Cup has given us a

number of "firsts." It's the first time that two countries, Australia and New Zealand, have co-hosted a Women's World Cup. It's also the first Women's World Cup in the southern hemisphere, and the first Women's World Cup with 32

FIFA, the governing body of football, is determined to keep expanding the World Cup. The Women's World Cup began with 12 teams in 1991, expanded to 16 in 1999, and 24 in 2015. The men's World Cup has also gradually expanded and will allow 48 teams to compete in 2026, which means that even Antarctica has a chance.

Several countries have enioved their first victories ever at the World Cup. Portugal, New

m enjoying the 2023 FIFA Zealand, Morocco, the Philippines and Zambia gave their fans a chance to celebrate and raise a banner that said, "We finally beat someone!"

New Zealand recorded its firstever World Cup win, then made history again by becoming the first host nation to be eliminated at the group stage. In a matter of 10 days, Kiwi fans went from We finally beat someone!" to "Oh hell Australia is still in it'

My favorite result was Zambia's 3-1 victory over Costa Rica in their final match in the group stage. Both teams had been eliminated before the match, but it was nevertheless a historic match for Zambia. Making their first appearance at the World Cup, the Copper Queens, as they're known, recorded their first-ever goal and first-ever victory on football's biggest stage.

I spent most of my childhood in Zambia (my parents left India to teach there) and had waited several decades for Zambia to qualify for the World Cup. Does it matter to me that it took a women's team to finally put Zambia in the World Cup? Nope.

Sometimes women need to show men how it's done.

Does it matter to me that Zambia lost 5-0 to both Japan and Spain in its first two matches? Nope. The Copper Queens were just warming up. Sometimes it takes a few matches to find your rhythm.

One of the most significant "firsts" at the World Cup was recorded during the Morocco-South Korea match. Morocco, the first Arab country to qualify for the Women's World Cup, won the match 1-0, their first victory at the Women's World Cup. Nouhaila Benzina, a defender for the Atlas Lionesses, made history as the first woman to wear a hijab at a senior-level global tournament.

It was only in 2014 that FIFA overturned its ban on religious health coverings during official matches. Various athletes and activists had protested the ban, which was based on "health and safety" reasons.

"I have no doubt that more and more women and Muslim girls will look at Benzina and just really be inspired -- not just

the players, but I think decisionmakers, coaches, other sports as well," Assmaah Helal, a cofounder of the Muslim Women in Sports Network, told the Associated Press.

Many Muslim women are unwilling to compete in sports without a hijab. But if they're competing in France, for example, they can't wear a hijab, becauseFrance wants to maintain its status as a secular country.

As far as I'm concerned, religious or traditional clothing should be permitted at all sporting events, as long as athletes are wearing the clothing on their own free will and are not gaining any sort of competitive ad-

I was happy to hear about the recent "Goal in Saree" tournament in Madhya Pradesh. Maybe someday we'll see a team of sareeclad women at the World Cup.

It could certainly happen in our lifetimes, especially since FIFA may eventually expand the World Cup to 200 teams.

I'm already predicting the score: Saree team 5, Antarctica 0.

New Delhi, August 1: Bountiful rains in July gave Delhi its best air quality for the month in five years, while the average maximum temperature also dropped to its lowest level since 2016, according to official data.

The data from the India Meteorological Department (IMD) and the Central Pollution Control Board (CPCB) also shows that Delhi's average air quality index (AQI) this year so far is the lowest for the corresponding period since 2019, ex-

cept for 2020 - the year of the Covid-19 lockdown.

The city recorded 384.6 mm of rainfall in July, which is the second-highest in the month in the last 15 years, compared to the normal of 195.8 mm.

It gauged above-normal rainfall in the last four months -- 53.2 mm against a normal of 17.4 mm in March, 20.1 mm against an average of 16.3 mm in April, 111 mm against a normal of 30.7 mm in May and 101.7 mm against a normal of 74.1 mm in June.

The city experienced its highest rainfall (153 mm) in a single



day in July since 1982 July 8-9 due to an interaction of a western disturbance, "monsoonal" winds and cyclonic circulation over northwest India. It received an additional 107 mm of rain in the subsequent 24 hours.

According to CPCB data, the average AQI of Delhi for the January-July period in 2023 was

182.6, showing a significant improvement compared to 209 in 2022, 204.7 in 2021, 159 in 2020, and 215.3 in 2019. The average AQI in July was the lowest in five years. The AQI for July 2023 was 83.7, while it was 87.3 in 2022, 110.1 in 2021, 83.8 in 2020, and 134.1 in 2019.

On Saturday, Delhi recorded an average AQI of 59, the lowest so far this year.

According to the CPCB data, the daily average PM2.5 concentration in Delhi in July stood at 35 μ g/m3, compared to 36 in 2022, 40 in 2021, 34 in 2020, and 47 in 2019

Similarly, the daily average PM10 concentration for July 2023 was 77 µg/m3, in contrast to 82 in 2022, 107 in 2021, 77 in 2020, and 143 in 2019

Military veterans claim statutory body for Yamuna cleaning

New Delhi, August 1: A group of military veterans Tuesday demanded the establishment of a separate statutory body for cleaning the Yamuna river, which they claim is a "slow poison" for the people in the Delhi-NCR region.

The group, known as "Atulya Ganga," presented the results of a survey evaluating the river's health here, pointing out that the National Mission for Clean Ganga (NMCG) primarily focuses on the Ganga and lacks sufficient efforts to clean other tributaries, including the Yamuna. Colonel (retd) Mike Keshwar said the Yamuna requires its own agency due to the significant cleaning task, as the Ganga's cleanup itself is massive. The NMCG, established under an Act, aims to comprehensively clean the Ganga and its tributaries. The Atulya Ganga team collected samples from 29 critical locations along the Yamunanagar-Prayagraj stretch, testing them on 16 parameters related to water quality, including pH, turbidity, hardness, chloride, chlorine, iron, fluorides, bacteria, dissolved oxygen and

total dissolved solids.

Shockingly, only one sample was deemed "good," while 12 were of fair quality and 17 were poor. One of the key parameters of the river's health is the dissolved oxygen level, which is required to be four parts per million (PPM) or better.

million (PPM) or better.

The samples showed that the dissolved oxygen level was less than one part per million (PPM), signifying severe pollution, the veterans said. The group also aims to create a 'Yamuna Health Dashboard' using satellite data, remote sensing, Internet of Things and artificial intelligence. This will make a 24x7 "Water Quality Index of Rivers"

According to the Delhi government's Outcome Budget 29 per cent of the sewage generated in Delhi in 2021-22 fell into the Yamuna untreated

It was 28 per cent in 2019-20 and 26 per cent in 2020-21

The city government is upgrading and rehabilitating the existing STPs to be able to meet the prescribed norms and reduce the pollution load in the Yamuna

available in the public domain which will be an effective tool to report the pollution levels, pinpoint the sources of contamination and drive accountability, said Lt Gen (retd) Alok Kler, CEO, Atulya Ganga.

Experts say untapped wastewater from unauthorised colonies and jhuggi-jhopri clusters, and poor quality of treated wastewater discharged from STPs and common effluent treatment plants (CETPs) is the main reason behind high levels of pollution in the river in the Delhi-

NCR region.

The river can be considered fit for bathing if biological oxygen demand is less than 3 milligram per litre and dissolved oxygen is greater than 5 milligram per litre. Delhi generates around 770 million gallons a day (MGD) of sewage. The 35 STPs located at 20 locations across Delhi can treat up to 630 MGD of sewage and have been utilising around 85 per cent of their capacity. The rest of the untreated sewage

falls into the river directly.

Multiple reports submitted by the Delhi Pollution Control Committee (DPCC) to the Union Jal Shakti Ministry have highlighted that the river cannot become fit for bathing in the absence of a minimum environment flow -- the minimum quantity of water flow that a river must have in order to preserve its ecosystems and meet the bathing standards.

Politics to heat up in MP

Bhopal, August 1: The political environment in Madhya Pradesh is set to heat up in coming days as the state is gearing up for the Assembly elections to be held later this year and the main contenders - BJP and Congress - are in no mood to leave any stone unturned in their efforts to win the polls.

While the BJP's Central leadership has appointed three union ministers as state election incharges, party's key strategist and Union Home Minister Amit Shah has intensified his visits to the poll-bound state.

Shah has visited state capital Bhopal thrice in the last 20 days and held several rounds of highlevel meetings at party headquarters

quarters.

He will be addressing a gathering of BJP workers in Indore on Sunday.

State Home Minister Narottam Mishra, who is the minister incharge of Indore, along with national General Secretary and local leader Kailash Vijayvargiya is setting the stage for Shah to charge up the party cadres in Malwa-Nimar region of the state.

Shah was also supposed to visit Bhopal on Sunday, however the programme was later postponed, party sources told

ANS.

On the other hand, the Congress is also organising several programmes in Indore. On Sunday, former Chief Minister and party's state unit chief Kamal Nath will address a 'Adivasi Yuva Pachavat'.

Former Jawaharlal Nehru University Students' Union president and Congress in-charge of NSUI Kanhaiya Kumar will also be sharing stage with Kamal Nath. Reacting to Congress' Indore event, fire-brand BJP leader Narottam Mishra has said: "Kamal Nath will be sharing stage with those who supported 'tukde tukde' gang in JNU and shouted slogans to divide the country."

Mean while, Congress spokesperson Abbas Hafeez has said that he has written a letter to BJP President J.P. Nadda, and urged him to curtail the frequency of Shah's visit to Bhopal as the Union Home Minister's visit "leave the city shut for hours and triggers traffic snarls".

"Several parts of Bhopal city gets shut due to heavy security for the Home Minister, which the security agencies obviously have to do, but the public has to suffer due to this... Other Union Ministers also visit Bhopal regularly but disruption is not that much," he claimed.

MCD to float tender for procurement of drones

Drones and Artificial Intelligence-based platforms will be used this year as part of a comprehensive plan to combat dengue, with focused fumigation at monument sites, hotels and markets in Delhi, which will host the G20 Summit in September



New Delhi, August 1: The MCD will soon float a tender for the procurement of drones that will be deployed for monitoring and concurrent anti-larval spraying on major drains and far-flung areas to prevent the breeding of mosquito larvae, officials said.

Larvivorous fish will be released in water bodies to prevent mosquito larva breeding through the biological control method. Fogging will be carried out according to National Vector Borne Disease Control Programme guidelines, whenever required and keeping National Green Tribunal orders in mind, in an ecofriendly manner, the MCD had said.

BJP, Cong stick to 'survey formula'

Bhopal, August 1: In view of rising number of candidates for assembly elections to be held in Madhya Pradesh, both the major political parties -- Congress and BJP -- have decided to adopt the 'survey formula', which has become a cause of concern for ticket-seekers.

In the 2018 elections in Madhya Pradesh, out of 230 assembly seats, the Congress had won 114, while the BJP bagged 109. Congress did not get full majority but with the support of SP, BSP and Independent MLAs, it formed the government.

The Congress government led by Kamal Nath lasted only for about 15 months and collapsed after 22 MLAs under the leadership of Jyotiraditya Scindia joined the BJP. Keeping in mind the results of the 2018 assembly elections and the subsequent urban body elections, both the political parties are treading cautiously in view of the forthcoming assembly elections. At the same time, the ticket-seekers are visiting the party headquarters and politicians, in Bhopal and Delhi.

MP to add 'Baiga' among the most backward tribes

Bhopal, August 1: Madhya Pradesh Chief Minister Shivraj Singh Chouhan has announced to include the particularly vulnerable tribal group (PVTG) Baiga among the most backward tribes in the state.

Baiga also have sub-castes like - Bijhwar, Narotia, Bharotiya, Nahar, Rai maina and Kath maina. The largest number of Baiga tribes are found in Mandla, Balaghat, Singrauli and Shahdol districts of Madhya Pradesh.

According to the Ministry of Tribal Affairs, at least seven tribes communities (Abujh Maria, Baiga, Bharia, Birhor, Hill Korba, Kamar and Saharia) in Madhya Pradesh have been categorised under the PVTG.

"Particularly vulnerable tribal group (PVTG) Baiga of Singrauli district would be included among the most backward tribes," CM Chouhan said. He also announced to upgrade the existing 'Charan Paduka Yojana' scheme, which was introduced ahead of the assembly polls in 2018 under which, the government provides slippers, saris

and water bottles to 15 lakh tendu leaf pluckers of the state. Now, the government has decided to provide umbrellas to them and for this purpose, an amount of Rs 200 each would be given to each beneficiary.

"I used to feel bad when my sisters used to go barefoot in the forests to pluck tendu leaves and thorn pricked their feet. If the Chief Minister is their brother, why should his sisters walk barefoot? Keeping this in mind, we

have upgraded the Mukhyamantri Charan Paduka Yojana. Now, we have decided that umbrellas will also be given to the tendu leaf collectors. For this, an amount of Rs 200 each is being sent to their accounts," Chouhan said.

The Chief Minister made some tendu patta collectors wear slippers with his own hands.

He said, "The double-engine governments are constantly working for the service and welfare of the poor. Prime Minister Narendra Modi is providing free food grains, housing, health and all necessary services to the poor. Poor people, who are landless, are being given pattas underthe Mukhyamantri Awasiya Bhu-Adhikar Yojana in the state."



New Delhi, August 1: Amid a rise in cases of conjunctivitis and other eye infections in Delhi, doctors have advised people to take all precautions, especially in crowded places.

Cases of conjunctivitis and other eye infection are on the rise in Delhi, with many doctors cautioning that it is "highly contagious" and proper hygiene behaviour needs to be maintained to check its spread.

Some parents said, teachers have also advised them that their wards should not be sent to school if "if anyone in the house is having any kind of eye infec-



very contagious.

It spreads through physical contact, wherein an uninfected individual may contract the virus by coming into contact with the secretions from an infected person's eye and subsequently touching their own eyes, he added. "Presently, we can see a 20-25 per cent rise in patients coming to OPD these days," the

doctor said.

Dr Aarti Nangia, senior consultant, ophthalmology at Fortis Hospital, Vasant Kunj, also said there has been an "increase" in cases of eye infections and conjunctivitis in Delhi lately.

Delhi government-run hospitals are "on alert" to deal with cases of conjunctivitis, fungal infections and vector-borne diseases, Health Minister Saurabh Bharadwaj had said July 25.

Cases of conjunctivitis and skin allergy are mostly being reported from relief camps housing people affected by the flooding in parts of Delhi, Bharadwaj had earlier said.



'Biggest' darknet LSD cartel busted, 3 held

New Delhi, August 1: The Narcotics Control Bureau Tuesday claimed to have busted the "biggest" darknet-based LSD cartel operating in India with the seizure of more than 13,000 blots and Rs 26 lakh in cash and the arrest of three persons.

The cartel named 'Zambada' has a "high volume of business and supply chain" of this hallucinogenic category of drug and is also operating in the UK, the US, South Africa, Canada, Russia, Spain, Portugal, Greece and Turkiye, NCB Deputy Director General (operations and enforcement) Gyaneshwar Singh said.

The cartel was being operated by young educated men in the age bracket of 21-25 years, he said. It is the second LSD trafficking cartel busted by the agency in the last about three months, officials said.

The federal anti-narcotics agency had seized a cache of 15.000 LSD blots, the highestever catch in one operation, and arrested half-a-dozen people in

In continued operations, it was learnt that the largest cartel operating in LSD on the darknet - Zambada- operates from Delhi-NCR, Singh said. Two of

the ground operators of this cartel were identified through technical and human surveillance and this led to the location of the "mastermind" of this cartel who was operating from Ballabgarh (Faridabad) in Haryana, he said.

The NCB Delhi zonal office conducted multiple raids at the premises of these three persons leading to the seizure of 13,863 LSD blots, 428 grams MDMA (ecstasy), and the freezing of Rs 26.73 lakh "drug money", agency officials said.

The 'Zambada' cartel, according to the agency, was the "only" cartel in the country with a so-called "5-star rating". In a statement, the NCB said the drug cartels on the darknet are rated on a scale of 1-5 stars based on the potency of the drug sold through their platform and their "customer service"

Darknet refers to the deep hidden internet platform that is used for narcotics sale, exchange of pornographic content and other illegal activities by using the secret alleys of the onion router (ToR) to stay away from surveillance by law enforcement agencies

The NCB said the cartel's name is derived from "Ismael-Marlo Zambada Garcia", a Mexican drug lord, and he was the last remaining fugitive on the list of Mexico's 37 most wanted drug criminals. He carries a reward of up to USD 15,000,000, the agency said. The first time the name of this cartel was reported in the country was in September 2022 when the Hyderabad Police arrested eight people for drug trafficking using the darknet.

Bishnoi extradited from Azerbaijan

New Delhi, August 1: Gangster Sachin Bishnoi, who was allegedly involved in the murder of Punjabi singer Sidhu Moosewala, was extradited from Azerbaijan and brought back to India Tuesday, officials of the Delhi Police said.

He was produced in a Delhi court, which remanded him in police custody for 10 days. Officers from the Delhi Police's Special Cell had travelled to the Azerbaijan capital Baku to monitor the progress in the case.

"Bishnoi alias Sachin Thapan was successfully extradited from Baku and brought to Delhi on Tuesday morning," Special Commissioner of Police (Special Cell) HGS Dhaliwal said. Sources claimed that Bishnoi was involved in the conspiracy and handling of the logistics for the murder. He was abroad at the time of the killing but tried to mislead the investigators by claiming that he had shot Moosewala, they claimed.

"Bishnoi left India before the murder of Moosewala. He first went to Dubai on a fake passport issued in the name of Tilak Raj Tuteja with an address of Sangam Vihar in south Delhi.

"He helped in doing recce and also provided one of the vehicles used by the assailants. He tried to mislead the investigation as after the murder he claimed that he had killed the singer," a source claimed.

When he was in Dubai, he

thought that since India had good relations with the UAE, he could be extradited from there. So he had gone to Baku, the sources said. Bishnoi was detained in Azerbaijan last year in August and claimed that he was not in India when the incident occurred. The sources said that he had applied for bail in Azerbaijan which was rejected.

Bishnoi was named in a Maharashtra Control of organised Crime Act (MCOCA) case, an attempt to murder case at Mohan Garden police station and other cases with the Special Cell, Dhaliwal said.

Sachin Bishnoi and another accused Anmol Bishnoi, brother of gangster Lawrence Bishnoi, had fled the country using fake passports before Moosewala's murder. Gangster Goldy Brar was in touch with the assailants through the Signal application during the incident.

Earlier, the National Investigation Agency (NIA) had arrested Vikramjeet Singh alias Vikram Brar, a key aide of jailed gangster Lawrence Bishnoi, following his deportation from the UAE to India.

Vikram Brar was involved in the killing of Moosewala. He was also involved in cases of smuggling weapons and extortion in India with the help of dreaded gangsters Lawrence Bishnoi, Goldy Brar and others. Shubhdeep Singh Sidhu, popularly known as Sidhu Moosewala, was shot dead in Punjab's Mansa district on May 29, 2022.

The bench, which had reserved its judgement on July 7, said in its 101-page-long verdict, "We find the action of the state to be perfectly valid, initiated with due competence, with the legitimate aim of providing development with justice."

The judgement began with the note: "The action of the state in carrying out a caste survey... And the vigorous challenge raised to it on multiple grounds... Reveal that despite attempts to efface it from the social fabric, caste remains a reality, and refuses to be swept aside, wished away or brushed aside nor does it wither away or disperse into thin air."

The judgement, which came less than three months after the court had stayed the survey, shocked the petitioners who vowed to challenge the order before the Supreme Court."After studying the judgement, we will move the Supreme Court," senior advocate Dinu Kumar, counsel for one of the many petitioners, told reporters soon after the bench pronounced its verdict in an open court. The ruling 'Mahagathbandhan' (Grand Alliance) in the state, which had so far been content with a countrywide caste census being adopted as a key agenda by the opposition grouping INDIA, was predictably elated.





Typhoon lashes **Japanese islands**

Tokyo: A powerful typhoon approached Japan's southwestern island of Okinawa Tuesday, lashing the region with strong winds and high waves and forcing transportation to halt and stores to close. Slow-moving Typhoon Khanun, which means jackfruit in Thai, was heading northwest at speeds of 15 kph (9 mph) Tuesday night, packing surface winds of up to 180 kph (111 mph). It was at sea southeast of Okinawa's main island, the Japan Meteorological Agency said. The city office in the Okinawan prefectural capital of Naha was closed due to violent winds, while supermarket chains were either shut or operating under shorter hours.

Bangladesh reports 251dengue deaths

Dhaka:The death toll in the ongoing dengue outbreak in Bangladesh has increased to 251, of which 204 were reported in July alone, General of Health Services (DGHS). In its latest update, the DGHS also said that a total of 51,832 cases have been reported so far this year, reports Xinhua news agency The DGHS data showed 43,854 cases were recorded in July after 5,956 people were infected with the mosquitoborne disease in June. In the last 24 hours, a total of 2,694 fresh dengue cases, including 1,168 in Dhaka, were reported.

17 dead due to heat wave in SK

Seoul: At least 17 people died from an ongoing heat wave in South Korea over the weekend, mostly elderly farmers working outside in the extreme heat, authorities said. Since the season's first heat wave alerts went into effect in mid-June, the country has been gripped with sweltering heat, with recent highs at around 35 degrees Celsius in many parts of the country, reports Yonhap News Agency, According to the latest data from the Korea Disease Control and Prevention Agency, North Gyeongsang province was the hardest-hit, with seven elderly farmers killed.

Pak sees 18 suicide attacks so far this yr

Islamabad: Pakistan, which is grappling with a surge in suicide attacks, reported 18 such incidents in the first seven months of 2023 that killed more than 200 people and left over 450 others injured, a report said. The report was published, a day after an Islamic State suicide bomber triggered a powerful blast that killed at least 54 people at a political convention of a hardline Islamist party.

Russia accuses Ukraine of another drone attack

Tallinn (Estonia), August 1: Russian authorities early Tuesday accused Kviv of vet another attack on Moscow and its surroundings with drones, one of which hit a building in the capital that was damaged by a drone just days ago in a similar attack early on Sunday.

Russian officials have claimed that the intensified attacks on the capital region reflect failures in Ukraine's counteroffensive, while Ukrainian President Volodymyr Zelenskyy said over the weekend that "the war is gradually coming back to Russian territory," but stopped short of taking responsibility of the attacks.

The repeated drone strikes underscore Moscow's vulnerability as Russia's war in Ukraine drags into its 18th month.

The Russian Defence Ministry

said in the early hours of Tuesday that it it shot down two Ukrainian drones outside

Moscow and jammed another, sending it crashing into a skyscraper in the Moscow City business district and damaging the building's facade. Moscow Mayor

Sergei Sobyanin said

the drone crashed into

the same building that was damaged in a similar attack early Sunday IQ-Quarter, located 7.2 kms (4.5 miles) from the Kremlin, houses a number of government agencies, including the headquarters of the Ministry of Economic Development, the Ministry of Digital Development and Communications, and the Ministry of Industry and Trade. "We are prepared to talk with ervone, even with our neighbour, provided that the neighbour is serious to talk serious matters on the table because war is no more an option, the prime minister said, in an apparent reference to India.

India has been maintaining that it desires normal neighbourly relations with Pakistan while insisting that the onus is on Islamabad to create an environment that is free of terror and hostility for such an engagement. India has also asserted that Jammu and Kashmir 'was, is and will" always be part

The Prime Minister talked about the history of wars between Pakistan and India. The wars in his opinion resulted in an increase in poverty, unemployment, and lack of resources to finance education, health, and well-being of the

Bilateral relations between Islamabad and New Delhi have been tense since August 2019 when India changed the special status of Jammu and Kashmir.

On India's ties with Pakistan, External Affairs Minister S Jaishankar has said that it is not possible for India to have normal relations with the neighbouring country until the policy of cross-border terrorism is abrogated.

"We can't allow terrorism to be normalised; we can not allow that to become the basis for getting us into discussions with Pakistan. To me it is a fairly common sense proposition," he said in June.

Earlier, Minister of State for Petroleum Dr. Musadik Malik, inviting foreign investors to invest in the minerals and mining sector, revealed that Pakistan has estimated mineral reserves \$6 trillion, which include gold, copper, coal, and other precious metals.

Paris, August 1: France prepared to evacuate hundreds of French and European citizens from Niger Tuesday, a day after neighbours Mali and Burkina Faso said any outside intervention to restore the ousted government would be seen as a declaration of war.

A military junta overthrew Niger's democratically elected President Mohamed Bazoum and his government last Wednesday in the seventh military takeover in less than three years in West and Central Africa.

West African regional bloc ECOWAS last Sunday threatened to use force to reinstate Bazoum if the soldiers didn't do it within a week, while neighbouring Mali and Burkina Faso also ruled by military juntas said they would come to Niger's defence.

With the risk of conflict escalating, Spain said it was preparing to evacuate more than 70 citizens by air and Italy said it would organise a repatriation flight. Germany urged its citizens to join the French flights.

The coup has sent shockwaves across the Sahel region, which is fighting an Islamist militant

insurgency and where Niger had been considered the West's most stable ally until now.

The recent coups in the region have come amid a wave of anti-French sentiment, with locals saying they want the former colonial ruler to stop intervening in their affairs and calling for partnerships with Russia instead.

Niger's new military leaders have proceeded to arrest senior politicians and warned against any foreign attempts to extract Bazoum, who is still shut in his palace.

"Considering the ongoing coup in Niger and the fact that the situation continues to be worrying, we decided to make sure that the French citizens who want to leave Niger can do so," French Foreign Minister Catherine Colonna told France's LCI TV.

France, the United States, Germany, and Italy have troops in Niger on counter-insurgency and training missions. There has been no announcement of troops being evacuated so far. Colonna said France had

talked with "those who are in control" in Niger to make sure the evacuation could proceed safely, which was in no way a recognition of the junta.



Floods around Chinese capital kill at least 20

Beijing, August 1: Torrential rain in areas around China's capital, Beijing, killed at least 20 people and left 27 missing, the government reported Tuesday, as flooding destroyed roads, uprooted trees and knocked out

Thousands of people were evacuated to shelters in schools and other public buildings in suburban Beijing and in the nearby cities of Tianjin and Zhuozhou.

The severity of the flooding took the Chinese capital by surprise. Beijing usually has dry summers but had a stretch of

record-breaking heat this year. Other areas, especially China's south, have suffered unusually severe summer flooding that caused scores of deaths. Other parts of the country are struggling with drought.

Gold demand dips

New Delhi: Gold demand in India, the world's secondlargest consumer, declined by seven per cent to 158.1 tonne during the April-June guarter of this year in reaction to record high prices in the domestic market, according to the World Gold Council (WGC) However, gold imports saw a 16 per cent jump to 209 tonne during Q2 of 2023, from the year-ago period on account of stocking, WGC said.

CIL output surges

New Delhi: Coal India has posted a 13.4 per cent yearon-year rise in coal production at 53.6 million tonne (MT) in July 2023. At 53.6 MT, the production was up by 6 MT from the 47.3 MT output of July last year, Coal India Ltd (CIL) said in a statement Tuesday. CIL's production soared to 229.1 MT till April-July 2023, 10.7 per cent higher compared to 207 MT of April-July 2022. The coal PSU has set a target to produce 780 MT coal in FY24. In FY23, CIL produced 703 MT of coal.

Petrol demand up

New Delhi: India's petrol consumption rose in July, but diesel demand fell owing to monsoon rains and floods in some parts of the country, preliminary industry data showed Tuesday. Consumption of diesel, the most consumed fuel in the country accounting for about two-fifths of the demand, fell 4.3 per cent to 6.15 million tonne in July compared to the year-ago period. Consumption had fallen by a steep 15 per cent in first half of July but picked up in the second fortnight.

ATF price hiked

New Delhi: Jet fuel or ATF price Tuesday was hiked by a steep 8.5 per cent - the second increase in a month, while commercial cooking gas rate was cut by ₹100 per cylinder in line with divergent trends in international benchmarks. Aviation turbine fuel (ATF) price was increased by 7,728.38 per kilolitre, or 8.5 per cent, in the national capital to ₹98,508.26 per kl, according to a price notification of stateowned fuel retailers.

Power use grows

New Delhi: The country's power consumption grew by 8.4 per cent to 139 billion units in July this year compared to the same month last year. In the year-ago period, power consumption stood at 128.25 billion units (BU), higher than 123.72 BU in July 2021, according to the government data. The peak power demand met, which is the highest supply in a day, rose to 208.82 GW in July 2023. The peak power supply stood at 190.35 GW in July 2022 and 200.53 GW in July 2021.

GST collections up by 11% in July YoY

New Delhi, August 1: GST collection rose 11 per cent to over ₹1.65 lakh crore in July as a result of anti-evasion measures and higher consumer spending.

This is the fifth time since the rollout of the Goods and Services Tax (GST) regime that monthly collections have crossed the ₹1.60 lakh crore mark -- making it the new normal.

"Gross GST revenue collected in July is ₹1,65,105 crore of which CGST is ₹29,773 crore, SGST is ₹37,623 crore, IGST is ₹85,930 crore (including ₹41,239 crore collected on import of goods) and cess is ₹11,779 crore (including ₹840 crore collected on import of goods)," the finance ministry said.

Revenues for the month were 11 per cent higher than GST revenues in July 2022, when it was about ₹1.49 lakh crore.

July 2023 is the second consecutive month when revenues from taxes paid on goods sold and services rendered showed an increase month-on-month. It was ₹1.61 lakh crore and ₹1.57 lakh crore in June and May, respectively. The record high collection of ₹1.87 lakh crore was witnessed in April.

During July, revenues from domestic transactions (including import of services) were 15 per cent higher than revenues from these sources during the same month last year.

The total number of ITRs for AY 2023-24 filed till 31st July 2023 are more than 6.77 crore, which is 16.1 per cent more than the total ITRs for AY 2022-23 (5.83 crore) filed till 31st July 2022," the income tax department said in a statement.

July 31 was the last date for filing income tax returns by salaried taxpayers and those who do not need to get their accounts audited for income earned in the 2022-23 fiscal.

The filing of ITRs peaked July 31, 2023, (the due date for salaried taxpavers and other non-tax audit cases), with over 64.33 lakh ITRs being filed on a single day.

The department also received 53.67 lakh ITRs till July 31, 2023, from first-time filers, a fair indication of the widening of the tax base, the department added. Of the 6.77 crore ITRs, 5.63

crore returns have been e-verified, out of which more than 5.27 crore are through Aadhaarbased OTP (94 per cent). Of the e-verified ITRs, more than 3.44 crore ITRs for AY 2023-



New Delhi, August 1: Manufacturing sector activities in India moderated for the second straight month in July as rates of expansion in output and new orders eased slightly, a monthly survey said Tuesday.

The seasonally adjusted S&P Global India Manufacturing Purchasing Managers' Index (PMI) eased to 57.7 in July from 57.8 in June.

The July PMI data pointed to an improvement in overall operating conditions for the 25th straight month. In PMI parlance, a print above 50 means expansion while a score below 50 indicates contraction.

'The Indian manufacturing sector showed little sign of losing growth momentum in July as production lines continued to motor on the back of strong new order growth," said Andrew

Harker, Economics Director at S&P Global Market Intelligence.

Rates of expansion in output and new orders were only marginally softer than in June, with firms expanding their employment and purchasing activity accordingly, the survey said. According to the survey, re-

ports of demand improvements were widespread and resulted in another marked expansion of new orders in the sector. Growth in new export business picked up to the fastest since last November. Respondents noted increase

in new orders from customers in the US and neighbouring countries such as Bangladesh and Nepal, it said. Firms responded to greater workloads by taking on extra

staff. The solid pace of job creation was broadly in line with those seen in May and June.

On the inflation front, cost inflationary pressures remained relatively muted. These higher prices for raw

materials, plus rising labour costs, led firms to increase their selling prices, the survey said, adding that the rate of inflation was solid, but eased to a threemonth low.

88% of ₹2,000 notes returned to banks

In value terms, crore ₹2,000 notes in circulation has come down to ₹42,000 crore as July from ₹3.56 lakh crore on the day of announcement of withdrawal May 19.

In a statement, the RBI said out of the total banknotes in ₹2.000 denomination received back from circulation, about 87 per cent is in the form of deposits and

the remaining around 13 per cent has been exchanged into other denomination banknotes.

The central bank, in a surprise move, May 19 announced withdrawal of ₹2.000 notes from circulation but gave public time till September 30 to either deposit such notes in accounts or

exchange them at banks. The total value of the ₹2,000 banknotes in cirexchanged culation. which amounted to ₹3.62 lakh currency stands crore March 31, 2023 at ₹3.14 lakh had declined to ₹3.56 lakh crore as at the close

of business May 19, 2023. According to the data received from the banks, the total value of ₹2,000 banknotes received back from circulation is ₹3.14 lakh crore up to July 31, 2023.

It may be noted that RBI has not yet clarified what would be the status of ₹2,000 notes in private hands after September 30.

DEBT OF STATE GOVERNMENTS IS ESTIMATED TO BE ABOUT 28% OF GDP

New Delhi, August 1: The central government's debt stood at ₹155.6 lakh crore or 57.1 per cent of the GDP at the end of March 2023, Parliament was informed Tuesday.

"The Central Government's debt was ₹155.6 lakh crore as on March 31, 2023. It has reduced from 61.5 per cent of GDP in 2020-21 to 57.1 per cent of GDP in FY 2022-23," Minister of State for Finance Pankaj Chaudhary said in a written reply to the Rajya Sabha.

The debt of state governments at the end of 2022-23 is estimated to be about 28 per cent of GDP. Replying to another question.

Chaudhary said the Gross Fixed Capital Formation (GFCF) in the Indian economy has increased from ₹45.41 lakh crore



(constant 2011-12 prices) in 2018-19 to ₹54.35 lakh crore in 2022-23 (Provisional Estimates).

"The government is implementing the 'Scheme for Special Assistance to States for Capital Expenditure' (2020-21 & 2021-22) and 'Scheme for Special Assistance to States for Capital Investment' (2022-23 & 2023-24), he said.

The government approved and released special assistance (loan) in the form of a 50-year interestfree loan for capital expenditure on capital projects in sectors like health, education, irrigation, and power etc for capital expenditure for different States,

During 2023-24, ₹84,883.90 crore

have been sanctioned under Scheme for Special Assistance to for States Expenditure/Investment to various states, he said, adding ₹29,517.66 crore have been disbursed so far during this fiscal.

In response to another ques-

tion, he said the government's roadmap for making India a \$5 trillion economy comprises focusing on growth at the macro level and complementing it with all-inclusive welfare at the micro level, promoting digital economy and fintech, technology-enabled development, energy transition and climate action and relying on a virtuous cycle of investment and growth. The government's road map

was put into effect in 2014, he said, adding major reforms -- including Goods and Services Tax (GST), Insolvency and Bankruptcy Code (IBC), a significant reduction in the corporate tax rate, the Make in India and Start-up India strategies and Production Linked Incentive Schemes, among others -- have been implemented.

Top 50 wilful defaulters owe ₹87,295 crore

New Delhi, August 1: The finance ministry Tuesday said ing Gitanjali Gems Limited, Era Infra Engineering Limited, REI Agro Limited, and ABG Shipyard Limited owe ₹87,295 crore to banks and financial institutions.

Of this, top 10 wilful defaulters owe ₹40,825 crore to schedule commercial banks (SCBs). Minister of State for Finance Bhagwat Karad said in a written reply in Rajya Sabha.

SCBs have written off an aggregate amount of ₹10,57,326 crore during the last five financial years (RBI provisional data for FY 2022-23), he said.

"The Reserve bank of India (RBI) has apprised that the amount owed by top 50 wilful defaulters in SCBs was ₹87,295 crore as on March 31, 2023,' he said.

Fugitive Mehul Choksi's Gitanjali Gems is the biggest wilful defaulter owing ₹8,738 crore to banks. It is followed by Era Infra Engineering Limited owing ₹5,750 crore, REI Agro Limited ₹5,148 crore, ABG Shipyard Limited ₹4,774 crore, and Concast Steel and Power Limited ₹3,911 crore.

Other wilful defaults are Rotomac Global Private Limited ₹2,894 crore, Winsome Diamonds and Jewellery Limited ₹2,846 crore, Frost International Limited ₹2.518 crore. Shri Lakshmi Cotsyn Limited ₹2,180 crore and Zoom Developers Private Limited ₹2,066 crore.

Karad said the provision enabling banks to enter into compromise settlement in respect of borrowers categorised as fraud or wilful defaulter is not a new regulatory instruction and has been the settled regulatory stance for more than fifteen years.

Further, he said, compromise settlement with borrowers classified as wilful defaulters or fraud is also covered in RBI's Master Circular on Wilful Defaulters dated July 1, 2015 and Master Directions on Frauds dated July 1, 2016.

New Delhi, August 1: Delhi state body chief Jai Prakash has filed nomination papers for three posts, including that of president, in the August 12 Wrestling Federation of India (WFI) elections, according to the official list issued by the returning officer

Tuesday. Besides Prakash, the other three in the fray for the top post are UP wrestling body vice-president Sanjay Singh, Jammu and Kashmir senior Senior Superintendent of Police Dushyant Sharma and 2010 Commonwealth Games gold medallist Anita Sheoran. Out of the four, Prakash and Singh are from the Brij Bhushan camp.

Sheoran, one of the witnesses in the sexual harassment case against Brij Bhushan, is representing Odisha, though the 38year-old hails from Haryana and is employed with the state police.

Returning officer and former J&K High Court Judge Mahesh Mittal Kumar Tuesday announced the official list of candidates for 15 posts. Prakash has also filed his nomination papers for two other posts as well - vicepresident and secretary general.

The Brij Bhushan camp had kept Prakash's name a closelyguarded secret Monday, the last date of filing nominations, portraying only Singh, who is also the WFI joint secretary, as their only candidate for the top post. It remains to be seen who, if

any, decides to pull out on the last date for withdrawal of nominations, which is August 7. Dushyant had attended the


