### Haryana seeks addl forces; death toll mounts to 6

Chandigarh, August 2: Haryana Chief Minister Manohar Lal Khattar Wednesday appeared to disagree with his deputy over the cause of the communal violence that has killed six people as he sought four more companies of central forces to restore peace in the state.

Asked about his deputy Dushyant Chautala saying the organisers of the religious procession that was attacked did not give a proper estimation of the expected turnout, Khattar said at a press conference that "it was not like that".

Khattar also sought four additional companies of central forces following the communal clashes and said a battalion of the India Reserve Battalion will also be deployed in Nuh.

 $Twenty\ companies\ of\ central$ forces are already deployed in Haryana - 14 in Nuh, three in Palwal, two in Gurugram and one in Faridabad.

Six people, including two home guards and a cleric, have died in the clashes that erupted in Nuh over an attempt to stop a Vishva Hindu Parishad procession and spread to Gurugram over the past two days.

As he appealed for peace, the Chief Minister asserted that those found responsible for the clashes will not be spared. Khattar said 116 people have been arrested and 90 detained since Monday's clashes MORE P9 in Nuh.

### **ARCHANA GETS** HC BAIL, BUT TO STAY IN JAIL

Cuttack, August 2: The Orissa High Court Wednesday granted conditional bail to Archana Nag in an alleged extortion case registered with Khandagiri police in Bhubaneswar.

While allowing Nag bail in the case registered on the basis of a complaint lodged by her former colleague Shrandhanjali Behera, Justice V Narasingh asked Nag to cooperate in the ongoing investigation, not to leave state without permission and not to influence the witnesses in the case.

The HC had earlier granted bail to Nag in an alleged honeytrapping case registered with Nayapalli police in Bhubaneswar.

However, despite the HC bail, Nag will continue to remain in jail as she is facing another case registered by the Enforcement Directorate (ED) under the Prevention of Money Laundering Act (PMLA).

Nag was arrested October 6, 2022 by Nayapalli police following a complaint by film producer Akshav Parija. She has since been in custody for allegedly demanding ransom from Parija and threatening to publicise photographs and video of his intimate moments with a co-accused following non-payment of the demanded ransom amount.

### Now, social security for barbers, tailors

Bhubaneswar, August 2: Workers in 50 more unorganised sectors in Odisha will now be covered under the Odisha Unorganised Workers Social Security Board (OUWSSB) welfare scheme. Chief Minister Naveen Patnaik Wednesday issued direction to officials in this

With this decision, people working as tailors, barbers, fishermen, and those working in spas, beauty parlours and saloons, delivery boys, potters, blacksmiths, pipe mechanics, among others, will be covered under the scheme.

At present, workers in 10 sectors, including street vendors, small shopkeepers, domestic help, rickshawallahs, auto drivers, agricultural workers, forest workers, newspaper hawkers, and sanitation workers are availing themselves of the facilities given under the scheme.

The Chief Minister increased the assistance given to the next of kin of workers registered with the Board in case of death in accidents from ₹2 lakh to ₹4

Similarly, the assistance given in the event of the natural death of a worker has been increased from Rs 1 lakh to ₹2 lakh.

Around 3.65 lakh workers registered with the Board are getting the facilities under the scheme launched on May 1, 2017.

#### **HEAVY RAIN BATTERS** ODISHA; SCHOOLS SHUT IN **OVER 12 DISTS; 1 KILLED & 6 HURT IN WALL COLLAPSE**

Bhubaneswar, August 2: One person was killed and six others, including two children, were iniured in separate wall collapse incidents as heavy rain triggered by a deep depression lashed Odisha Wednesday, officials said.

Heavy rainfall in the last 24 hours has led to the swelling of water levels in different rivers in both northern and western Odisha.

Brahmani, Baitarani, Jalaka, Vamsadhara, Nagabali and Jhanjabati rivers were in spate.

However, Water Resources department sources claimed that there was absolutely no flood threat except for river Baitarani.

A report from Keonjhar district said that an old woman died as the wall of her dwelling unit collapsed at Ghuntupani village under Jhumpura block. The deceased was identified as Shreemati Lohar (70).

As many as 206 houses have collapsed due to heavy downpour in Keojhar district, an official at the district emergency cell said.

NDRF teams were deployed in the districts of Bhadrak and Jajpur where the rivers have breached the danger marks.

(SRC) Satyabrata Sahu also held a review meeting on the prevailing situation and asked Collectors of 17 districts to provide relief to the affected people. Odisha received an average

### Iconic computer that launched Apple to go under hammer

Boston, August 2: A vintage Apple computer signed by company co-founder Steve Wozniak is being sold at auction.

The Apple-1 set in motion the company that in June became the first publicly traded business to close a trading day with a \$3 trillion market value, according to RR Auction in Boston. The computer has been restored to a fully operational state and comes with a custom-built case with a built-

in keyboard, the agency said. The computer, which originally sold for about \$666, is expected to sell for about \$200,000 at an auction that runs through August 24. An Apple-1 prototype sold last year for nearly \$700,000. About 200 were manufactured in Steve Jobs' garage in Los Altos, California, in 1976 and 1977 and, about 175 of them were sold, RR's Executive Vice President Bobby Livingston said.

"It is the legendary computer

that launched Apple," he said. Jobs approached Paul Terrell, owner of The Byte Shop in Mountain View, California, and he agreed to buy 50 Apple-1 computers, but only if they were fully assembled, according to RR Auction. The Apple-1 thus became one of the first personal computers that did not require soldering by the purchaser, RR said, although it did not come

with a power supply, case, key-



board or monitor.

It was followed by the introduction of the Apple-2 in 1977, which revolutionized the personal computing industry.





It was acquired, used by the owner in 1980 at a computer hobby ist show in Framingham. Massachusetts, and was used throughout the 1980s. It was brought to an operational state earlier this year by Apple expert Corey Cohen, the auction house said.

The auction also includes Apple company check No 2 signed by Jobs and Wozniak and dated March 19, 1976.

The check for \$116.97 was made out to Ramlor, Inc., a circuit board maker, and experts think it was likely linked to the production of the first Apple-1 computers, RR Auction said. The check was expected to sell for \$50,000 but early bidding has already surpassed that.

Mumbai: Renowned art director Nitin Desai was found hanging at his studio in Karjat near Mumbai Wednesday. He was 57. Desai's company ND's Art World Pvt Ltd had defaulted on a Rs 252-crore loan to its financial creditor, according to an insolvency petition filed in a bankruptcy court last week.

"Desai's body was found hanging with a rope in the morning at ND Studios," Raigad Superintendent of Police Somnath Gharge told reporters, adding that it seemed to be a case of suicide and the case was being investigated from all angles.

Police rushed to the studio in Karjat area in Raigad, about 50 km from Mumbai, as soon as information of his death

Desai's company had borrowed Rs 185 crore through two loans from ECL Finance in 2016 and 2018, and troubles with repayments started from January 2020.

His sudden death shocked the industry with Hema Malini, Manoj Bajpayee, Sanjay Dutt, Resul Pookutty, Madhur Bhandarkar and Siddhartha Basu among others sending their condolences.







### **EOW NABS 6TH ACCUSED IN GOVT SUBSIDY FRAUD CASE**

Bhubaneswar, August 2: The Economic Offences Wing (EOW) of state Crime Branch has ar rested another fraudster for his involvement in misappropriating government subsidies of ₹7.16 crore meant for supply of agricultural equipment to farmers, an EOW official said Wednesday.

The accused identified as Prahallad Meshua, proprietor of Subhalaxmi Traders, Bargarh was arrested Wednesday. Earlier, five persons including the prime accused Srinath Rana were arrested in this case by the EOW

This case was registered based on the complaint filed by KG Sree Charan, director of Varushapriya Agrotech Pvt Ltd,

Prime accused in the case. Srinath Rana, who earlier worked as regional manager in the said company, was authorised to register the sale of machinery in Odisha and facilitate subsidies to the beneficiaries/farmers by accessing the state Agriculture department website.

During the period from 2017-21, accused Srinath in criminal conspiracy with the present accused Prahallad and several other dealers had fraudulently uploaded the details of more than 556 paddy transplanters and equal number of beneficiaries covering 18 districts of Odisha. The accused have done it without the knowledge of the complainant farm, the officials said.

#### Five persons including the prime accused **Srinath Rana were** earlier arrested in this case by the EOW

By submitting fake documents, the accused managed to get release of subsidy amount to the tune of about ₹7.16 crore in favour of the beneficiaries.

Soon after the credit of subsidy amounts in accounts of beneficiary farmers, the accused persons in a criminal conspiracy with others used to lure the beneficiaries by giving them some token amount and were grabbing the subsidy amount, they said.

The cost of the transplanter ranges from ₹2.33 lakh to ₹3 lakh and the government released subsidy amounts ranging from ₹93.320 to ₹1.50 lakh.

Out of 556 paddy transplanters, 54 are shown to have been supplied by Prahallad, proprietor of Subhalaxmi Traders, who was also the authorised dealer of Varushapriya Agrotech Pvt Ltd. The EOW is further investigating the case to find out other persons involved in the fraud.

# Lokayukta orders Vig probe into culvert cave-in deaths

Bhubaneswar, August 2: Acting on a report published in **Orissa POST**, the state Lokayukta Wednesday ordered a Vigilance probe into the death of five persons including four children in collapse of an under-construction culvert in Rayagada district.

Five people were crushed to death when a portion of the culvert fell on them while they were taking bath in a rivulet at Upparsaja village in Kalyansinghpur block of the district, July 31.


These participants are very excited to be part of the quizzing extravaganza and are preparing hard to grab the grand prize.

rregular sleep patterns like late sleeping on weekends, waking up early on workdays could be associated with harmful bacteria in your gut and negatively affect your health, suggests a research.

The study, published in The European Journal of Nutrition, is the first to find multiple associations between social jet lag – the shift in your internal body clock when your sleeping patterns change between workdays and free days - and diet quality, diet habits, inflammation and gut microbiome composition in a single cohort.

Previous research has shown that working shifts disrupt the body clock and can increase risk of weight gain, heart problems and diabetes.

However, there is less awareness that our biological rhythms can be affected by smaller inconsistencies in sleeping patterns due to waking early with an alarm clock on workdays, for example, compared to waking naturally on non-work days for people working regular

Researchers found that just a 90-minute difference in the timing of the midpoint of sleep - the halfway point between sleep time and wake-up time - is associated with differences in gut microbiome composition. Having social jet lag was as-

sociated with lower overall diet quality, higher intakes of sugarsweetened beverages, and lower intakes of fruits and nuts, which may directly influence the abundance of specific microbiota in

"Sleep is a key pillar of health, and this research is particularly timely given the growing interest in circadian rhythms

and the gut microbiome. Even a 90-minute difference in the mid-point of sleep can encourage microbiota species which have unfavourable associations with your health," said Kate Bermingham, from King's College London.

"Maintaining regular sleep patterns, so when we go to bed and when we wake each day, is an easily adjustable lifestyle behaviour we can all do, that may impact your health via your gut microbiome for the better," added Sarah Berry from King's College London.

The composition of the microbes in your gut (microbiome) may negatively or positively affect your health by producing toxins or beneficial metabolites. Specific species of microbes can correspond to an individual's risk of long-term health conditions such as diabetes,

### BJD reiterates demand for special focus status

New Delhi, August 2: Biju Janata Dal (BJD) MP Sasmit Patra Wednesday reiterated the Odisha government's demand for awarding special focus status to the state in Rajya Sabha citing the state's vulnerability to natural calamities.

The BJD Rajya Sabha MP, while speaking during the zero hour, said that Odisha has been facing natural disasters on a regular basis. "Cyclones hit Odisha frequently and adversely affect the state's economy. We have faced at least 99 cyclones in the last 100 years," Patra said.

He proposed that through the special focus status, Union government should change the financial sharing pattern between Centre and the state in case of government schemes for 3 years from the date of incidence of a natural disaster in Odisha.

"The sharing pattern should be changed from the present 60:40 ratio to 90:10 ratio between Centre and the state for three years. Currently, the government schemes have a sharing pattern of 60:40, in which 60 per cent funds are provided by the Union government and 40 per cent are provided by the state. Our demand is to change the sharing pattern to 90:10 for three



years from the date of incidence

of a natural disaster," Sasmit Patra said.

Patra stressed that NDRF and SDRF funds are not enough to enable sufficient recovery from havoc wreaked by cyclones. He pressed that the sharing pattern should be changed to 90:10 for a period of three years in order to expedite the infrastructural de-

### **Centre urged to set up CoE on millets**

 $B_{\text{Sujeet Kumar Wednesday}}^{\text{iju Janata Dal (BJD) MP}}$ urged the Union government to set up a centre of excellence (CoE) and research institute on millets in Odisha.

### KIMS doctors remove tumours in novel way

Bhubaneswar, August 2: In two weeks, a team of doctors at KIMS Bhubaneswar has performed two rare surgeries consecutively removing tumors in the lower ends of trachea in minimal invasive processes using endoscope.

Usually, a tumour from trachea or airway is removed by surgery in which anaesthesia is given through a tube, but in these cases as the tumours were blocking the tracheal tube itself, the surgery was done with help of the heart-lung-machine, which was also used to supply oxygen to the lungs during the surgery.

The complex procedures were carried by doctors from ENT and cardio vascular and thoracic surgery (CTVS) departments.

In the first case involving a 68-

year-old male patient, a tumour in the lower end of trachea was blocking the opening of lungs. After his successful surgery, within a week, another 46-yearold lady was successfully operated on by the same ENT and CTVS team.

Both the surgeries were performed with the help of the heart-lung-machine, which is generally used in cardiac surgery. Both the patients are doing fine at KIMS and would be discharged soon, informed a doctor.

Explaining the procedure, head of ENT Khageswar Rout said, "The tumours in both the cases were blocking the lungs and in the second case one part of the lung of the lady was not working. The strategic location of the tumour between heart and lung also posed as a challenge for the ENT and CTVS team while planning.

## **LEOPARDS DISAPPEAR**

FORESTS OF DHENKANAL DISTRICT JUST A YEAR AGO ARE NOWHERE TO BE SEEN NOW. AS PER A RECENT REPORT RELEASED BY THE UNION GOVT



Dhenkanal, August 2: Leopards in Dhenkanal forests have made a vanishing act, if a recent report published by the Union Ministry of Environment, Forest and Climate Change is to be believed.

The seven leopards that were wandering in different reserve forests just a year ago are nowhere to be seen now, as per the report. However, it is unclear whether the leopards have fallen prey to the poachers which has gone unnoticed by the Forest department officials or they have moved into other forests.

On the other hand, not a sin-

gle photo of a leopard has been

caught in the trap camera in-

stalled in the forest. So, the Forest

department is unable to provide

accurate data about the avail-

ability of wild cats in the district. As per the report, the last survey for tigers was conducted in 2017-18 which mentioned about the presence of seven leopards in the district. The Forest department also insisted that the number of leopards is increasing in Koi and Kandhara reserve forests under Hindol forest range on the frontier of Satkosia, Anantapur reserve forest under Kamakhya Nagar forest range situated on Keonjhar border and in

the biodiversity-rich Kapilash Wildlife Sanctuary.

Even Koi and Kandhara reserve forests were given special focus on protection of leopards. Watchtowers were being erected and trap cameras installed for keeping a watch on the activities of leopards. Trained gunmen were deployed to counter the poachers. The pictures of the leopards were captured in the camera on a regular interval. But now the photos of the leopards are not being captured in the trap cameras. Hence, concerns are being raised after Dhenkanal district is declared 'leopard less' in the recent report published by the Centre.

The negative outcome has raised questions about the Forest department's style of functioning even though attempts were made to protect the leopards. Comprehensive security arrangements and huge investment on the project yields little result. Meanwhile, the state gov-

ernment has started preparations for the census of tigers and elephants in the district as it believes the Union government's data is unreliable. Divisional forest officer (DFO) Sumit Kar said the report released by the Centre mentions that there are no big cats in Dhenkanal forests. The state government will conduct a census of elephants and tigers again. The DFO said preparations for this fresh survey is in progress.

## 30kg plastic removed from cow's stomach

Berhampur, August 2: Doctors at the government-run veterinary hospital in Berhampur Wednesday removed plastic materials weighing around 30 kg from the stomach of a stray cow.

It took a four-hour long operation for a team of veterinary doctors, led by Satya Narayan Kar, to remove the undigested polythene bags from the stomach of the 10-year-old cow, chief district veterinary officer of Ganjam

Manoj Kumar Sahu said. The cow, which used to feed on

leftovers dumped in polythene bags by people, ended up with its stomach full of plastic and subsequently its intestines get blocked.

If left unattended for long, the animal would have died, said Kar.

The cow is stable now and it will stay in the hospital for a week in observation.

The ailing animal was taken from Giri Road here in an animal ambulance Monday evening ficials about its critical condition. The cow was not able to even stand.

when some people informed of-

"The cow was in critical condition when it was brought to the hospital. The animal had problems in passing stool and urine and had been kicking its belly in pain. The clinical examination of the cow revealed the accumulation of plastic waste in its stomach." said Kar.

Last year, doctors at the hospital had removed plastic materials of around 15kg from a stray cow here.

The incident highlights the severity of plastic pollution, despite a government ban on its use, transport and manufacture for five years, said Sudhir Rout, founder of Aryabhatt Foundation, an organisation spearheading campaigns against the use of plastic.

"We appealed to the Berhampur Municipal Corporation to enforce the ban properly," said Rout.

### **Green Globalisation**

International trade has boosted economic growth in many countries, especially those without abundant natural resources or fixed capital. In addition to creating opportunities for cross-border specialisation, trade has made it possible to import cheap consumer goods, intermediate inputs for manufacturing, and capital equipment. This is especially true in Asia and the Pacific, which accounted for 35% of global trade in 2020, up from 25% a decade earlier.

Likewise, globalisation and open trade could play an indispensable role in saving the planet. Given the existential threat of climate change, environmental goods and services should be made widely available at affordable prices to support a rapidly greening world economy. Imports of solar panels, wind turbines, and electric vehicles, along with services such as wastewater treatment, could also generate technological spillovers that stimulate and support the development of renewableenergy sectors and clean industries domestically.

But overall progress has been slow. The lack of a collective commitment to liberalise trade in environmental goods and services, coupled with a rise in protectionist measures, will almost surely undermine miti-

gation and adaptation efforts. Global and regional cooperation is urgently required to agree on common principles for facilitating such trade and safeguarding sup-

The first challenge is to define an environmental good or service. The Asia-Pacific Economic Cooperation (APEC) agreed to a list of 54 environmental goods on which they would apply tariffs of 5% or less. Yet the agreement has only a limited impact, owing to its voluntary nature and the relatively small number of products covered. Negotiations to conclude an Environmental Goods Agreement among a group of World Trade Organization members have stalled Of course, if governments want to expedite the green transition, they are free to lower tariffs on environmental goods (such as manufacturing equipment) unilaterally, in whatever way cuts domestic greenhousegas emissions most dramatically. Their inclusion in international trade agreements however, requires consensus on objective standards. Beyond the technical challenges of defining environmental goods, countries may seek to tailor specifications to protect their own producers.

The recent rise of competing industrial policies in both advanced and emerging

economies creates some opportunities to disseminate environmental goods more widely and at lower prices. After all, subsidies for renewable-energy producers can increase investment in research and development, which may yield cost-reducing innovations. For example, the price of solar modules has plunged, on average, to below \$1 per watt for the world's largest producers, including Germany, Japan, the United States, and the People's Republic of China. The ability to import such cheap renewable technology makes the clean-energy transition more affordable for a broader range of countries.

But the huge challenges that such policies pose to climate action outweigh the benefits. According to the International Energy Agency, China's share in all the components used to manufacture solar panels – such as polysilicon, ingots, wafers, cells, and modules – exceeds 80%. This is largely a result of its cost competitiveness, with prices 20% lower than in the US and 35% lower than in Europe. But much of the world cannot access cheap solar panels from China because of countervailing and anti-dumping duties imposed by its trading partners. While efforts to level the playing field between foreign and domestic producers are understandable and permitted under WTO rules, erecting trade barriers for environmental goods slows the green transition. Moreover, other protectionist policies, like those that link domestic sourcing requirements to market access, may be even harder to justify on competitive grounds. Imposing export restrictions on critical raw materials such as lithium, rare-earth elements, and chromium, all of which are in high demand as the energy transition gathers pace, is also unhelpful. Such restrictions, which include licensing requirements as well as export tariffs and bans, increased fivefold from 2009 to 2020. Any reduction in the cross-border flows of these materials could significantly challenge the security of supply chains for green products. Moreover, trade fragmentation makes it more difficult for leading global companies to maximise their competitive and innovative potential, reducing opportunities to cut costs further.

And yet, relatively few international trade agreements include provisions to liberalise trade in environmental goods and services. The urgency of the climate crisis obliges the international community to be proactive in agreeing on the definitions of such goods and services and implementing practical measures to lower both tariff and non-tariff trade barriers. These issues could be discussed at international forums such as the G20 and APEC, or as part of regional economic cooperation efforts like the Regional Comprehensive Economic Partnership or the Indo-Pacific Economic Framework.

Improving access to environmental goods and services can accelerate mitigation and adaptation efforts globally at a lower cost. So, rather than engage in protectionism, governments wishing to support domestic production of such goods are far better off subsidising research and development, which is permitted under WTO rules because it can help companies become more efficient and innovative. At the same time, they must support the free flow of trade, because making these goods more widely available might be our best chance to solve the climate crisis.

**SENTENCE HAS ALMOST BEEN PRACTICALLY ABOLISHED THROUGH STRINGENT** RESTRICTIONS **BY JUDICIAL DECISIONS** 

he monstrous growth of heinous crimes is a cause of concern for Indian society. There seems to be no end to the upward movement of the graph of crimes. What is more alarming is the gruesomeness of crimes and the guts and audacity of criminals while committing crimes in broad daylight and in full public glare. As if criminals are not at all afraid of the consequences of their actions or may be, sure of coming out scotfree from the proverbial spider's web of our justice system.

There are many factors behind such an ominous development. Firstly, weak and archaic laws, specifically procedural laws like the Criminal Procedure Code and Indian Evidence Act which were enacted in the 19th century by the British who had the least concern for Indian people or their socio-cultural roots. Secondly, the abnormal and inordinate delay in delivering justice reaffirms the dictum "justice delayed is justice denied."The last, but the most important factor is, the punishment inflicted on the convicts by the courts of law does not commensurate with the crime and thus fails to generate any fear in the minds of the

Now let's see why our punishment-system does not intimidate criminals or fails to make any deterrent effect on people inclined to crime. Section-53 of Indian Penal Code mentions about five types of punishments: death, imprisonment for life, rigorous or simple imprisonment, fine, and forfeiture

Death penalty is awarded for waging war against India, armed rebellion by defence personnel, fabricating evidence to fraudulently obtain capital punishment for an innocent person, abetting a minor's suicide, kidnapping for ransom, causing harm or death, murder, rape and murder, repeat of rape-of-

fence and dacoity with murder. The Commission of Sati (Prevention) Act, 1987, Narcotic Drugs & Psychotropic Act, 1985, The SC & ST (Prevention of Atrocities) Act, 1989 and the Protection of Children from Sexual Offences Act, 2019 also provide provisions for death sentence.

However, all the above death sentences contain the substitution of life-imprisonment. The only crime which had no substitute to death-sentence was murder by a life-convict. under Section 303 of IPC; but the Supreme Court has declared it void and unconstitutional as it violates the right to equality guaranteed under Article 14 of the Constitution.

Death-sentence has almost been practically abolished through stringent restrictions by judicial decisions. During the last decade (2013-2023) only six convicts have been hanged to death. Out of them,four were the convicts in the sensational Nirbhaya case who were hanged in 2020. We have already seen how the dreaded culprits heinous crime played with the loopholes of our laws and justice system for about a decade before being hanged. During the last 73 years only 174 convicts have been hanged. The touch-

stone of "rarest of rare case" set by the Supreme Court in Bachchan Singh Vs. State of Punjab (1982) and Machi Singh Cases, have almost made it impossible for trial courts to award death-sentence even in most heinous crimes

Then comes the punishment of life-imprisonment. The apex court in many of its decisions including the Gopal Vinayak Godse (1961) and Mohammad Munna (2005) cases, has clarified that life-imprisonment means imprisonment for the whole of the remaining period of the convict's natural life. But then how the life-convicts in the sensational Bilkis Bano case and the mafia-politician Anand Mohan were released after they served sentences for only 14 years?

Section 54 of IPC, Section 433 of CrPC and provisions of State Jail Manuals empower the Central and state governments to commute life-imprisonment of convicts to imprisonment for 14 years. The Article 72 and 161 provide the President and the Governors respectively to grant pardon or suspend, remit or commute sentence of a convict.

The Supreme Court in Bikram Dorjee Vs. State of WB (2009) has held that punishment should conform to be consistent with atrocity and brutality with

which crime has been perpe trated, and it should respond to society's cry for justice against criminals. "The object of punishment is to protect the society and deter the criminal". In State of MP Vs. Sheikh Shahid case (2009) the apex court has warned other courts of the country against showing undue sympathy by imposing inadequate sentence as it would harm justice system and erode public confidence in the system.

There is another confusing Section 57 in IPC which mentions, "In calculating fraction of term of punishment, imprisonment for life shall be reckoned on equivalent to imprisonment for 20 years." Many life-convicts claim benefit of this provision by claiming to be released after 20 years. The intent of this British-era legislation is yet to be understood, but the Supreme Court has made it clear through its decisions in Maru Ram Vs. Union of India (1980) and Krisan Lal Vs. State of Rajasthan (2001) that imprisonment for life means imprisonment for lifetime of the convict and no lifeconvict can claim that he be released after 20 years in jail as per Section 57, IPC. The top court however candidly admits that the Central or state government can remit the whole or part of sentence of a convict as per Section 401 of CrPC.

The miserable plight of the two major punishments under our legal and justice system death sentence and life imprisonment - is enough to multiply the morale of criminals. The wise words of the 4th Century BC Greek philosopher Aristotle are still relevant: "The generality of men are naturally apt to be swaved by fear rather than reverence, and to refrain from evil rather because of punishment that it brings than because of its own foulness.'

## Endangering our forests & environment

tions, and suggestions of em-L inent ecologists, scientists, naturalists, activists, tribal organisations, and Opposition parties, the BJP-led Central government has unilaterally passed the controversial Forest Conservation Bill 2023 in the Lok Sabha. Surprisingly, such an important Bill was hurriedly passed without any debate or discussion in Lok Sabha. The Rajya Sabha passed the Bill after a brief debate.

The government made many tall claims on increasing forest cover and reducing carbon emissions and targets "net zero emissions by 2070" by "creating carbon sink" for higher carbon dioxide absorption. But the Bill will facilitate large-scale diversion of forest land for nonforestry purposes and will have devastating effects on the envi-

ronment and biodiversity. Certain provisions of the Bill could jeopardise vast tracts of ecologically important forests and leave out several so-called unclassed forests that cover around 15% of India's total forest cover. Unclassed forests are recorded as forests but not included in reserved or protected forests category. According to the Forest Survey of India, the ownership of such forests varies from state to state. In the Bill, the govern-

gnoring all appeals, objec-ment has brought only declared or notified forests under the Indian Forest Act – 1927 or any other law and those recorded as forests on or after October 25. 1980 within its ambit. The states will now be able to classify unclassified forest land or patches of trees as forest land in order to be able to show larger tree coverage, within the definition of "forests." The purpose of this is to permit a huge part of the forest land including biodiversity hotspots to be potentially sold, diverted, cleared, and exploited for non-forestry purposes.

This will also render the Supreme Court verdict of 1996 in the case of "TN Godavarman vs Govt of India" meaningless. There, the SC had interpreted the definition of forest and ordered the declaration of all lands having dense tree cover and being surrounded by forests to be treated as forest land and be conserved. This unclassified forest also plays a sensitive and important role in protection of environment. If these classified forests are declassified, then thousands of square kilometers of forests will lose protection overnight and the government in the name of development will hand them over to corporates. There will be no need for taking permission or forest clearance for diversion from forest use.

This could destroy vast tracts of ecologically important forests.

As we know, the declared aim of Forest Conservation Act - 1980 was conservation of forests. For forest conservation all non-forest activities are strictly prohibited in forest land. If forest land is needed for any development project, then by giving a detailed report the state can apply for permission for diversion of forest land to the Central government. But the latest amendment dilutes this provision.

The Bill provides exemption for lands, "situated within a distance of 100 km along international borders or Line of Control or Line of Actual Control," for "construction of strategic linear projects of national importance and concerning national security." This clause could harm forests in Himalavan, trans-Himalayan and north-eastern regions significantly. Clearing such forests can trigger extreme weather conditions besides threatening the biodiversity of ecologically fragile areas.

The Bill also exempts certain types of land from its purview. This includes land used for nonforest purposes along railway lines, roads and habitations. Earlier, activities relating to "development and management of forests and wildlife" only were exempted from permission, now

the Bill has exempted "establishment of zoos and safaris, "eco-tourism facilities" and also "any other like purpose" which the government may specify from the ambit of permissions. The government wants to hand over vast tracks of forest land to private players for tourism activities for the super-rich. It also sidelines the rights of tribals and forest-dwellers. Exempting such a large number of projects from the clearance process will mean that forest-dwelling people will no longer be consulted, rather they will face eviction from forest land.

The latest move of the Modi government is not an isolated one. It is part of a series of amendments to various laws related to forest and environment in the interest of large corporates. During the nine years of BJP rule, there were attempts to amend the Indian Forest Act-1927. They brought the Forest Conservation Rules 2022 and also tried to weaken the Forest Rights Act-2006. These were intended only to consolidate the control of the state and corporates over our land, forest, and natural resources and ultimately affected the livelihood of lakhs of tribals and forest-dwellers.

### Shimla-Chandigarh NH blocked after landslide

Shimla, August 2: A landslide blocked the national highway connecting Shimla to Chandigarh in Himachal Pradesh's Solan district Wednesday morning, leaving many vehicles stranded, officials said. A 50-metre road stretch completely caved in following the landslide.

Light vehicles coming from Chandigarh have been routed through Parwanoo-Kasauli-Jangushu Road-Kumarhatti while vehicles going from Solan would take Bhognagar-Banasar-Kamli road.

Men and machinery have been deployed at the damaged stretch and work to open the road has commenced, officials said. The Shimla Police has routed traffic going from Shimla to Chandigarh via Theog-Sainj-Giripul-Oachghat-Kumarhatti-Sarahan-Kala Amb-Panchkula road while the traffic coming from Chandigarh would be routed via Dherowal-nalagarh-Parsehar-Kunihar-Totu-Shimla for light vehicles.

The local weather department has issued an orange alert warning of heavy to very heavy rains in isolated places in seven out of 12 districts, including Bilaspur, Chamba, Kangra, Mandi, Shimla, Solan and Sirmaur, August 3 and 4.

Rain related incidents like flash floods, cloud bursts and landslides and road accidents have so far claimed 194 lives in the state while 34 are missing since the onset of monsoon on June 24, according to the state emergency operation centre.

About 320 roads are still closed for traffic in the state as landslides triggered by rains and flash floods had wreaked havoc in Himachal Pradesh.

New Delhi, August 2: Karnataka has the highest total asset of MLAs among states, a report claimed Tuesday. According to a report released by the Association for Democratic Reforms (ADR) and the National Election Watch (NEW), the total asset of 223 MLAs analysed from Karnataka is ₹14,359 crore, which is more than the individual annual budget of 2023-24 of Mizoram and Sikkim.

The report said it is 26 per cent of the combined total assets of all sitting MLAs, which stood at ₹54,545 crore. "It is also more than the combined assets of sitting MLAs from Rajasthan. Punjab, Arunachal Pradesh, Bihar, Delhi, Chhattisgarh, Himachal Pradesh, West Bengal, Goa, Meghalaya, Odisha, Assam, Nagaland, Uttarakhand, Kerala, Puducherry, Jharkhand, Sikkim. Manipur, Mizoram and Tripura. The total combined assets of sitting MLAs from these 21 States and Union Territories are ₹13.976 crore," the report added.

As per the report, Karnataka is followed by Maharashtra with 284 MLAs whose assets stood at

₹6,679 crore, and 174 MLAs from Andhra Pradesh have total assets worth ₹4,914 crore.

As per the report, Tripura has the lowest total asset of MLAs. The total asset of 59 MLAs analysed from the state is ₹90 crore, followed by 40 MLAs from Mizoram with ₹190 crore, and 60 MLAs from Manipur have total assets worth ₹225 crore

The report was released after analysing the self-sworn affi-

davits of sitting MLAs in State Assemblies and Union

Territories across the nation.

The data has been extracted from affidavits filed by the MLAs prior to contesting their last elections. The report said that a total of 4,001 MLAs out of 4,033 have been analysed across 28 State Assemblies and two Union Territories. This report covers 4,001 sitting MLAs belonging to 84 political parties and Independent MLAs.



### **Court reserves** order on Tytler's bail plea for Aug 4

1984 ANTI-SIKH RIOTS CASE

New Delhi, August 2: A Delhi court Wednesday reserved its order for August 4 on Congress leader Jagdish Tytler's plea seeking anticipatory bail in connection with the anti-Sikh riots in 1984 in the national capital's Pul Bangash area.

Tytler Tuesday moved Rouse Avenue Court, which had issued a notice to the Central Bureau of Investigation (CBI) in the case.

During the hearing on Wednesday, the probe agency took an objection with his request saying that the witnesses have come forward showing great courage and the possibility of influencing them cannot be ignored.

On July 26, the court summoned Tytler for August 5 in the matter. Additional Chief Metropolitan Magistrate (ACMM) Vidhi Anand Gupta of a special MP-MLA court had passed the order after taking cognisance of a CBI chargesheet

Gurdwara Pul Bangash at Azad Market was set on fire by a mob on November 1, 1984 and three persons, namely Sardar Thakur Singh, Badal Singh and Gurcharan Singh, were burnt to death.

The incident took place a day after the then Prime Minister Indira Gandhi was assassinated by her Sikh bodyguards.

In its chargesheet filed before the court, the CBI has said that Tytler incited, instigated and provoked the mob that had assembled at gurdwara on November 1, that resulted in the burning down of the gurdwara and killing of three persons of the Sikh community.

Charges under Sections 147 (rioting), 109 (abetment) read with 302 (murder) of the Indian Penal Code (IPC), among others, have been invoked against Tytler by the probe agency.

New Delhi, August 2: Who can recommend the revocation of Article 370 in Jammu and Kashmir when no constituent assembly exists there? The Supreme Court Wednesday put this question to the petitioners who have challenged the abrogation of the constitutional provision that bestowed special status on the erstwhile state.

The bench, also comprising Justices Sanjay Kishan Kaul, Sanjiv Khanna, BR Gavai and Surva Kant asked senior advocate Kapil Sibal, the lead counsel for the petitioners, as to how can a provision (Article 370), which was specifically mentioned as a temporary provision in the Constitution, become permanent after tenure of the Jammu and Kashmir constituent

assembly came to an end in 1957.

The top court referred to proviso 3 of Article 370 which says, "Notwithstanding anything in the foregoing provisions of this article, the President may, by public notification, declare that this article shall cease to be operative or shall be operative only with such exceptions and modifications and from such date as he may specify: Provided that the recommendation of the Constituent Assembly of the State referred to in clause (2) shall be necessary before the President issues such a notification.'

### **Pak SC rejects** Imran's plea

Islamabad: Pakistan's Supreme Court rejected for a second time Wednesday former prime minister Imran Khan's plea seeking a halt on the trial court's criminal proceedings against him in the Toshakhana corruption case. Despite approaching the Islamabad High Court (IHC) twice, the 70-year-old Pakistan Tehreek-e-Insaf (PTI) chief Khan failed to get relief in the case pertaining to the concealment of details of state gifts. A three-member apex court bench headed by Justice Yahya Afridi conducted the hearing Wednesday.

### **Khanun pounds** Japan's Okinawa

Tokyo: A powerful typhoon islands in southwestern Japan Wednesday with high winds injuring more than 20 people as it moved west making its way toward mainland China. Typhoon Khanun, which means jackfruit in Thai, was heading west at speeds of 10 kmph, packing surface winds of up to 180 kmph. It was at sea southwest of Okinawa's main island, according to the Japan Meteorological Agency 22 people were injured, most of them minor, according to the Okinawa prefectural government.

### Tunisia sacks its first woman PM

Tunis (Tunisia): Tunisia's president has sacked the country's prime minister, who was the first woman to hold that job in an Arab League nation. A brief statement from the presidential office late Tuesday did not give reasons for the dismissal of Najla Bouden Ramadhane. President Kais Saied had appointed the engineering school professor as Tunisia's first female prime minister in September 2021. Her replacement is retired central bank director Ahmed Hachani, who was sworn in Tuesday night.

#### Russia attacks **Ukrainian port**

Kyiv: Russian drones Wednesday hit a Ukrainian port city along the border with Romania, causing significant damage and a huge fire at facilities that are key to Ukrainian grain exports. The attacks followed the end of a deal with Russia that had allowed Ukrainian shipments to world markets from the Black Sea port of Odesa. Since scrapping the deal, Russia has hammered the country's ports with strikes.

Colombo, August 2: Sri Lanka's Central Bank said Wednesday that no domestic transactions would be allowed with the Indian Rupee in the island country, as it warned people not to be misled by inaccurate information surrounding the issue.

The apex bank said that even though the Indian Rupee (INR) has been endorsed as a designated foreign currency, it is not a legal tender in Sri Lanka for domestic payments or settlements "Any transaction executed be-

tween or among residents in Sri Lanka shall be in LKR (Lankan Rupee), being the legal tender in Sri Lanka," the central bank said in a statement. It added that the INR was designated a foreign currency in Sri Lanka in August 2022.

In view of the expanding economic activities between India and Sri Lanka, particularly in promoting existing trade relations between the two countries, on several occasions, CBSL (Central Bank of Sri Lanka) has communicated to the Reserve Bank of India (RBI), the Monetary Authority of India, its willingness to authorise INR as a designated foreign currency in Sri Lanka, the statement said.

The statement came days after Sri Lankan President Ranil Wickremesinghe's official visit to India and talks with the top Indian leadership, including Prime Minister Narendra Modi.

## Beijing records heaviest rains in 140 years

The record rainfall comes as northern China has been deluged with heavy rains as the remnants of Typhoon Doksuri moved north after earlier hitting southern Chinese provinces

Fangshan (China), August 2: Deadly rains that pummelled China's capital in recent days were the heaviest since records began 140 years ago, Beijing's weather service said Wednesday, as a massive cleanup operation began.

Millions of people have been hit by extreme weather events and prolonged heat waves around the globe in recent weeks -- events that scientists

say are being exacerbated by climate change.

And Meteorological Service said the capital has just experienced the "heaviest rainfall in 140 years", when city authorities started keeping records.

"The maximum (amount) of rainfall recorded during this storm, which was 744.8 millimetres, occurred at the Wangjiayuan Reservoir in

Changping," the service said, adding the largest volume previously recorded was 609 millimetres in 1891.

Chinese authorities said Tuesday the torrential rains around Beijing had caused at least 20 deaths and 27 people are missing.

The epicentre of flooding shifted to neighbouring Hebei province Wednesday.

Heavy rains began pound-

ing the typically dry capital and surrounding areas Saturday. The amount recorded in just 40 hours neared the average rainfall for the entire month of July.

State media warned last week that 130 million people would be affected by the extremely heavy rainfall across northern China.

Swathes of suburban Beijing and the surrounding areas have been inundated, with state media reporting 974,400 people have been evacuated in the capital and neighbouring Hebei province.

And to the west, a further 42.211 people have been evac uated in Shanxi province.

Authorities in the capital lifted the red alert for flooding Wednesday morning "as the water flow in major rivers has gone below the warning mark", Xinhua reported.

## MORE TROUBLE FOR TRUMP

Washington, August 2: Former US President Donald Trump was indicted on a slew of charges for trying to overturn the 2020 election verdict, which put Joe Biden in the White House, stay in power by making false claims of election fraud and for fueling the January 6 attack on the US Capitol in pursuit of those goals with these lies.

Trump has been indicted -and arrested -- twice previously on multiple charges regarding payment of hush money to an adult film star to keep quiet about their affair (by New York state) and (by the federal government) for spiriting away classified papers from his presidency instead of turning them over to official archives as required by law.

These indictments, and arrests that follow, had made Trump the only American President facing this kind of legal jeopardy -- and there is more coming as Georgia state pursues a similar case of trying to overturn the 2020 election verdict with similar election fraud claims -- but they will stop him from continuing his campaign for the White House in the upcoming 2024 election.

In April 2015, the Ukrainian

New Delhi: Leading jewellery and watchmaker Titan Wednesday reported a 4 per cent drop in its consolidated net profit at ₹756 crore in the June quarter. The jewellery business remained the star performer with a 19 per cent growth on a year-on-year basis," Titan **Managing Director CK** Venkataraman said. The company is pursuing market share gain across categories and investing in various capabilities and retail network expansion, he added.

### IOB net profit rises 28 per cent

New Delhi: State-owned Indian Overseas Bank (IOB) Wednesday posted a 28 per cent increase in net profit at ₹500 crore in the June quarter, mainly due to a decline in bad loans. The Chennai-based lender had posted a net profit of ₹392 crore in the year-ago period. The total income in the first quarter of the current fiscal rose to ₹6.227 crore against ₹5.028 crore, IOB said in a regulatory filing. The lender's interest income also increased to ₹5.424 crore from ₹4.435 crore in the same guarter a year ago. On the asset quality side, the bank witnessed an improvement with the gross Non-Performing Assets (NPAs) easing to 7.13 per cent of the gross advances by June 2023 as against 9.12 per cent a year ago. The net NPA too declined to 1.44 per cent over 2.43 per cent in the same period of the previous financial year.

#### IndiGo posts record profit

## **Banks unprepared for climate risks: Report**

The report titled 'Still Unprepared' builds on a 2022 assessment and finds that despite the accelerating impacts of climate change, there remain significant gaps in the preparedness of the Indian banking sector to measure, manage and mitigate climate risks.

Process (ICAAP). At a time when climate disruption in the form of extreme weather events has hit new extremes, not a single bank has yet undertaken climate-related scenario analyses to gauge the

resiliency of their portfolios. The report also finds that pub lic banks in particular are failing to adequately finance India's energy transition. For example, public sector banks have accounted for less than eight per cent of total financing for the renewable energy sector.

Only 10 banks have disclosed their green financing activities.

The Reserve Bank of India has accepted that the climate crisis could pose a systemic risk to the Indian economy.

The Climate Risk Horizons analysis maps the potential climate change risks faced by India's banking sector based on sector-wise exposure, and emphasises the need for mandatory guidelines from the RBI on climate-related disclosures and common frameworks to manage climate risks.

For instance, based on disclosures of India's 30 largest banks, the SBI and HDFC Bank have the highest exposure to carbon intensive sectors with SBI's exposure dominated by coal.

"It has been more than a year since the RBI released a draft discussion paper on climate risk and sustainable finance for public comment. However, nothing has been finalised yet. Also, the RBI should classify and differentiate risks, and start mapping climate risk drivers to financial exposures under traditional risk categories," said Asapur.

The study lists proactive disclosure of green finances, adoption of a common reporting format, transition plans for their fossil fuel financing and the use of tools like climate scenario analyses as urgent steps required to be taken by banks to mitigate climate risks.

Mumbai, August 2: The Parliament Wednesday passed a law allowing the government to auction and mine its newly-discovered reserves of lithium, among other minerals, increasing the mining of the critical raw material for electric vehicle batteries.

Under the law, lithium, along with other minerals was removed from a previous list of atomic minerals, which prevented it from being auctioned to and mined by private companies.

"Upon removal of these minerals from the list of atomic minerals, exploration and mining of these minerals will be open to private sector," a government



statement said.

"As a result, exploration and mining of these minerals is expected to increase significantly in the country," the statement

Lithium reserves were discovered earlier this year in the federally administered region of Jammu and Kashmir, and the government has said it hopes to find more reserves later this

Other minerals that will now be open for mining and auction include titanium, bervl, niobium and zirconium, the statement said

These minerals were earlier only allowed to be mined by state-run companies, which meant that they were mined in limited quantities, and the involvement of private companies could be a 'force multiplier', the statement said. "There is a need to vigorously

increase exploration and production of the minerals proposed to be removed from the list of atomic minerals to meet the growing demands of the country,' the statement said.

### Foxconn to invest \$600mn in K'taka

Bangalore, August 2: Foxconn will invest \$600 million in two projects in Karnataka to make casing components for iPhones and chip-making equipment, signaling its growing interest in the south Asian nation as it spreads bets beyond China.

### WALMART TOPS FORTUNE GLOBAL 500 LIST

SAUDI ARAMCO MOST PROFITABLE COMPANY EVER

New York, August 2: Fortune announced that US retailer Walmart has topped its Global 500 list for 2023, ranking the world's largest corporations by revenue for fiscal 2022.

On Fortune's authoritative ranking of the (current) corporate world order, the Arkansasbased retailer claimed No. 1 for the 10th consecutive year and

for the 18th time since 1995. Walmart joins a spike in the number of US companies on the Global 500 this year, reaching its highest total since 2010 at 136 companies, which is also the highest for a stand-alone

The strength of the global energy sector was dramatically clear as Saudi Aramco nearly knocked the retail Goliath from its perch.

Saudi Aramco (No. 2) benefited from soaring energy prices -- fueled by Russia's invasion of Ukraine -- that also propelled Exxon Mobil (No. 7) and Shell (No. 9) back into the top 10 by revenue. In profits, Saudi Aramco earned \$159 billion, the highest annual total ever for a Fortune Global 500 company.

Big Tech, meanwhile, proved it also remains a robust and profitable sector. Together, Apple, Alphabet, and Microsoft brought in \$233 billion in net income, with Apple (No. 8) earning just short of \$100 billion in profits, the most ever by a US company.



With Ravindra Jadeja picking himself as the first spinner, there is no way that Axar Patel can make it to the playing XI.

# Eyes on Asiad, India begin final preparation

Chennai. August 2: Tournament favourites and three-time champions India will look to give final touches to their Asian Games preparation and address the areas of improvement in the Asian Champions Trophy men's hockey tournament, beginning here Thursday.

World No.4 India are the highest ranked side in the tournament and will open their campaign against China at the Mayor Radhakrishnan Stadium here, which will host a major event for the first time since 2007. It is also the first time India would be hosting the ACT since the tournament's inception in 2011.

For India, the primary objective in the tournament would be to test the players and get a fair bit of idea about their Asian rivals ahead of the Asian Games to be held in Hangzhou, China from September 23 to October 8.

With the Asian Games providing a direct ticket to next year's Paris Olympics, India are expected to test their resources in the ACT while also playing a balancing act to keep their players fresh and free from injuries ahead of the all-important con-

tinental showpiece. While the scheduling of the ACT just five weeks before the Hangzhou Games has drawn some criticism from the visiting sides, India head coach Craig

Fulton does not seem to be too offended by the prospect of featuring in this event.

India might have gained both in terms of ranking and respect in world hockey, but the Tokyo Games bronze medallists fared poorly in the FIH World Cup cohosted by Bhubaneswar and Rourkela earlier this year.

The Indians finished a disappointing ninth in the World Cup. But since then, the Harmanpreet Singh-led side has played as many as 16 games, winning nine of them, losing five, along with

a couple of draws. The Indians will come into the tournament straight from a four-nation Europe tour, with only a three-day gap between

India also won a silver (2012) and a bronze (2021) in the tournament, the last one just four months after the high of an Olympic medal.

# India might visit Pak for Olympic qualifiers

Rising shuttler Priyanshu Rajawat also tasted success as he beat Australia's Nathan Tang 21-12 21-16.

Among other Indians in the fray Wednesday, Aakarshi Kashyap beat Malaysia's Jin Wei Goh 21-15, 21-17, but it was curtains for Malvika Bansod as she lost 20-22, 11-21 against Yu Po Pai of Chinese Taipei.

Only one Indian will survive after the second round in the women's singles as Sindhu and Kashyap are pitted against each other.

The Indian mixed doubles pair of Rohan Kapoor and Sikki Reddy made first round exit after losing 14-21, 18-21 to World No.5 and third seeded Korean pair of Seung Jae Seo and Yu Jung Chae.

In the men's singles second round, Prannoy will take on Yu Jen Chi of Chinese Taipei, while Rajawat and Srikanth will be up against opponents from Taipei in Tzu Wei Wang and Li Yang Su respectively.
