BJD opposes no-trust motion against BJP

We can't support motion brought by Cong: Pinaki

New Delhi, August 8: Opposing the no confidence motion brought by Congress party against the Narendra Modi government, the Biju Janata Dal (BJD) Tuesday said that it can't support a motion brought by the Congress as its foundation is "anti-Congressism.

Senior BJD MP Pinaki Misra, while speaking on the motion in Lok Sabha, said the BJD was born to oppose the corrupt rule of Congress party in Odisha. He said this is a "misplaced motion".

"They are very adept at cutting their nose to spite their face," he said targeting the Congress. "It defies logic and political sense to bring a no-confidence motion that is bound to fail," Misra said and added that every time the Prime Minister gets up on the floor of the House, "he pushes the Congress party through the shredder"

"The foundation of BJD is anti-Congressism. Any motion brought by the Congress party is out of question for the BJD to support. We oppose this motion because of the fact that it's been brought by the Congress," he said.

On the Centre-state relation, Misra stated," the kind of fiscal architecture our Constitution has provided, it is impossible to continuously bicker and fight with the Central government and survive as a model fiscal state as Odisha is today. Our party doesn't believe in needless quarrel with the Centre."

Highlighting the several of state's demands fulfilled by the Centre, Misra said he is unable to persuade himself on behalf of his party and leader to support

the 'no confidence motion.' He held the Manipur High Court order responsible for the current turmoil in the state and termed the HC's judgement, which asked the state government to consider inclusion of Meitei community in ST list, as one of the "most ill-advised order"

He said the Centre made an error by demanding the matter to be remanded back to HC. The Matter should have been rested with the Supreme Court, he said.

To resolve the Manipur issue, Misra said, there is a need of constructive suggestions from all parties rather than this no confidence motion. He also emphasised on the passage of the Women's Reservation Bill as a way forward for women empowerment. "This is the kind of empowerment we need at the ground level. We should treat them at par," the BJD MP said.

New Delhi, August 8: Congress leader Rahul Gandhi has been reallotted the 12, Tughlaq Lane bungalow a day after his Lok Sabha membership was restored following the Supreme Court staying his conviction in a defamation case, officials said Tuesday.

The House Committee of the Lok Sabha decided to allot the bungalow which Gandhi was asked to vacate after he was disqualified as member of the lower house on March 24 and given a two-year jail term for the 'Modi surname' remarks

'Mera ghar pura Hindustan hai (Whole country is my home)," quipped Gandhi when asked about being allotted the 12, Tughlaq Lane bungalow.

Sources said Gandhi has received the letter re-allotting the same house he occupied as Lok Sabha MP for the past almost two decades.

They said Gandhi would be shifting back to his residence soon. He is currently staying with his mother Sonia Gandhi, who is also the chairperson of the Congress Parliamentary Party (CPP). The Lok Sabha Secretariat Monday restored Gandhi's membership of the lower house after the Supreme Court stayed his conviction in the defamation case

Its official: July 2023 Earth's hottest month by far

'THIS IS THE WARMEST RECORD **FOR 120,000 YEARS'**

Brussels, August 8: Now that July's sizzling numbers are all in, the European climate monitoring organisation made it official: July 2023 was Earth's hottest month on record by a wide margin.

July's global average temperature of 16.95 degrees Celsius (62.51 degrees Fahrenheit) was a third of a degree Celsius (six

tenths of a degree Fahrenheit) higher than the previous record set in 2019, Copernicus Climate Change Service, a division of the European Union's space programme, announced Tuesday. Normally global temperature

records are broken by hundredths or a tenth of a degree. So this margin is unusual.

"These records have dire consequences for both people and the planet exposed to ever more frequent and intense extreme events," said Copernicus deputy director, Samantha Burgess.

There have been deadly heat waves in the Southwestern United States and Mexico, Europe



and Asia. Scientific quick studies put the blame on humancaused climate change from the

burning of coal, oil and natural gas Days in July have been hotter than previously recorded from July 2 on. It's been so extra warm that Copernicus and the World Meteorological Organisation made the unusual early announcement that it was likely the hottest month days before it ended. Tuesday's calculations made it official.

The month was 1.5 degrees Celsius (2.7 degrees Fahrenheit) warmer than pre-industrial times. In 2015, the nations of the world agreed to try to prevent long-term warming - not individual months or even years, but decades — that is 1.5 degrees warmer than pre-industrial times.



Bhubaneswar, August 8: The Economic Offences Wing (EOW) of state Crime Branch Tuesday brought the accused held in purportedly one of the largest pan-India crypto fraud case on a three-day remand for further interrogation to unearth the syndicate behind the multicrore scam.

The court has granted three day-remand of the accused, Gurtej Sigh Sidhu, the head of STA Crypto Token, and its state head Nirod Das, against the EOW's plea seeking permission to take the duo on remand for five days. "This is so big a scam that we



Subhalaxmi died due to asphyxiation

Bhubaneswar, August 8: The autopsy report Tuesday confirmed that 18-year-old Subhalaxmi Sahoo died due to asphyxiation at Hotel Deepali International in Laxmisagar area here Saturday afternoon.

Police sources claimed that the deceased might have hanged herself to death. However, cops are yet to unearth the reason behind her taking such extreme step.

Meanwhile, police have recorded the statements of Subhalxmi's purported boyfriend Sanjay, her parents and the manager of the hotel

where the body was found. The cops reportedly recorded contradictory statements by the father and the alleged boyfriend of the deceased. Her father claimed that Subhalaxmi had left home August 2 while Sanjay told the police that she had reached Bhubaneswar

August 30 and was staying along with another male friend of her. Police, however, are trying to unearth the truth.

Subhalaxmi, a student of Kamala Nehru Women's College, had reportedly checked into the hotel Friday. She was staying in a room on the second floor of the hotel. Saturday, the room boy of the hotel suspected something wrong when she didn't come to the downstairs for lunch till late afternoon. After he expressed his concern before the manager, the manager broke into the room and found Subhalaxmi hanging from a ceiling fan with her stole.

Air pollution could be driving rise in antibiotic resistance

ontrolling air pollution could aid in reducing antibiotic resistance, which is when disease-causing microbes are able to resist the drugs designed to kill them, according to new research published in The Lancet Planetary Health iournal.

The association between PM2.5 air pollution and increase in antibiotic resistance has strengthened over time, with enhances in PM2.5 levels leading to larger increases in antibiotic resistance in more recent years, the analysis found using data for 116 countries from 2000 to 2018. Sources of PM2.5 include in-

dustrial processes, road transport, and domestic coal and wood burning. Previous research indicates 90 per cent of the world's population, or 7.3 billion people, are directly exposed to unsafe average annual PM2.5 levels, with 80 per cent of them living in lowand middle-income countries. PM2.5 air pollution was one of

the leading factors driving antibiotic resistance, accounting for 11 per cent of changes in average antibiotic resistance levels

globally, this study found. Further, every 1 per cent rise in air pollution was linked with an increase in antibiotic resistance of between 0.5 and 1.9 per cent, depending on the pathogen, or the disease-causing microbe, the study covering nine bacter-

ial pathogens and 43 types of



antibiotics found.

The highest levels of antibiotic resistance were found to be in North Africa, the Middle East and South Asia, while levels in Europe and North America were found to be low.

Misuse and overuse of antibiotics still remain the main drivers of antibiotic resistance. However, evidence suggests air pollution also contributes to the

spread of antibiotic-resistant bacteria and resistance genes, the study said.

PM2.5 air pollution-driven antibiotic resistance was also linked to an estimated 480.000 premature deaths in 2018, leading to additional economic costs of USD395 billion, the analysis said.

Owing to their huge populations. India and China are expected to face the greatest impact of PM2.5 changes on premature death toll from antibiotic resistance. By 2050, levels of antibiotic resistance worldwide could increase by 17 per cent under no changes to current air pollution policies, the authors modelling suggested.

India is expected to experi-

ence a 2.5 per cent increase in antibiotic resistance resulting from a 10 per cent increase in yearly PM2.5 levels.

In other scenarios, such as increased health spending, controlling air pollution, improving drinking water and reducing antibiotic usage, the level of antibiotic resistance could be greatly reduced, the study said. For example, limiting PM2.5

to 5 micrograms per cubic metres in the atmosphere (recommended by the World Health Organization) could decrease global antibiotic resistance by 17 per cent by 2050. It could further reduce premature deaths linked to antibiotic resistance by 23 per cent and save USD 640

billion annually, the study said "Antibiotic resistance and air pollution are each in their own right among the greatest threats to global health. Until now, we didn't have a clear picture of the possible links between the two, but this work suggests the benefits of controlling air pollution could be two-fold: not only will it reduce the harmful effects of poor air quality, it could also play a major role in combating the rise and spread of antibiotic-resistant bacteria," said lead author Hong Chen, Zhejiang University, China.

Future research should investigate underlying mechanisms of how air pollutants impact antibiotic resistance, the study said.

the boy on his motorcycle to a cashew orchard and raped the minor. Padhi then forced the boy to go with him to another desolate place and tried sodomising him again. However, when the boy screamed in pain and attracted the attention of the locals, Padhi fled the spot.

Returning home, the boy narrated the ordeal to his father. Subsequently a case (No 226/19) was registered at the Polasara

police station Police then arrested Padhi the next day and forwarded him to the court. The then IIC of Polasara PS, Jitendra Kumar Mallick submitted the chargesheet in court. Padhi however, got conditional bail February 4, 2021, However, when he failed to appear during a hear ing, a non-bailable warrant was issued against him. He was again arrested August 11, 2022.

The judge pronounced the verdict after hearing seven eyewitnesses and going through the investigation report, special public prosecutor PP Mohan Singari, who appeared for the government in the case, said.

Workers suffer as 13 plants down shutters in Keonjhar

Many lose jobs and continue to languish in poverty due to shut downs

Keonjhar, August 8: The closure of over 13 plants out of the 40 operating in mining rich Keonjhar district in the last 12 years has pushed hundreds of labourers and other personnel to the brink of starvation and poverty, sources informed here Tuesday. The closure of the plants has deprived the employees of their livelihood. They are facing a harrowing time to even arrange food for their families

To top up this worst-case scenario, sources informed that many other plants are on the brink of shutting down. It means that many more will soon be rendered jobless. The closure of the plants has severely impacted the financial scenario and economy of this district, the sources added.

Sources said that 'Deepak Steel and Power Ltd' stopped production in September, 2012. The plant belonging to 'Grewal Associate Pvt Ltd' downed shutters in January 2015 and with it 68 persons lost their jobs.

The IDCOL-run 'Kalinga Iron Works' which was established by late Chief Minister Biju Patnaik had its plant at Matkambeda in Barbil. It was one of the most successful industrial units to have come up in the district. It had a staff of 1,446 people out of which 775 were regular employees while the remaining 691 were contractual workers. However, all of them



were rendered jobless after the plant stopped production in February, 2015.

The 'Odisha Sponge Iron Ltd plant at Palashpanga which was known as the first sponge iron unit in Asia was shut down after the authorities announced lockout in October, 2012. A total of 964 employees among who were 464 regulars lost their jobs due to the shut down.

The plant was reopened in 2022, but under a different management. Very few former employees have rejoined due to the low salaries offered. The others continue to languish in acute poverty

'Pro-Mineral Pvt Ltd' established its plant at Basantpur locality. The plant had 75 regular and 108 contractual emplovees and 183 labourers. However, all lost their jobs when the plant stopped production

Rourkela, August 8: The 'Vedvyas Pitha', a famous Shaivaite destination in Odisha is all set for a complete facelift and transformation at a cost of ₹35 crore.

"The total DPR has been prepared and has got the approval from the state government. Soon Chief Minister Naveen Patnaik will announce the beginning of the project," an official said. Tuesday.

5T Secretary VK Pandian visited 'Vedvyas' January 1 this year. At that time, he had said the area would be developed keeping in mind its importance. Following his declaration. the DPR was prepared which is now ready awaiting the final go ahead from the CM.

'Vedvyas' is an important religious tourism destination in Odisha and every year lakhs of people visit the place. A huge fair and exhibition is held annually beginning on the auspicious



day of 'Shivratri'. The fair, known as Vedvyas Mela', continues for 15 days. The place is famous for the confluence of the three rivers, 'Sankha', 'Koel' and the 'Saraswati'. Incidentally 'Saraswati' is a small stream which originates from the small hillock on which the temple is situated. The mighty Brahmani river also begins its journey from here. The last rites of the deceased and the immersion of ashes are carried out at this place by thou-

sands of families. Sources informed that a hanging bridge will be constructed over the Brahmani river. The survey work for the bridge has been done. The bridge will originate from the 'Panposh' slum

and end just near the crematorium. Manoj Mahanand, executive engineer, PWD said, "The techno-feasibility report is ready following the survey. Soon the final report will be completed for approval."

The main temples, including 'Shri Chandrasekhar' and 'Balunkeswar', will get a total facelift. Both the Hanuman and the Kashi Vishwanath temples will be shifted elsewhere. The size of the prayer room will also be increased, officials said. They also informed that a high boundary wall will be constructed surrounding the temple. Similarly a new office for the trustee board, rest rooms for the devotees, lavatories and beautification of the river bank will be done.

Renowned historian Dr Prabhat Mallick who resides here said, "This is perhaps the holiest place in Odisha after Puri. This place has both historical and religious importance, with a rich heritage of its own. So, this place certainly requires such a facelift."

long cherished dream of the BJP government at the Centre seems to have come true in passing in the Lok Sabha of The Digital Personal Data Protection Bill. This is an egregious attempt at surveillance of the citizens on a massive scale in the name of protecting them against misuse of their personal data. Right from the moment the Bill was introduced the government has been resorting to equivocation and prevarication. The Union Communications, Electronics, and Information Technology Minister Ashwini Vaishnaw said it was an ordinary Bill. Later it was given out that it was a Money Bill which meant it was not required to be debated and scrutinised in the Rajya Sabha where the Bill could not have passed due to lack of numbers for the BJP, and therefore it would have made the exercise futile.

The Modi government has been trying to silence its critics in one way or the other by blocking access to information. The cornerstone of democracy is free flow of information and data so that the citizens can be informed of the functioning of a government and accordingly form their considered opinion on it. Under the present government, a major section of the media has either been won, bought or threatened into silence. A climate of fear has been created to intimidate both independent media and social activists with courage to expose the government for its various wrongdoings. Since that was not enough to stem the tide of free flow of information through various social media platforms, the government seems to have been hell-bent to take steps to throttle free speech by removing the source of information.

Its first version in this regard was introduced in the form of Data Privacy Law in Parliament in December 2019. But it was dropped in August 2022 following trenchant criticism by the Opposition, technology companies and advocacy groups

The current Bill, like the 2019 draft, would grant sweeping powers to the government beyond reasonable exceptions to exempt itself from compliance with the Bill's data protection provisions for vague reasons. This new addition has more or less crippled the Right to Information (RTI) Act under the guise of "interests of sovereignty and integrity of India, security of the state, friendly relations with foreign states or maintenance of public order." Security and public order are terms the government has long been using to trample freedom of expression and rights to criticise the government.

At the same time, the Data Protection Bill does not provide for safeguards or independent oversight of these government powers. On the contrary, it proposes a Data Protection Board which is nothing but a government entity whose members would be appointed and removed by the government. Their terms and conditions of service would also be prescribed by the government, removing all traces of independence of the board members.

All corrupt and also inefficient bureaucrats and politicians across the country must be greatly celebrating the death of the RTI Act. The fear of exposure has been forever removed from the hearts of the corrupt officials of India by the Modi government.

The absence of checks would only strengthen the government's hand in mounting surveillance and possible mass violations of people's privacy. A glaring example of Modi government's track record is its refusal to respond to allegations over the use of the Israeli spyware Pegasus to target journalists and activists. The intent of the government is clear from the fact that it did not cooperate with the committee set up by the Supreme Court to investigate the use of Pegasus spyware on Indian citizens. And as for common citizens, the Aadhaar data has enough loopholes that the government is incapable to plug which have, time and again, been demonstrated as to how that valuable database is being breached with impunity while the system looks on stupidly.

The surveillance concerns are not unfounded since the country has already had bitter experience of the government's intensified crackdown on freedom of speech and its enforcement of the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021. The rules give greater control to the government over online content, issue threats to weaken encryption and undermine rights to privacy and freedom of expression online. The authorities have been increasingly prosecuting and arresting human rights defenders, peaceful protesters and members of religious minorities in politically motivated cases under counterterrorism, sedition, and national security laws. There is also evidence that the phone numbers of several activists currently in jail on terrorism charges were on the spyware target list. That list also included some ministers of the current Modi government as also members of Opposition parties The Data Protection Bill, it is feared, will not safeguard the rights of users, as is being claimed. Unless there are provisions to make government agencies responsible for carrying out surveillance transparently accountable, there will be no respite in the strangulation process. A rights-affirming data protection law should ensure independent scrutiny of government surveillance to ensure any interference with the right to privacy is brought to book through legal mechanisms. This kind of transparency, accountability and good governance is definitely anathema to the present Narendra Modi government.

DISTORTING ECONOMY

s policymakers around the world embrace industrial policy in pursuit of a wide variety of objectives - supply-chain resilience, green technologies, geopolitical advantage, good jobs - the debate over its effectiveness is reaching fever pitch. Typically, this debate is portrayed as one where sound economics is squarely on the skeptics' side. "There is a strong case against industrial policy in economics," intoned one recent commentary, and embracing it "just wastes money and distorts the economy.

But this is an increasingly outmoded view. While it is generally true that mainstream economists have responded to industrial policy with knee-jerk hostility since at least the 1970s, things have been changing fast. owing to new academic research that is less driven by ideological hostility to government intervention and better grounded in rigorous empirical methods.

This recent crop of research provides more authoritative evidence on how industrial policy really works, improving the quality of debates that in the past shed more heat than light on the issue. And researchers' more nuanced and contextual understanding of such policies yields a generally more positive assessment.

Industrial policies are complex, and quantifying them for the purposes of analysis can be difficult. Consider, for example, China's recent push in the shipbuilding industry. Seeking to become the largest shipbuilding country within a decade, China deployed a multitude of policies, including production subsidies, investment subsidies, and entry subsidies. There were many changes along the way, as in 2009, when policymakers turned away from promoting entry and instead focused on industry consolidation.

In the past, economists too often focused on simple indicators such as import tariffs. capturing only limited dimensions of industrial policy and conflating its objectives with others (such as raising government revenue or playing special-interest politics). A number of recent research efforts

And the prevalence of industrial policies tends to increase with income: advanced economies use it more often and intensively than developing countries do.

Improved methods of causal inference are also leading economists to revise their views. Traditionally, economists assessed the effects of industrial policy by examining whether industries receiving more government help performed better – generally reaching a negative conclusion. It is now recognised that such correlational work is uninformative, because it cannot distinguish between cases where industrial policy is useful and not.

The more recent research

of industrial policy to East Asia's economic miracle. The early economic literature on East Asia's rise had argued that industrial policies were at best ineffective. Newer analyses paying closer attention to the structure of upstream and downstream linkages in these economies reach considerably more sanguine conclusions.

To cite one example, studies of South Korea's Heavy-Chemical Industry Drive (HCI) a landmark - and controversial - industrial policy pursued by President Park Chung-hee in the 1970s, found that the policy promoted the growth of targeted industries, both in the short and long run. HCI's effects on productivity and export performance were both positive.

Critics of East Asian policies thought governments could never pick the right sectors because they lacked information on where market failures were more prominent. Princeton economist Ernest Liu has recently provided a useful guide for policymakers confronting an economy where market imperfections occur across multiple, linked sectors. In such settings, subsidising upstream sectors generally minimises policy mistakes. Liu shows that the actual policies used in China and during South Korea's HCI were in line with this guidance.

Some commentators have recently criticised US President Joe Biden's industrial policy because it "lacks a rigorous economic foundation." The reality is that there is already plenty of good economic research on industrial policy. While more research is always beneficial, the new literature is already providing us with better assessments of industrial policies in all their diversity, evaluating the consequences of historical and contemporary examples, and illuminating how such policies work or fail depending on their instruments and objectives, and on prevailing economic structures.

Metemptosis

hough this word is extremely rare, the situation it refers to is still very I much with us, as it refers to one of the corrections that form part of the Gregorian calendar we all use. We need not worry that it will affect us anytime soon, however: the next metemptosis will occur in 2100. The problem for calendar creators is that the number of days in a year doesn't exactly fit the length of the year - there's about a quarter of a dav over. The older Julian calendar from Roman times had a simple way to deal with this: it just added an extra leap day every four years to make up the numbers and get the calendar back into sync with the year. Unfortunately, over the next 1500 years it slowly became clear this wasn't good enough. In fact, the number of days in the year is very slightly less than 3651/4, so the calendar was slowly gaining on the seasons. In the sixteenth century, advisors to Pope Gregory XIII told him that it was necessary to leave out some days to get things back in step and to change the calendar to omit three leap years in every 400 years. To do this, they suggested that century years should only be leap years if they were divisible by 400. So 2000 was a leap year, but 2100 won't be. Astronomers created metemptosis in the early eighteenth century for this second step, from Greek meta-, after, em-, in, and ptosis, a falling. It came into the language when the need to reform the British calendar was becoming very urgent (Catholic countries had implemented it in 1582; Britain only did so in 1752, though we weren't the last by any means). To be complete, there is proemptosis for the opposite process, adding a day to the calendar, in this case to keep it in step with the moon. For reasons we have no intention of trying to explain, one of these will not be needed until 4200.

I was particularly thrilled to hear about the 11 sanitation workers in Kerala who recently won the state's Rs 10 crore bumper prize lottery. When you win more money than you ever dreamed of, you think it's going to last forever. But a few expensive vacations and luxury cars can make a chunk of your money disappear.

Some lottery winners, unfortunately, have also been targeted by criminals. Others have ended up with poor relationships with family members. If you're sud-

Assault on privacy

Sir, The Digital Personal Data Protection Bill, 2023 was passed in Lok Sabha on Monday by a voice vote. The Bill has retained the contents of the original version of the legislation proposed last November, including those that were red-flagged by privacy experts, such as exemptions for the Centre. In its new avatar, the proposed law has also accorded virtual censorship powers to the Centre. This is India's second attempt at framing privacy legislation, and comes after at least three previous iterations of a data protection law have been considered, and shelved, by the government. Next, the Bill will have to be passed by the Rajya Sabha before it becomes a law. The Bill is criticised for seeking to dilute the provisions of the Right to Information (RTI) Act, which has empowered citizens to access information and hold governments accountable. The RTI Act includes a provision to protect privacy through Section 8(1)(j). A data protection law must safeguard and balance peoples' right to privacy and their right to information, which are fundamental rights flowing from the Constitution. This bill does not fulfill the purpose; hence it is anti-people.

The terms gender and sex are often used interchangeably in casual conversation, but are actually two distinct concepts related to human identity and bi ology. Sex refers to the biological characteristics of a person, particularly in relation to their reproductive anatomy and chromosomal composition. Gender on the other hand, is a social and cultural construct that encompasses the roles, behaviors, expectations, and identities associated with being male-female or non-binary," the court observed.

The court made this observation while hearing a petition moved by the parents of a seven-year-old child born with ambiguous genitalia, seeking to conduct genital reconstructive surgery to raise the child as a female. Although doctors advised genital reconstruction, they refused to actually go ahead

The synchronised survey covered Kerala and Karnataka along with Tamil Nadu and was conducted from May 17 to 19 this year, the report released by the chief minister at the Secretariat here said. Chennai, August 8: A few days ago the Nagapattinam Police in Tamil Nadu conducted raids and seized 300 kg of ganja which was to be ferried to Sri Lanka in a country boat. The police arrested six peo-

ple and the Tamil Nadu Coastal police conducted searches at several godowns and other fishing hamlets near the port town of Nagapattinam to unearth further stocks

Tamil Nadu intelligence agency sources said that they had received tip-offs from central agencies that some Tamil nationalist groups were behind the smuggling of ganja to Sri Lanka. National Investigation Agency (NIA) has registered many cases against Sri Lankan nationals who were former operatives of the Liberation Tigers of Tamil Eelam (LTTE) involved in smuggling of drugs, ferrying arms and indulging in hawala transof senior LTTE intelligence operative Satnukam alias Sabesan in Chennai.

He was one of the key operatives who provided logistics support to the drug cartels of India, Pakistan and Sri Lanka. LTTE operative Satnukam alias Sabesan has been in jail since October 2021 in a case related to smuggling of heroin worth Rs 3,000 crore while five AK 47 assault rifles and pellets have also been recovered from him.

National Investigation Agency (NIA) has also questioned Alla Pitchai in the Rs 3,000 crore heroin smuggling case in which Sabesan is under judicial cus tody. Interestingly, several Tamil nationalist groups and move ments are functioning in Tamil Nadu with the sole objective to revive LTTE. Notorious Haji Ali network of Pakistan has also been pushing drugs into the Indian and Sri Lankan markets. It is also alleged that a former LTTE operative is behind this



is a resident of Colombo, is considered a key person in the revival of LTTE. NIA had said that Gunashekharan had aligned with Haji Salim, a Pakistani national who has been pushing drugs and arms into Sri Lanka from Pakistan.

On March 29, 2022, a Sri Lankan woman, Mary Fransicka, was arrested by NIA while she was boarding a flight to Mumbai to revive a defunct bank account in a nationalised bank. The woman had arrived from Canada and was part of an international Tamil network.

NIA had said that Mary Franciska, T. Kenniston Fernando and K. Bhaskaran entered into a conspiracy with foreign entities to siphon off deposits in dormant bank ac-_ counts by using Indian identity documents obtained fraudulently and forging identity documents to revive, revamp and regroup LTTE in India and Sri Lanka. NIA had said that they were abetted by Johnson Samuvel, Dharmendran and Mohan in forging Indian identity documents. The revival of LTTE is a major agenda for certain Tamil groups and the drug cartels are being used as a major support base for raising funds for the revival of the movement.

Thiruvananthapuram, August 8: With vibrant hues of orange and yellow and the fragrance of freshness in air, the sprawling marigold farms here are a breathtaking visual treat for visitors in Kattakada.

It's hard to believe that these were once barren lands. Thanks to an ambitious project, the hamlets of Kattakada Assembly Constituency near the state capital here have gone from being a bare, desolate stretch to a vivid and inviting carpet of blooms.

As Onam is round the corner, the capital district may not have to depend on flowers from neighbouring Tamil Nadu or Karnataka anymore, as 60 acres of barren land in the constituency, located about 25 km away from here, has now been cultivated with marigold.

'Our Onam Our Flowers' was



an innovative project launched by Kattakada MLA I B Satheesh and it has now been implemented successfully. The sunshine-hued blossoms are now ready to be harvested and will be available till the end of the Onam season, the local people here said.

"I am so happy to see this. When we started to clear these five acres of land that was lying barren for several years and was just a shrub jungle, we were doubtful about the outcome. But now you can see the results." a woman farmer who was busy

plucking the blooms at a farm located in Pallichal Panchayat, said. She is happier about the involvement of women workers in the flower cultivation. The women workforce from Kudumbashree and MGNREGA are the ones who ploughed, planted, and watered the saplings to create this blooming marigold farm 'This is the success of col-

lective work. The panchayat, Agriculture office, MGNREGA, Kudumbashree, and the government worked together and achieved this feat. It was also part of a project to convert barren lands to agriculture farms, Mallika, Pallichal Panchayat President said.

In Pallichal panchayat alone, 26 acres of land have been converted into flower farms. Private individuals have also come forward to join the government initiative and cultivated flowers on their lands. "We used to grow grass for cattle on the slopes of this hill. But when the authorities talked about this initiative, we also joined. We are sure that

this is going to be a big success as all our plants have flowered, making this tourist area more beautiful," Ramesh, a young farmer, who takes care of a 5-acre farm in Valiyavila Panchayat, said.

When the Panchayat author ities started the farming project, women workers from Kudumbashree and MNREGA got fully immersed in it, unmindful of the time they spent at the farm. The results are breathtaking and people from all parts of Thiruvananthapuram are now coming to admire the sight. The panchayat will hold flower markets in the city for people to buy fresh flowers at a low cost. They are also supplying flowers to flower vendors in markets like Chala in Thiruvananthapuram.

The agriculture department supported this initiative wholeheartedly and helped them secure quality saplings. Our team also helps them with technical support at the farm," C V Jayadas, agriculture officer, Vilappilsala said. Thiruvananthapuram has never thought of cultivating flowers, thinking that the soil and climate may not support the crop. However, this new experiment has become a success and may prompt many other panchayats to follow the model. "This may help us produce the flowers that we want here," MLA Satheesh said.

Man jailed for making 300 calls in 48 hrs to lady cop

Kochi, August 8: A Kerala court has sentenced a man to jail for harassing a lady police officer by calling her 300 times in a 48hour period.

The Additional Judicial Magistrate court in Ernakulam sentenced Jose to three years of rigorous imprisonment along with a fine of Rs 10,000 for the offence of sexual harassment, as well as a sentence to one year of simple imprisonment for causing nuisance with a Rs 5,000 as fine. The court ruled that both jail sentences will run concurrently

Jose had made these calls from his personal mobile number to the official landline of a 'Vanitha' (all women) police station. According to the lady police officer, Jose made these calls from July 10-11, 2019 and whoever picked up the phone had to hear his lewd remarks.

The officials at the station were forced to keep the phone receiver aside in an effort to put an end to the calls. The court was also told that Jose had a history of creating such "nuisance" in many police stations.

A complaint was registered on July 11, 2019, which led to Jose's arrest. "The act of the accused has not only caused discomfort, mental pain and dis-



The report has held a Muslim League leader and his supporters responsible for the 1980 riots in which 83 people were killed and several others injured. Saxena, a retired judge of the Allahabad High Court, had submitted his report in November 1983. The report has justified police action saying that they fired in self-defence. It names a Muslim League leader and some of his supporters as responsible for the riots.

78 species of birds are found only in India: Report

Kolkata, August 8: A study by ZSI has revealed that there are as many as 78 bird species which are found only in India.

There is a rich diversity of 10,906 bird species in the world, and of them, India is home to 1,353, Zoological Survey of India scientist Amitava Majumder said.

These 1,353 bird species account for 12.4 per cent of the global avian diversity, he said. According to the International Union for Conservation of Nature (IUCN) categorisation, 25 of the 78 bird species, which are found only in India, are classified as 'threatened', the scientist said.

'Seventy-eight bird species are found only in the country's geographical region. On the oc-



casion of the 75th Independence year, we have focussed on 75 such species in the book, '75 Endemic Birds of India'. Majumder told PTI.

These selected winged species exhibit "remarkable distribution patterns" across various regions of the country, he said. Twenty-eight bird species are restricted to the Western Ghats, 25 to the Andaman and Nicobar Islands, four to the Eastern Himalayas and one each to the Southern Deccan plateau and Central Indian Forest, the scientist said

Of the 25 'threatened' species, three are listed as 'critically endangered', five as 'endangered', and 17 as 'vulnerable'. Eleven species are categorised as 'near threatened'.

Majumder said three bird species - the Manipur Bush Quail (Perdicula manipurensis), listed as 'endangered' by IUCN, the Himalayan Quail (Ophrysia superciliosa), categorised as 'critically endangered', and the Jerdon's Courser (Rhinoptilus bitorquatus), classified as 'critically endangered', have not been included in the ZSI publication.

According to records, the Manipur Bush Quail was last sighted in 1907, while the Himalayan Quail and the Jerdon's Courser were last seen in 1876 and 2009 respectively, he said.

Some researchers believe that the Mottled Wood Owl and the West Himalayan Bush Warbler are only available in India's geographical region but new records and distribution patterns indicate their existence in the nearby countries, Majumder said.

Malabar Grey Hornbill Ocyceros griseus, Malabar Parakeet from the Western Ghats and Nicobar Serpent Eagle Spilornis klossi, Andaman Barn Owl Tyto Deroepstorffi from the Andaman and Nicobar Islands among others have been featured in the ZSI publication.


Islamabad, August 8: Prime Minister Shehbaz Sharif Tuesday said he would write to President Arif Alvi Wednesday to dissolve Pakistan's National Assembly prematurely, a move aimed at getting extra time for holding the general elections scheduled for later this year.

"After completing our (government's) term tomorrow, I will write and send (the advice) to the President to dissolve the assembly and then an interim government will take over," Sharif said while addressing an event in Islamabad. The fiveyear tenure of the lower house of the Parliament is ending on August 12.

In case President Alvi, a former leader of Imran Khan's Pakistan Tehreek-e-Insaf party, dithers, the assembly would be dissolved within 48 hours of advice given by the premier. The government has announced that assemblies will be dissolved three days ahead of its mandated period, following which elections are to be held

within 90 days. In an indication that Sharif would relinquish premiership, he made a farewell visit to the General Headquarters of the Pakistan Army in Rawalpindi. Prime Minister Sharif paid his farewell visit to the General Headquarters (GHQ) Tuesday, marking an important moment in his tenure as the head of the government, The Express

Tribune newspaper reported. The prime minister was warmly welcomed by Chief of Army Staff General Asim Munir as the visit was replete with moving ceremonies and tributes to the nation's fallen heroes. Meanwhile, Leader of the

Opposition in the National Assembly Raja Riaz said that he had not vet met or consulted the premier regarding the names for the caretaker prime minister, Dawn newspaper reported.

"I hope to have a meeting tomorrow in which these things will be discussed," he said, adding that the consultation would happen at "the right time". However, Riaz said he had completed the consultation process with his allies, adding that the three names for the interim prime minister were "almost 90 per cent finalised"

The Pakistan Muslim League-Nawaz (PML-N)-led coalition government would have liked

to remain in power for a couple of more days and dissolved the Parliament on August 11 but it has a hunch that President Alvi might refuse to issue a notification immediately for the dissolution, political observers opine. That is why the advice for dis-

solution is being given three days before the end of the assembly so that even if the president refuses to oblige the prime minister, the assembly would be dissolved before the end of its term, giving the Election Commission of Pakistan 90 days for elections.

In case the assembly completes its constitutional term, the ECP is bound to hold an election within 60 days. But even 90 days may not be enough for election as the new census has been endorsed by the Council of Common Interests, a constitutional body tasked to address issues involving the federating units, and after its approval, it is incumbent on the ECP to hold elections according to it.

Pak extends visa of Indian woman

Peshawar, August 8: Pakistan has extended by one year the visa of a 34-year-old Indian mother of two children who travelled to a remote village in the Khvber Pakhtunkhwa province to marry her Facebook friend after converting to Islam, her Pakistani husband said Tuesday.

Anju - who now goes by the name of Fatima after converting to Islam - on July 25 married her 29-year-old friend Nasrullah, whose home is in the Upper Dir district in the province. They became friends on Facebook in 2019.

On Tuesday, Nasrullah said that Aniu's visa, which was earlier extended for 2 months, has now been extended for a year after their marriage. Her original one-month visa was set to expire on August 20. "The visa of my wife Anju has been extended for a year after the provision of related documents to the Interior Ministry," said Nasrullah.

"All Pakistani institutions are cooperating with us," he added. Last month, a real estate company gifted the couple a plot of land in Khyber Pakhtunkhwa and presented them with a cheque.

Anju, who was born in Kailor village in Uttar Pradesh and lived in the Alwar district of Rajasthan, travelled to Pakistan legally from India via the Wagah-Attari border. She was granted a 30-day visa, valid for Upper Dir only

Anju is married to Arvind, who is in Rajasthan. They have a 15-year-old daughter and a sixyear-old son. Her story is similar to Seema Ghulam Haider, a 30year-old Pakistani mother of four who sneaked into India to live with Sachin Meena, a 22-yearold Hindu man she got in touch with while playing PUBG in 2019.

Seoul, August 8: Carrying huge backpacks and water bottles, tens of thousands of scouts began arriving at university dormitories, government and corporate training centres, and hotels around Seoul and other inland cities Tuesday as the South Korean government evacuated the World Scout Jamboree ahead of a tropical storm.

The South Korean government had scrambled to keep the 12-day gathering of Scouts going in the face of struggles with heat, hygiene and land use controversies, as thousands of British and American scouts departed over the weekend.

It wasn't until Monday afternoon that officials announced the decision to abandon the coastal campsite in Saemangeum, a huge area reclaimed from the sea in the southwestern county of Buan, after forecasters raised alarms that Tropical Storm Khanun was heading toward the Korean Peninsula.

As of Tuesday evening, Khanun was passing through waters 60 kilometres south of Japan's Yakushima island, which is south of the southern main island of Kyushu. Japan's weather agency issued warnings for heavy rain and high winds in the southern regions of Kyushu and parts of Shikoku island, east of Kyushu.

The 37,000 scouts, who hailed from 156 countries and were



mostly teenagers, folded up their tents before boarding over 1,000 vehicles for the evacuation that began Tuesday morning.

The World Organisation of the Scout Movement said all youth participants had safely departed from the Jamboree campsite as of Tuesday evening. Most of the Scouts will be accommodated in Seoul and the surrounding area.

South Korean officials say the Jamboree will continue in the form of cultural events and activities, including a K-Pop concert in Seoul on Friday. Scouts from Britain, who had transferred to hotels in Seoul over the weekend because of the extreme heat at the Jamboree site, visited a war memorial and the former presidential palace.

Matt Hyde, the chief executive of UK Scouts, said the organization will need to use more than GBP 1 million from its reserves to cover the cost of moving 4.500 Scouts and adult volunteers, an expense that could impact its activities for the next five years.

UK scouts had become increasingly concerned about sanitation, the availability of food, medical services and the "punishing heat.""We feel let down by the organisers because we repeatedly raised some of these concerns before we went, and during, and we were promised things were going to be put in place and they weren't." Hyde said.

Hundreds of scouts from

Norway had already left the site on Monday, citing concerns about the complications of moving together with tens of thousands of other Scouts. Geir Olav Kaase, leader of the Norwegian contingent, said the Scouts arrived at their hotels in Incheon by 9 p.m. Monday.

The 1,500-member Swedish contingent was transferred to three university dormitories in the central city of Cheonan. Northern European nations are dealing with their own extreme weather, with strong winds and rains causing floods, damaging buildings and knocking out electricity at thousands of homes in Norway and Sweden, Denmark, Lithuania, Finland, Estonia and Latvia. The North Jeolla provincial government, which governs Buan, had hoped that the Jamboree would draw attention and investment to a controversial swath of reclaimed land.

The 42-year-old, who works at



a law firm in New York, is the second son of King Vajiralongkorn with his second wife Sujarinee Vivacharawongse, a former actress. The then-crown prince divorced Sujarinee who was accused of adultery in public in 1996.

Sujarinee and her children later moved abroad. The youngest daughter was taken back by the royal family and was given the title Princess Sirivannavari Nariratana, but the four sons remain estranged and do not have any formal royal titles. The Palace has not commented on his visit.

Vacharaesorn went to the Foundation for Slum Child Care and donated money to support their work, according to the foundation's Facebook post, saying he "greeted the children thoughtfully and took great interest in the foundation's work of helping underprivileged children and families"



The company said its consolidated net profit rose to 21.15 billion rupees (\$255.4 million) in the April-June quarter, from 11.58 billion rupees a year ago. Its revenue from operations increased 23.5% to 62.48 billion rupees, boosted by a 12% growth in cargo volumes. The company which operates the largest container handling port in India, Mundra in Gujarat -- kept its full-year revenue outlook of 240-250 billion rupees, implying year-over-growth of 15%-20%.

million people have signed up, getting their irises scanned in exchange for a digital ID and, in some countries, free crypto. The new project from ChatGPT founder Sam Altman aims to

create a blockchain-based "identity and financial network". Its native coin WLD has kept a steady price between \$2 and \$2.50 since its launch July 24, thus far spared the "pump-and-dump" trajectory of many new crypto tokens.

The investor jury is out on Worldcoin's prospects, according to Gordon Grant, co-head of trading at Genesis Trading, which isn't offering the token to clients yet. 'There are folks that have re-

ally taken a view about this project, both with the positive and negative side," he said.

Worldcoin's white paper on its website says that, over the next 15 years, a total of 10 billion of the tokens will be released into the market. The circulating supply was 120 million tokens

Worldcoin's bet is that this will become more important as artificial intelligence bots increase the need for people to be able to verify their human status online.

India ends WUG campaign with record 26 medals

Chengdu, August 8: India ended their World University Games (WUG) campaign Tuesday with their best-ever performance, winning a record haul of 26 medals, including 11 gold, here. India finished at seventh spot with 11 gold, 5 silver and 10 bronze, the best ever standing in the

medal tally. This edition's haul is even more than the combined total of all the past WUG medals won by the country. India had won just 21 medals (6 gold, 6 silver and 9 bronze) before the 2023 World University Games This time, India had sent 256 athletes in the WUG. The biggest let down, however, is the performance of the track and field athletes, who won just four bronze medals from 82 participants, the largest in the Indian contingent.


